# Commutant of $\mathcal{L}_{\widehat{\mathfrak{F}}_{2}}(4,0)$ in the cyclic permutation orbifold of $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(1,0)^{\otimes 4}$

#### Abstract

We study the commutant of the vertex operator algebra $\mathcal{L}_{\widehat{\mathfrak{F}}_{2}}(4,0)$ in the cyclic permutation orbifold model $\left(\mathcal{L}_{\widehat{\mathfrak{s}}_{2}}(1,0)^{\otimes 4}\right)^{\tau}$ with $\tau=(1234)$. It is shown that the commutant is isomorphic to a $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$-orbifold model of a tensor product of two lattice type vertex operator algebras of rank one.


## 1 Introduction

Let $A_{1}=\mathbb{Z} \alpha,\langle\alpha, \alpha\rangle=2$ be a root lattice of type $A_{1}$. It is well-known that the vertex operator algebra $V_{A_{1}}$ associated to the lattice $A_{1}$ is isomorphic to a simple affine vertex operator algebra $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(1,0)$ of type $\mathfrak{s l}_{2}$ with level 1 . For an integer $k \geq 2$, the cyclic sums of the weight one vectors in $V_{A_{1}}$ in the tensor product $V_{A_{1}}^{\otimes k}$ of $k$ copies of $V_{A_{1}}$ generate a vertex operator subalgebra isomorphic to $\mathcal{L}_{\widehat{\mathfrak{s}}_{2}}(k, 0)$. The commutant $M$ of $\mathcal{L}_{\widehat{\mathfrak{s}}_{2}}(k, 0)$ in $V_{A_{1}}^{\otimes k}$ has been studied well (see for example [JL], [LS], [LY]). Among other things the classification of irreducible modules for $M$ and the rationality of $M$ were established in [JL].

Let $\tau$ be a cyclic permutation on the tensor components of $V_{A_{1}}^{\otimes k}$ of length $k$. Then $\tau$ is an automorphism of the vertex operator algebra $V_{A_{1}}^{\otimes k}$ and every element of $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(k, 0)$ is fixed by $\tau$. Thus $\tau$ induces an automorphism of $M$. Our main concern is the orbifold model $M^{\tau}$ of $M$ by $\tau$, that is, the set of fixed points of $\tau$ in $M$, which is the commutant of $\mathcal{L}_{\widehat{\mathfrak{s}}_{2}}(k, 0)$ in the orbifold model $\left(V_{A_{1}}^{\otimes k}\right)^{\tau}$.

The vertex operator algebra $\mathcal{L}_{\widehat{\mathfrak{S}}_{2}}(k, 0)$ contains a subalgebra $T$ isomorphic to a vertex operator algebra associated to a rank one lattice generated by a square norm $2 k$ element, which corresponds to a Cartan subalgebra of $\mathfrak{s l}_{2}(\mathbb{C})$. The commutant of $T$ in $V_{A_{1}}^{\otimes k}$ is a lattice type vertex operator algebra $V_{\sqrt{2} A_{k-1}}$.

[^0]On the other hand the commutant $K\left(\mathfrak{s l}_{2}, k\right)$ of $T$ in $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(k, 0)$ is called a parafermion vertex operator algebra of type $\mathfrak{s l}_{2}$. The parafermion vertex operator algebra $K\left(\mathfrak{s l}_{2}, k\right)$ has been studied both in mathematics and in physics from various points of view (see for example [ALY], [DLY3], [DLWY], [DL]). We note that $M \otimes \mathcal{L}_{\mathfrak{\mathfrak { F }}_{2}}(k, 0) \subset V_{A_{1}}^{\otimes k}$ and $M \otimes K\left(\mathfrak{s l}_{2}, k\right) \subset V_{\sqrt{2} A_{k-1}}$. In fact, $M$ is the commutant of $K\left(\mathfrak{s l}_{2}, k\right)$ in $V_{\sqrt{2} A_{k-1}}$.

If $k=2$, then $M$ is isomorphic to the simple Virasoro vertex operator algebra $L\left(\frac{1}{2}, 0\right)$ of central charge $\frac{1}{2}$. In this case $\tau$ acts trivially on $M$ and $M^{\tau}$ coincides with $M$. The first nontrivial case, that is, the orbifold model $M^{\tau}$ for the case $k=3$ was studied in [DLTYY]. It was shown that $M^{\tau}$ is a $W_{3}$-algebra of central charge $\frac{6}{5}$. Furthermore, the classification of irreducible modules for $M^{\tau}$ was obtained and their properties were discussed in detail. Those results were used for the study of the vertex operator algebra $\left(V_{\sqrt{2} A_{2}}\right)^{\tau}$ in [TY].

In this paper we consider the orbifold model $M^{\tau}$ for the case $k=4$. The study of $M^{\tau}$ should lead to a better understanding of the structure of $\left(V_{\sqrt{2} A_{3}}\right)^{\tau}$, for $M^{\tau} \otimes K\left(\mathfrak{s l}_{2}, 4\right)$ is contained in $\left(V_{\sqrt{2} A_{3}}\right)^{\tau}$.

Let $L=\mathbb{Z} \alpha \oplus \mathbb{Z} \alpha \oplus \mathbb{Z} \alpha$ be an orthogonal sum of three copies of $\mathbb{Z} \alpha$, where $\langle\alpha, \alpha\rangle=2$. The main idea is the use of an automorphism $\rho$ of the vertex operator algebra $V_{L}$ studied in [DLY2], which maps $V_{N}$ onto $V_{L}^{+}$. Here $N$ is a sublattice of $L$ isomorphic to the sublattice $\sqrt{2} A_{3}$ of $A_{1}^{4}$. It was shown in [DLY2] that $\rho(M)=\operatorname{Com}_{V_{L}^{+}}\left(V_{\mathbb{Z} \gamma}\right)$; the commutant of $V_{\mathbb{Z} \gamma}$ in $V_{L}^{+}$, where $\gamma=(\alpha, \alpha, \alpha) \in L$.

The cyclic permutation $\tau$ on the tensor components of $V_{A_{1}}^{\otimes 4}=V_{A_{1}^{4}}$ is a lift of an isometry of the underlying lattice $A_{1}^{4}$. We denote the isometry of $A_{1}^{4}$ by the same symbol $\tau$. The sublattice $\sqrt{2} A_{3}$ of $A_{1}^{4}$ is invariant under $\tau$. Hence we can discuss an isometry $\widetilde{\tau}$ of $N$ corresponding to the isometry $\tau$ of $\sqrt{2} A_{3}$ by the isomorphism $N \cong \sqrt{2} A_{3}$. We extend $\widetilde{\tau}$ to an isometry of $L$ and consider its lift to an automorphism of the vertex operator algebra $V_{L}$. We denote the automorphism by the same symbol $\widetilde{\tau}$. Let $\tau^{\prime}=\rho \widetilde{\tau} \rho^{-1}$ be the conjugate of $\widetilde{\tau}$ by $\rho$ so that $\rho\left(M^{\tau}\right)=\operatorname{Com}_{V_{L}^{+}}\left(V_{\mathbb{Z} \gamma}\right)^{\tau^{\prime}}$. It turns out that $\operatorname{Com}_{V_{L}^{+}}\left(V_{\mathbb{Z} \gamma}\right)^{\tau^{\prime}}$ can be expressed as $\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{\frac{G}{G}}$, where $\gamma_{1}$ and $\gamma_{2}$ are elements of $L$ of square norm 12 and 4 , respectively and $G$ is a group of automorphisms of $V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}$ isomorphic to $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$.

It is known that the vertex operator algebra $M$ is generated by the set of conformal vectors $\omega_{\alpha}$ of central charge $\frac{1}{2}$ associated to the positive roots $\alpha$ of type $A_{3}$ (see [JL], [LS]). However, it is difficult to describe the properties of the orbifold model $M^{\tau}$ in terms of those generators of $M$. By the result in this paper we can discuss $\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{G}$ instead of $M^{\tau}$, which seems to be easy to treat.

This paper is organized as follows. In Section 2 we review basic materials of vertex operator algebras such as conformal vectors and the commutant of a vertex operator subalgebra. In Section 3 we discuss two kinds of automor-
phisms of a vertex operator algebra $V_{L}$ associated to a positive definite even lattice $L$, one is a lift of the -1 -isometry of the lattice $L$ and the other is an exponential of the operator $h_{(0)}$ for $h \in \mathbb{C} \otimes_{\mathbb{Z}} L$. We also recall three automorphisms of a rank one lattice type vertex operator algebra $V_{\mathbb{Z} \alpha}$ studied in [DLY1], [DLY2] for $\langle\alpha, \alpha\rangle=2$. In Section 4 we introduce the commutant $M$ of $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(4,0)$ in $\mathcal{L}_{\widehat{\mathfrak{s l}}_{2}}(1,0)^{\otimes 4}$ and its orbifold model $M^{\tau}$ by $\tau$. Finally, in Section 5 we prove that $M^{\tau}$ is isomorphic to a $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$-orbifold model of a tensor product of two rank one lattice type vertex operator algebras.

The automorphism $\rho$ of the vertex operator algebra $V_{L}$ plays a key role in our argument. The use of $\rho$ was suggested by Ching Hung Lam. The authors are grateful to him for the important advice.

## 2 Preliminaries

In this section we review some basic notions and notations for vertex operator algebras (see [MN], [K], [LL]). Let $V=(V, Y, \mathbf{1}, \omega)$ be a vertex operator algebra with the vacuum vector $\mathbf{1}$ and the Virasoro vector $\omega$. We denote $\omega$ by $\omega^{V}$ also. The $n$-th product of $u, v \in V$ will be written as $u_{(n)} v$ for $n \in \mathbb{Z}$. We often regard $u_{(n)}$ as a $\mathbb{C}$-linear endomorphism of $V$. Two vectors $u$ and $v$ in $V$ are said to be mutually commutative if $u_{(n)} v=0$ for all $n \in \mathbb{Z}_{\geq 0}$. The eigenspace $V_{n}$ for $L_{0}=\omega_{(1)}^{V}$ of eigenvalue $n \in \mathbb{Z}$ is finite dimensional. A vector in $V_{n}$ is said to be of weight $n$.

A vertex operator subalgebra of $V$ is a vertex subalgebra $U$ equipped with a Virasoro vector $\omega^{U}$. When $\omega^{V}=\omega^{U}, U$ is said to be full. For a pair of a vertex operator algebra $V$ and its subalgebra $U$, the subspace

$$
\operatorname{Com}_{V}(U)=\left\{v \in V \mid u_{(n)} v=0 \text { for } n \in \mathbb{Z}_{\geq 0} \text { and } u \in U\right\}
$$

becomes a vertex operator algebra with Virasoro vector $\omega^{\operatorname{Com}_{V}(U)}=\omega^{V}-\omega^{U}$. We call it the commutant of $U$ in $V$. Actually, it is known that

$$
\begin{equation*}
\operatorname{Com}_{V}(U)=\left\{v \in V \mid \omega_{(0)}^{U} v=0\right\} \tag{2.1}
\end{equation*}
$$

(see [FZ, Theorem 5.2]). Hence the commutant of $U$ in $V$ depends only on the Virasoro vector of $U$.

A vector $e \in V_{2}$ is called a conformal vector if $L_{n}^{e}=e_{(n+1)}, n \in \mathbb{Z}$ give a representation for the Virasoro algebra on $V$ of certain central charge. The Virasoro vector of a vertex operator subalgebra $U$ of $V$ is a conformal vector of $V$. Let $e$ be a conformal vector in $V$. For any vertex operator subalgebra $U$ with $\omega^{U}=e$, the commutant $\operatorname{Com}_{V}(U)$ does not depend on $U$ by (2.1). In such a case we may write $\operatorname{Com}_{V}(e)=\operatorname{Com}_{V}(U)$.

Proposition 2.1. Let $V$ be a vertex operator algebra and $e^{1}, e^{2}$ mutually commutative conformal vectors in $V$. Then $\operatorname{Com}_{V}\left(e^{1}+e^{2}\right)=\operatorname{Com}_{\operatorname{Com}_{V}\left(e^{1}\right)}\left(e^{2}\right)$.

Proof. Let $U$ be a vertex subalgebra generated by $e^{1}$ and $e^{2}$. Since $e^{1}$ and $e^{2}$ are mutually commutative, $e_{1}+e_{2}$ is the Virasoro vector of $U$. Thus we have

$$
\begin{aligned}
\operatorname{Com}_{V}\left(e^{1}+e^{2}\right) & =\operatorname{Com}_{V}(U) \\
& =\left\{v \in V \mid e_{(n)}^{1} v=e_{(n)}^{2} v=0 \text { for } n \in \mathbb{Z}_{\geq 0}\right\} \\
& =\left\{v \in \operatorname{Com}_{V}\left(e^{1}\right) \mid e_{(n)}^{2} v=0 \text { for } n \in \mathbb{Z}_{\geq 0}\right\} \\
& =\operatorname{Com}_{\operatorname{Com}_{V}\left(e^{1}\right)}\left(e^{2}\right) .
\end{aligned}
$$

An automorphism of a vertex operator algebra $V$ is a linear isomorphism of $V$ preserving all $n$-th product, and fixing the vacuum vector $\mathbf{1}$ and the Virasoro vector $\omega^{V}$. For a group $G$ consisting of automorphisms of $V$, the subset

$$
V^{G}=\{v \in V \mid g(v)=v \text { for } g \in G\}
$$

is a full vertex operator subalgebra of $V$, which is called the orbifold model of $V$ by $G$. When $G=\langle\tau\rangle$ is a cyclic group, we denote $V^{G}$ by $V^{\tau}$ simply.

Let $V$ be a vertex operator algebra and $G$ an automorphism group of $V$. Let $U$ a vertex operator subalgebra of $V$ and assume that $g\left(\omega^{U}\right)=\omega^{U}$ for any $g \in G$. Then the restriction $g^{\prime}$ of $g \in G$ to $\operatorname{Com}_{V}(U)$ gives rise to an automorphism of $\operatorname{Com}_{V}(U)$. In fact, for the automorphism group $H=\left\{g^{\prime} \mid g \in\right.$ $G\}$ of $\operatorname{Com}_{V}(U)$, we have

$$
\begin{equation*}
\operatorname{Com}_{V}(U)^{H}=\operatorname{Com}_{V^{G}}\left(\omega^{U}\right) . \tag{2.2}
\end{equation*}
$$

## 3 Lattice type vertex operator algebras and their automorphisms

In this section we discuss certain automorphisms of lattice type vertex operator algebras. Let $V_{L}$ be the vertex operator algebra constructed in [FLM] for a positive definite even lattice $(L,\langle\rangle$,$) of rank d$. As a vector space $V_{L}$ is isomorphic to a tensor product of the symmetric algebra $S\left(\mathfrak{h} \otimes t^{-1} \mathbb{C}\left[t^{-1}\right]\right)$ and the twisted group algebra $\mathbb{C}\{L\}$ of $L$, where $\mathfrak{h}=\mathbb{C} \otimes_{\mathbb{Z}} L$. In this paper we only consider the case where $\langle\alpha, \alpha\rangle \in 4 \mathbb{Z}$ for any $\alpha \in L$ or $L$ is an orthogonal sum of rank one lattices. In such a case the central extension $\hat{L}$ of $L$ studied in [FLM] splits and $\mathbb{C}\{L\}$ is canonically isomorphic to the ordinary group algebra $\mathbb{C}[L]$. Thus we take $\mathbb{C}[L]$ in place of $\mathbb{C}\{L\}$ here. A standard basis of $\mathbb{C}[L]$ is denoted by $\left\{e^{\alpha} \mid \alpha \in L\right\}$ with multiplication $e^{\alpha} e^{\beta}=e^{\alpha+\beta}$. The vacuum vector of $V_{L}$ is $\mathbf{1}=1 \otimes e^{0}$, and the Virasoro vector is given by

$$
\omega^{V_{L}}=\frac{1}{2} \sum_{i=1}^{d}\left(h_{i} \otimes t^{-1}\right)^{2} \otimes e^{0}
$$

where $\left\{h_{1}, \cdots, h_{d}\right\}$ is an orthonormal basis of $\mathfrak{h}$. Every eigenvalue for $L_{0}=\omega_{(1)}^{V_{L}}$ on $V_{L}$ is a nonnegative integer and the eigenspace $\left(V_{L}\right)_{n}$ with eigenvalue $n$ is finite dimensional.

For simplicity, we regard the sets $L, \mathfrak{h}$ and $\left\{e^{\alpha} \mid \alpha \in L\right\}$ as subsets of $V_{L}$, respectively, under the identification

$$
\alpha=(\alpha \otimes 1)_{(-1)} \mathbf{1}, \quad h=h_{(-1)} \mathbf{1}, \quad e^{\alpha}=1 \otimes e^{\alpha}
$$

for $\alpha \in L$ and $h \in \mathfrak{h}$. Then we have $\left(V_{L}\right)_{0}=\mathbb{C} 1$ and

$$
\left(V_{L}\right)_{1}=\mathfrak{h} \oplus \bigoplus_{\substack{\alpha \in L \\\langle\alpha, \alpha\rangle=2}} \mathbb{C} e^{\alpha}
$$

In fact, the weight of $e^{\alpha}$ is $\frac{1}{2}\langle\alpha, \alpha\rangle$ for $\alpha \in L$.
We will need two kinds of automorphisms of $V_{L}$. One is an involution $\theta_{L}$ given by a lift of the -1 -isometry of the lattice $L$. We have

$$
\theta_{L}(\beta)=-\beta, \quad \theta_{L}\left(e^{\beta}\right)=e^{-\beta}
$$

for $\beta \in L$. The set $\left(V_{L}\right)^{\theta_{L}}$ of fixed points of $\theta_{L}$ is also denoted by $V_{L}^{+}$. The other is an inner automorphism $\mathrm{I}_{h}=\exp \left(2 \pi \sqrt{-1} h_{(0)}\right)$ for $h \in \mathfrak{h}$. We have

$$
\mathrm{I}_{h}(\beta)=\beta, \quad \mathrm{I}_{h}\left(e^{\beta}\right)=e^{2 \pi \sqrt{-1}\langle h, \beta\rangle} e^{\beta}
$$

for $\beta \in L$. In particular,

$$
\mathrm{I}_{\alpha / 2\langle\alpha, \alpha\rangle}\left(e^{m \alpha}\right)=(-1)^{m} e^{m \alpha}
$$

for $m \in \mathbb{Z}$ and $0 \neq \alpha \in L$. Since $\mathrm{I}_{h_{1}} \mathrm{I}_{h_{2}}=\mathrm{I}_{h_{1}+h_{2}}$ for $h_{1}, h_{2} \in \mathfrak{h}$, the automorphism $\mathrm{I}_{h}$ is of finite order if and only if $h \in \frac{1}{T} L$ for some $T \in \mathbb{Z}_{>0}$. By the definition of $\theta_{L}$ and $\mathrm{I}_{h}$, we see that

$$
\theta_{L} \mathrm{I}_{h} \theta_{L}=\mathrm{I}_{-h}
$$

for any $h \in \mathfrak{h}$. Therefore,

$$
\begin{equation*}
\mathrm{I}_{-\frac{h}{2}}\left(\mathrm{I}_{h} \theta_{L}\right) \mathrm{I}_{\frac{h}{2}}=\theta_{L} \tag{3.1}
\end{equation*}
$$

That is, $\mathrm{I}_{h} \theta_{L}$ is conjugate to $\theta_{L}$ in $\operatorname{Aut}\left(V_{L}\right)$.
Let $\mathbb{Z} \alpha$ be a rank one lattice with $\langle\alpha, \alpha\rangle=2$, which is the root lattice of type $A_{1}$. In [DLY1, Section 2], three involutions $\theta_{1}, \theta_{2}$ and $\sigma$ of $V_{\mathbb{Z} \alpha}$ are considered. The involutions $\theta_{1}$ and $\theta_{2}$ are expressed as

$$
\theta_{1}=\mathrm{I}_{\frac{\alpha}{4}}, \quad \theta_{2}=\theta_{\mathbb{Z} \alpha},
$$

and $\sigma$ is a unique extension of the involution of the Lie algebra $\left(V_{\mathbb{Z} \alpha}\right)_{1} \cong \mathfrak{s l}_{2}(\mathbb{C})$ given by

$$
\begin{equation*}
\sigma(\alpha)=E^{\alpha}, \quad \sigma\left(E^{\alpha}\right)=\alpha, \quad \sigma\left(F^{\alpha}\right)=-F^{\alpha} \tag{3.2}
\end{equation*}
$$

where $E^{\alpha}=e^{\alpha}+e^{-\alpha}$ and $F^{\alpha}=e^{\alpha}-e^{-\alpha}$. As automorphisms of $V_{\mathbb{Z} \alpha}$, we have

$$
\begin{equation*}
\sigma \theta_{\mathbb{Z} \alpha} \sigma=\mathrm{I}_{\frac{\alpha}{4}} . \tag{3.3}
\end{equation*}
$$

## 4 Orbifold model $M^{\tau}$

In this section we introduce an orbifold model $M^{\tau}$. We use the notation $X_{N}$ to denote the root lattice of type $X_{N}$. We also write $X_{N}^{i}$ for an orthogonal sum of $i$ copies of the root lattice $X_{N}$.

For simplicity, we write $\mathcal{L}(k, 0)$ for the simple affine vertex operator algebra $\mathcal{L}_{\widehat{s l}_{2}}(k, 0)$ associated to $\mathfrak{s l}_{2}(\mathbb{C})$ of positive integer level $k$. It is well-known that $\mathcal{L}(1,0)$ is isomorphic to the lattice type vertex operator algebra $V_{A_{1}}$ associated to the root lattice of type $A_{1}$. Thus we have natural isomorphisms

$$
\begin{equation*}
\mathcal{L}(1,0)^{\otimes 4} \cong V_{A_{1}}^{\otimes 4} \cong V_{A_{1}^{4}} \tag{4.1}
\end{equation*}
$$

of vertex operator algebras. Let $\tau$ be a cyclic permutation on $\mathcal{L}(1,0)^{\otimes 4}$ defined by

$$
\tau\left(a_{1} \otimes a_{2} \otimes a_{3} \otimes a_{4}\right)=a_{4} \otimes a_{1} \otimes a_{2} \otimes a_{3}
$$

for $a_{i} \in \mathcal{L}(1,0)$. In fact, $\tau$ is a lift of an isometry

$$
\begin{equation*}
\tau: \alpha_{i} \mapsto \alpha_{i+1}, \quad i \in \mathbb{Z} / 4 \mathbb{Z} \tag{4.2}
\end{equation*}
$$

of the lattice

$$
\begin{equation*}
A_{1}^{4}=\mathbb{Z} \alpha_{1} \oplus \mathbb{Z} \alpha_{2} \oplus \mathbb{Z} \alpha_{3} \oplus \mathbb{Z} \alpha_{4} \tag{4.3}
\end{equation*}
$$

with $\left\langle\alpha_{i}, \alpha_{j}\right\rangle=2 \delta_{i, j}$.
Set

$$
H=\alpha_{1}+\alpha_{2}+\alpha_{3}+\alpha_{4}
$$

and consider a sublattice $\sqrt{2} A_{3}=\sum_{i, j=1}^{4} \mathbb{Z}\left(\alpha_{i}-\alpha_{j}\right)$ of $A_{1}^{4}$. We note that $\mathbb{Z} H$ and $\sqrt{2} A_{3}$ are mutually orthogonal and that $H \equiv 4 \alpha_{1}$ modulo $\sqrt{2} A_{3}$. Hence $A_{1}^{4}=\cup_{i=0}^{3}\left(i \alpha_{1}+\mathbb{Z} H+\sqrt{2} A_{3}\right)$ and

$$
V_{A_{1}^{4}}=\oplus_{i=0}^{3} V_{i \alpha_{1}+\mathbb{Z} H+\sqrt{2} A_{3}}
$$

as $V_{\mathbb{Z} H+\sqrt{2} A_{3}}$-modules. It follows that

$$
\operatorname{Com}_{V_{A_{1}^{4}}}\left(V_{\mathbb{Z} H}\right)=V_{\sqrt{2} A_{3}} .
$$

Since $\tau$ leaves $V_{\mathbb{Z} H}$ invariant, $\tau$ induces an automorphism of the vertex operator algebra $V_{\sqrt{2} A_{3}}$, which will be also denoted by $\tau$. This automorphism is a lift of the restriction of the isometry $\tau(4.2)$ of $A_{1}^{4}$ to its sublattice $\sqrt{2} A_{3}$ :

$$
\begin{equation*}
\tau\left(\alpha_{i}-\alpha_{i+1}\right)=\alpha_{i+1}-\alpha_{i+2}, \quad i \in \mathbb{Z} / 4 \mathbb{Z} \tag{4.4}
\end{equation*}
$$

Since $V_{\mathbb{Z} H}$ is contained in $\left(V_{A_{1}^{4}}\right)^{\tau}$, it follows from (2.2) that

$$
\left(V_{\sqrt{2} A_{3}}\right)^{\tau}=\operatorname{Com}_{\left(V_{A_{1}^{4}}\right)^{\tau}}\left(V_{\mathbb{Z} H}\right)
$$

We next take two vectors

$$
E=e^{\alpha_{1}}+e^{\alpha_{2}}+e^{\alpha_{3}}+e^{\alpha_{4}}, \quad F=e^{-\alpha_{1}}+e^{-\alpha_{2}}+e^{-\alpha_{3}}+e^{-\alpha_{4}}
$$

in $\left(V_{A_{1}^{4}}\right)_{1}^{\tau}$. Then the set $\{E, H, F\}$ generates a vertex operator subalgebra $U$ of $\left(V_{A_{1}^{4}}\right)^{\tau}$ isomorphic to $\mathcal{L}(4,0)$. We consider the commutant

$$
M=\operatorname{Com}_{V_{A_{1}^{4}}}(U) \cong \operatorname{Com}_{\mathcal{L}(1,0)^{\otimes 4}}(\mathcal{L}(4,0))
$$

We note that $U$ contains $V_{\mathbb{Z} H}$ as a vertex operator subalgebra. The commutant

$$
K_{0}=\operatorname{Com}_{U}\left(V_{\mathbb{Z} H}\right)
$$

has been studied in [ALY], [DLY3] and [DLWY]. The Virasoro vector of $K_{0}$ is $\omega^{K_{0}}=\omega^{U}-\omega^{V_{Z H}}$. Since $\omega^{K_{0}}$ and $\omega^{V_{Z H}}$ are mutually commutative conformal vectors and since $\operatorname{Com}_{V_{A_{1}^{4}}}\left(\omega^{V_{Z H}}\right)=V_{\sqrt{2} A_{3}}$, we see that

$$
\begin{equation*}
M=\operatorname{Com}_{V_{A_{1}^{4}}}\left(\omega^{U}\right)=\operatorname{Com}_{V_{\sqrt{2} A_{3}}}\left(\omega^{K_{0}}\right) \tag{4.5}
\end{equation*}
$$

by Proposition 2.1. Since $U$ is contained in $\left(V_{A_{1}^{4}}\right)^{\tau}$, we have

$$
\begin{equation*}
M^{\tau}=\operatorname{Com}_{\left(V_{\sqrt{2} A_{3}}\right)^{\tau}\left(\omega^{K_{0}}\right)=\left(\operatorname{Com}_{V_{\sqrt{2} A_{3}}}\left(\omega^{K_{0}}\right)\right)^{\tau} . . . . . .} \tag{4.6}
\end{equation*}
$$

## 5 Main results

In this section we show that $M^{\tau}$ is isomorphic to a $\mathbb{Z}_{2} \times \mathbb{Z}_{2}$-orbifold model of a tensor product of two lattice type vertex operator algebras of rank one. Following [DLY2], we study an isomorphism between the vertex operator algebras $V_{\sqrt{2} A_{3}}$ and $V_{A_{1}^{3}}^{+}$. We remark that another isomorphism was considered in [DLY1] (see [DLY2, Remark 3.2]).

Throughout this section, let

$$
L=\mathbb{Z} \alpha \oplus \mathbb{Z} \alpha \oplus \mathbb{Z} \alpha
$$

be an orthogonal sum of three copies of $\mathbb{Z} \alpha$, where $\langle\alpha, \alpha\rangle=2$. Set

$$
\alpha^{(1)}=(\alpha, 0,0), \quad \alpha^{(2)}=(0, \alpha, 0), \quad \alpha^{(3)}=(0,0, \alpha),
$$

so that $L=\mathbb{Z} \alpha^{(1)}+\mathbb{Z} \alpha^{(2)}+\mathbb{Z} \alpha^{(3)}$ and $\left\langle\alpha^{(i)}, \alpha^{(j)}\right\rangle=2 \delta_{i, j}$. The vertex operator algebra $V_{L}$ is isomorphic to the tensor product $V_{A_{1}}^{\otimes 3}$ of three copies of $V_{A_{1}}=V_{\mathbb{Z} \alpha}$. Hence the involution $\sigma$ of $V_{\mathbb{Z} \alpha}$ defined in (3.2) induces naturally an involution $\sigma \otimes \sigma \otimes \sigma$ of $V_{L}$. Let

$$
\begin{equation*}
\rho=\mathrm{I}_{\frac{1}{4}\left(\alpha^{(2)}+\alpha^{(3)}\right)}(\sigma \otimes \sigma \otimes \sigma) \in \operatorname{Aut}\left(V_{L}\right) \tag{5.1}
\end{equation*}
$$

be a composite of $\sigma \otimes \sigma \otimes \sigma$ and the inner automorphism $\mathrm{I}_{\frac{1}{4}\left(\alpha^{(2)}+\alpha^{(3)}\right)}$ of $V_{L}$ with respect to $\frac{1}{4}\left(\alpha^{(2)}+\alpha^{(3)}\right) \in \frac{1}{4} L$ (see [DLY2, Section 3]). We note that $\mathrm{I}_{\frac{1}{4}\left(\alpha^{(2)}+\alpha^{(3)}\right)}=1 \otimes \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}$. By the definition of $\rho$, we have

$$
\begin{align*}
\rho\left(\alpha^{(1)}\right) & =E^{\alpha^{(1)}}, \quad \rho\left(\alpha^{(i)}\right)=-E^{\alpha^{(i)}} & & (i=2,3),  \tag{5.2}\\
\rho\left(E^{\alpha^{(i)}}\right) & =\alpha_{i} & & (i=1,2,3),  \tag{5.3}\\
\rho\left(F^{\alpha^{(1)}}\right) & =-F^{\alpha^{(1)}}, \quad \rho\left(F^{\alpha^{(i)}}\right)=F^{\alpha_{i}} & & (i=2,3) . \tag{5.4}
\end{align*}
$$

Set

$$
\begin{array}{cc}
\beta_{1}=\alpha^{(1)}+\alpha^{(2)}, & \beta_{2}=-\alpha^{(2)}+\alpha^{(3)}, \quad \beta_{3}=-\alpha^{(1)}+\alpha^{(2)} \\
& \gamma=\alpha^{(1)}+\alpha^{(2)}+\alpha^{(3)} .
\end{array}
$$

Then $\left\{\frac{1}{\sqrt{2}} \beta_{1}, \frac{1}{\sqrt{2}} \beta_{2}, \frac{1}{\sqrt{2}} \beta_{3}\right\}$ forms the set of simple roots of type $A_{3}$. We consider the sublattice

$$
N=\sum_{i, j=1}^{3} \mathbb{Z}\left(\alpha^{(i)} \pm \alpha^{(j)}\right)=\left\langle\beta_{1}, \beta_{2}, \beta_{3}\right\rangle_{\mathbb{Z}}
$$

of $L$. It is known that $N \cong \sqrt{2} D_{3}$ is isomorphic to the sublattice $\sqrt{2} A_{3}$ of the lattice $A_{1}^{4}$ (4.3) discussed in Section 4 by the correspondence

$$
\begin{equation*}
\beta_{1} \leftrightarrow \alpha_{1}-\alpha_{2}, \quad \beta_{2} \leftrightarrow \alpha_{2}-\alpha_{3}, \quad \beta_{3} \leftrightarrow \alpha_{3}-\alpha_{4} \tag{5.5}
\end{equation*}
$$

This isomorphism between the lattices $N$ and $\sqrt{2} A_{3}$ induces an isomorphism between the vertex operator algebras $V_{N}$ and $V_{\sqrt{2} A_{3}}$. Thus we can think of the vertex operator subalgebras $M$ and $K_{0}$ of $V_{\sqrt{2} A_{3}}$ discussed in Section 4 as vertex operator subalgebras of $V_{N}$.

We need the following facts in [DLY2].
Theorem 5.1. (1) $\rho\left(V_{N}\right)=V_{L}^{+}$.
(2) $\rho\left(\omega^{K_{0}}\right)=\omega^{V_{Z \gamma}}$.
(3) $\rho(M)=\operatorname{Com}_{V_{L}^{+}}\left(\omega^{V_{Z \gamma}}\right)$.

Proof. The assertions (1) and (2) follow from [DLY2, Lemmas 3.4 (3) and 3.3 (3)]. Then the assertion (3) follows from (4.5).

Under the isomorphism (5.5) between $N$ and $\sqrt{2} A_{3}$, the isometry $\tau$ (4.4) of the lattice $\sqrt{2} A_{3}$ corresponds to an isometry

$$
\beta_{1} \mapsto \beta_{2} \mapsto \beta_{3} \mapsto-\alpha^{(2)}-\alpha^{(3)} \mapsto \beta_{1}
$$

of the lattice $N$. This isometry of $N$ is the restriction of an isometry $\widetilde{\tau}$ of the lattice $L$ of order 4 given by

$$
\widetilde{\tau}: \alpha^{(1)} \mapsto \alpha^{(3)} \mapsto-\alpha^{(1)} \mapsto-\alpha^{(3)} \mapsto \alpha^{(1)}, \quad \alpha^{(2)} \leftrightarrow-\alpha^{(2)} .
$$

The isometry $\widetilde{\tau}$ of $L$ lifts to an automorphism of the vertex operator algebra $V_{L}$ of order 4 , which is also denoted by $\widetilde{\tau}$.

Actually,

$$
\widetilde{\tau}=\left(\theta_{\mathbb{Z} \alpha} \otimes \theta_{\mathbb{Z} \alpha} \otimes 1\right) t_{13}
$$

is a composite of $t_{13}$ and $\theta_{\mathbb{Z} \alpha} \otimes \theta_{\mathbb{Z} \alpha} \otimes 1$, where $t_{13}$ denotes the transposition of the first component and the third one of the tensor product $V_{L}=V_{A_{1}}^{\otimes 3}$. By direct calculations, we have

$$
\begin{align*}
\widetilde{\tau}\left(\alpha^{(1)}\right) & =\alpha^{(3)}, & \widetilde{\tau}\left(\alpha^{(2)}\right) & =-\alpha^{(2)}, & \widetilde{\tau}\left(\alpha^{(3)}\right) & =-\alpha^{(1)},  \tag{5.6}\\
\widetilde{\tau}\left(e^{ \pm \alpha^{(1)}}\right) & =e^{ \pm \alpha^{(3)}}, & \widetilde{\tau}\left(e^{ \pm \alpha^{(2)}}\right) & =e^{\mp \alpha^{(2)}}, & \widetilde{\tau}\left(e^{ \pm \alpha^{(3)}}\right) & =e^{\mp \alpha^{(1)}} . \tag{5.7}
\end{align*}
$$

Now we consider the conjugate $\tau^{\prime}$ of $\widetilde{\tau}$ by $\rho$ (5.1).

$$
\tau^{\prime}=\rho \widetilde{\tau} \rho^{-1} \in \operatorname{Aut}\left(V_{L}\right)
$$

Lemma 5.2. As automorphisms of $V_{L}$, we have

$$
\begin{equation*}
\tau^{\prime}=\left(1 \otimes \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}\right) t_{13} . \tag{5.8}
\end{equation*}
$$

Proof. Using (3.3), we can calculate as follows.

$$
\begin{aligned}
\tau^{\prime}= & \rho \widetilde{\tau} \rho^{-1} \\
= & \mathrm{I}_{\frac{1}{4}\left(\alpha_{2}+\alpha_{3}\right)} \sigma \widetilde{\tau} \sigma \mathrm{I}_{\frac{1}{4}\left(\alpha_{2}+\alpha_{3}\right)} \\
= & \left(1 \otimes \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}\right)(\sigma \otimes \sigma \otimes \sigma)\left(\theta_{\mathbb{Z} \alpha} \otimes \theta_{\mathbb{Z} \alpha} \otimes 1\right) t_{13} \\
& \circ(\sigma \otimes \sigma \otimes \sigma)\left(1 \otimes \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}\right) \\
= & \left(\sigma \theta_{\mathbb{Z} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha} \sigma \theta_{\mathbb{Z} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha} \sigma\right) t_{13}\left(\sigma \otimes \sigma \mathrm{I}_{\frac{1}{4} \alpha} \otimes \sigma \mathrm{I}_{\frac{1}{4} \alpha}\right) \\
= & \left(\sigma \theta_{\mathbb{Z} \alpha} \sigma \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha} \sigma \theta_{\mathbb{Z} \alpha} \sigma \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}\right) t_{13} \\
= & \left(1 \otimes \mathrm{I}_{\frac{1}{4} \alpha} \otimes \mathrm{I}_{\frac{1}{4} \alpha}\right) t_{13} .
\end{aligned}
$$

Recall that $\gamma=\alpha^{(1)}+\alpha^{(2)}+\alpha^{(3)}$. We set

$$
\gamma_{1}=\beta_{2}-\beta_{3}=\alpha^{(1)}-2 \alpha^{(2)}+\alpha^{(3)}, \quad \gamma_{2}=-\beta_{2}-\beta_{3}=\alpha^{(1)}-\alpha^{(3)}
$$

and consider $P=\mathbb{Z} \gamma_{1}+\mathbb{Z} \gamma_{2}+\mathbb{Z} \gamma$. Since $\gamma_{1}, \gamma_{2}$ and $\gamma$ are mutually orthogonal, we have $V_{P}=V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}} \otimes V_{\mathbb{Z} \gamma}$. One can easily see that

$$
\begin{equation*}
P=\left\langle\alpha^{(1)}-\alpha^{(3)}, \alpha^{(2)}+2 \alpha^{(3)} 3,6 \alpha^{(3)}\right\rangle_{\mathbb{Z}} \tag{5.9}
\end{equation*}
$$

Hence we have a coset decomposition

$$
L=\cup_{i=0}^{5}\left(i \alpha^{(3)}+P\right)
$$

Since $\alpha^{(3)}=\frac{1}{6} \gamma_{1}-\frac{1}{2} \gamma_{2}+\frac{1}{3} \gamma$, we have

$$
3 \alpha^{(3)}+P=\left(\frac{1}{2} \gamma_{1}+\mathbb{Z} \gamma_{1}\right)+\left(\frac{1}{2} \gamma_{2}+\mathbb{Z} \gamma_{2}\right)+\mathbb{Z} \gamma
$$

Therefore,

$$
\begin{align*}
\operatorname{Com}_{V_{L}}\left(V_{\mathbb{Z} \gamma}\right) & =\operatorname{Com}_{V_{P} \oplus V_{3 \alpha(3)+P}}\left(V_{\mathbb{Z} \gamma}\right)  \tag{5.10}\\
& =\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right) \oplus\left(V_{\frac{1}{2} \gamma_{1}+\mathbb{Z} \gamma_{1}} \otimes V_{\frac{1}{2} \gamma_{2}+\mathbb{Z} \gamma_{2}}\right) .
\end{align*}
$$

Lemma 5.3. (1) The eigenvalues for $\tau^{\prime}$ on $V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}$ are $\pm 1$.
(2) The eigenvalues for $\tau^{\prime}$ on $V_{\frac{1}{2} \gamma_{1}+\mathbb{Z} \gamma_{1}} \otimes V_{\frac{1}{2} \gamma_{2}+\mathbb{Z} \gamma_{2}}$ are $\pm \sqrt{-1}$.
(3) $\left(V_{P} \oplus V_{3 \alpha^{(3)}+P}\right)^{\tau^{\prime}}=\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{\tau^{\prime}} \otimes V_{\mathbb{Z} \gamma}$.

Proof. Recall that we regard $L$ as a subset of $V_{L}$. Under the canonical identification between $V_{L}$ and $V_{A_{1}}^{\otimes 3}$, we have

$$
\begin{aligned}
\gamma_{1} & =\alpha \otimes \mathbf{1} \otimes \mathbf{1}-2(\mathbf{1} \otimes \alpha \otimes \mathbf{1})+\mathbf{1} \otimes \mathbf{1} \otimes \alpha \\
\gamma_{2} & =\alpha \otimes \mathbf{1} \otimes \mathbf{1}-\mathbf{1} \otimes \mathbf{1} \otimes \alpha \\
\gamma & =\alpha \otimes \mathbf{1} \otimes \mathbf{1}+\mathbf{1} \otimes \alpha \otimes \mathbf{1}+\mathbf{1} \otimes \mathbf{1} \otimes \alpha \\
e^{ \pm \gamma_{1}} & =e^{ \pm \alpha} \otimes e^{\mp 2 \alpha} \otimes e^{ \pm \alpha} \\
e^{ \pm \gamma_{2}} & =e^{ \pm \alpha} \otimes \mathbf{1} \otimes e^{\mp \alpha} \\
e^{ \pm \gamma} & =e^{ \pm \alpha} \otimes e^{ \pm \alpha} \otimes e^{ \pm \alpha}
\end{aligned}
$$

respectively. Then by Lemma 5.2, we have

$$
\begin{align*}
\tau^{\prime}\left(\gamma_{1}\right) & =\gamma_{1}, & \tau^{\prime}\left(e^{ \pm \gamma_{1}}\right) & =-e^{ \pm \gamma_{1}}  \tag{5.11}\\
\tau^{\prime}\left(\gamma_{2}\right) & =-\gamma_{2}, & \tau^{\prime}\left(e^{ \pm \gamma_{2}}\right) & =-e^{\mp \gamma_{2}}  \tag{5.12}\\
\tau^{\prime}(\gamma) & =\gamma, & \tau^{\prime}\left(e^{ \pm \gamma}\right) & =e^{ \pm \gamma} \tag{5.13}
\end{align*}
$$

Since $V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}$ is generated by the set $\left\{\gamma_{1}, \gamma_{2}, e^{ \pm \gamma_{1}}, E^{\gamma_{2}}, F^{\gamma_{2}}\right\}$ consisting of eigenvectors for $\tau^{\prime}$ whose eigenvalues are $\pm 1$, we have the assertion (1).

We note that $V_{\frac{1}{2} \gamma_{1}+\mathbb{Z} \gamma_{1}} \otimes V_{\frac{1}{2} \gamma_{2}+\mathbb{Z} \gamma_{2}}$ is an irreducible $V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}$-module and so it is generated by a nonzero vector $u=e^{\frac{1}{2}\left(\gamma_{1}+\gamma_{2}\right)}+\sqrt{-1} e^{\frac{1}{2}\left(\gamma_{1}-\gamma_{2}\right)}$. Since

$$
\begin{aligned}
& \tau^{\prime}\left(e^{\frac{1}{2}\left(\gamma_{1}+\gamma_{2}\right)}\right)=\tau^{\prime}\left(e^{\alpha^{(1)}-\alpha^{(2)}}\right)=e^{-\alpha^{(2)}+\alpha^{(3)}}=e^{\frac{1}{2}\left(\gamma_{1}-\gamma_{2}\right)}, \\
& \tau^{\prime}\left(e^{\frac{1}{2}\left(\gamma_{1}-\gamma_{2}\right)}\right)=\tau^{\prime}\left(e^{-\alpha^{(2)}+\alpha^{(3)}}\right)=-e^{\alpha^{(1)}-\alpha^{(2)}}=-e^{\frac{1}{2}\left(\gamma_{1}+\gamma_{2}\right)}
\end{aligned}
$$

we have $\tau^{\prime}(u)=\sqrt{-1} u$. Hence by (1), the assertion (2) holds.
The assertion (3) follows from (1), (2) and (5.13).
Here we note that $\left\langle\gamma_{1}, \gamma_{1}\right\rangle=12$ and $\left\langle\gamma_{2}, \gamma_{2}\right\rangle=4$. Let

$$
g=\mathrm{I}_{\frac{1}{24} \gamma_{1}} \otimes\left(\mathrm{I}_{\frac{1}{8} \gamma_{2}} \theta_{\mathbb{Z} \gamma_{2}}\right) \in \operatorname{Aut}\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right) .
$$

Then by (5.11) and (5.12), the restriction of $\tau^{\prime}$ to $V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}$ coincides with the automorphism $g$. Hence (5.10) and Lemma 5.3 imply the following proposition.

Proposition 5.4. Let $L$ and $\tau^{\prime}$ be as above. Then

$$
\operatorname{Com}_{V_{L}}\left(V_{\mathbb{Z} \gamma}\right)^{\tau^{\prime}}=\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{g} .
$$

Let $M$ and $\tau$ be as in Section 4. Then we see that

$$
\begin{aligned}
\rho\left(M^{\tau}\right) & =\operatorname{Com}_{V_{L}^{+}}\left(V_{\mathbb{Z} \gamma}\right)^{\tau^{\prime}} \\
& =\operatorname{Com}_{V_{L}}\left(V_{\mathbb{Z} \gamma}\right)^{\left\langle\tau^{\prime}, \theta^{\prime}\right\rangle} \\
& =\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{\left\langle g, \theta^{\prime}\right\rangle}
\end{aligned}
$$

by the definition of $\tau^{\prime}$, Theorem 5.1 and Proposition 5.4, where

$$
\theta^{\prime}=\theta_{\mathbb{Z} \gamma_{1}} \otimes \theta_{\mathbb{Z} \gamma_{2}} \in \operatorname{Aut}\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)
$$

Let $G=\left\langle g, \theta^{\prime}\right\rangle$ be a subgroup of $\operatorname{Aut}\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)$ generated by $g$ and $\theta^{\prime}$. We note that

$$
G=\left\langle\left(\mathrm{I}_{\frac{1}{24} \gamma_{1}} \theta_{\mathbb{Z} \gamma_{1}}\right) \otimes \mathrm{I}_{\frac{1}{8} \gamma_{2}}, \mathrm{I}_{\frac{1}{24} \gamma_{1}} \otimes\left(\mathrm{I}_{\frac{1}{8} \gamma_{2}} \theta_{\mathbb{Z} \gamma_{2}}\right)\right\rangle \cong \mathbb{Z}_{2} \times \mathbb{Z}_{2}
$$

Theorem 5.5. Let $M=\operatorname{Com}_{V_{A_{1}^{4}}}(\mathcal{L}(4,0))$ and $\tau$ a cyclic permutation of $V_{A_{1}^{4}}$ of length 4 as in Section 4. Let $G$ be as above. Then $M^{\tau}$ is isomorphic to the orbifold model $\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{G}$.

Let

$$
f=\mathrm{I}_{\frac{1}{48} \gamma_{1}} \otimes \mathrm{I}_{\frac{1}{16} \gamma_{2}} \in \operatorname{Aut}\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)
$$

By (3.1), we have

$$
\begin{aligned}
& f^{-1}\left(\left(\mathrm{I}_{\frac{1}{24} \gamma_{1}} \theta_{\mathbb{Z} \gamma_{1}}\right) \otimes \mathrm{I}_{\frac{1}{8} \gamma_{2}}\right) f=\theta_{\mathbb{Z} \gamma_{1}} \otimes \mathrm{I}_{\frac{1}{8} \gamma_{2}} \\
& f^{-1}\left(\mathrm{I}_{\frac{1}{24} \gamma_{1}} \otimes\left(\mathrm{I}_{\frac{1}{8} \gamma_{2}} \theta_{\mathbb{Z} \gamma_{2}}\right)\right) f=\mathrm{I}_{\frac{1}{24} \gamma_{1}} \otimes \theta_{\mathbb{Z} \gamma_{2}} .
\end{aligned}
$$

Let $g_{1}=\theta_{\mathbb{Z} \gamma_{1}} \otimes \mathrm{I}_{\frac{1}{8} \gamma_{2}}$ and $g_{2}=\mathrm{I}_{\frac{1}{24} \gamma_{1}} \otimes \theta_{\mathbb{Z} \gamma_{2}}$. Then $\left\langle g_{1}, g_{2}\right\rangle=f^{-1} G f \cong \mathbb{Z}_{2} \times \mathbb{Z}_{2}$ and the following corollary holds.

Corollary 5.6. The vertex operator algebra $M^{\tau}$ is isomorphic to the orbifold $\operatorname{model}\left(V_{\mathbb{Z} \gamma_{1}} \otimes V_{\mathbb{Z} \gamma_{2}}\right)^{\left\langle g_{1}, g_{2}\right\rangle}$.
