# A characterization of eventually periodicity

#### Abstract

In this article, we show that the Kamae-Xue complexity function for an infinite sequence classifies eventual periodicity completely. We prove that an infinite binary word $x_{1} x_{2} \cdots$ is eventually periodic if and only if $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ has a positive limit, where $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)$ is the sum of the squares of all the numbers of appearance of finite words in $x_{1} x_{2} \cdots x_{n}$, which was introduced by Kamae-Xue as a criterion of randomness in the sense that $x_{1} x_{2} \cdots x_{n}$ is more random if $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)$ is smaller. In fact, it is known that the lower limit of $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{2}$ is at least $3 / 2$ for any sequence $x_{1} x_{2} \cdots$, while the limit exists as $3 / 2$ almost surely for the $(1 / 2,1 / 2)$ product measure. For the other extreme, the upper limit of $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ is bounded by $1 / 3$. There are sequences which are not eventually periodic but the lower limit of $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ is positive, while the limit does not exist.


## 1 Introduction

In [3], a criterion of randomness for binary words is introduced. As stated in Definition 1 and 3, let

$$
\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)=\sum_{\xi \in \mathrm{U}_{k=1}^{\infty}\{0,1\}^{k}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}^{2},
$$

where

$$
\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}:=\#\left\{i: 1 \leq i \leq n-k+1, x_{i} x_{i+1} \cdots x_{i+k-1}=\xi\right\}
$$

is the number of appearance of a finite word $\xi$ in $x_{1} x_{2} \cdots x_{n}$. Since the function $f(x)=x^{2}$ is convex, the value $\sum_{\xi \in\{0,1\}^{k}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}^{2}$ for any $k=1,2, \cdots$ is smaller if the values $\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}$ for $\xi \in\{0,1\}^{k}$ are less deviated as a whole from the mean value $(n-k+1) / 2^{k}$, that is, the sequence $x_{1} x_{2} \cdots x_{n}$ is more random. In fact, it is proved in [3] that

$$
\liminf _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{2}} \geq \frac{3}{2}
$$

holds for any $x_{1} x_{2} \cdots \in\{0,1\}^{\infty}$, while

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(X_{1} X_{2} \cdots X_{n}\right)}{n^{2}}=\frac{3}{2}
$$

holds with probability 1 if $X_{1} X_{2} \cdots X_{n}$ is the i.i.d. process with $P\left(X_{i}=\right.$ $0)=P\left(X_{i}=1\right)=1 / 2$.

In this article, we study the opposite case that $\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)$ increase in the order of $n^{3}$ and prove that $x_{1} x_{2} \cdots \in\{0,1\}^{\infty}$ is eventually periodic if and only if

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}} \text { exists and }>0 .
$$

It is easy to see that if $x=x_{1} x_{2} \cdots \in\{0,1\}^{\infty}$ containes a few 1 , or exactly speaking, if $x=0^{k_{1}} 10^{k_{2}} 1 \cdots$ with $\liminf _{n \rightarrow \infty} k_{n+1} / k_{n}>1$, then we have

$$
\liminf _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0 .
$$

Since this $x_{1} x_{2} \cdots$ is not eventually periodic, it follows from our result that $\lim _{n \rightarrow \infty} \Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ does not exist.

There are many characterizations of eventually periodicity. Most famous one might be the result due to Hedlund and Morse concerning the complexity. That is, $x_{1} x_{2} \cdots$ is eventually periodic if and only if for some $k \geq 1$ the number of words of size $k$ appearing in $x_{1} x_{2} \cdots$ is smaller than $k+1$ ([1]). Another characterization concerning the return time is obtained in [2]. Here, we add one more characterization which concerns both the complexity and the return time.

## 2 Definitions and Lemmas

Definition 1. For $x_{1} x_{2} \cdots x_{n} \in\{0,1\}^{n}, \xi \in\{0,1\}^{k}$ with $1 \leq k \leq n$ and $i=0,1, \cdots, n-k$, we denote

$$
\xi \prec_{i} x_{1} x_{2} \cdots x_{n} \quad \text { if } \xi=x_{i+1} x_{i+2} \cdots x_{i+k}
$$

and

$$
\xi \prec x_{1} x_{2} \cdots x_{n} \text { if } \xi \prec_{i} x_{1} x_{2} \cdots x_{n} \text { for some } i=0,1, \cdots, n-k .
$$

We call $\xi$ a factor or suffix of $x_{1} x_{2} \cdots x_{n}$, respectively, if $\xi \prec x_{1} x_{2} \cdots x_{n}$ or $\xi \prec_{n-k} x_{1} x_{2} \cdots x_{n}$. We also denote

$$
\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}=\#\left\{i: 0 \leq i \leq n-k, \xi \prec_{i} x_{1} x_{2} \cdots x_{n}\right\}
$$

and $\left|x_{1} x_{2} \cdots x_{n}\right|=n$.
Definition 2. For $\eta=a_{1} \cdots a_{k} \in\{0,1\}^{k}$ and $\ell=1,2, \cdots$, we denote

$$
\eta^{\ell}=\underbrace{a_{1} \cdots a_{k}}_{1} \underbrace{a_{1} \cdots a_{k}}_{2} \cdots \underbrace{a_{1} \cdots a_{k}}_{\ell} .
$$

In the same way, we define $\eta^{\infty} \in\{0,1\}^{\infty}$. We call $\eta$ prime if there is no $\xi$ such that $\eta=\xi^{\ell}$ for some $\ell \geq 2$.

Definition 3 ([3]). Define $\Sigma^{n}:\{0,1\}^{n} \rightarrow \mathbb{R}$ by

$$
\Sigma^{n}\left(x_{1} x_{2} \cdots x_{n}\right)=\sum_{\xi \in\{0,1\}^{+}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}^{2},
$$

where $\{0,1\}^{+}=\bigcup_{k=1}^{\infty}\{0,1\}^{k}$. We write $\Sigma^{n}=\Sigma$ as a function from $\{0,1\}^{+}$ to $\mathbb{R}$.

Definition 4. For $x_{1} x_{2} \cdots x_{n} \in\{0,1\}^{n}$, define

$$
\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)=\max \left\{|\eta|^{2}(\ell+1)^{3}: \eta^{\ell} \prec x_{1} x_{2} \cdots x_{n}\right\}
$$

Lemma 1. For any $x_{1} x_{2} \cdots x_{n} \in\{0,1\}^{n}$, it holds that

$$
\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) \geq \frac{\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)}{48}
$$

Proof Let $M=\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)$. Then, there exist positive integers $k, \ell$ and $\eta \in\{0,1\}^{k}$ with $\eta^{l} \prec x_{1} x_{2} \cdots x_{n}$ such that $k^{2}(\ell+1)^{3}=M$. Then, we have

$$
\sum_{\xi ; \xi \prec \eta}\left|\eta^{\ell}\right|_{\xi}^{2} \geq l \sum_{\xi ; \xi \prec \eta}\left|\eta^{\ell}\right|_{\xi} \geq \frac{k^{2} \ell^{2}}{2},
$$

since $\left|\eta^{\ell}\right|_{\xi} \geq \ell$ if $\xi \prec \eta$ and $\sum_{\xi ; \xi \prec \eta}\left|\eta^{\ell}\right|_{\xi} \geq k^{2} \ell / 2$. In the same way, for any $i=1, \cdots, \ell-1$, we have

$$
\sum_{\xi ; \xi \nprec \eta^{i} \text { and } \xi \prec \eta^{i+1}}\left|\eta^{\ell}\right|_{\xi}^{2} \geq \frac{k^{2}(\ell-i)^{2}}{2} .
$$

Therefore, we have

$$
\begin{aligned}
\Sigma\left(x_{1} x_{2} \cdots x_{n}\right) & \geq \sum_{i=0}^{\ell-1} \sum_{\xi ; \xi \not \eta^{i} \text { and }}\left|\eta_{\xi \prec \eta^{i+1}}\right|_{\xi}^{2} \\
& \geq \sum_{i=0}^{\ell-1} \frac{k^{2}(\ell-i)^{2}}{2} \geq \frac{k^{2} \ell^{3}}{6} \geq \frac{k^{2}(\ell+1)^{3}}{48}=\frac{M}{48} .
\end{aligned}
$$

Lemma 2. For any $x_{1} x_{2} \cdots \in\{0,1\}^{\infty}$,

$$
\liminf _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0 \text { if and only if } \liminf _{n \rightarrow \infty} \frac{\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0,
$$

and

$$
\limsup _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0 \text { if and only if } \limsup _{n \rightarrow \infty} \frac{\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0 .
$$

Proof By Lemma 1, the "if" parts are clear. Let us prove the "only if" parts. Let $M_{n}=\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)$. Assume that there exists $i, m, k$ with $1 \leq i+1<i+k+1<i+m<i+k+m \leq n$ such that

$$
x_{i+1} x_{i+2} \cdots x_{i+m}=x_{i+k+1} x_{i+k+2} \cdots x_{i+k+m} .
$$

Let $k$ be the minimum with this property. Let $\eta=x_{i+1} x_{i+2} \cdots x_{i+k}$ and $\ell=$ $\lfloor m / k\rfloor$. Then, $k^{2}(\ell+1)^{3} \leq M_{n}$ holds since $\eta^{\ell} \prec x_{i+1} x_{i+2} \cdots x_{i+m}$. Hence, $k \geq(k(\ell+1))^{3} / M_{n}>m^{3} / M_{n}$. It follows that $\left|x_{1} x_{2} \cdots x_{n}\right| \xi \leq n /\left(m^{3} / M_{n}\right)$ for any $\xi \in\{0,1\}^{m}$. Therefore for any $1 \leq m \leq n$,

$$
\begin{align*}
\sum_{\xi \in\{0,1\}^{m}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}^{2} & \leq \frac{n}{m^{3} / M_{n}} \sum_{\xi \in\{0,1\}^{m}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}  \tag{2.1}\\
& \leq \frac{n}{m^{3} / M_{n}} \cdot n=\frac{n^{2} M_{n}}{m^{3}} .
\end{align*}
$$

Assume that

$$
\liminf _{n \rightarrow \infty} \frac{M_{n}}{n^{3}}=0
$$

Then, there exists a subsequence $\left\{n^{\prime}\right\}$ of $\{n\}=\{1,2, \cdots\}$ such that $M_{n^{\prime}} / n^{\prime 3}$ converges to 0 as $n^{\prime} \rightarrow \infty$. Let $\psi(n)=\left(M_{n} / n^{3}\right)^{1 / 3}$. Then, $\psi\left(n^{\prime}\right) \rightarrow 0$ as $n^{\prime} \rightarrow \infty$. For simplicity, we denote this subsequence $\left\{n^{\prime}\right\}$ by $\{n\}$. By (2.1), we have

$$
\begin{aligned}
\frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}} & =\frac{1}{n^{3}} \sum_{m=1}^{n} \sum_{\xi \in\{0,1\}^{m}}\left|x_{1} x_{2} \cdots x_{n}\right|_{\xi}^{2} \\
& \leq \frac{1}{n^{3}} \sum_{1 \leq m \leq \psi(n) n}(n-m)^{2}+\frac{1}{n^{3}} \sum_{m>\psi(n) n} \frac{n^{2} M_{n}}{m^{3}} \\
& \leq \frac{1}{n^{3}} \cdot \psi(n) n \cdot n^{2}+\frac{M_{n}}{n} \cdot \frac{1}{2(\psi(n) n-1)^{2}} \\
& =\psi(n)+\psi(n)^{3} \cdot \frac{1}{2 \psi(n)^{2}} \cdot \frac{1}{\left(1-(\psi(n) n)^{-1}\right)^{2}} \\
& =\psi(n)+\frac{\psi(n)}{2\left(1-\left(M_{n}\right)^{-1 / 3}\right)^{2}}
\end{aligned}
$$

which implies that

$$
\liminf _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}=0
$$

By the same argument, we can prove that

$$
\limsup _{n \rightarrow \infty} \frac{M_{n}}{n^{3}}=0
$$

implies that

$$
\limsup _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}=0,
$$

which completes the proof.

Definition 5. For $\omega \in\{0,1\}^{n}, \xi \in\{0,1\}^{k}$ with $k \leq n$ and $m=1,2, \cdots, n$, we denote

$$
|\omega|_{\xi, m}=\#\left\{i ; n-m-k+1 \leq i \leq n-k, \xi \prec_{i} \omega\right\} .
$$

Lemma 3. Let $\omega \in\{0,1\}^{n}$ and $\eta \in\{0,1\}^{m}$ with $n, m \geq 1$. Then, we have

$$
\Sigma(\omega \eta)-\Sigma(\omega)=\sum_{\xi \in\{0,1\}^{+}} 2|\omega \eta|_{\xi, m}|\omega|_{\xi}+|\omega \eta|_{\xi, m}^{2} .
$$

Proof Clear from the fact that $|\omega \eta|_{\xi}=|\omega|_{\xi}+|\omega \eta|_{\xi, m}$.
Lemma 4. Let $\omega \in\{0,1\}^{n}$ and $\eta \in\{0,1\}^{k}$ satisfy that $\left|\omega \eta^{\ell}\right|_{\eta^{\ell}}=1$. Assume that $\eta$ is prime and $\omega_{n} \neq \eta_{k}$ (i.e. the last elements of $\omega$ ad $\eta$ are different). Then, for $\ell=2,3, \cdots$, we have

$$
\begin{equation*}
0 \leq \Sigma\left(\omega \eta^{\ell+2}\right)-2 \Sigma\left(\omega \eta^{\ell+1}\right)+\Sigma\left(\omega \eta^{\ell}\right)-2 k^{2} \ell<2 k^{4}+3 k . \tag{2.2}
\end{equation*}
$$

Proof Put $\sigma=\omega \eta^{\ell}$. Denote

$$
\begin{aligned}
\Sigma\left(\sigma \eta^{2}\right)-2 \Sigma(\sigma \eta)+\Sigma(\sigma)= & \sum_{\substack{\xi \in\{0,1\}^{+} ; \\
\xi<\eta^{\ell+2},|\xi| \geq k}}\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2} \\
& +\sum_{\substack{\xi \in\{0,1\}^{+} ; \\
\xi \prec \eta^{+2},|\xi|<k}}\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2} \\
& +\sum_{\substack{\xi \in\{0,1\}^{+} ; \\
\xi \nless \eta^{\ell+2}}}\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2} \\
= & : S_{1}+S_{2}+S_{3} .
\end{aligned}
$$

Let $\xi \prec \eta^{\ell+1}$ with $|\xi| \geq k$. Since $\eta$ is prime, if $\xi \prec_{i} \eta^{\ell+1}$, then $\xi \prec_{j}$ $\eta^{\ell+1}$ holds if and only if $i \equiv j(\bmod k)$ and $j+|\xi| \leq\left|\eta^{\ell+1}\right|$. Therefore, $|\sigma \eta|_{\xi}-|\sigma|_{\xi}=|\sigma \eta|_{\xi, k}=1$. Hence, $|\sigma \eta|_{\xi}^{2}-|\sigma|_{\xi}^{2}=2|\sigma|_{\xi}+1$. In the same way, $\left|\sigma \eta^{2}\right|_{\xi}^{2}-|\sigma \eta|_{\xi}^{2}=2|\sigma \eta|_{\xi}+1$. Thus,

$$
\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2}=2\left(|\sigma \eta|_{\xi}-|\sigma|_{\xi}\right)=2 .
$$

If $\xi \prec \eta^{\ell+2}$ but not $\xi \prec \eta^{\ell+1}$, then by the assumptions that $\left|\omega \eta^{\ell}\right|_{\eta^{\ell}}=1, \eta$ is prime and $\omega_{n} \neq \eta_{k},\left|\sigma \eta^{2}\right|_{\xi}=1$ and $|\sigma \eta|_{\xi}=|\sigma|_{\xi}=0$ hold. Hence,

$$
\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2}=1
$$

Therefore,

$$
S_{1}=2((\ell k+1)+\ell k+\cdots+(\ell k-k+2))+k^{2}=2 k^{2} \ell+3 k,
$$

since the number of $\xi \prec \eta^{\ell+1}$ with $|\xi| \geq k$ is equal to the number of the pairs of positions $(i, j) \in\{1,2, \cdots,(\ell+1) k\}^{2}$ in $\eta^{\ell+1}$ with $1 \leq i \leq k$ and $j-i \geq k$. Also, the number of $\xi$ with $\xi \nprec \eta^{\ell+1}$ and $\xi \prec \eta^{\ell+2}$ is equal to the number of the pairs of positions $(i, j) \in\{1,2, \cdots,(\ell+2) k\}^{2}$ in $\eta^{\ell+2}$ with $1 \leq i \leq k$ and $(\ell+1) k+1 \leq j \leq(\ell+2) k$.

Let $\xi \prec \eta^{l+2}$ with $|\xi|<k$. Then, $1 \leq|\sigma|_{\xi, k}=|\sigma \eta|_{\xi, k}=\left|\sigma \eta^{2}\right|_{\xi, k} \leq k$ and $\left|\sigma \eta^{2}\right|_{\xi}-|\sigma \eta|_{\xi}=|\sigma \eta|_{\xi}-|\sigma|_{\xi}=|\sigma|_{\xi, k}$. Hence,

$$
\begin{aligned}
\left|\sigma \eta^{2}\right|_{\xi}^{2}-2|\sigma \eta|_{\xi}^{2}+|\sigma|_{\xi}^{2} & =\left(\left|\sigma \eta^{2}\right|_{\xi}^{2}-|\sigma \eta|_{\xi}^{2}\right)-\left(|\sigma \eta|_{\xi}^{2}-|\sigma|_{\xi}^{2}\right) \\
& =\left(2|\sigma \eta|_{\xi}\left|\sigma \eta^{2}\right|_{\xi, k}+|\sigma \eta|_{\xi, k}^{2}\right)-\left(2|\sigma|_{\xi}|\sigma \eta|_{\xi, k}+|\sigma|_{\xi, k}^{2}\right) \\
& =2\left(|\sigma \eta|_{\xi}-|\sigma|_{\xi}\right)|\sigma|_{\xi, k}=2|\sigma|_{\xi, k}^{2} .
\end{aligned}
$$

Therefore, $0 \leq S_{2}<2 k^{4}$.
If $\xi \prec \sigma$ with $\xi \nprec \eta^{\ell+2}$, then it holds that $|\sigma|_{\xi}=|\sigma \eta|_{\xi}$ since $|\sigma \eta|_{\xi, k}=0$ by the assumptions that $\left|\omega \eta^{\ell}\right|_{\eta^{\ell}}=1, \eta$ is prime and $\omega_{n} \neq \eta_{k}$. If $\xi \nprec \sigma, \xi \prec \sigma \eta$ and $\xi \nprec \eta^{\ell+2}$, then we have $|\sigma|_{\xi}=0$ and $|\sigma \eta|_{\xi}=1$. Hence,

$$
\sum_{\substack{\xi \in\{0,1\}^{+} \\ \xi \nprec \eta^{l+2}}}\left(|\sigma \eta|_{\xi}^{2}-|\sigma|_{\xi}^{2}\right)=\#\left\{\xi \in\{0,1\}^{+} ; \xi \nprec \eta^{l+2}, \xi \prec \sigma \eta, \xi \nprec \sigma\right\}=k n
$$

In the same way, we have

$$
\sum_{\substack{\xi \in\{0,1\}^{+} ; \\ \xi \nprec \eta^{\ell+2}}}\left(\left|\sigma \eta^{2}\right|_{\xi}^{2}-|\sigma \eta|_{\xi}^{2}\right)=k n .
$$

Therefore, we have $S_{3}=0$.
Thus, we have

$$
0 \leq \Sigma\left(\sigma \eta^{2}\right)-2 \Sigma(\sigma \eta)+\Sigma(\sigma)-2 k^{2} \ell<2 k^{4}+3 k
$$

Lemma 5. Assume that

$$
\limsup _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0
$$

Then, there exists a prime $\eta \in\{0,1\}^{+}$and $0 \leq \ell_{1} \leq \ell_{2} \leq \cdots$ such that

$$
\eta^{\ell_{n}} \prec x_{1} x_{2} \cdots x_{n} \quad \text { and } \quad \limsup _{n \rightarrow \infty} \frac{\ell_{n}}{n}>0 \text {. }
$$

Proof By Lemma 2, we have

$$
\limsup _{n \rightarrow \infty} \frac{\Lambda\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}>0
$$

Hence, there exist $\eta_{n} \in\{0,1\}^{+}$and $h_{n}$ for any sufficiently large $n$ with $\eta_{n}{ }^{h_{n}} \prec x_{1} x_{2} \cdots x_{n}$ such that

$$
\limsup _{n \rightarrow \infty} \frac{\left|\eta_{n}\right|^{2} h_{n}^{3}}{n^{3}} \geq \limsup _{n \rightarrow \infty} \frac{\left|\eta_{n}\right|^{2}\left(h_{n}+1\right)^{3}}{8 n^{3}}>0
$$

Since $\left|\eta_{n}\right|^{2} h_{n}^{3} / n^{3} \leq 1 /\left|\eta_{n}\right|, \liminf _{n \rightarrow \infty}\left|\eta_{n}\right|<\infty$. Therefore, there exist $\eta \in\{0,1\}^{+}$and $0 \leq \ell_{1} \leq \ell_{2} \leq \cdots$ such that $\eta^{\ell_{n}} \prec x_{1} x_{2} \cdots x_{n}$ and

$$
\limsup _{n \rightarrow \infty} \frac{\ell_{n}}{n}=\frac{1}{|\eta|^{2 / 3}}\left(\limsup _{n \rightarrow \infty} \frac{|\eta|^{2} \ell_{n}^{3}}{n^{3}}\right)^{1 / 3}>0
$$

If $\eta$ is not prime and $\eta=\xi^{p}$ with a prime $\xi$, we may replace $\eta$ by $\xi$ and $\ell_{n}$ by $p \ell_{n}$.

## 3 Main results

Theorem 1. If $x=x_{1} x_{2} \cdots$ is eventually periodic with the minimal period $k$. Then, it holds that

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{n}\right)}{n^{3}}=\frac{1}{3 k} .
$$

Proof Let $\eta \in\{0,1\}^{k}$ be prime with $k \geq 1$. Let $x=\zeta \eta^{\infty}$ with $\zeta \in$ $\{0,1\}^{+} \cup\{\emptyset\}$, where $\emptyset$ is the empty word. Let $|\zeta|=h$. Then, for any $\xi \in\{0,1\}^{+}$with $|\xi|=\ell$, we have

$$
0 \leq\left|\zeta \eta^{n}\right|_{\xi}-\left|\eta^{n}\right|_{\xi} \leq h
$$

Hence,

$$
0 \leq\left|\zeta \eta^{n}\right|_{\xi}^{2}-\left|\eta^{n}\right|_{\xi}^{2} \leq h\left(\left|\zeta \eta^{n}\right|_{\xi}+\left|\eta^{n}\right|_{\xi}\right)
$$

Therefore,

$$
0 \leq \sum_{\xi \in\{0,1\}^{\ell}}\left|\zeta \eta^{n}\right|_{\xi}^{2}-\sum_{\xi \in\{0,1\}^{\ell}}\left|\eta^{n}\right|_{\xi}^{2} \leq h((h+k n-\ell+1)+(k n-\ell+1))
$$

for any $\ell$ with $1 \leq \ell \leq k n$,

$$
0 \leq \sum_{\xi \in\{0,1\}^{\ell}}\left|\zeta \eta^{n}\right|_{\xi}^{2}-\sum_{\xi \in\{0,1\}^{\ell}}\left|\eta^{n}\right|_{\xi}^{2} \leq h(h+k n-\ell+1)
$$

for any $\ell$ with $k n+1 \leq \ell \leq h+k n$, and

$$
\sum_{\xi \in\{0,1\}^{\ell}}\left|\zeta \eta^{n}\right|_{\xi}^{2}-\sum_{\xi \in\{0,1\}^{\ell}}\left|\eta^{n}\right|_{\xi}^{2}=0
$$

otherwise. Hence,

$$
0 \leq \Sigma\left(\zeta \eta^{n}\right)-\Sigma\left(\eta^{n}\right) \leq h(h+k n)(h+k n+1) .
$$

Thus,

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(\zeta \eta^{n}\right)}{n^{3}}=\lim _{n \rightarrow \infty} \frac{\Sigma\left(\eta^{n}\right)}{n^{3}}
$$

holds in the sense that if the limit exists in one side, then the limit exists in the other side, and they coincides. Now, we prove that

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(\eta^{n}\right)}{n^{3}}=\frac{k^{2}}{3},
$$

which will complete the proof.
Assume that $|\xi| \geq k$ and $\xi \prec_{i} \eta^{n}$. Since $\eta$ is prime, $\xi \prec_{j} \eta^{n}$ holds if and only if $i \equiv j(\bmod k)$ and $0 \leq j \leq\left|\eta^{n}\right|-|\xi|$. Hence, for $\xi \prec \eta^{n}$ such that $|\xi| \geq k$, we have

$$
-1 \leq\left|\eta^{n}\right|_{\xi}-(n-|\xi| / k) \leq 1
$$

Therefore, it holds that

$$
\begin{aligned}
& \left.\sum_{\xi \in\{0,1\}^{+} ; ; \xi \prec \eta^{n},|\xi| \geq k}\left|\eta^{n}\right|_{\xi}^{2}-\sum_{\xi \in\{0,1\}^{+} ; \xi \prec \eta^{n},|\xi| \geq k}\left(n-\frac{|\xi|}{k}\right)^{2} \right\rvert\, \\
& \left.=\sum_{\xi \in\{0,1\}^{+} ; ; \xi \prec \eta^{n},|\xi| \geq k}\left(\left|\eta^{n}\right|_{\xi}-\left(n-\frac{|\xi|}{k}\right)\right)\left(\left|\eta^{n}\right| \xi+\left(n-\frac{|\xi|}{k}\right)\right) \right\rvert\, \\
& \leq \sum_{\xi \in\{0,1\}^{+} ; \xi<\eta^{n},|\xi| \geq k}\left(\left|\eta^{n}\right| \xi+\left(n-\frac{|\xi|}{k}\right)\right) \\
& \leq \sum_{\xi \in\{0,1\}^{+} ; \xi \prec \eta^{n},|\xi| \geq k}\left(2\left|\eta^{n}\right| \xi+1\right) \leq 2(k n)^{2}+k(k n) \leq 3(k n)^{2}
\end{aligned}
$$

On the other hand, if $\xi \prec \eta^{n}$ and $|\xi|<k$, then we have $1 \leq\left|\eta^{n}\right|_{\xi} \leq k n$ and there are at most $k^{2}$ number of $\xi$ as this. Therefore,

$$
0 \leq \Sigma\left(\eta^{n}\right)-\sum_{\xi \in\{0,1\}+;}\left|\xi \prec \eta^{n},|\xi| \geq k<\eta^{n}\right|_{\xi}^{2} \leq k^{2}(k n)^{2} .
$$

Thus,

$$
\lim _{n \rightarrow \infty} \frac{\Sigma\left(\eta^{n}\right)}{n^{3}}=\lim _{n \rightarrow \infty} \frac{1}{n^{3}} \sum_{\xi \in\{0,1\}^{+} ;} \sum_{\xi \prec \eta^{n},|\xi| \geq k}\left(n-\frac{|\xi|}{k}\right)^{2} .
$$

Here, $\xi$ as above corresdopnds to the pair $(i, j)$, where $i$ is the smallest $i$ such that $\xi \prec_{i-1} \eta^{n}$ and $|\xi|=j$. This correspondence gives an bijection between the set of $\xi$ as above and the set

$$
\{(i, j) \in\{1,2, \cdots, k\} \times\{k, k+1, \cdots, k n\} ; i+j-1 \leq k n\} .
$$

Hence, we have

$$
\begin{aligned}
\lim _{n \rightarrow \infty} \frac{\Sigma\left(\eta^{n}\right)}{n^{3}} & =\lim _{n \rightarrow \infty} \frac{1}{n^{3}} \sum_{\xi \in\{0,1\}+; \xi \nless \eta^{n},|\xi| \geq k}\left(n-\frac{|\xi|}{k}\right)^{2} \\
& =\lim _{n \rightarrow \infty} \frac{1}{n^{3}} \sum_{(i, j) \in\{1,2, \cdots, k\} \times\{k, k+1, \cdots, k n\}, i+j-1 \leq k n}\left(n-\frac{j}{k}\right)^{2} \\
& =\lim _{n \rightarrow \infty} \frac{k}{n^{3}} \sum_{j \in\{k, k+1, \cdots, k n\}}\left(n-\frac{j}{k}\right)^{2} \\
& =k^{2} \lim _{n \rightarrow \infty} \sum_{j \in\{1,2, \cdots, k n\}}\left(1-\frac{j}{k n}\right)^{2} \frac{1}{k n} \\
& =k^{2} \int_{0}^{1}(1-x)^{2} d x=\frac{k^{2}}{3} .
\end{aligned}
$$

Theorem 2. It holds that $x_{1} x_{2} \cdots$ is eventually periodic if and only if $\lim _{n \rightarrow \infty} \Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ exists and take a positive value.
Proof The "only if" part is proved in Theorem 1. Let us prove the "if" part.

Suppose that $\lim _{n \rightarrow \infty} \Sigma\left(x_{1} x_{2} \cdots x_{n}\right) / n^{3}$ exists and takes a positive value, but $x_{1} x_{2} \cdots$ is not eventually periodic.

By Lemma 5 , there exist $k \geq 1, \eta=a_{1} a_{2} \cdots a_{k} \in\{0,1\}^{k}$ and $0 \leq \ell_{1} \leq$ $l_{2} \leq \cdots$ such that

$$
\eta^{\ell_{n}} \prec x_{1} x_{2} \cdots x_{n} \text { and } A:=\limsup _{n \rightarrow \infty} \frac{\ell_{n}}{n}>0 .
$$

Here, we may also assume that $\eta$ is prime.
Take a subsequence $\{N\}$ of $\{1,2, \cdots\}$ and replace $\eta$ by $a_{i} \cdots a_{k} a_{1} \cdots a_{i-1}$ for some $i$ with $1 \leq i \leq k$ if necessary, we may assume that $\eta^{\ell_{N}}$ is a suffix of $x_{1} x_{2} \cdots x_{N}$ and $x_{N-k \ell_{N}} \neq a_{k}$. Since $x_{1} x_{2} \cdots$ is not eventually periodic, we may also assume that $N-k \ell_{N} \rightarrow \infty$ as $N \rightarrow \infty$. Note that $k A \leq 1$.
Take $\delta>0$ with $1-k A<\delta<1$. Take $\epsilon$ with $0<\epsilon<1 / 2$ such that $(1-k A(1-\epsilon))(1+\epsilon) /(1-\epsilon)<\delta<1$. Take a sufficiently large $N$ such that $\delta \ell_{N} \geq 2$ and $\ell_{N} / N>A(1-\epsilon)$ together with other requirements specified later.

We assume that $N-k \ell_{N}$ is sufficiently large. Denote $n=N-k \ell_{N}$ and $\omega=x_{1} x_{2} \cdots x_{n}$. Then, $x_{n} \neq a_{k}$. Since $n$ is sufficiently large, we may assume that $\ell_{n} / n<A(1+\epsilon)$. Hence,

$$
\begin{aligned}
\ell_{n} & <A(1+\epsilon) n=A(1+\epsilon)\left(N-k \ell_{N}\right) \\
& <A(1+\epsilon)(N-k A N(1-\epsilon))=(1+\epsilon)(1-k A(1-\epsilon)) A N \\
& <(1+\epsilon)(1-k A(1-\epsilon)) \frac{\ell_{N}}{1-\epsilon}<\delta \ell_{N} .
\end{aligned}
$$

Take integers $\ell$ and $\ell^{\prime}$ as functions of $N$ such that
(1) $\delta^{-1} \ell_{n}<\ell<\ell+2 \ell^{\prime}<\ell_{N}$ and
(2) $\ell / n$ and $\ell^{\prime} / n$ are bounded away both from 0 and $\infty$.

Since $x_{n} \neq a_{k}$ and $\eta$ is prime, $\left|x \eta^{\ell}\right|_{\eta^{\ell}} \geq 2$ is possible only if $|x \eta|_{\eta^{\ell}} \geq 1$, and hence, only if $|x|_{\eta^{\ell-1}} \geq 1$. This is impossible since $\ell_{n}<\delta \ell<\ell-1$ as $\delta<1$ and $N$ is sufficiently large. Thus, the assumptions in Lemma 4 are satisfied.

Adding (2.2) for $m=k \ell, k(\ell+1), \cdots, k\left(\ell+\ell^{\prime}-1\right)$, we have

$$
\begin{align*}
& \Sigma\left(\omega \eta^{\ell+\ell^{\prime}+1}\right)-\Sigma\left(\omega \eta^{\ell+\ell^{\prime}}\right)-\Sigma\left(\omega \eta^{\ell+1}\right)+\Sigma\left(\omega \eta^{\ell}\right) \\
& =2 k^{2}\left(\ell+(\ell+1)+\cdots+\left(\ell+\ell^{\prime}-1\right)\right)+\ell^{\prime} R  \tag{3.1}\\
& =k^{2} \ell^{\prime}\left(2 \ell+\ell^{\prime}-1\right)+\ell^{\prime} R
\end{align*}
$$

for some $R$ with $0 \leq R<2 k^{4}+3 k$.
We further add (3.1) for the pairs $\left(\ell, \ell^{\prime}\right),\left(\ell+1, \ell^{\prime}\right), \cdots,\left(\ell+\ell^{\prime}-1, \ell^{\prime}\right)$ in place of $\left(\ell, \ell^{\prime}\right)$, we get

$$
\begin{align*}
\Sigma\left(\omega \eta^{\ell+2 \ell^{\prime}}\right)-2 \Sigma\left(\omega \eta^{\ell+\ell^{\prime}}\right)+\Sigma\left(\omega \eta^{\ell}\right) & =\sum_{i=l}^{\ell+\ell^{\prime}-1}\left(k^{2} \ell^{\prime}\left(2 i+\ell^{\prime}-1\right)+\ell^{\prime} R_{i}\right)  \tag{3.2}\\
& =2 k^{2} \ell^{\prime 2}\left(\ell+\ell^{\prime}-1\right)+\ell^{\prime 2} \bar{R}
\end{align*}
$$

with some $\bar{R}, 0 \leq \bar{R}<2 k^{4}+3 k$.
Taking a subsequence $\left\{n^{\prime}\right\}$ of $\{n\}$ if necessary and denoting $\left\{n^{\prime}\right\}$ by $\{n\}$, we may assume that $\lim _{n \rightarrow \infty} k \ell / n=\alpha>0$ and $\lim _{n \rightarrow \infty} k \ell^{\prime} / n=\beta>0$. By the assumption

$$
L:=\lim _{h \rightarrow \infty} \frac{\Sigma\left(x_{1} x_{2} \cdots x_{h}\right)}{h^{3}}>0
$$

holds for $h=n+k\left(\ell+2 \ell^{\prime}\right), h=n+k\left(\ell+\ell^{\prime}\right)$ and $h=n+k \ell$. Dividing (3.2) by $n^{3}$ and letting $n \rightarrow \infty$, we have

$$
L(1+\alpha+2 \beta)^{3}-2 L(1+\alpha+\beta)^{3}+L(1+\alpha)^{3}=\frac{2 \alpha \beta^{2}}{k}+\frac{2 \beta^{3}}{k} .
$$

Since $\ell, \ell^{\prime}$ can be arbitrary satisfying (1), (2) above, this should holds for any $\alpha, \beta>0$ with $\alpha+2 \beta<A(1-\epsilon)$, which is impossible since the lefthand side is $6 L\left((1+\alpha) \beta^{2}+\beta^{3}\right)$ and has a term of $\beta^{2}$ which righthand side hasn't.
