# Energy-momentum relation for solitary waves of nonlinear Dirac equations

#### Abstract

Solitary waves of nonlinear Dirac, Maxwell-Dirac and Klein-Gordon-Dirac equations are considered. We prove that the energy-momentum relation for solitary waves coincides with the Einstein energy-momentum relation for point particles.

## 1 Introduction

The paper concerns the old problem of mathematically describing elementary particles in field theory. Einstein and Grommer [13] suggested that particles could be described as singularities of solutions to the field equations. The generalization of this result to interacting systems of particles was given by Einstein, Infeld and Hoffmann [14]. Rosen [27] was the first who proposed a description of particles for the coupled Klein-Gordon-Maxwell equations, which are invariant with respect to the Lorentz group. Namely, the particle at rest is described by a finite energy solution that has "Schrödinger's" form $\varphi(x) e^{-i \omega t}$ ("nonlinear eigenfunctions" or "solitary waves"). The particle with the nonzero velocity $v,|v|<1$, is obtained by the corresponding Lorentz (or Poincaré) transformation. Since the work of Rosen some authors have considered the interaction of classical fields, looking for localized solutions could be used as models of extended particles.

The existence of solitary waves has been analyzed by many authors for diverse Lagrangian field theories [15, 22, 26, 27, 31, 34, such that nonlinear Dirac fields, the Maxwell-Dirac (MD) and Klein-Gordon-Dirac (KGD) equations. We describe briefly some results.

Nonlinear Dirac equations occur in the attempt to construct relativistic models of extended particles by means of nonlinear Dirac fields. The review of such models can be found in [25]. The stationary solutions of nonlinear Dirac equation were extensively studied in the literature used variational methods [17] and a dynamical systems approach [6, 23, 2]. For details, see the survey papers [18, 16, 25] and the references therein.

The (MD) equations (see, e.g., [4, 30]) describing the interaction of an electron with its own electromagnetic field have been widely studied by many authors. The first results on the local existence and uniqueness of solutions was obtained by Gross [19], Chadam [7], Chadam and Glassey [9]. The stationary (localized) solutions of the classical (MD) system were studied numerically by Wakano [34] and Lisi [22]. Using variational methods, Esteban, Georgiev and Séré [15] have proved the existence of stationary solutions with $\omega \in(-m, 0)$. These results were extended by Abenda [1] for $\omega \in(-m, m)$.

For the (KGD) equations, the local existence and uniqueness of solutions were proved by Chadam and Glassey [8]. Numerical results on the stationary states were obtained by Ranada and Vazquez in [26]. The rigorous proof of the existence for the stationary solutions was given by Esteban et al. [15]. For some Lorentz invariant complex scalar fields theories, the particle-like solutions was studied by Rosen [28, 29].

Note that it would be of importance to develop a particle-like dynamics for moving solitons. We make a step in this direction for relativistic-invariant nonlinear Dirac, (MD) and (KGD) equations. Namely, we prove that the energy-momentum relation coincides with that of a relativistic particle.

Now we outline the main result in the case of nonlinear Dirac equations. We consider the Dirac equations of the form

\end{equation*}

We use natural units, in which we have rescaled length and time so that $\hbar=c=1$. Here unknown function $\psi \equiv \psi(t, x): \mathbb{R} \times \mathbb{R}^{3} \rightarrow \mathbb{C}^{4}$ is four-component Dirac spinor field, $m>0$, $\dot{\psi}=\partial_{t} \psi, x=\left(x_{1}, x_{2}, x_{3}\right), \nabla=\left(\partial_{1}, \partial_{2}, \partial_{3}\right), \partial_{k}=\partial /\left(\partial x_{k}\right), k=1,2,3, \alpha=\left(\alpha_{1}, \alpha_{2}, \alpha_{3}\right) . \alpha_{k}, \beta$ are the $4 \times 4$ complex Pauli-Dirac matrices (in the standard $2 \times 2$ blocks representation)

where $I$ denotes the $2 \times 2$ unit matrix, and $\sigma_{k}$ are Pauli matrices defined as

One verifies that $\sigma_{k} \sigma_{l}+\sigma_{l} \sigma_{k}=2 \delta_{k l} I, \sigma_{k}^{*}=\sigma_{k}, k=1,2,3$. Then

\beta^{*}=\beta, \quad \alpha_{k}^{*}=\alpha_{k}, \quad \alpha_{k}^{2}=\beta^{2}=I, \quad \alpha_{k} \alpha_{j}+\alpha_{j} \alpha_{k}=0 \quad \text { for } j \neq k, \quad \alpha_{k} \beta+\beta \alpha_{k}=0 \tag{1.2}
\end{equation*}

Let us fix the following notations. Given two vectors of $\mathbb{C}^{4}, \psi \phi:=\psi \cdot \phi$ is the inner product in $\mathbb{C}^{4}, *$ denotes the complex conjugate. By definition, the "adjoint spinor" is $\bar{\psi}=\psi^{*} \beta$.

The particular nonlinearity $g(s)=\lambda s$ corresponds to the so-called Soler model of extended fermions [31, [2]. In the general case of $g(s)$, Eqn (1.1) is often called the generalized Soler model (see [4, 17]).

The stationary solutions of nonlinear Dirac equation are considered as particle-like solutions. They are the solutions of a form $\psi_{0}(t, x)=e^{-i \omega t} \varphi(x)$, where $\varphi$ is non-zero localized solution of the stationary nonlinear Dirac equation (2.1), see Definition 2.1 below.

Denote by $\psi_{\mathbf{v}}(t, x)$ the moving solitary waves with velocity $\mathbf{v} \in \mathbb{R}^{3},|\mathbf{v}|<1$,

\psi_{\mathbf{v}}(t, x)=S\left(\Lambda_{\mathbf{v}}\right) \psi_{0}\left(\Lambda_{\mathbf{v}}^{-1}(t, x)\right), \quad x \in \mathbb{R}^{3}, \quad t \in \mathbb{R}
$$

where $\Lambda_{\mathbf{v}}$ is a Lorentz transformation (see formula (3.5) below), $S\left(\Lambda_{\mathbf{v}}\right)$ is a matrix defined in (3.6). Put $G(s)=\int_{0}^{s} g(p) d p$. The energy functional is given by

\mathcal{E}(\psi)=\int_{\mathbb{R}^{3}}\left(-i \psi^{*} \alpha \cdot \nabla \psi+m \bar{\psi} \psi-G(\bar{\psi} \psi)\right) d x \tag{1.3}
\end{equation*}
$$

Using equalities (1.2), it is easily to check that $\mathcal{E}(\psi(t, \cdot))=$ const.
Our main objective is to prove that the energy-momentum relation coincides with one of relativistic point particle, namely,

\mathcal{E}\left(\psi_{\mathbf{v}}\right)=\gamma \mathcal{E}\left(\psi_{0}\right), \quad \gamma=\left(1-|\mathbf{v}|^{2}\right)^{-1 / 2} \tag{1.4}
\end{equation*}
$$

The paper is organized as follows. In Sections 2 and 3, we check (1.4) for nonlinear Dirac equations (1.1). Section 4 concerns the Dirac equations in $\mathbb{R}^{1}$. For (MD) and (KGD) equations, the result is obtained in Sections 5 and 6, respectively.

## 2 Standing solitary waves for Dirac equations

Definition 2.1 The stationary states or localized solutions of Eqn (1.1) are the solutions of the form $\psi_{0}(t, x)=e^{-i \omega t} \varphi_{\omega}(x), \omega \in \mathbb{R}$, such that $\varphi_{\omega} \in H^{1}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$, and $\varphi \equiv \varphi_{\omega}$ is a nonzero localized solution of the following stationary nonlinear Dirac equation

\begin{equation*}
i \alpha \cdot \nabla \varphi+\omega \varphi-m \beta \varphi+g(\bar{\varphi} \varphi) \beta \varphi=0, \quad x \in \mathbb{R}^{3} . \tag{2.1}
\end{equation*}
$$

The existence of solutions of Eqn (2.1) has been proved in [2, 3, 6, 17, 23] under some restrictions on $G$ for $\omega \in(0, m)$. In [17], the following conditions were imposed.
G1. $G \in C^{2}(\mathbb{R} ; \mathbb{R})$
G2. For any $s \in \mathbb{R}, g(s) s \geq \theta G(s)$ with some $\theta>1,\left(g(s)=G^{\prime}(s)\right)$
G3. $G(0)=G^{\prime}(0)=0$
G4. $G(s) \geq 0$ for any $s \in \mathbb{R}$, and $G\left(A_{0}\right)>0$ for some $A_{0}>0$.

Theorem 2.2 (see [17, Theorem 1]) Let conditions G1-G4 hold and $\omega \in(0, m)$. Then there is an infinity of solutions of Eqn (2.1) in $\bigcap_{2 \leq q<\infty} W^{1, q}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$. Each of them are critical points of the functional $I_{D}^{\omega}, I_{D}^{\omega}(\varphi)=-\frac{1}{2} \int_{\mathbb{R}^{3}}\left(i \varphi^{*} \alpha \cdot \nabla \varphi-m \bar{\varphi} \varphi+\omega|\varphi|^{2}+G(\bar{\varphi} \varphi)\right) d x$. These solutions $\varphi \equiv \varphi_{\omega}$ are of the form (in the spherical coordinates $(r, \phi, \theta)$ of $x \in \mathbb{R}^{3}$ )

\varphi_{\omega}(x)=\binom{v(r)\binom{1}{0}}{i u(r)\binom{\cos \theta}{\sin \theta e^{i \phi}}}, \begin{align*}
& x_{1}=r \cos \phi \sin \theta  \tag{2.2}\\
& x_{2}=r \sin \phi \sin \theta \\
& x_{3}=r \cos \theta, r=|x| .
\end{align*}
$$

Thus they correspond to classical solutions of the O.D.E. system

$$
\left\{\begin{array}{l}
u^{\prime}+\frac{2 u}{r}=v\left[g\left(v^{2}-u^{2}\right)-(m-\omega)\right], \\
v^{\prime}=u\left[g\left(v^{2}-u^{2}\right)-(m+\omega)\right] .
\end{array}\right.
$$

Finally, the solutions decrease exponentially at infinity, together with their first derivatives.
Remarks 2.3 (i) Denote by $\mathcal{L}_{D}$ the Lagrangian density for considered Dirac fields,

\mathcal{L}_{D}(\psi)=\bar{\psi}\left(i \gamma^{\mu} \partial_{\mu}-m\right) \psi+G(\bar{\psi} \psi) \tag{2.3}
\end{equation*}
$$

where $\gamma^{\mu} \partial_{\mu}=\gamma^{0} \partial_{t}+\gamma \cdot \nabla$ with Dirac matrices $\gamma^{\mu}\left(\gamma^{0}=\beta, \gamma^{k}=\beta \alpha_{k}, k=1,2,3\right)$. It is easy to check that the Euler-Lagrange equations applied to (2.3) give Eqn (1.1). In particular, for stationary solutions $\psi_{0}(t, x), \mathcal{L}_{D}\left(\psi_{0}\right)=\varphi^{*}(\omega+i \alpha \cdot \nabla-m \beta) \varphi+G(\bar{\varphi} \varphi)$. Note that $I_{D}^{\omega}(\varphi)=$ $-(1 / 2) \int \mathcal{L}_{D}\left(\psi_{0}\right) d x$. Here and below, for simplicity, we omit the symbol $\mathbb{R}^{3}$ in the notation of the integral $\int_{\mathbb{R}^{3}} \ldots d x$.
(ii) In [3), the existence of solutions of the form (2.2) have been proved for singular selfinteractions $g(s) \sim s^{-\alpha}$ with some $\alpha \in(0,1)$.
(iii) The stationary nonlinear Dirac equations of the form

$$
\begin{equation*}
i \alpha \cdot \nabla \varphi+\omega \varphi-m \beta \varphi+\nabla F(\varphi)=0, \quad x \in \mathbb{R}^{3} \tag{2.4}
\end{equation*}
$$

has been studied by Esteban and Séré in [17]. For a more general class of nonlinearities $F$, which do not satisfy condition $F(\varphi)=G(\bar{\varphi} \varphi)$, the ansatz (2.2) is no more valid. In this case, the existence of solutions of (2.4) has been proved in [17, Theorems 2,3] with nonlinearities as (1) $F(\varphi)=\lambda\left(|\bar{\varphi} \varphi|^{\kappa_{1}}+b\left|\bar{\varphi} \gamma^{5} \varphi\right|^{\kappa_{2}}\right)$ with $1<\kappa_{1}, \kappa_{2}<3 / 2, \gamma^{5}=-i \alpha_{1} \alpha_{2} \alpha_{3}, \lambda, b>0$; and (2) $F^{\prime}(0)=F^{\prime \prime}(0)=0,0 \leq F(\varphi) \leq a\left(|\bar{\varphi}|^{\kappa_{3}}+|\varphi|^{\kappa_{4}}\right)$ with $a>0,2<\kappa_{3} \leq \kappa_{4}<3$.

The following virial identity (or so-called Pokhozhaev identity [24]) was proved in [17, Proposition 3.1].

Lemma 2.4 Let $\varphi \in H^{1}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$ be a solution to Eqn (2.1). Then $\varphi(x)$ satisfies

i \int \varphi^{*} \alpha \cdot \nabla \varphi d x=\frac{3}{2} \int\left(m \bar{\varphi} \varphi-\omega \varphi^{*} \varphi-G(\bar{\varphi} \varphi)\right) d x \tag{2.5}
\end{equation*}
$$

Introduce the following notations

$$

I_{k} & \equiv I_{k}(\varphi)=-i \int \varphi^{*} \alpha_{k} \partial_{k} \varphi d y, \quad k=1,2,3 \\
Q & \equiv Q(\varphi)=\int \varphi^{*} \varphi d x, \quad V \equiv V(\varphi)=\int(m \bar{\varphi} \varphi-G(\bar{\varphi} \varphi)) d x \tag{2.6}
\end{align*}
$$

Then the equality (2.5) is rewritten as

\omega Q=V+\frac{2}{3}\left(I_{1}+I_{2}+I_{3}\right) \tag{2.7}
\end{equation*}

Remark 2.5 Formally, the identity (2.5) can be proved used Derrick's technique [10, p.1253]. Indeed, introducing $\varphi_{\lambda}(x)=\varphi(x / \lambda)$ gives

0 & =\left.\frac{d}{d \lambda}\right|_{\lambda=1} I_{D}^{\omega}\left(\varphi_{\lambda}\right)=\left.\frac{1}{2} \frac{d}{d \lambda}\right|_{\lambda=1}\left[I_{1}\left(\varphi_{\lambda}\right)+I_{2}\left(\varphi_{\lambda}\right)+I_{3}\left(\varphi_{\lambda}\right)+V\left(\varphi_{\lambda}\right)-\omega Q\left(\varphi_{\lambda}\right)\right] \\
& =\left.\frac{1}{2} \frac{d}{d \lambda}\right|_{\lambda=1}\left[\lambda^{2} I_{1}(\varphi)+\lambda^{2} I_{2}(\varphi)+\lambda^{2} I_{3}(\varphi)+\lambda^{3} V(\varphi)-\lambda^{3} \omega Q(\varphi)\right] \\
& =I_{1}(\varphi)+I_{2}(\varphi)+I_{3}(\varphi)+\frac{3}{2}(V-\omega Q)
\end{aligned}
$$

This gives the identity (2.5). The similar Derrick's technique has been used in [11 for relativistic -invariant nonlinear wave equations.

Using the similar reasonings with $\varphi_{\lambda}(x)=\varphi\left(x_{1} / \lambda, x_{2}, x_{3}\right), \varphi_{\lambda}(x)=\varphi\left(x_{1}, x_{2} / \lambda, x_{3}\right), \varphi_{\lambda}(x)=$ $\varphi\left(x_{1}, x_{2}, x_{3} / \lambda\right)$, it is easy to check that

I_{1}=I_{2}=I_{3}=\frac{1}{3}\left(I_{1}+I_{3}+I_{3}\right)=\frac{1}{2}(\omega Q-V) \tag{2.8}
\end{equation*}
$$

Corollary 2.6 Let $\varphi$ be a solution of (2.1). Then the following relations hold.

I_{1}+I_{2}+I_{3} & =\omega Q+\int(g(\bar{\varphi} \varphi)-m) \bar{\varphi} \varphi d x  \tag{2.9}\\
I_{1}+I_{2}+I_{3} & =\left.3 \int(g(s) s-G(s))\right|_{s=\bar{\varphi} \varphi} d x>0  \tag{2.10}\\
\mathcal{E}_{0} & \equiv I_{1}+I_{2}+I_{3}+V>0 \tag{2.11}
\end{align*}
$$

Proof By (2.1), we have

$$
\int \varphi^{*} i \alpha \cdot \nabla \varphi d x=\int \varphi^{*}(-\omega \varphi+m \beta \varphi-g(\bar{\varphi} \varphi) \beta \varphi) d x .
$$

This implies the identity (2.9). Then, by (2.7) and (2.9), we obtain

\omega Q=V+\frac{2}{3}\left(I_{1}+I_{2}+I_{3}\right)=\int(m-g(\bar{\varphi} \varphi)) \bar{\varphi} \varphi d x+I_{1}+I_{2}+I_{3}
$$

Hence,

\begin{equation*}
\frac{1}{3}\left(I_{1}+I_{2}+I_{3}\right)=\left.\int(g(s) s-G(s))\right|_{s=\bar{\varphi} \varphi} d x \tag{2.12}
\end{equation*}
$$

Therefore, (2.10) follows from (2.12) and condition G2, since

g(s) s-G(s)>g(s) s-\theta G(s) \geq 0 \quad \text { for all } s \in \mathbb{R}
$$

By (1.3) and (2.9), the energy $\mathcal{E}_{0}:=\mathcal{E}\left(\psi_{0}(t, \cdot)\right)$ associated with particle-like solutions $\psi_{0}$ is expressed by

\mathcal{E}_{0} \equiv \mathcal{E}_{0}(\varphi)=I_{1}+I_{2}+I_{3}+V=\omega \int|\varphi(x)|^{2} d x+\left.\int(g(s) s-G(s))\right|_{s=\bar{\varphi} \varphi} d x>0
$$

by condition G2.
Denote by $(\cdot, \cdot)$ the inner scalar product in $L^{2}$.
Lemma 2.7 Let $\varphi$ be a solution of Eqn (2.1), $\varphi \in H^{1}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$. Then

\omega\left(\varphi^{*}, \alpha_{k} \varphi\right)=-i\left(\varphi^{*}, \partial_{k} \varphi\right), \quad k=1,2,3 . \tag{2.13}
\end{equation*}
$$

Proof Multiply (2.1) on the left by $\alpha_{1}$ and obtain

i \partial_{1} \varphi+i \alpha_{1} \alpha_{2} \partial_{2} \varphi+i \alpha_{1} \alpha_{3} \partial_{3} \varphi+\omega \alpha_{1} \varphi-m \alpha_{1} \beta \varphi+g(\bar{\varphi} \varphi) \alpha_{1} \beta \varphi=0
$$

Hence

$$
\begin{align*}
& i\left(\varphi^{*}, \partial_{1} \varphi\right)+i\left(\varphi^{*}, \alpha_{1} \alpha_{2} \partial_{2} \varphi\right)+i\left(\varphi^{*}, \alpha_{1} \alpha_{3} \partial_{3} \varphi\right)+\omega\left(\varphi^{*}, \alpha_{1} \varphi\right)-m\left(\varphi^{*}, \alpha_{1} \beta \varphi\right) \\
& +\left(\varphi^{*}, g(\bar{\varphi} \varphi) \alpha_{1} \beta \varphi\right)=0 \tag{2.14}
\end{align*}
$$

On the other hand, taking the adjoint of Eqn (2.1) and multiplying on the right by $\alpha_{1}$ one obtains

-i \partial_{1} \varphi^{*}-i \partial_{2} \varphi^{*} \alpha_{2} \alpha_{1}-i \partial_{3} \varphi^{*} \alpha_{3} \alpha_{1}+\omega \varphi^{*} \alpha_{1}-m \varphi^{*} \beta \alpha_{1}+g(\bar{\varphi} \varphi) \varphi^{*} \beta \alpha_{1}=0
$$

Hence,

\begin{align*}
& -i\left(\partial_{1} \varphi^{*}, \varphi\right)-i\left(\partial_{2} \varphi^{*} \alpha_{2} \alpha_{1}, \varphi\right)-i\left(\partial_{3} \varphi^{*} \alpha_{3} \alpha_{1}, \varphi\right)+\omega\left(\varphi^{*} \alpha_{1}, \varphi\right)-m\left(\varphi^{*} \beta \alpha_{1}, \varphi\right) \\
& +\left(\varphi^{*} \beta \alpha_{1}, g(\bar{\varphi} \varphi) \varphi\right)=0 . \tag{2.15}
\end{align*}

By (1.2), summing Eqns (2.14) and (2.15) gives (2.13) for $k=1$. For $k \neq 1$ the proof is similar.

### 2.1 A particular ansatz for the solutions of Eqn (2.1)

As in [22], we choose to orient the angular momentum along the $x_{3}$-axis and consider four families of solutions of (2.1) which in spherical coordinates $(r, \phi, \theta)$ (i.e. $x_{1}=r \cos \phi \sin \theta$, $\left.x_{2}=r \sin \phi \sin \theta, x_{3}=r \cos \theta\right)$ are of a form

\varphi^{3}(x)=\binom{v_{+}(r)\binom{0}{1}}{i u_{+}(r)\binom{\sin \theta e^{-i \phi}}{-\cos \theta}}, \quad \varphi^{4}(x)=\left(\begin{array}{c}
v_{-}(r)\left(\begin{array}{c}
-\sin \theta e^{-i \phi} \\
\cos \theta \\
0 \\
-1
\end{array}\right)
\end{array}\right)

If $\varphi^{1}, \ldots, \varphi^{4}$ are substituted into Eqn (2.1), then this equation reduces to the following O.D.E. system for radial functions $u_{ \pm}$and $v_{ \pm}$:

The existence of the solutions $u_{ \pm}$and $v_{ \pm}$follows from results [6, 23, 2, 17].
The total angular momentum operator is $\mathbf{M}=\mathbf{L}+\mathbf{S}$, where $\mathbf{L}=x \times(-i \nabla)$ is the orbital angular momentum, $\mathbf{S}=\Sigma / 2$ is the spin angular momentum, $\Sigma=\left(\begin{array}{cc}\sigma & 0 \\ 0 & \sigma\end{array}\right)$. In particular, in the spherical coordinates, the third component of $\mathbf{L}$ is $L_{3}=-i \partial_{\phi}$. It is easy to check the following properties of $\varphi^{a}, a=1,2,3,4$.
(i) $\varphi^{a}$ are eigenfunctions of the third component of $\mathbf{M}$ with eigenvalue $m_{3}= \pm 1 / 2$. More exactly, $M_{3} \varphi^{a}=1 / 2 \varphi^{a}$ for $a=1,2, M_{3} \varphi^{a}=-1 / 2 \varphi^{a}$ for $a=3,4$. Since $\mathbf{M} \varphi^{1}=(1 / 2)\left(\varphi^{3}, i \varphi^{3}, \varphi^{1}\right)$, $\mathbf{M} \varphi^{2}=(1 / 2)\left(-\varphi^{4},-i \varphi^{4}, \varphi^{2}\right), \mathbf{M} \varphi^{3}=(1 / 2)\left(\varphi^{1},-i \varphi^{1},-\varphi^{3}\right), \mathbf{M} \varphi^{4}=(1 / 2)\left(-\varphi^{2}, i \varphi^{2},-\varphi^{4}\right)$, then $M_{k}^{2} \varphi^{a}=1 / 4 \varphi^{a}$ for all $k=1,2,3$, and $\mathbf{M}^{2} \varphi^{a}=3 / 4 \varphi^{a}=j(j+1 / 2) \varphi^{a}$ for all $a$. Hence, the quantum number $j=1 / 2$ for all $\varphi^{a}$.
(ii) For the "spin-orbit" operator $\mathbf{K}=\beta \Sigma \cdot \mathbf{M}-1 / 2 \beta=\beta(\Sigma \cdot \mathbf{L}+1)$ (see [12, p.19]), we have $\mathbf{K}^{2}=\mathbf{M}^{2}+1 / 4$. Then the eigenvalues of $\mathbf{K}$ are $\kappa= \pm(j+1 / 2)$. Hence, for all $a, \varphi^{a}$ are eigenfunctions of $\mathbf{K}$ with eigenvalues $\kappa= \pm 1$, where the quantum number $\kappa=1$ for $a=1,3$ and $\kappa=-1$ for $a=2,4$.
(iii) For any solution $\varphi$ from the four families $\left\{\varphi^{1}, \ldots, \varphi^{4}\right\}$, the following equalities hold. At first, $\varphi^{*}(x) \alpha_{3} \varphi(x) \equiv 0$. Secondly,

(iv) For stationary states $\psi_{0}(t, x)=e^{-i \omega t} \varphi(x)$ with $\varphi$ from these particular families of solutions we have $Q\left(\psi_{0}\right)=4 \pi \int_{0}^{+\infty}\left(v_{ \pm}^{2}+u_{ \pm}^{2}\right) r^{2} d r$,

where $v_{ \pm}=v_{ \pm}(r), u_{ \pm}=u_{ \pm}(r)$. Moreover, the current $\mathbf{J}(x)=\psi_{0}^{*}(t, x) \alpha \psi_{0}(t, x)$ equals

where the quantum numbers $m_{3}= \pm 1 / 2, \kappa_{ \pm}= \pm 1$ are introduced above.

## 3 Moving solitary waves for nonlinear Dirac equations

As shown, e.g., in 44, 12, 32], the Dirac equation (1.1) with $g \equiv 0$ is Lorentz invariant. Namely, let $\Lambda=\left(\Lambda_{\mu \nu}\right)_{\mu, \nu=0}^{4}$ be a Lorentz transformation and $\psi(t, x)$ be a solution of (1.1) with $g \equiv 0$. Then there exists a matrix $S \equiv S(\Lambda)$ such that $\psi^{\prime}\left(t^{\prime}, x^{\prime}\right)=S(\Lambda) \psi(t, x)$ satisfies the same equation in the terms of the new variables $\left(t^{\prime}, x^{\prime}\right)=\Lambda(t, x)$. It requires the following conditions on $S \equiv S(\Lambda)$ :

Here and below by $I$ we denote the unit $4 \times 4$ (or $2 \times 2$ ) matrix. The nonlinear equation (1.1) is Lorentz invariant, if condition (3.1) holds and

The conditions (3.1) and (3.2) can be rewritten in the form (cf formulas (23) and (27) from [12])

The existence of the matrix $S$ satisfying conditions (3.3) follows from Pauli's Fundamental Theorem.

Let $\Lambda_{\mathbf{v}}: \mathbb{R}^{4} \rightarrow \mathbb{R}^{4}$ be a Lorentz transformation (boost) with velocity $\mathbf{v} \in \mathbb{R}^{3},|\mathbf{v}|<1$ : $\Lambda_{\mathbf{v}}(t, x)=\left(\gamma(t+\mathbf{v} \cdot x), \gamma\left(x^{\|}+\mathbf{v} t\right)+x^{\perp}\right)$, where $x^{\|}+x^{\perp}=x, x^{\|} \| \mathbf{v}, x^{\perp} \perp \mathbf{v}, \gamma=\left(1-\mathbf{v}^{2}\right)^{-1 / 2}$. Hence (see, e.g., [32, formula (2.14)]),

Note that $\operatorname{det} \Lambda_{v}=1$ and $\Lambda_{\mathbf{v}}^{-1}=\Lambda_{-\mathbf{v}}$. The matrix $S_{\mathbf{v}} \equiv S\left(\Lambda_{\mathbf{v}}\right)$ can be chosen as

\end{gather*}

and conditions (3.3) hold. In particular,

Let $\omega \in(0, m)$, and $\psi_{0}(t, x)=e^{-i \omega t} \varphi(x)$, be a standing solitary wave. By $\psi_{\mathbf{v}}(t, x)$ we denote a (moving) solitary wave with velocity $\mathbf{v} \in \mathbb{R}^{3},|\mathbf{v}|<1$ :

Remark 3.1 (i) Let $\varphi(x)$ be a non-zero solution of Eqn (2.1). Then solitary waves $\psi_{\mathbf{v}}(t, x)$ satisfies Eqn (1.1). This follows from (3.8) and (3.9). Indeed, substituting $\psi_{\mathbf{v}}(t, x)$ in Eqn (1.1) and using (3.7) and (3.8) we obtain

& \left.+i\left(\alpha \cdot S_{\mathbf{v}}\left(\nabla \varphi+\mathbf{v} \frac{\gamma-1}{|\mathbf{v}|^{2}} \nabla \varphi(y) \cdot \mathbf{v}\right)-\gamma S_{\mathbf{v}} \nabla \varphi(y) \cdot \mathbf{v}\right)-m \beta S_{\mathbf{v}} \varphi(y)+g(\bar{\varphi} \varphi) \beta S_{\mathbf{v}} \varphi\right] \\
= & e^{-i \omega \gamma(t-\mathbf{v} \cdot \mathbf{x})} S_{\mathbf{v}}^{-1}[\omega+i \alpha \cdot \nabla-m \beta+g(\bar{\varphi} \varphi) \beta] \varphi(y)=0,
\end{aligned}
$$

with $y=x+\mathbf{v}(\gamma-1) x \cdot \mathbf{v} /|\mathbf{v}|^{2}-\gamma \mathbf{v} t$.
(ii) Let $\psi^{\prime}\left(t^{\prime}, x^{\prime}\right)=S(\Lambda) \psi(t, x)$, where $\Lambda$ is a Lorentz transformation. Denote by $J(t, x)$ the 4-current, $J^{\mu}(t, x)=\psi^{*}(t, x) \alpha_{\mu} \psi(t, x)$ (with $\left.\alpha_{0} \equiv I\right)$ and let $J^{\prime \mu}(t, x)=\psi^{\prime}(t, x)^{*} \alpha_{\mu} \psi^{\prime}(t, x)$. Then

For simplicity, put $\mathbf{v}=(0,0, v) \in \mathbb{R}^{3}$. In this case we denote by $\Lambda_{v}$ the Lorentz transformation (boost) $\Lambda_{\mathrm{v}}$ :

the matrix $S_{v}\left(S_{v}:=S_{\mathbf{v}}\right.$ if $\left.\mathbf{v}=(0,0, v)\right)$ is defined as

Using the explicit formulas (3.13), we obtain the following properties of $S_{v}$ (cf (3.7), (3.8)).

In particular, $\gamma S_{v}^{*}\left(\alpha_{3}-v I\right) S_{v}=\alpha_{3}, \gamma S_{v}^{*}\left(I-\alpha_{3} v\right) S_{v}=I$.
Given $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$, we impose the following conditions on $\varphi(x)$.

\end{aligned}

where $\varphi \equiv \varphi\left(x_{1}, x_{2}, \gamma\left(x_{3}-v t\right)\right)$. Changing variables $x=\left(x_{1}, x_{2}, x_{3}\right) \rightarrow y:=\left(x_{1}, x_{2}, \gamma\left(x_{3}-v t\right)\right)$, we obtain

In the general case of $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$, we substitute $\psi_{\mathbf{v}}$ from (3.9) in (1.3), apply equalities (3.7), change variables $x \rightarrow y:=x+\mathbf{v}(\gamma-1) x \cdot \mathbf{v} /|\mathbf{v}|^{2}-\gamma \mathbf{v} t$, use formulas (2.7) and (2.13) and obtain $\mathcal{E}_{\mathbf{v}}=\gamma \mathcal{E}_{0}+\eta_{\mathbf{v}}$, where, by definition,

Hence, by conditions $\mathbf{C 1}$ and $\mathbf{C 2}, \eta_{\mathbf{v}}=0$, then identity (3.15) follows.
Let $\mathbf{v} \in \mathbb{R}^{3}, \Lambda_{\mathbf{v}}$ be defined in (3.5), $\psi_{\mathbf{v}}$ be of the form (3.9). Write $P_{\mathbf{v}}:=P\left(\psi_{\mathbf{v}}\right)$, where $P(\psi)$ stands for the momentum operator,

$\mathbf{C 2}$ ' Let $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$. For any $j=1,2,3, \sum_{k: k \neq j} v_{k} \int \varphi^{*} \alpha_{k} \partial_{j} \varphi d x=0$.

Lemma 3.3 Let $\varphi$ be a solution to Eqn (2.1) and conditions $\mathbf{C 1}$ ' and C2' hold. Then

P_{\mathbf{v}}=-i \int_{\mathbb{R}^{3}} \varphi^{*} \gamma(\alpha \cdot \mathbf{v}+I)(i \omega \gamma \mathbf{v} \varphi+\nabla \varphi+\mathbf{v} \kappa \nabla \varphi \cdot \mathbf{v}) d x, \quad \text { with } \kappa:=\frac{\gamma-1}{|\mathbf{v}|^{2}}
$$

where $\varphi \equiv \varphi(y)$ with $y:=x+\mathbf{v} \kappa(x \cdot \mathbf{v})-\gamma \mathbf{v} t$. Since $d y=\gamma d x$, changing variables $x \rightarrow y$ gives

$$
P_{\mathbf{v}}=-i \int_{\mathbb{R}^{3}} \varphi^{*}(\alpha \cdot \mathbf{v}+I)(i \omega \gamma \mathbf{v} \varphi+\nabla \varphi+\mathbf{v} \kappa \nabla \varphi \cdot \mathbf{v}) d y
$$

Using (2.5) and (2.13), we obtain $P_{\mathbf{v}}=\gamma \mathbf{v} \mathcal{E}_{0}-i \xi_{\mathbf{v}}$, where, by definition,

$$
\begin{align*}
\xi_{\mathbf{v}}= & \mathbf{v}(\gamma+\kappa) \int \varphi^{*} \nabla \varphi \cdot \mathbf{v} d y+\int \varphi^{*} \nabla \varphi d y+\mathbf{v} \kappa \sum_{k, j: k \neq j} \int \varphi^{*} \alpha_{k} \partial_{j} \varphi d y v_{k} v_{j} \\
& +\left(\sum_{k \neq 1} v_{k} \int \varphi^{*} \alpha_{k} \partial_{1} \varphi d y, \sum_{k \neq 2} v_{k} \int \varphi^{*} \alpha_{k} \partial_{2} \varphi d y, \sum_{k \neq 3} v_{k} \int \varphi^{*} \alpha_{k} \partial_{3} \varphi d y\right) \tag{3.19}
\end{align*}
$$

In particular, if $\mathbf{v}=(0,0, v) \in \mathbb{R}^{3}$,

$$
\xi_{\mathrm{v}}=\left(\int \varphi^{*}\left(v \alpha_{3}+1\right) \partial_{1} \varphi d y, \int \varphi^{*}\left(v \alpha_{3}+1\right) \partial_{2} \varphi d y, \gamma\left(v^{2}+1\right) \int \varphi^{*} \partial_{3} \varphi d y\right) .
$$

By conditions $\mathbf{C 1}{ }^{\prime}$ and $\mathbf{C} 2^{\prime}, \xi_{\mathbf{v}}=0$, then identity (3.18) holds.
Remark 3.4 (i) Conditions C1' and C2' (and also $\mathbf{C 1}$ and $\mathbf{C 2}$ ) are fulfilled with any $\mathbf{v} \in \mathbb{R}^{3}$ for four families of solutions considered in Section 2.1, see formulas (2.16) and (2.17).
(ii) Let $\psi_{\mathbf{v}}(t, x)$ be of the form (3.9) and condition $\mathbf{C} 1$ ' hold. Then, by (3.7), the charge functional is

$$
\begin{aligned}
Q\left(\psi_{\mathbf{v}}\right) & =\int \psi_{\mathbf{v}}^{*}(t, x) \psi_{\mathbf{v}}(t, x) d x=\int \varphi^{*}(y)(\alpha \cdot \mathbf{v}+I) \varphi(y) d y=\left(\varphi^{*}, \varphi\right)+\left(\varphi^{*}, \alpha \varphi\right) \cdot \mathbf{v} \\
& =\int|\varphi(y)|^{2} d y
\end{aligned}
$$

The last equality follows from (2.13) and condition $\mathbf{C 1}$ '. Hence, $Q\left(\psi_{\mathbf{v}}\right)=Q\left(\psi_{0}\right)$ for any $\mathbf{v} \in \mathbb{R}^{3}$.
(iii) Let $\varphi=\varphi_{\omega}$ be a solution of Eqn (2.1) from one of four families of solutions considered in Remark 2.1. Then applying the total angular momentum operator $M_{3}$ to $\psi_{v}$, we have

$$
M_{3} \psi_{v}=e^{-i \omega \gamma\left(t-v x_{3}\right)} S_{v} M_{3} \varphi\left(x_{1}, x_{2}, \gamma\left(x_{3}-v t\right)\right)
$$

Hence, if $\varphi \in\left\{\varphi^{1}, \varphi^{2}\right\}$ (see Remark (2.1), then $M_{3} \psi_{v}=1 / 2 \psi_{v}$. For $\varphi \in\left\{\varphi^{3}, \varphi^{4}\right\}, M_{3} \psi_{v}=$ $-1 / 2 \psi_{v}$.

## 4 Solitary waves in $1+1$ dimensions

We consider the nonlinear Dirac equation in $\mathbb{R}^{1}$,

$$
\begin{equation*}
i \dot{\psi}=-i \alpha \psi^{\prime}+m \beta \psi-\beta g(\bar{\psi} \psi) \psi, \quad x \in \mathbb{R}^{1}, \quad t \in \mathbb{R} . \tag{4.1}
\end{equation*}
$$

Here $\psi^{\prime}:=\partial_{x} \psi, \psi(t, x) \in \mathbb{C}^{2}, \alpha=-\sigma_{2}, \beta=\sigma_{3}$. In the case when $g(s)=s$, Eqn (4.1) is called the massive Gross-Neveu model (or the 1D Soler model). The stationary states or localized solutions of (4.1) are the solutions of the form $\psi(t, x)=e^{-i \omega t} \varphi_{\omega}, \omega \in(0, m)$, such that $\varphi_{\omega} \in H^{1}\left(\mathbb{R}^{1}\right)$, and $\varphi \equiv \varphi_{\omega}$ is a nonzero localized solution of the following stationary nonlinear Dirac equation

$$
\begin{equation*}
i \alpha \varphi^{\prime}+\omega \varphi-m \beta \varphi+g(\bar{\varphi} \varphi) \beta \varphi=0, \quad x \in \mathbb{R}^{1} \tag{4.2}
\end{equation*}
$$

The solitary wave solutions have been studied, e.g., in [20, 21]. Write

$$
I=-i \int_{\mathbb{R}^{1}} \varphi^{*} \alpha \varphi^{\prime} d y, \quad Q=\int_{\mathbb{R}^{1}} \varphi^{*} \varphi d x, \quad V=\int_{\mathbb{R}^{1}}(m \bar{\varphi} \varphi-G(\bar{\varphi} \varphi)) d y
$$

Note that

$$
\begin{equation*}
\omega Q=V . \tag{4.3}
\end{equation*}
$$

This equality can be proved similarly to (2.7).
For $v \in \mathbb{R}^{1},|v|<1$, introduce the "moving solitary waves"

$$
\psi_{v}(t, x)=e^{-i \omega \gamma(t-v x)} S_{v} \varphi(\gamma(x-v t)), \quad S_{v}=\sqrt{\frac{\gamma+1}{2}}\left(I+\alpha \frac{v \gamma}{\gamma+1}\right), \quad x \in \mathbb{R}^{1} .
$$

Note that $\alpha^{*}=\alpha, \beta^{*}=\beta, \alpha^{2}=\beta^{2}=I, \alpha \beta+\beta \alpha=0$. Hence $S_{v}^{*} \beta S_{v}=\beta, S_{v}^{*} S_{v}=\gamma(v \alpha+I)$, $S_{v}^{*} \alpha S_{v}=\gamma(v I+\alpha)$. Consider

$$
\mathcal{E}_{v}:=\mathcal{E}\left(\psi_{v}\right)=\int_{\mathbb{R}^{1}}\left(-i \psi_{v}^{*} \alpha \psi_{v}^{\prime}+m \bar{\psi}_{v} \psi_{v}-G\left(\bar{\psi}_{v} \psi_{v}\right)\right) d x
$$

Using the properties $S_{v}$, we obtain

$$
\begin{aligned}
\mathcal{E}_{v} & =\left.\int_{\mathbb{R}^{1}}\left(-i \varphi^{*} S_{v}^{*} \alpha S_{v}\left(i \omega \gamma v \varphi+\gamma \varphi^{\prime}\right)+m \bar{\varphi} \varphi-G(\bar{\varphi} \varphi)\right)\right|_{\varphi=\varphi(\gamma(x-v t))} d x \\
& =-i \gamma \int_{\mathbb{R}^{1}} \varphi^{*}(y)(v I+\alpha)\left(i \omega v \varphi(y)+\varphi^{\prime}(y)\right) d y+\frac{1}{\gamma} V .
\end{aligned}
$$

In the last integral we changed variable $x \rightarrow y=\gamma(x-v t)$. Hence,

$$
\mathcal{E}_{v}=\gamma v^{2} \omega Q+\gamma v \omega\left(\varphi^{*}, \alpha \varphi\right)-i \gamma v\left(\varphi^{*}, v \varphi^{\prime}\right)+\gamma I+\frac{1}{\gamma} V .
$$

In particular,

$$
\mathcal{E}_{0}=\int_{\mathbb{R}^{1}}\left(-i \varphi^{*} \alpha \varphi+m \bar{\varphi} \varphi-G(\bar{\varphi} \varphi)\right) d x=I+V .
$$

We apply equalities (4.3) and $\omega\left(\varphi^{*}, \alpha \varphi\right)=-i\left(\varphi^{*}, \varphi^{\prime}\right)($ cf (2.13) $)$ and obtain

$$
\mathcal{E}_{v}=\gamma \mathcal{E}_{0}-2 i \gamma v\left(\varphi^{*}, \varphi^{\prime}\right)
$$

Assuming that $\varphi$ satisfies the property $\left(\varphi^{*}, \varphi^{\prime}\right)=0(\mathrm{cf}$ condition $\mathbf{C 1}$ or $\mathbf{C 1}$ '), we have $\mathcal{E}_{v}=\gamma \mathcal{E}_{0}$. Moreover, under the same condition on $\varphi$, one obtains

$$
P_{v}=-i \int_{\mathbb{R}^{1}} \psi_{v}^{*}(t, x) \psi_{v}^{\prime}(t, x) d x=\gamma v \mathcal{E}_{0}-\gamma i\left(v^{2}+1\right) \int_{\mathbb{R}^{1}} \varphi^{*}(x) \varphi^{\prime}(x) d x=\gamma v \mathcal{E}_{0}
$$

## 5 Maxwell-Dirac equations

We use natural units, in which we have rescaled length and time so that $\hbar=c=e=1$. Then, in the Lorentz gauge, the (MD) system reads

$$
\begin{align*}
& i \dot{\psi}=\Phi \psi-i \alpha \cdot \nabla \psi-\alpha \cdot \mathbf{A} \psi+m \beta \psi, \quad x \in \mathbb{R}^{3}, \quad t \in \mathbb{R},  \tag{5.1}\\
& \quad \ddot{\Phi}-\Delta \Phi=4 \pi \rho \\
& \ddot{\mathbf{A}}-\Delta \mathbf{A}=4 \pi \mathbf{J}  \tag{5.2}\\
& \nabla \cdot \mathbf{A}+\dot{\Phi}=0 \tag{5.3}
\end{align*}
$$

Here $\psi$ describes the charged Dirac spinor, $\psi \equiv \psi(t, x) \in \mathbb{C}^{4}$ for $(t, x) \in \mathbb{R}^{3} \times \mathbb{R}, \mathbf{A} \equiv \mathbf{A}(t, x)=$ $\left(A^{1}, A^{2}, A^{3}\right)$ and $\Phi \equiv \Phi(t, x)$ are the classical electromagnetic potentials, $m>0, \rho \equiv \rho(t, x)$ is charge density, $\mathbf{J} \equiv \mathbf{J}(t, x)$ is electric current. By definition,

$$
\rho=\psi^{*} \psi, \quad \mathbf{J}=\psi^{*} \alpha \psi,
$$

$\beta, \alpha=\left(\alpha_{1}, \alpha_{2}, \alpha_{3}\right)$ are Pauli-Dirac matrices. We also introduce notation $J=(\rho, \mathbf{J})$ for the 4-electromagnetic current $\left(J^{\mu}=\bar{\psi} \gamma^{\mu} \psi\right)$, and $A=\left(A^{\mu}\right)=(\Phi, \mathbf{A})$ for the 4-potential of the electromagnetic field. The equation (5.3) is called the Lorentz gauge condition.

The magnetic and electric fields $\mathbf{H} \equiv \mathbf{H}(t, x)$ and $\mathbf{E} \equiv \mathbf{E}(t, x)$ are given by

$$
\begin{equation*}
\mathbf{H}=\operatorname{rot} \mathbf{A} \equiv \nabla \times \mathbf{A}, \quad \mathbf{E}=-\dot{\mathbf{A}}-\nabla \Phi . \tag{5.4}
\end{equation*}
$$

Then, by condition (5.3), equations (5.2) become classical Maxwell's equations of electrodynamics

$$
\dot{\mathbf{H}}=-\operatorname{rot} \mathbf{E}, \quad \dot{\mathbf{E}}=\operatorname{rot} \mathbf{H}-4 \pi \mathbf{J}, \quad \nabla \cdot \mathbf{E}=4 \pi \rho, \quad \nabla \cdot \mathbf{H}=0 .
$$

As shown, e.g., in [4, 30], this model is based on the Lagrangian density $\mathcal{L}_{Q}=\mathcal{L}_{D}+\mathcal{L}_{M}+\mathcal{L}_{I}$. Here $\mathcal{L}_{D}$ and $\mathcal{L}_{M}$ are Lagrangian densities for the free Dirac and electromagnetic fields, resp., $\mathcal{L}_{I}$ is extra term describing the interaction between $\psi$ and the electromagnetic field,
$\mathcal{L}_{D}=\bar{\psi}\left(i \gamma^{\mu} \partial_{\mu}-m\right) \psi, \quad \mathcal{L}_{M}=-\frac{1}{16 \pi} F^{\mu \nu} F_{\mu \nu}=\frac{1}{8 \pi}\left(\mathbf{E}^{2}-\mathbf{H}^{2}\right), \quad \mathcal{L}_{I}=-J_{\mu} A^{\mu} \equiv-\rho \Phi+\mathbf{J} \cdot \mathbf{A}$, where $F_{\mu \nu}$ stands for the electromagnetic field tensor, $F_{\mu \nu}:=\partial_{\nu} A_{\mu}-\partial_{\mu} A_{\nu}, \partial_{\mu}=\partial / \partial x^{\mu}$, $\mu, \nu=0,1,2,3$. Other words,

$$
\begin{equation*}
\mathcal{L}_{Q} \equiv \mathcal{L}_{Q}(\psi, A)=\psi^{*}\left(i \partial_{t}+i \alpha \cdot \nabla-\Phi+\alpha \cdot \mathbf{A}-m \beta\right) \psi+\frac{1}{8 \pi}\left(|\dot{\mathbf{A}}+\nabla \Phi|^{2}-|\operatorname{rot} \mathbf{A}|^{2}\right) \tag{5.5}
\end{equation*}
$$

It is easy to check that the Euler-Lagrange equations applied to (5.5) give Eqn (5.1) and $\left(\partial_{t}^{2}-\Delta\right) A^{\mu}-\partial^{\mu}\left(\partial_{\nu} A^{\nu}\right)=J^{\mu}$. Due to the Lorentz gauge (5.3), we obtain Eqn (5.2).

Since $\partial \mathcal{L}_{Q} /(\partial \dot{\Phi})=0$, the Hamiltonian density equals

$$
\begin{aligned}
\mathcal{H}(\psi, A) & =\frac{\partial \mathcal{L}_{Q}}{\partial \dot{\psi}} \cdot \dot{\psi}+\frac{\partial \mathcal{L}_{Q}}{\partial \dot{\mathbf{A}}} \cdot \dot{\mathbf{A}}-\mathcal{L}_{Q}=i \psi^{*} \cdot \dot{\psi}+\frac{1}{4 \pi}(\dot{\mathbf{A}}+\nabla \Phi) \cdot \dot{\mathbf{A}}-\mathcal{L}_{Q} \\
& =\psi^{*}[\alpha \cdot(-i \nabla-\mathbf{A})+\Phi+m \beta] \psi+\frac{1}{4 \pi} \mathbf{E} \cdot \nabla \boldsymbol{\Phi}+\frac{1}{8 \pi}\left(\mathbf{E}^{2}+\mathbf{H}^{2}\right)
\end{aligned}
$$

Hence the energy functional of the system (5.1)-(5.3) reads (cf [4])

$$
\begin{align*}
\mathcal{E}(t) & \equiv \mathcal{E}(\psi(t, \cdot), A(t, \cdot))=\int \mathcal{H}(\psi(t, \cdot), A(t, \cdot)) d x \\
& =\int \psi^{*}[\alpha \cdot(-i \nabla-\mathbf{A}) \psi+m \beta \psi] d x+\frac{1}{8 \pi} \int\left(\mathbf{E}^{2}+\mathbf{H}^{2}\right) d x \tag{5.6}
\end{align*}
$$

where $\mathbf{E}$ and $\mathbf{H}$ are defined in (5.4). Here we use the fact that $\int \mathbf{E} \cdot \nabla \Phi d x=-4 \pi \int \rho \Phi d x$. Evidently, $\dot{\mathcal{E}}(t)=0$.

### 5.1 Standing solitary waves

Let $\omega \in(-m, m)$. Consider a stationary solution $(\psi, A)$ of system (5.1)-(5.3) such that $\psi(t, x)=e^{-i \omega t} \varphi(x)$ and $A=(\Phi, \mathbf{A})$ does not depend on $t$. Such stationary solutions we denote by $\left(\psi_{0}, A_{0}\right)$. Substituting these solutions in system (5.1)-(5.2) we obtain

$$
\begin{align*}
& \left(-\omega+\Phi_{0}-i \alpha \cdot \nabla-\alpha \cdot \mathbf{A}_{0}+m \beta\right) \varphi=0, \quad x \in \mathbb{R}^{3}  \tag{5.7}\\
& -\Delta \Phi_{0}=4 \pi \rho_{0}=4 \pi \varphi^{*} \varphi,  \tag{5.8}\\
& -\Delta \mathbf{A}_{0}^{k}=4 \pi J_{0}^{k}=4 \pi \varphi^{*} \alpha_{k} \varphi, \quad k=1,2,3
\end{align*}
$$

By (5.8), $A_{0}^{\mu}=\varphi^{*} \alpha_{\mu} \varphi *(1 /|x|)\left(\right.$ with $\left.\alpha_{0} \equiv I\right), \mu=0,1,2,3$, i.e.,

$$
\begin{equation*}
\Phi_{0}(x)=\int \frac{\rho_{0}(y)}{|x-y|} d y, \quad \mathbf{A}_{0}(x)=\int \frac{\mathbf{J}_{0}(y)}{|x-y|} d y, \quad \text { with } \quad \rho_{0}=|\varphi|^{2}, \quad \mathbf{J}_{0}=\varphi^{*} \alpha \varphi \tag{5.9}
\end{equation*}
$$

Note that the Lorentz condition (5.3) becomes

$$
\begin{equation*}
\nabla \cdot \mathbf{A}_{0}=0 \tag{5.10}
\end{equation*}
$$

what follows from (5.7) and (5.9). Using (5.8) and (5.10), we rewrite the energy associated with stationary states $\left(\psi_{0}, A_{0}\right)$ as

$$
\begin{align*}
\mathcal{E}_{0} & :=\mathcal{E}\left(\psi_{0}, A_{0}\right)=\int \varphi^{*}\left[\alpha \cdot\left(-i \nabla-\mathbf{A}_{0}\right)+m \beta\right] \varphi d x+\frac{1}{8 \pi} \int\left(\left|\nabla \Phi_{0}\right|^{2}+\left|\operatorname{rot} \mathbf{A}_{0}\right|^{2}\right) d x \\
& =\int \varphi^{*}[-i \alpha \cdot \nabla+m \beta] \varphi d x+\frac{1}{2} \int\left(\rho_{0} \Phi_{0}-\mathbf{J}_{0} \cdot \mathbf{A}_{0}\right) d x \tag{5.11}
\end{align*}
$$

The last integral in (5.11) is

$$
\frac{1}{2} \int_{\mathbb{R}^{3}} J_{\mu}(x) A_{0}^{\mu}(x) d x=\frac{1}{2} \int_{\mathbb{R}^{6}} \frac{J_{\mu}(x) J^{\mu}(y)}{|x-y|} d x d y
$$

Definition 5.1 The stationary states or standing waves $\left(\psi_{0}(t, x), A_{0}(x)\right): \mathbb{R} \times \mathbb{R}^{3} \rightarrow \mathbb{C}^{4} \times \mathbb{R}^{4}$ are the solutions of the (MD) system of a form

$$
\begin{align*}
\psi_{0}(x, t) & =e^{-i \omega t} \varphi_{\omega}(x) \\
A_{0}^{\mu}(x) & =J^{\mu} * \frac{1}{|x|}=\int_{\mathbb{R}^{3}} \frac{J^{\mu}(y)}{|x-y|} d y, \quad \mu=0,1,2,3 \tag{5.12}
\end{align*}
$$

Here $\omega \in(-m, m),\left(J^{\mu}\right)=\left(\varphi_{\omega}^{*} \alpha_{\mu} \varphi_{\omega}\right)=\left(\rho_{0}, \mathbf{J}_{0}\right)$, and $\varphi \equiv \varphi_{\omega}$ is a solution of (5.7).
The stationary solutions of the (MD) system were studied numerically by Lisi [22]. Using variational methods, Esteban Georgiev and Séré [15] have proved the existence of stationary solutions with $\omega \in(-m, 0)$. To state this result we introduce a functional

$$
I_{Q}^{\omega}(\varphi):=\frac{1}{2} \int \mathcal{L}_{Q}\left(\psi_{0}, A_{0}\right) d x=\frac{1}{2} \int \varphi^{*}(i \alpha \cdot \nabla-m \beta+\omega) \varphi d x-\frac{1}{4} \iint \frac{J_{\mu}(x) J^{\mu}(y)}{|x-y|} d x d y
$$

Note that if $\left(\psi_{0}, A_{0}\right)$ is a solution of the (MD) system of the form (5.12), then (formally) $\varphi_{\omega}$ is a critical point of $I_{Q}^{\omega}(\varphi)$.
Theorem 5.2 (see [15, Theorem 1]) For any $\omega \in(-m, 0)$, there exists a non-zero critical point $\varphi \equiv \varphi_{\omega} \in H^{1 / 2}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$ of the functional $I_{Q}^{\omega}(\varphi)$. Moreover, $\varphi_{\omega}$ is a smooth function of $x$ exponentially decreasing at infinity with all its derivatives, and $\psi(x, t)=e^{-i \omega t} \varphi_{\omega}(x)$, $A^{\mu}(x, t)=J^{\mu} *(1 /|x|)$ are the solutions of the (MD) system.

### 5.2 Virial identities

The following virial identity was proved in [17, Proposition 3.1].
Lemma 5.3 Let $\varphi \in H^{1}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$ be a solution to Eqn (5.7). Then $\varphi(x)$ satisfies

$$
\begin{equation*}
i \int \varphi^{*} \alpha \cdot \nabla \varphi d x=\frac{3}{2} \int\left(m \bar{\varphi} \varphi-\omega \varphi^{*} \varphi+\frac{5}{6} J_{\mu}(x) A^{\mu}(x)\right) d x \tag{5.13}
\end{equation*}
$$

where $J_{\mu} A^{\mu}=\rho_{0} \Phi_{0}-\mathbf{J}_{0} \cdot \mathbf{A}_{0}, \rho_{0}=|\varphi|^{2}, \mathbf{J}_{0}=\varphi^{*} \alpha \varphi$.
Let functionals $I_{k}(\varphi), k=1,2,3$, and $Q(\varphi)$ be as in (2.6). Also, we put

$$
\begin{align*}
& T \equiv T(\varphi)=\int\left(\rho_{0}(x) \Phi_{0}(x)-\mathbf{J}_{0}(x) \cdot \mathbf{A}_{0}(x)\right) d x=(2 \pi)^{-3} 4 \pi \int \frac{\left|\hat{\rho}_{0}(k)\right|^{2}-\left|\mathbf{J}_{0}(k)\right|^{2}}{k^{2}} d k  \tag{5.14}\\
& m_{0} \equiv m_{0}(\varphi)=m \int \bar{\varphi} \varphi d x
\end{align*}
$$

Remark 5.4 Formally, the identity (5.13) can be proved used Derrick's technique [10, p.1253]. Indeed, using notations (5.14), we rewrite $I_{Q}^{\omega}(\varphi)$ as

$$
\begin{equation*}

\end{equation*}

and introduce $\varphi_{\lambda}(x)=\varphi(x / \lambda)$. Then $T\left(\varphi_{\lambda}\right)=\lambda^{5} T(\varphi), I_{k}\left(\varphi_{\lambda}\right)=\lambda^{2} I_{k}(\varphi), Q\left(\varphi_{\lambda}\right)=\lambda^{3} Q(\varphi)$, $m_{0}\left(\varphi_{\lambda}\right)=\lambda^{3} m_{0}(\varphi)$. Hence,

& =\frac{3}{2}\left(\omega Q(\varphi)-m_{0}(\varphi)\right)-I_{1}(\varphi)-I_{2}(\varphi)-I_{3}(\varphi)-\frac{5}{4} T(\varphi) .
\end{aligned}

Hence,

Proof Introduce $\varphi_{\lambda}(x)=\varphi\left(x_{1} / \lambda, x_{2}, x_{3}\right)$. Then $I_{1}\left(\varphi_{\lambda}\right)=I_{1}(\varphi), I_{k}\left(\varphi_{\lambda}\right)=\lambda I_{k}(\varphi), k=2,3$, $Q\left(\varphi_{\lambda}\right)=\lambda Q(\varphi), m_{0}\left(\varphi_{\lambda}\right)=\lambda m_{0}(\varphi)$, and $T\left(\varphi_{\lambda}\right)=(2 \pi)^{-3} 4 \pi \lambda \int \frac{\left|\hat{\rho}_{0}(k)\right|^{2}-\left|\hat{\mathbf{J}}_{0}(k)\right|^{2}}{k_{1}^{2} \lambda^{-2}+k_{2}^{2}+k_{3}^{2}} d k$. Hence,

Corollary 5.7 Since $T_{1}+T_{2}+T_{3}=T$, (5.20) implies identity (5.16). Moreover, by (5.17), we have $I_{j}=-T / 2+T_{j}, \quad j=1,2,3$.

Remark 5.8 (cf Lemma 2.4) Let $\varphi$ be a solution of Eqn (5.7). Then

### 5.3 A particular ansatz of stationary solutions

Abenda [1, Theorem A] extended the results of Theorem 5.2 for $\omega \in(-m, m)$ and proved the existence of the particular ansatz of solutions to Eqn (5.7)-(5.8) in the form

\end{array}\right), \quad \text { with } m_{3}= \pm \frac{1}{2},  \tag{5.24}\\
& \Phi_{0}(x)=\Phi_{*}(r, z), \quad \mathbf{A}_{0}(x)=A_{*}(r, z)(-\sin \phi, \cos \phi, 0), \tag{5.25}
\end{align*}
$$

where $(r, z, \phi)$ are the cylindric coordinates of $x \in \mathbb{R}^{3}$. Moreover, $u_{1}, u_{2}, u_{3}, u_{4}, \Phi_{*}, A_{*}$ are scalar real-valued smooth functions exponentially decreasing at infinity with all its derivatives. The system of equations for $u_{1}, u_{2}, u_{3}, u_{4}, \Phi_{*}, A_{*}$ was derived by Lisi [22].

Remark 5.9 The solutions $\left(\varphi_{\omega}, \Phi_{0}, \mathbf{A}_{0}\right)$ of the form (5.24) and (5.2.5) have the following properties. (i) $\varphi_{\omega}$ are eigenfunctions of the third component of the total angular momentum $\mathbf{M}$ (see Section [2.1) with eigenvalues $m_{3}= \pm 1 / 2$.
(ii) $\int \varphi_{\omega}^{*}(x) \nabla \varphi_{\omega}(x) d x=0$.
(iii) $\int \varphi_{\omega}^{*}(x) \alpha_{k} \partial_{j} \varphi_{\omega}(x) d x=0$ for $k \neq j, k, j=1,2,3$.
(iv) For $i \neq j, \int \partial_{i} \boldsymbol{\Phi}_{0}(x) \partial_{j} \boldsymbol{\Phi}_{0}(x) d x=0$ and $\int \partial_{i} \mathbf{A}_{0}(x) \cdot \partial_{j} \mathbf{A}_{0}(x) d x=0$.
(v) The current $\mathbf{J}_{0}(x)=\psi_{0}^{*}(t, x) \alpha \psi_{0}(t, x)=\varphi_{\omega}^{*}(x) \alpha \varphi_{\omega}(x)=2\left(u_{1} u_{4}-u_{2} u_{3}\right)(\sin \phi,-\cos \phi, 0)$, the charge density is $\rho_{0} \equiv \rho_{0}(r, z)=u_{1}^{2}+u_{2}^{2}+u_{3}^{2}+u_{4}^{2}$. Moreover, by (5.25),

### 5.4 Moving solitary waves

Consider travelling solutions $\left(\psi_{\mathbf{v}}, A_{\mathbf{v}}\right)$, where $A_{\mathbf{v}}=\left(\Phi_{\mathbf{v}}, \mathbf{A}_{\mathbf{v}}\right)$, with velocity $\mathbf{v} \in \mathbb{R}^{3},|\mathbf{v}|<1$ :

Here the stationary solutions $\left(\psi_{0}, A_{0}\right)$ are introduced in Definition 5.1, $S_{\mathbf{v}}$ is defined in (3.6), $\Lambda_{\mathbf{v}}$ is a Lorentz transformation defined in (3.4). It is easily to check that $\left(\psi_{\mathbf{v}}, A_{\mathbf{v}}\right)$ is a solution of the (MD) system. Indeed, first, similarly to Remark 3.1 (i), we obtain

Here and below $y$ stands for the expression $y=x+\mathbf{v}(\gamma-1) x \cdot \mathbf{v} /|\mathbf{v}|^{2}-\gamma \mathbf{v} t$ (as in (5.26)). On the other hand, $S_{\mathbf{v}}\left(\Phi_{\mathbf{v}}(t, x)-\alpha \cdot \mathbf{A}_{\mathbf{v}}(t, x)\right) S_{\mathbf{v}}=\Phi_{0}(y)-\alpha \cdot \mathbf{A}_{0}(y)$, hence

and Eqn (5.1) follows. To verify Eqn (5.2), we put $J_{\mathbf{v}}^{\mu}=\psi_{\mathbf{v}} \alpha_{\mu} \psi_{\mathbf{v}}$. Then, by (5.26), (5.8), and Remark 3.1 (ii), one obtains

and Eqn (5.2) follows. Moreover, $\dot{\Phi}_{\mathbf{v}}(t, x)+\nabla_{x} \cdot \mathbf{A}_{\mathbf{v}}(t, x)=\nabla_{y} \cdot \mathbf{A}_{0}(y)=0$, i.e., the Lorentz gauge condition (5.3) is fulfilled.
Remark 5.10 Denote $\mathbf{E}_{0}=-\nabla \Phi_{0}, \mathbf{H}_{0}=\nabla \times \mathbf{A}_{0}$, and $\mathbf{E}_{\mathbf{v}}=-\dot{\mathbf{A}}_{\mathbf{v}}-\nabla \Phi_{0}, \mathbf{H}_{\mathbf{v}}=\nabla \times \mathbf{A}_{\mathbf{v}}$, $\mathbf{v} \in \mathbb{R}^{3}$. Then

\mathbf{H}_{\mathbf{v}}(t, x) & =\gamma \mathbf{H}_{0}(y)-\mathbf{v} \kappa \mathbf{v} \cdot \mathbf{H}_{0}(y)+\gamma \mathbf{v} \times \mathbf{E}_{0}(y)
\end{array} \quad \kappa:=\frac{\gamma-1}{|\mathbf{v}|^{2}} .
$$

We impose conditions $\mathbf{C 1}$ and $\mathbf{C} 2$ on $\varphi_{\omega}$ (see Section (3). Moreover, we assume the additional condition $\mathbf{C 0}$ on $\left(\Phi_{0}, \mathbf{A}_{0}\right)$.
$\mathbf{C 0}$ For $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$,

Remark 5.11 (i) By Fourier transform and formulas (5.8), condition $\mathbf{C 0}$ can be rewritten in the form

(ii) Conditions $\mathbf{C 0}-\mathbf{C} 2$ are fulfilled, for instance, for the particular family of solutions considered in Section 5.3 (see Remark 5.9 (ii)-(iv)). Obviously, conditions C0 and C2 are valid in the particular case when $\mathbf{v}=(0,0, v)$.

Put $\mathcal{E}_{\mathbf{v}}=\mathcal{E}\left(\psi_{\mathbf{v}}, A_{\mathbf{v}}\right), \mathbf{v} \in \mathbb{R}^{3}$, where $\mathcal{E}$ is defined in (5.6),

Theorem 5.12 Let $\left(\psi_{\mathbf{v}}, A_{\mathbf{v}}\right)$ be a solitary wave of the (MD) system and conditions $\mathbf{C} \mathbf{0}-\mathbf{C} \mathbf{2}$ hold. Then the "particle-like" energy relation holds, $\mathcal{E}_{\mathbf{v}}=\gamma \mathcal{E}_{0}$.

& =\int\left(\gamma^{2} \omega \varphi^{*}\left[\alpha \cdot \mathbf{v}+\mathbf{v}^{2}\right] \varphi-i \varphi^{*}\left[\gamma^{2}(\alpha \cdot \mathbf{v}+1) \mathbf{v} \cdot \nabla \varphi+\alpha \cdot \nabla \varphi\right]+m \bar{\varphi} \varphi\right) d x,
\end{aligned}
$$

where $\varphi \equiv \varphi(y)$ with $y$ from (5.26). Here we apply formulas (3.7) and (3.8). We change variables $x \rightarrow y=x+\mathbf{v}(\gamma-1) x \cdot \mathbf{v} /|\mathbf{v}|^{2}-\gamma \mathbf{v} t, d x=d y / \gamma$. Using (5.23), we obtain

& =\omega Q \gamma \mathbf{v}^{2}+\frac{1}{\gamma}\left(I_{1}+I_{2}+I_{3}\right)+\frac{1}{\gamma} m_{0}+\gamma \sum_{j=1}^{3} v_{j}^{2} I_{j}+\eta_{\mathbf{v}} \tag{5.28}
\end{align*}
$$

where $\eta_{\mathrm{v}}$ is defined in (3.17). Applying 'virial' identities (5.16) and (5.20), we obtain

& =-\int\left(\gamma \mathbf{v}^{2} \Phi_{0}(y) \rho_{0}(y)+\frac{1}{\gamma} \mathbf{A}_{0}(y) \cdot \mathbf{J}_{0}(y)+\gamma\left(\mathbf{v} \cdot \mathbf{A}_{0}(y)\right)\left(\mathbf{v} \cdot \mathbf{J}_{0}(y)\right)\right) d y-R_{\mathbf{v}}, \tag{5.30}
\end{align*}
$$

where $R_{\mathbf{v}}$ stands for the integral $R_{\mathbf{v}}=2 \gamma \int \rho_{0}(y) \mathbf{v} \cdot \mathbf{A}_{0}(y) d y$.
Further, using (5.27), we rewrite the energy corresponding to the electromagnetic field,

& +\frac{\gamma}{8 \pi} \int\left(\mathbf{E}_{0}^{2}+\mathbf{H}_{0}^{2}+\left(\mathbf{v} \times \mathbf{E}_{0}\right)^{2}+\left(\mathbf{v} \times \mathbf{H}_{0}\right)^{2}-\left(\mathbf{v} \cdot \mathbf{E}_{0}\right)^{2}-\left(\mathbf{v} \cdot \mathbf{H}_{0}\right)^{2}\right) d y
\end{align*}
$$

Since $\int \mathbf{H}_{0} \times \mathbf{E}_{0} d y=4 \pi \int \rho_{0} \mathbf{A}_{\mathbf{0}} d y$, the first term in the r.h.s. of (5.31) equals $R_{\mathbf{v}}$. Using the formula $|a|^{2}|b|^{2}=(a \cdot b)^{2}+(a \times b)^{2}$ for $a, b \in \mathbb{R}^{3}$, the second term in $e_{M}$ can be rewritten as

e_{M}=\frac{\gamma\left(1+\mathbf{v}^{2}\right)}{2} \int\left(\rho_{0} \Phi_{0}+\mathbf{J}_{0} \cdot \mathbf{A}_{0}\right) d y-\frac{\gamma}{4 \pi} \int\left(\left(\mathbf{v} \cdot \nabla \Phi_{0}\right)^{2}+\left(\mathbf{v} \cdot\left(\nabla \times \mathbf{A}_{0}\right)\right)^{2}\right) d y+R_{\mathbf{v}} \tag{5.32}
\end{equation*}
$$

Finally, substituting (5.29), (5.30) and (5.32) in $\mathcal{E}_{\mathbf{v}}=e_{D}+e_{I}+e_{M}$ and using notations (5.14) and (5.21), we have

& -\int\left(\gamma \mathbf{v}^{2} \Phi_{0} \rho_{0}+\frac{1}{\gamma} \mathbf{A}_{0} \cdot \mathbf{J}_{0}+\gamma\left(\mathbf{v} \cdot \mathbf{A}_{0}\right)\left(\mathbf{v} \cdot \mathbf{J}_{0}\right)\right) d y-R_{\mathbf{v}} \\
& +\frac{\gamma\left(1+\mathbf{v}^{2}\right)}{2} \int\left(\rho_{0} \Phi_{0}+\mathbf{J}_{0} \cdot \mathbf{A}_{0}\right) d y-\frac{\gamma}{4 \pi} \int\left(\left(\mathbf{v} \cdot \nabla \Phi_{0}\right)^{2}+\left(\mathbf{v} \cdot\left(\nabla \times \mathbf{A}_{0}\right)\right)^{2}\right) d y+R_{\mathbf{v}} \\
= & \gamma m_{0}+\eta_{\mathbf{v}}+\frac{\gamma}{4 \pi}\left(\sum_{j=1}^{3} v_{j}^{2} \int\left|\partial_{j} \Phi_{0}\right|^{2} d y-\int\left(\mathbf{v} \cdot \nabla \Phi_{0}\right)^{2} d y\right) \\
+ & \frac{\gamma}{4 \pi} \int\left(4 \pi \mathbf{v}^{2} \mathbf{A}_{0} \cdot \mathbf{J}_{0}-4 \pi\left(\mathbf{v} \cdot \mathbf{A}_{0}\right)\left(\mathbf{v} \cdot \mathbf{J}_{0}\right)-\left(\mathbf{v} \cdot\left(\nabla \times \mathbf{A}_{0}\right)\right)^{2}-\sum_{j=1}^{3} v_{j}^{2}\left|\partial_{j} \mathbf{A}_{0}\right|^{2}\right) d y \cdot(5.33)
\end{aligned}
$$

Using Fourier transform, relation $\hat{\mathbf{J}}_{0}(k)=k^{2} \hat{\mathbf{A}}_{0}(k) /(4 \pi)$ and formula $|a|^{2}|b|^{2}=|a \cdot b|^{2}+|a \times b|^{2}$, we rewrite the last integral in (5.33) in the form

Finally, conditions $\mathbf{C} 0-\mathbf{C} 2$ yield $\eta_{\mathbf{v}}=\tilde{\eta}_{\mathbf{v}}=0$. Therefore, $\mathcal{E}_{\mathbf{v}}=\gamma m_{0}=\gamma \mathcal{E}_{0}$, by Corollary 5.5 (ii).

Denote by $P=\left(P^{1}, P^{2}, P^{3}\right)$ the momentum operator for the (MD) system,

Put $P_{\mathbf{v}}:=P\left(\psi_{\mathbf{v}}, A_{\mathbf{v}}\right), \mathbf{v} \in \mathbb{R}^{3}$. We impose conditions $\mathbf{C 1}$ ' and $\mathbf{C} 2$ ' on $\varphi_{\omega}$ (see Section 3). Moreover, we impose a stronger condition $\mathbf{C} 0$ ' on $A_{0}$ than $\mathbf{C 0}$.
$\mathbf{C} \mathbf{0}^{\prime}$ Let $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$. For any $k=1,2,3$,

Note that conditions $\mathbf{C} 0^{\prime}-\mathbf{C} 2^{\prime}$ are fulfilled for the particular ansatz of solutions $\varphi \equiv \varphi_{\omega}$ considered in Section 5.3, see Remark 5.9 (iv).

Lemma 5.13 Let conditions $\mathbf{C 0}{ }^{\prime}-\mathbf{C} 2 '$ hold. Then $P_{\mathbf{v}}=\gamma \mathbf{v} \mathcal{E}_{0}$.
Proof Using (5.26) and (3.7), we rewrite the term in $P_{\mathbf{v}}$ corresponding to $\psi_{\mathbf{v}}$,

By conditions C1' and $\mathbf{C} 2^{\prime}, \xi_{\mathrm{v}}=0$.

Further, the second term in $P_{\mathbf{v}}$ corresponding to $A_{\mathbf{v}}$ is

= & -\frac{1}{4 \pi} \int\left(\left(\mathbf{v} \cdot \nabla \Phi_{0}(y)\right) \nabla \Phi_{0}(y)+\mathbf{v} \kappa\left(\mathbf{v} \cdot \nabla \Phi_{0}(y)\right)^{2}\right. \\
& \left.-\sum_{n=1}^{3}\left(\left(\mathbf{v} \cdot \nabla A_{0}^{n}(y)\right) \nabla A_{0}^{n}(y)+\mathbf{v} \kappa\left(\mathbf{v} \cdot \nabla A_{0}^{n}(y)\right)^{2}\right)\right) d y \\
= & -\left(T_{1} v_{1}, T_{2} v_{2}, T_{3} v_{3}\right)-\mathbf{v} \kappa \sum_{j=1}^{3} v_{j}^{2} T_{j}-\tilde{\xi}_{\mathbf{v}} \tag{5.35}
\end{align*}
$$

where $\tilde{\xi}_{\mathrm{v}}$ stands for the following vector

Here by $T_{i j}$ we denote the integral

## 6 The Klein-Gordon-Dirac equations

We consider the Klein-Gordon-Dirac (KGD) system arising in the Yukawa model (see, for instance, [4, §49]) and describes the interaction between the Dirac and scalar (or pseudoscalar) fields. This system is based on the Lagrangian density

\begin{equation*}
\mathcal{L}(\psi, \chi)=\mathcal{L}_{D}(\psi)+\mathcal{L}_{K G}(\chi)+\mathcal{L}_{I}(\psi, \chi) \tag{6.1}
\end{equation*}
$$

Here $\mathcal{L}_{D}(\psi)$ and $\mathcal{L}_{K G}(\chi)$ are the Lagrangian densities for the nonlinear Dirac field $\psi$ and for the free Klein-Gordon field $\chi$, respectively, "extra" term $\mathcal{L}_{I}$ describes the Yukawa interaction between the fields. $\mathcal{L}_{D}(\psi)$ is defined in (2.3),

$$
\mathcal{L}_{K G}(\chi)=\frac{1}{2}\left(|\dot{\chi}|^{2}-|\nabla \chi|^{2}-M^{2} \chi^{2}\right), \quad \mathcal{L}_{I}(\psi, \chi)=\eta \bar{\psi} \Gamma \psi \chi,
$$

where $\chi$ is a (real) scalar field, $M>0, \eta$ is a constant, and $\Gamma$ is some $4 \times 4$ matrix. This model with $G \equiv 0$ and $\Gamma=I$ has been studied by Chadam and Glassey [8] and Esteban et al. [15]. In another model presented by Ranada and Vazquez [26] the self-coupling is $G(\bar{\psi} \psi)=\lambda(\bar{\psi} \psi)^{2}$ (as in the Soler model) and $\Gamma=i \gamma^{5}$ with $\gamma^{5}=i \gamma^{0} \gamma^{1} \gamma^{2} \gamma^{3}=\left(\begin{array}{cc}0 & I \\ I & 0\end{array}\right)$.

For simplicity, we consider the case $\Gamma=I$. Then applied the Lagrange-Euler equations to (6.1) we come to the following system

\left(\partial_{t}^{2}-\Delta+M^{2}\right) \chi & =\eta \bar{\psi} \psi \tag{6.3}
\end{align*}
$$

where $g(s)=G^{\prime}(s), n=1,3\left(\mathrm{cf}\left[8\right.\right.$, p.5]). If $n=1$, we put $\psi=\left(\psi_{1}, \psi_{2}\right), \beta=\sigma_{3}, \alpha=-\sigma_{2}$. Below we consider the case $n=3$ only. The case $n=1$ can be studied by a similar way. By (6.1), the Hamiltonian density reads

\mathcal{E}(\psi, \chi)=\int\left(\psi^{*}(-i \alpha \cdot \nabla+m \beta) \psi-G(\bar{\psi} \psi)+\frac{1}{2}\left(|\dot{\chi}|^{2}+|\nabla \chi|^{2}+M^{2}|\chi|^{2}\right)-\eta \bar{\psi} \psi \chi\right) d x
$$

If $G \equiv 0$, the local existence and uniqueness of solutions to system (6.2)- (6.3) were obtained by Chadam and Glassey [8]. The existence for the stationary solutions was given by Esteban et al. [15, Th.2] also only in the case when $G \equiv 0$. In spite of this fact we verify below the identity (1.4) for (KGD) system assuming that either the self-coupling $G$ vanishes or satisfies the conditions G1-G4 (see Section 2).

### 6.1 Standing waves for the (KGD) equations

Definition 6.1 Let $\omega \in(-m, m)$. The standing waves of the (KGD) system are the stationary solutions $\left(\psi_{0}, \chi_{0}\right)$ of the form

\psi_{0}(t, x)=e^{-i \omega t} \varphi(x), \quad \chi_{0}(x)=\frac{e^{-M|x|}}{4 \pi|x|} * f_{\varphi}, \quad \text { with } f_{\varphi}:=\eta \bar{\varphi} \varphi \tag{6.4}
\end{equation*}
$$

where $\varphi \in H^{1}\left(\mathbb{R}^{3} ; \mathbb{C}^{4}\right)$ satisfies the following equation

$$

\left(\omega+i \alpha \cdot \nabla-m \beta+\eta \chi_{0} \beta+g(\bar{\varphi} \varphi) \beta\right) \varphi=0 \tag{6.5}
\end{equation*}
$$

Put $I^{\omega}(\varphi)=\frac{1}{2} \int \mathcal{L}\left(\psi_{0}, \chi_{0}\right) d x$. Then, by (6.1) and (6.4),

I^{\omega}(\varphi)=\frac{1}{2} \int_{\mathbb{R}^{3}}\left(\varphi^{*}(i \alpha \cdot \nabla-m \beta+\omega) \varphi+G(\bar{\varphi} \varphi)\right) d x+\frac{1}{16 \pi} \int_{\mathbb{R}^{6}} \frac{e^{-M|x-y|}}{|x-y|} f_{\varphi}(x) f_{\varphi}(y) d x d y
$$

Note that if $\left(\psi_{0}, \chi_{0}\right)$ is a stationary solution of the (KGD) equations, then (formally) $\varphi \equiv \varphi_{\omega}$ is a critical point of $I^{\omega}(\varphi)$.

### 6.1.1 A particular family of solutions

In the spherical coordinates $(r, \phi, \theta)$ of $x \in \mathbb{R}^{3}$, the particular family of the stationary solutions ( $\psi_{0}, \chi_{0}$ ) is given by

\psi_{0}(t, x)=e^{-i \omega t} \varphi_{\omega}(x), \quad \varphi_{\omega}(x)=\binom{v\binom{1}{0}}{i u\binom{\cos \theta}{e^{i \phi} \sin \theta}}, \quad \chi_{0}(x)= \begin{cases}\chi_{*} \cos \theta, & \text { if } \Gamma=i \gamma^{5}, \\ \chi_{*}, & \text { if } \Gamma=I\end{cases}
$$

where $u, v, \chi_{*}$ being radial functions. In the case $\Gamma=i \gamma^{5}$, this ansatz has been studied numerically in [26]. In the case when $\Gamma=I$, the functions $u, v$ are classical solutions of the following system:

The function $\chi_{*}$ is a solution of the equation $-\chi_{*}^{\prime \prime}-\frac{2}{r} \chi_{*}^{\prime}+M^{2} \chi_{*}=\eta\left(v^{2}-u^{2}\right)$ or $\chi_{*}(|x|)=$ $\eta \int \frac{e^{-M|x-y|}}{4 \pi|x-y|}\left(v^{2}(|y|)-u^{2}(|y|)\right) d y$.

### 6.1.2 A virial identity

Let $I_{k} \equiv I_{k}(\varphi), V \equiv V(\varphi), Q \equiv Q(\varphi)$ be as in (2.6), and

Note that by Parseval identity and formulas (6.4),

where $\hat{f}_{\varphi}$ denotes the Fourier transform of $f_{\varphi}$. Using (6.7), we rewrite $I^{\omega}(\varphi)$ as

Remark 6.3 (i) The virial identity (6.8) was derived in [15] in the case when $G \equiv 0$. Formally, this identity can be proved used Derrick's technique. Indeed, introduce $\varphi_{\lambda}(x)=\varphi(x / \lambda)$. Then $R\left(\varphi_{\lambda}\right)=\lambda^{5} \int_{\mathbb{R}^{6}} \frac{e^{-\lambda M|x-y|}}{4 \pi|x-y|} f_{\varphi}(x) f_{\varphi}(y) d x d y, I_{k}\left(\varphi_{\lambda}\right)=\lambda^{2} I_{k}(\varphi), Q\left(\varphi_{\lambda}\right)=\lambda^{3} Q(\varphi), V\left(\varphi_{\lambda}\right)=$ $\lambda^{3} V(\varphi)$. Hence,

0 & =\left.\frac{d}{d \lambda}\right|_{\lambda=1} I^{\omega}\left(\varphi_{\lambda}\right)=\left.\frac{1}{2} \frac{d}{d \lambda}\right|_{\lambda=1}\left[\omega Q\left(\varphi_{\lambda}\right)-V\left(\varphi_{\lambda}\right)-I_{1}\left(\varphi_{\lambda}\right)-I_{2}\left(\varphi_{\lambda}\right)-I_{3}\left(\varphi_{\lambda}\right)+\frac{1}{2} R\left(\varphi_{\lambda}\right)\right] \\
& =\frac{3}{2}(\omega Q(\varphi)-V(\varphi))-I_{1}(\varphi)-I_{2}(\varphi)-I_{3}(\varphi)+\frac{1}{4}\left(5 R(\varphi)-M R_{1}(\varphi)\right),
\end{aligned}
$$

and the identity (6.8) holds.
(ii) Introduce $\varphi_{\lambda}(x)=\varphi\left(x_{1} / \lambda, x_{2}, x_{3}\right)$. Then $I_{1}\left(\varphi_{\lambda}\right)=I_{1}(\varphi), I_{k}\left(\varphi_{\lambda}\right)=\lambda I_{k}(\varphi), k=2,3$,
$Q\left(\varphi_{\lambda}\right)=\lambda Q(\varphi), V\left(\varphi_{\lambda}\right)=\lambda V(\varphi), R\left(\varphi_{\lambda}\right)=(2 \pi)^{-3} \lambda \int \frac{\left|\hat{f}_{\varphi}(k)\right|^{2} d k}{k_{1}^{2} \lambda^{-2}+k_{2}^{2}+k_{3}^{2}+M^{2}}$. By (6.10), we have $\left.\frac{d}{d \lambda} R\left(\varphi_{\lambda}\right)\right|_{\lambda=1}=R+2 P_{1}$. Hence

$$
0=\left.\frac{d}{d \lambda}\right|_{\lambda=1} I^{\omega}\left(\varphi_{\lambda}\right)=\frac{1}{2}\left(\omega Q(\varphi)-V(\varphi)-I_{2}(\varphi)-I_{3}(\varphi)+\frac{1}{2} R(\varphi)+P_{1}(\varphi)\right) .
$$

Therefore,

$$
\begin{equation*}
I_{2}(\varphi)+I_{3}(\varphi)=\omega Q(\varphi)-V(\varphi)+\frac{1}{2} R(\varphi)+P_{1}(\varphi) \tag{6.11}
\end{equation*}
$$

Therefore, identities (6.8) and (6.11) imply (6.9) with $j=1$. Similarly, introducing $\varphi_{\lambda}(x)=$ $\varphi\left(x_{1}, x_{2} / \lambda, x_{3}\right)$ or $\varphi_{\lambda}(x)=\varphi\left(x_{1}, x_{2}, x_{3} / \lambda\right)$ gives (6.9) with $j=2,3$. Note that (6.8) follows from (6.9), since $P_{1}+P_{2}+P_{3}=R-M R_{1} / 2$.

Corollary 6.4 (cf Corollary 2.6, Corollary 5.5) Let $\varphi$ be a solution of Eqn (6.5). Then the following relations hold. (i) By (6.5),

$$
\begin{equation*}
I_{1}+I_{2}+I_{3}=\omega Q+\int(g(\bar{\varphi} \varphi)-m) \bar{\varphi} \varphi d x+R \tag{6.12}
\end{equation*}
$$

(ii) Using identities (6.8) and (6.12), we obtain

$$
\omega Q=\frac{2}{3}\left(I_{1}+I_{2}+I_{3}\right)+V-\frac{1}{6}\left(5 R-M R_{1}\right)=I_{1}+I_{2}+I_{3}+\int(m-g(\bar{\varphi} \varphi)) \bar{\varphi} \varphi d x-R .
$$

Hence,

$$
\begin{equation*}
I_{1}+I_{2}+I_{3}=\left.3 \int(g(s) s-G(s))\right|_{s=\bar{\varphi} \varphi} d x+\frac{1}{2}\left(R+M R_{1}\right)>0 \tag{6.13}
\end{equation*}
$$

by (6.7) and condition G2.
(iii) The total energy associated to particle-like solutions $\left(\psi_{0}, \chi_{0}\right)$ is

$$
\begin{equation*}
\mathcal{E}_{0}:=\mathcal{E}\left(\psi_{0}, \chi_{0}\right)=I_{1}+I_{2}+I_{3}+V-\frac{1}{2} R . \tag{6.14}
\end{equation*}
$$

Using (6.12), we have

$$
\mathcal{E}_{0}=\omega \int|\varphi(x)|^{2} d x+\left.\int(g(s) s-G(s))\right|_{s=\bar{\varphi} \varphi} d x+\frac{1}{2} R>0,
$$

by condition G2.
(iv) Similarly to Lemma 2.7 it can be proved that identity (2.13) holds.

### 6.2 Moving waves for the (KGD) equations

Consider travelling solutions $\left(\psi_{\mathbf{v}}, \chi_{\mathbf{v}}\right)$ with velocity $\mathbf{v} \in \mathbb{R}^{3},|\mathbf{v}|<1$ :

$$
\left\{\begin{array}{l}
\psi_{\mathbf{v}}(t, x)=S_{\mathbf{v}} \psi_{0}\left(\Lambda_{\mathbf{v}}^{-1}(t, x)\right)  \tag{6.15}\\
\chi_{\mathbf{v}}(t, x)=\chi_{0}(y) \quad \text { with } y=x+\mathbf{v} \frac{(\gamma-1)}{|\mathbf{v}|^{2}} x \cdot \mathbf{v}-\gamma \mathbf{v} t
\end{array}\right.
$$

It is easy to check that $\left(\psi_{\mathbf{v}}, \chi_{\mathbf{v}}\right)$ is a solution of (6.2) $-(6.3)$.

Denote by $\mathcal{E}_{\mathbf{v}}:=\mathcal{E}\left(\psi_{\mathbf{v}}, \chi_{\mathbf{v}}\right)$ the energy of the moving solitary waves $\left(\psi_{\mathbf{v}}, \chi_{\mathbf{v}}\right)$,

$$
\mathcal{E}_{\mathbf{v}}=\int\left(\psi_{\mathbf{v}}^{*}(-i \alpha \cdot \nabla+m \beta) \psi_{\mathbf{v}}-G\left(\bar{\psi}_{\mathbf{v}} \psi_{\mathbf{v}}\right)+\frac{1}{2}\left(\left|\dot{\chi}_{\mathbf{v}}\right|^{2}+\left|\nabla \chi_{\mathbf{v}}\right|^{2}+M^{2}\left|\chi_{\mathbf{v}}\right|^{2}\right)-\eta \chi_{\mathbf{v}} \bar{\psi}_{\mathbf{v}} \psi_{\mathbf{v}}\right) d x
$$

Assume that conditions C1 and C2 hold (see Section 3). Moreover, we impose the additional condition C3.
C3 For given $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3},|\mathbf{v}|<1$,

$$
\begin{equation*}
\sum_{i, j: i \neq j} v_{i} v_{j} \int \partial_{i} \chi_{0}(x) \partial_{j} \chi_{0}(x) d x=0 \tag{6.16}
\end{equation*}
$$

The integral in (6.16) equals $(2 \pi)^{-3} \int \frac{k_{i} k_{j}\left|\hat{f}_{\varphi}(k)\right|^{2}}{\left(k^{2}+M^{2}\right)^{2}} d k$. Then condition C3 holds, for instance, if $\bar{\varphi} \varphi(x)$ is an even function in $x \in \mathbb{R}^{3}$. In particular, conditions $\mathbf{C 1} \mathbf{- C} 3$ are fulfilled for the particular family of solutions considered in Section 6.1.1 (see also Section 2.1 and formulas (2.16) and (2.17)).

Lemma 6.5 Let conditions $\mathbf{C 1} \mathbf{- C} 3$ hold, $\mathbf{v} \in \mathbb{R}^{3}$ with $|\mathbf{v}|<1$. Then $\mathcal{E}_{\mathbf{v}}=\gamma \mathcal{E}_{0}$.
Proof At first, consider the term in $\mathcal{E}_{\mathbf{v}}$ corresponding to the Dirac field (cf formula (5.28)),

$$
\begin{aligned}
\mathbf{e}_{D} & :=\int\left(\psi_{\mathbf{v}}^{*}(-i \alpha \cdot \nabla+m \beta) \psi_{\mathbf{v}}-G\left(\bar{\psi}_{\mathbf{v}} \psi_{\mathbf{v}}\right)\right) d x \\
& =\omega Q \gamma \mathbf{v}^{2}+\frac{1}{\gamma}\left(I_{1}+I_{2}+I_{3}\right)+\frac{1}{\gamma} V+\gamma \sum_{j=1}^{3} v_{j}^{2} I_{j}+\eta_{\mathbf{v}}
\end{aligned}
$$

where $\eta_{\mathrm{v}}$ is defined in (3.17). Applying formula (6.9) and then the identity (6.8), we obtain

$$
\begin{equation*}
\mathbf{e}_{D}=\gamma\left(I_{1}+I_{2}+I_{3}+V\right)-\frac{1}{2} \gamma \mathbf{v}^{2} R-\gamma \sum_{j=1}^{3} v_{j}^{2} P_{j}+\eta_{\mathbf{v}} \tag{6.17}
\end{equation*}
$$

Second, we rewrite the term in $\mathcal{E}_{\mathbf{v}}$ corresponding to the Klein-Gordon field,

$$
\begin{align*}
\mathbf{e}_{K G} & :=\frac{1}{2} \int\left(\left|\dot{\chi}_{\mathbf{v}}(t, x)\right|^{2}+\left|\nabla \chi_{\mathbf{v}}(t, x)\right|^{2}+M^{2}\left|\chi_{\mathbf{v}}(t, x)\right|^{2}\right) d x \\
& =\frac{1}{2 \gamma} \int\left(\left|\nabla \chi_{0}(y)\right|^{2}+2 \gamma^{2}\left|\mathbf{v} \cdot \nabla \chi_{0}(y)\right|^{2}+M^{2}\left|\chi_{0}(y)\right|^{2}\right) d y \\
& =\frac{1}{2 \gamma} \int \chi_{0}(y)\left(-\Delta+M^{2}\right) \chi_{0}(y) d y+\gamma \sum_{j=1}^{3} v_{j}^{2} \int\left|\partial_{j} \chi_{0}(y)\right|^{2} d y+\eta_{\mathbf{v}}^{\prime} \\
& =\frac{1}{2 \gamma} R+\gamma \sum_{j=1}^{3} v_{j}^{2} P_{j}+\eta_{\mathbf{v}}^{\prime} \tag{6.18}
\end{align*}
$$

where, by definition, $\eta_{\mathbf{v}}^{\prime}:=\gamma \sum_{i, j: i \neq j} v_{i} v_{j} \int \partial_{i} \chi_{0}(y) \partial_{j} \chi_{0}(y) d y$. Further, the term in $\mathcal{E}_{\mathbf{v}}$ corresponding to the interaction is

$$
\begin{equation*}
\mathbf{e}_{I}:=-\eta \int \chi_{\mathbf{v}}(t, x) \bar{\psi}_{\mathbf{v}}(t, x) \psi_{\mathbf{v}}(t, x) d x=-\frac{\eta}{\gamma} \int \chi_{0}(y) \bar{\varphi}(y) \varphi(y) d y=-\frac{1}{\gamma} R(\varphi) \tag{6.19}
\end{equation*}
$$

Applying (6.17)-(6.19), and (6.14), we obtain

$$
\mathcal{E}_{\mathbf{v}}=\mathbf{e}_{D}+\mathbf{e}_{K G}+\mathbf{e}_{I}=\gamma\left(I_{1}+I_{2}+I_{3}+V\right)-\frac{1}{2} \gamma R+\eta_{\mathbf{v}}+\eta_{\mathbf{v}}^{\prime}=\gamma \mathcal{E}_{0}+\eta_{\mathbf{v}}+\eta_{\mathbf{v}}^{\prime}
$$

Finally, by conditions $\mathbf{C} 1-\mathbf{C} 3, \eta_{\mathbf{v}}=\eta_{\mathbf{v}}^{\prime}=0$. Therefore, $\mathcal{E}_{\mathbf{v}}=\gamma \mathcal{E}_{0}$.
Remark If $\mathbf{v}=(0,0, v)$ with $|v|<1$, then $\eta_{\mathbf{v}}=-2 i \gamma v\left(\varphi^{*}, \partial_{3} \varphi\right)$ and $\eta_{\mathbf{v}}^{\prime}=0$. In this case, conditions C2 and C3 are fulfilled, and condition $\mathbf{C} 1$ is equivalent to the condition $\left(\varphi^{*}, \partial_{3} \varphi\right)=0$.

Denote by $P=\left(P^{1}, P^{2}, P^{3}\right)$ the momentum operator, where $P^{\beta}=\int T^{0 \beta} d x$, and $T^{\alpha \beta}$ $(\alpha, \beta=0,1,2,3,4)$ denotes the energy-momentum tensor for the (KGD) model. Using formula (13) from [26] for the tensor $T^{\alpha \beta}$, we have

$$
P \equiv P(\psi, \chi)=-\int\left(i \psi^{*}(t, x) \nabla \psi(t, x)+\dot{\chi}(t, x) \nabla \chi(t, x)\right) d x .
$$

Put $P_{\mathbf{v}}:=P\left(\psi_{\mathbf{v}}, \chi_{\mathbf{v}}\right), \mathbf{v} \in \mathbb{R}^{3}$. We impose conditions $\mathbf{C 1}$ ' and $\mathbf{C} 2$ ' on $\varphi_{\omega}$ (see Section 3). Moreover, we assume the additional condition C3' on $\chi_{0}$.
C3. Let $\mathbf{v}=\left(v_{1}, v_{2}, v_{3}\right) \in \mathbb{R}^{3}$. For any $k=1,2,3, \sum_{j: j \neq k} v_{j} \int \partial_{k} \chi_{0}(y) \partial_{j} \chi_{0}(y) d y=0$.
Note that conditions $\mathbf{C 1}{ }^{\prime}-\mathbf{C} 3^{\prime}$ are fulfilled for the particular ansatz of solutions $\varphi \equiv \varphi_{\omega}$ considered in Section 6.1.1.

Lemma 6.6 Let conditions $\mathbf{C 1}{ }^{\prime} \mathbf{C}$ ' hold. Then $P_{\mathbf{v}}=\gamma \mathbf{v} \mathcal{E}_{0}$.
Proof Using (6.15) and (3.7), we rewrite the term in $P_{\mathbf{v}}$ corresponding to $\psi_{\mathbf{v}}$,

$$
\begin{aligned}
P\left(\psi_{\mathbf{v}}\right) & :=-i \int \psi_{\mathbf{v}}^{*}(t, x) \nabla \psi_{\mathbf{v}}(t, x) d x \\
& =-i \int \varphi^{*}(y)(\alpha \cdot \mathbf{v}+I)(i \omega \gamma \mathbf{v} \varphi(y)+\nabla \varphi(y)+\mathbf{v} \kappa \nabla \varphi(y) \cdot \mathbf{v}) d y
\end{aligned}
$$

where $\kappa=(\gamma-1) /\left(|\mathbf{v}|^{2}\right)$. Applying (6.8) and (6.9), we obtain (cf (5.34))

$$
\begin{equation*}
P\left(\psi_{\mathbf{v}}\right)=\mathbf{v} \gamma \mathcal{E}_{0}-\left(P_{1} v_{1}, P_{2} v_{2}, P_{3} v_{3}\right)-\mathbf{v} \kappa \sum_{j=1}^{3} v_{j}^{2} P_{j}-i \xi_{\mathbf{v}} \tag{6.20}
\end{equation*}
$$

where $\xi_{\mathrm{v}}$ is defined in (3.19). By conditions $\mathbf{C} 1^{\prime}$ and $\mathbf{C} 2^{\prime}, \xi_{\mathbf{v}}=0$.
Further, the second term in $P_{\mathbf{v}}$ corresponding to $\chi_{\mathbf{v}}$ is

$$
\begin{align*}
P\left(\chi_{\mathbf{v}}\right) & :=-\int \dot{\chi}_{\mathbf{v}}(t, x) \nabla \chi_{\mathbf{v}}(t, x) d x=\int\left(\nabla \chi_{0}(y) \cdot \mathbf{v}\right)\left(\nabla \chi_{0}(y)+\mathbf{v} \kappa \nabla \chi_{0}(y) \cdot \mathbf{v}\right) d y \\
& =\left(P_{1} v_{1}, P_{2} v_{2}, P_{3} v_{3}\right)+\mathbf{v} \kappa \sum_{j=1}^{3} v_{j}^{2} P_{j}+\xi_{\mathbf{v}}^{\prime} \tag{6.21}
\end{align*}
$$

where $\xi_{\mathbf{v}}^{\prime}$ stands for the following vector

$$
\begin{aligned}
\xi_{\mathbf{v}}^{\prime}:= & \left(\sum_{j \neq 1} v_{j} \int \partial_{j} \chi_{0} \partial_{1} \chi_{0} d y, \sum_{j \neq 2} v_{j} \int \partial_{j} \chi_{0} \partial_{2} \chi_{0} d y, \sum_{j \neq 3} v_{j} \int \partial_{j} \chi_{0} \partial_{3} \chi_{0} d y\right) \\
& +\mathbf{v} \kappa \sum_{k, j: k \neq j} v_{k} v_{j} \int \partial_{k} \chi_{0} \partial_{j} \chi_{0} d y .
\end{aligned}
$$

By condition $\mathbf{C} 3^{\prime}, \xi_{\mathbf{v}}^{\prime}=0$. Hence, formulas (6.20) and (6.21) yield

$$
P_{\mathbf{v}}=-\int\left(i \psi_{\mathbf{v}}^{*}(t, x) \nabla \psi_{\mathbf{v}}(t, x)+\dot{\chi}_{\mathbf{v}}(t, x) \nabla \chi_{\mathbf{v}}(t, x)\right) d x=P\left(\psi_{\mathbf{v}}\right)+P\left(\chi_{\mathbf{v}}\right)=\gamma \mathbf{v} \mathcal{E}_{0}
$$
