# VANISHING OF THE HOCHSCHILD COHOMOLOGY FOR SOME SELF-INJECTIVE SPECIAL BISERIAL ALGEBRA OF RANK FOUR 

TAKAHIKO FURUYA AND TAKAO HAYAMI


#### Abstract

In this paper, we determine the dimensions of the Hochschild cohomology groups of some self-injective special biserial algebra whose Grothendieck group is of rank 4. This result provides us with a negative answer to Happel's question in H .


## 1. Introduction

Let $\Gamma$ be the following quiver with four vertices $e_{0}, e_{1}, e_{2}, e_{3}$, and eight arrows $a_{l, m}$ for $l=0,1$ and $m=0,1,2,3$ :


We consider the subscript $i$ of $e_{i}$ as modulo 4, and the subscripts $l$ and $m$ of $a_{l, m}$ as modulo 2 and 4 , respectively. Therefore, for all $l, m \in \mathbb{Z}$, the arrow $a_{l, m}$ starts at the vertex $e_{m}$ and ends with the vertex $e_{m+1}$. We write paths from left to right.

Let $K$ be an algebraically closed field, and denote by $K \Gamma$ the path algebra of $\Gamma$ over $K$. We set $x_{l}:=\sum_{m=0}^{3} a_{l, m} \in K \Gamma$ for $l=0,1$. (Hence we may consider the subscript $l$ of $x_{l}$ as modulo 2.) Then, for any $i, l \in \mathbb{Z}$ and an integer $k \geq 0$, the element $e_{i} x_{l}^{k}$ is exactly the path $a_{l, i} a_{l, i+1} \cdots a_{l, i+k-1}$ of length $k$, and hence $e_{i} x_{l}^{k}=e_{i} x_{l}^{k} e_{i+k}=x_{l}^{k} e_{i+k}$ holds.

Let $T \geq 0$ be an integer, and let $q_{i} \in K^{\times}(=K \backslash\{0\})$ for $0 \leq i \leq 3$. We always consider the subscript $i$ of $q_{i}$ as modulo 4 . Let $I=I_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ denote the ideal in $K \Gamma$ generated by the uniform elements $e_{i} x_{0} x_{1}, e_{i} x_{1} x_{0}, e_{j}\left(q_{j} x_{0}^{4 T+2}+x_{1}^{4 T+2}\right)$, and $e_{k}\left(q_{k} x_{1}^{4 T+2}+x_{0}^{4 T+2}\right)$ for $0 \leq i \leq 3, j=0,2$ and $k=1,3$, namely, $I=$ $I_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right):=\left\langle x_{l} x_{l+1}, e_{i}\left(q_{i} x_{i}^{4 T+2}+x_{i+1}^{4 T+2}\right) \mid l=0,1 ; 0 \leq i \leq 3\right\rangle$. We define the algebra $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ to be the quotient algebra $K \Gamma / I_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$. Then $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ is a self-injective special biserial algebra, and hence is of tame representation type. In particular, if $T=0$, then $A=A_{0}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ is a Koszul self-injective algebra for all $q_{i} \in K^{\times}(0 \leq i \leq 3)$ (see Proposition 2.3).

In [F2], we have found an explicit $K$-basis for the Hochschild cohomology group $\operatorname{HH}^{i}(A)(i \geq 0)$ of $A=A_{T}\left(1_{K}, 1_{K}, 1_{K}, 1_{K}\right)$ for all $T \geq 0$, and gave a presentation

[^0]by generators and relations of the Hochschild cohomology ring modulo nilpotence $\mathrm{HH}^{*}(A) / \mathcal{N}_{A}$ of $A=A_{0}\left(1_{K}, 1_{K}, 1_{K}, 1_{K}\right)$, where $\mathcal{N}_{A}$ denotes the ideal in $\mathrm{HH}^{*}(A)$ generated by all homogeneous nilpotent elements. This result shows that, for $T=0$ and $q_{i}=1_{K}(0 \leq i \leq 3), \operatorname{HH}^{*}(A) / \mathcal{N}_{A}$ is finitely generated as an algebra. In this paper, we construct an explicit projective bimodule resolution of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ by using a certain subset $\mathcal{G}^{n}(n \geq 0)$ of $K \Gamma$ found in GSZ] (see Theorem 2.5), and then compute the dimension of $\mathrm{HH}^{i}(A)(i \geq 0)$ completely for $T \geq 0$ and $q_{i}(0 \leq i \leq 3)$ such that the product $q_{0} q_{1} q_{2} q_{3} \in K^{\times}$is not a root of unity (see Theorem 3.5 (a)).

In [H], Happel has asked whether, if the Hochschild cohomology groups $\mathrm{HH}^{n}(\Lambda)$ of a finite-dimensional $K$-algebra $\Lambda$ vanish for all $n \gg 0$, then the global dimension of $\Lambda$ is finite. Recently, in the papers [BGMS, BE, PS, XZ], a negative answer to this question have been obtained, where the authors studied the Hochschild cohomology groups for certain self-injective special biserial Koszul algebras. In this paper, we verify that some of our algebras $A$ also give a negative answer to this question. In fact, the main theorem says that, if the product $q_{0} q_{1} q_{2} q_{3} \in K^{\times}$is not a root of unity, then $\mathrm{HH}^{n}(A)$ vanish for all $n \geq 3$ if and only if $T=0$ (see Theorem 3.5(b)).

Throughout this paper, for any arrow $\alpha$ in $\Gamma$, we denote its origin by $\mathfrak{o}(\alpha)$ and its terminus by $\mathfrak{t}(\alpha)$. Moreover we write $\otimes_{K}$ as $\otimes$, and denote the enveloping algebra $A^{\mathrm{op}} \otimes A$ of $A$ by $A^{\mathrm{e}}$ and the Jacobson radical of $A$ by $\mathfrak{r}_{A}$.

## 2. A projective bimodule resolution of $A$

Let $B:=K \Delta / I$ be a finite-dimensional $K$-algebra with $\Delta$ a finite quiver, and $I$ an admissible ideal in $K \Delta$. Denote by $\mathfrak{r}_{B}$ the Jacobson radical of $B$. We start by recalling the construction of a set $\mathcal{G}^{n}(n \geq 0)$ introduced in GSZ for the right $B$ module $B / \mathfrak{r}_{B}$, from which we immediately obtain a minimal projective resolution of $B / \mathfrak{r}_{B}$. Let $\mathcal{G}^{0}$ be the set of all vertices of $\Delta, \mathcal{G}^{1}$ the set of all arrows of $\Delta$ and $\mathcal{G}^{2}$ a minimal set of uniform generators of $I$. Then, in GSZ], Green, Solberg and Zacharia proved that, for $n \geq 3$, we can construct a set $\mathcal{G}^{n}$ of uniform elements in $K \Delta$ such that there is a minimal projective resolution $\left(P^{\bullet}, d\right)$ of the right $B$-module $B / \mathfrak{r}_{B}$ satisfying the following conditions:
(i) For all $n \geq 0$, we have $P^{n}=\bigoplus_{x \in \mathcal{G}^{n}} \mathfrak{t}(x) B$.
(ii) For each $x \in \mathcal{G}^{n}$, there are unique elements $r_{y}, s_{z} \in K \Delta$, where $y \in \mathcal{G}^{n-1}$ and $z \in \mathcal{G}^{n-2}$, such that $x=\sum_{y \in \mathcal{G}^{n-1}} y r_{y}=\sum_{z \in \mathcal{G}^{n-2}} z s_{z}$.
(iii) For all $n \geq 1, d^{n}: P^{n} \rightarrow P^{n-1}$ is determined by $d^{n}(\mathfrak{t}(x)):=\sum_{y \in \mathcal{G}^{n-1}} r_{y} \mathfrak{t}(x)$ for $x \in \mathcal{G}^{n}$, where $r_{y}$ denotes the element of (ii).
In this section, we provide a set $\mathcal{G}^{n}(n \geq 0)$ for the right $A$-module $A / \mathfrak{r}_{A}$, and then use it to give a projective bimodule resolution $\left(R^{\bullet}, \partial\right)$ of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$. For $v \in \mathbb{Z}$ and $u \geq 1$, we denote the product $\prod_{t=0}^{u-1} q_{t+v}$ in $K$ by $S_{u, v}$. (Thus the right lower subscript $v$ of $S_{u, v}$ can be considered as modulo 4.) Furthermore, for our convenience, we set $S_{0, t}:=1_{K}$ for all $t \in \mathbb{Z}$. Note that $S_{r, u} S_{t, r+u}=S_{r+t, u}$, $S_{t, u} S_{t, u+1} S_{t, u+2} S_{t, u+3}=S_{2 t, v} S_{2 t, v+2}=S_{4 t, w}=\left(q_{0} q_{1} q_{2} q_{3}\right)^{t}$, and $S_{2 t, 2 t+u}=S_{2 t, u+2}$ hold for all $u, v, w \in \mathbb{Z}, r \geq 0$, and $t \geq 0$.
2.1. Sets $\mathcal{G}^{n}$ for $A / \mathfrak{r}_{A}$. First, to construct a set $\mathcal{G}^{n}$ for each $n \geq 0$, we define the elements $g_{i, j}^{n}(0 \leq i \leq 3 ; 0 \leq j \leq n)$ in $K \Gamma$ as follows. Here, recall that the subscript $l$ of $x_{l}$ is considered as modulo 2 .

Definition 2.1. For $0 \leq i \leq 3$, and $0 \leq j \leq n$, we recursively define the uniform element $g_{i, j}^{n}$ in $K \Gamma$ by the following formulas:
(a) If $n=0$, then $g_{i, 0}^{0}:=e_{i}$.
(b) If $n=2 m+1$ for $m \geq 0$, then

g_{i, j}^{2 m+1}:= \begin{cases}g_{i, 0}^{2 m} x_{i} & \text { if } j=0 \\ S_{2 m-j+1, i+j-1} g_{i, j-1}^{2 m} x_{i+1}^{4 T+1}+g_{i, j}^{2 m} x_{i} & \text { if } 1 \leq j \leq m \\ S_{2 m-j+1, i+j-1} g_{i, j-1}^{2 m} x_{i+1}+g_{i, j}^{2 m} x_{i}^{4 T+1} & \text { if } m+1 \leq j \leq 2 m \\ g_{i, 2 m}^{2 m} x_{i+1} & \text { if } j=2 m+1\end{cases}
$$

(c) If $n=2 m$ for $m \geq 1$, then

$$
g_{i, j}^{2 m}:= \begin{cases}g_{i, 0}^{2 m-1} x_{i+1} & \text { if } j=0 \\ S_{2 m-j, i+j-1} g_{i, j-1}^{2 m-1} x_{i}^{4 T+1}+g_{i, j}^{2 m-1} x_{i+1} & \text { if } 1 \leq j \leq m-1 \\ S_{m, i+m-1} g_{i, m-1}^{2 m-1} x_{i}^{4 T+1}+g_{i, m}^{2 m-1} x_{i+1}^{4 T+1} & \text { if } j=m \\ S_{2 m-j, i+j-1} g_{i, j-1}^{2 m-1} x_{i}+g_{i, j}^{2 m-1} x_{i+1}^{4 T+1} & \text { if } m+1 \leq j \leq 2 m-1 \\ g_{i, 2 m-1}^{2 m-1} x_{i} & \text { if } j=2 m .\end{cases}
$$

Note that $\mathfrak{o}\left(g_{i, j}^{n}\right)=e_{i}$ for all $n \geq 0,0 \leq i \leq 3$ and $0 \leq j \leq n$, and also, if $i+n \equiv t$ $(\bmod 4)$, then $\mathfrak{t}\left(g_{i, j}^{n}\right)=e_{t}$. (So, it can be considered the left lower subscript $i$ of $g_{i, j}^{n}$ as modulo 4.)

Now set

$$
\mathcal{G}^{n}:=\left\{g_{i, j}^{n} \mid 0 \leq i \leq 3 ; 0 \leq j \leq n\right\} \quad \text { for all } n \geq 0
$$

Then, noting $e_{i+2 m-1}\left(q_{i+2 m-1} x_{i+1}^{4 T+2}+x_{i}^{4 T+2}\right)=e_{i+2 m-2}\left(q_{i+2 m-2} x_{i}^{4 T+2}+x_{i+1}^{4 T+2}\right)=$ 0 in $A$ for $0 \leq i \leq 3$ and $m \geq 1$, we see that the sets $\mathcal{G}^{n}$ satisfy the conditions (i), (ii), and (iii) in the beginning of this section.

Remark 2.2. It follows that $\mathcal{G}^{0}=\left\{e_{i} \mid 0 \leq i \leq 3\right\}, \mathcal{G}^{1}=\left\{a_{l, m} \mid l=0,1 ; 0 \leq m \leq\right.$ $3\}$, and $\mathcal{G}^{2}=\left\{e_{i} x_{l} x_{l+1}, e_{i}\left(x_{i+1}^{4 T+2}+q_{i} x_{i}^{4 T+2}\right) \mid l=0,1 ; 0 \leq i \leq 3\right\}$, so that $\mathcal{G}^{2}$ is precisely a minimal set of uniform generators of $I=I_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$.
Now we notice, in the case where $T=0$, that the resolution $\left(P^{\bullet}, d\right)$ determined by (i), (ii) and (iii) in the beginning of this section is a linear resolution of $A / \mathfrak{r}_{A}$, and hence we have the following:
Proposition 2.3. For any $q_{i} \in K^{\times}(0 \leq i \leq 3)$, the algebra $A=A_{0}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ is a self-injective Koszul algebra.
2.2. A projective bimodule resolution of $A$. We now construct a minimal projective bimodule resolution $\left(R^{\bullet}, \partial\right)$ for $A$ by using the sets $\mathcal{G}^{n}$. For simplicity, we denote by $\mathfrak{p}_{i, j}^{n}$ the element $\mathfrak{o}\left(g_{i, j}^{n}\right) \otimes \mathfrak{t}\left(g_{i, j}^{n}\right)$ in $A \mathfrak{o}\left(g_{i, j}^{n}\right) \otimes \mathfrak{t}\left(g_{i, j}^{n}\right) A$ for all $n \geq 0$, $0 \leq i \leq 3$, and $0 \leq j \leq n$. (Hence we may consider the subscript $i$ of $\mathfrak{p}_{i, j}^{n}$ as modulo 4.)

First, for $n \geq 0$, define the projective $A$ - $A$-bimodule, equivalently right $A^{\mathrm{e}}$ module, $R^{n}$ by

$$
R^{n}:=\bigoplus_{g \in \mathcal{G}^{n}} A \mathfrak{o}(g) \otimes \mathfrak{t}(g) A=\bigoplus_{i=0}^{3}\left(\bigoplus_{j=0}^{n} A \mathfrak{p}_{i, j}^{n} A\right)
$$

Second, let $\partial^{0}: R^{0} \rightarrow A$ be the multiplication map, and for $n \geq 1$ let $\partial^{n}: R^{n} \rightarrow$ $R^{n-1}$ be the $A$ - $A$-bimodule homomorphism determined by the following:

If $n=2 m+1$ for $m \geq 0$, then, for $0 \leq i \leq 3$ and $0 \leq j \leq 2 m+1$,

& \partial^{2 m+1}\left(\mathfrak{p}_{i, j}^{2 m+1}\right):= \\
& \begin{cases}\mathfrak{p}_{i, 0}^{2 m} x_{i}-x_{i} \mathfrak{p}_{i+1,0}^{2 m} & \text { if } j=0 \\
S_{2 m-j+1, i+j-1} \mathfrak{p}_{i, j-1}^{2 m} x_{i+1}^{4 T+1}+\mathfrak{p}_{i, j}^{2 m} x_{i} & \\
\quad-S_{j, i} x_{i} \mathfrak{p}_{i+1, j}^{2 m}-x_{i+1}^{4 T+1} \mathfrak{p}_{i+1, j-1}^{2 m} & \text { if } 1 \leq j<m+1 \\
S_{2 m-j+1, i+j-1} \mathfrak{p}_{i, j-1}^{2 m} x_{i+1}+\mathfrak{p}_{i, j}^{2 m} x_{i}^{4 T+1} \\
\quad-S_{j, i} x_{i}^{4 T+1} \mathfrak{p}_{i+1, j}^{2 m}-x_{i+1} \mathfrak{p}_{i+1, j-1}^{2 m} & \text { if } m+1 \leq j<2 m+1 \\
\mathfrak{p}_{i, 2 m}^{2 m} x_{i+1}-x_{i+1} \mathfrak{p}_{i+1,2 m}^{2 m} & \text { if } j=2 m+1\end{cases} \tag{1}
\end{align*}
$$

If $n=2 m$ for $m \geq 1$, then, for $0 \leq i \leq 3$ and $0 \leq j \leq 2 m$,

$$
\begin{aligned}
& \partial^{2 m}\left(\mathfrak{p}_{i, j}^{2 m}\right):=
\end{aligned}
$$

Remark 2.4. (a) By direct computations, it is not hard to check that $\partial^{n} \partial^{n+1}=0$ for all $n \geq 0$, and thus $\left(R^{\bullet}, \partial\right)$ is a complex of $A$ - $A$-bimodules.
(b) For $n \geq 0$, the right $A$-homomorphism $h_{n}: A / \mathfrak{r}_{A} \otimes_{A} R^{n} \rightarrow P^{n}$ determined by $\mathfrak{o}\left(g_{i, j}^{n}\right) \otimes_{A} \mathfrak{p}_{i, j}^{n} \mapsto \mathfrak{t}\left(g_{i, j}^{n}\right)(0 \leq i \leq 3 ; 0 \leq j \leq n)$ is an isomorphism, and the diagram

A / \mathfrak{r}_{A} \otimes_{A} R^{n+1} & \xrightarrow{i d_{A / \mathfrak{r}_{A}} \otimes_{A} \partial^{n+1}} A / \mathfrak{r}_{A} \otimes_{A} R^{n} \\
h_{n+1} \downarrow \simeq & \simeq \downarrow_{n} \\
P^{n+1} & \xrightarrow{d^{n+1}}
\end{array}
$$

is commutative. Therefore it follows that the complex $\left(A / \mathfrak{r}_{A} \otimes_{A} R^{\bullet}, i d_{A / \mathfrak{r}_{A}} \otimes_{A} \partial\right)$ is a minimal projective resolution of the right $A$-module $A / \mathfrak{r}_{A} \otimes_{A} A\left(\simeq A / \mathfrak{r}_{A}\right)$.
Now, using Remark 2.4 we can provide a projective bimodule resolution of $A$ :
Theorem 2.5. The complex $\left(R^{\bullet}, \partial\right)$ is a minimal projective bimodule resolution of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ for all $T \geq 0$ and $q_{0}, q_{1}, q_{2}, q_{3} \in K^{\times}$.
The proof is similar to that found in some recent works, for example ES, F1, F2, SS, ST, and so we omit it.

## 3. The Hochschild cohomology groups of $A$

In this section, we compute the dimensions of the Hochschild cohomology groups of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ by using the projective bimodule resolution $\left(R^{\bullet}, \partial\right)$ of Section2. Throughout this section, we keep the notation from the previous sections.

Recall that, for $n \geq 0$, the $n$th Hochschild cohomology group $\operatorname{HH}^{n}(A)$ of $A$ is defined to be the $K$-space $\operatorname{HH}^{n}(A):=\operatorname{Ext}_{A^{e}}^{n}(A, A)$. We set $(-)^{*}:=\operatorname{Hom}_{A^{e}}(-, A)$, for simplicity. Then, for $n \geq 0$, there is the following exact sequence of $K$-spaces:

\begin{equation*}
0 \rightarrow\left(\operatorname{Ker} \partial^{n-1}\right)^{*} \longrightarrow\left(R^{n}\right)^{*} \xrightarrow{i_{n}^{*}}\left(\operatorname{Ker} \partial^{n}\right)^{*} \longrightarrow \operatorname{HH}^{n+1}(A) \rightarrow 0 \tag{3}
\end{equation*}
$$

where $\operatorname{Ker} \partial^{-1}:=A$, and $i_{n}$ denotes the inclusion map. Hence, to give the dimensions of the Hochschild cohomology groups, it suffices to calculate the dimensions of $\left(R^{n}\right)^{*}$ and $\left(\operatorname{Ker} \partial^{n+1}\right)^{*}$.
3.1. The dimension of $\operatorname{Hom}_{A^{\mathrm{e}}}\left(R^{n}, A\right)$. We first find the dimension of $\left(R^{n}\right)^{*}:=$ $\operatorname{Hom}_{A^{\mathrm{e}}}\left(R^{n}, A\right)$ for $n \geq 0$.
Definition 3.1. Let $n \geq 0$ be an integer. For $l=0,1,0 \leq i \leq 3$ and $0 \leq j \leq n$, and for $\left\{\begin{array}{ll}0 \leq k \leq T & \text { if } n \not \equiv 3(\bmod 4) \\ 0 \leq k \leq T-1 & \text { if } T \geq 1 \text { and } n \equiv 3(\bmod 4),\end{array}\right.$ we define the $A$ - $A$-bimodule homomorphisms $\beta_{l, i, j}^{n, k}: R^{n} \rightarrow A$ by: for $0 \leq r \leq 3$ and $0 \leq s \leq n$,

$$
\beta_{l, i, j}^{n, k}\left(\mathfrak{p}_{r, s}^{n}\right):= \begin{cases}e_{i} x_{l}^{4 k+t} & \text { if } r=i, s=j, \text { and } n \equiv t(\bmod 4) \text { for } 0 \leq t \leq 3 \\ 0 & \text { otherwise } .\end{cases}
$$

Here we may consider the subscripts $l$ and $i$ of $\beta_{l, i, j}^{n, k}$ as modulo 2 and 4 , respectively. Note that, for $u \geq 0$ and $0 \leq i \leq 3, \beta_{0, i, j}^{4 u, 0}=\beta_{1, i, j}^{4 u, 0}(0 \leq j \leq 4 u)$ and $\beta_{i+1, i, j}^{4 u+2, T}=$ $-q_{i} \beta_{i, i, j}^{4 u+2, T}(0 \leq j \leq 4 u+2)$ hold.

Now recall that, for $n \geq 0$, the map $G_{n}: \bigoplus_{g \in \mathcal{G}^{n}} \mathfrak{o}(g) A \mathfrak{t}(g) \rightarrow\left(R^{n}\right)^{*}$ determined by $\left(G_{n}\left(\sum_{g \in \mathcal{G}^{n}} z_{g}\right)\right)\left(\mathfrak{p}_{i, j}^{n}\right)=z_{g_{i, j}^{n}}$ for $z_{g} \in \mathfrak{o}(g) A \mathfrak{t}(g)\left(g \in \mathcal{G}^{n}\right), 0 \leq i \leq 3$ and $0 \leq j \leq n$, is an isomorphism of $K$-spaces. Also, for all $0 \leq i \leq 3$ and $0 \leq j \leq n$, the space $\mathfrak{o}\left(g_{i, j}^{n}\right) A \mathfrak{t}\left(g_{i, j}^{n}\right)=e_{i} A e_{i+n}$ has a $K$-basis

$$
\begin{cases}\left\{e_{i}, e_{i} x_{l}^{4 k} \mid l=0,1 ; 1 \leq k \leq T\right\} & \text { if } n \equiv 0(\bmod 4) \\ \left\{e_{i} x_{l}^{4 k+1} \mid l=0,1 ; 0 \leq k \leq T\right\} & \text { if } n \equiv 1(\bmod 4) \\ \left\{e_{i} x_{l}^{4 k+2}, e_{i} x_{0}^{4 T+2} \mid l=0,1 ; 0 \leq k \leq T-1\right\} & \text { if } n \equiv 2(\bmod 4) \\ \left\{e_{i} x_{l}^{4 k+3} \mid l=0,1 ; 0 \leq k \leq T-1\right\} & \text { if } n \equiv 3(\bmod 4) \text { and } T \geq 1\end{cases}
$$

and $\mathfrak{o}\left(g_{i, j}^{n}\right) A \mathfrak{t}\left(g_{i, j}^{n}\right)=0$ if $n \equiv 3(\bmod 4)$ and $T=0$. It is straightforward to see that the image of the $K$-basis above under $G_{n}$ is precisely the set:
and moreover $\left(R^{n}\right)^{*}=0$ if $n \equiv 3(\bmod 4)$ and $T=0$. Since the set (4) gives a $K$-basis of $\left(R^{n}\right)^{*}$, we have the following:

Lemma 3.2. For $m \geq 0$ and $0 \leq r \leq 3$,

\operatorname{dim}_{K}\left(R^{4 m+r}\right)^{*}= \begin{cases}4(2 T+1)(4 m+1) & \text { if } r=0 \\ 16(T+1)(2 m+1) & \text { if } r=1 \\ 4(2 T+1)(4 m+3) & \text { if } r=2 \\ 32 T(m+1) & \text { if } r=3\end{cases}
$$

3.2. The dimension of $\operatorname{Hom}_{A^{\mathrm{e}}}\left(\operatorname{Ker} \partial^{n}, A\right)$. Until the end of this paper, we suppose that the product $S_{4,0}=q_{0} q_{1} q_{2} q_{3}\left(\in K^{\times}\right)$is not a root of unity. Therefore $S_{4 m, t}^{k}=S_{4,0}^{m k}=\left(q_{0} q_{1} q_{2} q_{3}\right)^{k m} \neq 1_{K}$ for all $t \in \mathbb{Z}$ and integers $k \geq 0$ and $m \geq 0$.

Now, using the equations (11) and (2), we can find a $K$-basis of the kernel of $i_{n}^{*}=\operatorname{Hom}_{A^{\mathrm{e}}}\left(i_{n}, A\right)(n \geq 0)$ in (3).

Lemma 3.3. If $T=0$, then
(i) (a) The set $\left\{\sum_{j=0}^{3} \beta_{0, j, 0}^{0,0}\right\}$ gives a $K$-basis of $\operatorname{Ker} i_{0}^{*}$.
(b) For $m \geq 1, \operatorname{Ker} i_{4 m}^{*}=\{0\}$.
(ii) (a) The set $\left\{\beta_{r, r, 0}^{1,0}+\beta_{r+1, r, 1}^{1,0}-\beta_{r, r+1,1}^{1,0}-\beta_{r+1, r+1,0}^{1,0} \mid r=0,1,2\right\} \cup\left\{\beta_{0,0,0}^{1,0}+\right.$ $\left.\beta_{1,0,1}^{1,0}, \beta_{1,0,1}^{1,0}+\beta_{0,1,1}^{1,0}+\beta_{1,2,1}^{1,0}+\beta_{0,3,1}^{1,0}\right\}$ gives a $K$-basis of Ker $i_{1}^{*}$.
(b) For $m \geq 1$, the set $\left\{S_{u, r} \beta_{r, r, u}^{4 m+1,0}+\beta_{r+1, r, u+1}^{4 m+1,0}-S_{4 m-u, u+r+1} \beta_{r, r+1, u+1}^{4 m+1,0}-\right.$ $\left.\beta_{r+1, r+1, u}^{4 m+1,0} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 4 m\right\}$ gives a $K$-basis of $\operatorname{Ker} i_{4 m+1}^{*}$.
(iii) For $m \geq 0$, the set $\left\{\beta_{0, r, u}^{4 m+2,0} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 4 m+2\right\}$ gives a $K$-basis of Ker $i_{4 m+2}^{*}$.
(iv) For $m \geq 0$, $\operatorname{Ker} i_{4 m+3}^{*}=\{0\}$.

If $T \geq 1$, then
(i) (a) The set $\left\{\sum_{j=0}^{3} \beta_{0, j, 0}^{0,0}\right\} \cup\left\{\sum_{j=0}^{3} \beta_{l, j, 0}^{0, k} \mid l=0,1 ; 1 \leq k \leq T\right\}$ gives a $K$-basis of $\operatorname{Ker} i_{0}^{*}$.
(b) For $m \geq 1$, the set $\left\{S_{u, r} \beta_{r, r, u}^{4 m, k}+\beta_{r, r+1, u}^{4 m, k} \mid 0 \leq r \leq 3 ; 0 \leq u \leq\right.$ $2 m-1 ; 1 \leq k \leq T\} \cup\left\{\beta_{r, r+1, u}^{4 m, k}+S_{4 m-u, r+u+1} \beta_{r, r+2, u}^{4 m, k} \mid 0 \leq r \leq\right.$ $3 ; 2 m+1 \leq u \leq 4 m ; 1 \leq k \leq T\} \cup\left\{S_{4 m, 0} \beta_{l, l, 2 m}^{4 m, k}+S_{2 m, l+2} \beta_{l, l+1,2 m}^{4 m, k}+\right.$ $\left.S_{2 m, l+2} S_{2 m, l+3} \beta_{l, l+2,2 m}^{4 m, k}+S_{2 m, l+3} \beta_{l, l+3,2 m}^{4 m, k} \mid l=0,1 ; 1 \leq k \leq T\right\}$ gives a $K$-basis of $\operatorname{Ker} i_{4 m}^{*}$.
(ii) (a) The set $\left\{\beta_{r, r, 0}^{1, k}, \beta_{r, r+1,1}^{1, k} \mid 0 \leq r \leq 3 ; 1 \leq k \leq T\right\} \cup\left\{\beta_{0,0,0}^{1,0}+\beta_{1,0,1}^{1,0}\right\} \cup$ $\left\{\beta_{r, r, 0}^{1,0}+\beta_{r+1, r, 1}^{1,0}-\beta_{r, r+1,1}^{1,0}-\beta_{r+1, r+1,0}^{1,0} \mid r=0,1,2\right\}$

(b) For $m \geq 1$, the set $\left\{S_{u, r} \beta_{r, r, u}^{4 m+1,0}+\beta_{r+1, r, u+1}^{4 m+1, T}-S_{4 m-u, u+r+1} \beta_{r, r+1, u+1}^{4 m+1, T}-\right.$ $\left.\beta_{r+1, r+1, u}^{4 m+1,0} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 2 m-1\right\} \cup\left\{S_{u, r} \beta_{r, r, u}^{4 m+1, T}+\beta_{r+1, r, u+1}^{4 m+1,0}-\right.$ $\left.S_{4 m-u, u+r+1} \beta_{r, r+1, u+1}^{4 m+1,0}-\beta_{r+1, r+1, u}^{4 m+1, T} \mid 0 \leq r \leq 3 ; 2 m+1 \leq u \leq 4 m\right\} \cup$ $\left\{\beta_{r, r, u}^{4 m+1, k} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 2 m ; 1 \leq k \leq T\right\} \cup\left\{\beta_{r+1, r, u}^{4 m+1, k} \mid 0 \leq r \leq\right.$ $3 ; 2 m+1 \leq u \leq 4 m+1 ; 1 \leq k \leq T\} \cup\left\{S_{2 m, r} \beta_{r, r, 2 m}^{4 m+1,0}+\beta_{r+1, r, 2 m+1}^{4 m+1,0}-\right.$

(iii) For $m \geq 0$, the set $\left\{S_{u, r} \beta_{r, r, u}^{4 m+2, k}+\beta_{r, r+1, u}^{4 m+2, k} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 2 m ; 0 \leq\right.$ $k \leq T-1\} \cup\left\{\beta_{r, r+1, u}^{4 m+2, k}+S_{4 m-u+2, u+r+1} \beta_{r, r+2, u}^{4 m+2, k} \mid 0 \leq r \leq 3 ; 2 m+2 \leq u \leq\right.$ $4 m+2 ; 0 \leq k \leq T-1\} \cup\left\{S_{2 m, l} \beta_{l, l+3,2 m+1}^{4 m+2, k}+S_{2 m, l} S_{2 m+1, l+2} \beta_{l, l+2,2 m+1}^{4 m+2, k}+\right.$ $\left.S_{2 m, l+3} \beta_{l, l+1,2 m+1}^{4 m+2, k}+S_{4 m+1, l} \beta_{l, l, 2 m+1}^{4 m+2, k} \mid l=0,1 ; 0 \leq k \leq T-1\right\} \cup\left\{\beta_{0, r, u}^{4 m+2, T} \mid\right.$ $0 \leq r \leq 3 ; 0 \leq u \leq 4 m+2\}$ gives a $K$-basis of $\operatorname{Ker} i_{4 m+2}^{*}$.

Proof. We only verify (i)(b) for the case $T \geq 1$. Suppose that $T \geq 1$ and $m \geq 1$, and we put $\mathcal{B}:=\left\{S_{u, r} \beta_{r, r, u}^{4 m, k}+\beta_{r, r+1, u}^{4 m, k} \mid 0 \leq r \leq 3 ; 0 \leq u \leq 2 m-1 ; 1 \leq k \leq\right.$ $T\} \cup\left\{\beta_{r, r+1, u}^{4 m, k}+S_{4 m-u, r+u+1} \beta_{r, r+2, u}^{4 m, k} \mid 0 \leq r \leq 3 ; 2 m+1 \leq u \leq 4 m ; 1 \leq k \leq\right.$ $T\} \cup\left\{S_{4 m, 0} \beta_{l, l, 2 m}^{4 m, k}+S_{2 m, l+2} \beta_{l, l+1,2 m}^{4 m, k}+S_{2 m, l+2} S_{2 m, l+3} \beta_{l, l+2,2 m}^{4 m, k}+S_{2 m, l+3} \beta_{l, l+3,2 m}^{4 m, k} \mid\right.$ $l=0,1 ; 1 \leq k \leq T\}$. Denote by $V$ the subspace in $\left(R^{4 m}\right)^{*}$ generated by $\mathcal{B}$. It is straightforward to see that the elements in $\mathcal{B}$ are linearly independent, and so it suffices to verify $V=\operatorname{Ker} i_{4 m}^{*}$.

First, let $\psi \in \mathcal{B}$. Then it is not hard to check that $\psi$ sends all elements in (11) to zero, namely, $\psi\left(\partial^{4 m+1}\left(\mathfrak{p}_{i, j}^{4 m+1}\right)\right)=0$ for all $0 \leq i \leq 3$ and $0 \leq j \leq 4 m+1$. So we get $\psi\left(\operatorname{Ker} \partial^{4 m}\right)=\psi\left(\operatorname{Im} \partial^{4 m+1}\right)=0$, which shows $\psi \in \operatorname{Ker} i_{4 m}^{*}$, since $i_{4 m}$ is the inclusion map. Hence it follows that $V \subseteq \operatorname{Ker} i_{4 m}^{*}$.

Conversely, let $\phi \in \operatorname{Ker} i_{4 m}^{*}$. By (4), we can write $\phi=\left(\sum_{i=0}^{3} \sum_{j=0}^{4 m} v_{i, j} \beta_{0, i, j}^{4 m, 0}\right)+$ $\left\{\sum_{i=0}^{3} \sum_{j=0}^{4 m} \sum_{k=1}^{T}\left(w_{0, i, j}^{k} \beta_{0, i, j}^{4 m, k}+w_{1, i, j}^{k} \beta_{1, i, j}^{4 m, k}\right)\right\}$ for $v_{i, j}, w_{l, i, j}^{k} \in K(0 \leq i \leq 3$, $0 \leq j \leq 4 m, 1 \leq k \leq T, l=0,1$ ). We always consider the subscripts $i$ of $v_{i, j}$ and $w_{l, i, j}^{k}$ as modulo 4 , and $l$ of $w_{l, i, j}^{k}$ as modulo 2 . Since $\phi \in \operatorname{Ker} i_{4 m}^{*}$, we get $\phi\left(\operatorname{Im} \partial^{4 m+1}\right)=\phi\left(\operatorname{Ker} \partial^{4 m}\right)=0$, so that $\phi\left(\partial^{4 m+1}\left(\mathfrak{p}_{r, u}^{4 m+1}\right)\right)=0$ for $0 \leq r \leq 3$ and $0 \leq u \leq 4 m+1$. Then, by direct computations of the images of (1) under $\phi$, we get: for $0 \leq r \leq 3,\left(v_{r, 0}-v_{r+1,0}\right) e_{r} x_{r}+\sum_{k=1}^{T}\left(w_{r, r, 0}^{k}-w_{r, r+1,0}^{k}\right) e_{r} x_{r}^{4 k+1}=0$, $\left(S_{4 m-u+1, r+u-1} v_{r, u-1}-v_{r+1, u-1}\right) e_{r} x_{r+1}^{4 T+1}+\left(v_{r, u}-S_{u, r} v_{r+1, u}\right) e_{r} x_{r}+\sum_{k=1}^{T}\left(w_{r, r, u}^{k}-\right.$ $\left.S_{u, r} w_{r, r+1, u}^{k}\right) e_{r} x_{r}^{4 k+1}=0(1 \leq u \leq 2 m),\left(S_{4 m-u+1, r+u-1} v_{r, u-1}-v_{r+1, u-1}\right) e_{r} x_{r+1}+$ $\left(v_{r, u}-S_{u, r} v_{r+1, u}\right) e_{r} x_{r}^{4 T+1}+\sum_{k=1}^{T}\left(S_{4 m-u+1, r+u-1} w_{r+1, r, u-1}^{k}-w_{r+1, r+1, u-1}^{k}\right) e_{r} x_{r+1}^{4 k+1}$ $=0(2 m+1 \leq u \leq 4 m),\left(v_{r, 4 m}-v_{r+1,4 m}\right) e_{r} x_{r+1}+\sum_{k=1}^{T}\left(w_{r+1, r, 4 m}^{k}-w_{r+1, r+1,4 m}^{k}\right)$ $e_{r} x_{r+1}^{4 k+1}=0$, which give the system of equations: for $0 \leq r \leq 3$ and $1 \leq k \leq T$, $v_{r, u}-S_{u, r} v_{r+1, u}=0(0 \leq u \leq 2 m), S_{4 m-u, r+u} v_{r, u}-v_{r+1, u}=0(0 \leq u \leq 2 m-1)$, $w_{r, r, u}^{k}-S_{u, r} w_{r, r+1, u}^{k}=0(0 \leq u \leq 2 m), S_{4 m-u, r+u} v_{r, u}-v_{r+1, u}=0(2 m \leq u \leq 4 m)$, $v_{r, u}-S_{u, r} v_{r+1, u}=0(2 m+1 \leq u \leq 4 m), S_{4 m-u, r+u} w_{r+1, r, u}^{k}-w_{r+1, r+1, u}^{k}=0$ $(2 m \leq u \leq 4 m)$. So it follows, for $0 \leq r \leq 3$ and $1 \leq k \leq T$, that $v_{r, u}=0$ $(0 \leq u \leq 4 m), w_{r, r, u}^{k}=S_{u, r} w_{r, r+1, u}^{k}(0 \leq u \leq 2 m-1), S_{4 m-u, r+u} w_{r+1, r, u}^{k}=$
$w_{r+1, r+1, u}^{k}(2 m+1 \leq u \leq 4 m), S_{4 m, 0} w_{l, l+3,2 m}^{k}=S_{2 m, l} w_{l, l+2,2 m}^{k}=S_{2 m, l+3} w_{l, l, 2 m}^{k}=$ $S_{2 m, l+3} S_{2 m, l} w_{l, l+1,2 m}^{k}(l=0,1)$. Then, using these equations, $\phi$ can be written as $\phi=\left\{\sum_{r=0}^{3} \sum_{k=1}^{T} \sum_{u=0}^{2 m-1} w_{r, r+1, u}\left(S_{u, r} \beta_{r, r, u}^{4 m, k}+\beta_{r, r+1, u}^{4 m, k}\right)\right\}+\left\{\sum_{r=0}^{3} \sum_{k=1}^{T} \sum_{u=2 m+1}^{4 m}\right.$ $\left.w_{r, r+1, u}\left(\beta_{r, r+1, u}^{4 m, k}+S_{4 m-u, r+u+1} \beta_{r, r+2, u}^{4 m, k}\right)\right\}+\left\{\sum_{k=1}^{T} \sum_{l=0}^{1} S_{4 m, 0}^{-1} w_{l, l, 2 m}^{k}\left(S_{4 m, 0} \beta_{l, l, 2 m}^{4 m, k}+\right.\right.$ $\left.\left.S_{2 m, l+2} \beta_{l, l+1,2 m}^{4 m, k}+S_{2 m, l+2} S_{2 m, l+3} \beta_{l, l+2,2 m}^{4 m, k}+S_{2 m, l+3} \beta_{l, l+3,2 m}^{4 m, k}\right)\right\}$, which shows $\phi \in V$. Accordingly it follows that $\operatorname{Ker} i_{4 m}^{*} \subseteq V$.

Therefore we get the required $K$-basis. Similarly, by using (11) and (2), we can verify the remaining statements.

By the sequence (3), we get $\operatorname{dim}_{K}\left(\operatorname{Ker} \partial^{n}\right)^{*}=\operatorname{dim}_{K} \operatorname{Ker} i_{n+1}^{*}$ for $n \geq-1$ (where $\operatorname{Ker} \partial^{-1}:=A$ ), so that Lemma 3.3 gives us the dimension of $\left(\operatorname{Ker} \partial^{n}\right)^{*}$ :

Proposition 3.4. For integers $m \geq-1$ and $0 \leq r \leq 3$ with $4 m+r \geq-1$,

& \operatorname{dim}_{K}\left(\operatorname{Ker} \partial^{4 m+r}\right)^{*} \\
& = \begin{cases}2 T+1 & \text { if } m=-1 \text { and } r=3 \\
8 T+6 & \text { if } m=r=0 \text { and char } K \mid 2 T+1 \\
8 T+5 & \text { if } m=r=0 \text { and char } K \nmid 2 T+1 \\
2(8 m+3)+8 T(2 m+1) & \text { if } m \geq 1, r=0 \text { and char } K \mid 2 T+1 \\
4(4 m+1)+8 T(2 m+1) & \text { if } m \geq 1, r=0 \text { and char } K \nmid 2 T+1 \\
4(4 m+3)+2 T(8 m+5) & \text { if } m \geq 0 \text { and } r=1 \\
16 T(m+1) & \text { if } m \geq 0 \text { and } r=2 \\
2 T(8 m+9) & \text { if } m \geq 0 \text { and } r=3 .\end{cases}
\end{aligned}
$$

Now, by using the sequence (3) and Proposition 3.4 we immediately get the dimensions of the Hochschild cohomology groups of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ :

Theorem 3.5. Let $T \geq 0$ be an integer, and let $q_{i}(0 \leq i \leq 3)$ be any element in $K^{\times}$. Suppose that the product $q_{0} q_{1} q_{2} q_{3}$ is not a root of unity. Then
(a) For $m \geq 0$ and $0 \leq r \leq 3$,

$$
\operatorname{dim}_{K} \operatorname{HH}^{4 m+r}(A)= \begin{cases}2 T+1 & \text { if } m=r=0 \\ 2 T+3 & \text { if } m=0, r=1 \text { and } \operatorname{char} K \mid 2 T+1 \\ 2 T+2 & \text { if } m=0, r=1 \text { and char } K \nmid 2 T+1 \\ 2 T+2 & \text { if } m=0, r=2 \text { and char } K \mid 2 T+1 \\ 2 T+1 & \text { if } m=0, r=2 \text { and char } K \nmid 2 T+1 \\ 2 T & \text { if } m \geq 0 \text { and } r=3, \\ & \text { or if } m \geq 1 \text { and } r=0 \\ 2 T+2 & \text { if } m \geq 1, r=1 \text { and } \operatorname{char} K \mid 2 T+1, \\ & \text { or if } m \geq 1, r=2 \text { and } \operatorname{char} K \mid 2 T+1 \\ 2 T & \text { if } m \geq 1, r=1 \text { and char } K \nmid 2 T+1, \\ \text { or if } m \geq 1, r=2 \text { and } \operatorname{char} K \nmid 2 T+1 .\end{cases}
$$

(b) $\operatorname{HH}^{n}(A)=0$ for all $n \geq 3$ if and only if $T=0$.

Remark 3.6. If $T=0$, since the global dimension of $A_{0}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ is infinite for all $q_{i} \in K^{\times}(0 \leq i \leq 3)$, Theorem 3.5(b) gives us a negative answer to Happel's question stated in Section 1 .

We end this paper by describing the Hochschild cohomology ring modulo nilpotence $\mathrm{HH}^{*}(A) / \mathcal{N}_{A}$ of $A=A_{T}\left(q_{0}, q_{1}, q_{2}, q_{3}\right)$ for $T=0$, where $\mathcal{N}_{A}$ is the ideal generated by all homogeneous nilpotent elements in $\mathrm{HH}^{*}(A)$, and thus $\mathrm{HH}^{*}(A) / \mathcal{N}_{A}$ is a commutative graded algebra. As a consequence of Theorem 3.5, we get the following:
Corollary 3.7. Let $T=0$ and $q_{i} \in K^{\times}$for $0 \leq i \leq 3$. Suppose that $q_{0} q_{1} q_{2} q_{3}$ is not a root of unity. Then $\mathrm{HH}^{*}(A)$ is a 4-dimensional local algebra, and $\mathrm{HH}^{*}(A) / \mathcal{N}_{A}$ is isomorphic to $K$.
