# SWITCHINGS OF SEMIFIELD MULTIPLICATIONS

#### Abstract

Let $B(X, Y)$ be a polynomial over $\mathbb{F}_{q^{n}}$ which defines an $\mathbb{F}_{q}$-bilinear form on the vector space $\mathbb{F}_{q^{n}}$, and let $\xi$ be a nonzero element in $\mathbb{F}_{q^{n}}$. In this paper, we consider for which $B(X, Y)$, the binary operation $x y+B(x, y) \xi$ defines a (pre)semifield multiplication on $\mathbb{F}_{q^{n}}$. We prove that this question is equivalent to finding $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$ such that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$. For $n \leq 4$, we present several families of $L(X)$ and we investigate the derived (pre)semifields. When $q$ equals a prime $p$, we show that if $n>\frac{1}{2}(p-1)\left(p^{2}-p+4\right), L(X)$ must be $a_{0} X$ for some $a_{0} \in \mathbb{F}_{p^{n}}$ satisfying $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right) \neq 0$. Finally, we include a natural connection with certain cyclic codes over finite fields, and we apply the Hasse-Weil-Serre bound for algebraic curves to prove several necessary conditions for such kind of $L(X)$.


## 1. Introduction

A semifield $\mathbb{S}$ is an algebraic structure satisfying all the axioms of a skewfield except (possibly) the associativity. In other words, it satisfies the following axioms:
$(\mathrm{S} 1)(\mathbb{S},+)$ is a group, with identity element 0 ;
(S2) ( $\mathbb{S} \backslash\{0\}, *$ ) is a quasigroup;
(S3) $0 * a=a * 0=0$ for all $a$;
(S4) The left and right distributive laws hold, namely for any $a, b, c \in \mathbb{S}$,

$$
\begin{aligned}
& (a+b) * c=a * c+b * c \\
& a *(b+c)=a * b+a * c
\end{aligned}
$$

(S5) There is an element $e \in \mathbb{S}$ such that $e * x=x * e=x$ for all $x \in \mathbb{S}$.
A finite field is a trivial example of a semifield. Furthermore, if $\mathbb{S}$ does not necessarily have a multiplicative identity, then it is called a presemifield. For a presemifield $\mathbb{S},(\mathbb{S},+)$ is necessarily abelian [17]. A semifield is not necessarily commutative

[^0]or associative. However, by Wedderburn's Theorem [27], in the finite case, associativity implies commutativity. Therefore, a non-associative finite commutative semifield is the closest algebraic structure to a finite field. We refer to [18] for a recent and comprehensive survey.

The first family of non-trivial semifields was constructed by Dickson [7] more than a century ago. In [17, Knuth showed that the additive group of a finite semifield $\mathbb{S}$ is an elementary abelian group, and the additive order of the nonzero elements in $\mathbb{S}$ is called the characteristic of $\mathbb{S}$. Hence, any finite semifield can be represented by $\left(\mathbb{F}_{q},+, *\right)$, where $q$ is a power of a prime $p$. Here $\left(\mathbb{F}_{q},+\right)$ is the additive group of the finite field $\mathbb{F}_{q}$ and $x * y$ can be written as $x * y=\sum_{i, j} a_{i j} x^{p^{i}} y^{p^{j}}$, which forms a mapping from $\mathbb{F}_{q} \times \mathbb{F}_{q}$ to $\mathbb{F}_{q}$.

Geometrically speaking, there is a well-known correspondence, via coordinatisation, between (pre)semifields and projective planes of Lenz-Barlotti type V.1, see [5, 13]. In 1], Albert showed that two (pre)semifields coordinatise isomorphic planes if and only if they are isotopic.

Definition 1.1. Let $\mathbb{S}_{1}=\left(\mathbb{F}_{p}^{n},+, *\right)$ and $\mathbb{S}_{2}=\left(\mathbb{F}_{p}^{n},+, \star\right)$ be two presemifields. If there exist three bijective linear mappings $L, M, N: \mathbb{F}_{p}^{n} \rightarrow \mathbb{F}_{p}^{n}$ such that

$$
M(x) \star N(y)=L(x * y)
$$

for any $x, y \in \mathbb{F}_{p}^{n}$, then $\mathbb{S}_{1}$ and $\mathbb{S}_{2}$ are called isotopic, and the triple $(M, N, L)$ is called an isotopism between $\mathbb{S}_{1}$ and $\mathbb{S}_{2}$.

Let $\mathbb{P}=\left(\mathbb{F}_{p^{n}},+, *\right)$ be a presemifield. We can obtain a semifield from it via isotopisms in several ways, such as the well known Kaplansky's trick (see [18, page 2]). The following method was recently given by Bierbrauer [2]. Define a new multiplication $\star$ by the rule

$$
\begin{equation*}
x \star y:=B^{-1}\left(B_{1}(x) * y\right) \tag{1.1}
\end{equation*}
$$

where $B(x):=1 * x$ and $B_{1}(x) * 1=1 * x$. We have $x \star 1=B^{-1}\left(B_{1}(x) * 1\right)=$ $B^{-1}(1 * x)=x$ and $1 \star x=B^{-1}\left(B_{1}(1) * x\right)=B^{-1}(1 * x)=x$, thus $\left(\mathbb{F}_{p^{n}},+, \star\right)$ is a semifield with identity 1 . In particular, when $\mathbb{P}$ is commutative, $B_{1}$ is the identity mapping.

Let $\mathbb{S}=\left(\mathbb{F}_{p^{n}},+, *\right)$ be a semifield. The subsets

$$
\begin{aligned}
N_{l}(\mathbb{S}) & =\{a \in \mathbb{S}:(a * x) * y=a *(x * y) \text { for all } x, y \in \mathbb{S}\} \\
N_{m}(\mathbb{S}) & =\{a \in \mathbb{S}:(x * a) * y=x *(a * y) \text { for all } x, y \in \mathbb{S}\} \\
N_{r}(\mathbb{S}) & =\{a \in \mathbb{S}:(x * y) * a=x *(y * a) \text { for all } x, y \in \mathbb{S}\}
\end{aligned}
$$

are called the left, middle and right nucleus of $\mathbb{S}$, respectively. It is easy to check that these sets are finite fields. The subset $N(\mathbb{S})=N_{l}(\mathbb{S}) \cap N_{m}(\mathbb{S}) \cap N_{r}(\mathbb{S})$ is called the nucleus of $\mathbb{S}$. It is easy to see, if $\mathbb{S}$ is commutative, then $N_{l}(\mathbb{S})=N_{r}(\mathbb{S})$ and $N_{l}(\mathbb{S}) \subseteq$ $N_{m}(\mathbb{S})$, therefore $N_{l}(\mathbb{S})=N_{r}(\mathbb{S})=N(\mathbb{S})$. In [13], a geometric interpretation of these nuclei is discussed. The subset $\{a \in \mathbb{S}: a * x=x * a$ for all $x \in \mathbb{S}\}$ is called the commutative center of $\mathbb{S}$ and its intersection with $N(\mathbb{S})$ is called the center of S.

Let $G$ be a group and $N$ a subgroup. A subset $D$ of $G$ is called a relative difference set with parameters $(|G| /|N|,|N|,|D|, \lambda)$, if the list of differences of $D$ covers every element in $G \backslash N$ exactly $\lambda$ times, and no element in $N \backslash\{0\}$. We call $N$ the forbidden subgroup.

Jungnickel [15] showed that every semifield $\mathbb{S}$ of order $q$ leads to a $(q, q, q, 1)$ relative difference set $D$ in a group $G$ which is not necessarily abelian. Assume that $\mathbb{S}$ is commutative. If $q=p^{n}$ and $p$ is odd, then $G$ is isomorphic to the elementary abelian group $C_{p}^{2 n}$; if $q=2^{n}$, then $G \cong C_{4}^{n}$. $\left(C_{m}\right.$ is the cyclic group of order $m$.)

Let $p$ be an odd prime. A function $f: \mathbb{F}_{p^{n}} \rightarrow \mathbb{F}_{p^{n}}$ is called planar, if the mapping

$$
x \mapsto f(x+a)-f(x)
$$

is a permutation of $\mathbb{F}_{p^{n}}$ for every $a \in \mathbb{F}_{p^{n}}^{*}$. Planar functions were first defined by Dembowski and Ostrom in [6]. It is not difficult to verify that planar functions over $\mathbb{F}_{p^{n}}$ are equivalent to $\left(p^{n}, p^{n}, p^{n}, 1\right)$-relative difference sets in $C_{p}^{2 n}$. Planar functions over $\mathbb{F}_{2^{n}}$, introduced recently in [25, 29], has a slightly different definition: A function $f: \mathbb{F}_{2^{n}} \rightarrow \mathbb{F}_{2^{n}}$ is called planar, if the mapping

$$
x \mapsto f(x+a)+f(x)+a x
$$

is a permutation of $\mathbb{F}_{2^{n}}$ for every $a \in \mathbb{F}_{2^{n}}^{*}$. They are equivalent to $\left(2^{n}, 2^{n}, 2^{n}, 1\right)$ relative difference sets in $C_{4}^{n}$; see [29, Theorem 2.1].

Let $f$ be a planar function over $\mathbb{F}_{q^{n}}$, where $q$ is a power of prime. A switching of $f$ is a planar function of the form $f+g \xi$ where $g$ is a mapping from $\mathbb{F}_{q^{n}}$ to $\mathbb{F}_{q}$ and $\xi \in \mathbb{F}_{q^{n}}^{*}$. Switchings of planar functions over $\mathbb{F}_{p^{n}}$, where $p$ is an odd prime, were investigated by Pott and the third author in [24]. In [29], it is proved that switchings of the planar function $f(x)=0$ defined over $\mathbb{F}_{2^{n}}$ can be written as affine polynomials $\sum a_{i} x^{2^{i}}+b$, which are equivalent to $f(x)$ itself.

In the present paper, we will investigate the switchings of (pre)semifield multiplications. To be precise, we will consider when the binary operation

$$
x * y=x \star y+B(x, y) \xi
$$

on $\mathbb{F}_{q^{n}}$ defines a (pre)semifield multiplication, where $\star$ is a given (pre)semifield multiplication, $\xi \in \mathbb{F}_{q^{n}}^{*}$ and $B(x, y)$ is an $\mathbb{F}_{q^{-}}$-bilinear form from $\mathbb{F}_{q^{n}} \times \mathbb{F}_{q^{n}}$ to $\mathbb{F}_{q}$. (One may identify $\mathbb{F}_{q^{n}}$ with $\mathbb{F}_{q}^{n}$, although it is not necessary.) We call $x * y$ a switching neighbour of $x \star y$. In particular, we will concentrate on the case in which $\star$ is the multiplication of a finite field.

In Section [2, we show that finding $B$ such that $x * y:=x y+B(x, y) \xi$ defines a (pre)semifield multiplication is equivalent to finding $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$ such that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$. For $n \leq 4$, we give in Section 3 several $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$ satisfying this condition and we discuss the presemifields of the corresponding switchings. In Section 4 we prove that when $q=p$ is a prime and $n>(p-1)\left(p^{2}-p+4\right) / 2$, the only $L(X)$ satisfying the above condition are those of the form $\beta X$ where $\operatorname{Tr}_{p^{n} / p}(\beta) \neq 0$. In Section 5 we explore a connection of the $q$-linearized polynomials $L(X)$ satisfying the above condition with certain cyclic codes over $\mathbb{F}_{q}$. Finally, in Section 6 we derive several necessary conditions for the existence of the $q$-linearized polynomials $L(X)$ from the Hasse-Weil-Serre bound for algebraic curves over finite fields.

## 2. Preliminary discussion

Let $\operatorname{Tr}_{q^{n} / q}$ be the trace function from $\mathbb{F}_{q^{n}}$ to $\mathbb{F}_{q}$. We define

$$
B(x, y):=\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right), \quad x, y \in \mathbb{F}_{q^{n}}
$$

where $b_{i} \in \mathbb{F}_{q^{n}}$. It is easy to see that $B(x, y)$ defines an $\mathbb{F}_{q^{\prime}}$-bilinear form from $\mathbb{F}_{q^{n}} \times \mathbb{F}_{q^{n}}$ to $\mathbb{F}_{q}$, and every such bilinear form can be written in this way.

In the next theorem, we consider the switchings of a finite field multiplication.
Theorem 2.1. Let $x * y:=x y+B(x, y) \xi$, where $B(x, y):=\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right)$, $b_{i} \in \mathbb{F}_{q^{n}}$, and $\xi \in \mathbb{F}_{q^{n}}^{*}$. Then $*$ defines a presemifield multiplication on $\mathbb{F}_{q^{n}}$ if and only if for any $a \in \mathbb{F}_{q^{n}}^{*}, \operatorname{Tr}_{q^{n} / q}(M(a) / a) \neq-1$, where $M(X):=\xi \sum_{i=0}^{n-1} b_{i} X^{q^{i}} \in$ $\mathbb{F}_{p^{n}}[X]$.
Proof. $(\Rightarrow)$ Let $x * y$ be a presemifield multiplication. Assume to the contrary that there is $a \in \mathbb{F}_{q^{n}}^{*}$ such that

$$
\operatorname{Tr}_{q^{n} / q}(M(a) / a)=-1
$$

We consider the equation $x * a=0$. It has a solution $x$ if and only if there exists $u \in \mathbb{F}_{q}$ such that

$$
\begin{align*}
x a & =\xi u \quad \text { and }  \tag{2.1}\\
B(x, a) & =-u . \tag{2.2}
\end{align*}
$$

Plugging (2.1) into (2.2), we have $B(\xi u / a, a)=-u$, which means that

$$
u \operatorname{Tr}_{q^{n} / q}\left(\xi \sum_{i=0}^{n-1} b_{i} a^{q^{i}-1}\right)=-u
$$

i.e.

$$
u \operatorname{Tr}_{q^{n} / q}(M(a) / a)=-u
$$

which holds for any $u \in \mathbb{F}_{q}$ according to our assumption. Therefore, $x * a=0$ has a nonzero solution. It contradicts our assumption that $*$ defines a presemifield multiplication.
$(\Leftarrow)$ It is easy to see that the left and right distributivity of the multiplication $*$ hold. We only need to show that for any $a \neq 0, x * a=0$ if and only if $x=0$. This is achieved by reversing the first part of the proof.

Let $x * y$ be the multiplication defined in Theorem 2.1. Then it is straightforward to verify that the presemifield $\left(\mathbb{F}_{q^{n}},+, *\right)$ is isotopic to $\left(\mathbb{F}_{q^{n}},+, \star\right)$, where

$$
x \star y:=x y+B^{\prime}(x, y)
$$

and $B^{\prime}(x, y)=\operatorname{Tr}_{q^{n} / q}\left(\xi \sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right)$. Therefore, we can restrict ourselves to the switchings of finite field multiplications with $\xi=1$.

For the switchings

$$
x \star y+B(x, y) \xi
$$

of a (pre)semifield multiplication $\star$, it is difficulty to obtain explicit conditions on $B(x, y)$. The reason is that generally we can not explicitly write down the solution of $x \star a=\xi u$ as we $\operatorname{did}$ for (2.1).

Let $\alpha$ be an element in $\mathbb{F}_{q^{n}}$ such that $\operatorname{Tr}_{q^{n} / q}(\alpha)=1$. To find $M(X)$ satisfying the condition in Theorem 2.1 we only need to consider the $q$-linearized polynomial $L(X):=M(X)+\alpha X \in \mathbb{F}_{q^{n}}[X]$ such that

$$
\begin{equation*}
\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0 \quad \text { for all } x \in \mathbb{F}_{q^{n}}^{*} \tag{2.3}
\end{equation*}
$$

Obviously, when $L(X)=\beta X$, where $\operatorname{Tr}_{q^{n} / q}(\beta) \neq 0$, we have $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for every nonzero $x$. The question is whether there are other $L$ 's. We will give several results concerning this question throughout Sections 3-6,

The proof of next proposition is also straightforward.
Proposition 2.2. Let $L(X)=\sum_{i=0}^{n-1} a_{i} X^{q^{i}} \in \mathbb{F}_{q^{n}}[X]$. If $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$, then the mapping $x \mapsto L(x)$ is a permutation of $\mathbb{F}_{q^{n}}$.

We include several lemmas which will be used later to investigate the commutativity of presemifield multiplications.

Lemma 2.3. Let $x * y:=x y+B(x, y)$, where $B(x, y):=\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right), b_{i} \in$ $\mathbb{F}_{q^{n}}$. Then $*$ is commutative if and only if $b_{i} \in \mathbb{F}_{q^{\operatorname{gcd}(i, n)}}$ for every $i=0,1, \ldots, n-1$.

Proof. Clearly, $x * y=y * x$ if and only if $B(x, y)=B(y, x)$, i.e.

$$
\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right)=\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} y x^{q^{i}}\right)
$$

which means that

$$
\operatorname{Tr}_{q^{n} / q}\left(x \sum_{i=0}^{n-1}\left(b_{i}-b_{i}^{q^{i}}\right) y^{q^{i}}\right)=0
$$

for every $x, y \in \mathbb{F}_{q^{n}}$. Therefore $*$ is commutative if and only if $b_{i}=b_{i}^{q^{i}}$ for every $i$.

It is possible that a non-commutative presemifield $\mathbb{P}$ is isotopic to a commutative presemifield. We can use the next criterion given by Bierbrauer [2], as a generalization of Ganley's criterion [8], to test whether this happens.

Lemma 2.4. A presemifield $(\mathbb{P},+, *)$ is isotopic to a commutative semifield if and only if there is some nonzero $v$ such that $A(v * x) * y=A(v * y) * x$, where $A$ : $\mathbb{F}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}$ is defined by $A(x) * 1=x$.

Given an arbitrary presemifield multiplication, it is not easy to get the explicit expression for $A(x)$. However, we can do it for the switchings of multiplications of finite fields.

Lemma 2.5. Let $x * y:=x y+B(x, y)$ be a switching of $\mathbb{F}_{q^{n}}$, where $B(x, y):=$ $\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} x y^{q^{i}}\right), b_{i} \in \mathbb{F}_{q^{n}}$. Let $A: \mathbb{F}_{q^{n}} \rightarrow \mathbb{F}_{q^{n}}$ be such that $A(x) * 1=x$ for every $x \in \mathbb{F}_{q^{n}}$. Then

$$
\begin{equation*}
A(x)=x+\operatorname{Tr}_{q^{n} / q}\left(\frac{-t x}{1+\operatorname{Tr}_{q^{n} / q}(t)}\right) \tag{2.4}
\end{equation*}
$$

where $t=\sum_{i=0}^{n-1} b_{i}$.
Proof. First, we have

$$
\begin{aligned}
u * 1 & =u+B(u, 1) \\
& =u+\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} b_{i} u\right) \\
& =u+\operatorname{Tr}_{q^{n} / q}(t u) .
\end{aligned}
$$

It is worth noting that $1 * 1=1+\operatorname{Tr}_{q^{n} / q}(t) \neq 0$. Let $s:=-t /\left(1+\operatorname{Tr}_{q^{n} / q}(t)\right)$. Replacing $u$ by the expression in (2.4), we have

$$
\begin{aligned}
A(x) * 1 & =x+\operatorname{Tr}_{q^{n} / q}(s x)+\operatorname{Tr}_{q^{n} / q}\left[t x+t \operatorname{Tr}_{q^{n} / q}(s x)\right] \\
& =x+\operatorname{Tr}_{q^{n} / q}\left[s\left(1+\operatorname{Tr}_{q^{n} / q}(t)\right) x+t x\right] \\
& =x .
\end{aligned}
$$

3. SWITChings of $\mathbb{F}_{q^{n}}$ FOR SmALL $n$

In this section, we investigate the switchings of finite fields $\left(\mathbb{F}_{q^{n}},+, \cdot\right)$ where $n \leq 4$.
Lemma 3.1. Let $L(X)=a_{1} X^{q}+a_{0} X \in \mathbb{F}_{q^{2}}[X]$. Then the polynomial

$$
f(X)=\operatorname{Tr}_{q^{2} / q}(L(X) / X)
$$

has no root in $\mathbb{F}_{q^{2}}^{*}$ if and only if the equation $x^{q-1}=y$ has no solution $x \in \mathbb{F}_{q^{2}}^{*}$ for every $y \in \mathbb{F}_{q^{2}}$ satisfying

$$
\begin{equation*}
a_{1} y^{2}+\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) y+a_{1}^{q}=0 \tag{3.1}
\end{equation*}
$$

Proof. Let $y:=x^{q-1}$, where $x \in \mathbb{F}_{q^{2}}^{*}$. Then

$$
\begin{aligned}
\operatorname{Tr}_{q^{2} / q}(L(x) / x) & =\operatorname{Tr}_{q^{2} / q}\left(a_{1} x^{q-1}+a_{0}\right) \\
& =\operatorname{Tr}_{q^{2} / q}\left(a_{1} y+a_{0}\right) \\
& =a_{1}^{q} y^{q}+a_{1} y+\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) \\
& =y^{q}\left(a_{1} y^{2}+\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) y+a_{1}^{q}\right)
\end{aligned}
$$

since $y^{q+1}=1$. Therefore, $f$ has a nonzero root if and only if there exists a $(q-1)$-th power in $\mathbb{F}_{q^{2}}^{*}$ satisfying (3.1).
Theorem 3.2. Let $L(X)=a_{1} X^{q}+a_{0} X \in \mathbb{F}_{q^{2}}[X]$. Then

$$
\begin{equation*}
f(X)=\operatorname{Tr}_{q^{2} / q}(L(X) / X) \tag{3.2}
\end{equation*}
$$

has no root in $\mathbb{F}_{q^{2}}^{*}$ if and only if $g(X)=X^{2}+\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) X+a_{1}^{q+1} \in \mathbb{F}_{q}[X]$ has two distinct roots in $\mathbb{F}_{q}$.
Proof. If $a_{1}=0$, then $f(X)=\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)$ and $g(X)=X^{2}+\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) X$. It is clear that $f$ has no nonzero roots if and only if $g$ has two distinct roots.

In the rest of the proof, we assume that $a_{1} \neq 0$.
$(\Leftarrow)$ Let $a_{1} y \in \mathbb{F}_{q}\left(y \in \mathbb{F}_{q^{2}}\right)$ be a root of $g$. By Lemma 3.1, it suffices to show that $y^{q+1} \neq 1$.

Case 1. Assume that $q$ is even. Since $g$ has two distinct roots, we have $\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) \neq 0$. Since

$$
\left(a_{1} y\right)^{q+1}=\left(a_{1} y\right)^{2}=\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) a_{1} y+a_{1}^{q+1}
$$

we have

$$
y^{q+1}=1+\frac{\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) y}{a_{1}^{q}} \neq 1
$$

Case 2. Assume that $q$ is odd. We have $y=\frac{1}{2 a_{1}}\left(-\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)+d\right)$, where $d \in \mathbb{F}_{q}^{*}$ and $d^{2}=\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}-4 a_{1}^{q+1}$. Suppose to the contrary that $y^{q+1}=1$. It follows that

$$
\left(-\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)+d\right)^{q+1}=4 a_{1}^{q+1}
$$

which means

$$
\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}+d^{2}-2 d \operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)=4 a_{1}^{q+1}
$$

Hence

$$
2 d^{2}-2 d \operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)=0
$$

Therefore $d=\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)$. But then $d^{2}=\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2} \neq \operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}-4 a_{1}^{q+1}$, which is a contradiction.
$(\Rightarrow)$ We first show that $g$ is reducible in $\mathbb{F}_{q}[x]$. Otherwise, let $a_{1} y \in \mathbb{F}_{q^{2}} \backslash \mathbb{F}_{q}$ be a root of $g$. Then $\left(a_{1} y\right)^{q+1}=a_{1}^{q+1}$, thus $y^{q+1}=1$. By Lemma 3.1] $f$ has nonzero roots.

It remains to show that $\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}-4 a_{1}^{q+1} \neq 0$. Assume to the contrary that $\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}-4 a_{1}^{q+1}=0$.

Case 1. Assume that $q$ is even. It follows that $\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)=0$. Write $a_{1}=x^{2}$, where $x \in \mathbb{F}_{q^{2}}$, and let $y=x^{q-1}$. Then $a_{1} y$ is a root of $g$, which leads to a contradiction.

Case 2. Assume that $q$ is odd. Then $a_{1} y=-\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right) / 2$ is a root of $g$, and

$$
y^{q+1}=\frac{\operatorname{Tr}_{q^{2} / q}\left(a_{0}\right)^{2}}{4 a_{1}^{q+1}}=1
$$

which is impossible by Lemma 3.1.
Remark. When $n=2$, if there is some $L(X)$ such that (3.2) has no root in $\mathbb{F}_{q^{2}}^{*}$, then we can define a presemifield multiplication $*$ over $\mathbb{F}_{q^{2}}$ via Theorem 2.1. Let $\mathbb{S}=\left(\mathbb{F}_{q^{2}},+, \star\right)$ be a semifield which is isotopic to $\left(\mathbb{F}_{q^{2}},+, *\right)$. We may assume that $\star$ is defined by (1.1) and hence $\mathbb{S}$ has identity 1 . There are $a_{i j} \in \mathbb{F}_{q^{2}}$ such that $x * y=\sum_{i, j} a_{i j} x^{q^{i}} y^{q^{j}}$ for all $x, y \in \mathbb{F}_{q^{2}}$. Thus there are $b_{i j} \in \mathbb{F}_{q^{2}}$ such that $x \star y=\sum_{i, j} b_{i j} x^{q^{i}} y^{q^{j}}$ for all $x, y \in \mathbb{F}_{q^{2}}$. It follows that the center of $\mathbb{S}$ contains $\mathbb{F}_{q}$. (For $x \in \mathbb{F}_{q}$ and $y \in \mathbb{F}_{q^{2}}$, we have $x \star y=x(1 \star y)=x y$ and $y \star x=x(y \star 1)=x y$. This implies that $\mathbb{F}_{q}$ is contained in both the commutative center and the nucleus of $\mathbb{S}$.) Due to the classification of two-dimensional finite semifields by Dickson [7, $\mathbb{S}$ is isotopic to a finite field.

Theorem 3.3. Let $q$ be a power of odd prime and let $L(X)=a_{1} X^{q^{2}}+a_{0} X \in \mathbb{F}_{q^{4}}[X]$ with $a_{1} \neq 0$. Then $\operatorname{Tr}_{q^{4} / q}(L(X) / X)$ has no root in $\mathbb{F}_{q^{4}}^{*}$ if and only if $a_{1}^{q^{2}+1}$ is a square in $\mathbb{F}_{q}^{*}$ and $\operatorname{Tr}_{q^{4} / q}\left(a_{0}\right)=0$.

Proof. Let $b=\operatorname{Tr}_{q^{4} / q}\left(a_{0}\right)$. Let $x \in \mathbb{F}_{q^{4}}^{*}$ and set $y:=x^{q^{2}-1}$ and $z:=a_{1} y+a_{1}^{q^{2}} / y$. Then

$$
\begin{align*}
\operatorname{Tr}_{q^{4} / q}(L(x) / x) & =\operatorname{Tr}_{q^{4} / q}\left(a_{1} x^{q^{2}-1}+a_{0}\right) \\
& =a_{1} y+a_{1}^{q} y^{q}+a_{1}^{q^{2}} / y+a_{1}^{q^{3}} / y^{q}+\operatorname{Tr}_{q^{4} / q}\left(a_{0}\right) \\
& =z+z^{q}+b \\
& =\left(z+\frac{b}{2}\right)^{q}+\left(z+\frac{b}{2}\right) . \tag{3.3}
\end{align*}
$$

Thus $\operatorname{Tr}_{q^{4} / q}(L(x) / x)=0$ if and only if $\left(z+\frac{b}{2}\right)^{q-1}=-1$ or 0 , i.e., $z=t-\frac{b}{2}$ for some $t \in T:=\left\{t \in \mathbb{F}_{q^{4}}: t^{q}=-t\right\} \subset \mathbb{F}_{q^{2}}$. Since $z=a_{1} y+a_{1}^{q^{2}} / y$, we see that $z=t-\frac{b}{2}$ if
and only if

$$
\begin{equation*}
a_{1} y^{2}+\left(\frac{b}{2}-t\right) y+a_{1}^{q^{2}}=0 . \tag{3.4}
\end{equation*}
$$

By the proof of Theorem 3.2, we see that $\left\{x \in \mathbb{F}_{q^{4}}^{*}: y=x^{q^{2}-1}\right.$ satisfies (3.4) $\} \neq \emptyset$ if and only if

$$
g(X):=X^{2}+\left(\frac{b}{2}-t\right) X+a_{1}^{q^{2}+1}
$$

has two distinct roots in $\mathbb{F}_{q^{2}}$. Therefore, to sum up, $\operatorname{Tr}_{q^{4} / q}(L(x) / x)$ has no root in $\mathbb{F}_{q^{4}}^{*}$ if and only if $g(X)$ has two distinct roots in $\mathbb{F}_{q^{2}}$ for every $t \in T$. We now proceed to prove the "if" and the "only if" portions of the theorem separately.
$(\Leftarrow)$ Assume $b=0$ and $a_{1}^{q^{2}+1}$ is a square in $\mathbb{F}_{q}^{*}$. Then $a_{1}^{q^{2}+1} \neq t^{2}$ for all $t \in T$. Hence

$$
\Delta:=\left(\frac{b}{2}-t\right)^{2}-4 a_{1}^{q^{2}+1}=t^{2}-4 a_{1}^{q^{2}+1} \in \mathbb{F}_{q}^{*} .
$$

It follows that $g$ has two distinct roots in $\mathbb{F}_{q^{2}}$.
$(\Rightarrow)$ Assume that $\operatorname{Tr}_{q^{4} / q}(L(X) / X)$ has no root in $\mathbb{F}_{q^{4}}^{*}$. We want to show
R1. $b=0$, and
R2. $a_{1}^{q^{2}+1}$ is a square in $\mathbb{F}_{q}^{*}$. Equivalently, $a_{1}^{q^{2}+1}$ is in $\mathbb{F}_{q}$ and there is no $t \in T$ such that $t^{2}=4 a_{1}^{q^{2}+1}$.
Now we assume that $\Delta=\left(\frac{b}{2}-t\right)^{2}-4 a_{1}^{q^{2}+1} \neq 0$ always has a square root in $\mathbb{F}_{q^{2}}$, for every $t \in T$. Choose an element $\xi$ of $\mathbb{F}_{q^{2}} \backslash \mathbb{F}_{q}$, such that $\xi^{q-1}=-1$. Then every element of $\mathbb{F}_{q^{2}}$ can be written as $z+w \xi$, where $z, w \in \mathbb{F}_{q}$, and $T=\left\{x \xi: x \in \mathbb{F}_{q}\right\}$. We write $a_{1}^{q^{2}+1}=A_{1}+A_{2} \xi$. As $\Delta$ is always a square in $\mathbb{F}_{q^{2}}^{*}$, the equation

$$
\begin{equation*}
(z+w \xi)^{2}=(x \xi-b / 2)^{2}-\left(A_{1}+A_{2} \xi\right) \tag{3.5}
\end{equation*}
$$

in $(z, w)$ has solutions for every $x \in \mathbb{F}_{q}$. Expanding (3.5), we have

$$
\begin{align*}
z^{2}+w^{2} \alpha & =x^{2} \alpha+b^{2} / 4-A_{1},  \tag{3.6}\\
2 w z & =-x b-A_{2}, \tag{3.7}
\end{align*}
$$

where $\alpha=\xi^{2} \in \mathbb{F}_{q}$.
If we can show that $b=0$ and $A_{2}=0$, then the proof is complete ( $\mathbf{R} 2$ can be easily derived from the condition that $\Delta \neq 0$ ). Suppose to the contrary that at least one of $b$ and $A_{2}$ is not 0 . Then there exists at most one $x=x_{0} \in \mathbb{F}_{q}$ such that $w=0$ by (3.7). Now assume that $w \neq 0$. From (3.7) we have

$$
z=-\frac{x b+A_{2}}{2 w} .
$$

Plugging it into (3.6), we get

$$
\frac{\left(x b+A_{2}\right)^{2}}{4 w^{2}}+w^{2} \alpha=x^{2} \alpha+\frac{b^{2}}{4}-A_{1},
$$

i.e.,

$$
\alpha\left(w^{2}\right)^{2}-\left(x^{2} \alpha+\frac{b^{2}}{4}-A_{1}\right) w^{2}+\frac{\left(x b+A_{2}\right)^{2}}{4}=0 .
$$

For every given $x \in \mathbb{F}_{q} \backslash\left\{x_{0}\right\}$, this equation always has a solution $w$ in $\mathbb{F}_{q}$. It follows that

$$
f(x)=\left(x^{2} \alpha+\frac{b^{2}}{4}-A_{1}\right)^{2}-\alpha\left(x b+A_{2}\right)^{2}
$$

is always a square in $\mathbb{F}_{q}$. Let $\psi$ be the multiplicative character of $\mathbb{F}_{q}$ of order 2 , and for convenience we set $\psi(0)=0$. Then we have

$$
\begin{equation*}
\sum_{c \in \mathbb{F}_{q}} \psi(f(c)) \geq q-6 \tag{3.8}
\end{equation*}
$$

On the other hand, by Theorem 5.41 in 19 (it is routine to verify all the conditions for $f(x)$, because $\left(b, A_{2}\right) \neq(0,0)$ and $\left.\left(A_{1}, A_{2}\right) \neq(0,0)\right)$, we have

$$
\sum_{c \in \mathbb{F}_{q}} \psi(f(c)) \leq 3 \sqrt{q}
$$

Therefore $q-6 \leq 3 \sqrt{q}$, which means that $q=3,5,7,9,11,13,17,19$. We can use MAGMA [3] to show that $f(x)$ is not always a square for $x \in \mathbb{F}_{q} \backslash\left\{x_{0}\right\}$ when $q \leq 19$. Hence $b=A_{2}=0$, which completes the proof.
Theorem 3.4. Let $q$ be a power of an odd prime. Let $a_{1} \in \mathbb{F}_{q^{4}}^{*}$ such that $a_{1}^{q^{2}+1}$ is a square in $\mathbb{F}_{q}^{*}$ and let $\tilde{a}_{0}$ be an element in $\mathbb{F}_{q^{4}}$ such that $\operatorname{Tr}_{q^{4} / q}\left(\tilde{a}_{0}\right)=-1$. Define

$$
x * y=x y+\operatorname{Tr}_{q^{4} / q}\left(a_{1} x y^{q^{2}}+\tilde{a}_{0} x y\right)
$$

According to Theorem 2.1 and Theorem $3.3,\left(\mathbb{F}_{q^{4}},+, *\right)$ forms a presemifield. Furthermore, it is isotopic to a commutative semifield.

Proof. According to Lemma [2.4 we only have to show that there exists some $v$ such that

$$
A(v * x) * y=A(v * y) * x
$$

for every $x, y \in \mathbb{F}_{q^{4}}$, where $A$ is given by (2.4).
Using the same notation as in Lemma 2.5, we set $t=a_{1}+\tilde{a}_{0}$ and $s=-t /(1+$ $\left.\operatorname{Tr}_{q^{4} / q}(t)\right)$. Now,

$$
\begin{aligned}
A(v * x) & =A\left(v x+\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}+\tilde{a}_{0} v x\right)\right) \\
& =v x+\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}+\tilde{a}_{0} v x\right)+\operatorname{Tr}_{q^{4} / q}\left[s\left(v x+\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}+\tilde{a}_{0} v x\right)\right)\right] \\
& =v x+\left(1+\operatorname{Tr}_{q^{4} / q}(s)\right) \operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}+\tilde{a}_{0} v x\right)+\operatorname{Tr}_{q^{4} / q}(s v x) \\
& =v x+\frac{\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}+\tilde{a}_{0} v x\right)}{1+\operatorname{Tr}_{q^{4} / q}\left(a_{1}+\tilde{a}_{0}\right)}-\frac{\operatorname{Tr}_{q^{4} / q}\left(\left(a_{1}+\tilde{a}_{0}\right) v x\right)}{1+\operatorname{Tr}_{q^{4} / q}\left(a_{1}+\tilde{a}_{0}\right)} \\
& =v x+\frac{\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}-a_{1} v x\right)}{1+\operatorname{Tr}_{q^{4} / q}\left(a_{1}+\tilde{a}_{0}\right)} .
\end{aligned}
$$

For convenience, let $r(x)$ denote $A(v * x)-v x$. Then

$$
\begin{aligned}
A(v * x) * y= & v x y+r(x) y+\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x y^{q^{2}}+\tilde{a}_{0} v x y\right)+r(x) \operatorname{Tr}_{q^{4} / q}\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right) \\
= & v x y+\frac{\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x^{q^{2}}-a_{1} v x\right)}{1+\operatorname{Tr}_{q^{4} / q}\left(a_{1}+\tilde{a}_{0}\right)}\left(y+\operatorname{Tr}_{q^{4} / q}\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right)\right) \\
& +\operatorname{Tr}_{q^{4} / q}\left(a_{1} v x y^{q^{2}}+\tilde{a}_{0} v x y\right) .
\end{aligned}
$$

It is not difficult to see that if $v$ is an element in $\mathbb{F}_{q^{4}}$ such that $a_{1} v \in \mathbb{F}_{q^{2}}$, then $A(v * x) * y=A(v * y) * x$, from which it follows that $\left(\mathbb{F}_{q^{4}},+, *\right)$ is isotopic to a commutative semifield.
Theorem 3.5. Let $q$ be a power of an odd prime. Let $a_{1} \in \mathbb{F}_{q^{4}}^{*}$ such that $a_{1}^{q^{2}+1}$ is a square in $\mathbb{F}_{q}^{*}$ and let $\tilde{a}_{0}$ be an element in $\mathbb{F}_{q^{4}}$ such that $\operatorname{Tr}_{q^{4} / q}\left(\tilde{a}_{0}\right)=-1$. Let $x * y$ be defined as in Theorem 3.4, i.e.,

$$
x * y=x y+\operatorname{Tr}_{q^{4} / q}\left(a_{1} x y^{q^{2}}+\tilde{a}_{0} x y\right)
$$

Then the presemifield $\left(\mathbb{F}_{q^{4}},+, *\right)$ is isotopic to Dickson's semifield.
Proof. We have already shown in Theorem 3.4 that $\left(\mathbb{F}_{q^{4}},+, *\right)$ is isotopic to a commutative semifield, which is denoted by $\mathbb{S}$. Next we are going to prove that its middle nucleus $N_{m}(\mathbb{S})$ is of size $q^{2}$ and its left nucleus $N_{l}(\mathbb{S})$ is of size $q$. Furthermore, as $\mathbb{S}$ is commutative, we have $N_{r}(\mathbb{S})=N_{l}(\mathbb{S})$. Due to the classification of semifields planes of order $q^{4}$ with kernel $\mathbb{F}_{q^{2}}$ and center $\mathbb{F}_{q}$ by Cardinali, Polverino and Trombetti in [4], $\left(\mathbb{F}_{q^{4}},+, *\right)$ is isotopic to Dickson's semifield.

To determine the middle and left nuclei of $\mathbb{S}$, we need to introduce another presemifield multiplication $x \circ y$, which corresponds to the dual spread of the spread defined by $x * y$. (For more details on the dual spread, see [16].) Actually, $x \circ y$ is defined as

$$
\begin{equation*}
x \circ y:=x y+\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right) \operatorname{Tr}_{q^{4} / q}(x) . \tag{3.9}
\end{equation*}
$$

It is straightforward to verify that $\operatorname{Tr}_{q^{4} / q}(x(z \circ y)-z(x * y))=0$. Let $\mathbb{S}^{\prime}$ denote a semifield which is isotopic to the presemifield defined by $x \circ y$. According to the interchanging of nuclei of semifields in the so called Knuth orbit ([16] and [18, Section 1.4]), we have $N_{l}\left(\mathbb{S}^{\prime}\right) \cong N_{m}(\mathbb{S})$ and $N_{m}\left(\mathbb{S}^{\prime}\right) \cong N_{l}(\mathbb{S})$.

To determine $N_{l}\left(\mathbb{S}^{\prime}\right)$ and $N_{m}\left(\mathbb{S}^{\prime}\right)$, we use the connection between certain homology groups as described in [13, Theorem 8.2] and [14, Result 12.4]. To be precise, we want to find every $q$-linearized polynomial $A(X)$ over $\mathbb{F}_{q^{4}}$ such that for every $y \in \mathbb{F}_{q^{4}}$, there is a $y^{\prime} \in \mathbb{F}_{q^{4}}$ satisfying $A(x) \circ y=x \circ y^{\prime}$ for every $x \in \mathbb{F}_{q^{4}}$. The set $\mathcal{M}\left(\mathbb{S}^{\prime}\right)$ of all such $A(X)$ is equivalent to the middle nucleus $N_{m}\left(\mathbb{S}^{\prime}\right)$.

First, it is routine to verify that $A(X)=u X$ with $u \in \mathbb{F}_{q}$ is in $\mathcal{M}\left(\mathbb{S}^{\prime}\right)$. Next we show that there are no other $A(X)$ in $\mathcal{M}\left(\mathbb{S}^{\prime}\right)$.

Assume that

$$
\begin{equation*}
A(x) y+\operatorname{Tr}_{q^{4} / q}(A(x))\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right)=x y^{\prime}+\operatorname{Tr}_{q^{4} / q}(x)\left(a_{1} y^{\prime q^{2}}+\tilde{a}_{0} y^{\prime}\right) \tag{3.10}
\end{equation*}
$$

holds for every $x \in \mathbb{F}_{q^{4}}$.
Let $x_{0} \in \mathbb{F}_{q^{4}}^{*}$ be such that $\operatorname{Tr}_{q^{4} / q}\left(x_{0}\right)=\operatorname{Tr}_{q^{4} / q}\left(A\left(x_{0}\right)\right)=0$. Then

$$
A\left(x_{0}\right) y=x_{0} y^{\prime}
$$

It means that $y^{\prime}=u y$ holds for each $y \in \mathbb{F}_{q^{4}}$, where $u=A\left(x_{0}\right) / x_{0}$. Plugging it into (3.10), we have

$$
A(x) y+\operatorname{Tr}_{q^{4} / q}(A(x))\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right)=u x y+\operatorname{Tr}_{q^{4} / q}(x)\left(a_{1}(u y)^{q^{2}}+\tilde{a}_{0} u y\right)
$$

From this equation we can deduce that

$$
\begin{align*}
A(x)-u x+\left(\operatorname{Tr}_{q^{4} / q}(A(x))-\operatorname{Tr}_{q^{4} / q}(x) u\right) \tilde{a}_{0} & =0  \tag{3.11}\\
\left(\operatorname{Tr}_{q^{4} / q}(A(x))-\operatorname{Tr}_{q^{4} / q}(x) u^{q^{2}}\right) a_{1} & =0 \tag{3.12}
\end{align*}
$$

Since $a_{1} \neq 0$, from (3.12) we see that

$$
\begin{equation*}
\operatorname{Tr}_{q^{4} / q}(A(x))=u^{q^{2}} \operatorname{Tr}_{q^{4} / q}(x) \tag{3.13}
\end{equation*}
$$

for every $x \in \mathbb{F}_{q^{4}}$. From (3.13) it follows that $u \in \mathbb{F}_{q}$. Therefore, by (3.11), we have $A(x)=u x$ where $u \in \mathbb{F}_{q}$. Hence $\left|N_{l}(\mathbb{S})\right|=\left|N_{m}\left(\mathbb{S}^{\prime}\right)\right|=q$.

Next we determine every $q$-linearized polynomial $A(X)$ over $\mathbb{F}_{q^{4}}$ such that for every $y \in \mathbb{F}_{q^{4}}$, there is a $y^{\prime} \in \mathbb{F}_{q^{4}}$ satisfying $A(x \circ y)=x \circ y^{\prime}$ for every $x \in \mathbb{F}_{q^{4}}$. The set of all such $A(X)$ is equivalent to the left nucleus $N_{l}\left(\mathbb{S}^{\prime}\right)$.

Assume that

$$
\begin{equation*}
A\left(x y+\operatorname{Tr}_{q^{4} / q}(x)\left(a_{1} y^{q^{2}}+\tilde{a}_{0} y\right)\right)=x y^{\prime}+\operatorname{Tr}_{q^{4} / q}(x)\left(a_{1} y^{\prime q^{2}}+\tilde{a}_{0} y^{\prime}\right) . \tag{3.14}
\end{equation*}
$$

It is readily verified that when $A(X)=c X$ for some $c \in \mathbb{F}_{q^{2}}$, (3.14) holds for all $x$ and $y$ in $\mathbb{F}_{q^{4}}$ with $y^{\prime}=c y$. Hence $\mathbb{F}_{q^{2}}$ is a subfield contained in $N_{l}\left(\mathbb{S}^{\prime}\right)$. On the other hand, $N_{l}\left(\mathbb{S}^{\prime}\right)$ has to be a proper subfield of $\mathbb{F}_{q^{4}}$, for otherwise $\mathbb{S}^{\prime}$ would be a finite field, which would lead to a contradiction. Therefore, we have $\left|N_{m}(\mathbb{S})\right|=\left|N_{l}\left(\mathbb{S}^{\prime}\right)\right|=q^{2}$, which completes the proof.
Theorem 3.6. Let $q$ be a power of prime and let $u, v$ be elements in $\mathbb{F}_{q^{3}}^{*}$ such that $\mathrm{N}_{q^{3} / q}(-v / u) \neq 1$. For every $\beta \in \mathcal{B}$, where

$$
\mathcal{B}:=\left\{x \in \mathbb{F}_{q^{3}}: \operatorname{Tr}_{q^{3} / q}\left(u^{q^{2}} v^{q} x\right)=u^{q^{2}+q+1}+v^{q^{2}+q+1}\right\},
$$

the equation

$$
\begin{equation*}
u x^{q^{2}-1}+v x^{q-1}+\beta=0 \tag{3.15}
\end{equation*}
$$

has no solution in $\mathbb{F}_{q^{3}}^{*}$. Let $L(X):=u^{q^{2}} v^{q}\left(u a^{q^{2}-1} X^{q^{2}}+v a^{q-1} X^{q}+\theta X\right)$, where $\theta \in \mathcal{B}$ and $a \in \mathbb{F}_{q^{3}}^{*}$. Then the polynomial $\operatorname{Tr}_{q^{3} / q}(L(X) / X)$ has no root in $\mathbb{F}_{q^{3}}^{*}$.

Proof. When $\beta=0$, (3.15) becomes $x^{q-1}\left(u x^{q(q-1)}+v\right)=0$. If there exists $x \in \mathbb{F}_{q^{3}}^{*}$ such that $u x^{q(q-1)}+v=0$, then $\mathrm{N}_{q^{3} / q}(-v / u)=\mathrm{N}_{q^{3} / q}\left(x^{q(q-1)}\right)=1$, which leads to a contradiction.

Now suppose $\beta \neq 0$. Assume to the contrary that (3.15) has a solution $x \in \mathbb{F}_{q^{3}}^{*}$. Let $y:=x^{q-1}$. Then we have $u y^{q+1}+v y+\beta=0$. It follows that

$$
\begin{equation*}
y^{q}=\frac{-v y-\beta}{u y}, \tag{3.16}
\end{equation*}
$$

and

$$
y^{q^{2}}=\frac{v^{q}(v y+\beta)-\beta^{q} u y}{-u^{q}(v y+\beta)} .
$$

Hence

$$
y^{q^{2}} y^{q} y=\frac{v^{q}(v y+\beta)-\beta^{q} u y}{u^{q+1}}
$$

which is equal to 1 since $y=x^{q-1}$. Therefore,

$$
\begin{equation*}
\left(v^{q+1}-\beta^{q} u\right) y+v^{q} \beta=u^{q+1} \tag{3.17}
\end{equation*}
$$

Suppose that $u \beta^{q}=v^{q+1}$. Then $u^{q^{2}} v^{q} \beta=v^{q^{2}+1} v^{q}$, and $\operatorname{Tr}_{q^{3} / q}\left(u^{q^{2}} v^{q} \beta\right)=3 v^{q^{2}+q+1}$. On the other hand, we also have $u^{q+1}=v^{q} \beta$ from (3.17). It follows that $\operatorname{Tr}_{q^{3} / q}\left(u^{q^{2}} v^{q} \beta\right)=$ $3 u^{q^{2}+q+1}$. All together with $\beta \in \mathcal{B}$, we have that

$$
u^{q^{2}+q+1}+v^{q^{2}+q+1}=3 v^{q^{2}+q+1}=3 u^{q^{2}+q+1},
$$

which can not holds for $3 \nmid q$. Moreover, if $3 \mid q$, then $u^{q^{2}+q+1}=-v^{q^{2}+q+1}$ which contradicts the assumption that $\mathrm{N}_{q^{3} / q}(-v / u) \neq 1$. Hence $u \beta^{q} \neq v^{q+1}$.

Since $u \beta^{q} \neq v^{q+1}$, from (3.17) we obtain

$$
\begin{equation*}
y=\frac{u^{q+1}-v^{q} \beta}{v^{q+1}-\beta^{q} u} \tag{3.18}
\end{equation*}
$$

Plugging (3.18) into (3.16), we have

$$
\frac{u^{q^{2}+q}-v^{q^{2}} \beta^{q}}{v^{q^{2}+q}-\beta^{q^{2}} u^{q}}=\frac{v u^{q}-\beta^{q+1}}{v^{q} \beta-u^{q+1}}
$$

Hence

$$
\begin{aligned}
& u^{q^{2}+q} v^{q} \beta-u^{q^{2}+2 q+1}+u^{q+1} v^{q^{2}} \beta^{q}-v^{q^{2}+q} \beta^{q+1} \\
= & v^{q^{2}+q+1} u^{q}-\beta^{q^{2}} v u^{2 q}-v^{q^{2}+q} \beta^{q+1}+\beta^{q^{2}+q+1} u^{q} .
\end{aligned}
$$

Dividing it by $u^{q}$, we have

$$
\beta^{q^{2}+q+1}-\left(u^{q} v \beta^{q^{2}}+u v^{q^{2}} \beta^{q}+u^{q^{2}} v^{q} \beta\right)+u^{q^{2}+q+1}+v^{q^{2}+q+1}=0
$$

It follows from $\operatorname{Tr}_{q^{3} / q}\left(u^{q^{2}} v^{q} \beta\right)=u^{q^{2}+q+1}+v^{q^{2}+q+1}$ that

$$
\beta^{q^{2}+q+1}=0
$$

Hence $\beta=0$, which is a contradiction. Therefore, (3.15) has no solution in $\mathbb{F}_{q^{3}}^{*}$.
Furthermore, if $\operatorname{Tr}_{q^{3} / q}(L(X) / X)$ has a root $x_{0} \in \mathbb{F}_{q^{3}}^{*}$, then $u^{q^{2}} v^{q}\left(u\left(a x_{0}\right)^{q^{2}-1}+\right.$ $\left.v\left(a x_{0}\right)^{q-1}+\theta\right)=\gamma$ for some $\gamma \in \mathbb{F}_{q^{3}}$ satisfying $\operatorname{Tr}_{q^{3} / q}(\gamma)=0$. We write $\gamma$ as $\gamma=u^{q^{2}} v^{q} \tau$ for some $\tau \in \mathbb{F}_{q^{3}}$. Then $\theta-\tau \in \mathcal{B}$ and

$$
u\left(a x_{0}\right)^{q^{2}-1}+v\left(a x_{0}\right)^{q-1}+\theta-\tau=0
$$

which contradicts the fact that (3.15) has no solution in $\mathbb{F}_{q^{3}}^{*}$.
For given $u$ and $v$, it is not difficult to see that for different $a$, we obtain isotopic semifields via Theorem 3.6. Let the multiplication corresponding to $a=1$ be $x y+B(x, y)$. Then for other $a \in \mathbb{F}_{q^{3}}{ }^{3}$, the semifield multiplication is $\frac{a x y+B(x, a y)}{a}$. Furthermore, when $u, v \in \mathbb{F}_{q}$ and $a=1$, it follows from Lemma 2.3 that the presemifield $\mathbb{P}$ derived from $L(x)$ in Theorem 3.6 is commutative. It is worth noting that, up to isotopism, we can obtain non-commutative semifields via Theorem 3.6 For instance, let $q=4$ and let $\xi$ be a primitive element of $\mathbb{F}_{q^{3}}$ which is a root of $X^{6}+X^{4}+X^{3}+X+1$. Setting $u=\xi^{5}, v=\xi$ and $\beta=\xi^{62}$, we can use computer to show that the presemifield $\mathbb{P}$ derived from Theorem 3.6 is not isotopic to a commutative one.

According to the classification of semifields of order $q^{3}$ with center containing $\mathbb{F}_{q}$ in [21], the presemifield obtained via Theorem 3.6 is either finite field or generalized twisted field.

Besides all the $L$ 's described in this section, we did not find any other examples. Thus we propose the following question:

Question 3.7. For $n>4$, is there a $q$-linearized polynomial $L(X)=\sum_{i=0}^{n-1} a_{i} X^{q^{i}} \in$ $\mathbb{F}_{q^{n}}[X]$ with $\left(a_{1}, \ldots, a_{n-1}\right) \neq(0, \ldots, 0)$ satisfying (2.3)?

## 4. Switchings of $\mathbb{F}_{p^{n}}$ FOR LARGE $n$

The main result of this section is a negative answer to Question 3.7 when $q=p$ (prime) and $n$ is large.
Theorem 4.1. Let $q=p$, where $p$ is a prime, and assume $n \geq \frac{1}{2}(p-1)\left(p^{2}-p+4\right)$. If $L(X)=\sum_{i=0}^{n-1} a_{i} X^{p^{i}} \in \mathbb{F}_{p^{n}}[X]$ satisfies (2.3), i.e.,

$$
\operatorname{Tr}_{p^{n} / p}(L(x) / x) \neq 0 \quad \text { for all } x \in \mathbb{F}_{p^{n}}^{*}
$$

then $a_{1}=\cdots=a_{n-1}=0$.
In 1971, Payne 22] considered a similar problem which calls for the determination of all 2-linearized polynomials $L=\sum_{i=0}^{n-1} a_{i} X^{2^{i}} \in \mathbb{F}_{2^{n}}[X]$ such that both $L(X)$ and $L(X) / X$ are permutation polynomials of $\mathbb{F}_{2^{n}}$. Such linearized polynomials give rise to translation ovoids in the projective plane $\operatorname{PG}\left(2, \mathbb{F}_{2^{n}}\right)$ [23]. Payne later solved the problem by showing that such linearized polynomials can have only one term [23]. For a different proof of Payne's theorem, see [11, §8.5]. For the $q$-ary version of Payne's theorem, see [12].
4.1. Preliminaries. Let $L(X)=\sum_{i=0}^{n-1} a_{i} X^{q^{i}} \in \mathbb{F}_{q^{n}}[X]$. For $x \in \mathbb{F}_{q^{n}}^{*}$, we have

$$
\operatorname{Tr}_{q^{n} / q}\left(\frac{L(x)}{x}\right)=\operatorname{Tr}_{q^{n} / q}\left(\sum_{i=0}^{n-1} a_{i} x^{q^{i}-1}\right)=\sum_{0 \leq i, j \leq n-1} a_{i}^{q^{j}} x^{q^{j}\left(q^{i}-1\right)}
$$

Therefore (2.3) is equivalent to

$$
\begin{align*}
{\left[\sum_{0 \leq i, j \leq n-1} a_{i}^{q^{j}} X^{q^{j}\left(q^{i}-1\right)}\right]^{q-1} \equiv } & \operatorname{Tr}_{q^{n} / q}\left(a_{0}\right)^{q-1}+\left[1-\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right)^{q-1}\right] X^{q^{n}-1}  \tag{4.1}\\
& \left(\bmod X^{q^{n}}-X\right)
\end{align*}
$$

Let $\Omega=\left\{0,1, \ldots, q^{n}-1\right\}$ and $\Omega_{0}=\left\{0,1, \ldots, \frac{q^{n}-1}{q-1}\right\}$. For $\alpha, \beta \in \Omega_{0}$, define $\alpha \oplus \beta \in$ $\Omega_{0}$ such that $\alpha \oplus \beta \equiv \alpha+\beta\left(\bmod \frac{q^{n}-1}{q-1}\right)$ and

$$
\alpha \oplus \beta= \begin{cases}0 & \text { if } \alpha=\beta=0, \\ \frac{q^{n}-1}{q-1} & \text { if } \alpha+\beta \equiv 0 \quad\left(\bmod \frac{q^{n}-1}{q-1}\right) \text { and }(\alpha, \beta) \neq(0,0)\end{cases}
$$

For $d_{0}, \ldots, d_{n-1} \in \mathbb{Z}$, we write

$$
\left(d_{0}, \ldots, d_{n-1}\right)_{q}=\sum_{i=0}^{n-1} d_{i} q^{i}
$$

When $q$ is clear from the context, we write $\left(d_{0}, \ldots, d_{n-1}\right)_{q}=\left(d_{0}, \ldots, d_{n-1}\right)$. For $j, i \in \mathbb{Z}, i \geq 0$, let

$$
s(j, i)=\left(\begin{array}{lllll}
0 & \cdots & 0 & \underbrace{j}_{i} \cdots 1 & \cdots
\end{array} \stackrel{n-1}{0}_{0}^{1}\right)_{q},
$$

where the positions of the digits are labeled modulo $n$ and the string of 1's may wrap around. For example, with $n=4$,

$$
s(1,3)=\left(\begin{array}{llll}
0 & 1 & 1 & 1
\end{array}\right), \quad s(3,2)=\left(\begin{array}{llll}
1 & 0 & 0 & 1
\end{array}\right)
$$

Note that

$$
s(j, i) \equiv q^{j} \frac{q^{i}-1}{q-1} \quad\left(\bmod q^{n}-1\right)
$$

For each $\alpha \in \Omega_{0}$, let $C(\alpha)$ denote the coefficient of $X^{\alpha(q-1)}$ in the left side of (4.1) after reduction modulo $X^{q^{n}}-X$. Then we have

$$
\begin{equation*}
C(\alpha)=\sum_{\substack{0 \leq j_{1}, i_{1}, \ldots, j_{q-1}, i_{q-1} \leq n-1 \\ s\left(j_{1}, i_{1}\right) \oplus \cdots \oplus s\left(\left(j_{q-1}, i_{q-1}\right)=\alpha\right.}} a_{i_{1}}^{q_{1}^{j_{1}}} \cdots a_{i_{q-1}}^{q^{j_{q-1}}} \tag{4.2}
\end{equation*}
$$

Let

$$
S=\{s(j, i): 0 \leq j \leq n-1,1 \leq i \leq n-1\}
$$

If $C(\alpha)=0$, we can derive from (4.2) useful information about $a_{i}$ 's if we know the possible ways to express $\alpha$ as an $\oplus$ sum of $q-1$ elements (not necessarily distinct) of $S \cup\{0\}$.

Let $\alpha=\left(d_{0}, \ldots, d_{n-1}\right)_{q} \in \Omega$, where $0 \leq d_{i} \leq q-1$. If $d_{i}>d_{i-1}\left(d_{i}<d_{i-1}\right)$, where the subscripts are taken modulo $n$, we say that $i$ is an ascending (descending) position of $\alpha$ with multiplicity $\left|d_{i}-d_{i-1}\right|$. The multiset of ascending (descending) positions of $\alpha$ is denoted by $\operatorname{Asc}(\alpha)(\operatorname{Des}(\alpha))$. The multiset cardinality $|\operatorname{Asc}(\alpha)|$ $(=|\operatorname{Des}(\alpha)|)$ is denoted by $\operatorname{asc}(\alpha)$. For example, if $\alpha=(201130)$, then

$$
\operatorname{Asc}(\alpha)=\{0,0,2,4,4\}, \quad \operatorname{Des}(\alpha)=\{1,1,5,5,5\}, \quad \operatorname{asc}(\alpha)=5
$$

Assume that $\alpha \in \Omega$ has $\operatorname{asc}(\alpha)=q-1$. Then $\alpha$ cannot be a sum of less than $q-1$ elements (not necessarily distinct) of $S$. Moreover, if

$$
\alpha=s\left(j_{1}, i_{1}\right)+\cdots+s\left(j_{q-1}, i_{q-1}\right)
$$

where $0 \leq j_{1}, \ldots, j_{q-1} \leq n-1$ and $1 \leq i_{1}, \ldots, i_{q-1} \leq n-1$, we must have $\left\{j_{1}, \ldots, j_{q-1}\right\}=\operatorname{Asc}(\alpha)$ and $\left\{j_{1}+i_{1}, \ldots, j_{q-1}+i_{q-1}\right\}=\operatorname{Des}(\alpha)$, where $j_{k}+i_{k}$ is taken modulo $n$.

### 4.2. Proof of Theorem 4.1.

Lemma 4.2. Let $q=p$, where $p$ is a prime, and assume $L=\sum_{i=0}^{n-1} a_{i} X^{p^{i}} \in \mathbb{F}_{p^{n}}[X]$ satisfies (2.3). Then for all $1 \leq i_{1}<\cdots<i_{p-1}$ and $0 \leq t_{p-2} \leq \cdots \leq t_{1}$ with $i_{p-1}+t_{1} \leq n-2$, we have

$$
\begin{equation*}
\sum_{\tau} a_{i_{p-1}+\tau(p-1)} a_{i_{p-2}+\tau(p-2)}^{p^{i_{p-1}-i_{p-2}}} \cdots a_{i_{1}+\tau(1)}^{p^{i_{p-1}-i_{1}}}=0 \tag{4.3}
\end{equation*}
$$

where $(\tau(1), \ldots, \tau(p-1))$ runs through all permutations of $\left(t_{1}, \ldots, t_{p-2}, 0\right)$.
Proof. Let

$$
\begin{aligned}
\alpha= & (\overbrace{1 \cdots 1}^{i_{p-1}-i_{p-2}} \cdots \overbrace{p-2}^{p-2} \underbrace{i_{2}-i_{1}}_{t_{p-2}} \overbrace{p-1}^{p-2 \cdots p-2} \underbrace{p-3 \cdots p-3}_{t_{p-3}-t_{p-2}} \cdots \underbrace{1 \cdots 1}_{t_{1}-t_{2}} \underbrace{0 \cdots 0}_{\substack{n-i_{p-1}-t_{1} \\
\geq 2}}) \in \Omega_{0} .
\end{aligned}
$$

For $1 \leq k \leq p-2$, we have

$$
=(\overbrace{k+1 \cdots k+1 \cdots p-1 \cdots p-101 \cdots 1 \cdots} \begin{array}{c}
\alpha+(k \cdots k) \\
i_{p-1}
\end{array} \overbrace{e \underbrace{t_{1} \cdots k}_{\geq 1}}^{\overbrace{\underbrace{}_{2}}^{k-i_{p-1}-t_{1}}}),
$$

where $e=k+1$ or $k$, depending on whether it receives a carry from the preceding digit. If $e=k+1$, then $\operatorname{asc}(\alpha+(k \cdots k)) \geq p-1-k+k+1=p$. If $e=k$, then
$t_{1}>0$ and $d \geq k+1$, which also implies that $\operatorname{asc}(\alpha+(k \cdots k)) \geq p$. Therefore $\alpha+(k \cdots k)$ is not a sum of $\leq p-1$ elements (not necessarily distinct) of $S$, i.e., not a sum of $p-1$ elements (not necessarily distinct) of $S \cup\{0\}$.

On the other hand, we have $\operatorname{asc}(\alpha)=p-1$ and

$$
\begin{aligned}
& \operatorname{Asc}(\alpha)=\left\{0, i_{p-1}-i_{p-2}, \ldots, i_{p-1}-i_{1}\right\} \\
& \operatorname{Des}(\alpha)=\left\{i_{p-1}, i_{p-1}+t_{p-2}, \ldots, i_{p-1}+t_{1}\right\} .
\end{aligned}
$$

Therefore, the only possible ways to express $\alpha$ as a sum of $p-1$ elements (not necessarily distinct) of $S \cup\{0\}$ are
$\alpha=s\left(0, i_{p-1}+\tau(p-1)\right)+s\left(i_{p-1}-i_{p-2}, i_{p-2}+\tau(p-2)\right)+\cdots+s\left(i_{p-1}-i_{1}, i_{1}+\tau(1)\right)$, where $(\tau(1), \ldots, \tau(p-1))$ is a permutation of $\left(t_{1}, \ldots, t_{p-2}, 0\right)$. Together with the fact that for $1 \leq k \leq p-2, \alpha+(k \cdots k)$ is not a sum of $p-1$ elements (not necessarily distinct) of $S \cup\{0\}$, we have proved that

$$
\alpha=\alpha_{1} \oplus \cdots \oplus \alpha_{p-1}, \quad \alpha_{i} \in S \cup\{0\}
$$

if and only if

$$
\begin{aligned}
& \left\{\alpha_{1}, \ldots, \alpha_{p-1}\right\} \\
= & \left\{s\left(0, i_{p-1}+\tau(p-1)\right), s\left(i_{p-1}-i_{p-2}, i_{p-2}+\tau(p-2)\right), \ldots, s\left(i_{p-1}-i_{1}, i_{1}+\tau(1)\right)\right\},
\end{aligned}
$$

where $(\tau(1), \ldots, \tau(p-1))$ is a permutation of $\left(t_{1}, \ldots, t_{p-2}, 0\right)$.
Now we have

$$
\begin{align*}
0 & =C(\alpha) \\
& =(p-1)!\sum_{\tau} a_{i_{p-1}+\tau(p-1)} a_{i_{p-2}+\tau(p-2)}^{p^{i_{p-1}-i_{p-2}} \cdots a_{i_{1}+\tau(1)}^{p^{i_{p-1}-i_{1}}}} \tag{4.4}
\end{align*}
$$

which gives (4.3).
Proof of Theorem 4.1. $1^{\circ}$ We first show that for all $1 \leq k \leq p-1$ and

$$
1+\sum_{j=0}^{k-1} j \leq i_{k}<\cdots<i_{p-1} \leq n-k-1
$$

we have

$$
a_{i_{k}} \cdots a_{i_{p-1}}=0
$$

We use induction on $k$. When $k=1$, the conclusion follows from Lemma 4.2 with $t_{p-2}=\cdots=t_{1}=0$. Assume $2 \leq k \leq p-1$. In Lemma 4.2, let $t_{1}=k-1$, $t_{2}=k-2, \ldots, t_{k-1}=1, t_{k}=\cdots=t_{p-2}=0, i_{k-1}=i_{k}-1, i_{k-2}=i_{k}-2, \ldots, i_{1}=$ $i_{k}-(k-1)$, and note that $i_{p-1}+t_{1}=i_{p-1}+k-1 \leq n-2$. We have

$$
\begin{equation*}
\sum_{\tau} a_{i_{p-1}+\tau(p-1)}^{*} \cdots a_{i_{1}+\tau(1)}^{*}=0 \tag{4.5}
\end{equation*}
$$

where $(\tau(1), \ldots, \tau(p-1))$ runs through all permutations of $(k-1, k-2, \ldots, 1,0, \ldots, 0)$ and the $*$ 's are suitable powers of $p$. (In general, we use $\mathrm{a} *$ to denote a positive integer exponent whose exact value is not important.) Multiplying (4.5) by $a_{i_{k}} \cdots a_{i_{p-1}}$ gives

a_{i_{k}}^{*} \cdots a_{i_{p-1}}^{*}+\sum_{(\tau(1), \ldots, \tau(k-1)) \neq(k-1, \ldots, 1)} a_{i_{k}} \cdots a_{i_{p-1}} a_{i_{p-1}+\tau(p-1)}^{*} \cdots a_{i_{1}+\tau(1)}^{*}=0 . \tag{4.6}
\end{equation*}
$$

When $(\tau(1), \ldots, \tau(k-1)) \neq(k-1, \ldots, 1)$, at least one of $i_{1}+\tau(1), \ldots, i_{p-1}+\tau(p-1)$, say $i_{k-1}^{\prime}$, is less than $i_{k}$. Also note that $i_{k-1}^{\prime} \geq i_{1}=i_{k}-(k-1) \geq 1+1+2+\cdots+$ $(k-2)$. Therefore by the induction hypothesis, $a_{i_{k-1}^{\prime}} a_{i_{k}} \cdots a_{i_{p-1}}=0$. Thus the $\sum$ in (4.6) equals 0 , which gives $a_{i_{k}} \cdots a_{i_{p-1}}=0$.
$2^{\circ}$ Let $k=p-1$ in $1^{\circ}$. We have

$$
a_{i}=0 \quad \text { for all } 1+\frac{1}{2}(p-2)(p-1) \leq i \leq n-p
$$

$3^{\circ}$ We claim that

$$
a_{i}=0 \quad \text { for all } 1 \leq i \leq \frac{1}{2}(p-2)(p-1)
$$

Assume to the contrary that this is not true. Let $1 \leq l \leq \frac{1}{2}(p-2)(p-1)$ be the largest integer such that $a_{l} \neq 0$. Let

$$
\alpha=(\underbrace{\underbrace{1 \cdots 1}_{l} \underbrace{0 \cdots 0}_{p+1} \underbrace{1 \cdots 1}_{l} \underbrace{0 \cdots 0}_{p+1} \cdots \underbrace{1 \cdots 1}_{l} \underbrace{0 \cdots 0}_{p+1}}_{p-1 \text { copies }} 0 \cdots 0) \in \Omega_{0} .
$$

(Here we used the assumption that $n \geq(p-1)\left[\frac{1}{2}(p-2)(p-1)+p+1\right]$.) For $0 \leq k \leq p-2$, we have $\operatorname{asc}(\alpha+(k \cdots k))=p-1$ and

$$
\operatorname{Asc}(\alpha+(k \cdots k))=\{0, l+p+1,2(l+p+1), \ldots,(p-2)(l+p+1)\}
$$

$$
\operatorname{Des}(\alpha+(k \cdots k))=\{l, l+p+1+l, 2(l+p+1)+l, \ldots,(p-2)(l+p+1)+l\} .
$$

If $\alpha+(k \cdots k)$ is expressed as a sum of $p-1$ elements (not necessarily distinct) of $S$, the expression must be of the form

$$
\begin{equation*}
\alpha+(k \cdots k)=s\left(0, i_{1}\right)+s\left(l+p+1, i_{2}\right)+\cdots+s\left((p-2)(l+p+1), i_{p-1}\right) \tag{4.7}
\end{equation*}
$$

where $i_{1}, \ldots, i_{p-1} \in\{1, \ldots, n-1\}$, and in modulus $n$

$$
\begin{align*}
& \left\{i_{1}, l+p+1+i_{2}, \ldots,(p-2)(l+p+1)+i_{p-1}\right\} \\
= & \{l, l+p+1+l, 2(l+p+1)+l, \ldots,(p-2)(l+p+1)+l\} . \tag{4.8}
\end{align*}
$$

We further require $a_{i_{1}} \cdots a_{i_{p-1}} \neq 0$, which implies that $i_{1}, \ldots, i_{p-1} \in\{1, \ldots, l\} \cup$ $\{n-p+1, \ldots, n-1\}$. It follows from (4.8) that $i_{1}=\cdots=i_{p-1}=l$. Thus we have

$$
\begin{align*}
0 & =C(\alpha) & & (\text { by (4.1) }) \\
& =(p-1)!a_{l}^{p^{0}} a_{l}^{p^{l+p+1}} \cdots a_{l}^{p^{(p-2)(l+p+1)}} & & (\text { by (4.2) and (4.7) }), \tag{4.9}
\end{align*}
$$

which is a contradiction.
$4^{\circ}$ Finally, we show that

$$
a_{i}=0 \quad \text { for all } n-p+1 \leq i \leq n-1 .
$$

Assume to the contrary that this is not true. Let $n-l \in\{n-p+1, \ldots, n-1\}$ be the smallest integer such that $a_{n-l} \neq 0$. Let


For $0 \leq k \leq p-2$, we have $\operatorname{asc}(\alpha+(k \cdots k))=p-1$ and
$\operatorname{Asc}(\alpha+(k \cdots k))=\{n-1, n-1-(l+1), \ldots, n-1-(p-2)(l+1)\}$,
$\operatorname{Des}(\alpha+(k \cdots k))=\{n-1-l, n-1-l-(l+1), \ldots, n-1-l-(p-2)(l+1)\}$.
If $\alpha+(k \cdots k)$ is expressed as a sum of $p-1$ elements (not necessarily distinct) of $S$, the expression must be of the form

= & s\left(n-1, i_{1}\right)+s\left(n-1-(l+1), i_{2}\right)+\cdots+s\left(n-1-(p-2)(l+1), i_{p-1}\right)

where $i_{1}, \ldots, i_{p-1} \in\{1, \ldots, n-1\}$, and in modulus $n$

$$
\begin{align*}
& \left\{n-1+i_{1}, n-1-(l+1)+i_{2}, \ldots, n-1-(p-2)(l+1)+i_{p-1}\right\} \\
= & \{n-1-l, n-1-l-(l+1), \ldots, n-1-l-(p-2)(l+1)\} . \tag{4.11}
\end{align*}
$$

We further require $a_{i_{1}} \cdots a_{i_{p-1}} \neq 0$, which implies that $i_{1}, \ldots, i_{p-1} \in\{n-l, \ldots, n-$ $1\}$. Under this restriction, it is easy to see that (4.11) forces $i_{1}=\cdots i_{p-1}=n-l$. Thus we have

$$
\begin{align*}
0 & =C(\alpha) & & (\text { by (4.1) }) \\
& =(p-1)!a_{n-l}^{p^{n-1}} a_{n-l}^{p^{n-1-(l+1)}} \cdots a_{n-l}^{p^{n-1-(p-2)(l+1)}} & & (\text { by (4.2) and 4.10) }), \tag{4.12}
\end{align*}
$$

which is a contradiction.
It appears that the assumption that $n \geq \frac{1}{2}(p-1)\left(p^{2}-p+4\right)$ in Theorem4.1 may be weakened. On the other hand, when $q$ is not a prime, the proofs of Lemma 4.2 and Theorem 4.1 fail for the following reason: In (4.4), (4.9) and (4.12), $(p-1)$ ! is replaced by $(q-1)$ !, which is 0 in $\mathbb{F}_{q}$. When $q=p^{e}$, (4.1) becomes

\end{gathered}
$$

The question is how to decipher this equation.

## 5. A connection to some cyclic codes for general $\mathbb{F}_{q}$

In this section we prove certain necessary conditions for a $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$ to satisfy $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$, where $q$ is a prime power. In particular, we give a natural connection to some cyclic codes. There is also a connection of such cyclic codes to some algebraic curves. In the next section, we will use this connection to algebraic curves to get some necessary conditions for such $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$.

If $L(X)=a_{0} X \in \mathbb{F}_{q^{n}}[X]$, then $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$ if and only if $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right) \neq 0$. Hence we assume that $L(X)=a_{0} X+a_{1} X^{q}+\cdots+a_{n-1} X^{q^{n-1}} \in$ $\mathbb{F}_{q^{n}}[X]$ with $\left(a_{1}, a_{2}, \ldots, a_{n-1}\right) \neq(0,0, \ldots, 0)$.

First we recall some notation and basic facts from coding theory (see, for example, [20]). Let $N=q^{n}-1$. A code of length $N$ over $\mathbb{F}_{q}$ is just a nonempty subset of $\mathbb{F}_{q}^{N}$. It is called a linear code if it is a vector space over $\mathbb{F}_{q}$. The set $C^{\perp}$ of all $N$-tuples in $\mathbb{F}_{q}^{N}$ orthogonal to all codewords of a linear code $C$ with respect to the
usual inner product on $\mathbb{F}_{q}^{N}$ is called the dual code of $C$. The Hamming weight of an arbitrary $N$-tuple $\mathbf{u}=\left(u_{0}, u_{1}, \ldots, u_{N-1}\right) \in \mathbb{F}_{q}^{N}$ is

$$
\|\mathbf{u}\|=\left|\left\{0 \leq i \leq N-1: u_{i} \neq 0\right\}\right| .
$$

A cyclic code of length $N$ over $\mathbb{F}_{q}$ is an ideal $C$ of the quotient ring $R=\mathbb{F}_{q}[X] /\left\langle X^{N}\right.$ 1). Here a codeword $\left(c_{0}, c_{1}, \ldots, c_{N-1}\right) \in \mathbb{F}_{q}^{N}$ of $C$ corresponds to an element $c_{0}+c_{1} X+\cdots+c_{N-1} X^{N-1}+\left\langle X^{N}-1\right\rangle \in C$. All ideals of $R$ are principal. The monic polynomial $g(X)$ of the least degree such that $C=\langle g(X)\rangle /\left\langle X^{N}-1\right\rangle$ is called the generator polynomial of $C$. The dual $C^{\perp}$ is cyclic with generator polynomial $X^{\operatorname{deg} h} h\left(X^{-1}\right) / h(0)$, where $h(X)=\left(X^{N}-1\right) / g(X)$.

If $\theta \in \mathbb{F}_{q^{n}}$ is a root of $g(X)$, then so is $\theta^{q}$. A set $B \subset \mathbb{F}_{q^{n}}$ is called a basic zero set of $C$ if both of the following conditions are satisfied:

- $\left\{\theta^{q^{i}}: \theta \in B, 0 \leq i \leq n-1\right\}$ is the set of the roots of $g(X)$.
- If $\theta_{1}, \theta_{2} \in B$ with $\theta_{1}^{q^{i}}=\theta_{2}$ for some integer $i$, then $\theta_{1}=\theta_{2}$.

The following proposition gives a natural connection to some cyclic codes. Some arguments in its proof will also be used in the next section.

Proposition 5.1. Let $\gamma$ be a primitive element of $\mathbb{F}_{q^{n}}^{*}$. Let $C$ be the cyclic code of length $N=q^{n}-1$ over $\mathbb{F}_{q}$ whose dual code $C^{\perp}$ has

$$
\left\{1, \gamma^{q-1}, \gamma^{q^{2}-1}, \ldots, \gamma^{q^{n-1}-1}\right\}
$$

as a basic zero set. We have the following: There exists a $q$-linearized polyno$\operatorname{mial} L(X)=a_{0} X+a_{1} X^{q}+\cdots+a_{n-1} X^{q^{n-1}} \in \mathbb{F}_{q^{n}}[X]$ with $\left(a_{1}, a_{2}, \ldots, a_{n-1}\right) \neq$ $(0,0, \ldots, 0)$ such that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$ if and only if the cyclic code $C$ has a codeword $\left(c_{0}, c_{1}, \ldots, c_{N-1}\right)$ of Hamming weight $N$ such that $\left(c_{0}, c_{1}, \ldots, c_{N-1}\right) \neq u(1,1, \ldots, 1)$ for any $u \in \mathbb{F}_{q}^{*}$. Moreover the dimension of $C$ over $\mathbb{F}_{q}$ is $n^{2}-n+1$.
Proof. We first show that $\left\{1, \gamma^{q-1}, \gamma^{q^{2}-1}, \ldots, \gamma^{q^{n-1}-1}\right\}$ is a basic zero set. This means that the exponents $0, q-1, q^{2}-1, \ldots, q^{n-1}-1$ are in distinct $q$-cyclotomic cosets modulo $q^{n}-1$. For $0 \leq d<q^{n}-1$, let $\psi(d)$ be the base $q$ digits of $d$, i.e., $\psi(d)=\left(d_{0}, d_{1}, \ldots, d_{n-1}\right)$, where $0 \leq d_{i} \leq q-1$ are integers such that $d=\sum_{i=0}^{n-1} d_{i} q^{i}$. Let $\overline{0}, \overline{q-1}, \overline{q^{2}-1}, \ldots, \overline{q^{n-1}-1}$ denote the $q$-cyclotomic cosets of $0, q-1, q^{2}-1, \ldots, q^{n-1}-1$ modulo $q^{n}-1$. Their images under $\psi$ are

$$
\begin{aligned}
& \psi(\overline{0})=\{(0,0, \ldots, 0)\} \\
& \psi(\overline{q-1})=\{(q-1,0,0, \ldots, 0),(0, q-1,0, \ldots, 0), \ldots,(0,0,, \ldots, 0, q-1)\} \\
& \psi\left(\overline{q^{2}-1}\right)=\{(q-1, q-1,0, \ldots, 0),(0, q-1, q-1, \ldots, 0), \ldots,(q-1,0, \ldots, 0, q-1)\} \\
& \quad \vdots \\
& \psi\left(\overline{q^{n-1}-1}\right)=\{(q-1, \ldots, q-1,0),(0, q-1, \ldots, q-1), \ldots,(q-1, \ldots, q-1.0)\}
\end{aligned}
$$

Note that the elements in each row are obtained via cyclic shifts of the first element of the row. This proves that $0, q-1, q^{2}-1, \ldots, q^{n-1}-1$ are in distinct $q$-cyclotomic cosets modulo $q^{n}-1$. Moreover the cardinality of the union of their $q$-cyclotomic cosets modulo $q^{n}-1$ is

$$
1+(n-1) n=n^{2}-n+1
$$

Therefore the dimensions of $C$ is $n^{2}-n+1$. Finally using Delsarte's Theorem [26, Theorem 9.1.2] we obtain that the codewords of $C$ in $\mathbb{F}_{q}^{N}$ are

$$
C=\left\{\left(\operatorname{Tr}_{q^{n} / q}\left(a_{0}+a_{1} x^{q-1}+\cdots+a_{n-1} x^{q^{n-1}-1}\right)\right)_{x \in \mathbb{F}_{q^{n}}^{*}}: a_{0}, a_{1}, \ldots, a_{n-1} \in \mathbb{F}_{q^{n}}\right\}
$$

Note that $\operatorname{Tr}_{q^{n} / q}(L(x) / x)=u$ for all $x \in \mathbb{F}_{q^{n}}^{*}$ if and only if $\operatorname{Tr}_{q^{n} / q}(L(X) / X) \equiv u$ $\left(\bmod X^{q^{n}}-X\right)$, from which it follows that $\left(a_{1}, a_{2}, \ldots, a_{n-1}\right)=(0,0, \ldots, 0)$. This completes the proof.
6. Some conditions via the Hasse-Weil-Serre bound for general $\mathbb{F}_{q}$

In this section we obtain some necessary conditions for the $q$-linearized polynomials $L(X) \in \mathbb{F}_{q^{n}}[X]$ such that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$.

The Hasse-Weil-Serre bound for algebraic curves over finite fields implies upper and lower bounds on the Hamming weights of codewords of cyclic codes (see [10, [28]). Using this method we obtain Theorem 6.1.

First we introduce further notations. Let Res : $\mathbb{Z} \rightarrow\left\{0,1, \ldots, q^{n}-2\right\}$ be the map such that $\operatorname{Res}(j) \equiv j\left(\bmod q^{n}-1\right)$. Put $q=p^{m}$ with $m \geq 1$, where $p$ is the characteristic of $\mathbb{F}_{q}$. Let Lead : $\left\{0,1, \ldots, p^{m n}-2\right\} \rightarrow\left\{0,1, \ldots, p^{m n}-2\right\}$ be the map sending $j$ to the smallest integer $k$ in $\left\{0,1, \ldots, p^{m n-2}\right\}$ such that $k \equiv j p^{u}$ $\left(\bmod p^{m n}-1\right)$ for some integer $u \geq 0$. In other words, $\operatorname{Lead}(j)$ is the smallest nonnegative integer in the $p$-cyclotomic coset of $j$ modulo $p^{m n}-1$. It is important to note that if $0<j<p^{m n}-1$, then $\operatorname{Lead}(j)$ is a nonnegative integer which is coprime to $p$.
Theorem 6.1. Let $L(X)=a_{0} X+a_{1} X^{q}+\cdots+a_{n-1} X^{q^{n-1}} \in \mathbb{F}_{q^{n}}[X]$ be a $q$ linearized polynomial with $\left(a_{1}, \ldots, a_{n-1}\right) \neq(0, \ldots, 0)$. For each $1 \leq j \leq q^{n}-2$ with $\operatorname{gcd}\left(j, q^{n}-1\right)=1$, let

$$
\ell(j)=\max \left\{\operatorname{Lead}\left(\operatorname{Res}\left(j\left(q^{i}-1\right)\right)\right): 1 \leq i \leq n-1 \text { and } a_{i} \neq 0\right\}
$$

Moreover, let

$$
\begin{equation*}
\ell=\min _{j} \ell(j) \tag{6.1}
\end{equation*}
$$

where the minimum is over all integers $1 \leq j \leq q^{n}-2$ with $\operatorname{gcd}\left(j, q^{n}-1\right)=1$. Then we have the following:

- Case $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right) \neq 0$ : If

$$
\begin{equation*}
q^{n}+1-\frac{(q-1)(\ell-1)}{2}\left\lfloor 2 q^{n / 2}\right\rfloor>1 \tag{6.2}
\end{equation*}
$$

then it is impossible that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$.

- Case $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right)=0$ : If

$$
\begin{equation*}
q^{n}+1-\frac{(q-1)(\ell-1)}{2}\left\lfloor 2 q^{n / 2}\right\rfloor>q+1 \tag{6.3}
\end{equation*}
$$

then it is impossible that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$.
Proof. If $\gamma$ is a primite element of $\mathbb{F}_{q^{n}}^{*}$, then $\gamma^{j}$ is also a primitive element of $\mathbb{F}_{q^{n}}^{*}$ for all $1 \leq j \leq q^{n}-2$ with $\operatorname{gcd}\left(j, q^{n}-1\right)=1$. Note that

$$
\operatorname{Tr}_{q^{n} / q}(L(x) / x)=\operatorname{Tr}_{q^{n} / q}\left(a_{0}+a_{1} x^{q-1}+\cdots+a_{n-1} x^{q^{n-1}-1}\right) \neq 0 \text { for all } x \in \mathbb{F}_{q^{n}}^{*}
$$

if and only if
$\operatorname{Tr}_{q^{n} / q}\left(L\left(x^{j}\right) / x^{j}\right)=\operatorname{Tr}_{q^{n} / q}\left(a_{0}+a_{1} x^{j(q-1)}+\cdots+a_{n-1} x^{j\left(q^{n-1}-1\right)}\right) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$.
Moreover, $x^{j\left(q^{i}-1\right)}=x^{\operatorname{Res}\left(j\left(q^{i}-1\right)\right)}$ for $x \in \mathbb{F}_{q^{n}}^{*}, 1 \leq i \leq n-1$ and $1 \leq j \leq q^{n}-2$.
Recall that $\ell$ is defined in (6.1). We choose and fix an integer $1 \leq j \leq q^{n}-2$ with $\operatorname{gcd}\left(j, q^{n}-1\right)=1$ such that $\ell=\ell(j)$.

Let $a_{t_{1}}, \ldots, a_{t_{s}}$ be the nonzero coefficients among $a_{1}, \ldots, a_{n-1}$. (Note that $s \geq 1$ since $\left(a_{1}, \ldots, a_{n-1}\right) \neq(0, \ldots, 0)$.) Since $0, q^{t_{1}}-1, \ldots, q^{t_{s}}-1$ belong to different $p$-cyclotomic cosets modulo $q^{n}-1$ and $\operatorname{gcd}\left(j, q^{n}-1\right)=1$, we have that $0, j\left(q^{t_{1}}-\right.$ 1) $, \ldots, j\left(q^{t_{s}}-1\right)$ belong to different $p$-cyclotomic cosets modulo $q^{n}-1$. Thus $\operatorname{Res}\left(j\left(q^{t_{i}}-1\right)\right)=j_{i} p^{u_{i}}$, where $u_{i} \geq 0, p \nmid j_{i}, 1 \leq i \leq s$, and $j_{1}, \ldots, j_{s}$ are distinct. We may assume $0<j_{1}<j_{2}<\cdots<j_{s}=\ell$. We have
$a_{0}+a_{1} X^{\operatorname{Res}(j(q-1))}+\cdots+a_{n-1} X^{\operatorname{Res}\left(j\left(q^{n-1}-1\right)\right)}=a_{0}+b_{1} X^{j_{1} p^{u_{1}}}+\cdots+b_{s} X^{j_{s} p^{u_{s}}}$, where $b_{i}=a_{t_{i}}, 1 \leq i \leq s$.

Let $\chi$ be the Artin-Shreier type algebraic curve over $\mathbb{F}_{q^{n}}$ given by

$$
\chi: Y^{q}-Y=a_{0}+b_{1} X^{j_{1} p^{u_{1}}}+\cdots+b_{s} X^{j_{s} p^{u_{s}}}
$$

Let $S \subset \mathbb{F}_{p^{m n}}^{*}$ be a complete set of coset representatives of $\mathbb{F}_{p}^{*}$ in $\mathbb{F}_{p^{m n}}^{*}$. For $\mu \in S$, let $\chi_{\mu}$ be the Artin-Shreier type algebraic curve over $\mathbb{F}_{q^{n}}$ given by

$$
\chi_{\mu}: Y^{p}-Y=\mu\left(a_{0}+b_{1} X^{j_{1} p^{u_{1}}}+\cdots+b_{s} X^{j_{s} p^{u_{s}}}\right)
$$

Note that $\chi_{\mu}$ is a degree $p$ covering of the projective line. Using [9, Theorem 2.1] the genus $g(\chi)$ of $\chi$ is computed in terms of the genera of $\chi_{\mu}$ as

$$
\begin{equation*}
g(\chi)=\sum_{\mu \in S} g\left(\chi_{\mu}\right) \tag{6.4}
\end{equation*}
$$

Now we determine the genus $g\left(\chi_{\mu}\right)$ of $\chi_{\mu}$. We choose and fix $\mu \in S$. Let $c_{1}, c_{2}, \ldots, c_{s} \in \mathbb{F}_{p^{m n}}^{*}$ be such that

$$
c_{1}^{p^{u_{1}}}=\mu b_{1}, c_{2}^{p^{u_{2}}}=\mu b_{2}, \ldots, c_{s}^{p^{u_{s}}}=\mu b_{s}
$$

Let $\chi_{\mu}^{\prime}$ be the Artin-Schreier type algebraic curve over $\mathbb{F}_{q^{n}}$ given by

$$
\chi_{\mu}^{\prime}: Y^{p}-Y=\mu a_{0}+c_{1} X^{j_{1}}+\cdots+c_{s} X^{j_{s}}
$$

We observe that $\chi_{\mu}$ and $\chi_{\mu}^{\prime}$ are birationally isomorphic and hence the genera $g\left(\chi_{\mu}\right)$ and $g\left(\chi_{\mu}^{\prime}\right)$ are the same. Indeed, if $u_{1} \geq 1$, then

$$
\begin{aligned}
Y^{p}-Y & =\mu a_{0}+c_{1}^{p^{u_{1}}} X^{j_{1} p^{u_{1}}}+c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}+\cdots+c_{s}^{p^{u_{s}}} X^{j_{s} p^{u_{s}}} \\
& =\mu a_{0}+\left(c_{1}^{p^{u_{1}-1}} X^{j_{1} p^{u_{1}-1}}\right)^{p}+c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}+\cdots+c_{s}^{p_{s}} X^{j_{s} p^{u_{s}}}
\end{aligned}
$$

and hence

$$
\begin{aligned}
& {\left[Y-\left(c_{1}^{p^{u_{1}-1}} X^{j_{1} p^{u_{1}-1}}\right)\right]^{p}-\left[Y-\left(c_{1}^{p^{u_{1}-1}} X^{j_{1} p^{u_{1}-1}}\right)\right]} \\
& =\mu a_{0}+c_{1}^{p^{u_{1}-1}} X^{j_{1} p^{u_{1}-1}}+c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}+\cdots+c_{s}^{p_{s}} X^{j_{s} p^{u_{s}}}
\end{aligned}
$$

This gives a birational isomorphism between $\chi_{\mu}$ and the curve given by

$$
Y^{p}-Y=\mu a_{0}+c_{1}^{p^{u_{1}-1}} X^{j_{1} p^{u_{1}-1}}+c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}+\cdots+c_{s}^{p^{u_{s}}} X^{j_{s} p^{u_{s}}}
$$

By induction on $u_{1}$ we obtain a birational isomorphism between $\chi_{\mu}$ and the curve given by

$$
Y^{p}-Y=\mu a_{0}+c_{1} X^{j_{1}}+c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}+\cdots+c_{s}^{p^{u_{s}}} X^{j_{s} p^{u_{s}}}
$$

Applying the same method to the monomials $c_{2}^{p^{u_{2}}} X^{j_{2} p^{u_{2}}}, \ldots, c_{s}^{p^{u_{s}}} X^{j_{s} p^{u_{s}}}$ we conclude that the curves $\chi_{\mu}$ and $\chi_{\mu}^{\prime}$ are birationally isomorphic.

Recall that the integers $0, j_{1}, \ldots, j_{s}$ are in distinct $p$-cyclotomic cosets modulo $q^{n}-1$. As $c_{s} \neq 0$ and $\operatorname{gcd}\left(j_{s}, p\right)=1$ we obtain that $\chi_{\mu}^{\prime}$ is absolutely irreducible over $\mathbb{F}_{q^{n}}$. Moreover $s \geq 1$ and $j_{s}=\ell$. Hence by [26, Proposition 3.7.8] we have

$$
g\left(\chi_{\mu}\right)=g\left(\chi_{\mu}^{\prime}\right)=(p-1)(\ell-1) / 2
$$

which is independent from the choice of $\mu \in S$. Using (6.4) for the genus $g(\chi)$ of $\chi$ we obtain that

$$
g(\chi)=\sum_{\mu \in S} g\left(\chi_{\mu}\right)=|S|(p-1)(\ell-1) / 2=(q-1)(\ell-1) / 2
$$

Assume that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$. The number $N(\chi)$ of $\mathbb{F}_{q^{n-}}$ rational points of $\chi$ is

$$
N(\chi)=1+q\left|\left\{x \in \mathbb{F}_{q^{n}}: \operatorname{Tr}(L(x) / x)=0\right\}\right|=\left\{\begin{array}{cl}
1 & \text { if } \operatorname{Tr}_{q^{n} / q}\left(a_{0}\right) \neq 0  \tag{6.5}\\
q+1 & \text { if } \operatorname{Tr}_{q^{n} / q}\left(a_{0}\right)=0
\end{array}\right.
$$

The Hasse-Weil-Serre lower bound on $N(\chi)$ (see, for example, [26, Theorem 5.3.1]) implies that

$$
\begin{equation*}
N(\chi) \geq q^{n}+1-\frac{(q-1)(\ell-1)}{2}\left\lfloor 2 q^{n / 2}\right\rfloor \tag{6.6}
\end{equation*}
$$

Combining (6.2), (6.3), (6.5) and (6.6), we complete the proof.

The following corollary, which is a restatement of Theorem 6.1] shows that the distribution of the nonzero coefficients of a $q$-linearized polynomial $L$ satisfying $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq 0$ for all $x \in \mathbb{F}_{q^{n}}^{*}$ is subject to certain restrictions.

Corollary 6.2. Let $L(X)=a_{0} X+a_{1} X^{q}+\cdots+a_{n-1} X^{q^{n-1}} \in \mathbb{F}_{q^{n}}[X]$ be a $q$ linearized polynomial with $\left(a_{1}, \ldots, a_{n-1}\right) \neq(0, \ldots, 0)$. Assume that $\operatorname{Tr}_{q^{n} / q}(L(x) / x) \neq$ 0 for all $x \in \mathbb{F}_{q^{n}}^{*}$. Then for each integer $1 \leq j \leq q^{n}-2$ with $\operatorname{gcd}\left(j, q^{n}-1\right)=1$ we have the following:
(i) If $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right) \neq 0$, there exits $1 \leq i \leq n-1$ such that $a_{i} \neq 0$ and

$$
\operatorname{Lead}\left(\operatorname{Res}\left(j\left(q^{i}-1\right)\right)\right) \geq 1+\left\lceil\frac{2 q^{n}}{(q-1)\left\lfloor 2 q^{n / 2}\right\rfloor}\right\rceil
$$

(ii) If $\operatorname{Tr}_{q^{n} / q}\left(a_{0}\right)=0$, there exits $1 \leq i \leq n-1$ such that $a_{i} \neq 0$ and

$$
\operatorname{Lead}\left(\operatorname{Res}\left(j\left(q^{i}-1\right)\right)\right) \geq 1+\left\lceil\frac{2\left(q^{n}-q\right)}{(q-1)\left\lfloor 2 q^{n / 2}\right\rfloor}\right\rceil
$$
