# E-cospectral hypergraphs and some hypergraphs determined by their spectra

#### Abstract

Two $k$-uniform hypergraphs are said to be cospectral (E-cospectral), if their adjacency tensors have the same characteristic polynomial (E-characteristic polynomial). A $k$-uniform hypergraph $H$ is said to be determined by its spectrum, if there is no other non-isomorphic $k$-uniform hypergraph cospectral with $H$. In this note, we give a method for constructing E-cospectral hypergraphs, which is similar with Godsil-McKay switching. Some hypergraphs are shown to be determined by their spectra.

## 1. Introduction

For a positive integer $n$, let $[n]=\{1, \ldots, n\}$. An order $k$ dimension $n$ tensor $\mathcal{A}=\left(a_{i_{1} \cdots i_{k}}\right) \in \mathbb{C}^{n \times \cdots \times n}$ is a multidimensional array with $n^{k}$ entries, where $i_{j} \in[n], j=1, \ldots, k . \mathcal{A}$ is called symmetric if $a_{i_{1} i_{2} \cdots i_{k}}=a_{i_{\sigma(1)} i_{\sigma(2)} \cdots i_{\sigma(k)}}$ for any permutation $\sigma$ on $[k]$. We sometimes write $a_{i_{1} \cdots i_{k}}$ as $a_{i_{1} \alpha}$, where $\alpha=i_{2} \cdots i_{k}$. When $k=1, \mathcal{A}$ is a column vector of dimension $n$. When $k=2, \mathcal{A}$ is an $n \times n$ matrix. The unit tensor of order $k \geqslant 2$ and dimension $n$ is the tensor $\mathcal{I}_{n}=\left(\delta_{i_{1} i_{2} \cdots i_{k}}\right)$ such that $\delta_{i_{1} i_{2} \cdots i_{k}}=1$ if $i_{1}=i_{2}=\cdots=i_{k}$, and

[^0]$\delta_{i_{1} i_{2} \cdots i_{b}}=0$ otherwise. When $k=2, \mathcal{I}_{n}$ is the identity matrix $I_{n}$. Recently, Shao [17] introduce the following product of tensors, which is a generalization of the matrix multiplication.

Definition 1.1. [17] Let $\mathcal{A}$ and $\mathcal{B}$ be order $m \geqslant 2$ and order $k \geqslant 1$, dimension $n$ tensors, respectively. The product $\mathcal{A B}$ is the following tensor $\mathcal{C}$ of order $(m-1)(k-1)+1$ and dimension $n$ with entries:

$$
c_{i \alpha_{1} \ldots \alpha_{m-1}}=\sum_{i_{2}, \ldots, i_{m} \in[n]} a_{i i_{2} \ldots i_{m}} b_{i_{2} \alpha_{1}} \cdots b_{i_{m} \alpha_{m-1}},
$$

where $i \in[n], \alpha_{1}, \ldots, \alpha_{m-1} \in[n]^{k-1}$.
Let $\mathcal{A}$ be an order $m \geqslant 2$ dimension $n$ tensor, and let $x=\left(x_{1}, \ldots, x_{n}\right)^{\top}$. From Definition 1.1, the product $\mathcal{A} x$ is a vector in $\mathbb{C}^{n}$ whose $i$-th component is (see Example 1.1 in [17])

$$
(\mathcal{A} x)_{i}=\sum_{i_{2}, \ldots, i_{m} \in[n]} a_{i i_{2} \cdots i_{m}} x_{i_{2}} \cdots x_{i_{m}} .
$$

In 2005, the concept of tensor eigenvalues was posed by Qi 13] and Lim [11]. A number $\lambda \in \mathbb{C}$ is called an eigenvalue of $\mathcal{A}$, if there exists a nonzero vector $x \in \mathbb{C}^{n}$ such that $\mathcal{A} x=\lambda x^{[m-1]}$, where $x^{[m-1]}=\left(x_{1}^{m-1}, \ldots, x_{n}^{m-1}\right)^{\top}$. The determinant of $\mathcal{A}$, denoted by $\operatorname{det}(\mathcal{A})$, is the resultant of the system of polynomials $f_{i}\left(x_{1}, \ldots, x_{n}\right)=(\mathcal{A} x)_{i}(i=1, \ldots, n)$. The characteristic polynomial of $\mathcal{A}$ is defined as $\Phi_{\mathcal{A}}(\lambda)=\operatorname{det}\left(\lambda \mathcal{I}_{n}-\mathcal{A}\right)$, where $\mathcal{I}_{n}$ is the unit tensor of order $m$ and dimension $n$. It is known that eigenvalues of $\mathcal{A}$ are exactly roots of $\Phi_{\mathcal{A}}(\lambda)$ (see [17]).

For an order $m \geqslant 2$ dimension $n$ tensor $\mathcal{A}$, a number $\lambda \in \mathbb{C}$ is called an $E$-eigenvalue of $\mathcal{A}$, if there exists a nonzero vector $x \in \mathbb{C}^{n}$ such that $\mathcal{A} x=\lambda x$ and $x^{\top} x=1$. In [14], the $E$-characteristic polynomial of $\mathcal{A}$ is defined as

$$
\phi_{\mathcal{A}}(\lambda)= \begin{cases}\operatorname{Res}_{x}\left(\mathcal{A} x-\lambda\left(x^{\top} x\right)^{\frac{m-2}{2}} x\right) & m \text { is even } \\ \operatorname{Res}_{x, \beta}\binom{\mathcal{A} x-\lambda \beta^{m-2} x}{x^{\top} x-\beta^{2}} & m \text { is odd }\end{cases}
$$

where 'Res' is the resultant of the system of polynomials. It is known that Eeigenvalues of $\mathcal{A}$ are roots of $\phi_{\mathcal{A}}(\lambda)$ (see [14]). If $m=2$, then $\phi_{\mathcal{A}}(\lambda)=\Phi_{\mathcal{A}}(\lambda)$ is just the characteristic polynomial of the square matrix $\mathcal{A}$.

A hypergraph $H$ is called $k$-uniform if each edge of $H$ contains exactly $k$ distinct vertices. All hypergraphs in this note are uniform and simple. Let $K_{n}^{k}$ denote the complete $k$-uniform hypergraph with $n$ vertices, i.e., every $k$ distinct vertices of $K_{n}^{k}$ forms an edge. For a $k$-uniform hypergraph $H=$ $(V(H), E(H))$, a hypergraph $G=(V(G), E(G))$ is a sub-hypergraph of $H$, if $V(G) \subseteq V(H)$ and $E(G) \subseteq E(H)$. For any edge $u_{1} \cdots u_{k} \in E(H)$, we say that $u_{k}$ is a neighbor of $\left\{u_{1}, \ldots, u_{k-1}\right\}$. The complement of $H$ is a $k$ uniform hypergraph with vertex set $V(H)$ and edge set $E\left(K_{|V(H)|}^{k}\right) \backslash E(H)$. The adjacency tensor of $H$, denoted by $\mathcal{A}_{H}$, is an order $k$ dimension $|V(H)|$ tensor with entries (see [2])

$$
a_{i_{1} i_{2} \cdots i_{k}}= \begin{cases}\frac{1}{(k-1)!} & \text { if } i_{1} i_{2} \cdots i_{k} \in E(H), \\ 0 & \text { otherwise. }\end{cases}
$$

Clearly $\mathcal{A}_{H}$ is a symmetric tensor. We say that two $k$-uniform hypergraphs are cospectral ( $E$-cospectral), if their adjacency tensors have the same characteristic polynomial (E-characteristic polynomial). A $k$-uniform hypergraph $H$ is said to be determined by its spectrum, if there is no other non-isomorphic $k$-uniform hypergraph cospectral with $H$. We shall use "DS" as an abbreviation for "determined by its spectrum" in this note. Cospectral (E-cospectral) hypergraphs and DS hypergraphs are generalizations of cospectral graphs and DS graphs in the classic sense [3].

Recently, the research on spectral theory of hypergraphs has attracted extensive attention [2,6-9,12,15-20]. In this note, we give a method for constructing E-cospectral hypergraphs. Some hypergraphs are shown to be DS.

## 2. Preliminaries

The following lemma can be obtained from equation (2.1) in [17].
Lemma 2.1. Let $\mathcal{A}=\left(a_{i_{1} \cdots i_{m}}\right)$ be an order $m \geqslant 2$ dimension $n$ tensor, and let $P=\left(p_{i j}\right)$ be an $n \times n$ matrix. Then

$$
\left(P \mathcal{A} P^{\top}\right)_{i_{1} \cdots i_{m}}=\sum_{j_{1}, \ldots, j_{m} \in[n]} a_{j_{1} \cdots j_{m}} p_{i_{1} j_{1}} p_{i_{2} j_{2}} \cdots p_{i_{m} j_{m}}
$$

We can obtain the following lemma from Lemma 2.1.
Lemma 2.2. Let $\mathcal{B}=P \mathcal{A} P^{\top}$, where $\mathcal{A}$ is a tensor of dimension n, $P$ is an $n \times n$ matrix. If $\mathcal{A}$ is symmetric, then $\mathcal{B}$ is symmetric.

Let $\mathcal{B}=P \mathcal{A} P^{\top}$, where $\mathcal{A}$ is a tensor of dimension $n, P$ is an $n \times n$ real orthogonal matrix. In [17], Shao pointed out that $\mathcal{A}, \mathcal{B}$ are orthogonally similar tensors defined by Qi [13]. Orthogonally similar tensors have the following property.

Lemma 2.3. 10] Let $\mathcal{B}=P \mathcal{A} P^{\top}$, where $\mathcal{A}$ is a tensor of dimension n, $P$ is an $n \times n$ real orthogonal matrix. Then $\mathcal{A}$ and $\mathcal{B}$ have the same $E$ characteristic polynomial.

A simplex in a $k$-uniform hypergraph is a set of $k+1$ vertices where every set of $k$ vertices forms an edge (see [2, Definition 3.4]).

Lemma 2.4. Let $G$ and $H$ be cospectral $k$-uniform hypergraphs. Then $G$ and $H$ have the same number of vertices, edges and simplices.

Proof. The degree of the characteristic polynomial of an order $k$ dimension $n$ tensors is $n(k-1)^{n-1}$ (see [13]). Since $\mathcal{A}_{G}$ and $\mathcal{A}_{H}$ are order $k$ tensors, $G$ and $H$ have the same number of vertices. From [2, Theorem 3.15] and [2, Theorem 3.17], we know that $G$ and $H$ have the same number of edges and simplices.

## 3. Main results

Let $H=(V(H), E(H))$ be a $k$-uniform hypergraph with a partition $V(H)=V_{1} \cup V_{2}$, and $H$ satisfies the following conditions:
(a) For each edge $e \in E(H)$, $e$ contains at most one vertex in $V_{1}$.
(b) For any $k-1$ distinct vertices $u_{1}, \ldots, u_{k-1} \in V_{2},\left\{u_{1}, \ldots, u_{k-1}\right\}$ has either $0, \frac{1}{2}\left|V_{1}\right|$ or $\left|V_{1}\right|$ neighbors in $V_{1}$.

Similar with GM switching [4, 5], we construct a hypergraph E-cospectral with $H$ as follows.

Theorem 3.1. Let $H$ be a $k$-uniform hypergraph satisfies the conditions (a) and (b) described above. For any $\left\{u_{1}, \ldots, u_{k-1}\right\} \subseteq V_{2}$ which has $\frac{1}{2}\left|V_{1}\right|$ neighbors in $V_{1}$, by replacing these $\frac{1}{2}\left|V_{1}\right|$ neighbors with the other $\frac{1}{2}\left|V_{1}\right|$ vertices in $V_{1}$, we obtain a $k$-uniform hypergraph $G$ which is $E$-cospectral with $H$.

Proof. Let $P=\left(\begin{array}{cc}\frac{2}{n_{1}} J-I_{n_{1}} & 0 \\ 0 & I_{n_{2}}\end{array}\right)$, where $n_{1}=\left|V_{1}\right|, n_{2}=\left|V_{2}\right|, J$ is the $n_{1} \times n_{1}$ all-ones matrix, $\frac{2}{n_{1}} J-I_{n_{1}}$ and $I_{n_{2}}$ correspond to the vertex sets $V_{1}$ and $V_{2}$, respectively. Then $P=P^{\top}=P^{-1}$. Suppose that $\mathcal{A}_{H}=\left(a_{i_{1} i_{2} \cdots i_{k}}\right)$, and
let $\mathcal{B}=P \mathcal{A}_{H} P^{\top}$. By Lemma [2.2, $\mathcal{B}$ is symmetric. We need to show that $\mathcal{B}=\mathcal{A}_{G}$. By Lemma 2.1, we have

$$
\begin{equation*}
(\mathcal{B})_{i_{1} \cdots i_{k}}=\sum_{j_{1}, \ldots, j_{k} \in V(H)} a_{j_{1} \cdots j_{k}} p_{i_{1} j_{1}} p_{i_{2} j_{2}} \cdots p_{i_{k} j_{k}} . \tag{1}
\end{equation*}
$$

Note that $P=\left(\begin{array}{cc}\frac{2}{n_{1}} J-I_{n_{1}} & 0 \\ 0 & I_{n_{2}}\end{array}\right)$. From Eq. (1), we have

$$
\begin{equation*}
(\mathcal{B})_{i_{1} \cdots i_{k}}=a_{i_{1} \cdots i_{k}} \text { if } i_{1}, \ldots, i_{k} \in V_{2} . \tag{2}
\end{equation*}
$$

Since $H$ satisfies the condition (a), we have $a_{j_{1} \cdots j_{k}}=0$ if $\left|\left\{j_{1}, \ldots, j_{k}\right\} \cap V_{1}\right| \geqslant 2$. From Eq. (1), we have

$$
\begin{equation*}
(\mathcal{B})_{i_{1} \cdots i_{k}}=a_{i_{1} \cdots i_{k}}=0 \text { if }\left|\left\{i_{1}, \ldots, i_{k}\right\} \cap V_{1}\right| \geqslant 2 . \tag{3}
\end{equation*}
$$

Next we consider the case $\left|\left\{i_{1}, \ldots, i_{k}\right\} \cap V_{1}\right|=1$. Note that $\mathcal{B}$ is symmetric. Without loss of generality, suppose that $i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2}$. From Eq. (11), we have

$$
\begin{equation*}
(\mathcal{B})_{i_{1} \cdots i_{k}}=\sum_{j_{1} \in V_{1}} a_{j_{1} i_{2} \cdots i_{k}} p_{i_{1} j_{1}}\left(i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2}\right) . \tag{4}
\end{equation*}
$$

Since $H$ satisfies the condition (b), $S^{i_{2} \cdots i_{k}}=\left\{a_{j_{1} i_{2} \cdots i_{k}} \mid j_{1} \in V_{1}, a_{j_{1} i_{2} \cdots i_{k}} \neq 0\right\}$ contains either $0, \frac{1}{2}\left|V_{1}\right|$ or $\left|V_{1}\right|$ elements for any given $i_{2}, \ldots, i_{k} \in V_{2}$. By computing the sum in (4), we have

$$
\begin{gather*}
(\mathcal{B})_{i_{1} \cdots i_{k}}=a_{i_{1} \cdots i_{k}}=0 \text { if } i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2},\left|S^{i_{2} \cdots i_{k}}\right|=0  \tag{5}\\
(\mathcal{B})_{i_{1} \cdots i_{k}}=a_{i_{1} \cdots i_{k}}=\frac{1}{(k-1)!} \text { if } i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2},\left|S^{i_{2} \cdots i_{k}}\right|=\left|V_{1}\right| .  \tag{6}\\
(\mathcal{B})_{i_{1} \cdots i_{k}}=0 \text { if } i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2}, a_{i_{1} \cdots i_{k}}=\frac{1}{(k-1)!},\left|S^{i_{2} \cdots i_{k}}\right|=\frac{1}{2}\left|V_{1}\right| .  \tag{7}\\
(\mathcal{B})_{i_{1} \cdots i_{k}}=\frac{1}{(k-1)!} \text { if } i_{1} \in V_{1}, i_{2}, \ldots, i_{k} \in V_{2}, a_{i_{1} \cdots i_{k}}=0,\left|S^{i_{2} \cdots i_{k}}\right|=\frac{1}{2}\left|V_{1}\right| . \tag{8}
\end{gather*}
$$

From Eqs. (2) (3) and (5)-(8), we have $\mathcal{B}=P \mathcal{A}_{H} P^{\top}=\mathcal{A}_{G}$. By Lemma 2.3, $G$ is E-cospectral with $H$.

If two $k$-uniform hypergraphs $G$ and $H$ are isomorphic, then there exists a permutation matrix $P$ such that $\mathcal{A}_{G}=P \mathcal{A}_{H} P^{\top}$ (see [1, 17]). From Lemma 2.3. we know that two isomorphic $k$-uniform hypergraphs are E-cospectral. By using the method in Theorem 3.1, we give a class of non-isomorphic E-cospectral hypergraphs as follows.

Example. Let $H$ be a 3 -uniform hypergraph whose vertex set and edge set are

$$
\begin{aligned}
V(H) & =\left\{u_{1}, u_{2}, u_{3}, u_{4}, v_{1}, \ldots, v_{n}\right\}(n \geqslant 3), \\
E(H) & =\left\{v_{1} v_{2} u_{2}, v_{1} v_{2} u_{3}, v_{2} v_{3} u_{2}, v_{2} v_{3} u_{4}, v_{1} v_{3} u_{3}, v_{1} v_{3} u_{4}\right\} \cup F,
\end{aligned}
$$

where each edge in $F$ contains three vertices in $\left\{v_{1}, \ldots, v_{n}\right\}$, and each vertex in $\left\{v_{4}, \ldots, v_{n}\right\}$ is contained in at least one edge in $F$ if $n \geqslant 4$. Let $G$ be a 3 -uniform hypergraph whose vertex set and edge set are
$V(G)=V(H), E(G)=\left\{v_{1} v_{2} u_{1}, v_{1} v_{2} u_{4}, v_{2} v_{3} u_{1}, v_{2} v_{3} u_{3}, v_{1} v_{3} u_{1}, v_{1} v_{3} u_{2}\right\} \cup F$.
The vertex set $V(H)$ has a partition $V(H)=V_{1} \cup V_{2}$ such that $H$ and $G$ satisfy the conditions in Theorem [3.1, where $V_{1}=\left\{u_{1}, u_{2}, u_{3}, u_{4}\right\}, V_{2}=\left\{v_{1}, \ldots, v_{n}\right\}$. Then $G$ and $H$ are E-cospectral. Moreover, $G$ and $H$ are non-isomorphic Ecospectral hypergraphs, because $H$ has an isolated vertex $u_{1}$ and $G$ has no isolated vertices.

Let $K_{n}^{k}-e$ denote the $k$-uniform hypergraph obtained from $K_{n}^{k}$ by deleting one edge. We can obtain the following result from Lemma 2.4.

Theorem 3.2. The complete $k$-uniform hypergraph $K_{n}^{k}$, the hypergraph $K_{n}^{k}-$ $e$ and their complements are DS. Any $k$-uniform sub-hypergraph of $K_{k+1}^{k}$ is $D S$. The disjoint union of $K_{k+1}^{k}$ and some isolated vertices is $D S$.

If $G$ is a sub-hypergraph of a hypergraph $H$, then let $H \backslash G$ denote the hypergraph obtained from $H$ by deleting all edges of $G$.

Theorem 3.3. The hypergraph $K_{n}^{k} \backslash G$ is $D S$, where $G$ is a $k$-uniform subhypergraph of $K_{n}^{k}$ such that all edges of $G$ share $k-1$ common vertices.

Proof. Let $H$ be any $k$-uniform hypergraph cospectral with $K_{n}^{k} \backslash G$. Suppose that $G$ has $r$ edges. By Lemma 2.4, $H$ can be obtained from $K_{n}^{k}$ by deleting $r$ edges. Deleting $r$ edges from $K_{n}^{k}$ destroys at least $\sum_{i=0}^{r-1}(n-k-i)$ simplices, with equality if and only if all deleted edges share $k-1$ common vertices. Lemma 2.4 implies that $H=K_{n}^{k} \backslash G$.
