# SOME CASES ON STRASSEN ADDITIVE CONJECTURE 

YOUNGHO WOO


#### Abstract

In this article, we verify the additivity for rank of a sum of coprime monomials and bivariate polynomials generalizing the result in ([CCG12]). We also show similar results hold for cactus rank.


## 1. Introduction

Given a homogeneous polynimial $F \in S^{d} V$ of degree $d$, the rank (or Waring rank) $\operatorname{rk}(F)$ of $F$ is the minimal number of linear forms $L_{1}, \ldots, L_{r} \in V$ satisfying $F=L_{1}^{d}+\cdots+L_{r}^{d}$. In CCG12, the authors show that rank of coprime monomials is the sum of ranks of such monomials. This work verified a particular case of the symmetric version of Strassen additive conjecture. (See [CC14 and reference therein)

Conjecture 1.1. If $F \in \mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$ and $G \in C\left[y_{0}, \ldots, y_{m}\right]$ are homogeneous polynomials of same degree $\geq 2$. Then $\operatorname{rk}(F+G)=\operatorname{rk}(F)+\operatorname{rk}(G)$

In this paper we verify this conjecture for $F$ and $G$ are sums of several coprime monomials and bivariate polymonimals. (See Corollary 3.6 for the precise statement). In the proof, we follows the same track as in CCG12. This is possible mainly because for a monomial or a bivariate form, the rank attains the lower bound of the inequality (2) in section 2 . In fact, we prove the conjecture for those polynomials satisfying this property. A similar method leads us to the same additivity property for cactus rank. (See section 3 and Corollary 4.6)

## 2. Preliminaries

2.1. Apolarity. Let $V$ be a finite dimensional vector space over the complex field $\mathbb{C}$ and $S=S V=\bigoplus_{d} S^{d} V$ be the polynomial algebra over $\mathbb{C}$ where $S^{d} V$ is the symmetric $d$-product. Similarly, let $T=S V^{*}=\bigoplus_{d} S^{d}\left(V^{*}\right)$ be the polynomial algebra of the dual space $V^{*}$. Then a polynomial $g \in T$ acts on $S$ as a linear differential operator. Given $F \in S^{d} V$, the perp ideal $F^{\perp} \subset T$ is the ideal of elements annihilating $F$. i.e.

$$
F^{\perp}=\{g \in T \mid g \cdot F=0\}
$$

It is well-known that the ideal $F^{\perp}$ is a homogeneous ideal such that the quotient $T / F^{\perp}$ is a zero-dimensional, Gorenstein algebra with socle degree $d$. A subscheme $X \subset \mathbb{P}(V)$ is called apolar to $F$ if $I_{X} \subset F^{\perp}$ where $I_{X}$ is the (saturated) homogeneous ideal of the subscheme $X$. Here we think of $T$ as the homogeneous coordinate ring of $\mathbb{P}(V)$.

Now suppose that $F \in S^{d} V$. Consider, up to scalar, $d$-th power $L^{d}$ of a linear form $L \in V$ as an image of the Veronese map $\nu_{d}: \mathbb{P}(V) \rightarrow \mathbb{P}\left(S^{d} V\right)$ defined by
$\nu_{d}([L])=\left[L^{d}\right]$. Then the point $[F] \in \mathbb{P}\left(S^{d} V\right)$ is contained in the linear span of the image $\nu_{d}\left(\left\{L_{1}, \ldots, L_{r}\right\}\right)$ if and only if $F=c_{1} L_{1}^{d}+\cdots+c_{r} L_{r}^{d}$ for some $c_{1}, \ldots, c_{r}$. Therefore the rank of $F$ is

$$
\min \left\{r \mid[F] \in<\nu_{d}(X)>, X \subset \mathbb{P}(V) \text { is reduced, } \operatorname{dim}(X)=0 \text { and } \operatorname{deg}(X)=r\right\}
$$

, where $<\cdot>$ means its linear span in $\mathbb{P}\left(S^{d} V\right)$.
The cactus rank of $F$ (denoted by $\operatorname{crk}(F))$ is defined similarly,

$$
\operatorname{crk}(F)=\min \left\{r \mid[F] \in<\nu_{d}(X)>, \operatorname{dim}(X)=0 \text { and } \operatorname{deg}(X)=r\right\}
$$

Note that in this case, we drop the condition "reduced" and consider all 0-dimensional subschemas $X \subset \mathbb{P}(V)$ of degree $r$.

Lemma 2.1 (Apolarity Lemma IK99). Let $F \in S^{d} V$ and $X \subset \mathbb{P}(V)$ be a zero dimensional subscheme. The point $[F] \in \mathbb{P}\left(S^{d} V\right)$ is in the linear span of $\nu_{d}(X)$ if and only if the subscheme $X$ is apolar to $F$. i.e. $I_{X} \subset F^{\perp} \subset T$.

Remark 2.2. Let $F \in S^{d} V$. According to the apolarity lemma, we can reformulate the definition of rank and cactus rank
(1) $\operatorname{rk}(F)=\min \left\{\operatorname{deg}(X) \mid X \subset \mathbb{P}(V)\right.$ is 0-dimensional, reduced and $\left.I_{X} \subset F^{\perp}\right\}$
(2) $\operatorname{crk}(F)=\min \left\{\operatorname{deg}(X) \mid X \subset \mathbb{P}(V)\right.$ is 0-dimensional and $\left.I_{X} \subset F^{\perp}\right\}$
2.2. Degree of a zero-dimensional subscheme. Let $X \subset \mathbb{P}(V)$ be a zerodimensional scheme, and let $I_{X} \subset T$ be the homogeneous ideal of $X$. Then for a linear form $l \in V^{*}$ such that $X \cap\{l=0\}=\phi$, we have

$$
\operatorname{deg}(X)=\operatorname{dim}_{\mathbb{C}} T /\left(I_{X}+(l)\right)=\sum_{i=0}^{\infty} H\left(T /\left(I_{X}+(l)\right), i\right)
$$

where $H\left(T /\left(I_{X}+(l)\right), \cdot\right)$ is the Hilbert function of $T /\left(I_{X}+(l)\right.$.
For a given $F \in S^{d} V$, if $X$ is apolar to $F$, then we have $\operatorname{deg}(X) \geq \operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}+(l)\right)$. On the other hand, the ideal $F^{\perp}+(l)$ defines a zero-dimensional subscheme in $\operatorname{Spec}(T)$. The length of this subscheme attains the minimum for a general $l$, by upper semi-continuity. So we conclude that

$$
\begin{equation*}
\operatorname{crk}(F) \geq \operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}+(l)\right) \text { for a general linear form } l \in V^{*} \tag{1}
\end{equation*}
$$

Now $t \in V^{*}$ be a linear form, assume that $X$ is reduced. Then the ideal quotient ( $I_{X}: t$ ) is the homogeneous ideal of the reduced subscheme $X \backslash\{t=0\}$. As above, if $X$ is apolar to $F$, then we have $\operatorname{deg}(X) \geq \operatorname{dim}_{\mathbb{C}} T /\left(\left(F^{\perp}: t\right)+(t)\right)$ and

$$
\begin{equation*}
\operatorname{rk}(F) \geq \operatorname{dim}_{\mathbb{C}} T /\left(\left(F^{\perp}: t\right)+(t)\right) \text { for any linear form } t \in V^{*} \tag{2}
\end{equation*}
$$

## 3. Rank

Definition 3.1. Let $F \in S^{d} V$ be a homogeneous polynomial of degree $d$, and $t \in V^{*}$. We will say that the rank of $F$ is computed by the linear form $t$ if

$$
\operatorname{rk}(F)=\operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}: t\right)+(t)
$$

Example 3.2 (Bivariate case). Suppose that $\operatorname{dim} V=2$. Then for every $F \in$ $S^{d} V$, the rank of $F$ is computed by some linear form $t \in V^{*}$. In fact, it is wellknown that $F^{\perp}=\left(g_{1}, g_{2}\right)$ for some homogeneous polynomials $g_{1}, g_{2} \in T$ of degree $d_{1} \leq d_{2}$ respectively. Let $t$ be any linear factor of $g_{1}$. Then the ideal quotient
$F^{\perp}: t=\left(g_{1} / t, g_{2}\right)$. In fact, it is obvious that $\left(g_{1} / t, g_{2}\right) \subset F^{\perp}: t$. Using an exact sequence

$$
0 \rightarrow T /\left(F^{\perp}: t\right) \rightarrow T / F^{\perp} \rightarrow T /\left(F^{\perp}, t\right) \rightarrow 0
$$

we have $\operatorname{dim} T /\left(F^{\perp}: t\right)=\left(d_{1}-1\right) d_{2}=\operatorname{dim} T /\left(g_{1} / t, g_{2}\right)$ because $t$ is not a factor of $g_{2}$. Hence $F^{\perp}: t=\left(g_{1} / t, g_{2}\right)$ holds. Now we have two separate cases
(1) ( $g_{1}$ has a double root) Then $\operatorname{rk}(F)=d_{2}$. Let $t$ be the multiple factor of $g_{1}$. Since $g_{1} / t$ still contains $t, \operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}: t\right)+(t)=d_{2}$
(2) ( $g_{1}$ has no double roots) Then $\operatorname{rk}(F)=d_{1}$. If $d_{1}<d_{2}$, then take $t$ as one of linear factors of $g_{2}$ and $\operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}: t\right)+(t)=d_{1}$. If $d_{1}=d_{2}$ and $g_{2}$ has no double roots, then we can choose $g_{1}^{\prime}=c_{1} g_{1}+c_{2} g_{2}$ for some constant $c_{1}, c_{2}$ such that $g_{1}^{\prime}$ has a double root and $F^{\perp}=\left(g_{1}^{\prime}, g_{2}\right)$ which belongs to the firtst case.

Example 3.3 (Monomial cases). (CCG12, BBZ13) Let $F=x_{0}^{a_{0}} \cdots x_{1}^{a_{n}} \in$ $\mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$. Let $\left\{t_{0}, \ldots, t_{n}\right\}$ be the dual basis of $\left\{x_{0}, \ldots, x_{n}\right\}$. Assume that $a_{0} \leq a_{i}$ for all $i$. Then $F^{\perp}=\left(t_{0}^{a_{0}+1}, \ldots, t_{n}^{a_{n}+1}\right)$ and $\operatorname{rk}(F)=\left(a_{1}+1\right) \cdots\left(a_{n}+1\right)$. Easy to see that $\left(F^{\perp}: t_{0}\right)+\left(t_{0}\right)=\left(t_{0}, t_{1}^{a_{1}+1}, \ldots, t_{n}^{a_{n}+1}\right)$. Therefore $\operatorname{rk}(F)=\operatorname{dim} T /\left(F^{\perp}:\right.$ $\left.\left.t_{0}\right)+\left(t_{0}\right)\right)$ is computed by $t_{0}$.

Now we fix some notations. Suppose that we have a decomposition $V=V_{1} \oplus V_{2} \oplus$ $\cdots \oplus V_{m}$ for some $m$ and the dual decomposition $V^{*}=V_{1}^{*} \oplus V_{2}^{*} \oplus \cdots \oplus V_{m}^{*}$. Then there is an natural idenfication $S\left(V_{i}\right)$ to a subspace of $S=S V$ (and $S\left(V_{i}^{*}\right)$ to $S V^{*}$ resp.) for each $i$. By abuse of notation, we will set $S_{i}=S\left(V_{i}\right)$ and $T_{i}=S\left(V_{i}^{*}\right)$. Suppose that $F_{i} \in S^{d}\left(V_{i}\right)$ and $t_{i} \in V_{i}^{*}$ for $i=1, \ldots, m$, and let $F=F_{1}+\cdots+F_{m} \in S^{d} V$. Fixing such $F_{i}$ and $t_{i}$ for all $i$, we put $J_{i}=\left(F_{i}^{\perp}: t_{i}\right)+\left(t_{i}, V_{1}^{*}, \ldots, V_{i-1}^{*}, V_{i+1}^{*}, \ldots, V_{m}^{*}\right)$. Here $F_{i}^{\perp}$ means the perp ideal of $F_{i}$ in $T_{i}$. For instance, $J_{1}$ is the ideal generated by

- $g \in T_{1}$ with $t_{1} g \in F_{1}^{\perp}$,
- $t_{1}$ and
- all linear forms in $V_{2}^{*}, \ldots, V_{m}^{*}$.
under the inclusion $T_{i} \subset T$.

Lemma 3.4. Notation as above. $\left(F^{\perp}:\left(t_{1}, \ldots, t_{m}\right)\right) \subset J_{1} \cap \cdots \cap J_{m}$.
PROOF. By symmetry, it is enough to show that $F^{\perp}: t_{1} \subset\left(F_{1}^{\perp}: t_{1}\right)+$ $\left(t_{1}, V_{2}^{*}, \ldots, V_{m}^{*}\right)$. Let $h \in\left(F^{\perp}: t_{1}\right)$. We can write $h=h_{1}+h_{2}$ where $h_{1} \in T_{1}$ and $h_{2} \in\left(V_{2}^{*}, \ldots, V_{m}^{*}\right)$. We claim that $h_{1} \in\left(F_{1}^{\perp}: t_{1}\right)$. By definition, $t_{1} h \in F^{\perp}$. Since $t_{1} h_{2} \in F^{\perp}$, we have $t_{1} h_{1}=t_{1} h-t_{1} h_{2} \in F^{\perp} \cap T_{1}=F_{1}^{\perp}$ and hence $h_{1} \in\left(F_{1}^{\perp}: t_{1}\right)$. The inclusion follows.

Proposition 3.5. Suppose that we have a decompsition $V=V_{1} \oplus V_{2} \oplus \cdots \oplus V_{m}$ for some $m$. Let $F_{i} \in S^{d} V_{i}$ for $1 \leq i \leq m$ and for $d \geq 2$, let $F=F_{1}+\ldots+F_{m} \in S^{d} V$. If the rank of $F_{i}$ is computed by some $t_{i} \in V_{i}^{*}$ for all $i$, then $\operatorname{rk}(F)=\operatorname{rk}\left(F_{1}\right)+\ldots+$ $\operatorname{rk}\left(F_{m}\right)$.

The proof proceeds similarly as in CCG12
PROOF. We will prove that

$$
\begin{equation*}
\operatorname{rk}(F) \geq \operatorname{rk}\left(F_{1}\right)+\cdots+r k\left(F_{m}\right) \tag{3}
\end{equation*}
$$

because the opposite inequality is obvious.
Let $r=\operatorname{rk}(F)$. Then by apolarity lemma, there is a finite set $X \subset \mathbb{P}(V)$ of degree $r$ such that the (saturated) homogeneous ideal $I_{X} \subset F^{\perp}$. Then the quotient ideal $I_{X}:\left(t_{1}, t_{2}, . ., t_{m}\right)$ is the homogeneous ideal of the subset $X^{\prime}$ of $X$ not lying on $\left\{t_{1}=t_{2}=\cdots=t_{m}=0\right\}$. Then a linear form $\lambda_{1} t_{1}+\cdots \lambda_{m} t_{m} \in V^{*}$ for general $\lambda_{1}, \ldots, \lambda_{m} \in \mathbb{C}$ does not vanish any point of $X^{\prime}$. By replacing $t_{i}$ by $\lambda_{i} t_{i}$, we may assume that $X^{\prime} \cap\left\{t_{1}+\cdots+t_{m}=0\right\}=\phi$. By the previous lemma and the fact $\left(t_{1}+\cdots+t_{m}\right) \subset J_{1} \cap \cdots \cap J_{m}$, we have

$$
\begin{equation*}
I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right) \subset J_{1} \cap \cdots \cap J_{m} \tag{4}
\end{equation*}
$$

Now we prove two claims.
Claim 1. $\operatorname{dim}_{\mathbb{C}} T /\left(J_{1} \cap \cdots \cap J_{m}\right)=\operatorname{rk}\left(F_{1}\right)+\cdots \operatorname{rk}\left(F_{m}\right)-(m-1)$.
For each $i=1, \ldots, 2$, one has $T / J_{i} \cong T_{i} /\left(\left(F_{i}^{\perp}: t_{i}\right)+\left(t_{i}\right)\right)$, and hence $\operatorname{dim} T / J_{i}=$ $\operatorname{rk}\left(F_{i}\right)$. From the exact sequence
$0 \rightarrow T /\left(J_{1} \cap \cdots \cap J_{m}\right) \rightarrow T /\left(J_{1} \cap \cdots \cap J_{m-1}\right) \oplus T / J_{m} \rightarrow T /\left(J_{1} \cap \cdots \cap J_{m-1}+J_{m}\right) \rightarrow 0$, and $T /\left(J_{1} \cap \cdots \cap J_{m-1}+J_{m}\right) \cong \mathbb{C}$, the assertion follows by induction.

Claim 2. $t_{1}, \ldots, t_{m}$ are linearly independent modulo $I_{X^{\prime}}$.
Suppose $\mu_{i} t_{1}+\cdots+\mu_{m} t_{m} \in I_{X^{\prime}}$ for some $\mu_{1}, \ldots, \mu_{m} \in \mathbb{C}$. Since this already vanishes along $\left\{t_{1}=\cdots=t_{m}=0\right\}$, we have $\mu_{1} t_{1}+\cdots \mu_{m} t_{m} \in I_{X} \subset F^{\perp}$. Then $\left(\mu_{1} t_{1}+\cdots \mu_{m} t_{m}\right) \cdot F=\mu_{1} t_{1} \cdot F_{1}+\cdots+\mu_{m} t_{m} \cdot F_{m}=0$. Note that each polynomial $t_{i} \cdot F_{i} \in S_{i}\left(=S\left(V_{i}\right)\right)$ has degree $\geq 1$ or $t_{i} \cdot F_{i}=0$ for $i=1, \ldots, m$. Since $t_{i}$ compute the rank of $F_{i}, t_{i} \cdot F_{i} \neq 0$. (Otherwise $1 \in\left(F_{i}: t_{i}\right)$.) Thus $\mu_{1}=\cdots=\mu_{m}=0$

From the claim 2 and the inclusion (4), we conclude that

$$
\begin{equation*}
H\left(T /\left(I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right)\right), 1\right) \geq H\left(T /\left(J_{1} \cap \cdots \cap J_{m}, 1\right)+(m-1)\right. \tag{5}
\end{equation*}
$$

since $t_{1}, \ldots, t_{m} \in J_{1} \cap \cdots \cap J_{m}$.
Now we verify the inequality (3).

$$
\begin{aligned}
r & \geq \operatorname{deg}\left(X^{\prime}\right)=\operatorname{dim} T /\left(\left(I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right)\right)\right. \\
& =\sum_{j=0}^{\infty} H\left(T /\left(I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right)\right), j\right) \\
& =H\left(T /\left(I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right)\right), 1\right)+\sum_{j \neq 1} H\left(T /\left(I_{X^{\prime}}+\left(t_{1}+\cdots+t_{m}\right)\right), j\right) \\
& \geq H\left(T /\left(J_{1} \cap \cdots \cap J_{m}, 1\right)+(m-1)+\sum_{j \neq 1} H\left(T /\left(J_{1} \cap \cdots \cap J_{m}, j\right)\right. \text { by (4) and (5) }\right. \\
& =\operatorname{dim}_{\mathbb{C}} T /\left(J_{1} \cap \cdots \cap J_{m}\right)+(m-1) \\
& =\operatorname{rk}\left(F_{1}\right)+\cdots \operatorname{rk}\left(F_{m}\right) \text { by the claim } 1
\end{aligned}
$$

Corollary 3.6. Let $F_{i} \in S^{d} V_{i}(d \geq 2)$ be a monomial or a bi-variate polynomial for each $i$. Then $\operatorname{rk}\left(F_{1}+\cdots+F_{m}\right)=\operatorname{rk}\left(F_{1}\right)+\cdots+\operatorname{rk}\left(F_{m}\right)$.

## 4. Cactus Rank

Definition 4.1. Let $F \in S^{d} V$ be a homogeneous polynomial of degree $d$. We will say that the cactus rank of $F$ is computed by a general linear form if

$$
\operatorname{crk}(F)=\operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}+(l)\right)
$$

for a general linear form $l \in V^{*}$.
Example 4.2. Suppose that $\operatorname{dim} V=2$. Then for every $F \in S^{d} V$, the cactus rank of $F$ is computed by a general linear form. As in the example (3.2), $F^{\perp}=\left(g_{1}, g_{2}\right)$ for some homogeneous polynomials $g_{1}, g_{2} \in T$ of degree $d_{1} \leq d_{2}$ respectively. Then $\operatorname{crk}(F)=d_{1}=\operatorname{dim}_{\mathbb{C}} T /\left(\left(g_{1}, g_{2}\right)+(l)\right)$ for a general $l \in V^{*}$.

Example 4.3. ( $\widehat{\mathrm{RS} 11}$ ) As in the example (3.3), let $F=x_{0}^{a_{0}} \cdots x_{1}^{a_{n}} \in \mathbb{C}\left[x_{0}, \ldots, x_{n}\right]$. Here we give an additional assumption that $a_{0}+\cdots+a_{n-1} \leq a_{n}$. Then $F^{\perp}=$ $\left(t_{0}^{a_{0}+1}, \ldots, t_{n}^{a_{n}+1}\right)$ and $\operatorname{crk}(F)=\left(a_{0}+1\right) \cdots\left(a_{n-1}+1\right)$ is computed by a general linear form. In fact, for general $\lambda_{0}, \ldots, \lambda_{n} \in \mathbb{C}$

$$
\begin{aligned}
& \operatorname{dim}_{\mathbb{C}} T /\left(F^{\perp}+\left(\lambda_{0} t_{0}+\cdots \lambda_{n} t_{n}\right)\right) \\
& \quad=\operatorname{dim}_{\mathbb{C}} \mathbb{C}\left[x_{0}, \ldots, x_{n-1}\right] /\left(t_{0}^{a_{0}+1}, \ldots, t_{n-1}^{a_{n-1}+1},\left(t_{0}+\cdots+t_{n-1}\right)^{a_{n}+1}\right) \\
& \quad=\operatorname{dim}_{\mathbb{C}} \mathbb{C}\left[x_{0}, \ldots, x_{n-1}\right] /\left(t_{0}^{a_{0}+1}, \ldots, t_{n-1}^{a_{n-1}+1}\right) \\
& \quad=\left(a_{0}+1\right) \cdots\left(a_{n-1}+1\right)
\end{aligned}
$$

because $\left(t_{0}+\cdots+t_{n-1}\right)^{a_{n}+1} \in\left(t_{0}^{a_{0}+1}, \ldots, t_{n-1}^{a_{n-1}+1}\right)$ provided that $a_{0}+\cdots+a_{n-1} \leq a_{n}$
From now on, fix $F \in S^{d} V$ for $d \geq 2$. Suppose that $F=F_{1}+F_{2}$ for some $F_{1} \in S^{d} V_{1}$ and $F_{2} \in S^{d} V_{2}$ under the decomposition $V=V_{1} \oplus V_{2}$.

Lemma 4.4. Let $l_{i} \in V_{i}^{*}$ for $i=1,2$. Suppose that $d \geq 2$ and $l_{i} \notin F_{i}^{\perp}$. Then
(1) $F^{\perp}+\left(l_{1}+l_{2}\right) \subsetneq\left[\left(F_{1}^{\perp}+\left(l_{1}\right)+\left(V_{2}^{*}\right)\right] \cap\left[F_{2}^{\perp}+\left(l_{2}\right)+\left(V_{1}^{*}\right)\right]\right.$
(2) $\operatorname{dim} T /\left(F^{\perp}+\left(l_{1}+l_{2}\right)\right) \geq \operatorname{dim} T_{1} /\left(F_{1}^{\perp}+\left(l_{1}\right)\right)+\operatorname{dim} T_{2} /\left(F_{2}^{\perp}+\left(l_{2}\right)\right)$

PROOF. At first, we show that $F^{\perp} \subset F_{1}^{\perp}+\left(l_{1}\right)+\left(V_{2}^{*}\right)$. Let $h \in F^{\perp}$ be a nonzero homogenous polynomial. Since the set $F_{1}^{\perp}+\left(V_{2}^{*}\right)$ contains all monomials of degree $>d$, we may assumt that $\operatorname{deg}(h) \leq d$. Now we can write $h=h_{1}+h_{2}$ for $h_{1} \in T_{1}$ and $h_{2} \in V_{2}^{*}$. Since $h \cdot F=0$, we have $h_{1} \cdot F_{1}+h_{2} \cdot F_{2}=0$. If $\operatorname{deg}(h)<d$, then $h_{1} \cdot F_{1}=h_{2} \cdot F_{2}=0$ and hence $h \in F_{1}^{\perp}+\left(V_{2}^{*}\right)$. On the other hand, if $\operatorname{deg}(h)=d$, then both $h_{1} \cdot F_{1}$ and $h_{2} \cdot F_{2}$ are constant. Since $l_{1} \notin F_{1}^{\perp}$, there is $g \in T_{1}$ of degree $d-1$ with $g \cdot\left(l_{1} \cdot F_{1}\right)$ is a nonzero constant. Then $h_{1}-\frac{\left(h_{1} \cdot F\right)}{g l_{1} \cdot F_{1}} g l_{1} \in F_{1}^{\perp}$. So we have $h=\left(h_{1}-\frac{\left(h_{1} \cdot F\right)}{g l_{1} \cdot F_{1}} g l_{1}\right)+\frac{\left(h_{1} \cdot F\right)}{g l_{1} \cdot F_{1}} g l_{1}+h_{2} \in F_{1}^{\perp}+\left(l_{1}\right)+\left(V_{2}^{*}\right)$. Up to symmetry, the inclusion of the lemma follows. This inclusion must be strict because $l_{1} \notin F^{\perp}+\left(l_{1}+l_{2}\right)$. Otherwise, there is a constant $\lambda$ such that $(1-\lambda) l_{1}-\lambda l_{2} \in F^{\perp}$, and hence $(1-\lambda) l_{1} \cdot F_{1}-\lambda l_{2} \cdot F_{2}=0$. But this is impossible since $\operatorname{deg}(F) \geq 2$ and $l_{i} \notin F_{i}^{\perp}$ for $i=1,2$. This proves (1).
Now Put $J_{1}=F_{1}^{\perp}+\left(l_{1}\right)+\left(V_{2}^{*}\right)$, and $J_{2}=F_{2}^{\perp}+\left(l_{2}\right)+\left(V_{1}^{*}\right)$ as in the rank case.

By (1), we have

$$
\begin{aligned}
& \operatorname{dim} T /\left(F^{\perp}+\left(l_{1}+l_{2}\right)\right) \\
> & \operatorname{dim} T / J_{1} \cap J_{2} \\
= & \operatorname{dim} T / J_{1}+\operatorname{dim} T / J_{2}-\operatorname{dim} T /\left(J_{1}+J_{2}\right) \\
= & \operatorname{dim} T_{1} /\left(F_{1}^{\perp}+\left(l_{1}\right)\right)+T_{2} /\left(F_{2}^{\perp}+\left(l_{2}\right)\right)-1
\end{aligned}
$$

Proposition 4.5. Suppose that the cactus rank of $F_{i}$ is computed by a general linear form for $i=1,2$. Then $\operatorname{crk}(F)=\operatorname{crk}\left(F_{1}\right)+\operatorname{crk}\left(F_{2}\right)$ and this is computed by a general linear form.

PROOF. We always have $\operatorname{crk}(F) \leq \operatorname{crk}\left(F_{1}\right)+\operatorname{crk}\left(F_{2}\right)$. By assumption, $\operatorname{crk}\left(F_{i}\right)=$ $\operatorname{dim} T_{i} /\left(F_{i}^{\perp}+\left(l_{i}\right)\right)$ for a general linear form $l_{i}$ for $i=1,2$. Then $l_{i} \notin F_{i}^{\perp}$. By apolarity lemma, there is a zero dimensional subscheme $X \subset \mathbb{P}(V)$ such that $I_{X} \subset$ $F^{\perp}$ and $\operatorname{deg}(X)=\operatorname{crk}(F)$. Since $l_{1}+l_{2}$ is a general linear form in $V^{*}$, we have

$$
\begin{aligned}
\operatorname{deg}(X) & =\operatorname{dim} T /\left(I_{X}+\left(l_{1}+l_{2}\right)\right) \\
& \geq \operatorname{dim} T /\left(F^{\perp}+\left(l_{1}+l_{2}\right)\right) \\
& \geq \operatorname{dim} T_{1} /\left(F_{1}^{\perp}+\left(l_{1}\right)\right)+\operatorname{dim} T_{2} /\left(F_{2}^{\perp}+\left(l_{2}\right)\right) \quad \text { (by the lemma) } \\
& =\operatorname{crk}\left(F_{1}\right)+\operatorname{crk}\left(F_{2}\right)
\end{aligned}
$$

Corollary 4.6. Let $F_{i} \in S^{d} V_{i}(d \geq 2)$ be a monomial satisfying the assumption in example 4.3 or a bi-variate polynomial for each $i=1, \ldots, m$. Then $\operatorname{crk}\left(F_{1}+\cdots+\right.$ $\left.F_{m}\right)=\operatorname{crk}\left(F_{1}\right)+\cdots+\operatorname{crk}\left(F_{m}\right)$.
