# A Characterization of the Two-weight Inequality for Riesz Potentials on Cones of Radially Decreasing Functions

#### Abstract

We establish necessary and sufficient conditions on a weight pair ( $v, w$ ) governing the boundedness of the Riesz potential operator $I_{\alpha}$ defined on a homogeneous group $G$ from $L_{d e c, r}^{p}(w, G)$ to $L^{q}(v, G)$, where $L_{d e c, r}^{p}(w, G)$ is the Lebesgue space defined for non-negative radially decreasing functions on $G$. The same problem is also studied for the potential operator with product kernels $I_{\alpha_{1}, \alpha_{2}}$ defined on a product of two homogeneous groups $G_{1} \times G_{2}$. In the latter case weights, in general, are not of product type. The derived results are new even for Euclidean spaces. To get the main results we use Sawyer type duality theorems (which are also discussed in this paper) and two-weight Hardy type inequalities on $G$ and $G_{1} \times G_{2}$ respectively.

## 1. Introduction

A homogeneous group is a simply connected nilpotent Lie group $G$ on a Lie algebra $g$ with the one-parameter group of transformations $\delta_{t}=\exp (A \log t), t>0$, where A is a diagonalized linear operator in $G$ with positive eigenvalues. In the homogeneous group $G$ the mappings exp o $\delta_{t}$ o $\exp ^{-1}, t>0$, are automorphisms in G , which will be again denoted by $\delta_{t}$. The number $Q=\operatorname{tr} A$ is the homogeneous dimension of $G$. The symbol $e$ will stand for the neutral element in $G$.

It is possible to equip $G$ with a homogeneous norm $r: G \rightarrow[0, \infty)$ which is continuous on $G$, smooth on $G \backslash\{e\}$ and satisfies the conditions:
(i) $r(x)=r\left(x^{-1}\right)$ for every $x \in G$;
(ii) $r\left(\delta_{t} x\right)=\operatorname{tr}(x)$ for every $x \in G$ and $t>0$;
(iii) $r(x)=0$ if and only if $x=e$;
(iv) There exists $c_{o}>0$ such that

r(x y) \leq c_{o}(r(x)+r(y)), \quad x, y \in G .
$$

In the sequel we denote by $B(a, t)$ an open ball with the center $a$ and radius $t>0$, i.e.

$$
B(a, t):=\left\{y \in G ; r\left(a y^{-1}\right)<t\right\} .
$$

It can be observed that $\delta_{t} B(e, 1)=B(e, t)$.
Let us fix a Haar measure $|\cdot|$ in $G$ such that $|B(e, 1)|=1$. Then $\left|\delta_{t} E\right|=t^{Q}|E|$. In particular, $|B(x, t)|=t^{Q}$ for $x \in$ $G, t>0$.

Examples of homogeneous groups are: the Euclidean n-dimensional space $\mathbb{R}^{n}$, the Heisenberg group, upper triangular groups, etc. For the definition and basic properties of the homogeneous group we refer to [9], p. 12.

An everywhere positive function $\rho$ on $G$ will be called a weight. Denote by $L^{p}(\rho, G)(1<p<\infty)$ the weighted Lebesgue space, which is the space of all measurable functions $f: G \rightarrow \mathbb{C}$ defined by the norm

\|f\|_{L^{p}(\rho, G)}=\left(\int_{G}|f(x)|^{p} \rho(x) d x\right)^{\frac{1}{p}}<\infty .
$$

If $\rho \equiv 1$, then we we use the notation $L^{p}(G)$.
Denote by $\mathcal{D R}(G)$ the class of all radially decreasing functions on $G$ with values in $\mathbb{R}_{+}$, i.e. the fact that $\phi \in \mathcal{D R}(G)$ means that there is decreasing $\bar{\phi}: \mathbb{R}_{+} \mapsto \mathbb{R}_{+}$such that $\varphi(x)=\bar{\phi}(r(x))$. In the sequel we will use the symbol $\phi$ itself for $\bar{\phi}$; the fact that $\phi \in \mathcal{D R}(G)$ will be written also by the symbol $\varphi \downarrow r$. Let $G_{1}$ and $G_{2}$ be homogeneous groups. We say that a function $\psi: G_{1} \times G_{2} \mapsto \mathbb{R}_{+}$is radially decreasing if it is such in each variable separately uniformly to another one. The fact that $\psi$ is radially decreasing on $G_{1} \times G_{2}$ will be denoted as $\psi \in \mathcal{D R}\left(G_{1} \times G_{2}\right)$.

Let

$$
\left(I_{\alpha} f\right)(x)=\int_{G} f(y)\left(r\left(x y^{-1}\right)\right)^{\alpha-Q} d y, \quad 0<\alpha<Q
$$

be the Riesz potential defined on $G$, where $r$ is the homogeneous norm and $d y$ is the normalized Haar measure on $G$. The operator $I_{\alpha}$ plays a fundamental role in harmonic analysis, e.g., in the theory of Sobolev embeddings, in the theory of sublaplacians on nilpotent groups etc. Weighted estimates for multiple Riesz potentials can be applied, for example, to establish Sobolev and Poincaré inequalities on product spaces (see, e.g., [20]).

Let $G_{1}$ and $G_{2}$ be homogeneous groups with homogeneous norms $r_{1}$ and $r_{2}$ and homogeneous dimensions $Q_{1}$ and $Q_{2}$ respectively. We define the potential operator on $G_{1} \times G_{2}$ as follows

I_{\alpha, \beta} f(x, y)=\iint_{G_{1} \times G_{2}} f(t, \tau)\left(r_{1}\left(x t^{-1}\right)\right)^{\alpha-Q_{1}}\left(r_{2}\left(y \tau^{-1}\right)\right)^{\beta-Q_{2}} d t d \tau, \quad(x, y) \in G_{1} \times G_{2}, \quad 0<\alpha<Q_{1}, 0<\beta<Q_{2}
$$

Our aim is to derive two-weight criteria for $I_{\alpha}$ on the cone of radially decreasing functions on $G$. The same problem is also studied for the potential operator with product kernels $I_{\alpha, \beta}$ defined on a product of two homogeneous groups, where only the right-hand side weight is of product type. As far as we know the derived results for $I_{\alpha, \beta}$ are new even in the case of Euclidean spaces. The proofs of the main results are based on E. Sawyer (see [18]) type duality theorem
which is also true for homogeneous groups (see Propositions Cand Eelow) and Hardy type two-weight inequalities in homogeneous groups. Analogous results for multiple potential operators defined on $\mathbb{R}_{+}^{n}$ with respect to the cone of non-negative decreasing functions on $\mathbb{R}_{+}^{n}$ were studied in [16], [15]. It should be emphasized that the two-weight problem for multiple Hardy operator for the cone of decreasing functions on $\mathbb{R}_{+}^{n}$ was investigated by S. Barza, H. P. Heinig and L. -E. Persson [4] under the restriction that both weights are of product type.

Historically the one-weight inequality for the classical Hardy operator was characterize by M. A. Arino and B. Muckenhoupt [3] under the so called $B_{p}$ condition. The same problem for multiple Hardy transform was studied by N. Arcozzi, S. Barza, J. L. Garcia-Domingo and J. Soria [2]. This problem in the the two-weight setting was solved by E. Sawyer [18]. Some sufficient conditions guaranteeing the two-weight inequality for the Riesz potential $I_{\alpha}$ on $\mathbb{R}^{n}$ was given by Y. Rakotondratsimba [17]. In particular, the author showed that $I_{\alpha}$ is bounded from $L_{\text {dec,r }}^{p}\left(w, \mathbb{R}^{n}\right)$ to $L^{q}\left(v, \mathbb{R}^{n}\right)$ if the weighted Hardy operators $(\mathcal{H} f)(x)=\frac{1}{|x|^{n-\alpha}} \int_{|y|<|x|} f(y) d y$ and $\left(\mathcal{H}^{\prime} f\right)(x)=\int_{|y|>|x|} \frac{f(y)}{|y|^{n-\alpha}} d y$ are bounded from $L^{p}\left(w, \mathbb{R}^{n}\right)$ to $L^{q}\left(v, \mathbb{R}^{n}\right)$. In fact the author studied the problem on the cone of monotone decreasing functions.

Now we give some comments regarding the notation: in the sequel under the symbol $A \approx B$ we mean that there are positive constants $c_{1}$ and $c_{2}$ (depending on appropriate parameters) such that $c_{1} A \leq B \leq c_{2} A ; A \ll B$ means that there is a positive constant $c$ such that $A \leq c B$; integral over a product set $E_{1} \times E_{2}$ from $g$ will be denoted by $\iint_{E_{1} \times E_{2}} g(x, y) d x d y$ or $\int_{E_{1}} \int_{E_{2}} g(x, y) d x d y$; for a weight functions $w$ and $w_{i}$ on $G$, by the symbols $W(t)$ and $W_{i}(t)$ will be denoted the integrals $\int_{B(e, t)} w(x) d x$ and $\int_{B\left(e_{i}, t\right)} w_{i}(x) d x$ respectively; for a weight $w$ on $G_{1} \times G_{2}$, we denote $W(t, \tau):=\int_{B\left(e_{1}, t\right) \times B\left(e_{2}, \tau\right)} w(x, y) d x d y$, where $e_{1}$ and $e_{1}$ are neutral elements in $G_{1}$ and $G_{2}$ respectively. Finally we mention that constants (often different constants in one and the same lines of inequalities) will be denoted by $c$ or $C$. The symbol $p^{\prime}$ stands for the conjugate number of $p: p^{\prime}=p /(p-1)$, where $1<p<\infty$.

## 2. Preliminaries

We begin this section with the statements regarding polar coordinates in $G$ (see e.g., [9], P. 14).
Proposition A. Let $G$ be a homogeneous group and let $S=\{x \in G: r(x)=1\}$. There is a (unique) Radon measure $\sigma$ on $S$ such that for all $u \in L^{1}(G)$,

\int_{G} u(x) d x=\int_{0}^{\infty} \int_{S} u\left(\delta_{t} \bar{y}\right) t^{Q-1} d \sigma(\bar{y}) d t
$$

Let $a$ be a positive number. The two-weight inequality for the Hardy-type transforms

$$
\begin{aligned}
& \left(H^{a} f\right)(x)=\int_{B(e, a r(x))} f(y) d y, \quad x \in G, \\
& \left(\widetilde{H}^{a} f(x)=\int_{G \backslash B(e, a r(x))} f(y) d y, \quad x \in G,\right.
\end{aligned}
$$

reeds as follows (see [8], Ch. 1 for more general case, in particular for quasi-metric measure spaces):
Theorem A. Let $1<p \leq q<\infty$ and let a be a positive number. Then
(i)

The operator $H^{a}$ is bounded from $L^{p}\left(u_{1}, G\right)$ to $L^{q}\left(u_{2}, G\right)$ if and only if

$$
\sup _{t>0}\left(\int_{G \backslash B(e, t)} u_{2}(x) d x\right)^{1 / q}\left(\int_{B(e, a t)} u_{1}^{1-p^{\prime}}(x) d x\right)^{1 / p^{\prime}}<\infty
$$

(ii)

The operator $\widetilde{H}^{a}$ is bounded from $L^{p}\left(u_{1}, G\right)$ to $L^{q}\left(u_{2}, G\right)$ if and only if

$$
\sup _{t>0}\left(\int_{B(e, t)} u_{2}(x) d x\right)^{1 / q}\left(\int_{G \backslash B(e, a t)} u_{1}^{1-p^{\prime}}(x) d x\right)^{1 / p^{\prime}}<\infty
$$

We refer also to [7] for the Hardy inequality written for balls with center at the origin.
In the sequel we denote $H^{1}$ by $H$.
The following statement for Euclidean spaces was derived by S. Barza, M. Johansson and L. -E. Persson [5].
Proposition B. Let w be a weight function on $G$ and let $1<p<\infty$. If $f \in \mathcal{D R}(G)$ and $g \geq 0$, then

$$
\sup _{f \downarrow r} \frac{\int_{G} f(x) g(x) d x}{\left(\int_{G} f(x)^{p} w(x) d x\right)^{1 / p}} \approx\|w\|_{L^{\prime}(G)}^{-1 / p}\|g\|_{L^{1}(G)}+\left(\int_{G} H^{p^{\prime}}(r(x)) W^{-p^{\prime}}(r(x)) w(x) d x\right)^{1 / p^{\prime}},
$$

where $H(t)=\int_{B(e, t)} g(x) d x, W(t)=\int_{B(e, t)} w(x) d x$.
The proof of Proposition B repeats the arguments (for $\mathbb{R}^{n}$ ) used in the proof of Theorem 3.1 of [5] taking Proposition A and the following lemma into account.

Lemma A. let $1<p<\infty$. For a weight function $w$, the inequality

$$
\int_{G} w(x)\left(\int_{G \backslash B(e, r(x))} f(y) d y\right)^{p} d x \leq p \int_{G} f^{p}(x) W^{p}(r(x)) w^{1-p}(x) d x, \quad f \geq 0,
$$

holds.
Proof of this lemma is based on Theorem A (part (ii)) taking $a=1, p=q, u_{2}(x)=v(x), u_{1}=w^{1-p}(x) W^{p}(r(x))$ there. Details are omitted.

Corollary A. Let the conditions of Proposition $\underline{B}$ be satisfied and let $\int_{G} w(x) d x=\infty$. Then the following relation holds:

\sup _{f \downarrow r} \frac{\int_{G} f(x) g(x) d x}{\left(\int_{G} f^{p}(x) w(x) d x\right)^{1 / p}} \approx\left(\int_{G} H^{p^{\prime}}(r(x)) W(r(x)) w(x) d x\right)^{1 / p} .
$$

Corollary Aimplies the following duality result which follows by the standard way (see [18], [5] for details).
Proposition C. Let $1<p, q<\infty$ and let $v, w$ be weight functions on $G$ with $\int_{G} w(x) d x=\infty$. Then the integral operator $T$ defined on functions on $G$ is bounded from $L_{\text {dec,r }}^{p}(w, G)$ to $L^{q}(v, G)$ if and only if

$$
\begin{equation*}
\left(\int_{G}\left(\int_{B(e, r(x))}\left(T^{*} g\right)(y) d y\right)^{p^{\prime}} W^{-p^{\prime}}(r(x)) w(x) d x\right)^{1 / p^{\prime}} \leq C\left(\int_{G} g^{q^{\prime}}(x) v^{1-q^{\prime}}(x) d x\right)^{1 / q^{\prime}} \tag{2.1}
\end{equation*}
$$

holds for every positive measurable $g$ on $G$.
The next statement yields the criteria for the two-weight boundedness of the operator $H$ on the cone $\mathcal{D R}(G)$. In particular the following statement is true:

Theorem B. Let $1<p \leq q<\infty$ and let $v$ and $w$ be weights on $G$ such that $\|w\|_{L^{1}(G)}=\infty$. Then $H$ is bounded from $L_{d e c, r}^{p}(w, G)$ to $L_{v}^{q}(v, G)$ if and only if
(i)

$$
\sup _{t>0}\left(\int_{B(e, t)} w(x) d x\right)^{-1 / p}\left(\int_{B(e, t)} v(x) r^{Q q}(x) d x\right)^{1 / q}<\infty
$$

(ii)

$$
\sup _{t>0}\left(\int_{B(e, t)} r^{Q p^{\prime}}(x) W^{-p^{\prime}}(r(x)) w(x) d x\right)^{1 / p^{\prime}}\left(\int_{G \backslash B(e, t)} v(x) d x\right)^{1 / q}<\infty .
$$

Proof of this statement follows by the standard way applying Proposition[C(see e.g. [18], [5]).
Definition 2.1. Let $\rho$ be a locally integrable a.e. positive function on $G$. We say that $\rho$ satisfies the doubling condition at $e(\rho \in D C(G))$ if there is a positive constant $b>1$ such that for all $t>0$ the following inequality holds:

$$
\int_{B(e, 2 t)} \rho(x) d x \leq b \int_{B(e, t)} \rho(x) d x .
$$

Further, we say that $w \in D C^{\gamma, p}(G)$, where $1<p<\infty, 0<\gamma<Q / p$, if there is a positive constant $b$ such that for all $t>0$

$$
\int_{G \backslash B(e, t)} r^{\gamma p^{\prime}}(x) W^{-p^{\prime}}(r(x)) w(x) d x \leq b \int_{G \backslash B(e, 2 t)} r^{\gamma p^{\prime}}(x) W^{-p^{\prime}}(r(x)) w(x) d x .
$$

Remark 2.1. It is also to check that under the assumption $1<p<\infty, 0<\gamma<Q / p$ the condition $w \in D C^{\gamma, p}(G)$ is satisfied for $w \equiv$ const .

Definition 2.2. We say that a locally integrable a.e. positive function $\rho$ on $G_{1} \times G_{2}$ satisfies the doubling condition with respect to the second variable $\left(\rho \in D C^{(s)}(y)\right)$ uniformly to the first one if there is a positive constant $c$ such that for all $t>0$ and almost every $x \in G_{1}$ the following inequality holds:

$$
\int_{B\left(e_{2}, 2 t\right)} \rho(x, y) d y \leq c \int_{B\left(e_{2}, t\right)} \rho(x, y) d y .
$$

Analogously is defined the class of weights $D C^{(s)}(x)$.

## 3. Riesz Potentials on $G$

The main result of this section reeds as follows:
Theorem 3.1. Let $1<p \leq q<\infty$ and let $v$ and $w$ be weights such that either $w \in D C^{\alpha, p}(G)$ or $v \in D C(G)$; let $\|w\|_{L^{1}(G)}=\infty$. Then the operator $I_{\alpha}$ is bounded from $L_{\text {dec,r }}^{p}(w, G)$ to $L^{q}(v, G)$ if and only if
(i)

$$
\begin{equation*}
\sup _{t>0}\left(\int_{B(e, t)} w(x) d x\right)^{-1 / p}\left(\int_{B(e, t)} r^{\alpha q}(x) v(x) d x\right)^{1 / q}<\infty ; \tag{3.1}
\end{equation*}
$$

(ii)

$$
\begin{equation*}
\sup _{t>0}\left(\int_{B(e, t)} r^{p^{\prime} Q}(x) W^{-p^{\prime}}(r(x)) w(x) d x\right)^{1 / p^{\prime}}\left(\int_{G \backslash B(e, t)} r^{(\alpha-Q) q}(x) v(x) d x\right)^{1 / q}<\infty ; \tag{3.2}
\end{equation*}
$$

(iii)

$$
\begin{equation*}
\sup _{t>0}\left(\int_{B(e, t)} v(x) d x\right)^{1 / q}\left(\int_{G \backslash B(e, t)} r^{\alpha p^{\prime}}(x) W^{-p^{\prime}}(r(x)) w(x) d x\right)^{1 / p^{\prime}}<\infty . \tag{3.3}
\end{equation*}
$$

To prove this result we need to prove some auxiliary statements.
Lemma 3.1. Let $0<\alpha<Q$ and let $c_{o}$ be the constant from the triangle inequality of $r$. Then there is a positive constant c depending only on $Q, \alpha$ and $c_{o}$ such that for all $s \in B(e, r(x) / 2)$,

I(x, y):=\int_{B(e, r(x)) \backslash B\left(e, 2 c_{0} r(y)\right)} r\left(t y^{-1}\right)^{\alpha-Q} d t \leq c r\left(x y^{-1}\right)^{\alpha} \tag{3.4}
\end{equation*}
$$

Proof. We have
$I(x, y)=\int_{0}^{\infty}\left|\left\{t \in G: r\left(t y^{-1}\right)^{\alpha-Q}>\lambda\right\} \cap B(e, r(x)) \backslash B\left(e, 2 c_{0} r(y)\right)\right| d \lambda=\int_{0}^{r\left(x y^{-1} \alpha^{\alpha-Q}\right.}(\cdots)+\int_{r\left(x y^{-1}\right)^{\alpha-Q}}^{\infty}(\cdots)=: I^{(1)}(x, y)+I^{(2)}(x, y)$.

Observe that, by the triangle inequality for $r$, we have $r^{Q}(x) \leq c_{0}^{Q} 2^{Q-1}\left(r^{Q}\left(x y^{-1}\right)+r^{Q}(y)\right)$. This implies that $r^{Q}(x)-$ $\left(2 c_{0}\right)^{Q^{Q}}{ }^{Q}(y) \leq c_{0}^{Q} 2^{Q-1} r^{Q}\left(x y^{-1}\right)$. Hence,

$$
I^{(1)}(x, y) \leq r\left(x y^{-1}\right)^{\alpha-Q}\left|B(e, r(x)) \backslash B\left(e, 2 c_{0} r(y)\right)\right|=r\left(x y^{-1}\right)^{\alpha-Q}\left(r^{Q}(x)-\left(2 c_{0}\right)^{Q} r^{Q}(y)\right) \leq c r\left(x y^{-1}\right)^{\alpha}
$$

Further, it is easy to see that

$$
I^{(2)}(x, y) \leq \operatorname{cr}\left(x y^{-1}\right)^{\alpha} .
$$

Finally we have (3.4).
Let us introduce the following potential operators

$$
\left(J_{\alpha} f\right)(x)=\int_{B\left(e, 2 c_{0} r(x)\right)} f(y) r^{\alpha-Q}\left(x y^{-1}\right) d y, \quad\left(S_{\alpha} f\right)(x)=\int_{G \backslash B\left(e, 2 c_{0} r(x)\right)} f(y) r^{\alpha-Q}\left(x y^{-1}\right) d y, \quad x \in G, 0<\alpha<Q .
$$

It is easy to see that

$$
\begin{equation*}
I_{\alpha} f=J_{\alpha} f+S_{\alpha} f \tag{3.5}
\end{equation*}
$$

We need also to introduce the following weighted Hardy operator

$$
\left(H_{\alpha} f\right)(x)=r(x)^{\alpha-Q}(H f)(x) .
$$

Proposition 3.1. The following relation holds for all $f \in \mathcal{D R}(G)$

$$
\begin{equation*}
J_{\alpha} f \approx H_{\alpha} f \tag{3.6}
\end{equation*}
$$

Proof. We have

$$
\left(J_{\alpha} f\right)(x)=\int_{B\left(e, r(x) / 2 c_{0}\right)} f(y) r^{\alpha-Q}\left(x y^{-1}\right) d y+\int_{B\left(e, 2 c_{0} r(x)\right) \backslash B\left(e, r(x) /\left(2 c_{0}\right)\right)} f(y) r^{\alpha-Q}\left(x y^{-1}\right) d y=:\left(J_{\alpha}^{(1)} f\right)(x)+\left(J_{\alpha}^{(2)} f\right)(x)
$$

If $y \in B\left(e, r(x) / 2 c_{0}\right)$, then $r(x) \leq c_{0}\left(r\left(x y^{-1}\right)+r(y)\right) \leq c_{0} r\left(x y^{-1}\right)+r(x) / 2$. Hence $r(x) \leq 2 c_{0}\left(r\left(x y^{-1}\right)\right.$. Consequently,

$$
\left(J_{\alpha}^{(1)} f\right)(x) \leq c\left(H_{\alpha} f\right)(x)
$$

Applying now the fact that $f \in D R(G)$ we see that

$$
\left(J_{\alpha}^{(2)} f\right)(x) \leq f\left(r(x) / 2 c_{0}\right) \quad \int_{B\left(e, r(x) / 2 c_{0}\right) \backslash B\left(e, 2 c_{0} r(x)\right)} r^{\alpha-Q}\left(x y^{-1}\right) d y \leq c f\left(r(x) / 2 c_{0}\right) r(x)^{\alpha} \leq c\left(H_{\alpha} f\right)(x)
$$

## 4. Multiple Potentials on $\boldsymbol{G}_{\mathbf{1}} \times \boldsymbol{G}_{\mathbf{2}}$

Let us now investigate the two-weight problem for the operator $I_{\alpha, \alpha_{2}}$ on the cone $\mathcal{D R}\left(G_{1} \times G_{2}\right)$. In the sequel without loss of generality we denote the triangle inequality constants for $G_{1}$ and $G_{2}$ by one and the same symbol $c_{0}$.

The following statement can be derived just in the same way as Theorem 3.1 was obtained in [4]. The proof is omitted because to avoid repeating those arguments.

Proposition D. Let $1<p<\infty$ and let $w(x, y)=w_{1}(x) w_{2}(y)$ be a product weight on $G_{1} \times G_{2}$. Then the following relation

We give the proof, for example, for $H^{a, b}$ in the case when $w(x, y)=w_{1}(x) w_{2}(y)$.

If $S<\infty$, then without loss of generality we can assume that $S=1$. In this case we choose the sequence $\left\{x_{k}\right\}_{k=-\infty}^{0}$ for which (4.1) holds for all $k \in \mathbb{Z}_{-}$. Arguing as in the case $S=\infty$ and using slight modification of the discrete Hardy inequality (see also [13], Chapter 1 for similar arguments), we finally obtain the desired result.

Finally we notice that the part (i) can be also proved if we first establish the boundedness of the operator $\left(\mathcal{H}^{a, b} \varphi\right)(t, \tau)=$ $\int_{0}^{a t} \int_{0}^{b \tau} \varphi(s, r) d s d r$ in the spirit of Theorem 1.1.6 in [13] and then pass to the case of $G_{1} \times G_{2}$ by Proposition A

The next statement will be useful for us.

& =\int_{B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{2}(y)\right)}\left(\int_{\left.B\left(e_{1}, r_{1}(x)\right) \backslash B\left(e_{1}, r(t)\right)\right)} \int_{B\left(e_{2}, r(\tau) / 2 c_{0}\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) r_{2}^{\alpha_{2}-Q_{2}}\left(\tau \varepsilon^{-1}\right) f(s, \varepsilon) d s d \varepsilon\right) d t d \tau \\
& +\int_{\left.B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{2}(y)\right)\right)}\left(\int_{G_{1} \backslash B\left(e_{1}, r_{1}(x)\right)} \int_{B\left(e_{2}, r(\tau) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) r_{2}^{\alpha_{2}-Q_{2}}\left(\tau \varepsilon^{-1}\right) f(s, \varepsilon) d s d \varepsilon\right) d t d \tau \\
& =: T_{1}(x, y)+T_{2}(x, y) .
\end{aligned}
$$

Tonelli's theorem for $G_{1}$, the inequality $r_{2}^{\alpha_{2}-Q_{2}}\left(\tau \varepsilon^{-1}\right) \geq c r_{2}^{\alpha_{2}-Q_{2}}(y)$ for $\tau \in B\left(e_{2}, r(y)\right), \varepsilon \in B\left(e_{2}, r(\tau) /\left(2 c_{0}\right)\right)$, and the
fact that the integral $\int_{B\left(e_{1}, \tau\right)} f(s, \varepsilon) d s$ is decreasing in $\tau$ uniformly to $\varepsilon$ yield that

$$
\begin{aligned}
T_{1}(x, y) & \geq c r_{2}^{\alpha_{2}-Q_{2}}(y) \int_{B\left(e_{1}, r_{1}(x)\right)} \int_{B\left(e_{2}, r_{2}(y)\right) \backslash B\left(e_{2}, r_{2}(y) / 2\right)}\left(\int_{B\left(e_{1}, r_{1}(x)\right) \backslash B\left(e_{1}, r(t)\right)} \int_{B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(s, \varepsilon) d s d \varepsilon\right) d t d \tau \\
& =c r_{2}^{\alpha_{2}}(y) \int_{B\left(e_{1}, r_{1}(x)\right)}\left(\int_{B\left(e_{1}, r_{1}(x)\right) \backslash B\left(e_{1}, r(t)\right)}\left(r_{1}^{\alpha_{1}-Q_{1}}(s)\left(\int_{B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} f(s, \varepsilon) d \varepsilon\right) d s\right) d t\right. \\
& =c r_{2}^{\alpha_{2}}(y) \int_{B\left(e_{1}, r_{1}(x)\right)}\left(\int_{B\left(e_{1}, r_{1}(x)\right) \backslash B\left(e_{1}, r(t)\right)} F(s, y) d s\right) d t=c r_{2}^{\alpha_{2}}(y) \int_{B\left(e_{1}, r_{1}(x)\right)} F(s, y)\left(\int_{B\left(e_{1}, r(s)\right)} d t\right) d s \\
& =c r_{2}^{\alpha_{2}}(y) \int_{B\left(e_{1}, r_{1}(x)\right)} \int_{B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} r_{1}^{\alpha_{1}}(s) f(t, \tau) d \varepsilon d s .
\end{aligned}
$$

Here we used the notation

$$
F(s, y):=\int_{B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} f(s, \varepsilon) d \varepsilon
$$

Taking into account that the function $\int_{B\left(e_{2}, 2 c_{0} \lambda\right)} f(s, \varepsilon) d \varepsilon$ is decreasing in $\lambda$ uniformly to $s$, the inequality $r_{2}\left(\tau \varepsilon^{-1}\right) \leq$ $c r_{2}(y)$ for $\tau \in B\left(e_{2}, r(y)\right), \varepsilon \in B\left(e_{2}, r(\tau) /\left(2 c_{0}\right)\right)$, and Tonelli's theorem for $G_{1}$ we find that

$$
T_{2}(x, y) \geq c r_{1}^{Q_{1}}(x) r_{2}^{\alpha_{2}}(y) \int_{G_{1} \backslash B\left(e_{1}, r_{1}(x)\right)} \int_{B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(t, \tau) d \varepsilon d s
$$

To get the upper estimate, observe that Tonelli's theorem for $G_{1} \times G_{2}$ and Lemma 3.1 for $r_{2}$ yield that

$$
\begin{aligned}
T_{1}(x, y) & \leq \int_{B\left(e_{1}, r_{1}(x)\right)} \int_{B\left(e_{2}, r_{2}(y) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(s, \varepsilon)\left(\int_{B\left(e_{1}, r_{1}(s)\right)} \int_{B\left(e_{2}, r_{2}(y)\right) \backslash B\left(e_{2}, 2 c_{0} r_{2}(\varepsilon)\right)} r_{2}^{\alpha_{2}-Q_{2}}\left(\tau \varepsilon^{-1}\right) d t d \tau\right) d s d \varepsilon \\
& \leq c r_{2}^{\alpha_{2}}(y) \iint_{B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{2}(y) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}}(s) f(s, \varepsilon) d s d \varepsilon .
\end{aligned}
$$

Similarly,

$$
T_{2}(x, y) \leq c r_{1}^{Q_{1}}(x) r_{2}^{\alpha_{2}}(y) \quad \iint_{G_{1} \backslash B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{2}(y) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(s, \varepsilon) d s d \varepsilon
$$

Summarazing these estimates we see that there are positive constants $c_{1}$ and $c_{2}$ depending only on $\alpha_{1}, \alpha_{2}, Q_{1}$ and $Q_{2}$ such that

$$
\begin{gathered}
r_{2}^{\alpha_{2}}(y) \iint_{B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{2}(y) /\left(4 c_{0}\right)\right)} r_{1}^{\alpha_{1}}(s) f(s, \varepsilon) d s d \varepsilon \\
+\quad r_{1}^{Q_{1}}(x) r_{2}^{\alpha_{2}}(y) \iint_{G_{1} \backslash B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{1}(y) /\left(4 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(s, \varepsilon) d s d \varepsilon \\
\leq c_{1} T(x, y) \leq r_{2}^{\alpha_{2}}(y) \iint_{B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r 2(y) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}}(s) f(s, \varepsilon) d s d \varepsilon \\
+\quad r_{1}^{Q_{1}}(x) r_{2}^{\alpha_{2}}(y) \quad \int_{G_{1} \backslash B\left(e_{1}, r_{1}(x)\right) \times B\left(e_{2}, r_{1}(y) /\left(2 c_{0}\right)\right)} r_{1}^{\alpha_{1}-Q_{1}}(s) f(s, \varepsilon) d s d \varepsilon .
\end{gathered}
$$

Taking Propositions 4.1 and Einto account together with the doubling condition for $v$ with respect to the second variable we see that the operator $J_{\alpha_{1}} S_{\alpha_{2}}$ is bounded from $L_{\text {dec, } r}^{p}\left(w, G_{1}\right)$ to $L^{q}\left(v, G_{2}\right)$ if and only if the conditions (vi) and (vii) are satisfied.

By the similar manner (changing the roles of the first and second variables) we can get that $S_{\alpha_{1}} J_{\alpha_{2}}$ is bounded from $L_{d e c, r}^{p}\left(w, G_{1}\right)$ to $L^{q}\left(\nu, G_{2}\right)$ if and only if the conditions (viii) and (ix) are satisfied.

Theorem 4.1 and Remark 2.1 imply criteria for the trace inequality for $I_{\alpha_{1}, \alpha_{2}}$. Namely the following statement holds:

Theorem 4.2. Let $1<p \leq q<\infty$ and let $0<\alpha_{i}<Q_{i} / p, i=1$, 2. Then $I_{\alpha_{1}, \alpha_{2}}$ is bounded from $L_{\text {dec,r }}^{p}\left(G_{1} \times G_{2}\right)$ to $L^{q}\left(v, G_{1} \times G_{2}\right)$ if and only if the following condition holds

$$
B:=\sup _{a_{1}, a_{2}>0}\left(\int_{B\left(e_{1}, a_{1}\right)} \int_{B\left(e_{2}, a_{2}\right)} v(x, y) d x d y\right)^{1 / q} a_{1}^{\alpha_{1}-Q_{1} / p} a_{2}^{\alpha_{2}-Q_{2} / p}<\infty .
$$

Proof. Sufficiency is a consequence of the inequality $\max \left\{A_{1}, \cdots, A_{9}\right\} \leq c B$, while necessity follows immediately by taking the test function $f_{a_{1}, a_{2}}(x, y)=\chi_{B\left(e_{1}, a_{1}\right)}(x) \chi_{B\left(e_{2}, a_{2}\right)}(y), a_{1}, a_{2}>0$.
