AUTOMORPHISMS OF \mathbb{C}^3 COMMUTING WITH A \mathbb{C}^+ -ACTION

ABSTRACT. Let ρ be an algebraic action of the additive group \mathbb{C}^+ on the threedimensional affine space \mathbb{C}^3 . We describe the group $\operatorname{Cent}(\rho)$ of polynomial automorphisms of \mathbb{C}^3 that commute with ρ . A particular emphasis lies in the description of the automorphisms in $\operatorname{Cent}(\rho)$ coming from algebraic \mathbb{C}^+ actions. As an application we prove that the automorphisms in $\operatorname{Cent}(\rho)$ that are the identity on the algebraic quotient of ρ form a characteristic subgroup of $\operatorname{Cent}(\rho)$.

1. INTRODUCTION

Let X be an affine algebraic variety. A classification of the algebraic \mathbb{C}^+ -actions on X up to conjugacy in the automorphism group $\operatorname{Aut}(X)$ is only known for a few varieties X. For example, when $X = \mathbb{C}^2$ we have a classification: every \mathbb{C}^+ -action is a modified translation up to conjugacy, i.e. an action of the form $t \cdot (x, y) =$ (x + td(y), y) for a suitable polynomial d (see [Ren68]). In contrast to the twodimensional case, there is no classification known for the \mathbb{C}^+ -actions on \mathbb{C}^3 . As a first step towards a classification, we study the centralizer of a \mathbb{C}^+ -action in $\operatorname{Aut}(\mathbb{C}^3)$, i.e. the group of automorphisms that commute with the \mathbb{C}^+ -action.

An automorphism $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^n)$ is called *unipotent* if there exists on \mathbb{C}^n an algebraic \mathbb{C}^+ -action $\rho \colon \mathbb{C}^+ \times \mathbb{C}^n \to \mathbb{C}^n$ such that

$$\mathbf{u}(x_1,\ldots,x_n) = \rho(1,x_1,\ldots,x_n)$$
 for all $(x_1,\ldots,x_n) \in \mathbb{C}^n$

In fact, the \mathbb{C}^+ -action ρ is uniquely determined by the unipotent automorphism $\rho_1 = ((x_1, \ldots, x_n) \mapsto \rho(1, x_1, \ldots, x_n))$. Thus $\rho \mapsto \rho_1$ is a bijection between algebraic \mathbb{C}^+ -actions on \mathbb{C}^n and unipotent automorphisms of \mathbb{C}^n . Moreover, the centralizer of ρ is the same as the centralizer of ρ_1 and thus we are reduced to the study of the centralizer of a unipotent automorphism.

For us it will be crucial that there is a different characterization of unipotent automorphisms. Namely, there is a bijective correspondence of unipotent automorphisms of \mathbb{C}^n and locally nilpotent derivations of the polynomial ring $\mathcal{O}(\mathbb{C}^n) = \mathbb{C}[x_1, \ldots, x_n]$, given by the exponential Exp

compare [Fre06, sec. 1.5].

In dimension n = 2, Shmuel Friedland and John Milnor proved that every automorphism of \mathbb{C}^2 is conjugate to a composition of so-called generalized Hénon

maps or to a triangular automorphism, i.e. an automorphism of the form $(x, y) \mapsto (ax+b(y), cy+e)$ where $a, c \in \mathbb{C}^*$, $b \in \mathbb{C}[y]$ and $e \in \mathbb{C}$ (cf. [FM89, Theorem 2.6]). In the first case, Stéphane Lamy showed that the centralizer of such an automorphism is isomorphic to a semi-direct product of \mathbb{Z} with a finite cyclic group \mathbb{Z}_q (cf. [Lam01, Proposition 4.8]). In the second case, assuming in addition that the automorphism is unipotent, it has the form $\mathbf{u}(x, y) = (x + d(y), y)$ for suitable coordinates (x, y) of \mathbb{C}^2 . One can see that the centralizer Cent(\mathbf{u}) consists of triangular automorphisms and that it fits into the following split short exact sequence

$$1 \to \{ (x, y) \mapsto (x + b(y), y) \mid b \in \mathbb{C}[y] \} \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{P} \operatorname{Aut}(\mathbb{C}, \operatorname{div}(d)) \to 1 \quad (1)$$

where $\operatorname{Aut}(\mathbb{C}, \operatorname{div}(d))$ denotes the automorphisms of \mathbb{C} that preserve the principal divisor $\operatorname{div}(d) \subseteq \mathbb{C}$ and p sends $((x, y) \mapsto (ax + b(y), cy + e))$ to $(y \mapsto cy + e)$.

In dimension n = 3, Cinzia Bisi proved the following for a regular automorphism \mathbf{f} (i.e. an automorphism such that the indeterminacy sets of the map and its inverse seen as birational maps of \mathbb{P}^3 do not intersect): If \mathbf{g} is any automorphism that commutes with \mathbf{f} , then $\mathbf{g}^m = \mathbf{f}^k$ for certain integers k, m (cf. [Bis08, Main Theorem 1.1]). As a counterpart to the regular automorphisms, one can regard the unipotent automorphisms (a regular automorphism satisfies $\deg(\mathbf{f}^k) = \deg(\mathbf{f})^k$ for all integers $k \ge 0$ and thus can not be unipotent). The work of David Finston and Sebastian Walcher [FW97] can be seen as a first step in the study of the centralizer of a unipotent automorphism. They explore the centralizer of a triangulable (locally nilpotent) derivation inside the algebra of all derivations of $\mathcal{O}(\mathbb{C}^3)$.

In this article we study the structure of the centralizer of a unipotent automorphism $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ with the aid of an exact sequence similar to (1) and give some applications of this study.

2. Statement of the main results

Let $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be a unipotent automorphism $\neq \operatorname{id}$ and let D be the locally nilpotent derivation of $\mathcal{O}(\mathbb{C}^3)$ such that $\mathbf{u} = \operatorname{Exp}(D)$. Denote by $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$ the functions that are invariant under the \mathbb{C}^+ -action induced by \mathbf{u} . They satisfy $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} = \ker D \subseteq \mathcal{O}(\mathbb{C}^3)$. Denote by $\mathbb{C}^3/\!\!/\mathbf{u}$ the algebraic quotient of \mathbb{C}^3 by the \mathbb{C}^+ -action induced by \mathbf{u} , i.e. $\mathbb{C}^3/\!\!/\mathbf{u} = \operatorname{Spec}(\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}})$. By Miyanishi's Theorem (cf. [Fre06, Theorem 5.1]), this algebraic quotient is isomorphic to \mathbb{C}^2 .

We call the ideal im $D \cap \ker D$ of ker D the *plinth ideal* of D. By [DK09, Theorem 1] this ideal is principal. We fix some generator a and call the principal divisor

$$\Gamma = \operatorname{div}(a) \subseteq \mathbb{C}^3 /\!\!/ \mathbf{u} = \mathbb{C}^2$$

the *plinth divisor* of **u** (respectively of *D*). We get a homomorphism of the centralizer Cent(**u**) into the group $\operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)$ of automorphisms of the algebraic quotient $\mathbb{C}^3 /\!\!/ \mathbf{u}$ that preserve the plinth divisor Γ

$$p: \operatorname{Cent}(\mathbf{u}) \to \operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)$$

(see sec. 3 for an exact definition of $\operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)$). In contrast to the two-dimensional case (see (1)), the homomorphism p in the three-dimensional case is in general not surjective (see [Sta13, Proposition 1]).

If $f \in \ker D = \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$, then fD is a locally nilpotent derivation of $\mathcal{O}(\mathbb{C}^3)$. We call $\operatorname{Exp}(fD)$ a *modification* of $\mathbf{u} = \operatorname{Exp}(D)$ and write

$$f \cdot \mathbf{u} = \operatorname{Exp}(fD) \,.$$

Note that the composition of two modifications is given by $(f \cdot \mathbf{u}) \circ (f' \cdot \mathbf{u}) = (f+f') \cdot \mathbf{u}$. Thus the modifications of \mathbf{u} form a group. We denote this group by $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}$.

For the sake of simplicity, we formulate in this section several results only for irreducible \mathbf{u} (see subsec. 4.2 for the definition of "irreducible"). However, in the course of this article we state and prove the results for general unipotent \mathbf{u} .

Theorem 2.0.1 (cf. Theorem 5.1.1). If \mathbf{u} is irreducible, then the kernel of p is the subgroup of modifications of \mathbf{u} :

$$\ker p = \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}.$$

The description of Cent(**u**) is special in the case when **u** is a *translation*, i.e. $\mathbf{u}(x, y, z) = (x+1, y, z)$ for suitable coordinates (x, y, z). Note that **u** is a translation if and only if its plinth divisor Γ is empty.

Proposition 2.0.2 (cf. Proposition 5.2.1). The unipotent automorphism \mathbf{u} is a translation, if and only if there is a split short exact sequence

$$1 \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u} \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}(\mathbb{C}^3/\!\!/\mathbf{u}) \to 1$$

In order to formulate the next results, we recall briefly some notion and facts of the theory of ind-groups (see [Kum02, ch. IV] for an introduction). A group G is called an *ind-group* if it is endowed with a filtration by affine varieties $G_1 \subseteq G_2 \subseteq$..., each one closed in the next, such that $G = \bigcup_{i=1}^{\infty} G_i$ and such that the map $G \times G \to G$, $(x, y) \mapsto x \cdot y^{-1}$ is a morphism of ind-varieties. We endow G with the following topology: $X \subseteq G$ is closed if and only if $X \cap G_i$ is closed in G_i for each i. We call a subgroup H of G algebraic, if it is a closed subset of some G_i . An element $g \in G$ is called algebraic, if it is contained in some algebraic subgroup of G.

For example, $\operatorname{Aut}(\mathbb{C}^n)$ is an ind-group with the filtration $\operatorname{Aut}(\mathbb{C}^n)_1 \subseteq \operatorname{Aut}(\mathbb{C}^n)_2 \subseteq$... where $\operatorname{Aut}(\mathbb{C}^n)_i$ is the set of all automorphisms of degree $\leq i$ (see [BCW82]). Then, $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ is a closed subgroup of $\operatorname{Aut}(\mathbb{C}^2)$ (cf. Proposition 3.0.3). Examples of closed subgroups of $\operatorname{Aut}(\mathbb{C}^3)$ are $\operatorname{Cent}(\mathbf{u})$ and $\operatorname{ker} p$ (cf. Remark 5.1.1). As a last example, the group of modifications $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}$ is closed in $\operatorname{Aut}(\mathbb{C}^3)$. Moreover, the homomorphism $(\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}, +) \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}$, $f \mapsto f \cdot \mathbf{u}$ is an isomorphism of ind-groups. In particular, the closure of $\langle \mathbf{u} \rangle$ in $\operatorname{Aut}(\mathbb{C}^3)$ is the group $\mathbb{C} \cdot \mathbf{u}$ and thus \mathbf{u} is an algebraic element of $\operatorname{Aut}(\mathbb{C}^3)$.

Theorem 2.0.3 (cf. Theorem 5.6.1, 5.7.1 and Corollary 5.7.2). Assume that **u** is not a translation. Then

- *i)* All elements in Cent(**u**) are algebraic.
- *ii)* The set of unipotent elements $Cent(\mathbf{u})_u \subseteq Cent(\mathbf{u})$ is a closed normal subgroup.
- iii) There exists an algebraic subgroup $R \subseteq \text{Cent}(\mathbf{u})$ consisting only of semi-simple elements such that $\text{Cent}(\mathbf{u}) \simeq \text{Cent}(\mathbf{u})_u \rtimes R$ (as ind-groups). In particular, the connected component of the identity in R is a torus.

The next result describes the group of unipotent elements $\operatorname{Cent}(\mathbf{u})_u$. For this, we need the following terminology. We call the divisor $\Gamma = \sum_i n_i \Gamma_i$ in \mathbb{C}^2 a *fence*, if $\Gamma_i \simeq \mathbb{C}$ for all *i* and the Γ_i are pairwise disjoint.

Theorem 2.0.4 (cf. Proposition 5.5.1 and Theorem 5.7.1). Assume **u** is irreducible and not a translation. If the plinth divisor Γ of **u**

i) is not a fence, then $Cent(\mathbf{u})_u = \ker p$.

ii) is a fence, then $\operatorname{Cent}(\mathbf{u})_u \simeq \ker p \rtimes \operatorname{Iner}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)_u$ (as ind-groups) where $\operatorname{Iner}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)_u$ is the subgroup of unipotent automorphisms in $\operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)$ that are the identity on Γ (cf. sec. 3 for an exact definition). Moreover, there exists an irreducible $\mathbf{e} \in \operatorname{Cent}(\mathbf{u})_u$ such that p induces an isomorphism of ind-groups $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}, \mathbf{e} \rangle} \cdot \mathbf{e} \simeq \operatorname{Iner}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)_u$ where $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}, \mathbf{e} \rangle}$ is the subring of \mathbf{e} -invariant polynomials inside $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$.

Let us give some explanation of the last result. If Γ is not a fence, then the underlying variety cannot be a union of orbits of a non-trivial \mathbb{C}^+ -action on \mathbb{C}^2 . Hence, all unipotent automorphisms of $\operatorname{Cent}(\mathbf{u})$ induce the identity on the algebraic quotient and thus the first part of the result follows. So let us assume that Γ is a non-empty fence. There exists a proper non-empty open subset $U \subseteq \mathbb{C}$ such that the algebraic quotient π : $\mathbb{C}^3 \to \mathbb{C}^3 /\!/ \mathbf{u}$ fits into the following commutative diagram

$$\begin{array}{cccc} \mathbb{C}^3 & \supseteq & \mathbb{C}^3 \setminus \pi^{-1}(\Gamma) & \simeq & (U \times \mathbb{C}) \times \mathbb{C} \\ \pi & & & & & & & \\ \pi & & & & & & & \\ \mathbb{C}^2 & \supseteq & \mathbb{C}^2 \setminus \Gamma & \simeq & & U \times \mathbb{C} \end{array}$$

where pr denotes the projection onto the first two factors (see Proposition 3.0.5 and [Fre06, Principle 11]). There exist coordinates (u, v, w) of $(U \times \mathbb{C}) \times \mathbb{C}$ such that **u** restricted to $(U \times \mathbb{C}) \times \mathbb{C}$ is given by $(u, v, w) \mapsto (u, v, w + 1)$. The automorphism $(u, v, w) \mapsto (u, v + 1, w)$ of $(U \times \mathbb{C}) \times \mathbb{C}$ extends to an irreducible unipotent automorphism **e** on \mathbb{C}^3 that commutes with **u** (see subsec. 5.3). Thus, $\operatorname{Cent}(\mathbf{u})_u$ contains $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}, \mathbf{e} \rangle} \cdot \mathbf{e}$ beside $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}$. It is not hard to prove that p induces an isomorphism $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}, \mathbf{e} \rangle} \cdot \mathbf{e} \simeq \operatorname{Iner}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)_u$. The difficulty lies in proving that $\operatorname{Cent}(\mathbf{u})_u$ is a group which is generated by $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}, \mathbf{e} \rangle} \cdot \mathbf{e}$ and $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} \cdot \mathbf{u}$.

2.1. Applications. We present two applications of the structure theorems above. The first one concerns abstract group automorphisms $Cent(\mathbf{u}) \rightarrow Cent(\mathbf{u})$.

Proposition 2.1.1 (cf. Proposition 6.0.4). If **u** is not a translation, then the subgroup ker $p \subseteq \text{Cent}(\mathbf{u})$ is characteristic, i.e. it is invariant under all abstract group automorphisms of $\text{Cent}(\mathbf{u})$.

The second application concerns the plinth divisor Γ . The underlying variety $\Gamma_{\rm red}$ has the following geometric description: The complement of $\Gamma_{\rm red}$ is the maximal open subset of $\mathbb{C}^3/\!/\mathbf{u}$ such that the algebraic quotient $\pi \colon \mathbb{C}^3 \to \mathbb{C}^3/\!/\mathbf{u}$ is a locally trivial principal \mathbb{C}^+ -bundle over it (see [DK14, Proposition 5.4]). So far - to the author's knowledge - there is no geometric description of the *scheme* Γ . But in the case when Γ is a non-empty fence and \mathbf{u} is irreducible we can give one.

Proposition 2.1.2 (cf. Proposition 6.0.3). If \mathbf{u} is irreducible and Γ is a non-empty fence, then Γ is the largest closed subscheme of $\mathbb{C}^3/\!/\mathbf{u}$ fixed by $\operatorname{Cent}(\mathbf{u})_u$.

3. Automorphisms of \mathbb{C}^2 that preserve a divisor

Let $\Gamma \subseteq \mathbb{C}^2$ be an effective divisor. Then there exists $a \in \mathcal{O}(\mathbb{C}^2)$ such that $\Gamma = \operatorname{div}(a)$ (*a* is uniquely determined up to elements of \mathbb{C}^*). We denote by $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ the subgroup of all $\mathbf{g} \in \operatorname{Aut}(\mathbb{C}^2)$ such that the comorphism $\mathbf{g}^* \colon \mathcal{O}(\mathbb{C}^2) \to \mathcal{O}(\mathbb{C}^2)$ sends the principal ideal (*a*) onto itself. Moreover, we denote by $\operatorname{Iner}(\mathbb{C}^2, \Gamma)$ the

subgroup of all $\mathbf{g} \in \operatorname{Aut}(\mathbb{C}^2, \Gamma)$ such that \mathbf{g} is the identity on the divisor Γ , i.e. we have a commutative diagram

Clearly, we get an exact sequence

$$1 \to \operatorname{Iner}(\mathbb{C}^2, \Gamma) \hookrightarrow \operatorname{Aut}(\mathbb{C}^2, \Gamma) \to \operatorname{Aut}(\Gamma)$$

The next result uses heavily the main result in [BS13].

Proposition 3.0.3. Let Γ be a non-trivial effective divisor of \mathbb{C}^2 . Then

- i) The subgroup $\operatorname{Aut}(\mathbb{C}^2, \Gamma) \subseteq \operatorname{Aut}(\mathbb{C}^2)$ is closed and all elements of $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ are algebraic.
- ii) The following statements are equivalent
 - a) Γ is a fence
 - b) $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ contains unipotent automorphisms $\neq \operatorname{id}$.
 - c) Iner(\mathbb{C}^2, Γ) \neq {id}
 - d) $\operatorname{Aut}(\mathbb{C}^2,\Gamma)$ is not an algebraic group

For the proof of this proposition we recall some facts about $\operatorname{Aut}(\mathbb{C}^2)$. The next result is a direct consequence of [BS13, Theorem 1].

Theorem 3.0.4. An automorphism of \mathbb{C}^2 that preserves an algebraic curve is conjugate to a triangular automorphism.

In the next result we prove a slightly more general version of the Abhyankar-Moh-Suzuki-Theorem which says that all closed embeddings $\mathbb{C} \hookrightarrow \mathbb{C}^2$ are equivalent up to automorphisms of \mathbb{C}^2 (see [AM75]).

Proposition 3.0.5. Let Γ be a fence in \mathbb{C}^2 and let $F \subseteq \mathbb{C}$ be a closed 0-dimensional subscheme such that $\Gamma \simeq F \times \mathbb{C}$. Then there exists an automorphism of \mathbb{C}^2 that maps Γ onto $F \times \mathbb{C}$ (scheme-theoretically).

Proof. Clearly, we can assume that $\Gamma \neq \emptyset$. Moreover, we can easily reduce to the case, where Γ is a reduced scheme. Let Γ_i , $i \in I$ be the irreducible components of Γ . Let $i_0 \in I$ be fixed. By the Abhyankar-Moh-Suzuki-Theorem, there exists a trivial \mathbb{C} -bundle $f: \mathbb{C}^2 \twoheadrightarrow \mathbb{C}$ such that Γ_{i_0} is a fiber of f. Now, if the restriction $f|_{\Gamma_i}: \Gamma_i \to \mathbb{C}$ is non-constant, then it is surjective, since $\Gamma_i \simeq \mathbb{C}$. But this implies that $\Gamma_i \cap \Gamma_{i_0} \neq \emptyset$, a contradiction. Thus every Γ_i is a fiber of f. This implies the proposition.

Proof of Proposition 3.0.3.

i) Assume that $\Gamma = \operatorname{div}(a)$ for some non-zero $a \in \mathcal{O}(\mathbb{C}^2) = \mathbb{C}[x, y]$. For $(f_1, f_2) \in \mathbb{C}[x, y]^2$ we denote by $a_{ij}(f_1, f_2)$ the coefficient of the monomial $x^i y^j$ in the polynomial $a(f_1, f_2)$. The subgroup $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ of $\operatorname{Aut}(\mathbb{C}^2)$ is defined by the equations

 $a_{ij}(f_1, f_2)a_{kl}(x, y) = a_{kl}(f_1, f_2)a_{ij}(x, y)$ for all pairs (i, j), (k, l).

This proves the first statement.

Let $\mathbf{g} \in \operatorname{Aut}(\mathbb{C}^2, \Gamma)$. By Theorem 3.0.4, \mathbf{g} is conjugate to a triangular automorphism and hence \mathbf{g} is algebraic. This proves the second statement.

ii) $a) \Rightarrow b$: This follows immediately form Proposition 3.0.5.

 $b) \Rightarrow c$): Let $\mathbf{g} \in \operatorname{Aut}(\mathbb{C}^2, \Gamma)$ be a unipotent automorphism $\neq \mathbf{id}$. Choose some $a \in \mathcal{O}(\mathbb{C}^2)$ such that $\Gamma = \operatorname{div}(a)$. As \mathbf{g} preserves Γ , it follows that ais a semi-invariant for the \mathbb{C}^+ -action on \mathbb{C}^2 induced by \mathbf{g} . Since \mathbb{C}^+ has no non-trivial character, a is an invariant. Hence, $\mathbf{id} \neq a \cdot \mathbf{g} \in \operatorname{Iner}(\mathbb{C}^2, \Gamma)$.

 $(c) \Rightarrow d$: Let $\mathbf{g} \in \operatorname{Iner}(\mathbb{C}^2, \Gamma)$ with $\mathbf{g} \neq \operatorname{id}$. By Theorem 3.0.4, \mathbf{g} preserves a trivial \mathbb{C} -bundle $f \colon \mathbb{C}^2 \to \mathbb{C}$. Let $\Gamma_i, i \in I$ be the irreducible components of the reduced scheme $\Gamma_{\operatorname{red}}$. If every Γ_i lies in a fiber of f, then Γ is a fence and thus $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ is not an algebraic group. Therefore we can assume that $f(\Gamma_i) \subseteq \mathbb{C}$ is dense for some i. As \mathbf{g} is the identity on Γ_i , it follows that \mathbf{g} maps each fiber on itself. Hence, there exists $\alpha \in \mathbb{C}^*$ and a polynomial b(y) such that for each $y \in \mathbb{C}$ the restriction of \mathbf{g} to the fiber $f^{-1}(y)$ is given by

$$\mathbf{g}_y \colon \mathbb{C} \to \mathbb{C}, \quad x \mapsto \alpha x + b(y).$$

As \mathbf{g} is the identity on Γ_i , it follows that \mathbf{g}_y has a fixed point for all $y \in f(\Gamma_i)$. If $\alpha = 1$, then \mathbf{g}_y is the identity map for all $y \in f(\Gamma_i) \subseteq \mathbb{C}$. Since $f(\Gamma_i)$ is dense in \mathbb{C} we get a contradiction to the fact that $\mathbf{g} \neq \mathbf{id}$. Thus, $\alpha \neq 1$. But this implies that \mathbf{g}_y has exactly one fixed point for each $y \in \mathbb{C}$. Thus, $\Gamma_i = V(ax + b(y) - x) \simeq \mathbb{C}$ and it is the only irreducible component of Γ_{red} . Therefore, Γ is again a fence and $\text{Aut}(\mathbb{C}^2, \Gamma)$ is not an algebraic group.

 $d) \Rightarrow a$): Assume that Γ is not a fence. By [BS13, Theorem 1], Aut($\mathbb{C}^2, \Gamma_{red}$) is an algebraic group. Now, Aut(\mathbb{C}^2, Γ) is an algebraic group as well, since it is a closed subgroup of Aut($\mathbb{C}^2, \Gamma_{red}$).

4. Some elementary facts

4.1. Locally nilpotent derivations. Let A be a \mathbb{C} -algebra and assume it is a unique factorization domain (UFD). Let D be a \mathbb{C} -derivation of A. Then, D is called *locally nilpotent*, if for every $f \in A$ there exists an integer n = n(f) such that $D^n(f) = 0$. Moreover, D is called *irreducible*, if $D \neq 0$ and the following holds: if D = fD' for some locally nilpotent derivation D' and some $f \in \ker D$, then $f \in A^*$ where A^* denotes the subgroup of units of A.

We list some basic facts about locally nilpotent derivations, that we will use constantly (see [Fre06] for proofs).

Lemma 4.1.1. Let A be a \mathbb{C} -algebra and assume it is a UFD, and let D be a locally nilpotent derivation of A. Then

- i) The units of A lie in ker D. In particular, $\mathbb{C} \subseteq \ker D$.
- ii) The kernel ker D is factorially closed in A, i.e. if $f, g \in A$ such that $fg \in \ker D$, then $f, g \in \ker D$.
- iii) If $S \subseteq \ker D$ is a multiplicative system, then D extends uniquely to a locally nilpotent derivation of the localization A_S .
- iv) If $D \neq 0$, then there exists $f \in A$ such that $D(f) \in \ker D$ and $D(f) \neq 0$.
- v) If $s \in A$ such that D(s) = 1, then A is a polynomial ring in s over ker D and $D = \partial/\partial s$.
- vi) For $f \in A$, the derivation fD is locally nilpotent if and only if $f \in \ker D$.

- vii) If D is irreducible and E is another locally nilpotent derivation of A such that $E(\ker D) = 0$, then there exists $f \in \ker D$ such that E = fD.
- viii) If $D \neq 0$, then there exists a unique irreducible locally nilpotent derivation D_0 (up to multiplication by some element of A^*) such that ker $D = \text{ker } D_0$.
- ix) If $D(f) \in fA$, then D(f) = 0.
- x) The exponential exp(D) = ∑_{i=0}[∞] Dⁱ/i! is a C-algebra automorphism of A and the map exp defines an injection from the set of locally nilpotent derivations of A to the set of C-algebra automorphisms of A.

4.2. Uniptent automorphisms of \mathbb{C}^3 . Let $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be a unipotent automorphism. We call \mathbf{u} *irreducible* if the corresponding locally nilpotent derivation is irreducible. If $\mathbf{u} \neq \mathbf{id}$, there exists an irreducible $\mathbf{u}_0 \in \operatorname{Aut}(\mathbb{C}^3)$ such that \mathbf{u} is the modification $d \cdot \mathbf{u}_0$ for some $0 \neq d \in \ker D$. The automorphism \mathbf{u}_0 is unique up to a modification by some element in \mathbb{C}^* (cf. subsec. 4.1). We call then

$$\mathbf{u} = d \cdot \mathbf{u}_0$$

a standard decomposition.

Now, let \mathbf{u}, \mathbf{u}' be unipotent automorphisms of \mathbb{C}^3 such that there exists $0 \neq f \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$ with $\mathbf{u} = f \cdot \mathbf{u}'$. If ρ and ρ' denote the \mathbb{C}^+ -actions on \mathbb{C}^3 corresponding to \mathbf{u} and \mathbf{u}' respectively, then the orbits of ρ are contained in the orbits of ρ' and the orbits are equal on the principal open set $(\mathbb{C}^3)_f$. Moreover, if $\mathbf{u} = \operatorname{Exp}(D)$ and $\mathbf{u}' = \operatorname{Exp}(D')$, then im D = f im $D' \subseteq \mathcal{O}(\mathbb{C}^3)$ and the plinth divisors Γ , Γ' of \mathbf{u}, \mathbf{u}' satisfy

$$\Gamma = \Gamma' + \operatorname{div}(f) \,.$$

Whenever S is a subset of $\operatorname{Aut}(\mathbb{C}^n)$ we denote by S_u the subset of unipotent automorphisms in S.

5. STRUCTURE THEOREMS FOR $Cent(\mathbf{u})$

5.1. The first unipotent subgroup in $\text{Cent}(\mathbf{u})$. Let $\mathbf{id} \neq \mathbf{u} \in \text{Aut}(\mathbb{C}^3)$ be unipotent and let $\mathbf{u} = d \cdot \mathbf{u}_0$ be a standard decomposition. There exists an obvious subgroup of unipotent automorphisms in $\text{Cent}(\mathbf{u})$: The modifications of \mathbf{u}_0 , i.e. the subgroup $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$. This subgroup has another characterization:

Proposition 5.1.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent with standard decomposition $\mathbf{u} = d \cdot \mathbf{u}_0$. The subgroup $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ consists of those automorphisms of \mathbb{C}^3 that commute with \mathbf{u} and that induce the identity on $\mathbb{C}^3/\!\!/\mathbf{u}$, i.e. the sequence

$$1 \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma) \cap \operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma_0)$$

is exact, where Γ , Γ_0 denote the plinth divisors of \mathbf{u} , \mathbf{u}_0 respectively. Moreover, the homomorphisms in the sequence above are homomorphisms of ind-groups.

This result is an immediate consequence of Remark 5.1.1 and Lemma 5.1.2.

Remark 5.1.1. Choose generators v_1, v_2 of the polynomial ring $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$ and choose a \mathbb{C} -linear retraction $r: \mathcal{O}(\mathbb{C}^3) \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$. The map $p: \operatorname{Cent}(\mathbf{u}) \to \operatorname{Aut}(\mathbb{C}^3/\!\!/ \mathbf{u}, \Gamma)$ is a morphism of ind-varieties due to the following commutative diagram

Lemma 5.1.2. Let A be a \mathbb{C} -algebra and assume it is a UFD, let B, B' be non-zero locally nilpotent derivations of A such that B' is irreducible and ker $B = \ker B'$. If $\varphi: A \to A$ is a \mathbb{C} -algebra automorphism, then we have

 $\varphi|_{\ker B} = \mathrm{id} \ and \ \varphi \circ B = B \circ \varphi \ if and only if \ \varphi = \exp(fB'), \ f \in \ker B.$

Proof. Assume that $\varphi|_{\ker B}$ is the identity and φ commutes with B. There exists $0 \neq d \in \ker B$, such that $A_d = \ker(B)_d[s]$ is a polynomial ring in an element $s \in A_d$ and B(s) = 1, if we extend B to A_d . Since φ commutes with B there exists $g \in \ker(B)_d$ such that the extension $\tilde{\varphi}$ to A_d of φ satisfies $\tilde{\varphi}(s) = s + g$. Now, we have $\varphi = \exp(gB)|_A$. A density argument shows that $\exp(tgB)(A) \subseteq A$ for all $t \in \mathbb{C}$. Since

$$gB = \frac{\exp(tgB) - \mathrm{id}}{t}\Big|_{t=0}$$

we have $gB(A) \subseteq A$. Hence gB is a locally nilpotent derivation of A that vanishes on ker $B = \ker B'$. Thus, gB = fB' for some $f \in \ker B$. The converse is clear. \Box

Remark 5.1.2. By Proposition 5.1.1, Cent(**u**) normalizes $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ and one can easily see, that the action is given by

$$\mathbf{g}^{-1} \circ f \cdot \mathbf{u}_0 \circ \mathbf{g} = \mu(\mathbf{g}) \mathbf{g}^*(f) \cdot \mathbf{u}_0, \quad \mathbf{g} \in \operatorname{Cent}(\mathbf{u}), \ f \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0}$$

where μ : Cent(**u**) $\rightarrow \mathbb{C}^*$ is the homomorphism given by $\mu(\mathbf{g})d = \mathbf{g}^*(d)$.

5.2. Centralizer of a modified translation in $Aut(\mathbb{C}^3)$.

Proposition 5.2.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be a modified translation with standard decomposition $\mathbf{u} = d \cdot \mathbf{u}_0$. Denote by Γ the plinth divisor of \mathbf{u} . Then

$$1 \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma) \to 1$$

is a split short exact sequence of ind-groups. Moreover, there exists a closed subgroup of Cent(**u**) that is mapped via p isomorphically onto Aut($\mathbb{C}^3/\!/\mathbf{u}, \Gamma$).

Remark 5.2.1. Under the assumptions of Proposition 5.2.1, Cent(**u**) consists only of algebraic elements, provided that Γ is non-empty. Indeed, let $H \subseteq \text{Cent}(\mathbf{u})$ be a closed subgroup, such that p induces an isomorphism $H \simeq \text{Aut}(\mathbb{C}^3 /\!\!/ \mathbf{u}, \Gamma)$. Let $(f \cdot \mathbf{u}_0, \mathbf{h}) \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \rtimes H \simeq \text{Cent}(\mathbf{u})$. By Proposition 3.0.3 i), $R = \overline{\langle \mathbf{h} \rangle}$ is an algebraic subgroup of H. Hence

$$W = \operatorname{span}\{\mathbf{r}^*(f) \mid \mathbf{r} \in R\}$$

is a finite dimensional subspace of $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0}$ and $W \cdot \mathbf{u}_0 \rtimes R \subseteq \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \rtimes H$ is an algebraic subgroup that contains $(f \cdot \mathbf{u}_0, \mathbf{h})$ (see Remark 5.1.2).

Proof of Proposition 5.2.1. By Proposition 5.1.1, the sequence is left exact. By assumption, there exist coordinates (x, y, z) on \mathbb{C}^3 such that $d \in \mathbb{C}[y, z]$ and $\mathbf{u} = (x + d, y, z)$. Moreover, we can identify the algebraic quotient $\pi \colon \mathbb{C}^3 \to \mathbb{C}^3 /\!\!/ \mathbf{u} = \mathbb{C}^2$ with the map $(x, y, z) \mapsto (y, z)$ and $\Gamma = \operatorname{div}(d)$. Let $\mathbf{f} \in \operatorname{Aut}(\mathbb{C}^2, \Gamma)$. Then $\mathbf{f}^*(d) = \lambda(\mathbf{f})d$ for some $\lambda(\mathbf{f}) \in \mathbb{C}^*$. One can see that $\operatorname{Aut}(\mathbb{C}^2, \Gamma) \to \mathbb{C}^*$, $\mathbf{f} \mapsto \lambda(\mathbf{f})$ is a homomorphism of ind-groups. Thus

$$H = \{ \sigma \in \operatorname{Aut}(\mathbb{C}^3) \mid \sigma(x, y, z) = (\lambda x, \mathbf{f}(y, z)) \text{ with } \mathbf{f} \in \operatorname{Aut}(\mathbb{C}^2, \Gamma) \text{ and } \lambda(\mathbf{f}) = \lambda \}$$

is a closed subgroup of Cent(**u**) (note that the subgroup $\operatorname{Aut}(\mathbb{C}^2, \Gamma) \subseteq \operatorname{Aut}(\mathbb{C}^2)$ is closed by Proposition 3.0.3) and $p|_H \colon H \to \operatorname{Aut}(\mathbb{C}^2, \Gamma)$ is an isomorphism of ind-groups. \Box **Proposition 5.2.2.** Let $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent. Then $\operatorname{Cent}(\mathbf{u})$ contains $(\mathbb{C}^*)^2$ as an algebraic subgroup if and only if \mathbf{u} is a modified translation and the plinth divisor Γ is given by $v^i w^j$ for some coordinates (v, w) of $\mathbb{C}^3 /\!\!/ \mathbf{u} \simeq \mathbb{C}^2$.

Proof. Assume that Cent(**u**) contains an algebraic subgroup $T \simeq (\mathbb{C}^*)^2$. By Proposition 5.2.1 it follows that T acts faithfully on $\mathbb{C}^3 /\!\!/ \mathbf{u}$ and preserves the plinth divisor Γ . Hence, it follows from [BB66] that there exist coordinates (v, w) on $\mathbb{C}^2 \simeq \mathbb{C}^3 /\!\!/ \mathbf{u}$ such that Γ is given by $v^i w^j$ for some integers i, j. By [BB67] there exist coordinates (x_1, x_2, x_3) of \mathbb{C}^3 such that the action of T is diagonal with respect to these coordinates. Hence there exist characters $\lambda_1, \lambda_2, \lambda_3$ of T such that $\mathbf{t}(x_1, x_2, x_3) = (\lambda_1(\mathbf{t})x_1, \lambda_2(\mathbf{t})x_2, \lambda_3(\mathbf{t})x_3)$ for all $\mathbf{t} \in T$. Let $\mathbf{u} = \text{Exp}(D)$. By assumption we have for all $\mathbf{t} \in T$ and i = 1, 2, 3

$$D(x_i) \circ \mathbf{t} = \lambda_i(\mathbf{t}) D(x_i). \tag{2}$$

As the action of T on \mathbb{C}^3 is faithful, the subgroup spanned by $\lambda_1, \lambda_2, \lambda_3$ inside the characters of T has rank 2. Assume first that the λ_i are pairwise different. Then there exist at least two different indices $k_1, k_2 \in \{1, 2, 3\}$ such that λ_{k_i} lies not in the monoid spanned by $\{\lambda_l \mid l \neq k_i\}$. By symmetry we can assume $k_1 = 1$, $k_2 = 2$. This implies that $D(x_i) \in x_i \mathbb{C}[x_1, x_2, x_3]$ for i = 1, 2. Since D is locally nilpotent we have $D(x_1) = D(x_2) = 0$. Hence, \mathbf{u} is a modified translation. Assume now that $\lambda_1 = \lambda_2 \neq \lambda_3$ (the other cases follow by symmetry). Thus, λ_3 does not lie in the monoid spanned by λ_1 and λ_2 . Hence we get $D(x_3) \in x_3 \mathbb{C}[x_1, x_2, x_3]$ and $D(x_1), D(x_2) \in \mathbb{C} x_1 \oplus \mathbb{C} x_2$. Since D is locally nilpotent it follows that $D(x_3) = 0$ and the linear endomorphism $D|_{\mathbb{C} x_1 \oplus \mathbb{C} x_2}$ is nilpotent. This implies that \mathbf{u} is a modified translation.

The converse of the statement is clear.

5.3. The second unipotent subgroup in $\operatorname{Cent}(\mathbf{u})$. Let $\operatorname{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent with standard decomposition $\mathbf{u} = d \cdot \mathbf{u}_0$. Throughout this subsection we assume that the plinth divisor $\Gamma = \operatorname{div}(a)$ of \mathbf{u} is a fence. There exists another subgroup of unipotent automorphisms inside $\operatorname{Cent}(\mathbf{u})$ in addition to $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$, that we describe in this subsection.

Lemma 5.3.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent. If the plinth divisor $\Gamma = \operatorname{div}(a)$ is a fence, then there exists a variable z of $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} = \mathcal{O}(\mathbb{C}^2)$ such that $a \in \mathbb{C}[z]$ and any such z is a variable of $\mathcal{O}(\mathbb{C}^3)$.

Proof. By Proposition 3.0.5 there exists a coordinate system (z, w) of \mathbb{C}^2 such that the embedding div $(a) = \Gamma \subseteq \mathbb{C}^2$ is given by the standard embedding $F \times \mathbb{C} \subseteq \mathbb{C}^2$ for some 0-dimensional closed subscheme F of \mathbb{C} . Thus $a \in \mathbb{C}[z]$. Since the quotient map $\pi \colon \mathbb{C}^3 \to \mathbb{C}^3 /\!\!/ \mathbf{u}$ is a trivial \mathbb{C} -bundle over $\mathbb{C}^2 \setminus \Gamma$, it follows that only finitely many fibers of $z \colon \mathbb{C}^3 \to \mathbb{C}$ are non-isomorphic to \mathbb{C}^2 . Thus z is a variable of $\mathcal{O}(\mathbb{C}^3)$, according to Kaliman's Theorem [Kal02].

Remark 5.3.1. If $\mathbf{u} = \operatorname{Exp}(D)$ is irreducible, then Γ is a fence if and only if rank $D \leq 2$ (i.e. there exists a variable z of $\mathcal{O}(\mathbb{C}^3)$ that lies in ker D). This follows from the lemma above and from [DF98, Theorem 2.4, Proposition 2.3].

Definition 5.3.2. Let A be a UFD and let $P \in A[x, y]$. We denote

$$\Delta_P = -P_y \frac{\partial}{\partial x} + P_x \frac{\partial}{\partial y}$$

where P_x and P_y denote the partial derivatives of P with respect to x and y respectively. Obviously, Δ_P is an A-derivation of A[x, y] and $\Delta_P(P) = 0$.

Let D, D_0 be locally nilpotent derivations of $\mathcal{O}(\mathbb{C}^3)$ such that $\mathbf{u} = \operatorname{Exp}(D)$ and $\mathbf{u}_0 = \operatorname{Exp}(D_0)$. Let $z \in \ker D$ be a variable such that $a \in \mathbb{C}[z]$ and let (x, y, z) be a coordinate system of $\mathcal{O}(\mathbb{C}^3)$ (see Lemma 5.3.1). Let $A = \mathbb{C}[z]$. It follows now from [DF98, Theorem 2.4] that there exists $P \in A[x, y]$ such that

$$D_0 = \Delta_P$$
 and $\ker D = \ker D_0 = \mathbb{C}[z, P]$.

Obviously, d divides a in $\mathbb{C}[z]$. Let $a = da_0$. An easy calculation shows that $\operatorname{div}(a_0)$ is the plinth divisor of \mathbf{u}_0 and that for all $Q \in A[x, y]$ we have

$$D(Q) = a$$
 if and only if $D_0(Q) = a_0$. (3)

By assumption $\Gamma = \operatorname{div}(a)$ is a fence and thus $a, a_0 \neq 0$.

Lemma 5.3.2. Let $A = \mathbb{C}[z]$. If $Q \in A[x, y]$ such that D(Q) = a, then $E = \Delta_Q$ is an irreducible locally nilpotent derivation. Moreover, E commutes with D.

Proof. Let K be the quotient field of A. The extension of D_0 to K[x, y] satisfies $D_0(Q/a_0) = 1$. Thus K[x, y] = K[P, Q]. E is non-zero, since $E(P) = -a_0 \neq 0$. If we extend E to a derivation of K[x, y] one easily sees that E is locally nilpotent. Thus E is a non-zero locally nilpotent derivation of A[x, y].

By [DF98, Theorem 2.4, Proposition 2.3]) there exists $S \in A[x, y]$ and $0 \neq h \in A[P]$ such that $E = h\Delta_S$ and Δ_S is irreducible. Thus $-a_0 = E(P) = h\Delta_S(P) = -h\Delta_P(S)$. Hence $\Delta_P(S)$ lies in the plinth ideal of Δ_P and thus $\Delta_P(S)$ is a multiple of a_0 . This implies that $h \in \mathbb{C}^*$ and proves that E is irreducible.

If we extend Δ_P and Δ_Q to K[x, y] = K[P, Q], we get $\Delta_P = a_0(\partial/\partial Q)$ and $\Delta_Q = -a_0(\partial/\partial P)$. Thus *E* commutes with D_0 . Since $d \in \mathbb{C}[z]$, *E* and $D = dD_0$ commute.

Definition 5.3.3. For any $Q \in \mathcal{O}(\mathbb{C}^3)$ with D(Q) = a we call

$$\mathbf{e} = \operatorname{Exp}(E) = \operatorname{Exp}(\Delta_Q)$$

an admissible complement to **u**.

By (3), we get that \mathbf{e} is an admissible complement to \mathbf{u} if and only if \mathbf{e} is an admissible complement to \mathbf{u}_0 . It follows from Lemma 5.3.2 that $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{e}, \mathbf{u} \rangle} \cdot \mathbf{e}$ is a subgroup of unipotent automorphisms inside Cent(\mathbf{u}).

Remark 5.3.4. We have $\mathbb{C}^2 \setminus \Gamma = U \times \mathbb{C}$ for some non-empty open subset $U \subseteq \mathbb{C}$. The restriction of **u** and of **e** to the open subset

$$\pi^{-1}(\mathbb{C}^2 \setminus \Gamma) = (U \times \mathbb{C}) \times \mathbb{C} = \operatorname{Spec}(\mathbb{C}[z]_a[P,Q])$$

are given by $(u, v, w) \mapsto (u, v, w+1)$ and $(u, v, w) \mapsto (u, v+1, w)$ respectively, where (u, v, w) is the coordinate system $(z, -P/a_0, Q/a)$.

5.4. The property (Sat). We introduce in this subsection a property for a subset $S \subseteq \operatorname{Aut}(\mathbb{C}^n)$ and we will show that $\operatorname{Cent}(\mathbf{v})$ satisfies this property for any unipotent automorphism $\mathbf{v} \in \operatorname{Aut}(\mathbb{C}^n)$. This property will then play a key role when we describe the set of unipotent elements inside the centralizer. One can think of this property as a saturation feature on the unipotent elements in S.

Definition 5.4.1. Let $S \subseteq \operatorname{Aut}(\mathbb{C}^n)$ be a subset. We say that S has the *property* (Sat) if for all unipotent $\mathbf{w} \in \operatorname{Aut}(\mathbb{C}^n)$ and for all $0 \neq f \in \mathcal{O}(\mathbb{C}^n)^{\mathbf{w}}$ we have

$$f \cdot \mathbf{w} \in S \implies \mathbf{w} \in S.$$
 (Sat)

Proposition 5.4.1. If $\mathbf{v} \in \operatorname{Aut}(\mathbb{C}^n)$ is unipotent, then the subgroup $\operatorname{Cent}(\mathbf{v}) \subseteq \operatorname{Aut}(\mathbb{C}^n)$ satisfies the property (Sat).

Proof. Let $\mathbf{v} = \text{Exp}(B)$ and let $\mathbf{w} = \text{Exp}(F)$. Assume that $f \cdot \mathbf{w}$ commutes with \mathbf{v} for some \mathbf{w} -invariant $0 \neq f \in \mathcal{O}(\mathbb{C}^n)$. If $\mathbf{v} = \mathbf{id}$ or $\mathbf{w} = \mathbf{id}$, then (Sat) is obviously satisfied. Thus we assume $\mathbf{v} \neq \mathbf{id} \neq \mathbf{w}$. For the Lie-bracket we have

$$0 = [fF, B] = f[F, B] - B(f)F.$$
(4)

Thus, it is enough to prove that B(f) = 0.

First, assume that F is irreducible. By (4), it follows that f divides B(f)F(g) for all $g \in \mathcal{O}(\mathbb{C}^n)$. As F is irreducible, it follows that f divides B(f). Since B is locally nilpotent, it follows that B(f) = 0.

Now, let F = f'F' for some irreducible F'. Thus, ff'F' commutes with B and by the argument above, B(ff') = 0. Since ker B is factorially closed in $\mathcal{O}(\mathbb{C}^n)$, we have B(f) = 0.

5.5. The subgroup $N \subseteq \text{Cent}(\mathbf{u})$. Let $\mathbf{id} \neq \mathbf{u} \in \text{Aut}(\mathbb{C}^3)$ be unipotent. We define in this subsection a subgroup N of $\text{Cent}(\mathbf{u})$ and we gather some facts about this group. In the next subsection, we will prove that N is exactly the set of unipotent automorphisms $\text{Cent}(\mathbf{u})$ if \mathbf{u} is not a translation.

Definition 5.5.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent with standard decomposition $\mathbf{u} = d \cdot \mathbf{u}_0$ and let Γ be the plinth divisor of \mathbf{u} . Let

$$N = N(\mathbf{u}) = \begin{cases} \mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{e}, \mathbf{u}_0 \rangle} \cdot \mathbf{e} \circ \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 & \text{if } \Gamma \text{ is a fence} \\ \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 & \text{otherwise.} \end{cases}$$

where \mathbf{e} is an admissible complement to \mathbf{u} (cf. subsec. 5.3). Moreover, let

$$M = M(\mathbf{u}) = \begin{cases} (\ker E \cap \ker D_0)E + \ker(D_0)D_0 & \text{if } \Gamma \text{ is a fence} \\ \ker(D_0)D_0 & \text{otherwise.} \end{cases}$$

where $\mathbf{u}_0 = \operatorname{Exp}(D_0)$ and $\mathbf{e} = \operatorname{Exp}(E)$ (cf. Lemma 5.3.2).

Proposition 5.5.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent and assume it is not a translation. Then:

- i) N consists of unipotent automorphisms and we have N = Exp(M).
- ii) N normalizes $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ and we have for all $\mathbf{g} \in N$ and for all $f \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0}$

$$\mathbf{g}^{-1} \circ f \cdot \mathbf{u}_0 \circ \mathbf{g} = \mathbf{g}^*(f) \cdot \mathbf{u}_0$$

iii) N is a closed normal subgroup of $Cent(\mathbf{u})$ that fits into the following split short exact sequence of ind-groups

$$1 \to \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \hookrightarrow N \xrightarrow{p|_N} \operatorname{Aut}(\mathbb{C}^2, \Gamma) \cap \operatorname{Iner}(\mathbb{C}^2, \Gamma_0)_u \to 1,$$

where Γ_0 is the plinth divisor of \mathbf{u}_0 . If Γ is a fence, then the restriction of p to $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{u}_0, \mathbf{e} \rangle} \cdot \mathbf{e}$ is an isomorphism of ind-groups. In particular, N is independent of the choice of \mathbf{e} .

iv) $N \subseteq \operatorname{Aut}(\mathbb{C}^3)$ satisfies the property (Sat).

Proof. Assume first that Γ is not a fence. Then i) ii) and iv) are clear, iii) follows from Proposition 3.0.3. Thus we can assume that Γ is a fence.

i) Let $hE + fD_0 \in M$. By induction on $l \geq 1$ one sees that $(hE + fD_0)^l$ is a sum of terms of the form $gE^i(D_0)^j$ where $g \in \ker D_0$. From this fact, one can deduce that $hE + fD_0$ is locally nilpotent and hence M consists only of locally nilpotent derivations.

For all $f \in \ker D_0$ and $h \in \ker D_0 \cap \ker E$ and $q \ge 0$ we have

$$f D_0 \operatorname{ad}(hE)^q = (-1)^q h^q E^q(f) D_0$$

where $A \operatorname{ad}(B) = [A, B]$. With the aid of this formula, an application of the Baker-Campbell-Hausdorff formula yields $\operatorname{Exp}(hE) \circ \operatorname{Exp}(fD_0) \in M$ (see [Jac62, Proposition 1, §5, chp. V]). Hence $N \subseteq \operatorname{Exp}(M)$ which shows in particular, that N consists of unipotent automorphisms. Moreover, $\operatorname{exp} hE$ and $\operatorname{exp}(fD_0 + hE)$ coincide on $\operatorname{ker} D_0$. Lemma 5.1.2 implies $(\operatorname{Exp} hE)^{-1} \circ$ $\operatorname{Exp}(fD_0 + hE) = \operatorname{Exp}(gD_0)$ for some $g \in \operatorname{ker} D_0$ and thus $\operatorname{Exp}(M) \subseteq N$.

- ii) This follows from Remark 5.1.2.
- iii) One can check that $N = p^{-1}(\operatorname{Aut}(\mathbb{C}^2, \Gamma) \cap \operatorname{Iner}(\mathbb{C}^2, \Gamma_0)_u)$ by using Proposition 5.1.1. Since $\operatorname{Aut}(\mathbb{C}^2, \Gamma) \cap \operatorname{Iner}(\mathbb{C}^2, \Gamma_0)_u$ is a closed normal subgroup of $\operatorname{Aut}(\mathbb{C}^2, \Gamma) \cap \operatorname{Aut}(\mathbb{C}^2, \Gamma_0)$ it follows that N is a closed normal subgroup of $\operatorname{Cent}(\mathbf{u})$.

It is enough to show that the homomorphism $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{e}, \mathbf{u}_0 \rangle} \cdot \mathbf{e} \to \operatorname{Aut}(\mathbb{C}^2, \Gamma) \cap$ Iner $(\mathbb{C}^2, \Gamma_0)_u$ (induced by p) is an isomorphism of ind-groups. Injectivity follows from the fact that $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{e}, \mathbf{u}_0 \rangle} \cdot \mathbf{e} \cap \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 = \{\mathbf{id}\}$ and surjectivity follows from a straightforward calculation, by using that Γ is non-empty. The inverse map is clearly a morphism.

iv) Let $0 \neq hE + fD_0 \in M$. It is enough to prove that

$$gcd(h, f) = 1 \implies hE + fD_0 \text{ is irreducible}$$
(5)

where the greatest common divisor is taken in the polynomial ring ker $D_0 = \mathbb{C}[z, P]$ (we use the notation of subsec. 5.3). Indeed, let $gB = hE + fD_0 \in M$ for some locally nilpotent derivation $B \neq 0$ and some $0 \neq g \in \ker B$ and let $h = \gcd(h, f)h_0, f = \gcd(h, f)f_0$. Thus B vanishes on ker $(h_0E + f_0D_0)$ and since $h_0E + f_0D_0$ is irreducible, there exists $b \in \ker(h_0E + f_0D_0)$ such that $B = b(h_0E + f_0D_0)$. This implies $gb = \gcd(h, f) \in \mathbb{C}[z]$ and therefore $b \in \mathbb{C}[z]$. This shows that $B \in M$.

Let us prove (5). Since E and D_0 are irreducible (see Lemma 5.3.2) we can assume that h and f both are non-zero. A calculation shows

$$hE + fD_0 = \Delta_F$$
, $F = hQ + fP - \int \left(\frac{\partial f}{\partial P}P\right) dP$

where the integration is taken inside the polynomial ring ker $D_0 = \mathbb{C}[z, P]$ and Δ_F is taken with respect to A[x, y] where $A = \mathbb{C}[z]$. Let $f = \sum_{i=0}^{n} f_i(z)P^i$. Thus we have

$$fP - \int \left(\frac{\partial f}{\partial P}P\right) dP = \sum_{i=0}^{n} f_i(z) \left(1 - \frac{i}{i+1}\right) P^{i+1}.$$

Denote this last polynomial by $G \in \mathbb{C}[z, P]$.

Now, assume towards a contradiction that $hE + fD_0$ is not irreducible. Hence, we have $hE + fD_0 = bB$ for some locally nilpotent derivation B and some non-constant $b \in \ker B$. By plugging in P and Q in $hE + fD_0 = bB$ and using the fact that gcd(h, f) = 1 we see that b divides a_0 (recall that $D_0(Q) = a_0$ and $E(P) = -a_0$). Hence there exists a root z_0 of a_0 such that the induced derivation of $\Delta_F = hE + fD_0$ on $\mathbb{C}[x, y, z]/(z - z_0) \simeq \mathbb{C}[x, y]$ vanishes. Thus, there exists a constant $c \in \mathbb{C}$ such that

$$h(z_0)Q(x,y,z_0) + \sum_{i=0}^n f_i(z_0) \left(1 - \frac{i}{i+1}\right) P^{i+1}(x,y,z_0) = c.$$
(6)

The polynomial $P(x, y, z_0) \in \mathbb{C}[x, y]$ is non-constant, since otherwise $\mathbf{u} = \text{Exp}(\Delta_P)$ would have a two-dimensional fixed point set, contradicting the irreducibility (cf. [Dai07, 2.10]). If $h(z_0) = 0$, then we have $f(z_0, P) = 0$ by (6). Hence $\text{gcd}(h, f) \neq 1$, a contradiction. Thus we can assume $h(z_0) \neq 0$. It follows that $Q + h(z_0)^{-1}(G(z, P) - c)$ is divisible by $z - z_0$ inside $\mathcal{O}(\mathbb{C}^3)$. Thus,

$$D_0\left(\frac{Q+h(z_0)^{-1}(G(z,P)-c)}{z-z_0}\right) = \frac{a_0}{z-z_0}.$$

But this contradicts the fact, that a_0 is a generator of the plinth ideal of D_0 .

5.6. The group $Cent(\mathbf{u})$ as a semi-direct product. In this subsection, we prove our first main result: There exists an algebraic subgroup $R \subseteq Cent(\mathbf{u})$ such that $Cent(\mathbf{u})$ is the semi-direct product of N with R, if \mathbf{u} is not a translation.

Theorem 5.6.1. Let $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent and assume that \mathbf{u} is not a translation. Then the subgroup $N \subseteq \operatorname{Cent}(\mathbf{u})$ is closed and normal, and there exists an algebraic subgroup $R \subseteq \operatorname{Cent}(\mathbf{u})$ such that $\operatorname{Cent}(\mathbf{u}) \simeq N \rtimes R$ as ind-groups. Moreover, all elements of $\operatorname{Cent}(\mathbf{u})$ are algebraic.

We prove the result for modified translations and reduce the general case to it.

Proof for a modified translation. Let $\mathbf{u} = d \cdot \mathbf{u}_0$ be a standard decomposition. There exists a coordinate system (x, y, z) such that $\mathbf{u}_0(x, y, z) = (x + 1, y, z)$ and $d \in \mathbb{C}[y, z] \setminus \mathbb{C}$.

If Γ is not a fence, then it follows from Proposition 3.0.3 that $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ is an algebraic group. By Proposition 5.2.1 there exists a closed subgroup R of $\operatorname{Cent}(\mathbf{u})$ that is mapped via p: $\operatorname{Cent}(\mathbf{u}) \twoheadrightarrow \operatorname{Aut}(\mathbb{C}^2, \Gamma)$ isomorphically onto $\operatorname{Aut}(\mathbb{C}^2, \Gamma)$ and $\operatorname{Cent}(\mathbf{u}) \simeq N \rtimes R$.

Now, assume that $\Gamma = \operatorname{div}(a)$ is a non-empty fence. By Proposition 3.0.5 there exist coordinates (y, z) of $\mathbb{C}^2 = \mathbb{C}^3 /\!\!/ \mathbf{u}$ such that $a \in \mathbb{C}[z]$. Thus we have a split short exact sequence of ind-groups

$$1 \to \operatorname{Aut}(\mathbb{C}^2, \Gamma)_u \hookrightarrow \operatorname{Aut}(\mathbb{C}^2, \Gamma) \xrightarrow{q} \mathbb{C}^* \times \operatorname{Aut}(\mathbb{C}, V(a)) \to 1$$

where q sends an automorphism $(y, z) \mapsto (\lambda y + h, \alpha z + \beta)$ to $(\lambda, z \mapsto \alpha z + \beta)$. Let *R* be the algebraic group $\mathbb{C}^* \times \operatorname{Aut}(\mathbb{C}, V(a))$. Since *N* is generated by $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ and $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{e}, \mathbf{u}_0 \rangle} \cdot \mathbf{e} \simeq \operatorname{Aut}(\mathbb{C}^2, \Gamma)_u$ (see Proposition 5.5.1), we have the desired split short exact sequence of ind-groups

$$1 \to N \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{q \circ p} R \to 1$$
.

By Remark 5.2.1, every element of $Cent(\mathbf{u})$ is algebraic.

Proof in the general case. Let $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}} = \mathbb{C}[\tilde{y}, \tilde{z}]$ and let $\tilde{x} \in \mathcal{O}(\mathbb{C}^3)$ such that $\mathbf{u}^*(\tilde{x}) = \tilde{x} + a$, where $\Gamma = \operatorname{div}(a)$. Let $\tilde{\mathbf{u}} \in \operatorname{Aut}(\mathbb{C}^3)$ be given by $\tilde{\mathbf{u}}(\tilde{x}, \tilde{y}, \tilde{z}) = (\tilde{x} + a, \tilde{y}, \tilde{z})$ where we interpret a as a polynomial in \tilde{y} and \tilde{z} . The morphism $\mathbb{C}^3 \to \mathbb{C}^3$ induced by the inclusion $\mathbb{C}[\tilde{x}, \tilde{y}, \tilde{z}] \subseteq \mathcal{O}(\mathbb{C}^3)$ is birational and thus we get an injective group homomorphism

$$\eta \colon \operatorname{Cent}(\mathbf{u}) \longrightarrow \operatorname{Cent}(\tilde{\mathbf{u}}).$$

In fact, η is a homomorphism of ind-groups, due to the following commutative diagram, where $r: \mathcal{O}(\mathbb{C}^3) \twoheadrightarrow \mathbb{C}[\tilde{x}, \tilde{y}, \tilde{z}]$ is a \mathbb{C} -linear retraction

According to the first case, $\operatorname{Cent}(\tilde{\mathbf{u}})$ is the semi-direct product of $N(\tilde{\mathbf{u}})$ with some algebraic subgroup $\tilde{R} \subseteq \operatorname{Cent}(\tilde{\mathbf{u}})$. Let $H \subseteq \tilde{R}$ be an algebraic subgroup. We claim that $\eta^{-1}(H) \subseteq \operatorname{Cent}(\mathbf{u})$ is an algebraic subgroup. Since $\eta \colon \operatorname{Cent}(\mathbf{u}) \to \operatorname{Cent}(\tilde{\mathbf{u}})$ is a homomorphism of ind-groups, it follows that $\eta^{-1}(H)$ is a closed subgroup. As H is algebraic and thus acts locally finite on \mathbb{C}^3 , it follows that $\eta^{-1}(H)$ acts also locally finite on \mathbb{C}^3 by [KS13, Lemma 3.6]. This implies the claim.

According to the claim all elements of $\text{Cent}(\mathbf{u})$ are algebraic and $R = \eta^{-1}(\tilde{R})$ is algebraic as well. Since η is an injective homomorphism of ind-groups we have the following commutative diagram

As the first column is a split short exact sequence of ind-groups, the second coloumn is also a split short exact sequence of ind-groups. This proves the theorem. \Box

5.7. The unipotent elements of $Cent(\mathbf{u})$. The goal of this subsection is to prove our second main result: The unipotent elements of $Cent(\mathbf{u})$ are exactly N provided \mathbf{u} is not a translation (see subsec. 5.5 for the definition of N). As we know from Proposition 5.5.1 the set N satisfies the property (Sat). This will be a key ingredient in the proof.

Theorem 5.7.1. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent and assume it is not a translation. Then the set of unipotent elements of $\operatorname{Cent}(\mathbf{u})$ is equal to N.

Proof. Let $\mathbf{u} = d \cdot \mathbf{u}_0$ be a standard decomposition. Let $\mathbf{g} \in \text{Cent}(\mathbf{u})$ be a unipotent automorphism with $\mathbf{g} \neq \mathbf{id}$. If Γ is not a fence, then $\text{Aut}(\mathbb{C}^2, \Gamma)$ contains no unipotent automorphism $\neq \mathbf{id}$ (see Proposition 3.0.3). By Proposition 5.1.1 it follows that $\mathbf{g} \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 = N$.

Hence we can assume that $\Gamma = \operatorname{div}(a)$ is a fence. Let $z \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$ be a variable of $\mathcal{O}(\mathbb{C}^3)$ such that $a \in \mathbb{C}[z]$ (see Lemma 5.3.1). If $\mathcal{O}(\mathbb{C}^3)^{\mathbf{g}} = \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$, then \mathbf{g} is a modification of \mathbf{u}_0 and therefore $\mathbf{g} \in N$. Now, assume $\mathcal{O}(\mathbb{C}^3)^{\mathbf{g}} \neq \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}}$. Thus \mathbf{g} is not a modification of \mathbf{u}_0 and hence $\mathbf{id} \neq p(\mathbf{g}) \in \operatorname{Aut}(\mathbb{C}^2, \Gamma)$. Since $p(\mathbf{g})$ is unipotent and $0 \neq a \in \mathbb{C}[z]$, it follows that $z \in \mathcal{O}(\mathbb{C}^3)^{\mathbf{g}}$ and thus $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{g}, \mathbf{u} \rangle}$ is an ∞ -dimensional \mathbb{C} -vector space. By Theorem 5.6.1 there exists an algebraic subgroup $R \subseteq \text{Cent}(\mathbf{u})$ and a split short exact sequence of ind-groups

$$1 \to N \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{\prime} R \to 1$$

If $\mathbf{g} \notin N$, then $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{g}, \mathbf{u} \rangle} \cdot \mathbf{g} \cap N = 1$, since N satisfies the property (Sat). We get an injection $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{g}, \mathbf{u} \rangle} \to \operatorname{Cent}(\mathbf{u}) \twoheadrightarrow R$, $h \mapsto r(h \cdot \mathbf{g})$. Choose any filtration by finite dimensional \mathbb{C} -subspaces to turn $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{g}, \mathbf{u} \rangle}$ into an ind-group. It follows that $\mathcal{O}(\mathbb{C}^3)^{\langle \mathbf{g}, \mathbf{u} \rangle} \to R$ is an injective homomorphism of ind-groups. But this implies that R has algebraic subgroups of arbitrary high dimension, which is absurd. This finishes the proof of the theorem.

If we endow $\text{Cent}(\mathbf{u})/N$ with the algebraic group structure induced by the semidirect product decomposition coming from Theorem 5.6.1, then we get immediately the following corollary from Theorem 5.7.1.

Corollary 5.7.2. If $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ is unipotent and not a translation, then the algebraic group $\operatorname{Cent}(\mathbf{u})/N$ consists only of semi-simple elements. In particular, the connected component of the neutral element in $\operatorname{Cent}(\mathbf{u})/N$ is a torus.

6. Applications

Proposition 6.0.3. Let $\mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent and irreducible, and assume that Γ is a non-empty fence. Then $\Gamma \subseteq \mathbb{C}^3 /\!\!/ \mathbf{u}$ is the largest closed subscheme fixed by $\operatorname{Cent}(\mathbf{u})_u$.

Proof. By Proposition 5.5.1 and Theorem 5.7.1, we get $p(\operatorname{Cent}(\mathbf{u})_u) = \operatorname{Iner}(\mathbb{C}^2, \Gamma)_u$, where $p: \operatorname{Cent}(\mathbf{u}) \to \operatorname{Aut}(\mathbb{C}^2, \Gamma)$ is the canonical morphism. Thus Γ is fixed by the action of $\operatorname{Cent}(\mathbf{u})_u$. Let $X \subseteq \mathbb{C}^2$ be a closed subscheme that is fixed under $\operatorname{Cent}(\mathbf{u})_u$ and assume that X contains Γ . Moreover, let $I(X) \subseteq \mathcal{O}(\mathbb{C}^2)$ be the ideal of X and let $\Gamma = \operatorname{div}(a)$. By Proposition 3.0.5 there exist coordinates (z, w) of \mathbb{C}^2 such that $a \in \mathbb{C}[z]$. Let $\sigma \in \operatorname{Iner}(\mathbb{C}^2, \Gamma)_u$ be given by $\sigma(z, w) = (z, w + a)$. By assumption, we get $a = \sigma^*(w) - w \in I(X)$. But this implies that X is a closed subscheme of Γ and hence $X = \Gamma$.

Proposition 6.0.4. Let $\mathbf{id} \neq \mathbf{u} \in \operatorname{Aut}(\mathbb{C}^3)$ be unipotent, not a translation, and let $\mathbf{u} = d \cdot \mathbf{u}_0$ be a standard decomposition. Then the subgroup $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ of $\operatorname{Cent}(\mathbf{u})$ is characteristic, i.e. $\mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0$ is invariant under all abstract group automorphisms of $\operatorname{Cent}(\mathbf{u})$.

Lemma 6.0.5. Let T be a torus acting on \mathbb{C}^2 . Assume that there exist coordinates (z, w) of \mathbb{C}^2 such that z is a semi-invariant. Then there exists $r \in \mathbb{C}[z]$ such that the action of T is diagonal with respect to the coordinate system (z, w + r).

Proof of Lemma 6.0.5. By assumption, pr: $\mathbb{C}^2 \to \mathbb{C}$, $(z, w) \to z$ is *T*-equivariant with respect to a suitable *T*-action on \mathbb{C} . Due to [KK96, Proposition 1], every lift of a *T*-action on \mathbb{C} to \mathbb{C}^2 (with respect to pr) is equivalent to a trivial lift (with respect to pr). Thus, there exists $r \in \mathbb{C}[z]$ such that w + r is a semi-invariant with respect to the action of *T*. This finishes the proof.

Proof of Proposition 6.0.4. Let $R \subseteq \text{Cent}(\mathbf{u})$ be an algebraic subgroup such that $\text{Cent}(\mathbf{u}) = R \ltimes N$ (see Theorem 5.6.1). Let $T = R^0$ be the connected component of the neutral element in R. By Corollary 5.7.2, it is a torus (possibly dim T = 0). It follows from Theorem 5.6.1 that $T \ltimes N \subseteq \text{Cent}(\mathbf{u})$ is a subgroup of finite index.

Moreover, $T \ltimes N$ has no proper subgroup of finite index, as this group is generated by groups that have no proper subgroup of finite index. This implies that $T \ltimes N$ is a characteristic subgroup of Cent(**u**). Let $G = T \ltimes N$ and let $H = \mathcal{O}(\mathbb{C}^3)^{\mathbf{u}_0} \cdot \mathbf{u}_0 \subseteq N$. It is now enough to prove, that H is characteristic in G. We divide the proof now in two cases.

 Γ is not a fence: If dim T = 0, then we have H = G. So assume dim T > 0. There exist coordinates (v_1, v_2) of $\mathbb{C}^3 /\!\!/ \mathbf{u}$ such that the action of T on $\mathbb{C}^3 /\!\!/ \mathbf{u}$ is diagonal with respect to (v_1, v_2) (see [Kam79]). Let ρ_1 and ρ_2 be the characters of T such that $\mathbf{t}^*(v_i) = \rho_i(\mathbf{t})v_i$ for all $\mathbf{t} \in T$. Let $\mathbf{t} \circ f \cdot \mathbf{u}_0 \in \text{Cent}_G(G^{(1)})$, where $G^{(1)} = [G, G]$ denotes the first derived group. A calculation shows for i = 1, 2 and for all $k \geq 0$

$$\mathbf{id} = [\mathbf{t} \circ f \cdot \mathbf{u}_0, [\mathbf{t}^{-1}, v_i^k \cdot \mathbf{u}_0]] = (1 - \mu(\mathbf{t}^{-1})\rho_i(\mathbf{t}^{-1})^k)(1 - \mu(\mathbf{t})\rho_i(\mathbf{t})^k)v_i^k \cdot \mathbf{u}_0$$

where $\mu: T \to \mathbb{C}^*$ is the character defined by $\mu(\mathbf{t})d = \mathbf{t}^*(d)$ (see Remark 5.1.2). Thus $\rho_i(\mathbf{t}) = 1$ for i = 1, 2. As the action of T on $\mathbb{C}^3 /\!\!/ \mathbf{u}$ is faithful, it follows that $\mathbf{t} = 1$. Hence $H = \operatorname{Cent}_G(G^{(1)})$.

 Γ is a fence: Let (z, P) be a coordinate system of $\mathbb{C}^2 = \mathbb{C}^3 /\!\!/ \mathbf{u}$ such that $\Gamma \subseteq \mathbb{C}^2$ is given by the standard embedding $F \times \mathbb{C} \subseteq \mathbb{C}^2$ for some 0-dimensional closed subscheme $F \subseteq \mathbb{C}$ and $\mathbf{u}_0 = \operatorname{Exp}(\Delta_P)$ (see subsec. 5.3). As the torus T preserves $\Gamma = V(a) \subseteq \mathbb{C}^2$ invariant and since $a \in \mathbb{C}[z]$, there exists $q \in \mathbb{C}$, such that z + qis a semi-invariant for the action of T. By replacing z + q with z, we can assume that z is a semi-invariant. Moreover, by replacing P with a suitable P + r for some $r \in \mathbb{C}[z]$ we can assume that the action of T with respect to (z, P) is diagonal (see Lemma 6.0.5). Moreover, we denote by \mathbf{e} an admissible complement to \mathbf{u} .

Assume first dim T = 0. Let $h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_0 \in \operatorname{Cent}_G(G^{(1)})$. A calculation shows that

$$\mathbf{id} = [h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_0, [P^2 \cdot \mathbf{u}_0, \mathbf{e}]] = -2h(a_0)^2 \cdot \mathbf{u}_0$$

where $a_0 \in \mathbb{C}[z]$ such that $\Gamma_0 = \operatorname{div}(a_0)$. Hence h = 0 and therefore $H = \operatorname{Cent}_G(G^{(1)})$.

Assume now, dim T > 0. Let $A = \mathbb{C}[z]$ and let $A \ltimes A[P]$ be the semi-direct product defined by

$$(h, f) \cdot (\bar{h}, \bar{f}) = (h + \bar{h}, f(P - \bar{h}a_0) + \bar{f})$$
 (7)

From Proposition 5.5.1 it follows that

$$A \ltimes A[P] \xrightarrow{\sim} N(\mathbf{u}), \quad (h, f) \longmapsto h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_0$$

is an isomorphism of groups. Under this isomorphism the subgroup A[P] is sent onto H. It follows from Lemma 6.0.6 that $H = \operatorname{Cent}_G G^{(2)}$.

Lemma 6.0.6. Let $A \ltimes A[P]$ be defined as in (7) and let $G = T \ltimes (A \ltimes A[P])$ where T is a torus with dim T > 0. Assume that $A[P] \subseteq G$ is a normal subgroup, that the action of T by conjugation on A[P] is given by $\lambda^{-1}f\lambda = \mu(\lambda)f(\rho_1(\lambda)z, \rho_2(\lambda)P)$ for some characters μ , ρ_1 , ρ_2 and that ker $\rho_1 \cap \text{ker } \rho_2 = \{1\}$. Furthermore we assume that the action of T by conjugation on the quotient G/A[P] is non-trivial and the product in G satisfies $(\lambda, 0, 0) \cdot (1, h, f) = (\lambda, h, f)$. Then $A[P] = \text{Cent}_G G^{(2)}$.

Proof of Lemma 6.0.6. As the action by conjugation of T on G/A[P] is non-trivial, it follows that the first derived subgroup $G^{(1)}$ is not contained in A[P]. As T is abelian it follows that $G^{(1)} \subseteq A \ltimes A[P]$ and as A is abelian we conclude $G^{(2)} \subseteq$

A[P]. Thus there exists $(1, h_0, f_0) \in G^{(1)}$ with $h_0 \neq 0$. As A[P] is abelian, we get $A[P] \subseteq \operatorname{Cent}_G G^{(2)}$. Now, we prove $\operatorname{Cent}_G G^{(2)} \subseteq A[P]$. We have

$$(1, 0, q - q(P + h_0 a_0)) = [(1, 0, q), (1, h_0, f_0)] \in G^{(2)}$$
 for all $(1, 0, q) \in G^{(1)}$.

Moreover, $(1, 0, z^i P^j) \in G^{(1)}$ for all $(i, j) \in \mathbb{N}_0^2$ such that $\mu \rho_1^i \rho_2^j$ is not the trivial character, as we have $(1, 0, z^i P^j) = [(\lambda, 0, 0), (1, 0, z^i P^j)]$ for some well chosen $\lambda \in T$. For all $j \geq 0$, the character $\mu \rho_1^i \rho_2^j$ is non-trivial, provided that i is large enough. For all $(1, 0, f) \in A[P]$ we have

$$\operatorname{Cent}_{G}(1,0,f) = \{ (\overline{\lambda},\overline{h},f) \in G \mid (\overline{\lambda},\overline{h},\overline{f})^{-1} \cdot (1,0,f) \cdot (\overline{\lambda},\overline{h},\overline{f}) = (1,0,f) \} \\ = \{ (\overline{\lambda},\overline{h},\overline{f}) \in G \mid f = (\overline{\lambda}^{-1}f\overline{\lambda})(P - \overline{h}a_{0}) \}$$

Let $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_G G^{(2)}$. Since $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_G(1, 0, -z^i h_0 a_0)$ for i sufficiently large, we get $\bar{\lambda} \in \ker \rho_1$. Moreover, $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_G(1, 0, -z^i h_0 a_0 (2P + h_0 a_0))$ for sufficiently large i. This implies $\rho_2(\bar{\lambda}) = \mu(\bar{\lambda})^{-1}$ and $\bar{h} = ((\mu(\bar{\lambda}) - 1)/2)h_0$. Since $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_G(1, 0, -z^i h_0 a_0 (3P^2 + 3Ph_0 a_0 + (h_0 a_0)^2))$ it follows that $\rho_2(\bar{\lambda})^2 =$ $\mu(\bar{\lambda})^{-1}$. Therefore $\bar{\lambda} \in \ker \rho_2$, $\bar{h} = 0$. Hence we have $(\bar{\lambda}, \bar{h}, \bar{f}) = (1, 0, \bar{f}) \in A[P]$ and this proves $\operatorname{Cent}_G G^{(2)} \subseteq A[P]$.
