# AUTOMORPHISMS OF $\mathbb{C}^{3}$ COMMUTING WITH A $\mathbb{C}^{+}$-ACTION

#### Abstract

Let $\rho$ be an algebraic action of the additive group $\mathbb{C}^{+}$on the threedimensional affine space $\mathbb{C}^{3}$. We describe the group $\operatorname{Cent}(\rho)$ of polynomial automorphisms of $\mathbb{C}^{3}$ that commute with $\rho$. A particular emphasis lies in the description of the automorphisms in Cent $(\rho)$ coming from algebraic $\mathbb{C}^{+}$actions. As an application we prove that the automorphisms in Cent $(\rho)$ that are the identity on the algebraic quotient of $\rho$ form a characteristic subgroup of $\operatorname{Cent}(\rho)$.


## 1. Introduction

Let $X$ be an affine algebraic variety. A classification of the algebraic $\mathbb{C}^{+}$-actions on $X$ up to conjugacy in the automorphism $\operatorname{group} \operatorname{Aut}(X)$ is only known for a few varieties $X$. For example, when $X=\mathbb{C}^{2}$ we have a classification: every $\mathbb{C}^{+}$-action is a modified translation up to conjugacy, i.e. an action of the form $t \cdot(x, y)=$ $(x+t d(y), y)$ for a suitable polynomial $d$ (see [Ren68]). In contrast to the twodimensional case, there is no classification known for the $\mathbb{C}^{+}$-actions on $\mathbb{C}^{3}$. As a first step towards a classification, we study the centralizer of a $\mathbb{C}^{+}$-action in $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$, i.e. the group of automorphisms that commute with the $\mathbb{C}^{+}$-action.

An automorphism $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{n}\right)$ is called unipotent if there exists on $\mathbb{C}^{n}$ an algebraic $\mathbb{C}^{+}$-action $\rho: \mathbb{C}^{+} \times \mathbb{C}^{n} \rightarrow \mathbb{C}^{n}$ such that

\mathbf{u}\left(x_{1}, \ldots, x_{n}\right)=\rho\left(1, x_{1}, \ldots, x_{n}\right) \quad \text { for all }\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{C}^{n}
$$

In fact, the $\mathbb{C}^{+}$-action $\rho$ is uniquely determined by the unipotent automorphism $\rho_{1}=\left(\left(x_{1}, \ldots, x_{n}\right) \mapsto \rho\left(1, x_{1}, \ldots, x_{n}\right)\right)$. Thus $\rho \mapsto \rho_{1}$ is a bijection between algebraic $\mathbb{C}^{+}$-actions on $\mathbb{C}^{n}$ and unipotent automorphisms of $\mathbb{C}^{n}$. Moreover, the centralizer of $\rho$ is the same as the centralizer of $\rho_{1}$ and thus we are reduced to the study of the centralizer of a unipotent automorphism.

For us it will be crucial that there is a different characterization of unipotent automorphisms. Namely, there is a bijective correspondence of unipotent automorphisms of $\mathbb{C}^{n}$ and locally nilpotent derivations of the polynomial ring $\mathcal{O}\left(\mathbb{C}^{n}\right)=$ $\mathbb{C}\left[x_{1}, \ldots, x_{n}\right]$, given by the exponential Exp
$\left\{\right.$ locally nilpotent derivations of $\left.\mathcal{O}\left(\mathbb{C}^{n}\right)\right\} \stackrel{1: 1}{\longleftrightarrow}\left\{\right.$ unipotent automorphisms of $\left.\mathbb{C}^{n}\right\}$

compare [Fre06, sec. 1.5].
In dimension $n=2$, Shmuel Friedland and John Milnor proved that every automorphism of $\mathbb{C}^{2}$ is conjugate to a composition of so-called generalized Hénon

[^0]maps or to a triangular automorphism, i.e. an automorphism of the form $(x, y) \mapsto$ $(a x+b(y), c y+e)$ where $a, c \in \mathbb{C}^{*}, b \in \mathbb{C}[y]$ and $e \in \mathbb{C}(c f$. [FM89, Theorem 2.6]). In the first case, Stéphane Lamy showed that the centralizer of such an automorphism is isomorphic to a semi-direct product of $\mathbb{Z}$ with a finite cyclic group $\mathbb{Z}_{q}$ (cf. [Lam01, Proposition 4.8]). In the second case, assuming in addition that the automorphism is unipotent, it has the form $\mathbf{u}(x, y)=(x+d(y), y)$ for suitable coordinates $(x, y)$ of $\mathbb{C}^{2}$. One can see that the centralizer Cent $(\mathbf{u})$ consists of triangular automorphisms and that it fits into the following split short exact sequence

where $\operatorname{Aut}(\mathbb{C}, \operatorname{div}(d))$ denotes the automorphisms of $\mathbb{C}$ that preserve the principal divisor $\operatorname{div}(d) \subseteq \mathbb{C}$ and $p$ sends $((x, y) \mapsto(a x+b(y), c y+e))$ to $(y \mapsto c y+e)$.

In dimension $n=3$, Cinzia Bisi proved the following for a regular automorphism f (i.e. an automorphism such that the indeterminacy sets of the map and its inverse seen as birational maps of $\mathbb{P}^{3}$ do not intersect): If $\mathbf{g}$ is any automorphism that commutes with $\mathbf{f}$, then $\mathbf{g}^{m}=\mathbf{f}^{k}$ for certain integers $k, m$ (cf. [Bis08, Main Theorem 1.1]). As a counterpart to the regular automorphisms, one can regard the unipotent automorphisms (a regular automorphism satisfies $\operatorname{deg}\left(\mathbf{f}^{k}\right)=\operatorname{deg}(\mathbf{f})^{k}$ for all integers $k \geq 0$ and thus can not be unipotent). The work of David Finston and Sebastian Walcher [FW97] can be seen as a first step in the study of the centralizer of a unipotent automorphism. They explore the centralizer of a triangulable (locally nilpotent) derivation inside the algebra of all derivations of $\mathcal{O}\left(\mathbb{C}^{3}\right)$.

In this article we study the structure of the centralizer of a unipotent automorphism $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ with the aid of an exact sequence similar to (1) and give some applications of this study.

## 2. Statement of the main Results

Let $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be a unipotent automorphism $\neq \mathbf{i d}$ and let $D$ be the locally nilpotent derivation of $\mathcal{O}\left(\mathbb{C}^{3}\right)$ such that $\mathbf{u}=\operatorname{Exp}(D)$. Denote by $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$ the functions that are invariant under the $\mathbb{C}^{+}$-action induced by u. They satisfy $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}=\operatorname{ker} D \subseteq \mathcal{O}\left(\mathbb{C}^{3}\right)$. Denote by $\mathbb{C}^{3} / / \mathbf{u}$ the algebraic quotient of $\mathbb{C}^{3}$ by the $\mathbb{C}^{+}$-action induced by $\mathbf{u}$, i.e. $\mathbb{C}^{3} / / \mathbf{u}=\operatorname{Spec}\left(\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}\right)$. By Miyanishi's Theorem (cf. [Fre06, Theorem 5.1]), this algebraic quotient is isomorphic to $\mathbb{C}^{2}$.

We call the ideal $\operatorname{im} D \cap \operatorname{ker} D$ of ker $D$ the plinth ideal of $D$. By [DK09, Theorem 1] this ideal is principal. We fix some generator $a$ and call the principal divisor

$$
\Gamma=\operatorname{div}(a) \subseteq \mathbb{C}^{3} / / \mathbf{u}=\mathbb{C}^{2}
$$

the plinth divisor of $\mathbf{u}$ (respectively of $D$ ). We get a homomorphism of the centralizer $\operatorname{Cent}(\mathbf{u})$ into the group $\operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$ of automorphisms of the algebraic quotient $\mathbb{C}^{3} / / \mathbf{u}$ that preserve the plinth divisor $\Gamma$

$$
p: \operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)
$$

(see sec. 3 for an exact definition of $\operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$ ). In contrast to the two-dimensional case (see (1)), the homomorphism $p$ in the three-dimensional case is in general not surjective (see [Sta13, Proposition 1]).

If $f \in \operatorname{ker} D=\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$, then $f D$ is a locally nilpotent derivation of $\mathcal{O}\left(\mathbb{C}^{3}\right)$. We call $\operatorname{Exp}(f D)$ a modification of $\mathbf{u}=\operatorname{Exp}(D)$ and write

$$
f \cdot \mathbf{u}=\operatorname{Exp}(f D)
$$

Note that the composition of two modifications is given by $(f \cdot \mathbf{u}) \circ\left(f^{\prime} \cdot \mathbf{u}\right)=\left(f+f^{\prime}\right) \cdot \mathbf{u}$. Thus the modifications of $\mathbf{u}$ form a group. We denote this group by $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}$.

For the sake of simplicity, we formulate in this section several results only for irreducible $\mathbf{u}$ (see subsec. 4.2 for the definition of "irreducible"). However, in the course of this article we state and prove the results for general unipotent $\mathbf{u}$.

Theorem 2.0.1 (cf. Theorem 5.1.1). If $\mathbf{u}$ is irreducible, then the kernel of $p$ is the subgroup of modifications of $\mathbf{u}$ :

$$
\operatorname{ker} p=\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}
$$

The description of $\operatorname{Cent}(\mathbf{u})$ is special in the case when $\mathbf{u}$ is a translation, i.e. $\mathbf{u}(x, y, z)=(x+1, y, z)$ for suitable coordinates $(x, y, z)$. Note that $\mathbf{u}$ is a translation if and only if its plinth divisor $\Gamma$ is empty.

Proposition 2.0.2 (cf. Proposition 5.2.1). The unipotent automorphism u is a translation, if and only if there is a split short exact sequence

$$
1 \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u} \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}\right) \rightarrow 1
$$

In order to formulate the next results, we recall briefly some notion and facts of the theory of ind-groups (see [Kum02, ch. IV] for an introduction). A group $G$ is called an ind-group if it is endowed with a filtration by affine varieties $G_{1} \subseteq G_{2} \subseteq$ $\ldots$, each one closed in the next, such that $G=\bigcup_{i=1}^{\infty} G_{i}$ and such that the map $G \times G \rightarrow G,(x, y) \mapsto x \cdot y^{-1}$ is a morphism of ind-varieties. We endow $G$ with the following topology: $X \subseteq G$ is closed if and only if $X \cap G_{i}$ is closed in $G_{i}$ for each $i$. We call a subgroup $H$ of $G$ algebraic, if it is a closed subset of some $G_{i}$. An element $g \in G$ is called algebraic, if it is contained in some algebraic subgroup of $G$.

For example, $\operatorname{Aut}\left(\mathbb{C}^{n}\right)$ is an ind-group with the filtration $\operatorname{Aut}\left(\mathbb{C}^{n}\right)_{1} \subseteq \operatorname{Aut}\left(\mathbb{C}^{n}\right)_{2} \subseteq$ $\ldots$ where $\operatorname{Aut}\left(\mathbb{C}^{n}\right)_{i}$ is the set of all automorphisms of degree $\leq i$ (see [BCW82]). Then, $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is a closed subgroup of $\operatorname{Aut}\left(\mathbb{C}^{2}\right)$ (cf. Proposition 3.0.3). Examples of closed subgroups of $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$ are $\operatorname{Cent}(\mathbf{u})$ and ker $p$ (cf. Remark 5.1.1). As a last example, the group of modifications $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}$ is closed in $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$. Moreover, the homomorphism $\left(\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}},+\right) \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}, f \mapsto f \cdot \mathbf{u}$ is an isomorphism of ind-groups. In particular, the closure of $\langle\mathbf{u}\rangle$ in $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$ is the group $\mathbb{C} \cdot \mathbf{u}$ and thus $\mathbf{u}$ is an algebraic element of $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$.

Theorem 2.0.3 (cf. Theorem 5.6.1, 5.7.1 and Corollary 5.7.2). Assume that $\mathbf{u}$ is not a translation. Then
i) All elements in $\operatorname{Cent}(\mathbf{u})$ are algebraic.
ii) The set of unipotent elements $\operatorname{Cent}(\mathbf{u})_{u} \subseteq \operatorname{Cent}(\mathbf{u})$ is a closed normal subgroup.
iii) There exists an algebraic subgroup $R \subseteq \operatorname{Cent}(\mathbf{u})$ consisting only of semi-simple elements such that $\operatorname{Cent}(\mathbf{u}) \simeq \operatorname{Cent}(\mathbf{u})_{u} \rtimes R$ (as ind-groups). In particular, the connected component of the identity in $R$ is a torus.

The next result describes the group of unipotent elements Cent $(\mathbf{u})_{u}$. For this, we need the following terminology. We call the divisor $\Gamma=\sum_{i} n_{i} \Gamma_{i}$ in $\mathbb{C}^{2}$ a fence, if $\Gamma_{i} \simeq \mathbb{C}$ for all $i$ and the $\Gamma_{i}$ are pairwise disjoint.

Theorem 2.0.4 (cf. Proposition 5.5.1 and Theorem 5.7.1). Assume $\mathbf{u}$ is irreducible and not a translation. If the plinth divisor $\Gamma$ of $\mathbf{u}$
i) is not a fence, then $\operatorname{Cent}(\mathbf{u})_{u}=\operatorname{ker} p$.
ii) is a fence, then $\operatorname{Cent}(\mathbf{u})_{u} \simeq \operatorname{ker} p \rtimes \operatorname{Iner}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)_{u}$ (as ind-groups) where $\operatorname{Iner}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)_{u}$ is the subgroup of unipotent automorphisms in $\operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$ that are the identity on $\Gamma$ (cf. sec. 3 for an exact definition). Moreover, there exists an irreducible $\mathbf{e} \in \operatorname{Cent}(\mathbf{u})_{u}$ such that $p$ induces an isomorphism of ind-groups $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{u}, \mathbf{e}\rangle} \cdot \mathbf{e} \simeq \operatorname{Iner}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)_{u}$ where $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{u}, \mathbf{e}\rangle}$ is the subring of e-invariant polynomials inside $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$.

Let us give some explanation of the last result. If $\Gamma$ is not a fence, then the underlying variety cannot be a union of orbits of a non-trivial $\mathbb{C}^{+}$-action on $\mathbb{C}^{2}$. Hence, all unipotent automorphisms of $\operatorname{Cent}(\mathbf{u})$ induce the identity on the algebraic quotient and thus the first part of the result follows. So let us assume that $\Gamma$ is a non-empty fence. There exists a proper non-empty open subset $U \subseteq \mathbb{C}$ such that the algebraic quotient $\pi: \mathbb{C}^{3} \rightarrow \mathbb{C}^{3} / / \mathbf{u}$ fits into the following commutative diagram

where pr denotes the projection onto the first two factors (see Proposition 3.0.5 and [Fre06, Principle 11]). There exist coordinates $(u, v, w)$ of $(U \times \mathbb{C}) \times \mathbb{C}$ such that $\mathbf{u}$ restricted to $(U \times \mathbb{C}) \times \mathbb{C}$ is given by $(u, v, w) \mapsto(u, v, w+1)$. The automorphism $(u, v, w) \mapsto(u, v+1, w)$ of $(U \times \mathbb{C}) \times \mathbb{C}$ extends to an irreducible unipotent automorphism e on $\mathbb{C}^{3}$ that commutes with $\mathbf{u}$ (see subsec. 5.3). Thus, $\operatorname{Cent}(\mathbf{u})_{u}$ contains $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{u}, \mathbf{e}\rangle} \cdot \mathbf{e}$ beside $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}$. It is not hard to prove that $p$ induces an isomorphism $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{u}, \mathbf{e}\rangle} \cdot \mathbf{e} \simeq \operatorname{Iner}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)_{u}$. The difficulty lies in proving that $\operatorname{Cent}(\mathbf{u})_{u}$ is a group which is generated by $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{u}, \mathbf{e}\rangle} \cdot \mathbf{e}$ and $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}} \cdot \mathbf{u}$.
2.1. Applications. We present two applications of the structure theorems above. The first one concerns abstract group automorphisms $\operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Cent}(\mathbf{u})$.

Proposition 2.1.1 (cf. Proposition 6.0.4). If $\mathbf{u}$ is not a translation, then the subgroup $\operatorname{ker} p \subseteq \operatorname{Cent}(\mathbf{u})$ is characteristic, i.e. it is invariant under all abstract group automorphisms of $\operatorname{Cent}(\mathbf{u})$.

The second application concerns the plinth divisor $\Gamma$. The underlying variety $\Gamma_{\text {red }}$ has the following geometric description: The complement of $\Gamma_{\text {red }}$ is the maximal open subset of $\mathbb{C}^{3} / / \mathbf{u}$ such that the algebraic quotient $\pi: \mathbb{C}^{3} \rightarrow \mathbb{C}^{3} / / \mathbf{u}$ is a locally trivial principal $\mathbb{C}^{+}$-bundle over it (see [DK14, Proposition 5.4]). So far - to the author's knowledge - there is no geometric description of the scheme $\Gamma$. But in the case when $\Gamma$ is a non-empty fence and $\mathbf{u}$ is irreducible we can give one.

Proposition 2.1.2 (cf. Proposition 6.0.3). If $\mathbf{u}$ is irreducible and $\Gamma$ is a non-empty fence, then $\Gamma$ is the largest closed subscheme of $\mathbb{C}^{3} / / \mathbf{u}$ fixed by $\operatorname{Cent}(\mathbf{u})_{u}$.

## 3. Automorphisms of $\mathbb{C}^{2}$ that preserve a divisor

Let $\Gamma \subseteq \mathbb{C}^{2}$ be an effective divisor. Then there exists $a \in \mathcal{O}\left(\mathbb{C}^{2}\right)$ such that $\Gamma=$ $\operatorname{div}(a)\left(a\right.$ is uniquely determined up to elements of $\left.\mathbb{C}^{*}\right)$. We denote by $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ the subgroup of all $\mathrm{g} \in \operatorname{Aut}\left(\mathbb{C}^{2}\right)$ such that the comorphism $\mathrm{g}^{*}: \mathcal{O}\left(\mathbb{C}^{2}\right) \rightarrow \mathcal{O}\left(\mathbb{C}^{2}\right)$ sends the principal ideal $(a)$ onto itself. Moreover, we denote by $\operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right)$ the
subgroup of all $\mathbf{g} \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ such that $\mathbf{g}$ is the identity on the divisor $\Gamma$, i.e. we have a commutative diagram


Clearly, we get an exact sequence

$$
1 \rightarrow \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right) \hookrightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \rightarrow \operatorname{Aut}(\Gamma)
$$

The next result uses heavily the main result in [BS13].
Proposition 3.0.3. Let $\Gamma$ be a non-trivial effective divisor of $\mathbb{C}^{2}$. Then
i) The subgroup $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \subseteq \operatorname{Aut}\left(\mathbb{C}^{2}\right)$ is closed and all elements of $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ are algebraic.
ii) The following statements are equivalent
a) $\Gamma$ is a fence
b) $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ contains unipotent automorphisms $\neq \mathbf{i d}$.
c) $\operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right) \neq\{\mathbf{i d}\}$
d) $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is not an algebraic group

For the proof of this proposition we recall some facts about Aut $\left(\mathbb{C}^{2}\right)$. The next result is a direct consequence of [BS13, Theorem 1].

Theorem 3.0.4. An automorphism of $\mathbb{C}^{2}$ that preserves an algebraic curve is conjugate to a triangular automorphism.

In the next result we prove a slightly more general version of the Abhyankar-Moh-Suzuki-Theorem which says that all closed embeddings $\mathbb{C} \hookrightarrow \mathbb{C}^{2}$ are equivalent up to automorphisms of $\mathbb{C}^{2}$ (see [AM75]).
Proposition 3.0.5. Let $\Gamma$ be a fence in $\mathbb{C}^{2}$ and let $F \subseteq \mathbb{C}$ be a closed 0-dimensional subscheme such that $\Gamma \simeq F \times \mathbb{C}$. Then there exists an automorphism of $\mathbb{C}^{2}$ that maps $\Gamma$ onto $F \times \mathbb{C}$ (scheme-theoretically).
Proof. Clearly, we can assume that $\Gamma \neq \varnothing$. Moreover, we can easily reduce to the case, where $\Gamma$ is a reduced scheme. Let $\Gamma_{i}, i \in I$ be the irreducible components of $\Gamma$. Let $i_{0} \in I$ be fixed. By the Abhyankar-Moh-Suzuki-Theorem, there exists a trivial $\mathbb{C}$-bundle $f: \mathbb{C}^{2} \rightarrow \mathbb{C}$ such that $\Gamma_{i_{0}}$ is a fiber of $f$. Now, if the restriction $\left.f\right|_{\Gamma_{i}}: \Gamma_{i} \rightarrow \mathbb{C}$ is non-constant, then it is surjective, since $\Gamma_{i} \simeq \mathbb{C}$. But this implies that $\Gamma_{i} \cap \Gamma_{i_{0}} \neq \varnothing$, a contradiction. Thus every $\Gamma_{i}$ is a fiber of $f$. This implies the proposition.

Proof of Proposition 3.0.3.
i) Assume that $\Gamma=\operatorname{div}(a)$ for some non-zero $a \in \mathcal{O}\left(\mathbb{C}^{2}\right)=\mathbb{C}[x, y]$. For $\left(f_{1}, f_{2}\right) \in$ $\mathbb{C}[x, y]^{2}$ we denote by $a_{i j}\left(f_{1}, f_{2}\right)$ the coefficient of the monomial $x^{i} y^{j}$ in the polynomial $a\left(f_{1}, f_{2}\right)$. The subgroup $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ of $\operatorname{Aut}\left(\mathbb{C}^{2}\right)$ is defined by the equations

$$
a_{i j}\left(f_{1}, f_{2}\right) a_{k l}(x, y)=a_{k l}\left(f_{1}, f_{2}\right) a_{i j}(x, y) \quad \text { for all pairs }(i, j),(k, l)
$$

This proves the first statement.

Let $\mathbf{g} \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$. By Theorem 3.0.4, $\mathbf{g}$ is conjugate to a triangular automorphism and hence $\mathbf{g}$ is algebraic. This proves the second statement. ii) $a) \Rightarrow b$ ): This follows immediately form Proposition 3.0.5.
$b) \Rightarrow c)$ : Let $\mathrm{g} \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ be a unipotent automorphism $\neq \mathrm{id}$. Choose some $a \in \mathcal{O}\left(\mathbb{C}^{2}\right)$ such that $\Gamma=\operatorname{div}(a)$. As $\mathbf{g}$ preserves $\Gamma$, it follows that $a$ is a semi-invariant for the $\mathbb{C}^{+}$-action on $\mathbb{C}^{2}$ induced by g . Since $\mathbb{C}^{+}$has no non-trivial character, $a$ is an invariant. Hence, $\mathbf{i d} \neq a \cdot \mathbf{g} \in \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right)$.
$c) \Rightarrow d)$ : Let $\mathbf{g} \in \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right)$ with $\mathbf{g} \neq \mathbf{i d}$. By Theorem 3.0.4, $\mathbf{g}$ preserves a trivial $\mathbb{C}$-bundle $f: \mathbb{C}^{2} \rightarrow \mathbb{C}$. Let $\Gamma_{i}, i \in I$ be the irreducible components of the reduced scheme $\Gamma_{\text {red }}$. If every $\Gamma_{i}$ lies in a fiber of $f$, then $\Gamma$ is a fence and thus Aut $\left(\mathbb{C}^{2}, \Gamma\right)$ is not an algebraic group. Therefore we can assume that $f\left(\Gamma_{i}\right) \subseteq \mathbb{C}$ is dense for some $i$. As $\mathbf{g}$ is the identity on $\Gamma_{i}$, it follows that $\mathbf{g}$ maps each fiber on itself. Hence, there exists $\alpha \in \mathbb{C}^{*}$ and a polynomial $b(y)$ such that for each $y \in \mathbb{C}$ the restriction of $\mathbf{g}$ to the fiber $f^{-1}(y)$ is given by

$$
\mathbf{g}_{y}: \mathbb{C} \rightarrow \mathbb{C}, \quad x \mapsto \alpha x+b(y)
$$

As $\mathbf{g}$ is the identity on $\Gamma_{i}$, it follows that $\mathbf{g}_{y}$ has a fixed point for all $y \in f\left(\Gamma_{i}\right)$. If $\alpha=1$, then $\mathbf{g}_{y}$ is the identity map for all $y \in f\left(\Gamma_{i}\right) \subseteq \mathbb{C}$. Since $f\left(\Gamma_{i}\right)$ is dense in $\mathbb{C}$ we get a contradiction to the fact that $\mathbf{g} \neq \mathbf{i d}$. Thus, $\alpha \neq 1$. But this implies that $\mathbf{g}_{y}$ has exactly one fixed point for each $y \in \mathbb{C}$. Thus, $\Gamma_{i}=V(a x+b(y)-x) \simeq \mathbb{C}$ and it is the only irreducible component of $\Gamma_{\text {red }}$. Therefore, $\Gamma$ is again a fence and $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is not an algebraic group.
$d) \Rightarrow a)$ : Assume that $\Gamma$ is not a fence. By $\left[\mathrm{BS} 13\right.$, Theorem 1], $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma_{\text {red }}\right)$ is an algebraic group. Now, $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is an algebraic group as well, since it is a closed subgroup of $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma_{\text {red }}\right)$.

## 4. Some elementary facts

4.1. Locally nilpotent derivations. Let $A$ be a $\mathbb{C}$-algebra and assume it is a unique factorization domain (UFD). Let $D$ be a $\mathbb{C}$-derivation of $A$. Then, $D$ is called locally nilpotent, if for every $f \in A$ there exists an integer $n=n(f)$ such that $D^{n}(f)=0$. Moreover, $D$ is called irreducible, if $D \neq 0$ and the following holds: if $D=f D^{\prime}$ for some locally nilpotent derivation $D^{\prime}$ and some $f \in \operatorname{ker} D$, then $f \in A^{*}$ where $A^{*}$ denotes the subgroup of units of $A$.

We list some basic facts about locally nilpotent derivations, that we will use constantly (see [Fre06] for proofs).

Lemma 4.1.1. Let $A$ be a $\mathbb{C}$-algebra and assume it is a UFD, and let $D$ be a locally nilpotent derivation of $A$. Then
i) The units of $A$ lie in $\operatorname{ker} D$. In particular, $\mathbb{C} \subseteq \operatorname{ker} D$.
ii) The kernel $\operatorname{ker} D$ is factorially closed in $A$, i.e. if $f, g \in A$ such that $f g \in \operatorname{ker} D$, then $f, g \in \operatorname{ker} D$.
iii) If $S \subseteq \operatorname{ker} D$ is a multiplicative system, then $D$ extends uniquely to a locally nilpotent derivation of the localization $A_{S}$.
iv) If $D \neq 0$, then there exists $f \in A$ such that $D(f) \in \operatorname{ker} D$ and $D(f) \neq 0$.
$v)$ If $s \in A$ such that $D(s)=1$, then $A$ is a polynomial ring in $s$ over $\operatorname{ker} D$ and $D=\partial / \partial s$.
vi) For $f \in A$, the derivation $f D$ is locally nilpotent if and only if $f \in \operatorname{ker} D$.
vii) If $D$ is irreducible and $E$ is another locally nilpotent derivation of $A$ such that $E(\operatorname{ker} D)=0$, then there exists $f \in \operatorname{ker} D$ such that $E=f D$.
viii) If $D \neq 0$, then there exists a unique irreducible locally nilpotent derivation $D_{0}$ (up to multiplication by some element of $A^{*}$ ) such that $\operatorname{ker} D=\operatorname{ker} D_{0}$.
ix) If $D(f) \in f A$, then $D(f)=0$.
x) The exponential $\exp (D)=\sum_{i=0}^{\infty} D^{i} / i$ ! is a $\mathbb{C}$-algebra automorphism of $A$ and the map exp defines an injection from the set of locally nilpotent derivations of $A$ to the set of $\mathbb{C}$-algebra automorphisms of $A$.
4.2. Uniptent automorphisms of $\mathbb{C}^{3}$. Let $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be a unipotent automorphism. We call $\mathbf{u}$ irreducible if the corresponding locally nilpotent derivation is irreducible. If $\mathbf{u} \neq \mathbf{i d}$, there exists an irreducible $\mathbf{u}_{0} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ such that $\mathbf{u}$ is the modification $d \cdot \mathbf{u}_{0}$ for some $0 \neq d \in \operatorname{ker} D$. The automorphism $\mathbf{u}_{0}$ is unique up to a modification by some element in $\mathbb{C}^{*}$ (cf. subsec. 4.1). We call then

$$
\mathbf{u}=d \cdot \mathbf{u}_{0}
$$

a standard decomposition.
Now, let $\mathbf{u}, \mathbf{u}^{\prime}$ be unipotent automorphisms of $\mathbb{C}^{3}$ such that there exists $0 \neq f \in$ $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$ with $\mathbf{u}=f \cdot \mathbf{u}^{\prime}$. If $\rho$ and $\rho^{\prime}$ denote the $\mathbb{C}^{+}$-actions on $\mathbb{C}^{3}$ corresponding to $\mathbf{u}$ and $\mathbf{u}^{\prime}$ respectively, then the orbits of $\rho$ are contained in the orbits of $\rho^{\prime}$ and the orbits are equal on the principal open set $\left(\mathbb{C}^{3}\right)_{f}$. Moreover, if $\mathbf{u}=\operatorname{Exp}(D)$ and $\mathbf{u}^{\prime}=\operatorname{Exp}\left(D^{\prime}\right)$, then $\operatorname{im} D=f \operatorname{im} D^{\prime} \subseteq \mathcal{O}\left(\mathbb{C}^{3}\right)$ and the plinth divisors $\Gamma, \Gamma^{\prime}$ of $\mathbf{u}, \mathbf{u}^{\prime}$ satisfy

$$
\Gamma=\Gamma^{\prime}+\operatorname{div}(f)
$$

Whenever $S$ is a subset of $\operatorname{Aut}\left(\mathbb{C}^{n}\right)$ we denote by $S_{u}$ the subset of unipotent automorphisms in $S$.

## 5. Structure theorems for $\operatorname{Cent}(\mathbf{u})$

5.1. The first unipotent subgroup in $\operatorname{Cent}(\mathbf{u})$. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent and let $\mathbf{u}=d \cdot \mathbf{u}_{0}$ be a standard decomposition. There exists an obvious subgroup of unipotent automorphisms in $\operatorname{Cent}(\mathbf{u})$ : The modifications of $\mathbf{u}_{0}$, i.e. the subgroup $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$. This subgroup has another characterization:

Proposition 5.1.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent with standard decomposition $\mathbf{u}=d \cdot \mathbf{u}_{0}$. The subgroup $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ consists of those automorphisms of $\mathbb{C}^{3}$ that commute with $\mathbf{u}$ and that induce the identity on $\mathbb{C}^{3} / / \mathbf{u}$, i.e. the sequence

$$
1 \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right) \cap \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma_{0}\right)
$$

is exact, where $\Gamma, \Gamma_{0}$ denote the plinth divisors of $\mathbf{u}, \mathbf{u}_{0}$ respectively. Moreover, the homomorphisms in the sequence above are homomorphisms of ind-groups.

This result is an immediate consequence of Remark 5.1.1 and Lemma 5.1.2.
Remark 5.1.1. Choose generators $v_{1}, v_{2}$ of the polynomial ring $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$ and choose a $\mathbb{C}$-linear retraction $r: \mathcal{O}\left(\mathbb{C}^{3}\right) \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$. The map $p: \operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$ is a morphism of ind-varieties due to the following commutative diagram


Lemma 5.1.2. Let $A$ be $a \mathbb{C}$-algebra and assume it is a $U F D$, let $B, B^{\prime}$ be non-zero locally nilpotent derivations of $A$ such that $B^{\prime}$ is irreducible and $\operatorname{ker} B=\operatorname{ker} B^{\prime}$. If $\varphi: A \rightarrow A$ is a $\mathbb{C}$-algebra automorphism, then we have

$$
\left.\varphi\right|_{\operatorname{ker} B}=\text { id } \text { and } \varphi \circ B=B \circ \varphi \quad \text { if and only if } \varphi=\exp \left(f B^{\prime}\right), f \in \operatorname{ker} B
$$

Proof. Assume that $\left.\varphi\right|_{\operatorname{ker} B}$ is the identity and $\varphi$ commutes with $B$. There exists $0 \neq d \in \operatorname{ker} B$, such that $A_{d}=\operatorname{ker}(B)_{d}[s]$ is a polynomial ring in an element $s \in A_{d}$ and $B(s)=1$, if we extend $B$ to $A_{d}$. Since $\varphi$ commutes with $B$ there exists $g \in \operatorname{ker}(B)_{d}$ such that the extension $\tilde{\varphi}$ to $A_{d}$ of $\varphi$ satisfies $\tilde{\varphi}(s)=s+g$. Now, we have $\varphi=\left.\exp (g B)\right|_{A}$. A density argument shows that $\exp (\operatorname{tg} B)(A) \subseteq A$ for all $t \in \mathbb{C}$. Since

$$
g B=\left.\frac{\exp (t g B)-\mathrm{id}}{t}\right|_{t=0},
$$

we have $g B(A) \subseteq A$. Hence $g B$ is a locally nilpotent derivation of $A$ that vanishes on ker $B=\operatorname{ker} B^{\prime}$. Thus, $g B=f B^{\prime}$ for some $f \in \operatorname{ker} B$. The converse is clear.

Remark 5.1.2. By Proposition 5.1.1, Cent $(\mathbf{u})$ normalizes $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ and one can easily see, that the action is given by

$$
\mathbf{g}^{-1} \circ f \cdot \mathbf{u}_{0} \circ \mathbf{g}=\mu(\mathbf{g}) \mathbf{g}^{*}(f) \cdot \mathbf{u}_{0}, \quad \mathbf{g} \in \operatorname{Cent}(\mathbf{u}), f \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}}
$$

where $\mu: \operatorname{Cent}(\mathbf{u}) \rightarrow \mathbb{C}^{*}$ is the homomorphism given by $\mu(\mathbf{g}) d=\mathbf{g}^{*}(d)$.
5.2. Centralizer of a modified translation in $\operatorname{Aut}\left(\mathbb{C}^{3}\right)$.

Proposition 5.2.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be a modified translation with standard decomposition $\mathbf{u}=d \cdot \mathbf{u}_{0}$. Denote by $\Gamma$ the plinth divisor of $\mathbf{u}$. Then

$$
1 \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{p} \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right) \rightarrow 1
$$

is a split short exact sequence of ind-groups. Moreover, there exists a closed subgroup of $\operatorname{Cent}(\mathbf{u})$ that is mapped via $p$ isomorphically onto $\operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$.
Remark 5.2.1. Under the assumptions of Proposition 5.2.1, Cent(u) consists only of algebraic elements, provided that $\Gamma$ is non-empty. Indeed, let $H \subseteq \operatorname{Cent}(\mathbf{u})$ be a closed subgroup, such that $p$ induces an isomorphism $H \simeq \operatorname{Aut}\left(\mathbb{C}^{3} / / \mathbf{u}, \Gamma\right)$. Let $\left(f \cdot \mathbf{u}_{0}, \mathbf{h}\right) \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \rtimes H \simeq \operatorname{Cent}(\mathbf{u})$. By Proposition 3.0.3 i), $R=\overline{\langle\mathbf{h}\rangle}$ is an algebraic subgroup of $H$. Hence

$$
W=\operatorname{span}\left\{\mathbf{r}^{*}(f) \mid \mathbf{r} \in R\right\}
$$

is a finite dimensional subspace of $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}}$ and $W \cdot \mathbf{u}_{0} \rtimes R \subseteq \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \rtimes H$ is an algebraic subgroup that contains $\left(f \cdot \mathbf{u}_{0}, \mathbf{h}\right)$ (see Remark 5.1.2).
Proof of Proposition 5.2.1. By Proposition 5.1.1, the sequence is left exact. By assumption, there exist coordinates $(x, y, z)$ on $\mathbb{C}^{3}$ such that $d \in \mathbb{C}[y, z]$ and $\mathbf{u}=(x+$ $d, y, z)$. Moreover, we can identify the algebraic quotient $\pi: \mathbb{C}^{3} \rightarrow \mathbb{C}^{3} / / \mathbf{u}=\mathbb{C}^{2}$ with the map $(x, y, z) \mapsto(y, z)$ and $\Gamma=\operatorname{div}(d)$. Let $\mathbf{f} \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$. Then $\mathbf{f}^{*}(d)=\lambda(\mathbf{f}) d$ for some $\lambda(\mathbf{f}) \in \mathbb{C}^{*}$. One can see that $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \rightarrow \mathbb{C}^{*}, \mathbf{f} \mapsto \lambda(\mathbf{f})$ is a homomorphism of ind-groups. Thus
$H=\left\{\sigma \in \operatorname{Aut}\left(\mathbb{C}^{3}\right) \mid \sigma(x, y, z)=(\lambda x, \mathbf{f}(y, z))\right.$ with $\mathbf{f} \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ and $\left.\lambda(\mathbf{f})=\lambda\right\}$
is a closed subgroup of $\operatorname{Cent}(\mathbf{u})$ (note that the subgroup $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \subseteq \operatorname{Aut}\left(\mathbb{C}^{2}\right)$ is closed by Proposition 3.0.3) and $\left.p\right|_{H}: H \rightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is an isomorphism of ind-groups.

Proposition 5.2.2. Let $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent. Then $\operatorname{Cent}(\mathbf{u})$ contains $\left(\mathbb{C}^{*}\right)^{2}$ as an algebraic subgroup if and only if $\mathbf{u}$ is a modified translation and the plinth divisor $\Gamma$ is given by $v^{i} w^{j}$ for some coordinates $(v, w)$ of $\mathbb{C}^{3} / / \mathbf{u} \simeq \mathbb{C}^{2}$.
Proof. Assume that Cent $(\mathbf{u})$ contains an algebraic subgroup $T \simeq\left(\mathbb{C}^{*}\right)^{2}$. By Proposition 5.2 .1 it follows that $T$ acts faithfully on $\mathbb{C}^{3} / / \mathbf{u}$ and preserves the plinth divisor $\Gamma$. Hence, it follows from $[\mathrm{BB} 66]$ that there exist coordinates $(v, w)$ on $\mathbb{C}^{2} \simeq \mathbb{C}^{3} / / \mathbf{u}$ such that $\Gamma$ is given by $v^{i} w^{j}$ for some integers $i, j$. By [BB67] there exist coordinates $\left(x_{1}, x_{2}, x_{3}\right)$ of $\mathbb{C}^{3}$ such that the action of $T$ is diagonal with respect to these coordinates. Hence there exist characters $\lambda_{1}, \lambda_{2}, \lambda_{3}$ of $T$ such that $\mathbf{t}\left(x_{1}, x_{2}, x_{3}\right)=\left(\lambda_{1}(\mathbf{t}) x_{1}, \lambda_{2}(\mathbf{t}) x_{2}, \lambda_{3}(\mathbf{t}) x_{3}\right)$ for all $\mathbf{t} \in T$. Let $\mathbf{u}=\operatorname{Exp}(D)$. By assumption we have for all $\mathbf{t} \in T$ and $i=1,2,3$

$$
\begin{equation*}
D\left(x_{i}\right) \circ \mathbf{t}=\lambda_{i}(\mathbf{t}) D\left(x_{i}\right) . \tag{2}
\end{equation*}
$$

As the action of $T$ on $\mathbb{C}^{3}$ is faithful, the subgroup spanned by $\lambda_{1}, \lambda_{2}, \lambda_{3}$ inside the characters of $T$ has rank 2 . Assume first that the $\lambda_{i}$ are pairwise different. Then there exist at least two different indices $k_{1}, k_{2} \in\{1,2,3\}$ such that $\lambda_{k_{i}}$ lies not in the monoid spanned by $\left\{\lambda_{l} \mid l \neq k_{i}\right\}$. By symmetry we can assume $k_{1}=1$, $k_{2}=2$. This implies that $D\left(x_{i}\right) \in x_{i} \mathbb{C}\left[x_{1}, x_{2}, x_{3}\right]$ for $i=1,2$. Since $D$ is locally nilpotent we have $D\left(x_{1}\right)=D\left(x_{2}\right)=0$. Hence, $\mathbf{u}$ is a modified translation. Assume now that $\lambda_{1}=\lambda_{2} \neq \lambda_{3}$ (the other cases follow by symmetry). Thus, $\lambda_{3}$ does not lie in the monoid spanned by $\lambda_{1}$ and $\lambda_{2}$. Hence we get $D\left(x_{3}\right) \in x_{3} \mathbb{C}\left[x_{1}, x_{2}, x_{3}\right]$ and $D\left(x_{1}\right), D\left(x_{2}\right) \in \mathbb{C} x_{1} \oplus \mathbb{C} x_{2}$. Since $D$ is locally nilpotent it follows that $D\left(x_{3}\right)=0$ and the linear endomorphism $\left.D\right|_{\mathbb{C} x_{1} \oplus \mathbb{C} x_{2}}$ is nilpotent. This implies that $\mathbf{u}$ is a modified translation.

The converse of the statement is clear.
5.3. The second unipotent subgroup in $\operatorname{Cent}(\mathbf{u})$. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent with standard decomposition $\mathbf{u}=d \cdot \mathbf{u}_{0}$. Throughout this subsection we assume that the plinth divisor $\Gamma=\operatorname{div}(a)$ of $\mathbf{u}$ is a fence. There exists another subgroup of unipotent automorphisms inside $\operatorname{Cent}(\mathbf{u})$ in addition to $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$, that we describe in this subsection.

Lemma 5.3.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent. If the plinth divisor $\Gamma=\operatorname{div}(a)$ is a fence, then there exists a variable $z$ of $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}=\mathcal{O}\left(\mathbb{C}^{2}\right)$ such that $a \in \mathbb{C}[z]$ and any such $z$ is a variable of $\mathcal{O}\left(\mathbb{C}^{3}\right)$.
Proof. By Proposition 3.0.5 there exists a coordinate system $(z, w)$ of $\mathbb{C}^{2}$ such that the embedding $\operatorname{div}(a)=\Gamma \subseteq \mathbb{C}^{2}$ is given by the standard embedding $F \times \mathbb{C} \subseteq \mathbb{C}^{2}$ for some 0 -dimensional closed subscheme $F$ of $\mathbb{C}$. Thus $a \in \mathbb{C}[z]$. Since the quotient $\operatorname{map} \pi: \mathbb{C}^{3} \rightarrow \mathbb{C}^{3} / / \mathbf{u}$ is a trivial $\mathbb{C}$-bundle over $\mathbb{C}^{2} \backslash \Gamma$, it follows that only finitely many fibers of $z: \mathbb{C}^{3} \rightarrow \mathbb{C}$ are non-isomorphic to $\mathbb{C}^{2}$. Thus $z$ is a variable of $\mathcal{O}\left(\mathbb{C}^{3}\right)$, according to Kaliman's Theorem [Kal02].

Remark 5.3.1. If $\mathbf{u}=\operatorname{Exp}(D)$ is irreducible, then $\Gamma$ is a fence if and only if $\operatorname{rank} D \leq$ 2 (i.e. there exists a variable $z$ of $\mathcal{O}\left(\mathbb{C}^{3}\right)$ that lies in $\operatorname{ker} D$ ). This follows from the lemma above and from [DF98, Theorem 2.4, Proposition 2.3].

Definition 5.3.2. Let $A$ be a UFD and let $P \in A[x, y]$. We denote

$$
\Delta_{P}=-P_{y} \frac{\partial}{\partial x}+P_{x} \frac{\partial}{\partial y}
$$

where $P_{x}$ and $P_{y}$ denote the partial derivatives of $P$ with respect to $x$ and $y$ respectively. Obviously, $\Delta_{P}$ is an $A$-derivation of $A[x, y]$ and $\Delta_{P}(P)=0$.

Let $D, D_{0}$ be locally nilpotent derivations of $\mathcal{O}\left(\mathbb{C}^{3}\right)$ such that $\mathbf{u}=\operatorname{Exp}(D)$ and $\mathbf{u}_{0}=\operatorname{Exp}\left(D_{0}\right)$. Let $z \in \operatorname{ker} D$ be a variable such that $a \in \mathbb{C}[z]$ and let $(x, y, z)$ be a coordinate system of $\mathcal{O}\left(\mathbb{C}^{3}\right)$ (see Lemma 5.3.1). Let $A=\mathbb{C}[z]$. It follows now from [DF98, Theorem 2.4] that there exists $P \in A[x, y]$ such that

$$
D_{0}=\Delta_{P} \quad \text { and } \quad \operatorname{ker} D=\operatorname{ker} D_{0}=\mathbb{C}[z, P]
$$

Obviously, $d$ divides $a$ in $\mathbb{C}[z]$. Let $a=d a_{0}$. An easy calculation shows that $\operatorname{div}\left(a_{0}\right)$ is the plinth divisor of $\mathbf{u}_{0}$ and that for all $Q \in A[x, y]$ we have

$$
\begin{equation*}
D(Q)=a \quad \text { if and only if } \quad D_{0}(Q)=a_{0} \tag{3}
\end{equation*}
$$

By assumption $\Gamma=\operatorname{div}(a)$ is a fence and thus $a, a_{0} \neq 0$.
Lemma 5.3.2. Let $A=\mathbb{C}[z]$. If $Q \in A[x, y]$ such that $D(Q)=a$, then $E=\Delta_{Q}$ is an irreducible locally nilpotent derivation. Moreover, $E$ commutes with $D$.

Proof. Let $K$ be the quotient field of $A$. The extension of $D_{0}$ to $K[x, y]$ satisfies $D_{0}\left(Q / a_{0}\right)=1$. Thus $K[x, y]=K[P, Q]$. $E$ is non-zero, since $E(P)=-a_{0} \neq 0$. If we extend $E$ to a derivation of $K[x, y]$ one easily sees that $E$ is locally nilpotent. Thus $E$ is a non-zero locally nilpotent derivation of $A[x, y]$.

By [DF98, Theorem 2.4, Proposition 2.3]) there exists $S \in A[x, y]$ and $0 \neq h \in$ $A[P]$ such that $E=h \Delta_{S}$ and $\Delta_{S}$ is irreducible. Thus $-a_{0}=E(P)=h \Delta_{S}(P)=$ $-h \Delta_{P}(S)$. Hence $\Delta_{P}(S)$ lies in the plinth ideal of $\Delta_{P}$ and thus $\Delta_{P}(S)$ is a multiple of $a_{0}$. This implies that $h \in \mathbb{C}^{*}$ and proves that $E$ is irreducible.

If we extend $\Delta_{P}$ and $\Delta_{Q}$ to $K[x, y]=K[P, Q]$, we get $\Delta_{P}=a_{0}(\partial / \partial Q)$ and $\Delta_{Q}=-a_{0}(\partial / \partial P)$. Thus $E$ commutes with $D_{0}$. Since $d \in \mathbb{C}[z], E$ and $D=d D_{0}$ commute.

Definition 5.3.3. For any $Q \in \mathcal{O}\left(\mathbb{C}^{3}\right)$ with $D(Q)=a$ we call

$$
\mathbf{e}=\operatorname{Exp}(E)=\operatorname{Exp}\left(\Delta_{Q}\right)
$$

an admissible complement to $\mathbf{u}$.
By (3), we get that $\mathbf{e}$ is an admissible complement to $\mathbf{u}$ if and only if $\mathbf{e}$ is an admissible complement to $\mathbf{u}_{0}$. It follows from Lemma 5.3.2 that $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{e}, \mathbf{u}\rangle} \cdot \mathbf{e}$ is a subgroup of unipotent automorphisms inside Cent(u).

Remark 5.3.4. We have $\mathbb{C}^{2} \backslash \Gamma=U \times \mathbb{C}$ for some non-empty open subset $U \subseteq \mathbb{C}$. The restriction of $\mathbf{u}$ and of $\mathbf{e}$ to the open subset

$$
\pi^{-1}\left(\mathbb{C}^{2} \backslash \Gamma\right)=(U \times \mathbb{C}) \times \mathbb{C}=\operatorname{Spec}\left(\mathbb{C}[z]_{a}[P, Q]\right)
$$

are given by $(u, v, w) \mapsto(u, v, w+1)$ and $(u, v, w) \mapsto(u, v+1, w)$ respectively, where $(u, v, w)$ is the coordinate system $\left(z,-P / a_{0}, Q / a\right)$.
5.4. The property (Sat). We introduce in this subsection a property for a subset $S \subseteq \operatorname{Aut}\left(\mathbb{C}^{n}\right)$ and we will show that Cent $(\mathbf{v})$ satisfies this property for any unipotent automorphism $\mathbf{v} \in \operatorname{Aut}\left(\mathbb{C}^{n}\right)$. This property will then play a key role when we describe the set of unipotent elements inside the centralizer. One can think of this property as a saturation feature on the unipotent elements in $S$.

Definition 5.4.1. Let $S \subseteq \operatorname{Aut}\left(\mathbb{C}^{n}\right)$ be a subset. We say that $S$ has the property (Sat) if for all unipotent $\mathbf{w} \in \operatorname{Aut}\left(\mathbb{C}^{n}\right)$ and for all $0 \neq f \in \mathcal{O}\left(\mathbb{C}^{n}\right)^{\mathbf{w}}$ we have

$$
\begin{equation*}
f \cdot \mathbf{w} \in S \quad \Longrightarrow \quad \mathbf{w} \in S \tag{Sat}
\end{equation*}
$$

Proposition 5.4.1. If $\mathbf{v} \in \operatorname{Aut}\left(\mathbb{C}^{n}\right)$ is unipotent, then the subgroup $\operatorname{Cent}(\mathbf{v}) \subseteq$ Aut $\left(\mathbb{C}^{n}\right)$ satisfies the property (Sat).
Proof. Let $\mathbf{v}=\operatorname{Exp}(B)$ and let $\mathbf{w}=\operatorname{Exp}(F)$. Assume that $f \cdot \mathbf{w}$ commutes with $\mathbf{v}$ for some $\mathbf{w}$-invariant $0 \neq f \in \mathcal{O}\left(\mathbb{C}^{n}\right)$. If $\mathbf{v}=\mathbf{i d}$ or $\mathbf{w}=\mathbf{i d}$, then (Sat) is obviously satisfied. Thus we assume $\mathbf{v} \neq \mathbf{i d} \neq \mathbf{w}$. For the Lie-bracket we have

$$
\begin{equation*}
0=[f F, B]=f[F, B]-B(f) F \tag{4}
\end{equation*}
$$

Thus, it is enough to prove that $B(f)=0$.
First, assume that $F$ is irreducible. By (4), it follows that $f$ divides $B(f) F(g)$ for all $g \in \mathcal{O}\left(\mathbb{C}^{n}\right)$. As $F$ is irreducible, it follows that $f$ divides $B(f)$. Since $B$ is locally nilpotent, it follows that $B(f)=0$.

Now, let $F=f^{\prime} F^{\prime}$ for some irreducible $F^{\prime}$. Thus, $f f^{\prime} F^{\prime}$ commutes with $B$ and by the argument above, $B\left(f f^{\prime}\right)=0$. Since ker $B$ is factorially closed in $\mathcal{O}\left(\mathbb{C}^{n}\right)$, we have $B(f)=0$.
5.5. The subgroup $N \subseteq \operatorname{Cent}(\mathbf{u})$. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent. We define in this subsection a subgroup $N$ of $\operatorname{Cent}(\mathbf{u})$ and we gather some facts about this group. In the next subsection, we will prove that $N$ is exactly the set of unipotent automorphisms $\operatorname{Cent}(\mathbf{u})$ if $\mathbf{u}$ is not a translation.

Definition 5.5.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent with standard decomposition $\mathbf{u}=d \cdot \mathbf{u}_{0}$ and let $\Gamma$ be the plinth divisor of $\mathbf{u}$. Let

$$
N=N(\mathbf{u})=\left\{\begin{aligned}
\mathcal{O}\left(\mathbb{C}^{3}\right)^{\left\langle\mathbf{e}, \mathbf{u}_{0}\right\rangle} \cdot \mathbf{e} \circ \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} & \text { if } \Gamma \text { is a fence } \\
\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} & \text { otherwise }
\end{aligned}\right.
$$

where $\mathbf{e}$ is an admissible complement to $\mathbf{u}$ (cf. subsec. 5.3). Moreover, let

$$
M=M(\mathbf{u})=\left\{\begin{aligned}
\left(\operatorname{ker} E \cap \operatorname{ker} D_{0}\right) E+\operatorname{ker}\left(D_{0}\right) D_{0} & \text { if } \Gamma \text { is a fence } \\
\operatorname{ker}\left(D_{0}\right) D_{0} & \text { otherwise }
\end{aligned}\right.
$$

where $\mathbf{u}_{0}=\operatorname{Exp}\left(D_{0}\right)$ and $\mathbf{e}=\operatorname{Exp}(E)$ (cf. Lemma 5.3.2)
Proposition 5.5.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent and assume it is not $a$ translation. Then:
i) $N$ consists of unipotent automorphisms and we have $N=\operatorname{Exp}(M)$.
ii) $N$ normalizes $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ and we have for all $\mathbf{g} \in N$ and for all $f \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}}$

$$
\mathbf{g}^{-1} \circ f \cdot \mathbf{u}_{0} \circ \mathbf{g}=\mathbf{g}^{*}(f) \cdot \mathbf{u}_{0}
$$

iii) $N$ is a closed normal subgroup of $\operatorname{Cent}(\mathbf{u})$ that fits into the following split short exact sequence of ind-groups

$$
1 \rightarrow \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \hookrightarrow N \xrightarrow{\left.p\right|_{N}} \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \cap \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma_{0}\right)_{u} \rightarrow 1
$$

where $\Gamma_{0}$ is the plinth divisor of $\mathbf{u}_{0}$. If $\Gamma$ is a fence, then the restriction of $p$ to $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\left\langle\mathbf{u}_{0}, \mathbf{e}\right\rangle} \cdot \mathbf{e}$ is an isomorphism of ind-groups. In particular, $N$ is independent of the choice of $\mathbf{e}$.
iv) $N \subseteq \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ satisfies the property (Sat).

Proof. Assume first that $\Gamma$ is not a fence. Then i) ii) and iv) are clear, iii) follows from Proposition 3.0.3. Thus we can assume that $\Gamma$ is a fence.
i) Let $h E+f D_{0} \in M$. By induction on $l \geq 1$ one sees that $\left(h E+f D_{0}\right)^{l}$ is a sum of terms of the form $g E^{i}\left(D_{0}\right)^{j}$ where $g \in \operatorname{ker} D_{0}$. From this fact, one can deduce that $h E+f D_{0}$ is locally nilpotent and hence $M$ consists only of locally nilpotent derivations.

For all $f \in \operatorname{ker} D_{0}$ and $h \in \operatorname{ker} D_{0} \cap \operatorname{ker} E$ and $q \geq 0$ we have

$$
f D_{0} \operatorname{ad}(h E)^{q}=(-1)^{q} h^{q} E^{q}(f) D_{0}
$$

where $A \operatorname{ad}(B)=[A, B]$. With the aid of this formula, an application of the Baker-Campbell-Hausdorff formula yields $\operatorname{Exp}(h E) \circ \operatorname{Exp}\left(f D_{0}\right) \in M$ (see [Jac62, Proposition 1, §5, chp. V]). Hence $N \subseteq \operatorname{Exp}(M)$ which shows in particular, that $N$ consists of unipotent automorphisms. Moreover, $\exp h E$ and $\exp \left(f D_{0}+h E\right)$ coincide on ker $D_{0}$. Lemma 5.1.2 implies $(\operatorname{Exp} h E)^{-1} \circ$ $\operatorname{Exp}\left(f D_{0}+h E\right)=\operatorname{Exp}\left(g D_{0}\right)$ for some $g \in$ ker $D_{0}$ and thus $\operatorname{Exp}(M) \subseteq N$.
ii) This follows from Remark 5.1.2.
iii) One can check that $N=p^{-1}\left(\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \cap \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma_{0}\right)_{u}\right)$ by using Proposition 5.1.1. Since $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \cap \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma_{0}\right)_{u}$ is a closed normal subgroup of $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \cap \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma_{0}\right)$ it follows that $N$ is a closed normal subgroup of Cent( $\mathbf{u}$ ).

It is enough to show that the homomorphism $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\left\langle\mathbf{e}, \mathbf{u}_{0}\right\rangle} \cdot \mathbf{e} \rightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \cap$ $\operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma_{0}\right)_{u}$ (induced by $p$ ) is an isomorphism of ind-groups. Injectivity follows from the fact that $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\left\langle\mathbf{e}, \mathbf{u}_{0}\right\rangle} \cdot \mathbf{e} \cap \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}=\{\mathbf{i d}\}$ and surjectivity follows from a straightforward calculation, by using that $\Gamma$ is non-empty. The inverse map is clearly a morphism.
iv) Let $0 \neq h E+f D_{0} \in M$. It is enough to prove that

$$
\begin{equation*}
\operatorname{gcd}(h, f)=1 \quad \Longrightarrow \quad h E+f D_{0} \text { is irreducible } \tag{5}
\end{equation*}
$$

where the greatest common divisor is taken in the polynomial ring ker $D_{0}=$ $\mathbb{C}[z, P]$ (we use the notation of subsec. 5.3). Indeed, let $g B=h E+f D_{0} \in M$ for some locally nilpotent derivation $B \neq 0$ and some $0 \neq g \in \operatorname{ker} B$ and let $h=\operatorname{gcd}(h, f) h_{0}, f=\operatorname{gcd}(h, f) f_{0}$. Thus $B$ vanishes on $\operatorname{ker}\left(h_{0} E+f_{0} D_{0}\right)$ and since $h_{0} E+f_{0} D_{0}$ is irreducible, there exists $b \in \operatorname{ker}\left(h_{0} E+f_{0} D_{0}\right)$ such that $B=b\left(h_{0} E+f_{0} D_{0}\right)$. This implies $g b=\operatorname{gcd}(h, f) \in \mathbb{C}[z]$ and therefore $b \in \mathbb{C}[z]$. This shows that $B \in M$.

Let us prove (5). Since $E$ and $D_{0}$ are irreducible (see Lemma 5.3.2) we can assume that $h$ and $f$ both are non-zero. A calculation shows

$$
h E+f D_{0}=\Delta_{F}, \quad F=h Q+f P-\int\left(\frac{\partial f}{\partial P} P\right) \mathrm{d} P
$$

where the integration is taken inside the polynomial ring ker $D_{0}=\mathbb{C}[z, P]$ and $\Delta_{F}$ is taken with respect to $A[x, y]$ where $A=\mathbb{C}[z]$. Let $f=\sum_{i=0}^{n} f_{i}(z) P^{i}$. Thus we have

$$
f P-\int\left(\frac{\partial f}{\partial P} P\right) \mathrm{d} P=\sum_{i=0}^{n} f_{i}(z)\left(1-\frac{i}{i+1}\right) P^{i+1}
$$

Denote this last polynomial by $G \in \mathbb{C}[z, P]$.
Now, assume towards a contradiction that $h E+f D_{0}$ is not irreducible. Hence, we have $h E+f D_{0}=b B$ for some locally nilpotent derivation $B$ and
some non-constant $b \in \operatorname{ker} B$. By plugging in $P$ and $Q$ in $h E+f D_{0}=b B$ and using the fact that $\operatorname{gcd}(h, f)=1$ we see that $b$ divides $a_{0}$ (recall that $D_{0}(Q)=a_{0}$ and $\left.E(P)=-a_{0}\right)$. Hence there exists a root $z_{0}$ of $a_{0}$ such that the induced derivation of $\Delta_{F}=h E+f D_{0}$ on $\mathbb{C}[x, y, z] /\left(z-z_{0}\right) \simeq \mathbb{C}[x, y]$ vanishes. Thus, there exists a constant $c \in \mathbb{C}$ such that

$$
\begin{equation*}
h\left(z_{0}\right) Q\left(x, y, z_{0}\right)+\sum_{i=0}^{n} f_{i}\left(z_{0}\right)\left(1-\frac{i}{i+1}\right) P^{i+1}\left(x, y, z_{0}\right)=c \tag{6}
\end{equation*}
$$

The polynomial $P\left(x, y, z_{0}\right) \in \mathbb{C}[x, y]$ is non-constant, since otherwise $\mathbf{u}=$ $\operatorname{Exp}\left(\Delta_{P}\right)$ would have a two-dimensional fixed point set, contradicting the irreducibility (cf. [Dai07, 2.10]). If $h\left(z_{0}\right)=0$, then we have $f\left(z_{0}, P\right)=0$ by (6). Hence $\operatorname{gcd}(h, f) \neq 1$, a contradiction. Thus we can assume $h\left(z_{0}\right) \neq 0$. It follows that $Q+h\left(z_{0}\right)^{-1}(G(z, P)-c)$ is divisible by $z-z_{0}$ inside $\mathcal{O}\left(\mathbb{C}^{3}\right)$. Thus,

$$
D_{0}\left(\frac{Q+h\left(z_{0}\right)^{-1}(G(z, P)-c)}{z-z_{0}}\right)=\frac{a_{0}}{z-z_{0}}
$$

But this contradicts the fact, that $a_{0}$ is a generator of the plinth ideal of $D_{0}$.
5.6. The group Cent(u) as a semi-direct product. In this subsection, we prove our first main result: There exists an algebraic subgroup $R \subseteq \operatorname{Cent}(\mathbf{u})$ such that Cent $(\mathbf{u})$ is the semi-direct product of $N$ with $R$, if $\mathbf{u}$ is not a translation.

Theorem 5.6.1. Let $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent and assume that $\mathbf{u}$ is not a translation. Then the subgroup $N \subseteq \operatorname{Cent}(\mathbf{u})$ is closed and normal, and there exists an algebraic subgroup $R \subseteq \operatorname{Cent}(\mathbf{u})$ such that $\operatorname{Cent}(\mathbf{u}) \simeq N \rtimes R$ as ind-groups. Moreover, all elements of $\operatorname{Cent}(\mathbf{u})$ are algebraic.

We prove the result for modified translations and reduce the general case to it.
Proof for a modified translation. Let $\mathbf{u}=d \cdot \mathbf{u}_{0}$ be a standard decomposition. There exists a coordinate system $(x, y, z)$ such that $\mathbf{u}_{0}(x, y, z)=(x+1, y, z)$ and $d \in$ $\mathbb{C}[y, z] \backslash \mathbb{C}$.

If $\Gamma$ is not a fence, then it follows from Proposition 3.0.3 that $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is an algebraic group. By Proposition 5.2 .1 there exists a closed subgroup $R$ of $\operatorname{Cent}(\mathbf{u})$ that is mapped via $p: \operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ isomorphically onto $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ and $\operatorname{Cent}(\mathbf{u}) \simeq N \rtimes R$.

Now, assume that $\Gamma=\operatorname{div}(a)$ is a non-empty fence. By Proposition 3.0.5 there exist coordinates $(y, z)$ of $\mathbb{C}^{2}=\mathbb{C}^{3} / / \mathbf{u}$ such that $a \in \mathbb{C}[z]$. Thus we have a split short exact sequence of ind-groups

$$
1 \rightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)_{u} \hookrightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right) \xrightarrow{q} \mathbb{C}^{*} \times \operatorname{Aut}(\mathbb{C}, V(a)) \rightarrow 1
$$

where $q$ sends an automorphism $(y, z) \mapsto(\lambda y+h, \alpha z+\beta)$ to $(\lambda, z \mapsto \alpha z+\beta)$. Let $R$ be the algebraic group $\mathbb{C}^{*} \times \operatorname{Aut}(\mathbb{C}, V(a))$. Since $N$ is generated by $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ and $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\left\langle\mathbf{e}, \mathbf{u}_{0}\right\rangle} \cdot \mathbf{e} \simeq \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)_{u}$ (see Proposition 5.5.1), we have the desired split short exact sequence of ind-groups

$$
1 \rightarrow N \hookrightarrow \operatorname{Cent}(\mathbf{u}) \xrightarrow{q \circ p} R \rightarrow 1
$$

By Remark 5.2.1, every element of $\operatorname{Cent}(\mathbf{u})$ is algebraic.

Proof in the general case. Let $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}=\mathbb{C}[\tilde{y}, \tilde{z}]$ and let $\tilde{x} \in \mathcal{O}\left(\mathbb{C}^{3}\right)$ such that $\mathbf{u}^{*}(\tilde{x})=\tilde{x}+a$, where $\Gamma=\operatorname{div}(a)$. Let $\tilde{\mathbf{u}} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be given by $\tilde{\mathbf{u}}(\tilde{x}, \tilde{y}, \tilde{z})=$ $(\tilde{x}+a, \tilde{y}, \tilde{z})$ where we interpret $a$ as a polynomial in $\tilde{y}$ and $\tilde{z}$. The morphism $\mathbb{C}^{3} \rightarrow \mathbb{C}^{3}$ induced by the inclusion $\mathbb{C}[\tilde{x}, \tilde{y}, \tilde{z}] \subseteq \mathcal{O}\left(\mathbb{C}^{3}\right)$ is birational and thus we get an injective group homomorphism

$$
\eta: \operatorname{Cent}(\mathbf{u}) \longrightarrow \operatorname{Cent}(\tilde{\mathbf{u}})
$$

In fact, $\eta$ is a homomorphism of ind-groups, due to the following commutative diagram, where $r: \mathcal{O}\left(\mathbb{C}^{3}\right) \rightarrow \mathbb{C}[\tilde{x}, \tilde{y}, \tilde{z}]$ is a $\mathbb{C}$-linear retraction


According to the first case, $\operatorname{Cent}(\tilde{\mathbf{u}})$ is the semi-direct product of $N(\tilde{\mathbf{u}})$ with some algebraic subgroup $\tilde{R} \subseteq \operatorname{Cent}(\tilde{\mathbf{u}})$. Let $H \subseteq \tilde{R}$ be an algebraic subgroup. We claim that $\eta^{-1}(H) \subseteq \operatorname{Cent}(\mathbf{u})$ is an algebraic subgroup. Since $\eta$ : $\operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Cent}(\tilde{\mathbf{u}})$ is a homomorphism of ind-groups, it follows that $\eta^{-1}(H)$ is a closed subgroup. As $H$ is algebraic and thus acts locally finite on $\mathbb{C}^{3}$, it follows that $\eta^{-1}(H)$ acts also locally finite on $\mathbb{C}^{3}$ by [KS13, Lemma 3.6]. This implies the claim.

According to the claim all elements of $\operatorname{Cent}(\mathbf{u})$ are algebraic and $R=\eta^{-1}(\tilde{R})$ is algebraic as well. Since $\eta$ is an injective homomorphism of ind-groups we have the following commutative diagram


As the first column is a split short exact sequence of ind-groups, the second coloumn is also a split short exact sequence of ind-groups. This proves the theorem.
5.7. The unipotent elements of $\operatorname{Cent}(\mathbf{u})$. The goal of this subsection is to prove our second main result: The unipotent elements of Cent(u) are exactly $N$ provided $\mathbf{u}$ is not a translation (see subsec. 5.5 for the definition of $N$ ). As we know from Proposition 5.5.1 the set $N$ satisfies the property (Sat). This will be a key ingredient in the proof.

Theorem 5.7.1. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent and assume it is not $a$ translation. Then the set of unipotent elements of $\operatorname{Cent}(\mathbf{u})$ is equal to $N$.

Proof. Let $\mathbf{u}=d \cdot \mathbf{u}_{0}$ be a standard decomposition. Let $\mathbf{g} \in \operatorname{Cent}(\mathbf{u})$ be a unipotent automorphism with $\mathbf{g} \neq \mathbf{i d}$. If $\Gamma$ is not a fence, then $\operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ contains no unipotent automorphism $\neq \mathbf{i d}$ (see Proposition 3.0.3). By Proposition 5.1.1 it follows that $\mathbf{g} \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}=N$.

Hence we can assume that $\Gamma=\operatorname{div}(a)$ is a fence. Let $z \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$ be a variable of $\mathcal{O}\left(\mathbb{C}^{3}\right)$ such that $a \in \mathbb{C}[z]$ (see Lemma 5.3.1). If $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{g}}=\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$, then g is a modification of $\mathbf{u}_{0}$ and therefore $\mathbf{g} \in N$. Now, assume $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{g}} \neq \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}}$. Thus $\mathbf{g}$ is not a modification of $\mathbf{u}_{0}$ and hence $\mathbf{i d} \neq p(\mathbf{g}) \in \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$. Since $p(\mathbf{g})$ is unipotent and $0 \neq a \in \mathbb{C}[z]$, it follows that $z \in \mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{g}}$ and thus $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{g}, \mathbf{u}\rangle}$ is an
$\infty$-dimensional $\mathbb{C}$-vector space. By Theorem 5.6.1 there exists an algebraic subgroup $R \subseteq \operatorname{Cent}(\mathbf{u})$ and a split short exact sequence of ind-groups

$$
1 \rightarrow N \hookrightarrow \operatorname{Cent}(\mathbf{u}) \stackrel{r}{\rightarrow} R \rightarrow 1
$$

If $\mathbf{g} \notin N$, then $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{g}, \mathbf{u}\rangle} \cdot \mathbf{g} \cap N=1$, since $N$ satisfies the property (Sat). We get an injection $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{g}, \mathbf{u}\rangle} \rightarrow \operatorname{Cent}(\mathbf{u}) \rightarrow R, h \mapsto r(h \cdot \mathbf{g})$. Choose any filtration by finite dimensional $\mathbb{C}$-subspaces to turn $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{g}, \mathbf{u}\rangle}$ into an ind-group. It follows that $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\langle\mathbf{g}, \mathbf{u}\rangle} \rightarrow R$ is an injective homomorphism of ind-groups. But this implies that $R$ has algebraic subgroups of arbitrary high dimension, which is absurd. This finishes the proof of the theorem.

If we endow $\operatorname{Cent}(\mathbf{u}) / N$ with the algebraic group structure induced by the semidirect product decomposition coming from Theorem 5.6.1, then we get immediately the following corollary from Theorem 5.7.1.
Corollary 5.7.2. If $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ is unipotent and not a translation, then the algebraic group $\operatorname{Cent}(\mathbf{u}) / N$ consists only of semi-simple elements. In particular, the connected component of the neutral element in $\operatorname{Cent}(\mathbf{u}) / N$ is a torus.

## 6. Applications

Proposition 6.0.3. Let $\mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent and irreducible, and assume that $\Gamma$ is a non-empty fence. Then $\Gamma \subseteq \mathbb{C}^{3} / / \mathbf{u}$ is the largest closed subscheme fixed by $\operatorname{Cent}(\mathbf{u})_{u}$.
Proof. By Proposition 5.5.1 and Theorem 5.7.1, we get $p\left(\operatorname{Cent}(\mathbf{u})_{u}\right)=\operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right)_{u}$, where $p: \operatorname{Cent}(\mathbf{u}) \rightarrow \operatorname{Aut}\left(\mathbb{C}^{2}, \Gamma\right)$ is the canonical morphism. Thus $\Gamma$ is fixed by the action of $\operatorname{Cent}(\mathbf{u})_{u}$. Let $X \subseteq \mathbb{C}^{2}$ be a closed subscheme that is fixed under Cent $(\mathbf{u})_{u}$ and assume that $X$ contains $\Gamma$. Moreover, let $I(X) \subseteq \mathcal{O}\left(\mathbb{C}^{2}\right)$ be the ideal of $X$ and let $\Gamma=\operatorname{div}(a)$. By Proposition 3.0.5 there exist coordinates $(z, w)$ of $\mathbb{C}^{2}$ such that $a \in \mathbb{C}[z]$. Let $\sigma \in \operatorname{Iner}\left(\mathbb{C}^{2}, \Gamma\right)_{u}$ be given by $\sigma(z, w)=(z, w+a)$. By assumption, we get $a=\sigma^{*}(w)-w \in I(X)$. But this implies that $X$ is a closed subscheme of $\Gamma$ and hence $X=\Gamma$.

Proposition 6.0.4. Let $\mathbf{i d} \neq \mathbf{u} \in \operatorname{Aut}\left(\mathbb{C}^{3}\right)$ be unipotent, not a translation, and let $\mathbf{u}=d \cdot \mathbf{u}_{0}$ be a standard decomposition. Then the subgroup $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ of $\operatorname{Cent}(\mathbf{u})$ is characteristic, i.e. $\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0}$ is invariant under all abstract group automorphisms of $\operatorname{Cent}(\mathbf{u})$.
Lemma 6.0.5. Let $T$ be a torus acting on $\mathbb{C}^{2}$. Assume that there exist coordinates $(z, w)$ of $\mathbb{C}^{2}$ such that $z$ is a semi-invariant. Then there exists $r \in \mathbb{C}[z]$ such that the action of $T$ is diagonal with respect to the coordinate system $(z, w+r)$.

Proof of Lemma 6.0.5. By assumption, pr: $\mathbb{C}^{2} \rightarrow \mathbb{C},(z, w) \rightarrow z$ is $T$-equivariant with respect to a suitable $T$-action on $\mathbb{C}$. Due to [KK96, Proposition 1], every lift of a $T$-action on $\mathbb{C}$ to $\mathbb{C}^{2}$ (with respect to pr ) is equivalent to a trivial lift (with respect to pr). Thus, there exists $r \in \mathbb{C}[z]$ such that $w+r$ is a semi-invariant with respect to the action of $T$. This finishes the proof.

Proof of Proposition 6.0.4. Let $R \subseteq \operatorname{Cent}(\mathbf{u})$ be an algebraic subgroup such that $\operatorname{Cent}(\mathbf{u})=R \ltimes N$ (see Theorem 5.6.1). Let $T=R^{0}$ be the connected component of the neutral element in $R$. By Corollary 5.7.2, it is a torus (possibly $\operatorname{dim} T=0$ ). It follows from Theorem 5.6.1 that $T \ltimes N \subseteq \operatorname{Cent}(\mathbf{u})$ is a subgroup of finite index.

Moreover, $T \ltimes N$ has no proper subgroup of finite index, as this group is generated by groups that have no proper subgroup of finite index. This implies that $T \ltimes N$ is a characteristic subgroup of $\operatorname{Cent}(\mathbf{u})$. Let $G=T \ltimes N$ and let $H=\mathcal{O}\left(\mathbb{C}^{3}\right)^{\mathbf{u}_{0}} \cdot \mathbf{u}_{0} \subseteq N$. It is now enough to prove, that $H$ is characteristic in $G$. We divide the proof now in two cases.
$\Gamma$ is not a fence: If $\operatorname{dim} T=0$, then we have $H=G$. So assume $\operatorname{dim} T>0$. There exist coordinates $\left(v_{1}, v_{2}\right)$ of $\mathbb{C}^{3} / / \mathbf{u}$ such that the action of $T$ on $\mathbb{C}^{3} / / \mathbf{u}$ is diagonal with respect to $\left(v_{1}, v_{2}\right)$ (see $[\operatorname{Kam} 79]$ ). Let $\rho_{1}$ and $\rho_{2}$ be the characters of $T$ such that $\mathbf{t}^{*}\left(v_{i}\right)=\rho_{i}(\mathbf{t}) v_{i}$ for all $\mathbf{t} \in T$. Let $\mathbf{t} \circ f \cdot \mathbf{u}_{0} \in \operatorname{Cent}_{G}\left(G^{(1)}\right)$, where $G^{(1)}=[G, G]$ denotes the first derived group. A calculation shows for $i=1,2$ and for all $k \geq 0$

$$
\mathbf{i d}=\left[\mathbf{t} \circ f \cdot \mathbf{u}_{0},\left[\mathbf{t}^{-1}, v_{i}^{k} \cdot \mathbf{u}_{0}\right]\right]=\left(1-\mu\left(\mathbf{t}^{-1}\right) \rho_{i}\left(\mathbf{t}^{-1}\right)^{k}\right)\left(1-\mu(\mathbf{t}) \rho_{i}(\mathbf{t})^{k}\right) v_{i}^{k} \cdot \mathbf{u}_{0}
$$

where $\mu: T \rightarrow \mathbb{C}^{*}$ is the character defined by $\mu(\mathbf{t}) d=\mathbf{t}^{*}(d)$ (see Remark 5.1.2). Thus $\rho_{i}(\mathbf{t})=1$ for $i=1,2$. As the action of $T$ on $\mathbb{C}^{3} / / \mathbf{u}$ is faithful, it follows that $\mathbf{t}=1$. Hence $H=\operatorname{Cent}_{G}\left(G^{(1)}\right)$.
$\Gamma$ is a fence: Let $(z, P)$ be a coordinate system of $\mathbb{C}^{2}=\mathbb{C}^{3} / / \mathbf{u}$ such that $\Gamma \subseteq \mathbb{C}^{2}$ is given by the standard embedding $F \times \mathbb{C} \subseteq \mathbb{C}^{2}$ for some 0 -dimensional closed subscheme $F \subseteq \mathbb{C}$ and $\mathbf{u}_{0}=\operatorname{Exp}\left(\Delta_{P}\right)$ (see subsec. 5.3). As the torus $T$ preserves $\Gamma=V(a) \subseteq \mathbb{C}^{2}$ invariant and since $a \in \mathbb{C}[z]$, there exists $q \in \mathbb{C}$, such that $z+q$ is a semi-invariant for the action of $T$. By replacing $z+q$ with $z$, we can assume that $z$ is a semi-invariant. Moreover, by replacing $P$ with a suitable $P+r$ for some $r \in \mathbb{C}[z]$ we can assume that the action of $T$ with respect to $(z, P)$ is diagonal (see Lemma 6.0.5). Moreover, we denote by e an admissible complement to $\mathbf{u}$.

Assume first $\operatorname{dim} T=0$. Let $h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_{0} \in \operatorname{Cent}_{G}\left(G^{(1)}\right)$. A calculation shows that

$$
\mathbf{i d}=\left[h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_{0},\left[P^{2} \cdot \mathbf{u}_{0}, \mathbf{e}\right]\right]=-2 h\left(a_{0}\right)^{2} \cdot \mathbf{u}_{0}
$$

where $a_{0} \in \mathbb{C}[z]$ such that $\Gamma_{0}=\operatorname{div}\left(a_{0}\right)$. Hence $h=0$ and therefore $H=\operatorname{Cent}_{G}\left(G^{(1)}\right)$.
Assume now, $\operatorname{dim} T>0$. Let $A=\mathbb{C}[z]$ and let $A \ltimes A[P]$ be the semi-direct product defined by

$$
\begin{equation*}
(h, f) \cdot(\bar{h}, \bar{f})=\left(h+\bar{h}, f\left(P-\bar{h} a_{0}\right)+\bar{f}\right) \tag{7}
\end{equation*}
$$

From Proposition 5.5.1 it follows that

$$
A \ltimes A[P] \xrightarrow{\sim} N(\mathbf{u}), \quad(h, f) \longmapsto h \cdot \mathbf{e} \circ f \cdot \mathbf{u}_{0}
$$

is an isomorphism of groups. Under this isomorphism the subgroup $A[P]$ is sent onto $H$. It follows from Lemma 6.0.6 that $H=\operatorname{Cent}_{G} G^{(2)}$.

Lemma 6.0.6. Let $A \ltimes A[P]$ be defined as in (7) and let $G=T \ltimes(A \ltimes A[P])$ where $T$ is a torus with $\operatorname{dim} T>0$. Assume that $A[P] \subseteq G$ is a normal subgroup, that the action of $T$ by conjugation on $A[P]$ is given by $\lambda^{-1} f \lambda=\mu(\lambda) f\left(\rho_{1}(\lambda) z, \rho_{2}(\lambda) P\right)$ for some characters $\mu, \rho_{1}, \rho_{2}$ and that $\operatorname{ker} \rho_{1} \cap \operatorname{ker} \rho_{2}=\{1\}$. Furthermore we assume that the action of $T$ by conjugation on the quotient $G / A[P]$ is non-trivial and the product in $G$ satisfies $(\lambda, 0,0) \cdot(1, h, f)=(\lambda, h, f)$. Then $A[P]=\operatorname{Cent}_{G} G^{(2)}$.

Proof of Lemma 6.0.6. As the action by conjuagtion of $T$ on $G / A[P]$ is non-trivial, it follows that the first derived subgroup $G^{(1)}$ is not contained in $A[P]$. As $T$ is abelian it follows that $G^{(1)} \subseteq A \ltimes A[P]$ and as $A$ is abelian we conclude $G^{(2)} \subseteq$
$A[P]$. Thus there exists $\left(1, h_{0}, f_{0}\right) \in G^{(1)}$ with $h_{0} \neq 0$. As $A[P]$ is abelian, we get $A[P] \subseteq \operatorname{Cent}_{G} G^{(2)}$. Now, we prove $\operatorname{Cent}_{G} G^{(2)} \subseteq A[P]$. We have

$$
\left(1,0, q-q\left(P+h_{0} a_{0}\right)\right)=\left[(1,0, q),\left(1, h_{0}, f_{0}\right)\right] \in G^{(2)} \quad \text { for all }(1,0, q) \in G^{(1)}
$$

Moreover, $\left(1,0, z^{i} P^{j}\right) \in G^{(1)}$ for all $(i, j) \in \mathbb{N}_{0}^{2}$ such that $\mu \rho_{1}^{i} \rho_{2}^{j}$ is not the trivial character, as we have $\left(1,0, z^{i} P^{j}\right)=\left[(\lambda, 0,0),\left(1,0, z^{i} P^{j}\right)\right]$ for some well chosen $\lambda \in$ $T$. For all $j \geq 0$, the character $\mu \rho_{1}^{i} \rho_{2}^{j}$ is non-trivial, provided that $i$ is large enough. For all $(1,0, f) \in A[P]$ we have

$$
\begin{aligned}
\operatorname{Cent}_{G}(1,0, f) & =\left\{(\bar{\lambda}, \bar{h}, \bar{f}) \in G \mid(\bar{\lambda}, \bar{h}, \bar{f})^{-1} \cdot(1,0, f) \cdot(\bar{\lambda}, \bar{h}, \bar{f})=(1,0, f)\right\} \\
& =\left\{(\bar{\lambda}, \bar{h}, \bar{f}) \in G \mid f=\left(\bar{\lambda}^{-1} f \bar{\lambda}\right)\left(P-\bar{h} a_{0}\right)\right\}
\end{aligned}
$$

Let $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_{G} G^{(2)}$. Since $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_{G}\left(1,0,-z^{i} h_{0} a_{0}\right)$ for $i$ sufficiently large, we get $\bar{\lambda} \in \operatorname{ker} \rho_{1}$. Moreover, $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_{G}\left(1,0,-z^{i} h_{0} a_{0}\left(2 P+h_{0} a_{0}\right)\right)$ for sufficiently large $i$. This implies $\rho_{2}(\bar{\lambda})=\mu(\bar{\lambda})^{-1}$ and $\bar{h}=((\mu(\bar{\lambda})-1) / 2) h_{0}$. Since $(\bar{\lambda}, \bar{h}, \bar{f}) \in \operatorname{Cent}_{G}\left(1,0,-z^{i} h_{0} a_{0}\left(3 P^{2}+3 P h_{0} a_{0}+\left(h_{0} a_{0}\right)^{2}\right)\right)$ it follows that $\rho_{2}(\bar{\lambda})^{2}=$ $\mu(\bar{\lambda})^{-1}$. Therefore $\bar{\lambda} \in \operatorname{ker} \rho_{2}, \bar{h}=0$. Hence we have $(\bar{\lambda}, \bar{h}, \bar{f})=(1,0, \bar{f}) \in A[P]$ and this proves $\operatorname{Cent}_{G} G^{(2)} \subseteq A[P]$.
