#### Abstract

Rough sheets are two-parameter analogs of rough paths. In this work the theory of integration over functions of two parameters is extended to cover the case of irregular functions by developing an appropriate notion of rough sheet. The main application is to give a path by path construction of the stochastic integral in the plane and obtain a stratonovich change of variables formula.

## 1 Introduction

For processes indexed by one dimensional parameter Lyons' theory of rough paths [11,12] provide an effective approach to the understanding of relatively complex maps like the stochastic integral or the Itô map which sends the data of an SDE to its solution. These insights were instrumental in proving new results or simplifying the proofs of some important results in stochastic analysis. Just to mention some application: path-wise solutions of SDEs, the support theorem for diffusions, differentiation of the Itô map, the existence of path-wise versions for stochastic currents and the solution of an ODE over Brownian paths driven by a non-adapted vector-field. The theory, being independent from notions like martingales, adaptness, etc...is straightforwardly extended to other, more complex, noises like fractional Brownian motions.

In [8] Gubinelli introduces the notion of controlled path in order to abstract the basic structures allowing the integration of rough signals and pointed out the existence of a map (the sewing map) which turns out to be at the "core" of the integration process.

In the present paper we study a multi parameter extension to the controlled path theory of [8] and inspired by the structures which one encounters when trying to solve hyperbolic equations driven by irregular signals.

More precisely the example what we have in mind is the stochastic wave equation driven by a fractional Brownian sheet. This equation has been already studied in [19] when the Hurst parameters of the fractional Brownian sheet are strictly bigger than $\frac{1}{2}$ by using the two dimensional Young integration theory. In the cited paper the authors obtain a global existence result in this case in $(1+1)$-dimension.

Our work is a (partially successful) attempt to extend this previous work for the case where the Hurst parameters are less than $\frac{1}{2}$ and for that we will give a definition of a rough sheet, which is the basic objects underlying multi-parameter integration suitable to build a theory of path-wise integration over the fractional Brownian sheet. Unfortunately the construction of the rough integral in the multiparametrs setting give rise to a very complex algebraic structure which is not well understood at the moment. Due to this difficulties we are not able to construct a full-fledged theory capable of handling solutions to the stochastic wave equation for that reason we will prefer to restrict ourself to the construction of the integral for a restricted family of integrands and to leave the study of the wave equation to further investigations.

More precisely the main result of this paper can be resumed in the following theorem
Theorem 1.1. Let $\gamma_{1}, \gamma_{2}>1 / 3$, then there exist a complete metric space $\mathscr{R}^{\gamma_{1}, \gamma_{2}}$ and two continuous application $\mathscr{I}_{a}: C_{b}^{8}(\mathbb{R}) \times \mathscr{R}^{\gamma_{1}, \gamma_{2}} \rightarrow \mathscr{C}_{2} \mathscr{C}_{2}^{\gamma_{1}, \gamma_{2}}$ (see the equation (29) for the exact definition of $\mathscr{C}_{2} \mathscr{C}_{2}^{\gamma_{1}, \gamma_{2}}$ ), $a=1,2$ such that :

\mathscr{I}_{1}(\varphi, \mathbb{X})_{s_{1} s_{2} ; t_{1} t_{2}}=\int_{s_{1}}^{s_{2}} \int_{t_{1}}^{t_{2}} \varphi\left(x_{s t}\right) \partial_{s} \partial_{t} x_{s t} \mathrm{~d} s \mathrm{~d} t
$$

and

$$
\mathscr{I}_{2}(\varphi, \mathbb{X})_{s_{1} s_{2} ; t_{1} t_{2}}=\int_{s_{1}}^{s_{2}} \int_{t_{1}}^{t_{2}} \varphi\left(x_{s t}\right) \partial_{s} x_{s t} \partial_{t} x_{s t} \mathrm{~d} s \mathrm{~d} t
$$

for all $\left(s_{1}, s_{2}, t_{1}, t_{2}\right) \in[0,1]^{4}$ and for every smooth sheet $x$ with $\mathbb{X}$ is the rough sheet associated. Moreover if $x$ is a fractional Brownian sheet with Hust parameter $\gamma_{1}, \gamma_{2}>1 / 3$ then it can be enhanced in a rough sheet $\mathbb{X}$ and then we obtain in this case the following Stratonovich formula :

\delta \varphi(x)=\mathscr{I}_{1}\left(\varphi^{\prime}, \mathbb{X}\right)+\mathscr{I}_{2}\left(\varphi^{\prime \prime}, \mathbb{X}\right)
$$

We remark that this result is used in [3] to deal with the multi-parametric Skorohod integral defined in $[20,21]$ and that an explicit formula which give a link between the two notion of integration is obtained.

During the elaboration of this paper two other approaches have been developed to deal with singular parabolic SPDE using rough path ideas. The first one is due to P. Imkeller, N. Perkowsky and M. Gubinelli [9] in which the authors use Bony's paraproducts [1] to set up a controlled structure which allow to handle product of distributions in enough generality to be useful to solve PDEs driven by singular signals. A second and more powerful approach has been introduced by M.Hairer in [18] where the author builds a complete non-linear theory for distributions which can be analyzed in terms of a basic set of simple objects called a model.

These two extension of rough path theory are very efficient to deal with parabolic SPDE driven by a very irregular multi parameter noise but at the moment while seems possible to adapt these two approaches to handle hyperbolic problems it seems not very clear what would be the final form of a successful theory. In this respect our study and the objects we introduce seems to be needed, maybe in a slightly different form, in order to build a complete theory of hyperbolic rough equations similar to the non-linear stochastic heat equation. Our efforts then can be seen as a first step in this direction.

Plan. This note is structured as follows. In Sec. 2 we recall the basic setup of [8] which allows to embed the theory of rough paths in a theory of integration of "generalized differentials", called $k$-increments. In Sec. 3 we introduce and study a complex of 2d increments (or biincrements) suitable to analyze 2 d integrals and show the existence of a $2 \mathrm{~d} \Lambda$-map and of an abstract integration theory (in the sense of convergence of Riemann sums of particular biincrements).

In Sec. 4 we use the theory outlined in Sec. 3 to generalize Young theory of integration to two dimensions. Like in the one-dimensional setting this should be seen as a first (mostly pedagogical) step towards a full theory of rough sheets.

In Sec. 5 we proceed to the dissection of a 2 d integral with the purpose of exposing the constituent elements of the would-be rough sheet. All the computations will be done in the smooth setting, emphasizing the algebraic aspects and the respective rôles of the various objects.

In Sec. 5.1 the definition of the rough sheet will be given, and on 5.1.2 a space of sheets controlled by a rough sheet, will be introduced and we will show how to obtain an integration theory for them.

In Sec 5.2 we show that for a smooth function $\varphi$ that $\varphi(x)$ is controlled by $x$ if $x$ is a rough sheet and then obtain some continuity result for the integral constructed in this case using the procedure developed in 5.1.

In Sec 6 we show that the fractional Brownian motion can be enhanced in a rough sheet and then we obtain a Stratonovich change of variable formula in this case.

## 2 Algebraic integration in one dimension

The integration theory introduced in [8] is based on an algebraic structure, which turns out to be useful for computational purposes, but has also its own interest. Since this setting is quite non-standard,
compared with the one developed in [10], and since it lay at the base of our approach to 2d integrals we will recall briefly here its main features.

### 2.1 Increments

Let $T>0$ be an arbitrary positive real number. For any vector space $V$ we introduce a cochain complex $\left(\mathscr{C}_{*}(V), \delta\right)$ as follows. a $k$-increment with values in $V$ is a function $g:[0, T]^{k} \rightarrow V$, such that $g_{t_{1} \cdots t_{k}}=0$ whenever $t_{i}=t_{i+1}$ for some $i=1, \ldots, k$. Denote with $\mathscr{C}_{k}(V)$ the corresponding set. On $k$-increments, define a the following coboundary operator $\delta$ :

\begin{equation*}
\delta: \mathscr{C}_{k}(V) \rightarrow \mathscr{C}_{k+1}(V) \quad(\delta g)_{t_{1} \cdots t_{k+1}}=\sum_{i=1}^{k+1}(-1)^{i+1} g_{t_{1} \cdots \hat{t}_{i} \cdots t_{k+1}} \tag{1}
\end{equation*}
$$

where $\hat{t}_{i}$ means that this particular argument is omitted. It is easy to verify that $\delta \delta=0$. We will denote $\mathscr{Z} \mathscr{C}_{k}(V)=\mathscr{C}_{k}(V) \cap \operatorname{Ker} \delta$ and $\mathscr{B} \mathscr{C}_{k}(V):=\mathscr{C}_{k}(V) \cap \operatorname{Im} \delta$, respectively the spaces of $k$-cocycles and of $k$-coboundaries following standard conventions of homological algebra. We will write $\mathscr{C}_{k}$ when the underlying vector space is $\mathbb{R}$.

Some simple examples of actions of $\delta$ are obtained by letting $g \in \mathscr{C}_{1}(V)$ and $h \in \mathscr{C}_{2}(V)$. Then, for any $t, u, s \in[0, T]$, we have

$$
\begin{equation*}
(\delta g)_{t s}=g_{t}-g_{s}, \quad \text { and } \quad(\delta h)_{t u s}=h_{t s}-h_{t u}-h_{u s} \tag{2}
\end{equation*}
$$

The complex $\left(\mathscr{C}_{*}(V), \delta\right)$ is acyclic, i.e. $\mathscr{Z} \mathscr{C}_{k+1}(V)=\mathscr{B} \mathscr{C}_{k}(V)$ for any $k \geq 0$ or otherwise stated, the sequence

$$
\begin{equation*}
0 \rightarrow \mathbb{R} \rightarrow \mathscr{C}_{1}(V) \stackrel{\delta}{\longrightarrow} \mathscr{C}_{2}(V) \xrightarrow{\delta} \mathscr{C}_{3}(V) \xrightarrow{\delta} \mathscr{C}_{4}(V) \rightarrow \cdots \tag{3}
\end{equation*}
$$

is exact.
This exactness implies that all the elements $h \in \mathscr{C}_{2}(V)$ such that $\delta h=0$ can be written as $h=\delta f$ for some (non unique) $f \in \mathscr{C}_{1}(V)$. Thus we get a heuristic interpretation of $\left.\delta\right|_{\mathscr{C}_{1}(V)}$ : it measures how much a given 1-increment is far from being an exact increment of a function (i.e. a finite difference).

For our discussion only $k$-increments with $k \leq 3$ will be relevant. When $V$ is a Banach space with norm $|\cdot|$ we measure the size of these increments by Hölder norms defined in the following way: for $f \in \mathscr{C}_{2}(V)$ let

\|f\|_{\mu} \equiv \sup _{s, t \in[0, T]} \frac{\left|f_{s t}\right|}{|t-s|^{\mu}}, \quad \text { and } \quad \mathscr{C}_{2}^{\mu}(V)=\left\{f \in \mathscr{C}_{2}(V) ;\|f\|_{\mu}<\infty\right\}
$$

In the same way for $h \in \mathscr{C}_{3}(V)$ set

$$
\begin{align*}
\|h\|_{\gamma, \rho} & =\sup _{s, u, t \in[0, T]} \frac{\left|h_{\text {sut }}\right|}{|u-s|^{\gamma}|t-u|^{\rho}}  \tag{4}\\
\|h\|_{\mu} & \equiv \inf \left\{\sum_{i}\left\|h_{i}\right\|_{\rho_{i}, \mu-\rho_{i}} ; h=\sum_{i} h_{i}, 0<\rho_{i}<\mu\right\}
\end{align*}
$$

where the last infimum is taken over all sequences $\left\{h_{i} \in \mathscr{C}_{3}(V)\right\}$ such that $h=\sum_{i} h_{i}$ and for all choices of the numbers $\rho_{i} \in(0, z)$. Then $\|\cdot\|_{\mu}$ is easily seen to be a norm on $\mathscr{C}_{3}(V)$, and we set

$$
\mathscr{C}_{3}^{\mu}(V):=\left\{h \in \mathscr{C}_{3}(V) ;\|h\|_{\mu}<\infty\right\}
$$

Let $\mathscr{C}_{3}^{1+}(V)=\cup_{\mu>1} \mathscr{C}_{3}^{\mu}(V)$. Analogous meaning should be given to $\mathscr{Z} \mathscr{C}_{2}^{\mu}(V), \ldots$
From now on $V$ will be a generic Banach space.
The following proposition is a basic result which is at the core of our approach to path-wise integration:

Proposition 2.1 (The $\Lambda$-map). There exists a unique linear map $\Lambda: \mathscr{Z}_{\mathscr{3}}^{1+}(V) \rightarrow \mathscr{C}_{2}^{1+}(V)$ such that $\delta \Lambda=1_{\mathscr{Z} \mathscr{C}_{3}(V)}$. Furthermore, for any $\mu>1$ this map is continuous from $\mathscr{Z} \mathscr{C}_{2}^{\mu}(V)$ to $\mathscr{C}_{1}^{\mu}(V)$ and we have

$$
\begin{equation*}
\|\Lambda h\|_{\mu} \leq \frac{1}{2^{\mu}-2}\|h\|_{\mu}, \quad h \in \mathscr{Z} \mathscr{C}_{2}^{1+}(V) \tag{5}
\end{equation*}
$$

Proof. See [8].

Let $\mathscr{R}^{\mu}(V)=\left\{g \in \mathscr{C}_{2}(V): \delta g \in \mathscr{C}_{3}^{\mu}(V)\right\}$. When $\mu>1$ this is the subspace of 1-increments whose coboundary is small enough to be in the domain of $\Lambda \cdot \mathscr{R}^{1+}(V)$ is defined as the union of all $\mathscr{R}^{\mu}(V)$ for $\mu>1$.

An immediate implication of Prop. 2.1 is the following algorithm for a canonical decomposition of the elements of $\mathscr{R}^{1+}(V)$ :

Corollary 2.2. Take an element $g \in \mathscr{R}^{\mu}(V)$ for $\mu>1$. Then $g$ can be decomposed in a unique way as $g=\delta f+\Lambda \delta g$, where $f \in \mathscr{C}_{1}(V)$. If moreover $g \in \mathscr{C}_{2}^{1+}(V)$ then $f=0$ and $g=\Lambda \delta g$ : the coboundary $\delta$ is invertible (as a linear map) in $\mathscr{C}_{1}^{1+}(V)$.

Proof. By assumption there are no ambiguity to define $\Lambda \delta g$ and by definition we have that $\delta(g-\Lambda \delta g)=$ 0 and then there exist $f \in \mathscr{C}_{1}(V)$ such that $\delta f=g-\Lambda \delta g$. In the case when $g \in \mathscr{C}_{2}^{1+}$ we see that $f$ is a $\gamma$-Hölder function for some $\gamma>1$ and then $f_{t}=f_{0}$ which gives our result.

At this point the relation of the structure we introduced with the problem of integration of irregular functions can be still quite obscure to the non-initiated reader. However something interesting is already going on and the previous corollary has a very nice consequence which is the subject of the next corollary.

Corollary 2.3 (Integration of small increments). For any 1-increment $g \in \mathscr{C}_{2}(V)$, such that $\delta g \in \mathscr{C}_{1}^{1+}$ set $\delta f=(1-\Lambda \delta) g$, then

$$
(\delta f)_{t s}=\lim _{\left|\Pi_{t s}\right| \rightarrow 0} \sum_{i=0}^{n} g_{t_{i} t_{i+1}}
$$

where the limit is over all partitions $\Pi_{t s}=\left\{t_{0}=t, \ldots, t_{n}=s\right\}$ of $[t, s]$ as the size of the partition goes to zero. The 1-increment $\delta f$ is the indefinite integral of the 1-increment $g$.

Even if the result is already in [8] we would like to repeat the proof since it is quite illuminating and it will be source of inspiration when proving a similar statement in the 2 d setting.

Proof. Just consider the equation $g=\delta f+\Lambda \delta g$ and write

$$
S_{\Pi}=\sum_{i=0}^{n} g_{t_{i} t_{i+1}}=\sum_{i=0}^{n}(\delta f)_{t_{i} t_{i+1}}+\sum_{i=0}^{n}(\Lambda \delta g)_{t_{i} t_{i+1}}=(\delta f)_{t s}+\sum_{i=0}^{n}(\Lambda \delta g)_{t_{i} t_{i+1}}
$$

and observe that, due to the fact that $\Lambda \delta g \in \mathscr{C}_{1}^{1+}(V)$ the last sum converges to zero.

### 2.1.1 Computations in $\mathscr{C}_{*}$

If $V$ is an associative algebra the complex $\left(\mathscr{C}_{*}, \delta\right)$ is an (associative, non-commutative) graded algebra once endowed with the following product: for $g \in \mathscr{C}_{n}(V)$ and $h \in \mathscr{C}_{m}(V)$ let $g h \in \mathscr{C}_{n+m-1}(V)$ the element defined by

$$
\begin{equation*}
(g h)_{t_{1}, \ldots, t_{m+n+1}}=g_{t_{1}, \ldots, t_{n}} h_{t_{n}, \ldots, t_{m+n-1}}, \quad t_{1}, \ldots, t_{m+n} \in[0, T] \tag{6}
\end{equation*}
$$

The coboundary $\delta$ act as a graded derivation with respect to the algebra structure. In particular we have the following useful properties.

Proposition 2.4. The following differentiation rules hold:

1. Let $g, h$ be two elements of $\mathscr{C}_{1}(V)$. Then

$$
\begin{equation*}
\delta(g h)=\delta g h+g \delta h \tag{7}
\end{equation*}
$$

2. Let $g \in \mathscr{C}_{1}(V)$ and $h \in \mathscr{C}_{2}(V)$. Then

$$
\delta(g h)=-\delta g h+g \delta h, \quad \delta(h g)=\delta h g+h \delta g .
$$

Proof. We will just prove (7), the other relations being equally trivial: if $g, h \in \mathscr{C}_{1}(V)$, then

$$
[\delta(g h)]_{t s}=g_{t} h_{t}-g_{s} h_{s}=g_{t}\left(h_{t}-h_{s}\right)+\left(g_{t}-g_{s}\right) h_{s}=g_{t}(\delta h)_{t s}+(\delta h)_{t s} g_{s}
$$

which proves our claim.

The iterated integrals of smooth functions on $[0, T]$ are of course particular cases of elements of $\mathscr{C}$ which will be of interest for us. Let us recall some basic rules for these objects: consider $f, g \in \mathscr{C}_{1}^{\infty}$, where $\mathscr{C}_{1}^{\infty}$ is the set of smooth functions from $[0, T]$ to $\mathbb{R}$. Then the integral $\int f d g$, that we will denote by $\mathscr{J}(f d g)$, can be considered as an element of $\mathscr{C}_{2}^{\infty}$. That is, for $s, t \in[0, T]$, we set

$$
\mathscr{J}_{t s}(f \mathrm{~d} g)=\left(\int f \mathrm{~d} g\right)_{t s}=\int_{s}^{t} f_{u} \mathrm{~d} g_{u}
$$

The multiple integrals can also be defined in the following way: given a smooth element $h \in \mathscr{C}_{2}^{\infty}$ and $s, t \in[0, T]$, we set

$$
\mathscr{J}_{t s}(h \mathrm{~d} g) \equiv\left(\int h \mathrm{~d} g\right)_{t s}=\int_{s}^{t} h_{u s} \mathrm{~d} g_{u}
$$

In particular, the double integral $\mathscr{J}_{t s}\left(f^{1} d f^{2} d f^{3}\right)$ is defined, for $f^{1}, f^{2}, f^{3} \in \mathscr{C}_{0}^{\infty}$, as

$$
\mathscr{J}_{t s}\left(f^{1} \mathrm{~d} f^{2} \mathrm{~d} f^{3}\right)=\left(\int f^{1} \mathrm{~d} f^{2} \mathrm{~d} f^{3}\right)_{t s}=\int_{s}^{t} \mathscr{J}_{u s}\left(f^{1} \mathrm{~d} f^{2}\right) \mathrm{d} f_{u}^{3}
$$

Now, suppose that the $n$th order iterated integral of $f^{1} d f^{2} \cdots d f^{n}$, still denoted by the expression $\mathscr{J}\left(f^{1} d f^{2} \cdots d f^{n}\right)$, has been defined for $f^{1}, f^{2}, \cdots, f^{n} \in \mathscr{C}_{1}^{\infty}$. Then, if $f^{n+1} \in \mathscr{C}_{1}^{\infty}$, we set

$$
\begin{equation*}
\mathscr{J}_{t s}\left(f^{1} \mathrm{~d} f^{2} \cdots \mathrm{~d} f^{n} \mathrm{~d} f^{n+1}\right)=\int_{s}^{t} \mathscr{J}_{u s}\left(f^{1} \mathrm{~d} f^{2} \cdots \mathrm{~d} f^{n}\right) \mathrm{d} f_{u}^{n+1} \tag{8}
\end{equation*}
$$

which defines the iterated integrals of smooth functions recursively. Observe that a $n$th order integral $\mathscr{J}\left(\mathrm{d} f^{1} \mathrm{~d} f^{2} \cdots d f^{n}\right)$ could be defined along the same lines.

The following relations between multiple integrals and the operator $\delta$ will also be useful in the remainder of the paper:
Proposition 2.5. Let $f, g$ be two elements of $\mathscr{C}_{1}^{\infty}$. Then, recalling the convention (6); it holds that

$$
\delta f=\mathscr{J}(\mathrm{d} f), \quad \delta(\mathscr{J}(f \mathrm{~d} g))=0, \quad \delta(\mathscr{J}(\mathrm{~d} g \mathrm{~d} f))=(\delta g)(\delta f)=\mathscr{J}(\mathrm{d} g) \mathscr{J}(\mathrm{d} f),
$$

and, in general,

$$
\begin{equation*}
\delta\left(\mathscr{J}\left(\mathrm{d} f^{n} \cdots \mathrm{~d} f^{1}\right)\right)=\sum_{i=1}^{n-1} \mathscr{J}\left(\mathrm{~d} f^{n} \cdots \mathrm{~d} f^{i+1}\right) \mathscr{J}\left(\mathrm{d} f^{i} \cdots \mathrm{~d} f^{1}\right) . \tag{9}
\end{equation*}
$$

Proof. Here again, the proof is elementary, and we will just show the third of these relations: we have, for $s, t \in[0, T]$,

$$
\mathscr{J}_{t s}(\mathrm{~d} g \mathrm{~d} f)=\int_{s}^{t} \mathrm{~d} g_{u}\left(f_{u}-f_{s}\right)=\int_{s}^{t} \mathrm{~d} g_{u} f_{u}-K_{t s}
$$

with $K_{t s}=\left(g_{t}-g_{s}\right) f_{s}$. The first term of the right hand side is easily seen to be in $\operatorname{ker} \delta_{\Sigma_{2}^{*}}$. Thus

$$
\delta(\mathscr{J}(\mathrm{d} g \mathrm{~d} f))_{t u s}=(\delta K)_{t u s}=\left[g_{t}-g_{u}\right]\left[f_{u}-f_{s}\right],
$$

which gives the announced result.

### 2.1.2 Dissection of an integral

To grasp the algorithm underling the rough-path approach to integrals over irregular functions we will exercise ourselves on the deconstruction of a "classic" integral.

With the notations of Sec. 2.1.1 in mind, we will split the integral $\int \varphi(x) \mathrm{d} x=\mathscr{J}(\varphi(x) \mathrm{d} x)$ for a smooth function $x \in \mathscr{C}_{1}$ into "more elementary" components. This decomposition suggest the right structure for the 1d rough paths. A similar exercise for 2 d integrals will be very important in understanding the correct structure of the rough sheets.

The first idea one can have in mind in order to analyze $\mathscr{J}(\varphi(x) \mathrm{d} x)$ is to perform an expansion around the increment $\mathrm{d} x$. By Taylor expansion we have

$$
\begin{equation*}
\mathscr{J}(\varphi(x) \mathrm{d} x)=\varphi(x) \mathscr{J}(\mathrm{d} x)+\mathscr{J}(\mathrm{d} \varphi(x) \mathrm{d} x) . \tag{10}
\end{equation*}
$$

The first term in the r.h.s will be considered "elementary" and not elaborated further. Note that it is defined independently of the regularity of $x$ since $\varphi(x) \mathscr{J}(\mathrm{d} x)=\varphi(x) \delta x$.

Moreover, as a 1 -increment it is easy to see that the second term in the r.h.s. of eq. (10) is smaller than the first but more problematic and we proceed to its dissection by the application of $\delta$ : invoking Proposition 2.5, we get that

$$
\begin{equation*}
\delta(\mathscr{J}(\mathrm{d} \varphi(x) \mathrm{d} x))=\delta(\varphi(x)) \delta x \tag{11}
\end{equation*}
$$

Now the r.h.s. is well defined independently of the regularity of $x$ since

$$
[\delta(\varphi(x)) \delta x]_{t u s}=\left(\varphi\left(x_{t}\right)-\varphi\left(x_{u}\right)\right)\left(x_{u}-x_{s}\right) .
$$

Since $x$ is smooth and assuming that $\varphi$ is differentiable, then $\mathscr{J}(\mathrm{d} \varphi(x) \mathrm{d} x) \in \mathscr{C}_{1}^{1+}$ (since actually it belongs to $\mathscr{C}_{1}^{2}$ by easy bounds on the iterated integral). Then as a consequence of Corollary 2.2 we have that

$$
\begin{equation*}
\mathscr{J}(\mathrm{d} \varphi(x) \mathrm{d} x)=\Lambda \delta[\mathscr{J}(\mathrm{d} \varphi(x) \mathrm{d} x)]=-\Lambda[\delta(\varphi(x)) \delta x] \tag{12}
\end{equation*}
$$

and, as a result, the following expression for the original integral holds

$$
\begin{equation*}
\mathscr{J}(\varphi(x) \mathrm{d} x)=\varphi(x) \delta x-\Lambda(\delta(\varphi(x)) \delta x)=(1-\Lambda \delta)[\varphi(x) \delta x] . \tag{13}
\end{equation*}
$$

Eq. (13) shows that the ordinary integral on the l.h.s. is equivalent to an expression in the r.h.s which does not depend any more on any differentiability assumptions on $x$, indeed the r.h.s makes sense, for example, when $\varphi \in \operatorname{Lip}$ and $x \in \mathscr{C}_{0}^{\gamma}$ for any $\gamma>1 / 2$ : the only thing we have to check is that $\delta(\varphi(x)) \delta x \in \mathscr{C}_{2}^{1+}$ but under these assumptions we have

$$
\left|\left(\varphi\left(x_{t}\right)-\varphi\left(x_{u}\right)\right)\left(x_{u}-x_{s}\right)\right| \leq L_{\varphi}\|x\|_{\gamma}^{2}\|\varphi(x)\|_{\gamma}|t-u|^{\gamma}|u-s|^{\gamma}
$$

where $\|\cdot\|_{\gamma}$ is the ordinary $\gamma$-Hölder norm on functions and $L_{\varphi}$ is the Lipshitz norm of $\varphi$. In this case we can define the integral in the l.h.s. as being equivalent to the well-defined r.h.s. and this new integral is essentially the integral introduced by Young in [22]. What is really relevant to our discussion is to note that the integral can, in this case, be completely recovered from the 1-increment $\varphi(x) \delta x$.

However, the procedure can be continued further on by the next step in the Taylor expansion of the integral (10), which reads, for $s, t \in[0, T]$,

$$
\int_{s}^{t}\left[\mathrm{~d}_{u} \varphi\left(x_{u}\right)\right]=\int_{s}^{t} \varphi^{\prime}\left(x_{u}\right) \mathrm{d} x_{u}=\varphi^{\prime}\left(x_{s}\right)\left[x_{t}-x_{s}\right]+\int_{s}^{t}\left(\int_{s}^{u} \varphi^{\prime}\left(x_{v}\right) \mathrm{d} x_{v}\right) \mathrm{d} x_{u}
$$

or according to the notations of Section 2.1.1,

$$
\begin{equation*}
\delta \varphi(x)=\mathscr{J}(\mathrm{d} \varphi(x))=\mathscr{J}\left(\varphi^{\prime}(x) \mathrm{d} x\right)=\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x)+\mathscr{J}\left(d \varphi^{\prime}(x) \mathrm{d} x\right) \tag{14}
\end{equation*}
$$

Injecting this equality in equation (10), thanks to (8), we obtain

$$
\begin{equation*}
\mathscr{J}(\varphi(x) \mathrm{d} x)=\varphi(x) \mathscr{J}(\mathrm{d} x)+\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)+\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x \mathrm{~d} x\right) \tag{15}
\end{equation*}
$$

In the two first terms in the r.h.s of eq. (15) the function $\varphi(x)$ has "pop out" form the integral, so we consider them elementary (in a sense we will discuss below). Again, the last term in the r.h.s. can be seen to belong to $\mathscr{C}_{1}^{1+}$ (since actually, in this smooth setting, it belongs to $\mathscr{C}_{1}^{3}$ ). Then in analogy with eq. (12) we can represent it in terms of its image under $\delta$ as

$$
\begin{equation*}
\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) d x d x\right)=-\Lambda \delta \mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x \mathrm{~d} x\right)=-\Lambda\left[\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x)\right) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)+\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x\right) \mathscr{J}(\mathrm{d} x)\right] \tag{16}
\end{equation*}
$$

where we acted with $\delta$ upon the triple iterated integral according to Prop. 2.5. Concerning the argument of $\Lambda$ in this last equation, we note the following two facts: $\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x)\right)=\delta \varphi^{\prime}(x)$ while the double iterated integral $\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) d x\right)$ appears in the Taylor expansion for $\delta \varphi(x)$ :

$$
\delta \varphi(x)=\mathscr{J}(\mathrm{d} \varphi(x))=\mathscr{J}\left(\varphi^{\prime}(x) \mathrm{d} x\right)=\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x)+\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x\right)
$$

so

$$
\begin{equation*}
\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x\right)=\delta \varphi(x)-\varphi^{\prime}(x) \delta x \tag{17}
\end{equation*}
$$

Then we can rewrite eq. (16) as

$$
\begin{equation*}
\mathscr{J}\left(\mathrm{d} \varphi^{\prime}(x) \mathrm{d} x \mathrm{~d} x\right)=-\Lambda\left[\delta \varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)+\left(\delta \varphi(x)-\varphi^{\prime}(x) \delta x\right) \mathscr{J}(\mathrm{d} x)\right] \tag{18}
\end{equation*}
$$

and finally we have obtained another expression for the integral $\mathscr{J}(\varphi(x) \mathrm{d} x)$ :

$$
\begin{align*}
\mathscr{J}(\varphi(x) \mathrm{d} x)= & \varphi(x) \delta x+\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x) \\
& \quad-\Lambda\left[\delta \varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)+\left(\delta \varphi(x)-\varphi^{\prime}(x) \delta x\right) \mathscr{J}(\mathrm{d} x)\right]  \tag{19}\\
= & (1-\Lambda \delta)\left[\varphi(x) \delta x+\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)\right]
\end{align*}
$$

where to go from the first equation to the second we used the algebraic relation

$$
\begin{equation*}
\delta \mathscr{J}(\mathrm{d} x \mathrm{~d} x)=\mathscr{J}(\mathrm{d} x) \mathscr{J}(\mathrm{d} x) \tag{20}
\end{equation*}
$$

Up to this point all we got are another equivalent expression for the classic integral in the r.h.s. of eq. (18).

It is a very remarkable basic result of rough path theory that the r.h.s. of eq. (18) makes sense for paths $x$ which are very irregular like the sample paths of Brownian motion (which a.s. are not Hölder continuous for any index greater than $1 / 2$ ), once we have at our disposal also a 1-increment $\mathscr{J}(d x d x)$ which is sufficiently small and satisfy eq. (20). Heuristically, in this situation the formula says that the 1-increment $\varphi(x) \delta x$ can be "corrected" or "renormalized" by adding the correction $\varphi^{\prime}(x) \mathscr{J}(d x d x)$ so that it becomes integrable (in the sense of Corollary 2.3).

In the cases where this correction belongs to $\mathscr{C}_{1}^{1+}$ we have $(1-\Lambda \delta)\left[\varphi^{\prime}(x) \mathscr{J}(\mathrm{d} x \mathrm{~d} x)\right]=0$ so eq. (18) becomes again eq. (12) and we reobtain the Young integral.

It is worth noticing at that point that the integral, as defined by eq. (18), has now to be understood as an integral over the (step-2) rough path $(x, \mathscr{J}(\mathrm{~d} x d x))$ [8] and it coincide with the notion of integral over a rough path given by Lyons in [12].

This algorithm has an obvious extension to higher orders if we assume that a reasonable definition of the iterated integrals $\mathscr{J}(\mathrm{d} x \mathrm{~d} x \cdots \mathrm{~d} x)$ can be given. To proceed further however we need the notion of geometric rough path (for more details on this notion see [12]) which must be exploited crucially to show that some terms are small and belongs to the domain of $\Lambda$.

Note that we have worked in the scalar setting (i.e. all the object we considered are real-valued). Willing to add some notational burden it is easy to see that this section has an equivalent formulation in the vector case (when $x$ takes values on $\mathbb{R}^{n}$ and $\varphi$ is a (smooth) differential from on $\mathbb{R}^{n}$ ). Indeed all the theory is interesting and useful especially in the vector case. This explain the fact that we do not considered techniques like the Doss-Sussmann approach to define one dimensional integrals since they are essentially limited to the scalar setting (where every reasonable differential form $\varphi$ is exact) and do not have a vectorial counterpart.

## 3 The increment complex in two dimensions

In this paper we are interested in particular two-dimensional integrals which can take two basic forms which in general are not equivalent. If $f, g: \mathbb{R}^{2} \rightarrow \mathbb{R}$ are regular enough we can define the two dimensional integral of $f$ wrt. $g$ as

$$
\begin{equation*}
\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} f \mathrm{~d} g:=\int_{s_{1}}^{s_{2}} \mathrm{~d} s \int_{t_{1}}^{t_{2}} \mathrm{~d} t f(s, t) \partial_{1} \partial_{2} g(s, t) \tag{21}
\end{equation*}
$$

where $\partial_{1}$ and $\partial_{2}$ are the partial derivatives wrt. the first and the second coordinate, respectively. Another possible and nonequivalent basic integral in two-dimension is given, for a triple of functions $f, g, h$, by

$$
\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} f \mathrm{~d}_{1} g \mathrm{~d}_{2} h:=\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} f(s, t) \partial_{1} g(s, t) \partial_{2} h(s, t) \mathrm{d} s \mathrm{~d} t
$$

Then

$$
\begin{equation*}
\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} \mathrm{d} g=:(\delta g)\left(s_{1}, t_{1}, s_{2}, t_{2}\right) \tag{22}
\end{equation*}
$$

defines the coboundary map $\delta$ for functions of two parameters:

$$
\begin{align*}
(\delta g)\left(s_{1}, t_{1}, s_{2}, t_{2}\right) & =g\left(s_{2}, t_{2}\right)-g\left(s_{1}, t_{2}\right)-g\left(s_{2}, t_{1}\right)+g\left(s_{1}, t_{1}\right)  \tag{23}\\
& =\left[g\left(s_{2}, t_{2}\right)-g\left(s_{1}, t_{2}\right)\right]-\left[g\left(s_{2}, t_{1}\right)-g\left(s_{1}, t_{1}\right)\right]
\end{align*}
$$

which is just the composition of two finite-difference operator in the two directions. These integrals are to be considered as continuous functions of two points $\left(s_{1}, t_{1}\right)$ and $\left(s_{2}, t_{2}\right)$ on the plane which vanishes whenever $s_{1}=s_{2}$ or $t_{1}=t_{2}$. This preliminary observation leads to the following general construction for a 2 d cochain complex suitable for the analysis of these two-parameter integrals.

Fix a positive real $T$ and let $\mathscr{C} \mathscr{C}_{k, l}(V)$ the space of continuous functions from $[0, T]^{k} \times[0, T]^{l} \rightarrow V$, $V$ some vector space such that

$$
g_{\left(s_{1}, \ldots, s_{k}\right)\left(t_{1}, \ldots, t_{l}\right)}=0
$$

whenever $s_{i}=s_{i+1}$ or $t_{i}=t_{i+1}$. We will write $\mathscr{C} \mathscr{C}_{k, l}=\mathscr{C} \mathscr{C}_{k, l}(\mathbb{R})$.
For $\mathscr{C} \mathscr{C}_{k}(V)=\mathscr{C} \mathscr{C}_{k, k}(V)$ we will use the natural identification with the space of continuous functions from $\left([0, T]^{2}\right)^{k} \rightarrow V$. These will play the rle of $2 \mathrm{~d} k$-increments: they are functions of $k$ points in the square $[0, T]^{2}$ such that they become zero whenever two contiguous arguments have one coordinate in common.

Note that $\mathscr{C} \mathscr{C}_{k, l}=\mathscr{C}_{k} \otimes \mathscr{C}_{l}$ and in general

$$
\begin{equation*}
\mathscr{C} \mathscr{C}_{k, l}(V)=\mathscr{C}_{k} \otimes \mathscr{C}_{l} \otimes V \tag{24}
\end{equation*}
$$

We will call the elements of $\mathscr{C} \mathscr{C}_{k, l}(V)(k, l)$-biincrements and the elements of $\mathscr{C} \mathscr{C}_{k}(V) k$-biincrements. Moreover we introduce one-dimensional coboundaries $\delta_{1}, \delta_{2}$ which acts as described in Sec. 2 on the biincrements view as functions of the first set, or of the second set of arguments, i.e. they acts on the first or second $\mathscr{C}_{*}$ factor according to factorization of eq. (24). To be concrete

$$
\begin{aligned}
& \delta_{1}: \mathscr{C} \mathscr{C}_{k, l}(V) \rightarrow \mathscr{C} \mathscr{C}_{k+1, l}(V) \\
& \delta_{2}: \mathscr{C} \mathscr{C}_{k, l}(V) \rightarrow \mathscr{C} \mathscr{C}_{k, l+1}(V)
\end{aligned}
$$

and for example, if $g \in \mathscr{C}_{\mathscr{C}_{k, l}}(V)$ then

$$
\left(\delta_{1} g\right)_{\left(s_{1}, \cdots, s_{k+1}\right),\left(t_{1}, \cdots, t_{l}\right)}=\sum_{i=1}^{k+1}(-1)^{i+1} g_{\left(s_{1}, \cdots, \hat{s}_{i}, \cdots, s_{k+1}\right),\left(t_{1}, \cdots, t_{l}\right)}
$$

where, as usual, the notation $\hat{s}_{i}$ means that the corresponding argument is omitted. It is easy to see that $\delta_{1}$ and $\delta_{2}$ commute and that

$$
\delta=\delta_{1} \delta_{2}: \mathscr{C} \mathscr{C}_{k}(V) \rightarrow \mathscr{C} \mathscr{C}_{k+1}(V)
$$

is a coboundary, i.e. satisfy the equation $\delta \delta=0$. Moreover, if $g \in \mathscr{C} \mathscr{C}_{k, l}(V)$ we have

$$
(\delta g)_{\left(s_{1}, \cdots, s_{k+1}\right),\left(t_{1}, \cdots, t_{l+1}\right)}=\sum_{i=1}^{k+1} \sum_{j=1}^{l+1}(-1)^{i+j} g_{\left(s_{1}, \cdots, \hat{s}_{i}, \cdots, s_{k+1}\right),\left(t_{1}, \cdots, \hat{t}_{j}, \cdots, t_{j+1}\right)}
$$

Then $\left(\mathscr{C} \mathscr{C}_{*}(V), \delta\right)$ is a cochain complex. It will be important to note that its cohomology is not trivial and that it will play a rle in our subsequent results.

### 3.1 Cohomology of $\left(\mathscr{C} \mathscr{C}_{*}, \delta\right)$

The complex $\left(\mathscr{C} \mathscr{C}_{*}(V), \delta\right)$ is the diagonal of the following commutative diagram


We are mainly interested in the first cohomology group

$$
H_{1}(\mathscr{C} \mathscr{C}, \delta)=\frac{\mathscr{Z} \mathscr{C} \mathscr{C}_{1}(V)}{\mathscr{B} \mathscr{C} \mathscr{C}_{1}(V)}
$$

where as before we denote $\mathscr{Z} \mathscr{C} \mathscr{C}_{k}(V)=\left.\operatorname{Ker} \delta\right|_{\mathscr{C} \mathscr{C}_{k}(V)}$ and $\mathscr{B} \mathscr{C} \mathscr{C}_{k}(V)=\left.\operatorname{Im} \delta\right|_{\mathscr{C} \mathscr{C}_{k-1}(V)}$, the spaces of $k$-bicocycles and $k-1$-bicoboundaries, respectively.

To compute the cohomology consider applications $\sigma_{1}: \mathscr{C}_{\mathscr{C}, l}(V) \rightarrow \mathscr{C}_{6}(1, l(V)$ (for $k \geq 1$ ) and $\sigma_{2}: \mathscr{C} \mathscr{C}_{k, l}(V) \rightarrow \mathscr{C} \mathscr{C}_{k, l-1}(V)$ (for $l \geq 1$ ) which fix the first argument on each direction to the (arbitrary) value 0 . For example:

$$
\left(\sigma_{1} g\right)_{\left(s_{1}, \ldots, s_{k-1}\right)\left(t_{1}, \ldots, t_{l}\right)}=g_{\left(0, s_{1}, \ldots, s_{k-1}\right)\left(t_{1}, \ldots, t_{l}\right)}
$$

and a similar equation for $\sigma_{2}$. Then we have the homotopy formulas

$$
\sigma_{i} \delta_{i}-\delta_{i} \sigma_{i}=1, \quad \text { for } \mathrm{i}=1,2
$$

which are at the origin of the exactness of the one-dimensional complexes forming the rows and the columns of the diagram (25). Let $k \geq 1$. Take $a \in \mathscr{Z} \mathscr{C} \mathscr{C}_{k}(V)$ and let

$$
b=a-\sigma_{1} \delta_{1} a-\sigma_{2} \delta_{2} a
$$

and, using the homotopy formulas, verify that

$$
\delta_{1} b=\delta_{1} a-\delta_{1} a-\delta_{1} \sigma_{2} \delta_{2} a=-\sigma_{2} \delta a=0
$$

since $\delta_{1}$ commutes with $\sigma_{2}$. Similarly $\delta_{2} b=0$. Then $b \in \operatorname{Ker} \delta_{1} \cap \operatorname{Ker} \delta_{2}$ which means that we can write

$$
b=\delta_{1} s_{1} b=\delta_{1} \sigma_{1} \delta_{2} \sigma_{2} b
$$

but since operators with different indexes commutes we can always rewrite this as

$$
b=\delta_{1} \delta_{2} \sigma_{1} \sigma_{2} b=\delta \sigma_{1} \sigma_{2} b
$$

so that $b \in \mathscr{B} \mathscr{C} \mathscr{C}_{k}(V)$. Next, note that $\sigma_{1} \delta_{1} a \in \operatorname{Ker} \delta_{2}$, since $\delta_{2} \sigma_{1} \delta_{1} a=\sigma_{1} \delta a=0$ so $\sigma_{1} \delta_{1} a=\delta_{2} \sigma_{2} \sigma_{1} \delta_{1} a$. Then for any $a \in \mathscr{Z} \mathscr{C} \mathscr{C}_{k}(V)$ we have the decomposition

$$
\begin{equation*}
a=\delta q+\delta_{1} \sigma \delta_{2} a+\delta_{2} \sigma \delta_{1} a \tag{26}
\end{equation*}
$$

for some $q \in \mathscr{C} \mathscr{C}_{k-1}(V)$ where we let $\sigma=\sigma_{1} \sigma_{2}=\sigma_{2} \sigma_{1}$.

### 3.2 Computations in $\mathscr{C} \mathscr{C}_{*, *}$

For $a \in \mathscr{C} \mathscr{C}_{n, m}, b \in \mathscr{C} \mathscr{C}_{k, l}$ we can define the (noncommutative, associative) product $a b \in \mathscr{C} \mathscr{C}_{n+k-1, m+l-1}$ as

$$
a b_{\left(s_{1}, \ldots, s_{n+k-1}\right)\left(t_{1}, \ldots, t_{m+l-1}\right)}=a_{\left(s_{1}, \ldots, s_{n}\right)\left(t_{1}, \ldots, t_{m}\right)} b_{\left(s_{n}, \ldots, s_{n+k-1}\right)\left(t_{m}, \ldots, t_{l+m-1}\right)} .
$$

For example for $a \in \mathscr{C} \mathscr{C}_{2,1}, b \in \mathscr{C} \mathscr{C}_{1,2}$ we have $(a b)_{\left(s_{1}, s_{2}\right)\left(t_{1}, t_{2}\right)}=a_{\left(s_{1}, s_{2}\right) t_{1}} b_{s_{2}\left(t_{1}, t_{2}\right)}$. This definition is suited to work well with the action of $\delta_{1}, \delta_{2}$, for example we have that, if $a, b \in \mathscr{C} \mathscr{C}_{1, *}$ :

$$
\delta_{1}\left(a \delta_{1} b\right)=\delta_{1} a \delta_{1} b, \quad \delta_{1}\left(\delta_{1} b a\right)=-\delta_{1} b \delta_{1} a
$$

If $a, b \in \mathscr{C} \mathscr{C}_{1}$ :

$$
\begin{gathered}
\delta_{2}\left(a \delta_{1} b\right)=\delta_{2} a \delta_{1} b+a \delta b, \\
\left.\delta\left(\delta_{1} a \delta_{2} b\right)=\delta_{1}\left(\left(\delta_{2} \delta_{1} a\right) \delta_{2} b\right)+\delta_{1} a\left(\delta_{2} \delta_{2} b\right)\right)=\delta_{1}\left(\delta a \delta_{2} b\right)=-\delta a \delta b
\end{gathered}
$$

and

$$
\delta\left(\delta_{2} b \delta_{1} a\right)=-\delta b \delta a, \quad \delta(a \delta b)=\delta(\delta a b)=\delta a \delta b
$$

as can be easily checked by a direct computation. In the two parameters setting we will improve our algebraic structure by adding a new type of product for $f \in \mathscr{C} \mathscr{C}_{m, n}$ and $g \in \mathscr{C} \mathscr{C}_{m, l}$ we define $f \circ_{1} g \in \mathscr{C} \mathscr{C}_{m, n+l}$ by

$$
f \circ_{1} g_{\left(s_{1} s_{2} \ldots s_{m}\right)\left(t_{1} t_{2} \ldots t_{n+l-1}\right)}=f_{\left(s_{1} s_{2} \ldots s_{m}\right)\left(t_{1} t_{2} \ldots t_{n}\right)} g_{\left(s_{1} s_{2} \ldots s_{n}\right)\left(t_{n}, t_{n+1} \ldots t_{n+l-1}\right)}
$$

and an analogue definition in the second direction .
For a two-dimensional quantity like the basic integral in eq.(21) we can write down the following relation

$$
\begin{align*}
\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} & {\left[\iint_{\left(s_{1}, t_{1}\right)}^{(s, t)} \mathrm{d} f(u, v)\right] \mathrm{d} g(s, t) } \\
& =\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)}\left[f(s, t)-f\left(s_{1}, t\right)-f\left(s, t_{1}\right)+f\left(s_{1}, t_{1}\right)\right] \mathrm{d} g(s, t) \\
& =\iint_{\left(s_{1}, t_{1}\right)}^{\left(s_{2}, t_{2}\right)} f(s, t) \mathrm{d} g(s, t)+f\left(s_{1}, t_{1}\right)(\delta g)\left(s_{1}, t_{1}, s_{2}, t_{2}\right)  \tag{27}\\
& -\int_{t_{1}}^{t_{2}} f\left(s_{1}, t\right) \mathrm{d}_{2}\left[g\left(s_{2}, t\right)-g\left(s_{1}, t\right)\right] \\
& -\int_{s_{1}}^{s_{2}} f\left(s, t_{1}\right) \mathrm{d}_{1}\left[g\left(s, t_{2}\right)-g\left(s, t_{1}\right)\right]
\end{align*}
$$

which will play the same rle as eq. (10) in the one-dimensional setting.
As an example of the formalism set up up to now we can consider the decomposition of eq. (27) for the (two-dimensional) iterated integral $\iint d f d g$ of two smooth elements $f, g \in \mathscr{C} \mathscr{C}_{1}$. In compact notation it reads:

where we understand the integrals as functions of both the extremes of integration. Note that

Actually the three factors in eq. (28) corresponds exactly to the decomposition (26) since

where the star in the integral sign denote that the lower integration point has been fixed arbitrarily (e.g. to $0 \in[0, T]$ ).

Another relevant remark is to note that the antisymmetric element $\omega^{a}=\delta_{1} f \delta_{2} g-\delta_{2} f \delta_{1} g$ satisfy $\delta \omega^{a}=0$. Indeed

\delta_{1} \omega^{a}=-\delta_{1} f \delta g-\delta f \delta_{1} g, \quad \delta \omega^{a}=-\delta f \delta g+\delta f \delta g=0
$$

according to the rules established above. For the symmetric counterpart $\omega^{s}=\delta_{1} f \delta_{2} g+\delta_{2} f \delta_{1} g$ we have

\delta_{1} \omega^{s}=-\delta_{1} f \delta g+\delta f \delta_{1} g, \quad \delta \omega^{s}=-\delta f \delta g-\delta f \delta g=-2 \delta f \delta g
$$

### 3.3 Splitting and other operations

Each of the vector spaces $\mathscr{C} \mathscr{C}_{k, m}(V)$ is naturally isomorphic to either $\mathscr{C}_{k}\left(\mathscr{C}_{m}(V)\right)$ or to $\mathscr{C}_{m}\left(\mathscr{C}_{k}(V)\right)$ : consider each $k, m$-biincrement either as a $k$-increment in the first direction with values in $m$-increments in the other direction or vice-versa. The multiplication in $\mathscr{C} \mathscr{C}_{*, *}$ is compatible with these isomorphism.

In what follows it will be useful to introduce a one-dimensional splitting map $S$ which sends products $a b \in \mathscr{C}_{2}(V)$ for $a \in \mathscr{C}_{1}(V)$ and $b \in \mathscr{C}_{1}(V)$ to the elementary tensor $S(a b)=a \otimes b \in \mathscr{C}_{1}(V) \stackrel{V}{\otimes}$ $\mathscr{C}_{1}(V)$ where the tensor product is over the algebra $V$. The map is the extended by linearity to the subspace $\mathscr{M}_{2}$ of $\mathscr{C}_{2}$ generated by the linear combinations of products of two elements of $\mathscr{C}_{1}$. Elements of $\mathscr{C}_{1}(V) \stackrel{V}{\otimes} \mathscr{C}_{1}(V)$ are just functions $(t, u, v, s) \mapsto c_{\text {tuvs }}$ of four arguments which are 1-increments in the couple $(t, u)$ and in the couple $(v, s)$ but which may be non-zero for $u=v$. The multiplication $\operatorname{map} \mu: \mathscr{C}_{1}(V) \stackrel{V}{\otimes} \mathscr{C}_{1}(V) \rightarrow \mathscr{C}_{2}(V)$ just sends each $c$ to the 2 -increment $(t, u, s) \mapsto a_{t u u s}$ and is the inverse of $S: \mu \circ S(a)=a$ for any $a \in \mathscr{M}_{2}$.

We will denote $S_{1}: \mathscr{C}_{2}(V) \rightarrow \mathscr{C}_{1}\left(\mathscr{C}_{k}(V)\right) \stackrel{\mathscr{C}_{k}(V)}{\otimes_{1}} \mathscr{C}_{1}\left(\mathscr{C}_{k}(V)\right)$ and $S_{2}: \mathscr{C}_{k}(V) \rightarrow \mathscr{C}_{1}\left(\mathscr{C}_{k}(V)\right) \stackrel{\mathscr{C}_{k}(V)}{\otimes_{2}}$ $\mathscr{C}_{1}\left(\mathscr{C}_{k}(V)\right)$ the splitting maps according to the first or the second direction. These are understood according to the above isomorphism $\mathscr{C}_{k, m}(V) \simeq \mathscr{C}_{k}\left(\mathscr{C}_{m}(V)\right) \simeq \mathscr{C}_{m}\left(\mathscr{C}_{k}(V)\right)$ and the index 1,2 on the tensor product remember in which of the two directions the splitting has taken place.

### 3.4 Abstract integration in $\mathscr{C} \mathscr{C}_{*}$

From now on we assume that $V$ is a Banach space with norm $|\cdot|$. When they appears tensor product will be understood according to the projective topology.

Let us introduce the following norms, for any $g \in \mathscr{C} \mathscr{C}_{2}(V)$

and for $h \in \mathscr{C} \mathscr{C}_{3}(V)$

\|h\|_{\gamma_{1}, \gamma_{2}, \rho_{1}, \rho_{2}}:=\sup _{s, u, t \in[0, T]^{2}} \frac{\left|h_{\left(s_{1}, u_{1}, t_{1}\right)\left(s_{2}, u_{2}, t_{2}\right.}\right|}{\prod_{i=1,2}\left|s_{i}-u_{i}\right| \gamma_{i}\left|u_{i}-t_{i}\right| \rho_{i}}
$$

and

$$
\|h\|_{z_{1}, z_{2}}:=\inf \left\{\sum_{i}\left\|h_{i}\right\|_{\gamma_{1, i}, \gamma_{2, i}, z_{1}-\gamma_{1, i}, z_{2}-\gamma_{2, i}} \mid h=\sum_{i} h_{i}, \gamma_{j, i} \in\left(0, z_{i}\right), j=1,2\right\}
$$

and the corresponding subspaces $\mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}}(V), \mathscr{C} \mathscr{C}_{3}^{\gamma_{1}, \gamma_{2}, \rho_{1}, \rho_{2}}(V)$ and $\mathscr{C} \mathscr{C}_{3}^{z_{1}, z_{2}}(V)$. Moreover we say that $f \in \mathscr{C} \mathscr{C}_{1}^{\rho_{1}, \rho_{2}}$ if

\begin{equation*}
\mathscr{N}_{\rho_{1}, \rho_{2}}(f)=\|\delta f\|_{\rho_{1}, \rho_{2}}+\left\|\delta_{1} f\right\|_{\rho_{1}, 0}+\left\|\delta_{2} f\right\|_{0, \rho_{2}}+\|f\|_{\infty}<+\infty \tag{30}
\end{equation*}
$$

with

$$
\left\|\delta_{1} f\right\|_{\rho_{1}, 0}=\sup _{\left(s_{1}, s_{2}, t_{1}\right) \in[0, T]^{3}} \frac{\left|\delta_{1} f_{s_{1} s_{2} t_{1}}\right|}{\left|s_{2}-s_{1}\right|^{\rho_{1}}}
$$

and similar definition in the second direction. The main feature of the space $\mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}}$ is that $\mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}} \cap$ ker $\delta_{1}=\{0\}$ if $z_{1}>1$ and $\mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}} \cap \operatorname{ker} \delta_{2}=\{0\}$ if $z_{2}>1$. This implies that the equation $\delta a=0$ has only a trivial solution $a=0$ if we require $a \in \mathscr{C} \mathscr{C}_{1}^{z_{1}, z_{2}}$ with $z_{1}, z_{2}>1$.

Let $\mathscr{C} \mathscr{C}_{i}^{1+}(V)=\cup_{z_{1}>1, z_{2}>1} \mathscr{C} \mathscr{C}_{i}^{z_{1}, z_{2}}(V), i=1,2$.
Note that we have the isomorphism $\mathscr{C} \mathscr{C}_{a, b}^{z_{1}, z_{2}}(V) \simeq \mathscr{C}_{a}^{z_{1}}\left(\mathscr{C}_{b}^{z_{2}}(V)\right) \simeq \mathscr{C}_{b}^{z_{2}}\left(\mathscr{C}_{a}^{z_{1}}(V)\right)$ for $a, b=0,1,2$ and $z_{1}, z_{2} \geq 0$.

Before stating the main result of this section we introduce two versions of the one-dimensional $\Lambda$ map of Prop. 2.1, acting on the two different coordinates.
Lemma 3.1. $\Lambda_{1}: \mathscr{B}_{2} \mathscr{C} \mathscr{C}_{3, a}^{w_{1}, z_{2}}(V) \rightarrow \mathscr{C} \mathscr{C}_{2, a}^{w_{1}, z_{2}}(V)$ for $a=1,2,3$ with $w_{1}>1$ such that $\delta_{1} \Lambda_{1}=1$ and

\left\|\Lambda_{1} h\right\|_{z_{1}, w_{2}} \leq C_{z_{1}}\|h\|_{z_{1}, w_{2}} \tag{31}
\end{equation*}
$$

and an analogous bound for $\Lambda_{2}$.
Proof. If we fix $s_{2}, u_{2}, t_{2} \in[0, T]$ we can consider $h^{s_{2} u_{2} t_{2}} \in \mathscr{C}_{2}(V)$ such that

and note that $h^{s_{2} u_{2} t_{2}} \in \mathscr{B} \mathscr{C}_{2}^{z_{1}}(V)$ since $\delta h^{s_{1} u_{1} t_{1}}=0$ so that it is in the range of the one-dimensional $\Lambda$ of Prop. 2.1 and

\begin{equation*}
\left|\left(\Lambda h^{s_{2}, u_{2}, t_{2}}\right)_{s_{1} t_{1}}\right| \leq C_{z_{1}}\left\|h^{s_{2}, u_{2}, t_{2}}\right\|_{z_{1}}\left|s_{1}-t_{1}\right|^{z_{1}} . \tag{32}
\end{equation*}
$$

Then define $\Lambda_{1}$ as

\left(\Lambda_{1} h\right)_{\left(t_{1}, s_{1}\right),\left(t_{2}, u_{2}, s_{2}\right)}:=\left(\Lambda h^{s_{2}, u_{2}, t_{2}}\right)_{s_{1} t_{1}}
$$

and note that the bound (32) implies eq. (31). Proceeding similarly one can prove a similar statement about $\Lambda_{2}$.

Then it holds the analogous of the one-dimensional result:
Proposition 3.2. There exists a unique map $\Lambda: \mathscr{B}_{\mathscr{C}}^{\mathscr{C}} \mathscr{C}_{2}^{1+}(V) \rightarrow \mathscr{C} \mathscr{C}_{1}^{1+}(V)$ such that $\delta \Lambda=1$. Moreover if $z_{1}, z_{2}>1, h \in \mathscr{B} \mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}}(V)$ then

$$
\|\Lambda h\|_{z_{1}, z_{2}} \leq \frac{1}{2^{z_{1}}-2} \frac{1}{2^{z_{2}}-2}\|h\|_{z_{1}, z_{2}}
$$

Proof. Since $h \in \operatorname{Img} \delta$ we have $\delta_{1} h=\delta_{2} h=0$. Then let $\Lambda h=\Lambda_{1} \Lambda_{2} h$ which is meaningful since the $\delta_{1} \Lambda_{2} h=\Lambda_{2} \delta_{1} h=0$ (by linearity) and the requirement on the regularity is satisfied. Then

$$
\delta \Lambda h=\delta_{2} \delta_{1} \Lambda_{1} \Lambda_{2} h=\delta_{2} \Lambda_{2} h=h
$$

and

$$
\|\Lambda h\|_{z_{1}, z_{2}}=\left\|\Lambda_{1} \Lambda_{2} h\right\|_{z_{1}, z_{2}} \leq C_{z_{1}}\left\|\Lambda_{2} h\right\|_{z_{1}, z_{2}} \leq C_{z_{1}} C_{z_{2}}\|h\|_{z_{1}, z_{2}}
$$

Uniqueness depends on the fact that $z_{1}, z_{2}>1$. Using the uniqueness it is easy to deduce that $\Lambda=\Lambda_{2} \Lambda_{1}$, i.e. the one-dimensional maps commute (when they can be both applied).

We can already state an interesting result about integration of "small" biincrements.
Corollary 3.3 (2d integration). Let $a \in \mathscr{C} \mathscr{C}_{2,2}(V)$ such that $\delta_{1} a \in \mathscr{C} \mathscr{C}_{3,2}^{z_{1}, *}, \delta_{2} a \in \mathscr{C} \mathscr{C}_{2,3}^{*, z_{2}}, \delta a \in \mathscr{C} \mathscr{C}_{2,2}^{z_{1}, z_{2}}$ with $z_{1}, z_{1}>1$. There exists $f \in \mathscr{C} \mathscr{C}_{1,1}(V)$ such that

$$
\delta f=\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right) a
$$

and

$$
\lim _{|\Pi| \rightarrow 0} \sum_{i, j} a_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}=(\delta f)_{\left(t^{1}, s^{1}\right),\left(t^{2}, s^{2}\right)}
$$

where the limit is taken over partitions $\Pi=\left\{\left(t_{i}^{1}, t_{j}^{2}\right)_{i, j}\right\}$ of the square $\left[t^{1}, t^{2}\right] \times\left[s^{1}, s^{2}\right]$ into boxes whose maximum size $|\Pi|$ goes to zero.

Proof. The required conditions on $a$ ensure that the 1-biincrement

$$
h=\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right) a=a-\Lambda_{1} \delta_{1} a-\Lambda_{2} \delta_{2} a+\Lambda \delta a
$$

is well defined. By direct computation we have that

\delta_{1} h=\delta_{1}\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right) a=\left(\delta_{1}-\delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right) a=0
$$

and $\delta_{2} h=0$. So $h$ must be in the image of $\delta$, i.e. there exists $f$ such that $h=\delta f$. This proves the first claim.

To prove the convergence of the sums consider the above decomposition

a=\delta f+\Lambda_{2} \delta_{2} a+\Lambda_{1} \delta_{1} a-\Lambda \delta a
$$

written as $a=\delta f+r_{1}+r_{2}+r$ where

r_{1}=\left(1-\Lambda_{1} \delta_{1}\right) \Lambda_{2} \delta_{2} a, \quad r_{2}=\left(1-\Lambda_{2} \delta_{2}\right) \Lambda_{1} \delta_{1} a \quad r=\Lambda \delta a

Note that $r_{1} \in \mathscr{C} \mathscr{C}_{2,2}^{*, z_{2}}, \delta_{1} r_{1}=0$ and $r_{2} \in \mathscr{C} \mathscr{C}_{2,2}^{z_{1}, *}$ and $\delta_{2} r_{2}=0$.

Then let

\begin{aligned}
S_{\Pi}= & \sum_{i, j} a_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)} \\
= & \sum_{i, j}(\delta f)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}+\sum_{i, j}\left(r_{1}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)} \\
& +\sum_{i, j}\left(r_{2}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}+\sum_{i, j}(r)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}
\end{aligned}
$$

and note that, using the fact that $\delta f$ is an exact biincrement

$$
\sum_{i, j}(\delta f)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}=(\delta f)_{\left(t^{1}, s^{1}\right)\left(t^{2}, s^{2}\right)}
$$

and

$$
\sum_{i, j}\left(r_{1}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}=\sum_{j}\left(r_{1}\right)_{\left(t^{1}, s^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}
$$

since $\delta_{1} r_{1}=0$ (i.e. $r_{1}$ is an exact increment in the direction 1 ). In the same way

\sum_{i, j}\left(r_{2}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}=\sum_{i}\left(r_{2}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t^{2}, s^{2}\right)}
$$

Then

\left|\sum_{j}\left(r_{1}\right)_{\left(t^{1}, s^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}\right| \leq\left\|r_{1}\right\| \sum_{j}\left|t_{j+1}^{2}-t_{j}^{2}\right|^{z_{2}} \rightarrow 0
$$

and

$$
\left|\sum_{i}\left(r_{2}\right)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t^{2}, s^{2}\right)}\right| \leq\left\|r_{2}\right\| \sum_{i}\left|t_{i+1}^{1}-t_{i}^{1}\right|^{z_{1}} \rightarrow 0
$$

and finally

$$
\left|\sum_{i, j}(r)_{\left(t_{i+1}^{1}, t_{i}^{1}\right)\left(t_{j+1}^{2}, t_{j}^{2}\right)}\right| \leq\|r\| \sum_{i, j}\left|t_{i+1}^{1}-t_{i}^{1}\right|^{z_{1}}\left|t_{j+1}^{2}-t_{j}^{2}\right|^{z_{2}} \rightarrow 0
$$

as $|\Pi| \rightarrow 0$ which proves our claim.

## 4 Two-dimensional Young theory

Proposition 4.1. Let $f \in \mathscr{C} \mathscr{C}_{1,1}^{\gamma_{1}, \gamma_{2}}, g \in \mathscr{C} \mathscr{C}_{1,1}^{\rho_{1}, \rho_{2}}$ with $\gamma_{1}+\rho_{1}=z_{1}>1, \gamma_{2}+\rho_{2}=z_{2}>1$. Then $\delta f \delta g \in \mathscr{C} \mathscr{C}_{2}^{z_{1}, z_{2}} \cap \operatorname{Img} \delta$ and the integral $\iint f \mathrm{~d} g$ can be defined as

$$
\begin{align*}
\iint f \mathrm{~d} g & =\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right)(f \delta g)  \tag{33}\\
& =-f \delta g+\Lambda(\delta f \delta g)+\int f \mathrm{~d}_{1} \delta_{2} g+\int f \mathrm{~d}_{2} \delta_{1} g
\end{align*}
$$

where $\int f \mathrm{~d}_{1} \delta_{2} g, \int f \mathrm{~d}_{2} \delta_{1} g$ are standard Young integrals. Moreover we can define also the integral $\iint \mathrm{d}_{1} f \mathrm{~d}_{2} g$ as

\iint \mathrm{d}_{1} f \mathrm{~d}_{2} g=\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right)\left(\delta_{1} f \delta_{2} g\right) \tag{34}
\end{equation*}
$$

and for $\rho_{1}, \rho_{2}>1 / 2$ we can define

\begin{equation*}
\iint f \mathrm{~d}_{1} g \mathrm{~d}_{2} g=\left(1-\Lambda_{1} \delta_{1}\right)\left(1-\Lambda_{2} \delta_{2}\right)\left(f \delta_{1} g \delta_{2} g\right) \tag{35}
\end{equation*}
$$

Corollary 4.2. Under the hypothesis of the previous proposition, the two-dimensional sums of the increments $f \delta g$ converge:

where $\Pi:=\left\{\left(s_{i}, t_{j}\right)\right\}_{i, j}$ is a partition of $\left[s_{1}, s_{2}\right] \times\left[t_{1}, t_{2}\right]$ and we denote also by $\Pi_{1}=\left(s_{i}\right)_{i}$ and $\Pi_{2}=\left(t_{j}\right)_{j}$ a respectively partition of $\left[s_{1}, s_{2}\right]$ and $\left[t_{1}, t_{2}\right]$. Once again by the Corollary (3.3) we have that

then $a^{1}$ satisfies the assumption of the Corollary (3.3) which also true for $a^{2}$ and $a^{3}$ by a similar computation. Then the integral $\iint y \mathrm{~d}_{1} x \mathrm{~d}_{2} z, \iint y \mathrm{~d}_{2} z \mathrm{~d}_{1} x$ and $\iint y \mathrm{~d}_{1} x \bullet \mathrm{~d}_{2} z$ are well defined and we have that

& \left(\iint y \mathrm{~d}_{2} z \mathrm{~d}_{1} x\right)_{s_{1} s_{2} t_{1} t_{2}}=\lim _{|\pi| \rightarrow 0} \sum_{i, j} y_{s_{i} t_{j}} \delta_{2} z_{s_{i} t_{j} t_{j+1}} \delta_{1} x_{s_{i} s_{i+1} t_{j+1}}
\end{aligned}

and

To prove that this last integral coincide it suffices to show that the difference between the Riemann sum vanish when the mesh of the partition go to zero. In fact we have that

Using the fact that $\left|\int_{t_{1}}^{t_{2}} y_{s_{i} t} \delta_{1} x_{s_{i} s_{i+1} t} \mathrm{~d}_{t} z_{s_{i} s_{i+1} t}\right| \lesssim\left(s_{i+1}-s_{i}\right)^{\rho_{1}+\beta_{1}}$ we obtain that :

## 5 Analysis of a two-parameter integral

Following the informal approach of sec. 2.1.2 we would like to get inspired for a general construction from the analysis of a concrete two-dimensional integral. Then consider $\iint \varphi(x) \mathrm{d} x$ for a smooth surface $x: \mathbb{R}^{2} \rightarrow \mathbb{R}$ and a smooth function $\varphi: \mathbb{R} \rightarrow \mathbb{R}$. The decomposition of eq.(27) gives

\iint \varphi(x) \mathrm{d} x=-\varphi(x) \int \mathrm{d} x+\int_{1} \varphi(x) \int_{2} \mathrm{~d} x+\int_{2} \varphi(x) \int_{1} \mathrm{~d} x+\iint \mathrm{d} \varphi(x) \mathrm{d} x
$$

where, for example, we used the notation $\int_{1} \varphi(x) \int_{2} \mathrm{~d} x$ to mean

\left(\int_{1} \varphi(x) \int_{2} \mathrm{~d} x\right)_{\left(s_{1}, s_{2} ; t_{1}, t_{2}\right)}:=\int_{s_{1}}^{t_{1}} \varphi\left(x_{u_{1}, s_{2}}\right) \int_{s_{2}}^{t_{2}} \partial_{1} \partial_{2} x\left(u_{1}, u_{2}\right) \mathrm{d} u_{1} \mathrm{~d} u_{2}

and the others analogous expressions.
This decomposition is at the origin of Prop.4.1 when the demanded regularity is satisfied since the iterated integral is given by the formula

Using eq.(45) and the definition of iterated integral, we have

\iint \varphi^{\prime}(x) \mathrm{d} x \mathrm{~d} x=-\varphi^{\prime}(x) \int \mathrm{d} x \mathrm{~d} x+\int_{1} \varphi^{\prime}(x) \int_{2} \mathrm{~d} x \mathrm{~d} x+\int_{2} \varphi^{\prime}(x) \int_{1} \mathrm{~d} x \mathrm{~d} x+\iint \mathrm{d} \varphi^{\prime}(x) \mathrm{d} x \mathrm{~d} x \tag{47}
\end{equation*}
$$

This expression seems complicated, however it shows that, in order to control the l.h.s. we need two ingredients:

1) Being able to define essentially one-dimensional integrals like

2) Control the remainders given by the three-fold iterated integrals

### 5.0.1 The boundary integrals

We call integrals like those appearing in eq.(48) boundary integrals to emphasize their one-dimensional nature (which, we hope, will be clear from what follows). Their appearance is characteristic of the multidimensional setting and it is linked to the cohomological structure of the complex $\left(\mathscr{C}_{\mathscr{*}}, \delta\right)$ studied in Sec. 3. Take the first of them and expand it according to the (one-dimensional) eq.(10):

Next, apply $\delta_{1}$ to the second term in the r.h.s.:

The first term in the r.h.s. is simple since it is equivalent to $\delta_{1} \varphi^{\prime}(x) \iint \mathrm{d} x \mathrm{~d} x$, and can be controlled with some regularity of $\varphi^{\prime}$ and the a-priori knowledge of $\iint \mathrm{d} x \mathrm{~d} x$. The second needs to be further expanded as

& =\varphi^{\prime \prime}(x) \int_{1} \mathrm{~d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x+\int_{1} \mathrm{~d}_{1} \varphi^{\prime \prime}(x) \mathrm{d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x \tag{51}
\end{align*}
$$

Again, the first term in the r.h.s do not pose any further problem so we continue to study only the last one. Set

We apply to $\mathscr{A}_{1}$ the splitting operator $S_{1}$ obtaining

Let us clarify the meaning of this last term: in the first direction is the tensor product of two 1increments, while in the second direction is a 1 -increment. Taking four points $\left(u_{1}, u_{2}, u_{3}, u_{4}\right)$ in direction 1 and two $\left(v_{1}, v_{2}\right)$ in direction 2 , its value is given by the expression

As the reader can easily check, by setting $u_{2}=u_{3}$ we reobtain $\mathscr{A}_{1}$.
Denote with $\delta_{1} \otimes_{1} 1$ the action of the $\delta_{1}$ operator on the first factor of an element of $\mathscr{C}_{1} \otimes \mathscr{C}_{1}$, where again the 1 as index of the tensor operation denote that it acts on tensor products according to the first direction. Apply $\delta_{1} \otimes_{1} 1$ to the r.h.s of eq. (52) last term in the r.h.s to obtain

=\int_{1} \mathrm{~d}_{1} \varphi^{\prime \prime}(x) \int_{1} \mathrm{~d}_{1} x \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x+\int_{1} \mathrm{~d}_{1} \varphi^{\prime \prime}(x) \mathrm{d}_{1} x \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x
\end{array}
$$

Hence let

$$

and (cfr. eq. (17))

\mathscr{A} \mathscr{B}_{1}:=\int_{1} \mathrm{~d}_{1} \varphi^{\prime \prime}(x) \mathrm{d}_{1} x \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x=\left(\delta_{1} \varphi^{\prime \prime}(x)-\varphi^{\prime \prime}(x) \delta_{1} x\right) \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} d x
$$

which depend only on the function $\varphi^{\prime \prime}(x)$ and on the "splitted" iterated integrals

Since we are working under smoothness conditions is possible to recover $\mathscr{A}_{1}$ by applying $\Lambda_{1} \otimes_{1} 1$ : $\mathscr{A}_{1}=-\left(\Lambda_{1} \otimes_{1} 1\right)\left(\mathscr{A}_{\mathscr{A}_{1}}+\mathscr{A} \mathscr{B}_{1}\right)$. Moreover

where recall that $\mu_{1}$ is the multiplication in the first direction which is the inverse operation of the splitting $S_{1}$. Then we can recover also the term $\int_{1} \mathrm{~d}_{1} \varphi^{\prime}(x) \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x$ by eq.(49) and an application of $\Lambda_{1}$. Finally we have obtained the following expression for the boundary term:

where the r.h.s. depends only on a finite number of iterated integrals of $x$.

### 5.0.2 The remainders $\mathscr{R}, \widetilde{\mathscr{R}}$

The three-fold iterated integral $\iint d \varphi^{\prime}(x) d x d x$ will be analyzed in terms of its image under $\delta$ :

The first term is readily controlled in the same spirit as above. Consider the fourth (the third is similar) which we will write as

& =\int_{1} \delta_{2}\left[\varphi^{\prime \prime}(x)\right] \mathrm{d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x+\int_{1} \varphi^{\prime \prime}(x) \mathrm{d}_{1} \delta_{2} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x \\
& =\mathscr{D}_{1}+\mathscr{E}_{1}
\end{align*}
$$

Expanding the integral of $\delta_{2}\left[\varphi^{\prime \prime}(x)\right] \mathrm{d}_{1} x$ we get

& =\delta_{2}\left[\varphi^{\prime \prime}(x)\right] \int_{1} \mathrm{~d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x+\int_{1} \mathrm{~d}_{1} \delta_{2}\left[\varphi^{\prime \prime}(x)\right] \mathrm{d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x \tag{55}
\end{align*}
$$

Again we apply $\left(\delta_{1} \otimes_{1} 1\right) S_{1}$ to the second term:

& =\int_{1} \mathrm{~d}_{1} \delta_{2}\left[\varphi^{\prime \prime}(x)\right] \int_{1} \mathrm{~d}_{1} x \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x+\int_{1} \mathrm{~d}_{1} \delta_{2}\left[\varphi^{\prime \prime}(x)\right] \mathrm{d}_{1} x \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x  \tag{56}\\
& =: \mathscr{D} \mathscr{A}_{1}+\mathscr{D} \mathscr{B}_{1}
\end{align*}
$$

From which we get:

\mathscr{D}_{1}=\delta_{2}\left[\varphi^{\prime \prime}(x)\right] \int_{1} \mathrm{~d}_{1} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x-\mu_{1}\left[\Lambda_{1} \otimes_{1} 1\right]\left(\mathscr{D} \mathscr{A}_{1}+\mathscr{D} \mathscr{B}_{1}\right) \tag{57}
\end{equation*}
$$

And in the same way:

\mathscr{E}_{1}=\varphi^{\prime \prime}(x) \int_{1} \mathrm{~d}_{1} \delta_{2} x \int_{2} \mathrm{~d} x \int_{1} \mathrm{~d} x-\mu_{1}\left[\Lambda_{1} \otimes_{1} 1\right]\left(\mathscr{E} \mathscr{A}_{1}+\mathscr{E} \mathscr{B}_{1}\right) \tag{58}
\end{equation*}

with

Note that

& =\delta_{2}\left[\int_{1} \mathrm{~d}_{1} \varphi^{\prime \prime}(x) \mathrm{d}_{1} x\right] \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x  \tag{59}\\
& =\delta_{2}\left[\delta_{1} \varphi^{\prime}(x)-\varphi^{\prime \prime}(x) \delta_{1} x\right] \int_{1} \int_{2} \mathrm{~d} x \otimes_{1} \int_{1} \mathrm{~d} x
\end{align*}
$$

Together eq.(54), (59) (60) (59) imply the representation:

The only term, appearing in $\mathscr{R}$ which is left is the second term in eq.(53): $\iint d \varphi^{\prime}(x) d x \iint d x$. This term can be handled together a similar term appearing in the expansion of $\widetilde{\mathscr{R}}$ which reads:

Indeed we have that the sum of $\iint d \varphi^{\prime}(x) d x$ and $\iint d \varphi^{\prime \prime}(x) d_{1} x d_{2} x$ which are nontrivial two-dimensional iterated integrals, appear in the expansion for $\delta \varphi(x)$ :

& +\iint \mathrm{d} \varphi^{\prime}(x) \mathrm{d} x+\iint d \varphi^{\prime \prime}(x) \mathrm{d}_{1} x \mathrm{~d}_{2} x
\end{align*}
$$

In this expression all the terms, except the last two can be expressed, following the approach we used for the boundary integrals above, as functional of a small number of integrals of $x$.

### 5.1 Rough sheet

We have shown in this section how the 2-dimensional integral $\iint \varphi(x) \mathrm{d} x$ admits to be expressed as a well behaved functional $F$ of a family $\mathbb{X}$ of iterated integrals of $x$ and of $\varphi(x)$. This functional can then be extended to more irregular functions $x$, not necessarily smooth, in two ways:
a) Algebraic approach. We are given a family $\mathbb{X}$ of biincrements which satisfy algebraic conditions analogous to that which allowed us to perform the computations in this section. In this case, the integral can be defined by the same functional $F$. The algebraic relations are then needed to show that such a definition is consistent with our notion of integral (e.g. that this integral is in the kernel of both $\delta_{1}$ and $\delta_{2}$ ).
b) Geometric approach. We are able to show that, there exists a sequence of families $\mathbb{X}^{n}$ obtained by iterated integrals over smooth 2-dimensional functions $x^{n}$, which converges, under suitable topologies on the biincrements, to a limiting family $\mathbb{X}$. Then by the continuity of the map $F$ we are able to identify the limit of $\iint \varphi\left(x^{n}\right) \mathrm{d} x^{n}$ and to consider it as an extension of the integral over smooth 2 -parameter functions. This is analogous to the geometric theory of rough paths.

Already in the one-dimensional theory the two approaches can give different notions of integrals.

### 5.1.1 Algebraic assumption and Boundary integrals

Hypothesis 5.1. If $a=1,2$ then $\hat{a}=2,1$. Assume that $\alpha, \beta>1 / 3$. Now as in the one parameter case we assume the existence of some algebraic object

Moreover all these formulas have meaning and when $x$ is differentiable we can choose the rough sheet so that they coincide well with their definition in the Riemann-Stieltjes case, which justifies the notation.

Proof. We will only prove the first two formula, for the others we have identical proofs. Let now $x$ a smooth sheet and $y \in \mathscr{Q}_{x}^{\alpha, \beta}$, then we have easily the following expansion

We observe that this definition of the two parameter integral is not consistent with the definition of the controlled sheet, indeed if $y \in \mathscr{K}_{x}^{\alpha, \beta}$ then the element $z \in \mathscr{C} \mathscr{C}_{1,1}$ defined by $z_{0 t}=z_{s 0}=0$ and $\delta z=\iint y \mathrm{~d} x$ is not in general a controlled sheet.

### 5.2 Stability under mapping by regular functions

In this section we show that $\varphi(x) \in \mathscr{K}_{x}^{\alpha, \beta}$ under more algebraic and geometric assumptions. To prove this result we will proceed by linear approximation the problem is that the terms which contain $\mathrm{d}_{1} x \mathrm{~d}_{2} x$ does not approximate well to bypass this difficulty we will start by giving an alternative expression for the space $\mathscr{K}_{x}^{\alpha, \beta}$

Now to simplify the notation we introduce the following definition.
Definition 5.19. Let $x \in \mathscr{C} \mathscr{C}_{1,1}$ a sheet satisfying the Hypothesis $5.1,5.8,5.11$ and 5.17 then we denote by $\mathbb{X}$ the collection of all iterated integrals giving in these Hypothesis and we call it Rough-Sheet associated to $x$ and then we define $\mathscr{H}_{\alpha, \beta}$ the space which contain the rough sheet as the product of the Hölder space giving in these Hypothesis equipped with the product topology.

Now we have the following lemma:

## 6 Enhancement of the fractional Brownian Sheet and Stratonovich formula

Let $(\Omega, \mathscr{F}, \mathbb{P})$ a probability space, in this section we construct the rough-sheet associated to the fractional Brownian sheet $x$. Before staring with probabilistic computation let us recall the definition of such process.

Definition 6.1. The process $\left(x_{s t}\right)_{(s, t) \in[0,1]^{2}}$ defined on the probability space $(\Omega, \mathscr{F}, \mathbb{P})$ is called fractional Brownian sheet with hurst parameter $\alpha, \beta \in[0,1]$ if $x$ is a Gaussian process with covariance function

Let $x^{N}$ the process given by the equation (78) and $\mathbb{X}^{N}$ the associated rough sheet then there exists a random variable $\mathbb{X} \in \mathscr{H}_{h, h^{\prime}}$ such that $\mathbb{X}^{N}$ converges to $\mathbb{X}$ in $L^{p}\left(\Omega, \mathscr{H}_{h, h^{\prime}}\right)$ for all $\left(h, h^{\prime}, p\right) \in\left(\frac{1}{3}, \alpha\right) \times\left(\frac{1}{3}, \beta\right) \times[1,+\infty)$.

To prove the theorem 6.3 we will need the following lemma
Lemma 6.4. Let $\alpha>1 / 3$ and the function defined on $\mathbb{R}^{2}$ by :

In [2] the authors give a definition a la Itô for the multidimensional integral in the case of the Brownian sheet, the aim of this section is to compare their notion of integration with the integral that we defined. More precisely we will show that the two concepts coincide when the rough sheet is understood a la Itô. In all this subsection $x$ is a Brownian sheet and $\mathbb{X}^{I t o}$ the rough sheet be associated where all the iterated integrals are understood in the sense given in [2].

Of course using the same argument as in the lemma 6.5 we can see that our objects satisfy the regularity expected. For example

which the r.h.s vanish when the mesh of the partition go to zero then we have the result.
