# Squarefull Numbers in Arithmetic Progression II 

Tsz Ho Chan


#### Abstract

In this paper, we improve the error term in a previous paper on an asymptotic formula for the number of squarefull numbers in an arithmetic progression.


## 1 Introduction and Main Results

A positive integer $n$ is squarefull if $n=1$ or for every prime $p$ dividing $n, p^{2}$ also divides $n$. They are also known as powerful numbers. In [2], Professor Tsang and the author studied squarefull numbers in arithmetic progression and obtained

Theorem 1 For $(l, q)=1$,
$T_{q}(x ; l):=\sum_{\substack{n \leq x \\ n \text { squarefull } \\ n \equiv l(\bmod q)}} 1=\frac{C_{q}(l)}{\zeta(3)} \prod_{p \mid q}\left(\frac{p^{3}}{p^{3}-1}\right) \frac{x^{1 / 2}}{q}+\frac{D_{q}(l)}{\zeta(2)} \prod_{p \mid q}\left(\frac{p^{2}}{p^{2}-1}\right) \frac{x^{1 / 3}}{q}+O_{\epsilon}\left(\min \left(x^{1 / 6} q^{1 / 3+\epsilon}, x^{1 / 5} q^{\epsilon}\right)\right)$.
Here, for any modulus $q$, we define

$$
N_{2}(n ; q):=\#\left\{x(\bmod q): x^{2} \equiv n(\bmod q),(x, q)=1\right\}
$$

and

$$
N_{3}(n ; q):=\#\left\{x(\bmod q): x^{3} \equiv n(\bmod q),(x, q)=1\right\}
$$

where $\# S$ stands for the number of elements in a set $S$. Also

$$
C_{q}(l):=\sum_{b=1}^{\infty} \frac{N_{2}(l b ; q)}{b^{3 / 2}}
$$

and

$$
D_{q}(l):=-2 \frac{\phi(q)}{q}+\frac{2}{3} \int_{1}^{\infty} \frac{\sum_{a \leq u} N_{3}(l a ; q)-\frac{\phi(q)}{q} u}{u^{5 / 3}} d u
$$

Note that $N_{2}\left(n a^{2} ; q\right)=N_{2}(n ; q)$ and $N_{3}\left(n a^{3} ; q\right)=N_{3}(n ; q)$ for any $(a, q)=1$, and $N_{2}(n ; q)=0=$ $N_{3}(n ; q)$ if $(n, q)>1$. Also note that

$$
\begin{equation*}
\sum_{n \leq q} N_{2}(n ; q)=\phi(q) \text { and } \sum_{n \leq q} N_{3}(n, q)=\phi(q) \tag{1}
\end{equation*}
$$

More recently, Srichan [6] used the method of exponent pairs and obtained the same result with a slightly bigger error term. However, he expressed the main terms using Dirichlet characters and Dirichlet $L$-functions. He also studied the case where $l$ and $q$ are not relatively prime as well as cubefull numbers in arithmetic progressions.

In this paper, we improve the error term further by Kloosterman-type exponential sum method and obtain

Theorem 2 For $(l, q)=1$,

$$
T_{q}(x ; l)=\frac{C_{q}(l)}{\zeta(3)} \prod_{p \mid q}\left(\frac{p^{3}}{p^{3}-1}\right) \frac{x^{1 / 2}}{q}+\frac{D_{q}(l)}{\zeta(2)} \prod_{p \mid q}\left(\frac{p^{2}}{p^{2}-1}\right) \frac{x^{1 / 3}}{q}+O_{\epsilon}\left(\left(x^{1 / 6} q^{1 / 12}+\frac{x^{1 / 5}}{q^{1 / 5}}\right) q^{\epsilon}\right)
$$

As an intermediate step, we also prove
Theorem 3 For $(l, q)=1$ and $0<\mu<1 / 5$,

$$
S_{q}(X ; l):=\sum_{\substack{a^{2} b^{3} \leq X \\ a^{2} b^{3} \equiv l(\bmod q)}} 1=C_{q}(l) \frac{X^{1 / 2}}{q}+D_{q}(l) \frac{X^{1 / 3}}{q}+O_{\epsilon}\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+\min \left(X^{\mu}, q^{1 / 2}\right) q^{\epsilon}\right) .
$$

As an immediate corollary, we have
Corollary 1 For $(l, q)=1$,

$$
T_{q}(x ; l) \lll \epsilon \frac{x^{1 / 2+\epsilon}}{q} \quad \text { for } \quad q \leq x^{1 / 3}
$$

However, one suspects the following is true.
Conjecture 1 For $(l, q)=1$,

$$
T_{q}(x ; l) \ll_{\epsilon} \frac{x^{1 / 2+\epsilon}}{q} \quad \text { for } \quad q \leq x^{1 / 2}
$$

To prove Theorem 3, we need a result on the number of points of the curve $x^{2} y^{3} \equiv l(\bmod q)$ in a box.

Theorem 4 For $(l, q)=1$,

$$
N_{A, B}(K, L)=: \#\left\{(a, b): a^{2} b^{3} \equiv l(\bmod q), A<a \leq A+K, B<b \leq B+L\right\}=\frac{\phi(q) K L}{q^{2}}+O\left(\frac{K+L}{q^{1 / 2-\epsilon}}+q^{1 / 2+\epsilon}\right)
$$

The paper is organized as follows. First, we state and prove some lemmas which are needed later. Then we prove Theorem 4 and use it to prove Theorem 3. Finally, we prove Theorem 2

Some Notations Throughout the paper, $p$ stands for a prime. $p \mid q$ means that $p$ divides $q$, and $p^{a}| | q$ means that $p^{a} \mid q$ but $p^{a+1} \nmid q$. The symbol $\bar{a}$ stands for the multiplicative inverse of $a$ $(\bmod q)($ i.e. $a \bar{a} \equiv 1(\bmod q)$ ). The notations $f(x)=O(g(x)), f(x) \ll g(x)$ and $g(x) \gg f(x)$ are all equivalent to $|f(x)| \leq C g(x)$ for some constant $C>0$. Finally $f(x)=O_{\lambda}(g(x)), f(x)<_{\lambda} g(x)$ or $g(x) \gg_{\lambda} f(x)$ mean that the implicit constant $C$ may depend on $\lambda$.

## 2 Lemmas

Lemma 1 Let $\chi$ be a character $(\bmod q)$ and $\chi^{*}\left(\bmod q^{*}\right)$ be the primitive character that induces $\chi$. Then

\left|\sum_{x=1}^{q} \chi(x) e\left(\frac{a x}{q}\right)\right| \leq \sigma\left(a, q / q^{*}\right) \sqrt{q^{*}}
$$

Proof: See equation (12.48) on page 324 of [3].

Lemma 2 For $(l, q)=1, \alpha \leq 1$,

$$
S=: \sum_{n=1}^{q-1}(n, q)\left|\sum_{b=B+1}^{B+L} e\left(-\frac{n b}{q}\right)\right| \ll d(q) q \log q
$$

Proof: Let $\|x\|$ be the distance from $x$ to the nearest integer. Then we have

\begin{aligned}
S= & \sum_{d \mid q} d \sum_{n^{\prime}=1}^{q / d-1}\left|\sum_{b=B+1}^{B+L} e\left(-\frac{n^{\prime} b}{q / d}\right)\right| \\
& \ll \sum_{d \mid q} d \sum_{n^{\prime}=1}^{q / d-1} \min \left(L, \frac{1}{\left\|\frac{n^{\prime}}{q / d}\right\|}\right) \\
& \ll \sum_{d \mid q} d\left[\sum_{n^{\prime} \leq q /(L d)} L+\sum_{q /(L d)<n^{\prime} \leq q /(2 d)} \frac{q / d}{n^{\prime}}\right] \ll \sum_{d \mid q} d \frac{q}{d} \log q \ll d(q) q \log q .
\end{aligned}
$$

Lemma 3 For $(l, q)=1$,

$$
\begin{aligned}
& \sum_{b \leq u} N_{2}(l b ; q)-\frac{\phi(q)}{q} u=O_{\epsilon}\left(q^{1 / 2+\epsilon}\right) \\
& \sum_{a \leq u} N_{3}(l a ; q)-\frac{\phi(q)}{q} u=O_{\epsilon}\left(q^{1 / 2+\epsilon}\right)
\end{aligned}
$$

Proof: By (1), we can assume that $u \leq q$. By orthogonal property of additive characters, we have

$$
\begin{aligned}
\sum_{b \leq u} N_{2}(l b ; q) & =\sum_{b \leq u} \frac{1}{q} \sum_{n=1}^{q} \sum_{x=1}^{q} e\left(\frac{n\left(x^{2}-l b\right)}{q}\right) \\
& =\frac{\phi(q)}{q}(u+O(1))+\frac{1}{q} \sum_{n=1}^{q-1} \sum_{b \leq u} e\left(\frac{-n l b}{q}\right) \sum_{x=1}^{q} e\left(\frac{n x^{2}}{q}\right) \\
& =\frac{\phi(q)}{q}(u+O(1))+\frac{1}{q} \sum_{n=1}^{q-1} \sum_{b \leq u} e\left(\frac{-n l b}{q}\right) \sum_{y(\bmod q)} e\left(\frac{n y}{q}\right) \sum_{\chi \in G_{2}} \chi(y)
\end{aligned}
$$

where $G_{2}$ is the set of all characters $\chi(\bmod q)$ such that $\chi^{2}=\chi_{0}$, the principal character. Interchanging the summations, we have

$$
\begin{aligned}
\sum_{b \leq u} N_{2}(l b ; q) & =\frac{\phi(q)}{q}(u+O(1))+\frac{1}{q} \sum_{\chi \in G_{2}} \sum_{n=1}^{q-1} \sum_{b \leq u} e\left(\frac{-n l b}{q}\right) \sum_{y(\bmod q)} \chi(y) e\left(\frac{n y}{q}\right) \\
& =\frac{\phi(q)}{q}(u+O(1))+O\left(\frac{1}{q} \sum_{\chi \in G_{2}} \sum_{n=1}^{q-1}\left|\sum_{b \leq u} e\left(\frac{-n l b}{q}\right)\right|(n, q) d((n, q)) \sqrt{q}\right) \\
& =\frac{\phi(q)}{q}(u+O(1))+O\left(\frac{d(q)}{\sqrt{q}}\left|G_{2}\right| \sum_{n=1}^{q-1}\left|\sum_{b \leq u} e\left(\frac{-n l b}{q}\right)\right|(n, q)\right) \\
& =\frac{\phi(q)}{q} u+O_{\epsilon}\left(q^{1 / 2+\epsilon}\right)
\end{aligned}
$$

by Lemma 1 Lemma 2 and $d(q)<_{\epsilon} q^{\epsilon}, N_{2}(n ; q)<_{\epsilon} q^{\epsilon}$ (See Nagell [5) and the fact that the group of characters $(\bmod q)$ is isomorphic to the group of reduced residues $\mathbb{Z} / q \mathbb{Z}^{*}$. The proof of the result for $N_{3}(l a ; q)$ is almost identical except that one should use $G_{3}$, the set of all characters $\chi(\bmod q)$ such that $\chi^{3}=\chi_{0}$, instead of $G_{2}$.

Below we are going to study the exponential sum

$$
S(a, b ; q):=\sum_{n=1}^{q} e\left(\frac{a n^{2}+b \bar{n}^{3}}{q}\right)
$$

Suppose $q=r s$ with $(r, s)=1$. By the "reciprocity" formula

$$
\frac{\bar{s}}{r}+\frac{\bar{r}}{s}=\frac{1}{q}(\bmod 1)
$$

where $s \bar{s} \equiv 1(\bmod r)$ and $r \bar{r} \equiv 1(\bmod s)$,

$$
e\left(\frac{a n^{2}+b \bar{n}^{3}}{q}\right)=e\left(\frac{a \bar{s} n^{2}+b \bar{s} \bar{n}^{3}}{r}\right) e\left(\frac{a \bar{r} n^{2}+b \bar{r} \bar{n}^{3}}{s}\right)
$$

and hence with $n=s x+r y$ with $1 \leq x \leq r, 1 \leq y \leq s,(x, r)=1$ and $(y, s)=1$

$$
\begin{equation*}
S(a, b ; q)=\sum_{x=1}^{r} \sum_{y=1}^{s} e\left(\frac{a \bar{s} x^{2}+b \bar{s} \bar{x}^{3}}{r}\right) e\left(\frac{a \bar{r} y^{2}+b \bar{r} \bar{y}^{3}}{s}\right)=S(a \bar{s}, b \bar{s} ; r) S(a \bar{r}, b \bar{r} ; s) . \tag{2}
\end{equation*}
$$

Therefore the study of $S(a, b ; q)$ reduces to that of prime power moduli. When $q=p$ is prime, we have by Theorem 5 of [1] with the rational function $R(x)=\frac{a x^{5}+b}{x^{3}}$ that

$$
\begin{equation*}
|S(a, b ; p)| \leq 2(a, b, p)^{1 / 2} p^{1 / 2} \tag{3}
\end{equation*}
$$

Note: When $(a, b, p)=1$, one needs to check that $R(x) \neq h(x)^{p}-h(x)$ for $h(x) \in \overline{\mathbb{Z} / p \mathbb{Z}}[x]$. Suppose not, then

$$
\begin{equation*}
\frac{a x^{5}+b}{x^{3}}=\frac{f(x)^{p}}{g(x)^{p}}-\frac{f(x)}{g(x)} \text { or } g(x)^{p}\left(a x^{5}+b\right)=x^{3}\left(f(x)^{p}-g(x)^{p-1} f(x)\right) \tag{4}
\end{equation*}
$$

with $(f(x), g(x))=1$. This forces $g(x)^{p} \mid x^{3}$. If $p>3$, then this forces $g(x)$ to be a constant. Then (4) is impossible by degree consideration. If $p \leq 3$, one can obtain (3) by bounding the exponential sum trivially.

For prime power moduli $q=p^{\beta}$ with $\beta \geq 2$, we may assume that $(a, b, p)=1$ for otherwise we can reduce the modulus to a lower exponent. If $\beta=2 \alpha$ with $\alpha \geq 1$, by Lemma 12.2 in [3], we have

\begin{equation*}
S\left(a, b ; p^{2 \alpha}\right)=p^{\alpha} \sum_{\substack{y=1 \\ g^{\prime}(y) \equiv 0\left(\bmod p^{\alpha}\right)}}^{p^{\alpha},} e\left(\frac{g(y)}{p^{2 \alpha}}\right) \tag{5}
\end{equation*}
$$

where $g(y)=\frac{a y^{5}+b}{y^{3}}$. Note $g^{\prime}(y)=\frac{2 a y^{7}-3 b y^{2}}{y^{6}}$. Since $(y, p)=1, g^{\prime}(y) \equiv 0\left(\bmod p^{\alpha}\right)$ when

$$
\begin{equation*}
2 a y^{5}-3 b \equiv 0\left(\bmod p^{\alpha}\right) \tag{6}
\end{equation*}
$$

If $(b, p)=p$, then $(a, p)=1$ and (6) has no solution with $(y, p)=1$ unless $p=2$ in which case

$$
a y^{5}-3\left(\frac{b}{2}\right) \equiv 0\left(\bmod 2^{\alpha-1}\right)
$$

has at most one solution by Hensel's lemma. So we can suppose $(b, p)=1$. If $p=2$, (6) has no solution. If $p=3$, then (6) has no solution unless $3 \| a$ in which case

$$
2\left(\frac{a}{3}\right) y^{5} \equiv b\left(\bmod 3^{\alpha-1}\right)
$$

has at most five solutions by using primitive root $\left(\bmod 3^{\alpha-1}\right)$. If $p>3$, then (6) has no solution unless $(a, p)=1$ in which case it has at most five solutions by using primitive root $\left(\bmod p^{\alpha}\right)$. Therefore we can conclude that

$$
\begin{equation*}
\left|S\left(a, b ; p^{2 \alpha}\right)\right| \leq 5 p^{\alpha} \text { if }(a, b, p)=1 \tag{7}
\end{equation*}
$$

Now if $\beta=2 \alpha+1$ with $\alpha \geq 1$, by Lemma 12.3 in [3, we have

$$
\begin{equation*}
S\left(a, b, p^{2 \alpha+1}\right)=p^{\alpha} \sum_{\substack{y=1 \\ g^{\prime}(y) \equiv 0\left(\bmod p^{\alpha}\right)}}^{p^{\alpha}} e\left(\frac{g(y)}{p^{2 \alpha+1}}\right) G_{p}(y) \tag{8}
\end{equation*}
$$

where $g(y)=\frac{a y^{5}+b}{y^{3}}$,

$$
G_{p}(y)=\sum_{z=1}^{p} e\left(\frac{d(y) z^{2}+g^{\prime}(y) p^{-\alpha} z}{p}\right)
$$

and $d(y)=\frac{g^{\prime \prime}(y)}{2}$. Note $g^{\prime}(y)=\frac{2 a y^{7}-3 b y^{2}}{y^{6}}$ and $g^{\prime \prime}(y)=\frac{2 a y^{8}+12 b y^{3}}{y^{8}}$. So $d(y)=\frac{a y^{8}+6 b y^{3}}{y^{8}}$. If $(b, p)=p$, then by the analysis in the case $\beta=2 \alpha$, the sum in (8) is empty unless $p=2$ in which case one has $\left|S\left(a, b, 2^{2 \alpha+1}\right)\right| \leq 2^{\alpha+1}$. Now suppose $(b, p)=1$. If $p \neq 3,5$, we consider those $y$ such that $(y, p)=1$ and satisfy (6). Then one can show that $p \nmid 2 d(y)$ (for otherwise $p \mid 2 a y^{5}+12 b$ and $p \mid 2 a y^{5}-3 b$ imply $p \mid 15 b$, a contradiction.) Then the Gauss sum $G_{p}(y)$ satisfies $\left|G_{p}(y)\right| \leq p^{1 / 2}$ (see equation (12.37) on page 322 of 3 for example) and hence $\left|S\left(a, b ; p^{2 \alpha+1}\right)\right| \leq 5 p^{\alpha+1 / 2}$ as there are at most five solutions to (6). If $p=3$ or $5,\left|G_{p}(y)\right| \leq 5$ and hence $\left|S\left(a, b ; p^{2 \alpha+1}\right)\right| \leq 25 p^{\alpha+1 / 2}$. In any case, we have

\begin{equation*}
\left|S\left(a, b ; p^{2 \alpha+1}\right)\right| \leq 25 p^{\alpha+1 / 2} \text { if }(a, b, p)=1 \tag{9}
\end{equation*}
$$

Hence combining (3), (7) and (9), we have

$$
\left|S\left(a, b, p^{\beta}\right)\right| \leq 25\left(a, b, p^{\beta}\right)^{1 / 2} p^{\beta / 2}
$$

and, by (2), we have

## Lemma 4

$$
|S(a, b, q)| \leq 25^{\omega(q)}(a, b, q)^{1 / 2} q^{1 / 2}<_{\epsilon}(a, b, q)^{1 / 2} q^{1 / 2+\epsilon} .
$$

## 3 Proof of Theorem 4

Recall $N_{A, B}(K, L)=: \#\left\{(a, b): a^{2} b^{3} \equiv l(\bmod q), A<a \leq A+K, B<b \leq B+L\right\}$. Note that if $a^{2} b^{3} \equiv l(\bmod q)$, then $a^{2} b^{4} \equiv l b(\bmod q)$ and $b \equiv \bar{l}\left(a b^{2}\right)^{2}(\bmod q)$. So
$N_{A, B}(K, L)=\#\left\{(a, b, w): b \equiv \bar{l} w^{2}(\bmod q), a \equiv l \bar{w}^{3}(\bmod q), A<a \leq A+K, B<b \leq B+L, 1 \leq w \leq q,(w, q)=1\right\}$.
By orthogonality of additive characters,

$$
N_{A, B}(K, L)=\frac{1}{q^{2}} \sum_{m=1}^{q} \sum_{n=1}^{q} \sum_{A<a \leq A+K} \sum_{B<b \leq B+L} \sum_{w}^{\prime} e\left(\frac{m\left(l^{2} \bar{w}^{3}-a\right)}{q}\right) e\left(\frac{n\left(\bar{l} w^{2}-b\right)}{q}\right) .
$$

Separating the main contribution from $(m, n)=(q, q)$, we have

$$
\begin{aligned}
N_{A, B}(K, L)= & \frac{\phi(q)([A+K]-[A])([B+L]-[B])}{q^{2}} \\
& +\frac{K}{q^{2}} \sum_{n=1}^{q-1} \sum_{B<b \leq B+L} \sum_{w}^{\prime} e\left(\frac{n\left(\bar{l} w^{2}-b\right)}{q}\right)+\frac{L}{q^{2}} \sum_{m=1}^{q-1} \sum_{A<a \leq A+K} \sum_{w}^{\prime} e\left(\frac{m\left(l^{2} \bar{w}^{3}-a\right)}{q}\right) \\
& +\frac{1}{q^{2}} \sum_{m=1}^{q-1} \sum_{n=1}^{q-1} \sum_{A<a \leq A+K} \sum_{B<b \leq B+L} \sum_{w}^{\prime} e\left(\frac{m\left(l \bar{w}^{3}-a\right)}{q}\right) e\left(\frac{n\left(\bar{l} w^{2}-b\right)}{q}\right):=S_{1}+S_{2}+S_{3}+S_{4}
\end{aligned}
$$

Firstly,

$$
S_{2}=\frac{K}{q^{2}} \sum_{n=1}^{q-1} \sum_{B<b \leq B+L} e\left(-\frac{n b}{q}\right) S(\bar{l} n, 0 ; q) \ll_{\epsilon} \frac{K}{q^{1 / 2-\epsilon}}
$$

by Lemma 2 and Lemma 4. Similarly,

$$
S_{3} \ll \epsilon \frac{L}{q^{1 / 2-\epsilon}}
$$

Finally,

$$
\begin{aligned}
S_{4} & =\frac{1}{q^{2}} \sum_{m=1}^{q-1} \sum_{A<a \leq A+K} e\left(-\frac{m a}{q}\right) \sum_{n=1}^{q-1} \sum_{B<b \leq B+L} e\left(-\frac{n b}{q}\right) S\left(m l^{2}, n \bar{l} ; q\right) \\
& \ll \epsilon \frac{1}{q^{2}} \sum_{m=1}^{q-1}\left|\sum_{A<a \leq A+K} e\left(-\frac{m a}{q}\right)\right| \sum_{n=1}^{q-1}\left|\sum_{B<b \leq B+L} e\left(-\frac{n b}{q}\right)\right|(m, n, q)^{1 / 2} q^{1 / 2+\epsilon} \\
& \ll \epsilon_{\epsilon} \frac{1}{q^{3 / 2-\epsilon}} \sum_{m=1}^{q-1}\left|\sum_{A<a \leq A+K} e\left(-\frac{m a}{q}\right)\right| \sum_{n=1}^{q-1}\left|\sum_{B<b \leq B+L} e\left(-\frac{n b}{q}\right)\right|(n, q)^{1 / 2}<_{\epsilon} q^{1 / 2+\epsilon}
\end{aligned}
$$

by Lemmas 2, 3 and 4. Therefore

$$
N_{A, B}(K, L)=\frac{\phi(q) K L}{q^{2}}+O\left(\frac{K+L}{q^{1 / 2-\epsilon}}+q^{1 / 2+\epsilon}\right)
$$

which gives Theorem 4.

## 4 Proof of Theorem 3

Suppose $\lambda, \mu<1 / 5$.

(\bmod q)}} 1=\sum_{b \leq X^{\mu}} N_{2}(l b ; q)\left[\frac{X^{\lambda}}{q}+O(1)\right] \\
& =\frac{X^{\lambda}}{q} \sum_{b \leq X^{\mu}} N_{2}(l b ; q)+O_{\epsilon}\left(\sum_{b \leq X^{\mu}} N_{2}(l b ; q)\right)=\frac{\phi(q)}{q^{2}} X^{\lambda+\mu}+O_{\epsilon}\left(\frac{X^{\lambda}}{q^{1 / 2-\epsilon}}\right)+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right)
\end{aligned}
$$

by definition of $N_{2}(n ; q)$, Lemma 3 and $N_{2}(n ; q) \ll_{\epsilon} q^{\epsilon}$ (See Nagell [5). Secondly,

$$
\begin{aligned}
T_{1} & =\sum_{\substack{b \leq X^{\mu} \\
(b, q)=1}} \sum_{\substack{a \leq X^{1 / 2} / b^{3 / 2} \\
a^{2} \equiv l b^{3}(\bmod q)}} 1=\sum_{b \leq X^{\mu}} N_{2}(l b ; q)\left[\frac{X^{1 / 2}}{b^{3 / 2} q}+O(1)\right] \\
& =\frac{X^{1 / 2}}{q} \sum_{b \leq X^{\mu}} \frac{N_{2}(l b ; q)}{b^{3 / 2}}+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right) \\
& =\frac{X^{1 / 2}}{q} \sum_{b=1}^{\infty} \frac{N_{2}(l b ; q)}{b^{3 / 2}}-\frac{X^{1 / 2}}{q} \int_{X^{\mu}}^{\infty} \frac{1}{u^{3 / 2}} d \sum_{b \leq u} N_{2}(l b ; q)+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right) \\
& =C_{q}(l) \frac{X^{1 / 2}}{q}-2 \frac{\phi(q) X^{1 / 2-\mu / 2}}{q^{2}}-\frac{X^{1 / 2}}{q} \int_{X^{\mu}}^{\infty} \frac{1}{u^{3 / 2}} d\left(\sum_{b \leq u} N_{2}(l b ; q)-\frac{\phi(q)}{q} u\right)+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right) \\
& =C_{q}(l) \frac{X^{1 / 2}}{q}-2 \frac{\phi(q) X^{1 / 2-\mu / 2}}{q^{2}}-\frac{3}{2} \frac{X^{1 / 2}}{q} \int_{X^{\mu}}^{\infty} \frac{\sum_{b \leq u} N_{2}(l b ; q)-\frac{\phi(q)}{q} u}{u^{5 / 2}} d u+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right) \\
& =C_{q}(l) \frac{X^{1 / 2}}{q}-2 \frac{\phi(q)}{q^{2}} X^{1 / 2-\mu / 2}+O\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}\right)+O_{\epsilon}\left(X^{\mu} q^{\epsilon}\right)
\end{aligned}
$$

by definition of $N_{2}(n ; q)$, Lemma 3 and $N_{2}(n ; q) \ll_{\epsilon} q^{\epsilon}$.
Thirdly, let

F(u):=\sum_{l_{1} \leq u} N_{3}\left(l l_{1} ; q\right)-\frac{\phi(q)}{q} u .
$$

We can have

$$
\begin{aligned}
T_{2} & =\sum_{\substack{a \leq X^{\lambda} \\
(a, q)=1}} \sum_{\substack{b \leq X^{1 / 3} / a^{2 / 3} \\
b^{3} \equiv l a^{2}(\bmod q)}} 1=\sum_{a \leq X^{\lambda}} N_{3}(l a ; q)\left[\frac{X^{1 / 3}}{a^{2 / 3} q}+O(1)\right] \\
& =\frac{X^{1 / 3}}{q} \sum_{a \leq X^{\lambda}} \frac{N_{3}(l a ; q)}{a^{2 / 3}}+O\left(\sum_{a \leq X^{\lambda}} N_{3}(l a ; q)\right) \\
& =\frac{X^{1 / 3}}{q} \int_{1}^{X^{\lambda}} \frac{1}{u^{2 / 3}} d F(u)+\frac{X^{1 / 3}}{q} \frac{\phi(q)}{q} \int_{1}^{X^{\lambda}} \frac{1}{u^{2 / 3}} d u+O_{\epsilon}\left(X^{\lambda} q^{\epsilon}\right) \\
& =\frac{X^{1 / 3}}{q}\left[O\left(\frac{q^{1 / 2+\epsilon}}{\left(X^{\lambda}\right)^{2 / 3}}\right)+\frac{\phi(q)}{q}+\frac{2}{3} \int_{1}^{X^{\lambda}} \frac{F(u)}{u^{5 / 3}} d u\right]+\frac{\phi(q) X^{1 / 3}}{q^{2}}\left[3 X^{\lambda / 3}-3\right]+O_{\epsilon}\left(X^{\lambda} q^{\epsilon}\right) \\
& =3 \frac{\phi(q)}{q^{2}} X^{1 / 3+\lambda / 3}+\left[-2 \frac{\phi(q)}{q}+\frac{2}{3} \int_{1}^{X^{\lambda}} \frac{F(u)}{u^{5 / 3}} d u\right] \frac{X^{1 / 3}}{q}+O\left(\frac{X^{1 / 3-2 \lambda / 3}}{q^{1 / 2-\epsilon}}\right)+O_{\epsilon}\left(X^{\lambda} q^{\epsilon}\right) \\
& =3 \frac{\phi(q)}{q^{2}} X^{1 / 3+\lambda / 3}+\left[-2 \frac{\phi(q)}{q}+\frac{2}{3} \int_{1}^{\infty} \frac{F(u)}{u^{5 / 3}} d u\right] \frac{X^{1 / 3}}{q}+O\left(\frac{X^{1 / 3-2 \lambda / 3}}{q^{1 / 2-\epsilon}}\right)+O_{\epsilon}\left(X^{\lambda} q^{\epsilon}\right)
\end{aligned}
$$

by definition of $N_{3}(n ; q)$, Lemma 3 and $N_{3}(n ; q) \ll_{\epsilon} q^{\epsilon}$.
Finally, we deal with $T_{4}$. We are going to partition the region $\left\{(a, b): X^{\lambda}<a, X^{\mu}<b, a^{2} b^{3} \leq X\right\}$ into rectangles with some left-over regions. We follow closely the construction in 4. Here we require that the choices for $\lambda$ and $\mu$ are such that $\log _{2} X^{1 / 2-3 \mu / 2-\lambda}$ is an integer.

Firstly, we begin with the rectangles

R_{i}=:\left(2^{i-1} X^{\lambda}, 2^{i} X^{\lambda}\right] \times\left(X^{\mu},\left(\frac{X}{\left(2^{i} X^{\lambda}\right)^{2}}\right)^{1 / 3}\right] \quad \text { for } 1 \leq i<I=\log _{2} X^{1 / 2-3 \mu / 2-\lambda}
$$

In the remaining regions

$$
S_{i}=:\left\{(a, b): 2^{i-1} X^{\lambda}<a \leq 2^{i} X^{\lambda}, b>\left(\frac{X}{\left(2^{i} X^{\lambda}\right)^{2}}\right)^{1 / 3}, a^{2} b^{3} \leq X\right\} \text { for } i=1,2, \ldots, I
$$

we place additional rectangles $R_{i j k}$. In $S_{i}$ we put

$$
R_{i 11}=\left(2^{i-1} X^{\lambda}, 2^{i-1}\left(1+\frac{1}{2}\right) X^{\lambda}\right] \times\left(\left(\frac{X}{\left(2^{i} X^{\lambda}\right)^{2}}\right)^{1 / 3},\left(\frac{X}{\left(2^{i-1}\left(1+\frac{1}{2}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}\right]
$$

Left over in $S_{i}$ are two regions of the same kind into each of which we place a further rectangle and so on. Thus on the $j$-th occasion we place $2^{j-1}$ rectangles $R_{i j k}\left(1 \leq k \leq 2^{j-1}\right)$ where
$R_{i j k}=\left(2^{i-1}\left(1+\frac{2 k-2}{2^{j}}\right) X^{\lambda}, 2^{i-1}\left(1+\frac{2 k-1}{2^{j}}\right) X^{\lambda}\right] \times\left(\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k}{2^{j}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3},\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-1}{2^{j}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}\right]$.
The left over regions are
$S_{i j k}=\left\{(a, b): 2^{i-1}\left(1+\frac{2 k-2}{2^{j}}\right) X^{\lambda}<a \leq 2^{i-1}\left(1+\frac{2 k-1}{2^{j}}\right) X^{\lambda}, b>\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-1}{2^{j}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}, a^{2} b^{3} \leq X\right\}$
and
$S_{i j k}^{\prime}=\left\{(a, b): 2^{i-1}\left(1+\frac{2 k-1}{2^{j}}\right) X^{\lambda}<a \leq 2^{i-1}\left(1+\frac{2 k}{2^{j}}\right) X^{\lambda}, b>\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k}{2^{j}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}, a^{2} b^{3} \leq X\right\}$.
We keep doing this until $j=J$. Hence, by Theorem 4

$$
\begin{aligned}
T_{4}= & \sum_{i=1}^{I-1} \sum_{\substack{(a, b) \in R_{i} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1+\sum_{j=1}^{J} \sum_{i=1}^{I} \sum_{k=1}^{2^{j-1}} \sum_{\substack{(a, b) \in R_{i j k} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1+\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \sum_{\substack{(a, b) \in S_{i J k} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1+\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \sum_{\substack{(a, b) \in S_{i J k}^{\prime} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1 \\
= & \frac{\phi(q)}{q^{2}} \text { Area of }\left\{(a, b): X^{\lambda}<a, X^{\mu}<b, a^{2} b^{3} \leq X\right\}+O_{\epsilon}\left(I 2^{J} q^{1 / 2+\epsilon}\right)+O\left(\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \frac{\text { Area of } S_{i J k}}{q}\right) \\
& +O\left(\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \frac{\text { Area of } S_{i J k}^{\prime}}{q}\right)+O\left(\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \sum_{\substack{(a, b) \in S_{i J k} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1\right)+O\left(\sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \sum_{\substack{(a, b) \in S_{i J k}^{\prime} \\
a^{2} b^{3} \equiv l(\bmod q)}} 1\right)
\end{aligned}
$$

Note that
$S_{i J k} \subset\left(2^{i-1}\left(1+\frac{2 k-2}{2^{J}}\right) X^{\lambda}, 2^{i-1}\left(1+\frac{2 k-1}{2^{J}}\right) X^{\lambda}\right] \times\left(\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-1}{2^{J}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3},\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-2}{2^{J}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}\right]$.

So the area of $S_{i J k}$ is at most

\frac{2^{i-1} X^{\lambda}}{2^{J}}\left[\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-2}{2^{J}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}-\left(\frac{X}{\left(2^{i-1}\left(1+\frac{2 k-1}{2^{J}}\right) X^{\lambda}\right)^{2}}\right)^{1 / 3}\right] \ll \frac{2^{i-1} X^{\lambda}}{2^{J}} \cdot \frac{X^{1 / 3}}{\left(2^{i-1} X^{\lambda}\right)^{2 / 3}} \cdot \frac{1}{2^{J}}
$$

So the second and fourth error terms are

$$
\ll \epsilon \sum_{i=1}^{I} \sum_{k=1}^{2^{J-1}} \frac{\left(2^{i-1} X^{\lambda}\right)^{1 / 3} X^{1 / 3}}{q} \frac{1}{2^{2 J}}+q^{1 / 2+\epsilon} \ll \frac{X^{1 / 2-\mu / 2}}{2^{J} q}+2^{J} q^{1 / 2+\epsilon} \log X
$$

Similarly, we have the same error bound for the third and the fifth error terms. Therefore

$$
\begin{aligned}
T_{4} & =\frac{\phi(q)}{q^{2}} \int_{X^{\lambda}}^{X^{1 / 2-3 \mu / 2}}\left(\frac{X}{a^{2}}\right)^{1 / 3}-X^{\mu} d a+O_{\epsilon}\left(\frac{X^{1 / 2-\mu / 2}}{2^{J} q}+2^{J} q^{1 / 2+\epsilon} \log X\right) \\
& =\frac{\phi(q)}{q^{2}}\left[2 X^{1 / 2-\mu / 2}-3 X^{1 / 3+\lambda / 3}-X^{\lambda+\mu}\right]+O_{\epsilon}\left(\frac{X^{1 / 2-\mu / 2}}{2^{J} q}+2^{J} q^{1 / 2+\epsilon} \log X\right) .
\end{aligned}
$$

Hence
$S_{q}(X ; l)=C_{q}(l) \frac{X^{1 / 2}}{q}+D_{q}(l) \frac{X^{1 / 3}}{q}+O_{\epsilon}\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+\frac{X^{1 / 3-2 \lambda / 3}}{q^{1 / 2-\epsilon}}+X^{\lambda} q^{\epsilon}+X^{\mu} q^{\epsilon}+\frac{X^{1 / 2-\mu / 2}}{2^{J} q}+2^{J} q^{1 / 2+\epsilon} \log X\right)$.
We are going to pick $X^{\lambda}$ to have the same size as $X^{\mu}$ with $\mu \leq 1 / 5$. Then the first error term dominates the second one. We will also pick $2^{J}$ such that $\frac{X^{\mu}}{2^{J} q^{1 / 2}} \ll 1$. Then the first error term dominates the fifth one. So

$$
S_{q}(X ; l)=C_{q}(l) \frac{X^{1 / 2}}{q}+D_{q}(l) \frac{X^{1 / 3}}{q}+O_{\epsilon}\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+X^{\mu} q^{\epsilon}+2^{J} q^{1 / 2+\epsilon}\right)
$$

If $q \leq X^{2 \mu}$, then we can pick $2^{J}$ of size $\frac{X^{\mu}}{q^{1 / 2}}$ and bigger than 1 and obtain

$$
S_{q}(X ; l)=C_{q}(l) \frac{X^{1 / 2}}{q}+D_{q}(l) \frac{X^{1 / 3}}{q}+O_{\epsilon}\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+X^{\mu} q^{\epsilon}\right)
$$

If $q>X^{2 \mu}$, we simply pick $2^{J}=2$ and get

$$
S_{q}(X ; l)=C_{q}(l) \frac{X^{1 / 2}}{q}+D_{q}(l) \frac{X^{1 / 3}}{q}+O_{\epsilon}\left(\frac{X^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+q^{1 / 2+\epsilon}\right)
$$

The above together gives Theorem 3.

## 5 Proof of Theorem 2

First recall that any squarefull number $n$ can be written uniquely as $n=a^{2} b^{3}$ with $b$ is squarefree. Hence, by Theorem 11 $C_{q}\left(l a^{2}\right)=C_{q}(l)$ for any $(a, q)=1$, and $C_{q}(l)<_{\epsilon} q^{\epsilon}$ as $N_{2}(n ; q)<_{\epsilon} q^{\epsilon}$,

$$
\begin{aligned}
T_{q}(x ; l):= & \sum_{\substack{a^{2} b^{3} \leq x \\
b \text { squarefree } \\
a^{2} b^{3} \equiv l(\bmod q)}} 1=\sum_{\substack{a^{2} b^{3} \leq x \\
a^{2} b^{3} \equiv l(\bmod q)}} \sum_{d^{2} \mid b} \mu(d)=\sum_{\substack{a^{2} d^{6} b^{\prime 3} \leq x \\
a^{2} d^{6} b^{\prime 3} \equiv l(\bmod q)}} \mu(d) \\
= & \sum_{\substack{d \leq x^{1 / 6} / q^{1 /(12 \mu)} \\
(d, q)=1}} \mu(d) \sum_{\substack{a^{2} b^{\prime 3} \leq x / d^{6} \\
a^{2} b^{\prime 3} \equiv l \bar{d}^{6}(\bmod q)}} 1+\sum_{\substack{x^{1 / 6} / q^{1 /(12 \mu)<d \leq x^{1 / 6} / q^{\nu}} \begin{array}{c}
(d, q)=1
\end{array}}} \mu(d) \sum_{\substack{a^{2} b^{\prime 3} \leq x / d^{6} \\
a^{2} b^{\prime 3} \equiv l \bar{d}^{6}(\bmod q)}} 1 \\
& +\sum_{\substack{x^{1 / 6 / q^{\nu}<d \leq x^{1 / 6}}(d, q)=1}} 1 \\
= & U_{1}+U_{2}+U_{3}
\end{aligned}
$$

For $U_{1}$, one can check that the condition on $d$ implies $q \leq\left(\frac{x}{d^{0}}\right)^{2 \mu}$. So we can apply Theorem 3 and get

$$
\begin{aligned}
U_{1} & =\sum_{\substack{d \leq x^{1 / 6 / q^{1 /(12 \mu)}}(d, q)=1}} \mu(d)\left[C_{q}(l) \frac{x^{1 / 2}}{d^{3} q}+D_{q}(l) \frac{x^{1 / 3}}{d^{2} q}+O_{\epsilon}\left(\frac{x^{1 / 2-3 \mu / 2}}{d^{3-9 \mu} q^{1 / 2-\epsilon}}+\frac{x^{\mu} q^{\epsilon}}{d^{6 \mu}}\right)\right] \\
& =C_{q}(l) \sum_{\substack{d=x^{1 / 6} / q^{1 /(12 \mu)} \\
(d, q)=1}} \frac{\mu(d)}{d^{3}} \frac{x^{1 / 2}}{q}+D_{q}(l) \sum_{\substack{d \leq x^{1 / 6 / q^{1 /(12 \mu)}}(d, q)=1}} \frac{\mu(d)}{d^{2}} \frac{x^{1 / 3}}{q}+O_{\epsilon}\left(\frac{x^{1 / 2-3 \mu / 2}}{q^{1 / 2-\epsilon}}+x^{\mu} q^{\epsilon}\right)
\end{aligned}
$$

as $C_{q}(l) \ll q^{\epsilon}$ and $D_{q}(l) \ll q^{\epsilon}$. By Theorem 3,

$$
\begin{aligned}
& U_{2}=\sum_{\substack{x^{1 / 6} / q^{1 /(12 \mu)}<d \leq x^{1 / 6} / q^{\nu} \\
(d, q)=1}} \mu(d) \sum_{\substack{a^{2} b^{\prime 3} \leq x / d^{6} \\
a^{2} b^{\prime 3} \equiv \overline{d^{6}}(\bmod q)}} 1 \\
& =\sum_{\substack{x^{1 / 6 / q^{1 /(12 \mu)}<d \leq x^{1 / 6} / q^{\nu}}(d, q)=1}} \mu(d)\left[C_{q}(l) \frac{x^{1 / 2}}{d^{3} q}+D_{q}(l) \frac{x^{1 / 3}}{d^{2} q}+O_{\epsilon}\left(\left(\frac{x^{1 / 2-3 \mu / 2}}{d^{3-9 \mu} q^{1 / 2}}+q^{1 / 2}\right) q^{\epsilon}\right)\right] \\
& (d, q)=1 \\
& =C_{q}(l) \sum_{x^{1 / 6} / q^{1 /(12 \mu)}<d \leq x^{1 / 6} / q^{\nu}} \frac{\mu(d)}{d^{3}} \frac{x^{1 / 2}}{q}+D_{q}(l) \sum_{x^{1 / 6} / q^{1 /(12 \mu)}<d \leq x^{1 / 6} / q^{\nu}} \frac{\mu(d)}{d^{2}} \frac{x^{1 / 3}}{q} \\
& +O_{\epsilon}\left(\left(\frac{x^{1 / 6}}{q^{1 / 2-(2-9 \mu) /(12 \mu)}}+x^{1 / 6} q^{1 / 2-\nu}\right) q^{\epsilon}\right) .
\end{aligned}
$$

Finally, by Theorem 1 ,

$$
\begin{aligned}
U_{3} & \left.\leq \sum_{\substack{x^{1 / 6} / q^{\nu}<d \leq x^{1 / 6} \\
(d, q)=1}} \sum_{\substack{a^{2} b^{\prime 3} \leq x / d^{6} \\
a^{2} b^{\prime 3} \equiv l \bar{d}\\
}} 1 \bmod q\right) \\
& \ll \sum_{\substack{x^{1 / 6} / q^{\nu}<d \leq x^{1 / 6} \\
(d, q)=1}}\left[\frac{\left(x / d^{6}\right)^{1 / 2}}{q}+\left(\frac{x}{d^{6}}\right)^{1 / 5}\right] q^{\epsilon} \\
& \ll\left(x^{1 / 6} q^{2 \nu-1}+x^{1 / 6} q^{\nu / 5}\right) q^{\epsilon} .
\end{aligned}
$$

To minimize the errors, we set $1 / 2-\nu=\nu / 5$ which means $\nu=5 / 12$; and set $x^{1 / 2-3 \mu / 2} / q^{1 / 2}=x^{\mu}$ which means $\mu=1 / 5-\theta / 5$ where $q=x^{\theta}$. Consequently, we have

$$
T_{q}(x ; l)=C_{q}(l) \sum_{\substack{d=1 \\(d, q)=1}}^{\infty} \frac{\mu(d)}{d^{3}} \frac{x^{1 / 2}}{q}+D_{q}(l) \sum_{\substack{d=1 \\(d, q)=1}}^{\infty} \frac{\mu(d)}{d^{2}} \frac{x^{1 / 3}}{q}+O_{\epsilon}\left(\left(x^{1 / 6} q^{1 / 12}+\frac{x^{1 / 5}}{q^{1 / 5}}\right) q^{\epsilon}\right)
$$

which is Theorem 2.
