# Generalized $\beta$-Gaussian Ensemble Equilibrium measure method

#### Abstract

Abstact

We describe $\beta$-Generalized random Hermitian matrices ensemble sometimes called Chiral ensemble. We give global asymptotic of the density of eigenvalues or the statistical density. We investigate general method names as equilibrium measure method. When taking $n$ large limit we will see that the asymptotic density of eigenvalues generalize the Wigner semicircle law.

## 1 Introduction

The generalized $\beta$-Gaussian ensemble, generalize the classical random matrix ensemble: Gaussian orthogonal, unitary and symplectic ensembles (denoted by GOE, GUE and GSE for short, which correspond to the Dyson index $\beta=1,2$ and 4), from the quantization index to the continuous exponents $\beta>0$. These ensembles possess the joint probability density function (p.d.f.) of real eigenvalues $\lambda_{1}, \ldots, \lambda_{n}$ with the form

$$
\mathbb{P}_{n}(d \lambda)=\frac{1}{Z_{n}} e^{-\sum_{i=1}^{n} \lambda_{i}^{2}} \prod_{1 \leq i<j \leq n}\left|\lambda_{i}-\lambda_{j}\right|^{\beta} d \lambda_{1} \ldots d \lambda_{n},
$$

where $Z_{n}$ can be evaluated by the using the Selberg integral

$$
Z_{n}=(2 \pi)^{2 n} \prod_{i=1}^{n} \frac{\Gamma\left(1+\frac{\beta i}{2}\right)}{\Gamma\left(1+\frac{\beta}{2}\right)} .
$$

Recently, Dumitriu and Eldeman have construct a tri-diagonal matrix model of these ensembles see [3].

Basing on the p.d.f. of eigenvalues $\mathbb{P}_{n}$, the (level) density, or onedimensional marginal eigenvalue density scaled by the factor $\frac{1}{\sqrt{2 n}}$ converge weakly to the famous Wigner semi-cercle law as follows: for every bounded continuous functions $f$ on $\mathbb{R}$

$$
\lim _{n \rightarrow \infty} \int_{\mathbb{R}} f\left(\frac{x}{\sqrt{2 n}}\right) h_{n}(x) d x=\int_{\mathbb{R}} f(x) \rho(x) d x
$$

where

$$
\begin{gathered}
\rho(x)= \begin{cases}\frac{1}{\pi} \sqrt{2-x^{2}} & \text { if }|x| \leq \sqrt{2} \\
0 & \text { if }|x| \geq \sqrt{2}\end{cases} \\
h_{n}\left(\lambda_{1}\right)=\int_{\mathbb{R}^{n-1}} \mathbb{P}_{n}\left(\lambda_{1}, \ldots, \lambda_{n}\right) d \lambda_{2} \ldots d \lambda_{n} .
\end{gathered}
$$

Many others work in this direction of random matrices and asymptotic of eigenvalues has been developed in the last years, one can see [6], for a good reference.

In this work we will study a generalization of the Gaussian random matrices ensemble which is called some times the Chiral-ensemble when $\beta=1,2$ or 4 . We will consider the general case where $\beta>0$, in that case the joint probability density in $\mathbb{R}^{n}$ is given by:

$$
\mathbb{P}_{n}(d x)=\frac{1}{Z_{n}} e^{-\sum_{i=1}^{n} x_{i}^{2}} \prod_{i=1}^{n}\left|x_{i}\right|^{2 \lambda} \prod_{1 \leq i<j \leq n}\left|x_{i}-x_{j}\right|^{\beta} d x_{1} \ldots d x_{n},
$$

where $Z_{n}$ is a normalizing constant and $\lambda$ is a positive parameter. Using a general method of logarithmic potential we will prove that, the statistical density of eigenvalues converge for the tight topology as $n \rightarrow+\infty$ to some probability density. Which generalized the Wigner semi-circle law. Such result has been proved in [1] for $\beta=2$, by the orthogonal polynomials method.

The paper is organized as follow. In sections 2 and 3 we gives some results about classical potential theory, which will be used together with some fact about boundary values distribution to characterized the Cauchy transform of some equilibrium measures.

In section 4, we will describe the model to study, as physics model, and we give the joint probability density. Moreover we defined the statistical density $v_{n}$ of eigenvalues and we explain how the eigenvalues must be rescaling by the factor $\sqrt{n}$. Also we gives the first means result theorem 4.1, which state the convergence of the statistical density $v_{n}$ to some probability measure $v_{\beta, c}$. We will prove that, the measure $v_{\beta, c}$ is an equilibrium measure and we compute the exact value of the energy for general $\beta$, after calculating the energy for $\beta=2$.

In section 5 we gives the proof of the first result of theorem 4.1.

## 2 Logarithmic potential

The logarithmic potential of a positive measure $v$ on $\mathbb{R}$ is the function $U^{v}$ defined by

$$
U^{v}(x)=\int_{\mathbb{R}} \log \frac{1}{|x-t|} v(d t) .
$$

It will defined with value on $]-\infty,+\infty]$ if $v$ is with compactly support or more general, if

$$
\int_{\mathbb{R}} \log (1+|t|) v(d t)<\infty .
$$

Observe that

$$
\lim _{n \rightarrow \infty}\left(U^{v}(x)+v(\mathbb{R}) \log |x|\right)=0
$$

The Cauchy transform $G_{v}$ of a bounded measure $v$ on $\mathbb{R}$ is the function defined on $\mathbb{C} \backslash \operatorname{supp}(v)$ by

$$
G_{v}(z)=\int_{\mathbb{R}} \frac{1}{z-t} v(d t)
$$

The Cauchy transform is holomorphic.
Assume that $\operatorname{supp}(v) \subset]-\infty, a]$, and

$$
\int_{\mathbb{R}} \log (1+|t|) v(d t)<\infty .
$$

Then the function

$$
F(z)=\int_{\mathbb{R}} \log \frac{1}{|z-t|} v(d t) .
$$

is defined and holomorphic in $\mathbb{C} \backslash]-\infty, a]$. Furthermore $F^{\prime}(z)=G_{v}(z)$, and

$$
\begin{aligned}
& U^{v}(x)=-\operatorname{Re} F(x) \quad(x>a) \\
& U^{v}(x)=-\lim _{\varepsilon \rightarrow 0} \operatorname{Re} F(x+i \varepsilon) \quad(x \in \mathbb{R})
\end{aligned}
$$

In the distribution sense,

$$
\frac{d}{d x} U^{v}(x)=-\operatorname{Re} G_{v}(x) .
$$

We will use some properties of the boundary value distribution of a holomorphic function. Let $f$ be holomorphic in $\mathbb{C} \backslash \mathbb{R}$. It is said to be of moderate growth near $\mathbb{R}$ if, for every compact set $K \subset \mathbb{R}$, there are $\varepsilon>0, N>0$, and $C>0$ such that

$$
|f(x+i y)| \leq \frac{C}{|y|^{N}} \quad(x \in K, 0<|y| \leq \varepsilon) .
$$

Then for all $\varphi \in \mathcal{D}(\mathbb{R})$,

$$
(T, \varphi)=\lim _{\varepsilon \rightarrow 0, \varepsilon>0} \int_{\mathbb{R}} \varphi(x)(f(x+i \varepsilon)-f(x-i \varepsilon)) d x,
$$

defines a distribution $T$ on $\mathbb{R}$. It is denoted $T=[f]$, and called the difference of boundary values of $f$. One shows that the function $f$ extends as a holomorphic function in $\mathbb{C} \backslash \operatorname{supp}([f])$. In particular, if $[f]=0$, then $f$ extends as a holomorphic function in $\mathbb{C}$.
For $\alpha \in \mathbb{C}$, the distribution $Y_{\alpha}$ is defined, for $\operatorname{Re} \alpha>0$, by

$$
\left(Y_{\alpha}, \varphi\right)=\frac{1}{\Gamma(\alpha)} \int_{\mathbb{R}} \varphi(t) t^{\alpha-1} d t
$$

The distribution $Y_{\alpha}$, as a function of $\alpha$, admits an analytic continuation for $\alpha \in \mathbb{C}$. In particular $Y_{0}=\delta_{0}$, the Dirac measure at 0 .

For $\alpha \in \mathbb{C}$, we defines the holomorphic function $z^{\alpha}$ in $\left.\left.\mathbb{C} \backslash\right]-\infty, 0\right]$ as follows: if $z=r e^{i \theta}$, with $r>0,-\pi<\theta<\pi$, then

$$
z^{\alpha}=r^{\alpha} e^{i \alpha \theta} .
$$

The function $z^{\alpha}$ is of moderate growth near $\mathbb{R}$, and

$$
\left(\left[z^{\alpha}\right], \varphi\right)=-2 i \pi \frac{1}{\Gamma(-\alpha)}\left(Y_{\alpha+1}, \check{\varphi}\right),
$$

where $\check{\varphi}(t)=\varphi(-t)$. In particular when $\alpha=-1$

$$
\left[\frac{1}{z}\right]=-2 i \pi \delta_{0} .
$$

Proposition 2.1 Let $v$ be a bounded positive measure on $\mathbb{R}$.
(i) The Cauchy transform $G_{v}$ of $v$ is holomorphic in $\mathbb{C} \backslash \operatorname{supp}(v)$, of moderate growth near $\mathbb{R}$, and

$$
\left[G_{v}\right]=-2 i \pi v
$$

(ii) Assume that the support of $v$ is compact. Let $F$ be holomorphic in $\mathbb{C} \backslash \mathbb{R}$, of moderate growth near $\mathbb{R}$, such that

$$
[F]=-2 i \pi v .
$$

Then $F$ is holomorphic in $\mathbb{C} \backslash \operatorname{supp}(v)$. If further

$$
\lim _{|z| \rightarrow \infty} F(z)=0 .
$$

Then

$$
G_{v}=F .
$$

## 3 Equilibrium measure some basic results

Let us first recall some basic facts about the tight topology. All the present result in equilibrium measure can be find in the good reference [11] and references therein. Let $\mathfrak{M}^{1}(\Sigma)$ be the set of probability measures on the closed set $\Sigma \subset \mathbb{R}$. We consider the tight topology. For this topology a sequence $\left(v_{n}\right)$ converges to a measure $v$ if, for every continuous bounded function $f$ on $\Sigma$,

$$
\lim _{n \rightarrow \infty} \int_{\Sigma} f(x) v_{n}(d x)=\int_{\Sigma} f(x) v(d x) .
$$

This topology is metrizable. If $\Sigma$ is bounded, then $\mathfrak{M}^{1}(\Sigma)$ is compact.
Let $\Sigma$ be a closed interval $(\Sigma=\mathbb{R}]-,\infty, a],[b,+\infty[\operatorname{or}[a, b])$, and $Q$ a function defined on $\Sigma$ with values on $]-\infty,+\infty]$, continuous on $\operatorname{int}(\Sigma)$. If $\Sigma$ is unbounded, it is assumed that

$$
\lim _{|x| \rightarrow+\infty}\left(Q(x)-\log \left(1+x^{2}\right)\right)=+\infty
$$

If $v$ is a probability measure supported by $\Sigma$, the energy $E(v)$ of $v$ is defined by

$$
E(v)=\int_{\Sigma \times \Sigma} \log \frac{1}{|x-y|} v(d x) v(d y)+\int_{\Sigma} Q(x) v(d x) .
$$

which mean that

$$
E(v)=\int_{\Sigma} U^{v}(x) v(d x)+\int_{\Sigma} Q(x) v(d x) .
$$

By a straightforward computation we can prove that $E(v)$ is bounded below. Hence we defined

$$
E^{*}=\inf \left\{E(v) \mid v \in \mathfrak{M}^{1}(\Sigma)\right\} .
$$

Theorem 3.1 If $v(d x)=f(x) d x$, where $f$ is a continuous function with compact support $\subset \operatorname{int}(\Sigma)$. Then the potential $U^{v}$ is a continuous function, and $E^{*} \leq E(v)<\infty$. Furthermore there is a unique measure $v^{*} \in \mathfrak{M}^{1}(\Sigma)$ such that

$$
E^{*}=E\left(v^{*}\right) .
$$

The support of $v^{*}$ is compact.
This measure $v^{*}$ is called the equilibrium measure.
Proposition 3.2 Let $v \in \mathfrak{M}^{1}(\Sigma)$ with compact support. Assume that the potentiel $U^{v}$ of $v$ is continuous and that there is a constant $C$ such that
(i) $U^{\nu}(x)+\frac{1}{2} Q(x) \geq C$ on $\Sigma$.
(ii) $U^{v}(x)+\frac{1}{2} Q(x)=C$ on $\operatorname{supp}(v)$. Then $v$ is the equilibrium measure: $v=v^{*}$.

The constant $C$ is called the (modified) Robin constant. Observe that

$$
E^{*}=C+\frac{1}{2} \int_{\Sigma} Q(x) v^{*}(d x) .
$$

It is easy to see the action by linear transformation on the energy.

Proposition 3.3 Let the transformation $h(s)=a s+b$ map $\sum$ onto $\Sigma^{\prime}$. If $Q$ is defined on $\Sigma^{\prime}$, then $Q \circ h$ is defined on $\Sigma$. If $v$ is a probability measure on $\Sigma$, then $\sigma=h(v)$ is the probability measure on $\Sigma^{\prime}$ defined by

$$
\int_{\Sigma^{\prime}} f(t) \sigma(d t)=\int_{\Sigma} f \circ h(t) v(d t) .
$$

Then

$$
E_{\left(\Sigma^{\prime}, \mathrm{Q}\right)}(h(v))=E_{(\Sigma, \mathrm{Q} \circ h)}(v)-\log |a| .
$$

For the proof of the previous theorem and proposition, see for instance theorem II.2.3, proposition II.3.1 of [4].

## 4 Statistical of the generalized Gaussian unitary ensemble

Let $H_{n}=\operatorname{Herm}(n, \mathbb{F})$ be the vector space of square Hermitian matrices with coefficient in the field $\mathbb{F}=\mathbb{R}, \mathbb{C}$ or $\mathbb{H}$. For $\mu>-\frac{1}{2}$, we denote by $\mathbb{P}_{n, \mu}$ the probability measure on $H_{n}$ defined by.

$$
\int_{H_{n}} f(x) \mathbb{P}_{n, \mu}(d x)=\frac{1}{C_{n}} \int_{H_{n}} f(x)|\operatorname{det}(x)|^{2 \mu} e^{-\operatorname{tr}\left(x^{2}\right)} m_{n}(d x),
$$

for a bounded mesurable function $f$, where $m_{n}$ is the Euclidean measure associated to the usual inner product $\langle x, y\rangle=\operatorname{tr}(x y)$ on $H_{n}$ and $C_{n}$ is a normalized constant. which is given for $d=2$ by

$$
\begin{gather*}
C_{n}=n!\prod_{k=0}^{n-1} \gamma_{\mu}(k) \\
\gamma_{\mu}(k)= \begin{cases}m!\Gamma\left(m+\mu+\frac{1}{2}\right) & \text { if } k=2 m \\
m!\Gamma\left(m+\mu+\frac{3}{2}\right) & \text { if } k=2 m+1\end{cases} \tag{4.1}
\end{gather*}
$$

For general $\beta=1$ or 4 the constant is given by Jack polynomials.
When $\mu=0$ we recover the classical Gaussian unitary ensemble and,

$$
C_{n}=\pi^{\frac{n}{2}} 2^{\frac{n(n-1)}{2}} \prod_{k=0}^{n} k!.
$$

We endowed the space $H_{n}$ with the probability measure $\mathbb{P}_{n, \mu}$. The probability $\mathbb{P}_{n, \mu}$ is invariant for the action of the unitary group $U(n)$ by the conjugation

$$
x \mapsto u x u^{*} \quad(u \in U(n)) .
$$

### 4.1 Spectral density of eigenvalues

Let $f$ be a $U(n)$-invariant function on $H_{n}$.

$$
f\left(u x u^{*}\right)=f(x) \quad \forall u \in U(n),
$$

Then by the spectral theorem there exist a symmetric function $F$ in $\mathbb{R}^{n}$ such that

$$
f(x)=F\left(\lambda_{1}, \ldots, \lambda_{n}\right) .
$$

If $f$ is integrable with respect to $\mathbb{P}_{n, \mu}$, then by using the formula of integration of Well we obtain

$$
\int_{H_{n}} f(x) \mathbb{P}_{n, \mu}(d x)=\int_{n} F\left(\lambda_{1}, \ldots, \lambda_{n}\right) q_{n, \mu}\left(\lambda_{1}, \ldots, \lambda_{n}\right) d \lambda_{1} \ldots \lambda_{n}
$$

where

$$
q_{n, \mu}\left(\lambda_{1}, \ldots, \lambda_{n}\right)=\frac{1}{c_{n}} e^{-\sum_{k=1}^{n} \lambda_{k}^{2}} \prod_{k=1}^{n}\left|\lambda_{k}\right|^{2 \mu}|\Delta(\lambda)|^{\beta}
$$

and $\beta=1,2,4$ for $\mathbb{F}=\mathbb{R}, \mathbb{C}$ or $\mathbb{H}$. $\Delta$ is the vandermonde determinant

$$
\Delta(\lambda)=\prod_{1 \leq i<j \leq n}\left(\lambda_{i}-\lambda_{j}\right)
$$

More general we will consider $n$ particles free to move in $\mathbb{R}^{n}$, in equilibrium at absolute temperature $T$. A fundamental postulate gives the p.d.f. for the event that the particles are at positions $\lambda_{1}, \ldots, \lambda_{n}$ as:

$$
q_{n, \mu_{n}}\left(\lambda_{1}, \ldots, \lambda_{n}\right)=\frac{1}{Z_{N}} e^{-\beta V_{n}\left(\lambda_{1}, \ldots \lambda_{n}\right)},
$$

where

$$
V_{n}\left(\lambda_{1}, \ldots, \lambda_{n}\right)=\frac{2 n}{\beta} \sum_{k=1}^{n}\left(\lambda_{k}^{2}+\frac{2 \mu_{n}}{n} \log \frac{1}{\left|\lambda_{k}\right|}\right)+\sum_{1 \leq i<j \leq n} \log \frac{1}{\left|\lambda_{i}-\lambda_{j}\right|}
$$

Here $V_{n}\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ denotes the total potential energy of the system, $\beta:=\frac{1}{k_{B} T}$ ( $k_{B}$ is Boltzmannś constant), and $Z_{n}$ is a normalizing constant.

The term $V_{n}\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ is referred to as the Boltzmann factor and $\widetilde{Z}_{n}:=$ $\frac{Z_{n}}{n!}$ is called the (canonical) partition function.

Our first result is to study as $n$ go to infinity the asymptotic of the Normalized Counting Measure (Density of States) $v_{n}$ defined on $\mathbb{R}$ as follows: if $f$ is a measurable function,

$$
\int_{\mathbb{R}} f(t) v_{n}(d t)=\mathbb{E}_{n, \mu_{n}}\left(\frac{1}{n} \sum_{i=1}^{n} f\left(\lambda_{i}\right)\right),
$$

where $\mathbb{E}_{n, \mu_{n}}$ is the expectation with respect the probability measure on $\mathbb{R}^{n}$

$$
\mathbb{P}_{n, \mu_{n}}(d \lambda)=\frac{1}{Z_{n}} e^{-n \sum_{k=1}^{n} Q_{n}\left(\lambda_{k}\right)} \prod_{1 \leq i<j \leq n}\left|\lambda_{i}-\lambda_{j}\right|^{\beta},
$$

and

$$
Q_{n}(x)=x^{2}+\frac{2 \mu_{n}}{n} \log \frac{1}{|x|}
$$

By invariance of the measure $\mathbb{P}_{n, \mu_{n}}$ by the symmetric group, we have that the measure $v_{n}$ is continue with respect to the Lebesgue measure

$$
v_{n}(d t)=h_{n, \mu_{n}}(t) d t
$$

where

$$
h_{n, \mu_{n}}(t)=\int_{\mathbb{R}^{n-1}} q_{n, \mu_{n}}\left(t, \lambda_{2}, \ldots, \lambda_{n}\right) d \lambda_{2} \ldots d \lambda_{n} .
$$

Let compute the two first moments of the measure $v_{n}$ :

$$
m_{1}\left(\mu_{n}\right)=\int_{\mathbb{R}} t v_{n}(d t)=\frac{1}{n} \int_{\mathbb{R}^{n}} \sum_{k=1}^{n} \lambda_{k} \mathbb{P}_{n, \mu_{n}}(d \lambda)=0
$$

the second moment is:

$$
m_{2}\left(v_{n}\right)=\frac{1}{n} \int_{\mathbb{R}^{n}} \sum_{k=1}^{n} \lambda_{k}^{2} \mathbb{P}_{n, \mu_{n}}(d \lambda)
$$

Since for all $\alpha>0$,
$Z_{n}(\alpha)=\int_{\mathbb{R}^{n}} e^{-\alpha \sum_{k=1}^{n} \lambda_{k}^{2}} \prod_{k=1}^{n}\left|\lambda_{k}\right|^{2 \mu_{n}} \prod_{1 \leq i<j \leq n}\left|\lambda_{i}-\lambda_{j}\right|^{\beta} d \lambda_{1} \cdots d \lambda_{n}=\alpha^{-n \mu_{n}-\frac{\beta}{4} n(n-1)-\frac{n}{2}} Z_{n}$, and

$$
m_{2}\left(v_{n}\right)=-\left.\frac{1}{n} \frac{d}{d \alpha} \log \left(Z_{n}(\alpha)\right)\right|_{\alpha=1}=\mu_{n}+\frac{\beta}{4}(n-1)+\frac{1}{2}
$$

This suggests that $v_{n}$ does not converge, and that a scaling of order $\sqrt{n \frac{\beta}{4}+\mu_{n}}$ is necessary.

We come to The mean result: the measure $v_{n}$ converge weakly to some probability measure $v_{\beta, c}$ which is an equilibrium measure.

Theorem 4.1 Let $\left(\mu_{n}\right)_{n}$ be a nonnegative real sequence, if $\lim _{n \rightarrow \infty} \frac{\mu_{n}}{n}=c$. Then the probability measure $v_{n}$ converge weakly to the probability $v_{\beta, c}$, where $v_{\beta, c}$ is the measure on $S=[-b,-a] \cup[a, b]$ with density with respect to the Lebesque measure

$$
f_{\beta, c}(t)=\left\{\begin{array}{ll}
\frac{2}{\pi \beta} \frac{1}{|t|} \sqrt{\left(t^{2}-a^{2}\right)\left(b^{2}-t^{2}\right)} & \text { if } t \in S \\
0 & \text { if } t \notin S
\end{array},\right.
$$

and $a=\sqrt{\frac{\beta}{2}} \sqrt{1+\frac{2 c}{\beta}-\sqrt{1+\frac{4 c}{\beta}}}, b=\sqrt{\frac{\beta}{2}} \sqrt{1+\frac{2 c}{\beta}+\sqrt{1+\frac{4 c}{\beta}}}$. Moreover the energy of the equilibrium measure $v_{\beta, c}$ is

$$
E_{\beta, c}^{*}=\frac{3 \beta}{8}+\frac{\beta}{4} \log \left(\frac{4}{\beta}\right)+c\left(\frac{3}{2}+\log \frac{4}{\beta}\right)+\frac{2 c^{2}}{\beta} \log \frac{4 c}{\beta}-\left(\frac{2 c^{2}}{\beta}+c+\frac{\beta}{8}\right) \log \left(1+\frac{4 c}{\beta}\right)
$$

The convergence is in the sense that for every continuous bounded function $f$ on $\mathbb{R}$

$$
\lim _{n \rightarrow \infty} \int_{\mathbb{R}} f(t) v_{n}(d t)=\int_{\mathbb{R}} f(t) v_{\beta, c}(d t)
$$

### 4.2 Equilibrium measure of generalized Gaussian unitary ensemble

For $c \geq 0, \beta>0$, one considers on $\Sigma=\mathbb{R}$, the potential

$$
Q_{c}(t)=t^{2}+2 c \log \frac{1}{|t|}
$$

The energy of a probability measure $\mu \in \mathfrak{M}^{1}(\mathbb{R})$ is defined by

$$
E_{\beta, c}(\mu)=\frac{\beta}{2} \int_{\mathbb{R}^{2}} \log \frac{1}{|s-t|} \mu(d s) \mu(d t)+\int_{\mathbb{R}} Q_{c}(t) \mu(d t)
$$

and let $U_{\beta, c}$ be the potential of the measure $v_{\beta, c}, U_{\beta, c}(x)=\int_{\mathbb{R}} \log \frac{1}{|x-y|} v_{\beta, c}(d y)$

Proposition 4.2 The probability measure $v_{\beta, c}$ is the equilibrium measure, which mean that

\inf \left\{E_{\beta, c}(v) \mid v \in \mathfrak{M}^{1}(\mathbb{R})\right\}=E\left(v_{\beta, c}\right)=E_{\beta, c}^{*}
$$

Furthermore
(i) $U_{\beta, c}(x)+\frac{1}{2} Q_{c}(x)=C$, on $S$.
(ii) $U_{\beta, c}(x)+\frac{1}{2} Q_{c}(x) \geq C$, on $\mathbb{R} \backslash S$.

We will give the value of the energy $E_{\beta, c}^{*}$ in section 3.3.
To prove the proposition we need same preliminary results and then applying proposition 2.2.
For more convenient notation we shall denote $c^{\prime}=\frac{2 c}{\beta}$.

## Putting

f(z)=\frac{2}{\beta z} \sqrt{z-a} \sqrt{z-b} \sqrt{z+a} \sqrt{z+b}

The function $f$ is holomorphic on the domain $\mathbb{C} \backslash(S \cup\{0\})$, of moderate growth near $S \cup\{0\}$.

Proposition 4.3 The difference between the two limits values of $f$ in the distribution sense, $[f]=f(x+i 0)-f(x-i 0)$, is given by

For $b>0$, observe that the function $f(z)=\frac{2}{\beta z} \sqrt{z-a} \sqrt{z-b} \sqrt{z+a} \sqrt{z+b}$, is defined and holomorphic on $\mathbb{C} \backslash]-\infty, b]$.
For $x>b, f(x)=\frac{2}{\beta x} \sqrt{(x-a)(x-b)(x+a)(x+b)}=\frac{2}{\beta x} \sqrt{\left(x^{2}-a^{2}\right)\left(x^{2}-b^{2}\right)}$, be
the usual square root of positive numbers.
For $x<-b$,
$\lim _{\varepsilon \rightarrow 0, \varepsilon>0} f(x \pm i \varepsilon)=e^{ \pm i \pi} e^{ \pm i \pi} \frac{2}{\beta x} \sqrt{(a-x)(b-x)(-x-a)(-x-b)}=\frac{2}{\beta x} \sqrt{\left(x^{2}-a^{2}\right)\left(x^{2}-b^{2}\right)}$.
There for $f$ extended as holomorphic function on $\mathbb{C} \backslash S$. Furthermore For $-b<x<-a$,
$\lim _{\varepsilon \rightarrow 0, \varepsilon>0} f(x \pm i \varepsilon)=-e^{ \pm i \frac{\pi}{2}} \frac{2}{\beta x} \sqrt{(a-x)(b-x)(-x-a)(x+b)}=\mp i \frac{2}{\beta x} \sqrt{\left(a^{2}-x^{2}\right)\left(b^{2}-x^{2}\right)}$.
For $-a<x<a, x \neq 0$,
$\lim _{\varepsilon \rightarrow 0, \varepsilon>0} f(x \pm i \varepsilon)=e^{ \pm i \pi} \frac{2}{\beta x} \sqrt{(a-x)(b-x)(x+a)(x+b)}=-\frac{2}{\beta x} \sqrt{\left(a^{2}-x^{2}\right)\left(b^{2}-x^{2}\right)}$.
For $z$ near 0, by Taylor expansion

f(z)=-\frac{2 a b}{\beta z}+g(z)=\frac{-c^{\prime}}{z}+g(z),
$$

where $g$ is an holomorphic function.

For $a<x<b$,

\lim _{\varepsilon \rightarrow 0, \varepsilon>0} f(x \pm i \varepsilon)=e^{ \pm i \frac{\pi}{2}} \frac{2}{\beta x} \sqrt{(a-x)(b-x)(-x-a)(x+b)}= \pm i \frac{2}{\beta x} \sqrt{\left(x^{2}-a^{2}\right)\left(b^{2}-x^{2}\right)} .
$$

Which complete the proof of the proposition.
Let denote by $G_{\beta, c^{\prime}}$ the Cauchy transform of the measure $v_{\beta, c^{\prime}}$ : for all $z \in \mathbb{C} \backslash S$,

The function $g(\omega)=\frac{1}{z-\omega} f(\omega)=\frac{2}{\beta \omega(z-\omega)} \sqrt{\omega-a} \sqrt{\omega-b} \sqrt{\omega+a} \sqrt{\omega+b}$, is meromorphic in $\overline{\mathbb{C}} \backslash S \cup\{0, z\}$. with simple pole at $\omega=0, \omega=z$ and a pole at infinity.

Furthermore the residue at $\omega=0$ is $-\frac{2 c}{\beta z}=-\frac{c^{\prime}}{z}$, the residue at $\omega=z$ is $-f(z)$, and $f$ admit a Laurent expansion for $|\omega|>\max (|a|,|b|,|z|)$

Let denote by $U_{\beta, c^{\prime}}$ the logarithmic potential of the measure $v_{\beta, c^{\prime}}$ for all $x \in \mathbb{R}$,

Hence it is bounded below and the minimum is realized at some point $\lambda^{(n)}=\left(\lambda_{1}^{(n)}, \cdots, \lambda_{n}^{(n)}\right)$, which means that

From proposition 4.2, if we replace $c$ by $\alpha_{n}$ the equilibrium measure of the potential $\frac{2}{\beta} Q_{\alpha_{n}}$ is $v_{\beta, \alpha_{n}}$, where the density of the equilibrium measure $v_{\beta, \alpha_{n}}$ is given by

Proposition 4.6 Let $\left(\mu_{n}\right)_{n}$ be a positive real sequence. Assume there is some constant $c$ such that $\lim _{n \rightarrow \infty} \frac{\mu_{n}}{n}=c$. Then
(1) $\lim _{n \rightarrow \infty} \tau_{n}=E_{\beta, c^{*}}^{*}$.
(2) The measure $\rho_{n}$ converge weakly the the equilibrium measure $v_{\beta, c}$.
(3) $\lim _{n \rightarrow \infty}-\frac{1}{n^{2}} \log A_{n}=E_{\beta, c}^{*}$.

Proposition 4.7 Let $\left(\mu_{n}\right)_{n}$ be a positive real sequence. Assume there is some constant $c$ such that $\lim _{n \rightarrow \infty} \frac{\mu_{n}}{n}=c$. Then the energy $E_{\beta, c}^{*}$ is given by

E_{\beta, \alpha_{n}}=\frac{\beta}{2} E_{2, \frac{2 \alpha_{n}}{\beta}}+\frac{\beta}{2} \log \sqrt{\frac{2}{\beta}}+2 \alpha_{n} \log \sqrt{\frac{2}{\beta}} .
$$

We saw from lemma 3.5 that

$$
\lim _{n \rightarrow \infty} E_{2, \frac{2 \alpha_{n}}{\beta}}=E_{2, \frac{2 c}{\beta}}^{*} \text { and } \lim _{n \rightarrow \infty} E_{\beta, \alpha_{n}}=E_{\beta, c}^{*} .
$$

From the first case $\beta=2$ and simple computation we deduce the desired result.

## 5 Proof of theorem 4.1

Recall the statistical distribution $v_{n}$ is defined by: for all bounded continuous function $f$ on $\mathbb{R}$,

$$
\int_{\mathbb{R}} f(t) v_{n}(d t)=\mathbb{E}_{n, \mu_{n}}\left(\frac{1}{n} \sum_{i=1}^{n} f\left(\lambda_{i}\right)\right),
$$

where $\mathbb{E}_{n, \mu_{n}}$ is the expectation with respect the probability on $\mathbb{R}^{n}$

$$
\mathbb{P}_{n, \mu_{n}}(d \lambda)=\frac{1}{Z_{n}} e^{-n \sum_{i=1}^{n} \lambda_{i}^{2}} \prod_{i=1}^{n}\left|\lambda_{i}\right|^{2 \mu_{n}} \prod_{1 \leq i<j \leq n}\left|\lambda_{i}-\lambda_{j}\right|^{\beta} d \lambda_{1} \cdots d \lambda_{n} .
$$

Let Define on $\mathbb{R}^{n}$ the function:

$$
K_{n}(x)=\frac{\beta}{2} \sum_{i \neq j} \log \frac{1}{\left|x_{i}-x_{j}\right|}+(n-1) \sum_{i=1}^{n} Q_{\alpha_{n}}\left(x_{i}\right),
$$

where $Q_{\alpha_{n}}=x^{2}+2 \alpha_{n} \log \frac{1}{|x|}$ and $\alpha_{n}=\frac{\mu_{n}}{n}$.
The probability $\mathbb{P}_{n, \mu_{n}}$ concentrates in a neighborhood of the points where the function $K_{n}(x)$ attains its infimum:

Proposition 5.1 Let $\varepsilon>0$ and $A_{n, \varepsilon}=\left\{x \in \mathbb{R}^{n} \mid K_{n}(x) \leq\left(E_{\beta, c}^{*}+\varepsilon\right) n^{2}\right\}$. Then $A_{n, \varepsilon}$ is compact and

$$
\lim _{n \rightarrow \infty} \mathbb{P}_{n, \mu_{n}}\left(A_{n, \varepsilon}\right)=1
$$

This proposition can be found in [4], lemma IV.5.2. We give the proof.
Proof. Recall that $h_{\alpha_{n}}(x)=Q_{\alpha_{n}}(x)-\log \left(1+x^{2}\right)$. Since $h_{\alpha_{n}}$ is lower semicontinuous and

$$
K_{n}(x) \geq(n-1) \sum_{i=1}^{n} h_{\alpha_{n}}\left(x_{i}\right), \quad \lim _{x_{i} \rightarrow \pm \infty} h_{\alpha_{n}}\left(x_{i}\right)=+\infty,
$$

then $A_{n, \varepsilon}$ is closed and bounded hence it is compact.
Let $\varepsilon>0$, from the definition of $A_{n, \varepsilon}$ we have on $\mathbb{R}^{n} \backslash A_{n, \varepsilon}$

$$
K_{n}(x)>\left(E_{\beta, c}^{*}+\varepsilon\right) n^{2},
$$

then

$$
\mathbb{P}_{n, \mu_{n}}\left(\mathbb{R}^{n} \backslash A_{n, \varepsilon}\right) \leq \frac{1}{Z_{n}} e^{-\left(E_{\beta, c}^{*}+\varepsilon\right) n^{2}}\left(\int_{\mathbb{R}} e^{-Q_{a_{n}}(x) d x}\right)^{n} .
$$

Furthermore

$$
\int_{\mathbb{R}} e^{-Q_{\alpha_{n}}(x)} d x=\int_{\mathbb{R}}|x|^{2 \alpha_{n}} e^{-x^{2}} d x=\Gamma\left(\alpha_{n}+\frac{1}{2}\right) .
$$

By continuity of the gamma function we have $\lim _{n \rightarrow \infty} \Gamma\left(\alpha_{n}+\frac{1}{2}\right)=\Gamma\left(c+\frac{1}{2}\right)$. Since from proposition $4.6 \lim _{n \rightarrow \infty}-\frac{1}{n^{2}} \log Z_{n}=E_{\beta, c}^{*}$. Then there is $n_{0}$ such that for all $n \geq n_{0}$,

$$
\frac{1}{Z_{n}} \leq e^{\left(E_{\beta, c}^{*}+\frac{\varepsilon}{2}\right) n^{2}}
$$

Using all those arguments we obtain for $n$ large enough

$$
\mathbb{P}_{n, \mu_{n}}\left(\mathbb{R}^{n} \backslash A_{n, \varepsilon}\right) \leq\left(\Gamma\left(c+\frac{1}{2}\right)+\varepsilon\right)^{n} e^{-\frac{\varepsilon}{2} n^{2}} .
$$

Which complete the proof.

Proof of theorem 4.1. We keep those notations:

$$
k_{\alpha_{n}}(s, t)=\log \frac{1}{|s-t|}+\frac{1}{2} Q_{\alpha_{n}}(s)+\frac{1}{2} Q_{\alpha_{n}}(t),
$$

for $\ell>0$,

$$
\begin{gathered}
k_{\alpha_{n}}^{\ell}(s, t)=\inf \left(k_{\delta}(s, t), \ell\right) . \\
h_{\alpha_{n}}(t)=Q_{\alpha_{n}}(t)-\log \left(1+t^{2}\right),
\end{gathered}
$$

and $h(t)=\inf \left(h_{a_{1}}(t), h_{a_{2}}(t)\right), h_{a_{1}}$ and $h_{a_{2}}$ are the functions used on the proof of proposition 3.6 where $a_{1}, a_{2} \geq 0$

For a bounded continuous function $f$ on $\mathbb{R}$, defined on $\mathbb{R}^{n}$ the continuous function

$$
F_{n}(x)=\frac{1}{n} \sum_{i=1}^{n} f\left(x_{i}\right),
$$

Let $\varepsilon>$, the set $A_{n, \varepsilon}$ is compact, hence $F_{n}$ attaint it supremum at same point in $A_{n, \varepsilon}$ say

$$
x_{\varepsilon}^{(n)}=\left(x_{1, \varepsilon}^{(n)}, \cdots, x_{n, \varepsilon}^{(n)}\right) .
$$

We obtain

$$
\int_{\mathbb{R}} f(t) v_{n}(d t) \leq F_{n}\left(x_{\varepsilon}^{(n)}\right)+\|f\|_{\infty}\left(1-\mathbb{P}_{n, \mu_{n}}\left(A_{n, \varepsilon}\right)\right) .
$$

To the point $x_{\varepsilon}^{(n)}$ we associate the probability measure on $\mathbb{R}$

$$
\sigma_{n, \varepsilon}=\frac{1}{n} \sum_{i=1}^{n} \delta_{x_{i, \varepsilon}^{(n)}} .
$$

The previous inequality can be written

$$
\int_{\mathbb{R}} f(t) v_{n}(d t) \leq \int_{\mathbb{R}} f(t) \sigma_{n, \varepsilon}(d t)+\|f\|_{\infty}\left(1-\mathbb{P}_{n, \mu_{n}}\left(A_{n, \varepsilon}\right)\right),
$$

The truncated energy $E^{\ell}$ of the measure $\sigma_{n, \varepsilon}$ satisfies:

$$
E^{\ell}\left(\sigma_{n, \varepsilon}\right) \leq \frac{\ell}{n}+\left(E_{\beta, c}^{*}+\varepsilon\right) .
$$

From the inequality

$$
(n-1) \sum_{i=1}^{n} h\left(x_{i}\right) \leq K_{n}(x) \text {, }
$$

we obtain

$$
\int_{\mathbb{R}} h(t) \sigma_{n, \varepsilon}(d t) \leq \frac{n}{n-1}\left(E_{\beta, c}^{*}+\varepsilon\right) .
$$

This implies that the sequence $\sigma_{n, \varepsilon}$ is relatively compact for the weak topology. There is a sequence $n_{j}$ going to $\infty$ such that the subsequence $\sigma_{n_{j}, \varepsilon}$ converges in the weak topology:

$$
\lim _{n \rightarrow \infty} \sigma_{n_{j}, \varepsilon}=\sigma_{\varepsilon}
$$

We may also assume in the weak topology that

$$
\lim _{j \rightarrow \infty} v_{n_{j}}=\limsup _{n} v_{n} .
$$

the limit measure satisfies

$$
E^{\ell}\left(\sigma_{\varepsilon}\right) \leq E_{\beta, c}^{*}+\varepsilon .
$$

The rest of the proof is analogous to the proof of theorem IV.5.1 [4].
