SISO OUTPUT AFFINE FEEDBACK TRANSFORMATION GROUP AND ITS FAÀ DI BRUNO HOPF ALGEBRA

Abstract. The general goal of this paper is to identify a transformation group that can be used to describe a class of feedback interconnections involving subsystems which are modeled solely in terms of *Chen–Fliess functional expansions* or *Fliess operators* and are independent of the existence of any state space models. This interconnection, called an *output affine feedback connection*, is distinguished from conventional output feedback by the presence of a multiplier in an outer loop. Once this transformation group is established, three basic questions are addressed. How can this transformation group be used to provide an explicit Fliess operator representation of such a closedloop system? Is it possible to use this feedback scheme to do system inversion purely in an inputoutput setting? In particular, can feedback input-output linearization be posed and solved entirely in this framework, i.e., without the need for any state space realization? Lastly, what can be said about feedback invariants under this transformation group? A final objective of the paper is to describe the Lie algebra of infinitesimal characters associated with the group in terms of a pre-Lie product.

Key words. nonlinear control systems, Chen-Fliess series, Hopf algebras, transformation groups

1. Introduction. Feedback transformation groups have been used extensively in control theory since its inception to explain the way that feedback can alter the nature of a system. The early work of Brockett and Krishnaprasad in the case of linear systems [3, 4] and Brockett, Jakubczyk, Respondek, and many others in the context of nonlinear state space systems [2,26,27,38] has been important, for example, in identifying feedback invariants. The general goal of this paper is to identify a transformation group that can be used to describe a class of feedback interconnections involving subsystems which are modeled solely in terms of *Chen-Fliess functional* expansions or Fliess operators and are independent of the existence of any state space models [11, 12]. This interconnection, called an *output affine feedback connection*, is shown in Figure 1. The presence of a multiplier in an outer loop distinguishes this structure from conventional output feedback. Once this transformation group is established, three basic questions are addressed. How can this transformation group be used to provide an explicit Fliess operator representation of such a closed-loop system? Is it possible to use this feedback scheme to do system inversion purely in an input-output setting? In particular, can feedback input-output linearization be posed and solved entirely in this framework, i.e., without the need for any state space realization? Lastly, what can be said about feedback invariants under this transformation group? A final objective of the paper is to describe the Lie algebra of infinitesimal characters associated with this new transformation group and show that it is induced by a pre-Lie product analogous to what was found for the output feedback transformation group in [13, 14]. This fact may give deeper insight into the combinatorial aspects of the theory and group invariants (see [21]), but this aspect of the problem will be deferred to a later publication.

The basic approach to solving these problems is to use an operator algebra encoded by various products of formal power series. This is somewhat analogous to the familiar way in which interconnections of linear time-invariant systems are analyzed

using only transfer functions and the algebra of rational functions. The feedback connection in general requires the use of a certain inverse operator that is naturally described in terms of a group. To do any calculations explicitly and efficiently here, it is necessary to present an associated Hopf algebra induced by the group product and its inverse. It has been known for a long time in some physics communities that Hopf algebras provide a natural computational framework for working with groups [5, 10, 15]. For example, the group inverse can be computed explicitly in terms of the *antipode*, a particular antihomomorphism of the Hopf algebra. If the latter is both connected and graded, then this antipode has a recursive description which is ideal for software implementation. As will be seen, the Hopf algebra of interest here is directly related to a composition of Fliess operators. The inversion formula that it provides is a kind of functional analogue of Lagrange's formula for the inversion of smooth functions in terms of their Taylor series coefficients. This classical formula has a combinatorial interpretation in terms of a connected graded Hopf algebra [28]. In particular, the coproduct of this Hopf algebra is defined in terms of the classical Faà di Bruno formula which gives the Taylor series coefficients for the composition of two sufficiently well behaved functions. Therefore, this Hopf algebra is often referred to as a $Fa\dot{a} di$ Bruno type Hopf algebra [10, 15]. The Hopf algebra presented in this paper is also of Faà di Bruno type and is best viewed as a generalization of existing work on output feedback (corresponding to setting $F_{d_L}[y] = 1$ for all y in Figure 1) by the authors and others appearing in [7, 13, 14, 17–19, 21, 23, 39]. The focus here will be on the single-input single-output (SISO) case as the multivariable case introduces additional technical issues that are nontrivial and require more advanced concepts from Hopf algebra theory. Finally, it should be noted that a portion of this paper appeared in preliminary form in [16].

The paper is organized as follows. In the next section, some preliminary concepts concerning Fliess operators, ultrametric spaces, and Hopf algebras are briefly outlined. In Section 3, the output affine feedback transformation group is described. The problem of determining a Fliess operator representation of the output affine closed-loop system is then solved. The Hopf algebra is next developed in Section 4 and subsequently applied in the following section to address the remaining two problems concerning system inversion/feedback linearization and feedback invariants. In Section 6, the Lie algebra of infinitesimal characters is described.

2. Preliminaries. A finite nonempty set of noncommuting symbols $X = \{x_0, x_1, \dots, x_m\}$ is called an *alphabet*. Each element of X is called a *letter*, and any finite sequence of letters from X, $\eta = x_{i_1} \cdots x_{i_k}$, is called a *word* over X. The *length* of the word η , $|\eta|$, is given by the number of letters it contains. The set of all words with length k is denoted by X^k . The set of all words including the empty word, \emptyset ,

is designated by X^* , while $X^+ := X^* - \{\emptyset\}$. The set X^* forms a monoid under catenation. The set ηX^* is comprised of all words with the prefix $\eta \in X^*$. For any fixed integer $\ell \ge 1$, a mapping $c: X^* \to \mathbb{R}^{\ell}$ is called a *formal power series*. The value of c at $\eta \in X^*$ is written as $(c, \eta) \in \mathbb{R}^{\ell}$ and called the *coefficient* of η in c. Typically, c is represented as the formal sum $c = \sum_{\eta \in X^*} (c, \eta)\eta$. If the *constant term* $(c, \emptyset) = 0$ then c is said to be *proper*. The *support* of c, $\supp(c)$, is the set of all words having nonzero coefficients. The *order* of c, ord(c), is the length of the shortest word in its support $(ord(0) := \infty)$.¹ The collection of all formal power series over X^* is denoted by $\mathbb{R}^{\ell}\langle\langle X \rangle\rangle$. It forms an associative \mathbb{R} -algebra under the catenation product and a commutative and associative \mathbb{R} -algebra under the shuffle product, denoted here by the shuffle symbol \sqcup . The latter is the \mathbb{R} -bilinear extension of the shuffle product of two words, which is defined inductively by

(2.1)
$$(x_i\eta) \sqcup (x_j\xi) = x_i(\eta \sqcup (x_j\xi)) + x_j((x_i\eta) \sqcup \xi)$$

with $\eta \sqcup \emptyset = \emptyset \sqcup \eta = \eta$ for all $\eta, \xi \in X^*$ and $x_i, x_j \in X$ [11].

2.1. Fliess Operators and Their Interconnections. One can formally associate with any series $c \in \mathbb{R}^{\ell}\langle\langle X \rangle\rangle$ a causal *m*-input, ℓ -output operator, F_c , in the following manner. Let $\mathfrak{p} \geq 1$ and $t_0 < t_1$ be given. For a Lebesgue measurable function $u : [t_0, t_1] \to \mathbb{R}^m$, define $\|u\|_{\mathfrak{p}} = \max\{\|u_i\|_{\mathfrak{p}} : 1 \leq i \leq m\}$, where $\|u_i\|_{\mathfrak{p}}$ is the usual $L_{\mathfrak{p}}$ -norm for a measurable real-valued function, u_i , defined on $[t_0, t_1]$. Let $L_{\mathfrak{p}}^m[t_0, t_1]$ denote the set of all measurable functions defined on $[t_0, t_1]$ having a finite $\|\cdot\|_{\mathfrak{p}}$ norm and $B_{\mathfrak{p}}^m(R)[t_0, t_1] := \{u \in L_{\mathfrak{p}}^m[t_0, t_1] : \|u\|_{\mathfrak{p}} \leq R\}$. Assume $C[t_0, t_1]$ is the subset of continuous functions in $L_1^m[t_0, t_1]$. Define inductively for each word $\eta \in X^*$ the map $E_{\eta} : L_1^m[t_0, t_1] \to C[t_0, t_1]$ by setting $E_{\emptyset}[u] = 1$ and letting

$$E_{x_i\bar{\eta}}[u](t,t_0) = \int_{t_0}^t u_i(\tau) E_{\bar{\eta}}[u](\tau,t_0) \, d\tau,$$

where $x_i \in X$, $\bar{\eta} \in X^*$, and $u_0 = 1$. The input-output operator corresponding to $c = \sum_{\eta \in X^*} (c, \eta) \eta \in \mathbb{R}^{\ell} \langle \langle X \rangle \rangle$ is the *Fliess operator*

$$F_{c}[u](t) = \sum_{\eta \in X^{*}} (c, \eta) E_{\eta}[u](t, t_{0})$$

[11, 12]. If there exist real numbers $K_c, M_c > 0$ such that

$$(2.2) \qquad |(c,\eta)| \le K_c M_c^{|\eta|} |\eta|!, \quad \forall \eta \in X^*,$$

then F_c constitutes a well defined mapping from $B_{\mathfrak{p}}^m(R)[t_0, t_0+T]$ into $B_{\mathfrak{q}}^\ell(S)[t_0, t_0+T]$ for sufficiently small R, T > 0 and some S > 0, where the numbers $\mathfrak{p}, \mathfrak{q} \in [1, \infty]$ are conjugate exponents, i.e., $1/\mathfrak{p} + 1/\mathfrak{q} = 1$ [22]. (Here, $|z| := \max_i |z_i|$ when $z \in \mathbb{R}^{\ell}$.) The set of all such *locally convergent* series is denoted by $\mathbb{R}_{LC}^\ell\langle\langle X \rangle\rangle$. A Fliess operator F_c defined on $B_{\mathfrak{p}}^m(R)[t_0, t_0 + T]$ is said to be *realizable* when there exists a state space model consisting of n differential equations and ℓ output functions

(2.3a)
$$\dot{z} = g_0(z) + \sum_{i=1}^m g_i(z) u_i, \ z(t_0) = z_0$$

(2.3b)
$$y_j = h_j(z), \quad j = 1, 2, \dots, \ell,$$

where each g_i is an analytic vector field expressed in local coordinates on some neighborhood \mathcal{W} of z_0 , and each output function h_j is an analytic function on \mathcal{W} such that (2.3a) has a well defined solution z(t), $t \in [t_0, t_0 + T]$ on \mathcal{W} for any given input $u \in B^m_{\mathfrak{p}}(R)[t_0, t_0 + T]$, and $y_j(t) = F_{c_j}[u](t) = h_j(z(t))$, $t \in [t_0, t_0 + T]$, $j = 1, 2, \ldots, \ell$ [11,12,22,25,33]. It can be shown that for any word $\eta = x_{i_k} \cdots x_{i_1} \in X^*$

(2.4)
$$(c_j, \eta) = L_{g_\eta} h_j(z_0) := L_{g_{i_1}} \cdots L_{g_{i_k}} h_j(z_0),$$

where $L_{g_i}h_j$ is the *Lie derivative* of h_j with respect to g_i . For any $c \in \mathbb{R}^{\ell}\langle\langle X \rangle\rangle$, the \mathbb{R} -linear mapping $\mathcal{H}_c : \mathbb{R}\langle X \rangle \to \mathbb{R}^{\ell}\langle\langle X \rangle\rangle$ uniquely specified by $(\mathcal{H}_c(\eta), \xi) = (c, \xi\eta), \quad \xi, \eta \in X^*$ is called the *Hankel mapping* of c. The series c is said to have *Lie rank* n when the range space of \mathcal{H}_c restricted to the \mathbb{R} -vector space of Lie polynomials over X, i.e., the free Lie algebra $\mathcal{L}(X)$, has dimension n. It is well known that F_c is realizable if and only if $c \in \mathbb{R}_{LC}^{\ell}\langle\langle X \rangle\rangle$ has finite Lie rank [12, 25, 33].

When convergent Fliess operators are connected in a parallel-sum configuration, it is elementary to show that the composite system satisfies $F_c + F_d = F_{c+d}$. It was shown in [11] for the parallel-product connection that $F_cF_d = F_c \sqcup d$. If F_c and F_d with $c \in$ $\mathbb{R}_{LC}^{\ell}\langle\langle X\rangle\rangle$ and $d\in\mathbb{R}_{LC}^{m}\langle\langle X\rangle\rangle$ are interconnected in a cascade manner, the composite system $F_c \circ F_d$ has the Fliess operator representation $F_{c \circ d}$, where $c \circ d$ denotes the composition product of c and d as described in [9]. This product is associative and \mathbb{R} -linear in its left argument c. In the event that two convergent Fliess operators are interconnected to form a feedback system, the closed-loop system has a convergent Fliess operator representation whose generating series is the *output feedback product* of c and d, denoted by c@d [18,39]. Consider, for example, the SISO case where the alphabet $X = \{x_0, x_1\}$ and $\ell = 1$. Define the set of unital Fliess operators $\mathscr{F}_{\delta} = \{I + F_c : c \in \mathbb{R}_{LC}(\langle X \rangle)\}, \text{ where } I \text{ denotes the identity map, i.e., } I[u] = u.$ It is convenient to introduce the symbol δ as the (fictitious) generating series for I. That is, $F_{\delta} := I$ such that $I + F_c := F_{\delta+c} = F_{c_{\delta}}$ with $c_{\delta} := \delta + c$. The set of all such generating series for \mathscr{F}_{δ} is denoted by $\mathbb{R}_{LC}\langle \langle X_{\delta} \rangle \rangle$ with the augmented alphabet $X_{\delta} := \{\delta\} \cup X$. It has been proved that \mathscr{F}_{δ} forms a group under the composition $F_{c_{\delta}} \circ F_{d_{\delta}} = (I + F_c) \circ (I + F_d) = F_{c_{\delta} \circ d_{\delta}}$, where $c_{\delta} \circ d_{\delta} := \delta + d + c \circ d$, and \circ denotes the *modified composition product* [20].² The unit element of this group is the identity map I. Of central importance is the so-called *coordinate algebra* of functions, H, on the corresponding group $(\mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle, \circ, \delta)$. In this setting the group multiplication is dualized to a comultiplication on H, which is captured through the notion of a Hopf algebra. In fact, the compositional nature of the product on \mathscr{F}_{δ} turns H into a Faà di Bruno type Hopf algebra. In which case, the group (composition) inverse in $(\mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle, \circ, \delta), c_{\delta}^{-1} =: \delta + c^{-1}$, can be computed efficiently by a recursive algorithm [7]. This inverse is also key in describing the output feedback product as shown in the following theorem.

THEOREM 2.1. [18,39] For any $c, d \in \mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle$ it follows that $c@d = c \circ (-d \circ c)^{-1}$ with $c@d \in \mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle$. In addition, $c@d = c \circ (d \circ (c@d))$.

It is known that the set of locally convergent generating series is closed under addition, the shuffle product [40], the composition product [20], the modified composition product [29], and the feedback product [18,39]. Therefore, all the corresponding elementary interconnections of Fliess operators preserve local convergence.

Finally, the algebraic theory described above remains largely intact for formal power series that do not necessarily satisfy convergence condition (2.2). In place of a convergent Fliess operator one can introduce a *formal* Fliess operator which maps formal functions to formal functions [23]. The motivation for this is the observation that if $c \in \mathbb{R}_{LC}^{\ell}\langle X \rangle$ and u is analytic with a convergent Taylor series representation $u = \sum_{n\geq 0} (c_u, x_0^n)(t-t_0)^n/n! = \sum_{n\geq 0} (c_u, x_0^n) E_{x_0^n}[u](t, t_0)$, then $y = F_c[u]$ is also analytic with Taylor series coefficients given by $c_y = c \circ c_u$ so that $c_u \in \mathbb{R}_{LC}^m[X_0]$ and $c_y \in \mathbb{R}_{LC}^{\ell}[[X_0]]$ with $X_0 := \{x_0\}$. But when c is not locally convergent, the mapping $\mathbb{R}^m[[X_0]] \to \mathbb{R}_{LC}^{\ell}[[X_0]] : c_u \mapsto c_y = c \circ c_u$ is still well defined. It can be viewed as the formal version of F_c . The set $\mathbb{R}^{\ell}\langle \langle X_{\delta} \rangle$, which also forms a group under the product $c_{\delta} \circ d_{\delta}$, is the corresponding set of generating series for these formal operators.

2.2. Shuffle Product Operations on Ultrametric Spaces. Given a set S, a function $\mathscr{U}: S \times S \to \mathbb{R}$ is called an *ultrametric* if it satisfies the following properties for all $s, s', s'' \in S$:

- i. $\mathscr{U}(s,s') \ge 0$
- ii. $\mathscr{U}(s,s') = 0$ if and only if s = s'
- iii. $\mathscr{U}(s,s')=\mathscr{U}(s',s)$
- iv. $\mathscr{U}(s,s') \leq \max{\{\mathscr{U}(s,s''), \mathscr{U}(s'',s')\}}.$

The pair (S, \mathscr{U}) is referred to as an *ultrametric space*. In the event that property iv is replaced with the triangle inequality, (S, \mathscr{U}) reduces to the usual definition of a metric space. It is not difficult to show for any fixed $0 < \sigma < 1$ that the \mathbb{R} -vector space $\mathbb{R}\langle\langle X \rangle\rangle$ with the distance between two series defined as $\operatorname{dist}(c, d) = \sigma^{\operatorname{ord}(c-d)}$ is a complete ultrametric space [1]. In this section two key lemmas are presented which describe how the distance between two series is altered by operations involving the shuffle product defined in (2.1). These results are employed in Section 3 to prove the existence of a group inverse using ultrametric contractions on $(\mathbb{R}\langle\langle X \rangle\rangle, \operatorname{dist})$.

LEMMA 2.2. For any series $c_i, d_i \in \mathbb{R}\langle\langle X \rangle\rangle$, i = 1, 2,

$$\operatorname{dist}(c_1 \sqcup d_1, c_2 \sqcup d_2) \leq \max(\sigma^{\operatorname{ord}(c_1)} \operatorname{dist}(d_1, d_2), \sigma^{\operatorname{ord}(d_2)} \operatorname{dist}(c_1, c_2)).$$

Proof. First observe that

 $\operatorname{dist}(c_i \sqcup d_1, c_i \sqcup d_2) = \sigma^{\operatorname{ord}(c_i \sqcup (d_1 - d_2))} = \sigma^{\operatorname{ord}(c_i) + \operatorname{ord}(d_1 - d_2)} = \sigma^{\operatorname{ord}(c_i)} \operatorname{dist}(d_1, d_2).$

In which case, it follows that

$$\operatorname{dist}(c_1 \sqcup d_1, c_2 \sqcup d_2) \leq \max(\operatorname{dist}(c_1 \sqcup d_1, c_1 \sqcup d_2), \operatorname{dist}(c_1 \sqcup d_2, c_2 \sqcup d_2))$$
$$= \max(\sigma^{\operatorname{ord}(c_1)} \operatorname{dist}(d_1, d_2), \sigma^{\operatorname{ord}(d_2)} \operatorname{dist}(c_1, c_2)).$$

COROLLARY 2.3. For a fixed $c \in \mathbb{R}\langle\langle X \rangle\rangle$, the mapping $d \mapsto c \sqcup d$ is an ultrametric contraction if c is proper and an isometry on $(\mathbb{R}\langle\langle X \rangle\rangle, \text{dist})$ otherwise.

THEOREM 2.4. [19] The set of nonproper series $\mathbb{R}_{np}\langle\langle X \rangle\rangle \subset \mathbb{R}\langle\langle X \rangle\rangle$ is a group under the shuffle product. In particular, the shuffle inverse of any such series $c \in$ $\mathbb{R}_{np}\langle\langle X \rangle\rangle$ is $c^{\sqcup -1} = ((c, \emptyset)(1 - c'))^{\sqcup -1} := (c, \emptyset)^{-1}(c')^{\sqcup *}$, where $c' := 1 - c/(c, \emptyset)$ is proper and $(c')^{\sqcup *} := \sum_{k\geq 0} (c')^{\sqcup k}$.

LEMMA 2.5. The shuffle inverse is an isometry for any $c, d \in \mathbb{R}_{np}\langle\langle X \rangle\rangle$ having identical constant terms.

Proof. For any $c, d \in \mathbb{R}_{np}\langle\langle X \rangle\rangle$ with $(c, \emptyset) = (d, \emptyset)$ observe that

$$\operatorname{ord}(c^{\,\sqcup\,-1} - d^{\,\sqcup\,-1}) = \operatorname{ord}\left(\sum_{k=1}^{\infty} (c')^{\,\sqcup\,k} - (d')^{\,\sqcup\,k}\right) = \operatorname{ord}(c' - d') = \operatorname{ord}(c - d),$$

and hence the lemma is proved. \square

2.3. Hopf Algebras. Some definitions and basic facts concerning Hopf algebras are summarized in this section for later use. The treatment is based largely on [10, 24,30,35,37]. In the following, a *unital* \mathbb{R} -algebra refers to a vector space A over the base field \mathbb{R} with associative product $m_A: A \otimes A \to A$ and unit map (element) $\mathbf{e}_A: \mathbb{R} \to A$ $(\mathbf{e}_A(1) = 1_A)$. A counital coalgebra over \mathbb{R} consists of a triple $(C, \Delta_C, \varepsilon_C)$. The coproduct $\Delta_C : C \to C \otimes C$ is coassociative, that is, $(\mathrm{id}_C \otimes \Delta_C) \circ \Delta_C = (\Delta_C \otimes \mathrm{id}_C) \circ \Delta_C$, where id_C is the identity map on C and $\varepsilon_C : C \to \mathbb{R}$ denotes the counit (augmentation) map. A coalgebra is cocommutative if $\tau_C \circ \Delta_C = \Delta_C$, where $\tau_C : C \otimes C \to C \otimes C$ is the flip map, $\tau_C(x \otimes y) = y \otimes x$. A bialgebra B is both a unital algebra and a counital coalgebra together with compatibility relations, such as both the algebra product, $xy := m_B(x \otimes y)$, and the unit map, $\mathbf{e}_B : \mathbb{R} \to B$, are coalgebra morphisms. This provides, for example, the identity $\Delta_B(xy) = \Delta_B(x)\Delta_B(y)$. The unit of B is denoted by $\mathbf{1}_B = \mathbf{e}_B(1)$. A bialgebra is called *graded* if there are \mathbb{R} -vector subspaces $B_n, n \in \mathbb{N}$ such that $B = \bigoplus_{n \ge 0} B_n$ with $m_B(B_k \otimes B_l) \subseteq B_{k+l}$ and $\Delta_B B_n \subseteq \bigoplus_{k+l=n} B_k \otimes B_l$. Elements $x \in B_n$ are given a degree deg(x) = n. Moreover, B is called *connected* if the \mathbb{R} -vector subspace $B_0 = \mathbb{R}\mathbf{1}_B$. Define $B_+ = \bigoplus_{n>0} B_n$. In a connected graded bialgebra, the coproduct for any $x \in B_n$ is of the form

$$\Delta_B(x) = x \otimes \mathbf{1}_B + \mathbf{1}_B \otimes x + \Delta'_B(x) \in \bigoplus_{k+l=n} B_k \otimes B_l,$$

where $\Delta'_B(x) := \Delta_B(x) - x \otimes \mathbf{1}_B - \mathbf{1}_B \otimes x \in \bigoplus_{\substack{k+l=n\\k,l>0}} B_k \otimes B_l$ is the *reduced* coproduct. Note that in the following the use of subscripts on the structure maps is limited to the cases where there is potential for notational confusion.

Suppose B is a bialgebra and A is an \mathbb{R} -algebra with product $m_A : A \otimes A \to A$ and unit map \mathbf{e}_A , e.g., $A = \mathbb{R}$ or A = B. The vector space L(B, A) of linear maps from the bialgebra B to A together with the convolution product

(2.5)
$$\Phi \star \Psi := m_A \circ (\Phi \otimes \Psi) \circ \Delta : B \to A,$$

where $\Phi, \Psi \in L(B, A)$, is an associative algebra with unit $\iota := \mathbf{e}_A \circ \varepsilon$. A Hopf algebra H is a bialgebra together with a particular \mathbb{R} -linear map called an *antipode* $S: H \to H$ which satisfies the Hopf algebra axioms [35,37] and has the property of being an antihomomorphism for both the algebra and the coalgebra structures, i.e., S(xy) = S(y)S(x) and $\Delta \circ S = (S \otimes S) \circ \tau \circ \Delta$. When A = H, the necessarily unique antipode $S \in L(H, H)$ is the inverse of the identity map id $: H \to H$ with respect to the convolution product, that is,

(2.6)
$$S \star \mathrm{id} = \mathrm{id} \star S := m \circ (S \otimes \mathrm{id}) \circ \Delta = \mathsf{e} \circ \varepsilon.$$

Group-like and primitive elements in a Hopf algebra satisfy $\Delta(x) = x \otimes x$ and $\Delta(y) = y \otimes \mathbf{1} + \mathbf{1} \otimes y$, respectively. Note that if x_1, x_2 are primitive in H, then $[x_1, x_2] := m_H(x_1 \otimes x_2) - m_H(x_2 \otimes x_1)$ is primitive as well. In particular, the set of primitive elements $P(H) \subset H$ is a Lie algebra. Another important observation is that a connected graded bialgebra $H = \bigoplus_{n \geq 0} H_n$ is always a connected graded Hopf algebra.

Let $H = \bigoplus_{n \ge 0} H_n$ be a connected graded commutative bialgebra, and suppose A is a commutative unital algebra. Any $\Phi \in L(H, A)$ is called a *character* if $\Phi(\mathbf{1}) = \mathbf{1}_A$ and

(2.7)
$$\Phi(xy) = \Phi(x)\Phi(y)$$

for all $x, y \in H$. The set of characters is denoted by $G_A \subset L(H, A)$ and forms a group with respect to the convolution product (2.5). The neutral element $\iota := \mathbf{e}_A \circ \varepsilon$ in G_A is given by $\iota(\mathbf{1}) = \mathbf{1}_A$ and $\iota(x) = 0$ for elements x in the *augmentation ideal* $\operatorname{Ker}(\varepsilon) = H_+ = \bigoplus_{n>0} H_n$. The inverse of $\Phi \in G_A$ is given by composition with the antipode

$$\Phi^{\star -1} = \Phi \circ S$$

which follows from (2.6) and the fact that Φ is an algebra morphism. Specifically,

$$\Phi \star (\Phi \circ S) = \Phi \circ (\mathrm{id} \star S) = \Phi \circ (S \star \mathrm{id}) = (\Phi \circ S) \star \Phi = \Phi \circ \mathsf{e} \circ \varepsilon = \mathsf{e} \circ \varepsilon.$$

An infinitesimal character with values in A is a linear map $\xi \in L(H, A)$ such that for $x, y \in H^+$, $\xi(m_H(x \otimes y)) = 0$, which implies $\xi(1) = 0$. The linear space of infinitesimal characters $g_A \subset L(H, A)$ forms a Lie algebra with respect to the Lie bracket defined in terms of the convolution product (2.5). For $\alpha \in g_A$ and any $x \in H_n$ the exponential $\exp^*(\alpha)(x) := \sum_{j>0} \frac{1}{j!} \alpha^{*j}(x)$ is a finite sum terminating at j = n.

PROPOSITION 2.6. exp* restricts to a bijection from g_A onto G_A . (For details see references [8, 10]). The inverse of exp* is given by $\log^*(\iota + \gamma)(x) = \sum_{k \ge 1} \frac{(-1)^{k-1}}{k} \gamma^{*k}(x)$, where again the sum terminates at k = n for any $x \in H_n$.

Finally, a brief description of the relationship between the group $G_A \subset L(H, A)$ and the Hopf algebra H is given. The reader is referred to the paper of Manchon and Frabetti [15] for details and additional references. By definition, elements in G_A map all of H into the commutative unital algebra A. However, any element $x \in H$ can also be seen as an A-valued function on G_A . Indeed, let $\Phi \in G_A$, then $x(\Phi) := \Phi(x) \in A$ and the usual pointwise product of functions $(xy)(\Phi) = x(\Phi)y(\Phi)$ follows from (2.7) since $\Phi \in G_A$. The definition of the convolution product (2.5) in terms of the coproduct of H implies a natural coproduct on functions $x \in H$, that is, $\Delta(x)(\Phi, \Psi) := (\Phi \star \Psi)(x) \in A$. Similarly, the inverse of G_A as well as its unit correspond naturally to the antipode and counit map on H, respectively. This reversed perspective on the relationship between H and its group of characters G_A allows one to interpret H as the (Hopf) algebra of *coordinate functions* of the group G_A . More precisely, H contains the representative functions over G_A . The reader is directed to Cartier's work [5] for a comprehensive review of this topic. In this paper, the starting point will be a particular group whose product, unit and inverse are used to identify its Hopf algebra of coordinate functions.

3. Output Affine Feedback Transformation Group. In general, if G is a group and S a given set, then G is said to act as a *transformation group* on the right of S if there exists a mapping $\phi : S \times G \to S : (h, g) \mapsto hg$ such that:

i. h1 = h, where 1 is the identity element of G;

ii. $h(g_1g_2) = (hg_1)g_2$ for all $g_1, g_2 \in G$.

The action is said to be *free* if hg = h implies that g = 1. It will be evident in what follows that it is most convenient to redefine $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle := \mathbb{R}\langle\langle X\rangle\rangle \times \mathbb{R}\langle\langle X\rangle\rangle$ and to identify the output affine feedback transformation group with those elements of $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ which are invertible in some sense. Each tuple $c_{\delta} := (c_L, c_R) \in \mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle :=$ $\mathbb{R}_{LC}\langle\langle X\rangle\rangle \times \mathbb{R}_{LC}\langle\langle X\rangle\rangle$ gives rise to an operator of the form $F_{c_{\delta}}[u] := F_{c_{L}}[u]u + F_{c_{R}}[u]$, and by design the group product $c_{\delta} \circ d_{\delta}$ for elements in $\mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle$ will satisfy the identity $F_{c_{\delta}} \circ F_{d_{\delta}} = F_{c_{\delta} \circ d_{\delta}}$ when $c_{\delta} \circ d_{\delta} \in \mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle$. In addition, a second product $c \tilde{\circ} d$ is defined which describes the action of the group $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ on $\mathbb{R}\langle\langle X\rangle\rangle$ so that $F_{c} \circ F_{d_{\delta}} = F_{c \tilde{\circ} d_{\delta}}$ when the series involved are all locally convergent. This product, referred to as the *mixed composition product*, plays a central role in the paper, so it will be the starting point for the section. Once these concepts are in place and the transformation group is established, the affine extension of the output feedback product in Theorem 2.1 will be given. Henceforth, the focus is on the SISO case.

For a fixed $d_{\delta} = (d_L, d_R) \in \mathbb{R}\langle\langle X_{\delta} \rangle\rangle$, the mixed composition product is defined in terms of an algebra morphism ϕ_d which takes words in X^* to a composition of simple vector space endomorphisms involving only the shuffle product and catenation with a single letter x_0 or x_1 . This sets up an inductive definition which provides some insight into the core combinatorial structures at play. The reader is referred in particular to [13,14] for a broader theoretical view behind this approach.

DEFINITION 3.1. Let $d_{\delta} = (d_L, d_R) \in \mathbb{R}\langle \langle X_{\delta} \rangle \rangle$. Define the mixed composition product mapping $\mathbb{R}\langle \langle X \rangle \rangle \times \mathbb{R}\langle \langle X_{\delta} \rangle \rangle$ into $\mathbb{R}\langle \langle X \rangle \rangle$ as

(3.1)
$$c \,\tilde{\circ} \, d_{\delta} = \phi_d(c)(1) = \sum_{\eta \in X^*} (c, \eta) \, \phi_d(\eta)(1),$$

where ϕ_d is the continuous (in the ultrametric sense) algebra homomorphism from $\mathbb{R}\langle\langle X\rangle\rangle$ to $\operatorname{End}(\mathbb{R}\langle\langle X\rangle\rangle)$ uniquely specified by $\phi_d(x_i\eta) = \phi_d(x_i) \circ \phi_d(\eta)$ with

(3.2)
$$\phi_d(x_0)(e) = x_0 e, \ \phi_d(x_1)(e) = x_1(d_L \sqcup e) + x_0(d_R \sqcup e)$$

for any $e \in \mathbb{R}\langle \langle X \rangle \rangle$, and where $\phi_d(\emptyset)$ denotes the identity map on $\mathbb{R}\langle \langle X \rangle \rangle$. EXAMPLE 3.2. Suppose $c = 2x_0 + x_1x_0$ and $d_{\delta} = (d_L, d_R) = (3x_1, -x_1^2)$. Then

$$c \,\tilde{\circ}\, d_{\delta} = 2\phi_d(x_0)(1) + \phi_d(x_1) \circ \phi_d(x_0)(1),$$

where $\phi_d(x_0)(e) = x_0 e$ and $\phi_d(x_1)(e) = x_1(3x_1 \sqcup e) + x_0(-x_1^2 \sqcup e)$. Therefore, $c \circ d_{\delta} = 2x_0 + 3x_1^2x_0 + 3x_1x_0x_1 - x_0x_1^2x_0 - x_0x_1x_0x_1 - x_0^2x_1^2$.

The modified composition product referred to in Section 2 and used in earlier work on output feedback [18–20, 29, 39] corresponds here to the special case where $d_L = 1$. Some fundamental properties of the mixed composition product are given next.

LEMMA 3.3. The mixed composition product (3.1)

- (1) is left \mathbb{R} -linear;
- (2) satisfies $c \circ (1, 0) = c$;
- (3) satisfies $c \ \tilde{\circ} d_{\delta} = k \in \mathbb{R}$ for any fixed d_{δ} if and only if c = k;
- (4) satisfies $(x_0c) \circ d_{\delta} = x_0(c \circ d_{\delta})$ and $(x_1c) \circ d_{\delta} = x_1(d_L \sqcup (c \circ d_{\delta})) + x_0(d_R \sqcup (c \circ d_{\delta}));$
- (5) distributes to the left over the shuffle product. Proof.
- (1) This fact follows directly from the definition of the mixed composition product.
- (2) The claim is immediate since $\phi_{(1,0)}(\eta)(1) = \eta$.

(3) The only non trivial assertion is that $c \circ d_{\delta} = k$ implies c = k. This claim is best handled in a Hopf algebra setting. So the proof is deferred until Section 4. (4) Observe:

$$(x_0c) \,\tilde{\circ} \, d_\delta = \phi_d(x_0c)(1) = \phi_d(x_0) \circ \phi_d(c)(1) = x_0(c \,\tilde{\circ} \, d_\delta) (x_1c) \,\tilde{\circ} \, d_\delta = \phi_d(x_1c)(1) = \phi_d(x_1) \circ \phi_d(c)(1) = x_1(d_L \sqcup (c \,\tilde{\circ} \, d_\delta)) + x_0(d_R \sqcup (c \,\tilde{\circ} \, d_\delta)).$$

(5) For any $e_{\delta} \in \mathbb{R}\langle \langle X_{\delta} \rangle \rangle$, one can define a shuffle product on $\operatorname{End}(\mathbb{R}\langle \langle X \rangle \rangle)$ via

$$\phi_e(x_i\eta) \sqcup \phi_e(x_j\xi) = \phi_e(x_i) \circ [\phi_e(\eta) \sqcup \phi_e(x_j\xi)] + \phi_e(x_j) \circ [\phi_e(x_i\eta) \sqcup \phi_e(\xi)].$$

In which case, ϕ_e acts as an algebra map between the shuffle algebra on $\mathbb{R}\langle\langle X\rangle\rangle$ and the shuffle algebra on $\operatorname{End}(\mathbb{R}\langle\langle X\rangle\rangle)$. That is, $\phi_e(c \sqcup d) = \phi_e(c) \sqcup \phi_e(d)$. Hence, $(c \sqcup d) \circ e_{\delta} = \phi_e(c \sqcup d)(1) = \phi_e(c)(1) \sqcup \phi_e(d)(1) = (c \circ e_{\delta}) \sqcup (d \circ e_{\delta})$.

It is easily checked that $\operatorname{dist}(c_{\delta}, d_{\delta}) := \max(\operatorname{dist}(c_L, d_L), \operatorname{dist}(c_R, d_R))$ is an ultrametric on $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$, and $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ is complete.³ The following lemma states that the mixed composition product reduces ultrametric distance in a certain sense.

LEMMA 3.4. For any $c \in \mathbb{R}\langle\langle X \rangle\rangle$ and $d_{\delta,1}, d_{\delta,2} \in \mathbb{R}\langle\langle X_{\delta} \rangle\rangle$ it follows that

 $\operatorname{dist}(c \circ d_{\delta,1}, c \circ d_{\delta,2}) \leq \sigma^{\operatorname{ord}(c')} \operatorname{dist}(d_{\delta,1}, d_{\delta,2}),$

where $c = (c, \emptyset)\emptyset + c'$ with c' proper.

Proof. For a fixed d_R , consider the map $d_L \mapsto c \tilde{\circ} (d_L, d_R)$. Likewise, for a fixed d_L there is a companion map $d_R \mapsto c \tilde{\circ} (d_L, d_R)$. It is first shown that on the ultrametric space $(\mathbb{R}\langle\langle X \rangle\rangle, \text{dist})$:

(3.3a)
$$\operatorname{dist}(c \,\tilde{\circ} \, (d_{L,1}, d_R), c \,\tilde{\circ} \, (d_{L,2}, d_R)) \leq \sigma^{\operatorname{ord}(c')} \operatorname{dist}(d_{L,1}, d_{L,2})$$

(3.3b)
$$\operatorname{dist}(c \,\tilde{\circ} \, (d_L, d_{R,1}), c \,\tilde{\circ} \, (d_L, d_{R,2})) \leq \sigma^{\operatorname{ord}(c')} \operatorname{dist}(d_{R,1}, d_{R,2}).$$

Inequality (3.3a) is clearly true when $d_{L,1} = d_{L,2}$. When $d_{L,1} \neq d_{L,2}$, it is first necessary to show that for any $\eta \in X^*$

(3.4)
$$\operatorname{ord}(\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1)) \ge |\eta| + \operatorname{ord}(d_{L,1} - d_{L,2}).$$

The proof is by induction on the length of η . The claim is trivial when η is empty or a single letter. Assume the inequality holds for words up to length $k \ge 0$. For any $x_0\eta$ with $\eta \in X^k$, inequality (3.4) follows directly from the induction hypothesis. The case for $x_1\eta$ is handled as follows:

$$\begin{aligned} \operatorname{ord}(\phi_{d_1}(x_1\eta)(1) - \phi_{d_2}(x_1\eta)(1)) \\ &= \operatorname{ord}(x_1[d_{L,1} \sqcup \phi_{d_1}(\eta)(1) - d_{L,2} \sqcup \phi_{d_2}(\eta)(1)] + x_0[d_R \sqcup (\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1))]) \\ &= \operatorname{ord}(x_1[(d_{L,1} - d_{L,2}) \sqcup \phi_{d_1}(\eta)(1) + d_{L,2} \sqcup (\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1))] + \\ & x_0[d_R \sqcup (\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1))]) \\ &\geq 1 + \min(\operatorname{ord}([d_{L,1} - d_{L,2}] \sqcup \phi_{d_1}(\eta)(1)), \operatorname{ord}(d_{L,2} \sqcup [\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1)]), \\ & \operatorname{ord}(d_R \sqcup [\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1)])) \\ &\geq 1 + \min(\operatorname{ord}(d_{L,1} - d_{L,2}) + |\eta|, \operatorname{ord}(\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1))) \\ &= |\eta| + 1 + \operatorname{ord}(d_{L,1} - d_{L,2}). \end{aligned}$$

In which case, (3.4) holds for any $\eta \in X^*$. The inequality (3.3a) is now derived. Observe

$$dist(c \,\tilde{\circ}\,(d_{L,1}, d_R), c \,\tilde{\circ}\,(d_{L,2}, d_R)) = \sigma^{\operatorname{ord}(\sum_{\eta} (c', \eta) [\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1)])} \\ \leq \sigma^{\min_{\eta \in \operatorname{supp}(c')} \operatorname{ord}(\phi_{d_1}(\eta)(1) - \phi_{d_2}(\eta)(1))} \leq \sigma^{\min_{\eta \in \operatorname{supp}(c')} |\eta| + \operatorname{ord}(d_{L,1} - d_{L,2})} \\ = \sigma^{\operatorname{ord}(c')} \operatorname{dist}(d_{L,1}, d_{L,2}).$$

³Using dist for both the ultrametric on $\mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ should cause minimal confusion since their arguments are distinct.

The proof for (3.3b) is completely analogous. The final step of the proof is to employ the ultrametric property iv in conjunction with (3.3). Observe

 $dist(c \circ d_{\delta,1}, c \circ d_{\delta,2}) = dist(c \circ (d_{L,1}, d_{R,1}), c \circ (d_{L,2}, d_{R,2})) \\ \leq max(dist(c \circ (d_{L,1}, d_{R,1}), c \circ (d_{L,2}, d_{R,1})), dist(c \circ (d_{L,2}, d_{R,1}), c \circ (d_{L,2}, d_{R,2}))) \\ \leq \sigma^{\operatorname{ord}(c')} max(dist(d_{L,1}, d_{L,2}), dist(d_{R,1}, d_{R,2})) = \sigma^{\operatorname{ord}(c')} dist(d_{\delta,1}, d_{\delta,2}).$

The group product on $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ is now defined in terms of the mixed composition product. Its basic properties are given in the subsequent lemma.

DEFINITION 3.5. The composition product on $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ is defined as

$$c_{\delta} \circ d_{\delta} = ((c_L \, \widetilde{\circ} \, d_{\delta}) \sqcup d_L, (c_L \, \widetilde{\circ} \, d_{\delta}) \sqcup d_R + c_R \, \widetilde{\circ} \, d_{\delta}).$$

LEMMA 3.6. The composition product on $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$

(1) is left \mathbb{R} -linear;

(2) satisfies $(c \circ d_{\delta}) \circ e_{\delta} = c \circ (d_{\delta} \circ e_{\delta})$ (mixed associativity);

(3) is associative.

(1) This property follows from the left linearity of the mixed composition product. (2) In light of the first item, it is sufficient to prove the claim only for $c = \eta \in X^k$, $k \ge 0$. The cases k = 0 and k = 1 are trivial. Assume the claim holds up to some

fixed $k \ge 0$. Then via Lemma 3.3 (4) and the induction hypothesis it follows that

$$((x_0\eta)\tilde{\circ} d_{\delta})\tilde{\circ} e_{\delta} = (x_0(\eta\tilde{\circ} d_{\delta}))\tilde{\circ} e_{\delta} = x_0((\eta\tilde{\circ} d_{\delta})\tilde{\circ} e_{\delta}) = x_0(\eta\tilde{\circ} (d_{\delta}\circ e_{\delta})) = (x_0\eta)\tilde{\circ} (d_{\delta}\circ e_{\delta}).$$

In a similar fashion, apply the properties in Lemma 3.3(1), (4), and (5) to get

$$\begin{split} &((x_1\eta) \circ d_{\delta}) \circ e_{\delta} \\ &= [x_1(d_L \sqcup (\eta \circ d_{\delta})) + x_0(d_R \sqcup (\eta \circ d_{\delta}))] \circ e_{\delta} \\ &= [x_1(d_L \sqcup (\eta \circ d_{\delta}))] \circ e_{\delta} + [x_0(d_R \sqcup (\eta \circ d_{\delta}))] \circ e_{\delta} \\ &= x_1[e_L \sqcup ((d_L \sqcup (\eta \circ d_{\delta})) \circ e_{\delta})] + x_0[e_R \sqcup ((d_L \sqcup (\eta \circ d_{\delta})) \circ e_{\delta})] + \\ &\quad x_0[(d_R \sqcup (\eta \circ d_{\delta})) \circ e_{\delta}] \\ &= x_1[\underbrace{e_L \sqcup (d_L \circ e_{\delta})}_{(d_{\delta} \circ e_{\delta})_L} \sqcup ((\eta \circ d_{\delta}) \circ e_{\delta})] + x_0[\underbrace{((d_L \circ e_{\delta}) \sqcup e_R + d_R \circ e_{\delta})}_{(d_{\delta} \circ e_{\delta})_R} \sqcup ((\eta \circ d_{\delta}) \circ e_{\delta})] + \end{split}$$

Now employ the induction hypothesis so that

$$((x_1\eta) \circ d_{\delta}) \circ e_{\delta} = x_1[(d_{\delta} \circ e_{\delta})_L \sqcup (\eta \circ (d_{\delta} \circ e_{\delta}))] + x_0[(d_{\delta} \circ e_{\delta})_R \sqcup (\eta \circ (d_{\delta} \circ e_{\delta}))] = (x_1\eta) \circ (d_{\delta} \circ e_{\delta}).$$

Therefore, the claim holds for all $\eta \in X^*$, and the identity is proved. (3) First apply Definition 3.5 twice, Lemma 3.3 (1) and (5) to get

$$\begin{aligned} (c_{\delta} \circ d_{\delta}) \circ e_{\delta} &= ((c_{L} \circ d_{\delta}) \sqcup d_{L}, (c_{L} \circ d_{\delta}) \sqcup d_{R} + c_{R} \circ d_{\delta}) \circ e_{\delta} \\ &= ([((c_{L} \circ d_{\delta}) \sqcup d_{L}) \circ e_{\delta}] \sqcup e_{L}, [((c_{L} \circ d_{\delta}) \sqcup d_{L}) \circ e_{\delta}] \sqcup e_{R} + \\ &[(c_{L} \circ d_{\delta}) \sqcup d_{R} + c_{R} \circ d_{\delta}] \circ e_{\delta}) \\ &= ([(c_{L} \circ d_{\delta}) \circ e_{\delta}] \sqcup [d_{L} \circ e_{\delta}] \sqcup e_{L}, [(c_{L} \circ d_{\delta}) \circ e_{\delta}] \sqcup e_{\delta}] \\ \end{aligned}$$

$$[d_L \,\tilde{\circ} \, e_\delta] \sqcup e_R + ((c_L \,\tilde{\circ} \, d_\delta) \,\tilde{\circ} \, e_\delta) \sqcup (d_R \,\tilde{\circ} \, e_\delta) + (c_R \,\tilde{\circ} \, d_\delta) \,\tilde{\circ} \, e_\delta)$$

Now apply the mixed associativity property from the previous item and then recombine terms according to Definition 3.5 so that

$$\begin{aligned} (c_{\delta} \circ d_{\delta}) \circ e_{\delta} &= \left(\left[c_{L} \circ (d_{\delta} \circ e_{\delta}) \right] \sqcup \underbrace{\left[d_{L} \circ e_{\delta} \right] \sqcup e_{L}}_{(d_{\delta} \circ e_{\delta})_{L}}, \left[c_{L} \circ (d_{\delta} \circ e_{\delta}) \right] \sqcup \left[d_{L} \circ e_{\delta} \right] \sqcup e_{R} + \\ & \underbrace{\left(c_{L} \circ (d_{\delta} \circ e_{\delta}) \right) \sqcup \left(d_{R} \circ e_{\delta} \right) + c_{R} \circ (d_{\delta} \circ e_{\delta}) \right)}_{(d_{\delta} \circ e_{\delta})_{L}} \\ &= \left(\left[c_{L} \circ (d_{\delta} \circ e_{\delta}) \right] \sqcup \left(d_{\delta} \circ e_{\delta} \right)_{L}, \left[c_{L} \circ (d_{\delta} \circ e_{\delta}) \right] \sqcup \\ & \underbrace{\left[(d_{L} \circ e_{\delta}) \sqcup e_{R} + d_{R} \circ e_{\delta} \right] + c_{R} \circ (d_{\delta} \circ e_{\delta}) \right)}_{(d_{\delta} \circ e_{\delta})_{R}} \\ &= \left(\left(c_{\delta} \circ (d_{\delta} \circ e_{\delta}) \right)_{L}, \left(c_{\delta} \circ (d_{\delta} \circ e_{\delta}) \right)_{R} \right) = c_{\delta} \circ (d_{\delta} \circ e_{\delta}), \end{aligned}$$

and the lemma is proved. \square

The Fliess operator interpretations of the two formal power series products described above are given in the next theorem.

THEOREM 3.7. For any $c \in \mathbb{R}_{LC}\langle\langle X \rangle\rangle$ and $c_{\delta}, d_{\delta} \in \mathbb{R}_{LC}\langle\langle X_{\delta} \rangle\rangle$ such that $c \circ d_{\delta} \in \mathbb{R}_{LC}\langle\langle X_{\delta} \rangle\rangle$ and $c_{\delta} \circ d_{\delta} \in \mathbb{R}_{LC}\langle\langle X_{\delta} \rangle\rangle$, the following identities hold: (1) $F_{c} \circ F_{d_{\delta}} = F_{c \circ d_{\delta}}$ (2) $F_{c_{\delta}} \circ F_{d_{\delta}} = F_{c_{\delta} \circ d_{\delta}}$. *Proof.*

(1) It is sufficient to prove the claim for $c = \eta \in X^*$. This is done by induction on the length of η . The case for the empty word is trivial. Assume the identity holds for words $\eta \in X^k$ up to some fixed length $k \ge 0$. Then

$$E_{x_0\eta} \circ F_{d_\delta}[u](t) = \int_{t_0}^t E_{\eta}[F_{d_\delta}[u]](\tau, t_0) \, d\tau = \int_{t_0}^t F_{\eta \,\tilde{\circ} \, d_\delta}[u](\tau) \, d\tau = F_{x_0(\eta \,\tilde{\circ} \, d_\delta)}[u](t)$$
$$= F_{(x_0\eta) \,\tilde{\circ} \, d_\delta}[u](t).$$

Similarly,

$$E_{x_{1}\eta} \circ F_{d_{\delta}}[u](t) = \int_{t_{0}}^{t} F_{\eta \,\check{\circ}\, d_{\delta}}[u](\tau)[F_{d_{L}}[u](\tau)u(\tau) + F_{d_{R}}[u](\tau)] \, d\tau$$

$$= \int_{t_{0}}^{t} F_{d_{L}\,\sqcup\, \sqcup\, (\eta \,\check{\circ}\, d_{\delta})}[u](\tau)u(\tau) + F_{(\eta \,\check{\circ}\, d_{\delta})\,\sqcup\, \sqcup\, d_{R}}[u](\tau) \, d\tau$$

$$= F_{x_{1}(d_{L}\,\sqcup\, \sqcup\, (\eta \,\check{\circ}\, d_{\delta})) + x_{0}((\eta \,\check{\circ}\, d_{\delta})\,\sqcup\, d_{R})}[u](t) = F_{(x_{1}\eta)\circ d_{\delta}}[u](t)$$

Hence, the claim holds for all $\eta \in X^*$. (2) Observe

$$\begin{split} F_{c_{\delta}} \circ F_{d_{\delta}}[u] &= (F_{c_{L}}[u]u + F_{c_{R}}[u]) \circ (F_{d_{L}}[u]u + F_{d_{R}}[u]) \\ &= F_{c_{L}}[F_{d_{\delta}}[u]]F_{d_{L}}[u]u + F_{c_{L}}[F_{d_{\delta}}[u]]F_{d_{R}}[u] + F_{c_{R}}[F_{d_{\delta}}[u]] \\ &= F_{(c_{L} \circ d_{\delta}) \ \sqcup \ d_{L}}[u]u + F_{(c_{L} \circ d_{\delta}) \ \sqcup \ d_{R}}[u] + F_{c_{R} \circ d_{\delta}}[u] \\ &= F_{(c_{\delta} \circ d_{\delta})_{L}}[u]u + F_{(c_{\delta} \circ d_{\delta})_{R}}[u] = F_{c_{\delta} \circ d_{\delta}}[u]. \end{split}$$

Let $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ denote the subset of $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ whose left series are nonproper. THEOREM 3.8. The set $(\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle, \circ, (1,0))$ is a group. *Proof.* From Lemma 3.3 (2), it follows directly that $c_{\delta} \circ (1,0) = c_{\delta}$. Using the identities $1 \circ c_{\delta} = 1$ and $0 \circ c_{\delta} = 0$ from Lemma 3.3 (3), it is straightforward to see that $(1,0) \circ c_{\delta} = c_{\delta}$. Associativity of the group product was established in Lemma 3.6 (3). So the only open issue is the existence of inverses. Suppose c_{δ} is fixed, and one seeks a right inverse $c_{\delta}^{-1} := (c_{L}^{\circ-1}, c_{R}^{\circ-1})$, that is, $c_{\delta} \circ c_{\delta}^{-1} = (1,0)$.⁴ Then it follows directly from Theorem 2.4 and Definition 3.5 that

(3.5a)
$$c_L^{\circ-1} = (c_L \,\tilde{\circ} \, (c_L^{\circ-1}, c_R^{\circ-1}))^{\,\sqcup\, -1}$$

(3.5b)
$$c_R^{\circ-1} = -c_L^{\circ-1} \sqcup (c_R \, \tilde{\circ} \, (c_L^{\circ-1}, c_R^{\circ-1})).$$

It is first shown that the mapping

$$S_R: (e_L, e_R) \mapsto ((c_L \,\tilde{\circ}(e_L, e_R))^{\sqcup \sqcup -1}, -e_L \sqcup (c_R \,\tilde{\circ}(e_L, e_R))))$$

is an ultrametric contraction on $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$, and therefore has a unique fixed point, which by design is a right inverse, c_{δ}^{-1} . Note that for any e_{δ} it follows that $(S_R(e_L, e_R)_L, \emptyset) = (c_L, \emptyset)^{-1} \neq 0$. Thus, the fixed point will always be in the group. Then it is shown that this same series is also a left inverse, that is, $c_{\delta}^{-1} \circ c_{\delta} = (1, 0)$, or equivalently,

(3.6a)
$$c_L = (c_L^{\circ - 1} \tilde{\circ} (c_L, c_R))^{\sqcup \sqcup - 1}$$

(3.6b)
$$c_R = -c_L \sqcup (c_R^{\circ -1} \tilde{\circ} (c_L, c_R)).$$

To establish the first claim, observe via Corollary 2.3 and Lemma 2.5 that for any $e_{\delta}, \bar{e}_{\delta} \in \mathbb{R}\langle \langle X_{\delta} \rangle \rangle$

$$dist(S_R(e_{\delta}), S_R(\bar{e}_{\delta})) = \max(dist((c_L \,\tilde{\circ}(e_L, e_R))^{\sqcup \sqcup -1}, (c_L \,\tilde{\circ}(\bar{e}_L, \bar{e}_R))^{\sqcup \sqcup -1}),$$

$$dist(-e_L \sqcup (c_R \,\tilde{\circ}(e_L, e_R)), -\bar{e}_L \sqcup (c_R \,\tilde{\circ}(\bar{e}_L, \bar{e}_R))))$$

$$\leq \max(dist(c_L \,\tilde{\circ}(e_L, e_R), c_L \,\tilde{\circ}(\bar{e}_L, \bar{e}_R)),$$

$$dist(c_R \,\tilde{\circ}(e_L, e_R), c_R \,\tilde{\circ}(\bar{e}_L, \bar{e}_R))).$$

In which case, from Lemma 3.4 it follows that

$$\operatorname{dist}(S_R(e_{\delta}), S_R(\bar{e}_{\delta})) \leq \max(\sigma^{\operatorname{ord}(c'_L)}\operatorname{dist}((e_L, e_R), (\bar{e}_L, \bar{e}_R)), \sigma^{\operatorname{ord}(c'_R)}\operatorname{dist}((e_L, e_R), (\bar{e}_L, \bar{e}_R))) \leq \sigma \operatorname{dist}(e_{\delta}, \bar{e}_{\delta}).$$

. . . .

To address the second claim, suppose c_{δ}^{-1} satisfies (3.5a). In which case,

$$(c_L \circ c_{\delta}^{-1}) \sqcup c_L^{\circ - 1} = 1$$
$$(c_L \circ c_{\delta}^{-1}) \sqcup (c_L^{\circ - 1} \circ (c_{\delta} \circ c_{\delta}^{-1})) = 1$$

Using Lemma 3.6 (2) and Lemma 3.3 (5) gives

$$(c_L \circ c_{\delta}^{-1}) \sqcup ((c_L^{\circ - 1} \circ c_{\delta}) \circ c_{\delta}^{-1})) = 1$$
$$(c_L \sqcup (c_L^{\circ - 1} \circ c_{\delta})) \circ c_{\delta}^{-1} = 1.$$

⁴The notation $c^{\circ-1}$, $c \in \mathbb{R}\langle\langle X \rangle\rangle$, is used in this situation instead of c^{-1} to distinguish it from $c \sqcup -1$.

Applying Lemma 3.3 (3) then yields $c_L \sqcup (c_L^{\circ^{-1}\tilde{\circ}} c_\delta) = 1$, and thus, $c_L = (c_L^{\circ^{-1}\tilde{\circ}} c_\delta)^{\sqcup^{-1}}$, which is (3.6a). If, in addition, c_δ^{-1} also satisfies (3.5b), then substituting (3.5a) into (3.5b) gives $c_R^{\circ^{-1}} = -(c_L \tilde{\circ} c_\delta^{-1})^{\sqcup^{-1}} \sqcup (c_R \tilde{\circ} c_\delta^{-1})$. Therefore, in a similar fashion,

$$-(c_L \ \tilde{\circ} \ c_{\delta}^{-1}) \sqcup c_R^{\circ -1} = c_R \ \tilde{\circ} \ c_{\delta}^{-1}$$
$$(-c_L \sqcup (c_R^{\circ -1} \ \tilde{\circ} \ c_{\delta})) \ \tilde{\circ} \ c_{\delta}^{-1} = c_R \ \tilde{\circ} \ c_{\delta}^{-1}$$
$$(c_R + c_L \sqcup (c_R^{\circ -1} \ \tilde{\circ} \ c_{\delta})) \ \tilde{\circ} \ c_{\delta}^{-1} = 0.$$

Once again applying Lemma 3.3 (3) gives $c_R + c_L \sqcup (c_R^{\circ -1} \tilde{\circ} c_\delta) = 0$, which is equivalent to (3.6b). \square

The following theorem is the first main result of this section. The issue of freeness will be addressed in Section 5.

THEOREM 3.9. The group $(\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle, \circ, (1,0))$ acts as a right transformation group on $\mathbb{R}\langle\langle X\rangle\rangle$ via the action $c \circ d_{\delta}$.

Proof. See Lemma 3.3 (2) and Lemma 3.6 (2). \Box

The second main result of the section is a formula for the group element e_{δ} which describes the output affine feedback connection shown in Figure 1. This defines the *output affine feedback product*.

THEOREM 3.10. Let $c \in \mathbb{R}_{LC}\langle\langle X \rangle\rangle$ and $d_{\delta} = (d_L, d_R) \in \mathbb{R}_{LC}\langle\langle X_{\delta} \rangle\rangle$. Then the generating series for the output affine feedback connected system is $c@d_{\delta} := c \circ e_{\delta}^{-1}$, where

$$(3.7) e_{\delta} = ((d_L \circ c)^{\sqcup \sqcup -1}, -(d_L \circ c)^{\sqcup \sqcup -1} \sqcup (d_R \circ c)),$$

provided that $e_{\delta}^{-1} \in \mathbb{R}_{LC}\langle\langle X_{\delta}\rangle\rangle$ and $c@d_{\delta} \in \mathbb{R}_{LC}\langle\langle X\rangle\rangle$. In addition, $c@d_{\delta}$ satisfies the fixed-point equation

(3.8)
$$c@d_{\delta} = c \,\tilde{\circ} \, (d_L \circ (c@d_{\delta}), d_R \circ (c@d_{\delta})).$$

Proof. From Figure 1 it is clear that $u = F_{d_L}[y]v + F_{d_R}[y] = F_{d_L \circ c}[u]v + F_{d_R \circ c}[u]$. Therefore, using the nonproperness of $d_L \circ c$, and the fact that the shuffle product, shuffle inverse and composition product on $\mathbb{R}_{LC}\langle\langle X \rangle\rangle$ all preserve local convergence, it follows that

$$\begin{aligned} u - F_{d_R \circ c}[u] &= F_{d_L \circ c}[u]v\\ F_{(d_L \circ c) \sqcup -1}[u](u - F_{d_R \circ c}[u]) &= v\\ F_{((d_L \circ c) \sqcup -1, -(d_L \circ c) \sqcup -1 \sqcup \sqcup (d_R \circ c))}[u] &= v. \end{aligned}$$

It is easily verified that $e := ((d_L \circ c)^{\sqcup \sqcup -1}, -(d_L \circ c)^{\sqcup \sqcup -1} \sqcup (d_R \circ c)) \in \mathbb{R}_{np} \langle \langle X \rangle \rangle \cap \mathbb{R}_{LC} \langle \langle X_{\delta} \rangle \rangle$, so if its inverse is locally convergent, then $u = F_{e_{\delta}^{-1}}[v]$. In which case, $y = F_c[u] = F_{c \ \tilde{\circ} e_{\delta}^{-1}}[v] = F_{c \ \mathbb{Q} d}[v]$. Since generating series are always unique, this implies identity (3.7). To determine the fixed-point equation that $c \ \mathbb{Q} d_{\delta}$ must satisfy, observe that the output affine feedback equation is $y = F_c[F_{d_L}[y]v + F_{d_R}[y]]$. So if $y = F_c \ \mathbb{Q} d_{\delta}[v]$ then

$$y = F_c[F_{d_L}[F_{c@d_{\delta}}[v]]v + F_{d_R}[F_{c@d_{\delta}}[v]]] = F_{c \,\tilde{\circ}\,(d_L \circ (c@d_{\delta}), d_R \circ (c@d_{\delta}))}[v].$$

Again, since generating series are unique, equation (3.8) must hold.

EXAMPLE 3.11. Consider the feedback system shown in Figure 1 with $d_L = 1$. As discussed in the introduction, this corresponds to conventional output feedback and was the main object of study in [17, 18]. In this case, $F_{c_{\delta}}[u] = u + F_{c_R}[u]$ when $c_R \in \mathbb{R}_{LC}\langle\langle X \rangle\rangle$, and (3.7)-(3.8) reduce to their expected forms $e_{\delta} = (1, -(d_R \circ c))$ and $(c@d_{\delta}) = c \tilde{\circ} (1, d_R \circ (c@d_{\delta}))$, respectively, in Theorem 2.1.

EXAMPLE 3.12. Consider now the case where $d_R = 0$ in Figure 1, i.e., pure multiplicative feedback as used, for example, in phase-locked loops. This problem lies entirely outside the framework of earlier work by the authors. In this case, (3.7)-(3.8) reduce to $e_{\delta} = ((d_L \circ c)^{\sqcup -1}, 0)$ and $c@d_{\delta} = c \tilde{\circ} (d_L \circ (c@d_{\delta}), 0)$. respectively. A specific example exercising these formulas is given in Example 4.10 after the Hopf algebra machinery is developed in the next section for computing the composition inverse.

4. Hopf Algebra of Coordinate Functions for $\mathbb{R}_{np}\langle \langle X_{\delta} \rangle \rangle$. In this section the Hopf algebra of coordinate functions for the group $\mathbb{R}_{np}\langle \langle X_{\delta} \rangle \rangle$ is described. This provides an explicit computational framework in which to compute group inverses, and thus, evaluate the output affine feedback product as described in the previous section. It is first necessary to restrict the set up to the subset of series having the form $c_{\delta} = (1 + c'_L, c_R)$, where c'_L is proper. From a control theory point of view, there is no loss of generality since the generating series of any Fliess operator $y = F_{c_{\delta}}[u]$ can assume this form by simply rescaling y. So abusing the notation, in this section $\mathbb{R}_{np}\langle \langle X_{\delta} \rangle \rangle$ will be used to denote exclusively this subset. The strategy is to first introduce a connected graded algebra and then a compatible coalgebra in terms of the composition products. The connectedness property ensures that this bialgebra is a Hopf algebra. The section culminates by providing a purely inductive formula for the antipode of this Hopf algebra, and some illustrative examples are given.

For any word $\eta \in X^*$ define the left and right coordinate functions as

$$(4.1) \qquad b_{\eta}: \mathbb{R}_{\mathrm{np}}\langle\langle X_{\delta}\rangle\rangle \to \mathbb{R}: c_{\delta} \mapsto (c_{L}, \eta), \ a_{\eta}: \mathbb{R}_{\mathrm{np}}\langle\langle X_{\delta}\rangle\rangle \to \mathbb{R}: c_{\delta} \mapsto (c_{R}, \eta),$$

respectively.⁵ Let V denote the \mathbb{R} -vector space spanned by these maps. Define the corresponding free commutative algebra, H, with product $\mu : h_{\eta} \otimes \tilde{h}_{\xi} \mapsto h_{\eta}\tilde{h}_{\xi}$, $h, \tilde{h} \in \{a, b\}$ and unit **1** which maps every $c_{\delta} \in \mathbb{R}_{np}\langle\langle X \rangle\rangle$ to 1. Consequently, definition (4.1) is extended multiplicatively, that is, for $h, \tilde{h} \in \{a, b\}$ the product $h_{\eta}\tilde{h}_{\xi}$ corresponds to the pointwise product of coordinate functions with respect to $c_{\delta} = (c_L, c_R) \in \mathbb{R}_{np}\langle\langle X_{\delta} \rangle\rangle$

(4.2)
$$h_{\eta}\tilde{h}_{\xi}(c_{\delta}) := h_{\eta}(c_{\delta})\tilde{h}_{\xi}(c_{\delta}).$$

The degree of a coordinate function is taken as $\deg(b_{\eta}) = 2 |\eta|_{x_0} + |\eta|_{x_1}$, $\deg(a_{\eta}) = 2 |\eta|_{x_0} + |\eta|_{x_1} + 1$, and $\deg(\mathbf{1}) = 0$. In which case, V is a connected graded vector space, that is, $V = \bigoplus_{n\geq 0} V_n$ with V_n denoting the span of all coordinate functions of degree n and $V_0 = \mathbb{R}\mathbf{1}$. Let $V_+ = \bigoplus_{n\geq 1} V_n$. Similarly, H has the connected graduation $H = \bigoplus_{n>0} H_n$ with $H_0 = \mathbb{R}\mathbf{1}$.

Three coproducts are now introduced. The first coproduct is used to define the Hopf algebra on H. The remaining two products provide an inductive method in which to compute it. Recalling that $(c_{\delta} \circ d_{\delta})_L = (c_L \tilde{\circ} d_{\delta}) \sqcup d_L$ and $(c_{\delta} \circ d_{\delta})_R = (c_L \tilde{\circ} d_{\delta}) \sqcup d_R + c_R \tilde{\circ} d_{\delta}$, define coproduct Δ for any $b_\eta, a_\eta \in V_+$ such that

- (4.3a) $\Delta b_{\eta}(c_{\delta}, d_{\delta}) = b_{\eta}(c_{\delta} \circ d_{\delta}) = ((c_{L} \ \tilde{\circ} d_{\delta}) \sqcup d_{L}, \eta)$
- (4.3b) $\Delta a_{\eta}(c_{\delta}, d_{\delta}) = a_{\eta}(c_{\delta} \circ d_{\delta}) = ((c_{L} \circ d_{\delta}) \sqcup d_{R}, \eta) + (c_{R} \circ d_{\delta}, \eta).$

⁵This terminology will be justified later.

The coassociativity of Δ follows directly from the associativity of the group product on $\mathbb{R}_{np}\langle \langle X \rangle \rangle$. The second coproduct is $\Delta_{\sqcup}^{\cdot}(V_+) \subset V_+ \otimes V_+$, which is defined for any $h, \tilde{h} \in V_+$ by

(4.4a)
$$\Delta^{\dot{h}}_{\iota\iota} h_{\emptyset} = h_{\emptyset} \otimes \tilde{h}_{\emptyset}$$

(4.4b)
$$\Delta_{\perp \perp}^{\tilde{h}} \circ \theta_k = (\theta_k \otimes \mathbf{1} + \mathbf{1} \otimes \theta_k) \circ \Delta_{\perp \perp}^{\tilde{h}},$$

where θ_k denotes the endomorphism on V_+ specified by $\theta_k h_\eta = h_{x_k\eta}$ for k = 0, 1. Clearly this coproduct can be computed recursively. Finally, consider for any $\eta \in X^*$ the coproduct $\tilde{\Delta}(V_+) \subset V_+ \otimes H$, where

(4.5)
$$\tilde{\Delta}b_{\eta}(c_{\delta}, d_{\delta}) = (c_L \,\tilde{\circ} \, d_{\delta}, \eta), \quad \tilde{\Delta}a_{\eta}(c_{\delta}, d_{\delta}) = (c_R \,\tilde{\circ} \, d_{\delta}, \eta).$$

In either case, using the notation of Sweedler [37],

$$\tilde{\Delta}h_{\eta}(c_{\delta}, d_{\delta}) = \sum h_{\eta(1)}(c_{\delta}) \ h_{\eta(2)}(d_{\delta}) = \sum h_{\eta(1)} \otimes h_{\eta(2)}(c_{\delta}, d_{\delta})$$

where $h_{\eta(1)} \in V_+$ and $h_{\eta(2)} \in H$. The sums are taken over all the terms that appear in the respective composition in (4.5), and the specific nature of the factors $h_{\eta(1)}$ and $h_{\eta(2)}$ is not important here. Like the coproduct $\Delta_{\sqcup \sqcup}^{\cdot}$, this coproduct can also be computed inductively as described next.

LEMMA 4.1. The following identities hold:

- (1) $\Delta h_{\emptyset} = h_{\emptyset} \otimes \mathbf{1}$
- (2) $\tilde{\Delta} \circ \theta_1 = (\theta_1 \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^b_{\mu}$
- (3) $\tilde{\Delta} \circ \theta_0 = (\theta_0 \otimes \mathrm{id}) \circ \tilde{\Delta} + (\theta_1 \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^a_{\sqcup}$,

where id denotes the identity map on H.

(1) Assume h = a and write $c_R = x_0 c_R^0 + x_1 c_R^1 + (c_R, \emptyset)$ with $c_R^0, c_R^1 \in \mathbb{R}\langle\langle X \rangle\rangle$. Then from Lemma 3.3 (1) and (4) it follows that

$$\begin{aligned} c_R \,\tilde{\circ} \, d_\delta &= (x_0 c_R^0) \,\tilde{\circ} \, d_\delta + (x_1 c_R^1) \,\tilde{\circ} \, d_\delta + (c_R, \emptyset) \,\tilde{\circ} \, d_\delta \\ &= x_0 (c_R^0 \,\tilde{\circ} \, d_\delta) + x_1 (d_L \sqcup (c_R^1 \,\tilde{\circ} \, d_\delta)) + x_0 (d_R \sqcup (c_R^1 \,\tilde{\circ} \, d_\delta)) + (c_R, \emptyset). \end{aligned}$$

In which case, $\tilde{\Delta}a_{\emptyset}(c_{\delta}, d_{\delta}) = (c_R \circ d_{\delta}, \emptyset) = (c_R, \emptyset) = (a_{\emptyset} \otimes \mathbf{1})(c_{\delta}, d_{\delta})$. A similar argument holds when h = b. (2) If h = a then

(2) If
$$n = a$$
 then

$$\begin{split} (\tilde{\Delta} \circ \theta_i) a_\eta(c_\delta, d_\delta) &= \tilde{\Delta} a_{x_i\eta}(c_\delta, d_\delta) = (c_R \circ d_\delta, x_i\eta) \\ &= (x_i^{-1} [x_0(c_R^0 \circ d_\delta) + x_1(d_L \sqcup (c_R^1 \circ d_\delta)) + x_0(d_R \sqcup (c_R^1 \circ d_\delta))], \eta) \\ &= (\mathbbm{1}_{i0} [c_R^0 \circ d_\delta + d_R \sqcup (c_R^1 \circ d_\delta)] + \mathbbm{1}_{i1} [d_L \sqcup (c_R^1 \circ d_\delta)], \eta), \end{split}$$

where $x_i^{-1}(\cdot)$ is the \mathbb{R} -linear left-shift operator specified by $x_i^{-1}(\eta) = \eta'$ when $\eta = x_i \eta'$ with $\eta' \in X^*$ and zero otherwise, and $\mathbb{1}_{xy}$ is the indicator function. So $\mathbb{1}_{xy} = 1$ when x = y and zero otherwise. Letting $c_{\delta}^1 = (c_L, c_R^1)$, it follows that

$$\begin{split} (\tilde{\Delta} \circ \theta_1) a_\eta(c_\delta, d_\delta) &= (d_L \sqcup (c_R^1 \,\tilde{\circ} \, d_\delta), \eta) = \sum_{\xi, \nu \in X^*} (c_R^1 \,\tilde{\circ} \, d_\delta, \xi) (d_L, \nu) (\xi \sqcup \nu, \eta) \\ &= \sum_{\xi, \nu \in X^*} \tilde{\Delta} a_\xi(c_\delta^1, d_\delta) b_\nu(d_\delta) (\xi \sqcup \nu, \eta) \end{split}$$

$$= \sum_{\xi,\nu\in X^*} \sum a_{\xi(1)} \otimes a_{\xi(2)}(c_{\delta}^1, d_{\delta}) b_{\nu}(d_{\delta})(\xi \sqcup \nu, \eta)$$

$$= \sum_{\xi,\nu\in X^*} \sum \theta_1(a_{\xi(1)}) \otimes a_{\xi(2)}(c_{\delta}, d_{\delta}) b_{\nu}(d_{\delta})(\xi \sqcup \nu, \eta)$$

$$= (\theta_1 \circ \mathrm{id}) \circ \sum_{\xi,\nu\in X^*} \tilde{\Delta} a_{\xi} \otimes b_{\nu}(c_{\delta}, d_{\delta}, d_{\delta})(\xi \sqcup \nu, \eta)$$

$$= (\theta_1 \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^b_{\sqcup} a_{\eta}(c_{\delta}, d_{\delta}).$$

The proof when h = b is perfectly analogous. (3) If h = a then $(\tilde{\Delta} \circ \theta_0) a_\eta (c_\delta, d_\delta) = (c_R^0 \tilde{\circ} d_\delta, \eta) + (d_R \sqcup (c_R^1 \tilde{\circ} d_\delta), \eta)$. From this point, the method of proof is exactly the same as that in part (2) modulo the fact that $\Delta^a_{\ \sqcup}$ is used here due to the presence of d_R instead of d_L in the shuffle product.

EXAMPLE 4.2. Applying the identities in Lemma 4.1 gives the first few Δ coproduct terms ordered by degree n_b (h = b), n_a (h = a):

$$\begin{split} n_{b}, n_{a} &= 0, 1: \tilde{\Delta}h_{\emptyset} = h_{\emptyset} \otimes \mathbf{1} \\ n_{b}, n_{a} &= 1, 2: \tilde{\Delta}h_{x_{1}} = h_{x_{1}} \otimes \mathbf{1} \\ n_{b}, n_{a} &= 2, 3: \tilde{\Delta}h_{x_{0}} = h_{x_{0}} \otimes \mathbf{1} + h_{x_{1}} \otimes a_{\emptyset} \\ n_{b}, n_{a} &= 2, 3: \tilde{\Delta}h_{x_{1}^{2}} = h_{x_{1}^{2}} \otimes \mathbf{1} + h_{x_{1}} \otimes b_{x_{1}} \\ n_{b}, n_{a} &= 3, 4: \tilde{\Delta}h_{x_{0}x_{1}} = h_{x_{0}x_{1}} \otimes \mathbf{1} + h_{x_{1}} \otimes a_{x_{1}} + h_{x_{1}^{2}} \otimes a_{\emptyset} \\ n_{b}, n_{a} &= 3, 4: \tilde{\Delta}h_{x_{1}x_{0}} = h_{x_{1}x_{0}} \otimes \mathbf{1} + h_{x_{1}} \otimes b_{x_{0}} + h_{x_{1}^{2}} \otimes a_{\emptyset} \\ n_{b}, n_{a} &= 3, 4: \tilde{\Delta}h_{x_{1}^{3}} = h_{x_{1}^{3}} \otimes \mathbf{1} + 3h_{x_{1}^{2}} \otimes b_{x_{1}} + h_{x_{1}} \otimes b_{x_{1}^{2}} \\ n_{b}, n_{a} &= 4, 5: \tilde{\Delta}h_{x_{0}^{2}} = h_{x_{0}^{2}} \otimes \mathbf{1} + h_{x_{1}} \otimes a_{x_{0}} + h_{x_{0}x_{1}} \otimes a_{\emptyset} + h_{x_{1}x_{0}} \otimes a_{\emptyset} + h_{x_{1}^{2}} \otimes (a_{\emptyset})^{2}. \end{split}$$

The next lemma provides a grading for the coproduct $\hat{\Delta}$, which is clearly evident in the example above. Its particular form, namely having V on the left, implies that H is a right-sided Hopf algebra [30, 32], a property that is essential in Section 6.

LEMMA 4.3. For any $h_{\eta} \in V_n$

(4.6)
$$\tilde{\Delta}h_{\eta} \in \bigoplus_{j+k=n} V_j \otimes H_k =: (V \otimes H)_n.$$

Proof. The following facts are essential:

- (1) $\deg(\theta_1 h) = \deg(h) + 1$
- (2) $\deg(\theta_0 h) = \deg(h) + 2$ (3) $\Delta_{\perp \perp}^{\tilde{h}} h \in (V \otimes V)_{\deg(h) + \mathbb{1}_{\tilde{h}a}}.$

The proof is via induction on the length of η . When $|\eta| = 0$ then clearly $\tilde{\Delta}h_{\emptyset} =$ $h_{\emptyset} \otimes \mathbf{1} \in V_n \otimes H_0$, where $n = \deg(h_{\emptyset}) \in \{0, 1\}$ (noting that $b_{\emptyset} \sim \mathbf{1}$). Assume now that (4.6) holds for words up to length $|\eta| \ge 0$. Let $n = \deg(h_{\eta})$. There are two ways to increase the length of η . First consider $h_{x_1\eta}$. From item (1) above deg $(h_{x_1\eta}) = n + 1$. Now apply item (3), the induction hypothesis, and Lemma 4.1 in that order:

$$\Delta^{b}_{\sqcup \sqcup} h_{\eta} \in (V \otimes V)_{n}$$
$$(\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{b}_{\sqcup \sqcup} h_{\eta} \in (V \otimes H \otimes V)_{n}$$
$$(\theta_{1} \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{b}_{\sqcup \sqcup} h_{\eta} \in \bigoplus_{j+k=1}^{n} \in V_{j+1} \otimes H_{k}$$

16

$$\tilde{\Delta}h_{x_1\eta} \in (V \otimes H)_{n+1},$$

which proves the assertion. Consider next $h_{x_0\eta}$. From item (2) above $\deg(h_{x_0\eta}) = n+2$. In this case, repeat the first two steps of the previous case and apply item (1) to get

$$(\theta_1 \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^a_{\sqcup} h_\eta \in \bigoplus_{j+k=1}^{n+1} \in V_{j+1} \otimes H_k \subset (V \otimes H)_{n+2}.$$

In addition, from the induction hypothesis and item (2) it follows that

$$(\theta_0 \otimes \mathrm{id}) \circ \tilde{\Delta} h_\eta \in \bigoplus_{j+k=1}^n V_{j+2} \otimes H_k \subset (V \otimes H)_{n+2}.$$

Thus, applying Lemma 4.1, $\tilde{\Delta}h_{x_0\eta} \in (V \otimes H)_{n+2}$, which again proves the assertion and completes the proof. \Box

The following lemma is of central importance as it shows how to compute the Hopf algebra coproduct Δ in terms of $\tilde{\Delta}$ and $\Delta_{\perp \perp}$.

LEMMA 4.4. The following identities holds:

- (1) $\Delta b_{\eta} = (\mathrm{id} \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{b}_{\perp \perp} b_{\eta}$
- (2) $\Delta a_{\eta} = (\mathrm{id} \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{\overline{a}}_{\sqcup \sqcup} b_{\eta} + \tilde{\Delta} a_{\eta}.$ Proof.

(1) Observe

$$\Delta b_{\eta}(c_{\delta}, d_{\delta}) = \sum_{\xi, \nu \in X^{*}} (c_{L} \circ d_{\delta}, \xi)(d_{L}, \nu)(\xi \sqcup \nu, \eta) = \sum_{\xi, \nu \in X^{*}} \tilde{\Delta} b_{\xi}(c_{\delta}, d_{\delta})b_{\nu}(d_{\delta})(\xi \sqcup \nu, \eta)$$
$$= (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{b}_{\sqcup} b_{\eta}(c_{\delta}, d_{\delta}, d_{\delta}) = (\mathrm{id} \otimes \mu) \circ (\tilde{\Delta} \otimes \mathrm{id}) \circ \Delta^{b}_{\sqcup} b_{\eta}(c_{\delta}, d_{\delta}).$$

(2) In a similar fashion

$$\Delta a_{\eta}(c_{\delta}, d_{\delta}) = (\tilde{\Delta} \otimes \operatorname{id}) \circ \Delta^{a}_{\sqcup \sqcup} b_{\eta}(c_{\delta}, d_{\delta}, d_{\delta}) + \tilde{\Delta} a_{\eta}(c_{\delta}, d_{\delta})$$
$$= [(\operatorname{id} \otimes \mu) \circ (\tilde{\Delta} \otimes \operatorname{id}) \circ \Delta^{a}_{\sqcup \sqcup} b_{\eta} + \tilde{\Delta} a_{\eta}](c_{\delta}, d_{\delta}).$$

EXAMPLE 4.5. Applying the identities in Lemma 4.4 gives the first few reduced coproduct terms, namely, $\Delta' h_{\eta} := \Delta h_{\eta} - h_{\eta} \otimes \mathbf{1} - \mathbf{1} \otimes h_{\eta}$:

$$\begin{split} n &= 1 : \Delta' b_{x_1} = 0 \\ n &= 2 : \Delta' b_{x_0} = b_{x_1} \otimes a_{\emptyset} \\ n &= 2 : \Delta' b_{x_1^2} = 3b_{x_1} \otimes b_{x_1} \\ n &= 3 : \Delta' b_{x_0x_1} = b_{x_0} \otimes b_{x_1} + b_{x_1} \otimes b_{x_0} + b_{x_1} \otimes a_{x_1} + b_{x_1} \otimes b_{x_1} a_{\emptyset} + b_{x_1^2} \otimes a_{\emptyset} \\ n &= 3 : \Delta' b_{x_1x_0} = b_{x_0} \otimes b_{x_1} + 2b_{x_1} \otimes b_{x_0} + b_{x_1} \otimes b_{x_1} a_{\emptyset} + b_{x_1^2} \otimes a_{\emptyset} \\ n &= 3 : \Delta' b_{x_1^3} = 6b_{x_1^2} \otimes b_{x_1} + 4b_{x_1} \otimes b_{x_1^2} + 3b_{x_1} \otimes (b_{x_1})^2 \\ n &= 4 : \Delta' b_{x_0^2}^2 = 2b_{x_0} \otimes b_{x_0} + b_{x_1} \otimes a_{x_0} + 2b_{x_1} \otimes b_{x_0} a_{\emptyset} + b_{x_0x_1} \otimes a_{\emptyset} + b_{x_1x_0} \otimes a_{\emptyset} + b_{x_0x_1} \otimes a_{\emptyset} + b_{x_1x_0} \otimes a_{\emptyset} + b_{x_0x_1} \otimes a_{\emptyset} + b_{x_0x_$$

 $n = 1 : \Delta' a_{\emptyset} = 0$

$$\begin{split} n &= 2: \Delta' a_{x_1} = b_{x_1} \otimes a_{\emptyset} \\ n &= 3: \Delta' a_{x_0} = b_{x_0} \otimes a_{\emptyset} + a_{x_1} \otimes a_{\emptyset} + b_{x_1} \otimes (a_{\emptyset})^2 \\ n &= 3: \Delta' a_{x_1^2} = a_{x_1} \otimes b_{x_1} + 2b_{x_1} \otimes a_{x_1} + b_{x_1} \otimes b_{x_1} a_{\emptyset} + b_{x_1^2} \otimes a_{\emptyset} \\ n &= 4: \Delta' a_{x_0 x_1} = b_{x_1} \otimes a_{x_0} + b_{x_0} \otimes a_{x_1} + a_{x_1} \otimes a_{x_1} + b_{x_0 x_1} \otimes a_{\emptyset} + a_{x_1^2} \otimes a_{\emptyset} + \\ & 2b_{x_1} \otimes a_{x_1} a_{\emptyset} + b_{x_1^2} \otimes (a_{\emptyset})^2 \\ n &= 4: \Delta' a_{x_1 x_0} = a_{x_1} \otimes b_{x_0} + b_{x_1} \otimes a_{x_0} + b_{x_0} \otimes a_{x_1} + b_{x_1} \otimes b_{x_0} a_{\emptyset} + b_{x_1 x_0} \otimes a_{\emptyset} + \\ & a_{x_1^2} \otimes a_{\emptyset} + b_{x_1} \otimes a_{x_1} a_{\emptyset} + b_{x_1^2}^2 \otimes (a_{\emptyset})^2 \\ n &= 4: \Delta' a_{x_1^3} = b_{x_1^3} \otimes a_{\emptyset} + 3b_{x_1^2} \otimes b_{x_1} a_{\emptyset} + b_{x_1} \otimes b_{x_1^2} a_{\emptyset} + 3b_{x_1^2} \otimes a_{x_1} + 3b_{x_1} \otimes b_{x_1} a_{x_1} + \\ & 3b_{x_1} \otimes a_{x_1^2}^2 + 3a_{x_1^2} \otimes b_{x_1} + a_{x_1} \otimes b_{x_1^2}^2 \\ n &= 5: \Delta' a_{x_0^2}^2 = 2b_{x_0} \otimes a_{x_0} + a_{x_1} \otimes a_{x_0} + b_{x_0^2} \otimes a_{\emptyset} + a_{x_0 x_1} \otimes a_{\emptyset} + a_{x_1 x_0} \otimes a_{\emptyset} + \\ & 3b_{x_1} \otimes a_{x_0} a_{\emptyset} + b_{x_0 x_1} \otimes (a_{\emptyset})^2 + b_{x_1 x_0} \otimes (a_{\emptyset})^2 + a_{x^2} \otimes (a_{\emptyset})^2 + b_{x^2} \otimes (a_{\emptyset})^3. \end{split}$$

The main result of this section is given next, namely that the commutative unital algebra (H, μ) together with the coproduct Δ is a connected graded bialgebra, and thus has an antipode S. Before stating the actual theorem, some additional motivation is given concerning the nature of the antipode. Observe that for any $c_{\delta} \in \mathbb{R}_{np}\langle \langle X_{\delta} \rangle \rangle$ one can naturally associate a Hopf algebra character $\Phi_c \in L(H, \mathbb{R})$ by letting Φ_c : $b_{\eta} \mapsto (c_L, \eta), \Phi_c: a_{\eta} \mapsto (c_R, \eta), \text{ and } \Phi_c(\mathbf{1}) = 1$. Note that (4.2) implies $\Phi_c(h_{\eta}\tilde{h}_{\xi}) = \Phi_c(h_{\eta})\Phi_c(\tilde{h}_{\xi})$ for any $h, \tilde{h} \in \{a, b\}$ and $\eta, \xi \in X^*$. Since the coproduct Δ of H has been constructed to satisfy (4.3), the following simple calculation shows that for all $c_{\delta}, d_{\delta} \in \mathbb{R}_{np}\langle \langle X_{\delta} \rangle \rangle$;

$$(\Phi_c \star \Phi_d)(h_\eta) := m_{\mathbb{R}}(\Phi_c \otimes \Phi_d) \Delta(h_\eta) = h_\eta (c_\delta \circ d_\delta) = (c_\delta \circ d_\delta, \eta).$$

(See [18, Lemma 2] for a similar calculation.) In light of (2.8), it then follows that

(4.7)
$$h_{\eta}(c_{\delta}^{-1}) = (Sh_{\eta})(c_{\delta}), \quad \forall \eta \in X^*, \quad h \in \{b, a\}.$$

Thus, the antipode provides an explicit way to compute the group inverse.

THEOREM 4.6. (H, μ, Δ) is a connected graded commutative unital Hopf algebra. Proof. From the development above, it is clear that (H, μ, Δ) is a connected

bialgebra with unit **1** and a counit ε defined by $\varepsilon(a_\eta) = 0$ for all $\eta \in X^*$, $\varepsilon(b_\eta) = 0$ for all nonempty $\eta \in X^*$, and $\varepsilon(\mathbf{1}) = 1$. Here it is shown that this bialgebra is also graded and thus is automatically a Hopf algebra, i.e., has a well defined antipode, S [10]. It only remains to be shown for any $n \ge 0$ that $\Delta H_n \subseteq (H \otimes H)_n$. It is well known if $h \in V_n$ then $\Delta_{\perp}^{\tilde{h}} h \in (V \otimes V)_n$. Therefore, it follows directly from Lemmas 4.3 and 4.4 that $\Delta h \in (V \otimes H)_n$. In which case, via the identity $\Delta(a_\eta^i a_\xi^j) = \Delta a_\eta^i \Delta a_\xi^j$, it must hold that $\Delta H_n \subseteq (H \otimes H)_n$, $n \ge 0$. \square

The next theorem says that the antipode of any connected graded Hopf algebra can be computed in a recursive manner once the coproduct is computed.

THEOREM 4.7. [10] The antipode, S, of any connected graded Hopf algebra (H, μ, Δ) can be computed for any $a \in H_k$, $k \ge 1$ by

$$Sa = -a - \sum (Sa'_{(1)})a'_{(2)} = -a - \sum a'_{(1)}Sa'_{(2)},$$

where the reduced coproduct is $\Delta' a = \Delta a - a \otimes \mathbf{1} - \mathbf{1} \otimes a = \sum a'_{(1)} a'_{(2)}$.

As noted earlier, the coproducts $\Delta_{\perp \perp}$ and Δ can be computed recursively, and Δ is computed directly in terms of $\Delta_{\perp \perp}$ and $\tilde{\Delta}$. So in fact the antipode of H can be computed in a *fully* recursive manner as described next.

THEOREM 4.8. The antipode, S, of any $h_{\eta} \in V_+$ can be computed by the following algorithm:

i. Recursively compute Δ^{h̃}_{LL} via (4.4).
ii. Recursively compute Δ̃ via Lemma 4.1.

iii. Compute Δ via Lemma 4.4.

iv. Recursively compute S via Theorem 4.7.

EXAMPLE 4.9. The first few antipode terms computed via Theorem 4.8 are:

$$n = 1 : Sb_{x_1} = -b_{x_1}$$

$$n = 2 : Sb_{x_0} = -b_{x_0} + b_{x_1}a_{\emptyset}$$

$$n = 2 : Sb_{x_1^2} = -b_{x_1^2} + 3(b_{x_1})^2$$

$$n = 3 : Sb_{x_0x_1} = -b_{x_0x_1} + b_{x_1^2}a_{\emptyset} - 3(b_{x_1})^2a_{\emptyset} + 2b_{x_0}b_{x_1} + b_{x_1}a_{x_1}$$

$$n = 3 : Sb_{x_1x_0} = -b_{x_1x_0} + b_{x_1^2}a_{\emptyset} + 3b_{x_0}b_{x_1} - 3(b_{x_1})^2a_{\emptyset}$$

$$n = 3 : Sb_{x_1^3} = -b_{x_1^3} + 10b_{x_1}b_{x_1^2} - 15(b_{x_1})^3$$

$$n = 4 : Sb_{x_0^2} = -b_{x_0^2} + b_{x_0x_1}a_{\emptyset} + b_{x_1x_0}a_{\emptyset} - b_{x_1^2}(a_{\emptyset})^2 + 3(b_{x_1})^2(a_{\emptyset})^2 + 2(b_{x_0})^2 - 5b_{x_0}b_{x_1}a_{\emptyset} - b_{x_1}a_{\emptyset}a_{x_1} + b_{x_1}a_{x_0}$$

$$\begin{split} n &= 1: Sa_{\emptyset} = -a_{\emptyset} \\ n &= 2: Sa_{x_{1}} = -a_{x_{1}} + b_{x_{1}}a_{\emptyset} \\ n &= 3: Sa_{x_{0}} = -a_{x_{0}} + b_{x_{0}}a_{\emptyset} - b_{x_{1}}(a_{\emptyset})^{2} + a_{\emptyset}a_{x_{1}} \\ n &= 3: Sa_{x_{1}^{2}} = -a_{x_{1}^{2}} + b_{x_{1}^{2}}a_{\emptyset} - 3(b_{x_{1}})^{2}a_{\emptyset} + 3b_{x_{1}}a_{x_{1}} \\ n &= 4: Sa_{x_{0}x_{1}} = -a_{x_{0}x_{1}} + b_{x_{0}x_{1}}a_{\emptyset} - 2b_{x_{0}}b_{x_{1}}a_{\emptyset} - 4b_{x_{1}}a_{\emptyset}a_{x_{1}} + 3(b_{x_{1}})^{2}(a_{\emptyset})^{2} - b_{x_{1}^{2}}(a_{\emptyset})^{2} + (a_{x_{1}})^{2} + a_{\emptyset}a_{x_{1}^{2}} + b_{x_{0}}a_{x_{1}} + b_{x_{1}}a_{x_{0}} \\ n &= 4: Sa_{x_{1}x_{0}} = -a_{x_{1}x_{0}} + b_{x_{1}x_{0}}a_{\emptyset} + a_{\emptyset}a_{x_{1}^{2}} - 3b_{x_{0}}b_{x_{1}}a_{\emptyset} - 3b_{x_{1}}a_{\emptyset}a_{x_{1}} - b_{x_{1}^{2}}(a_{\emptyset})^{2} + 3(b_{x_{1}})^{2}(a_{\emptyset})^{2} + 2b_{x_{0}}a_{x_{1}} + b_{x_{1}}a_{x_{0}} \\ n &= 4: Sa_{x_{1}^{3}} = -a_{x_{1}^{3}} + b_{x_{1}^{3}}a_{\emptyset} - 10b_{x_{1}}b_{x_{1}^{2}}a_{\emptyset} + 15(b_{x_{1}})^{3}a_{\emptyset} + 4b_{x_{1}^{2}}a_{x_{1}} - 15(b_{x_{1}})^{2}a_{x_{1}} + 6b_{x_{1}}a_{x_{1}^{2}} \\ n &= 5: Sa_{x_{0}^{2}} = -a_{x_{0}^{2}} + b_{x_{0}^{2}}a_{\emptyset} - 2(b_{x_{0}})^{2}a_{\emptyset} + a_{\emptyset}a_{x_{0}x_{1}} + a_{\emptyset}a_{x_{1}x_{0}} - 3b_{x_{1}}a_{x_{0}}a_{\emptyset} - 3b_{x_{0}}a_{x_{1}}a_{\emptyset} - a_{\emptyset}(a_{x_{1}})^{2} - b_{x_{0}x_{1}}(a_{\emptyset})^{2} - b_{x_{1}x_{0}}(a_{\emptyset})^{2} + 5b_{x_{0}}b_{x_{1}}(a_{\emptyset})^{2} - (a_{\emptyset})^{2}a_{x_{1}^{2}} + 4b_{x_{1}}(a_{\emptyset})^{2}a_{x_{1}} + b_{x_{1}^{2}}(a_{\emptyset})^{3} - 3(b_{x_{1}})^{2}(a_{\emptyset})^{3} + 2b_{x_{0}}a_{x_{0}} + a_{x_{0}}a_{x_{1}}. \end{split}$$

EXAMPLE 4.10. Reconsider the multiplicative feedback system described in Example 3.12. Suppose $c = \sum_{k\geq 0} k! x_1^k = \sum_{k\geq 0} x_1^{\sqcup k} = (1-x_1)^{\sqcup -1}$ and $F_{d_{\delta}} = I$ (unity feedback). In this case, (3.8) reduces to $(c@d_{\delta}) = c \tilde{\circ} (d_L \circ c@d_{\delta}, 0)$ so that

$$c@d_{\delta} = c \,\tilde{\circ} \, (c^{\,\sqcup\,-1}, 0)^{-1} = (c^{\,\sqcup\,-1}, 0)^{-1} = (1 - x_1, 0)^{-1}.$$

The composition inverse can be computed directly from (4.7) and the antipode formulas above. Namely, taking into account only the antipode terms containing powers of the coordinate function b_{x_1} (all others will yield zero), it follows that

$$c@d_{\delta} = (1 - x_{1}, 0)^{-1} = \left(\left[\mathbf{1} + \sum_{\eta \in X^{+}} \eta Sb_{\eta} \right] (1 - x_{1}), \sum_{\eta \in X^{*}} \eta Sa_{\eta}(0) \right)$$

= $([\mathbf{1} + x_{1}Sb_{x_{1}} + x_{1}^{2}Sb_{x_{1}^{2}} + x_{1}^{3}Sb_{x_{1}^{3}} + \cdots](1 - x_{1}), 0)$
= $(1 + x_{1}(-b_{x_{1}}(1 - x_{1})) + x_{1}^{2}([-b_{x_{1}^{2}} + 3(b_{x_{1}})^{2}](1 - x_{1}) + x_{1}^{3}([b_{x_{1}^{3}} + 10b_{x_{1}}b_{x_{1}^{2}} - 15(b_{x_{1}})^{3}](1 - x_{1})), 0)$
= $(1 + x_{1} + 3x_{1}^{2} + 15x_{1}^{3} + \cdots, 0).$

The deferred proof from Section 3 is presented next.

Proof of Lemma 3.3 (3). The assertion is that $c \circ d_{\delta} = k$ implies c = k. The proof is by induction on the grading of H. If $c \circ d_{\delta} = k$ then clearly $k = a_{\emptyset}(c_{\delta} \circ d_{\delta}) = \tilde{\Delta}a_{\emptyset}(c_{\delta}, d_{\delta}) = a_{\emptyset}(c_{\delta})$ assuming without loss of generality that $c_{\delta} = (1, c)$. Therefore, $(c, \emptyset) = k$. Similarly, it follows that $0 = a_{x_1}(c_{\delta} \circ d_{\delta}) = \tilde{\Delta}a_{x_1}(c_{\delta}, d_{\delta}) = a_{x_1}(c_{\delta})$. Thus, $(c, x_1) = 0$. Now suppose $a_{\eta}(c_{\delta}) = 0$ for all $a_{\eta} \in H_n$ up to some fixed $n \geq 2$. Then for any $x_j \in X$

$$0 = \tilde{\Delta}a_{x_j\eta}(c_{\delta}, d_{\delta}) = a_{x_j\eta}(c_{\delta}) + \sum_{a_{x_j\eta(2)}\neq 1} a_{x_j\eta(1)}(c_{\delta}) \ a_{x_j\eta(2)}(d_{\delta}),$$

where in general $a_{x_j\eta(1)} \neq a_{\emptyset}$. Therefore, $a_{x_j\eta}(c_{\delta}) = 0$, or equivalently, $(c, x_j\eta) = 0$. In which, case c = k. \square

The section is concluded by some dimensional analysis of the grading of V and H. This information could be useful in determining the complexity of the antipode recursion as a function of the degree of the coordinate functions, but that topic is beyond the scope of this paper. Let $V_{h,k}$ denote the subspace of V_k spanned by the coordinate functions h_η of degree k where $h \in \{a, b\}$. Define $p_{h,k} = \dim(V_{h,k})$, $p_k = \dim(V_k)$ and the corresponding generating functions $F_{V_h} = \sum_{k\geq 1} p_{h,k} X^k$, $F_V = \sum_{k\geq 1} p_k X^k$. Analogous definitions apply when V is replaced by H.

THEOREM 4.11. The following identities hold:

$$\begin{split} F_{V_a} &= \frac{X}{1 - X - X^2} = X + X^2 + 2X^3 + 3X^4 + 5X^5 + 8X^6 + 13X^7 + 21X^8 + \cdots \\ F_{V_b} &= \frac{X + X^2}{1 - X - X^2} = X + 2X^2 + 3X^3 + 5X^4 + 8X^5 + 13X^6 + 21X^7 + 34X^8 + \cdots \\ F_V &= F_{V_a} + F_{V_b} = \frac{2X + X^2}{1 - X - X^2} = 2X + 3X^2 + 5X^3 + 8X^4 + 13X^5 + 21X^6 + \cdots \\ F_{H_a} &= \prod_{k=1}^{\infty} \frac{1}{(1 - X^k)^{p_{a,k}}} = 1 + X + 2X^2 + 4X^3 + 8X^4 + 15X^5 + 30X^6 + 56X^7 + \cdots \\ F_{H_b} &= \prod_{k=1}^{\infty} \frac{1}{(1 - X^k)^{p_{b,k}}} = 1 + X + 3X^2 + 6X^3 + 14X^4 + 28X^5 + 61X^6 + 122X^7 + \cdots \\ F_H &= \prod_{k=1}^{\infty} \frac{1}{(1 - X^k)^{p_{k,k}}} = F_{H_a}F_{H_b} = 1 + 2X + 6X^2 + 15X^3 + 38X^4 + 89X^5 + \cdots . \end{split}$$

Proof. The identity for F_{V_a} is proved in [13, Proposition 8], the proof for F_{V_b} is perfectly analogous. The identity for F_V follows directly from the fact that V =

 $V_a \oplus V_b$. It is worth noting that the coefficients of all three series come from the Fibonacci sequence. The identity for F_{H_a} was also proved in [13], and again the proof for F_{H_b} is very similar. The factorization of F_H is a consequence of the fact that $p_k = p_{a,k} + p_{b,k}$. In this case, the coefficients of F_{H_a} and F_{H_b} are integer sequences A166861 and A200544, respectively, in [36], while the sequence for F_H appears to be new. \square

5. System Inversion and Feedback Invariants. In this section two system theoretic problems connected with the output affine feedback transformation group are addressed. First it is shown how to pose the dynamic inversion in terms of this transformation group and its inverse. This naturally leads to the topic of feedback input-output linearization via nonlinear feedback. This then takes the presentation to the second problem of feedback invariants under the output affine feedback transformation group.

5.1. System Inversion. A problem often encountered in control applications is the following system inverse problem. An input u is mapped to an output y by an operator F defined in terms of a dynamical system

(5.1a) $\dot{z} = g_0(z) + g_1(z)u, \ z(t_0) = z_0$

(5.1b)
$$y = h_L(z)u + h_R(z),$$

where all the functions of the state z are assumed to be analytic on some neighborhood \mathcal{W} of z_0 . If $h_L(z_0) \neq 0$ then F is locally invertible. The left inverse, $F^{-1}: y \mapsto u$, can be determined dynamically by first solving the output equation for $u, u = h_L^{-1}(z)[y - h_R(z)]$, and then substituting the result into the state equation so that the system

$$\dot{z} = \left[g_0(z) - g_1(z)h_L^{-1}(z)h_R(z)\right] + g_1(z)h_L^{-1}(z)y, \quad z(t_0) = z_0$$
$$u = h_L^{-1}(z)y - h_L^{-1}(z)h_R(z)$$

has the property that if y is a given function in the range of F then y = F[u] maps to u over an interval $[t_0, t_0 + T]$ with T > 0. In short, input-output inversion is done by mapping the given system $(g_0, g_1, h_L, h_R, z_0)$ to its inverse system

(5.2)
$$(\bar{g}_0, \bar{g}_1, \bar{h}_L, \bar{h}_R, z_0) := (g_0 - g_1 h_L^{-1} h_R, g_1 h_L^{-1}, h_L^{-1}, -h_L^{-1} h_R, z_0).$$

It is not difficult to see that the mapping $F: u \mapsto y$ can be described independent of the state z and its dynamics by an element $c_{\delta} = (c_L, c_R)$ of the output affine feedback transformation group so that $y = F[u] = F_{c_L}[u]u + F_{c_R}[u] =: F_{c_{\delta}}[u]$, where $c_L, c_R \in \mathbb{R}_{LC}\langle\langle X \rangle\rangle$ are each computed from (2.4) using the respective outputs h_L and h_R . The condition that $h_L(z_0) \neq 0$ ensures that c_L is nonproper. In which case, the inverse input-output map is given by $F_{c_{\delta}^{-1}}$, where the generating series c_{δ}^{-1} can be computed using the antipode of the underlying Hopf algebra described in Section 4. In fact, the following example demonstrates that this relation goes in both directions when $c_{\delta} = (c_L, c_R)$ has a realization of the form (5.1).

EXAMPLE 5.1. Reconsider Example 4.10 where it was necessary to compute $(1 - x_1, 0)^{-1}$. It is straightforward to show that $y_L = F_{c_L}[u] = F_{1-x_1}[u]$, $y_R = 0$ is realized by $(g_0, g_1, h_L, h_R, z_0) = (0, -1, z, 0, 1)$ so that by (5.2) it follows that $(\bar{g}_0, \bar{g}_1, \bar{h}_L, \bar{h}_R, z_0) = (0, -1/z, 1/z, 0, 1)$. In which case, $c_R^{\circ -1} = 0$ and

$$c_L^{\circ -1} = 1 + x_1 L_{\bar{g}_1} \bar{h}_L(z_0) + x_1^2 L_{\bar{g}_1}^2 \bar{h}_L(z_0) + x_1^3 L_{\bar{g}_1}^3 \bar{h}_L(z_0) + \cdots$$

$$= 1 + x_1 + 3x_1^2 + 15x_1^3 + \cdots,$$

as computed earlier.

Given the connection between dynamic inversion and feedback linearization [25, 33], it is natural to consider the latter in terms of the output affine feedback transformation group. Consider a Fliess operator $y = F_c[u]$ which has an *n* dimensional analytic state space realization of the form

(5.3)
$$\dot{z} = g_0(z) + g_1(z)u, \ z(0) = z_0, \ y = h(z),$$

with relative degree r. In which case, it follows that $y^{(r)} = L_{g_0}^r h(z) + L_{g_1} L_{g_0}^{r-1} h(z) u$ with $L_{g_1} L_{g_0}^{r-1} h(z)$ being nonzero on some neighborhood of z_0 [25, 33]. Since the state can be viewed in terms of a Fliess operator for some generating series $c_z \in$ $\mathbb{R}_{LC}^n \langle \langle X \rangle \rangle$, it follows from Fliess's fundamental formula that there are generating series $e_L, e_R \in \mathbb{R}_{LC} \langle \langle X \rangle \rangle$ such that $F_{e_R}[u] = L_{g_0}^r h(F_{c_z}[u])$ and $F_{e_L}[u] = L_{g_1} L_{g_0}^{r-1} h(F_{c_z}[u])$, respectively, so that $y^{(r)} = F_{e_L}[u]u + F_{e_R}[u]$. Since $(e_L, \emptyset) = L_{g_1} L_{g_0}^{r-1} h(F_{c_z}[u])(0) \neq 0$, it follows that $e_{\delta} = (e_L, e_R) \in \mathbb{R}_{np} \langle \langle X_{\delta} \rangle \cap \mathbb{R}_{LC} \langle \langle X_{\delta} \rangle \rangle$, and therefore, if $v := y^{(r)}$ then the feedback linearization law can be written in the form $u = F_{e_{\delta}^{-1}}[v]$. When this feedback is applied to the plant, F_c , the feedback linearized system is described by

$$y = F_c[u] = F_c[F_{e_{\lambda}^{-1}}[v]] = F_{c \,\tilde{\circ} \, e_{\lambda}^{-1}}[v] = v^{(-r)}$$

So it is evident that the output affine feedback transformation group is at play in this problem. The proposition, however, is that this analysis holds even when F_c does not have a state space realization.

The starting point for a realization free framework for feedback input-output linearization is the following definition which describes relative degree from a generating series point of view. It uses the notion of a *linear word*, that is, any word in the language $\mathscr{L} = \{\eta \in X^* : \eta = x_0^{n_1} x_1 x_0^{n_0}, n_1, n_0 \ge 0\}$. Furthermore, note that every $c \in \mathbb{R}\langle\langle X \rangle\rangle$ can be decomposed into its natural and forced components, that is, $c = c_N + c_F$, where $c_N := \sum_{k \ge 0} (c, x_0^k) x_0^k$ and $c_F := c - c_N$. Finally, for any letter $x_i \in X$, the left-shift operator $x_i^{-1}(\cdot)$ introduced earlier is defined inductively for higher order shifts via $(x_i \xi)^{-1}(\cdot) = \xi^{-1} x_i^{-1}(\cdot)$, where $\xi \in X^*$. DEFINITION 5.2. [19] Given $c \in \mathbb{R}\langle\langle X \rangle\rangle$, let $r \ge 1$ be the largest integer such

DEFINITION 5.2. [19] Given $c \in \mathbb{R}\langle\langle X \rangle\rangle$, let $r \geq 1$ be the largest integer such that $\operatorname{supp}(c_F) \subseteq x_0^{r-1}X^*$. Then c has **relative degree** r if the linear word $x_0^{r-1}x_1 \in \operatorname{supp}(c)$, otherwise it is not well defined.

Observe that c having relative degree r is equivalent to saying that

(5.4)
$$c = c_N + c_F = c_N + K x_0^{r-1} x_1 + x_0^{r-1} e$$

for some $K \neq 0$ and some proper $e \in \mathbb{R}\langle\langle X \rangle\rangle$ with $x_1 \notin \operatorname{supp}(e)$. Furthermore, this notion coincides with the classical definition when $y = F_c[u]$ has an analytic state space realization of the form given in (5.3). Specifically, in light of the identity $\dot{y} = F_{x_0^{-1}(c)}[u] + uF_{x_1^{-1}(c)}[u]$ and (5.4), it follows that if c has relative degree r then on some interval [0, T) with T > 0 and for any sufficiently small $u \in L_1[0, T]$:

(5.5a)
$$y^{(k)} = F_{(x_0^k)^{-1}(c)}[u], \ k = 0, 1, \dots, r-1$$

(5.5b)
$$y^{(r)} = F_{(x_0^r)^{-1}(c)}[u] + uF_{(x_0^{r-1}x_1)^{-1}(c)}[u].$$

This would imply that $L_{g_1}L_{g_0}^k h(z(t)) = F_{(x_0^k x_1)^{-1}(c)}[u] = 0$ on [0,T) for $k = 0, 1, \ldots, r-2$. In addition, $L_{g_1}L_{g_0}^{r-1}(z_0) = F_{(x_0^{r-1} x_1)^{-1}(c)}[u](0) = (c, x_0^{r-1} x_1) = K \neq 0$. Hence, the

realization has relative degree r at z_0 in the classical sense. Furthermore, if the word $x_0^{r-1}x_1 \notin \operatorname{supp}(c)$ then $F_{(x_0^{r-1}x_1)^{-1}(c)}[u](0) = 0$, but $F_{(x_0^{r-1}x_1)^{-1}(c)}[u]$ is not identically zero on some interval $[0, T_1)$ with $T_1 > 0$ unless $(x_0^{r-1}x_1)^{-1}(c) = x_1^{-1}(e) = 0$ (since generating series are unique). But this can only happen if $\operatorname{supp}(e) \subseteq x_0 X^*$, which contradicts the assumption that r is the largest integer such that $\operatorname{supp}(c_F) \subseteq x_0^{r-1}X^*$. Therefore, the realization can not have a well defined relative degree in this case. Conversely, if the realization (5.3) has relative degree r at z_0 then for $k = 0, 1, \ldots, r-2$ it follows that $L_{g_1}L_{g_0}^kh(z(t)) = F_{(x_0^kx_1)^{-1}(c)}[u] = 0$ on a neighborhood of z_0 . So necessarily $(x_0^kx_1)^{-1}(c) = 0$ for $k = 0, 1, \ldots, r-2$, or equivalently, no word in the support of c_F can have a prefix of the form $x_0^kx_1$ with k < r-1. Therefore, $\operatorname{supp}(c_F) \subseteq x_0^{r-1}x_1 \neq 0$, then $x_0^{r-1}x_1 \in \operatorname{supp}(c_F)$, and x_0^{r-1} is the longest such prefix that all the words in $\operatorname{supp}(c_F)$ can share. So c must have the form of (5.4), implying that c has relative degree r.

EXAMPLE 5.3. Consider the state space realization (5.3), where

$$g_0(z) = \begin{bmatrix} z_2^2 + z_2 z_3 + z_3 \\ z_1^5 + z_3 \\ z_1^2 \end{bmatrix}, \quad g_1(z) = \begin{bmatrix} 0 \\ 0 \\ 1 \end{bmatrix}, \quad h(z) = z_1$$

Observe that $L_{g_1}h(z) = 0$ and $L_{g_1}L_{g_0}h(z) = z_2 + 1$, so that the realization has relative degree 2 at $z_0 = [z_{01} \ z_{02} \ z_{03}]^T$ if $z_{02} \neq -1$ and is undefined otherwise. So, for example, the generating series for $y = F_c[u]$ when $z = [0 \ 1 \ 1]^T$ is

$$c = 3x_0 + 3x_0^2 + 2x_0x_1 + 2x_0^3 + 4x_0^2x_1 + x_0x_1x_0 + 36x_0^4 + 4x_0^3x_1 + 2x_0^2x_1x_0 + \cdots,$$

which has relative degree 2 since $\operatorname{supp}(c_F) \subset x_0 X^*$, $\operatorname{supp}(c_F) \not\subseteq x_0^{r-1} X^*$ for r > 2, and $x_0 x_1 \in \operatorname{supp}(c)$. But when $z = [0 - 1 \ 1]^T$, the generating series becomes

$$c = x_0 - x_0^2 + 2x_0^3 + x_0x_1x_0 + 4x_0^3x_1 + 2x_0^2x_1x_0 + 2x_0^2x_1^2 + x_0x_1x_0x_1 + 6x_0^5 + 4x_0^3x_1^2 + \cdots,$$

which fails to have a well defined relative degree since $\operatorname{supp}(c_F) \subset x_0 X^*$ and $\operatorname{supp}(c_F) \not\subseteq x_0^{r-1} X^*$ for r > 2, but $x_0 x_1 \notin \operatorname{supp}(c)$.

The following theorem describes feedback input-output linearization without any requirement that the plant has a state space realization.

THEOREM 5.4. Suppose $c \in \mathbb{R}_{LC}\langle\langle X \rangle\rangle$ has relative degree r. Then $y = F_c[u]$ is feedback input-output linearized by $u = F_{e_{\delta}^{-1}}[v]$, where $e_{\delta} = ((x_0^{r-1}x_1)^{-1}(c), (x_0^r)^{-1}(c))$ and provided that $e_{\delta}^{-1} \in \mathbb{R}_{LC}\langle\langle X_{\delta} \rangle\rangle$, giving the closed-loop system $y = v^{(-r)}$. Proof. It follows from (5.5b) that $y^{(r)} = F_{e_{\delta}}[u]$. Therefore, setting $u = F_{e_{\delta}^{-1}}[v]$

Proof. It follows from (5.5b) that $y^{(r)} = F_{e_{\delta}}[u]$. Therefore, setting $u = F_{e_{\delta}^{-1}}[v]$ gives $y^{(r)} = F_{e_{\delta}} \circ F_{e_{\delta}^{-1}}[v] = F_{e_{\delta} \circ e_{\delta}^{-1}}[v] = F_{(1,0)}[v] = v$, which yields the desired result.

EXAMPLE 5.5. Consider the polynomial $c = x_1 + x_1^2$, which has relative degree 1. Setting $e_{\delta} = (x_1^{-1}(c), x_0^{-1}(c)) = (1 + x_1, 0)$, the inverse of e_{δ} can be computed by the same computational approach as in Example 4.10:

$$(1+x_1,0)^{-1} = ([1+x_1Sb_{x_1}+x_1^2Sb_{x_1^2}+x_1^3Sb_{x_1^3}+\cdots](1+x_1),0)$$

= $(1-x_1+3x_1^2-15x_1^3+\cdots,0).$

Therefore, a direct calculation gives $c \tilde{\circ} (1+x_1, 0)^{-1} = x_1$ as desired. This can also be verified by observing that $c = x_1 \tilde{\circ} (1+x_1, 0) = \phi_d(x_1)(1) + \phi_d(x_1^2)(1) = x_1 + x_1^2$. In addition, $c \tilde{\circ} e_{\delta}^{-1}$ clearly has the same relative degree as c, which in the next section is shown to hold in general.

5.2. Feedback Invariants. It is shown next that relative degree as defined in Definition 5.2 is invariant under the action of the output affine feedback transformation group. In addition, this action is free when restricted to all series having well defined relative degree.

THEOREM 5.6. A series c has relative degree r if and only if it is on the orbit of $c_N + x_0^{r-1} x_1 \text{ under } \mathbb{R}_{np} \langle \langle X_\delta \rangle \rangle.$

Proof. If c has well defined relative degree r then it can be decomposed as in (5.4), where without loss of generality $e = x_0 e_0 + x_1 e_1$ with e_1 proper. Then, setting $e_{\delta} := (K + e_1, e_0) \in \mathbb{R}_{np} \langle \langle X_{\delta} \rangle \rangle$ (since $K + e_1$ is nonproper), it follows from (3.2) that

$$c = c_N + x_0^{r-1} x_1 (K + e_1) + x_0^r e_0 = c_N + \phi_e (x_0^{r-1} x_1) (1) = (c_N + x_0^{r-1} x_1) \,\tilde{\circ} \, e_\delta.$$

In which case, $c \circ e_{\delta}^{-1} = c_N + x_0^{r-1}x_1$, or equivalently, c is on the orbit of $c_N + x_0^{r-1}x_1$ under $\mathbb{R}_{np}\langle\langle X_\delta \rangle\rangle$. The converse holds since all the steps above are reversible. \Box When the series e_{δ} and e_{δ}^{-1} above are both locally convergent then it follows directly that if $u = F_{e_{\delta}^{-1}}[v]$ then $y = F_c[u] = F_c \circ F_{e_{\delta}^{-1}}[v] = F_{c \circ e_{\delta}^{-1}}[v] = F_{c_N + x_0^{r-1}x_1}[v]$, as expected.

THEOREM 5.7. The transformation group $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ acts freely on the subset of $\mathbb{R}\langle\langle X \rangle\rangle$ having well defined relative degree.

Proof. Assume c has relative degree r. Without loss of generality let $c_N = 0$. Then there exists an $e_{\delta} \in \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ such that $c \circ e_{\delta}^{-1} = x_0^{r-1} x_1$. So if $c \circ d_{\delta} = c$ for some $d_{\delta} \in \mathbb{R}_{np}\langle\langle X_{\delta} \rangle\rangle$, then it follows immediately that $(c \circ d_{\delta}) \circ e_{\delta}^{-1} = c \circ e_{\delta}^{-1}$ and $(c \circ e_{\delta}^{-1}) \circ d_{\delta}^{e} = c \circ e_{\delta}^{-1}$, where d_{δ}^{e} corresponds to the conjugate action $e_{\delta} \circ d_{\delta} \circ e_{\delta}^{-1}$. In which case, $x_{0}^{r-1}x_{1} \circ d_{\delta}^{e} = x_{0}^{r-1}x_{1}$, or equivalently, $x_{0}^{r-1}x_{1}d_{L}^{e} + x_{0}^{r}d_{R}^{e} = x_{0}^{r-1}x_{1}$, and therefore, $d^{e}_{\delta} := (d^{e}_{L}, d^{e}_{R}) = (1, 0)$, the identity element of $\mathbb{R}_{np} \langle \langle X_{\delta} \rangle \rangle$. Thus, $e_{\delta} \circ d_{\delta} \circ e_{\delta}^{-1} = (1,0)$, which gives the desired conclusion that $d_{\delta} = (1,0)$.

6. The Lie Algebra Lie $(\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle)$. The main goal in this section is to describe the Lie algebra $\operatorname{Lie}(\mathbb{R}_{np}\langle \langle X_{\delta} \rangle)$ of infinitesimal characters associated with the group $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ (see Proposition 2.6) in terms of a pre-Lie product. The latter is considered the most elementary combinatorial building block since the group can be fully reconstructed solely in terms of its pre-Lie product [14,34]. The reader is referred to [6,31] for details on pre-Lie algebras. There are at least two ways to approach this problem. One way is to view $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ as an affine group scheme, which in turn always corresponds to a Hopf algebra [41, p. 9], in this case the Hopf algebra H as described in Theorem 4.6. In this setting, an \mathbb{R} -derivation D is any linear mapping taking H into an H-module M satisfying $D(h_1h_2) = D(h_1)h_2 + h_1D(h_2)$ for all $h_1, h_2 \in H$ with D(k) = 0 when $k \in \mathbb{R}$. It is described in terms of the universal derivation on H $\mathbf{d} = (\mathrm{id} \otimes \pi) \circ \Delta$, where $\pi : H \to H_+$ with $H_+ = \bigoplus_{n>0} H_n$ being the augmentation ideal $\operatorname{Ker}(\varepsilon)$ (recall the augmentation map $\varepsilon : H \to \mathbb{R}$ of a Hopf algebra). A linear operator $T: H \to H$ is said to be *left-invariant* when $\Delta \circ T = (\mathrm{id} \otimes T) \circ \Delta$. In which case, the Lie algebra of the group represented by H is the \mathbb{R} -vector space of all left-invariant derivations on H. This is the approach taken in [13] for the case of output feedback. The Lie algebra $\operatorname{Lie}(\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle)$ is then determined by dualizing this approach using the fact that $a_{\eta}(\nu) = \mathbb{1}_{\eta\nu}$ for all $a_{\eta} \in H$ and $\nu \in X^*$.

A second approach is to treat $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ as though it were a Lie group and to show that the Lie algebra associated with the set of all left-invariant vector fields at the identity element can be described in terms of a pre-Lie product. Of course, this in no way implies that $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ is a Lie group, but it provides a complementary point of view to the purely algebraic first approach. It is convenient in this context to write $c_{\delta} = (c_L, c_R) \in \mathbb{R}_{np} \langle \langle X_{\delta} \rangle \rangle$ as $c_{\delta} = \delta c_L + c_R$, so that the symbol δ is treated more like a letter in X. The first task is to describe a left-invariant vector field on $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$. The left translation of d_{δ} by c_{δ} is $c_{\delta} \circ d_{\delta} = \delta[(c_L \circ d_{\delta}) \sqcup d_L] + [(c_L \circ d_{\delta}) \sqcup d_R + c_R \circ d_{\delta}]$, which is denoted by $(c_{\delta} \circ) : \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle \to \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle : d_{\delta} \mapsto c_{\delta} \circ d_{\delta}$. Since composition is left linear, there is no loss of generality in setting $c_{\delta} = \xi_{\delta} := \delta\xi_L + \xi_R$, where $\xi_L, \xi_R \in X^*$. The differential of $(\xi_{\delta} \circ) : \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle \to \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ at the identity element δ is the linear map $(\xi_{\delta} \circ)_* : T_{\delta}\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle \to T_{\xi_{\delta}}\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$. Consider for some $\epsilon > 0$ a differentiable path $\gamma : (-\epsilon, \epsilon) \to \mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle : t \mapsto d_{\delta}(t)$ such that $d_{\delta}(0) = \delta$. Define the velocity vector at t = 0 as the series in $\mathbb{R}\langle\langle X_{\delta}\rangle\rangle$ of the form $v_{\delta} = \dot{d}_{\delta}(0) = \delta \dot{d}_L(0) + \dot{d}_R(0) = \delta v_L + v_R$, where $v_L \in \mathbb{R}\langle\langle X\rangle\rangle$ is proper. Then specifically the differential of $\xi_{\delta} \circ$ at δ in the direction of v_{δ} is

$$\begin{aligned} (\xi_{\delta}\circ)_*(v_{\delta}) &= \left. \frac{d}{dt} \xi_{\delta} \circ d_{\delta}(t) \right|_{t=0} \\ &= \left. \frac{d}{dt} \delta[(\xi_L \circ d_{\delta}(t)) \sqcup d_L(t)] + (\xi_L \circ d_{\delta}(t)) \sqcup d_R(t) + \xi_R \circ d_{\delta}(t) \right|_{t=0} \\ &= \delta \left[\left. \frac{d}{dt} \xi_L \circ d_{\delta}(t) \right|_{t=0} + \xi_L \sqcup v_L \right] + \xi_L \sqcup v_R + \left. \frac{d}{dt} \xi_R \circ d_{\delta}(t) \right|_{t=0}. \end{aligned}$$

The time derivative of the product $\xi \circ d_{\delta}$ is computed inductively. It is clearly zero when $\xi = \emptyset$. Otherwise, using Lemma 3.3 (4),

$$\frac{d}{dt}(x_0\xi) \tilde{\circ} d_{\delta}(t)\Big|_{t=0} = x_0 \frac{d}{dt}\xi \tilde{\circ} d_{\delta}(t)\Big|_{t=0}$$

$$\frac{d}{dt}(x_1\xi) \tilde{\circ} d_{\delta}(t)\Big|_{t=0} = x_1 \frac{d}{dt}(d_L(t) \sqcup (\xi \tilde{\circ} d_{\delta}(t))) + x_0(d_R(t) \sqcup (\xi \tilde{\circ} d_{\delta}(t)))\Big|_{t=0}$$

$$= x_1 \left(v_L \sqcup \xi + \frac{d}{dt}\xi \tilde{\circ} d_{\delta}(t)\Big|_{t=0}\right) + x_0(v_R \sqcup \xi).$$

Therefore, $\frac{d}{dt}\xi \circ d_{\delta}(t)\big|_{t=0} = \xi \bullet v_{\delta}$, where $\emptyset \bullet v_{\delta} = 0$ and

(6.1)
$$(x_0\xi) \bullet v_{\delta} = x_0(\xi \bullet v_{\delta}), \quad (x_1\xi) \bullet v_{\delta} = x_1(v_L \sqcup \xi + \xi \bullet v_{\delta}) + x_0(v_R \sqcup \xi).$$

So the differential in question is

$$(\xi_{\delta}\circ)_*(v_{\delta}) = \delta[\xi_L \bullet v_{\delta} + \xi_L \sqcup v_L] + \xi_L \sqcup v_R + \xi_R \bullet v_{\delta} = (\delta\xi_L) \bullet v_{\delta} + \xi_R \bullet v_{\delta} = \xi_{\delta} \bullet v_{\delta},$$

where the definition in (6.1) is extended to treat the *letter* δ as $(\delta\xi) \bullet v_{\delta} = \delta(v_L \sqcup \xi + \xi \bullet v_{\delta}) + (v_R \sqcup \xi)$. In which case, the left-invariant vector field satisfying $\chi_{\delta}^{v_{\delta}} = v_{\delta}$ is

(6.2)
$$\chi^{v_{\delta}} : \mathbb{R}_{\mathrm{np}} \langle \langle X_{\delta} \rangle \rangle \to \mathrm{T} \mathbb{R}_{\mathrm{np}} \langle \langle X_{\delta} \rangle \rangle : c_{\delta} \mapsto c_{\delta} \bullet v_{\delta}.$$

Now H is free as a commutative algebra, that is, H = S(V), where S(V) is the symmetric algebra over the vector space V. Also the mixed composition product is left linear, and in light of (4.6) the corresponding coproduct satisfies $\tilde{\Delta}V \subseteq V \otimes H$. Hence, H is a free commutative, right-sided Hopf algebra. In which case, the graded dual of V, namely the vector space V^* formed from the \mathbb{R} span over words in X^* (the duals of the a_η 's) and nonempty words with prefix δ , denoted by δX^+ , (the duals of b_η 's, recall $b_{\emptyset} \sim 1$) must have a right pre-Lie product [6, 30–32].

LEMMA 6.1. The vector space V^* with product • is a right pre-Lie algebra, i.e.,

(6.3)
$$(v_{\delta}^{1} \bullet v_{\delta}^{2}) \bullet v_{\delta}^{3} - v_{\delta}^{1} \bullet (v_{\delta}^{2} \bullet v_{\delta}^{3}) = (v_{\delta}^{1} \bullet v_{\delta}^{3}) \bullet v_{\delta}^{2} - v_{\delta}^{1} \bullet (v_{\delta}^{3} \bullet v_{\delta}^{2}).$$

Proof. The identity can be verified directly using the distributive property $(\eta \sqcup \xi) \bullet v_{\delta} = (\eta \bullet v_{\delta}) \sqcup \xi + \eta \sqcup (\xi \bullet v_{\delta})$, which can be proved by induction on the sum of the lengths of $\eta, \xi \in X^*$. \square

EXAMPLE 6.2. Consider (6.3) where $v_{\delta}^1 = \delta x_1$, $v_{\delta}^2 = x_1$ and $v_{\delta}^3 = \delta x_0$. Then $\delta x_1 \bullet x_1 = \delta x_0 x_1 + 2x_1^2$, $x_1 \bullet \delta x_0 = x_1 x_0$, $\delta x_1 \bullet \delta x_0 = \delta(2x_1 x_0 + x_0 x_1)$, $\delta x_0 \bullet x_1 = x_0 x_1 + x_1 x_0$, and both sides of (6.3) equal $\delta(2x_0^2 x_1 + x_0 x_1 x_0) + 2x_1^2 x_0 + x_1 x_0 x_1$.

Finally, a pre-Lie product is Lie admissible, that is, it always defines a proper Lie bracket $[\cdot, \cdot]_{\bullet}$ under antisymmetrization. In the present case, this is equivalent to the Lie algebra induced by (6.2) since

$$[v_{\delta}^{1}, v_{\delta}^{2}] = \left[\chi^{v_{\delta}^{1}}, \chi^{v_{\delta}^{2}}\right]\Big|_{\delta} = \left.\partial\chi^{v_{\delta}^{1}}(c_{\delta} \bullet v_{\delta}^{2}) - \left.\partial\chi^{v_{\delta}^{2}}(c_{\delta} \bullet v_{\delta}^{1})\right|_{c_{\delta} = \delta} = v_{\delta}^{2} \bullet v_{\delta}^{1} - v_{\delta}^{1} \bullet v_{\delta}^{2}$$

The next theorem follows directly from what is known for free commutative right-(or left-) sided polynomial Hopf algebras (see [30, Theorem 5.8], [32, Proposition 5], and [34, Section 3].

THEOREM 6.3. The Lie algebra Lie($\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$) of infinitesimal characters associated with the group $\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ is isomorphic as a Lie algebra to $(V^*, [\cdot, \cdot]_{\bullet})$.

EXAMPLE 6.4. In the special case where $c_{\delta} = \delta + c_R$ and $d_{\delta} = \delta + d_R$, the corresponding subspace of $T_{\delta}\mathbb{R}_{np}\langle\langle X_{\delta}\rangle\rangle$ is spanned by vectors of the form $v_{\delta} = \delta 0 + v_R$. Thus, the pre-Lie product and Lie bracket above reduce to those described in [13] and [21], respectively.
