# CRITERION OF HURWITZ EQUIVALENCE FOR QUASIPOSITIVE FACTORIZATIONS OF 3-BRAIDS

The problem of Hurwitz equivalence of $n$-tuples of braids appears in the study of braid monodromy of algebraic curves in $\mathbb{C}^{2}$. It was considered by many authors, see $[1,3,4]$ and references in [3]. We give an answer for the case mentioned in the title.

Let $\mathbf{B}_{3}=\left\langle\mathcal{A} \mid \sigma_{2} \sigma_{1}=\sigma_{1} \sigma_{0}=\sigma_{0} \sigma_{2}\right\rangle, \mathcal{A}=\left\{\sigma_{0}, \sigma_{1}, \sigma_{2}\right\}$ be the Birman-Ko-Lee presentation (see [2]) of the group of braids with three strings. A quasipositive factorization of a braid $X \in \mathbf{B}_{3}$ is a collection $\left(X_{1}, \ldots, X_{k}\right) \in \mathbf{B}_{3}^{k}$ such that $X=$ $X_{1} X_{2} \ldots X_{k}$ and for each $i$, the braid $X_{i}$ is conjugate to $\sigma_{1}$. Note that $\sigma_{0}, \sigma_{1}$, and $\sigma_{2}$ are conjugate to each other. We denote the set of quasipositive factorizations of $X$ by $\mathcal{Q}(X)$. A braid $X$ is called quasipositive if $\mathcal{Q}(X) \neq \varnothing$. The braid group $\mathbf{B}_{k}$ acts on $\mathcal{Q}(X)$ by $\Sigma_{i}:\left(X_{1}, \ldots, X_{k}\right) \mapsto\left(Y_{1}, \ldots, Y_{k}\right)$ where $\left(Y_{i}, Y_{i+1}\right)=\left(X_{i} X_{i+1} X_{i}^{-1}, X_{i}\right)$ and $Y_{j}=X_{j}$ for $j \notin\{i, i+1\}$. This action is called the Hurwitz action. Elements belonging to the same orbit are called Hurwitz-equivalent.

It is proven in [4] that each orbit of the Hurwitz action contains an element of a certain explicitly specified finite set. The purpose of the present paper is to give an easy criterion to decide if two given elements of this finite set belong to the same orbit. To give precise statements, we need to introduce some notation with slightly differs from that in [4]. Let us extend the alphabet $\mathcal{A}$ up to $\hat{\mathcal{A}}=\mathcal{A} \cup\left\{\hat{\sigma}_{0}, \hat{\sigma}_{1}, \hat{\sigma}_{2}\right\}$. Let $\mathcal{A}^{*}$ and $\hat{\mathcal{A}}^{*}$ be the free monoids generated by $\mathcal{A}$ and $\hat{\mathcal{A}}$ respectively. If $U, V \in \hat{\mathcal{A}}^{*}$, then $U \equiv V$ stands for equality in $\hat{\mathcal{A}}^{*}$ (i. e. letterwise coincidence of words) and $U=V$ (when $U, V \in \mathcal{A}^{*}$ ) stands for equality of the corresponding elements of $\mathbf{B}_{3}$. For $U \in \hat{\mathcal{A}}^{*}$, we denote the word obtained from $U$ by erasing of all letters $\hat{\sigma}_{i}$ (resp. by replacing each $\hat{\sigma}_{i}$ with $\sigma_{i}$ or by replacing each $\sigma_{i}$ with $\hat{\sigma}_{i}$ ) by $\bar{U}$ (resp. $U^{\prime}$ or $\hat{U}$ ). For example, if $U \equiv \sigma_{0} \hat{\sigma}_{1} \sigma_{2} \hat{\sigma}_{1}$, then $U^{\prime} \equiv \sigma_{0} \sigma_{2}, \bar{U} \equiv \sigma_{0} \sigma_{1} \sigma_{2} \sigma_{1}$, and $\hat{U} \equiv \hat{\sigma}_{0} \hat{\sigma}_{1} \hat{\sigma}_{2} \hat{\sigma}_{1}$.

We set $\delta=\sigma_{2} \sigma_{1}=\sigma_{1} \sigma_{0}=\sigma_{0} \sigma_{2}$. It is easy to check that any $X \in \mathbf{B}_{3}$ can be written as

If, moreover, $U$ does not contain any subword which is equal (in $\mathbf{B}_{3}$ ) to $\delta$, then the presentation of $X$ in the form (1) is unique and it is called the right Garside normal form.

Let

W=W_{1} \hat{x}_{1} W_{2} \hat{x}_{2} \ldots W_{k} \hat{x}_{k} W_{k+1} \in \hat{\mathcal{A}}^{*}, \quad W_{i} \in \mathcal{A}^{*}, \quad x_{i} \in \mathcal{A} . \tag{2}

If $W^{\prime}=\delta^{p}$, then $[W]$ stands for the quasipositive factorization of $\bar{W} \delta^{-p}$ of the form $\left(X_{1}, \ldots, X_{k}\right)$ where $X_{i}=A_{i} x_{i} A_{i}^{-1}, A_{i}=W_{1} \ldots W_{i}$.

To each $X \in \mathbf{B}_{3}$ we associate a graph $\mathcal{G}_{0}(X)$ in the following way. Let (1) be the right Garside normal form of $X$. We define the set of vertices of $\mathcal{G}_{0}(X)$ as
$\mathcal{V}_{0}(X)=\left\{W \in \hat{\mathcal{A}}^{*} \mid W^{\prime}=\delta^{p}, \bar{W}=U\right\}$. Two vertices are connected by an edge if they are of the form $A \hat{x} B y C$ and $A x B \hat{y} C, x, y \in \mathcal{A}$ where $x B^{\prime}=B^{\prime} y$ and, for some $q \geq 0$, either $B^{\prime}=\delta^{q}$ (an edge of type (h1)), or $x B^{\prime}=\delta^{q}$ (an edge of type (h2)).

Theorem 1. Suppose that the right Garside normal form of a braid $X \in \mathbf{B}_{3}$ is (1) with $p \geq 0$. Then each orbit of the Hurwitz action on $\mathcal{Q}(X)$ contains an element of the form $[W], W \in \mathcal{V}_{0}(X)$. Two such elements belong to the same orbit if and only if the corresponding vertices belong to the same connected component of $\mathcal{G}_{0}(X)$.

Remark 1. The condition $p \geq 0$ in Theorem 1 is not very restrictive. Indeed, if $p<0$, then the Hurwitz action has a single orbit (see [4; Corollary 4]).

The rest of the paper is devoted to the proof of Theorem 1. Let $\tau: \hat{\mathcal{A}}^{*} \rightarrow \hat{\mathcal{A}}^{*}$ be the monoid homomorphism defined on the generators by $\sigma_{0} \mapsto \sigma_{1} \mapsto \sigma_{2} \mapsto \sigma_{0}$, $\hat{\sigma}_{0} \mapsto \hat{\sigma}_{1} \mapsto \hat{\sigma}_{2} \mapsto \hat{\sigma}_{0}$. It induces the inner automorphism $\tau: X \mapsto \delta^{-1} X \delta$ of $\mathbf{B}_{3}$.

Lemma 1. If $A, B \in \mathcal{A}^{*}, A=B$, and $A \not \equiv B$, then $A=C \delta=\delta \tau(C), C \in \mathcal{A}^{*}$.
Proof. It is known (see [2; Theorem 2.7]) that if $A=B$, then $B$ is obtained from $A$ by applying the relations without inserting the inverses of the generators. If $A \not \equiv B$, then a relation can be applied to $A$, hence $A=D \delta E, D, E \in \mathcal{A}^{*}$. Then $A=C \delta=\delta \tau(C)$ for $C=\tau(D) E$.

Definition. Let $W \equiv a_{1} \ldots a_{n}, a_{i} \in \hat{\mathcal{A}}, W^{\prime}=\delta^{q}, q>0$. We say that letters $a_{i}$ and $a_{j}(i<j)$ match each other in $W$ if $a_{i}, a_{j} \in \mathcal{A},\left(a_{i} \ldots a_{j}\right)^{\prime} \equiv a_{i} B a_{j}=\delta^{r+1}$ and $B=\delta^{r}, r \geq 0$.

Formally speaking, the indices $i$ and $j$ rather than the letters $a_{i}$ and $a_{j}$ match each other in the above definition. However, abusing the language, we shall speak about matching letters to avoid cumbersome notation.

Lemma 2. (follows from [4; Lemma 5]) Let $W \in \mathcal{A}^{*}, W=\delta^{q}, q>0$. Then one can associate parentheses to all letters of $W$ so that the parentheses are balanced and matching pairs of parentheses correspond to matching pairs of letters.

Lemma 3. Let $W \equiv A u B C v D \in \mathcal{A}^{*}, W=\delta^{q}$, and let $v$ match $u$ in $W$. Let $W_{1} \equiv C v D \tau^{q}(A u B)$. Then $W_{1}=\delta^{q}$ and $\tau^{q}(u)$ matches $v$ in $W_{1}$.

Proof. Let $E=A u B, F=C v D$. Then $\delta^{q}=E F$, hence $W_{1}=F \delta^{-q} E \delta^{q}=$ $F\left(F^{-1} E^{-1}\right) E(E F)=E F=\delta^{q}$. The same computation with $E=A u, F=B C v D$ yields $B C v D \tau^{q}(A u)=\delta^{q}$. Since $B C=\delta^{r}$, we obtain $v D \tau^{q}(A u)=\delta^{q-r}$. Similarly, by setting $E=A$ and $F=u B C v D$, we obtain $D \tau^{q}(A)=\delta^{q-r-1}$.

Lemma 4. Let $W \equiv A B C \in \mathcal{A}^{*}, W=\delta^{q}, B=\delta^{r}$. Then, for any letter $u$ in $A$ there is a letter in $A$ or in $C$ which matches $u$ in $W$.

Proof. Follows from Lemma 3 combined with Lemma 2 applied to $\tau^{q}(C) A$.
Let a braid $X$ satisfies the hypothesis of Theorem 1. We extend the graph $\mathcal{G}_{0}(X)$ up to $\mathcal{G}(X)$ as follows. We define the set of vertices as $\mathcal{V}(X)=\bigcup_{j \geq 0} \mathcal{V}_{j}$ where $\mathcal{V}_{j}=\left\{W \in \hat{\mathcal{A}}^{*} \mid W^{\prime}=\delta^{p+j}, \bar{W} \delta^{-p-j}=X\right\}$. The weight of a vertex $W \in \mathcal{V}_{j}$ is defined as $\mathrm{wt}(W)=j$. We define edges of types (h1) and (h2) in the same way as in $\mathcal{G}_{0}(X)$ and we add more edges $(W, V)$ in the following cases:
(h3) $W \equiv A \hat{B}_{1} C, V \equiv A \hat{B}_{2} C, B_{1}, B_{2} \in \mathcal{A}^{*}, B_{1}=B_{2}$;
(v1) $W \equiv A P B, V \equiv A \tau^{-1}(B), P \in \mathcal{A}^{*}, P=\delta$;
(v2) either $W \equiv A P B y C$ and $V \equiv A \tau^{-1}(B \hat{y} C)$, or $W \equiv A y B P C$ and $V \equiv$ $A \hat{y} B \tau^{-1}(C)$ where $P \in\{u \hat{x}, \hat{x} u\}, \bar{P}=\delta$, and $y$ matches $u$ in $W$;
(v3) $\mathrm{wt}(V)=\mathrm{wt}(W)-1, W$ is connected by an edge of type (h3) to a vertex which is connected to $V$ by an edge of type (v2).

We call edges of types (h1-h3) horizontal and edges of types (v1-v3) vertical. The notation $(W, V)$ for vertical edges assumes that $\mathrm{wt}(W)>\mathrm{wt}(V)$. If two vertices $W$ and $V$ belong to the same connected component of $\mathcal{G}(W)$, then we write $W \sim V$. If either $W \equiv V$ or there exists an edge ( $W, V$ ) of type, say, (h1), then we write $W \sim_{\mathrm{h} 1} V$. If wt $W=\mathrm{wt} V$ and $W$ is connected to $V$ by a path in $\mathcal{G}(X)$, which passes through vertices of weight $\leq \mathrm{wt}(W)$ only, then we write $W \sim_{\mathrm{h}} V$.

We define $f:\left(\hat{\mathcal{A}} \cup \mathcal{A}^{-1}\right)^{*} \rightarrow \hat{\mathcal{A}}^{*}$ by $f(1)=1, f(x A) \equiv x f(A)$ for $x \in \hat{\mathcal{A}}$ and $f\left(x^{-1} A\right) \equiv \tau(\tau(x) f(A))$ for $x \in \mathcal{A}$. Note that the braid $A^{-1} f(A)$ is a power of $\delta$.

Lemma 5. (a). Let $W \in \mathcal{V}(X)$. Then $W \sim f\left(Y_{1} \ldots Y_{k}\right), Y_{i} \equiv A_{i} \hat{x}_{i} A_{i}^{-1}$ for some $A_{i} \in \mathcal{A}^{*}, x_{i} \in \mathcal{A}, i=1, \ldots, k$. (b). If $X$ is conjugate to $\sigma_{1}$, then $\mathcal{V}_{0}(X)$ contains a single element and it has the form $f\left(A x A^{-1}\right), A \in \mathcal{A}^{*}, x \in \mathcal{A}$.

Proof. (a). Let $W$ be as in (2) and set $A_{i} \equiv W_{1} \ldots W_{i}$. Then $f\left(Y_{1} \ldots Y_{k}\right)$ is connected to $W$ by a chain of edges of type (v1). (b). Follows from Lemma 2.

Lemma 6. [4; Lemmas 6 and 7]. If $W \in \mathcal{V}(X)$ then $W \sim V$ for some $V \in$ $\mathcal{V}_{0}(X)$.

Lemma 7. Let $W, V \in \mathcal{V}(X)$. Then $[W] \sim[V]$ is equivalent to $W \sim V$.
Proof. $(\Rightarrow)$ Let $[W]=\left(X_{1}, \ldots, X_{i}\right)$. Lemma $5($ a) combined with Lemmas 6 and $5(\mathrm{~b})$ applied to $Y_{i}{ }^{\prime}$ s imply $W \sim f\left(Y_{1} \ldots Y_{k}\right)$ where $\mathcal{V}_{0}\left(X_{i}\right)=\left\{f\left(Y_{i}\right)\right\}$. Thus $[W]=$ $[V] \Rightarrow W \sim V$. It remains to note that if $W \equiv f\left(Y_{1} \ldots Y_{k}\right), Y_{i} \equiv A_{i} \hat{x}_{i} A_{i}^{-1}$, and

V \equiv f\left(\ldots Y_{i-1} \bar{Y}_{i} Y_{i+1} \bar{Y}_{i}^{-1} Y_{i} Y_{i+2} \ldots\right), \quad W_{1} \equiv f\left(\ldots Y_{i-1} Y_{i} Y_{i+1} \bar{Y}_{i}^{-1} \bar{Y}_{i} Y_{i+2} \ldots\right)
$$

then $\Sigma_{i}([W])=[V], W_{1} \sim_{\mathrm{h} 2} V$, and $W_{1}$ is connected to $W$ by a chain of (v1)-edges.
$(\Leftarrow)\left(\mathrm{cp} . \quad\left[4 ;\right.\right.$ Lemma 6]). It suffices to consider the cases $W \sim_{\mathrm{h} 1} V$ and $W \sim_{\mathrm{h} 2} V$. Let $W$ be as in (2). Then, for some $m, s, 1 \leq m<s \leq k+1$, we have $W \equiv A \hat{x}_{m} B y C$ and $V \equiv A x_{m} B \hat{y} C$ where $A \equiv W_{1} \hat{x}_{1} W_{2} \hat{x}_{2} \ldots W_{m}, B \equiv$ $W_{m+1} \hat{x}_{m+1} \ldots W_{s-1} \hat{x}_{s-1} D, C \equiv E \hat{x}_{s} W_{s+1} \hat{x}_{s+1} \ldots \hat{x}_{k} W_{k+1}$ (if $s=k+1$, then $C \equiv E), W_{s} \equiv D y E$. Let $[W]=\left(X_{1}, \ldots, X_{k}\right)$ and $[V]=\left(Y_{1}, \ldots, Y_{k}\right)$.

It is clear that $Y_{i}=X_{i}$ for $i<m$.
If $m \leq i<s-1$, then $Y_{i}=B_{i} x_{i+1} B_{i}^{-1}$ where $B_{i}=A^{\prime} x_{m} W_{m+1} W_{m+2} \ldots W_{i+1}$ $=\left(A^{\prime} x_{m}\left(A^{\prime}\right)^{-1}\right) A^{\prime} W_{m+1} \ldots W_{i+1}=X_{m} W_{1} \ldots W_{i+1}$, whence $Y_{i}=X_{m} X_{i+1} X_{m}^{-1}$.

If $i=s-1$, then $Y_{i}=A^{\prime} x_{m} B^{\prime} y\left(A^{\prime} x_{m} B^{\prime}\right)^{-1}$. Using $x_{m} B^{\prime}=B^{\prime} y$, we obtain $Y_{i}=A^{\prime} x_{m}\left(x_{m} B^{\prime}\right)\left(A^{\prime} x_{m} B^{\prime}\right)^{-1}=A^{\prime} x_{m}\left(A^{\prime}\right)^{-1}=X_{m}$.

If $i \geq s$, then $Y_{i}=B_{i} x_{i} B_{i}^{-1}$ where $B_{i}=A^{\prime} x_{m} B^{\prime} E F$ and $F=W_{s+1} \ldots W_{i}$. Using $x_{m} B^{\prime}=B^{\prime} y$, we obtain $B_{i}=A^{\prime} B^{\prime} y E F=W_{1} W_{2} \ldots W_{i}$, whence $Y_{i}=X_{i}$.

Thus, $[V]=\left(X_{1}, \ldots, X_{m-1}, X_{m} X_{m+1} X_{m}^{-1}, \ldots, X_{m} X_{s-1} X_{m}^{-1}, X_{m}, X_{s}, \ldots, X_{k}\right)$ $=\Sigma_{s-2} \ldots \Sigma_{m+1} \Sigma_{m}[W]$.

Let $\mathbf{c}_{s}: \hat{\mathcal{A}}^{*} \rightarrow \hat{\mathcal{A}}^{*}$ be defined as $a W \mapsto W \tau^{s}(a), a \in \hat{\mathcal{A}}, W \in \hat{\mathcal{A}}^{*}$.
Lemma 8. (follows from Lemma 3) (a). Let $e=(W, V) \equiv(a A, b B), a, b \in \hat{\mathcal{A}}$, be an edge of $\mathcal{G}(X)$ of type (h1) or (h2). Let $s=p+\mathrm{wt}(W)$. Then $e_{1}=\left(\mathbf{c}_{s}(W), \mathbf{c}_{s}(V)\right)$ is an edge of $\mathcal{G}\left(\mathbf{c}_{s}(\bar{W}) \delta^{-s}\right)$ of type (h1) or (h2). If $a=b$, then $e$ and $e_{1}$ are of the same type. If $a \neq b$, then they are not.
(b). Let $e=(W, V)$ be an edge of $\mathcal{G}(X)$ of type (v1) or (v2). Let $s=p+\mathrm{wt}(W)$. Let $e_{1}=\left(\mathbf{c}_{s}^{m}(W), \mathbf{c}_{s-1}^{m}(V)\right)$ where $m=2$ if $W$ starts with the word $P$ used in the definition of $e$, and $m=1$ otherwise. Then $e_{1}$ is an edge of $\mathcal{G}\left(\mathbf{c}_{s}^{m}(\bar{W}) \delta^{-s}\right)$ of the same type as e.
Lemma 9 (Diamond Lemma). Let $e_{1}=\left(W, V_{1}\right)$ and $e_{2}=\left(W, V_{2}\right)$ be vertical edges in $\mathcal{G}(X)$. Then $V_{1} \sim_{h} V_{2}$.

Proof. By Lemma 8, mutual arrangements of subwords of $W$ used in the definition of the edges can be considered up to cyclic permutations.

Case 1. Both $e_{1}$ and $e_{2}$ are of type (v1). The statement is evident.
Case 2. Both $e_{1}$ and $e_{2}$ are of type (v2). Let $P_{i} \in\left\{u_{i} \hat{x}_{i}, \hat{x}_{i} u_{i}\right\}$, and $y_{i}, i=1,2$, be the subwords of $W$ used in the definition of $e_{i}$.

Case 2.1. $P_{1}$ coincides with $P_{2}$, i. e., $W \equiv A y_{1} B y_{2} C P, V_{1} \equiv A \hat{y}_{1} B y_{2} C, V_{2} \equiv$ $A y_{1} B \hat{y}_{2} C, P \in\{\hat{x} u, u \hat{x}\}, \bar{P}=\delta$. By definition of edges of type (v2), we have $B^{\prime} y_{2} C^{\prime}=\delta^{q}, C^{\prime}=\delta^{r}, y_{1} B^{\prime} y_{2} C^{\prime} u=\delta^{q+1}, y_{2} C^{\prime} u=\delta^{r+1}$. The former two identities imply $B^{\prime} y_{2}=\delta^{q-r}$. The latter two identities imply $y_{1} B^{\prime}=\delta^{q-r}$. Hence $V_{1} \sim_{\mathrm{h} 2} V_{2}$.

Case 2.2. $P_{1}$ and $P_{2}$ have a common letter $\hat{x}_{1}=\hat{x}_{2}=\hat{x}$. Since $u_{1} x=x u_{2}=\delta$, it follows that $u_{1}$ cannot match $u_{2}$. Hence $y_{1}$ and $y_{2}$ cannot coincide with them.

Case 2.2.1. $y_{1}=y_{2}=y . W \equiv A y B u_{1} \hat{x} u_{2}, V_{1} \equiv A \hat{y} B \tau^{-1}\left(u_{2}\right), V_{2} \equiv A \hat{y} B u_{1}$. Then $B^{\prime} u_{1}=\delta^{q}$ and $B^{\prime}=\delta^{r}$, whence $u_{1}=\delta^{q-r}$. Contradiction.

Case 2.2.2. $W \equiv A y_{2} B y_{1} C u_{1} \hat{x} u_{2}, V_{1} \equiv A y_{2} B \hat{y}_{1} C \tau^{-1}\left(u_{2}\right), V_{2} \equiv A \hat{y}_{2} B y_{1} C u_{1}$. Since $u_{1} \delta=u_{1} x u_{2}=\delta u_{2}$, we have $u_{2}=\tau\left(u_{1}\right)$, whence $V_{1} \equiv A y_{2} B \hat{y}_{1} C u_{1}$. Since $B^{\prime} y_{1} C^{\prime} u_{1}=\delta^{q}$ ( $e_{2}$ is of type (v2)) and $y_{1} C^{\prime} u_{1}=\delta^{r+1}$ ( $e_{1}$ is of type (v2)), it follows that $B^{\prime}=\delta^{q-r-1}$. To conclude that $V_{1} \sim_{\mathrm{h} 1} V_{2}$, it remains to check that $y_{1}=\tau^{q-r-1}\left(y_{2}\right)$. Indeed, $y_{1} \delta^{r} u_{1}=\delta^{r+1}$ implies $\tau^{r}\left(y_{1}\right) u_{1}=\delta$, and $y_{2} \delta^{q} u_{2}=$ $\delta^{q+1}$ implies $\tau^{q}\left(y_{2}\right) u_{2}=\delta$. Recall that $u_{2}=\tau\left(u_{1}\right)$. So, we obtain $\delta=\tau(\delta)=$ $\tau\left(\tau^{r}\left(y_{1}\right) u_{1}\right)=\tau^{r+1}\left(y_{1}\right) u_{2}$, whence $\tau^{r+1}\left(y_{1}\right)=\delta u_{2}^{-1}=\tau^{q}\left(y_{2}\right)$.

Case 2.2.3. $W \equiv A y_{1} B y_{2} C u_{1} \hat{x} u_{2}, V_{1} \equiv A \hat{y}_{1} B y_{2} C \tau^{-1}\left(u_{2}\right), V_{2} \equiv A y_{1} B \hat{y}_{2} C u_{1}$. Since $e_{2}$ is of type (v2), we have $C^{\prime} u_{1}=\delta^{q}$. Hence, by Lemma 2, we have $C u_{1} \equiv$ $C_{1} z_{1} C_{2} u_{1}$ where $z_{1}$ matches $u_{1}$ in $C u_{1}$. Let $V_{3} \equiv A y_{1} B y_{2} C_{1} \hat{z}_{1} C_{2} u_{1}$. Then $e_{3}=$ $\left(W, V_{3}\right)$ is an edge of type (v2) and the pair $\left(e_{1}, e_{3}\right)$ (resp. ( $\left.e_{3}, e_{2}\right)$ ) satisfies the conditions of Case 2.1 (resp. by Case 2.2.2).

Case 2.3. $P_{1}$ and $P_{2}$ have a common letter $u_{1}=u_{2}=u$, i. e., $W \equiv A \hat{x}_{1} u \hat{x}_{2}$. Since $x_{1} \delta=x_{1} u x_{2}=\delta x_{2}$, we have $x_{2}=\tau^{-1}\left(x_{1}\right)$. Hence the edge of type (v2) defined by $\left(P_{1}, y_{2}\right)$ coincides with $e_{2}$. The problem is reduced to Case 2.1.

Case 2.4. $P_{1}$ and $P_{2}$ are disjoint, $y_{1}=u_{2}$, and $y_{2}=u_{1}$. Then $W \equiv A P_{1} B P_{2}$, $V_{1} \equiv A \tau^{-1}\left(B \hat{P}_{2}\right), V_{2} \equiv A \hat{P}_{1} B, B^{\prime}=\delta^{q}$. If $q=0$, then $V_{1} \sim_{\mathrm{h} 3} V_{2}$. Let $q>0$. Let $B \equiv \hat{C} z D, z \in \mathcal{A}$ and let $x y=y z=\delta$. Since $P_{1} C=\tau^{-1}(C) x y$, we have $V_{3} \equiv A \tau^{-1}(\hat{C}) \hat{x} \hat{y} z D \sim_{\mathrm{h} 3} \quad V_{2}$. Then $V_{1} \equiv E \tau^{-1}\left(z D \hat{P}_{2}\right)$ and $V_{3} \equiv E \hat{x} \hat{y} z D$ for $E \equiv A \tau^{-1}(\hat{C})$. Since $z D^{\prime}=(\hat{C} z D)^{\prime}=B^{\prime}=\delta^{q}$, it follows from Lemma 2 that $z D$ includes a letter $u$ which matches $z$. Let $\left(V_{3}, U_{3}\right)$ be the edge of type (v2) defined by $(\hat{y} z, u)$. Then $D \equiv D_{1} u D_{2}$ and $U_{3} \equiv E \hat{x} \tau^{-1}\left(D_{1} \hat{u} D_{2}\right)$. We have $D_{1}^{\prime}=\delta^{r}$ and $z D_{1}^{\prime} u=\delta^{r+1}$. Recall that $z D_{1}^{\prime} u D_{2}^{\prime}=\delta^{q}$ which implies $D_{2}^{\prime}=\delta^{q-r-1}$. Let
$v=\tau^{q-r-1}(u)$ and $v w=\delta$. We may assume that $P_{2} \equiv v w$ (otherwise we add an edge of type (h3)). Then $V_{1} \sim_{\mathrm{h} 1} V_{4} \equiv E \tau^{-1}\left(z D_{1} \hat{u} D_{2} v \hat{w}\right)$. Let us show that $\tau^{-1}(z)$ matches $\tau^{-1}(v)$ in $V_{4}$. Indeed, we have $D_{1}^{\prime} D_{2}^{\prime}=\delta^{r} \delta^{q-r-1}=\delta^{q-1}$ and $u D_{2}^{\prime}=D_{2}^{\prime} v$ (by the choice of $v$ ), whence $z D_{1}^{\prime} D_{2}^{\prime} v=z D_{1}^{\prime} u D_{2}^{\prime}=B^{\prime}=\delta^{q}$. Let $\left(V_{4}, U_{4}\right)$ be the edge of type (v2) defined by $\left(\tau^{-1}(v \hat{w}), \tau^{-1}(z)\right)$. Then $U_{4} \equiv E \tau^{-1}\left(\hat{z} D_{1} \hat{u} D_{2}\right)$. It remains to note that $x \delta=x y z=\delta z$, whence $x=\tau^{-1}(z)$ and therefore $U_{3} \equiv U_{4}$.

Case 2.5. $P_{1}, P_{2}$, and $y_{2}$ are pairwise disjoint: $W \equiv D_{1} D_{2}$ where $D_{1} \equiv A P_{1} B$, $D_{2} \equiv y_{2} C P_{2}, C^{\prime}=\delta^{q}$, and $D_{2}^{\prime}=\delta^{q+1}$. Then $D_{1}^{\prime}=W^{\prime} \delta^{-q-1}$ is a power of $\delta$. By Lemma 2, this implies that $D_{1}$ has a letter $z_{1}$ which matches $u_{1}$. Let $\left(W, V_{3}\right)$ be the edge of type (v2) defined by $\left(P_{1}, z_{1}\right)$. Then we have $V_{1} \sim_{h} V_{3}$ (see Case 2.1), $V_{2} \equiv D_{1} E_{2}$, and $V_{3} \equiv E_{1} \tau^{-1}\left(D_{2}\right)$ where $D_{i} \sim_{\mathrm{v} 2} E_{i}$ in the corresponding graphs. Hence $V_{2} \sim_{\mathrm{v} 2} E_{1} \tau^{-1}\left(E_{2}\right) \sim_{\mathrm{v} 2} V_{3}$.

Case 3. $e_{1}$ is of type (v3) and $e_{2}$ is of type (v2) or (v3). Let $W \sim_{\mathrm{h} 3} W_{i} \sim_{\mathrm{v} 2} V_{i}$, $i=1,2$. Let $P_{i} \in\left\{\hat{x}_{i} u_{i}, u_{i} \hat{x}_{i}\right\}$ and $y_{i}$ be the subwords of $W_{i}$ used in the definition of the edge $\left(W_{i}, V_{i}\right)$. We may assume that $W_{1} \equiv E u_{1} \hat{x}_{1} \hat{F}_{1} u_{2}$ and $W_{2} \equiv E u_{1} \hat{F}_{2} \hat{x}_{2} u_{2}$ where $x_{1} F_{1}=F_{2} x_{2}$ (otherwise the problem reduces to Case 2). By Lemma 1, we have $x_{1} F_{1}=\delta \tau(D)=D \delta, D \in \mathcal{A}^{*}$. So, we may assume that $x_{1} F_{1} \equiv x_{1} v_{1} \tau(D)$ and $F_{2} x_{2} \equiv D v_{2} x_{2}$ where $x_{1} v_{1}=v_{2} x_{2}=\delta$. Without loss of generality we may assume also that $u_{1} x_{1} v_{1} \equiv \sigma_{2} \sigma_{1} \sigma_{0}$.

Case 3.1. $y_{1}=u_{2}$ and $y_{2}=u_{1}$. Then $u_{1}\left(\hat{x}_{1} \hat{F}_{1}\right)^{\prime} u_{2}=u_{1} u_{2}=\delta$. Hence $W_{1} \equiv E \sigma_{2} \hat{\sigma}_{1} \hat{\sigma}_{0} \tau(\hat{D}) \sigma_{1}$ and $W_{2} \equiv E \sigma_{2} \hat{D} \hat{\sigma}_{0} \hat{\sigma}_{2} \sigma_{1}$, whence $V_{1} \equiv E \tau^{-1}\left(\hat{\sigma}_{0} \tau(\hat{D}) \hat{\sigma}_{1}\right) \equiv$ $E \hat{\sigma}_{2} \hat{D} \hat{\sigma}_{0} \equiv V_{2}$.

Case 3.2. $E \equiv E_{2} y_{1} E_{1}$. Then $E_{1}^{\prime}=\delta^{q}$ and $y_{1} E_{1}^{\prime} u_{1}=\delta^{q+1}$. Hence, by Lemma 4, there is a letter $z_{2}$ in $E_{2}$ which matches $u_{2}$. Let $\left(W_{2}, V_{3}\right)$ be the edge of type (v2) defined by $\left(P_{2}, z_{2}\right)$. Then $V_{2} \sim_{h} V_{3}$ (see Case 2.1). By passing to a cyclic permutation of $W$, we may assume that $W_{1} \equiv A y_{1} B u_{1} \hat{x}_{1} \hat{v}_{1} \tau(\hat{D}) u_{2} C z_{2}, W_{2} \equiv$ $A y_{1} B u_{1} D \hat{v}_{2} \hat{x}_{2} u_{2} C z_{2}, B^{\prime}=\delta^{q}, y_{1} B u_{1}=\delta^{q+1}, C^{\prime}=\delta^{r}, u_{2} C^{\prime} z_{2}=\delta^{r+1}$. For each possible value of $u_{2}$, we find $V_{4}$ such that $V_{1} \sim_{h} V_{4} \sim_{h} V_{3}$. (for $u_{2}=\sigma_{1}, \sigma_{2}$ we just list the indices which should be inserted into the formulas for $V_{1}, V_{3}$, and $V_{4}$ ).

& V_{4} \equiv A \tau^{-q}\left(\sigma_{0}\right) B \hat{\sigma}_{2} \hat{D} \sigma_{2} \tau^{-1}(C) \tau^{r}\left(\hat{\sigma}_{1}\right) ; \\
& u_{2}=\sigma_{1}: V_{1}(\hat{0} \hat{2} 02), V_{4}(0 \hat{2} \hat{0} 2), V_{3}(02 \hat{0} \hat{2}) ; \quad u_{2}=\sigma_{2}: V_{1}(\hat{0} \hat{2} 10), V_{4}(\hat{0} 21 \hat{0}), V_{3}(02 \hat{1} \hat{0}) .

Case 4. $e_{1}$ is of type (v1) and $e_{2}$ is of type (v2). Let $\left(W, V_{1}\right) \equiv\left(A P_{1}, A\right), P_{1}=\delta$. Let $P$ and $y$ be the subwords of $W$ used in the definition of $e_{2}$.

Case 4.1. $P_{1}$ has one common letter with $P: W \equiv A y B \hat{x} u v, x u=u v=\delta$, $B^{\prime}=\delta^{q}, y B^{\prime} u=\delta^{q+1}, V_{1} \equiv A y B \hat{x}$, and $V_{2} \equiv A \hat{y} B \tau^{-1}(v)$. Then $x \delta=x u v=\delta v$ implies $\tau^{-1}(v)=x$, and $y \delta^{q} u=\delta^{q+1}$ combined with $x u=\delta$ implies $x=\tau^{q}(y)$. Hence $V_{1} \sim_{v} V_{2}$.

Case 4.2. $P_{1}$ is disjoint from $P$. Lemma 4 implies $A \equiv B z C P D$ where $z$ matches $u$. Let $\left(W, V_{3}\right)$ be the edge of type (v2) defined by $(P, z)$. Then $V_{2} \sim_{h} V_{3}$ (see Case 2.1) and there exist vertical edges $\left(V_{1}, V_{4}\right)$ and $\left(V_{3}, V_{4}\right)$ where $V_{4} \equiv B \hat{z} C \tau^{-1}(D)$.

Case 5. $e_{1}$ is of type (v1) and $e_{2}$ is of type (v3). Let $W \sim_{\mathrm{h} 3} W_{1} \sim_{\mathrm{v} 2} V_{2}$. Then we have $W_{1} \sim_{\mathrm{v} 1} V_{1}$ which reduces the problem to Case 4.

Lemma 10. Let $e=\left(W_{1}, W_{2}\right)$ be a horizontal edge in $\mathcal{G}(X)$. If $\mathrm{wt}\left(W_{1}\right)>0$, then there exist vertical edges $\left(W_{1}, V_{1}\right)$ and $\left(W_{2}, V_{2}\right)$ such that $V_{1} \sim_{h} V_{2}$.
Proof. The condition wt $\left(W_{1}\right)>0$ implies that $\bar{W}_{1}$ has a subword $P$ which is equal to $\delta$. By Lemma 8, it suffices to consider edges of type (h1) and (h3) only.

Case 1. $e$ of type (h1). Let $x$ and $y$ be as in the definition of edges of type (h1). It is clear that $P \not \equiv x y$. If $P, x, y$ are disjoint, then the statement is evident.

Case 1.1. $W_{1} \equiv A \hat{y} B u x, W_{2} \equiv A y B u \hat{x}, u x=\delta$. Let $V_{1}=A \hat{y} B$. Then $W_{1} \sim_{\mathrm{v} 1} V_{1}$. Since $e$ is an edge of type (h1), we have $B^{\prime} u=\delta^{q}, x=\tau^{q}(y)$. Hence, by Lemma 2 , there is a letter $z$ in $B u$ which matches $u$, i. e., $B \equiv B_{1} z B_{2}, B_{2}^{\prime}=\delta^{r}$, $z B_{2}^{\prime} u=\delta^{r+1}$. Hence $W_{2} \sim_{\mathrm{v} 2} V_{2} \equiv A y B_{1} \hat{z} B_{2}$. Let us show that $V_{1} \sim_{\mathrm{h} 1} V_{2}$. Indeed, $B_{1}^{\prime} z B_{2}^{\prime} u=B^{\prime} u=\delta^{q}$ combined with $z B_{2}^{\prime} u=\delta^{r+1}$ imply $B_{1}^{\prime}=\delta^{q-r-1}$, and $z \delta^{r} u=\delta^{r+1}$ combined with $u x=\delta$ imply $x=\tau^{r+1}(z)$. Since $x=\tau^{q}(y)$, we obtain $z=\tau^{q-r-1}(y)$.

Case 1.2. $W_{1} \equiv A \hat{y} B x u, W_{2} \equiv A y B \hat{x} u, x u=\delta, B^{\prime}=\delta^{q}$, and $y B^{\prime}=B^{\prime} x$. Then $y B^{\prime} u=B^{\prime}(x u)=\delta^{q+1}$, i. e., $\left(W_{1}, A \hat{y} B\right)$ and $\left(W_{2}, A \hat{y} B\right)$ are edges of type (v1) and (v2) respectively.

Case 2. $e$ of type (h3). Without loss of generality we may assume that $W_{1} \equiv$ $A u \hat{B}_{1}, W_{2} \equiv A u \hat{B}_{2}, u \in \mathcal{A}, B_{1}, B_{2} \in \mathcal{A}^{*}$, and $B_{1}=B_{2}$. Lemma 1 implies $B_{1}=\delta B$. Let $W \equiv A u \hat{x} \hat{v} \hat{B}$ where $u x=x v=\delta$. Then $W_{1} \sim_{\mathrm{h} 3} W \sim_{\mathrm{h} 3} W_{2}$. Let $y$ matches $u$ and let ( $W, V$ ) be the edge of type (v2) defined by (ux,y). Then $W_{1} \sim_{\mathrm{v} 3} V \sim_{\mathrm{v} 3} W_{2}$.

Proof of Theorem 1. By Lemma 7, it is enough to show that: if $W \sim V$ and $\mathrm{wt}(W)=\mathrm{wt}(V)$, then $W \sim_{\mathrm{h}} V$. Indeed, if a path from $W$ to $V$ in $\mathcal{G}(X)$ passes through vertices whose weight is greater than $\mathrm{wt}(W)$, then, by Lemmas 9 and 10 , we can modify the path so that either the number of vertices of the maximal weight is reduced, or the number of horizontal edges incident to such vertices is reduced.
