# Some notes on the $k$-normal elements and $k$-normal polynomials over finite fields

#### Abstract

Recently, the $k$-normal element over finite fields is defined and characterized by Huczynska et al.. In this paper, the characterization of $k$-normal elements, by using to give a generalization of Schwartz's theorem, which allows us to check if an element is a normal element, is obtained. In what follows, in respect of the problem of existence of a primitive 1-normal element in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$, for all $q$ and $n$, had been stated by Huczynska et al., it is shown that, in general, this problem is not satisfied. Finally, a recursive method for constructing 1-normal polynomials of higher degree from a given 1-normal polynomial over $\mathbb{F}_{2^{m}}$ is given.


Keywords: Finite field, normal basis, $k$-normal element, $k$-normal polynomial, primitive element.

## 1 Introduction

Let $\mathbb{F}_{q}$, be the Galois field of order $q=p^{m}$, where $p$ is a prime and $m$ is a natural number, and $\mathbb{F}_{q}^{*}$ be its multiplicative group. A normal basis of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ is a basis of the form $N=\left\{\alpha, \alpha^{q}, \ldots, \alpha^{q^{n-1}}\right\}$, i.e., a basis that consists of the algebraic conjugates of a fixed element $\alpha \in \mathbb{F}_{q^{n}}^{*}$. Recall that an element $\alpha \in \mathbb{F}_{q^{n}}$ is said to generate a normal basis over $\mathbb{F}_{q}$ if its conjugates form a basis of $\mathbb{F}_{q^{n}}$ as a vector space over $\mathbb{F}_{q}$. For convenience an element $\alpha$ generating a normal basis, is called a normal element.

A monic irreducible polynomial $F(x) \in \mathbb{F}_{q}[x]$ is called normal polynomial or $N$-polynomial if its roots form a normal basis or, equivalently, if they are linearly independent over $\mathbb{F}_{q}$. The minimal polynomial of an element in a normal basis $\left\{\alpha, \alpha^{q}, \ldots, \alpha^{q^{n-1}}\right\}$ is $m(x)=\prod_{i=0}^{n-1}\left(x-\alpha^{q^{i}}\right) \in \mathbb{F}_{q}[x]$, which is irreducible over $\mathbb{F}_{q}$.

Normal bases have many applications, including coding theory, cryptography and computer algebra systems. The elements in a normal basis are exactly the roots of some $N$-polynomial. Hence an $N$-polynomial is just another way of describing a normal basis. The construction of normal polynomials over finite fields is a challenging mathematical problem [7].

Recently, the $k$-normal element over finite fields is defined and characterized by Huczynska, Mullen, Panario and Thomson [6]. The following definition for checking whether an element is a $k$-normal element, is given by them.

Definition 1.1 For each $0 \leq k \leq n-1$, the element $\alpha \in \mathbb{F}_{q^{n}}$ is called a $k$-normal element if $\operatorname{deg}\left(\operatorname{gcd}\left(x^{n}-1, \sum_{i=0}^{n-1} \alpha^{q^{i}} x^{n-1-i}\right)\right)=k$.

Using this mention, a normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ is a 0 -normal element. The existence of primitive normal elements has been obtained in [1] and [2] for sufficiently large $q$ and $n$. The Primitive Normal Basis Theorem has been established for all $q$ and $n$ in [8] and 4]. Moreover, the existence of primitive 1normal elements is established in 6, for sufficiently large $q^{n}$. Also, the existence of primitive 1-normal elements of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$, for all $q$ and $n$ is stated in ( 6$]$, Problem 6.2), as a problem.

In this paper, in Section 2, some definitions, notes and results which are useful for our study have been stated. Section 3 is devoted to characterization and construction of $k$-normal elements (especially, 1-normal elements). Also, in this section, in respect of the problem of existence of primitive 1-normal elements, for all $q$ and $n$, some value of $q$ and $n$ is given, such that the extension finite field $\mathbb{F}_{q^{n}}$ is not consists of any primitive 1-normal element. Finally, in Section 4, by definition of $k$-normal polynomials, given in Section 2, a recursive method for construction 1-normal polynomials of higher degree from a given 1-normal polynomial over $\mathbb{F}_{2^{m}}$ is given.

## 2 Preliminary notes

We use the definitions, notations and results given by Huczynska [6], Cohen [3], Gao [5] and Kyuregyan [7, where similar problems are considered. We need the following results for our further study.

Recall that $\operatorname{Tr}_{\mathbb{F}_{q^{n}} \mid \mathbb{F}_{q}}(\alpha)$, the trace of $\alpha$ in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$, is given by $\operatorname{Tr}_{\mathbb{F}_{q^{n}} \mid \mathbb{F}_{q}}(\alpha)=$ $\sum_{i=0}^{n-1} \alpha^{q^{i}}$. For convince, $\operatorname{Tr}_{\mathbb{F}_{q^{n} \mid \mathbb{F}_{q}}}$ is denoted by $\operatorname{Tr}_{q^{n} \mid q}$. To state further results, recall that the Frobenius map

\sigma: \eta \rightarrow \eta^{q}, \quad \eta \in \mathbb{F}_{q^{n}}
$$

is an automorphism of $\mathbb{F}_{q^{n}}$ that fixes $\mathbb{F}_{q}$. In particular, $\sigma$ is a linear transformation of $\mathbb{F}_{q^{n}}$ viewed as a vector space of dimension $n$ over $\mathbb{F}_{q}$. For any polynomial $g(x)=\sum_{i=0}^{n-1} g_{i} x^{i} \in F_{q}[x]$, define

$$
g(\sigma) \eta=\left(\sum_{i=0}^{n-1} g_{i} \sigma^{i}\right) \eta=\sum_{i=0}^{n-1} g_{i} \eta^{q^{i}}
$$

which is also a linear transformation on $F_{q^{n}}$.
The null space of $g(\sigma)$ is defined to be the set of all elements $\alpha \in \mathbb{F}_{q^{n}}$ such that $g(\sigma) \alpha=0$, we also call it the null space of $g(x)$. For any element $\alpha \in \mathbb{F}_{q^{n}}$, the monic polynomial $g(x) \in \mathbb{F}_{q}[x]$ of the smallest degree such that $g(\sigma) \alpha=0$ is called the $\sigma$-order of $\alpha$. This polynomial is denoted by $\operatorname{Ord}_{\alpha, \sigma}(x)$. Note that $\operatorname{Ord}_{\alpha, \sigma}(x)$ divides any polynomial $h(x)$ annihilating $\alpha$. In particular, for every $\alpha \in F_{q^{n}}, \operatorname{Ord}_{\alpha, \sigma}(x)$ divides $x^{n}-1$, the minimal or characteristic polynomial for $\sigma$.

Proposition 2.1 [6] Let $\alpha \in \mathbb{F}_{q^{n}}$. Then $\alpha$ is a $k$-normal element over $\mathbb{F}_{q}$ if and only if $\operatorname{deg}\left(\operatorname{Ord}_{\alpha, \sigma}(x)\right)=n-k$.

Proposition 2.2 [3] A necessary condition for existence a primitive element with zero trace in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ is $n \geq 3$, except when $n=2$ and $q=3$. Also if $n \geq 3$, such a primitive element exists, except when $n=3$ and $q=4$.

Recall that, an element $\alpha \in \mathbb{F}_{q^{n}}$ is called a proper element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if $\alpha \notin \mathbb{F}_{q^{v}}$ for any proper divisor $v$ of $n$. So by this mention, an element $\alpha \in \mathbb{F}_{q^{n}}$ is called a proper $k$-normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if $\alpha$ is a $k$-normal element and a proper element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$.

Definition 2.3 A monic irreducible polynomial $P(x) \in \mathbb{F}_{q}$ of degree $n$ is called a $k$-normal polynomial (or $N_{k}$-polynomial)over $\mathbb{F}_{q}$ if its roots be the $k$-normal elements of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$.

By using the above definition, an $N$-polynomial is an $N_{0}$-polynomial. Since, the proper $k$-normal elements of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ are the roots of a $k$-normal polynomial of degree $n$ over $\mathbb{F}_{q}$, hence the $k$-normal polynomials of degree $n$ over $\mathbb{F}_{q}$ is just another way of describing the proper $k$-normal elements of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$.

The following proposition is useful for constructing $N_{1}$-polynomials over $\mathbb{F}_{2^{m}}$.
Proposition 2.4 [7] Let $\delta \in \mathbb{F}_{2^{s}}^{*}$ and $F_{1}(x)=\sum_{i=0}^{n} c_{i} x^{i}$ be an irreducible polynomial of degree $n$ over $\mathbb{F}_{2^{m}}$. Also let $\operatorname{Tr}_{2^{m} \mid 2}\left(\frac{c_{1} \delta}{c_{0}}\right)=1$ and $\operatorname{Tr}_{2^{m} \mid 2}\left(\frac{c_{n-1}}{\delta}\right)=$ 1. Then the sequence $\left(F_{u}(x)\right)_{u \geq 1}$, defined by

$$
F_{u+1}(x)=x^{n 2^{u-1}} F_{u}\left(x+\delta^{2} x^{-1}\right) \quad u \geq 1
$$

is a sequence of irreducible polynomials of degree $2^{u} n$ over $\mathbb{F}_{2^{m}}$ for every $u \geq 1$.

## 3 Characterization and construction of $k$-normal elements and existence of primitive 1-normal elements

In this section, the characterization and construction of $k$-normal elements (specially, of 1-normal elements), and also a characterization of some extension finite fields, consist a primitive 1-normal element is given. In the continue, in respect
of the problem of existence of the primitive 1-normal elements for all $q$ and $n$ (6), problem 6.2), some values of $q$ and $n$ is introduced, such that the extension finite field $\mathbb{F}_{q^{n}}$ is not consists of any primitive 1-normal element over $\mathbb{F}_{q}$.

Let $p$ denote the characteristic of $\mathbb{F}_{q}$ and let $n=n_{1} p^{e}=n_{1} t$, with $\operatorname{gcd}\left(p, n_{1}\right)=$ 1 and suppose that $x^{n}-1$ has the following factorization in $\mathbb{F}_{q}[x]$ :

$$
\begin{equation*}
x^{n}-1=\left(\varphi_{1}(x) \varphi_{2}(x) \cdots \varphi_{r}(x)\right)^{t} \tag{1}
\end{equation*}
$$

where $\varphi_{i}(x) \in \mathbb{F}_{q}[x]$ are the distinct irreducible factors of $x^{n}-1$. For each $s, 0 \leq s<n$, let there is a $u_{s}>0$ such that, $R_{s, 1}(x), R_{s, 2}(x), \cdots, R_{s, u_{s}}(x)$ be all of the $s$ degree polynomials dividing $x^{n}-1$. So, from (11) we can write $R_{s, i}(x)=\prod_{j=1}^{r} \varphi_{j}^{t_{i j}}(x)$, for each $1 \leq i \leq u_{s}, 0 \leq t_{i j} \leq t$. Let

$$
\begin{equation*}
\phi_{s, i}(x)=\frac{x^{n}-1}{R_{s, i}(x)} \tag{2}
\end{equation*}
$$

for $1 \leq i \leq u_{s}$. Then, there is a useful characterization of the $k$-normal elements in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ as follows.

Lemma 3.1 An element $\alpha \in \mathbb{F}_{q^{n}}$ is a $k$-normal element if and only $i f$, there is a $j, 1 \leq j \leq u_{k}$, such that

$$
\begin{equation*}
\phi_{k, j}(\sigma) \alpha=0 \tag{3}
\end{equation*}
$$

and also

$$
\begin{equation*}
\phi_{s, i}(\sigma) \alpha \neq 0 \tag{4}
\end{equation*}
$$

for each $s, k<s<n$, and $1 \leq i \leq u_{s}$.
Proof. According to Proposition $2.1, \alpha$ is a $k$-normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if and only if $\operatorname{deg}(\operatorname{Ord}(\alpha))=n-k$. This is true if and only if the Equations (3) and (4) hold.

In the case $k=0$, the Lemma 3.1 is obtained by Schwartz 12 (see also [10], Theorem 4.10). Actually, Lemma 3.1 is a generalization of Schwartz's theorem. The definition 1.1 does give us a method to test if an element is a $k$-normal element. In fact, the Lemma 3.1 dose give us another way to check if an element is $k$-normal.

The following results are some immediate consequences of Lemma 3.1.
Theorem 3.2 Let $n=n_{1} p^{e}$, for some $e \geq 1$ and $a, b \in \mathbb{F}_{q}^{*}$. Then the element $\alpha$ is a proper 1-normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if and only if $a+b \alpha$ is a proper 1 -normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$.

Proof. Let $n=n_{1} p^{e}=n_{1} t$, then by (11), $x^{n}-1$ has the following factorization in $\mathbb{F}_{q}[x]$ :

$$
x^{n}-1=\left(x^{n_{1}}-1\right)^{t}=\left(\varphi_{1}(x) \varphi_{2}(x) \cdots \varphi_{r}(x)\right)^{t} .
$$

Let

$$
\begin{equation*}
R_{1,1}(x)=\varphi_{1}(x)=x-1 \tag{5}
\end{equation*}
$$

Set for each $s, 0<s<n$ and $1 \leq i \leq u_{s}$, except when $s=i=1$,

$$
\begin{aligned}
\phi_{s, i}(x) & =\frac{x^{n}-1}{R_{s, i}(x)} \\
& =(x-1)^{t} M_{s, i}(x) \\
& =(x-1) M_{s, i}^{\prime}(x),
\end{aligned}
$$

where

$$
M_{s, i}^{\prime}(x)=(x-1)^{t-1} M_{s, i}(x)=\sum_{v=0}^{n-s-1} t_{i v}^{\prime} x^{v}
$$

Hence

$$
\begin{equation*}
\phi_{s, i}(x)=\sum_{v=0}^{n-s-1} t_{i v}^{\prime} x^{v+1}-\sum_{v=0}^{n-s-1} t_{i v}^{\prime} x^{v} \tag{6}
\end{equation*}
$$

From (6), we obtain

$$
\begin{align*}
\phi_{s, i}(\sigma)(a+b \alpha) & =\sum_{v=0}^{n-s-1} t_{i v}^{\prime}(a+b \alpha)^{q^{v+1}}-\sum_{v=0}^{n-s-1} t_{i v}^{\prime}(a+b \alpha)^{q^{v}} \\
& =a \sum_{v=0}^{n-s-1} t_{i v}^{\prime}+b \sum_{v=0}^{n-s-1} t_{i v}^{\prime} \alpha^{q^{v+1}}-a \sum_{v=0}^{n-s-1} t_{i v}^{\prime}-b \sum_{v=0}^{n-s-1} t_{i v}^{\prime} \alpha^{q^{v}} \\
& =b\left(\sum_{v=0}^{n-s-1} t_{i v}^{\prime} \alpha^{q^{v+1}}-\sum_{v=0}^{n-s-1} t_{i v}^{\prime} \alpha^{q^{v}}\right)=b \phi_{s, i}(\sigma)(\alpha) \tag{7}
\end{align*}
$$

for each $s, 0<s<n$ and $1 \leq i \leq u_{s}$, except when $s=i=1$. On the other hand, in the case $s=i=1$, from (5), we have

$$
\phi_{1,1}(x)=\frac{x^{n}-1}{R_{1,1}(x)}=\frac{x^{n}-1}{x-1}=x^{n-1}+x^{n-2}+\cdots+x+1=\sum_{i=0}^{n-1} x^{i}
$$

So

$$
\begin{align*}
\phi_{1,1}(\sigma)(a+b \alpha) & =\sum_{i=0}^{n-1}(a+b \alpha)^{q^{i}} \\
& =\sum_{i=0}^{n-1} a+b \sum_{i=0}^{n-1} \alpha^{q^{i}} \\
& =n a+b \phi_{1,1}(\sigma)(\alpha) \\
& =b \phi_{1,1}(\sigma)(\alpha) . \tag{8}
\end{align*}
$$

From (7) and (8), it follows that

$$
\phi_{s, i}(\sigma)(a+b \alpha)=b \phi_{s, i}(\sigma)(\alpha)
$$

for each $s, 0<s<n$ and $1 \leq i \leq u_{s}$. By Lemma 3.1, the proof is completed.

Theorem 3.3 Suppose that $\alpha$ is a proper element of $\mathbb{F}_{q^{2}}$. Then $\alpha$ is 1-normal over $\mathbb{F}_{q}$ if and only if $\operatorname{Tr}_{q^{2} \mid q}(\alpha)=0$.

Proof. By (11), $x^{2}-1$ has the following factorization in $\mathbb{F}_{q}[x]$ :

$$
x^{2}-1=(x-1)(x+1)
$$

So, we have $R_{1,1}(x)=x-1$ and $R_{1,2}(x)=x+1$. Hence, $\phi_{1,1}(x)=x+1$ and $\phi_{1,2}(x)=x-1$. Note that, by Lemma 3.1 to complete the proof, it is enough that

\begin{equation*}
\phi_{1,1}(\sigma) \alpha=\alpha^{q}+\alpha=\operatorname{Tr}_{q^{2} \mid q}(\alpha)=0 \tag{9}
\end{equation*}
$$

This is satisfied by hypothesis.
Theorem 3.4 Let $n$ be a prime different from $p$ and $q$ a primitive element modulo $n$. Suppose that $\alpha$ is a proper element of $\mathbb{F}_{q^{n}}$. Then $\alpha$ is a 1-normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if and only if $\operatorname{Tr}_{q^{n} \mid q}(\alpha)=0$.
Proof. Note that

$$
x^{n}-1=(x-1)\left(x^{n-1}+\cdots+x+1\right)
$$

Since $q$ is a primitive modulo $n, x^{n-1}+\cdots+x+1$ is an irreducible polynomial over $\mathbb{F}_{q}$. Hence, from (11), we have $R_{1,1}(x)=x-1$ and $R_{n-1,1}(x)=x^{n-1}+\cdots+x+1$. So, $\phi_{1,1}(x)=x^{n-1}+\cdots+x+1$ and $\phi_{n-1,1}(x)=x-1$. Thus, by Lemma 3.1, $\alpha \in \mathbb{F}_{q^{n}}$ is a 1-normal element of $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ if and only if

$$
\begin{equation*}
\phi_{1,1}(\sigma) \alpha=\sum_{i=0}^{n-1} \sigma^{i}(\alpha)=\sum_{i=0}^{n-1} \alpha^{q^{i}}=T r_{q^{n} \mid q}(\alpha)=0 \tag{10}
\end{equation*}
$$

and

$$
\begin{equation*}
\phi_{n-1,1}(\sigma) \alpha=\alpha^{q}-\alpha \neq 0 . \tag{11}
\end{equation*}
$$

The expressions (10) and (11) are satisfied by hypothesis. This completes the proof.

In the case, the 0-normal elements, similar problems for Theorems 3.2 and 3.4 had been established by Kyuregyan [7] and Pei, Wang and Omura [11, respectively.

The following corollary which characterize some of extension finite fields, consist a primitive 1-normal element, is an immediate consequence of Theorems 3.3, 3.4 and Proposition 2.2

Corollary 3.5 Let $n$ be a prime different from $p$ and $q$ a primitive element modulo $n$. Then, A necessary condition for existence a primitive 1-normal element in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$ is $n \geq 3$, except when $n=2$ and $q=3$. Also if $n \geq 3$, such a primitive 1-normal element exists, except when $n=3$ and $q=4$.

In respect of the problem of existence of a primitive 1-normal element in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$, for all $q$ and $n$, the following notation, which is an immediate consequence of Corollary 3.5 is given.

Notation 3.6 By Corollary 3.5, it is shown that, there are some extension finite fields $\mathbb{F}_{q^{n}}$, with out any primitive 1-normal element over $\mathbb{F}_{q}$. For this, for example, we can refer to the finite fields $\mathbb{F}_{4}$ over $\mathbb{F}_{2}, \mathbb{F}_{4^{3}}$ over $\mathbb{F}_{4}$ and $\mathbb{F}_{q^{2}}$ over $\mathbb{F}_{q}$, for each odd prime power $q \neq 3$. Consequently, it is shown that, the problem of existence of a primitive 1-normal element in $\mathbb{F}_{q^{n}}$ over $\mathbb{F}_{q}$, for all $q$ and $n$ is not satisfied.

## 4 Recursive construction $N_{1}$-polynomials

In this section, we establish a theorem which will show how Lemma 3.1 and Proposition 2.4 can be applied to produce infinite sequences of $N_{1}$-polynomials over $\mathbb{F}_{2^{m}}$. Nothing that $\phi_{s, i}(\sigma) \alpha=\sum_{i=0}^{n-s} a_{i} \alpha^{q^{i}}$ for any polynomial $\phi_{s, i}(x)=$ $\sum_{i=0}^{n-s} a_{i} x^{i}$, we can restate Lemma 3.1 as follows.

Proposition 4.1 Let $F(x)$ be an irreducible polynomial of degree $n$ over $\mathbb{F}_{q}$ and $\alpha$ be a root of it. Let $x^{n}-1$ factors as (1) and let $\phi_{s, i}(x)$ be as in (14). Then $F(x)$ is a $N_{k}$-polynomial over $\mathbb{F}_{q}$ if and only if, there is $j, 1 \leq j \leq u_{k}$, such that

$$
L_{\phi_{k, j}}(\alpha)=0
$$

and also

$$
L_{\phi_{s, i}}(\alpha) \neq 0
$$

for each $s, k<s<n$, and $1 \leq i \leq u_{s}$, where $u_{s}$ is the number of all $s$ degree polynomials dividing $x^{n}-1$ and $L_{\phi_{s, i}}(x)$ is the linearized polynomial defined by

$$
L_{\phi_{s, i}}(x)=\sum_{v=0}^{n-s} t_{i v} x^{q^{v}} \text { if } \phi_{s, i}(x)=\sum_{v=0}^{n-s} t_{i v} x^{v}
$$

The following theorem dose give us a recursive method for construction 1normal polynomials of higher degree from a given 1-normal polynomial over $\mathbb{F}_{2^{m}}$. A similar result, in the case 0-normal polynomials has been established by Kyuregyan in [7]. We use of an analogues technique, which used by Kyuregyan, in the proof of theorem

Theorem 4.2 Let $\delta \in \mathbb{F}_{2^{s}}^{*}$ and $F_{1}(x)=\sum_{i=0}^{n} c_{i} x^{i}$ be $N_{1}$-polynomial of degree the even integer $n$ over $\mathbb{F}_{2^{m}}$. Also let $\operatorname{Tr}_{2^{m} \mid 2}\left(\frac{c_{1} \delta}{c_{0}}\right)=1$ and $\operatorname{Tr}_{2^{m} \mid 2}\left(\frac{c_{n-1}}{\delta}\right)=1$. Then the sequence $\left(F_{u}(x)\right)_{u \geq 1}$, defined by

\begin{equation*}
F_{u+1}(x)=x^{n 2^{u-1}} F_{u}\left(x+\delta^{2} x^{-1}\right) \quad u \geq 1 \tag{12}
\end{equation*}
$$

is a sequence of $N_{1}$-polynomials of degree $2^{u} n$ over $\mathbb{F}_{2^{m}}$ for every $u \geq 1$.
Proof. Since $F_{1}(x)$ is an irreducible polynomial over $\mathbb{F}_{2^{m}}$, so Proposition 2.4 and the hypothesis imply that $F_{2}(x)$ is irreducible over $\mathbb{F}_{2^{m}}$.
Let $\alpha \in \mathbb{F}_{2^{m n}}$ be a root of $F_{1}(x)$. Since $F_{1}(x)$ is an $N_{1}$-polynomial of degree $n$ over $\mathbb{F}_{2^{m}}$ by the hypothesis, so $\alpha \in \mathbb{F}_{2^{m n}}$ is a 1-normal element over $\mathbb{F}_{2^{m}}$.

Let $n=n_{1} 2^{e}$, where $n_{1}$ is a non-negative integer with $\operatorname{gcd}\left(n_{1}, 2\right)=1$ and $e \geq 0$. For convenience we denote $2^{e}$ by $t$. Let $x^{n}+1$ has the following factorization in $\mathbb{F}_{2^{m}}[x]$ :

$$
\begin{equation*}
x^{n}+1=\left(x^{n_{1}}+1\right)^{t}=\left(\varphi_{1}(x) \varphi_{2}(x) \cdots \varphi_{r}(x)\right)^{t} \tag{13}
\end{equation*}
$$

where the polynomials $\varphi_{i}(x) \in \mathbb{F}_{q}[x]$ are the distinct irreducible factors of $x^{n_{1}}+$ 1. From (13), for each $1<s<n$, that, there is a $u_{s}>0$ such that, $R_{s, 1}(x)$, $R_{s, 2}(x), \cdots, R_{s, u_{s}}(x)$ are all of the $s$ degree polynomials dividing $x^{n}+1$, we can write $R_{s, i}(x)=\prod_{j=1}^{r} \varphi_{j}^{t_{i j}}(x)$, for each $1 \leq i \leq u_{s}, 0 \leq t_{i j} \leq t$. Let

$$
\begin{equation*}
\phi_{s, i}(x)=\frac{x^{n}+1}{R_{s, i}(x)}=\sum_{v=0}^{n-s} t_{i v} x^{v} \tag{14}
\end{equation*}
$$

for $1 \leq i \leq u_{s}$. Since $F_{1}(x)$ is an $N_{1}$-polynomial of degree $n$ over $\mathbb{F}_{2^{m}}$, so by Proposition 4.1, there is a $j, 1 \leq j \leq u_{1}$, such that

$$
\begin{equation*}
L_{\phi_{1, j}}(\alpha)=0 \tag{15}
\end{equation*}
$$

and also

$$
\begin{equation*}
L_{\phi_{s, i}}(\alpha) \neq 0 \tag{16}
\end{equation*}
$$

for each $1<s<n$, which there is a $u_{s}>0$ such that, $R_{s, 1}(x), R_{s, 2}(x), \cdots$, $R_{s, u_{s}}(x)$ be all of the $s$ degree polynomials dividing $x^{n}+1$, and $1 \leq i \leq u_{s}$.

Now, we proceed by proving that $F_{u+1}(x)$ is a 1-normal polynomial. Obviously, by Proposition 2.4 and the hypothesis, $F_{u+1}(x)$ is irreducible over $\mathbb{F}_{2^{m}}$. Let $\alpha_{u+1}$ be a root of $F_{u+1}(x)$. Note that by (13), the polynomial $x^{2^{u} n}+1$ has the following factorization in $\mathbb{F}_{2^{m}}[x]$ :

$$
\begin{equation*}
x^{2^{u} n}+1=\left(\varphi_{1}(x) \cdot \varphi_{2}(x) \cdots \cdots \varphi_{r}(x)\right)^{2^{u} t} \tag{17}
\end{equation*}
$$

where $\varphi_{j}(x) \in \mathbb{F}_{2^{m}}[x]$ are distinct irreducible factors of $x^{n_{1}}+1$.
For each $1<s^{\prime}<2^{u} n$, let there is a $u_{s^{\prime}}^{\prime}>0$ such that, $R_{s^{\prime}, 1}^{\prime}(x), R_{s^{\prime}, 2}^{\prime}(x)$, $\cdots, R_{s, u_{s^{\prime}}^{\prime}}^{\prime}(x)$ be all of the $s^{\prime}$ degree polynomials dividing $x^{2^{u} n}+1$. So, from (17) we can write $R_{s^{\prime}, i^{\prime}}^{\prime}(x)=\prod_{j=1}^{r} \varphi_{j}{ }_{t_{i^{\prime} j}^{\prime}}^{\prime}(x)$, for each $1 \leq i^{\prime} \leq u_{s^{\prime}}^{\prime}, 0 \leq t_{i^{\prime} j}^{\prime} \leq 2^{u} t$. Let

$$
\begin{equation*}
H_{s^{\prime}, i^{\prime}}^{\prime}(x)=\frac{x^{2^{u} n}+1}{R_{s^{\prime}, i^{\prime}}^{\prime}(x)} \tag{18}
\end{equation*}
$$

for $1 \leq i^{\prime} \leq u_{s^{\prime}}^{\prime}$. By Proposition 4.1, $F_{u+1}(x)$ is an $N_{1}$-polynomial of degree $2^{u} n$ over $\mathbb{F}_{2^{m}}$ if and only if, there is a $j, 1 \leq j \leq u_{1}^{\prime}$, such that

$$
L_{H_{1, j}^{\prime}}\left(\alpha_{u+1}\right)=0
$$

and also

$$
L_{H_{s^{\prime}, i^{\prime}}^{\prime}}^{\prime}\left(\alpha_{u+1}\right) \neq 0
$$

for each $1<s^{\prime}<2^{u} n$, which there is a $u_{s^{\prime}}^{\prime}>0$ such that, $R_{s^{\prime}, 1}^{\prime}(x), R_{s^{\prime}, 2}^{\prime}(x), \cdots$, $R_{s, u_{s^{\prime}}^{\prime}}^{\prime}(x)$ be all of the $s^{\prime}$ degree polynomials dividing $x^{2^{u} n}+1$, and $1 \leq i^{\prime} \leq u_{s^{\prime}}^{\prime}$.

Let $H_{s, i}(x)=\frac{x^{2^{u} n}+1}{R_{s, i}(x)}$, for each $1<s<n$, and $1 \leq i \leq u_{s}$, satisfied in the stated conditions. We note that by (14)

$$
\begin{align*}
H_{s, i}(x) & =\frac{x^{2^{u} n}+1}{R_{s, i}(x)} \\
& =\frac{\left(x^{n}+1\right)\left(\sum_{j=0}^{2^{u}-1} x^{j n}\right)}{R_{s, i}(x)} \\
& =\left(\sum_{j=0}^{2^{u}-1} x^{j n}\right) \phi_{s, i}(x) \\
& =\sum_{v=0}^{n-s} t_{i v}\left(\sum_{j=0}^{2^{u}-1} x^{j n+v}\right) \tag{19}
\end{align*}
$$

It follows that

$$
\begin{equation*}
L_{H_{s, i}}\left(\alpha_{u+1}\right)=\sum_{v=0}^{n-s} t_{i v}\left(\sum_{j=0}^{2^{u}-1} \alpha_{u+1}^{2^{j m n}}\right)^{2^{m v}} \tag{20}
\end{equation*}
$$

From (121), if $\alpha_{y+1}$ is a root of $F_{y+1}(x)$, then $\alpha_{y+1}+\delta^{2} \alpha_{y+1}^{-1}$ is a root of $F_{y}(x)$, and therefore, it may assume that

$$
\begin{equation*}
\alpha_{y+1}+\delta^{2} \alpha_{y+1}^{-1}=\alpha_{y} \tag{21}
\end{equation*}
$$

for all $1 \leq y \leq u$, where $\alpha_{1}=\alpha$.
Now, by (21) and observing that $F_{y}(x)$ is an irreducible polynomial of degree $2^{y-1} n$ over $\mathbb{F}_{2^{m}}$, we obtain

$$
\begin{equation*}
\alpha_{y+1}^{2^{2^{y-1} m n}}+\delta^{2} \alpha_{y+1}^{-2^{2^{y-1} m n}}=\alpha_{y}^{2^{2^{y-1} m n}}=\alpha_{y} \tag{22}
\end{equation*}
$$

So from (21) and (22) we have

$$
\left(\alpha_{y+1}^{2^{2^{y-1} m n}}+\alpha_{y+1}\right)+\delta^{2}\left(\alpha_{y+1}^{-2^{2^{y-1} m n}}+\alpha_{y+1}^{-1}\right)=0
$$

Or

$$
\begin{equation*}
\left(\alpha_{y+1}^{2^{y-1} m n}+\alpha_{y+1}\right)\left(1+\frac{\delta^{2}}{\alpha_{y+1}^{2^{2 y-1} m n}+1}\right)=0 \tag{23}
\end{equation*}
$$

Also observing that $F_{y+1}(x)$ is an irreducible polynomial of degree $2^{y} n$ over $\mathbb{F}_{2^{m}}$, we have $\alpha_{y+1}^{2^{2^{y-1} m n}}+\alpha_{y+1} \neq 0$, and so $\alpha_{y+1}^{2^{2^{y-1} m n}}=\delta^{2} \alpha_{y+1}^{-1}$. It follows that

$$
\begin{equation*}
\alpha_{y+1}^{2^{2^{y-1} m n}}+\alpha_{y+1}=\delta^{2} \alpha_{y+1}^{-1}+\alpha_{y+1}=\alpha_{y} \tag{24}
\end{equation*}
$$

for each $y, 1 \leq y \leq u$. Hence by (24) we obtain

$$
\begin{aligned}
\sum_{j=0}^{2^{u}-1} \alpha_{u+1}^{2^{j m n}} & =\sum_{j=0}^{2^{u-1}-1}\left(\alpha_{u+1}^{2^{2^{u-1} m n}}+\alpha_{u+1}\right)^{2^{j m n}}=\sum_{j=0}^{2^{u-1}-1} \alpha_{u}^{2^{j m n}} \\
& =\cdots=\sum_{j=0}^{2^{u-z}-1} \alpha_{u-z+1}^{2^{j m n}}=\sum_{j=0}^{2^{u-z}-1}\left(\alpha_{u-z+1}^{2^{2^{u-z-1}}{ }_{m n}}+\alpha_{u-z+1}\right)^{2^{j m n}} \\
& =\sum_{j=0}^{2^{u-z}-1} \alpha_{u-z}^{2^{j m n}}=\cdots=\sum_{j=0}^{1} \alpha_{2}^{2^{j m n}}=\alpha_{1}=\alpha
\end{aligned}
$$

Therefore, $\sum_{j=0}^{2^{u}-1} \alpha_{u+1}^{2^{j m n}}=\alpha$. By substituting $\alpha$ for $\sum_{j=0}^{2^{u}-1} \alpha_{u+1}^{2^{j m n}}$ in (20), we get

$$
\begin{equation*}
L_{H_{s, i}}\left(\alpha_{u+1}\right)=\sum_{v=0}^{n-s} t_{i v} \alpha^{2^{m v}}=L_{\phi_{s, i}}(\alpha) \tag{25}
\end{equation*}
$$

for each $s, 1 \leq s<n$, which there is a $u_{s}>0$ such that, $R_{s, 1}(x), R_{s, 2}(x), \cdots$, $R_{s, u_{s}}(x)$ are all of the $s$ degree polynomials dividing $x^{n}+1$.

So, by (15) and (25), there is a $j, 1<j<u_{1}^{\prime}=u_{1}$, such that

$$
L_{H_{1, j}^{\prime}}\left(\alpha_{u+1}\right)=L_{H_{1, j}}\left(\alpha_{u+1}\right)=L_{\phi_{1, j}}(\alpha)=0
$$

Now we clime that, for each $1<s^{\prime}<2^{u} n$, which there is a $u_{s^{\prime}}^{\prime}>0$, such that, $R_{s^{\prime}, 1}^{\prime}(x), R_{s^{\prime}, 2}^{\prime}(x), \cdots, R_{s, u_{s^{\prime}}^{\prime}}^{\prime}(x)$ be all of the $s^{\prime}$ degree polynomials dividing $x^{2^{u} n}+1$, and $1 \leq i^{\prime} \leq u_{s^{\prime}}^{\prime}$ we have

$$
L_{H_{s^{\prime}, i^{\prime}}^{\prime}}\left(\alpha_{u+1}\right) \neq 0
$$

Setting $t_{i^{\prime} j}^{\prime}=t$ for each $t_{i^{\prime} j}^{\prime}>t$ in $R_{s^{\prime}, i^{\prime}}^{\prime}(x)=\prod_{j=1}^{r} \varphi_{j}^{t_{i^{\prime} j}^{\prime}}(x)$, we get
$\left(R_{s^{\prime}, i^{\prime}}^{\prime}(x)\right)_{\left.\right|_{t_{i^{\prime} j}^{\prime}=t f o r t_{i^{\prime} j}^{\prime}>t} ^{\prime}}=\prod_{j=1, t_{i^{\prime} j}^{\prime}=t \text { ort }_{i^{\prime} j}^{\prime}>t}^{r} \varphi_{j} t_{j}^{t_{i^{\prime} j}^{\prime}}(x)=\prod_{j=1}^{r} \varphi_{j}^{t_{i_{0} j}}(x)=R_{s_{0}, i_{0}}(x)$,
for some $1<s_{0}<n$ and $1 \leq i_{0} \leq u_{s_{0}}$. Hence, $R_{s_{0}, i_{0}}(x)$ divide $R_{s^{\prime}, i^{\prime}}^{\prime}(x)$ and so $H_{s^{\prime}, i^{\prime}}^{\prime}(x)$ divide $H_{s_{0}, i_{0}}(x)$. Consequently, $L_{H_{s^{\prime}, i^{\prime}}^{\prime}}^{\prime}\left(\alpha_{u+1}\right)$ divide $L_{H_{s_{0}, i_{0}}}\left(\alpha_{u+1}\right)$. Therefore, by (16) and (25), the clime is true. The proof is completed.
