# ON METRICS DEFINED BY LENGTH SPECTRA ON TEICHMÜLLER SPACES OF SURFACES WITH BOUNDARY

#### Abstract

We prove that the length spectrum metric and the arclength spectrum metric are almost-isometric on the $\epsilon_{0}$-relative part of Teichmüller spaces of surfaces with boundary.


Keywords: Teichmüller space; length spectrum metric; arc-length spectrum metric.

## 1. Introduction

Let $S=S_{g, p, b}$ be a connected oriented surface of genus $g \geq 0$ with $p \geq 0$ punctures and $b \geq 0$ boundary components. The boundary of $S$ is denoted by $\partial S$. The Euler characteristic of $S$ is $\mathcal{X}(S)=2-2 g-p-b$. In this paper, we always assume that $g \geq 0, p \geq 0, b \geq 1$ and $\mathcal{X}(S)<0$.

In the following, all hyperbolic metrics on $S$ are assumed to be complete and totally geodesic on the boundary components. By the assumption that $\mathcal{X}(S)<0$, there always exist a hyperbolic metric on $S$.

A marked hyperbolic metric $(X, f)$ is a hyperbolic metric $X$ on $S$ equipped with an orientation-preserving homeomorphism $f: S \rightarrow X$, where $f$ maps each component of $\partial S$ to a geodesic boundary of $X$ and maps punctures to cusps. The reduced Teichmüller space of $S$, denoted by $\mathcal{T}(S)$, is the set of equivalence classes of marked hyperbolic metrics on $S$, where two markings $\left(X_{1}, f_{1}\right)$ and $\left(X_{2}, f_{2}\right)$ are equivalent if there is an isometry $h: X_{1} \rightarrow X_{2}$ homotopic to $f_{2} \circ f_{1}^{-1}$. We should point out that, in this reduced theory, homotopies do not necessarily fix $\partial S$ pointwise. The notion of a reduced Teichmüller space was introduced by Earle [8, 9, where he defined the space by using quasiconformal deformations of Fuchsian groups (of the second kind).

Since all Teichmüller spaces that we consider are reduced, we shall omit the word "reduced" in this paper. For the sake of simplicity, we shall denote a marked hyperbolic surface $(X, f)$ or its equivalence class in $\mathcal{T}(S)$ by $X$, without explicit reference to the marking or to the equivalence relation.

There are several natural metrics on Teichmüller space, e.g. the classical Teichmüller metric and the Weil-Petersson metric. In this paper, we will study the length spectrum metric and the arc-length spectrum metric. The length spectrum metric was first studied by Sorvali [24, 25], which can also be considered as the symmetrization of an asymmetric Finsler metric defined

[^0]by Thurston [27]. The arc-length spectrum metric is new, which is defined only on Teichmüller spaces of surfaces with boundary. Both of the two above metrics are defined by using hyperbolic (or geodesic) length functions. There is no doubt that hyperbolic length is one of the most fundamental tools in Teichmüller theory. We note that by recent works of Danciger, Guéritaud and Kassel [7], deformations of hyperbolic surfaces with boundary is related to Margulis spacetimes in Lorentz geometry.
1.1. Metrics defined by length spectra. To provide concrete definitions and state our results, we fix some terminology and notation.

A simple closed curve on $S$ is said to be peripheral if it is isotopic to a puncture. It is said to be essential if it is neither peripheral nor isotopic to a point. It should be noticed that an essential closed curve may be isotopic to a boundary component. We denote by $\mathcal{C}(S)$ the set of homotopy classes of essential simple closed curves on $S$.

An arc on $S$ is the homeomorphic image of a closed interval which is properly embedded in $S$, that is, the interior of the arc is in the interior of $S$ and the endpoints of the arc lie on $\partial S$. An arc is said to be essential if it is not isotopic to a subset of $\partial S$. All homotopies of arcs that we consider here are relative to $\partial S$. However, we don't require homotopies to fix $\partial S$ pointwise. Let $\mathcal{B}(S)$ be the set of homotopy classes of essential arcs on $S$.

For any $\alpha \in \mathcal{B}(S) \cup \mathcal{C}(S)$ and $X \in \mathcal{T}(S)$, we denote by $\ell_{X}(\alpha)$ the hyperbolic length of $\alpha$, that is, the length of the geodesic representation of $\alpha$ under the hyperbolic metric $X$.

For surfaces without boundary, Thurston [27] defined the following asymmetric metric:

$$
d(X, Y)=\log \sup _{\alpha \in \mathcal{C}(S)} \frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)}
$$

For surfaces with boundary, the following asymmetric metric is a natural generalization of Thurston's formula [16, 3] :

$$
\bar{d}(X, Y)=\log \sup _{\alpha \in \mathcal{C}(S) \cup \mathcal{B}(S)} \frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)} .
$$

Both of the above two metrics satisfy the separation axiom and triangle inequality, but none of them satisfies the symmetric condition.

Remark 1.1. For surfaces with boundary, there exist (see [22]) distinct hyperbolic structures $X$ and $Y$ on $S$ such that for any element $\alpha \in \mathcal{C}(S)$, $\frac{l_{X}(\alpha)}{l_{Y}(\alpha)}<1$. This implies that

$$
\log \sup _{\alpha \in \mathcal{C}(S)} \frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)} \leq 0
$$

As a result, it's necessary to consider the union of closed curves and arcs in the definition of $\bar{d}$.

Definition 1.2. The length spectrum metric $d_{L}$ on $\mathcal{T}(S)$ is defined by

$$
d_{L}(X, Y)=\log \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}, \frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)}\right\}
$$

Definition 1.3. The arc-length spectrum metric $\delta_{L}$ on $\mathcal{T}(S)$ is defined by

$$
\begin{aligned}
\delta_{L}(X, Y) & =\max \{\bar{d}(X, Y), \bar{d}(Y, X)\} \\
& =\log \sup _{\alpha \in \mathcal{C}(S) \cup \mathcal{B}(S)}\left\{\frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}, \frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)}\right\} .
\end{aligned}
$$

The fact that $d_{L}$ is a metric on $\mathcal{T}(S)$ was proved in 24, 13]. It is obvious that $d_{L} \leq \delta_{L}$. When $b=0$, since $\mathcal{B}(S)$ is empty, $d_{L}=\delta_{L}$. For more works about the length spectrum metric, one refers to [6, 11, 12, 13, 14, 15, 16, 21, 23.
1.2. Main theorems. The aim of this paper is to compare the length spectrum metric with the arc-length spectrum on a large subset of $\mathcal{T}(S)$.

Definition 1.4. Given $\epsilon_{0}>0$, the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$ is the subset of $\mathcal{T}(S)$ consisting of hyperbolic metrics with lengths of all boundary components bounded above by $\epsilon_{0}$.

In this paper we prove:
Theorem 1.5. There is a constant $C$ depending on $\epsilon_{0}$ such that

$$
d_{L}(X, Y) \leq \delta_{L}(X, Y) \leq d_{L}(X, Y)+C
$$

for any $X, Y$ in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.
The left-hand side inequality follows by definition. The right-hand side inequality is equivalent to the following result:

Theorem 1.6. There exists a positive constant $K$ depending on $\epsilon_{0}$ such that

$$
\sup _{\beta \in \mathcal{C}(S) \cup \mathcal{B}(S)}\left\{\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)}, \frac{\ell_{X_{2}}(\beta)}{\ell_{X_{1}}(\beta)}\right\} \leq K \cdot \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{2}}(\alpha)}{\ell_{X_{1}}(\alpha)}\right\}
$$

for any $X_{1}, X_{2}$ in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.
Remark 1.7. Recall that a map $f: M \rightarrow N$ between metric spaces is called a $(\lambda, C)$ quasi-isometry (with given constants $C \geq 0$ and $\lambda \geq 1$ ) if

$$
\frac{1}{\lambda} d_{M}(x, y)-C \leq d_{N}(f(x), f(y)) \leq \lambda d_{M}(x, y)+C
$$

for all $x, y \in M$, and the $C$-neighborhood of $f(M)$ in $N$ is all of $N$. An $(1, C)$ quasi-isometry is called an almost-isometry.

Theorem 1.5 implies that the length spectrum metric and the arc-length spectrum metric are almost-isometric on the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.

For $0<\epsilon<\epsilon_{0}$, the $\epsilon$-thick part of $\mathcal{T}(S)$ is the subset of $\mathcal{T}(S)$ consisting of hyperbolic metrics $X$ with hyperbolic length $\ell_{X}(\alpha)$ not less than $\epsilon$ for all $\alpha \in \mathcal{C}(S)$. The intersection of the $\epsilon$-thick part and the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$ is called the $\epsilon_{0}$-relative $\epsilon$-thick part of $\mathcal{T}(S)$. We can deduce from [16, Theorem 3.6] that the length spectrum metric and the arc-length spectrum metric are almost-isometric on the $\epsilon_{0}$-relative $\epsilon$-thick part of $\mathcal{T}(S)$. In fact,
by [16, Proposition 3.5], there exists a positive constant $K_{0}$ depending on $\epsilon$ and $\epsilon_{0}$ such that, for any $X_{1}, X_{2}$ in the $\epsilon$-thick $\epsilon_{0}$-relative part of $\mathcal{T}(S)$,

$$
\begin{equation*}
\sup _{\beta \in \mathcal{C}(S) \cup \mathcal{B}(S)}\left\{\frac{\ell_{X_{2}}(\beta)}{\ell_{X_{1}}(\beta)}\right\} \leq K_{0} \cdot \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X_{2}}(\alpha)}{\ell_{X_{1}}(\alpha)}\right\} . \tag{1}
\end{equation*}
$$

However, the above inequality does not hold on the whole $\epsilon_{0}$-relative part of $\mathcal{T}(S)$. A counter example is constructed at the end of Section 4 (Example 4.8). As a result, Theorem 1.5 can be seen as an extension of 16, Theorem 3.6].

Remark 1.8. We should mention that, in the statement of [16, Proposition 3.5] the constant $K_{0}$ depends on $\epsilon, \epsilon_{0}$ and the topology of $S$. But during the proof of (1), the constant $K_{0}$ only depend on $\epsilon$ and $\epsilon_{0}$. Similarly, the constants $C$ and $K$ in Theorem 1.5 and Theorem 1.6 are independent of the topology of the surface $S$.
1.3. Outline of the paper. In Section 2 we will recall some elementary results in hyperbolic geometry that we need later. The proof of Theorem 1.6 will be given in Section 3 and Section 4. In Section 3, we deal with the case where the constant $\epsilon_{0}$ is sufficiently small. In Section 4, we use the results in Section 3 to prove Theorem 1.6 in the general case.

To prove Theorem 1.6, we will use the technique of "replacing an arc by a loop" to show that the length ratio of an arc can be controlled by the length ratio of some appropriated simple closed curve. Such an idea was initiated by Minsky [20] and it has many applications (see, e.g., Rafi [6]).

We will discuss related results on moduli spaces and on surfaces of infinite type in Section 5.

## 2. Preliminaries

2.1. Formulae for right-angle pentagon and hexagon. For a rightangled pentagon on the hyperbolic plane with consecutive side lengths $a, b$, $\alpha, c$ and $\beta$, as in Figure 1, we have

$$
\begin{equation*}
\cosh c=\sinh a \sinh b \tag{2}
\end{equation*}
$$

We also need the following formula for a right-angled hexagon with consecutive side lengths $a, \gamma, b, \alpha, c$ and $\beta$, as in Figure 2 :

$$
\begin{equation*}
\cosh c+\cosh a \cosh b=\sinh a \sinh b \cosh \gamma \tag{3}
\end{equation*}
$$

The inverse hyperbolic sine function and the inverse hyperbolic cosine function are given by

$$
\begin{equation*}
\sinh ^{-1} x=\ln \left(x+\sqrt{x^{2}+1}\right) \tag{4}
\end{equation*}
$$

and

$$
\begin{equation*}
\cosh ^{-1} x=\ln \left(x+\sqrt{x^{2}-1}\right), \text { for } x \geq 1 \tag{5}
\end{equation*}
$$

Let $f$ and $g$ be any two functions defined on a set $U$. We call $f \asymp g$ if there exists a positive constant $C$ such that

$$
C^{-1} \cdot f(\tau) \leq g(\tau) \leq C \cdot f(\tau), \forall \tau \in U
$$

Usually the constant $C$ will depend on the choice of $U$.
Given $\epsilon_{0}>0$, we have $x \asymp \sinh x$ if $x \leq \epsilon_{0}$, and $\sinh x \asymp e^{x}$ if $x \geq \epsilon_{0}$. Here it is obvious that the multiplicative constants for $\asymp$ depend on $\epsilon_{0}$.
2.2. Regular annulus. Let $X$ be a hyperbolic structure on $S$ and denote the distance between two distinct points $p$ and $q$ on $X$ by $d_{X}(p, q)$. The distance between two subsets $S_{1}$ and $S_{2}$ of $X$ is defined by

$$
d_{X}\left(S_{1}, S_{2}\right)=\inf _{x_{1} \in S_{1}, x_{2} \in S_{2}} d_{X}\left(x_{1}, x_{2}\right)
$$

Let $A$ be an annulus embedded in $S$. Denote the two boundaries of $A$ by $\gamma$ and $\gamma^{\prime}$. The annulus $A$ is said to be regular if there is a constant $w>0$ such that

$$
d_{X}\left(p, \gamma^{\prime}\right)=d_{X}\left(p^{\prime}, \gamma\right)=w, \forall p \in \gamma, p^{\prime} \in \gamma^{\prime}
$$

For a positive number $\delta$ and a simple closed geodesic $\gamma$ on $X$ (either in the interior of $X$ or be a boundary component of $X$ ), we denote the $\delta$-neighborhood of $\gamma$ by

$$
A_{\delta}(\gamma)=\left\{x \in X \mid d_{X}(x, \gamma)<\delta\right\}
$$

By the Collar Lemma (ref. [5]), $A_{\delta}(\gamma)$ is a regular annulus if

$$
\delta \leq \sinh ^{-1}\left(\frac{1}{\sinh \frac{\ell_{X}(\gamma)}{2}}\right)
$$

Suppose that $A_{\delta}(\gamma)$ is a regular annulus. If $\gamma$ is in the interior of $X$, then the width of $A_{\delta}(\gamma)$ is equal to $2 \delta$ and $\gamma$ lies in the middle of $A_{\delta}(\gamma)$. If $\gamma$ is a boundary component of $S$, then the width of $A_{\delta}(\gamma)$ is equal to $\delta$. In both cases, we will say that $A_{\delta}(\gamma)$ is a regular annulus around $\gamma$.

We define the auxiliary function $\eta(x)$ by

$$
\eta(x):=\sinh ^{-1}\left(\frac{1}{\sinh \frac{x}{2}}\right)=\frac{1}{2} \ln \frac{\cosh (x / 2)+1}{\cosh (x / 2)-1} .
$$

By the Collar Lemma again, for any two distinct simple closed geodesics $\gamma_{1}$ and $\gamma_{2}$ on $X$, the regular annuli $A_{\eta\left(\ell_{X}\left(\gamma_{1}\right)\right)}\left(\gamma_{1}\right)$ and $A_{\eta\left(\ell_{X}\left(\gamma_{2}\right)\right)}\left(\gamma_{2}\right)$ are disjoint.

Throughout this paper, we only consider regular annuli as collar neighborhoods of boundary components of $X$. In this case, as we show in Figure 3 , the geodesic $\gamma$ is a boundary component of $X$. The regular annulus contains $\gamma$ and $\gamma^{\prime}$ as boundary components. We call $\gamma^{\prime}$ the inner boundary of $A_{\delta}(\gamma)$ and denote the length of $\gamma^{\prime}$ on $X$ by $\ell_{X}\left(\gamma^{\prime}\right)$ (even through $\gamma^{\prime}$ is not a geodesic, now and later, we will use the notation $\ell$ to denote the length of an inner boundary when there is no cause of confusion). The relation between $\ell_{X}(\gamma)$ and $\ell_{X}\left(\gamma^{\prime}\right)$ is given by (see [6, 19])

$$
\begin{equation*}
\ell_{X}\left(\gamma^{\prime}\right)=\ell_{X}(\gamma) \cdot \cosh d_{X}\left(\gamma, \gamma^{\prime}\right) \tag{6}
\end{equation*}
$$

## 3. Proof of Theorem 1.6: the case where $\epsilon_{0}$ IS sufficiently SMALL

The proof of Theorem 1.6 is separated into two steps. Recall that $\epsilon_{0}$ is an upper bound for the lengths of all boundary components of $S$. In this section we will prove Theorem 1.6 in the case where $\epsilon_{0}$ is sufficiently small. We will consider the general case in next section.

We assume that $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$. Here the constant $e^{-1} \ln (1+\sqrt{2})$ is chosen such that the width of some regular annulus neighborhood around a boundary component of $S$ has an explicit lower bound. Let $\epsilon_{0}^{\prime}=\ln (1+\sqrt{2})$. Note that $\epsilon_{0}<\epsilon_{0}^{\prime}<2$. Let $X_{1}$ and $X_{2}$ be two hyperbolic metrics in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$. We fix an essential arc $\beta \in \mathcal{B}(S)$. Denote the boundary curves where the two endpoints of $\beta$ lie by $\gamma$ and $\gamma^{\prime}$.

### 3.1. The case where $\gamma \neq \gamma^{\prime}$.

In this subsection, we consider the case where $\gamma$ and $\gamma^{\prime}$ are not the same boundary component of $S$.

There is a unique (isotopy class of) simple closed curve $\alpha$ which is homotopic to the boundary of a regular neighborhood of $\beta \cup \gamma \cup \gamma^{\prime}$. To simplify notation, for a given hyperbolic metric on $S$, we will denote by $\alpha, \beta, \gamma$ and $\gamma^{\prime}$ the geodesic representations of the isotopy classes of $\alpha, \beta, \gamma$ and $\gamma^{\prime}$, if no confusion arises.

Lemma 3.1. For $i=1,2$, we can take a regular annulus $A_{i}$ around $\gamma$ and a regular annulus $A_{i}^{\prime}$ around $\gamma^{\prime}$ on $X_{i}$ satisfying the following conditions:
(1) Denote the inner boundary of $A_{i}$ by $C_{i}$ and the inner boundary of $A_{i}^{\prime}$ by $C_{i}^{\prime}$, then $\ell_{X_{i}}\left(C_{i}\right)=\ell_{X_{i}}\left(C_{i}^{\prime}\right)=\epsilon_{0}^{\prime}$.
(2) The inner boundaries $C_{i}$ and $C_{i}^{\prime}$ are disjoint.

Proof. Denote by $X=X_{1}$. As we showed in Section 2, by the Collar Lemma, there exist two disjoint regular annuli $A_{\eta\left(\ell_{X}(\gamma)\right)}(\gamma)$ and $A_{\eta\left(\ell_{X}\left(\gamma^{\prime}\right)\right)}\left(\gamma^{\prime}\right)$. Let $\Delta_{1}$ and $\Delta_{1}^{\prime}$ be the inner boundaries of $A_{\eta\left(\ell_{X}(\gamma)\right)}(\gamma)$ and $A_{\eta\left(\ell_{X}\left(\gamma^{\prime}\right)\right)}\left(\gamma^{\prime}\right)$, respectively. By (6), the length of $\Delta_{1}$ satisfies

$$
\begin{aligned}
\ell_{X}\left(\Delta_{1}\right) & =\ell_{X}(\gamma) \cosh \left(\eta\left(\ell_{X}(\gamma)\right)\right) \\
& =\ell_{X}(\gamma) \frac{e^{\ell_{X}(\gamma)}+1}{e^{\ell_{X}(\gamma)}-1}
\end{aligned}
$$

For $x>0$, we consider the function

$$
f_{1}(x)=x\left(e^{x}+1\right) /\left(e^{x}-1\right)
$$

It's easy to see that $f_{1}^{\prime}(x)>0$ for all $x>0$ and $\lim _{x \rightarrow 0} f_{1}(x)=2$. It follows that $f_{1}(x)>2$ for all $x>0$. In particular, we have

$$
\ell_{X}\left(\Delta_{1}\right)>2>\epsilon_{0}^{\prime}
$$

As a result, we can choose a regular annulus $A_{1} \subset A_{\eta\left(\ell_{X}(\gamma)\right)}(\gamma)$ around $\gamma$ with inner boundary $C_{1}$ such that $\ell_{X}\left(C_{1}\right)=\epsilon_{0}^{\prime}$. By the same argument, we can choose $C_{1}^{\prime}$ to be the inner boundary of a regular annulus that is contained in $A_{\eta\left(\ell_{X}\left(\gamma^{\prime}\right)\right)}\left(\gamma^{\prime}\right)$. Since $A_{\eta\left(\ell_{X}(\gamma)\right)}(\gamma)$ and $A_{\eta\left(\ell_{X}\left(\gamma^{\prime}\right)\right)}\left(\gamma^{\prime}\right)$ are disjoint, $C_{1}$ and $C_{1}^{\prime}$ are disjoint.

By the same argument, we can choose $C_{2}$ and $C_{2}^{\prime}$ on $X_{2}$ that are contained in disjoint regular annuli.

It follows from Lemma 3.1 that $C_{1}$ and $C_{1}^{\prime}$ separate $\beta$ into three parts. Let $\beta_{1}^{A}=\beta \bigcap A_{1}$ and $\beta_{1}^{\prime A}=\beta \bigcap A_{1}^{\prime}$ be the two terminal parts of $\beta$ and $\beta_{1}^{Q}=\beta \backslash\left\{\beta_{1}^{A} \bigcup \beta_{1}^{\prime A}\right\}$ be the middle part of $\beta$. We use similar notations $C_{2}$, $C_{2}^{\prime}, \beta_{2}^{A}, \beta_{2}^{\prime A}$ and $\beta_{2}^{Q}$ for the hyperbolic structure $X_{2}$. Figure 4 shows the above notations.

The key point of our argument is to prove that there exists a positive constant $K_{1}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)} \leq K_{1} \cdot \max \left\{1, \frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{2}}(\gamma)}{\ell_{X_{1}}(\gamma)}, \frac{\ell_{X_{2}}\left(\gamma^{\prime}\right)}{\ell_{X_{1}}\left(\gamma^{\prime}\right)}\right\} \tag{7}
\end{equation*}
$$

Let us explain more explicitly. As it is shown in Figure 5, by cutting the pair of pants along three geodesic arcs, each of which is perpendicular to a pair of boundary components, we have two right-angled hexagons. By symmetry, we only need to consider one of them.

For the sake of simplicity, we denote $\ell_{X_{i}}$ by $\ell_{i}$, for $i=1,2$. Let $a_{i}=$ $\ell_{i}(\alpha) / 2, b_{i}=\ell_{i}(\beta), c_{i}=\ell_{i}(\gamma) / 2, c_{i}^{\prime}=\ell_{i}\left(\gamma^{\prime}\right) / 2, d_{i}=\ell_{i}\left(\beta_{i}^{A}\right), d_{i}^{\prime}=\ell_{i}\left(\beta_{i}^{\prime A}\right)$, $b_{i}^{\prime}=\ell_{i}\left(\beta_{i}^{Q}\right)$, for $i=1,2$. And let $c_{0}^{\prime}=\epsilon_{0}^{\prime} / 2$. Then $b_{i}=d_{i}+b_{i}^{\prime}+d_{i}^{\prime}$, for $i=1,2$.

With the above notations, we have

$$
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)}=\frac{b_{1}}{b_{2}}=\frac{b_{1}^{\prime}+d_{1}+d_{1}^{\prime}}{b_{2}^{\prime}+d_{2}+d_{2}^{\prime}} \leq \max \left\{\frac{b_{1}^{\prime}}{b_{2}^{\prime}}, \frac{d_{1}}{d_{2}}, \frac{d_{1}^{\prime}}{d_{2}^{\prime}}\right\}
$$

To prove (7), it suffices to control $b_{1}^{\prime} / b_{2}^{\prime}, d_{1} / d_{2}$ and $d_{1}^{\prime} / d_{2}^{\prime}$ by the ratios of the lengths of $\alpha, \gamma$ and $\gamma^{\prime}$. This will be done in Lemma 3.3 and Lemma 3.6 below. As soon as Lemma 3.3 and Lemma 3.6 are proved, (7) is a direct corollary, see Proposition 3.8.

Example 3.2 (An exceptional case). If $S=S_{0,1,2}$, that is, the surface is homeomorphic to a pair of pants with one puncture and two boundary components, then $a_{i}=\ell_{i}(\alpha) / 2=0$. In this case, the ratio $\frac{a_{1}}{a_{2}}$ in the following discussions would not make sense.

To avoid this difficulty, we can take two sequences of pairs of pants $\left(X_{1, n}\right)_{n=1}^{\infty},\left(X_{2, n}\right)_{n=1}^{\infty}$ (we denote their boundary components by $\alpha, \gamma, \gamma^{\prime}$ as above) such that

$$
\ell_{X_{i, n}}(\gamma)=\ell_{X_{i}}(\gamma), \ell_{X_{i, n}}\left(\gamma^{\prime}\right)=\ell_{X_{i}}\left(\gamma^{\prime}\right), \ell_{X_{i, n}}(\alpha)=\frac{1}{n}, i=1,2
$$

Since the constants in the following lemmas are independent of $n$, by taking a limit as $n$ goes to infinity, we will get the same results (all the following lemmas are true in such a special case if we set $\frac{0}{0}=1$ ).

Note that the same argument applies to $S=S_{0,2,1}$, that is, the surface is homeomorphic to a pair of pants with two punctures and one boundary component, which we will consider in Section 3.2.

By Example 3.2, we can assume that $a_{i}>0, i=1,2$. We first consider the ratio $b_{1}^{\prime} / b_{2}^{\prime}$.

Lemma 3.3. There exists a positive constant $K_{1}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq K_{1}^{\prime} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\} \tag{8}
\end{equation*}
$$

Proof. The proof of this lemma will use Lemma 3.4 and Lemma 3.5 below.
Lemma 3.4. There is a uniform positive lower bound for $b_{i}^{\prime}, i=1,2$.
Proof. Recall that the regular annulus $A_{\eta\left(\ell_{1}(\gamma)\right)}(\gamma)$ contains $C_{1}$ and the length of the inner boundary of $A_{\eta\left(\ell_{1}(\gamma)\right)}(\gamma)$ is greater than 2 . We can take another regular annulus around $\gamma$ which is isometrically embedded in $A_{\eta\left(\ell_{1}(\gamma)\right)}(\gamma)$ and which has a inner boundary, denoted by $\widetilde{C}_{1}$, with length equal to 2. Denote by $e_{1}$ the distance between $\gamma$ and $\widetilde{C}_{1}$. It can be seen from Figure 6 that $b_{1}^{\prime} \geq\left(e_{1}-d_{1}\right)+\left(e_{1}^{\prime}-d_{1}^{\prime}\right)$.

It suffices to give a lower bound for $e_{1}-d_{1}$. By (6) and (5), we have

$$
e_{1}-d_{1}=\ln \frac{1 / c_{1}+\sqrt{\left(1 / c_{1}\right)^{2}-1}}{c_{0}^{\prime} / c_{1}+\sqrt{\left(c_{0}^{\prime} / c_{1}\right)^{2}-1}}
$$

where $c_{1}<\frac{\ln (1+\sqrt{2})}{2 e}$. Consider the function

$$
f_{2}(y)=\left(y+\sqrt{y^{2}-1}\right) /\left(c_{0}^{\prime} y+\sqrt{c_{0}^{\prime 2} y^{2}-1}\right), y>2 e / \ln (1+\sqrt{2})
$$



Figure 6. An example for $e_{i}$ and $e_{i}^{\prime}$, for $i=1,2$.

By the fact $f_{2}^{\prime}(y)<0$ and $y>2 e / \ln (1+\sqrt{2})$, we have

$$
e_{1}-d_{1}=f_{2}\left(1 / c_{1}\right) \geq f_{2}(2 e / \ln (1+\sqrt{2}))=4 / \ln (1+\sqrt{2})>0
$$

By the same argument we have $e_{1}^{\prime}-d_{1}^{\prime} \geq 4 / \ln (1+\sqrt{2})$. Let $M_{0}=8 / \ln (1+$ $\sqrt{2}$ ), then we have (the same estimation for $b_{2}^{\prime}$ )

$$
\begin{equation*}
b_{i}^{\prime} \geq M_{0}, \text { for } i=1,2 \tag{9}
\end{equation*}
$$

Next we will give a upper bound for the difference between $a_{i}$ and $b_{i}^{\prime}$, $i=1,2$.

Lemma 3.5. There is a constant $D_{1}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\left|a_{i}-b_{i}^{\prime}\right| \leq D_{1}, \quad i=1,2 \tag{10}
\end{equation*}
$$

Proof. The method used here is similar to that of [6].
Since $c_{1} \leq \epsilon_{0} / 2$ and $c_{1}^{\prime} \leq \epsilon_{0} / 2$, there exists a constant $k_{1}$ depending on $\epsilon_{0}$ such that

$$
c_{1}<\sinh c_{1}<k_{1} c_{1} \text { and } c_{1}^{\prime}<\sinh c_{1}^{\prime}<k_{1} c_{1}^{\prime} .
$$

By (6), we have

$$
c_{1} \cosh d_{1}=c_{1}^{\prime} \cosh d_{1}^{\prime}=c_{0}^{\prime}=\ln (1+\sqrt{2}) / 2
$$

Then we have

$$
\begin{aligned}
& \sinh c_{1} \cdot \sinh c_{1}^{\prime} \cdot \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) \\
& >c_{1} \cdot c_{1}^{\prime} \cdot \frac{e^{b_{1}^{\prime}+d_{1}+d_{1}^{\prime}}}{2}=\frac{e^{b_{1}^{\prime}}}{2} \cdot c_{1} e^{d_{1}} \cdot c_{1}^{\prime} e^{d_{1}^{\prime}} \\
& >\frac{e^{b_{1}^{\prime}}}{2} \cdot c_{1} \cosh d_{1} \cdot c_{1}^{\prime} \cosh d_{1}^{\prime}=\frac{1}{2} c_{0}^{\prime 2} e^{b_{1}^{\prime}}
\end{aligned}
$$

and

$$
\begin{aligned}
& \sinh c_{1} \cdot \sinh c_{1}^{\prime} \cdot \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) \\
& <k_{1} c_{1} \cdot k_{1} c_{1}^{\prime} \cdot e^{b_{1}^{\prime}+d_{1}+d_{1}^{\prime}}=4 k_{1}^{2} e^{b_{1}^{\prime}} \cdot c_{1} \frac{e^{d_{1}}}{2} \cdot c_{1}^{\prime} \frac{e^{d_{1}^{\prime}}}{2} \\
& <4 k_{1}^{2} e^{b_{1}^{\prime}} \cdot c_{1} \cosh d_{1} \cdot c_{1}^{\prime} \cosh d_{1}^{\prime}=4 k_{1}^{2}{c_{0}^{\prime}}^{2} e^{b_{1}^{\prime}}
\end{aligned}
$$

Let $M_{1}=\max \left\{2 /{c_{0}^{\prime}}^{2}, 4 k_{1}^{2} c_{0}^{2}\right\}$. It follows that

$$
M_{1}^{-1} e^{b_{1}^{\prime}} \leq \sinh c_{1} \cdot \sinh c_{1}^{\prime} \cdot \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) \leq M_{1} e^{b_{1}^{\prime}}
$$

Combining the above inequality with (3), we have

$$
\begin{aligned}
e^{a_{1}} & \leq 2 \cosh a_{1}<2\left(\cosh a_{1}+\cosh c_{1} \cdot \cosh c_{1}^{\prime}\right) \\
& =2 \cdot \sinh c_{1} \cdot \sinh c_{1}^{\prime} \cdot \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) \\
& \leq 2 M_{1} \cdot e^{b_{1}^{\prime}} .
\end{aligned}
$$

On the other hand, we have

$$
\begin{aligned}
\cosh c_{1} \cdot \cosh c_{1}^{\prime} & <\cosh c_{1} \cosh c_{1}^{\prime}+\sinh c_{1} \sinh c_{1}^{\prime} \\
& =\cosh \left(c_{1}+c_{1}^{\prime}\right)<\cosh \left(\frac{\epsilon_{0}}{2}+\frac{\epsilon_{0}}{2}\right) \\
& <\cosh \epsilon_{0} \cdot \cosh a_{1} .
\end{aligned}
$$

Applying (3) again, we have

$$
\begin{aligned}
e^{a_{1}} & \geq \cosh a_{1}=\left(1+\cosh \epsilon_{0}\right)^{-1}\left(\cosh a_{1}+\cosh \epsilon_{0} \cosh a_{1}\right) \\
& >\left(1+\cosh \epsilon_{0}\right)^{-1}\left(\cosh a_{1}+\cosh c_{1} \cdot \cosh c_{1}^{\prime}\right) \\
& =\left(1+\cosh \epsilon_{0}\right)^{-1} \cdot \sinh c_{1} \cdot \sinh c_{1}^{\prime} \cdot \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) \\
& \geq\left(1+\cosh \epsilon_{0}\right)^{-1} M_{1}^{-1} \cdot e^{b_{1}^{\prime}} .
\end{aligned}
$$

In conclusion, we have

$$
\left(1+\cosh \epsilon_{0}\right)^{-1} M_{1}^{-1} \cdot e^{b_{1}^{\prime}} \leq e^{a_{1}} \leq 2 M_{1} \cdot e^{b_{1}^{\prime}}
$$

or, equivalently,

$$
\left(1+\cosh \epsilon_{0}\right)^{-1} M_{1}^{-1} \leq e^{a_{1}-b_{1}^{\prime}} \leq 2 M_{1} .
$$

Setting $D_{1}=\max \left\{\left|\ln \left(2 M_{1}\right)\right|,\left|\ln \left(M_{1} \cdot\left(1+\cosh \epsilon_{0}\right)\right)\right|\right\}$, then we have

$$
\left|a_{1}-b_{1}^{\prime}\right| \leq D_{1} .
$$

By the same proof we also have

$$
\left|a_{2}-b_{2}^{\prime}\right| \leq D_{1} .
$$

We continue with our proof of Lemma 3.3. Let $M>2 D_{1}$ be a sufficiently large positive number. The remaining discussion is separated into several different cases.

Case 1: $b_{i}^{\prime} \geq M, i=1,2$.
In this case, using (10), we have (for $i=1,2$ )

$$
\frac{a_{i}}{b_{i}^{\prime}} \leq \frac{b_{i}^{\prime}+D_{1}}{b_{i}^{\prime}}<1+\frac{D_{1}}{M}<\frac{3}{2}
$$

and

$$
\frac{a_{i}}{b_{i}^{\prime}} \geq \frac{b_{i}^{\prime}-D_{1}}{b_{i}^{\prime}}>1-\frac{D_{1}}{M}>\frac{1}{2} .
$$

That is

$$
\frac{1}{2} \leq \frac{a_{i}}{b_{i}^{\prime}} \leq \frac{3}{2}
$$

It follows that

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq 3 \cdot \frac{a_{1}}{a_{2}}
$$

Case 2: $b_{i}^{\prime} \leq M$ and $a_{i}>\epsilon_{0}, i=1,2$.
Combing with (9) and (10), we have $M_{0} \leq b_{i}^{\prime} \leq M$ and $\epsilon_{0} \leq a_{i} \leq b_{i}^{\prime}+D_{1} \leq$ $M+D_{1}$. It follows that

$$
\frac{2 M_{0}}{3 M}<\frac{M_{0}}{M+D_{1}} \leq \frac{b_{i}^{\prime}}{a_{i}} \leq \frac{M}{\epsilon_{0}}
$$

In this case

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{M}{\epsilon_{0}} \cdot \frac{3 M}{2 M_{0}} \cdot \frac{a_{1}}{a_{2}}
$$

Case 3: $b_{1}^{\prime}>M$ and $b_{2}^{\prime} \leq M, a_{2}>\epsilon_{0}$.
It follows from the estimations in Case 1 and Case 2 that

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{3 M}{M_{0}} \cdot \frac{a_{1}}{a_{2}}
$$

Case 4: $b_{2}^{\prime}>M$ and $b_{1}^{\prime} \leq M, a_{1}>\epsilon_{0}$.
In this case, we have the same conclusion as in Case 3.
Case 5: $b_{1}^{\prime}>M$ and $b_{2}^{\prime} \leq M, a_{2} \leq \epsilon_{0}$.
By (9), we have

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{b_{1}^{\prime}}{M_{0}} \leq \frac{2 \cdot a_{1}}{M_{0}}=\frac{2 \cdot a_{2}}{M_{0}} \cdot \frac{a_{1}}{a_{2}} \leq \frac{2 \cdot \epsilon_{0}}{M_{0}} \cdot \frac{a_{1}}{a_{2}}
$$

Case 6: $b_{1}^{\prime} \leq M, a_{1}>\epsilon_{0}$ and $b_{2}^{\prime} \leq M, a_{2} \leq \epsilon_{0}$.
By (9), we have

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{b_{1}^{\prime}}{M_{0}} \leq \frac{M}{\epsilon_{0}} \cdot \frac{a_{1}}{M_{0}}=\frac{M}{\epsilon_{0}} \cdot \frac{a_{2}}{M_{0}} \cdot \frac{a_{1}}{a_{2}} \leq \frac{M}{\epsilon_{0}} \cdot \frac{\epsilon_{0}}{M_{0}} \cdot \frac{a_{1}}{a_{2}}=\frac{a_{1}}{a_{2}} .
$$

Case 7: $b_{1}^{\prime} \leq M, a_{1} \leq \epsilon_{0}$ and $b_{2}^{\prime} \leq M, a_{2} \leq \epsilon_{0}$.
By (9), we have

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{M}{M_{0}} .
$$

In this case, it is obvious that

$$
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq \frac{M}{M_{0}} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\}
$$

The other two remaining cases, that is, $b_{2}^{\prime}>M, b_{1}^{\prime} \leq M, a_{1} \leq \epsilon_{0}$ and $b_{2}^{\prime} \leq M, a_{2}>\epsilon_{0}, b_{1}^{\prime} \leq M, a_{1} \leq \epsilon_{0}$, can be reduced to Case 5 and Case 6. By choosing $K_{1}^{\prime}=\max \left\{3, \frac{3 M^{2}}{2 M_{0} \epsilon_{0}}, \frac{3 M}{M_{0}}, \frac{2 \epsilon_{0}}{M_{0}}\right\}$, we complete the proof of Lemma 3.3 .

Next we will consider the ratio $d_{1} / d_{2}$.
Lemma 3.6. The ratio $d_{1} / d_{2}$ has an upper bound given by

$$
\begin{equation*}
\frac{d_{1}}{d_{2}} \leq 2 \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\} \tag{11}
\end{equation*}
$$

Proof. As $c_{0}^{\prime}=(\ln (1+\sqrt{2})) / 2$ and $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$, we have

$$
c_{0}^{\prime} / c_{1} \geq \epsilon_{0}^{\prime} / \epsilon_{0}>e>1
$$

By (6), we have

$$
c_{1} \cosh d_{1}=c_{0}^{\prime} .
$$

By (5), we have

$$
d_{1}=\operatorname{arcosh}\left(c_{0}^{\prime} / c_{1}\right)=\ln \left(c_{0}^{\prime} / c_{1}+\sqrt{\left(c_{0}^{\prime} / c_{1}\right)^{2}-1}\right) .
$$

Note that for any $x>e, \ln (2 x) \leq 2 \ln x$. Since $\sqrt{\left(c_{0}^{\prime} / c_{1}\right)^{2}-1} \leq c_{0}^{\prime} / c_{1}$ and $c_{0}^{\prime} / c_{1}>e$, we have

$$
d_{1}=\ln \left(c_{0}^{\prime} / c_{1}+\sqrt{\left(c_{0}^{\prime} / c_{1}\right)^{2}-1}\right) \leq \ln \left(2 c_{0}^{\prime} / c_{1}\right) \leq 2 \cdot \ln \left(c_{0}^{\prime} / c_{1}\right) .
$$

Since $d_{1}=\ln \left(c_{0}^{\prime} / c_{1}+\sqrt{\left(c_{0}^{\prime} / c_{1}\right)^{2}-1}\right) \geq \ln \left(c_{0}^{\prime} / c_{1}\right)$, we have

$$
\ln c_{0}^{\prime}-\ln c_{1} \leq d_{1} \leq 2 \cdot\left(\ln c_{0}^{\prime}-\ln c_{1}\right)
$$

The same discussion implies

$$
\ln c_{0}^{\prime}-\ln c_{2} \leq d_{2} \leq 2 \cdot\left(\ln c_{0}^{\prime}-\ln c_{2}\right)
$$

As a result, we have

$$
\frac{d_{1}}{d_{2}} \leq 2 \cdot \frac{\ln c_{0}^{\prime}-\ln c_{1}}{\ln c_{0}^{\prime}-\ln c_{2}} .
$$

If $c_{2} \leq c_{1}$, we have

$$
\frac{\ln c_{0}^{\prime}-\ln c_{1}}{\ln c_{0}^{\prime}-\ln c_{2}} \leq 1
$$

Now suppose that $c_{2}>c_{1}$. Let $f_{3}(x)=x^{-1} \ln x$. Then $f_{3}^{\prime}(x)=(1-$ $\ln x) / x^{2}$. We know that $f_{3}^{\prime}(x) \leq 0$ as $x \geq e$. Since $\frac{c_{0}^{\prime}}{c_{i}} \geq e, i=1,2$, and $\frac{c_{0}^{\prime}}{c_{1}}>\frac{c_{c_{1}^{\prime}}^{c_{2}}}{c_{2}}$. It follows that $f_{3}\left(\frac{c_{0}^{\prime}}{c_{1}}\right)<f_{3}\left(\frac{c_{0}^{\prime}}{c_{2}}\right)$. This implies

$$
\frac{\ln c_{0}^{\prime}-\ln c_{1}}{\ln c_{0}^{\prime}-\ln c_{2}} \leq \frac{c_{2}}{c_{1}} .
$$

The above discussions lead to the following inequality:

$$
\frac{d_{1}}{d_{2}} \leq 2 \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\} .
$$

By the same discussion as above, we have
Lemma 3.7. The ratio $d_{1}^{\prime} / d_{2}^{\prime}$ has an upper bound given by

$$
\begin{equation*}
\frac{d_{1}^{\prime}}{d_{2}^{\prime}} \leq 2 \cdot \max \left\{1, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\} \tag{12}
\end{equation*}
$$

Proposition 3.8. Let $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$. For any essential arc $\beta \in \mathcal{B}(S)$ whose endpoints lie on different boundary components $\gamma$ and $\gamma^{\prime}$ of $S$, let $\alpha$ be the associated simple closed curve homotopic to the boundary of a regular neighborhood of $\beta \cup \gamma \cup \gamma^{\prime}$. Then there exists a positive number $K_{1}$ depending on $\epsilon_{0}$ such that inequality (7) holds for any $X_{1}, X_{2}$ in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.

Proof. We apply the results of Lemma 3.3 and Lemma 3.6 and the notations in their proof. It follows that the ratio of $\ell_{1}(\beta)$ and $\ell_{2}(\beta)$ satisfies

$$
\begin{aligned}
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)} & \leq \max \left\{\frac{b_{1}^{\prime}}{b_{2}^{\prime}}, \frac{d_{1}}{d_{2}}, \frac{d_{1}^{\prime}}{d_{2}^{\prime}}\right\} \\
& \leq \max \left\{K_{1}^{\prime} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\}, 2 \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\}, 2 \cdot \max \left\{1, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\}\right\} \\
& \leq K_{1} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}, \frac{c_{2}}{c_{1}}, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\} \\
& =K_{1} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}, \frac{\ell_{2}\left(\gamma^{\prime}\right)}{\ell_{1}\left(\gamma^{\prime}\right)}\right\},
\end{aligned}
$$

where $K_{1}=\max \left\{K_{1}^{\prime}, 2\right\}$ only depend on $\epsilon_{0}$.
3.2. The case where $\gamma=\gamma^{\prime}$.

Now we consider the case where $\gamma=\gamma^{\prime}$. In this case, we denote by $\gamma$ the boundary component of $S$ where the two endpoints of $\beta$ lie.

Consider a regular neighborhood of $\beta \cup \gamma$. It is homotopic to a pair of pants whose boundary components consist of $\gamma$ and two other simple closed curves, denoted by $\alpha$ and $\alpha^{\prime}$.

We will prove an analogue of inequality (7), that is, there exists a positive constant $K_{2}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)} \leq K_{2} \cdot \max \left\{1, \frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{1}}\left(\alpha^{\prime}\right)}{\ell_{X_{2}}\left(\alpha^{\prime}\right)}, \frac{\ell_{X_{2}}(\gamma)}{\ell_{X_{1}}(\gamma)}\right\} . \tag{13}
\end{equation*}
$$

Remark 3.9. By Example 3.2, we can assume that one of the curves $\gamma$ and $\gamma^{\prime}$ is not homotopic to a puncture. Without loss of generality, we may suppose that $\ell_{X_{1}}(\alpha) \geq \ell_{X_{1}}\left(\alpha^{\prime}\right)$. Note that $\alpha^{\prime}$ maybe homotopic to a puncture. In this case, we shall identify a puncture with a simple closed geodesic with length zero and let $\frac{0}{0}=1$.

For $X_{i}, i=1,2$, let $C_{i}$ be the inner boundary of the regular annulus around $\gamma$ with length $\ell_{X_{i}}\left(C_{i}\right)=\epsilon_{0}^{\prime}$ (the existence of such a regular annulus is given by Lemma 3.1). Then $C_{i}$ separates $\beta$ into three parts $\beta_{i}^{A}, \beta_{i}^{Q}$ and $\beta_{i}^{\prime A}$, for $i=1,2$. See Figure 7 .


Figure 7. An example of the pair of pants when $\gamma=\gamma^{\prime}$ and $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$, for $i=1,2$.

One can see from Figure 7 that the endpoints of $\beta$ separate the geodesic $\gamma$ into two parts, denoted by $\gamma_{i}^{\prime}$ and $\gamma_{i}^{\prime \prime}$. Note that $\gamma_{i}^{\prime} \cup \beta$ (resp. $\gamma_{i}^{\prime \prime} \cup \beta$ ) is isotopic to $\alpha$ (resp. $\alpha^{\prime}$ ), for $i=1,2$.

By cutting each pair of pants along the three perpendicular geodesic arcs connecting the boundary components, we have two symmetric right-angled hexagons on $X_{i}$, for $i=1,2$. We consider one of them for $i=1,2$, as we shown in Figure 8. To simplify notation, we denote $\ell_{X_{i}}$ by $\ell_{i}$ and let $c_{0}^{\prime}=\epsilon_{0}^{\prime} / 2, b_{i}=\ell_{i}\left(\beta_{i}^{Q}\right) / 2, d_{i}=\ell_{i}\left(\beta_{i}^{A}\right)=\ell_{i}\left(\beta_{i}^{\prime A}\right), a_{i}=\ell_{i}(\alpha) / 2, a_{i}^{\prime}=\ell_{i}\left(\alpha^{\prime}\right) / 2$, $c_{i}^{\prime}=\ell_{i}\left(\gamma_{i}^{\prime}\right) / 2$ and $c_{i}^{\prime \prime}=\ell_{i}\left(\gamma_{i}^{\prime \prime}\right) / 2$, for $i=1,2$. See Figure 8. Since $l_{i}(\alpha) \geq$ $l_{i}\left(\alpha^{\prime}\right)$, we have $a_{i} \geq a_{i}^{\prime}$, for $i=1,2$.

It's easy to show that the ratio of $\ell_{1}(\beta)$ and $\ell_{2}(\beta)$ satisfies

$$
\begin{equation*}
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)}=\frac{2\left(b_{1}+d_{1}\right)}{2\left(b_{2}+d_{2}\right)} \leq \max \left\{\frac{b_{1}}{b_{2}}, \frac{d_{1}}{d_{2}}\right\} \tag{14}
\end{equation*}
$$

As in the case where $\gamma \neq \gamma^{\prime}$, we will control $b_{1} / b_{2}$ and $d_{1} / d_{2}$ by the ratios of lengths of $\alpha$ and $\gamma$. We will prove these results in Lemma 3.10 and Lemma 3.11.

We first discuss the $b_{1} / b_{2}$ part.
Lemma 3.10. There exists a positive constant $K_{2}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{b_{1}}{b_{2}} \leq K_{2}^{\prime} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}\right\} \tag{15}
\end{equation*}
$$



Figure 8. An example of the hexagon on $X_{i}$ when $\gamma=\gamma^{\prime}$ and $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$, for $i=1,2$.

Proof. We follow the same outline as in the proof of Lemma 3.3. By our assumption (see Remark (3.9), $\ell_{X_{1}}(\alpha) \geq \ell_{X_{1}}\left(\alpha^{\prime}\right)$. Let us first consider the case where $\ell_{X_{2}}(\alpha) \geq \ell_{X_{2}}\left(\alpha^{\prime}\right)$.

As $\beta_{i}^{Q}, i=1,2$, can be viewed as the middle part of $\beta$, by the same proof as that of (9) in Lemma 3.4, we have

$$
\begin{equation*}
b_{i} \geq \frac{M_{0}}{2}, \text { for } i=1,2 \tag{16}
\end{equation*}
$$

Next we discuss the relation between $c_{i}^{\prime}$ and $\ell_{i}(\gamma)$, for $i=1,2$. It is obvious that $c_{1}^{\prime}<\ell_{1}(\gamma) / 2$.

By (2), we have

$$
\cosh a_{1} / \sinh c_{1}^{\prime}=\sinh \left(b_{1}+d_{1}\right)=\cosh a_{1}^{\prime} / \sinh c_{1}^{\prime \prime}
$$

Since (by assumption) $a_{1} \geq a_{1}^{\prime}$, we have

$$
\sinh c_{1}^{\prime} / \sinh c_{1}^{\prime \prime}=\cosh a_{1} / \cosh a_{1}^{\prime} \geq 1
$$

Therefore $c_{1}^{\prime} \geq c_{1}^{\prime \prime}$. Since $2\left(c_{1}^{\prime}+c_{1}^{\prime \prime}\right)=\ell_{1}(\gamma)$, we have $c_{1}^{\prime} \geq \ell_{1}(\gamma) / 4$. We have similar result for $c_{2}^{\prime}$.

It follows that

$$
\begin{equation*}
\frac{1}{4} \ell_{i}(\gamma) \leq c_{i}^{\prime}<\frac{1}{2} \ell_{i}(\gamma), \text { for } i=1,2 \tag{17}
\end{equation*}
$$

Since $c_{i}^{\prime}, i=1,2$ are bounded above by $\frac{\epsilon_{0}}{2}$, there is a positive constant $k_{2}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
c_{i}^{\prime} \leq \sinh c_{i}^{\prime} \leq k_{2} \cdot c_{i}^{\prime}, \text { for } i=1,2 \tag{18}
\end{equation*}
$$

Since $b_{i}+d_{i}, i=1,2$ are bounded by $M_{0}$ from below, we can choose $k_{2}$ such that

$$
\begin{equation*}
k_{2}^{-1} \cdot e^{b_{i}+d_{i}} \leq \sinh \left(b_{i}+d_{i}\right) \leq \frac{1}{2} \cdot e^{b_{i}+d_{i}}, \text { for } i=1,2 \tag{19}
\end{equation*}
$$

Similar to the case where $\gamma \neq \gamma^{\prime}$, we can estimate the difference between $a_{i}$ and $b_{i}, i=1,2$.

By (2), (17), (18), (19) and the fact that $\ell_{i}(\gamma) \cdot \cosh d_{i}=\epsilon_{0}^{\prime}, i=1,2$, we have (for $i=1,2$ )

$$
\begin{aligned}
e^{a_{i}} & \geq \cosh a_{i}=\sinh \left(b_{i}+d_{i}\right) \cdot \sinh c_{i}^{\prime} \\
& \geq k_{2}^{-1} \cdot e^{b_{i}+d_{i}} \cdot c_{i}^{\prime} \geq k_{2}^{-1} e^{b_{i}} \cdot \cosh d_{i} \cdot \frac{1}{4} \ell_{i}(\gamma) \\
& =\frac{k_{2}^{-1} \epsilon_{0}^{\prime}}{4} \cdot e^{b_{i}}
\end{aligned}
$$

and

$$
\begin{aligned}
e^{a_{i}} & \leq 2 \cosh a_{i}=2 \sinh \left(b_{i}+d_{i}\right) \cdot \sinh c_{i}^{\prime} \\
& \leq e^{b_{i}+d_{i}} \cdot k_{2} \cdot c_{i}^{\prime}<k_{2} e^{b_{i}} \cdot 2 \cosh d_{i} \cdot \frac{1}{2} \ell_{i}(\gamma) \\
& =k_{2} \epsilon_{0}^{\prime} \cdot e^{b_{i}} .
\end{aligned}
$$

Let $D_{2}=\max \left\{\left|\ln \left(k_{2}^{-1} \epsilon_{0}^{\prime}\right)-\ln 4\right|,\left|\ln \left(k_{2} \epsilon_{0}^{\prime}\right)\right|\right\}$. We have

$$
\begin{equation*}
\left|b_{i}-a_{i}\right| \leq D_{2}, i=1,2 . \tag{20}
\end{equation*}
$$

Now we have inequalities (16) and (20), the analogy of (9) and (10) previously. By the same proof as in Lemma 3.3 (see the discussion after Lemma (3.5), we can show that there is a constant $K_{2}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\frac{b_{1}}{b_{2}} \leq K_{2}^{\prime} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\} .
$$

Since $\frac{a_{1}}{a_{2}}=\frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}$, we finish the proof under the assumption that $\ell_{X_{2}}(\alpha) \geq$ $\ell_{X_{2}}\left(\alpha^{\prime}\right)$.

If $\ell_{X_{2}}(\alpha)<\ell_{X_{2}}\left(\alpha^{\prime}\right)$, then we can modify the above argument to show that

$$
\frac{b_{1}}{b_{2}} \leq K_{2}^{\prime} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}\left(\alpha^{\prime}\right)}\right\}
$$

Since $\frac{\ell_{1}(\alpha)}{\ell_{2}\left(\alpha^{\prime}\right)} \leq \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}$, the inequality (15)) remains true.
Next we will discuss the $d_{1} / d_{2}$ part.
Lemma 3.11. We have

$$
\begin{equation*}
\frac{d_{1}}{d_{2}} \leq 2 \cdot \max \left\{1, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\} . \tag{21}
\end{equation*}
$$

Proof. The proof is the same as that of Lemma 3.6. We have

$$
\ln \epsilon_{0}^{\prime}-\ln \ell_{i}(\gamma) \leq d_{i} \leq 2\left(\ln \epsilon_{0}^{\prime}-\ln \ell_{i}(\gamma)\right), i=1,2 .
$$

Then

$$
\frac{d_{1}}{d_{2}} \leq 2 \cdot \frac{\ln \epsilon_{0}^{\prime}-\ln \ell_{1}(\gamma)}{\ln \epsilon_{0}^{\prime}-\ln \ell_{2}(\gamma)}
$$

As we did in the case where $\gamma \neq \gamma^{\prime}$, we consider the two cases depending on whether $\ell_{2}(\gamma) \leq \ell_{1}(\gamma)$ or not.

If $\ell_{2}(\gamma) \leq \ell_{1}(\gamma)$, we have

$$
\left(\ln \epsilon_{0}^{\prime}-\ln \ell_{1}(\gamma)\right) /\left(\ln \epsilon_{0}^{\prime}-\ln \ell_{2}(\gamma)\right) \leq 1
$$

If $\ell_{2}(\gamma)>\ell_{1}(\gamma)$, by the same proof as that of Lemma 3.6, we have

$$
\left(\ln \epsilon_{0}^{\prime}-\ln \ell_{1}(\gamma)\right) /\left(\ln \epsilon_{0}^{\prime}-\ln \ell_{2}(\gamma)\right) \leq \ell_{2}(\gamma) / \ell_{1}(\gamma)
$$

From the above discussions, we have

$$
\frac{d_{1}}{d_{2}} \leq 2 \cdot \max \left\{1, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\}
$$

Proposition 3.12. Let $\epsilon_{0}$ be a positive number with $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$ and let $X_{1}, X_{2}$ be any two hyperbolic metrics in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$. For any essential arc $\beta \in \mathcal{B}(S)$ with endpoints lying on the same boundary component $\gamma$ of $S$, let $\alpha$ and $\alpha^{\prime}$ be the associated simple closed curves homotopic the boundaries of a regular neighborhood of $\beta \cup \gamma$. Then there exists a positive constant $K_{2}$ depending on $\epsilon_{0}$ such that the inequality (13) holds.

Proof. By (14), (15) and (21), we have (with the assumption that $\ell_{X_{1}}(\alpha) \geq$ $\left.\ell_{X_{1}}\left(\alpha^{\prime}\right)\right)$

$$
\begin{aligned}
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)} & \leq \max \left\{\frac{b_{1}}{b_{2}}, \frac{d_{1}}{d_{2}}\right\} \\
& \leq \max \left\{K_{2}^{\prime} \cdot \max \left\{1, \frac{\ell_{1}\left(\alpha_{1}\right)}{\ell_{2}(\alpha)}\right\}, 2 \cdot \max \left\{1, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\}\right\} \\
& \leq K_{2} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\},
\end{aligned}
$$

where $K_{2}=\max \left\{K_{2}^{\prime}, 2\right\}$ is a positive constant depending on $\epsilon_{0}$.
3.3. Corollary. By Proposition 3.8 and Proposition 3.12, we have the following corollary.
Corollary 3.13. Let $\epsilon_{0}$ be a positive number with $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$. There exists a positive constant $K$ depending on $\epsilon_{0}$ such that

$$
\sup _{\beta \in \mathcal{B}(S)}\left\{\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)}, \frac{\ell_{X_{2}}(\beta)}{\ell_{X_{1}}(\beta)}\right\} \leq K \cdot \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{2}}(\alpha)}{\ell_{X_{1}}(\alpha)}\right\}
$$

for any $X_{1}, X_{2}$ on the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.

## 4. Proof of Theorem 1.6: The general case

We have shown in Section 3 that the supremum of the ratio of lengths of arcs is controlled by that of simple closed curves in the case where $\epsilon_{0}<$ $e^{-1} \ln (1+\sqrt{2})$. In this section, we will prove the result in the general case. We assume that $\epsilon_{0} \geq e^{-1} \ln (1+\sqrt{2})$.

Here is the idea of the proof. Recall that in Section3, we separated the arc $\beta$ into several parts. In the case where $\epsilon_{0}<e^{-1} \ln (1+\sqrt{2})$, the length of $\beta_{i}^{Q}$ is bounded below by a positive number and $\ell_{X_{1}}\left(\beta_{1}^{Q}\right) / \ell_{X_{2}}\left(\beta_{2}^{Q}\right)$ is controlled by the ratio of the lengths of some corresponding simple closed curves. But in the case where $\epsilon_{0} \geq e^{-1} \ln (1+\sqrt{2})$, in general, it's impossible to give a
lower bound for $\ell_{X_{2}}\left(\beta_{2}^{Q}\right)$. To deal with this, we will not separate the arc $\beta$ into parts unless the width of collar neighborhood of $\gamma$ or $\gamma^{\prime}$ is large enough.

Let $\epsilon_{0}^{\prime}=\ln (1+\sqrt{2})$. Let $X_{1}$ and $X_{2}$ be in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$. We apply the same notations $\beta, \gamma, \gamma^{\prime}$ and $\alpha$ as in Section 3.
4.1. The case where $\gamma \neq \gamma^{\prime}$. First we will consider the case where $\gamma \neq \gamma^{\prime}$. We define $C_{i}$ and $C_{i}^{\prime}, i=1,2$, as follows.

If $\ell_{X_{1}}(\gamma)<e^{-1} \ln (1+\sqrt{2})$, let $C_{1}$ be a closed curve isotopic to $\gamma$ with $\ell_{X_{1}}\left(C_{1}\right)=\epsilon_{0}^{\prime}$ such that $C_{1}$ and $\gamma$ are the boundaries of a regular annulus around $\gamma$ on $X_{1}$. Otherwise, we let $C_{1}=\gamma$. Similarly, we can define $C_{1}^{\prime}$. The corresponding notations on $X_{2}$ are obtained only by replacing subscript.

We have four cases according to whether $\ell_{X_{i}}(\gamma)$ or $\ell_{X_{i}}\left(\gamma^{\prime}\right), i=1,2$, is less than $e^{-1} \ln (1+\sqrt{2})$ or not. Figure 9 shows how to choose $C_{i}$ and $C_{i}^{\prime}$ in each case, for $i=1,2$.

Again, to simplify notation, we denote $\ell_{i}=\ell_{X_{i}}$, for $i=1,2$. Let $a_{i}=$ $\ell_{i}(\alpha) / 2, b_{i}=\ell_{i}(\beta) / 2, c_{i}=\ell_{i}(\gamma) / 2, c_{i}^{\prime}=\ell_{i}\left(\gamma^{\prime}\right) / 2, d_{i}=\ell_{i}\left(\beta_{i}^{A}\right), d_{i}^{\prime}=\ell_{i}\left(\beta_{i}^{\prime A}\right)$, $b_{i}^{\prime}=\ell_{i}\left(\beta_{i}^{Q}\right), e_{i}=\ell_{i}\left(C_{i}\right) / 2, e_{i}^{\prime}=\ell_{i}\left(C_{i}^{\prime}\right) / 2$ and $c_{0}^{\prime}=\epsilon_{0}^{\prime} / 2$, for $i=1,2$. It should be noted that $d_{i}=0$ and $e_{i}=c_{i}$ if $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$.

With the above notations, let us describe Figure 9 in more details:
Case (a): $\ell_{i}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right)<e^{-1} \ln (1+\sqrt{2}), i=1,2$.
In this case, $e_{i}=e_{i}^{\prime}=c_{0}^{\prime}, i=1,2$. This implies that $d_{i}$ and $d_{i}^{\prime}, i=1,2$ are positive.

Case (b): $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right)<e^{-1} \ln (1+\sqrt{2}), i=1,2$.
In this case, $e_{i}=c_{i}$ and $e_{i}^{\prime}=c_{0}^{\prime}, i=1,2$. This implies that $d_{i}=0$ and $d_{i}>0, i=1,2$.

Case (c): $\ell_{i}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right) \geq e^{-1} \ln (1+\sqrt{2}), i=1,2$.
Similar to Case (b), $e_{i}=c_{0}^{\prime}$ and $e_{i}^{\prime}=c_{i}^{\prime}, i=1,2$. This implies that $d_{i}>0$ and $d_{i}^{\prime}=0, i=1,2$.

Case (d): $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right) \geq e^{-1} \ln (1+\sqrt{2}), i=1,2$.
In this case, we have $e_{i}=c_{i}, e_{i}^{\prime}=c_{i}^{\prime}$ and $d_{i}=d_{i}^{\prime}=0, i=1,2$.
These four cases are shown in Figure 9. The ratio of the lengths of $\beta$ on $X_{1}$ and $X_{2}$ satisfies the following

$$
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)}=\frac{b_{1}}{b_{2}}=\frac{b_{1}^{\prime}+d_{1}+d_{1}^{\prime}}{b_{2}^{\prime}+d_{2}+d_{2}^{\prime}} \leq 3 \cdot \max \left\{\frac{b_{1}^{\prime}}{b_{2}^{\prime}}, \frac{d_{1}}{b_{2}^{\prime}+d_{2}}, \frac{d_{1}^{\prime}}{b_{2}^{\prime}+d_{2}^{\prime}}\right\}
$$

We will study each part on the right hand side of the above inequality.
Lemma 4.1. There exists a positive constant $K_{3}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{b_{1}^{\prime}}{b_{2}^{\prime}} \leq K_{3}^{\prime} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\} \tag{22}
\end{equation*}
$$


(a) Case $\ell_{i}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right)<e^{-1} \ln (1+\sqrt{2})$

(b) Case $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right)<e^{-1} \ln (1+\sqrt{2})$

(c) Case $\ell_{i}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right) \geq e^{-1} \ln (1+\sqrt{2})$

(d) Case $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$ and $\ell_{i}\left(\gamma^{\prime}\right) \geq e^{-1} \ln (1+\sqrt{2})$

Figure 9. Examples of pair of pants on $X_{i}$ when $\gamma \neq \gamma^{\prime}$ and $\epsilon_{0} \geq e^{-1} \ln (1+\sqrt{2})$, for $i=1,2$.

Proof. We first show that there exists a positive lower bound (that may depend on $\epsilon_{0}$ ) for $b_{i}^{\prime}$, for $i=1,2$. Consider $b_{1}^{\prime}$. We have to consider all four cases as illustrated in Figure 9.

In Case (a), by (9), we have $b_{1}^{\prime} \geq 8 / \ln (1+\sqrt{2})$.
In Case (b) or Case (c), the proof of (9) shown that $b_{1}^{\prime} \geq 4 / \ln (1+\sqrt{2})$.
In Case (d), $C=\gamma$ and $C^{\prime}=\gamma^{\prime}$. By (3), we have

$$
\cosh a_{1}+\cosh c_{1} \cosh c_{1}^{\prime}=\sinh c_{1} \sinh c_{1}^{\prime} \cosh b_{1}^{\prime}
$$

Since $c_{1} \leq \epsilon_{0} / 2$ and $c_{1}^{\prime} \leq \epsilon_{0} / 2$, we have a lower bound for $\cosh b_{1}^{\prime}$ :

$$
\begin{aligned}
\cosh b_{1}^{\prime} & =\frac{\cosh a_{1}+\cosh c_{1} \cosh c_{1}^{\prime}}{\sinh c_{1} \sinh c_{1}^{\prime}} \\
& =\frac{\cosh a_{1}}{\sinh c_{1} \sinh c_{1}^{\prime}}+\operatorname{coth} c_{1} \operatorname{coth} c_{1}^{\prime} \geq\left(\sinh \frac{\epsilon_{0}}{2}\right)^{-2}+1 .
\end{aligned}
$$

It follows that $b_{1}^{\prime} \geq \operatorname{arcosh}\left(\left(\sinh \left(\epsilon_{0} / 2\right)\right)^{-2}+1\right)$. Using the same argument we have that $b_{2}^{\prime} \geq \operatorname{arcosh}\left(\left(\sinh \left(\epsilon_{0} / 2\right)\right)^{-2}+1\right)$. Let

$$
M^{\prime}=\min \left\{4 / \ln (1+\sqrt{2}), \operatorname{arcosh}\left(\left(\sinh \left(\epsilon_{0} / 2\right)\right)^{-2}+1\right)\right\}
$$

then we have

$$
\begin{equation*}
b_{i}^{\prime} \geq M^{\prime}, \text { for } i=1,2 \tag{23}
\end{equation*}
$$

Now we claim that the difference between $a_{i}$ and $b_{i}^{\prime}$ is bounded from above in all the above four cases, for $i=1,2$. We only give the discussion on $X_{1}$. The discussion on $X_{2}$ is the same.

Case (a) is handled by inequality (10).
In Case (b) or Case (c), it is sufficient to consider Case (b). The discussion of Case (c) works in the same way. As $\ell_{1}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$ and $d_{1}=0$, we have
$\sinh c_{1} \sinh c_{1}^{\prime} \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right)>\frac{1}{2} \cdot c_{1} \cdot c_{1}^{\prime} \cosh d_{1}^{\prime} \cdot e^{b_{1}^{\prime}}=\frac{1}{2} \cdot \frac{\ell_{1}(\gamma)}{2} \cdot c_{0}^{\prime} \cdot e^{b_{1}^{\prime}}$

$$
\geq \frac{(\ln (1+\sqrt{2}))^{2}}{8 e} \cdot e^{b_{1}^{\prime}}
$$

As $c_{1}<\epsilon_{0} / 2, c_{1}^{\prime}<\epsilon_{0} / 2$, we have a positive constant $k_{1}$ (depending on $\epsilon_{0}$ ) that satisfies $\sinh c_{1} \leq k_{1} \cdot c_{1}$ and $\sinh c_{1}^{\prime} \leq k_{1} \cdot c_{1}^{\prime}$. Then we have

$$
\begin{aligned}
\sinh c_{1} \sinh c_{1}^{\prime} \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right) & <k_{1}^{2} \cdot c_{1} \cdot c_{1}^{\prime} \cosh d_{1}^{\prime} \cdot e^{b_{1}^{\prime}} \\
& \leq \frac{\epsilon_{0} k_{1}^{2} \ln (1+\sqrt{2})}{4 e} \cdot e^{b_{1}^{\prime}}
\end{aligned}
$$

Let $M_{1}=\max \left\{8 e /(\ln (1+\sqrt{2}))^{2}, \epsilon_{0} k_{1}^{2} \ln (1+\sqrt{2}) /(4 e)\right\}$. Then we have proved that

$$
M_{1}^{-1} e^{b_{1}^{\prime}} \leq \sinh c_{1} \sinh c_{1}^{\prime} \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}\right) \leq M_{1} e^{b_{1}^{\prime}}
$$

Similarly to the proof of inequality (10), we can show that there exists a positive constant $D_{2}$ depending on $\epsilon_{0}$ such that $\left|a_{1}-b_{1}^{\prime}\right| \leq D_{2}$.

In Case (d), the assumption of this case implies that $d_{1}=0$ and $d_{1}^{\prime}=0$. It follows that

$$
\sinh c_{1} \sinh c_{1}^{\prime} \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right)>\frac{c_{1} c_{1}^{\prime}}{2} \cdot e^{b_{1}^{\prime}} \geq \frac{(\ln (1+\sqrt{2}))^{2}}{8 e^{2}} \cdot e^{b_{1}^{\prime}}
$$

and

$$
\sinh c_{1} \sinh c_{1}^{\prime} \cosh \left(b_{1}^{\prime}+d_{1}+d_{1}^{\prime}\right)<K_{1}^{2} c_{1} c_{1}^{\prime} e^{b_{1}^{\prime}} \leq \frac{K_{1}^{2} \epsilon_{0}^{2}}{4} e^{b_{1}^{\prime}} .
$$

Let $M_{1}=\max \left\{8 e^{2} /(\ln (1+\sqrt{2}))^{2}, K_{1}^{2} \epsilon_{0}^{2} / 4\right\}$. Again, similarly to the proof of inequality (10), we can prove that $\left|a_{1}-b_{1}^{\prime}\right| \leq D_{3}$, where the constant $D_{3}$ depends on $\epsilon_{0}$.

The same proof applies to $\left|a_{2}-b_{2}^{\prime}\right|$. Then we have a positive constant $D$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\left|a_{i}-b_{i}^{\prime}\right| \leq D, i=1,2 \tag{24}
\end{equation*}
$$

Comparing (23) and (24) with (19) and (10) in the proof of Lemma 3.3, we finish the proof.

Next we will consider the $d_{1} /\left(b_{2}^{\prime}+d_{2}\right)$ part.
Lemma 4.2. There exists a positive constant $K_{3}^{\prime \prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{d_{1}}{b_{2}^{\prime}+d_{2}} \leq K_{3}^{\prime \prime} \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\} \tag{25}
\end{equation*}
$$

Proof. By (6), we have

$$
\ell_{i}(\gamma) \cdot \cosh d_{i}=\ell_{i}\left(C_{i}\right), i=1,2
$$

Similarly,

$$
\ell_{i}\left(\gamma^{\prime}\right) \cdot \cosh d_{i}^{\prime}=\ell_{i}\left(C_{i}^{\prime}\right), i=1,2
$$

We consider the two cases depending on whether $\ell_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ or not.

Case 1: $\ell_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$.
By assumption, we have $\ell_{1}\left(C_{1}\right)=\ln (1+\sqrt{2})$. As in the proof of Lemma 3.6, we have

$$
\begin{equation*}
\ln \ell_{1}\left(C_{1}\right)-\ln \ell_{1}(\gamma) \leq d_{1} \leq 2\left(\ln \ell_{1}\left(C_{1}\right)-\ln \ell_{1}(\gamma)\right) \tag{26}
\end{equation*}
$$

If $\ell_{2}(\gamma)<e^{-1} \ln (1+\sqrt{2})$, the lemma follows from Lemma 3.6. If $\ell_{2}(\gamma) \geq$ $e^{-1} \ln (1+\sqrt{2})$, then $d_{2}=0$. By (26), we have

$$
\begin{aligned}
\frac{d_{1}}{b_{2}^{\prime}+d_{2}} & \leq \frac{d_{1}}{M^{\prime}} \leq \frac{2}{M^{\prime}} \cdot \ln \frac{\ell_{1}\left(C_{1}\right)}{\ell_{1}(\gamma)} \leq \frac{2}{M^{\prime}} \cdot \frac{\ell_{1}\left(C_{1}\right)}{\ell_{1}(\gamma)} \\
& \leq \frac{2 \ln (1+\sqrt{2})}{M^{\prime} \ell_{2}(\gamma)} \cdot \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)} \leq \frac{2 e}{M^{\prime}} \cdot \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}
\end{aligned}
$$

Case $2: \ell_{1}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$.
Since $d_{1}=0$ and $b_{2}^{\prime} \geq M^{\prime}$, we have $d_{1} /\left(b_{2}^{\prime}+d_{2}\right)=0$.
Let $K_{3}^{\prime \prime}=\max \left\{2,2 e / M^{\prime}\right\}$. Since $\frac{c_{2}}{c_{1}}=\frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}$, we have

$$
\frac{d_{1}}{b_{2}^{\prime}+d_{2}} \leq K_{3}^{\prime \prime} \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\}
$$

This completes the proof.

We argue similarly for

Lemma 4.3. There exists a positive constant $K_{3}^{\prime \prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{d_{1}^{\prime}}{b_{2}^{\prime}+d_{2}^{\prime}} \leq K_{3}^{\prime \prime \prime} \cdot \max \left\{1, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\} \tag{27}
\end{equation*}
$$

Proposition 4.4. For any essential arc $\beta \in \mathcal{B}(S)$ with endpoints lying on different boundary components $\gamma$ and $\gamma^{\prime}$ of $S$, let $\alpha$ be the associated simple closed curve isotopic to the boundary of a regular neighborhood of $\beta \cup \gamma \cup \gamma^{\prime}$. Then there exists a positive constant $K_{3}$ depending on $\epsilon_{0}$ such that the following inequality holds for any $X_{1}, X_{2}$ in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$ :

$$
\begin{equation*}
\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)} \leq K_{3} \cdot \max \left\{1, \frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{2}}(\gamma)}{\ell_{X_{1}}(\gamma)}, \frac{\ell_{X_{2}}\left(\gamma^{\prime}\right)}{\ell_{X_{1}}\left(\gamma^{\prime}\right)}\right\} \tag{28}
\end{equation*}
$$

Proof. By Lemma 4.1, Lemma 4.2 and Lemma 4.3, the ratio $\ell_{1}(\beta) / \ell_{2}(\beta)$ satisfies

$$
\begin{aligned}
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)} & \leq 3 \cdot \max \left\{\frac{b_{1}^{\prime}}{b_{2}^{\prime}}, \frac{d_{1}}{b_{2}^{\prime}+d_{2}}, \frac{d_{1}^{\prime}}{b_{2}^{\prime}+d_{2}^{\prime}}\right\} \\
& \leq 3 \cdot \max \left\{K_{3}^{\prime} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}\right\}, K_{3}^{\prime \prime} \cdot \max \left\{1, \frac{c_{2}}{c_{1}}\right\}, K_{3}^{\prime \prime \prime} \cdot \max \left\{1, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\}\right\} \\
& \leq K_{3} \cdot \max \left\{1, \frac{a_{1}}{a_{2}}, \frac{c_{2}}{c_{1}}, \frac{c_{2}^{\prime}}{c_{1}^{\prime}}\right\} \\
& =K_{3} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}, \frac{\ell_{2}\left(\gamma^{\prime}\right)}{\ell_{1}\left(\gamma^{\prime}\right)}\right\},
\end{aligned}
$$

where $K_{3}=3 \cdot \max \left\{K_{3}^{\prime}, K_{3}^{\prime \prime} K_{3}^{\prime \prime \prime}\right\}$.

### 4.2. The case where $\gamma=\gamma^{\prime}$.

For hyperbolic structures $X_{i}, i=1,2$, on $S$, we choose $\alpha_{i}, \alpha_{i}^{\prime}, \gamma_{i}^{\prime}$ and $\gamma_{i}^{\prime \prime}$, $i=1,2$, as in the beginning of subsection 3.2. We repeat the constructions as follows. Let $\alpha$ and $\alpha^{\prime}$ be the boundaries of the regular neighborhood of $\beta \cup \gamma$. We may assume that $\ell_{i}(\alpha) \geq \ell_{i}\left(\alpha^{\prime}\right)$, for $i=1,2$. As we show in Figure 10 , the arc $\beta$ separates $\gamma$ into two sub-arcs $\gamma_{i}^{\prime}$ and $\gamma_{i}^{\prime \prime}$, such that $\gamma_{i}^{\prime} \bigcup \beta$ is isotopic to $\alpha$, for $i=1,2$.

Similar to the criterion given in the above subsection, we choose closed curves $C_{i}, i=1,2$, which are isotopic to $\gamma$ as follows. Denote $\ell_{X_{i}}$ by $\ell_{i}$, $i=1,2$. If $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$, then we let $C_{i}=\gamma$, for $i=1,2$, as we shown in (b) of Figure 10. Otherwise, we let $C_{i}$ be the inner boundary of a regular annulus around $\gamma$ with $\ell_{i}\left(C_{i}\right)=\epsilon_{0}^{\prime}$, for $i=1$, 2 , as we show in (a) of Figure 10 .

Cutting along the three geodesic arcs which connect any two of the boundaries of the pair of pants, we obtain two symmetric right-angled hexagons. We only need consider one of them.

If $\ell_{i}(\gamma)<e^{-1} \ln (1+\sqrt{2})$, the part of $\beta$ in one of the hexagon is separated by $C_{i}$ into two sub-arcs, for $i=1,2$. As we show in Figure 10 (b), let $b_{i}=\ell_{i}\left(\beta_{i}^{Q}\right) / 2$ and $d_{i}=\ell_{i}\left(\beta_{i}^{A}\right)=\ell_{i}\left(\beta_{i}^{\prime A}\right)$, for $i=1,2$.

(b) Case $\ell_{X_{i}}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$

Figure 10. Examples of pair of pants on $X_{i}$ when $\gamma=\gamma^{\prime}$ and $\epsilon_{0} \geq e^{-1} \ln (1+\sqrt{2})$.

If $\ell_{i}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$, since $C_{i}=\gamma$, we let $b_{i}=\ell_{i}(\beta) / 2$ and $d_{i}=0$, for $i=1,2$. For sake of simplicity, let $c_{i}^{\prime}=\ell_{i}\left(\gamma_{i}^{\prime}\right), c_{i}^{\prime \prime}=\ell_{i}\left(\gamma_{i}^{\prime \prime}\right), a_{i}=\ell_{i}(\alpha) / 2$, $a_{i}^{\prime}=\ell_{i}\left(\alpha^{\prime}\right) / 2$ and $c_{0}^{\prime}=\epsilon_{0}^{\prime} / 2=\ln (1+\sqrt{2}) / 2$, for $i=1,2$.

In either case, $\ell_{i}(\beta)=b_{i}+d_{i}, i=1,2$. It's easy to show that

$$
\frac{\ell_{1}(\beta)}{\ell_{2}(\beta)}=\frac{2 \cdot\left(b_{1}+d_{1}\right)}{2 \cdot\left(b_{2}+d_{2}\right)} \leq 2 \cdot \max \left\{\frac{b_{1}}{b_{2}}, \frac{d_{1}}{b_{2}+d_{2}}\right\}
$$

We will study the $b_{1} / b_{2}$ part and the $d_{2} /\left(b_{2}+d_{2}\right)$ part.
We first consider the $b_{1} / b_{2}$ part.
Lemma 4.5. There exists a positive constant $K_{4}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{b_{1}}{b_{2}} \leq K_{4}^{\prime} \cdot \max \left\{1, \frac{\ell_{1}(\alpha)}{\ell_{2}(\alpha)}\right\} \tag{29}
\end{equation*}
$$

Proof. As in the proof of (17), we have

$$
\frac{\ell_{i}(\gamma)}{4} \leq c_{i}^{\prime} \leq \frac{\ell_{i}(\gamma)}{2}, i=1,2
$$

We will show that there exists a positive lower bound for $b_{i}, i=1,2$.
Consider $b_{1}$ first. If $l_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$, then $b_{1} \geq 4 / \ln (1+\sqrt{2})$, see (16). Now we suppose that $l_{1}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$. By (2) (we refer to

Figure 8), we have

$$
\sinh b_{1} \sinh c_{1}^{\prime}=\cosh a_{1}
$$

And the inequality $c_{1}^{\prime} \leq \ell_{1}(\gamma) / 2 \leq \epsilon_{0} / 2$ implies that

$$
\sinh b_{1}=\frac{\cosh a_{1}}{\sinh c_{1}^{\prime}} \geq \frac{1}{\sinh \left(\epsilon_{0} / 2\right)} .
$$

Therefore $b_{1} \geq \operatorname{arsinh}\left(\left(\sinh \left(\epsilon_{0} / 2\right)\right)^{-1}\right)$.
Let $M_{0}^{\prime}=\max \left\{4 / \ln (1+\sqrt{2}), \operatorname{arsinh}\left(\left(\sinh \left(\epsilon_{0} / 2\right)\right)^{-1}\right)\right\}$. Then we have $b_{1} \geq M_{0}^{\prime}$. The same argument implies $b_{2} \geq M_{0}^{\prime}$. Thus we have

$$
\begin{equation*}
b_{i} \geq M_{0}^{\prime}, i=1,2 . \tag{30}
\end{equation*}
$$

Since $b_{i}+d_{i} \geq M_{0}^{\prime}$ and $c_{i}^{\prime}<\epsilon_{0} / 2, i=1,2$, we have $k_{2}>0$ (depending on $\epsilon_{0}$ ) such that

$$
k_{2}^{-1} \cdot e^{b_{i}+d_{i}} \leq \sinh \left(b_{i}+d_{i}\right) \leq \frac{1}{2} \cdot e^{b_{i}+d_{i}}, i=1,2,
$$

and

$$
c_{i}^{\prime} \leq \sinh c_{i}^{\prime} \leq k_{2} \cdot c_{i}^{\prime}, \quad i=1,2
$$

Similarly to the proof of (20), we will show that the difference between $b_{i}$ and $a_{i}, i=1,2$, is bounded from above. We first study the difference between $b_{1}$ and $a_{1}$. There are two cases depending on whether $\ell_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$ or not.

Case (a): $\ell_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$.
For this case, by the same argument as in the proof of (20), we have $\left|b_{1}-a_{1}\right|<D_{2}$.
Case (b): $\ell_{1}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$.
In this case, since $d_{1}=0$, as in the proof of (20), we have

$$
e^{a_{1}} \geq k_{2}^{-1} c_{1}^{\prime} e^{b_{1}} \geq \frac{k_{2}^{-1}}{4} \ell_{1}(\gamma) e^{b_{1}} \geq \frac{k_{2}^{-1} \ln (1+\sqrt{2})}{4 e} \cdot e^{b_{1}}
$$

and

$$
e^{a_{1}} \leq k_{2} c_{1}^{\prime} e^{b_{1}} \leq \frac{k_{2} \epsilon_{0}}{2} \cdot e^{b_{1}}
$$

Let $D_{2}^{\prime}=\max \left\{\left|\ln \left(k_{2}^{-1} \ln (1+\sqrt{2})\right)-\ln (4 e)\right|,\left|\ln \left(k_{2} \epsilon_{0}\right)-\ln 2\right|\right\}$. We have $\left|b_{1}-a_{1}\right|<D_{2}^{\prime}$.

The same proof applies to $a_{2}-b_{2}$. Thus we have a positive constant $D_{2}^{\prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\left|b_{i}-a_{i}\right|<D_{2}^{\prime}, \text { for } i=1,2 . \tag{31}
\end{equation*}
$$

The rest of the proof of this lemma is identical to the proof of Lemma 3.10 after the inequality (20). We omit the details.

The next lemma is the discussion for the $d_{1} /\left(b_{2}+d_{2}\right)$ part.
Lemma 4.6. There exists a positive constant $K_{4}^{\prime \prime}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{d_{1}}{b_{2}+d_{2}} \leq K_{4}^{\prime \prime} \cdot \max \left\{1, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\} . \tag{32}
\end{equation*}
$$

Proof. We need to consider the two cases depending on whether $\ell_{1}(\gamma)<$ $e^{-1} \ln (1+\sqrt{2})$ or not.

Case (a): $\ell_{1}(\gamma)<e^{-1} \ln (1+\sqrt{2})$.
If, moreover, $\ell_{2}(\gamma)<e^{-1} \ln (1+\sqrt{2})$, then by Lemma 3.11, we have

$$
\begin{equation*}
\frac{d_{1}}{b_{2}+d_{2}} \leq \frac{d_{1}}{d_{2}} \leq 2 \max \left\{1, \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}\right\} \tag{33}
\end{equation*}
$$

Otherwise, $\ell_{2}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$. As $d_{2}=0$, by (26), we have

$$
\frac{d_{1}}{b_{2}+d_{2}}=\frac{d_{1}}{b_{2}} \leq \frac{2}{M_{0}} \ln \frac{\ell_{1}(C)}{\ell_{1}(\gamma)}
$$

Since $\ell_{1}(C) \geq \ell_{1}(\gamma)$, we have

$$
\ln \frac{\ell_{1}(C)}{\ell_{1}(\gamma)} \leq \frac{\ell_{1}(C)}{\ell_{1}(\gamma)}
$$

It follows that

$$
\frac{d_{1}}{b_{2}+d_{2}} \leq \frac{2}{M^{\prime \prime}} \frac{\ell_{1}(C)}{\ell_{1}(\gamma)}=\frac{2 \ln (1+\sqrt{2})}{M^{\prime \prime} \ell_{2}(\gamma)} \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}=\frac{2 e}{M^{\prime \prime}} \cdot \frac{\ell_{2}(\gamma)}{\ell_{1}(\gamma)}
$$

Case (b): $\ell_{1}(\gamma) \geq e^{-1} \ln (1+\sqrt{2})$.
By assumption, $d_{1}=0$. It follows that

$$
d_{1} /\left(b_{2}+d_{2}\right)=0
$$

Let $K_{4}^{\prime \prime}=\max \left\{2,2 e / M_{0}^{\prime}\right\}$. We are done.
Proposition 4.7. Let $X_{1}, X_{2}$ be any hyperbolic metrics in the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$. For any essential arc $\beta \in \mathcal{B}(S)$ with endpoints lying on the same boundary component $\gamma$ of $S$, let $\alpha$ and $\alpha^{\prime}$ be the associated simple closed curves homotopic the boundaries of a regular neighborhood of $\beta \cup \gamma$. Then there exists a positive constant $K_{4}$ depending on $\epsilon_{0}$ such that

$$
\begin{equation*}
\frac{\ell_{X_{1}}(\beta)}{\ell_{X_{2}}(\beta)} \leq K_{4} \cdot \max \left\{1, \frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{2}}(\alpha)}, \frac{\ell_{X_{1}}\left(\alpha^{\prime}\right)}{\ell_{X_{2}}\left(\alpha^{\prime}\right)}, \frac{\ell_{X_{2}}(\gamma)}{\ell_{X_{1}}(\gamma)}\right\} . \tag{34}
\end{equation*}
$$

Proof. This is a corollary of (29) and (32).
4.3. Conclusion. By Proposition 4.4 and Proposition 4.7, the same proof as that of Corollary 3.13 proves Theorem 1.6. Theorem 1.6 implies Theorem 1.5.

Recall that in the proof of Theorem 1.5, we just use elementary hyperbolic geometry. However, for example, the inequality (7) we have shown is not obvious. Note that we only assume that the hyperbolic surfaces belong to the $\epsilon_{0}$-relative part of $\mathcal{T}(S)$ (not the thick part), thus the geodesic arcs we consider may cross long narrow cylinders or twist a lot. Thus it is difficult to control the lengths of arcs by that of simple closed curves. What we have done is to show that the ratios can be controlled uniformly.

Example 4.8. We use the Nielsen extension of Riemann surfaces with boundary [4, 22] to show that inequality (1) fails on the whole $\epsilon_{0}$-relative part of $\mathcal{T}(S)$.

Let $X_{0}$ be any given hyperbolic metric on $S$. We can add each geodesic boundary component of $X_{0}$ with an infinite funnel such that $X_{0}$ becomes the convex core of a Riemann surface $R=\mathbb{H}^{2} / \Gamma$, where $\Gamma$ is a Fuchsian group of the second kind. By taking the double of $R$, we obtain a Riemann surface $R^{d}$ without boundary. There is a unique hyperbolic metric in the conformal class of $R^{d}$ and its restriction on $R$ defines a new hyperbolic metric $X_{1}$ on $S$ with geodesic boundary. We call $X_{1}$ the Nielsen extension of $X_{0}$.

We may view $X_{0}$ as a conformal embedded subsurface of $X_{1}$. By the Schwarz Lemma, the Nielsen extension decreases the hyperbolic metric on $X_{0}$. As a result, we have

$$
\sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X_{1}}(\alpha)}{\ell_{X_{0}}(\alpha)}\right\} \leq 1
$$

A theorem of Halpern [10] shows that, if $\alpha$ is a boundary curve of $X_{0}$ with length $l$, then the length of the corresponding boundary curve of the Nielsen extension $X_{1}$ is less than $\frac{l}{2}$. In particular, if we define by $X_{n+1}$ be the Nielsen extension of $X_{n}$, then $\ell_{X_{n}}(\alpha) \rightarrow 0$ for any boundary curve $\alpha$. Combined with the Collar Lemma, we have

$$
\sup _{\alpha \in \mathcal{C}(S) \cup \mathcal{B}(S)}\left\{\frac{\ell_{X_{n}}(\alpha)}{\ell_{X_{0}}(\alpha)}\right\} \rightarrow \infty
$$

while

$$
\sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X_{n}}(\alpha)}{\ell_{X_{0}}(\alpha)}\right\} \leq 1
$$

Note that the sequence $\left(X_{n}\right)$ we constructed lies in some $\epsilon_{0}$-relative part of $\mathcal{T}(S)$, but not in any $\epsilon$-thick $\epsilon_{0}$-relative part.

On the other hand, the " $\epsilon_{0}$-relative" upper boundedness assumption on lengths of the boundary curves is necessary for both inequality (1) and Theorem 1.6, see Example 3.8 in [16].

## 5. Applications and further study

5.1. Moduli space. Let $\operatorname{Mod}(S)$ be the modular group (or the mapping class group) of $S$. Recall that $\operatorname{Mod}(S)$ is the group of homotopy classes of orientation-preserving homeomorphism of $S . \operatorname{Mod}(S)$ acts on the Te ichmüller space $\mathcal{T}(S)$ by switching the markings. Moreover, the action is properly discontinuous and by isometries (here we endow $\mathcal{T}(S)$ with the length spectrum metric or the arc-length spectrum metric). The moduli space of $S$, denoted by $\mathcal{M}(S)$, is the quotient space

$$
\mathcal{M}(S)=\mathcal{T}(S) / \operatorname{Mod}(S)
$$

We have the natural projective map $\pi: \mathcal{T}(S) \rightarrow \mathcal{M}(S)$.
For any fixed positive number $\epsilon_{0}$, the subset of $\mathcal{M}(S)$ consisting of hyperbolic structures with lengths of boundary components bounded above by $\epsilon_{0}$ is called the $\epsilon_{0}$-relative part of $\mathcal{M}(S)$.

The metric $d$ on $\mathcal{T}(S)$ induces a metric $d^{M}$ on $\mathcal{M}(S)$ by letting

$$
d^{M}\left(\tau_{1}, \tau_{2}\right)=\inf _{X_{i} \in \pi^{-1}\left(\tau_{i}\right)} d\left(X_{1}, X_{2}\right)
$$

Similarly, we have corresponding metrics $\bar{d}^{M}, \delta_{L}^{M}$ and $d_{L}^{M}$ on $\mathcal{M}(S)$ which are induced by $\bar{d}, \delta_{L}$ and $d_{L}$ on $\mathcal{T}(S)$, respectively.

The following result is a direct corollary of Theorem 1.5
Corollary 5.1. Given $\epsilon_{0}>0$. Let $d_{L}^{(M)}$ and $\delta_{L}^{(M)}$ be the length spectrum metric and the arc-length spectrum metric on $\mathcal{M}(S)$. For any $\tau_{1}, \tau_{2}$ in the $\epsilon_{0}$-relative part of $\mathcal{M}(S)$, we have

$$
\begin{equation*}
d_{L}^{M}\left(\tau_{1}, \tau_{2}\right) \leq \delta_{L}^{M}\left(\tau_{1}, \tau_{2}\right) \leq d_{L}^{M}\left(\tau_{1}, \tau_{2}\right)+C \tag{35}
\end{equation*}
$$

where $C$ is a positive constant depending on $\epsilon_{0}$.
In the case where $S$ is a surface of finite type without boundary, the authors [15] proved that the length spectrum metric and the Teichmüller metric are almost isometric on the moduli space $\mathcal{M}(S)$. The result can not be generalized to surfaces of finite type with boundary [18]. However, we ask the following

Problem 5.2. Let $S$ be a surface of finite type with boundary. Are the arc-length spectrum metric and the Teichmüller metric almost isometric on the moduli space $\mathcal{M}(S)$ ?
5.2. Metrics on Teichmüller spaces of surfaces of infinite type. A surface is said to be of finite type if its fundamental group is finitely generated. Otherwise it is said to be of infinite type. For more details on Teichmüller spaces of surfaces of infinite type (where the definition of Teichmüller space is not unique and more involved), we refer to [2].

A hyperbolic surface $S$ (possibly with geodesic boundary) is said to be convex if for every pair of points $x, y \in S$ and for every arc $\gamma$ with endpoints $x$ and $y$, there exists a geodesic arc of $S$ connecting $x$ and $y$ that is homotopic to $\gamma$ relative to the endpoints.

A convex hyperbolic surface $S$ with geodesic boundary is Nielsen convex if every point of $S$ is contained in a geodesic arc with endpoints contained in some simple closed geodesics of $S$. For a hyperbolic surface of finite type to be Nielsen convex is equivalent to be convex with geodesic boundary and of finite area. However, for surfaces of infinite type the two notions maybe not equivalent [2].

In this following, we assume that $S$ is a hyperbolic surfaces of infinite type and $S$ is Nielsen convex. Moreover, we assume that all the boundary components of $S$ are of length less than some positive constant.

Denote by $\mathcal{T}_{L}(S)$ the length spectrum Teichmüller space of $S$, which consists of (equivalence classes) of hyperbolic surfaces $X$ that are homeomorphic with $S$ and satisfy

$$
d_{L}(S, X)=\log \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{X}(\alpha)}{\ell_{S}(\alpha)}, \frac{\ell_{S}(\alpha)}{\ell_{X}(\alpha)}\right\}<\infty
$$

We endow $\mathcal{T}_{L}(S)$ with the length spectrum metric

$$
d_{L}(X, Y)=\log \sup _{\alpha \in \mathcal{C}(S)}\left\{\frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)}, \frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}\right\}
$$

We define the $\epsilon_{0}$-relative part of $\mathcal{T}_{L}(S)$ to be the subset consisting of hyperbolic surfaces with lengths of boundary components bounded above by $\epsilon_{0}$. By assumption on $S$, the $\epsilon_{0}$-relative part of $\mathcal{T}_{L}(S)$ is not a empty set if $\epsilon_{0}$ is sufficiently large. We can also define the arc-length spectrum metric by

$$
\delta_{L}(X, Y)=\log \sup _{\alpha \in \mathcal{C}(S) \cup \mathcal{B}(S)}\left\{\frac{\ell_{Y}(\alpha)}{\ell_{X}(\alpha)}, \frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}\right\}
$$

As the discussions in the previous sections are not related to the topological type of surface, we have the following theorem.

Theorem 5.3. Given $\epsilon_{0}>0$. Let $d_{L}$ and $\delta_{L}$ be the length spectrum metric and the arc-length spectrum metric on $\mathcal{T}_{L}(S)$. For any $X$ and $Y$ in the $\epsilon_{0}$-relative part of $\mathcal{T}_{L}(S)$, we have

$$
d_{L}(X, Y) \leq \delta_{L}(X, Y) \leq d_{L}(X, Y)+C
$$

where $C$ is a positive constant depending on $\epsilon_{0}$.

### 5.3. Further study.

Note that the constant $C=C\left(\epsilon_{0}\right)$ in Theorem 1.5 only depend on $\epsilon_{0}$.
Problem 5.4. Does the constant $C=C\left(\epsilon_{0}\right)$ in Theorem 1.5 tends to 0 as $\epsilon_{0}$ tends to 0 ?

It was shown in 16 that for surfaces of finite type with boundary,

$$
\begin{equation*}
\log \sup _{\alpha \in \mathcal{B}(S) \cup \mathcal{C}(S)}\left\{\frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}\right\}=\log \sup _{\alpha \in \mathcal{B}(S) \cup \partial S}\left\{\frac{\ell_{X}(\alpha)}{\ell_{Y}(\alpha)}\right\} \tag{36}
\end{equation*}
$$

for any $X, Y \in \mathcal{T}(S)$. This gives new formulae for Thurston's metric and the arc-length spectrum metric. The above equality (36) was proved by using Thurston's theory of measured laminations.

Problem 5.5. Does the equality (36) hold on Teichmüller spaces of surfaces of infinite type?
