# CYCLE CONNECTIVITY AND PSEUDOCONCAVITY OF FLAG DOMAINS

ABSTRACT. We prove that a non-classical flag domain is pseudoconcave if it satisfies a certain condition on the root system. Moreover, we prove that every point in a codimension-one real boundary orbit of a non-classical period domains is a pseudoconcave boundary point if it satisfies a certain Hodgetheoretical condition.

## 1. INTRODUCTION

Flag domains are open real group orbits in flag manifolds. The simplest example of flag domain is open orbits in  $\mathbb{P}^1(\mathbb{C})$ . The projective line  $\mathbb{P}^1(\mathbb{C})$  is a flag manifold with the holomorphic action of  $SL(2, \mathbb{C})$ , which has the three real forms  $SL(2, \mathbb{R})$ , SU(1, 1), and SU(2). Here the upper/lower-half planes are open  $SL(2, \mathbb{R})$ -orbits, the unit disks around 0 and  $\infty$  are open SU(1, 1)-orbits, and  $\mathbb{P}^1(\mathbb{C})$  itself is the SU(2)-orbit. In general, there are finitely many open real group orbits in flag manifolds, and study on flag domains has been developed by complex geometers (cf. [FHW]). Flag domains are classified into two kinds; classical or non-classical. Here we say a flag domain is non-classical if it has no non-constant holomorphic function. A classical flag domain is almost like a Hermitian symmetric domain and is well-studied, however a non-classical one is not. In this paper, we investigate non-classical flag domains. In particular, we focus on their cycle connectivity and pseudoconcavity.

Cycle connectivity of flag domains are investigated by Huckleberry [Huc2] and Green, Robles and Toledo [GRT]. We recall it briefly. Let  $\check{D}$  be a flag manifold with a holomorphic action of a connected complex semisimple Lie group G. Let Dbe an open  $G_{\mathbb{R}}$ -orbit contained in  $\check{D}$  with a real form  $G_{\mathbb{R}}$ . For a base point  $o \in D$ , we have the parabolic subgroup P of G stabilizing o and  $G_{\mathbb{R}} \cap P$  contains a  $\theta$ stable fundamental Cartan subgroup with a Cartan involution  $\theta$ . For the maximal compact subgroup  $K_{\mathbb{R}}$  fixed by  $\theta$ , the  $K_{\mathbb{R}}$ -orbit  $C_0 = K_{\mathbb{R}}o$  is a compact submanifold contained in D. A flag domain D is non-classical if and only if any two points of D are connected by a connected chain  $g_1C_0 \cup \cdots \cup g_\ell C_0$  contained in D with  $g_1, \ldots, g_\ell \in G$ .

The other property we discuss in this paper is pseudoconcavity. We say D is pseudoconcave if D contains a relatively compact subset where a Levi form on every boundary point has at least one negative eigenvalue. Pseudoconcavity of complex manifolds is studied by Andreotti and Grauert in 1960's. Pseudoconcave manifolds are a generalization of compact complex manifolds, which behave like compact complex manifolds in many ways. For instance, if D is pseudoconcave,  $H^0(D, \mathcal{O}) = \mathbb{C}$ and dim  $H^0(D, E) < \infty$  (the finiteness theorem) for any holomorphic vector bundle E. Moreover, the field of all meromorphic functions on a pseudoconcave manifold D

is an algebraic field of transcendental degree less than  $\dim D$ . Huckleberry [Huc1] proved that classical flag domains are not pseudoconcave but pseudoconvex.

Cycle connectivity and pseudoconcavity are closely related. Huckleberry introduced *one-connectivity* in [Huc1]. One-connectivity is cycle connectivity in a strong sense, which requires that any two points are connected by a single cycle  $gC_0$  with some  $g \in G$ . He showed that D is pseudoconcave if D is generically one-connected. For example, D is generically one-connected if  $G_{\mathbb{R}} = SL(n, \mathbb{R})$ , however we do not completely know what kind of flag domain this property holds. In [GGK2, Lecture 10], Green, Griffiths and Kerr examined pseudoconcavity of the Carayol domain (Example 3.8) by an argument about boundary behavior of its cycle space. On the other hand, Kollár [Ko] proved the finiteness theorem for every non-classical flag domains by using their cycle connectivity without pseudoconcavity. Huckleberry conjectured that any non-classical flag domain is pseudoconcave.

Our purpose of this paper is to give a sufficient condition for non-classical flag domains to be pseudoconcave, which [Huc1] did not reach. In the Lie algebra level, we have the  $\theta$ -stable Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}} \subset \mathfrak{g}_{\mathbb{R}} \cap \mathfrak{p}$  and the maximal compact subalgebra  $\mathfrak{k}_{\mathbb{R}}$  fixed by  $\theta$ . Let  $\Delta$  be the set of roots. Then we have the graded Lie algebra decomposition  $\mathfrak{g} = \mathfrak{g}^{-k} \oplus \cdots \oplus \mathfrak{g}^k$  defined by a subset of the simple roots such that  $\mathfrak{p} = \bigoplus_{\ell \geq 0} \mathfrak{g}^{\ell}$ . We say a root  $\alpha \in \Delta$  is compact (resp. non-compact) if  $\alpha \in \Delta(\mathfrak{k})$  (resp.  $\alpha \in \Delta(\mathfrak{k}^{\perp})$ ).

**Theorem 1.1.** Suppose that there exist a compact root  $\beta$  such that for any noncompact root  $\alpha$  in  $\Delta(\mathfrak{g}^{<0})$  the  $\beta$ -string containing  $\alpha$  is one of the following:

- $\{\alpha, \alpha + \beta\}$  with  $\alpha + \beta \in \Delta(\mathfrak{p})$ ;
- $\{\alpha, \alpha + \beta, \alpha + 2\beta\}$  with  $\alpha + 2\beta \in \Delta(\mathfrak{p})$ .

Then D is pseudoconcave.

Our study is motivated by Hodge theory. A rational Hodge structure defines a rational algebraic group called a Mumford–Tate group, and an orbit of a real Mumford–Tate group is called a Mumford–Tate domain, which is a measurable flag domain (cf. [GGK1]). For example, a period domain (cf. [CG]) is a Mumford–Tate domain of a special kind. We give two examples of Mumford–Tate domain where the above theorem holds (Example 3.8–3.9).

In the latter half of this paper, we discuss pseudoconcavity at a boundary point of D in a real codimension-one  $G_{\mathbb{R}}$ -orbit for a non-classical period domain D. In this case  $G_{\mathbb{R}}$  is Sp(2n) or SO(p,q) depending on its Hodge numbers. Now the boundary bd(D) in  $\check{D}$  is the disjoint union of finitely many boundary  $G_{\mathbb{R}}$ -orbits. For a real codimension-one  $G_{\mathbb{R}}$ -orbit  $\mathcal{O}$ , we may consider a Levi form and define pseudoconcavity at a point in  $\mathcal{O}$ . By transitivity of  $G_{\mathbb{R}}$  acting on D, every point in  $\mathcal{O}$  is pseudoconcave boundary point of D if one point in  $\mathcal{O}$  is. We then say a codimension-one  $G_{\mathbb{R}}$ -orbit  $\mathcal{O}$  is a pseudoconcave boundary orbit of D if a point in  $\mathcal{O}$  is pseudoconcave boundary point of D.

Boundary  $G_{\mathbb{R}}$ -orbits have a relationship with degeneration of Hodge structures. By the nilpotent orbit theorem [S], degenerating Hodge structures over a product of punctured disks are asymptotically approximated by nilpotent orbits. A nilpotent orbit is generated by a pair consisting of  $N \in \mathfrak{g}_{\mathbb{R}}$  and  $F^{\bullet} \in \check{D}$ , and the limit point  $\lim_{\mathrm{Im}(z)\to\infty} \exp(zN) =: F_{\infty}^{\bullet} \in \check{D}$ , which is called the reduced limit, is in a boundary  $G_{\mathbb{R}}$ -orbit. A boundary  $G_{\mathbb{R}}$ -orbit is said to be poralizable if it is a  $G_{\mathbb{R}}$ -orbit of a reduced limit. Remark that *not* every boundary  $G_{\mathbb{R}}$ -orbits are polarizable. Green, Griffiths and Kerr [GGK2] and Kerr and Pearlstein [KP] showed that any codimension-one boundary  $G_{\mathbb{R}}$ -orbit  $\mathcal{O}$  is polarizable. We then have a nilpotent orbit  $(N, F^{\bullet})$  so that the reduced limit  $F_{\infty}^{\bullet}$  is in  $\mathcal{O}$ , which is called a *minimal degeneration*. Minimal degenerations are studied by Green, Griffiths and Robles [GGR]. In Theorem 4.4, we will give a sufficient condition of  $(N, F^{\bullet})$  for  $\mathcal{O}$  to be a pseudoconcave boundary orbit examining minimal degenerations.

In this paper, we do not deal with degree of pseudoconcavity, and we leave it open. If a flag domain D is q-pseudoconcave in the sense of Andreotti-Grauert, we have the finiteness theorem for cohomology groups of degree less than dim D-q-1 with locally free sheaves. In addition, it is speculated that the finiteness theorem is true for degree less than dim  $C_0$  in [GGK2, Lecture 10] as an open question.

## 2. PSEUDOCONCAVITY OF COMPLEX MANIFOLDS

We recall pseudoconcavity of complex manifolds following [A]. Let  $\Omega$  be an open subset of  $\mathbb{C}^n$  with a smooth boundary. For every point  $z_0$  in the boundary  $\mathrm{bd}(\Omega)$ , we can find a neighborhood  $U_{z_0}$  of  $z_0$  and a  $C^{\infty}$ -function  $\phi: U_{z_0} \to \mathbb{R}$  such that

$$(\mathrm{d}\phi)_{z_0} \neq 0, \quad \Omega \cap U_{z_0} = \{ z \in U_{z_0} \mid \phi(z) < \phi(z_0) \}.$$

The real tangent plane at  $z_0$  to  $bd(\Omega)$  contains the (n-1)-dimensional complex plane defined by the equation

$$\sum_{k} \frac{\partial \phi}{\partial z^{k}}(z_{0})(z^{k} - z_{0}^{k}) = 0$$

with the coordinate function  $z^1, \ldots, z^n$ . This is called the analytic tangent plane. Since  $\phi$  is real-valued, the quadratic form

$$L(\phi)_{z_0}(z) := \sum_{k,\ell} \frac{\partial^2 \phi}{\partial z^k \partial \bar{z}^\ell}(z_0) z^k \bar{z}^\ell,$$

is Hermitian, which is called the Levi form. The boundary point  $z_0$  is said to be pseudoconcave if the Levi form has at least one negative eigenvalue on the analytic tangent plane. Remark that the number of positive/negative eigenvalues does not depend on the choice of coordinate function and defining function. We may assume  $z_0 = 0$  and  $\phi(0) = 0$ , and we may change the coordinate so that the Tayler expansion of  $\phi$  at 0 is

$$\phi(z) = 2\operatorname{Re}(z^1) + L_0(\phi)(z) + O(||z||^3)$$

and the Levi form restricted to the analytic tangent plane  $T_0(\mathrm{bd}(\Omega))$ , defined by  $z^1 = 0$ , is

$$L(\phi)_0|_{T_0(\mathrm{bd}(\Omega))}(z) = \sum_{k\geq 2}^n \lambda_k |z^k|^2$$

with eigenvalues  $\lambda_2, \ldots, \lambda_n$ . If 0 is a pseudoconcave boundary point, we have at least one negative eigenvalue, then we have a holomorphic map  $\rho : \mathbb{D} \to c\ell(\Omega)$  from the unit disk such that  $\rho(0) = 0$  and  $bd(\rho(\mathbb{D})) \subset \Omega$ . On the other hand, if 0 is not a pseudoconcave boundary point, we do not have such a holomorphic map. We then define pseudoconcavity of complex manifolds as follows:

**Definition 2.1.** Let X be a connected complex manifold. We say X is pseudoconcave if there exists a relatively compact open subset U with a smooth boundary such that at every point  $z \in bd(U)$  a holomorphic map  $\rho : \mathbb{D} \to c\ell(U)$  where  $\rho(0) = z$  and  $bd(\rho(\mathbb{D})) \subset U$  exists.

**Example 2.2.** (1) Every compact complex connected manifold is pseudoconcave.

(2) Let Z be a compact complex connected manifold of dimension greater than 2 and let Y be a complex submanifold with dim  $Y \leq \dim Z - 2$ . Then Z - Y is pseudoconcave.

## 3. FLAG DOMAINS

We review flag domains and their root structure, and then we prove Theorem 1.1. This proof is based on technique of [Huc1, §3.2]. The key point of Huckleberry's proof is to construct a relatively compact neighborhood of the base cycle  $C_0$  which is filled out by cycles and where any points are one-connected to  $C_0$ . We construct such a neighborhood in Lemma 3.7. Here Cayley transform associated with compact root plays important role.

3.1. **Parabolic subalgebras.** Let  $\mathfrak{g}$  be a complex semisimple Lie algebra, and let  $\mathfrak{p}$  be a parabolic subgroup. Let  $\mathfrak{g}_{\mathbb{R}}$  be a real form of  $\mathfrak{g}$ . We fix a Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}} \subset \mathfrak{g}_{\mathbb{R}} \cap \mathfrak{p}$  and choose a Borel subgroup  $\mathfrak{b} \subset \mathfrak{p}$  containing the Cartan subgroup  $\mathfrak{h} := \mathfrak{h}_{\mathbb{R}} \otimes \mathbb{C}$ . The Cartan subalgebra  $\mathfrak{h}$  determines a set  $\Delta = \Delta(\mathfrak{g}, \mathfrak{h}) \subset \mathfrak{h}^*$  of roots. A root  $\alpha \in \Delta$  defines the root space  $\mathfrak{g}^{\alpha}$ , and we have the root space decomposition  $\mathfrak{g} = \mathfrak{h} \oplus \bigoplus_{\alpha \in \Delta} \mathfrak{g}^{\alpha}$ . For a subalgebra  $\mathfrak{s}$ , we denote by  $\Delta(\mathfrak{s})$  the subset of roots of which root spaces contained in  $\mathfrak{s}$ . The Borel subalgebra  $\mathfrak{b}$  defines a positive root system by

$$\Delta^+ := \Delta(\mathfrak{b}) = \{ \alpha \in \Delta \mid \mathfrak{g}^\alpha \subset \mathfrak{b} \}.$$

Let  $S = \{\sigma_1, \ldots, \sigma_r\}$  be the set of simple roots, and let  $\{S^1, \ldots, S^r\}$  be the dual basis to S. An integral linear combination  $E = \sum_j n_j S^j$  is called a grading element. The E-eigenspaces

$$\mathfrak{g}^\ell = igoplus_{lpha(\mathrm{E})=\ell} \mathfrak{g}^lpha, \quad \mathfrak{g}^0 = \mathfrak{h} \oplus igoplus_{lpha(\mathrm{E})=0} \mathfrak{g}^lpha$$

determines a graded Lie algebra decomposition  $\mathfrak{g} = \mathfrak{g}^{-k} \oplus \cdots \oplus \mathfrak{g}^k$  in the sense that  $[\mathfrak{g}^\ell, \mathfrak{g}^m] \subset \mathfrak{g}^{\ell+m}$ . A grading  $\mathtt{E}$  defines a parabolic subalgebra  $\mathfrak{p}_{\mathtt{E}} = \bigoplus_{\ell \ge 0} \mathfrak{g}^\ell$ . On the other hand, setting

$$I(\mathfrak{p}) = \{i \mid \mathfrak{g}^{-\sigma_i} \not\subset \mathfrak{p}\},\$$

the parabolic subalgebra  $\mathfrak{p}_{\mathsf{E}}$  defined by  $\mathsf{E} = \sum_{i \in I(\mathfrak{p})} \mathsf{S}^i$  coincides with  $\mathfrak{p}$ .

We review Chevalley basis and their properties (cf. [Hum, §25]). Since the Killing form defines a non-degenerate negative-definite symmetric form on  $\mathfrak{h}_{\mathbb{R}}$ , we have the induced form  $(\bullet, \bullet)$  on  $\mathfrak{h}_{\mathbb{R}}^*$ . Let  $\alpha \in \Delta \cup \{0\}$  and let  $\beta \in \Delta$ . The set of all members of  $\Delta \cup \{0\}$  of the form  $\alpha + n\beta$  for  $n \in \mathbb{Z}$  is called the  $\beta$ -string containing  $\alpha$ . Then the  $\beta$ -string containing  $\alpha$  is given by

(3.1) 
$$\{\alpha + n\beta \mid -r \le n \le q\}.$$

If  $\alpha$  and  $\beta$  are linearly independent, we have

$$\langle \alpha, \beta \rangle := 2 \frac{(\alpha, \beta)}{(\beta, \beta)} = r - q.$$

We can choose  $\mathbb{H}^{\alpha} \in \mathfrak{h}$  and  $x^{\alpha} \in \mathfrak{g}^{\alpha}$  for all  $\alpha \in \Delta$  satisfying

$$\begin{split} [x^{\alpha}, x^{-\alpha}] &= \mathsf{H}^{\alpha}, \quad [\mathsf{H}^{\beta}, x^{\alpha}] = \langle \alpha, \beta \rangle x^{\alpha}, \\ [x^{\alpha}, x^{\beta}] &= \begin{cases} c_{\alpha, \beta} x^{\alpha+\beta} & \text{if } \alpha + \beta \in \Delta \\ 0 & \text{if } \alpha + \beta \notin \Delta \end{cases} \\ \text{where } c_{\alpha, \beta} &= -c_{-\alpha, -\beta} \in \mathbb{Z}. \end{split}$$

Here  $c_{\beta,\alpha} = \pm (r+1)$  if  $\alpha$  and  $\beta$  are linearly independent and  $\alpha + \beta \in \Delta$ . Now

 $\{x^{\alpha} \mid \alpha \in \Delta\} \cup \{\mathbf{H}^{\sigma} \mid \sigma \in \mathcal{S}\}\$ 

is a basis of  $\mathfrak{g}$ , which is called a Chevalley basis.

**Lemma 3.1** ([Hum, §25.2]). If  $\alpha$  and  $\beta$  are linearly independent, then

$$[x^{-\beta}, [x^{\beta}, x^{\alpha}]] = q(r+1)x^{\alpha}$$

where (r, q) is given by the form (3.1).

**Example 3.2** ( $\mathfrak{g} = \mathfrak{sl}_2(\mathbb{C})$ ). A basis of  $\mathfrak{g}_{\mathbb{R}} = \mathfrak{sl}_2(\mathbb{R})$  is given by

$$x^{\alpha} = \begin{pmatrix} 0 & 1 \\ 0 & 0 \end{pmatrix}, \quad \mathbf{H}^{\alpha} = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, \quad x^{-\alpha} = \begin{pmatrix} 0 & 0 \\ 1 & 0 \end{pmatrix}.$$

Here  $\mathfrak{h} = \mathbb{C}\mathfrak{H}^{\alpha}$  is a Cartan subalgebra, and  $x^{\pm \alpha}$  is in the root space  $\mathfrak{g}^{\pm \alpha}$  where  $\alpha$  is the root given by  $\alpha(\mathfrak{H}^{\alpha}) = 2$ . This triple satisfies

(3.2) 
$$[x^{\alpha}, x^{-\alpha}] = \mathbf{H}^{\alpha}, \quad [\mathbf{H}^{\alpha}, x^{\alpha}] = 2x^{\alpha}, \quad [\mathbf{H}^{\alpha}, x^{-\alpha}] = -2x^{-\alpha}.$$

In this case,  $\Delta = \{\pm \alpha\}$  and we set  $\alpha$  as a positive root. We define a grading  $\mathbf{E} = \mathbf{S}$  where  $\mathbf{S}$  is the dual of  $\alpha$ . Then

$$\mathfrak{g}^1 = \mathfrak{g}^{\alpha}, \quad \mathfrak{g}^0 = \mathfrak{h}, \quad \mathfrak{g}^{-1} = \mathfrak{g}^{-\alpha},$$

and  $\mathfrak{p}_{\mathsf{E}} = \mathfrak{g}^1 \oplus \mathfrak{g}^0$ .

In general, a triple in a semisimple Lie algebra satisfying (3.2) is called a standard  $sl_2$ -triple.

3.2. Flag domains and Cayley transforms. In the Lie group level, we have the parabolic subgroup  $P \subset G$  corresponding to  $\mathfrak{p} \subset \mathfrak{g}$ . The homogeneous manifold  $\check{D} = G/P$  is called a flag manifold. We fix a Cartan involution of  $\mathfrak{g}_{\mathbb{R}}$ . Let  $\mathfrak{p}_x$  be the Lie algebra of the parabolic subgroup  $P_x$  of G stabilizing  $x \in \check{D}$ . By [FHW, Theorem 4.2.2], the  $G_{\mathbb{R}}$ -orbit  $G_{\mathbb{R}}x$  is open if and only if  $\mathfrak{p}_x = \mathfrak{p}_{\mathbb{E}}$  where

- $\mathfrak{g}_{\mathbb{R}} \cap \mathfrak{p}_x$  contains a fundamental Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}}$ , and
- E is an integral linear combination of a set of simple roots for a system  $\Delta^+ \subset \Delta = \Delta(\mathfrak{g}, \mathfrak{h})$  with  $\mathfrak{h} = \mathfrak{h}_{\mathbb{R}} \otimes \mathbb{C}$  such that  $\tau \Delta^+ = -\Delta^+$  for the complex conjugation  $\tau$ .

An open  $G_{\mathbb{R}}$ -orbit is called a flag domain. Let D be a flag domain contained in  $\check{D}$ , and fix a base point  $o \in D$ . We may assume  $\mathfrak{p} = \mathfrak{p}_o$ . There exists a fundamental Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}} \subset \mathfrak{g}_{\mathbb{R}} \cap \mathfrak{p}$ , a positive root system  $\Delta^+$ , and a grading  $\mathsf{E}$  such that  $\mathfrak{p} = \mathfrak{p}_{\mathsf{E}}$ . We may choose a Chevalley basis of  $\mathfrak{g}$ . We define the Cayley transform  $\mathbf{c}_{\alpha}$  for  $\alpha \in \Delta$  by

$$\mathbf{c}_{\alpha} = \exp\left(\frac{\pi}{4}(x^{-\alpha} - x^{\alpha})\right).$$

**Remark 3.3.** Usually, Cayley transforms of the above form are defined for noncompact imaginary roots as [Kn, §VI.7]. We use a Cayley transform for a *compact* root in the proof of Theorem 1.1.

**Example 3.4** ( $\mathfrak{g} = \mathfrak{sl}_2(\mathbb{C})$ ). This is continuation of Example 3.2. Let us consider the three real forms  $\mathfrak{su}(2)$ ,  $\mathfrak{su}(1,1)$ , and  $\mathfrak{sl}(2,\mathbb{R})$  of  $\mathfrak{sl}(2,\mathbb{C})$ . We set

$$\begin{split} u^{\alpha} &:= x^{\alpha} - x^{-\alpha} = \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \quad h^{1} := \mathbf{i} \mathbb{H}^{\alpha} = \mathbf{i} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, \\ v^{\alpha} &:= \mathbf{i} (x^{\alpha} + x^{-\alpha}) = \mathbf{i} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \end{split}$$

where  $\mathbf{i} = \sqrt{-1}$ . Then

$$\begin{aligned} \mathfrak{su}(2) &= \mathbb{R}u^{\alpha} + \mathbb{R}h^{1} + \mathbb{R}v^{\alpha}, \quad \mathfrak{su}(1,1) = \mathbb{R}\mathbf{i}u^{\alpha} + \mathbb{R}h^{1} + \mathbb{R}\mathbf{i}v^{\alpha}, \\ \mathfrak{sl}(2,\mathbb{R}) &= \mathbb{R}x^{\alpha} + \mathbb{R}\mathbf{H}^{\alpha} + \mathbb{R}x^{-\alpha} = \mathbb{R}(u_{\alpha} - \mathbf{i}v_{\alpha}) + \mathbb{R}\mathbf{i}h^{1} + \mathbb{R}(u_{\alpha} + \mathbf{i}v_{\alpha}). \end{aligned}$$

The *G*-orbit  $\check{D}$  is  $\mathbb{P}^1(\mathbb{C})$  in this case. Each real group orbits of  $o = \begin{pmatrix} 1 \\ 0 \end{pmatrix} \in \check{D}$  are

$$\mathbb{P}^{1}(\mathbb{C}), \quad \left\{ \begin{pmatrix} 1\\z \end{pmatrix} \; ; \; |z| < 1 \right\}, \quad \left\{ \begin{pmatrix} 1\\y \end{pmatrix} \; ; \; y \in \mathbb{R} \right\} \cup \left\{ \begin{pmatrix} 0\\1 \end{pmatrix} \right\}$$

In a case where  $\mathfrak{g}_{\mathbb{R}}$  is  $\mathfrak{su}(2)$  or  $\mathfrak{su}(1,1)$ , the Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}} = \mathfrak{p} \cap \mathfrak{g}_{\mathbb{R}} = \mathbb{R}h^1$  is compact and  $\tau x^{\alpha} = x^{-\alpha}$  for the complex conjugate  $\tau$ . On the other hand, in the case where  $\mathfrak{g}_{\mathbb{R}}$  is  $\mathfrak{sl}(2,\mathbb{R})$ , the Cartan subalgebra  $\mathfrak{h}_{\mathbb{R}} = \mathfrak{p} \cap \mathfrak{g}_{\mathbb{R}} = \mathbb{R}\mathbf{i}h^1$  is noncompact and  $\tau x^{\alpha} = x^{\alpha}$ . The Cayley transform for  $\alpha$  is

$$\mathbf{c}_{\alpha} = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & -1 \\ 1 & 1 \end{pmatrix}.$$

We then have

$$\mathbf{c}_{\alpha}(o) = \begin{pmatrix} 1\\ 1 \end{pmatrix}, \quad \mathbf{c}_{\alpha}^{2}(o) = \begin{pmatrix} 0\\ 1 \end{pmatrix}.$$

**Proposition 3.5.** If  $\alpha$  and  $\beta$  are linearly independent, then

$$\operatorname{Ad}(\mathbf{c}_{-\beta}^{2})x^{\alpha} = \begin{cases} \pm x^{\alpha+\beta} & \text{if } (r,q) = (0,1), \\ \pm x^{\alpha+2\beta} & \text{if } (r,q) = (0,2) \end{cases}$$

where (r, q) is given by the form (3.1).

*Proof.* First, we consider the case for (r,q) = (0,1). Since  $\alpha - \beta \notin \Delta$ ,

ad 
$$(x^{\beta} - x^{-\beta})x^{\alpha}$$
 = ad  $(x^{\beta})x^{\alpha} = c_{\beta,\alpha}x^{\alpha+\beta}$ 

By Lemma 3.1,

$$[x^{-\beta}, [x^{\beta}, x^{\alpha}]] = x^{\alpha}.$$

Then

$$(\mathrm{ad}\,(x^{\beta} - x^{-\beta}))^2 x^{\alpha} = -[x^{-\beta}, [x^{\beta}, x^{\alpha}]] = -x^{\alpha}$$

Therefore

Ad 
$$(\exp\left(\frac{\pi}{2}(x^{\beta}-x^{-\beta})\right))x^{\alpha} = \sum_{\ell=0}^{\infty} \frac{(-1)^{2\ell}}{(2\ell)!} (\frac{\pi}{2})^{2\ell} x^{\alpha} + \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2k+1)!} (\frac{\pi}{2})^{2k+1} c_{\beta,\alpha} x^{\alpha+\beta}$$
  
$$= \cos\left(\frac{\pi}{2}\right) x^{\alpha} + \sin\left(\frac{\pi}{2}\right) c_{\beta,\alpha} x^{\alpha+\beta} = c_{\beta,\alpha} x^{\alpha+\beta}$$

Since  $c_{\beta,\alpha} = \pm 1$ , the equation holds.

Next, we consider the case for (r, q) = (0, 2). As is the case for (r, q) = (0, 1), we have

$$\mathrm{ad}\,(x^\beta-x^{-\beta})x^\alpha=c_{\beta,\alpha}x^{\alpha+\beta},\quad [x^{-\beta},[x^\beta,x^\alpha]]=2x^\beta$$

Then

$$(\mathrm{ad}\,(x^{\beta} - x^{-\beta}))^2 x^{\alpha} = c_{\beta,\alpha+\beta} c_{\beta,\alpha} x^{\alpha+2\beta} - 2x^{\alpha}.$$

By Lemma 3.1,

$$[x^{\beta}, [x^{-\beta}, x^{\alpha+2\beta}]] = 2x^{\alpha+2\beta}.$$

On the other hand,

$$[x^{\beta}, [x^{-\beta}, x^{\alpha+2\beta}]] = c_{\beta,\alpha+\beta}c_{-\beta,\alpha+2\beta}x^{\alpha+2\beta}.$$

Then  $c_{\beta,\alpha+\beta}c_{-\beta,\alpha+2\beta} = 2$ . Therefore,

$$(\mathrm{ad}\,(x^{\beta}-x^{-\beta}))^3x^{\alpha} = -c_{-\beta,\alpha+2\beta}c_{\beta,\alpha+\beta}c_{\beta,\alpha}x^{\alpha+\beta} - 2c_{\beta,\alpha}x^{\alpha+\beta} = -4c_{\beta,\alpha}x^{\alpha+\beta}.$$

To summarize the above calculations, we have

Ad 
$$(\exp\left(\frac{\pi}{2}(x^{\beta}-x^{-\beta})\right))x^{\alpha} = x^{\alpha} + \sum_{k=0}^{\infty} \frac{1}{(2k+1)!} (\frac{\pi}{2})^{2k+1} (-4)^{k} c_{\beta,\alpha} x^{\alpha+\beta}$$
  
+  $\sum_{\ell=1}^{\infty} \frac{1}{(2\ell)!} (\frac{\pi}{2})^{2\ell} (-4)^{\ell-1} (c_{\beta,\alpha+\beta} c_{\beta,\alpha} x^{\alpha+2\beta} - 2x^{\alpha})$ 

where

$$\sum_{k=0}^{\infty} \frac{1}{(2k+1)!} (\frac{\pi}{2})^{2k+1} (-4)^k = \frac{1}{2} \sum_{k=0}^{\infty} \frac{(-1)^k}{(2k+1)!} (\frac{\pi}{2})^{2k+1} 2^{2k+1} = \frac{1}{2} \sin \pi = 0,$$
  
$$\sum_{\ell=1}^{\infty} \frac{1}{(2\ell)!} (\frac{\pi}{2})^{2\ell} (-4)^{\ell-1} = -\frac{1}{4} \sum_{\ell=1}^{\infty} \frac{(-1)^\ell}{(2\ell)!} (\frac{\pi}{2})^{2\ell} 2^{2\ell} = -\frac{1}{4} (\cos \pi - 1) = \frac{1}{2}.$$

Hence

Ad 
$$\left(\exp\left(\frac{\pi}{2}(x^{\beta}-x^{-\beta})\right)\right)x^{\alpha}=\frac{1}{2}c_{\beta,\alpha+\beta}c_{\beta,\alpha}x^{\alpha+2\beta}.$$

Since  $c_{\beta,\alpha+\beta} = \pm 2$  and  $c_{\beta,\alpha} = \pm 1$ , the equation holds.

In the case for (r,q) = (1,0) or (r,q) = (2,0), the same equation holds if  $\beta$  is replaced by  $-\beta$ .

**Remark 3.6.** The proof of Proposition 3.5 looks similar to the one of [Kn, Proposition 6.72]. However, the latter one requires that  $\beta$  is orthogonal to  $\alpha$ , i.e. r = q.

3.3. **Proof of Theorem 1.1.** There exists a Cartan involution  $\theta$  of  $\mathfrak{g}_{\mathbb{R}}$  such that  $\mathfrak{h}_{\mathbb{R}}$  is a  $\theta$ -stable fundamental Cartan subalgebra. Let  $\mathfrak{g}_{\mathbb{R}} = \mathfrak{k}_{\mathbb{R}} \oplus \mathfrak{k}_{\mathbb{R}}^{\perp}$  be the Cartan decomposition associated with  $\theta$ . We set the base cycle  $C_0 = K_{\mathbb{R}}o$  with the maximal compact subgroup  $K_{\mathbb{R}}$  corresponding to  $\mathfrak{k}_{\mathbb{R}}$ . By [FHW, Theorem 4.3.1], the base cycle  $C_0$  is a compact complex manifold satisfying  $C_0 = Ko$  with  $K = K_{\mathbb{R}} \otimes \mathbb{C}$ .

**Lemma 3.7.** Suppose that there exists a compact root  $\beta$  satisfying the condition of Theorem 1.1. We choose a sufficiently small  $\varepsilon > 0$  so that

$$\mathcal{K} := \left\{ \begin{array}{c} k \prod_{i=1}^{\ell} \exp\left(\varepsilon_{i} x^{\alpha_{i}}\right) z \end{array} \middle| \begin{array}{c} k \in K_{\mathbb{R}}, \ z \in C_{0} \\ \sum_{i} |\varepsilon_{i}|^{2} \le \varepsilon \end{array} \right\}$$

is contained in D where  $\{\alpha_1, \ldots, \alpha_\ell\} = \Delta(\mathfrak{k}^\perp) \cap \Delta(\mathfrak{g}^{<0})$ . Then int  $(\mathcal{K})$  is a relatively compact subset containing  $C_0$ . Moreover, for every point z' in  $\mathcal{K}$ , there exists  $gC_0 \subset \mathcal{K}$  with  $g \in G$  such that  $C_0 \cap gC_0 \neq \emptyset$  and  $z' \in gC_0$ .

*Proof.* Let  $U_o$  be an open neighbourhood of o in  $C_0$ . Since  $\{\prod_{i=1}^{\ell} \exp(\varepsilon_i x^{\alpha_i}) z; |\varepsilon_i| < \varepsilon, z \in U_o\}$  is an open neighborhood of o in D and  $K_{\mathbb{R}}$  acts on  $C_0$  transitively, int  $(\mathcal{K})$  is a relatively compact open subset containing  $C_0$ . Let  $z' = k\xi z \in \mathcal{K}$  where  $k \in K_{\mathbb{R}}$ ,  $z \in C_0$ , and

$$\xi = \prod_{i=1}^{\ell} \exp\left(\varepsilon_i x^{\alpha_i}\right)$$

with  $\sum_i |\varepsilon_i|^2 \leq \varepsilon$ . Since  $z' \in k\xi C_0$ , it is enough to show  $k\xi C_0 \cap C_0 \neq \emptyset$ . Now we have

$$\operatorname{Ad}^{G}(\mathbf{c}_{-\beta}^{2})\xi = \prod_{i=1}^{\ell} \exp\left(\varepsilon_{i} \operatorname{Ad}\left(\mathbf{c}_{-\beta}^{2}\right) x^{\alpha_{i}}\right)$$

where  $\operatorname{Ad}^{G}$  is the adjoint action on G. By Proposition 3.5 and the hypothesis,  $\operatorname{Ad}(\mathbf{c}_{-\beta}^{2})x^{\alpha_{i}} \in \mathfrak{p}$ , therefore  $\operatorname{Ad}^{G}(\mathbf{c}_{-\beta}^{2})\xi \in P$ . Then  $\operatorname{Ad}^{G}(\mathbf{c}_{-\beta}^{2})(\xi)o = o$ , and hence  $\xi \mathbf{c}_{\beta}^{2}(o) = \mathbf{c}_{\beta}^{2}(o)$ . Since  $\mathbf{c}_{\beta} \in K$  and K acts on  $C_{0}$  transitively,  $\mathbf{c}_{\beta}^{2}(o) \in C_{0} \cap \xi C_{0}$ . It concludes that  $k\mathbf{c}_{\beta}^{2}(o) \in C_{0} \cap k\xi C_{0}$ .

By applying the above  $\mathcal{K}$  to the proof of [Huc1, Theorem 3.7], we complete the proof. To show pseudoconcavity at any point  $z \in \mathrm{bd}(\mathcal{K})$ , we need to construct a disk  $\mathbb{D}$  about z such that  $\mathrm{bd}(\mathbb{D}) \subset \mathrm{int}(\mathcal{K})$ . By the above lemma, we have  $gC_0 \subset \mathcal{K}$  with  $g \in G$  containing z such that there exists a point  $z_0 \in gC_0 \cap C_0$ . We may construct  $Z \subset gC_0$  with  $z \in Z$  and  $Z \cong \mathbb{P}^1(\mathbb{C})$  so that Z intersects an arbitrary neighborhood of  $z_0$ . We then choose  $y_0 \in \mathrm{int}(\mathcal{K}) \cap Z$  and define  $\mathbb{D}$  to be the complement in Z of the closure of a sufficiently small disk about  $y_0$  so that  $\mathrm{bd}(\mathbb{D}) \subset \mathrm{int}(\mathcal{K})$ . Therefore z is a pseudoconcave boundary point, and hence D is pseudoconcave.




FIGURE 1. The root diagram of  $\mathfrak{sl}(3,\mathbb{C})$

**Example 3.8.** Let D be the Mumford–Tate domain with  $G_{\mathbb{R}} = SU(2, 1)$  investigated by Carayol [C]. The root diagram is depicted in Figure 1, where compact roots are those within a box and the shaded area is a Weyl Chamber. The parabolic

subalgebra  $\mathfrak{p}$  is associated with  $\mathbf{E} = \mathbf{S}^1 + \mathbf{S}^2$ . Here  $\{-\sigma_1, -\sigma_2\} = \Delta(\mathfrak{k}^{\perp}) \cap \Delta(\mathfrak{g}^{<0})$ , and  $\sigma_1 + \sigma_2 \in \Delta(\mathfrak{k})$  satisfies the condition of Theorem 1.1. Hence D is pseudoconcave.




FIGURE 2. The root diagram of  $\mathfrak{so}(5,\mathbb{C})$ 

**Example 3.9.** Let *D* be the period domain with  $h^{2,0} = 2$  and  $h^{1,1} = 1$ . Then  $G_{\mathbb{R}} = SO(4,1)$ , and the root diagram is depicted in Figure 2. The parabolic subalgebra  $\mathfrak{p}$  is associated with  $\mathbf{E} = \mathbf{S}^1$ . Here  $\{-\sigma_1, -\sigma_1 - \sigma_2\} = \Delta(\mathfrak{k}^{\perp}) \cap \Delta(\mathfrak{g}^{<0})$ , and  $2\sigma_1 + \sigma_2 \in \Delta(\mathfrak{k})$  satisfies the condition. Hence *D* is pseudoconcave.

## 4. Period domains

We review minimal degeneration for period domains and prove Theorem 4.4. Strategy of this proof is similar to the one of Theorem 1.1. We will show that a certain boundary point and an interior point are connected by a single cycle  $gC_0$ , which induces pseudoconcavity at the boundary orbit. We examine  $sl_2$ -triples associated with minimal degenerations for this proof.

In this section, D is a period domain parametrizing Hodge structures of weight n with Hodge numbers  $\{h^{p,q}\}_{p+q=n}$  on a real vector space  $V_{\mathbb{R}}$  polarized by Q. Here

$$G_{\mathbb{R}} = \operatorname{Aut}\left(V_{\mathbb{R}}, Q\right) \cong \begin{cases} Sp(m, \mathbb{R}) & \text{if } n \text{ is odd,} \\ SO(m_{\mathrm{ev}}, m_{\mathrm{od}}) & \text{if } n \text{ is even} \end{cases}$$

where  $2m = \dim V$  if n is odd,  $m_{ev} = \sum_{p: even} h^{p,q}$  and  $m_{od} = \sum_{p: odd} h^{p,q}$  if n is even. We then have

$$D \cong \begin{cases} Sp(m,\mathbb{R})/\prod_{p < k} U(h^{p,q}) & \text{if } n = 2k+1, \\ SO(m_{\text{ev}}, m_{\text{od}})/(\prod_{p < k} U(h^{p,q}) \times SO(h^{k,k})) & \text{if } n = 2k. \end{cases}$$

If we choose a reference point in D, then the  $G_{\mathbb{R}}$ -orbit D is a flag domain contained in the G-orbit with  $G = \operatorname{Aut}(V_{\mathbb{C}}, Q)$ .

4.1. Nilpotent orbits and  $SL_2$ -orbits. We recall the nilpotent orbit theorem and the  $SL_2$ -orbit theorem of [S]. A pair  $(N, F^{\bullet})$  consisting of a nilpotent  $N \in \mathfrak{g}_{\mathbb{R}}$ , as an element of End  $(V_{\mathbb{R}})$ , and  $F^{\bullet} \in \check{D}$  is called a nilpotent orbit if it satisfies the following conditions:

- $\exp(zN)F^{\bullet} \in D$  if  $\operatorname{Im}(z)$  is sufficiently large;
- $NF^p \subset F^{p-1}$ .

For a nilpotent orbit  $(N, F^{\bullet})$ , there exists the monodromy weight filtration  $W_{\bullet} := W_{\bullet}(N)[-n]$ , and  $(W_{\bullet}, F^{\bullet})$  is a mixed Hodge structure, which is called the limit mixed Hodge structure.

Let  $(N, F^{\bullet})$  be a nilpotent orbit such that  $(W_{\bullet}, F^{\bullet})$  is split over  $\mathbb{R}$ , i.e. the Deligne decomposition

$$V_{\mathbb{C}} = \bigoplus_{p,q} I^{p,q}$$

is defined over  $\mathbb{R}$ . We define  $Y \in \mathfrak{g}_{\mathbb{R}}$  which acts on  $I^{p,q}$  by the scalar p+q-n and  $N^+ \in \mathfrak{g}_{\mathbb{R}}$  so that  $(N^+, Y, N)$  is a  $sl_2$ -triple in  $\mathfrak{g}_{\mathbb{R}}$ . The  $SL_2$ -orbit theorem guarantees existence of a homomorphism  $v : SL(2, \mathbb{R}) \to G_{\mathbb{R}}$  such that

$$v_* \begin{pmatrix} 0 & 1 \\ 0 & 0 \end{pmatrix} = N^+, \quad v_* \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} = Y, \quad v_* \begin{pmatrix} 0 & 0 \\ 1 & 0 \end{pmatrix} = N$$

and a  $SL_2(\mathbb{C})$ -equivalent horizontal holomorphic map  $\psi : \mathbb{P}^1(\mathbb{C}) \to \check{D}$  given by

$$\begin{pmatrix} 1\\z \end{pmatrix} \mapsto \exp{(zN)}F^{\bullet}$$

Here  $\exp(zN)F^{\bullet} \in D$  for  $\operatorname{Im}(z) > 0$ , and  $\psi$  defines a  $SL_2(\mathbb{R})$ -equivalent map from the upper half plane to D.

Let

$$\mathbf{d}_N := \exp\left(\mathbf{i}\frac{\pi}{4}(N^+ + N)\right).$$

We then have

$$\varphi := \mathbf{d}_N(F^{\bullet}) = \psi(\frac{1}{\sqrt{2}} \begin{pmatrix} 1 & \mathbf{i} \\ \mathbf{i} & 1 \end{pmatrix} \begin{pmatrix} 1 \\ 0 \end{pmatrix}) = \psi(\begin{pmatrix} 1 \\ \mathbf{i} \end{pmatrix}) \in D$$

which defines the Hodge decomposition

$$V_{\mathbb{C}} = \bigoplus V^{p,n-p}$$

and homomorphism  $\varphi: S^1 = \{z \in \mathbb{C} ; |z| = 1\} \to G_{\mathbb{R}}$  of real algebraic groups given by

$$\varphi(z)v = z^{2p-n}v \quad \text{for } v \in V^{p,n-p}.$$

The image  $\varphi(S^1)$  is contained in a compact maximal torus T ([GGK1, Proposition IV.A.2]), and we define the Cartan subalgebra  $\mathfrak{h} = \mathfrak{t} \otimes \mathbb{C}$ . The associated grading element is  $\mathbb{E}_{\varphi} = \frac{1}{4\pi \mathbf{i}} \varphi'(1) \in \mathfrak{t}$ , which satisfies

$$\mathsf{E}_{\varphi}v = \frac{2p-n}{2}v \quad \text{for } v \in V^{p,n-p}.$$

Now  $\varphi$  defines a weight-0 real Hodge structure on  $\mathfrak{g}$  with the polarization given by minus the Killing form *B*. Here the (p, -p)-component is the eigenspace

$$\mathfrak{g}^p = \{ X \in \mathfrak{g} \mid \operatorname{ad}(\mathtt{E}_{\varphi})X = pX \} = \{ X \in \mathfrak{g} \mid XV^{k,n-k} \subset V^{k+p,n-k-p} \}$$

The Lie algebra of the parabolic subgroup stabilizing  $\varphi$  is  $\mathfrak{p} = \bigoplus_{p\geq 0} \mathfrak{g}^p$ . Since  $\varphi(\mathbf{i})$  is the Weil operator,  $-B(\varphi(\mathbf{i})\bullet,\bullet)$  is positive definite. Therefore Ad  $(\varphi(\mathbf{i}))$  is an Cartan involution defined over  $\mathbb{R}$ , which defines the Cartan decomposition  $\mathfrak{g}_{\mathbb{R}} = \mathfrak{k}_{\mathbb{R}} \oplus \mathfrak{k}_{\mathbb{R}}^{\perp}$  such that

$$\mathfrak{k}_{\mathbb{R}}\otimes\mathbb{C}=igoplus_{p: ext{ even }}\mathfrak{g}^p, \quad \mathfrak{k}_{\mathbb{R}}^{\perp}\otimes\mathbb{C}=igoplus_{p: ext{ odd }}\mathfrak{g}^p.$$

The maximal compact subalgebra  $\mathfrak{k}_{\mathbb{R}}$  satisfies  $\mathfrak{t} \subset \mathfrak{g}_{\mathbb{R}} \cap \mathfrak{p} \subset \mathfrak{k}_{\mathbb{R}}$ , i.e. *D* is measurable in the sense of [FHW, §4.5].

We set the  $sl_2$ -triple

$$(\overline{\mathcal{E}}, \mathcal{Z}, \mathcal{E}) := \operatorname{Ad}_{\mathbf{d}_N}(N^+, Y, N)$$

in  $\mathfrak{g}_{\mathbb{C}}$ . Then

$$\bar{\mathcal{E}} = \frac{1}{2}(N + N^+ - \mathbf{i}Y), \quad \mathcal{Z} = \mathbf{i}(N - N^+), \quad \mathcal{E} = \frac{1}{2}(N + N^+ + \mathbf{i}Y).$$

Since  $NF^p \subset F^{p-1}$  by the property of nilpotent orbits, we have

$$ar{\mathcal{E}}\in \mathfrak{g}^1, \quad \mathcal{Z}\in \mathfrak{g}^0, \quad \mathcal{E}\in \mathfrak{g}^{-1}.$$

Let  $V_{\mathbb{C}} = \bigoplus V^{\mu}$  be the weight space decomposition with respect to  $\mathfrak{h}$ . That is,  $\mu \in \mathfrak{h}^*$  and  $v \in V^{\mu}$  if and only if  $\xi(v) = \mu(\xi)v$  for all  $\xi \in \mathfrak{h}$ . Then we have  $V^{p,n-p} = \bigoplus_{\mu(\mathbf{E}_{\varphi})=(2p-n)/2} V^{\mu}$ . The infinitesimal period relation is bracket-generating in the sense of [R, §3.12]. Then we have

(4.1) 
$$\mathbf{d}_{N}(I^{p,q}) = \bigoplus_{\substack{\mu(\mathbf{E}_{\varphi}) = (2p-n)/2\\ \mu(\mathcal{Z}) = p+q-n}} V^{\mu} = \{ v \in V^{p,n-p} \mid \mathcal{Z}v = (p+q-n)v \}.$$

by [R, Theorem 5.5(d)] and [R, Theorem 5.9(b)].

4.2. Minimal degenerations. For a nilpotent orbit  $(N, F^{\bullet})$ , we have the reduced limit

$$F^{\bullet}_{\infty} = \lim_{\mathrm{Im}\,(z) \to \infty} \exp{(zN)} F^{\bullet} \in \mathrm{bd}(D).$$

A nilpotent orbit  $(N, F^{\bullet})$  is called a minimal degeneration if  $F_{\infty}^{\bullet}$  is in a real codimension-one boundary  $G_{\mathbb{R}}$ -orbit of D. Type of minimal degenerations is classified into two kinds as follows:

**Theorem 4.1** ([GGR] Theorem 1.7). A minimal degeneration in a period domain is either

Type I:  $N \neq 0$ ,  $N^2 = 0$  and rank N = 1, 2, or Type II:  $N^2 \neq 0$ ,  $N^3 = 0$  and rank N = 2.




FIGURE 3. Deligne decompositions for minimal degenerations

Moreover, type of minimal degeneration is determined by  $\{i^{p,q}\}$ , where  $i^{p,q} = \dim I^{p,q}$ , and  $\{h^{p,q}\}$  (see also Figure 3):

- (I)  $(N, F^{\bullet})$  is of type I if and only if there exists  $p_o \in \mathbb{Z}$  such that  $2p_o < n$  satisfying the following conditions:
  - (i)  $i^{p_o+1,n-p_o}, i^{p_o,n-p_o-1} = 1;$
  - (ii)  $i^{p_o,n-p_o} = h^{p_o,n-p_o} 1$  and  $i^{p_o+1,n-p_o-1} = h^{p_o+1,n-p_o-1} 1;$
  - (iii) for all other p such that 2p < n,  $i^{p,n-p} = h^{p,n-p}$ .
- (II)  $(N, F^{\bullet})$  is of type II if and only if n = 2m is even and it satisfies the following conditions:
  - (i)  $i^{m-1,m-1}, i^{m+1,m+1} = 1;$
  - (ii)  $i^{m-1,m+1} = h^{m-1,m+1} 1$  and  $i^{m+1,m-1} = h^{m+1,m-1} 1$ ;
  - (iii) for all other p such that 2p < n,  $i^{p,n-p} = h^{p,n-p}$ .

Let  $(N, F^{\bullet})$  be a minimal degeneration such that the limit mixed Hodge structure is  $\mathbb{R}$ -split. In this case, N and N<sup>+</sup> are root vectors and  $\mathbf{d}_N$  is the Cayley transform (see [GGK2, Appendix to Lecture 10] or [KP]).

**Lemma 4.2.** (1) Suppose that  $(N, F^{\bullet})$  is of type I. Let  $v \in I^{p_o+1, n-p_o}$ . We then have

$$\mathbf{d}_N(v) = \frac{1}{\sqrt{2}}(v + \mathbf{i}Nv), \qquad \mathbf{d}_N(Nv) = \frac{\mathbf{i}}{\sqrt{2}}(v - \mathbf{i}Nv), \mathbf{d}_N(\bar{v}) = \mathbf{i} \cdot \overline{\mathbf{d}_N(Nv)}, \qquad \mathbf{d}_N(N\bar{v}) = \mathbf{i} \cdot \overline{\mathbf{d}_N(v)}.$$

In particular, if  $n = 2p_o + 1$  and  $v \in I^{p_o + 1, p_o + 1} \cap V_{\mathbb{R}}$ ,  $\mathbf{d}_N(v) = \mathbf{i} \cdot \overline{\mathbf{d}_N(Nv)}$ .

(2) Suppose that 
$$(N, F^{\bullet})$$
 is of type II. Let  $v \in I^{m+1,m+1}$ . We then have  
 $\mathbf{d}_N(v) = \frac{1}{2}v + \frac{1}{2}\mathbf{i}Nv - \frac{1}{4}N^2v, \quad \mathbf{d}_N(Nv) = \mathbf{i}(v + \frac{1}{2}N^2v), \quad \mathbf{d}_N(N^2v) = -2\overline{\mathbf{d}_N(v)}$ 

*Proof.* First, we prove (1). By property of limit mixed Hodge structure, N is a (-1, -1)-endomorphism and the nil-positive element  $N^+$  is a (1, 1)-endomorphism of the limit mixed Hodge structure  $(W_{\bullet}, F^{\bullet})$ . Moreover, N is an isomorphism from  $I^{p_o+1,n-p_o}$  to the image. Then

$$(N^+ + N)v = Nv, \quad (N^+ + N)^2v = N^+Nv = [N^+, N]v = Yv = v.$$

and we have

$$\begin{aligned} \mathbf{d}_{N}(v) &= \sum_{\ell=0}^{\infty} \frac{(-1)^{\ell}}{(2\ell)!} (\frac{\pi}{4})^{2\ell} v + \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2k+1)!} (\frac{\pi}{4})^{2k+1} \mathbf{i} N v \\ &= \cos\left(\frac{\pi}{4}\right) v + \mathbf{i} \sin\left(\frac{\pi}{4}\right) N v = \frac{1}{\sqrt{2}} (v + \mathbf{i} N v), \\ \mathbf{d}_{N}(Nv) &= \sum_{\ell=0}^{\infty} \frac{(-1)^{\ell}}{(2\ell)!} (\frac{\pi}{4})^{2\ell} N v + \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2k+1)!} (\frac{\pi}{4})^{2k+1} \mathbf{i} v \\ &= \cos\left(\frac{\pi}{4}\right) N v + \mathbf{i} \sin\left(\frac{\pi}{4}\right) v = \frac{\mathbf{i}}{\sqrt{2}} (v - \mathbf{i} N v). \end{aligned}$$

The equations for  $\mathbf{d}_N(\bar{v})$  and  $\mathbf{d}_N(N\bar{v})$  follows from similar calculations. Next, we prove (2). By property of limit mixed Hodge structure,

$$N^{+}Nv = [N^{+}, N]v = Yv = 2v,$$

$$N^{+}N^{2}v = [N^{+}, N]Nv + NN^{+}Nv = YNv + 2Nv = 2Nv.$$
(4.2)
$$(N^{+} + N)v = Nv, \quad (N^{+} + N)^{2}v = N^{+}Nv + N^{2}v = 2v + N^{2}v,$$

$$(N^{+} + N)^{3}v = 2Nv + N^{+}N^{2}v = 4Nv.$$

Then

$$\mathbf{d}_N(v) = v + \sum_{k=0}^{\infty} \frac{(-1)^k}{(2k+1)!} (\frac{\pi}{4})^{2k+1} 4^k \mathbf{i} N v + \sum_{\ell=1}^{\infty} \frac{(-1)^\ell}{(2\ell)!} (\frac{\pi}{4})^{2\ell} 4^{\ell-1} (2v+N^2v).$$

Here

$$(4.3) \qquad \sum_{k=0}^{\infty} \frac{(-1)^k}{(2k+1)!} (\frac{\pi}{4})^{2k+1} 4^k = \frac{1}{2} \sum_{k=0}^{\infty} \frac{(-1)^k}{(2k+1)!} (\frac{\pi}{4})^{2k+1} 2^{2k+1} = \frac{1}{2} \sin\left(\frac{\pi}{2}\right) = \frac{1}{2}$$
$$\sum_{\ell=1}^{\infty} \frac{(-1)^\ell}{(2\ell)!} (\frac{\pi}{4})^{2\ell} 4^{\ell-1} = \frac{1}{4} \sum_{\ell=1}^{\infty} \frac{(-1)^\ell}{(2\ell)!} (\frac{\pi}{4})^{2\ell} 2^{2\ell} = \frac{1}{4} (\cos\left(\frac{\pi}{2}\right) - 1) = -\frac{1}{4}.$$

Therefore,

$$\mathbf{d}_N(v) = \frac{1}{2}v + \frac{1}{2}\mathbf{i}Nv - \frac{1}{4}N^2v.$$

Since we have  $(N^+ + N)Nv = (N^+ + N)^2 v$ , by using (4.2) and (4.3)

$$\mathbf{d}_N(Nv) = \sum_{\ell=0}^{\infty} \frac{(-1)^{\ell}}{(2\ell)!} (\frac{\pi}{4})^{2\ell} 4^{\ell}(Nv) + \sum_{k=0}^{\infty} \frac{(-1)^k}{(2k+1)!} (\frac{\pi}{4})^{2k+1} 4^k \mathbf{i}(2v+N^2v)$$
$$= \cos\left(\frac{\pi}{2}\right) Nv + \frac{\mathbf{i}}{2}(2v+N^2v) = \mathbf{i}(v+\frac{1}{2}N^2v).$$

Since we have  $(N^+ + N)N^2v = N^+N^2v = 2Nv$ , by using (4.2) and (4.3)

$$\mathbf{d}_{N}(N^{2}v) = N^{2}v + \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2k+1)!} (\frac{\pi}{4})^{2k+1} 4^{k} 2\mathbf{i}Nv + \sum_{\ell=1}^{\infty} \frac{(-1)^{\ell}}{(2\ell)!} (\frac{\pi}{4})^{2\ell} 4^{\ell-1} 2(2v+N^{2}v)$$
$$= N^{2}v + \mathbf{i}Nv - \frac{1}{2}(2v+N^{2}v) = \frac{1}{2}N^{2}v + \mathbf{i}Nv - v = -2\overline{\mathbf{d}_{N}(v)}.$$

4.3. Pseudoconcave boundary orbits. For a point in a codimension-one boundary orbit, we may define a local defining function. Considering its Levi form, we can define pseudoconcavity at a point in a codimension-one boundary orbit as Definition 2.1:

**Definition 4.3.** A codimension-one boundary  $G_{\mathbb{R}}$ -orbit  $\mathcal{O}$  in  $\mathrm{bd}(D)$  is pseudoconcave boundary orbit of D if a holomorphic map  $\rho : \mathbb{D} \to c\ell(D)$  where  $\rho(0) \in \mathcal{O}$  and  $\mathrm{bd}(\rho(\mathbb{D})) \subset D$  exists.

Let  $\mathcal{O}$  be a codimension-one boundary  $G_{\mathbb{R}}$ -orbit. We have a minimal degeneration  $(N, F^{\bullet})$  where the associated reduced limit  $F_{\infty}^{\bullet}$  is in  $\mathcal{O}$ .

**Theorem 4.4.** Suppose that there exists  $r \in \mathbb{Z}$  such that  $i^{r,n-r} \neq 0$  satisfying one of the following conditions:

(i)  $(N, F^{\bullet})$  is of type I and  $r = p_o + 2\ell$  or  $r = p_o - 2\ell + 1$   $(\ell \ge 1)$ ;

(ii)  $(N, F^{\bullet})$  is of type II and  $r = m + 2\ell + 1$  ( $\ell \in \mathbb{Z}$ ).

Then  $\mathcal{O}$  is a pseudoconcave boundary orbit of D.

**Example 4.5.** Let D be the period domain with  $h^{3,0} = h^{2,1} = 1$ . This is the period domain for quintic-mirror threefolds. In this case, nontrivial nilpotent orbits and the Deligne–Hodge numbers of the limit mixed Hodge structures are classified into the following three types:

- (I)  $N^2 = 0$  and dim (Im N) = 1 ( $i^{2,2} = i^{1,1} = i^{3,0} = i^{0,3} = 1$ );
- (II)  $N^2 = 0$  and dim (Im N) = 2  $(i^{3,1} = i^{1,3} = i^{2,0} = i^{0,2} = 1)$ ; (III)  $N^3 \neq 0$  and  $N^4 = 0$   $(i^{3,3} = i^{2,2} = i^{1,1} = i^{0,0} = 1)$ .

Here (I) and (II) are minimal degeneration of type I. Moreover (I) satisfies the condition of Theorem 4.4, and then the corresponding codimension-one boundary  $G_{\mathbb{R}}$ -orbit is a pseudoconcave boundary orbit.

4.4. **Proof of Theorem 4.4.** For a nilpotent orbit  $(N, F^{\bullet})$ , there uniquely exists  $\tilde{F}^{\bullet} \in \check{D}$  such that the limit mixed Hodge structure  $(W_{\bullet}, \tilde{F}^{\bullet})$  is  $\mathbb{R}$ -split by [CKS, Proposition 2.20]. Since  $\mathcal{O} = G_{\mathbb{R}}F_{\infty}^{\bullet} = G_{\mathbb{R}}\tilde{F}_{\infty}^{\bullet}$  by [KP, §5.1], we may choose  $F^{\bullet} \in \check{D}$  so that  $F^{\bullet} = \tilde{F}^{\bullet}$ .

We have  $\varphi = \mathbf{d}_N(F^{\bullet}) \in D$  as in §4.1. Let  $K_{\mathbb{R}}$  be the maximal compact subgroup containing  $G_{\mathbb{R}} \cap P$  where P is the parabolic subgroup of G stabilizing  $\varphi$ . We define the base cycle  $C_0 = K_{\mathbb{R}}\varphi$ . For  $\mathcal{E} = \mathrm{Ad}_{\mathbf{d}_N}(N)$  we have

$$\exp\left(\mathbf{i}\mathcal{E}\right)\varphi = \psi\left(\frac{1}{\sqrt{2}}\begin{pmatrix}1&\mathbf{i}\\\mathbf{i}&1\end{pmatrix}\begin{pmatrix}1\\\mathbf{i}\end{pmatrix}\right) = F_{\infty}^{\bullet}.$$

By Lemma 4.6,  $\exp(\mathbf{i}\mathcal{E})C_0 \ni F_{\infty}^{\bullet}$  and  $\exp(\mathbf{i}\mathcal{E})C_0 \cap C_0 \neq \emptyset$ . We may construct  $Z \subset gC_0$  and a disk  $\mathbb{D} \subset Z$  about  $F_{\infty}^{\bullet}$  satisfying  $\operatorname{bd}(\mathbb{D}) \subset D$  applying the discussion of the proof of [Huc1, Theorem 3.7].

Hence we prove Lemma 4.6, which completes the proof of Theorem 4.4.

**Lemma 4.6.** If  $r \in \mathbb{Z}$  satisfying the condition of Theorem 4.4 exists, then there exists  $k \in K$  such that  $\operatorname{Ad}(k)(\mathcal{E}) \in \mathfrak{p}$ . In particular,  $k^{-1}\varphi \in C_0$  is a fixed point of  $\exp(\lambda \mathcal{E})$  with  $\lambda \in \mathbb{C}$ .

*Proof.* We first consider the case for type I. Let  $v \in I^{p_o+1,n-p_o}$ . By Lemma 4.2

(4.4) 
$$\mathcal{E}\mathbf{d}_N(v) = \mathbf{d}_N(Nv), \quad \mathcal{E}\mathbf{d}_N(v) = -\mathbf{i}\mathbf{d}_N(\bar{v}),$$
$$\mathcal{E} \cdot \overline{\mathcal{E}\mathbf{d}_N(v)} = -\mathbf{i}\mathbf{d}_N(N\bar{v}) = \overline{\mathbf{d}_N(v)}.$$

In particular, if  $n = 2p_o + 1$  and  $v \in I^{p_o+1,p_o+1} \cap V_{\mathbb{R}}$ , then

(4.5) 
$$\mathbf{d}_N(v) = \mathbf{i} \cdot \overline{\mathcal{E} \mathbf{d}_N(v)}, \quad \mathcal{E} \cdot \overline{\mathcal{E} \mathbf{d}_N(v)} = -\mathbf{i} \mathcal{E} \mathbf{d}_N(v)$$

We put  $w := \mathcal{E}\mathbf{d}_N(v)$ . We may assume ||w|| = 1 for the Hodge norm  $||\bullet|| = Q(\varphi(\mathbf{i})\bullet, \overline{\bullet})$ . Let  $r = p_o + 2\ell$  with  $\ell \ge 1$  and  $i^{r,n-r} \ne 0$ . Since  $I^{r,n-r} \subset W^n$  is contained in Ker N by property of monodromy weight filtration,  $I^{r,n-r} = \mathbf{d}_N(I^{r,n-r}) \subset V^{r,n-r}$ . We choose  $u \in I^{r,n-r}$  so that ||u|| = 1. We define  $k \in \text{Aut}(V_{\mathbb{C}})$  by


(4.6) 
$$kw = u, \quad ku = w, \quad k\bar{u} = \bar{w}, \quad k\bar{w} = \bar{u},$$
  
 $kv' = v' \quad \text{if } v' \perp w, u, \bar{w} \text{ and } \bar{u} \text{ with respect to } Q.$ 

Then  $k \in G$ , and  $\operatorname{Ad}(\varphi(\mathbf{i}))k = k$ , i.e.  $k \in K$  (see Figure 4). By using (4.4) and (4.5) we have

$$\operatorname{Ad}(k)(\mathcal{E})\mathbf{d}_{N}(v) = \begin{cases} \mathbf{i} \operatorname{Ad}(k)(\mathcal{E})\bar{w} = \mathbf{i}k\mathcal{E}\bar{u} = 0 & \text{if } n = 2p_{o} + 1\\ kw = u & \text{otherwise;} \end{cases}$$
$$\operatorname{Ad}(k)(\mathcal{E})\bar{u} = k\mathcal{E}\bar{w} = \begin{cases} -\mathbf{i}kw = -\mathbf{i}u & \text{if } n = 2p_{o} + 1,\\ \mathcal{E}\bar{w} = \mathbf{d}_{N}(v) & \text{otherwise;} \end{cases}$$
$$\operatorname{Ad}(k)(\mathcal{E})v' = 0 & \text{if } v' \perp u \text{ and } \overline{\mathbf{d}_{N}(v)}. \end{cases}$$

Since  $\mathbf{d}_N(v) \in V^{p_o+1,n-p_o-1}$  by (4.1), we conclude that

(4.7) 
$$\operatorname{Ad}(k)\mathcal{E} \in \begin{cases} \mathfrak{g}^{4\ell-1} \subset \mathfrak{p} & \text{if } n = 2p_o + 1, \\ \mathfrak{g}^{2\ell-1} \subset \mathfrak{p} & \text{otherwise.} \end{cases}$$

For the case where  $r = p_o - 2\ell + 1$  with  $\ell \ge 1$ , we put  $w = \mathbf{d}_N(v)$  instead and define  $k \in K$  as (4.6). Then we obtain (4.7).

Next, we consider the case for type II. Let  $v \in I^{m+1,m+1}$  such that  $\|\mathbf{d}_N(v)\| = 1$ and put  $w = \mathbf{d}_N(v)$ . Then

$$\overline{\mathcal{E}w} = -\mathcal{E}w, \quad -2\bar{w} = \mathcal{E}^2w.$$

Let  $r = m + 2\ell + 1$  with  $i^{r,n-r} \neq 0$ . Since  $n - r = m + 2(-\ell - 1) + 1$  and  $i^{n-r,r} \neq 0$ , we may assume  $\ell < 0$ . We choose  $u \in V^{r,n-r}$  so that ||u|| = 1. We define  $k \in K$  as (4.6), and then

> $\operatorname{Ad}(k)(\mathcal{E})u = k\mathcal{E}w = \mathcal{E}w, \quad \operatorname{Ad}(k)(\mathcal{E})\mathcal{E}w = -2\bar{u},$ Ad  $(k)(\mathcal{E})v' = 0$  if  $v' \perp \overline{u}$  and  $\overline{\mathcal{E}w}$ .

Since  $\mathcal{E}w \in V^{m,m}$ , we have  $\operatorname{Ad}(k)\mathcal{E} \in \mathfrak{g}^{-2\ell-1} \subset \mathfrak{p}$ .
