# On some free boundary problem of the Navier-Stokes equations in the maximal $L_{p}-L_{q}$ regularity class

#### Abstract

This paper is concerned with the free boundary problem for the Navier Stokes equations without surface tension in the $L_{p}$ in time and $L_{q}$ in space setting with $2<p<\infty$ and $N<q<\infty$. A local in time existence theorem is proved in a uniform $W^{2-1 / q}$ domain in the $N$-dimensional Euclidean space $\mathbb{R}^{N}(N \geq 2)$ under the assumption that weak Dirichlet-Neumann problem is uniquely solvable. Moreover, a global in time existence theorem is proved for small initial data under the assumption that $\Omega$ is bounded additionally. This was already proved by Solonnikov 28 by using the continuation argument of local in time solutions which are exponentially stable in the energy level under the assumption that the initial data is orthogonal to the rigid motion. We also use the continuation argument and the same orthogonality for the initial data. But, our argument about the continuation of local in time solutions is based on some decay theorem for the linearized problem, which is a different point than [28].

## 1 Introduction

The present paper deals with some local and global in time unique existence theorems of solutions to the Navier-Stokes equations describing the motion of a viscous incompressible fluid flow with free surface without taking surface tension into account. Our problem is formulated in the following. Let $\Omega$ be a domain in the $N$-dimensional Euclidean space $\mathbb{R}^{N}(N \geq 2)$ occupied by a viscous incompressible fluid. We assume that the boundary of $\Omega$ consists of two parts $S$ and $\Gamma$ with $S \cap \Gamma=\emptyset$. We may assume that $\Gamma$ is an empty set. Let $\Omega_{t}$ and $S_{t}$ be evolutions of $\Omega$ and $S$ with time variable $t>0$ and we assume that $S_{t} \cap \Gamma=\emptyset$ for $t \geq 0$. The velocity vector field $\mathbf{v}=\mathbf{v}(x, t)=\left(v_{1}(x, t), \ldots, v_{N}(x, t)\right)$ and the pressure $\pi=\pi(x, t)$ for $x=\left(x_{1}, \ldots, x_{N}\right) \in \Omega_{t}$ satisfy the Navier-Stokes equations

The initial conditions, the boundary conditions on the free boundary $S_{t}$ and the non-slip conditions on the fixed boundary $\Gamma$ have the following forms:

Here, $\mathbf{n}_{t}$ is the unit outward normal to $S_{t}$. Moreover, $\mathbf{T}=\mathbf{T}(\mathbf{v}, \pi)$ denotes the stress tensor of the form:

where $\mu$ denotes a positive constant describing the viscosity coefficient, $\mathbf{D}(\mathbf{v})$ the deformation tensor whose $(j, k)$ components are $D_{j k}(\mathbf{v})=\left(\partial_{j} v_{k}+\partial_{k} v_{j}\right)$ with $\partial_{j}=\partial / \partial x_{j}$, and $\mathbf{I}$ the $N \times N$ identity matrix. Finally, for any matrix field $\mathbf{K}$ with components $K_{i j}, i, j=1, \ldots, N$, the quantity $\operatorname{Div} \mathbf{K}$ is an $N$ vector with $i$-th component $\sum_{j=1}^{N} \partial_{j} K_{i j}$, and also for any vector of functions $\mathbf{u}=\left(u_{1}, \ldots, u_{N}\right)$ we set $\operatorname{div} \mathbf{u}=\sum_{j=1}^{N} \partial_{j} u_{j}, \mathbf{u} \cdot \nabla=\sum_{j=1}^{N} u_{j} \partial_{j}$ and $\partial_{t} \mathbf{u}=\left(\partial u_{1} / \partial t, \ldots, \partial u_{N} / \partial t\right)$.

Aside from the dynamical system (1.1), we impose a further kinematic condition:

where $S_{t}$ is defined by $F=F(x, t)=0$ locally. In other words, $S_{t}$ is given by

where $\mathbf{x}=\mathbf{x}(\xi, t)$ is the solution to the Cauchy problem: $\dot{\mathbf{x}}=d \mathbf{x} / d t=\mathbf{v}(\mathbf{x}, t)(t>0)$ with $\left.\mathbf{x}\right|_{t=0}=\xi$. This expresses the fact that the free boundary $S_{t}$ consists of the same particles for all $t>0$, which do not leave it and are not incident from $\Omega_{t}$.

The free boundary problem for the Navier-Stokes equations has been studied by many mathematicians in the following two cases:
(1) The motion of an isolated liquid mass;
(2) The motion of a viscous incompressible fluid contained in an ocean of infinite content.

In case (1) the initial domain $\Omega$ is bounded. A local in time unique existence theorem was proved by Solonnikov [26, 29, 30, 31] in the $L_{2}$ Sobolev-Slobodetskii space, by Schweizer [20] in the semigroup setting, by Moglievskiĭ and Solonnikov [16, 31] in the Hölder spaces with surface tension; and by Solonnikov [28] and Mucha and W. Zajạczkowski 18] in the $L_{p}$ Sobolev-Slobodetskii space and by Shibata and Shimizu [23] in the $L_{p}$ in time and $L_{q}$ in space setting without surface tension. A global in time unique existence theorem for small initial velocity was proved by Solonnikov [28] in the $L_{p}$ Sobolev-Slobodetskii space without surface tension; and by Solonnikov [27] in the $L_{2}$ Sobolev-Slobodetskii space and by Padula and Solonnikov [19] in the Hölder spaces under the additional assumption that the initial domain $\Omega$ is sufficiently close to a ball with surface tension.

In case (2), the initial domain $\Omega$ is a perturbed layer like: $\Omega=\left\{x \in \mathbb{R}^{N} \mid-b<X_{N}<\eta\left(x^{\prime}\right), x^{\prime}=\right.$ $\left.\left(x_{1}, \ldots, x_{N-1}\right) \in \mathbb{R}^{N-1}\right\}$. A local in time unique existence theorem was proved by Beale [5], Allain [2] and Tani [36] in the $L_{2}$ Sobolev-Slobodetskii space with surface tension and by Abels [1] in the $L_{p}$ Sobolev-Slobodetskii space without surface tension. A global in time unique existence theorem for small initial velocity was proved in the $L_{2}$ Sobolev-Slobodetskii space by Beale [6 and Tani and Tanaka 37] with surface tension, and by Sylvester [34] without surface tension. The decay rate was studied by Beale and Nishida 7], Sylvestre [35] and Hataya [14.

The purpose of this paper is to prove a local in time unique existence theorem for problem (1.1) and (1.2) under the assumption that the initial domain $\Omega$ is a uniform $W_{q}^{2-1 / q}(N<q<\infty)$ domain and weak Dirichlet-Neumann problem is uniquely solvable *, which includes the cases (1) and (2) without surface tension. And also, we prove a global in time unique existence theorem for problem (1.1) and (1.2) for a small initial data in the $L_{p}$ in time and $L_{q}$ in space setting assuming that $\Omega$ is bounded in addition. This was mentioned in Shibata and Shimizu [23], but there was a serious gap in the proof, so that we reprove it in a different approach than [23] in this paper.

To prove a local in time unique existence theorem, the key step is to prove the maximal regularity theorem for the linearized equations given in the following:

with $0<T \leq \infty$. Here, $\tilde{\mathbf{n}}$ denotes the extension of $\mathbf{n}$ to the whole space $\mathbb{R}^{N}$. In fact, as was seen in (13, (5.12)] (cf. also [12, Appendix]), we can define $\tilde{\mathbf{n}}$ on $\mathbb{R}^{N}$ such that $\left.\tilde{\mathbf{n}}\right|_{S}=\mathbf{n}$ and

*These assumptions are exactly stated in Definition 2.1 and Definition 2.2 in the following.
for any $f \in W_{q}^{1}(\Omega)$ with some constant $C$ depending on $\Omega$ if $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain with $N<r<\infty$.

To prove the maximal regularity theorem, problem (1.6) is reduced locally to the model problems in a neighbourhood of either an interior point or a boundary point by using the localization technique and the partition of unity associated with the domain $\Omega$. The boundary neighbourhood problem (1.6) is transformed to a problem in the half-space $x_{N}>0$. By applying the Fourier transform with respect to time and tangential directions, problem (1.6) becomes a system of ordinary differential equations. Solonnikov [25] calculates explicityly the inverse Fourier transform of solutions of such ordinary differential equations and expresses them in the form of potentials in the half-space. Then, he estimates them in suitable norms. Mucha and Zajączkowski [17] directly estimate them using the multiplier theorem of Marinkiewicz and Mikhlin type [15].

On the other hand, Shibata [22] proved the maximal regularity theorem $\dagger$ by using the $\mathcal{R}$ - bounded solution operators to the corresponding resolvent problem of the form:

In fact, according to the theorem in [22, for any $\epsilon \in(0, \pi / 2)$ there exist a constant $\lambda_{0} \geq 1$ and an operator family $\mathcal{R}(\lambda) \in \operatorname{Hol}\left(\Sigma_{\epsilon, \lambda_{0}}, \mathcal{L}\left(\mathcal{X}_{q}(\Omega), W_{q}^{2}(\Omega)^{N}\right)\right)$ such that for any $\mathbf{f} \in L_{q}(\Omega)^{N}, g \in W_{q}^{1}(\Omega), \mathbf{g} \in L_{q}(\Omega)^{N}$ and $\mathbf{h} \in W_{q}^{1}(\Omega)^{N}$, problem (1.8) admits a unique solution $\mathbf{v}=\mathcal{R}(\lambda)\left(\mathbf{f}, \lambda^{1 / 2} g, \nabla g, \lambda \mathbf{g}, \lambda^{1 / 2} \mathbf{h}, \nabla \mathbf{h}\right)$ with some pressure term $\kappa$, and $\left(\lambda, \lambda^{1 / 2} \nabla, \nabla^{2}\right) \mathcal{R}(\lambda)$ is $\mathcal{R}$ bounded for $\lambda \in \Sigma_{\epsilon, \lambda_{0}}$ with value in $\mathcal{L}\left(\mathcal{X}_{q}(\Omega), L_{q}(\Omega)^{\tilde{N}}\right)$. Here, $\tilde{N}=N+N^{2}+N^{3}, \Sigma_{\epsilon, \lambda_{0}}=\left\{\lambda \in \mathbb{C}| | \lambda\left|\geq \lambda_{0},|\arg \lambda| \leq \pi-\epsilon\right\}, \mathcal{X}_{q}(\Omega)=\left\{F=\left(F_{1}, \ldots, F_{6}\right) \mid\right.\right.$ $\left.F_{1}, F_{3}, F_{4}, F_{5} \in L_{q}(\Omega)^{N}, F_{2} \in L_{q}(\Omega), F_{6} \in L_{q}(\Omega)^{N^{2}}\right\}$, and $F_{1}, F_{2}, F_{3}, F_{4}, F_{5}$ and $F_{6}$ are independent variables corresponding to $\mathbf{f}, \lambda^{1 / 2} g, \nabla g, \lambda \mathbf{g}, \lambda^{1 / 2} \mathbf{h}$ and $\nabla \mathbf{h}$, respectively. Moreover, $\operatorname{Hol}\left(\Sigma_{\epsilon, \lambda_{0}}, \mathcal{L}(X, Y)\right)$ denotes the set of all $\mathcal{L}(X, Y)$ valued holomorphic functions defined on $\Sigma_{\epsilon, \lambda_{0}}$ and $\mathcal{L}(X, Y)$ the set of all bounded linear operators from a Banach space $X$ into another Banach space $Y$. Since the solution $\mathbf{u}$ for (1.6) is given by the Laplace inverse transform of $\mathcal{R}(\lambda)\left(\mathbf{f}, \lambda^{1 / 2} g, \nabla g, \lambda \mathbf{g}, \lambda^{1 / 2} \mathbf{h}, \nabla \mathbf{h}\right)$, the maximal regularity is obtained with help of Weis' operator valued Fourier multiplier theorem [38].

Finally, we introduce some symbols used throughout the paper. For any domain $D$ and $1 \leq q \leq \infty$, $L_{q}(D)$ and $W_{q}^{m}(D)$ denote the usual Lebesgue space and Sobolev space, while $\|\cdot\|_{L_{q}(D)}$ and $\|\cdot\|_{W_{q}^{m}(D)}$ denote their norms, respectively. We set $W_{q}^{0}(D)=L_{q}(D) . C_{0}^{\infty}(D)$ denotes the set of all $C^{\infty}\left(\mathbb{R}^{N}\right)$ functions whose supports are compact and contained in $D$. We set $(f, g)_{D}=\int_{D} f(x) g(x) d x$. For any Banach space $X$ and $1 \leq p \leq \infty, L_{p}((a, b), X)$ and $W_{p}^{m}((a, b), X)$ denote the usual Lebesgue space and Sobolev space of $X$-valued functions defined on an interval $(a, b)$, while $\|\cdot\|_{L_{p}((a, b), X)}$ and $\|\cdot\|_{W_{p}^{m}((a, b), X)}$ denote their norms, respectively. For $0<\theta<1, B_{q, p}^{2 \theta}(D)$ denotes the real interpolation space defined by $B_{q, p}^{2 \theta}(D)=\left(L_{q}(D), W_{q}^{2}(D)\right)_{\theta, p}$ with real interpolation functor $(\cdot, \cdot)_{\theta, p}$, while $\|\cdot\|_{B_{q, p}^{2 \theta}(D)}$ denotes its norm. We set $W_{q}^{2 \theta}=B_{q, q}^{2 \theta}$. The $d$-product space of $X$ is defined by $X^{d}=\left\{f=\left(f, \ldots, f_{d}\right) \mid f_{i} \in\right.$ $X(i=1, \ldots, d)\}$, while its norm is denoted by $\|\cdot\|_{X}$ instead of $\|\cdot\|_{X^{d}}$ for the sake of simplicity. $\mathbb{N}$, $\mathbb{R}$ and $\mathbb{C}$ denote the sets of all natural numbers, real numbers and complex numbers, respectively. We set $\mathbb{N}_{0}=\mathbb{N} \cup\{0\}$. For any multi-index $\kappa=\left(\kappa_{1}, \ldots, \kappa_{N}\right) \in \mathbb{N}_{0}^{N}$, we write $|\kappa|=\kappa_{1}+\cdots+\kappa_{N}$ and $\partial_{x}^{\kappa}=\partial_{1}^{\kappa_{1}} \cdots \partial_{N}^{\kappa_{N}}$ with $x=\left(x_{1}, \ldots, x_{N}\right)$ and $\partial_{j}=\partial / \partial x_{j}$. For any scalor function $f$ and $N$-vector of functions $\mathbf{g}$, we set

For $\mathbf{a}=\left(a_{1}, \ldots, a_{N}\right)$ and $\mathbf{b}=\left(b_{1}, \ldots, b_{N}\right) \in \mathbb{R}^{N}$, we set $\mathbf{a} \cdot \mathbf{b}=<\mathbf{a}, \mathbf{b}>=\sum_{j=1}^{N} a_{j} b_{j}$. For scalor functions $f, g$ and $N$-vectors of functions $\mathbf{f}, \mathbf{g}$, we set $(f, g)_{D}=\int_{D} f(x) g(x) d x$ and $(\mathbf{f}, \mathbf{g})_{D}=\int_{D} \mathbf{f}(x) \cdot \mathbf{g}(x) d x$. The letter $C$ denotes generic constants and the constant $C_{a, b, \cdots}$ depends on $a, b, \cdots$. The values of constants $C$ and $C_{a, b, \ldots}$ may change from line to line.

## 2 Main Results

In this section, we state our main results. Since $\Omega_{t}$ should be decided, we transfer $\Omega_{t}$ to $\Omega$ by the Lagrange transformation as follows: If the velocity field $\mathbf{u}(\xi, t)$ is known as a function of the Lagrange coordinates $\xi \in \Omega$, then the Euler coordinates $x \in \Omega_{t}$ is written in the form:

x=\xi+\int_{0}^{t} \mathbf{u}(\xi, s) d s \equiv \mathbf{X}_{\mathbf{u}}(\xi, t)
$$

where $\mathbf{u}(\xi, t)=\left(u_{1}(\xi, t), \ldots, u_{N}(\xi, t)\right)=\mathbf{v}\left(\mathbf{X}_{\mathbf{u}}(\xi, t), t\right)$. Let $A$ be the Jacobi matrix of the transformation $x=\mathbf{X}_{\mathbf{u}}(\xi, t)$ with elements $a_{i j}=\delta_{i j}+\int_{0}^{t}\left(\partial u_{i} / \partial \xi_{j}\right)(\xi, s) d s$. Since $\operatorname{det} A=1$ as follows from $\operatorname{div} \mathbf{v}=0$ in $\Omega_{t}$, denoting the cofactor matrix of $A$ by $\mathcal{A}$, we have $\nabla_{x}=\mathcal{A} \nabla_{\xi}$ with $\nabla_{x}={ }^{T}\left(\partial / \partial x_{1}, \ldots, \partial / \partial x_{N}\right)$ and $\nabla_{\xi}={ }^{T}\left(\partial / \partial \xi_{1}, \ldots, \partial / \partial \xi_{N}\right)$ 团. We can represent $\mathcal{A}$ by $\mathcal{A}=\mathbf{I}+\mathbf{V}_{0}\left(\int_{0}^{t} \nabla \mathbf{u}(\xi, s) d s\right)$ with some matrix $\mathbf{V}_{0}(\mathbf{K})$ of polynomials with respect to $\mathbf{K}=\left(k_{i j}\right)$ satisfying the condition: $\mathbf{V}_{0}(0)=0$, where $k_{i j}$ is a corresponding variable to $\int_{0}^{t}\left(\partial u_{i} / \partial \xi_{j}\right)(\xi, s) d s$. Let $\mathbf{n}$ be the unit outward normal to $S$, and then by (1.4) we have

with $\hat{\mathbf{w}}(\xi, t)=\mathbf{w}\left(\mathbf{X}_{\mathbf{u}}(\xi, t), t\right)$, where $\operatorname{tr} M$ denotes the trace of any matrix $M$. Moreover, what $A=$ $\left(A^{-1}\right)^{-1}=\mathcal{A}^{-1}$ yields that

with some matrix $\mathbf{V}_{1}(\mathbf{K})$ of polynomials with respect to $\mathbf{K}=\left(k_{i j}\right)$ satisfying the condition: $\mathbf{V}_{1}(0)=$ 0 . Using (2.1), (2.2) and (2.3), and setting $\theta(\xi, t)=\pi\left(\mathbf{X}_{\mathbf{u}}(\xi, t)\right)$, we have the following Lagrangian description of problem (1.1)-(1.2):

\left.\mathbf{T}(\mathbf{u}, \theta) \tilde{\mathbf{n}}\right|_{S}=\left.\mathbf{H}(\mathbf{u}) \tilde{\mathbf{n}}\right|_{S},\left.\mathbf{u}\right|_{\Gamma}=0,\left.\mathbf{u}\right|_{t=0}=\mathbf{v}_{0} \text { in } \Omega \tag{2.4}

Here, $\mathbf{F}(\mathbf{u}), g(\mathbf{u}), \mathbf{g}(\mathbf{u})$ and $\mathbf{H}(\mathbf{u})$ are nonlinear functions of the forms:

& G(\mathbf{u})=\mathbf{V}_{4}\left(\int_{0}^{t} \nabla \mathbf{u} d s\right) \nabla \mathbf{u}, \quad \mathbf{G}(\mathbf{u})=\mathbf{V}_{5}\left(\int_{0}^{t} \nabla \mathbf{u} d s\right) \mathbf{u}, \quad \mathbf{H}(\mathbf{u})=\mathbf{V}_{6}\left(\int_{0}^{t} \nabla \mathbf{u} d s\right) \nabla \mathbf{u} \tag{2.5}

with some matrices $\mathbf{V}_{i}(\mathbf{K})(i=1, \ldots, 6)$ of polynomials with respect to $\mathbf{K}$ satisfying the conditions:

We introduce the definition of uniform $W_{r}^{2-1 / r}$ domain.
Definition 2.1. Let $1<r<\infty$ and let $\Omega$ be a domain in $\mathbb{R}^{N}$ with boundary $\partial \Omega$. We say that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain, if there exist positive constants $\alpha, \beta$ and $K$ such that for any $x_{0}=\left(x_{01}, \ldots, x_{0 N}\right) \in$ $\partial \Omega$ there exist a coordinate number $j$ and a $W_{r}^{2-1 / r}$ function $h\left(x^{\prime}\right)\left(x^{\prime}=\left(x_{1}, \ldots, \hat{x}_{j}, \ldots, x_{N}\right)\right)$ defined on $B_{\alpha}^{\prime}\left(x_{0}^{\prime}\right)$ with $x_{0}^{\prime}=\left(x_{01}, \ldots \hat{x}_{0 j}, \ldots, x_{0 N}\right)$ and $\|h\|_{W_{r}^{2-1 / r}\left(B_{\alpha}^{\prime}\left(x_{0}^{\prime}\right)\right)} \leq K$ such that

Here, $\left(x_{1}, \ldots, \hat{x}_{j}, \ldots, x_{N}\right)=\left(x_{1}, \ldots, x_{j-1}, x_{j+1}, \ldots, x_{N}\right), B_{\alpha}^{\prime}\left(x_{0}^{\prime}\right)=\left\{x^{\prime} \in \mathbb{R}^{N-1}| | x^{\prime}-x_{0}^{\prime} \mid<\alpha\right\}$ and $B_{\beta}\left(x_{0}\right)=\left\{x \in \mathbb{R}^{N}| | x-x_{0} \mid<\beta\right\}$.

[^1]To prove our local in time unique existence theorem for (2.4) in a uniform $W_{q}^{2-1 / q}$ domain, we need the unique solvability of weak Dirichlet-Neumann problem to treat the divergence condition. But, in general it is not known except for the $L_{2}$ framework, so that we have to assume it in this paper. For this purpose, we introduce spaces $W_{q, 0}^{1}(\Omega)$ and $\hat{W}_{q, 0}^{1}(\Omega)$ defined by $\hat{W}_{q, 0}^{1}(\Omega)=\left\{\theta \in L_{q, \text { loc }}(\Omega)\left|\nabla \theta \in L_{q}(\Omega)^{N}, \theta\right|_{S}=0\right\}$ and $W_{q, 0}^{1}(\Omega)=\left\{\theta \in W_{q}^{1}(\Omega)|\theta|_{S}=0\right\}$.

Definition 2.2. Let $1<q<\infty$ and let $\mathcal{W}_{q}^{1}(\Omega)$ be a closed subspace of $\hat{W}_{q, 0}^{1}(\Omega)$ that contains $W_{q, 0}^{1}(\Omega)$. Then, weak Dirichlet-Neumann problem is called uniquely solvable for $\mathcal{W}_{q}^{1}(\Omega)$, if the following assertion holds: For any $f \in L_{q}(\Omega)^{N}$ there exists a unique $\theta \in \mathcal{W}_{q}^{1}(\Omega)$ which satisfies the variational equation:

and the estimate: $\|\nabla \theta\|_{L_{q}(\Omega)} \leq C_{q}\|f\|_{L_{q}(\Omega)}$ for some constant $C_{q}$ independent of $f, \theta$ and $\varphi$.
Remark 2.3. (1) $W_{q}^{1}(\Omega)+\mathcal{W}_{q}^{1}(\Omega)=\left\{p=p_{1}+p_{2} \mid p_{1} \in W_{q}^{1}(\Omega), p_{2} \in \mathcal{W}_{q}^{1}(\Omega)\right\}$ is the space for pressures.
(2) When $\Omega$ is a bounded domain, a half-space, a perturbed half-space, or a layer domain, weak DirichletNeumann problem is uniquely solvable with $\mathcal{W}_{q}^{1}(\Omega)=\hat{W}_{q, 0}^{1}(\Omega)$, while when $\Omega$ is an exterior domain, it is uniquely solvable with $\mathcal{W}_{q}^{1}(\Omega)$ being the closure of $W_{q, 0}^{1}(\Omega)$ by semi-norm $\|\nabla \cdot\|_{L_{q}(\Omega)}$. More examples of domains where the unique solvability of weak Dirichlet-Neumann problem holds were given in [21, 22].

To state the compatibility condition for initial data $\mathbf{v}_{0}$, we introduce the solenoidal space $J_{q}(\Omega)$ defined by $J_{q}(\Omega)=\left\{\mathbf{f} \in L_{q}(\Omega)^{N} \mid(\mathbf{f}, \nabla \varphi)_{\Omega}=0\right.$ for any $\left.\varphi \in \mathcal{W}_{q^{\prime}}^{1}(\Omega)\right\}$. Since $C_{0}^{\infty}(\Omega) \subset \mathcal{W}_{q^{\prime}}^{1}(\Omega)$, we see that $\operatorname{div} \mathbf{f}=0$ in $\Omega$ provided that $\mathbf{f} \in J_{q}(\Omega)$. But, the opposite direction does not hold in general. We define $\mathcal{D}_{q, p}(\Omega)$ by $\mathcal{D}_{q, p}(\Omega)=\left(J_{q}(\Omega), \mathcal{D}_{q}(\Omega)\right)_{1-1 / p . p}$ with

From Steiger 32], we know that

\mathcal{D}_{q, p}(\Omega)= \begin{cases}\left\{\mathbf{f} \in B_{q, p}^{2(1-1 / p)}(\Omega) \cap J_{q}(\Omega) \mid \mathbf{f} \text { satisfies (2.9) }\right\} & \text { when } 2(1-1 / p)>1+1 / q \\ \left\{\mathbf{f} \in J_{q}(\Omega) \cap B_{q, p}^{2(1-1 / p)}(\Omega)|\mathbf{f}|_{\Gamma}=0\right\} & \text { when } 1 / q<2(1-1 / p)<1+1 / q \\ B_{q, p}^{2(1-1 / p)}(\Omega) \cap J_{q}(\Omega) & \text { when } 2(1-1 / p)<1 / q\end{cases}
$$

The following theorem is concerned with local in time unique existence theorem for (2.4).
Theorem 2.4. Let $2<p<\infty, N<q<\infty$ and $R>0$. Assume that $\Omega$ is a uniform $W_{q}^{2-1 / q}$ domain and that weak Dirichlet-Neumann problem is uniquely solvable for $\mathcal{W}_{q}^{1}(\Omega)$ and $\mathcal{W}_{q^{\prime}}^{1}(\Omega)\left(q^{\prime}=q /(q-1)\right)$. Then, there exists a time $T>0$ depending on $R$ such that for any initial data $\mathbf{v}_{0} \in \mathcal{D}_{q, p}(\Omega)$ with $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq R$ problem (2.4) admits a unique solution $\mathbf{u} \in L_{q}\left((0, T), W_{q}^{2}(\Omega)\right) \cap W_{p}^{1}\left((0, T), L_{q}(\Omega)\right)$ with some pressure term $\theta \in L_{p}\left((0, T), W_{q}^{1}(\Omega)+\mathcal{W}_{q}^{1}(\Omega)\right)$ possessing the estimate:

\|\mathbf{u}\|_{L_{p}\left((0, T), W_{q}^{2}(\Omega)\right)}+\left\|\partial_{t} \mathbf{u}\right\|_{L_{p}\left((0, T), L_{q}(\Omega)\right)} \leq M_{0} R

with some positive constant $M_{0}$ independent of $R$ and $T$.
Remark 2.5. (1) Employing the similar argumentation to Strömer 33, we can prove that there exists a positive number $\sigma>0$ such that the map: $x=\mathbf{X}_{\mathbf{u}}(\xi, t)$ is diffeomorphism from $\Omega$ onto $\Omega_{t}, S$ onto $S_{t}$ and $\Gamma$ onto $\Gamma$ for any $t \in(0, T)$ provided that

so that from Theorem 2.4 $\mathbf{v}(x, t)=\mathbf{u}\left(\mathbf{X}_{\mathbf{u}}^{-1}(x, t), t\right)$ solves the original free boundary problem (1.1)(1.2) for small $T>0$ with some pressure term $\pi$, where $\mathbf{X}_{\mathbf{u}}^{-1}(x, t)$ denotes the inverse map of the correspondence: $x=\mathbf{X}_{\mathbf{u}}(\xi, t)$.
(2) It is easy to extend Theorem [2.4 to the equation:

instead of (1.1) under similar assumption on $\mathbf{f}$ to Solonnikov [28] and Shibata and Shimizu [23]. But, we only consider the case $\mathbf{f}=0$ in this paper for simplicity.

Our global in time unique existence theorem is obtained under the assumption that $\Omega$ is a bounded domain and the key issue is the orthogonality of the rigid motion. We introduce the rigid space $\mathcal{R}_{d}$ defined by

We know that $\mathbf{u}$ satisfies $\mathbf{D}(\mathbf{u})=0$ if and only if $\mathbf{u} \in \mathcal{R}_{d}$ (cf. [11]). Let $\left\{\mathbf{p}_{\ell}\right\}_{\ell=1}$ be the orthogonal bases of $\mathcal{R}_{d}$, that is $\mathbf{p}_{\ell} \in \mathcal{R}_{d}(\ell=1, \ldots, M)$ and

where $\delta_{\ell m}$ is the Kronecker delta symbol such that $\delta_{\ell \ell}=1$ and $\delta_{\ell m}=0$ with $\ell \neq m, M$ the dimension of $\mathcal{R}_{d}$ and $(\cdot, \cdot)_{\Omega}$ the $L_{2}$ inner-product on $\Omega$. The following theorm is our global in time unique existence result.

Theorem 2.6. Let $2<p<\infty$ and $N<q<\infty$. Assume that $\Omega$ is a bounded domain, $S$ and $\Gamma$ are $W_{q}^{2-1 / q}$ compact hypersurfaces and that $S \neq \emptyset$. Then, there exist numbers $\epsilon>0$ and $\gamma>0$ such that for any initial data $\mathbf{v}_{0} \in \mathcal{D}_{q, p}(\Omega)$ with $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq \epsilon$ that satisfies, in addition, the orthogonality condition:

problem (2.4) with $T=\infty$ admits a unique solution $\mathbf{u} \in L_{p}\left((0, \infty), W_{q}^{2}(\Omega)\right) \cap W_{p}^{1}\left((0, \infty), L_{q}(\Omega)\right)$ possessing the estimate:

\left\|e^{\gamma t} \mathbf{u}\right\|_{L_{p}\left((0, \infty), W_{q}^{2}(\Omega)\right)}+\left\|e^{\gamma t} \partial_{t} \mathbf{u}\right\|_{L_{p}\left((0, \infty), L_{q}(\Omega)\right)} \leq C \epsilon
$$

for some positive constant $C$ independent of $\epsilon$.

## 3 A proof of a local in time unique existence theorem

In this section, we prove Theorem [2.4. For this purpose, first we state our maximal $L_{p}-L_{q}$ regularity theorem obtained by Shibata [22] for the linearized system (1.6). To state our maximal regularity result for (1.6), we introduce some symbols. For any Banach space $X$ with norm $\|\cdot\|_{X}$, integer $m \geq 0$ and $\gamma_{0}>0$, we set

W_{p, 0, \gamma_{0}}^{m}(\mathbb{R}, X) & =\left\{f: \mathbb{R} \rightarrow X \mid e^{-\gamma_{0} t} f(t) \in W_{p}^{m}(\mathbb{R}, X), \quad f(t)=0 \text { for } t<0\right\},
\end{aligned}
$$

where $\mathbb{R}_{+}=(0, \infty)$. We set $W_{p, \gamma_{0}}^{0}=L_{p, \gamma_{0}}$ and $W_{p, 0, \gamma_{0}}^{0}=L_{p, 0, \gamma_{0}}$. Let $\mathcal{L}$ and $\mathcal{L}^{-1}$ be the Laplace transform and its inverse transform defined by

\mathcal{L}[f](\lambda)=\int_{-\infty}^{\infty} e^{-\lambda t} f(t) d t, \quad \mathcal{L}^{-1}[g](t)=\frac{1}{2 \pi} \int_{-\infty}^{\infty} e^{\lambda t} g(\gamma+i \tau) d \tau

with $\lambda=\gamma+i \tau \in \mathbb{C}$. For any real number $s \geq 0$, let $H_{p, \gamma_{0}}^{s}(\mathbb{R}, X)$ be the Bessel potential space of order $s$ defined by

H_{p, \gamma_{0}}^{s}(\mathbb{R}, X)=\left\{f \in L_{p, \gamma_{0}}(\mathbb{R}, X) \mid e^{-\gamma t} \Lambda_{\gamma}^{s} f \in L_{p}(\mathbb{R}, X) \text { for any } \gamma \geq \gamma_{0}\right\}
$$

with $\left[\Lambda_{\gamma}^{s} f\right](t)=\mathcal{L}^{-1}\left[\lambda^{s} \mathcal{L}[f](\lambda)\right](t)$. We set $H_{p, 0, \gamma_{0}}^{s}(\mathbb{R}, X)=\left\{f \in H_{p, \gamma_{0}}^{s}(\mathbb{R}, X) \mid f(t)=0\right.$ for $\left.t<0\right\}$. By using the $\mathcal{R}$ bounded solution opeator $\mathcal{R}(\lambda)$ introduced in Sect.1, Shibata [22] proved the following maximal $L_{p}-L_{q}$ result for problem (1.6).

Theorem 3.1. Let $1<p, q<\infty, N<r<\infty$ and $\max \left(q, q^{\prime}\right) \leq r\left(q^{\prime}=q /(q-1)\right)$. Assume that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain and that the weak Dirichlet-Neumann problem is uniquely solvable for $\mathcal{W}_{q}^{1}(\Omega)$ and $\mathcal{W}_{q^{\prime}}^{1}(\Omega)\left(q^{\prime}=q /(q-1)\right)$. Then, there exists a positive number $\gamma_{0}$ such that for any initial data $\mathbf{u}_{0} \in \mathcal{D}_{q, p}(\Omega)$ and right members $\mathbf{f}, g, \mathbf{g}$ and $\mathbf{h}$ with

$$
\begin{aligned}
& \mathbf{f} \in L_{p, 0, \gamma_{0}}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right), \quad g \in L_{p, 0, \gamma_{0}}\left(\mathbb{R}, W_{q}^{1}(\Omega)\right) \cap H_{p, 0, \gamma_{0}}^{1 / 2}\left(\mathbb{R}, L_{q}(\Omega)\right) \\
& \mathbf{g} \in W_{p, 0, \gamma_{0}}^{1}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right), \mathbf{h} \in L_{p, 0, \gamma_{0}}\left(\mathbb{R}, W_{q}^{1}(\Omega)^{N}\right) \cap H_{p, 0, \gamma_{0}}^{1 / 2}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right),
\end{aligned}
$$

problem (1.6) admits a unique solution $\mathbf{u} \in L_{p, \gamma_{0}}\left(\mathbb{R}_{+}, W_{q}^{2}(\Omega)\right) \cap W_{p, \gamma_{0}}^{1}\left(\mathbb{R}_{+}, L_{q}(\Omega)^{N}\right)$ with some pressure term $\theta \in L_{p, \gamma_{0}}\left(\mathbb{R}_{+}, W_{q}^{1}(\Omega)+\mathcal{W}_{q}^{1}(\Omega)\right)$ possessing the estimate:

$$
\begin{aligned}
& \left\|e^{-\gamma t} \partial_{t} \mathbf{u}\right\|_{L_{p}\left(\mathbb{R}_{+}, L_{q}(\Omega)\right)}+\left\|e^{-\gamma t} \mathbf{u}\right\|_{L_{p}\left(\mathbb{R}_{+}, W_{q}^{2}(\Omega)\right)} \leq C\left\{\left\|\mathbf{u}_{0}\right\|_{\left.B_{q, p}^{2(1-1 / p)}(\Omega)\right)}\right. \\
& \left.\quad+\left\|e^{-\gamma t}\left(\mathbf{f}, \partial_{t} \mathbf{g}\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}+\left\|e^{-\gamma t}(g, \mathbf{h})\right\|_{L_{p}\left(\mathbb{R}, W_{q}^{1}(\Omega)\right)}+\left\|e^{-\gamma t} \Lambda_{\gamma}^{1 / 2}(g, \mathbf{h})\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}\right\}
\end{aligned}
$$

for any $\gamma \geq \gamma_{0}$ with some constant $C$ independent of $\gamma \geq \gamma_{0}$.
To prove Theorem [2.4 we use the maximal $L_{p}-L_{q}$ regularity theorem for problem (1.6) in a finite time interval, which is derived from Theorem 3.1. But, we have to replace the nonlocal operator $\Lambda_{\gamma}^{1 / 2}$ with value in $L_{q}(\Omega)$ by the local operator $\partial_{t}$ with value in $W_{q}^{-1}(\Omega)$. For this purpose, first of all, we introduce the extension map $\iota: L_{1, \operatorname{loc}}(\Omega) \rightarrow L_{1, \operatorname{loc}}\left(\mathbb{R}^{N}\right)$ having the following properties:
(e-1) For any $1<q<\infty$ and $f \in W_{q}^{1}(\Omega), \iota f \in W_{q}^{1}\left(\mathbb{R}^{N}\right), \iota f=f$ in $\Omega$ and $\|\iota f\|_{W_{q}^{i}\left(\mathbb{R}^{N}\right)} \leq C_{q}\|f\|_{W_{q}^{i}(\Omega)}$ for $i=0,1$ with some constant $C_{q}$ depending on $q, r$ and $\Omega$.
(e-2) For any $1<q<\infty$ and $f \in W_{q}^{1}(\Omega),\left\|(1-\Delta)^{-1 / 2} \iota(\nabla f)\right\|_{L_{q}\left(\mathbb{R}^{N}\right)} \leq C_{q}\|f\|_{L_{q}(\Omega)}$ with some constant $C_{q}$ depending on $q, r$ and $\Omega$.
Here, $(1-\Delta)^{-1 / 2}$ is the operator defined by $(1-\Delta)^{-1 / 2} f=\mathcal{F}^{-1}\left[\left(1+|\xi|^{2}\right)^{1 / 4} \mathcal{F}[f]\right]$ with the help of Fourier transform $\mathcal{F}$ and Fourier inverse transform $\mathcal{F}^{-1}$ which are defined by

In the following, such extension map $\iota$ is fixed. We define $W_{q}^{-1}(\Omega)$ by

$\partial_{t}\left[(1-\Delta)^{-1 / 2} \iota((\nabla f) g)\right]=(1-\Delta)^{-1 / 2} \iota\left[\nabla\left\{\left(\partial_{t} f\right) g\right\}\right]-(1-\Delta)^{-1 / 2} \iota\left[\left(\partial_{t} f\right)(\nabla g)\right]+(1-\Delta)^{-1 / 2} \iota\left[(\nabla f) \partial_{t} g\right]$,
by (3.22), (3.9) and (e-2) we have Lemma 3.3.
Applying Lemma 3.3 to $G(\mathbf{w})$ and $\mathbf{H}(\mathbf{w}) \tilde{\mathbf{n}}$ with $f=\mathbf{w}, g=\mathbf{V}_{4}\left(\int_{0}^{t} \nabla(\mathbf{w}) d s\right)$ and $f=\mathbf{w}, g=$ $\mathbf{V}_{6}\left(\int_{0}^{t} \nabla(\mathbf{w}) d s\right) \tilde{\mathbf{n}}$, respectively, and using (3.14), (3.16) and (3.20), we have

Thus, applying Theorem 3.2 to problem (3.11) and using (3.15), (3.21) and (3.23), we have

Let $R$ be a number such that $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq R$ and set $L=\left(M_{2}+1\right) R$. Choosing $T>0$ so small that

Next, we show the contractility of the map $\Phi$ on $\mathcal{I}_{L, T}$. Let $\mathbf{w}_{i} \in \mathcal{I}_{L, T}$ and set $\mathbf{v}_{i}=\Phi\left(\mathbf{w}_{i}\right)(i=1,2)$. Setting $\mathbf{v}=\mathbf{v}_{1}-\mathbf{v}_{2}$, we have

\end{gather*}

with some pressure term $\omega$, where we have set

We estimate each terms in the right-hand side of (3.25). Recalling that $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq R$ and $L=\left(M_{2}+1\right) R$, by (3.12), (3.13), (3.14), (3.16) and (3.20) we have

Choosing $T$ smaller in such a way that $M_{4} M_{5} \mathcal{C}(R, T) \leq 1 / 2$, we have $\Phi$ is a contraction map on $\mathcal{I}_{L, T}$. Thus, the Banach fixed point theorem tells us that $\Phi$ has a unique fixed point $\mathbf{u}$ in $\mathcal{I}_{L, T}$ satisfying the equations (2.4).

Finally, we prove the uniqueness. Given two $\mathbf{v}_{i} \in \mathcal{I}_{L, T}(i=1,2)$ both of which satisfy the equations (2.4) with the same initial data $\mathbf{v}_{0} \in B_{q, p}^{2(1-1 / p}(\Omega)$, employing the same argument as in proving (3.28) and replacing $\mathbf{w}_{i}$ by $\mathbf{v}_{i}$, we have $\mathbb{I}_{\mathbf{v}_{1}-\mathbf{v}_{2}}(0, T) \leq M_{4} M_{5} \mathcal{C}(R, T) \mathbb{I}_{\mathbf{v}_{1}-\mathbf{v}_{2}}(0, T)$. Since $T$ has been chosen in such a way that $M_{4} M_{5} \mathcal{C}(R, T) \leq 1 / 2$, we have $\mathbb{I}_{\mathbf{v}_{1}-\mathbf{v}_{2}}(0, T) \leq \frac{1}{2} \mathbb{I}_{\mathbf{v}_{1}-\mathbf{v}_{2}}(0, T)$, which implies that $\mathbf{v}_{1}=\mathbf{v}_{2}$. This completes the proof of Theorem [2.4]

## 4 Some decay properties of solutions to problem (1.6)

In this section, we discuss exponential stability of solutions to problem (1.6) assuming that $\Omega$ is bounded in addition. Let $\mathcal{R}(\lambda)$ be the $\mathcal{R}$ bounded solution operator for problem (1.8) introduced in Sect. 1. If we consider the time shifted equation of (1.6):

\left.\mathbf{T}(\mathbf{v}, \hat{\theta}) \tilde{\mathbf{n}}\right|_{S}=\left.\mathbf{h}\right|_{S},\left.\quad \mathbf{v}\right|_{\Gamma}=0,\left.\quad \mathbf{v}\right|_{t=0}=\mathbf{u}_{0} \quad \text { in } \Omega, \tag{4.1}
\end{gather*}
$$

a solution $\mathbf{v}$ is represented by using $\mathcal{R}\left(\lambda+\lambda_{1}\right)$, so that we have the following theorem concerning the exponential stability of solutions to (4.1).

Theorem 4.1. Let $1<p, q<\infty, N<r<\infty$ and $\max \left(q, q^{\prime}\right) \leq r\left(q^{\prime}=q /(q-1)\right)$. Assume that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain and that weak Dirichlet-Neumann problem is uniquely solvable for $\mathcal{W}_{q}^{1}(\Omega)$ and $\mathcal{W}_{q^{\prime}}^{1}(\Omega)\left(q^{\prime}=q /(q-1)\right)$. Then, there exists a $\lambda_{1}>\lambda_{0}$ such that problem (4.1) admits a unique solution $(\mathbf{v}, \hat{\theta})$ with

& \quad \leq C\left(\left\|\mathbf{u}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)}+\left\|e^{\gamma t}\left(\mathbf{f}, \tilde{\Lambda}_{\gamma}^{1 / 2} g, \partial_{t} \mathbf{g}, \tilde{\Lambda}_{\gamma}^{1 / 2} \mathbf{h}\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}+\left\|e^{\gamma t}(g, \mathbf{h})\right\|_{L_{p}\left(\mathbb{R}, W_{q}^{1}(\Omega)\right)}\right)
\end{aligned}
$$

for any $\gamma \leq \lambda_{0}$ with some constants $C$ independent of $\gamma \leq \lambda_{0}$, provided that $\mathbf{u}_{0} \in \mathcal{D}_{q, p}(\Omega)$,

e^{\gamma t} \mathbf{f} \in L_{p}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right), \quad e^{\gamma t} g \in L_{p}\left(\mathbb{R}, W_{q}^{1}(\Omega)\right), \quad e^{\gamma t} \tilde{\Lambda}_{\gamma}^{1 / 2} g \in L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right), \\
e^{\gamma t} \partial_{t} \mathbf{g} \in L_{p}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right), e^{\gamma t} \mathbf{h} \in L_{p}\left(\mathbb{R}, W_{q}^{1}(\Omega)^{N}\right), e^{\gamma t} \tilde{\Lambda}_{\gamma}^{1 / 2} \mathbf{h} \in L_{p}\left(\mathbb{R}, L_{q}(\Omega)^{N}\right), \tag{4.2}
\end{gather*}
$$

and $\mathbf{f}, g, \mathbf{g}$ and $\mathbf{h}$ vanish for $t<0$. Here, we have defined $\tilde{\Lambda}_{\gamma}^{1 / 2} f$ by

Since the $\mathcal{R}$ boundedness implies the usual boundedness of operators, we also see that for any $\lambda \in$ $\Sigma_{\epsilon, \lambda_{0}}, \mathbf{f} \in L_{q}(\Omega)^{N}, g \in W_{q}^{1}(\Omega), \mathbf{g} \in L_{q}(\Omega)^{N}$ and $\mathbf{h} \in W_{q}^{1}(\Omega)^{N}$, a unique solution $\mathbf{v}$ of problem (1.8) possesses the generalized resolvent estmate:

with some constant $C$ depending on $\epsilon$ and $\lambda_{0}$. Especially, we see the existence of a continous semigroup $\{\mathbb{T}(t)\}_{t \geq 0}$ associated with problem (1.6), which is analytic.

To prove a global in time unique existence theorem for (2.4), we need the exponential stability of solutions to (1.6), so that from now on, we assume that $\Omega$ is bounded in addition. In this case, weak Dirichlet-Neumann problem is uniquely solvable for any exponent $q \in(1, \infty)$ with $\mathcal{W}_{q}^{1}(\Omega)=\hat{W}_{q, 0}^{1}(\Omega)$ and $J_{q}(\Omega)=\left\{\mathbf{f} \in L_{q}(\Omega)^{N}\left|\operatorname{div} \mathbf{f}=0, \mathbf{n}_{\Gamma} \cdot \mathbf{f}\right|_{\Gamma}=0\right\}$, where $\mathbf{n}_{\Gamma}$ is the unit outer normal to $\Gamma$. When $\Omega$ is bounded, the uniqueness of solutions to problem (1.8) holds when $\Gamma \neq \emptyset$ up to $\lambda=0$. When $\Gamma=\emptyset$, if we restrict the space of solutions to the quotient space $W_{q}^{2}(\Omega) / \mathcal{R}_{d}$, then we also have the uniqueness of solutions to (1.8). Namely, if $\mathbf{u} \in W_{q}^{2}(\Omega)$ satisfies the equations (1.8) with $\mathbf{f}=0, g=0, \mathbf{g}=0$ and $\mathbf{h}=0$ and if $\mathbf{u}$ satisfies the orthogonal condition: $\left(\mathbf{u}, \mathbf{p}_{\ell}\right)_{\Omega}=0$ for $\ell=1, \ldots, M$, then $\mathbf{u}=0$ up to $\lambda=0$. Moreover, if $\mathbf{f} \in L_{q}(\Omega)^{N}$ and $\mathbf{g} \in W_{q}^{1}(\Omega)^{N}$ satisfy the condition: $\left(\mathbf{f}, \mathbf{p}_{\ell}\right)_{\Omega}+<\mathbf{h}, \mathbf{p}_{\ell}>_{S}=0$, then a solution $\mathbf{u}$ to problem (1.8) also satisfies $\left(\mathbf{u}, \mathbf{p}_{\ell}\right)_{\Omega}=0$ whenever $\lambda \neq 0$. Here, $<f, g>_{S}=\int_{\Gamma} f(x) g(x) d \sigma$, $d \sigma$ being the surface element of $S$. Using these facts and applying a homotopic argument, we see that $\{\mathbb{T}(t)\}_{t \geq 0}$ is exponentially stable. Namely, we have the following theorem which was already proved in Shibata and Shimizu [23] in the case of $\Gamma=\emptyset$.

Theorem 4.2. Let $1<q<\infty, N<r<\infty$ and $\max \left(q, q^{\prime}\right) \leq r\left(q^{\prime}=q /(q-1)\right)$. Assume that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain and that $\Omega$ is bounded in addition. Then, there exists a continuous semigroup $\{\mathbb{T}(t)\}_{t \geq 0}$ on $J_{q}(\Omega)$ associated with problem (1.6) such that $\mathbf{u}=\mathbb{T}(t) \mathbf{u}_{0}$ with some pressure term $\theta$ solves problem (1.6) with $\mathbf{f}=0, g=0, \mathbf{g}=0$ and $\mathbf{h}=0$. Moreover, $\{\mathbb{T}(t)\}_{t \geq 0}$ is analytic and exponentially stable, that is

\end{equation*}

with some positive constants $C$ and $\gamma$ provided that $\mathbf{u}_{0} \in J_{q}(\Omega)$ when $\Gamma \neq \emptyset$ and $\mathbf{u}_{0} \in J_{q}(\Omega)$ satisfying the orthogonal condition: $\left(\mathbf{u}_{0}, \mathbf{p}_{\ell}\right)_{\Omega}=0$ for $\ell=1, \ldots, M$ when $\Gamma=\emptyset$. Here, $W_{q}^{0}(\Omega)=L_{q}(\Omega)$.

By Theorem 4.2, we have the following Corollary which was proved in Shibata and Shimizu [23] in the case of $\Gamma=\emptyset$ under the asumption that the boundary of $\Omega$ is a $C^{1,1}$ hypersurface.

Corollary 4.3. Let $1<q<\infty, N<r<\infty$ and $\max \left(q, q^{\prime}\right) \leq r\left(q^{\prime}=q /(q-1)\right)$. Assume that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain and that $\Omega$ is bounded in addition. Then, there exists a positive constant $\gamma_{0}$ such that problem (1.6) with $\mathbf{f}=0, g=0, \mathbf{g}=0$ and $\mathbf{h}=0$ admits unique solutions $\mathbf{u}$ and $\theta$ with

with some positive constants $C$ independent of $\gamma \leq \gamma_{0}$ provided that $\mathbf{u}_{0} \in \mathcal{D}_{q, p}(\Omega)$ when $\Gamma \neq \emptyset$ and $\mathbf{u}_{0} \in \mathcal{D}_{q, p}(\Omega)$ and $\mathbf{u}_{0}$ satisfies the orthogonal condition: $\left(\mathbf{u}_{0}, \mathbf{p}_{\ell}\right)_{\Omega}=0$ for $\ell=1, \ldots, M$ when $\Gamma=\emptyset$.

Under the preparations mentioned above, we show the following theorem about the exponential stability of solutions to (1.6).
Theorem 4.4. Let $1<p, q<\infty, N<r<\infty$ and $\max \left(q, q^{\prime}\right) \leq r\left(q^{\prime}=q /(q-1)\right)$. Assume that $\Omega$ is a uniform $W_{r}^{2-1 / r}$ domain and that $\Omega$ is bounded in addition. Then, there exists a positive constant $\gamma_{0}$ such that the following assertion holds: Let $\mathbf{u}_{0} \in \mathcal{D}_{q, p}(\Omega)$, and let right members $\mathbf{f}, g$, $\mathbf{g}$, and $\mathbf{h}$ for (1.6) satisfy the decay condition (4.2) and vanish for $t<0$, then problem (1.6) with $T=\infty$ admits a unique solution $\mathbf{u} \in L_{p}\left(\mathbb{R}_{+}, W_{q}^{2}(\Omega)^{N}\right) \cap W_{p}^{1}\left(\mathbb{R}_{+}, L_{q}(\Omega)^{N}\right)$ with some pressure term $\theta \in L_{p}\left(\mathbb{R}_{+}, W_{q}^{1}(\Omega)+\hat{W}_{q, 0}^{1}(\Omega)\right)$ possessing the estimate:

Then, there exists a positive constant $\gamma_{0}$ such that for any $\mathbf{u}_{0} \in \mathcal{D}_{p, q}(\Omega)$ and right members $\mathbf{f}, g$, $\mathbf{g}$ and $\mathbf{h}$ with

& \left\|e^{\gamma s}\left(\phi_{t} E_{t} g, \partial_{s}\left(\phi_{t} E_{t} \mathbf{h}\right)\right)\right\|_{L_{p}\left(\mathbb{R}, W_{q}^{1}(\Omega)\right)} \leq C e^{2 \gamma_{0}}\left\|e^{\gamma s}(g, \mathbf{h})\right\|_{L_{p}\left((0, t), W_{q}^{1}(\Omega)\right)} \tag{4.16}
\end{align*}
$$

for any $\gamma \in\left(0, \gamma_{0}\right]$ with some constant independent of $\gamma, t$ and $T$.
In addition, applying the same argumentation as in the proof of the inequality (3.2) in the appendix below, we have

\end{equation*}

so that using (4.15) and (3.4), we have

& \quad \leq C e^{2 \gamma_{0}}\left\{\left\|e^{\gamma s} \partial_{s}\left[(1-\Delta)^{-1 / 2}(\iota g, \iota \mathbf{h})\right]\right\|_{L_{p}\left((0, t), L_{q}\left(\mathbb{R}^{N}\right)\right)}+\left\|e^{\gamma s}(g, \mathbf{h})\right\|_{L_{p}\left((0, t), W_{q}^{1}(\Omega)\right)}\right\} .
\end{align*}
$$

Setting $\mathbf{u}=\mathbf{u}^{T}$ and $\theta=\theta^{T}$ and combining (4.14), (4.16) and (4.18), we have Theorem 4.5)

## 5 A proof of a global in time unique existence theorem

In this section, we prove Theorem [2.6, so that we assume that $\Omega$ is bounded in addition. Let $T_{0}$ be a positive number such that for any initial data $\mathbf{v}_{0} \in \mathcal{D}_{q, p}(\Omega)$ with $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq 1$, problem (2.4) admits a unique solution $\mathbf{u} \in \mathcal{S}_{p, q}^{1,2}\left(0, T_{0}\right)$ satisfying (2.10). Here and in the following, we set

\begin{aligned}
\mathcal{S}_{p, q}^{1,2}(a, b) & =W_{p}^{1}\left((a, b), L_{q}(\Omega)^{N}\right) \cap L_{p}\left((a, b), W_{q}^{2}(\Omega)^{N}\right), \\
\mathbb{I}_{\mathbf{v}}(a, b) & =\left\|e^{\gamma t} \partial_{t} \mathbf{v}\right\|_{L_{p}\left((a, b), L_{q}(\Omega)\right)}+\left\|e^{\gamma t} \mathbf{v}\right\|_{L_{p}\left((a, b), W_{q}^{2}(\Omega)\right)}
\end{aligned}
$$

for any $a, b$ satisfying $0 \leq a<b \leq \infty$ for the notational simplicity, where $\gamma$ is a fixed positive number for which Theorem 4.2 and Theorem 4.4 hold. By Theorem 2.4, such $T_{0}>0$ exists.

Let $\epsilon$ be a small positive number $\leq 1$ that is determined later and we assume that $\mathbf{v}_{0} \in \mathcal{D}_{q, p}(\Omega)$ and $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq \epsilon$. Let $T$ be a positive number such that problem (2.4) admits a solution $\mathbf{u} \in \mathcal{S}_{p, q}^{1,2}(0, T)$ that satisfies (2.10). Since $\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq \epsilon \leq 1$, we have $T \geq T_{0}$. The main step is to prove that there exist constants $\epsilon_{0}>0$ and $M_{6}$ independet of $\epsilon$ and $T$ such that

for any $t \in(0, T]$ provided that $0<\epsilon \leq \epsilon_{0}$.
In fact, let $r_{ \pm}(\epsilon)$ be two roots of the quadratic equation: $M_{6}\left(\epsilon+x^{2}\right)-x=0$, that is $r_{ \pm}(\epsilon)=$ $\left(2 M_{6}\right)^{-1} \pm \sqrt{\left(2 M_{6}\right)^{-2}-\epsilon}$. We find a small posivite number $\epsilon_{1}>0$ such that $0<r_{-}(\epsilon)<r_{+}(\epsilon)$ whenever $0<\epsilon \leq \epsilon_{1}$. In this case, $r_{-}(\epsilon)=M_{6} \epsilon+O\left(\epsilon^{2}\right)$ as $\epsilon \rightarrow 0+0$. Since $\mathbb{I}_{\mathbf{u}}(0, t) \rightarrow 0$ as $t \rightarrow 0$ and $\mathbb{I}_{\mathbf{u}}(0, t)$ is a continuous function with respect to $t$, by (5.1) we have $\mathbb{I}_{\mathbf{u}}(0, t) \leq r_{-}(\epsilon)$ for any $t \in(0, T]$, especially $\mathbb{I}_{\mathbf{u}}(0, T) \leq r_{-}(\epsilon)$. To prove

\sup _{t \in(0, T)}\|\mathbf{u}(\cdot, t)\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq M_{7}\left(\mathbf{I}_{\mathbf{u}}(0, T)+e^{-\gamma T}\left\|\mathbf{v}_{0}\right\|_{B_{q, p}^{2(1-1 / p)}(\Omega)}\right) \tag{5.2}
\end{equation*}
$$

we take $\mathbf{Z} \in \mathcal{S}_{p, q}^{1,2}(0, \infty)$ which solves (3.18) with some pressure term $\Pi$. By Corollary 4.3 we have

with some constant $M_{8}$ independent of $\epsilon$ and $T$, because $\mathbf{v}_{0}$ satisfies (2.14) when $\Gamma=\emptyset$. Employing the same argument as in the proof of (3.16), we have (5.2).

Since we may assume that $r_{-}(\epsilon) \leq 2 M_{0}$, by (5.2) we have $\|\mathbf{u}(\cdot, T-0)\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq M_{7}\left(2 M_{0}+1\right) \epsilon$, because $e^{-\gamma T} \leq 1$. Choose $\epsilon$ so small that $M_{7}\left(2 M_{0}+1\right) \epsilon \leq 1$. By Theorem 2.4] there exists a unique solution $\mathbf{u}^{\prime} \in \mathcal{S}_{p, q}^{1,2}\left(T, T+T_{0}\right)$ of the equations:

\left.\mathbf{T}\left(\mathbf{u}^{\prime}, \theta^{\prime}\right) \mathbf{n}\right|_{S}=\left.\mathbf{H}\left(\mathbf{u}^{\prime}\right) \mathbf{n}\right|_{S},\left.\mathbf{u}^{\prime}\right|_{\Gamma}=0,\left.\mathbf{u}^{\prime}\right|_{t=T+0}=\left.\mathbf{u}\right|_{t=T-0},
\end{gathered}
$$

with some pressure term $\theta^{\prime}$. Choosing $T_{0}$ smaller if necessary, we may assume that

\int_{T}^{T+T_{0}}\left\|\nabla \mathbf{u}^{\prime}(\cdot, t)\right\|_{L_{\infty}(\Omega)} d t \leq \sigma / 2
$$

Since $\int_{0}^{T}\|\nabla \mathbf{u}(\cdot, t)\|_{L_{\infty}(\Omega)} d t \leq M_{9} \mathbb{I}_{\mathbf{u}}(0, T)$ with some constant $M_{9}$ independent of $\epsilon$ and $T$ as follows from (3.9), we choose $\epsilon$ so small that $M_{9} \epsilon<\sigma / 2$, so that $\int_{0}^{T}\|\nabla \mathbf{u}(\cdot, t)\|_{L_{\infty}(\Omega)} d t \leq \sigma / 2$. If we define $\mathbf{u}^{\prime \prime}$ by $\mathbf{u}^{\prime \prime}(\cdot, t)=\mathbf{u}(\cdot, t)$ for $0 \leq t \leq T$ and $\mathbf{u}^{\prime \prime}(\cdot, t)=\mathbf{u}^{\prime}(\cdot, t)$ for $T \leq t \leq T+T_{0}$, then $\mathbf{u}^{\prime \prime}$ satisfies the equations (2.4) for $t \in\left(0, T+T_{0}\right)$ with some pressure term $\theta^{\prime}$ and the condition: $\int_{0}^{T+T_{0}}\left\|\mathbf{u}^{\prime \prime}(\cdot, t)\right\|_{L_{\infty}(\Omega)} d t \leq \sigma$. Thus, by (5.1) $\mathbb{I}_{\mathbf{u}^{\prime \prime}}\left(0, T+T_{0}\right) \leq M_{6}\left(\epsilon+\mathbb{I}_{\mathbf{u}^{\prime \prime}}\left(0, T+T_{0}\right)^{2}\right)$. Repeating this argument, we can prolong $\mathbf{u}$ to any time interval $(0, T)$ with $\mathbb{I}_{\mathbf{u}}(0, T) \leq r_{-}(\epsilon)$, which completes the existence of solution $\mathbf{u}$ globally defined in time with $\mathbb{I}_{\mathbf{u}}(0, \infty) \leq r_{-}(\epsilon)$. The uniquness follows from the same argumentations as in the proof of Theorem 2.4 with small $\epsilon>0$ instead of small $T>0$. Therefore, our task is to prove (5.1).

Applying Theorem 4.4 to problem (2.4), we have

\end{equation*}

for any $t \in(0, T]$ with

\begin{aligned}
\mathbb{K}_{\mathbf{u}}(0, t) & =\left\|e^{\gamma s}\left(\mathbf{F}(\mathbf{u}), \partial_{s} \mathbf{G}(\mathbf{u})\right)\right\|_{L_{p}\left((0, t), L_{q}(\Omega)\right)}+\left\|e^{\gamma s}(G(\mathbf{u}), \mathbf{H}(\mathbf{u}) \tilde{\mathbf{n}})\right\|_{L_{p}\left((0, t), W_{q}^{1}(\Omega)\right)} \\
& +\left\|e^{\gamma s} \partial_{s}\left[(1-\Delta)^{-1 / 2}(\iota G(\mathbf{u}), \iota \mathbf{H}(\mathbf{u}) \tilde{\mathbf{n}})\right)\right\|_{L_{p}\left((0, t), L_{q}\left(\mathbb{R}^{N}\right)\right)}
\end{aligned}
$$

Here and in the following, $C$ denotes a generic constant independent of $\epsilon, t \in(0, T]$ and $T$.
When $\Gamma=\emptyset, \delta(\Gamma)=1$, so that we have to estimate $\left.\int_{0}^{t}\left|e^{\gamma t}\left(\mathbf{u}(\cdot, s), \mathbf{p}_{\ell}\right)_{\Omega}\right|\right)^{p} d s$. Recalling Remark 2.5 (1), $\mathbf{v}(x, t)=\mathbf{u}\left(\mathbf{X}_{\mathbf{u}}^{-1}(x, t), t\right)$ satisfies the equation (1.1) with (1.2), where $\mathbf{X}^{-1}(x, t)$ denotes the inverse map of the correspondence: $x=\xi+\int_{0}^{t} \mathbf{u}(\xi, s) d s=\mathbf{X}_{\mathbf{u}}(\xi, t)$. Since $\frac{d}{d t} \int_{\Omega_{t}} \mathbf{v}(x, t) \mathbf{p}_{\ell}(x) d x=0$, by (2.14) we have $\int_{\Omega_{t}} \mathbf{v}(x, t) \mathbf{p}_{\ell}(x) d x=0$, so that

& \leq C\|\mathbf{u}(\cdot, s)\|_{L_{q}(\Omega)}\left(\int_{0}^{s} e^{-p^{\prime} \gamma r} d s\right)^{1 / p^{\prime}}\left(\int_{0}^{t}\left(e^{\gamma r}\|\mathbf{u}(\cdot, r)\|_{W_{q}^{1}(\Omega)}\right)^{p} d r\right)^{1 / p}
\end{aligned}
$$

Thus, we have

\delta(\Gamma) \sum_{\ell=1}^{M}\left(\int_{0}^{t}\left|e^{\gamma s}\left(\mathbf{u}(\cdot, s), \mathbf{p}_{\ell}\right)_{\Omega}\right|^{p} d s\right)^{1 / p} \leq C \mathbb{I}_{\mathbf{u}}(0, t)^{2} \tag{5.4}
\end{equation*}

From now on, we estimate $\mathbb{K}_{\mathbf{u}}(0, t)$. By Hölder's inequality we have

\end{equation*}
$$

Since (2.10) holds and since we may assume that $\sigma \leq 1$, by (2.6), (5.5) and (3.9)

& \sup _{s \in(0, t)} \| \nabla \mathbf{W}\left(\int_{0}^{s} \nabla \mathbf{u}(\cdot, r) d r \|_{L_{q}(\Omega)} \leq C \mathbb{I}_{\mathbf{u}}(0, t),\right. \tag{5.6}
\end{align*}
$$

where $i=1,2,4,5$ and 6 and $\mathbf{W}=\mathbf{W}(\mathbf{K})$ is any matrix of polynomials with respect to $\mathbf{K}$. By (3.9), (1.7), (2.5) and (5.6), we have

Since $B_{q, p}^{2(1-1 / p)}(\Omega) \subset W_{q}^{1}(\Omega)$ as follows from the assumption: $2<p, \infty$, by (5.2) we have

\end{equation*}

because $0<\epsilon \leq 1$.
To estimate $\left\|e^{\gamma t}\left(\tilde{\Lambda}_{\gamma}^{1 / 2} g_{\mathbf{u}}, \tilde{\Lambda}_{\gamma}^{1 / 2}\left(\mathbf{h}_{\mathbf{u}} \tilde{\mathbf{n}}\right)\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}$, we use the following lemma which can be proved in the same manner as in the proof of Lemma 3.3.

Lemma 5.1. Let $1<p, q<\infty, N<r, q<\infty$ and let $\Omega$ be a uniform $W_{r}^{2-1 / r}$. Let $\iota$ be the extension map satisfying the properties (e-1) and (e-2). Then

\end{aligned}

Applying Lemma 5.1 and using (1.7), (5.6) and (5.7), we have

& \quad \leq C\left(\mathbb{I}_{\mathbf{u}}(0, t)^{2}+\left(\mathbb{I}_{\mathbf{u}}(0, T)+\epsilon\right) \mathbb{I}_{\mathbf{u}}(0, T)\right) \leq 2\left(\mathbb{I}_{\mathbf{u}}(0, T)^{2}+\epsilon\right)
\end{align*}
$$

which combined with (5.3), (5.4), (5.7) and (5.9) furnishes (5.1). This completes the proof of Theorem 2.6

## A A proof of the inequality (3.2)

First, we prove the inequality (3.2) in case of $\Omega=\mathbb{R}^{N}$.
Lemma A.1. Let $1<p, q<\infty$ and set $(1-\Delta)^{s} f-\mathcal{F}_{\xi}^{-1}\left[\left(1+|\xi|^{2}\right)^{s / 2} \hat{f}(\xi)\right]$ for $f \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ and $s \in \mathbb{R}$. Here, $\hat{f}$ denotes the Fourier transform of $f, \mathcal{F}_{\xi}^{-1}$ the inverse Fourier transform and $\mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ the space of tempered distributions on $\mathbb{R}^{N}$ in the sense of L. Schwartz. Then, we have

\end{aligned}

Proof. The idea of our proof here is the same as in the proof of Proposition 2.8 in [24. Let $\varphi_{0}(t)$ be a function in $C^{\infty}(\mathbb{R})$ such that $\varphi_{0}(t)=1$ for $|t| \leq 1$ and $\varphi_{0}(t)=0$ for $|t| \geq 2$, and set $\varphi_{\infty}(t)=1-\varphi_{0}(t)$. We define functions $A_{j}(\xi, \lambda)(j=1,2)$ by

$$
\begin{aligned}
& A_{1}(\xi, \lambda)=\varphi_{\infty}(\tau) \varphi_{0}\left(\frac{\left(1+|\xi|^{2}\right)^{1 / 2}}{|\lambda|}\right) \frac{\left(1+|\xi|^{2}\right)^{1 / 4} \lambda^{1 / 2}}{\lambda} \\
& A_{2}(\xi, \lambda)=\varphi_{\infty}(\tau) \varphi_{\infty}\left(\frac{\left(1+|\xi|^{2}\right)^{1 / 2}}{|\lambda|}\right) \frac{\lambda^{1 / 2}}{\left(1+|\xi|^{2}\right)^{1 / 4}}
\end{aligned}
$$

We have

$$
\left|\partial_{\tau}^{\ell} \partial_{\xi}^{\alpha} A_{j}(\xi, \lambda)\right| \leq C_{\ell, \alpha}|\tau|^{-\ell}|\xi|^{-|\alpha|} \quad(\lambda=i \tau+\gamma, \quad j=1,2)
$$

for any $\ell \in \mathbb{N}_{0}$ and $\alpha \in \mathbb{N}_{0}^{N}, \xi \in \mathbb{R}^{N} \backslash\{0\}, \tau, \gamma \in \mathbb{R} \backslash\{0\}$ with some constant $C_{\ell, \alpha}$ depending solely on $\ell$ and $\alpha$. Set $A_{j}\left(\lambda, D_{x}\right) f=\mathcal{F}_{\xi}^{-1}\left[A_{j}(\xi, \lambda) \hat{f}(\xi)\right]$ for any $f \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$, and then by Theorem 3.3 in [12] we know that the sets $\left\{\tau^{k} \partial_{\tau}^{k} A_{j}\left(\lambda, D_{x}\right) \mid \tau \in \mathbb{R} \backslash\{0\}\right\}$ are $\mathcal{R}$-bounded families in $\mathcal{L}\left(L_{q}\left(\mathbb{R}^{N}\right)\right)$ and their $\mathcal{R}$-bounded are less than $C_{q, N} \max _{|\alpha| \leq N+2} C_{k, \alpha}$ for $k=0,1$ and $j=1,2$, where $\mathcal{L}\left(L_{q}\left(\mathbb{R}^{N}\right)\right)$ is the set of all bounded linear operators on $L_{q}\left(\mathbb{R}^{N}\right)$. Therefore, by Weis's operator valued Fourier multiplier theorem [38] we have

$$
\begin{equation*}
\left\|e^{-\gamma t} A_{j}\left(\partial_{t}, D_{x}\right) F\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)} \leq C\left\|e^{-\gamma t} F\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)} \quad(\gamma \neq 0) \tag{A.1}
\end{equation*}
$$

Here, the operators $A_{j}\left(\partial_{t}, D_{x}\right)$ are defined by

$$
A_{j}\left(\partial_{t}, D_{x}\right) F=\mathcal{L}_{\lambda}^{-1}\left[A_{j}\left(\lambda, D_{x}\right) \mathcal{L}[F](\lambda, \cdot)\right](t)
$$

Dividing $\lambda^{1 / 2}$ into the following three parts:

$$
\lambda^{1 / 2}=\varphi_{0}(\tau) \lambda^{1 / 2}+\varphi_{\infty}(\tau) A_{1}(\xi, \lambda) \frac{\lambda}{\left(1+|\xi|^{2}\right)^{1 / 4}}+\varphi_{\infty}(\tau) A_{2}(\xi, \lambda)\left(1+|\xi|^{2}\right)^{1 / 4}
$$

and using (A.1) and Bourgain's Fourier multiplier theorem [8, we have Lemma A. 1 ,
Proof of the inequality (3.2). To prove the lemma, we use the exitension map $E$ having the following properties:
(Ex-1) $\|E f\|_{L_{q}\left(\mathbb{R}^{N}\right)} \leq C_{q, \Omega}\|f\|_{L_{q}(\Omega)}$
(Ex-2) $\quad\left\|(1-\Delta)^{1 / 2} E f\right\|_{L_{q}\left(\mathbb{R}^{N}\right)} \leq C_{q, \Omega}\|f\|_{W_{q}^{1}(\Omega)}$
(Ex-3) $\quad\left\|(1-\Delta)^{-1 / 2} E(\nabla f)\right\|_{L_{q}\left(\mathbb{R}^{N}\right)} \leq C_{q, \Omega}\|f\|_{L_{q}(\Omega)}$.
Such extension map can be constructed under the assumption that $N<q, r<\infty$. By Lemma A.1, we have

$$
\begin{aligned}
& \left\|e^{-\gamma t} \Lambda_{\gamma}^{1 / 2}((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)} \leq\left\|e^{-\gamma t} \Lambda_{\gamma}^{1 / 2} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)} \\
& \quad \leq\left\|e^{-\gamma t} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}+\left\|e^{-\gamma t}(1-\Delta)^{-1 / 2} \partial_{t} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)} \\
& \quad+\left\|e^{-\gamma t}(1-\Delta)^{1 / 2}((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}
\end{aligned}
$$

Using the identity: $\partial_{t}((\nabla f) g)=\nabla\left(\partial_{t} f \cdot g\right)-\partial_{t} f(\nabla g)+(\nabla f) \partial_{t} g$ and (Ex-3), we have

$$
\begin{aligned}
& \left\|e^{-\gamma t}(1-\Delta)^{-1 / 2} \partial_{t} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)} \leq C\left\|e^{-\gamma t}\left(\partial_{t} f \cdot g\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)} \\
& \quad+\left\|e^{-\gamma t}(1-\Delta)^{-1 / 2} E\left(\partial_{t} f(\nabla g)\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)}+\left\|e^{-\gamma t}(1-\Delta)^{-1 / 2} E\left((\nabla f) \partial_{t} g\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right.}
\end{aligned}
$$

By (3.9) and (Ex-1), we have

$$
\begin{aligned}
\left\|e^{-\gamma t}\left(\partial_{t} f \cdot g\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}^{p} \leq C \int_{-\infty}^{\infty}\left(e^{-\gamma t}\left\|\partial_{t} f(\cdot, t)\right\|_{L_{q}(\Omega)}\|g(\cdot, t)\|_{W_{q}^{1}(\Omega)}\right)^{p} d t \\
\left\|e^{-\gamma t} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}(\Omega)\right)}^{p} \leq C \int_{-\infty}^{\infty}\left(e^{-\gamma t}\|\nabla f(\cdot, t)\|_{L_{q}(\Omega)}\|g(\cdot, t)\|_{W_{q}^{1}(\Omega)}\right)^{p} d t
\end{aligned}
$$

To estimate other terms, we use the inequality:

$$
\begin{equation*}
\left\|(1-\Delta)^{-1 / 2} E(f g)\right\|_{L_{q}\left(\mathbb{R}^{N}\right)} \leq C\|f\|_{L_{q}(\Omega)}\|g\|_{L_{q}(\Omega)} \tag{A.2}
\end{equation*}
$$

In fact, for any $\varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, we observe that

$$
\begin{aligned}
\left|\left((1-\Delta)^{-1 / 2} E(f, g), \varphi\right)_{\mathbb{R}^{N}}\right| & \leq\|E(f g)\|_{L_{q / 2}\left(\mathbb{R}^{N}\right)}\left\|(1-\Delta)^{-1 / 2} \varphi\right\|_{L_{s}\left(\mathbb{R}^{N}\right)} \\
& \leq C\|f\|_{L_{q}(\Omega)}\|g\|_{L_{q}(\Omega)}\left\|(1-\Delta)^{-1 / 2} \varphi\right\|_{L_{s}\left(\mathbb{R}^{N}\right)}
\end{aligned}
$$

where $s$ is an index such that $1 / s+2 / q=1$. Since $2 \leq N<q<\infty$, we can choose such $s$ with $1<s<\infty$. Since $N\left(1 / q^{\prime}-1 / s\right)=N(1-1 / q-1 / s)=N / q<1$, we have $\left\|(1-\Delta)^{-1 / 2} \varphi\right\|_{L_{s}\left(\mathbb{R}^{N}\right)} \leq$ $C\left\|(1-\Delta)^{-1 / 2} \varphi\right\|_{W_{q^{\prime}}^{1}\left(\mathbb{R}^{N}\right)}$, so that we have A.2).

By (A.2) we have

$$
\begin{gathered}
\left\|e^{-\gamma t}(1-\Delta)^{-1 / 2} E\left(\partial_{t} f(\nabla g)\right)\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)}^{p} \leq C \int_{-\infty}^{\infty}\left(e^{-\gamma t}\left\|\partial_{t} f(\cdot, t)\right\|_{L_{q}(\Omega)}\|\nabla g(\cdot, t)\|_{L_{q}(\Omega)}\right)^{p} d t, \\
\left.\| e^{-\gamma t}(1-\Delta)^{-1 / 2} E\left((\nabla f) \partial_{t} g\right)\right) \|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)}^{p} \leq C \int_{-\infty}^{\infty}\left(e^{-\gamma t}\|\nabla f(\cdot, t)\|_{L_{q}(\Omega)}\left\|\partial_{t} g(\cdot, t)\right\|_{L_{q}(\Omega)}\right)^{p} d t .
\end{gathered}
$$

By (3.9) and (Ex-2) we have

$$
\begin{aligned}
\left\|e^{-\gamma t}(1-\Delta)^{1 / 2} E((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, L_{q}\left(\mathbb{R}^{N}\right)\right)}^{p} & \leq C\left\|e^{-\gamma t}((\nabla f) g)\right\|_{L_{p}\left(\mathbb{R}, W_{q}^{1}\left(\mathbb{R}^{N}\right)\right)}^{p} \\
& \leq C \int_{-\infty}^{\infty}\left(e^{-\gamma t}\|\nabla f(\cdot, t)\|_{W_{q}^{1}(\Omega)}\|\nabla g(\cdot, t)\|_{W_{q}^{1}(\Omega)}\right)^{p} d t .
\end{aligned}
$$

This completes the proof of the inequality (3.2).
