# THREE-DIMENSIONAL PURELY QUASI-MONOMIAL ACTIONS

#### Abstract

Let $G$ be a finite subgroup of $\operatorname{Aut}_{k}\left(K\left(x_{1}, \ldots, x_{n}\right)\right)$ where $K / k$ is a finite field extension and $K\left(x_{1}, \ldots, x_{n}\right)$ is the rational function field with $n$ variables over $K$. The action of $G$ on $K\left(x_{1}, \ldots, x_{n}\right)$ is called quasi-monomial if it satisfies the following three conditions (i) $\sigma(K) \subset K$ for any $\sigma \in G$; (ii) $K^{G}=k$ where $K^{G}$ is the fixed field under the action of $G$; (iii) for any $\sigma \in G$ and $1 \leq j \leq n, \sigma\left(x_{j}\right)=c_{j}(\sigma) \prod_{i=1}^{n} x_{i}^{a_{i j}}$ where $c_{j}(\sigma) \in K^{\times}$and $\left[a_{i, j}\right]_{1 \leq i, j \leq n} \in$ $G L_{n}(\mathbb{Z})$. A quasi-monomial action is called purely quasi-monomial if $c_{j}(\sigma)=1$ for any $\sigma \in G$, any $1 \leq j \leq n$. When $k=K$, a quasi-monomial action is called monomial. The main problem is that, under what situations, $K\left(x_{1}, \ldots, x_{n}\right)^{G}$ is rational (= purely transcendental) over $k$. For $n=1$, the rationality problem was solved by Hoshi, Kang and Kitayama. For $n=2$, the problem was solved by Hajja when the action is monomial, by Voskresenskii when the action is faithful on $K$ and purely quasi-monomial, which is equivalent to the rationality problem of $n$-dimensional algebraic $k$-tori which split over $K$, and by Hoshi, Kang and Kitayama when the action is purely quasi-monomial. For $n=3$, the problem was solved by Hajja, Kang, Hoshi and Rikuna when the action is purely monomial, by Hoshi, Kitayama and Yamasaki when the action is monomial except for one case and by Kunyavskii when the action is faithful on $K$ and purely quasi-monomial. In this paper, we determine the rationality when $n=3$ and the action is purely quasi-monomial except for few cases using a technique of conjugacy classes move. As an application, we will show the rationality of some 5 -dimensional purely monomial actions which are decomposable.

## 1. Introduction

Let $k$ be a field and $K$ be a finitely generated field extension of $k$. $K$ is called $k$-rational (or rational over $k$ ) if $K$ is purely transcendental over $k$, i.e. $K$ is isomorphic to $k\left(x_{1}, \ldots, x_{n}\right)$, the rational function field with $n$ variables over $k$ for some integer $n$. $K$ is called stably $k$ rational if $K\left(y_{1}, \ldots, y_{m}\right)$ is $k$-rational for some $y_{1}, \ldots, y_{m}$ such that $y_{1}, \ldots, y_{m}$ are algebraically independent over $K$. When $k$ is an infinite field, $K$ is called retract $k$-rational if $K$ is the quotient field of some integral domain $A$ where $k \subset A \subset K$ satisfying the conditions that there exist a polynomial ring $k\left[X_{1}, \ldots, X_{m}\right]$, some non-zero element $f \in k\left[X_{1}, \ldots, X_{m}\right]$, and $k$-algebra morphisms $\varphi: A \rightarrow k\left[X_{1}, \ldots, X_{m}\right][1 / f], \psi: k\left[X_{1}, \ldots, X_{m}\right][1 / f] \rightarrow A$ such that $\psi \circ \varphi=1_{A}$. $K$ is called $k$-unirational if $k \subset K \subset k\left(x_{1}, \ldots, x_{n}\right)$ for some integer $n$. It is not difficult to see that " $k$-rational" $\Rightarrow$ "stably $k$-rational" $\Rightarrow$ "retract $k$-rational" $\Rightarrow$ " $k$-unirational". The reader is referred to the papers MT86, CTS07, Swa83] for surveys of the various rationality problems, e.g. Noether's problem. We will restrict ourselves to consider the rationality problem of the fixed field $K\left(x_{1}, \ldots, x_{n}\right)^{G}$ under the following special kind of actions:
Definition 1.1 ([HKK14, Definition 1.1]). Let $G$ be a finite subgroup of $\operatorname{Aut}_{k}\left(K\left(x_{1}, \ldots, x_{n}\right)\right)$. (1) The action of $G$ on $K\left(x_{1}, \ldots, x_{n}\right)$ is called quasi-monomial if it satisfies the following three conditions:
(i) $\sigma(K) \subset K$ for any $\sigma \in G$;
(ii) $K^{G}=k$, where $K^{G}$ is the fixed field under the action of $G$;
(iii) for any $\sigma \in G$ and any $1 \leq j \leq n$,

$$
\sigma\left(x_{j}\right)=c_{j}(\sigma) \prod_{i=1}^{n} x_{i}^{a_{i j}}
$$

where $c_{j}(\sigma) \in K^{\times}$and $\left[a_{i j}\right]_{1 \leq i, j \leq n} \in G L_{n}(\mathbb{Z})$.
(2) The quasi-monomial action is called purely quasi-monomial action if $c_{j}(\sigma)=1$ for any $\sigma \in G$ and any $1 \leq j \leq n$ in (iii).
(3) The quasi-monomial action is called monomial action if $G$ acts trivially on $K$, i.e. $k=K$.
(4) The quasi-monomial action is called purely monomial action if it is purely quasi-monomial and monomial.

We have the following implications:


Algebraic torus case.
When $G \simeq \operatorname{Gal}(K / k)$, i.e. $G$ acts faithfully on $K$, and $G$ acts on $K\left(x_{1}, \ldots, x_{n}\right)$ by purely quasi-monomial $k$-automorphisms, the rationality problem of $K\left(x_{1}, \ldots, x_{n}\right)^{G}$ coincides with that of algebraic $k$-tori of dimension $n$ which split over $K$ (see [HKK14, Section 1], [Hos14], [HY17]). The rationality problem of algebraic $k$-tori of dimension two and three was solved by Voskresenskii [Vos67] and Kunyavskii Kun87] respectively:

Theorem 1.2 (Voskresenskii Vos67]). Let $k$ be a field. All the two-dimensional algebraic $k$ tori are $k$-rational. In particular, $K\left(x_{1}, x_{2}\right)^{G}$ is $k$-rational if $G$ acts on $K$ faithfully and on $K\left(x_{1}, x_{2}\right)$ by purely quasi-monomial $k$-automorphisms.
Theorem 1.3 (Kunyavskii Kun87, see also Kang Kan12, Section 1]). Let $k$ be a field. All the three-dimensional algebraic $k$-tori are $k$-rational except for the 15 cases in the list of Kun87, Theorem 1]. In particular, $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if $G$ acts on $K$ faithfully and
on $K\left(x_{1}, x_{2}, x_{3}\right)$ by purely quasi-monomial $k$-automorphisms except for the 15 cases. For the exceptional 15 cases, they are not $k$-rational; in fact, they are even not retract $k$-rational.

The rationality problem for algebraic $k$-tori depends on the conjugacy class of $G \leq G L_{n}(\mathbb{Z})$. There exist 13 (resp. 73, 710, 6079) conjugacy classes of finite subgroups in $G L_{2}(\mathbb{Z})$ (resp. $\left.G L_{3}(\mathbb{Z}), G L_{4}(\mathbb{Z}), G L_{5}(\mathbb{Z})\right)$. A stably rational classification of the algebraic $k$-tori of dimension four and five was given by HY17.

Theorem 1.4 (Hoshi, Yamasaki HY17, Theorem 1.9]). Let $K / k$ be a Galois extension and $G \simeq \operatorname{Gal}(K / k)$ be a finite subgroup of $G L_{4}(\mathbb{Z})$ which acts on $K\left(x_{1}, x_{2}, x_{3}, x_{4}\right)$ by purely quasimonomial $k$-automorphisms.
(i) $K\left(x_{1}, x_{2}, x_{3}, x_{4}\right)^{G}$ is stably $k$-rational if and only if $G$ is conjugate to one of the 487 groups which are not in [HY17, Tables 2, 3 and 4].
(ii) $K\left(x_{1}, x_{2}, x_{3}, x_{4}\right)^{G}$ is not stably but retract $k$-rational if and only if $G$ is conjugate to one of the 7 groups which are given as in [HY17, Table 2].
(iii) $K\left(x_{1}, x_{2}, x_{3}, x_{4}\right)^{G}$ is not retract $k$-rational if and only if $G$ is conjugate to one of the 216 groups which are given as in [HY17, Tables 3 and 4].

Theorem 1.5 (Hoshi, Yamasaki [HY17, Theorem 1.12]). Let $K / k$ be a Galois extension and $G \simeq \operatorname{Gal}(K / k)$ be a finite subgroup of $G L_{5}(\mathbb{Z})$ which acts on $K\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right)$ by purely quasi-monomial $k$-automorphisms.
(i) $K\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right)^{G}$ is stably $k$-rational if and only if $G$ is conjugate to one of the 3051 groups which are not in [HY17, Tables 11, 12, 13, 14 and 15].
(ii) $K\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right)^{G}$ is not stably but retract $k$-rational if and only if $G$ is conjugate to one of the 25 groups which are given as in [HY17, Table 11].
(iii) $K\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right)^{G}$ is not retract $k$-rational if and only if $G$ is conjugate to one of the 3003 groups which are given as in [HY17, Tables 12, 13, 14 and 15].

However, we do not know the $k$-rationality in Theorem 1.4 (i) and Theorem 1.5 (i).

## Monomial action case.

When $G$ acts on $K$ trivially, i.e. $K=k$, the rationality of $k\left(x_{1}, x_{2}\right)^{G}$ and $k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ under the monomial actions of $G$ is known as follows:

Theorem 1.6 (Hajja Haj87). Let $k$ be a field and $G$ be a finite group acting on $k\left(x_{1}, x_{2}\right)$ by monomial $k$-automorphisms. Then $k\left(x_{1}, x_{2}\right)^{G}$ is $k$-rational.

Theorem 1.7 (Hajja, Kang [HK92, HK94, Hoshi, Rikuna HR08]). Let $k$ be a field and $G$ be a finite group acting on $k\left(x_{1}, x_{2}, x_{3}\right)$ by purely monomial $k$-automorphisms. Then $k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational.

Let $G$ be a finite group acting on $K\left(x_{1}, \ldots, x_{n}\right)$ by quasi-monomial $k$-automorphisms. There exists a group homomorphism $\rho_{\underline{x}}: G \rightarrow G L_{n}(\mathbb{Z})$ defined by $\rho_{\underline{x}}(\sigma)=\left[a_{i, j}\right]_{1 \leq i, j \leq n} \in G L_{n}(\mathbb{Z})$ for any $\sigma \in G$ where $\left[a_{i, j}\right]_{1 \leq i, j \leq n}$ is given in (iii) of Definition 1.1.

Theorem 1.8 (Hoshi, Kang, Kitayama [HKK14, Proposition 1.12]). Let $k$ be a field and $G$ be a finite group acting on $K\left(x_{1}, \ldots, x_{n}\right)$ by quasi-monomial $k$-automorphisms. Then there is a normal subgroup $N$ of $G$ satisfying the following conditions:
(i) $K\left(x_{1}, \ldots, x_{n}\right)^{N}=K^{N}\left(y_{1}, \ldots, y_{n}\right)$ where each $y_{i}$ is of the form $a x_{1}^{e_{1}} x_{2}^{e_{2}} \cdots x_{n}^{e_{n}}$ with $a \in K^{\times}$ and $e_{i} \in \mathbb{Z}$ (we may take $a=1$ if the action is a purely quasi-monomial action);
(ii) $G / N$ acts on $K^{N}\left(y_{1}, \ldots, y_{n}\right)$ by quasi-monomial $k$-automorphisms;
(iii) $\rho_{\underline{y}}: G / N \rightarrow G L_{n}(\mathbb{Z})$ is an injective group homomorphism.

By Theorem [1.8, we may assume that $\rho_{\underline{x}}: G \rightarrow G L_{n}(\mathbb{Z})$ is injective and thus $G$ may be regarded as a finite subgroup of $G L_{n}(\mathbb{Z})$. The following theorem was already proved by Prokhorov Pro10 when $k=\mathbb{C}$.

Theorem 1.9 (Hoshi, Kitayama, Yamasaki HKY11, Yam12]). Let $k$ be a field with char $k \neq 2$ and $G$ be a finite subgroup of $G L_{3}(\mathbb{Z})$ acting on $K\left(x_{1}, x_{2}, x_{3}\right)$ by monomial $k$-automorphisms. Then $k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational except for the 8 cases contained in Yam12 and one additional case. For the last exceptional case, $k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is also $k$-rational except for a minor situation. Moreover, there exists $L=k(\sqrt{a})$ with $a \in k^{\times}$such that $L\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is L-rational. In particular, if $k$ is a quadratically closed field, then $k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational.

Indeed, for the exceptional 8 cases in Theorem [1.9, the necessary and sufficient condition for the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ was given in terms of $k$ and $c_{j}(\sigma)$. In particular, if it is not $k$-rational, then it is not retract $k$-rational (see [Yam12]). We also note that there exists $\mathbb{C}\left(x_{1}, x_{2}, x_{3}, x_{4}\right)^{G}$ under the monomial action of $G$ which is not retract $\mathbb{C}$-rational (see CHKK10, Example 5.11]).

## Quasi-monomial action case.

When we consider general quasi-monomial actions, it turns out that non-unirational fields $K(x)^{G}$ appear even in the one-dimensional case. Let $(a, b)_{k}$ (resp. $[a, b)_{k}$ ) be the norm residue symbol of degree two over $k$ when char $k \neq 2$ (resp. char $k=2$ ), see [Dra83, Chapter 11]. For dimension one (resp. two), the rationality problem for quasi-monomial (resp. purely quasimonomial) actions was solved by Hoshi, Kang and Kitayama HKK14.

Theorem 1.10 (Hoshi, Kang, Kitayama HKK14, Proposition 1.13]). Let $k$ be a field.
(1) Let $G$ be a finite group acting on $K(x)$ by purely quasi-monomial $k$-automorphisms. Then $K(x)^{G}$ is $k$-rational.
(2) Let $G$ be a finite group acting on $K(x)$ by quasi-monomial $k$-automorphisms. Then $K(x)^{G}$ is $k$-rational except for the following case: There is a normal subgroup $N$ of $G$ such that (i) $G / N=\langle\sigma\rangle \simeq \mathcal{C}_{2}$, (ii) $K(x)^{N}=k(\alpha)(y)$ with $\alpha^{2}=a \in K^{\times}, \sigma(\alpha)=-\alpha($ if char $k \neq 2)$, and $\alpha^{2}+\alpha=a \in K, \sigma(\alpha)=\alpha+1$ (if chark $=2$ ), (iii) $\sigma \cdot y=b / y$ for some $b \in k^{\times}$.

For the exceptional case, $K(x)^{G}=k(\alpha)(y)^{G / N}$ is $k$-rational if and only if the norm residue 2 -symbol $(a, b)_{k}=0$ (if char $k \neq 2$ ), and $[a, b)_{k}=0$ (if char $k=2$ ).

Moreover, if $K(x)^{G}$ is not $k$-rational, then $k$ is an infinite field, the $\operatorname{Brauer}$ group $\operatorname{Br}(k)$ is non-trivial, and $K(x)^{G}$ is not $k$-unirational.

Let $\mathcal{S}_{n}$ (resp. $\mathcal{A}_{n}, \mathcal{D}_{n}, \mathcal{C}_{n}$ ) be the symmetric group (resp. the alternating group, the dihedral group, the cyclic group) of degree $n$ of order $n!$ (resp. $n!/ 2,2 n, n$ ).

Theorem 1.11 (Hoshi, Kang, Kitayama [HKK14, Theorem 1.14]). Let $k$ be a field and $G$ be a finite group acting on $K(x, y)$ by purely quasi-monomial $k$-automorphisms. Define $N=\{\sigma \in$ $G: \sigma(x)=x, \sigma(y)=y\}, H=\{\sigma \in G: \sigma(\alpha)=\alpha$ for all $\alpha \in K\}$. Then $K(x, y)^{G}$ is $k$-rational except possibly for the following situation: (1) char $k \neq 2$ and $(2)(G / N, H N / N) \simeq\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right)$ or $\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right)$.

More precisely, in the exceptional situation we may choose $u, v \in k(x, y)$ satisfying that $k(x, y)^{H N / N}=k(u, v)$ (and therefore $K(x, y)^{H N / N}=K(u, v)$ ) such that
(i) when $(G / N, H N / N) \simeq\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right), K^{N}=k(\sqrt{a})$ for some $a \in k \backslash k^{2}, G / N=\langle\sigma\rangle \simeq \mathcal{C}_{4}$, then $\sigma$ acts on $K^{N}(u, v)$ by $\sigma: \sqrt{a} \mapsto-\sqrt{a}, u \mapsto \frac{1}{u}, v \mapsto-\frac{1}{v}$; or
(ii) when $(G / N, H N / N) \simeq\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right), K^{N}=k(\sqrt{a}, \sqrt{b})$ is a biquadratic extension of $k$ with $a, b \in k \backslash k^{2}, G / N=\langle\sigma, \tau\rangle \simeq \mathcal{D}_{4}$, then $\sigma$ and $\tau$ act on $K^{N}(u, v)$ by $\sigma: \sqrt{a} \mapsto-\sqrt{a}, \sqrt{b} \mapsto \sqrt{b}$, $u \mapsto \frac{1}{u}, v \mapsto-\frac{1}{v}, \tau: \sqrt{a} \mapsto \sqrt{a}, \sqrt{b} \mapsto-\sqrt{b}, u \mapsto u, v \mapsto-v$.

For Case (i), $K(x, y)^{G}$ is $k$-rational if and only if the norm residue 2 -symbol $(a,-1)_{k}=0$. For Case (ii), $K(x, y)^{G}$ is $k$-rational if and only if $(a,-b)_{k}=0$.

Moreover, if $K(x, y)^{G}$ is not $k$-rational, then $k$ is an infinite field, the $\operatorname{Brauer} \operatorname{group} \operatorname{Br}(k)$ is non-trivial, and $K(x, y)^{G}$ is not $k$-unirational.

The following definition gives an equivalent definition of quasi-monomial actions. This definition follows the approach of Saltman's definition of twisted multiplicative actions Sal90a, Sal90b, Kan09, Definition 2.2].

Definition 1.12 ([HKK14, Definition 1.15]). Let $G$ be a finite group. A $G$-lattice $M$ is a finitely generated $\mathbb{Z}[G]$-module which is $\mathbb{Z}$-free as an abelian group, i.e. $M=\bigoplus_{1 \leq i \leq n} \mathbb{Z} \cdot x_{i}$ with a $\mathbb{Z}[G]$-module structure. Let $K / k$ be a field extension such that $G$ acts on $K$ with $K^{G}=k$. Consider a short exact sequence of $\mathbb{Z}[G]$-modules $\alpha: 1 \rightarrow K^{\times} \rightarrow M_{\alpha} \rightarrow M \rightarrow 0$ where $M$ is a $G$-lattice and $K^{\times}$is regarded as a $\mathbb{Z}[G]$-module through the $G$-action on $K$. The $\mathbb{Z}[G]$-module structure (written multiplicatively) of $M_{\alpha}$ may be described as follows: For each $x_{j} \in M$ (where $1 \leq j \leq n$ ), take a pre-image $u_{j}$ of $x_{j}$. As an abelian group, $M_{\alpha}$ is the direct product of $K^{\times}$and $\left\langle u_{1}, \ldots, u_{n}\right\rangle$. If $\sigma \in G$ and $\sigma \cdot x_{j}=\sum_{1 \leq i \leq n} a_{i j} x_{i} \in M$, we find that $\sigma \cdot u_{j}=c_{j}(\sigma) \cdot \prod_{1 \leq i \leq n} u_{i}^{a_{i j}} \in M_{\alpha}$ for a unique $c_{j}(\sigma) \in K^{\times}$determined by the group extension $\alpha$.

Using the same idea, once a group extension $\alpha: 1 \rightarrow K^{\times} \rightarrow M_{\alpha} \rightarrow M \rightarrow 0$ is given, we may define a quasi-monomial action of $G$ on the rational function field $K\left(x_{1}, \ldots, x_{n}\right)$ as follows: If $\sigma \cdot x_{j}=\sum_{1 \leq i \leq n} a_{i j} x_{i} \in M$, then define $\sigma \cdot x_{j}=c_{j}(\sigma) \prod_{1 \leq i \leq n} x_{i}^{a_{i j}} \in K\left(x_{1}, \ldots, x_{n}\right)$ and $\sigma \cdot \alpha=\sigma(\alpha)$ for $\alpha \in \bar{K}$ where $\sigma(\alpha)$ is the image of $\alpha$ under $\sigma$ via the prescribed action of $G$ on $K$. This quasi-monomial action is well-defined (see [Sal90a, page 538] for details). The field $K\left(x_{1}, \ldots, x_{n}\right)$ with such a $G$-action will be denoted by $K_{\alpha}(M)$ to emphasize the role of the extension $\alpha$; its fixed field is denoted as $K_{\alpha}(M)^{G}$. We will say that $G$ acts on $K_{\alpha}(M)$ by quasi-monomial $k$-automorphisms.

If $k=K$, then $k_{\alpha}(M)^{G}$ is nothing but the fixed field associated to the monomial action.
If the extension $\alpha$ splits, then we may take $u_{1}, \ldots, u_{n} \in M_{\alpha}$ satisfying that $\sigma \cdot u_{j}=\prod_{1 \leq i \leq n} u_{i}^{a_{i j}}$. Hence the associated quasi-monomial action of $G$ on $K\left(x_{1}, \ldots, x_{n}\right)$ becomes a purely quasimonomial action. In this case, we will write $K_{\alpha}(M)$ and $K_{\alpha}(M)^{G}$ as $K(M)$ and $K(M)^{G}$ respectively (the subscript $\alpha$ is omitted because the extension $\alpha$ plays no important role). We will say that $G$ acts on $K(M)$ by purely quasi-monomial $k$-automorphisms. Again $k(M)^{G}$ is the fixed field associated to the purely monomial action.

As an application of Theorem 1.11, we have the following theorems:
Theorem 1.13 (Hoshi, Kang, Kitayama HKK14, Theorem 1.16]). Let $k$ be a field, $G$ be a finite group and $M$ be a $G$-lattice with $\operatorname{rank}_{\mathbb{Z}} M=4$ such that $G$ acts on $k(M)$ by purely monomial $k$-automorphisms. If $M$ is decomposable, i.e. $M=M_{1} \oplus M_{2}$ as $\mathbb{Z}[G]$-modules where $1 \leq \operatorname{rank}_{\mathbb{Z}} M_{1} \leq 3$, then $k(M)^{G}$ is $k$-rational.

Theorem 1.14 (Hoshi, Kang, Kitayama HKK14, Theorem 6.2]). Let $k$ be a field, $G$ be a finite group and $M$ be a $G$-lattice such that $G$ acts on $k(M)$ by purely monomial $k$-automorphisms. Assume that (i) $M=M_{1} \oplus M_{2}$ as $\mathbb{Z}[G]$-modules where $\operatorname{rank}_{\mathbb{Z}} M_{1}=3$ and $\operatorname{rank}_{\mathbb{Z}} M_{2}=2$, (ii) either $M_{1}$ or $M_{2}$ is a faithful $G$-lattice. Then $k(M)^{G}$ is $k$-rational except the following situation: char $k \neq 2, G=\langle\sigma, \tau\rangle \simeq \mathcal{D}_{4}$ and $M_{1}=\bigoplus_{1 \leq i \leq 3} \mathbb{Z} x_{i}, M_{2}=\bigoplus_{1 \leq j \leq 2} \mathbb{Z} y_{j}$ such that $\sigma: x_{1} \leftrightarrow x_{2}$, $x_{3} \mapsto-x_{1}-x_{2}-x_{3}, y_{1} \mapsto y_{2} \mapsto-y_{1}, \tau: x_{1} \leftrightarrow x_{3}, x_{2} \mapsto-x_{1}-x_{2}-x_{3}, y_{1} \leftrightarrow y_{2}$ where the $\mathbb{Z}[G]$-module structure of $M$ is written additively. For the exceptional case, $k(M)^{G}$ is not retract $k$-rational.

The aim of this paper is to investigate the rationality problem of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ for purely quasi-monomial $k$-automorphisms of dimension three. The followings are main results of this paper.

Note that (i) by Theorem 1.8, we may assume $N=\left\{\sigma \in G: \sigma\left(x_{i}\right)=x_{i}(i=1,2,3)\right\}=1$ and hence $G$ may be regarded as a finite subgroup of $G L_{3}(\mathbb{Z})$; (ii) when $H=1$ the answer to the rationality problem in dimension 3 was given by Kunyavskii (see Theorem 1.3).

There exist 73 finite subgroups $G_{i, j, k}(1 \leq i \leq 7)$ contained in $G L_{3}(\mathbb{Z})$ up to conjugation which are classified into 7 crystal systems (see Section 2 for details).

Theorem 1.15 (The groups $G$ do not belong to the 7 th crystal system in dimension 3). Let $k$ be a field with char $k \neq 2$ and $G$ be a finite subgroup of $G L_{3}(\mathbb{Z})$ acting on $K\left(x_{1}, x_{2}, x_{3}\right)$ by purely quasi-monomial $k$-automorphisms. Assume that $G$ does not belong to the 7 th crystal system in dimension 3 and $H=\{\sigma \in G \mid \sigma(\alpha)=\alpha$ for any $\alpha \in K\} \neq 1$.
(1) If $G$ does not belong to the 4 th crystal system in dimension 3, i.e. $G$ is either not a 2-group or a 2-group of exponent 2, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational;
(2) When $G$ belongs to the 4 th crystal system in dimension 3, i.e. $G$ is a 2-group of exponent 4, $G$ is $\mathbb{Q}$-conjugate to one of the following 8 groups: $\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle \simeq \mathcal{C}_{4},\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle \simeq \mathcal{C}_{4} \times \mathcal{C}_{2}$, $\left\langle \pm \sigma_{4 \mathrm{~A}}, \pm \lambda_{1}\right\rangle \simeq \mathcal{D}_{4},\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle \simeq \mathcal{D}_{4} \times \mathcal{C}_{2}$ where

and $I_{3}$ is the $3 \times 3$ identity matrix. Then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational except possibly for the following cases with $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}}^{2},-I_{3}\right\rangle$ :
(i) The case where $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}\right\rangle \simeq \mathcal{C}_{2}$.
(i-1) When $G$ is $\mathbb{Q}$-conjugate to $\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle$, (resp. $\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle$ ) we may take $K=k(\sqrt{a})$ (resp. $\left.K^{\left\langle-I_{3}\right\rangle}=k(\sqrt{a})\right)$ on which $G$ acts by $\pm \sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto-\sqrt{a}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $(a,-1)_{k}=0$.
(i-2) When $G$ is $\mathbb{Q}$-conjugate to $\left\langle \pm \sigma_{4 \mathrm{~A}}, \pm \lambda_{1}\right\rangle$ (resp. $\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle$ ) we may take $K=$ $k(\sqrt{a}, \sqrt{b})\left(\right.$ resp. $K^{\left\langle-I_{3}\right\rangle}=k(\sqrt{a}, \sqrt{b})$ ) on which $G$ acts by $\pm \sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto-\sqrt{a}, \sqrt{b} \mapsto \sqrt{b}$, $\pm \lambda_{1}: \sqrt{a} \mapsto \sqrt{a}, \sqrt{b} \mapsto-\sqrt{b}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $(a,-b)_{k}=0$.
(ii) The case where $H=\left\langle\sigma_{4 \mathrm{~A}}^{2},-I_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$.
(ii-1) When $G$ is $\mathbb{Q}$-conjugate to $\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle$, we may take $K=k(\sqrt{a})$ on which $G$ acts by $\sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto-\sqrt{a}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $(a,-1)_{k}=0$.
(ii-2) When $G$ is $\mathbb{Q}$-conjugate to $\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle$, we may take $K=k(\sqrt{a}, \sqrt{b})$ on which $G$ acts by $\sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto-\sqrt{a}, \sqrt{b} \mapsto \sqrt{b}, \lambda_{1}: \sqrt{a} \mapsto \sqrt{a}, \sqrt{b} \mapsto-\sqrt{b}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $(a,-b)_{k}=0$.

Moreover, if $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is not $k$-rational, then $k$ is an infinite field, the Brauer group $\operatorname{Br}(k)$ is non-trivial, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is not $k$-unirational.

In particular, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ does not depend on the $\mathbb{Q}$-conjugacy class of $G$ and the sign of $\pm \sigma_{4 \mathrm{~A}}$ and $\pm \lambda_{1}$.

There exist 15 finite subgroups $G_{7, j, k}(1 \leq j \leq 5,1 \leq k \leq 3)$ of $G L_{3}(\mathbb{Z})$ which belong to the 7th crystal system (see Section (2).

Theorem 1.16 (The groups $G$ belong to the 7 th crystal system in dimension 3). Let $k$ be $a$ field with char $k \neq 2$ and $G$ be a finite subgroup of $G L_{3}(\mathbb{Z})$ acting on $K\left(x_{1}, x_{2}, x_{3}\right)$ by purely quasi-monomial $k$-automorphisms. Assume that $G=G_{7, j, k}$ belongs to the 7 th crystal system in dimension 3 and $H=\{\sigma \in G \mid \sigma(\alpha)=\alpha$ for any $\alpha \in K\} \neq 1$.
(1) If $G=G_{7, j, 1}(1 \leq j \leq 5)$, $G_{7, j, 2}(1 \leq j \leq 5)$ or $G_{7, j, 3}(j=1,4)$, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is
$k$-rational;
(2) When $G=G_{7, j, 3}(j=2,3,5), G_{7,2,3}=\left\langle\tau_{3}, \lambda_{3}, \sigma_{3 \mathrm{~B}},-I_{3}\right\rangle \simeq \mathcal{A}_{4} \times \mathcal{C}_{2}, G_{7,3,3}=\left\langle\tau_{3}, \lambda_{3}, \sigma_{3 \mathrm{~B}},-\beta_{3}\right\rangle$ $\simeq \mathcal{S}_{4}, G_{7,5,3}=\left\langle\tau_{3}, \lambda_{3}, \sigma_{3 \mathrm{~B}}, \beta_{3},-I_{3}\right\rangle \simeq \mathcal{S}_{4} \times \mathcal{C}_{2}$ where

and $I_{3}$ is the $3 \times 3$ identity matrix. Then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational except possibly for the following cases with $H=\left\langle\tau_{3}, \lambda_{3}\right\rangle$ or $\left\langle\tau_{3}, \lambda_{3}, \sigma_{3 \mathrm{~B}}\right\rangle$ :
(i) The case where $H=\left\langle\tau_{3}, \lambda_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$. We have

We do not know the rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ in Theorem 1.16 (2) (i) with $H \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$. For the case (2) (ii) of Theorem 1.16 with $H \simeq \mathcal{A}_{4}$, we will give the following partial result. It turns out that the fixed field $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ has a conic bundle structure.

Proposition 1.17. Let $k$ be a field with char $k \neq 2$ and $G=G_{7, j, 3}(j=2,3,5)$. Assume that $H=\{\sigma \in G \mid \sigma(\alpha)=\alpha$ for any $\alpha \in K\}=\left\langle\tau_{3}, \lambda_{3}, \sigma_{3 \mathrm{~B}}\right\rangle \simeq \mathcal{A}_{4}$.
(1) $G=G_{7,2,3}=\left\langle H,-I_{3}\right\rangle$. There exist $w_{1}, w_{2}, w_{3} \in K\left(x_{1}, x_{2}, x_{3}\right)^{H}$ such that $K\left(x_{1}, x_{2}, x_{3}\right)^{H}=$ $K\left(w_{1}, w_{2}, w_{3}\right)$ and

(i) $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational;
(ii) $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-unirational;
(iii) $X^{2}-d Y^{2}-2 v_{0}^{2}-2 v_{1}^{2}+2 d v_{2}^{2}$ has a non-trivial $k$-zero with $K=k(\sqrt{d})$.

In particular, if $\sqrt{5}, \sqrt{2} \in k$ or $\sqrt{5}, \sqrt{-1} \in k$, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational.
(3) $G=G_{7,5,3}=\left\langle H, \beta_{3},-I_{3}\right\rangle$. There exist $p_{1}, p_{2}, p_{3} \in K\left(x_{1}, x_{2}, x_{3}\right)^{H}$ such that $K\left(x_{1}, x_{2}, x_{3}\right)^{H}$ $=K\left(p_{1}, p_{2}, p_{3}\right)$ and

In particular, if $\sqrt{-3}, \sqrt{-1} \in k$, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational.
(5) If char $k=3$, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational for $G=G_{7, j, 3}(j=2,3,5)$.

As an application of Theorems 1.15 and 1.16 and Proposition 1.17, we get the following theorem which complements to Theorem 1.14 .

Theorem 1.18. Let $k$ be a field with char $k \neq 2, G$ be a finite group and $M$ be a $G$-lattice such that $G$ acts on $k(M)$ by purely monomial $k$-automorphisms. Assume that (i) $M=M_{1} \oplus M_{2}$ as $\mathbb{Z}[G]$-modules where $\operatorname{rank}_{\mathbb{Z}} M_{1}=3$ and $\operatorname{rank}_{\mathbb{Z}} M_{2}=2$, (ii) both $M_{1}$ and $M_{2}$ are not faithful $G$-lattices. Let $N_{i}=\left\{\sigma \in G \mid \sigma(\alpha)=\alpha\right.$ for any $\left.\alpha \in k\left(M_{i}\right)\right\}(i=1,2)$. Then $k(M)^{G}$ is $k$ rational except the following situation: $\left(G / N_{1}, N_{1} N_{2} / N_{1}, G / N_{2}, N_{1} N_{2} / N_{2}\right) \simeq\left(G_{7,2,3}, \mathcal{A}_{4}, \mathcal{C}_{4}, \mathcal{C}_{2}\right)$, $\left(G_{7,3,3}, \mathcal{A}_{4}, \mathcal{C}_{4}, \mathcal{C}_{2}\right)$ and $\left(G_{7,5,3}, \mathcal{A}_{4}, \mathcal{D}_{4}, \mathcal{C}_{2}\right)$. Moreover, if char $k=3$, then $k(M)^{G}$ is $k$-rational.

This paper is organized as follows. In Section 2, we recall the classification of subgroups of $G L_{3}(\mathbb{Z})$ up to conjugation. Section 3 contains some rationality results which will be used in the paper. A technique of conjugacy classes move, which is described in Subsection 3.4, is useful and will be used in the proof of Theorems 1.15 and 1.16 to the cases of 3 rd crystal system (II), the 4th crystal system (II) and 7th crystal system (II) in Subsections $4.1,4.2$ and 5.1 respectively. Section 4 contains the proof of Theorem 1.15. The proof of Theorem 1.16 is given in Section 5. In Section 6, the proof of Proposition 1.17 will be given. We will prove Theorem 1.18 in Section 7.

Let $\mathcal{S}_{n}$ (resp. $\mathcal{A}_{n}, \mathcal{D}_{n}, \mathcal{C}_{n}$ ) be the symmetric group (resp. the alternating group, the dihedral group, the cyclic group) of degree $n$ of order $n!$ (resp. $n!/ 2,2 n, n$ ). Let $I_{3}$ be the $3 \times 3$ identity matrix. We define the following matrices:

The 15 groups * $G_{i, j, k}$ with marked $*$ above are in the Kunyavskii's list of Kun87, Theorem 1], i.e. the only 15 groups in $G L_{3}(\mathbb{Z})$ up to conjugation for which $K\left(x_{1}, x_{2}, x_{3}\right)^{G_{i, j, k}}$ are not retract $k$-rational under the faithful action of $G_{i, j, k}$ on $K$ (see Theorem 1.3).

## 3. Preliminaries

### 3.1. Reduction to lower degree.

Theorem 3.1 (Miyata Miy71, Lemma, page 70], Ahmad, Hajja, Kang AHK00, Theorem 3.1]). Let $L$ be a field, $L(x)$ be the rational function field with one variable $x$ over $L$ and $G$ be a finite group acting on $L(x)$. Suppose that, for any $\sigma \in G, \sigma(L) \subset L$ and $\sigma(x)=a_{\sigma} x+b_{\sigma}$ where $a_{\sigma}, b_{\sigma} \in L$ and $a_{\sigma} \neq 0$. Then $L(x)^{G}=L^{G}(f)$ for some polynomial $f \in L[x]^{G}$.

Corollary 3.2. Let $k$ be a field with char $k \neq 2$ and $G$ be a finite subgroup of $G L_{n}(\mathbb{Z})$ acting on $K\left(x_{1}, \ldots, x_{n}\right)$ by purely quasi-monomial $k$-automorphisms. If $G$ is $\mathbb{Z}$-reducible of $(n-1,1)$-type and $K\left(x_{1}, \ldots, x_{n-1}\right)^{G}$ is $k$-rational, then $K\left(x_{1}, \ldots, x_{n}\right)^{G}$ is $k$-rational.

Proof. Put $x_{n}^{\prime}=\left(x_{n}-1\right) /\left(x_{n}+1\right)$ and apply Theorem 3.1.
The following lemmas are a restatement of Hilbert 90 (see also Miy71, Lemma, page 70]).
Theorem 3.3 (Endo, Miyata [EM73, Proposition 1.1]). Let $L / k$ be a finite Galois extension of fields with Galois group $G$ which acts on $L\left(x_{1}, \ldots, x_{n}\right)$ by $k$-automorphisms. Suppose that for any $\sigma \in G$,

Then $L\left(x_{1}, \ldots, x_{n}\right)^{G}$ is $k$-rational.
Theorem 3.4 (Hajja, Kang HK95, Theorem 1]). Let $L$ be a field and $G$ be a finite group acting on $L\left(x_{1}, \ldots, x_{n}\right)$. Suppose that
(i) $\sigma(L) \subset L$ for any $\sigma \in G$;
(ii) the restriction of the actions of $G$ to $L$ is faithful;
(iii) for any $\sigma \in G$,

where $A(\sigma) \in G L_{n}(L)$ and $B(\sigma)$ is an $n \times 1$ matrix over $L$. Then there exist $z_{1}, \ldots, z_{n} \in$ $L\left(x_{1}, \ldots, x_{n}\right)$ such that $L\left(x_{1}, \ldots, x_{n}\right)=L\left(z_{1}, \ldots, z_{n}\right)$ with $\sigma\left(z_{i}\right)=z_{i}$ for any $\sigma \in G$ and $1 \leq i \leq n$.

### 3.2. Explicit transcendental bases.

Lemma 3.5 (Hashimoto, Hoshi, Rikuna HHR08, page 1176], Hoshi, Kang, Kitayama HKK14, Lemma 3.3], see also [HKY11, Lemma 3.4]). Let $k$ be a field and $\tau$ act on $k\left(x_{1}, x_{2}\right)$ by $k$ automorphisms

Define $w=c /\left(x_{1} x_{2} x_{3}\right)$. Then $k\left(x_{1}, x_{2}, x_{3}\right)^{G_{3,1,4}}=k\left(x_{1}, x_{2}, x_{3}\right)^{\left\langle\tau_{3}, \lambda_{3}\right\rangle}=k\left(v_{1}, v_{2}, v_{3}\right)$ where

### 3.3. Rationality of quadrics and conic bundles.

Theorem 3.11 (Ohm [Ohm94, Lemma 5.7], see also Hajja, Kang, Ohm HKO94, Proposition 2.1]). Let $k$ be a field with char $k \neq 2$ and $K$ be a function field of a quadric $q=a_{0}+a_{1} x_{1}^{2}+$ $\cdots+a_{n} x_{n}^{2}$ over $k$, i.e. $K$ is $k$-isomorphic to $k\left[x_{1}, \ldots, x_{n}\right] /(q)$. Then the following conditions are equivalent:
(i) $a_{0} x_{0}^{2}+a_{1} x_{1}^{2}+\cdots+a_{n} x_{n}^{2}$ has a non-trivial $k$-zero;
(ii) $a_{0}+a_{1} x_{1}^{2}+\cdots+a_{n} x_{n}^{2}$ has a $k$-zero;
(iii) $K$ is $k$-rational;
(iv) $K$ is $k$-unirational.

Lemma 3.12. Let $k$ be a field with char $k \neq 2, K=k(\sqrt{d})$ be a quadratic extension of $k$ and $\sigma$ act on $K\left(x_{1}, \ldots, x_{n}\right)$ by $k$-automorphisms

$$
\sigma: \sqrt{d} \mapsto-\sqrt{d}, x_{i} \mapsto x_{i}(1 \leq i \leq n-1), x_{n} \mapsto \frac{f\left(x_{1}, \ldots, x_{n-1}\right)}{x_{n}}
$$

where $f\left(x_{1}, \ldots, x_{n-1}\right)$ is a polynomial in $k\left[x_{1}, \ldots, x_{n-1}\right]$. Then we have $K\left(x_{1}, \ldots, x_{n}\right)^{\langle\sigma\rangle}=$ $k\left(X, Y, x_{1}, \ldots, x_{n-1}\right)$ where $X^{2}-d Y^{2}=f\left(x_{1}, \ldots, x_{n-1}\right)$.
Proof. Define

X=\frac{1}{2}\left(x_{n}+\frac{f\left(x_{1}, \ldots, x_{n-1}\right)}{x_{n}}\right), Y=\frac{1}{2 \sqrt{d}}\left(x_{n}-\frac{f\left(x_{1}, \ldots, x_{n-1}\right)}{x_{n}}\right)
$$

Then the assertion follows from $K\left(x_{1}, \ldots, x_{n}\right)^{\langle\sigma\rangle} \supset k\left(X, Y, x_{1}, \ldots, x_{n-1}\right)$ and $\left[K\left(x_{1}, \ldots, x_{n}\right)\right.$ : $\left.k\left(X, Y, x_{1}, \ldots, x_{n-1}\right)\right] \leq 2$.

For the rationality of quadrics and conic bundles, see [Kan07, Section 4], Yam.

### 3.4. Conjugacy classes move.

For the rationality problem of $K\left(x_{1}, \ldots, x_{n}\right)^{G}$ under purely quasi-monomial actions, we may convert some cases into their $G L_{n}(\mathbb{Q})$-conjugation (see also [HKY11, Section 13.2]) although the problem is determined up to $G L_{n}(\mathbb{Z})$-conjugation (a conjugate of $G$ corresponds to just some base change). When the action of $G$ on $K$ is faithful, i.e. algebraic $k$-tori case, $G L_{n}(\mathbb{Q})$ conjugation corresponds to $k$-isogeny (see Ono [Ono61, Section 1.3]).

Theorem 3.13 (Kitayama Kit11, Theorem 2.4]). Let $k$ be a field with char $k \neq 2$. Let $G$ and $G^{\prime}$ be $G L_{n}(\mathbb{Q})$-conjugate subgroups of $G L_{n}(\mathbb{Z})$ which act on $K\left(x_{1}, \ldots, x_{n}\right)$ by purely quasimonomial $k$-automorphisms, $P=\left[p_{i, j}\right] \in G L_{n}(\mathbb{Q})$ be an integer matrix with $G^{\prime}=P^{-1} G P$ and $H^{\prime}=\left\{\sigma \in G^{\prime} \mid \sigma(\alpha)=\alpha\right.$ for any $\left.\alpha \in K\right\}$. For $y_{j}=\prod_{i=1}^{n} x_{i}^{p_{i, j}}(j=1, \ldots, n)$, the induced purely quasi-monomial action of $G$ on $K\left(y_{1}, \ldots, y_{n}\right)$ is the same action of $G^{\prime}$ on $K\left(x_{1}, \ldots, x_{n}\right)$ and $H=\{\sigma \in G \mid \sigma(\alpha)=\alpha$ for any $\alpha \in K\}$ where $H=P H^{\prime} P^{-1}$.

We will apply Theorem 3.13 as follows.
Lemma 3.14. Let $P_{1}, P_{2} \in G L_{3}(\mathbb{Z})$ be two matrices defined by

Let $\rho_{1}, \rho_{2}$ and $\rho_{3}$ be $K$-automorphisms on $K\left(x_{1}, x_{2}, x_{3}\right)$ defined by

& \rho_{3}: x_{1} \mapsto x_{1}, x_{2} \mapsto-x_{2}, x_{3} \mapsto-x_{3}
\end{aligned}
$$

Then we have:
(i) $K\left(x_{1}, x_{2}, x_{3}\right)^{P_{1}^{-1} G P_{1}}$ is $k$-rational if and only if $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ is $k$-rational;
(ii) $K\left(x_{1}, x_{2}, x_{3}\right)^{P_{2}^{-1} G P_{2}}$ is $k$-rational if and only if $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$ is $k$-rational.

Proof. By Theorem 3.13, we have

K\left(x_{1}, x_{2}, x_{3}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}=K\left(z_{1}, z_{2}, z_{3}\right), & z_{1}=x_{1} x_{2} x_{3}, z_{2}=x_{2}^{2}, z_{3}=x_{3}^{2}
\end{array}
$$

and the action of $G$ on $K\left(y_{1}, y_{2}, y_{3}\right)$ (resp. $\left.K\left(z_{1}, z_{2}, z_{3}\right)\right)$ is the same as the action of $P_{1}^{-1} G P_{1}$ (resp. $\left.P_{2}^{-1} G P_{2}\right)$ on $K\left(x_{1}, x_{2}, x_{3}\right)$.

Indeed, we will take a finite subgroup $G$ of $G L_{3}(\mathbb{Z})$ such that $G$ is $\mathbb{Z}$-reducible and $P_{1}^{-1} G P_{1}$ (resp. $\left.P_{2}^{-1} G P_{2}\right) \leq G L_{3}(\mathbb{Z})$ is $\mathbb{Z}$-irreducible. Namely, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{P_{1}^{-1} G P_{1}}$ (resp. $K\left(x_{1}, x_{2}, x_{3}\right)^{P_{2}^{-1} G P_{2}}$ ) for $\mathbb{Z}$-irreducible $P_{1}^{-1} G P_{1}$ (resp. $P_{2}^{-1} G P_{2}$ ) can be reduced to the $k$-rationality of $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}\left(\right.$ resp. $\left.\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}\right)$ for $\mathbb{Z}$-reducible $G$ (see Subsections 4.1 and 4.2). We will also use this technique for the 7 th crystal system (I), (II) although the both of $G$ and $P_{1}^{-1} G P_{1}$ are $\mathbb{Z}$-irreducible (see Subsection 5.1).

## 4. Proof of Theorem 1.15

In this section, we will give a proof of Theorem 1.15, First, we obtain the following theorem by Theorem 1.11 and Corollary 3.2,

Theorem 4.1. If $G$ is a group which belongs to the 1 st crystal system, the 2 nd crystal system, the 3 rd crystal system (I), the 5th crystal system (II), or the 6 th crystal system, then $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ under purely quasi-monomial actions of $G$ is $k$-rational.

Let $H=\{\sigma \in G \mid \sigma(\alpha)=\alpha$ for any $\alpha \in K\}$. The remaining cases will be treated below.
4.1. The 3 rd crystal system (II). We treat the following six groups:

\begin{array}{ll}
G_{3,1,3}=\left\langle\tau_{2}, \lambda_{2}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}, & G_{3,1,4}=\left\langle\tau_{3}, \lambda_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2} \\
G_{3,2,4}=\left\langle\tau_{2},-\lambda_{2}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}, & G_{3,2,5}=\left\langle\tau_{3},-\lambda_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2} \\
G_{3,3,3}=\left\langle\tau_{2}, \lambda_{2},-I_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2} \times \mathcal{C}_{2}, & G_{3,3,4}=\left\langle\tau_{3}, \lambda_{3},-I_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2} \times \mathcal{C}_{2}
\end{array}
$$

Let $P_{1}, P_{2} \in G L_{3}(\mathbb{Z})$ be two matrices defined as in Equation (11). Then we may confirm that

$$

G_{3,1,3} \sim P_{1}^{-1} G_{3,1,1} P_{1}, & G_{3,1,4} \sim P_{2}^{-1} G_{3,1,1} P_{2} \\
G_{3,2,4} \sim P_{1}^{-1} G_{3,2,1} P_{1}, & G_{3,2,5} \sim P_{2}^{-1} G_{3,2,1} P_{2} \\
G_{3,3,3} \sim P_{1}^{-1} G_{3,3,1} P_{1}, & G_{3,3,4} \sim P_{2}^{-1} G_{3,3,1} P_{2}
\end{aligned}
$$

where $\sim$ means $G L_{3}(\mathbb{Z})$-conjugation. Let $\rho_{1}, \rho_{2}, \rho_{3}$ be $K$-automorphisms on $K\left(x_{1}, x_{2}, x_{3}\right)$ defined by

& \rho_{1}: x_{1} \mapsto-x_{1}, x_{2} \mapsto-x_{2}, x_{3} \mapsto-x_{3}, \rho_{2}: x_{1} \mapsto-x_{1}, x_{2} \mapsto x_{2}, x_{3} \mapsto-x_{3}, \\
& \rho_{3}: x_{1} \mapsto x_{1}, x_{2} \mapsto-x_{2}, x_{3} \mapsto-x_{3}
\end{aligned}
$$

as in Lemma 3.14. By Lemma3.14, it suffices to consider the $k$-rationality of $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$ for $G=G_{3, j, 1}(j=1,2,3)$. Note that we already know that $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational by Theorem 4.1.

The actions of $\tau_{1}, \lambda_{1}$ and $-I_{3}$ on $K\left(x_{1}, x_{2}, x_{3}\right)$ are given by

$$

Case 1: $G=G_{3,1,1}=\left\langle\tau_{1}, \lambda_{1}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$.
Let $H$ be a non-trivial proper normal subgroup of $G$. By symmetry, we have only to consider $H=\left\langle\tau_{1}\right\rangle$. We can take $\sqrt{a} \in K$ such that $K=k(\sqrt{a})$ and $\lambda_{1}(\sqrt{a})=-\sqrt{a}$. Then we have $K\left(x_{1}, x_{2}, x_{3}\right)^{G}=k\left(y_{1}, y_{2}, y_{3}\right)$ where

$$
y_{1}=\left(\frac{x_{1}-1}{x_{1}+1}\right)^{2}, y_{2}=\frac{\sqrt{a}\left(x_{1}-1\right)\left(x_{2}-1\right)}{\left(x_{1}+1\right)\left(x_{2}+1\right)}, y_{3}=\frac{\sqrt{a}\left(x_{3}-1\right)}{x_{3}+1}
$$

and $\rho_{1}, \rho_{2}$ and $\rho_{3}$ act on $k\left(y_{1}, y_{2}, y_{3}\right)$ by

$$
\begin{aligned}
& \rho_{1}: y_{1} \mapsto \frac{1}{y_{1}}, y_{2} \mapsto \frac{a}{y_{2}}, y_{3} \mapsto \frac{a}{y_{3}} \\
& \rho_{2}: y_{1} \mapsto \frac{1}{y_{1}}, y_{2} \mapsto \frac{y_{2}}{y_{1}}, y_{3} \mapsto \frac{a}{y_{3}}, \rho_{3}: y_{1} \mapsto y_{1}, y_{2} \mapsto \frac{a y_{1}}{y_{2}}, y_{3} \mapsto \frac{a}{y_{3}} .
\end{aligned}
$$

Hence the $k$-rationality of $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$ can be reduced to the $k$-rationality for three-dimensional monomial actions on $k\left(y_{1}, y_{2}, y_{3}\right)$ of $G_{1,2,1} \simeq \mathcal{C}_{2}$ and $G_{3,1,2} \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$ respectively, which has already been settled in Sal00] and HKY11. They are both $k$-rational.

Case 2: $G=G_{3,2,1}=\left\langle\tau_{1},-\lambda_{1}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2}$.
Because $\tau_{1}\left(x_{3}\right)=-\lambda_{1}\left(x_{3}\right)=x_{3}$ and $\rho_{i}\left(x_{3}\right)=-x_{3}(i=1,2,3)$, by Theorem 3.1, the $k$ rationality of $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$ can be reduced to the $k$-rationality of purely quasi-monomial actions of $G$ on $K\left(x_{1}, x_{2}\right)^{\left\langle\rho_{1}\right\rangle}$ and $K\left(x_{1}, x_{2}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$. They are $k$-rational for any non-trivial proper normal subgroup $H$ of $G$ by Theorem 1.11.

Case 3: $G=G_{3,3,1}=\left\langle\tau_{1}, \lambda_{1},-I_{3}\right\rangle \simeq \mathcal{C}_{2} \times \mathcal{C}_{2} \times \mathcal{C}_{2}$.
Let $H$ be a non-trivial proper normal subgroup of $G$. By symmetry, we have only to consider the following three cases:
(i) $\left\langle-\tau_{1} \lambda_{1}\right\rangle \leq H$. We have $K\left(x_{1}, x_{2}, x_{3}\right)^{\left\langle-\tau_{1} \lambda_{1}\right\rangle}=K\left(y_{1}, y_{2}, y_{3}\right)$ where $y_{1}=x_{1}+\frac{1}{x_{1}}, y_{2}=x_{2}$, $y_{3}=x_{3}$. By Theorem 3.1, the $k$-rationality of $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$ can be reduced to the $k$-rationality for purely quasi-monomial actions of $G$ on $K\left(y_{2}, y_{3}\right)^{\left\langle\rho_{1}\right\rangle}$ and $K\left(y_{2}, y_{3}\right)^{\left\langle\rho_{2}, \rho_{3}\right\rangle}$. They are both $k$-rational by Theorem 1.11.
(ii) $\left\langle\tau_{1}\right\rangle \leq H$. By Lemma 3.5, we have $K\left(x_{1}, x_{2}, x_{3}\right)^{\left\langle\tau_{1}\right\rangle}=K\left(y_{1}, y_{2}, y_{3}\right)$ where

For $G=G_{4, j, 1}=\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle(j=1,2)$, (resp. $\left.G_{4,3,1}=\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle\right)$ we may take $K=k(\sqrt{a})$ (resp. $K^{\left\langle-I_{3}\right\rangle}=k(\sqrt{a})$ on which $G$ acts by $\pm \sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto-\sqrt{a}$. By Theorem $1.10(2), K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $k(\sqrt{a})\left(z_{1}\right)^{\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle}$ is $k$-rational if and only if $(a,-1)_{k}=0$.

For $G=\left\langle \pm \sigma_{4 \mathrm{~A}}, \pm \lambda_{1}\right\rangle$, i.e. $G=G_{4,4,1}, G_{4,5,1}, G_{4,6,1}$ or $G_{4,6,2},\left(\right.$ resp. $\left.G_{4,7,1}=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle\right)$ we may take $K=k(\sqrt{a}, \sqrt{b})$ (resp. $K^{\left\langle-I_{3}\right\rangle}=k(\sqrt{a}, \sqrt{b})$ ) on which $G$ acts by $\pm \sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto$ $-\sqrt{a}, \sqrt{b} \mapsto \sqrt{b}, \pm \lambda_{1}: \sqrt{a} \mapsto \sqrt{a}, \sqrt{b} \mapsto-\sqrt{b}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $K\left(z_{1}\right)^{\left\langle \pm \sigma_{4 \mathrm{~A}}, \pm \lambda_{1}\right\rangle}$ is $k$-rational if and only if $k(\sqrt{a})\left(\sqrt{b} z_{1}\right)^{\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle}$ is $k$-rational if and only if $(a,-b)_{k}=0$.
(ii) $H=\left\langle\sigma_{4 \mathrm{~A}}^{2},-I_{3}\right\rangle$. We have $K\left(x_{1}, x_{2}, x_{3}\right)^{H}=K\left(z_{1}, z_{2}, z_{3}\right)^{\left\langle-I_{3}\right\rangle}=K\left(z_{1}, z_{2}, z_{3}^{2}\right)$.

For $G=G_{4,3,1}=\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle$, we may take $K=k(\sqrt{a})$ on which $G$ acts by $\sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto$ $-\sqrt{a}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $k(\sqrt{a})\left(z_{1}\right)^{\left\langle\sigma_{4 A}\right\rangle}$ is $k$-rational if and only if $(a,-1)_{k}=0$.

For $G=G_{4,7,1}=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle$, we may take $K=k(\sqrt{a}, \sqrt{b})$ on which $G$ acts by $\sigma_{4 \mathrm{~A}}: \sqrt{a} \mapsto$ $-\sqrt{a}, \sqrt{b} \mapsto \sqrt{b}, \lambda_{1}: \sqrt{a} \mapsto \sqrt{a}, \sqrt{b} \mapsto-\sqrt{b}$, and $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational if and only if $K\left(z_{1}\right)^{\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1}\right\rangle}$ is $k$-rational if and only if $k(\sqrt{a})\left(\sqrt{b} z_{1}\right)^{\left\langle\sigma_{4 \mathrm{~A}}\right\rangle}$ is $k$-rational if and only if $(a,-b)_{k}=0$.
(iii) $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}, \pm \lambda_{1}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}}^{2}, \lambda_{1},-I_{3}\right\rangle$. For $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}, \lambda_{1}\right\rangle$, we define

Hence, by Theorem 3.1 and Theorem 3.3 (or Theorem 3.4), $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational for $G=G_{4,4,1}=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1}\right\rangle, G_{4,6,1}=\left\langle-\sigma_{4 \mathrm{~A}}, \lambda_{1}\right\rangle, G_{4,7,1}=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle$.

Similarly, we see that $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational when $H=\left\langle\sigma_{4 \mathrm{~A}}^{2},-\lambda_{1}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}}^{2}, \lambda_{1},-I_{3}\right\rangle$.
(iv) $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}, \pm \sigma_{4 \mathrm{~A}} \lambda_{1}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}}^{2}, \sigma_{4 \mathrm{~A}} \lambda_{1},-I_{3}\right\rangle$. For $H=\left\langle\sigma_{4 \mathrm{~A}}^{2}, \sigma_{4 \mathrm{~A}} \lambda_{1}\right\rangle$, we define

Similarly, $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational when $H=\left\langle\sigma_{4 \mathrm{~A}}^{2},-\sigma_{4 \mathrm{~A}} \lambda_{1}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}}^{2}, \sigma_{4 \mathrm{~A}} \lambda_{1},-I_{3}\right\rangle$.
(v) $H=\left\langle \pm \sigma_{4 \mathrm{~A}}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle$. For $H=\left\langle\sigma_{4 \mathrm{~A}}\right\rangle$, we define

Similarly, $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$-rational when $H=\left\langle-\sigma_{4 \mathrm{~A}}\right\rangle$ or $\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle$.
(vi) $H=\left\langle \pm \sigma_{4 \mathrm{~A}}, \pm \lambda_{1}\right\rangle$. We have $G=G_{4,7,1}=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle$. For $H=\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1}\right\rangle$, define

By Theorem 3.1, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is reduced to that of $K\left(y_{2}, y_{3}\right)^{\left\langle\sigma_{4 \mathrm{~A}}\right\rangle}$ and $K\left(y_{2}, y_{3}\right)^{\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1}\right\rangle}$, which is the rationality problem of two-dimensional algebraic tori. By Theorem 1.2, they are both $k$-rational.

On the other hand, we have

By Theorem 1.3, they are all $k$-rational (see also the last paragraph of Section (2).

By Theorem 3.1, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ can be reduced to that of $K\left(y_{1}, y_{2}\right)^{\left\langle\sigma_{4 \mathrm{~A}},-I_{3}\right\rangle}$ and $K\left(y_{1}, y_{2}\right)^{\left\langle\sigma_{4 \mathrm{~A}}, \lambda_{1},-I_{3}\right\rangle}$, which is the rationality problem of two-dimensional algebraic tori. By Theorem [1.2, they are both $k$-rational.

The actions of $-I_{3}, \alpha$ and $-\alpha$ on $K\left(y_{1}, y_{2}, y_{3}\right)$ are given by

Then, by Theorem [3.1, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ for each $G=G_{5, j, 1}$ is reduced to that of $K\left(Y_{2}, Y_{3}\right)^{G}$, which is the rationality problem of two-dimensional purely quasi-monomial actions. By Theorem 1.11, they are all $k$-rational.

Case 2: $H=\left\langle-I_{3}\right\rangle \simeq \mathcal{C}_{2}$.
There exist only two cases $G=G_{5,2,1}=\left\langle\sigma_{3 \mathrm{~B}},-I_{3}\right\rangle \simeq \mathcal{C}_{6}, G_{5,5,1}=\left\langle\sigma_{3 \mathrm{~B}}, \alpha,-I_{3}\right\rangle \simeq \mathcal{D}_{6}$. By Lemma 3.7, we have

Since $\left\langle\sigma_{3 \mathrm{~B}}\right\rangle$ and $\left\langle\sigma_{3 \mathrm{~B}}, \alpha\right\rangle$ act on $K$ faithfully, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ for $G_{5,2,1}$ (resp. $G_{5,5,1}$ ) is reduced to the rationality problem of three-dimensional algebraic torus corresponding to $G_{5,1,1}$ (resp. $G_{5,4,1}$ ). By Theorem 1.3, they are both $k$-rational.

## 5. Proof of Theorem 1.16

We consider the following 15 groups $G_{7, j, k}(1 \leq j \leq 5,1 \leq k \leq 3)$ which belong to the 7th crystal system in dimension 3:

& G_{7,4, k}=\left\langle\tau_{k}, \lambda_{k}, \sigma_{3 \mathrm{~B}}, \beta_{k}\right\rangle \quad \simeq \mathcal{S}_{4} \quad \simeq\left(\mathcal{C}_{2} \times \mathcal{C}_{2}\right) \rtimes \mathcal{S}_{3}, \\

The non-trivial proper normal subgroups $H$ of each $G=G_{7, j, k}(1 \leq k \leq 3)$ are:

as in Lemma 3.14, By Lemma 3.14, it suffices to prove the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ for $G=G_{7, j, 1}(1 \leq j \leq 5)$ which belong to the 7 th crystal system (I).

Case 1: $\left\langle\tau_{1}, \lambda_{1}\right\rangle \leq H$.
The actions of $\tau_{1}, \lambda_{1}, \sigma_{3 \mathrm{~B}},-I_{3}, \beta_{1}$ and $\rho_{1}$ on $K\left(x_{1}, x_{2}, x_{3}\right)$ are given by

Hence the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G_{7, j, 1}}$ is reduced to that of $K\left(y_{1}, y_{2}, y_{3}\right)^{G_{5, j, 1}}$. By Theorem 1.15, they are all $k$-rational.

On the other hand, we have $K\left(y_{1}, y_{2}, y_{3}\right)^{\left\langle\rho_{1}\right\rangle}=K\left(z_{1}, z_{2}, z_{3}\right)$ where $z_{1}=y_{2} y_{3}, z_{2}=y_{1} y_{3}$, $z_{3}=y_{1} y_{2}$. The actions of $\sigma_{3 \mathrm{~B}},-I_{3}$ and $\beta_{1}$ on $K\left(z_{1}, z_{2}, z_{3}\right)$ are the same as the actions on $K\left(y_{1}, y_{2}, y_{3}\right)$. Hence the $k$-rationality of $\left(K\left(y_{1}, y_{2}, y_{3}\right)^{G_{7, j, 1}}\right)^{\left\langle\rho_{1}\right\rangle}$ is reduced to the $k$-rationality of $K\left(z_{1}, z_{2}, z_{3}\right)^{G_{5, j, 1}}$. By Theorem 1.15 again, they are all $k$-rational.

Case 2: $H=\left\langle-I_{3}\right\rangle \simeq \mathcal{C}_{2}$.
There exist two cases: $G=G_{7,2,1}=\left\langle\tau_{1}, \lambda_{1}, \sigma_{3 \mathrm{~B}},-I_{3}\right\rangle \simeq \mathcal{A}_{4} \times \mathcal{C}_{2}, G_{7,5,1}=\left\langle\tau_{1}, \lambda_{1}, \sigma_{3 \mathrm{~B}}, \beta_{1},-I_{3}\right\rangle$ $\simeq \mathcal{S}_{4} \times \mathcal{C}_{2}$. By Lemma 3.7, we have

Hence, as in Case 1, the $k$-rationality of $K\left(x_{1}, x_{2}, x_{3}\right)^{G}$ and $\left(K\left(x_{1}, x_{2}, x_{3}\right)^{G}\right)^{\left\langle\rho_{1}\right\rangle}$ for $G=G_{7,2,1}$ (resp. $G_{7,5,1}$ ) can be reduced to the $k$-rationality of three-dimensional algebraic torus for $G_{7,1, k}$ (resp. $G_{7,4, k}$ ) with $k=1,2$. By Theorem [1.3, they are all $k$-rational.

-\beta_{3}^{*}: t_{1} \mapsto t_{1}, t_{2} \mapsto-t_{2}, t_{3} \mapsto \frac{t_{1}^{2}-t_{2}^{2}+1}{t_{3}} \\
\beta_{3}^{*}: t_{1} \mapsto-t_{1}, t_{2} \mapsto-t_{2}, t_{3} \mapsto-t_{3} \\
-I_{3}^{*}: t_{1} \mapsto-t_{1}, t_{2} \mapsto t_{2}, t_{3} \mapsto-\frac{t_{1}^{2}-t_{2}^{2}+1}{t_{3}}
\end{aligned}
$$

Hence $K\left(x_{1}, x_{2}, x_{3}\right)^{G_{7,3,3}}=K\left(t_{1}, t_{2}, t_{3}\right)^{\left\langle-\beta_{3}\right\rangle}$ and $K\left(x_{1}, x_{2}, x_{3}\right)^{G_{7,2,3}}=K\left(t_{1}, t_{2}, t_{3}\right)^{\left\langle-I_{3}\right\rangle}$ are $k$－ rational．For $G_{7,5,3}=\left\langle H, \beta_{3},-I_{3}\right\rangle$ ，we may take $K=k(\sqrt{a}, \sqrt{b})$ with $\beta_{3}(\sqrt{a})=-\sqrt{a}, \beta_{3}(\sqrt{b})=$ $\sqrt{b}$ ．Define $T_{1}=\sqrt{a} t_{1}, T_{2}=\sqrt{a} t_{2}, T_{3}=\sqrt{a} t_{3}$ ．Then $K\left(t_{1}, t_{2}, t_{3}\right)^{\left\langle\beta_{3}\right\rangle}=k(\sqrt{b})\left(T_{1}, T_{2}, T_{3}\right)$ and

$$
-I_{3}: \sqrt{b} \mapsto-\sqrt{b}, T_{1} \mapsto-T_{1}, T_{2} \mapsto T_{2}, T_{3} \mapsto-\frac{T_{1}^{2}-T_{2}^{2}+a}{T_{3}}
$$

By Lemma 3．12，we have $K\left(T_{1}, T_{2}, T_{3}\right)^{\left\langle-I_{3}\right\rangle}=k\left(X, Y, U_{1}, U_{2}\right)$ where $U_{1}=T_{1} / \sqrt{b}, U_{2}=T_{2}$ and $X^{2}-b Y^{2}=-b U_{1}^{2}+U_{2}^{2}-a$ ．Hence $K\left(x_{1}, x_{2}, x_{3}\right)^{G_{7,2,5}}=K\left(T_{1}, T_{2}, T_{3}\right)^{\left\langle-I_{3}\right\rangle}=k\left(X, Y+U_{1}, U_{2}\right)$ is $k$－rational．

## 7．Proof of Theorem 1.18

Write $M_{1}=\bigoplus_{1 \leq i \leq 3} \mathbb{Z} x_{i}, M_{2}=\bigoplus_{1 \leq i \leq 2} \mathbb{Z} y_{j}$ and $k(M)=k\left(x_{1}, x_{2}, x_{3}, y_{1}, y_{2}\right)$ ．Then $N_{1}=$ $\left\{\sigma \in G \mid \sigma\left(x_{i}\right)=x_{i}(i=1,2,3)\right\}$ and $N_{2}=\left\{\sigma \in G \mid \sigma\left(y_{j}\right)=y_{j}(j=1,2)\right\}$ ．

By Theorem 1．8，without loss of generality，we may assume that $M$ is a faithful $G$－lattice， i．e．$N=\left\{\sigma \in G \mid \sigma\left(x_{i}\right)=x_{i}, \sigma\left(y_{j}\right)=y_{j}(i=1,2,3, j=1,2)\right\}=N_{1} \cap N_{2}=\{1\}$ ．

Step 1．Case $\left(G / N_{2}, N_{1} N_{2} / N_{2}\right) \nsucceq\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right),\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right)$.
We have $k(M)^{G}=K\left(y_{1}, y_{2}\right)^{G / N_{2}}$ and $G / N_{2}$ acts on $K\left(y_{1}, y_{2}\right)$ by purely quasi－monomial $k$－ automorphisms where $K=k\left(x_{1}, x_{2}, x_{3}\right)^{N_{2}}$ ．By Theorem 1．11，if $\left(G / N_{2}, N_{1} N_{2} / N_{2}\right) \nsucceq\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right)$ ， $\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right)$ ，then $k(M)^{G}=K\left(y_{1}, y_{2}\right)^{G / N_{2}}$ is $K^{G / N_{2}}$－rational．It follows from Theorem 1.7 that $K^{G / N_{2}}=k\left(x_{1}, x_{2}, x_{3}\right)^{G}$ is $k$－rational．Hence $k(M)$ is $k$－rational if $\left(G / N_{2}, N_{1} N_{2} / N_{2}\right) \not 千\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right)$ ， $\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right)$.

Step 2．Case $\left(G / N_{1}, N_{1} N_{2} / N_{1}\right) \not 千\left(G_{7, j, 3}, \mathcal{A}_{4}\right),\left(G_{7, j, 3}, \mathcal{C}_{2} \times \mathcal{C}_{2}\right)(j=2,3,5)$.
As in Step 1，we have $k(M)^{G}=K\left(x_{1}, x_{2}, x_{3}\right)^{G / N_{1}}$ and $G / N_{1}$ acts on $K\left(x_{1}, x_{2}, x_{3}\right)$ by purely quasi－monomial $k$－automorphisms where $K=k\left(y_{1}, y_{2}\right)^{N_{1}}$ ．It follows from Theorem 1.6 that $K^{G / N_{1}}=k\left(y_{1}, y_{2}\right)^{G}$ is $k$－rational．Thus，by Theorem 1．16，if $\left(G / N_{1}, N_{1} N_{2} / N_{1}\right) \not 千$ $\left(G_{4, j, k}, \mathcal{C}_{2}\right),\left(G_{4, j, k}, \mathcal{C}_{2} \times \mathcal{C}_{2}\right),\left(G_{7, j, 3}, \mathcal{A}_{4}\right),\left(G_{7, j, 3}, \mathcal{C}_{2} \times \mathcal{C}_{2}\right)(j=2,3,5)$ ，then $k(M)^{G}$ is $K^{G / N_{1}}$ rational，and hence $k$－rational．

For the case where $G / N_{1}=G_{4, j, k}$ ，the rationality does not depend on the $\mathbb{Q}$－conjugacy class by Theorem 1．16．Indeed，the actions of the groups which belong to 4 th crystal system（I）and the groups which belong to 4 th crystal system（II）on $K\left(x_{1}, x_{2}, x_{3}\right)^{\left\langle\sigma_{4 \mathrm{~A}}^{2}\right\rangle}=K\left(z_{1}, z_{2}, z_{3}\right)$ coincide （see Case 1 in Subsection 4．2）．Hence we may assume that $G / N_{1}$ belongs to the 4 th crystal system（I）and $M_{1}=M_{1,1} \oplus M_{1,2}$ where $\operatorname{rank}_{\mathbb{Z}} M_{1,1}=1$ and $\operatorname{rank}_{\mathbb{Z}} M_{1,2}=2$ ．Therefore，it
follows from HKK14, Proposition 5.2] that $k(M)^{G}$ is $k$-rational.

Step 3. By Steps 1 and 2, the remaining cases that we should treat are $\left(G / N_{1}, N_{1} N_{2} / N_{1}\right) \simeq$ $\left(G_{7, j, 3}, \mathcal{A}_{4}\right),\left(G_{7, j, 3}, \mathcal{C}_{2} \times \mathcal{C}_{2}\right)(j=2,3,5)$ and $\left(G / N_{2}, N_{1} N_{2} / N_{2}\right) \simeq\left(\mathcal{C}_{4}, \mathcal{C}_{2}\right),\left(\mathcal{D}_{4}, \mathcal{C}_{2}\right)$.

Note that $N_{1} N_{2} / N_{1} \simeq N_{2}$ and $N_{1} N_{2} / N_{2} \simeq N_{1}$ because $N_{1} \cap N_{2}=\{1\}$. Thus $\# G=\# G_{7, j, 3} \times$ $\# N_{1}=\# G / N_{2} \times \# N_{2}$ where $N_{1} \simeq \mathcal{C}_{2}$ and $N_{2} \simeq \mathcal{A}_{4}$ or $\mathcal{C}_{2} \times \mathcal{C}_{2}$. Hence we see that only the cases where $\left(G / N_{1}, N_{2}, G / N_{2}, N_{1}\right) \simeq\left(G_{7,2,3}, \mathcal{A}_{4}, \mathcal{C}_{4}, \mathcal{C}_{2}\right),\left(G_{7,3,3}, \mathcal{A}_{4}, \mathcal{C}_{4}, \mathcal{C}_{2}\right)$ or $\left(G_{7,5,3}, \mathcal{A}_{4}, \mathcal{D}_{4}, \mathcal{C}_{2}\right)$ may occur. The last statement follows from Step 2 and Proposition 1.17(5).
