# An improved Hardy-Trudinger-Moser inequality

## Abstract

Let $\mathbb{B}$ be the unit disc in $\mathbb{R}^{2}, \mathscr{H}$ be the completion of $C_{0}^{\infty}(\mathbb{B})$ under the norm

$$
\|u\|_{\mathscr{H}}=\left(\int_{\mathbb{B}}|\nabla u|^{2} d x-\int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x\right)^{1 / 2}, \quad \forall u \in C_{0}^{\infty}(\mathbb{B}) .
$$

Denote $\lambda_{1}(\mathbb{B})=\inf _{u \in \mathscr{H},\|u\|_{2}=1}\|u\|_{\mathscr{H}}^{2}$, where $\|\cdot\|_{2}$ stands for the $L^{2}(\mathbb{B})$-norm. Using blow-up analysis, we prove that for any $\alpha, 0 \leq \alpha<\lambda_{1}(\mathbb{B})$,

$$
\sup _{u \in \mathscr{H},\|u\|_{\mathscr{C}}^{2}-\alpha\|u\|_{2}^{2} \leq 1} \int_{\mathbb{B}} e^{4 \pi u^{2}} d x<+\infty,
$$

and that the above supremum can be attained by some function $u \in \mathscr{H}$ with $\|u\|_{\mathscr{H}}^{2}-\alpha\|u\|_{2}^{2}=1$. This improves an earlier result of G. Wang and D. Ye [29].

## 1. Introduction

Let $\mathbb{B}$ be the unit disc in $\mathbb{R}^{2}$ and $W_{0}^{1,2}(\mathbb{B})$ be the usual Sobolev space. The Trudinger-Moser inequality [34, 24, 23, 28, 22] says that for any $\beta \leq 4 \pi$,

$$
\begin{equation*}
\sup _{u \in W_{0}^{1,2}(\mathbb{B}),\|\nabla u\|_{2} \leq 1} \int_{\mathbb{B}} e^{\beta u^{2}} d x<\infty . \tag{1}
\end{equation*}
$$

Here and throughout this paper we denote the $L^{p}(\mathbb{B})$-norm by $\|\cdot\|_{p}$. This inequality is sharp in the sense that for any $\beta>4 \pi$, the integrals in (1) are still finite but the supremum is infinity. It is a very powerful tool in the problem of prescribed Gaussian curvature and partial differential equations.

Another important inequality in analysis is the Hardy inequality, namely

$$
\int_{\mathbb{B}}|\nabla u|^{2} d x \geq \int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x, \quad \forall u \in W_{0}^{1,2}(\mathbb{B}) .
$$

[^0]The Hardy inequality was improved in many ways. It was proved by H. Brezis and M. Marcus [7] that there exists some constant $C$ such that

$$
\begin{equation*}
\int_{\mathbb{B}}|\nabla u|^{2} d x-\int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x \geq C \int_{\mathbb{B}} u^{2} d x, \quad \forall u \in W_{0}^{1,2}(\mathbb{B}) . \tag{2}
\end{equation*}
$$

Further improvements known as the Hardy-Sobolev inequalities were done by Maz'ya ([21], Corollary 3, Section 2.1.6), Mancini-Sandeep [19], Adimurthi-do Ó-Tintarev [2], and Mancini-Sandeep-Tintarev [20]. In view of (2),

$$
\|u\|_{\mathscr{H}}=\left(\int_{\mathbb{B}}|\nabla u|^{2} d x-\int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x\right)^{1 / 2}
$$

defines a norm on $C_{0}^{\infty}(\mathbb{B})$. Let $\mathscr{H}$ be the completion of $C_{0}^{\infty}(\mathbb{B})$ under the norm $\|\cdot\|_{\mathscr{H}}$. Clearly $\mathscr{H}$ is a Hilbert space. By a result of Mancini-Sandeep ([19], the inequality (1.2)), we can see that for any $p>1$, there exists a constant $C_{p}>0$ such that

$$
\begin{equation*}
\|u\|_{p} \leq C_{p}\|u\|_{\mathscr{H}}, \quad \forall u \in \mathscr{H} \tag{3}
\end{equation*}
$$

This is also obtained by Wang-Ye [29]. Thus we have

$$
W_{0}^{1,2}(\mathbb{B}) \subset \mathscr{H} \subset \cap_{p \geq 1} L^{p}(\mathbb{B})
$$

Obviously $\mathscr{H} \not \subset L^{\infty}(\mathbb{B})$. In view of (1), one can expect a Hardy-Trudinger-Moser inequality, namely

$$
\begin{equation*}
\sup _{u \in \mathscr{H},\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{4 \pi u^{2}} d x<+\infty \tag{4}
\end{equation*}
$$

This was done by Wang-Ye by using blow-up analysis in [29], where the existence of extremal function for (4) was also obtained. The inequality (4) was further extended by C. Tintarev [27] to a generalized Euclidean version by using Ground state transform, and by Mancini-SandeepTintarev [20] to a hyperbolic space version via a rearrangement argument. Compared with (4), another kind of singular Trudinger-Moser inequalities were obtained by Adimurthi-Sandeep [3], Adimurthi-Yang [4], and de Souza-do Ó [12].

Motivated by the works of Adimurthi-Druet [1], Y. Yang [30, 31, 32, 33] and C. Tintarev [27], we aim to rewrite (4) with $\|u\|_{\mathscr{H}}$ replaced by certain equivalent norm on $\mathscr{H}$. To clarify this problem, we define

$$
\begin{equation*}
\lambda_{1}(\mathbb{B})=\inf _{u \in \mathscr{H}, u \neq 0} \frac{\|u\|_{\mathscr{H}}^{2}}{\|u\|_{2}^{2}} \tag{5}
\end{equation*}
$$

By (3) and a variational direct method, we have that $\lambda_{1}(\mathbb{B})$ can be attained by some function $u \in \mathscr{H}$ with $\|u\|_{2}=1$. In particular, $\lambda_{1}(\mathbb{B})>0$. In fact, $\lambda_{1}(\mathbb{B})$ is the first eigenvalue of the Hardy-Laplace operator, namely

$$
\mathscr{L}_{H}=-\Delta-\frac{1}{\left(1-|x|^{2}\right)^{2}}
$$

For any $\alpha, 0 \leq \alpha<\lambda_{1}(\mathbb{B})$ and any $u \in \mathscr{H}$, we denote

$$
\begin{equation*}
\|u\|_{1, \alpha}=\left(\|u\|_{\mathscr{H}}^{2}-\alpha\|u\|_{2}^{2}\right)^{1 / 2} \tag{6}
\end{equation*}
$$

Clearly $\|\cdot\|_{1, \alpha}$ is equivalent to $\|\cdot\|_{\mathscr{H}}$. Our main result is the following:

Theorem 1. Let $\mathbb{B}$ be the unit ball in $\mathbb{R}^{2}, \lambda_{1}(\mathbb{B})$ be defined as in (5). Then for any $\beta \leq 4 \pi$ and any $\alpha, 0 \leq \alpha<\lambda_{1}(\mathbb{B})$, the supremum

$$
\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{\beta u^{2}} d x
$$

can be attained by some function $u_{0} \in \mathscr{H}$ with $\left\|u_{0}\right\|_{1, \alpha}=1$, where $\|\cdot\|_{1, \alpha}$ is defined as in (6).
An interesting consequence of Theorem is the following weak form of the Hardy-TrudingerMoser inequality.

Corollary 2. Let $\lambda_{1}(\mathbb{B})$ be defined as in (5). Then for any $\alpha, 0 \leq \alpha<\lambda_{1}(\mathbb{B})$, there exists a constant $C>0$ depending only on $\alpha$ such that

$$
\int_{\mathbb{B}}|\nabla u|^{2} d x-\int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x-\alpha \int_{\mathbb{B}} u^{2} d x-16 \pi \log \int_{\mathbb{B}} e^{u} d x \geq-C, \quad \forall u \in W_{0}^{1,2}(\mathbb{B}) .
$$

Following the lines of Y. Li [15], Adimurthi-Druet [1], Yang [31], and Wang-Ye [29], we prove Theorem 1 by using blow-up analysis. We remark that Wang-Ye [29] solved (4) by using a result of Carleson-Chang [10] in addition to standard blow-up analysis. This method was originally used by Li-Liu-Yang [16]. In this paper, we shall employ the capacity estimate introduced by Y. Li [15], instead of Carleson-Chang's result. It would be interesting to extend our Theorem 11to the case involving $L^{p}(\mathbb{B})$-norm as in [18].

Earlier works in this direction were due to Carleson-Chang [10], M. Struwe [25], F. Flucher [13], K. Lin [17], Ding-Jost-Li-Wang [11], and Adimurthi-Struwe [5]. The remaining part of this paper is organized as follows. In Section 2, we give several preliminary lemmas; In Section 3, we prove Theorem 1

## 2. Preliminary results

In this section, we list several properties of the space $\mathscr{H}$. Let

$$
\mathscr{S}_{0}=\left\{u \in C_{0}^{\infty}(B): u(x)=u(r), u^{\prime}(r) \leq 0, \text { where } r=|x|\right\}
$$

and $\mathscr{S}$ be the completion of $\mathscr{S}_{0}$ under the norm $\|\cdot\|_{\mathscr{H}}$. The following embedding theorem was proved by Wang-Ye [29]:
Lemma 3. $\mathscr{S}$ is embedded continuously in $W_{\mathrm{loc}}^{1,2}(\mathbb{B}) \cap C_{\mathrm{loc}}^{0, \frac{1}{2}}(\mathbb{B} \backslash\{0\})$. Moreover, $\mathscr{S}$ is embedded compactly in $L^{p}(\mathbb{B})$ for any $p \geq 1$.

The second important property of $\mathscr{H}$ is an embedding of Orlicz type, namely
Lemma 4. For any $p>1$ and any $u \in \mathscr{H}$, there holds

$$
\int_{\mathbb{B}} e^{p u^{2}} d x<+\infty
$$

Proof. Fix $p>1$ and $u \in \mathscr{H}$. Since $C_{0}^{\infty}(\mathbb{B})$ is dense in $\mathscr{H}$, we take $u_{0} \in C_{0}^{\infty}(\mathbb{B})$ such that $\left\|u-u_{0}\right\|_{\mathscr{H}}^{2}<\pi / p$. Using an inequality $2 a b \leq a^{2}+b^{2}$ twice, we have

$$
\int_{\mathbb{B}} e^{p u^{2}} d x \leq \int_{\mathbb{B}} e^{4 p\left(u-u_{0}\right)^{2}} d x+\int_{\mathbb{B}} e^{4 p u_{0}^{2}} d x
$$

By ([29], Theorem 1), we have

$$
\int_{\mathbb{B}} e^{4 p\left(u-u_{0}\right)^{2}} d x<+\infty
$$

Since $u_{0}$ is uniformly bounded in $\mathbb{B}$, we have $\int_{\mathbb{B}} e^{4 p u_{0}^{2}} d x<+\infty$. This gives the desired estimate.
Finally we state an obvious but very important property of $\mathscr{H}$.
Lemma 5. Suppose $u \in W_{\mathrm{loc}}^{1,2}(\mathbb{B}), v \in \mathscr{H}$ and $v$ is radially symmetric. If there exists some $r$, $0<r<1$, such that $u=v$ on $\mathbb{B} \backslash \mathbb{B}_{r}$, then $u \in \mathscr{H}$.

Proof. It follows from Lemma 3 that $v \in W_{\mathrm{loc}}^{1,2}(\mathbb{B})$. Clearly we have $u-v \in W_{0}^{1,2}\left(\mathbb{B}_{r}\right) \subset W_{0}^{1,2}(\mathbb{B})$. This leads to $u=(u-v)+v \in \mathscr{H}$.

## 3. Proof of Theorem 1

In this section, we prove Theorem 1 by using a blow-up scheme similar to that of Wang-Ye [29], and thereby follow closely Y. Li [15], Adimurthi-Druet [1], and Yang [31]. The proof will be divided into several subsections.

### 3.1. The subcritical case

In this subsection, we prove that the subcritical Trudinger-Moser functional $J(u)=\int_{\mathbb{B}} e^{\gamma u^{2}} d x$ has a maximizer in the function space $\left\{u \in \mathscr{H}:\|u\|_{1, \alpha} \leq 1\right\}$ for any $\gamma<4 \pi$ and any $\alpha$, $0 \leq \alpha<\lambda_{1}(\mathbb{B})$.

Proposition 6. Let $0 \leq \alpha<\lambda_{1}(\mathbb{B})$. For any $\epsilon>0$, there exists $u_{\epsilon} \in \mathscr{S} \cap C^{\infty}(\mathbb{B}) \cap C^{0}(\overline{\mathbb{B}})$ such that $\left\|u_{\epsilon}\right\|_{1, \alpha}=1$ and

$$
\begin{equation*}
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x \tag{7}
\end{equation*}
$$

Moreover, $u_{\epsilon}$ satisfies the following Euler-Lagrange equation

$$
\left\{\begin{array}{l}
-\Delta u_{\epsilon}-\frac{u_{\epsilon}}{\left(1-|x|^{2}\right)^{2}}-\alpha u_{\epsilon}=\frac{1}{\lambda_{\epsilon}} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} \text { in } \mathbb{B},  \tag{8}\\
\lambda_{\epsilon}=\int_{\mathbb{B}} u_{\epsilon}^{2} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x
\end{array}\right.
$$

Furthermore, we have

$$
\begin{equation*}
\liminf _{\epsilon \rightarrow 0} \lambda_{\epsilon}>0 \tag{9}
\end{equation*}
$$

Proof. We first claim that for any $\gamma<4 \pi$, there holds

$$
\begin{equation*}
\sup _{u \in \mathscr{H},\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{\gamma u^{2}} d x<+\infty \tag{10}
\end{equation*}
$$

To see this, we use an argument of radially decreasing rearrangement with respect to the standard hyperbolic metric $d v=\frac{1}{\left.(1-\mid x)^{2}\right)^{2}} d x$. For any $u \in C_{0}^{\infty}(\mathbb{B})$, we let $u^{*}$ be the radially decreasing rearrangement of $|u|$ with respect to the standard hyperbolic metric. It follows from [6] that

$$
\int_{\mathbb{B}}\left|\nabla u^{*}\right|^{2} d x \leq \int_{\mathbb{B}}|\nabla u|^{2} d x, \quad \int_{\mathbb{B}} \frac{u^{* 2}}{\left(1-|x|^{2}\right)^{2}} d x=\int_{\mathbb{B}} \frac{u^{2}}{\left(1-|x|^{2}\right)^{2}} d x
$$

Clearly we have $\left\|u^{*}\right\|_{\mathscr{H}} \leq\|u\|_{\mathscr{H}}$. This leads to

$$
\sup _{u \in C_{0}^{\infty}(\mathbb{B}),\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{\gamma u^{2}} d x \leq \sup _{u \in \mathscr{S},\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{\gamma u^{2}} d x
$$

In view of Lemma 3, for any $u \in \mathscr{H}$ with $\|u\|_{\mathscr{H}} \leq 1$, there exists a sequence of functions $u_{j} \in C_{0}^{\infty}(\mathbb{B})$ such that $\left\|u_{j}\right\|_{\mathscr{H}} \leq 1, u_{j} \rightarrow u$ in $\mathscr{H}$ and $u_{j} \rightarrow u$ a. e. in $\mathbb{B}$. Thus

$$
\int_{\mathbb{B}} e^{\gamma u^{2}} d x \leq \limsup _{j \rightarrow \infty} \int_{\mathbb{B}} e^{\gamma u_{j}^{2}} d x
$$

Hence

$$
\sup _{u \in \mathscr{H},\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{\gamma u^{2}} d x=\sup _{u \in \mathscr{S},\|u\|_{\mathscr{H}} \leq 1} \int_{\mathbb{B}} e^{\gamma u^{2}} d x
$$

which together with ([29], Theorem 3) implies (10).
Now let $0<\epsilon<4 \pi$ be fixed. Note that

$$
\begin{aligned}
\int_{\mathbb{B}} u^{* 2} d x & =\int_{\mathbb{B}} u^{* 2}\left(1-|x|^{2}\right)^{2} d v \\
& \geq \int_{\mathbb{B}}\left(u^{2}\left(1-|x|^{2}\right)^{2}\right)^{*} d v \\
& =\int_{\mathbb{B}} u^{2}\left(1-|x|^{2}\right)^{2} d v \\
& =\int_{\mathbb{B}} u^{2} d x
\end{aligned}
$$

and that

$$
\begin{aligned}
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{* 2}} d x & =\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{* 2}}\left(1-|x|^{2}\right)^{2} d v \\
& \geq \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}}\left(1-|x|^{2}\right)^{2} d v \\
& =\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x
\end{aligned}
$$

where we have used the Hardy-Littlewood inequality (see [8]) and the fact that the radially decreasing rearrangement of $\left(1-|x|^{2}\right)^{2}$ with respect to the standard hyperbolic metric is itself. Therefore

$$
\sup _{\left.u \in C_{0}^{C_{(\mathbb{B}}}\right),\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x \leq \sup _{u \in \mathscr{S},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x .
$$

Since $C_{0}^{\infty}(\mathbb{B})$ is dense in $\mathscr{H}$, we obtain

$$
\begin{equation*}
\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x=\sup _{u \in \mathscr{S},\|u\|_{, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x . \tag{11}
\end{equation*}
$$

To prove (7), we use a method of variation. Observing (10) and (11), we can take a sequence of functions $u_{j} \in \mathscr{S}$ with $\left\|u_{j}\right\|_{1, \alpha} \leq 1$ such that

$$
\begin{equation*}
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{j}^{2}} d x \rightarrow \sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x \quad \text { as } \quad j \rightarrow \infty . \tag{12}
\end{equation*}
$$

Since $0 \leq \alpha<\lambda_{1}(\mathbb{B})$, we have

$$
\left\|u_{j}\right\|_{\mathscr{H}}^{2} \leq \frac{\lambda_{1}(\mathbb{B})}{\lambda_{1}(\mathbb{B})-\alpha}
$$

Note that $\mathscr{H}$ is a Hilbert space. Up to a subsequence there exists some $u_{\epsilon} \in \mathscr{S}$ such that

$$
\begin{array}{ll}
u_{j} \rightharpoonup u_{\epsilon} & \text { weakly in } \mathscr{H} \\
u_{j} \rightarrow u_{\epsilon} & \text { strongly in } \quad L^{p}(\mathbb{B}), \forall p \geq 1 \\
u_{j} \rightarrow u_{\epsilon} & \text { a.e. in } \mathbb{B} .
\end{array}
$$

It follows that

$$
\begin{equation*}
\left\|u_{\epsilon}\right\|_{1, \alpha}^{2} \leq \liminf _{j \rightarrow \infty}\left\|u_{j}\right\|_{1, \alpha}^{2} \leq 1 . \tag{13}
\end{equation*}
$$

A straightforward calculation shows

$$
\begin{align*}
\left\|u_{j}-u_{\epsilon}\right\|_{\mathscr{H}}^{2} & =\left\langle u_{j}-u_{\epsilon}, u_{j}-u_{\epsilon}\right\rangle_{\mathscr{H}} \\
& =\left\|u_{j}\right\|_{\mathscr{H}}^{2}+\left\|u_{\epsilon}\right\|_{\mathscr{H}}^{2}-2\left\langle u_{j}, u_{\epsilon}\right\rangle_{\mathscr{H}} \\
& =\left\|u_{j}\right\|_{\mathscr{H}}^{2}-\left\|u_{\epsilon}\right\|_{\mathscr{H}}^{2}+o_{j}(1) \\
& =\left\|u_{j}\right\|_{1, \alpha}^{2}-\left\|u_{\epsilon}\right\|_{1, \alpha}^{2}+o_{j}(1), \tag{14}
\end{align*}
$$

since $\left\langle u_{j}, u_{\epsilon}\right\rangle_{\mathscr{H}} \rightarrow\left\|u_{\epsilon}\right\|_{\mathscr{H}}^{2}$ and $\left\|u_{j}\right\|_{2} \rightarrow\left\|u_{\epsilon}\right\|_{2}$ as $j \rightarrow \infty$.
For any $v>0$, using an elementary inequality $2 a b \leq v a^{2}+b^{2} / v$, we have

$$
u_{j}^{2} \leq(1+v)\left(u_{j}-u_{\epsilon}\right)^{2}+(1+1 / v) u_{\epsilon}^{2} .
$$

Choosing $v=\epsilon /(8 \pi-2 \epsilon)$ in the above equation, we have

$$
\begin{equation*}
(4 \pi-\epsilon) u_{j}^{2} \leq(4 \pi-\epsilon / 2)\left(u_{j}-u_{\epsilon}\right)^{2}+\frac{32 \pi^{2}}{\epsilon} u_{\epsilon}^{2} \tag{15}
\end{equation*}
$$

From (14) we can find some positive integer $j_{0}$ such that

$$
\left\|u_{j}-u_{\epsilon}\right\|_{\mathscr{H}}^{2} \leq \frac{4 \pi-\epsilon / 3}{4 \pi-\epsilon / 2}, \quad \forall j \geq j_{0}
$$

This together with (15) gives

$$
\begin{equation*}
(4 \pi-\epsilon) u_{j}^{2} \leq(4 \pi-\epsilon / 3) \frac{\left(u_{j}-u_{\epsilon}\right)^{2}}{\left\|u_{j}-u_{\epsilon}\right\|_{\mathscr{H}}^{2}}+\frac{32 \pi^{2}}{\epsilon} u_{\epsilon}^{2}, \quad \forall j \geq j_{0} . \tag{16}
\end{equation*}
$$

By Lemma 4

$$
\begin{equation*}
\int_{\mathbb{B}} e^{q u_{\varepsilon}^{2}} d x<\infty, \quad \forall q>1 \tag{17}
\end{equation*}
$$

Take

$$
p=\frac{4 \pi-\epsilon / 4}{4 \pi-\epsilon / 3}>1 .
$$

Combining (10), (16) and (17), we conclude that $e^{(4 \pi-\epsilon) u_{j}^{2}}$ is bounded in $L^{p}(\mathbb{B})$, which together with $u_{j} \rightarrow u_{0}$ a. e. as $j \rightarrow \infty$ implies that $e^{(4 \pi-\epsilon) u_{j}^{2}}$ converges to $e^{(4 \pi-\epsilon) u_{\epsilon}^{2}}$ in $L^{1}(\mathbb{B})$. This together 6
with (12) leads to (7). Recall (13) we have $\left\|u_{\epsilon}\right\|_{1, \alpha} \leq 1$. Now we claim that $\left\|u_{\epsilon}\right\|_{1, \alpha}=1$. For otherwise, we have $\left\|u_{\epsilon}\right\|_{1, \alpha}<1$, and thus

$$
\begin{aligned}
\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x & =\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \\
& <\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}\| \| u_{\epsilon} \|_{1, \alpha}^{2}} d x \\
& \leq \sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x,
\end{aligned}
$$

which is a contradiction.
It is not difficult to see that $u_{\epsilon}$ satisfies the Euler-Lagrange equation (8). Finally $u_{\epsilon} \in C^{\infty}(\mathbb{B})$ follows from standard elliptic estimates, and the fact that $u_{\epsilon} \in C^{0}(\overline{\mathbb{B}})$ follows from $u_{\epsilon} \in \mathscr{S}$.

Finally we prove (9). Using an elementary inequality $e^{t} \leq 1+t e^{t}$ for $t \geq 0$, we have

$$
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \pi+(4 \pi-\epsilon) \lambda_{\epsilon} .
$$

Note that $\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x$ is monotone with respect to $\epsilon>0$. For any fixed $u \in \mathscr{H}$ with $\|u\|_{1, \alpha}=1$, in view of Lemma4 there holds

$$
\pi<\int_{\mathbb{B}} e^{4 \pi u^{2}} d x=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u^{2}} d x \leq \liminf _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \pi+4 \pi \liminf _{\epsilon \rightarrow 0} \lambda_{\epsilon} .
$$

This leads to (9) immediately.

### 3.2. Blow-up analysis

In this subsection, we perform the blow-up procedure. Let $u_{\epsilon}$ be as in Proposition6. Since $\left\|u_{\epsilon}\right\|_{1, \alpha}=1$ and $\alpha<\lambda_{1}(\mathbb{B}), u_{\epsilon}$ is bounded in $\mathscr{H}$. By Lemma 3, there exists $u_{0} \in L^{2}(\mathbb{B})$ such that up to a subsequence, $u_{\epsilon} \rightarrow u_{0}$ in $L^{2}(\mathbb{B})$ and $u_{\epsilon} \rightarrow u_{0}$ a. e. in $\mathbb{B}$ as $\epsilon \rightarrow 0$. On the other hand, there exists some $v_{0} \in \mathscr{S}$ such that $u_{\epsilon} \rightharpoonup v_{0}$ weakly in $\mathscr{H}$. In particular

$$
\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} u_{\epsilon} \varphi d x=\int_{\mathbb{B}} v_{0} \varphi d x, \quad \forall \varphi \in L^{2}(\mathbb{B}) .
$$

Since the weak limit is unique, we have $v_{0}=u_{0}$. In conclusion, there exists $u_{0} \in \mathscr{S}$ such that up to a subsequence,

$$
u_{\epsilon} \rightharpoonup u_{0} \text { in } \mathscr{H}, u_{\epsilon} \rightarrow u_{0} \text { a. e. in } \mathbb{B}
$$

as $\epsilon \rightarrow 0$. Noting that $\left\langle u_{\epsilon}, u_{0}\right\rangle_{\mathscr{H}} \rightarrow\left\langle u_{0}, u_{0}\right\rangle_{\mathscr{H}}$, we have

$$
\left\|u_{0}\right\|_{1, \alpha}^{2}=\left\|u_{0}\right\|_{\mathscr{H}}^{2}-\alpha\left\|u_{0}\right\|_{2}^{2} \leq \liminf _{\epsilon \rightarrow 0}\left\|u_{\epsilon}\right\|_{1, \alpha}=1
$$

Let $c_{\epsilon}=u_{\epsilon}(0)=\max _{\mathbb{B}} u_{\epsilon}$. If $c_{\epsilon}$ is bounded, we have by using the Lebesgue dominated convergence theorem,

$$
\int_{\mathbb{B}} e^{4 \pi u_{0}^{2}} d x=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{4 \pi u^{2}} d x .
$$

Hence $u_{0}$ is a desired extremal function and Theorem 1 holds. In the following, we assume

$$
\begin{equation*}
c_{\epsilon} \rightarrow+\infty \text { as } \epsilon \rightarrow 0 \tag{18}
\end{equation*}
$$

Now we claim that $u_{0} \equiv 0$. To see this, suppose $u_{0} \not \equiv 0$, then $\left\|u_{0}\right\|_{1, \alpha}>0$. On one hand, by the Hölder inequality, $\forall v>0$, there holds

$$
\begin{equation*}
\left\|e^{(4 \pi-\epsilon) u_{\epsilon}^{2}}\right\|_{1+v} \leq\left\|e^{(4 \pi-\epsilon)\left(u_{\epsilon}-u_{0}\right)^{2}}\right\|_{(1+v)(1+2 v)}^{1+v}\left\|e^{(4 \pi-\epsilon) u_{0}^{2}}\right\|_{(1+v)^{2}(1+2 v) / v^{2}}^{1+1 / v} \tag{19}
\end{equation*}
$$

On the other hand, we calculate

$$
\begin{align*}
\left\|u_{\epsilon}-u_{0}\right\|_{\mathscr{H}}^{2} & =\left\langle u_{\epsilon}-u_{0}, u_{\epsilon}-u_{0}\right\rangle_{\mathscr{H}} \\
& =\left\|u_{\epsilon}\right\|_{\mathscr{H}}^{2}-\left\|u_{0}\right\|_{\mathscr{H}}^{2}+o_{\epsilon}(1) \\
& =\left\|u_{\epsilon}\right\|_{1, \alpha}^{2}-\left\|u_{0}\right\|_{1, \alpha}^{2}+o_{\epsilon}(1) \\
& =1-\left\|u_{0}\right\|_{1, \alpha}^{2}+o_{\epsilon}(1) \\
& <1-\left\|u_{0}\right\|_{1, \alpha}^{2} / 2, \tag{20}
\end{align*}
$$

provided that $\epsilon$ is sufficiently small. Choosing $v=\left\|u_{0}\right\|_{1, \alpha}^{2} / 16$ in (19), we have by (20) and (10) that $e^{(4 \pi-\epsilon) u_{\epsilon}^{2}}$ is bounded in $L^{1+v}(\mathbb{B})$. Then applying standard elliptic estimates to 8 , we get that $u_{\epsilon}$ is bounded in $C_{\mathrm{loc}}^{0}(\mathbb{B})$, which contradicts (18). Therefore $u_{0} \equiv 0$.

We set

$$
r_{\epsilon}=\sqrt{\lambda_{\epsilon}} c_{\epsilon}^{-1} e^{-(2 \pi-\epsilon / 2) c_{\epsilon}^{2}}
$$

For any $0<\delta<4 \pi$, we have by using the Hölder inequality and (10),

$$
\lambda_{\epsilon}=\int_{\mathbb{B}} u_{\epsilon}^{2} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq e^{\delta c_{\epsilon}^{2}} \int_{\mathbb{B}} u_{\epsilon}^{2} e^{(4 \pi-\epsilon-\delta) u_{\epsilon}^{2}} d x \leq C e^{\delta c_{\epsilon}^{2}}
$$

for some constant $C$ depending only on $\delta$. This leads to

$$
\begin{equation*}
r_{\epsilon}^{2} \leq C c_{\epsilon}^{-2} e^{-(4 \pi-\epsilon-\delta) c_{\epsilon}^{2}} \rightarrow 0 \quad \text { as } \quad \epsilon \rightarrow 0 \tag{21}
\end{equation*}
$$

Define two blow-up sequences of functions on $\mathbb{B}_{r_{\epsilon}^{-1}}=\left\{x \in \mathbb{R}^{2}:|x|<r_{\epsilon}^{-1}\right\}$ as

$$
\psi_{\epsilon}(x)=c_{\epsilon}^{-1} u_{\epsilon}\left(r_{\epsilon} x\right), \quad \varphi_{\epsilon}(x)=c_{\epsilon}\left(u_{\epsilon}\left(r_{\epsilon} x\right)-c_{\epsilon}\right) .
$$

This kind of blow-up functions are suitable for such a problem was first discovered by AdimurthiStruwe [5]. A direct computation shows

$$
\begin{align*}
& -\Delta \psi_{\epsilon}=\frac{r_{\epsilon}^{2}}{\left(1-r_{\epsilon}^{2}|x|^{2}\right)^{2}} \psi_{\epsilon}+\alpha r_{\epsilon}^{2} \psi_{\epsilon}+c_{\epsilon}^{-2} \psi_{\epsilon} e^{(4 \pi-\epsilon)\left(1+\psi_{\epsilon}\right) \varphi_{\epsilon}} \quad \text { in } \quad \mathbb{B}_{r_{\epsilon}^{-1}}  \tag{22}\\
& -\Delta \varphi_{\epsilon}=\frac{r_{\epsilon}^{2} c_{\epsilon}^{2}}{\left(1-r_{\epsilon}^{2}|x|^{2}\right)^{2}} \psi_{\epsilon}+\alpha r_{\epsilon}^{2} c_{\epsilon}^{2} \psi_{\epsilon}+\psi_{\epsilon} e^{(4 \pi-\epsilon)\left(1+\psi_{\epsilon}\right) \varphi_{\epsilon}} \quad \text { in } \quad \mathbb{B}_{r_{\epsilon}^{-1}} \tag{23}
\end{align*}
$$

We now consider the asymptotic behavior of $\psi_{\epsilon}$ and $\varphi_{\epsilon}$. By (21), we have $r_{\epsilon}^{2} c_{\epsilon}^{q} \rightarrow 0$ as $\epsilon \rightarrow 0$ for any $q \geq 1$. Since $\mathbb{B}_{r_{\epsilon}^{-1}} \rightarrow \mathbb{R}^{2}$ as $\epsilon \rightarrow 0$, we have that $\left|\psi_{\epsilon}\right| \leq 1$ and $\Delta \psi_{\epsilon}(x) \rightarrow 0$ uniformly in $\mathbb{B}_{R}$ for any fixed $R>0$ as $\epsilon \rightarrow 0$. Applying elliptic estimates to (22), we have $\psi_{\epsilon} \rightarrow \psi$ in
$C_{\text {loc }}^{1}\left(\mathbb{R}^{2}\right)$, where $\psi$ is a bounded harmonic function in $\mathbb{R}^{2}$. Note that $\psi(0)=\lim _{\epsilon \rightarrow 0} \psi_{\epsilon}(0)=1$. The Liouville theorem implies that $\psi \equiv 1$ on $\mathbb{R}^{2}$. Hence

$$
\psi_{\epsilon} \rightarrow 1 \quad \text { in } \quad C_{\mathrm{loc}}^{1}\left(\mathbb{R}^{2}\right)
$$

Since $\varphi_{\epsilon}(x) \leq \varphi_{\epsilon}(0)=0$ for all $x \in \mathbb{B}_{r_{\epsilon}^{-1}}$, it is not difficult to see that $\Delta \varphi_{\epsilon}$ is uniformly bounded in $\mathbb{B}_{R}$ for any fixed $R>0$. We then conclude by applying elliptic estimates to the equation (23) that

$$
\begin{equation*}
\varphi_{\epsilon} \rightarrow \varphi \quad \text { in } \quad C_{\mathrm{loc}}^{1}\left(\mathbb{R}^{2}\right) \tag{24}
\end{equation*}
$$

where $\varphi$ satisfies

$$
\left\{\begin{array}{l}
\Delta \varphi=-e^{8 \pi \varphi} \quad \text { in } \quad \mathbb{R}^{2} \\
\varphi(0)=0=\sup _{\mathbb{R}^{2}} \varphi \\
\int_{\mathbb{R}^{2}} e^{8 \pi \varphi} d x \leq 1
\end{array}\right.
$$

By a result of Chen-Li [9], we have

$$
\begin{equation*}
\varphi(x)=-\frac{1}{4 \pi} \log \left(1+\pi|x|^{2}\right), \quad \int_{\mathbb{R}^{2}} e^{8 \pi \varphi} d x=1 \tag{25}
\end{equation*}
$$

Now we consider the convergence behavior of $u_{\epsilon}$ away from zero. Set $u_{\epsilon, \beta}=\min \left\{u_{\epsilon}, \beta c_{\epsilon}\right\}$ for any $\beta, 0<\beta<1$. Then we have

Lemma 7. For any $\beta, 0<\beta<1$, there holds $\lim _{\epsilon \rightarrow 0}\left\|u_{\epsilon, \beta}\right\|_{1, \alpha}^{2}=\beta$.
Proof. Note that $\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} \in W_{0}^{1,2}(\mathbb{B})$ and thus $u_{\epsilon, \beta}=u_{\epsilon}-\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} \in \mathscr{H}$. Testing the equation (8) by $u_{\epsilon, \beta}$, we have

$$
\int_{\mathbb{B}}\left(\nabla u_{\epsilon, \beta} \nabla u_{\epsilon}-\frac{u_{\epsilon, \beta} u_{\epsilon}}{\left(1-|x|^{2}\right)^{2}}-\alpha u_{\epsilon, \beta} u_{\epsilon}\right) d x=\int_{\mathbb{B}} \frac{1}{\lambda_{\epsilon}} u_{\epsilon, \beta} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x .
$$

It follows that

$$
\begin{aligned}
\left\|u_{\epsilon, \beta}\right\|_{1, \alpha}^{2}= & \int_{\mathbb{B}}\left(\nabla u_{\epsilon, \beta} \nabla u_{\epsilon}-\frac{u_{\epsilon, \beta} u_{\epsilon}}{\left(1-|x|^{2}\right)^{2}}-\alpha u_{\epsilon, \beta} u_{\epsilon}\right) d x \\
& +\int_{\mathbb{B}} \frac{u_{\epsilon, \beta}\left(u_{\epsilon}-u_{\epsilon, \beta}\right)}{\left(1-|x|^{2}\right)^{2}} d x+\alpha \int_{\mathbb{B}} u_{\epsilon, \beta}\left(u_{\epsilon}-u_{\epsilon, \beta}\right) d x \\
\geq & \int_{\mathbb{B}} \frac{1}{\lambda_{\epsilon}} u_{\epsilon, \beta} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \\
\geq & \beta \int_{\mathbb{B}_{R}(0)}\left(1+o_{\epsilon}(1)\right) e^{8 \pi \varphi} d y
\end{aligned}
$$

for any $R>0$. Letting $\epsilon \rightarrow 0$ first, and then $R \rightarrow \infty$, we obtain

$$
\liminf _{\epsilon \rightarrow 0}\left\|u_{\epsilon, \beta}\right\|_{1, \alpha}^{2} \geq \beta
$$

Similarly, testing the equation (8) by $\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+}$, we have

$$
\begin{aligned}
\left\|\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+}\right\|_{1, \alpha}^{2}= & \int_{\mathbb{B}}\left(\nabla\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} \nabla u_{\epsilon}-\frac{\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} u_{\epsilon}}{\left(1-|x|^{2}\right)^{2}}-\alpha\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} u_{\epsilon}\right) d x \\
& +\int_{\mathbb{B}} \frac{\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} u_{\epsilon, \beta}}{\left(1-|x|^{2}\right)^{2}} d x+\alpha \int_{\mathbb{B}}\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} u_{\epsilon, \beta} d x \\
\geq & \int_{\mathbb{B}} \frac{1}{\lambda_{\epsilon}}\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \\
\geq & (1-\beta) \int_{\mathbb{B}_{R}(0)}\left(1+o_{\epsilon}(1)\right) e^{8 \pi \varphi} d y .
\end{aligned}
$$

This implies that

$$
\liminf _{\epsilon \rightarrow 0}\left\|\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+}\right\|_{1, \alpha}^{2} \geq(1-\beta)
$$

Since $u_{\epsilon} \rightarrow 0$ in $L^{p}(\mathbb{B})$ as $\epsilon \rightarrow 0$ for any fixed $p>1$, one can see that

$$
\lim _{\epsilon \rightarrow 0}\left(\left\|u_{\epsilon, \beta}\right\|_{1, \alpha}^{2}+\left\|\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+}\right\|_{1, \alpha}^{2}-\left\|u_{\epsilon}\right\|_{1, \alpha}^{2}\right)=0 .
$$

Therefore

$$
\lim _{\epsilon \rightarrow 0}\left\|u_{\epsilon, \beta}\right\|_{1, \alpha}^{2}=\beta, \lim _{\epsilon \rightarrow 0}\left\|\left(u_{\epsilon}-\beta c_{\epsilon}\right)^{+}\right\|_{1, \alpha}^{2}=1-\beta
$$

This completes the proof of the lemma.

## Lemma 8. There holds

$$
\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=\pi+\limsup _{\epsilon \rightarrow 0} \frac{\lambda_{\epsilon}}{c_{\epsilon}^{2}}
$$

Proof. On one hand we have for any $\beta, 0<\beta<1$,

$$
\begin{aligned}
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x & =\int_{u_{\epsilon}<\beta c_{\epsilon}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x+\int_{u_{\epsilon} \geq \beta c_{\epsilon}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \\
& \leq \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon \beta}^{2}} d x+\frac{\lambda_{\epsilon}}{\beta^{2} c_{\epsilon}^{2}}
\end{aligned}
$$

It follows from Lemma77that $\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon \beta}^{2}} d x \rightarrow|\mathbb{B}|=\pi$ as $\epsilon \rightarrow 0$. Hence

$$
\int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \pi+\frac{\lambda_{\epsilon}}{\beta^{2} c_{\epsilon}^{2}}+o_{\epsilon}(1)
$$

Letting $\epsilon \rightarrow 0$ first, then $\beta \rightarrow 1$ in the above inequality, we get

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \pi+\limsup _{\epsilon \rightarrow 0} \frac{\lambda_{\epsilon}}{c_{\epsilon}^{2}} \tag{26}
\end{equation*}
$$

On the other hand we have by (24)

$$
\int_{\mathbb{B}_{R_{\epsilon}}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=\frac{\lambda_{\epsilon}}{c_{\epsilon}^{2}}\left(\int_{10} e_{\mathbb{B}_{R}}^{8 \pi \varphi} d x+o_{\epsilon}(1)\right)
$$

It is easy to see that

$$
\int_{\mathbb{B}_{R r_{\epsilon}}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x-\pi\left(1-R^{2} r_{\epsilon}^{2}\right)
$$

Combining the above two estimates and letting $\epsilon \rightarrow 0$ first, then $R \rightarrow+\infty$, we have

$$
\begin{equation*}
\limsup _{\epsilon \rightarrow 0} \frac{\lambda_{\epsilon}}{c_{\epsilon}^{2}} \leq \lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x-\pi \tag{27}
\end{equation*}
$$

Combining (26) and (27), we get the desired result.
Obviously Lemma 8 implies that

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} c_{\epsilon} / \lambda_{\epsilon}=0 . \tag{28}
\end{equation*}
$$

(Here and in the sequel we do not distinguish sequence and subsequence.) This will be used to prove the following:

Lemma 9. $\forall \phi \in C^{\infty}(\overline{\mathbb{B}})$, we have

$$
\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} \phi \frac{1}{\lambda_{\epsilon}} c_{\epsilon} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=\phi(0)
$$

Proof. For any fixed $\beta, 0<\beta<1$, we divide $\mathbb{B}$ into three parts

$$
\mathbb{B}=\left(\left\{u_{\epsilon}>\beta c_{\epsilon}\right\} \backslash \mathbb{B}_{R r_{\epsilon}}\right) \cup\left(\left\{u_{\epsilon} \leq \beta c_{\epsilon}\right\} \backslash \mathbb{B}_{R r_{\epsilon}}\right) \cup \mathbb{B}_{R r_{\epsilon}} .
$$

Denote the integrals on the above three domains by $I_{1}, I_{2}$ and $I_{3}$ respectively. Firstly we have

$$
\begin{aligned}
\left|I_{1}\right| & \leq \sup _{\mathbb{B}}|\phi| \int_{\left\{u_{\epsilon}>\beta c_{\epsilon}\right\} \backslash \mathbb{B}_{R r_{\epsilon}}} \frac{1}{\lambda_{\epsilon}} c_{\epsilon} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \\
& \leq \frac{1}{\beta} \sup _{\mathbb{B}}|\phi|\left(1-\int_{\mathbb{B}_{R r_{\epsilon}}} \frac{1}{\lambda_{\epsilon}} u_{\epsilon}^{2} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x\right) \\
& =\frac{1}{\beta} \sup _{\mathbb{B}}|\phi|\left(1-\int_{\mathbb{B}_{R}} e^{8 \pi \varphi} d x+o_{\epsilon}(R)\right),
\end{aligned}
$$

where $o_{\epsilon}(R) \rightarrow 0$ as $\epsilon \rightarrow 0$ for any fixed $R>0$. Letting $\epsilon \rightarrow 0$ first, then $R \rightarrow+\infty$, we have $I_{1} \rightarrow 0$. Secondly there holds

$$
\left|I_{2}\right| \leq \sup _{\mathbb{B}}|\phi| \frac{c_{\epsilon}}{\lambda_{\epsilon}} \int_{\mathbb{B}} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon \beta}^{2}} d x .
$$

It follows from Lemma 7 and (28) that $I_{2} \rightarrow 0$ as $\epsilon \rightarrow 0$ first and then $R \rightarrow+\infty$.
Finally we can easily see that

$$
I_{3}=\phi(\xi)\left(\int_{\mathbb{B}_{R}} e^{8 \pi \varphi} d x+o_{\epsilon}(R)\right)
$$

for some $\xi \in \mathbb{B}_{R r_{\epsilon}}$. Letting $\epsilon \rightarrow 0$ first, then $R \rightarrow+\infty$, we have $I_{3} \rightarrow \phi(0)$. Combining all the above estimates, we finish the proof of the lemma.

For simplicity we denote

$$
\mathscr{L}_{\alpha}=-\Delta-\frac{1}{\left(1-|x|^{2}\right)^{2}}-\alpha .
$$

Then we have the following:
Lemma 10. The function sequence $c_{\epsilon} u_{\epsilon}$ converges to $G$ weakly in $W_{\mathrm{loc}}^{1, p}(\mathbb{B})$ for any $p \in(1,2)$, strongly in $L^{q}(\mathbb{B})$ for any $q \geq 1$, and in $C^{0}\left(\overline{\mathbb{B}_{r}^{c}}\right)$ for any $r \in(0,1)$, where $G$ is a Green function satisfying $\mathscr{L}_{\alpha} G=\delta_{0}$, where $\delta_{0}$ is the usual Dirac measure centered at $0 \in \mathbb{B}$.

Proof. Note that

$$
\mathscr{L}_{\alpha}\left(c_{\epsilon} u_{\epsilon}\right)=f_{\epsilon}=\frac{1}{\lambda_{\epsilon}} c_{\epsilon} u_{\epsilon} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} .
$$

Let $v_{\epsilon}$ be a solution to

$$
\left\{\begin{array}{l}
\mathscr{L}_{\alpha} v_{\epsilon}=f_{\epsilon} \quad \text { in } \quad \mathbb{B}_{1 / 2}  \tag{29}\\
v_{\epsilon}=0 \quad \text { on } \quad \partial \mathbb{B}_{1 / 2}
\end{array}\right.
$$

By Lemma $9, f_{\epsilon}$ is bounded in $L^{1}(\mathbb{B})$. By a result of Struwe [26], for any $q, 1<q<2$, there holds

$$
\begin{equation*}
\left\|\nabla v_{\epsilon}\right\|_{q} \leq C\left\|f_{\epsilon}\right\|_{1}, \tag{30}
\end{equation*}
$$

and there exists some $v_{0} \in W_{0}^{1, q}\left(\mathbb{B}_{1 / 2}\right)$ such that

$$
\begin{equation*}
v_{\epsilon} \rightharpoonup v_{0} \quad \text { weakly in } \quad W_{0}^{1, q}\left(\mathbb{B}_{1 / 2}\right) \tag{31}
\end{equation*}
$$

Take a cut-off function $\phi \in C_{0}^{\infty}(\mathbb{B})$ satisfying $0 \leq \phi \leq 1, \phi \equiv 1$ on $\mathbb{B}_{1 / 8}$ and $\phi \equiv 0$ outside $\mathbb{B}_{1 / 4}$. Set $w_{\epsilon}=c_{\epsilon} u_{\epsilon}-\phi v_{\epsilon}$. It follows that

$$
\mathscr{L}_{\alpha} w_{\epsilon}=(1-\phi) f_{\epsilon}+\Delta \phi v_{\epsilon}+2 \nabla \phi \nabla v_{\epsilon} .
$$

By (28) and Lemma3, $f_{\epsilon}$ is uniformly bounded in $\mathbb{B} \backslash \mathbb{B}_{1 / 16}$. While (30) and the Sobolev embedding theorem imply that $v_{\epsilon}$ is bounded in $L^{2}\left(\mathbb{B}_{1 / 2}\right)$. Then applying elliptic estimates to (29), we conclude that $v_{\epsilon}$ is bounded in $W^{2,2}\left(\mathbb{B}_{1 / 4} \backslash \mathbb{B}_{1 / 8}\right)$, and thus $\nabla \phi \nabla v_{\epsilon}$ is bounded in $L^{2}(\mathbb{B})$. Therefore $\mathscr{L}_{\alpha} w_{\epsilon}$ is bounded in $L^{2}(\mathbb{B})$. Recalling Lemma 3, we have

$$
\left\|w_{\epsilon}\right\|_{1, \alpha}^{2}=\left\langle w_{\epsilon}, \mathscr{L}_{\alpha} w_{\epsilon}\right\rangle_{L^{2}} \leq C\left\|w_{\epsilon}\right\|_{1, \alpha}\left\|\mathscr{L}_{\alpha} w_{\epsilon}\right\|_{2} .
$$

This implies that $w_{\epsilon}$ is bounded in $\mathscr{H}$ and there exists some $w_{0} \in \mathscr{H}$ such that

$$
\begin{equation*}
w_{\epsilon} \rightharpoonup w_{0} \quad \text { weakly in } \mathscr{H} . \tag{32}
\end{equation*}
$$

Let $G=\phi v_{0}+w_{0}$. Here we extend $v_{0}$ to be zero in $\mathbb{B} \backslash \mathbb{B}_{1 / 2}$. It follows from (31) and Lemma 3 that $c_{\epsilon} u_{\epsilon} \rightarrow G$ in $L^{p}(\mathbb{B})$ for any $p \geq 1$ and in $C^{0}\left(\mathbb{B} \backslash \mathbb{B}_{r}\right)$ for any $r>0$. Moreover we have

$$
\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} c_{\epsilon} u_{\epsilon} \mathscr{L}_{\alpha} \varphi d x=\int_{\mathbb{B}} G \mathscr{L}_{\alpha} \varphi d x, \quad \forall \varphi \in C_{0}^{\infty}(\mathbb{B}) .
$$

This together with Lemma 9 finishes the proof of the lemma.

Before ending this subsection, we decompose the Green function $G$. Since

$$
-\Delta\left(G+\frac{1}{2 \pi} \log r\right)=\frac{G}{\left(1-|x|^{2}\right)^{2}}+\alpha G \in L_{\mathrm{loc}}^{p}(\mathbb{B}),
$$

there holds

$$
\begin{equation*}
G=-\frac{1}{2 \pi} \log r+A_{0}+\widetilde{\psi} \tag{33}
\end{equation*}
$$

where $\tilde{\psi} \in C_{\mathrm{loc}}^{1}(\mathbb{B})$.

### 3.3. Neck analysis and upper bound estimate

In this subsection, we use the capacity estimate due to Y. Li [15] to derive an upper bound of the supremum in (4). While in [29], this was done by G. Wang and D. Ye by using a result of Carleson-Chang [10], which was employed originally by Li-Liu-Yang [16] when deriving an upper bound of certain Trudinger-Moser functional for vector bundles on a compact Riemannian surface.

Lemma 11. For any $r, 0<r<1$, there holds

$$
\int_{\mathbb{B}_{r}}\left|\nabla u_{\epsilon}\right|^{2} d x=1+\frac{1}{c_{\epsilon}^{2}}\left(\frac{1}{2 \pi} \log r-A_{0}+o_{r}(1)+o_{\epsilon}(1)\right),
$$

where $o_{\epsilon}(1) \rightarrow 0$ as $\epsilon \rightarrow 0, o_{r}(1) \rightarrow 0$ as $r \rightarrow 0$.
Proof. In view of the Euler-Lagrange equation (8), we have by using the divergence theorem

$$
\begin{aligned}
\int_{\mathbb{B}_{r}}\left|\nabla u_{\epsilon}\right|^{2} d x & =-\int_{\mathbb{B}_{r}} u_{\epsilon} \Delta u_{\epsilon} d x+\int_{\partial \mathbb{B}_{r}} u_{\epsilon} \frac{\partial u_{\epsilon}}{\partial v} d s \\
& =\int_{\mathbb{B}_{r}} u_{\epsilon} \mathscr{L}_{\alpha} u_{\epsilon} d x+\int_{\partial \mathbb{B}_{r}} u_{\epsilon} \frac{\partial u_{\epsilon}}{\partial v} d s+\int_{\mathbb{B}_{r}} \frac{u_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}} d x+\alpha \int_{\mathbb{B}_{r}} u_{\epsilon}^{2} d x \\
& =\int_{\mathbb{B}_{r}} \frac{u_{\epsilon}^{2}}{\lambda_{\epsilon}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x+\int_{\partial \mathbb{B}_{r}} u_{\epsilon} \frac{\partial u_{\epsilon}}{\partial v} d s+\int_{\mathbb{B}_{r}} \frac{u_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}} d x+\alpha \int_{\mathbb{B}_{r}} u_{\epsilon}^{2} d x .
\end{aligned}
$$

Now we estimate the above four integrals respectively. It follows from Lemma 10 and (28) that

$$
\int_{\mathbb{B}_{r}} \frac{u_{\epsilon}^{2}}{\lambda_{\epsilon}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=1-\frac{1}{c_{\epsilon}^{2}} \int_{\mathbb{B} \backslash \mathbb{B}_{r}} \frac{\left(c_{\epsilon} u_{\epsilon}\right)^{2}}{\lambda_{\epsilon}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x=1-\frac{1}{c_{\epsilon}^{2}} o_{\epsilon}(1) .
$$

Moreover, Lemma 10 and (33) lead to

$$
\begin{gathered}
\int_{\partial \mathbb{B}_{r}} u_{\epsilon} \frac{\partial u_{\epsilon}}{\partial v} d s=\frac{1}{c_{\epsilon}^{2}}\left(\int_{\partial \mathbb{B}_{r}} G \frac{\partial G}{\partial r} d s+o_{\epsilon}(1)\right)=\frac{1}{c_{\epsilon}^{2}}\left(\frac{1}{2 \pi} \log r-A_{0}+o_{r}(1)\right), \\
\int_{\mathbb{B}_{r}} \frac{u_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}} d x=\frac{1}{c_{\epsilon}^{2}}\left(\int_{\mathbb{B}_{r}} \frac{G^{2}}{\left(1-|x|^{2}\right)^{2}} d x+o_{\epsilon}(1)\right)=\frac{o_{r}(1)+o_{\epsilon}(1)}{c_{\epsilon}^{2}},
\end{gathered}
$$

and

$$
\int_{\mathbb{B}_{r}} u_{\epsilon}^{2} d x=\frac{1}{c_{\epsilon}^{2}}\left(\int_{\mathbb{B}_{r}} G^{2} d x+o_{\epsilon}(1)\right)=\frac{o_{r}(1)+o_{\epsilon}(1)}{c_{\epsilon}^{2}} .
$$

Combining all the above estimates, we finish the proof of the lemma.

Lemma 12. For two positive numbers $\delta$ and $R$ with $\delta>R r_{\epsilon}$, there holds

$$
\int_{\mathbb{B}_{\delta} \backslash \mathbb{B}_{R_{\epsilon}}}\left|\nabla u_{\epsilon}\right|^{2} d x=1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{2 \pi}+\frac{\log \delta}{2 \pi}-\frac{\log \pi}{4 \pi}+\frac{1}{4 \pi}-A_{0}+o_{\delta}(1)+O\left(\frac{1}{R^{2}}\right)+o_{\epsilon}(1)\right) .
$$

Proof. By (24) and (25), we have

$$
\begin{aligned}
\int_{\mathbb{B}_{R r_{\epsilon}}}\left|\nabla u_{\epsilon}\right|^{2} d x & =\frac{1}{c_{\epsilon}^{2}}\left(\int_{\mathbb{B}_{R}}|\nabla \varphi(y)|^{2} d y+o_{\epsilon}(1)\right) \\
& =\frac{1}{c_{\epsilon}^{2}}\left(\frac{\log R}{2 \pi}+\frac{\log \pi}{4 \pi}-\frac{1}{4 \pi}+O\left(\frac{1}{R^{2}}\right)+o_{\epsilon}(1)\right)
\end{aligned}
$$

This together with Lemma 11 implies the lemma.
Let $0<s<r<1$ and $a, b \in \mathbb{R}$. The function $h: \mathbb{B}_{r} \backslash \mathbb{B}_{s} \rightarrow \mathbb{R}$ defined by

$$
h(x)=\frac{b \log \frac{|x|}{s}+a \log \frac{r}{|x|}}{\log \frac{r}{s}},
$$

is harmonic on the planar domain $\mathbb{B}_{r} \backslash \mathbb{B}_{s}$. Obviously $h$ has boundary values

$$
\left.h\right|_{\partial \mathbb{B}_{s}}=a,\left.\quad h\right|_{\partial \mathbb{B}_{r}}=b
$$

Moreover we have

$$
\begin{equation*}
\int_{\mathbb{B}_{r} \backslash \mathbb{B}_{s}}|\nabla h|^{2} d x=\frac{2 \pi(b-a)^{2}}{\log \frac{r}{s}} . \tag{34}
\end{equation*}
$$

Define a function space associated with $h$ as

$$
\mathcal{W}=\mathcal{W}(h, r, s)=\left\{u \in W^{1,2}\left(\mathbb{B}_{r} \backslash \mathbb{B}_{s}\right) \mid u-h \in W_{0}^{1,2}\left(\mathbb{B}_{r} \backslash \mathbb{B}_{s}\right)\right\} .
$$

By a variational direct method, one can see that the infimum

$$
\inf _{u \in \mathcal{W}} \int_{\mathbb{B}_{r} \backslash \mathbb{B}_{s}}|\nabla u|^{2} d x
$$

can be attained by the above harmonic function $h$. In fact we have proved the following:
Lemma 13. Let $0<s<r<1, a, b \in \mathbb{R}$, and $h, \mathcal{W}$ be given as above. There holds

$$
\inf _{u \in \mathcal{W}} \int_{\mathbb{B}_{r} \backslash \mathbb{B}_{s}}|\nabla u|^{2} d x=\frac{2 \pi(b-a)^{2}}{\log \frac{r}{s}}
$$

This lemma can be used to derive the following:
Lemma 14. Assume $0<\delta<1, R>0$ and $\epsilon$ is sufficiently small. Then there holds

$$
\int_{\mathbb{B}_{\delta} \backslash \mathbb{B}_{R_{\epsilon}}}\left|\nabla u_{\epsilon}\right|^{2} d x \geq \frac{2 \pi\left(b_{\epsilon}-a_{\epsilon}\right)^{2}}{\log \frac{\delta}{R r_{\epsilon}}}
$$

where $a_{\epsilon}$ and $b_{\epsilon}$ are defined as

$$
\begin{aligned}
& a_{\epsilon}=u_{\epsilon} \left\lvert\, \partial \mathbb{B}_{R r \epsilon}=c_{\epsilon}+\frac{1}{c_{\epsilon}}\left(-\frac{1}{2 \pi} \log R-\frac{1}{4 \pi} \log \pi+O\left(\frac{1}{R^{2}}\right)+o_{\epsilon}(1)\right)\right., \\
& b_{\epsilon}=\left.u_{\epsilon}\right|_{\partial \mathbb{B}_{\delta}}=\frac{1}{c_{\epsilon}}\left(-\frac{1}{2 \pi} \log \delta+A_{0}+o_{\delta}(1)+o_{\epsilon}(1)\right) .
\end{aligned}
$$

Proof. Substitute $a_{\epsilon}, b_{\epsilon}, R r_{\epsilon}$ and $\delta$ for $a, b, s$ and $r$ respectively in Lemma 13. Let

$$
h_{\epsilon}(x)=\frac{b_{\epsilon} \log \frac{|x|}{R r_{\epsilon}}+a_{\epsilon} \log \frac{\delta}{|x|}}{\log \frac{\delta}{R r_{\epsilon}}} .
$$

Then $\left.h_{\epsilon}\right|_{\partial \mathbb{B}_{R r_{\epsilon}}}=u_{\epsilon} \mid \partial \mathbb{B}_{R r_{\epsilon}}$ and $\left.h_{\epsilon}\right|_{\partial \mathbb{B}_{\delta}}=\left.u_{\epsilon}\right|_{\mathbb{B}}$. . Hence we have $u_{\epsilon}-h_{\epsilon} \in W_{0}^{1,2}\left(\mathbb{B}_{\delta} \backslash \mathbb{B}_{R r_{\epsilon}}\right)$ and

$$
\int_{\mathbb{B}_{\delta} \backslash \mathbb{B}_{R r \epsilon}}\left|\nabla u_{\epsilon}\right|^{2} d x \geq \inf _{v \in \mathcal{W}\left(h_{\epsilon}, \delta, R r_{\epsilon}\right)} \int_{\mathbb{B}_{\delta} \backslash \mathbb{B}_{R r \epsilon}}|\nabla v|^{2} d x=\int_{\mathbb{B}_{\delta} \backslash \mathbb{B}_{R r \epsilon}}\left|\nabla h_{\epsilon}\right|^{2} d x .
$$

This together with an obvious analog of (34) concludes the lemma.
A straightforward calculation shows

$$
\begin{align*}
2 \pi\left(b_{\epsilon}-a_{\epsilon}\right)^{2} & =2 \pi\left\{c_{\epsilon}+\frac{1}{c_{\epsilon}}\left(-\frac{1}{2 \pi} \log R+\frac{1}{2 \pi} \log \delta-\frac{1}{4 \pi} \log \pi-A_{0}+o(1)\right)\right\}^{2} \\
& =2 \pi c_{\epsilon}^{2}\left\{1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{1}{\pi} \log R+\frac{1}{\pi} \log \delta-\frac{1}{2 \pi} \log \pi-2 A_{0}+o(1)\right)\right\} \tag{35}
\end{align*}
$$

Here and in the sequel $o(1) \rightarrow 0$ as $\epsilon \rightarrow 0$ first, then $R \rightarrow+\infty$, and finally $\delta \rightarrow 0$. Also we have

$$
\begin{equation*}
\log \frac{\delta}{R r_{\epsilon}}=\log \delta-\log R-\log \frac{\sqrt{\lambda_{\epsilon}}}{c_{\epsilon}}+(2 \pi-\epsilon / 2) c_{\epsilon}^{2} \tag{36}
\end{equation*}
$$

Combining Lemma 12, Lemma (14, (35) and (36), we obtain

$$
\begin{aligned}
& 1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{2 \pi}+\frac{\log \delta}{2 \pi}-\frac{\log \pi}{4 \pi}+\frac{1}{4 \pi}-A_{0}+o(1)\right) \\
& \geq \frac{1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{\pi}+\frac{\log \delta}{\pi}-\frac{\log \pi}{2 \pi}-2 A_{0}+o(1)\right)}{1-\frac{\epsilon}{4 \pi}+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{2 \pi}+\frac{\log \delta}{2 \pi}-\frac{1}{2 \pi} \log \frac{\sqrt{\lambda_{\epsilon}}}{c_{\epsilon}}\right)} .
\end{aligned}
$$

This leads to

$$
\begin{aligned}
& 1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{\pi}+\frac{\log \delta}{\pi}-\frac{\log \pi}{4 \pi}+\frac{1}{4 \pi}-A_{0}-\frac{1}{2 \pi} \log \frac{\sqrt{\lambda_{\epsilon}}}{c_{\epsilon}}+o(1)\right) \\
& \geq 1+\frac{1}{c_{\epsilon}^{2}}\left(-\frac{\log R}{\pi}+\frac{\log \delta}{\pi}-\frac{\log \pi}{2 \pi}-2 A_{0}+o(1)\right) .
\end{aligned}
$$

It then follows that

$$
\frac{1}{2 \pi} \log \frac{\sqrt{\lambda_{\epsilon}}}{c_{\epsilon}} \leq \frac{\log \pi}{4 \pi}+\frac{1}{4 \pi}+A_{0}+o(1)
$$

Therefore

$$
\frac{\lambda_{\epsilon}}{c_{\epsilon}^{2}} \leq \pi e^{1+4 \pi A_{0}+o(1)}
$$

This together with Lemma 8 implies the following:
Proposition 15. Under the assumption that $c_{\epsilon}=\max _{\mathbb{B}} u_{\epsilon} \rightarrow+\infty$ as $\epsilon \rightarrow 0$, there holds

$$
\begin{equation*}
\sup _{u \in \mathscr{H},\|u\|_{1, \alpha} \leq 1} \int_{\mathbb{B}} e^{4 \pi u^{2}} d x=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{B}} e^{(4 \pi-\epsilon) u_{\epsilon}^{2}} d x \leq \pi+\pi e^{1+4 \pi A_{0}} \tag{37}
\end{equation*}
$$

### 3.4. Test function computation

In this subsection, we construct a sequence of test functions $\phi_{\epsilon} \in \mathscr{H}$ such that $\left\|\phi_{\epsilon}\right\|_{1, \alpha} \leq 1$ and if $\epsilon$ is chosen sufficiently small, there holds

$$
\begin{equation*}
\int_{\mathbb{B}} e^{4 \pi \phi_{\epsilon}^{2}} d x>\pi+\pi e^{1+4 \pi A_{0}} \tag{38}
\end{equation*}
$$

By Proposition 15 this would contradicts (37) unless $c_{\epsilon}$ is bounded. Therefore we get the desired extremal function and complete the proof of Theorem 1 .

We set

$$
\phi_{\epsilon}(x)= \begin{cases}c+\frac{-\frac{1}{4 \pi} \log \left(1+\pi \frac{\left|x^{2}\right|^{2}}{\epsilon^{2}}\right)+B}{c} & \text { for } \quad|x| \leq R \epsilon  \tag{39}\\ \frac{G(x)}{c} & \text { for } \quad R \epsilon<|x| \leq 1\end{cases}
$$

where $R=-\log \epsilon, B$ and $c$ are constants to be determined later. We now require

$$
\begin{equation*}
c+\frac{1}{c}\left(-\frac{1}{4 \pi} \log \left(1+\pi R^{2}\right)+B\right)=\left.\frac{1}{c} G\right|_{\partial \mathbb{B}_{R \epsilon}}=\frac{1}{c}\left(-\frac{1}{2 \pi} \log (R \epsilon)+A_{0}+O(R \epsilon)\right), \tag{40}
\end{equation*}
$$

which gives

$$
\begin{equation*}
2 \pi c^{2}=-\log \epsilon-2 \pi B+2 \pi A_{0}+\frac{1}{2} \log \pi+O\left(\frac{1}{R^{2}}\right) . \tag{41}
\end{equation*}
$$

Clearly, (39) and (40) imply that $\phi_{\epsilon} \in W_{\text {loc }}^{1,2}(\mathbb{B})$. While in view of (32), $G$ coincides with $w_{0} \in \mathscr{H}$ on $\mathbb{B} \backslash \mathbb{B}_{1 / 2}$. Hence $\phi_{\epsilon}-w_{0} / c \in W_{0}^{1,2}(\mathbb{B})$, which immediately leads to the fact that $\phi_{\epsilon} \in \mathscr{H}$.

Since $\phi_{\epsilon} \in \mathscr{H}$, we have by integration by parts, Lemma 10 and (33) that

$$
\begin{aligned}
\int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}}\left(\left|\nabla \phi_{\epsilon}\right|^{2}-\frac{\phi_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}}-\alpha \phi_{\epsilon}^{2}\right) d x & =\frac{1}{c^{2}} \int_{\partial \mathbb{B}_{R \epsilon}} G \frac{\partial G}{\partial v} d s+\frac{1}{c^{2}} \int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}} G \mathscr{L}_{\alpha} G d x \\
& =\frac{1}{c^{2}}\left(-\frac{1}{2 \pi} \log (R \epsilon)+A_{0}+O\left(\frac{1}{R^{2}}\right)\right) .
\end{aligned}
$$

Also a straightforward calculation gives

$$
\int_{\mathbb{B}_{R \epsilon}}\left|\nabla \phi_{\epsilon}\right|^{2} d x=\frac{1}{c^{2}}\left(\frac{\log R}{2 \pi}+\frac{\log \pi}{4 \pi}-\frac{1}{4 \pi}+O\left(\frac{1}{R^{2}}\right)\right) .
$$

Hence

$$
\begin{aligned}
\left\|\phi_{\epsilon}\right\|_{1, \alpha}^{2} & \leq \int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}}\left(\left|\nabla \phi_{\epsilon}\right|^{2}-\frac{\phi_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}}-\alpha \phi_{\epsilon}^{2}\right) d x+\int_{\mathbb{B}_{R \epsilon}}\left|\nabla \phi_{\epsilon}\right|^{2} d x \\
& =\frac{1}{c^{2}}\left(-\frac{1}{2 \pi} \log \epsilon+A_{0}+\frac{\log \pi}{4 \pi}-\frac{1}{4 \pi}+O\left(\frac{1}{R^{2}}\right)\right) .
\end{aligned}
$$

We set

$$
\int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}}\left(\left|\nabla \phi_{\epsilon}\right|^{2}-\frac{\phi_{\epsilon}^{2}}{\left(1-|x|^{2}\right)^{2}}-\alpha \phi_{\epsilon}^{2}\right) d x+\int_{\mathbb{B}_{R \epsilon}}\left|\nabla \phi_{\epsilon}\right|^{2} d x=1
$$

which implies $\left\|\phi_{\epsilon}\right\|_{1, \alpha} \leq 1$ and

$$
\begin{equation*}
2 \pi c^{2}=-\log \epsilon+2 \pi A_{0}+\frac{1}{2} \log \pi-\frac{1}{2}+O\left(\frac{1}{R^{2}}\right) \tag{42}
\end{equation*}
$$

Combining (41) and (42), we obtain

$$
\begin{equation*}
B=\frac{1}{4 \pi}+O\left(\frac{1}{R^{2}}\right) . \tag{43}
\end{equation*}
$$

We now derive the estimate (38). It is clear that

$$
\begin{aligned}
\int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}} e^{4 \pi \phi_{\epsilon}^{2}} d x & \geq \int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}}\left(1+4 \pi \phi_{\epsilon}^{2}\right) d x \\
& =\pi+\frac{4 \pi}{c^{2}}\left(\int_{\mathbb{B}} G^{2} d x+O\left(\frac{1}{R^{2}}\right)\right) .
\end{aligned}
$$

By (42) and (43), there holds on $\mathbb{B}_{R \epsilon}$,

$$
\begin{aligned}
\phi_{\epsilon}^{2} & \geq c^{2}+2 B-\frac{1}{2 \pi} \log \left(1+\pi \frac{|x|^{2}}{\epsilon^{2}}\right) \\
& =-\frac{1}{2 \pi} \log \left(1+\pi \frac{|x|^{2}}{\epsilon^{2}}\right)-\frac{1}{2 \pi} \log \epsilon+A_{0}+\frac{\log \pi}{4 \pi}+\frac{1}{4 \pi}+O\left(\frac{1}{R^{2}}\right) .
\end{aligned}
$$

This leads to

$$
\begin{aligned}
\int_{\mathbb{B}_{R \epsilon}} e^{4 \pi \phi_{\epsilon}^{2}} d x & \geq e^{1+4 \pi A_{0}+\log \pi+O\left(\frac{1}{R^{2}}\right)} \int_{\mathbb{B}_{R}} \frac{1}{\left(1+\pi|x|^{2}\right)^{2}} d x \\
& =\pi e^{1+4 \pi A_{0}}\left(1+O\left(\frac{1}{R^{2}}\right)\right) .
\end{aligned}
$$

Since $1 / R^{2}=o\left(1 / c^{2}\right)$, we obtain

$$
\begin{aligned}
\int_{\mathbb{B}} e^{4 \pi \phi_{\epsilon}^{2}} d x & =\int_{\mathbb{B} \backslash \mathbb{B}_{R \epsilon}} e^{4 \pi \phi_{\epsilon}^{2}} d x+\int_{\mathbb{B}_{R \epsilon}} e^{4 \pi \phi_{\epsilon}^{2}} d x \\
& \geq \pi+\pi e^{1+4 \pi A_{0}}+\frac{4 \pi}{c^{2}}\left(\int_{\mathbb{B}} G^{2} d x+o(1)\right) .
\end{aligned}
$$

This gives the desired estimate (38) provided that $\epsilon$ is sufficiently small.
