# HARVEY LAWSON MANIFOLDS AND DUALITIES

#### Abstract

The purpose of this paper is to introduce Harvey-Lawson manifolds and review the construction of certain "mirror dual" Calabi-Yau submanifolds inside a $G_{2}$ manifold. More specifically, given a Harvey-Lawson manifold $H L$, we explain how to assign a pair of tangent bundle valued 2 and 3 -forms to a $G_{2}$ manifold ( $M, H L, \varphi, \Lambda$ ), with the calibration 3 -form $\varphi$ and an oriented 2-plane field $\Lambda$. As in AS2 these forms can then be used to define different complex and symplectic structures on certain 6 -dimensional subbundles of $T(M)$. When these bundles are integrated they give mirror CY manifolds (related thru HL manifolds).


## 1. Introduction

Let $\left(M^{7}, \varphi\right)$ be a $G_{2}$ manifold with the calibration 3 -form $\varphi$. If $\varphi$ restricts to be the volume form of an oriented 3-dimensional submanifold $Y^{3}$, then $Y$ is called an associative submanifold of $M$. In [AS2] the authors introduced a notion of mirror duality in any $G_{2}$ manifold $\left(M^{7}, \varphi\right)$ based on the associative/coassociative splitting of its tangent bundle $T M=\mathbb{E} \oplus \mathbb{V}$ by the non-vanishing 2 -fame fields provided by [T]. This duality initially depends on the choice of two non-vanishing vector fields, one in $\mathbb{E}$ and the other in $\mathbb{V}$. In this article we give a natural form of this duality where the choice of these vector fields are made more canonical, in the expense of possibly localizing this process to the tubular neighborhood of the 3 -skeleton of $(M, \varphi)$.

## 2. Basic Definitions

Let us recall some basic facts about $G_{2}$ manifolds (e.g. [B1], [HL, AS1]). Octonions give an 8 dimensional division algebra $\mathbb{O}=\mathbb{H} \oplus l \mathbb{H}=\mathbb{R}^{8}$ generated by $\langle 1, i, j, k, l, l i, l j, l k\rangle$. The imaginary octonions $\operatorname{im} \mathbb{O}=\mathbb{R}^{7}$ is equipped with the cross product operation $\times: \mathbb{R}^{7} \times \mathbb{R}^{7} \rightarrow \mathbb{R}^{7}$ defined by $u \times v=i m(\bar{v} . u)$. The exceptional Lie group $G_{2}$ is the linear automorphisms of $\operatorname{im}(\mathbb{O}$ preserving this cross product. Alternatively:

where $\varphi_{0}=e^{123}+e^{145}+e^{167}+e^{246}-e^{257}-e^{347}-e^{356}$ with $e^{i j k}=d x^{i} \wedge d x^{j} \wedge d x^{k}$. We say a 7 -manifold $M^{7}$ has a $G_{2}$ structure if there is a 3 -form $\varphi \in \Omega^{3}(M)$ such that at each $p \in M$ the pair $\left(T_{p}(M), \varphi(p)\right)$ is (pointwise) isomorphic to $\left(T_{0}\left(\mathbb{R}^{7}\right), \varphi_{0}\right)$. This condition is equivalent to reducing the tangent frame bundle of $M$ from $G L(7, \mathbb{R})$ to $G_{2}$. A manifold with $G_{2}$ structure $(M, \varphi)$ is called a $G_{2}$ manifold (integrable $G_{2}$ structure) if at each point $p \in M$ there is a chart $(U, p) \rightarrow\left(\mathbb{R}^{7}, 0\right)$ on which $\varphi$ equals to $\varphi_{0}$ up to second order term, i.e. on the image of the open set $U$ we can write $\varphi(x)=\varphi_{0}+O\left(|x|^{2}\right)$.

One important class of $G_{2}$ manifolds are the ones obtained from Calabi-Yau manifolds. Let $(X, \omega, \Omega)$ be a complex 3 -dimensional Calabi-Yau manifold with Kähler form $\omega$ and a nowhere vanishing holomorphic 3-form $\Omega$, then $X^{6} \times S^{1}$ has holonomy group $S U(3) \subset G_{2}$, hence is a $G_{2}$ manifold. In this case $\varphi=\operatorname{Re} \Omega+\omega \wedge d t$. Similarly, $X^{6} \times \mathbb{R}$ gives a noncompact $G_{2}$ manifold.

Definition 1. Let $(M, \varphi)$ be a $G_{2}$ manifold. A 4-dimensional submanifold $X \subset M$ is called coassociative if $\left.\varphi\right|_{X}=0$. A 3-dimensional submanifold $Y \subset M$ is called associative if $\left.\varphi\right|_{Y} \equiv \operatorname{vol}(Y)$; this condition is equivalent to the condition $\left.\chi\right|_{Y} \equiv 0$, where $\chi \in \Omega^{3}(M, T M)$ is the tangent bundle valued 3-form defined by the identity:

The equivalence of these conditions follows from the 'associator equality' of HL

$$
\varphi(u, v, w)^{2}+|\chi(u, v, w)|^{2} / 4=|u \wedge v \wedge w|^{2}
$$

Similar to the definition of $\chi$ one can define a tangent bundle 2-form, which is just the cross product of $M$ (nevertheless viewing it as a 2 -form has its advantages).

Definition 2. Let $(M, \varphi)$ be a $G_{2}$ manifold. Then $\psi \in \Omega^{2}(M, T M)$ is the tangent bundle valued 2-form defined by the identity:

\langle\psi(u, v), w\rangle=\varphi(u, v, w)=\langle u \times v, w\rangle \tag{4}
\end{equation*}

On a local chart of a $G_{2}$ manifold $(M, \varphi)$, the form $\varphi$ coincides with the form $\varphi_{0} \in \Omega^{3}\left(\mathbb{R}^{7}\right)$ up to quadratic terms, we can express the tangent valued forms $\chi$ and $\psi$ in terms of $\varphi_{0}$ in local coordinates. More generally, if $e_{1}, \ldots e_{7}$ is any local orthonormal frame and $e^{1}, \ldots, e^{7}$ is the dual frame, from definitions we get:

Here are some useful facts :
Lemma 1. (AS1) To any 3-dimensional submanifold $Y^{3} \subset(M, \varphi), \chi$ assigns a normal vector field, which vanishes when $Y$ is associative.

Lemma 2. (AS1]) To any associative manifold $Y^{3} \subset(M, \varphi)$ with a non-vanishing oriented 2-plane field, $\chi$ defines a complex structure on its normal bundle (notice in particular that any coassociative submanifold $X \subset M$ has an almost complex structure if its normal bundle has a non-vanishing section).

Proof. Let $L \subset \mathbb{R}^{7}$ be an associative 3-plane, that is $\left.\varphi_{0}\right|_{L}=\operatorname{vol}(L)$. Then for every pair of orthonormal vectors $\{u, v\} \subset L$, the form $\chi$ defines a complex structure on the orthogonal 4-plane $L^{\perp}$, as follows: Define $j: L^{\perp} \rightarrow L^{\perp}$ by

This is well defined i.e. $j(X) \in L^{\perp}$, because when $w \in L$ we have:

\langle\chi(u, v, X), w\rangle=* \varphi_{0}(u, v, X, w)=-* \varphi_{0}(u, v, w, X)=\langle\chi(u, v, w), X\rangle=0
$$

Also $j^{2}(X)=j(\chi(u, v, X))=\chi(u, v, \chi(u, v, X))=-X$. We can check the last equality by taking an orthonormal basis $\left\{X_{j}\right\} \subset L^{\perp}$ and calculating

\left\langle\chi\left(u, v, \chi\left(u, v, X_{i}\right)\right), X_{j}\right\rangle & =* \varphi_{0}\left(u, v, \chi\left(u, v, X_{i}\right), X_{j}\right)=-* \varphi_{0}\left(u, v, X_{j}, \chi\left(u, v, X_{i}\right)\right) \\
& =-\left\langle\chi\left(u, v, X_{j}\right), \chi\left(u, v, X_{i}\right)\right\rangle=-\delta_{i j}
\end{aligned}
$$

The last equality holds since the map $j$ is orthogonal, and the orthogonality can be seen by polarizing the associator equality, and by noticing $\varphi_{0}\left(u, v, X_{i}\right)=0$. Observe that the map $j$ only depends on the oriented 2-plane $\Lambda=<u, v>$ generated by $\{u, v\}$ (i.e. it only depends on the complex structure on $\Lambda$ ).

## 3. Calabi-Yau's hypersurfaces in $G_{2}$ manifolds

In AS2 authors proposed a notion of mirror duality for Calabi-Yau submanifold pairs lying inside of a $G_{2}$ manifold $(M, \varphi)$. This is done first by assigning almost Calabi-Yau structures to hypersurfeces induced by hyperplane distributions. The construction goes as follows. Suppose $\xi$ be a nonvanishing vecor fileld $\xi \in \Omega^{0}(M, T M)$, which gives a codimension one integrable distribution $V_{\xi}:=\xi^{\perp}$ on $M$. If $X_{\xi}$ is a leaf of this distribution, then the forms $\chi$ and $\psi$ induce a nondegenerate 2 -form $\omega_{\xi}$ and an almost complex structure $J_{\xi}$ on $X_{\xi}$ as follows:

\omega_{\xi}=\langle\psi, \xi\rangle \text { and } J_{\xi}(u)=u \times \xi .  \tag{6}\\
\operatorname{Re} \Omega_{\xi}=\left.\varphi\right|_{V_{\xi}} \text { and } \operatorname{Im} \Omega_{\xi}=\langle\chi, \xi\rangle . \tag{7}
\end{gather*}
$$

where the inner products, of the vector valued differential forms $\psi$ and $\chi$ with vector field $\xi$, are performed by using their vector part. So $\left.\omega_{\xi}=\xi\right\lrcorner \varphi$, and $\left.\operatorname{Im} \Omega_{\xi}=\xi\right\lrcorner * \varphi$. Call $\Omega_{\xi}=\operatorname{Re} \Omega_{\xi}+i \operatorname{Im} \Omega_{\xi}$. These induce almost Calabi-Yau structure on $X_{\xi}$, analogous to Example 1.

Theorem 3. (AS2) Let $(M, \varphi)$ be a $G_{2}$ manifold, and $\xi$ be a unit vector field such that $\xi^{\perp}$ comes from a codimension one foliation on $M$, then $\left(X_{\xi}, \omega_{\xi}, \Omega_{\xi}, J_{\xi}\right)$ is an almost Calabi-Yau manifold such that $\left.\varphi\right|_{X_{\xi}}=R e \Omega_{\xi}$ and $\left.* \varphi\right|_{X_{\xi}}=*_{3} \omega_{\xi}$. Furthermore, if $\left.\mathcal{L}_{\xi}(\varphi)\right|_{X_{\xi}}=0$ then $d \omega_{\xi}=0$, and if $\left.\mathcal{L}_{\xi}(* \varphi)\right|_{X_{\xi}}=0$ then $J_{\xi}$ is integrable; when both conditions are satisfied $\left(X_{\xi}, \omega_{\xi}, \Omega_{\xi}, J_{\xi}\right)$ is a Calabi-Yau manifold.

Here is a brief discussion of AS2] with explanation of its terms: Let $\xi^{\#}$ be the dual 1-form of $\xi$, and $e_{\xi \#}$ and $\left.i_{\xi}=\xi\right\lrcorner$ denote the exterior and interior product operations on differential forms, then

\varphi=e_{\xi^{\#}} \circ i_{\xi}(\varphi)+i_{\xi} \circ e_{\xi^{\#}}(\varphi)=\omega_{\xi} \wedge \xi^{\#}+\operatorname{Re} \Omega_{\xi} .
$$

This is the decomposition of the form $\varphi$ with respect to $\xi \oplus \xi^{\perp}$. The condition that the distribution $V_{\xi}$ to be integrable is $d \xi^{\#} \wedge \xi^{\#}=0$. Also it is clear from definitions that $J_{\xi}$ is an almost complex structure on $X_{\xi}$, and the 2-form $\omega_{\xi}$ is non-degenerate on $X_{\xi}$, because

\left.\left.\left.\left.\left.\omega_{\xi}^{3}=(\xi\lrcorner \varphi\right)^{3}=\xi\right\lrcorner[(\xi\lrcorner \varphi) \wedge(\xi\lrcorner \varphi\right) \wedge \varphi\right]=\xi\right\lrcorner\left(6|\xi|^{2} \mu\right)=6 \mu_{\xi}
$$

where $\mu_{\xi}=\left.\mu\right|_{V_{\xi}}$ is the induced orientation form on $V_{\xi}$. For $u, v \in V_{\xi}$.

\begin{aligned}
\omega_{\xi}\left(J_{\xi}(u), v\right) & =\omega_{\xi}(u \times \xi, v)=\langle\psi(u \times \xi, v), \xi\rangle=\varphi(u \times \xi, v, \xi) \\
& =-\varphi(\xi, \xi \times u, v)=-\langle\xi \times(\xi \times u), v\rangle \\
& \left.=-\left.\langle-| \xi\right|^{2} u+\langle\xi, u\rangle \xi, v\right\rangle=|\xi|^{2}\langle u, v\rangle-\langle\xi, u\rangle\langle\xi, v\rangle \\
& =\langle u, v\rangle .
\end{aligned}
$$

implies $\left\langle J_{\xi}(u), J_{\xi}(v)\right\rangle=-\omega_{\xi}\left(u, J_{\xi}(v)\right)=\langle u, v\rangle$. By a calculation of $J_{\xi}$, one checs that the 3 -form $\Omega_{\xi}$ is a $(3,0)$ form, furthermore it is non-vanishing because

\frac{1}{2 i} \Omega_{\xi} \wedge \bar{\Omega}_{\xi}=\operatorname{Im} \Omega_{\xi} \wedge \operatorname{Re} \Omega_{\xi} & \left.=(\xi\lrcorner * \varphi) \wedge[\xi\lrcorner\left(\xi^{\#} \wedge \varphi\right)\right] \\
& \left.=-\xi\lrcorner[(\xi\lrcorner * \varphi) \wedge\left(\xi^{\#} \wedge \varphi\right)\right] \\
& =\xi\lrcorner\left[*\left(\xi^{\#} \wedge \varphi\right) \wedge\left(\xi^{\#} \wedge \varphi\right)\right] \\
& \left.=\left|\xi^{\#} \wedge \varphi\right|^{2} \xi\right\lrcorner \operatorname{vol}(M) \\
& =4\left|\xi^{\#}\right|^{2}\left(* \xi^{\#}\right)=4 \operatorname{vol}\left(X_{\xi}\right) .
\end{aligned}
$$

It is easy to see $* \operatorname{Re} \Omega_{\xi}=-\operatorname{Im} \Omega_{\xi} \wedge \xi^{\#}$ and $* \operatorname{Im} \Omega_{\xi}=\operatorname{Re} \Omega_{\xi} \wedge \xi^{\#}$.

$$
*_{3} \operatorname{Re} \Omega_{\xi}=\operatorname{Im} \Omega_{\xi} .
$$

Notice that $\omega_{\xi}$ is a symplectic structure on $X_{\xi}$ when $d \varphi=0$ and $\left.\mathcal{L}_{\xi}(\varphi)\right|_{V_{\xi}}=0$, ( $\mathcal{L}_{\xi}$ is the Lie derivative along $\xi$ ), since $\left.\omega_{\xi}=\xi\right\lrcorner \varphi$ and:

$$
\left.d \omega_{\xi}=\mathcal{L}_{\xi}(\varphi)-\xi\right\lrcorner d \varphi=\mathcal{L}_{\xi}(\varphi)
$$

$J_{\xi}$ is integrable complex structure if $d^{*} \varphi=0$ and $\left.\mathcal{L}_{\xi}(* \varphi)\right|_{V_{\xi}}=0$ since

$$
\left.\left.d\left(\operatorname{Im} \Omega_{\xi}\right)=d(\xi\lrcorner * \varphi\right)=\mathcal{L}_{\xi}(* \varphi)-\xi\right\lrcorner d(* \varphi)=0
$$

Also notice that $d \varphi=0 \Longrightarrow d\left(\operatorname{Re} \Omega_{\xi}\right)=d\left(\left.\varphi\right|_{X_{\xi}}\right)=0$.

## 4. HL manifolds and Mirror duality in $G_{2}$ manifolds

By [T] any 7 -dimensional Riemanninan manifold admits a non-vanishing orthonormal 2-frame field $\Lambda=\langle u, v\rangle$, in particular $(M, \varphi)$ admits such a field. $\Lambda$ gives a section of the bundle of oriented 2-frames $V_{2}(M) \rightarrow M$, and hence gives an associative/coassociative splitting of the tangent bundle $T M=\mathbf{E} \oplus \mathbf{V}$, where $\mathbf{E}=\mathbf{E}_{\Lambda}=\left\langle u, v, u \times v>\right.$ and $\mathbf{V}=\mathbf{V}_{\Lambda}=\mathbf{E}^{\perp}$. When there is no danger of confusion we will denote the 2 -frame fields and the 2-planes fields which they induce by the same symbol $\Lambda$. Also, any unit section $\xi$ of $\mathbf{E} \rightarrow M$ induces a complex structure $J_{\xi}$ on the bundle $\mathbf{V} \rightarrow M$ by the cross product $J_{\xi}(u)=u \times \xi$.

In AS2] any two almost Calabi-Yau's $X_{\xi}$ and $X_{\xi^{\prime}}$ inside $(M, \varphi)$ were called dual if the defining vector fields $\xi$ and $\xi^{\prime}$ are chosen from $\mathbf{V}$ and $\mathbf{E}$, respectively. Here we
make this correspondence more precise, in particular showing how to choose $\xi$ and $\xi^{\prime}$ in a more canonical way.

Definition 3. A 3-dimensional submanifold $Y^{3} \subset(M, \varphi)$ is called Harvey-Lawson manifold (HL in short) if $\left.\varphi\right|_{Y}=0$.

Definition 4. (AS1]) Call any orthonormal 3-frame field $\Gamma=<u, v, w>$ on $(M, \varphi)$, a $G_{2}$-frame field if $\varphi(u, v, w)=<u \times v, w>=0$, equivalently $w$ is a unit section of $\mathbf{V}_{\Lambda} \rightarrow X$, with $\Lambda=\langle u, v\rangle$ (see (1)).

Now pick a nonvanishing 2-frame field $\Lambda=\langle u, v>$ on $M$ and let $T M=\mathbf{E} \oplus \mathbf{V}$ be the induced splitting with $\mathbf{E}=\langle u, v, u \times v\rangle$. Let $w$ be a unit section of the bundle $\mathbf{V} \rightarrow M$. Such a section $w$ may not exist on whole $M$, but by obstruction theory it exists on a tubular neighborhood $U$ of the 3 -skeleton $M^{(3)}$ of $M$ (which is a complement of some 3-complex $Z \subset M$ ). So $\varphi(u, v, w)=0$, and hence $\Gamma=<$ $u, v, w>$ is a $G_{2}$ frame field. Next consider the non-vanishing vector fields:

- $R=\chi(u, v, w)=-u \times(v \times w)$
- $R^{\prime}=\frac{1}{\sqrt{3}}(u \times v+v \times w+w \times u)$
- $R^{\prime \prime}=\frac{1}{\sqrt{3}}(u+v+w)$

If the 6 -plane fields $R^{\perp}, R^{\prime \perp}$, and $R^{\prime \prime \perp}$, are integrable we get almost Calabi-Yau manifolds ( $\left.X_{R}, w_{R}, \Omega_{R}, J_{R}\right)$, ( $X_{R^{\prime}}, w_{R^{\prime}}, \Omega_{R^{\prime}}, J_{R^{\prime}}$ ), and ( $\left.X_{R^{\prime \prime}}, w_{R^{\prime \prime}}, \Omega_{R^{\prime \prime}}, J_{R^{\prime \prime}}\right)$. Let us use the convention that $a, b, c$ are real numbers, and $\left[u_{1}, . . u_{n}\right]$ is the distribution generated by the vectors $u_{1}, . ., u_{n}$.

Lemma 4. By definitions, the following hold
(a) $Y:=[u, v, w]=[a u+b v+c w \mid a+b+c=0] \oplus\left[R^{\prime \prime}\right]$
(b) $\mathbb{V}=[u, v, w, R]$, is a coassociative 4-plane field.
(c) $\mathbb{E}:=[u \times v, v \times w, w \times u]$ is an associative 3-plane field.
(d) $\mathbb{E} \perp \mathbb{V}$

Theorem 5. For $(a, b, c) \in \mathbb{R}^{3}$ with $a+b+c=0$, then
(a) $T X_{R}=\left[a u+b v+c w, R^{\prime \prime}, R^{\prime}, a(v \times w)+b(w \times u)+c(u \times v)\right]$
$J_{R}(a u+b v+c w)=-a(v \times w)-b(w \times u)-c(u \times v)$ $J_{R}\left(R^{\prime \prime}\right)=-R^{\prime}$
(b) $T X_{R^{\prime}}=\left[a u+b v+c w, R^{\prime \prime}, R, a(v \times w)+b(w \times u)+c(u \times v)\right]$
$J_{R^{\prime}}(a u+b v+c w)=-((b-c) u+(c-a) v+(a-b) w) / \sqrt{3}$
$J_{R^{\prime}}(a(v \times w)+b(w \times u)+c(u \times v))=$ $((b-c)(v \times w)+(c-a)(w \times u)+(a-b)(u \times v)) / \sqrt{3}$ $J_{R^{\prime}}\left(R^{\prime \prime}\right)=R$
(c) $T X_{R^{\prime \prime}}=\left[a u+b v+c w, R, R^{\prime},(a(v \times w)+b(w \times u)+c(u \times v)]\right.$

(d) $\{u, v, w, R, u \times v, v \times w, w \times u\}$ is an orthonormal frame field.

Proof. To show (a) by using (4) we calculate:

R \times u & =\chi(u, v, w) \times u=-[u \times(v \times w)] \times u=u \times[u \times(v \times w)] \\
& =-\chi(u, u, v \times w)-<u, u>(v \times w)+<u, v \times w>u \\
& =-(v \times w)+\varphi(u, v, w) u
\end{aligned}

\text { Therefore } R \times u=-(v \times w) \tag{8}
\end{equation*}
$$

Similarly, $R \times v=-(w \times u)$ and $R \times w=-(u \times v)$. Therefore we have $J_{R}(a u+$ $b v+c w)=-a(v \times w)-b(w \times u)-c(u \times v)$, and $J_{R}\left(R^{\prime \prime}\right)=-R^{\prime}$.

$$
\begin{align*}
\sqrt{3} R^{\prime} \times u= & (u \times v+v \times w+w \times u) \times u \\
= & -u \times(u \times v)-u \times(v \times w)-u \times(w \times u) \\
= & <u, u>v-<u, v>u \\
& +\chi(u, v, w)+<u, v>w-<u, w>v \\
& +<u, w>u-<u, u>w \tag{9}
\end{align*}
$$

Therefore $\sqrt{3} R^{\prime} \times u=R+(v-w)$
Similarly $\sqrt{3} R^{\prime} \times v=R+(w-u)$, and $\sqrt{3} R^{\prime} \times w=R+(u-v)$, which implies the first part of $(\mathrm{b})$, and $J_{R^{\prime}}\left(R^{\prime \prime}\right)=R$.

For the second part of (b) we need the compute the following:

$$
\begin{gather*}
\sqrt{3} R^{\prime} \times[a(v \times w)+b(w \times u)+c(u \times v)]=  \tag{10}\\
(u \times v+v \times w+w \times u) \times[a(v \times w)+b(w \times u)+c(u \times v)]
\end{gather*}
$$

For this first by repeatedly using (4) and $\varphi(u, v, w)=0$ we calculate:

$$
\begin{aligned}
(v \times u) \times(w \times v) & =-\chi(v \times u, w, v)-<v \times u, w>v+<v \times u, v>w \\
& =-\chi(v \times u, w, v)=-\chi(w, v, v \times u) \\
& =w \times(v \times(v \times u))+<w, v>(v \times u)-<w, v \times u>v \\
& =w \times(v \times(v \times u)) \\
& =w \times(-\chi(v, v, u)-<v, v>u+<v, u>v)=-(w \times u)
\end{aligned}
$$

Then by plugging in (9) gives (b). Proof of (c) is similar to (a)
In particular from the above calculations we get can express $\varphi$ as:

## Corollary 6.

$$
\begin{gathered}
\varphi=u^{\#} \wedge v^{\#} \wedge\left(u^{\#} \times v^{\#}\right)+v^{\#} \wedge w^{\#} \wedge\left(v^{\#} \times w^{\#}\right)+w^{\#} \wedge u^{\#} \wedge\left(w^{\#} \times u^{\#}\right) \\
+u^{\#} \wedge R^{\#} \wedge\left(v^{\#} \times w^{\#}\right)+\left(v^{\#} \wedge R^{\#}\right) \wedge\left(w^{\#} \times u^{\#}\right)+w^{\#} \wedge R^{\#} \wedge\left(u^{\#} \times v^{\#}\right) \\
-\left(u^{\#} \times v^{\#}\right) \wedge\left(v^{\#} \times w^{\#}\right) \wedge\left(w^{\#} \times u^{\#}\right)
\end{gathered}
$$

Recall that in an earlier paper we proved the following facts:
Proposition 7. AS2 Let $\{\alpha, \beta\}$ be orthonormal vector fields on $(M, \varphi)$. Then on $X_{\alpha}$ the following hold
(i) $R e \Omega_{\alpha}=\omega_{\beta} \wedge \beta^{\#}+\operatorname{Re} \Omega_{\beta}$
(ii) $\left.\left.\operatorname{Im} \Omega_{\alpha}=\alpha\right\lrcorner\left(\star \omega_{\beta}\right)-(\alpha\lrcorner \operatorname{Im} \Omega_{\beta}\right) \wedge \beta^{\#}$
(iii) $\left.\left.\omega_{\alpha}=\alpha\right\lrcorner R e \Omega_{\beta}+(\alpha\lrcorner \omega_{\beta}\right) \wedge \beta^{\#}$

Proof. Since $\operatorname{Re} \Omega_{\alpha}=\left.\varphi\right|_{X_{\alpha}}$ (i) follows. Since $\left.\operatorname{Im} \Omega_{\alpha}=\alpha\right\lrcorner * \varphi$ following gives (ii)

$$
\begin{aligned}
\alpha\lrcorner\left(\star \omega_{\beta}\right) & =\alpha\lrcorner[\beta\lrcorner *(\beta\lrcorner \varphi)] \\
& =\alpha\lrcorner \beta\lrcorner\left(\beta^{\#} \wedge * \varphi\right) \\
& \left.\left.=\alpha\lrcorner * \varphi+\beta^{\#} \wedge(\alpha\lrcorner \beta\right\lrcorner * \varphi\right) \\
& \left.=\alpha\lrcorner * \varphi+(\alpha\lrcorner \operatorname{Im} \Omega_{\beta}\right) \wedge \beta^{\#}
\end{aligned}
$$

(iii) follows from the following computation

$$
\left.\left.\left.\left.\left.\left.\left.\alpha\lrcorner R e \Omega_{\beta}=\alpha\right\lrcorner \beta\right\lrcorner\left(\beta^{\#} \wedge \varphi\right)=\alpha\right\lrcorner \varphi+\beta^{\#} \wedge(\alpha\lrcorner \beta\right\lrcorner \varphi\right)=\alpha\right\lrcorner \varphi-(\alpha\lrcorner \omega_{\beta}\right) \wedge \beta^{\#}
$$

Note that even though the identities of this proposition hold only after restricting the right hand side to $X_{\alpha}$, all the individual terms are defined everywhere on $(M, \varphi)$. Also, from the construction, $X_{\alpha}$ and $X_{\beta}$ inherit vector fields $\beta$ and $\alpha$, respectively.

Corollary 8. AS2 Let $\{\alpha, \beta\}$ be orthonormal vector fields on $(M, \varphi)$. Then there are $A_{\alpha \beta} \in \Omega^{3}(M)$, and $W_{\alpha \beta} \in \Omega^{2}(M)$ satisfying

$$
\begin{array}{rrll}
(a) & \left.\varphi\right|_{X_{\alpha}}=\operatorname{Re} \Omega_{\alpha} & \text { and } & \left.\varphi\right|_{X_{\beta}}=\operatorname{Re} \Omega_{\beta} \\
(b) & \left.A_{\alpha \beta}\right|_{X_{\alpha}}=\operatorname{Im} \Omega_{\alpha} & \text { and } & \left.\left.A_{\alpha \beta}\right|_{X_{\beta}}=\alpha\right\lrcorner\left(\star \omega_{\beta}\right) \\
(c) & \left.W_{\alpha \beta}\right|_{X_{\alpha}}=\omega_{\alpha} & \text { and } & \left.\left.W_{\alpha \beta}\right|_{X_{\beta}}=\alpha\right\lrcorner \operatorname{Re} \Omega_{\beta}
\end{array}
$$

Now we can choose $\alpha$ as $R$ and $\beta$ as $R^{\prime}$ of the given $H L$ manifold. That concludes that given a $H L$ submanifold of a $G_{2}$ manifold, it will determine a "canonical" mirror pair of Calabi-Yau manifolds (related thru the HL manifold) with the complex and symplectic structures given above.
