# NONLINEAR FOURIER TRANSFORMS AND THE MKDV EQUATION IN THE QUARTER PLANE

#### Abstract

The unified transform method introduced by Fokas can be used to analyze initial-boundary value problems for integrable evolution equations. The method involves several steps, including the definition of spectral functions via nonlinear Fourier transforms and the formulation of a Riemann-Hilbert problem. We provide a rigorous implementation of these steps in the case of the $m K d V$ equation in the quarter plane under limited regularity and decay assumptions. We give detailed estimates for the relevant nonlinear Fourier transforms. Using the theory of $L^{2}$-RH problems, we consider the construction of quarter plane solutions which are $C^{1}$ in time and $C^{3}$ in space.

## 1. Introduction

Initial value problems for integrable evolution equations can be analyzed via the inverse scattering transform (IST) cf. [1, 15. Starting with the initial data, certain spectral functions (often referred to as reflection and transmission coefficients) are defined via a nonlinear Fourier transform. Since the time evolution of these spectral functions is simple, the solution at time $t$ can be recovered via the solution of an inverse problem. The inverse problem is most conveniently formulated as a Riemann-Hilbert (RH) problem whose jump matrix involves the given spectral functions.

Following the many successes of the inverse scattering approach, one of the main open problems in the area of integrable systems in the late twentieth century was the extension of the IST formalism to initial-boundary value (IBV) problems, see [1]. Such an extension was introduced by Fokas in [16] (see also [17, 18]) and has subsequently been developed and applied by several authors [2, 5, 8, 21-26, 30-37]. In analogy with the IST on the line, the unified transform of [16] relies for the analysis of an IBV problem on the definition of several spectral functions via nonlinear Fourier transforms and on the formulation of a RH problem.

In this paper, we provide a rigorous study of the nonlinear Fourier transforms and RH problems relevant for the analysis of the $m K d V$ equation

in the quarter plane $\{x \geq 0, t \geq 0\}$. The unified transform method presents the solution of this problem in terms of the solution of a RH problem, which is defined in terms of four spectral functions $\{a(k), b(k), A(k), B(k)\}$, see [4]. The functions $a(k)$ and $b(k)$ can be viewed as half-line nonlinear Fourier transforms of the initial data, while the functions $A(k)$ and $B(k)$ can be viewed as half-line nonlinear Fourier transforms of the
boundary values. We present detailed estimates for these half-line transforms, which can be used to formulate an appropriate RH problem under limited regularity and decay assumptions. In particular, we derive uniform asymptotic expansions for large $k$ and give conditions under which these expansions can be differentiated termwise. We also show how smoothness and decay of the initial and boundary values translate into decay and smoothness of the spectral functions, respectively. Finally, using the theory of $L^{2}-\mathrm{RH}$ problems, we consider the construction of quarter plane solutions of (1.1) which are $C^{1}$ in time and $C^{3}$ in space. Our presentation can be viewed as an extension of [4], where equation (1.1) was analyzed on the half-line under less explicit regularity assumptions. We present our results for the mKdV equation for definiteness, but similar arguments are applicable also to other integrable equations such as the nonlinear Schrödinger, KdV, sine-Gordon, and Camassa-Holm equations.

The rigorous study of nonlinear Fourier transforms and RH problems is rather involved even in simple cases. For example, for the KdV equation on the line, the relevant nonlinear Fourier transform is that associated with the one-dimensional Schrödinger operator $-\partial_{x}^{2}+u_{0}(x)$, and Deift and Trubowitz presented the rigorous analysis of this operator and of the associated transform in an elegant but long paper [11. In many cases, to avoid technical details, results relying on inverse scattering techniques are presented under rather vague assumptions on the given data such as "sufficient smoothness and decay". This can sometimes be motivated by the fact that the qualitative outcomes of the theory are independent of the precise assumptions. However, there are situations where more precise formulations are vital also qualitatively. In the context of IBV problems, physically relevant examples of such situations include:

1. The derivation of long-time asymptotics via the nonlinear steepest descent method.
2. Problems with asymptotically time-periodic data.
3. Problems whose initial and boundary data are not compatible to all orders at the points of the boundary for which $t=0$.
4. Problems with step-like initial and/or boundary profiles.

For the derivation of long-time asymptotics, the decay properties of the boundary values are particularly important - if the boundary values do not decay as $t \rightarrow \infty$, the asymptotic formulas will receive additional contributions from the boundary. For problems with $t$-periodic data, the spectral functions may have branch cuts, hence the formulation of a RH problem is intricate and a detailed understanding of the half-line Fourier transforms is crucial, see [6, 7, [29]. In addition to providing a detailed study of the mKdV equation in the quarter plane, the present paper intends to lay the foundation for future explorations of the above topics.

The analysis of IBV problems is more involved than the analysis of pure initial value problems. Thus, although the unified transform method and the IST formalism share several characteristics, there are important differences. Let us comment on a few of these differences relevant for the present study:
(a) For an initial value problem on the line, the IST formalism utilizes two eigenfunctions which are normalized at plus and minus infinity. For the corresponding quarter plane problem, the unified transform method utilizes one eigenfunction normalized at spatial infinity, one normalized at temporal infinity, and one normalized at the origin. The latter eigenfunction is entire, but has a more complicated large $k$ behavior than the eigenfunctions normalized at infinity. Indeed, in order to be correctly normalized at the origin, this eigenfunction must be a linear combination of two solutions, one of which admits an expansion in $1 / k$ whereas the other is exponentially small in each asymptotic sector. The contribution from the exponentially small solution can sometimes be ignored, but it becomes important as $k$ approaches the anti-Stokes lines that form the boundary
of the asymptotic sector. In fact, as $k \rightarrow \infty$ along one of these lines, the two solutions contribute terms of comparable order asymptotically.
(b) Since the spectral functions for the IBV problem are defined via half-line transforms, they do not have rapid decay as $k \rightarrow \infty$ even in the case of smooth data. Indeed, the half-line transform of a function $f(x), x \geq 0$, can be viewed as the transform on the whole line of $f_{e}(x)$ where $f_{e}=f$ for $x \geq 0$ and $f_{e}=0$ for $x<0$. If $f(0) \neq 0$, the dicontinuity of $f_{e}(x)$ at $x=0$ implies that the transform only decays as $1 / k$ as $k \rightarrow \infty$. The rigorous formulation of a RH problem therefore involves a careful study of asymptotic expansions.
(c) The initial data and the boundary values of a solution of an IBV problem are not independent. The relationship between the initial and boundary values is encoded in a relation among the spectral functions called the global relation. When formulating the main RH problem, we must assume that the global relation is fulfilled (see equation (5.3) below).

Section 2 contains some definitions and notational conventions. In Section 3, we consider the definition of $a(k)$ and $b(k)$. In Section 4, we consider the definition of $A(k)$ and $B(k)$. In Section 5, we consider the construction of quarter plane solutions of (1.1) which are $C^{1}$ in time and $C^{3}$ in space. A few results on $L^{2}$-RH problems are collected in the appendix.

## 2. Preliminaries

2.1. Lax pair. The mKdV equation (1.1) admits the Lax pair

where $\mu(x, t, k)$ is a $2 \times 2$-matrix valued eigenfunction, $k \in \mathbb{C}$ is the spectral parameter, and

The versions of (1.1) with $\lambda=1$ and $\lambda=-1$ are referred to as the defocusing and focusing mKdV equations, respectively.
2.2. Notation. For a $2 \times 2$ matrix $A$, we let $A^{(d)}$ and $A^{(o)}$ denote the diagonal and off-diagonal parts, respectively. If $A$ is an $n \times m$ matrix, we define $|A|$ by

Then $|A+B| \leq|A|+|B|$ and $|A B| \leq|A||B|$. For a contour $\gamma \subset \mathbb{C}$ and $1 \leq p \leq \infty$, we write $A \in L^{p}(\gamma)$ if $|A|$ belongs to $L^{p}(X)$. We define $\|A\|_{L^{p}(\gamma)}:=\||A|\|_{L^{p}(\gamma)}$. Note that $A \in L^{p}(\gamma)$ if and only if each entry $A_{i j}$ belongs to $L^{p}(\gamma)$. We let $\left\{\sigma_{j}\right\}_{1}^{3}$ denote the three Pauli matrices. We let $\hat{\sigma}_{3}$ act on a $2 \times 2$ matrix $A$ by $\hat{\sigma}_{3} A=\left[\sigma_{3}, A\right]$, i.e. $e^{\hat{\sigma}_{3}} A=e^{\sigma_{3}} A e^{-\sigma_{3}}$. For a $2 \times 2$ matrix $A$, we let $[A]_{1}$ and $[A]_{2}$ denote the first and second columns of $A$. We let $\mathbb{C}_{+}=\{\operatorname{Im} k>0\}$ and $\mathbb{C}_{-}=\{\operatorname{Im} k<0\}$ denote the open upper and lower half-planes; $\overline{\mathbb{C}}_{ \pm}=\mathbb{C}_{ \pm} \cup \mathbb{R}$ will denote their closures. The notation $k \in\left(\mathbb{C}_{+}, \mathbb{C}_{-}\right)$indicates that the first and second columns are valid for $k \in \mathbb{C}_{+}$and $k \in \mathbb{C}_{-}$, respectively. Given $x \in \mathbb{R}$,

$[x]$ will denote the integer part of $x$. The open domains $\left\{D_{j}\right\}_{1}^{4}$ of the complex $k$-plane are defined by (see Figure 1)

We let $D_{+}=D_{1} \cup D_{3}$ and $D_{-}=D_{2} \cup D_{4}$. We let $\Gamma=\mathbb{R} \cup e^{i \pi / 3} \mathbb{R} \cup e^{2 i \pi / 3} \mathbb{R}$ denote the contour separating the $D_{j}$ 's oriented so that $D_{+}$lies to the left of $\Gamma$. Throughout the paper $C$ denotes a generic constant.

## 3. Spectral analysis of the $x$-Part

Let $u(x)$ be a real-valued function defined for $x \geq 0$ and let

Consider the linear differential equation

where $X(x, k)$ is a $2 \times 2$-matrix valued eigenfunction and $k \in \mathbb{C}$ is a spectral parameter. We define two $2 \times 2$-matrix valued solutions of 3.1 as the solutions of the linear Volterra integral equations

The proof of the following theorem is given in Section 3.2,
Theorem 3.1. Let $m \geq 1$ and $n \geq 1$ be integers. Suppose

Then the equations (3.2) uniquely define two $2 \times 2$-matrix valued solutions $X$ and $Y$ of (3.1) with the following properties:
(a) The function $X(x, k)$ is defined for $x \geq 0$ and $k \in\left(\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$. For each $k \in\left(\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$, the function $X(\cdot, k) \in C^{1}([0, \infty))$ satisfies (3.1).
(b) The function $Y(x, k)$ is defined for $x \geq 0$ and $k \in \mathbb{C}$. For each $k \in \mathbb{C}$, the function $Y(\cdot, k) \in C^{1}([0, \infty))$ satisfies (3.1).
(c) For each $x \geq 0$, the function $X(x, \cdot)$ is bounded and continuous for $k \in\left(\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$ and analytic for $k \in\left(\mathbb{C}_{+}, \mathbb{C}_{-}\right)$.
(d) For each $x \geq 0$, the function $Y(x, \cdot)$ is an entire function of $k \in \mathbb{C}$ which is bounded for $k \in\left(\overline{\mathbb{C}}_{-}, \overline{\mathbb{C}}_{+}\right)$.
(e) For each $x \geq 0$ and each $j=1, \ldots, n$, the partial derivative $\frac{\partial^{j} X}{\partial k^{j}}(x, \cdot)$ has a continuous extension to ( $\left.\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$.
(f) $X$ and $Y$ satisfy the following estimates:

for $j=0,1, \ldots, n$.
3.1. Behavior as $k \rightarrow \infty$. In addition to the properties listed in Theorem 3.1, we also need to know the behavior of the eigenfunctions $X$ and $Y$ as $k \rightarrow \infty$. To this end, we note that equation (3.1) admits formal power series solutions $X_{\text {formal }}$ and $Y_{\text {formal }}$, normalized at $x=\infty$ and $x=0$ respectively, such that

The coefficients $\left\{X_{j}(x), Z_{j}(x), W_{j}(x)\right\}$ are determined recursively from (3.7)-(3.9), the equations obtained from (3.8) by replacing $\left\{X_{j}\right\}$ with $\left\{Z_{j}\right\}$, and the initial assignments

& -\frac{i}{8} \sigma_{3} \sigma_{\lambda}\left\{\int_{0}^{x} u\left[u^{3}\left(W_{1}\right)_{12}+\lambda\left(4 u\left(W_{3}\right)_{12}+2 i\left(W_{2}\right)_{12} u_{x}-\left(W_{1}\right)_{12} u_{x x}\right)\right] d x^{\prime}\right.
\end{aligned}

If $u(x)$ has a finite degree of regularity and decay, only finitely many coefficients $\left\{X_{j}, Z_{j}, W_{j}\right\}$ are well-defined. The following result, whose proof is given in Section 3.3, describes the behavior of $X$ and $Y$ as $k \rightarrow \infty$.

Theorem 3.2. Suppose $u(x)$ satisfies (3.3) for some integers $m \geq 1$ and $n \geq 1$. Then, as $k \rightarrow \infty, X$ and $Y$ coincide to order $m$ with $X_{\text {formal }}$ and $Y_{\text {formal }}$ respectively in the following sense: The functions

are well-defined and there exists a $K>0$ such that

for all $k \in\left(\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$with $|k|>K$, and

\left|\frac{\partial^{j}}{\partial k^{j}}(Y-\hat{Y})\right| \leq \frac{C(1+x)^{j+2} e^{\frac{C x}{|k|^{m+1}}}}{|k|^{m+1}}, \quad x \geq 0, \quad j=0,1, \ldots, n, \tag{3.15b}
\end{equation*}
$$

for all $k \in\left(\overline{\mathbb{C}}_{-}, \overline{\mathbb{C}}_{+}\right)$with $|k|>K$, and

\left|\frac{\partial^{j}}{\partial k^{j}}\left((Y-\hat{Y}) e^{2 i k x \sigma_{3}}\right)\right| \leq \frac{C(1+x)^{j+2} e^{\frac{C x}{|k|^{m+1}}}}{|k|^{m+1}}, \quad x \geq 0, \quad j=0,1, \ldots, n, \tag{3.15c}
\end{equation*}
$$

for all $k \in\left(\overline{\mathbb{C}}_{+}, \overline{\mathbb{C}}_{-}\right)$with $|k|>K$.
Remark 3.3. It is relatively straightforward to derive from equations (3.2) that $X$ and $Y$ have the properties listed in Theorem 3.1. For the proof of Theorem 3.2, which is much more involved, the equations (3.2) are not suitable; instead we will consider the equations satisfied by the 'errors' $\hat{X}^{-1} X, Z^{-1} Y$, and $\hat{W}^{-1} Y e^{2 i k x \sigma_{3}}$, where $\hat{Y}=\hat{Z}+\hat{W} e^{-2 i k x \sigma_{3}}$.
3.2. Proof of Theorem 3.1. In view of the symmetries

which are valid for $F=X$ and $F=Y$, it is enough to prove the theorem for $[X]_{2}$ and $[Y]_{2}$. We first consider the construction of $[X]_{2}$.

Let $\Psi(x, k)$ denote the second column of $X(x, k)$. Then, by 3.2a),

We use successive approximations to show that the Volterra integral equation (3.17) has a unique solution $\Psi(x, k)$ for each $k \in \overline{\mathbb{C}}_{-}$. Let $\Psi_{0}=\binom{0}{1}$ and define $\Psi_{l}$ for $l \geq 1$ inductively by

\end{equation*}
$$

Using the estimates

\left|E\left(x, x^{\prime}, k\right)\right|<C, \quad 0 \leq x \leq x^{\prime}<\infty, \quad k \in \overline{\mathbb{C}}_{-}
$$

and

$$

we find

\left|\Psi_{l}(x, k)\right| & \leq C \int_{x \leq x_{l} \leq \cdots \leq x_{1}<\infty} \prod_{i=1}^{l}\left|\mathrm{U}\left(x_{i}\right)\right|\left|\Psi_{0}\right| d x_{1} \cdots d x_{l} \\
& \leq \frac{C}{l!}\|\mathrm{U}\|_{L^{1}([x, \infty))}^{l} \leq \frac{C}{l!}\left(\frac{C}{(1+x)^{n}}\right)^{l}, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{-} \tag{3.19}
\end{align*}
$$

Hence the series

converges absolutely and uniformly for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{-}$to a continuous solution $\Psi(x, k)$ of (3.17). Moreover,

with $j=1$ to differentiate under the integral sign in 3.18 , we see that $\Psi_{l}(x, \cdot)$ is analytic in $\mathbb{C}_{-}$for each $l$; the uniform convergence then proves that $\Psi$ is analytic in $\mathbb{C}_{-}$.

It remains to show that $[X]_{2}=\Psi$ satisfies $(e)$ and $(f)$ for $j=1, \ldots, n$. Let

for each $k$ in the interior of $\overline{\mathbb{C}}_{-}$; the differentiation can be justified by dominated convergence using (3.21) and a Cauchy estimate for $\partial_{k} \Psi$. We seek a solution of (3.23) of the form $\Lambda=\sum_{l=0}^{\infty} \Lambda_{l}$, where the $\Lambda_{l}$ 's are defined by replacing $\left\{\Psi_{l}\right\}$ by $\left\{\Lambda_{l}\right\}$ in 3.18 . Proceeding as in (3.19), we find

In particular $\left\|\Lambda_{0}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}$ is bounded for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{-}$. Thus, $\sum_{l=0}^{\infty} \Lambda_{l}$ converges uniformly on $[0, \infty) \times \overline{\mathbb{C}}_{-}$to a continuous solution $\Lambda$ of $(3.23)$, which satisfies the following analog of (3.20):

If $1 \leq j \leq n$, then $\left\|\Lambda_{0}^{(j)}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}$ is bounded for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{-}$; hence the associated series $\Lambda^{(j)}=\sum_{l=0}^{\infty} \Lambda_{l}^{(j)}$ converges uniformly on $[0, \infty) \times \overline{\mathbb{C}}_{-}$to a continuous solution with the desired properties.

We now consider the the construction of $[Y]_{2}$. In this case, we still let $\Psi_{0}=\binom{0}{1}$, but instead of (3.18) we now introduce $\left\{\Psi_{l}\right\}_{1}^{\infty}$ by

where $x \geq 0$ and $k \in \mathbb{C}$. This leads to an entire function $\Psi(x, k)=\sum_{l=0}^{\infty} \Psi_{l}(x, k)$ satisfying (3.1). Moreover, as in (3.19), we find

The proof of (3.4b) for $j=1$ follows from the following analogs of (3.24)-(3.26):

& \left|\Lambda_{0}(x, k)\right| \leq C \int_{0}^{x}\left(1+\left|x-x^{\prime}\right|\right)\left|u\left(x^{\prime}\right)\right| d x^{\prime} \leq C x+C x \int_{0}^{x}\left|u\left(x^{\prime}\right)\right| d x^{\prime} \leq C x, \\
& \left|\Lambda(x, k)-\Lambda_{0}(x, k)\right| \leq C x
\end{aligned}
$$

which are valid for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{+} ;$the proof for $j \geq 2$ is similar.
3.3. Proof of Theorem 3.2. We first consider $[X]_{2}$. Our first goal is to show that $\hat{X}$ is well-defined and invertible for $k$ large enough.
Claim 1. $\left\{X_{j}(x)\right\}_{1}^{m+1}$ are $C^{1}$ functions of $x \geq 0$ satisfying

$$

By (3.28),

Using the estimate $(3.30)$ and the expression $\sqrt{3.10}$ for $X_{1}$, we conclude that $S_{1}$ holds. Similar estimates together with the relations (3.8) imply that if $1 \leq j \leq m$ and $S_{j}$ holds, then $S_{j+1}$ also holds. Thus, by induction, $\left\{S_{j}\right\}_{j=1}^{m+1}$ hold. This shows that $\left\{X_{j}\right\}_{1}^{m+1}$ are $C^{1}$ functions satisfying $(1+x)^{n} \partial^{i} X_{j}(x) \in L^{1}([0, \infty))$ for $i=0,1$ and $j=1, \ldots, m+1$. The boundedness of $(1+x)^{n} X_{j}(x)$ follows by an estimate analogous to (3.29).

Claim 2. There exists a $K>0$ such that $\hat{X}(x, k)^{-1}$ exists for all $k \in \mathbb{C}$ with $|k| \geq K$. Moreover, letting $A=i k \sigma_{3}+\mathrm{U}$ and

for $x \geq 0$ and $|k| \geq K$. Now let $Q_{0}(x)+\frac{Q_{1}(x)}{k}+\frac{Q_{2}(x)}{k^{2}}+\cdots$ be the formal power series expansion of $\hat{X}(x, k)^{-1}$ as $k \rightarrow \infty$, i.e.

\end{aligned}

Equation (3.34) and the inequality (3.35) imply that the function $\mathcal{E}(x, k)$ defined by

satisfies

Let $\hat{A}(x, k)$ be given by 3.31. Since $X_{\text {formal }}$ is a formal solution of 3.1), the coefficient of $k^{-j}$ in the formal expansion of $\Delta=A-\hat{A}$ as $k \rightarrow \infty$ vanishes for $j \leq m$; hence, in view of Claim 1 and (3.36),

|\Delta| & =\left|A-\left(\hat{X}_{x}+i k \hat{X} \sigma_{3}\right)\left(\sum_{j=0}^{m+1} \frac{Q_{j}}{k^{j}}+\mathcal{E}\right)\right| \\
& \leq \frac{C g(x)}{|k|^{m+1}(1+x)^{n}}+\left|\left(\hat{X}_{x}+i k \hat{X} \sigma_{3}\right) \mathcal{E}\right| \\
& \leq \frac{C f(x)}{\mid k^{m+1}(1+x)^{n}}, \quad x \geq 0, \quad|k| \geq K,
\end{aligned}
$$

where $f$ is a continuous (not necessarily bounded) function in $L^{1}([0, \infty))$. This proves (3.32).

Given $K>0$, we let $\overline{\mathbb{C}}_{ \pm}^{K}=\overline{\mathbb{C}}_{ \pm} \cap\{|k| \geq K\}$.

Claim 3. The Volterra integral equation

where $\Psi_{0}(x, k)=[\hat{X}(x, k)]_{2}$ and

e^{-2 i k\left(x^{\prime}-x\right)} & 0  \tag{3.38}\\
0 & 1
\end{array}\right) \hat{X}\left(x^{\prime}, k\right)^{-1}
$$

has a unique solution $\Psi(x, k)$ for each $k \in \overline{\mathbb{C}}_{-}^{K}$. This solution satisfies $\Psi=[X]_{2}$.
Proof of Claim 3. Define $\Psi_{l}$ for $l \geq 1$ inductively by

\end{equation*}
$$

Using the estimate

\left|E\left(x, x^{\prime}, k\right)\right|<C, \quad 0 \leq x \leq x^{\prime}<\infty, \quad k \in \overline{\mathbb{C}}_{-}^{K}
$$

as well as 3.33 , we find, for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{-}^{K}$,

& \leq \frac{C}{l!}\left\|\Psi_{0}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}\|\Delta(\cdot, k)\|_{L^{1}([x, \infty))}^{l} \\
& \leq \frac{C}{l!}\left\|\Psi_{0}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}\left(\frac{C}{|k|^{m+1}(1+x)^{n}}\right)^{l} \tag{3.40}
\end{align*}
$$

Since

\sup _{k \in \overline{\mathbb{C}}_{-}^{K}}\left\|\Psi_{0}(\cdot, k)\right\|_{L^{\infty}([0, \infty))}<C
$$

we find

\left|\Psi_{l}(x, k)\right| \leq \frac{C}{l!}\left(\frac{C}{|k|^{m+1}(1+x)^{n}}\right)^{l}, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{-}^{K}

Hence the series $\Psi(x, k)=\sum_{l=0}^{\infty} \Psi_{l}(x, k)$ converges absolutely and uniformly for $x \geq 0$ and $k \in \overline{\mathbb{C}}_{-}^{K}$ to a continuous solution $\Psi(x, k)$ of 3.37 . Moreover,

It follows from the integral equation (3.37) that $\Psi$ satisfies the second column of (3.1). By 3.41 , $\Psi(x, k) \sim\binom{0}{1}$ as $x \rightarrow \infty$. Hence, by uniqueness of solution, $\Psi=[X]_{2}$ for $k \in \mathbb{C}_{-}^{K}$.

Claim 4. $[X]_{2}$ satisfies (3.15a).
Proof of Claim 4. Equation (3.41) implies that $[X]_{2}=\Psi$ satisfies (3.15a) for $j=0$.

A glance at the proof of Claim 2 shows that the inequality (3.32) can be extended to derivatives of $\Delta$ with respect to $k$ :

\end{equation*}

Differentiating the integral equation (3.37) with respect to $k$, we find that $\Lambda:=\partial_{k} \Psi$ satisfies

for each $k$ in the interior of $\overline{\mathbb{C}}_{-}^{K}$; the differentiation can be justified by dominated convergence using (3.42) and a Cauchy estimate for $\partial_{k} \Psi$. We seek a solution of (3.44) of the form $\Lambda=\sum_{l=0}^{\infty} \Lambda_{l}$, where the $\Lambda_{l}$ 's are defined by replacing $\left\{\Psi_{l}\right\}$ by $\left\{\Lambda_{l}\right\}$ in (3.39). Proceeding as in (3.40), we find

In particular $\left\|\Lambda_{0}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}$ is bounded for $k \in \overline{\mathbb{C}}_{-}^{K}$ and $x \geq 0$. Thus, $\sum_{l=0}^{\infty} \Lambda_{l}$ converges uniformly on $[0, \infty) \times \overline{\mathbb{C}}_{-}^{K}$ to a continuous solution $\Lambda$ of $(\sqrt{3.44})$, which satisfies the following analog of (3.41):

Proceeding inductively, we find that $\Lambda^{(j)}:=\partial_{k}^{j} \Psi$ satisfies an integral equation of the form

If $1 \leq j \leq n$, then $\left\|\Lambda_{0}^{(j)}(\cdot, k)\right\|_{L^{\infty}([x, \infty))}$ is bounded for $k \in \overline{\mathbb{C}}_{-}^{K}$ and $x \geq 0$; hence the associated series $\Lambda^{(j)}=\sum_{l=0}^{\infty} \Lambda_{l}^{(j)}$ converges uniformly on $[0, \infty) \times \overline{\mathbb{C}}_{-}^{K}$ to a continuous solution with the desired properties.

The above claims prove the theorem for $X$. We now consider $[Y]_{2}$.

Claim 5. $\left\{Z_{j}(x), W_{j}(x)\right\}_{1}^{m+1}$ are $C^{1}$ functions of $x \geq 0$ satisfying

\partial^{i} Z_{j}^{(o)} \in L^{1}([0, \infty)) \text { for } i=1, \ldots, m+2-j \\
\partial^{i} Z_{j}^{(d)} \in L^{1}([0, \infty)) \text { for } i=1, \ldots, m+3-j
\end{array}\right.
$$

and

$$
\left\{\begin{array}{l}
W_{j}^{(d)} \in C^{m+2-j}([0, \infty)), \quad W_{j}^{(o)} \in C^{m+3-j}([0, \infty)), \\
\partial^{i} W_{j}^{(d)} \in L^{1}([0, \infty)) \text { for } i=1, \ldots, m+2-j, \\
\partial^{i} W_{j}^{(o)} \in L^{1}([0, \infty)) \text { for } i=1, \ldots, m+3-j,
\end{array}\right.
$$

respectively. Using the expressions (3.11) and $(3.12)$ for $Z_{1}$ and $W_{1}$, we conclude that $S_{1}$ and $\mathcal{S}_{1}$ hold. The relations (3.8) and (3.9) imply by induction that $\left\{S_{j}, \mathcal{S}_{j}\right\}_{j=1}^{m+1}$ hold. This shows that $\left\{Z_{j}, W_{j}\right\}_{1}^{m+1}$ are $C^{1}$ functions satisfying $Z_{j}^{\prime}, W_{j}^{\prime} \in L^{1}([0, \infty))$ for $j=1, \ldots, m+1$. Integration shows that $Z_{j}, W_{j} \in L^{\infty}([0, \infty))$ for $j=1, \ldots, m+1$. $\nabla$

We write

\hat{Y}(x, k)=\hat{Z}(x, k)+\hat{W}(x, k) e^{-2 i k x \sigma_{3}},
$$

where $\hat{Z}$ and $\hat{W}$ are defined by

Claim 6. There exists a $K>0$ such that $\hat{Z}(x, k)^{-1}$ and $\hat{W}(x, k)^{-1}$ exist for all $k \in \mathbb{C}$ with $|k| \geq K$. Moreover, letting $A=i k \sigma_{3}+\mathrm{U}$ and

\Delta_{l}(x, k)=A(x, k)-\hat{A}_{l}(x, k), \quad l=1,2,
$$

satisfy

$$
\left|\partial_{k}^{j} \Delta_{l}(x, k)\right| \leq \frac{C+f(x)}{|k|^{m+1}}, \quad x \geq 0, \quad|k| \geq K, \quad j=0,1, \ldots, n, \quad l=1,2,
$$

where $f$ is a function in $L^{1}([0, \infty)) \cap C([0, \infty))$. In particular,

\left\|\Delta_{l}(\cdot, k)\right\|_{L^{1}([0, x])} \leq \frac{C x}{|k|^{m+1}}, \quad x \geq 0, \quad|k| \geq K, \quad l=1,2 . \tag{3.47}

Proof of Claim 6. The proof uses Claim 5 and is similar to that of Claim 2.
Claim 7. We have

& \left|\frac{\partial^{j}}{\partial k^{j}}\left[\hat{W}(x, k) e^{-i k x \hat{\sigma}_{3}} \hat{W}^{-1}(0, k)-\hat{Y}(x, k) e^{2 i k x \sigma_{3}}\right]_{2}\right| \leq C(1+x)^{j} \frac{1+\left|e^{-2 i k x}\right|}{|k|^{m+2}}, \tag{3.48b}
\end{align*}
$$

for all $x \geq 0,|k| \geq K$, and $j=0,1, \ldots, n$.

Proof of Claim 7. We write

formally to all orders in $k$. Indeed, both sides of (3.49) are formal solutions of (3.1) satisfying the same initial condition at $x=0$. Truncating (3.49) at order $k^{-m-1}$, it follows that

We seek a solution $\Psi(x, k)=\sum_{l=0}^{\infty} \Psi_{l}(x, k)$ where

\Psi_{l}(x, k)=(-1)^{l} \int_{0 \leq x_{1} \leq \cdots \leq x_{l} \leq x<\infty} \prod_{i=1}^{l} E\left(x_{i+1}, x_{i}, k\right) \Delta_{1}\left(x_{i}, k\right) \Psi_{0}\left(x_{1}, k\right) d x_{1} \cdots d x_{l}
$$

The estimates

\begin{equation*}
\left|\partial_{k}^{j} E\left(x, x^{\prime}, k\right)\right|<C\left(1+\left|x^{\prime}-x\right|\right)^{j}, \quad 0 \leq x^{\prime} \leq x<\infty, \quad k \in \overline{\mathbb{C}}_{+}^{K}, \quad j=0,1, \ldots, n, \tag{3.52}
\end{equation*}
$$

and

\left|\Psi_{0}(x, k)\right| \leq C, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{+}^{K},
$$

together with (3.47) yield

& \leq \frac{C}{l!}\left\|\Psi_{0}(\cdot, k)\right\|_{L^{\infty}([0, x])}\left\|\Delta_{1}(\cdot, k)\right\|_{L^{1}([0, x])}^{l} \\
& \leq \frac{C}{l!}\left(\frac{C x}{|k|^{m+1}}\right)^{l}, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{+}^{K} .
\end{aligned}

Differentiating the integral equation (3.51) with respect to $k$, we find that $\Lambda:=\partial_{k} \Psi$ satisfies

\Lambda_{0}(x, k)=\left[\partial_{k} \Psi_{0}(x, k)\right]_{2}+\int_{0}^{x} \frac{\partial}{\partial k}\left[E\left(x, x^{\prime}, k\right) \Delta_{1}\left(x^{\prime}, k\right)\right] \Psi\left(x^{\prime}, k\right) d x^{\prime} \tag{3.55}
\end{equation*}
$$

We seek a solution of (3.54) of the form $\Lambda=\sum_{l=0}^{\infty} \Lambda_{l}$. Proceeding as above, we find

\left|\Lambda_{l}(x, k)\right| \leq \frac{C}{l!}\left\|\Lambda_{0}(\cdot, k)\right\|_{L^{\infty}([0, x])}\left(\frac{C x}{|k|^{m+1}}\right)^{l}, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{+}^{K}
$$

Using (3.4b) and (3.52) in (3.55), we obtain

\left|\Lambda_{0}(x, k)-\left[\partial_{k} \Psi_{0}(x, k)\right]_{2}\right| \leq \frac{C(1+x)^{2}}{|k|^{m+1}}, \quad x \geq 0, \quad k \in \overline{\mathbb{C}}_{+}^{K} . \tag{3.56}
\end{equation*}

Thus $\sum_{l=0}^{\infty} \Lambda_{l}$ converges uniformly on compact subsets of $[0, \infty) \times \overline{\mathbb{C}}_{+}^{K}$ to a continuous solution $\Lambda$ of (3.54), which satisfies

Equations (3.48a), 3.56), and (3.57) show that $[Y]_{2}=\Psi$ satisfies (3.15b) for $j=1$. Extending the above argument, we find that (3.15b holds also for $j=2, \ldots, n$.

Claim 9. $[Y]_{2}$ satisfies (3.15c).
Proof of Claim 9. Let $y(x, k)=Y(x, k) e^{2 i k x \sigma_{3}}$. Then $y$ satisfies $y_{x}=A y+i k y \sigma_{3}$. Thus

=\hat{W}^{-1} \Delta_{2} y-i k\left[\sigma_{3}, \hat{W}^{-1} y\right] .
$$

Hence

Integrating and using the initial condition $y(0, k)=I$, we conclude that $y$ satisfies the following Volterra integral equation:

As in the proof of Claim 8, the estimates

Equations (3.48b) and (3.59) prove the second column of $(3.15 \mathrm{c})$ for $j=0$. Proceeding as in the proof of Claim 8, equation (3.15c) follows also for $j=1, \ldots, n$.

Remark 3.4. The proof of Theorem 3.2 was inspired by Chapter 6 of [9, where asymptotic results are derived for differential equations on a finite interval.
3.4. The spectral functions $\{a(k), b(k)\}$. Let $s(k)=X(0, k)$. Since $X$ obeys the symmetries (3.16), we may define the spectral functions $a(k)$ and $b(k)$ for $\operatorname{Im} k \leq 0$ by

(a) $a(k)$ and $b(k)$ are continuous for $\operatorname{Im} k \leq 0$ and analytic for $\operatorname{Im} k<0$.
(b) There exist complex constants $\left\{a_{j}, b_{j}\right\}_{1}^{m}$ such that

uniformly as $k \rightarrow \infty$ with $\operatorname{Im} k \leq 0$.
(c) For $j=1, \ldots n$, the derivatives $a^{(j)}(k)$ and $b^{(j)}(k)$ have continuous extensions to $\operatorname{Im} k \leq 0$ and

uniformly as $k \rightarrow \infty$ with $\operatorname{Im} k \leq 0$.
(d) $a$ and $b$ obey the symmetries

$$
\left\{\begin{array}{l}
a(k)=\overline{a(-\bar{k})},  \tag{3.62}\\
b(k)=\overline{b(-\bar{k})},
\end{array} \quad \quad \operatorname{Im} k \leq 0\right.
$$

(e) $|a(k)|^{2}-\lambda|b(k)|^{2}=1$ for $k \in \mathbb{R}$.
(f) If $\lambda=1$, then $a(k) \neq 0$ for $\operatorname{Im} k \leq 0$.

Proof. Letting $a_{j}=\left(X_{j}(0)\right)_{22}$ and $b_{j}=\left(X_{j}(0)\right)_{12}$, properties $(a)-(c)$ follow immediately from Theorems 3.1 and 3.2 . Property $(d)$ is a consequence of the symmetry $X(x, k)=$ $\bar{X}(x,-\bar{k})$. Property $(e)$ follows since $\operatorname{det} X=1$.

Suppose $\lambda=1$. Then (e) implies that $|a(k)| \geq 1$ for $k \in \mathbb{R}$. It only remains to prove that $a(k) \neq 0$ for $\operatorname{Im} k<0$.

Suppose $a\left(k_{0}\right)=0$ for some $k_{0} \in \mathbb{C}$ with $\operatorname{Im} k_{0}<0$. Consider the space $L^{2}\left(\mathbb{R}, \mathbb{C}^{2}\right)$ of vector valued functions $f=\left(f_{1}, f_{2}\right)$ equipped with the inner product

Then the operator $L=i \sigma_{3} \partial_{x}-i \sigma_{3} \mathrm{U}_{e}$ satisfies

\langle L f, g\rangle=\langle f, L g\rangle \quad \text { whenever } \quad f, g \in H^{1}\left(\mathbb{R}, \mathbb{C}^{2}\right) \subset L^{2}\left(\mathbb{R}, \mathbb{C}^{2}\right)

Define $h \in L^{2}\left(\mathbb{R}, \mathbb{C}^{2}\right)$ by

The condition $a\left(k_{0}\right)=0$ implies that $h$ is continuous at $x=0$. Moreover, since $\operatorname{Im} k_{0}<0$, $h$ has exponential decay as $x \rightarrow \pm \infty$. It follows that $h \in H^{1}\left(\mathbb{R}, \mathbb{C}^{2}\right)$. But since $L h=k_{0} h$ this leads to the contradiction that the eigenvalue $k_{0}$ must be real:

Consider the linear differential equation

where $T(t, k)$ is a $2 \times 2$-matrix valued eigenfunction and $k \in \mathbb{C}$ is a spectral parameter. We define two $2 \times 2$-matrix valued solutions of (4.1) as the solutions of the linear Volterra integral equations

The proof of the following theorem is given in Section 4.2.
Theorem 4.1. Let $m \geq 1$ and $n \geq 1$ be integers. Suppose

(a) The function $T(t, k)$ is defined for $t \geq 0$ and $k \in\left(\bar{D}_{-}, \bar{D}_{+}\right)$. For each $k \in\left(\bar{D}_{-}, \bar{D}_{+}\right)$, the function $T(\cdot, k) \in C^{1}([0, \infty))$ satisfies (4.1).
(b) The function $U(t, k)$ is defined for $t \geq 0$ and $k \in \mathbb{C}$. For each $k \in \mathbb{C}$, the function $U(\cdot, k) \in C^{1}([0, \infty))$ satisfies (4.1).
(c) For each $t \geq 0$, the function $T(t, \cdot)$ is bounded and continuous for $k \in\left(\bar{D}_{-}, \bar{D}_{+}\right)$and analytic for $k \in\left(D_{-}, D_{+}\right)$.
(d) For each $t \geq 0$, the function $U(t, \cdot)$ is an entire function of $k \in \mathbb{C}$ which is bounded for $k \in\left(\bar{D}_{+}, \bar{D}_{-}\right)$.
(e) For each $t \geq 0$ and each $j=1, \ldots, n$, the partial derivative $\frac{\partial^{j} T}{\partial k^{j}}(t, \cdot)$ has a continuous extension to $\left(\bar{D}_{-}, \bar{D}_{+}\right)$.
(f) $T$ and $U$ satisfy the following estimates:

& \left|\frac{\partial^{j}}{\partial k^{j}}(U(t, k)-I)\right| \leq C \min (t, 1)(1+t)^{j} e^{C(1+|k|)^{2}}, \quad t \geq 0, \quad k \in\left(\bar{D}_{+}, \bar{D}_{-}\right)  \tag{4.4b}\\
& \quad \text { for } j=0,1, \ldots, n
\end{align*}
$$

4.1. Behavior as $k \rightarrow \infty$. Equation (4.1) admits formal power series solutions $T_{\text {formal }}$ and $U_{\text {formal }}$, normalized at $t=\infty$ and $t=0$ respectively, such that

Equations (4.8) provide the recursive equations necessary to generate the $T_{j}$ 's. The coefficients $\left\{V_{j}\right\}$ satisfy the equations obtained by replacing $\left\{T_{j}\right\}$ with $\left\{V_{j}\right\}$ in 4.8). Moreover, substituting

The coefficients $\left\{T_{j}(t), V_{j}(t), W_{j}(t)\right\}$ are determined recursively from the above equations and the initial assignments

W_{3}(t)= & -\frac{\lambda}{4}\left(g_{1}\left(W_{1}\right)_{12}-2 i g_{0}\left(W_{2}\right)_{12}\right) \sigma_{3}+\sigma_{\lambda}\left\{\int _ { 0 } ^ { t } \frac { 1 } { 4 } \left[2 i\left(3 g_{0}^{4}+\lambda g_{1}^{2}-2 \lambda g_{0} g_{2}\right)\left(W_{2}\right)_{12}\right.\right. \\

If $\left\{g_{j}(t)\right\}_{0}^{2}$ have a finite degree of regularity and decay, only finitely many coefficients $\left\{T_{j}, V_{j}, W_{j}\right\}$ are well-defined. The following result, whose proof is given in Section 4.3 . describes the behavior of $T$ and $U$ as $k \rightarrow \infty$.

Theorem 4.2. Suppose $\left\{g_{j}(t)\right\}_{0}^{2}$ satisfy (4.3) for some integers $m \geq 1$ and $n \geq 1$. Then, as $k \rightarrow \infty, T$ and $U$ coincide to order $m$ with $T_{\text {formal }}$ and $U_{\text {formal }}$ respectively in the following sense: The functions

for all $k \in\left(\bar{D}_{-}, \bar{D}_{+}\right)$with $|k|>K$.
4.2. Proof of Theorem 4.1. In view of the symmetries

& \leq \frac{C}{l!}\|\mathrm{V}(\cdot, k)\|_{L^{1}([t, \infty))}^{l} \leq \frac{C}{l!}\left(\frac{C(1+|k|)^{2}}{(1+t)^{n}}\right)^{l}, \quad t \geq 0, \quad k \in \bar{D}_{+} \tag{4.17}
\end{align*}

Hence the series

It remains to show that $[T]_{2}=\Psi$ satisfies $(e)$ and $(f)$ for $j=1, \ldots, n$. Let

We now consider the the construction of $[U]_{2}$. In this case, we introduce $\left\{\Psi_{l}\right\}_{1}^{\infty}$ by the following analog of 4.16:

The boundedness of $(1+t)^{n} T_{j}(t)$ follows by an estimate analogous to (4.27).

Claim 2. There exists a $K>0$ such that $\hat{T}(t, k)^{-1}$ exists for all $k \in \mathbb{C}$ with $|k| \geq K$. Moreover, letting $A=-4 i k^{3} \sigma_{3}+\mathrm{V}$ and

Given $K>0$, we let $\bar{D}_{ \pm}^{K}=\bar{D}_{ \pm} \cap\{|k| \geq K\}$.
Claim 3. The Volterra integral equation

where $\Psi_{0}(t, k)=[\hat{T}(t, k)]_{2}$ and

e^{8 i k^{3}\left(t^{\prime}-t\right)} & 0 \\
0 & 1
\end{array}\right) \hat{T}\left(t^{\prime}, k\right)^{-1}
$$

has a unique solution $\Psi(t, k)$ for each $k \in \bar{D}_{+}^{K}$. This solution satisfies $\Psi=[T]_{2}$.
Proof of Claim 3. Define $\Psi_{l}$ for $l \geq 1$ inductively by

\end{equation*}

Using the estimate

as well as 4.31, we find, for $t \geq 0$ and $k \in \bar{D}_{+}^{K}$,

& \leq \frac{C}{l!}\left\|\Psi_{0}(\cdot, k)\right\|_{L^{\infty}([t, \infty))}\left(\frac{C}{|k|^{m+1}(1+t)^{n}}\right)^{l} \tag{4.37}
\end{align*}

Hence the series $\Psi(t, k)=\sum_{l=0}^{\infty} \Psi_{l}(t, k)$ converges absolutely and uniformly for $t \geq 0$ and $k \in \bar{D}_{+}^{K}$ to a continuous solution $\Psi(t, k)$ of 4.35 . Moreover,

It follows from the integral equation (4.35) that $\Psi$ satisfies the second column of (4.1). By 4.38, $\Psi(t, k) \sim\binom{0}{1}$ as $t \rightarrow \infty$. Hence, by uniqueness of solution, $\Psi=[T]_{2}$ for $k \in D_{+}^{K}$.

Claim 4. $[T]_{2}$ satisfies 4.13a).

Proof of Claim 4. Equation (4.38) implies that $[T]_{2}=\Psi$ satisfies 4.13a) for $j=0$.
A glance at the proof of Claim 2 shows that the inequality 4.30) can be extended to derivatives of $\Delta$ with respect to $k$ :

Differentiating the integral equation (4.35) with respect to $k$, we find that $\Lambda:=\partial_{k} \Psi$ satisfies

for each $k$ in the interior of $\bar{D}_{+}^{K}$; the differentiation can be justified by dominated convergence using (4.39) and a Cauchy estimate for $\partial_{k} \Psi$. We seek a solution of (4.41) of the form $\Lambda=\sum_{l=0}^{\infty} \Lambda_{l}$. Proceeding as in 4.37), we find

In particular $\left\|\Lambda_{0}(\cdot, k)\right\|_{L^{\infty}([t, \infty))}$ is bounded for $k \in \bar{D}_{+}^{K}$ and $t \geq 0$. Thus, $\sum_{l=0}^{\infty} \Lambda_{l}$ converges uniformly on $[0, \infty) \times \bar{D}_{+}^{K}$ to a continuous solution $\Lambda$ of 4.41], which satisfies the following analog of (4.38):

If $1 \leq j \leq n$, then $\left\|\Lambda_{0}^{(j)}(\cdot, k)\right\|_{L^{\infty}([t, \infty))}$ is bounded for $k$ in compact subsets of $\bar{D}_{+}^{K}$ and $t \geq 0$; hence the associated series $\Lambda^{(j)}=\sum_{l=0}^{\infty} \Lambda_{l}^{(j)}$ converges uniformly on compact subsets of $[0, \infty) \times \bar{D}_{+}^{K}$ to a continuous solution with the desired properties.

The above claims prove the theorem for $T$. We now consider $[U]_{2}$.

\partial^{i} V_{j}^{(d)}(t) \in L^{1}([0, \infty)) \text { for } i=1, \ldots,\left[\frac{m+7-j}{3}\right],
\end{array}\right.
$$

and

$$
\left\{\begin{array}{l}
W_{j}^{(d)} \in C^{\left[\frac{m+6-j}{3}\right]}([0, \infty)), \quad W_{j}^{(o)} \in C^{\left[\frac{m+7-j}{3}\right]}([0, \infty)), \\
\partial^{i} W_{j}^{(d)}(t) \in L^{1}([0, \infty)) \text { for } i=1, \ldots,\left[\frac{m+6-j}{3}\right], \\
\partial^{i} W_{j}^{(o)}(t) \in L^{1}([0, \infty)) \text { for } i=1, \ldots,\left[\frac{m+7-j}{3}\right],
\end{array}\right.
$$

respectively. Using the expressions (3.11) and (3.12) for $V_{1}$ and $W_{1}$, we conclude that $\left\{S_{j}, \mathcal{S}_{j}\right\}_{1}^{3}$ hold. The relations 3.8 and (3.9) imply that if $4 \leq j \leq m+3$ and $\left\{S_{i}, \mathcal{S}_{i}\right\}_{i=j-3}^{j-1}$ hold, then $S_{j}$ and $\mathcal{S}_{j}$ also hold. Thus, by induction, $\left\{S_{j}, \mathcal{S}_{j}\right\}_{j=1}^{m+3}$. This shows that $\left\{V_{j}, W_{j}\right\}_{1}^{m+3}$ are $C^{1}$ functions satisfying $\partial V_{j}, \partial W_{j} \in L^{1}([0, \infty))$ for $j=1, \ldots, m+3$. Integration shows that $V_{j}, W_{j} \in L^{\infty}([0, \infty))$ for $j=1, \ldots, m+3$.

We define $\hat{V}$ and $\hat{W}$ by

\Delta_{l}(t, k)=A(t, k)-\hat{A}_{l}(t, k), \quad l=1,2,
$$

satisfy

\left|\partial_{k}^{j} \Delta_{l}(t, k)\right| \leq \frac{C+f(t)}{|k|^{m+1}}, \quad t \geq 0, \quad|k| \geq K, \quad j=0,1, \ldots, n, \quad l=1,2
$$

where $f$ is a function in $L^{1}([0, \infty)) \cap C([0, \infty))$. In particular,

& \left|\frac{\partial^{j}}{\partial k^{j}}\left[\hat{W}(t, k) e^{4 i k^{3} t \hat{\sigma}_{3}} \hat{W}^{-1}(0, k)-\hat{U}(t, k) e^{-8 i k^{3} t \sigma_{3}}\right]_{2}\right| \leq C(1+t)^{j} \frac{1+\left|e^{8 i k^{3} t}\right|}{|k|^{m+4-2 j}}, \tag{4.45b}
\end{align*}

for all $t \geq 0,|k| \geq K$, and $j=0,1, \ldots, n$.

\end{equation*}

We seek a solution of 4.50 of the form $\Lambda=\sum_{l=0}^{\infty} \Lambda_{l}$. Proceeding as above, we find

Thus $\sum_{l=0}^{\infty} \Lambda_{l}$ converges uniformly on compact subsets of $[0, \infty) \times \bar{D}_{-}^{K}$ to a continuous solution $\Lambda$ of 4.50), which satisfies

\left|\Lambda(t, k)-\Lambda_{0}(t, k)\right| \leq \frac{C(1+t)^{2} t e^{\frac{C t}{|k|^{m+1}}}}{|k|^{m+1}}, \quad t \geq 0, \quad k \in \bar{D}_{-}^{K} \tag{4.53}
\end{equation*}
$$

Equations 4.45a, 4.52, and 4.53) show that $[U]_{2}=\Psi$ satisfies 4.13b for $j=1$. Extending the above argument, we find that 4.13b) holds also for $j=2, \ldots, n$.

Claim 9. $[U]_{2}$ satisfies (4.13c).
Proof of Claim 9. Let $w(t, k)=U(t, k) e^{-8 i k^{3} t \sigma_{3}}$. Then $w$ satisfies $w_{t}=A w-4 i k^{3} w \sigma_{3}$. Thus

& =-\hat{W}^{-1}\left(\hat{A}_{2} \hat{W}-4 i k^{3} \hat{W} \sigma_{3}\right) \hat{W}^{-1} w+\hat{W}^{-1}\left(A w-4 i k^{3} w \sigma_{3}\right) \\
& =\hat{W}^{-1} \Delta_{2} w+4 i k^{3}\left[\sigma_{3}, \hat{W}^{-1} w\right]
\end{aligned}
$$

Hence

$$
\left(e^{-4 i k^{3} t \hat{\sigma}_{3}} \hat{W}^{-1} w\right)_{t}=e^{-4 i k^{3} t \hat{\sigma}_{3}} \hat{W}^{-1} \Delta_{2} w
$$

Integrating and using the initial condition $w(0, k)=I$, we conclude that $w$ satisfies the Volterra integral equation

Letting $\Psi=[w]_{2}$ and $\Psi_{0}(t, k)=\left[\hat{W}(t, k) e^{4 i k^{3} t \hat{\sigma}_{3}} \hat{W}^{-1}(0, k)\right]_{2}$, we can write the second column of 4.54 as

As in the proof of Claim 8, the estimates

\left|\partial_{k}^{j} E\left(t, t^{\prime}, k\right)\right|<C|k|^{2 j}\left(1+\left|t^{\prime}-t\right|\right)^{j}, \quad 0 \leq t^{\prime} \leq t<\infty, \quad k \in \bar{D}_{+}^{K}, \quad j=0,1, \ldots, n
$$

and

\left|\Psi_{0}(t, k)\right| \leq C, \quad t \geq 0, \quad k \in \bar{D}_{+}^{K}
$$

together with (4.44) yield

\left|\Psi(t, k)-\Psi_{0}(t, k)\right| \leq \frac{C t e^{\frac{C t}{|k|^{m+1}}}}{|k|^{m+1}}, \quad t \geq 0, \quad k \in \bar{D}_{+}^{K} \tag{4.55}
\end{equation*}
$$

Equations 4.45b and 4.55 prove the second column of 4.13c for $j=0$. Proceeding as in the proof of Claim $8,(4.13 \mathrm{c})$ follows also for $j=1, \ldots, n$.
4.4. The spectral functions $\{A(k), B(k)\}$. We let $S(k)=T(0, k)$ and define the spectral functions $A(k)$ and $B(k)$ for $k \in \bar{D}_{+}$by

Theorem 4.3. Suppose $\left\{g_{j}(t)\right\}_{0}^{2}$ satisfy (4.3) for some integers $m \geq 1$ and $n \geq 1$. Then the spectral functions $A(k)$ and $B(k)$ have the following properties:
(a) $A(k)$ and $B(k)$ are continuous for $k \in \bar{D}_{+}$and analytic for $k \in D_{+}$.
(b) There exist complex constants $\left\{A_{j}, B_{j}\right\}_{1}^{m}$ such that

& A(k)=1+\frac{A_{1}}{k}+\cdots+\frac{A_{m}}{k^{m}}+O\left(\frac{1}{k^{m+1}}\right) \\
& B(k)=\frac{B_{1}}{k}+\cdots+\frac{B_{m}}{k^{m}}+O\left(\frac{1}{k^{m+1}}\right) \tag{4.57a}
\end{align*}
$$

uniformly as $k \rightarrow \infty$ with $k \in \bar{D}_{+}$.
(c) For $j=1, \ldots n$, the derivatives $A^{(j)}(k)$ and $B^{(j)}(k)$ have continuous extensions to $k \in \bar{D}_{+}$and

A^{(j)}(k) & =\frac{d^{j}}{d k^{k}}\left(1+\frac{A_{1}}{k}+\cdots+\frac{A_{m}}{k^{m}}\right)+O\left(\frac{1}{k^{m+1-2 j}}\right) \\
B^{(j)}(k) & =\frac{d^{j}}{d k^{j}}\left(\frac{B_{1}}{k}+\cdots+\frac{B_{m}}{k^{m}}\right)+O\left(\frac{1}{k^{m+1-2 j}}\right) \tag{4.57~b}
\end{align*}
$$

uniformly as $k \rightarrow \infty$ with $k \in \bar{D}_{+}$.
(d) $A$ and $B$ obey the symmetries

$$
\left\{\begin{array}{l}
A(k)=\overline{A(-\bar{k})},  \tag{4.58}\\
B(k)=\overline{B(-\bar{k})},
\end{array} \quad k \in \bar{D}_{+}\right.
$$

(e) $A$ and $B$ satisfy the relation

A(k) \overline{A(\bar{k})}-\lambda B(k) \overline{B(\bar{k})}=1, \quad k \in \Gamma . \tag{4.59}
\end{equation*}
$$

Proof. Letting $A_{j}=\left(T_{j}(0)\right)_{22}$ and $B_{j}=\left(T_{j}(0)\right)_{12}$, properties $(a)-(c)$ follow immediately from Theorems 4.1 and 4.2. Property $(d)$ is a consequence of the symmetry $T(x, k)=$ $\overline{T(x,-\bar{k})}$. Property (e) follows since $\operatorname{det} T=1$.
4.5. More spectral functions. Suppose $u_{0}, g_{0}, g_{1}, g_{2}$ satisfy (3.3) and (4.3) for some integers $m \geq 1$ and $n \geq 1$. Let $\{a(k), b(k), A(k), B(k)\}$ be given by (3.60) and 4.56).

We define the spectral functions $c(k)$ and $d(k)$ by

We also define spectral functions $h(k)$ and $r(k)$ by

## 5. The mKdV equation in the quarter plane

In this section, we apply the results from the preceding sections to express the solution of the mKdV equation in the quarter plane in terms of the solution of a RH problem.

Before stating the main result, we need to recall some definitions related to $L^{p}-\mathrm{RH}$ problems. We use the notation of [27]. Further details can be found in [27] (see also the appendix). Let $\mathcal{J}$ denote the collection of all subsets $\gamma$ of the Riemann sphere $\hat{\mathbb{C}}=\mathbb{C} \cup\{\infty\}$ such that $\gamma$ is homeomorphic to the unit circle and

$$
\begin{equation*}
\sup _{z \in \gamma \cap \mathbb{C}} \sup _{r>0} \frac{|\gamma \cap D(z, r)|}{r}<\infty \tag{5.1}
\end{equation*}
$$

where $D(z, r)$ denotes the disk of radius $r$ centered at $z$. Curves satisfying 5.1) are called Carleson curves. Let $1 \leq p<\infty$. If $D$ is the bounded component of $\mathbb{C} \backslash \gamma$ where $\gamma \in \mathcal{J}$ and $\infty \notin \gamma$, then a function $f$ analytic in $D$ belongs to the Smirnoff class $E^{p}(D)$ if there exists a sequence of rectifiable Jordan curves $\left\{C_{n}\right\}_{1}^{\infty}$ in $D$, tending to the boundary in the sense that $C_{n}$ eventually surrounds each compact subdomain of $D$, such that $\sup _{n \geq 1} \int_{C_{n}}|f(z)|^{p}|d z|<\infty$. If $D \subset \widehat{\mathbb{C}}$ is bounded by an arbitrary curve in $\mathcal{J}$, $E^{p}(D)$ is defined as the set of functions $f$ analytic in $D$ for which $f \circ \varphi^{-1} \in E^{p}(\varphi(D))$, where $\varphi(z)=\frac{1}{z-z_{0}}$ and $z_{0}$ is any point in $\mathbb{C} \backslash \bar{D}$. The subspace of $E^{p}(D)$ consisting of all functions $f \in E^{p}(D)$ such that $z f(z) \in E^{p}(D)$ is denoted by $\dot{E}^{p}(D)$. We let $E^{\infty}(D)$ denote the space of bounded analytic functions in $D$.

Let $n \geq 1$ be an integer and let $\Sigma$ be a Carleson jump contour. Given an $n \times n$-matrix valued function $v: \Sigma \rightarrow G L(n, \mathbb{C})$, a solution of the $L^{p}$-RH problem determined by $(\Sigma, v)$ is an $n \times n$-matrix valued function $m \in I+\dot{E}^{p}(\hat{\mathbb{C}} \backslash \Sigma)$ such that the nontangential boundary values $m_{ \pm}$satisfy $m_{+}=m_{-} v$ a.e. on $\Sigma$.

Given a Carleson jump contour $\Sigma$ and $a, b \in \mathbb{R}$ with $a<b$, we call $W_{a, b}=\{a \leq$ $\arg k \leq b\}$ a nontangential sector at $\infty$ if there exists a $\delta>0$ such that $W_{a-\delta, b+\delta}$ does not intersect $\Sigma \cap\{|z|>R\}$ whenever $R>0$ is large enough. If $f(k)$ is a function of $k \in \mathbb{C} \backslash \Sigma$, we say that $f$ has nontangential limit $L$ at $\infty$, written

$$
\lim _{k \rightarrow \infty}^{L} f(k)=L
$$

if $\lim _{\substack{k \rightarrow \infty \\ k \in W_{a, b}}} f(k)=L$ for every nontangential sector $W_{a, b}$ at $\infty$.
The following theorem expresses the solution of (1.1) in the quarter plane $\{x \geq 0, t \geq$ $0\}$ in terms of the solution of an $L^{2}$-RH problem.

Theorem 5.1. Suppose $u_{0}, g_{0}, g_{1}, g_{2}$ satisfy (3.3) and (4.3) with $n=1$ and $m=4$, i.e., suppose

\left\{\begin{array}{l}
u_{0} \in C^{5}([0, \infty)), \quad g_{0} \in C^{3}([0, \infty)), \quad g_{1}, g_{2} \in C^{2}([0, \infty)), \\
(1+x) u_{0}^{(i)}(x) \in L^{1}([0, \infty)), \quad i=0,1, \ldots, 5, \\
(1+t) g_{0}^{(i)}(t) \in L^{1}([0, \infty)), \quad i=0,1,2,3, \\
(1+t) g_{1}^{(i)}(t),(1+t) g_{2}^{(i)}(t) \in L^{1}([0, \infty)), \quad i=0,1,2
\end{array}\right.
$$

Define the spectral functions $h(k)$ and $r(k)$ by 4.60). Define the jump matrix $J(x, t, k)$ by

$$
J(x, t, k)=\left\{\begin{array}{cl}
\left(\begin{array}{cc}
1 & 0 \\
\lambda h(k) e^{-2 i k x+8 i k^{3} t} & 1
\end{array}\right), & k \in \partial D_{1}  \tag{5.2}\\
1 & -\overline{r(\bar{k})} e^{2 i k x-8 i k^{3} t} \\
\lambda r(k) e^{-2 i k x+8 i k^{3} t} & 1-\lambda|r(k)|^{2}
\end{array}\right), \quad k \in \mathbb{R}, \quad \begin{array}{ll}
\left(\begin{array}{cc}
1 & -\overline{h(\bar{k})} e^{2 i k x-8 i k^{3} t} \\
0 & 1
\end{array}\right), & k \in \partial D_{4}
\end{array}
$$

If $\lambda=-1$, assume that $a(k)$ is nonzero for $k \in \overline{\mathbb{C}}_{-}$and that $d(k)$ is nonzero for $k \in \bar{D}_{2}$. If $\lambda=1$, suppose the homogeneous RH problem determined by $(\Gamma, J(x, t, \cdot)$ ) (see equation (5.9)) has only the trivial solution for each $(x, t) \in[0, \infty) \times[0, \infty)$.

Suppose the spectral functions satisfy

A(k) b(k)-B(k) a(k)=0, \quad k \in \bar{D}_{1} . \tag{5.3}

Then the $L^{2}$-RH problem

\left\{\begin{array}{l}
M(x, t, \cdot) \in I+\dot{E}^{2}(\mathbb{C} \backslash \Gamma),  \tag{5.4}\\
M_{+}(x, t, k)=M_{-}(x, t, k) J(x, t, k) \quad \text { for a.e. } k \in \Gamma
\end{array}\right.
$$

has a unique solution for each $(x, t) \in[0, \infty) \times[0, \infty)$. Moreover, the nontangential limit

$$
\begin{equation*}
u(x, t)=-2 i \lim _{k \rightarrow \infty}^{\swarrow}(k M(x, t, k))_{12} \tag{5.5}
\end{equation*}
$$

exists for each $(x, t) \in[0, \infty) \times[0, \infty)$ and the function $u(x, t)$ defined by 5.5) has the following properties:
(a) $u:[0, \infty) \times[0, \infty) \rightarrow \mathbb{R}$ is $C^{3}$ in $x$ and $C^{1}$ in $t$.
(b) $u(x, t)$ satisfies (1.1) for $x \geq 0$ and $t \geq 0$.
(c) $u(0, t)=g_{0}(t), u_{x}(0, t)=g_{1}(t)$, and $u_{x x}(0, t)=g_{2}(t)$ for $t \geq 0$.
(d) $u(x, 0)=u_{0}(x)$ for $x \geq 0$.

Proof. The proof proceeds through a series of claims.
Claim 1. $a(k)$ is nonzero for $k \in \overline{\mathbb{C}}_{-}$and $d(k)$ is nonzero for $k \in \bar{D}_{2}$.
Proof of Claim 1. For $\lambda=-1$ this holds by assumption. If $\lambda=1$, Theorem 3.5 shows that $a(k)$ is nonzero for $k \in \overline{\mathbb{C}}_{-}$, while the arguments of [28] show that $d(k)$ is nonzero in $\bar{D}_{2}$.

In view of Claim 1, Theorems 3.5 and 4.3 imply that $r(k)$ and $h(k)$ have the following properties:

- $r \in C^{1}(\mathbb{R})$.
- $h$ is analytic in $D_{2}$ and $h, h^{\prime}$ have continuous extensions to $\bar{D}_{2}$.
- There exist complex constants $\left\{r_{j}, h_{j}\right\}_{1}^{4}$ such that

$$
\begin{align*}
& r^{(j)}(k)=\frac{d^{j}}{d k^{j}}\left(\frac{r_{1}}{k}+\cdots+\frac{r_{4}}{k^{4}}\right)+O\left(k^{-5}\right), \quad|k| \rightarrow \infty, \quad k \in \mathbb{R}, \quad j=0,1,  \tag{5.6}\\
& h^{(j)}(k)=\frac{d^{j}}{d k^{j}}\left(\frac{h_{1}}{k}+\cdots+\frac{h_{4}}{k^{4}}\right)+O\left(k^{-5}\right), \quad k \rightarrow \infty, \quad k \in \bar{D}_{2}, \quad j=0,1 .  \tag{5.7}\\
& \bullet r(k)=\overline{r(-\bar{k})} \text { for } k \in \mathbb{R} \text { and } h(k)=\overline{h(-\bar{k})} \text { for } k \in \bar{D}_{2} .
\end{align*}
$$

Relation (5.3) implies that $r_{j}=0$ for $j=1, \ldots, 4$, so that in fact

r^{(j)}(k)=O\left(k^{-5}\right), \quad|k| \rightarrow \infty, \quad k \in \mathbb{R}, \quad j=0,1 . \tag{5.8}
\end{equation*}
$$

Indeed, the expansions in (3.61) of $\{a(k), b(k)\}$ are valid as $k \rightarrow \infty$ in $\bar{D}_{1} \cup \bar{D}_{2}$ and the expansions in 4.57) of $\{A(k), B(k)\}$ are valid as $k \rightarrow \infty$ in $\bar{D}_{1} \cup \bar{D}_{3}$. Hence $c(k)$ has an expansion

c(k)=\frac{c_{1}}{k}+\cdots+\frac{c_{4}}{k^{4}}+O\left(k^{-5}\right), \quad k \rightarrow \infty, \quad k \in \bar{D}_{1} \cup \mathbb{R},
$$

where the coefficients $\left\{c_{j}\right\}_{1}^{4}$ are the same as $k \rightarrow \infty$ in $\bar{D}_{1}$ and in $\mathbb{R}$. Since $c(k)$ vanishes identically in $\bar{D}_{1}$ by 5.3), we have $c_{j}=0$ for $j=1, \ldots, 4$. Since $r(k)=\frac{\overline{c(\bar{k})}}{d(k)}$, this proves (5.8).

Claim 2. (Vanishing Lemma) Let $x \geq 0$ and $t \geq 0$. Suppose $N(x, t, k)$ is a solution of the homogeneous $L^{2}$-RH problem determined by $(\Gamma, J(x, t, \cdot))$, i.e.

N(x, t, \cdot) \in \dot{E}^{2}(\mathbb{C} \backslash \Gamma),  \tag{5.9}\\
N_{+}(x, t, k)=N_{-}(x, t, k) J(x, t, k) \quad \text { for a.e. } k \in \Gamma
\end{array}\right.
$$

Then $N$ vanishes identically.
Proof of Claim 2. For $\lambda=1$, this holds by assumption. Thus suppose $\lambda=-1$. We
 and $n=0$, we obtain $G \in \dot{E}^{1}(\mathbb{C} \backslash \Gamma)$ and

\int_{\partial D_{3}} G_{+}(k) d k=0, \quad \int_{\partial D_{4}} G_{-}(k) d k=0 .
$$

Adding these equations, we find

\int_{\mathbb{R}} G_{+} d k-\int_{\partial D_{4}}\left(G_{+}-G_{-}\right) d k=0
$$

Since

$$
\begin{aligned}
G_{+}(k) & =N_{+}(k){\overline{N_{-}(\bar{k})}}^{T}=N_{-}(k) J(x, t, k){\overline{N_{-}(\bar{k})}}^{T} \\
& =N_{-}(k) \overline{J(x, t, \bar{k})}^{T}{\overline{N_{-}(\bar{k})}}^{T}=G_{-}(k), \quad k \in \Gamma,
\end{aligned}
$$

this gives

$$
0=\int_{\mathbb{R}} G_{+}(k) d k=\int_{\mathbb{R}} N_{-}(k) J(x, t, k){\overline{N_{-}(k)}}^{T} d k .
$$

For $k \in \mathbb{R}, J(x, t, k)$ is a Hermitian matrix with (11) entry 1 and determinant one; by Sylvester's criterion it is positive definite. It follows that $N_{-}=0$ a.e. on $\mathbb{R}$. But then $N_{+}=N_{-} J$ also vanishes a.e. on $\mathbb{R}$.

Let $B_{r}$ be a small open ball contained in $D_{2} \cup \mathbb{R} \cup D_{3}$ centered at some nonzero real number. The function $\tilde{N}(k)$ defined by

\tilde{N}(k)=\frac{1}{2 \pi i} \int_{\partial B_{r}} \frac{N(s)}{s-k} d s
$$

is analytic in $B_{r}$ and equals $N(k)$ for $k \in B_{r} \backslash \mathbb{R}$. Indeed, if $k \in B_{r} \cap \mathbb{C}_{+}$, then

\tilde{N}(k)=\frac{1}{2 \pi i} \int_{\partial\left(B_{r} \cap \mathbb{C}_{+}\right)} \frac{N_{+}(s)}{s-k} d s+\frac{1}{2 \pi i} \int_{\partial\left(B_{r} \cap \mathbb{C}_{-}\right)} \frac{N_{-}(s)}{s-k} d s=N(k)+0,
$$

and a similar argument applies if $k \in B_{r} \cap \mathbb{C}_{-}$. We infer that $N(k)$ is analytic in $B_{r}$. Since $N=0$ on $B_{r} \cap \mathbb{R}$, it follows by analytic continuation that $N$ vanishes identically for $k \in D_{2} \cup \mathbb{R} \cup D_{3}$. But then $N_{ \pm}=0$ on $\partial D_{1} \cup \partial D_{4}$ so by a similar argument we find that $N$ vanishes for all $k \in \mathbb{C} \backslash \Gamma$.

The global relation 5 5.3) implies that $h(0)=-\frac{\overline{b(0)}}{a(0)}$ and $r(0)=00^{1}$ It follows that unless $b(0)=0$, the matrix $J$ is not continuous at $k=0$. In order to obtain a jump matrix which is continuous and which approaches the identity matrix sufficiently fast as $k \rightarrow \infty$, we introduce $m(x, t, k)$ by

M(x, t, k), & \text { otherwise }\end{cases}

where $h_{a}(k)$ is a rational function such that $h_{a}$ has no poles in $\bar{D}_{1}, h_{a}(0)=h(0), h_{a}(k)=$ $h_{a}(-\bar{k})$, and

$$

Claim 7. $u(x, 0)=u_{0}(x)$ for $x \geq 0$.
Proof of Claim 7. Consider the $x$-part (3.1) with potential $u(x)$ given by $u_{0}(x)$. Let $X(x, k)$ and $Y(x, k)$ denote the associated eigenfunctions defined in Theorem 3.1. The results of Section 3 imply that the function $m^{(x)}(x, k)$ defined by

Since $A(k) \rightarrow 1$ uniformly as $k \rightarrow \infty, k \in \bar{D}_{3}$, we can define deformed domains $\left\{\mathcal{D}_{j}\right\}_{1}^{4}$ so that $A(k)$ is nonzero in $\overline{\mathcal{D}}_{3}$, see Figure 2 . We let $\Sigma=$ $\mathbb{R} \cup\left(\overline{\mathcal{D}}_{1} \cap \overline{\mathcal{D}}_{2}\right) \cup\left(\overline{\mathcal{D}}_{3} \cap \overline{\mathcal{D}}_{4}\right)$ denote the contour separating the $\mathcal{D}_{j}$ 's oriented as in Figure 2. We choose the $\mathcal{D}_{j}$ 's so that $\Sigma$ is invariant under the involution $k \rightarrow \bar{k}$.

Consider the $t$-part 4.1) defined in terms of $\left\{g_{j}(t)\right\}_{0}^{2}$. Let $T(t, k)$ and $U(t, k)$ denote the associated eigenfunctions defined in Theorem 4.1. The relation (5.3) and the condition $\operatorname{det} S(k)=1$ imply

d(k)=a(k) \overline{A(\bar{k})}-\lambda \frac{B(k) a(k)}{\overline{A(\bar{k})}} \overline{B(\bar{k})}=\frac{a(k)}{A(k)}, \quad k \in \partial D_{1} .
$$

This shows that $A(k)$ admits an analytic continuation to $D_{2}$. Since $B=b A / a$ in $\bar{D}_{1}$ by (5.3), it follows that $B(k)$ also admits an analytic continuation to $D_{2}$. The relation
$T=U e^{-4 i k^{3} t \hat{\sigma}_{3}} S(k)$ together with the assumption 5.3 yield the identity

$$
\frac{[T(t, k)]_{2}}{A(k)}=\frac{b(k)}{a(k)} e^{-8 i k^{3} t}[U(t, k)]_{1}+[U(t, k)]_{2}, \quad t \geq 0, \quad k \in \bar{D}_{1}
$$

Since $U(t, \cdot)$ is entire, this shows that $[T]_{2} / A$ also admits an analytic continuation to $D_{2}$. Hence we may define $m^{(t)}$ by

$$
m^{(t)}(t, k)= \begin{cases}\left([U(t, k)]_{1}, \frac{[T(t, k)]_{2}}{A(k)}\right), & k \in \mathcal{D}_{1} \cup \mathcal{D}_{3}  \tag{5.30}\\ \left(\frac{[T(t, k)]_{1}}{\overline{A(\bar{k})}},[U(t, k)]_{2}\right), & k \in \mathcal{D}_{2} \cup \mathcal{D}_{4}\end{cases}
$$

The results of Section 4 imply that $m^{(t)}(t, k)$ satisfies the $L^{2}-\mathrm{RH}$ problem

$$
\left\{\begin{array}{l}
m^{(t)}(t, \cdot) \in I+\dot{E}^{2}(\mathbb{C} \backslash \Sigma),  \tag{5.31}\\
m_{+}^{(t)}(t, k)=m_{-}^{(t)}(t, k)\left(\begin{array}{cc}
1 & \frac{B(k)}{A(k)} e^{-8 i k^{3} t} \\
-\frac{\lambda \overline{B(\bar{k})}}{\overline{A(\bar{k})}} e^{8 i k^{3} t} & \frac{1}{A(k) \overline{A(\bar{k})}}
\end{array}\right) \quad \text { for a.e. } k \in \Gamma .
\end{array}\right.
$$

Moreover, by 4.13a and the explicit expression 4.10 for $V_{j}, j=1,2,3$, we have

$$
\begin{align*}
& g_{0}(t)=-2 i\left(m_{1}\right)_{12}(t)  \tag{5.32a}\\
& g_{1}(t)=4\left(m_{2}\right)_{12}(t)-2 i g_{0}(t)\left(m_{1}\right)_{22}(t)  \tag{5.32b}\\
& g_{2}(t)=\lambda g_{0}^{3}(t)+8 i\left(m_{3}\right)_{12}(t)+4 g_{0}(t)\left(m_{2}\right)_{22}(t)-2 i g_{1}(t)\left(m_{1}\right)_{22}(t) \tag{5.32c}
\end{align*}
$$

where

$$
m_{j}(t)=\lim _{k \rightarrow \infty}^{\llcorner } k^{j} m^{(t)}(t, k), \quad j=1,2,3
$$

and the limit is taken in a nontangential sector in $D_{2} \cup D_{4}$.
On the other hand, deforming the contour from $\Gamma$ to $\Sigma$, we find that the function $\mathcal{M}$ defined by

$$
\mathcal{M}= \begin{cases}M\left(\begin{array}{cc}
1 & 0 \\
\lambda h(k) e^{-2 i k x+8 i k^{3} t} & 1
\end{array}\right), & k \in \mathcal{D}_{1} \cap D_{2} \\
M\left(\begin{array}{ll}
1 \overline{h(\bar{k})} e^{2 i k x-8 i k^{3} t} \\
0 & 1
\end{array}\right), & k \in \mathcal{D}_{4} \cap D_{3} \\
M, & \text { otherwise }\end{cases}
$$

satisfies

$$
\left\{\begin{array}{l}
\mathcal{M}(x, t, \cdot) \in I+\dot{E}^{2}(\mathbb{C} \backslash \Sigma)  \tag{5.33}\\
\mathcal{M}_{+}(x, t, k)=\mathcal{M}_{-}(x, t, k) \mathcal{J}(x, t, k) \quad \text { for a.e. } k \in \Sigma
\end{array}\right.
$$

where $\mathcal{J}$ is defined by

Furthermore, since $a(k), d(k)$, and $A(k)$ are nonzero in $\overline{\mathcal{D}}_{1} \cup \overline{\mathcal{D}}_{2}, \overline{\mathcal{D}}_{2}$, and $\overline{\mathcal{D}}_{3}$, respectively, we have

$$
\left(\frac{d(k)}{\overline{A(\bar{k})}}\right)^{ \pm 1} \in 1+\left(\dot{E}^{2} \cap E^{\infty}\right)\left(\mathcal{D}_{2}\right), \quad a(k)^{ \pm 1} \in 1+\left(\dot{E}^{2} \cap E^{\infty}\right)\left(\mathcal{D}_{1} \cap \mathcal{D}_{2}\right)
$$

It follows that the functions

$$
\begin{align*}
& G_{1}(t, k)=\left(\begin{array}{cc}
a(k) & 0 \\
0 & \frac{1}{a(k)}
\end{array}\right), \quad G_{2}(t, k)=\left(\begin{array}{cc}
\frac{d(k)}{A(\bar{k})} & -b(k) e^{-8 i k^{3} t} \\
0 & \frac{\overline{A(\bar{k})}}{d(k)}
\end{array}\right), \\
& G_{3}(t, k)=\left(\begin{array}{cc}
\frac{A(k)}{\overline{d(\bar{k})}} & 0 \\
-\lambda \overline{\bar{k} \bar{k})} e^{8 i k^{3} t} & \frac{\overline{d(\bar{k})}}{A(k)}
\end{array}\right), \quad G_{4}(t, k)=\left(\begin{array}{cc}
\frac{1}{a(\bar{k})} & 0 \\
0 & \frac{a(\bar{k})}{a(\bar{x}}
\end{array}\right), \tag{5.34}
\end{align*}
$$

satisfy $G_{j}(t, \cdot) \in \dot{E}^{2}\left(\mathcal{D}_{j}\right) \cap E^{\infty}\left(\mathcal{D}_{j}\right)$ for $j=1, \ldots, 4$. Thus a contour deformation argument together with the expression (5.2) for $J$ show that the function $M^{(t)}(t, k)$ defined by

$$
M^{(t)}(t, k)=\mathcal{M}(0, t, k) G_{j}(t, k), \quad k \in \mathcal{D}_{j}, \quad j=1, \ldots, 4,
$$

also satisfies 5.31). By uniqueness, $M^{(t)}=m^{(t)}$. Comparing the definition 5.5) of $u(x, t)$ with 5.32), we obtain $u(0, t)=g_{0}(t)$ for $t \geq 0$. Comparing (5.32) with equation (5.25) in the defocusing case, or with an equation analogous to (5.25) in the focusing case, we obtain also $u_{x}(0, t)=g_{1}(t)$ and $u_{x x}(0, t)=g_{2}(t)$ for $t \geq 0$.

Remark 5.2. In the focusing (i.e. $\lambda=-1$ ) case, the function $d(k)$ could have zeros. The assumption in Theorem 5.1 that $d(k)$ is nonzero in $\bar{D}_{2}$ is made purely for convenience. Indeed, suppose $d(k)$ has zeros in $\bar{D}_{2}$. Since $d(k) \rightarrow 1$ as $k \rightarrow \infty$, we can define deformed domains $\left\{\mathcal{D}_{j}\right\}_{1}^{4}$ as in Figure 2 such that $d(k)$ is nonzero in $\mathcal{D}_{2}$. By formulating the RH problem (5.4) in terms of the deformed domains $\left\{\mathcal{D}_{j}\right\}$ instead of $\left\{D_{j}\right\}$, the same proof goes through with obvious modifications.

Remark 5.3. In the focusing (i.e. $\lambda=-1$ ) case, the function $a(k)$ could have zeros. The assumption in Theorem 5.1 that $a(k)$ is nonzero in $\overline{\mathbb{C}}_{-}$can be weakened. In particular, if $a(k)$ has a finite number of simple poles, then these poles can be easily treated as in [4].

Remark 5.4. Let us comment on the existence of a vanishing lemma for the RH problem (5.4). Zhou showed in [38] (see Theorem 9.3 of [38]) that a homogeneous RH problem with a Schwarz reflection invariant contour has only the trivial solution provided that the jump matrix $J(k)$ satisfies (a) $J(k)=\overline{J(\bar{k}})^{T}$ for $k \in \Gamma \backslash \mathbb{R}$ and (b) $\operatorname{Re} J(k)$ is positive definite on $\mathbb{R}^{2}$ In the focusing (i.e. $\lambda=-1$ ) case, the jump matrix (5.2) satisfies these conditions, so there exists a vanishing lemma. In the defocusing (i.e. $\lambda=1$ ) case, we have not been able to establish a vanishing lemma. Let us explain the main difficulties. Let $\lambda=1$. Then the condition (a) is not satisfied; instead the jump matrix $J$ satisfies $\left.J(k)=\sigma_{3} \overline{J(\bar{k}}\right)^{T} \sigma_{3}$. This implies that if $M(k)$ is a solution of the homogeneous RH problem, then the function $M(k) \sigma_{3} \overline{M(\bar{k})}^{T}$ has no jump across $\Gamma$; hence it vanishes identically. In particular,

$$
M_{-}(k) J(k) \sigma_{3}{\overline{M_{-}(k)}}^{T}=M_{-}(k) \sigma_{3} \overline{J(k)}^{T}{\overline{M_{-}(k)}}^{T}=0, \quad k \in \mathbb{R} .
$$

[^1]However, since no linear combination of $J \sigma_{3}$ and $\sigma_{3} \bar{J}^{T}$ is positive definite, we cannot conclude that $M_{-}=0$. More generally, proceeding as in the appendix of [20], we may consider a sectionally analytic function $G(k)$ defined by

$$
G(k)=M(k) H_{j}(k) \overline{M(\bar{k})}^{T}, \quad k \in D_{j}, \quad j=1, \ldots, 4,
$$

where $H_{j}(k)$ is any $2 \times 2$-matrix valued function which is analytic and bounded in $D_{j}$. The requirement that $G$ be continuous across $\partial D_{1}$ enforces the condition $J(k) H_{1}(k)=$ $\left.H_{2}(k) \overline{J(\bar{k}}\right)^{T}$ on $\partial D_{1}$, i.e.

$$
H_{2}(k)=\left(\begin{array}{cc}
1 & 0 \\
h(k) e^{-2 i k x+8 i k^{3} t} & 1
\end{array}\right) H_{1}(k)\left(\begin{array}{cc}
1 & 0 \\
h(k) e^{-2 i k x+8 i k^{3} t} & 1
\end{array}\right) .
$$

Since we want $H_{2}$ to be analytic and bounded in $D_{2}$ we assume that $H_{1}$ is traceless and lower triangular. Similarly, continuity across $\partial D_{4}$ enforces the condition $J(k) H_{3}(k)=$ $H_{4}(k) \overline{J(\bar{k})}^{T}$ on $\partial D_{4}$, so we need to assume that $H_{4}$ is traceless and upper triangular. Then $\mathrm{H}_{2}$ and $\mathrm{H}_{3}$ are also traceless and lower resp. upper triangular. The equations

$$
\begin{aligned}
& 0=\int_{\mathbb{R}} G_{+}(k) d k=\int_{\mathbb{R}} M_{-}(k) J(k) H_{3}(k){\overline{M_{-}(k)}}^{T} d k, \\
& 0=\int_{\mathbb{R}} G_{-}(k) d k=\int_{\mathbb{R}} M_{-}(k) H_{2}(k) \overline{J(k)}^{T}{\overline{M_{-}(k)}}^{T} d k,
\end{aligned}
$$

imply that

$$
\int_{\mathbb{R}} M_{-} X{\overline{M_{-}}}^{T} d k=0, \quad X:=c_{1} J H_{3}+c_{2}{\overline{H_{3}}}^{T} \bar{J}^{T}+c_{3} H_{2} \bar{J}^{T}+c_{4} J{\overline{H_{2}}}^{T}
$$

for any complex constants $\left\{c_{j}\right\}_{1}^{4}$. We seek $\left\{c_{j}\right\}_{1}^{4}$ such that $X$ is positive definite for $k \in \mathbb{R}$. Since $X$ is positive definite iff $\operatorname{Re} X$ is positive definite, it is enough to consider positive definiteness of

$$
Y:=d_{1} \operatorname{Re}\left(J H_{3}\right)+d_{2} \operatorname{Im}\left(J H_{3}\right)+d_{3} \operatorname{Re}\left(H_{2} \bar{J}^{T}\right)+d_{4} \operatorname{Im}\left(H_{2} \bar{J}^{T}\right),
$$

where $\left\{d_{j}\right\}_{1}^{4}$ are real coefficients. The matrix $Y$ is positive definite iff the inequalities $Y_{11}>0$ and $\operatorname{det} Y>0$ are satisfied. However, it appears that no real numbers $\left\{d_{j}\right\}_{1}^{4}$ and traceless lower resp. upper triangular matrices $H_{2}(k)$ and $H_{3}(k)$ fulfill these inequalities.

## Appendix A. $L^{2}$-Riemann-Hilbert problems

We collect some results on Smirnoff classes and $L^{2}$-RH problems; detailed proofs can be found in [27]. In the context of smooth contours, more information on $L^{2}-\mathrm{RH}$ problems can be found in [10, 13, 19, 38].

Assume $\Gamma=\partial D_{+}=-\partial D_{-}$is a Carleson jump contour. If $f \in \dot{E}^{2}\left(D_{+}\right)$or $f \in \dot{E}^{2}\left(D_{-}\right)$, then the nontangential limits of $f(z)$ as $z$ approaches the boundary exist a.e. on $\Gamma$ and the boundary function belongs to $L^{2}(\Gamma)$. If $h \in L^{2}(\Gamma)$, then the Cauchy transform $\mathcal{C} h$ defined by

$$
\begin{equation*}
(\mathcal{C} h)(z)=\frac{1}{2 \pi i} \int_{\Gamma} \frac{h(s)}{s-z} d s, \quad z \in \mathbb{C} \backslash \Gamma \tag{A.1}
\end{equation*}
$$

satisfies $\mathcal{C} h \in \dot{E}^{2}\left(D_{+} \cup D_{-}\right)$. We denote the nontangential boundary values of $\mathcal{C} f$ from the left and right sides of $\Gamma$ by $\mathcal{C}_{+} f$ and $\mathcal{C}_{-} f$ respectively. Then $\mathcal{C}_{+}$and $\mathcal{C}_{-}$are bounded operators on $L^{2}(\Gamma)$ and $\mathcal{C}_{+}-\mathcal{C}_{-}=I$. Given two functions $w^{ \pm} \in L^{2}(\Gamma) \cap L^{\infty}(\Gamma)$, we define the operator $\mathcal{C}_{w}: L^{2}(\Gamma)+L^{\infty}(\Gamma) \rightarrow L^{2}(\Gamma)$ by

$$
\begin{equation*}
\mathcal{C}_{w}(f)=\mathcal{C}_{+}\left(f w^{-}\right)+\mathcal{C}_{-}\left(f w^{+}\right) \tag{A.2}
\end{equation*}
$$

Then

$$
\begin{equation*}
\left\|\mathcal{C}_{w}\right\|_{\mathcal{B}\left(L^{2}(\Gamma)\right)} \leq C \max \left\{\left\|w^{+}\right\|_{L^{\infty}(\Gamma)},\left\|w^{-}\right\|_{L^{\infty}(\Gamma)}\right\} . \tag{A.3}
\end{equation*}
$$

where $C=\max \left\{\left\|\mathcal{C}_{+}\right\|_{\mathcal{B}\left(L^{2}(\Gamma)\right)},\left\|\mathcal{C}_{-}\right\|_{\mathcal{B}\left(L^{2}(\Gamma)\right)}\right\}<\infty$ and $\mathcal{B}\left(L^{2}(\Gamma)\right)$ denotes the Banach space of bounded linear maps $L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)$.

The next lemma shows that if $v=\left(v^{-}\right)^{-1} v^{+}$and $w^{ \pm}= \pm v^{ \pm} \mp I$ then the $L^{2}-\mathrm{RH}$ problem determined by $(\Gamma, v)$ is equivalent to the following singular integral equation for $\mu \in I+L^{2}(\Gamma):$

$$
\begin{equation*}
\mu-I=\mathcal{C}_{w}(\mu) \quad \text { in } \quad L^{2}(\Gamma) . \tag{A.4}
\end{equation*}
$$

Lemma A.1. Given $v^{ \pm}: \Gamma \rightarrow G L(n, \mathbb{C})$, let $v=\left(v^{-}\right)^{-1} v^{+}, w^{+}=v^{+}-I$, and $w^{-}=$ $I-v^{-}$. Suppose $v^{ \pm},\left(v^{ \pm}\right)^{-1} \in I+L^{2}(\Gamma) \cap L^{\infty}(\Gamma)$. If $m \in I+\dot{E}^{2}(\mathbb{C} \backslash \Gamma)$ satisfies the $L^{2}-R H$ problem determined by $(\Gamma, v)$, then $\mu=m_{+}\left(v^{+}\right)^{-1}=m_{-}\left(v^{-}\right)^{-1} \in I+L^{2}(\Gamma)$ satisfies (A.4). Conversely, if $\mu \in I+L^{2}(\Gamma)$ satisfies A.4), then $m=I+\mathcal{C}\left(\mu\left(w^{+}+w^{-}\right)\right) \in$ $I+\dot{E}^{2}(\mathbb{C} \backslash \Gamma)$ satisfies the $L^{2}-R H$ problem determined by $(\Gamma, v)$.
Lemma A.2. Given $v^{ \pm}: \Gamma \rightarrow G L(n, \mathbb{C})$, let $v=\left(v^{-}\right)^{-1} v^{+}, w^{+}=v^{+}-I$, and $w^{-}=$ $I-v^{-}$. Suppose $v^{ \pm},\left(v^{ \pm}\right)^{-1} \in I+L^{2}(\Gamma) \cap L^{\infty}(\Gamma)$ and $v^{ \pm} \in C(\Gamma)$. If $w^{ \pm}$are nilpotent matrices, then each of the following four statements implies the other three:
(a) The map $I-\mathcal{C}_{w}: L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)$ is bijective.
(b) The $L^{2}$-RH problem determined by $(\Gamma, v)$ has a unique solution.
(c) The homogeneous $L^{2}-R H$ problem determined by $(\Gamma, v)$ has only the zero solution.
(d) The map $I-\mathcal{C}_{w}: L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)$ is injective.

Lemma A. 3 (Uniqueness). Suppose $v: \Gamma \rightarrow G L(2, \mathbb{C})$ satisfies $\operatorname{det} v=1$ a.e. on $\Gamma$. If the solution of the $L^{2}-R H$ problem determined by $(\Gamma, v)$ exists, then it is unique and has unit determinant.
Lemma A.4. Let $D$ be a subset of $\widehat{\mathbb{C}}$ bounded by a curve $\Gamma \in \mathcal{J}$ and let $f: D \rightarrow \mathbb{C}$ be an analytic function. Suppose there exist curves $\left\{C_{n}\right\}_{1}^{\infty} \subset \mathcal{J}$ in $D$, tending to $\Gamma$ in the sense that $C_{n}$ eventually surrounds each compact subset of $D \subset \widehat{\mathbb{C}}$, such that $\sup _{n \geq 1} \int_{C_{n}}\left|z-z_{0}\right|^{p-2}|f(z)|^{p}|d z|<\infty$. Then $f \in \dot{E}^{p}(D)$.
Lemma A. 5 (Contour deformation). Let $\gamma \in \mathcal{J}$. Suppose that, reversing the orientation on a subcontour if necessary, $\hat{\Gamma}=\Gamma \cup \gamma$ is a Carleson jump contour. Let $B_{+}$and $B_{-}$be the two components of $\widehat{\mathbb{C}} \backslash \gamma$. Let $\hat{D}_{ \pm}$be the open sets such that $\hat{\mathbb{C}} \backslash \hat{\Gamma}=\hat{D}_{+} \cup \hat{D}_{-}$and $\partial \hat{D}_{+}=-\partial \hat{D}_{-}=\hat{\Gamma}$. Let $\hat{D}=\hat{D}_{+} \cup \hat{D}_{-}$. Let $\gamma_{+}$and $\gamma_{-}$be the parts of $\gamma$ that belong to the boundary of $\hat{D}_{+} \cap B_{+}$and $\hat{D}_{-} \cap B_{+}$, respectively. Suppose $v: \Gamma \rightarrow G L(n, \mathbb{C})$. Suppose $m_{0}: \hat{D} \cap B_{+} \rightarrow G L(n, \mathbb{C})$ satisfies

$$
\begin{equation*}
m_{0}, m_{0}^{-1} \in I+\dot{E}^{2}\left(\hat{D} \cap B_{+}\right) \cap E^{\infty}\left(\hat{D} \cap B_{+}\right) . \tag{A.5}
\end{equation*}
$$

Define $\hat{v}: \hat{\Gamma} \rightarrow G L(n, \mathbb{C})$ by

$$
\hat{v}=\left\{\begin{array}{lll}
m_{0-} v m_{0+}^{-1} & \text { on } & \Gamma \cap B_{+}, \\
m_{0+}^{-1} & \text { on } & \gamma_{+}, \\
m_{0-} & \text { on } & \gamma_{-}, \\
v & \text { on } & \Gamma \cap B_{-}
\end{array}\right.
$$

Let $m$ and $\hat{m}$ be related by

$$
\hat{m}=\left\{\begin{array}{lll}
m m_{0}^{-1} & \text { on } & \hat{D} \cap B_{+}  \tag{A.6}\\
m & \text { on } & \hat{D} \cap B_{-}
\end{array}\right.
$$

Then $m(z)$ satisfies the $L^{2}$-RH problem determined by $(\Gamma, v)$ if and only if $\hat{m}(z)$ satisfies the $L^{2}$-RH problem determined by $(\hat{\Gamma}, \hat{v})$.
Lemma A.6. Let $D$ be a subset of $\widehat{\mathbb{C}}$ bounded by a curve $\Gamma \in \mathcal{J}$. Let $m \geq 1$ be an integer and let $\left\{f_{j}\right\}_{1}^{m}$ be functions in $\dot{E}^{m}(D)$. Let $f=\prod_{j=1}^{m} f_{j}$. Then $f \in \dot{E}^{1}(D)$ and

$$
\begin{equation*}
\int_{\Gamma} \frac{f_{+}(z)}{\left(z-z_{0}\right)^{n-m+2}} d z=0, \quad n=0,1, \ldots \tag{A.7}
\end{equation*}
$$

Proof. Let $z_{0} \in \mathbb{C} \backslash \bar{D}$ and let $\varphi(z)=\frac{1}{z-z_{0}}$. By Proposition 3.6 in [27], the assumption $f_{j} \in \dot{E}^{m}(D)$ is equivalent to $w^{-1} f_{j}\left(\varphi^{-1}(w)\right) \in \dot{E}^{m}(\varphi(D))$. Thus, by Lemma 3.8 in [27], $w^{-m} f\left(\varphi^{-1}(w)\right)^{m} \in \dot{E}^{1}(\varphi(D))=E^{1}(\varphi(D))$. According to Theorem 10.4 of [14],

$$
\int_{\varphi(\Gamma)} w^{n-m} f_{+}\left(\varphi^{-1}(w)\right)^{m} d w=0, \quad n=0,1, \ldots
$$

The change of variables $w=\varphi(z)$ yields A.7).
