# ON A RELATIVE MUMFORD-NEWSTEAD THEOREM 

SURATNO BASU


#### Abstract

In this paper, we prove a relative version of the classical Mumford-Newstead theorem for a family of smooth curves degenerating to a reducible curve with a simple node. We also prove a Torelli-type theorem by showing that certain moduli spaces of torsion free sheaves on a reducible curve allows us to recover the curve from the moduli space.


## 1. Introduction

Let $X$ be a smooth, projective curve of genus $g \geq 2$ over $\mathbb{C}$. We fix a line bundle $L$ of odd degree over $X$. Let $M_{X}$ be the moduli space of rank 2, stable vector bundles $E$ such that $\operatorname{det} E \simeq L$. It is known that $M_{X}$ is a smooth, projective and unirational variety. Consequently it follows, by [20, Lemma 1], that the Hodge numbers $h^{0, p}=h^{p, 0}=0$. Therefore, we have the following Hodge decomposition:

H^{3}\left(M_{X}, \mathbb{C}\right)=H^{1,2} \oplus \overline{H^{1,2}}
$$

where $\bar{\alpha}$ is the complex conjugate of $\alpha \in H^{3}\left(M_{X}, \mathbb{C}\right)=H^{3}\left(M_{X}, \mathbb{R}\right) \otimes \mathbb{C}$ and $H^{1,2} \simeq H^{2}\left(M_{X}, \Omega_{M_{X}}^{1}\right)$. Let $p r_{1}: H^{3}\left(M_{X}, \mathbb{C}\right) \rightarrow H^{1,2}$ be the first projection. Since $H^{3}\left(M_{X}, \mathbb{R}\right) \cap H^{1,2}=\{0\}$, we get that the image $\operatorname{pr}_{1}\left(H^{3}\left(M_{X}, \mathbb{Z}\right)\right)$ is a full lattice in $H^{1,2}$. We associate a complex torus corresponding to the above Hodge structure:

J^{2}\left(M_{X}\right):=\frac{H^{1,2}}{p r_{1}\left(H^{3}\left(M_{X}, \mathbb{Z}\right)\right)} \tag{1.0.1}
\end{equation*}

It is known as the second intermediate Jacobian of $M_{x}$. We remark that the complex torus, defined above, varies holomorphically in an analytic family of smooth projective, unirational varieties and is a principally polarised abelian variety. It is known that the second Betti number $b_{2}\left(M_{X}\right)=1$ ([15]). Let $\omega$ be the unique ample, integral, Kähler class on $M_{X}$. Then the principal polarisation on $J^{2}\left(M_{X}\right)$ is induced by the following paring:

\end{equation*}

where $\alpha, \beta \in H^{1,2}$ and $n=\operatorname{dim}_{\mathbb{C}} M_{X}$. We denote this polarisation on $J^{2}\left(M_{X}\right)$ by $\theta^{\prime}$. The theorem of Mumford and Newstead ([12, Theorem in page 1201]) asserts that there is a natural isomorphism $\phi: J(X) \rightarrow J^{2}\left(M_{X}\right)$ such that $\phi^{*}\left(\theta^{\prime}\right)=$ $\theta$, where $J(X)$ is the Jacobian of the curve and $\theta$ is the canonical polarisation on $J(X)$. In [2, Section 5, page 625]) there is a detailed proof of the fact $\phi^{*}\left(\theta^{\prime}\right)=\theta$. Hence, appealing to the classical Torelli theorem one can recover the curve $X$ from the moduli space $M_{X}$.

Let $X_{0}$ be a projective curve with exactly two smooth irreducible components $X_{1}$ and $X_{2}$ meeting at a simple node $p$. Fix two rational numbers $0<$
$a_{1}, a_{2}<1$ such that $a_{1}+a_{2}=1$ and let $\chi$ be an odd integer. Under some numerical conditions, Nagaraj and Seshadri construct in [13, Theorem 4.1], the moduli space $M\left(2,\left(a_{1}, a_{2}\right), \chi\right)$ of rank $2,\left(a_{1}, a_{2}\right)$-semistable torsion free sheaves on $X_{0}$ with Euler charachteristic $\chi$. Moreover, they show that $M\left(2,\left(a_{1}, a_{2}\right), \chi\right)$ is the union of two smooth, projective varieties intersecting transversally along a smooth divisor. We will observe that there exists a determinant morphism det: $M\left(2,\left(a_{1}, a_{2}\right), \chi\right) \rightarrow J^{\chi-(1-g)}\left(X_{0}\right)$ where $J^{\chi-(1-g)}\left(X_{0}\right)$ is the Jacobian parametrising the line bundles with Euler characteristic $\chi-(1-g)$ over $X_{0}$ (see Proposition 6.4 in Appendix). We further observe that the fibres of the morphism det is again the union of two smooth projective varieties intersecting transversally (see Proposition 6.5 in Appendix). Fix $\xi \in J^{\chi-(1-g)}$. We denote the fibre $\operatorname{det}^{-1}(\xi)$ by $M_{0, \xi}$. Since $M_{0, \xi}$ is a singular variety, a priori $H^{3}\left(M_{0, \xi}, \mathbb{C}\right)$ has an intrinsic mixed Hodge structure. Let $g$ be the arithmetic genus of $X_{0}$. Note that $g=g_{1}+g_{2}$, where $g_{i}$ is the genus of $X_{i}$ for $i=1,2$. Under the assumption $g_{i}>3, i=1,2$, we will show that $H^{3}\left(M_{0, \xi}, \mathbb{Q}\right) \simeq \mathbb{Q}^{2 g}$, and that it has a pure Hodge structure with Hodge numbers $h^{3,0}=h^{0,3}=0$. Thus we have an intermediate Jacobian $J^{2}\left(M_{0, \xi}\right)$, as defined earlier, corresponding to the Hodge structure on $H^{3}\left(M_{0, \xi}, \mathbb{C}\right)$ which is a priori only a complex torus of dimension $g$.

Let $\pi: \mathscr{X} \rightarrow C$ be a proper, flat and surjective family of curves, parametrised by a smooth, irreducible curve $C$. Fix $0 \in C$. We assume that $\pi$ is smooth outside the point 0 and $\pi^{-1}(0)=X_{0}$, where $X_{0}$ is as above, $g_{i}>3$ for $i=1,2$. Let $X_{t}$ be the fibre $\pi^{-1}(t)$ over $t \in C$. Fix a line bundle $\mathscr{L}$ over $\mathscr{X}$ such that the restrictions $\mathscr{L}_{t}$ to $X_{t}$ are line bundles with Euler characteristics $\chi-(1-g)$ for $t \neq 0$ and $\mathscr{L}_{0}$ is isomorphic to the line bundle $\xi$. In this situation, it is observed in [13, Lemma 7.2] that there is a family $\pi^{\prime}: \mathscr{M}_{\mathscr{L}} \rightarrow C$ such that the fibre $\pi^{\prime-1}(t)$ over a point $t \neq 0$ is $M_{t, \mathscr{L}_{t}}$, the moduli space of rank 2 , semistable locally free sheaves with $d e t \simeq \mathscr{L}_{t}$ over the smooth projective curve $X_{t}$ and $\pi^{\prime-1}(0)=M_{0, \xi}$ (see Section 6.3.1). We should mention a related work by X Sun [23]. In [23] the author constructs a family of rank $r$ fixed determinant, semistable bundles over smooth projective curves degenerating to a "fixed determinant" moduli space of rank $r$ torsion free sheaves over $X_{0}$. Though his methods are different we believe, in rank 2 case, the relative moduli space in [23] coincides with $\mathscr{M}_{\mathscr{L}}$. We consider an analytic disc $\Delta$ around the point 0 and we denote the family $\pi^{\prime}: \pi^{\prime-1}(\Delta) \rightarrow \Delta$ by $\left\{M_{t, \mathscr{L}_{t}}\right\}_{t \in \Delta}$.

With these notations we state one of the main results of this paper :

## Theorem 1.1.

(1) There is a holomorphic family $\left\{J^{2}\left(M_{\left.t, \mathscr{L}_{t}\right)}\right\}_{t \in \Delta}\right.$ of intermediate Jacobians corresponding to the family $\left\{M_{t, \mathscr{L}_{t}}\right\}_{t \in \Delta}$. In other words, there is a surjective, proper, holomorphic submersion

\pi_{2}: J^{2}\left(\mathscr{M}_{\mathscr{L}}\right) \longrightarrow \Delta
$$

such that $\pi_{2}^{-1}(t)=J^{2}\left(M_{t, \mathscr{Y}_{t}}\right) \forall t \in \Delta^{*}:=\Delta \backslash\{0\}$ and $\pi_{2}^{-1}(0)=J^{2}\left(M_{0, \xi}\right)$. Further, there exists a relative ample class $\Theta^{\prime}$ on $J^{2}\left(\mathscr{M}_{\mathscr{L}}\right)_{\mid \Delta^{*}}$ such that $\Theta_{\mid J^{2}\left(M_{t, \mathscr{L}_{t}}\right)}^{\prime}=\theta_{t}^{\prime}$, where $\theta_{t}^{\prime}$ is the principal polarisation on $J^{2}\left(M_{\left.t, \mathscr{L}_{t}\right)}\right)$.
(2) There is an isomorphism

such that $\Phi^{*} \Theta_{\mid \pi_{1}^{-1}(t)}^{\prime}=\theta_{t}$ for all $t \in \Delta^{*}$, where $\pi_{1}: J^{0}(\mathscr{X}) \rightarrow \Delta$ is the holomorphic family $\left\{J^{0}\left(X_{t}\right)\right\}_{t \in \Delta}$ of Jacobians and $\theta_{t}$ is the canonical polarisation on $J^{0}\left(X_{t}\right)$. In particular $J^{2}\left(\mathscr{M}_{\mathscr{L}}\right)_{0}:=\pi_{2}^{-1}(0)$ is an abelian variety.
By the above theorem we deduce the following:
Corollary 1.2. Let $X_{0}$ be a projective curve with exactly two smooth irreducible components $X_{1}$ and $X_{2}$ meeting at a simple node $p$. We further assume that $g_{i}>3, i=1,2$. Then, there is an isomorphism $J^{0}\left(X_{0}\right) \simeq J^{2}\left(M_{0, \xi}\right)$, where $\xi \in J^{\chi}\left(X_{0}\right)$. In particular, $J^{2}\left(M_{0,5}\right)$ is an abelian variety.
Since $J^{0}\left(X_{0}\right)$ is isomorphic to $J^{0}\left(X_{1}\right) \times J^{0}\left(X_{2}\right)$, we observe the Jacobian $J^{0}\left(X_{0}\right)$ is independent of the nodal point in $X_{0}$. Hence, the classical Torelli theorem fails for such curves (see [10, Page 6 ]). On the other hand, it is known that under suitable choice of the polarisation on the Jacobian $J^{0}\left(X_{0}\right)$, one can recover the normalization $\tilde{X}_{0}$ of $X_{0}$, but not the curve $X_{0}$. In otherwords one can recover both the components of $X_{0}$ but not the nodal point(see [8, page 125]).
We see that the moduli space $M_{0, \xi}$ of rank 2 torsion free sheaves carries more information than the Jacobian $J\left(X_{0}\right)$. In fact, we show that we can actually recover the curve $X_{0}$ from $M_{0, \xi^{\prime}}$ by following a strategy of [3]. More precisely, we will prove the following analogue of the Torelli theorem for reducible curves:

Theorem 1.3. Let $X_{0}\left(\right.$ resp. $\left.Y_{0}\right)$ be the projective curve with two smooth irreducible components $X_{i}$ (resp. $Y_{i}$ ), $i=1,2$ meeting at a simple node $p$ (resp. q). We assume that genus $\left(X_{i}\right)=\operatorname{genus}\left(Y_{i}\right)$, for $i=1,2$, and $X_{1} \not \not X_{2}\left(\right.$ resp. $Y_{1} \not \not Y_{2}$ ). Let $M_{0, \xi_{X_{0}}}$ (resp. $M_{0, \xi_{Y_{0}}}$ ) be the moduli space of rank 2, semistable torsion free sheaves $E$ with det $E \simeq \xi_{X_{0}}, \xi_{X_{0}} \in J^{\chi}\left(X_{0}\right)$, on $X_{0}$ (resp. on $Y_{0}$ ). If $M_{0, \xi_{X_{0}}} \simeq M_{0, \xi_{Y_{0}}}$ then we have $X_{0} \simeq Y_{0}$.

## 2. Preliminaries

In this section, we briefly recall the main results in [13] which will be extensively used in the present work. Before proceeding further we will fix the following notations:

### 2.0.1. Notation.

- Throughout we work over the field $\mathbb{C}$ of complex numbers. We assume that all the schemes are reduced, separated and finite type over $\mathbb{C}$.
- Let $p_{i}: X_{1} \times \cdots \times X_{n} \rightarrow X_{i}$ be the $i^{\text {th }}$ projection, where $X_{i}$ is a scheme for $i=1, \ldots, n$. By abuse of notation, we denote $p_{i}^{*}\left(E_{i}\right)$ also by $E_{i}$, where $E_{i}$ is a sheaf of $\mathscr{O}_{X_{i}}$ module.
- Let $X$ be a projective scheme and $E$ be a vector bundle over $X$. Then we set $h^{i}(E):=\operatorname{dim}_{\complement} H^{i}(X, E)$. Let $S$ be another projective scheme and $\mathscr{E}$ be a coherent sheaf over $X \times S$ then we set $\mathscr{E}_{s}:=\left.\mathscr{E}\right|_{X \times s}, s \in S$.
- By cohomology of a scheme $X$, we mean the singular cohomology of the space $X_{a n n}$, the analytic space with complex analytic topology associated to $X$.
- Let $E$ be coherent sheaf over $X$. We denote by $E(p):=\frac{E_{p}}{m_{p} E_{p}}$ the fibre of E at $p \in X$.
- Let $X$ be a smooth projective curve and $E$ be a vector bundle over $X$. Then we denote $E \otimes \mathscr{O}_{X}(n p)$ by $E(n p)$, where $p \in X$ is a closed point and $n$ is an integer.
- If $Z$ is a closed subvariety of a smooth variety $X$, then we denote by $\operatorname{Codim}(Z, X)$, the codimension of $Z$ in $X$.
2.1. Triples associated to a torsion free sheaves on a reducible nodal curve. Let $X_{0}$ be a projective curve of arithmetic genus $g$ with exactly two smooth irreducible components $X_{1}$ and $X_{2}$ meeting at a simple node $p$. The arithmetic genus $g$ of such a curve is $g=g_{1}+g_{2}$, where $g_{i}$ is the genus of $X_{i}$ for $i=1,2$.

By a torsion free sheaf over $X_{0}$ we always mean a coherent $\mathscr{O}_{X_{0}}$-module of depth 1. Let $\vec{C}$ be a category whose objects are triples $\left(F_{1}, F_{2}, A\right)$ where $F_{i}$ are vector bundles on $X_{i}$, for $i=1,2$ and $A: F_{1}(p) \rightarrow F_{2}(p)$ is a linear map. Let $\left(F_{1}, F_{2}, A\right),\left(G_{1}, G_{2}, B\right) \in \vec{C}$. We say $\phi:\left(F_{1}, F_{2}, A\right) \rightarrow\left(G_{1}, G_{2}, B\right)$ is a morphism if there are morphisms $\phi_{i}: F_{i} \rightarrow G_{i}$ of $\mathscr{O}_{X_{i}}$-modules for $i=1,2$ such that the following diagram is commutative:

In [13, Lemma 2.8], it is shown that there is an equivalence of categories between $\vec{C}$ and the category of torsion free sheaves over $X_{0}$.

Remark 2.1. Similarly, we define another category $\overleftarrow{\leftarrow}$ whose objects are triples $\left(F_{1}, F_{2}, A\right)$ where $F_{i}$ are vector bundles over $X_{i}$ for $i=1,2$ and $A: F_{2}(p) \rightarrow F_{1}(p)$ is a linear map. The morphism between any two such triples is defined in the same way before. The category of torsion free sheaves is equivalent to the category $\overleftarrow{C}$ (see [13, Remark 2.9]). Now if the triples $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ and $\left(F_{1}^{\prime}, F_{2}^{\prime}, B\right) \in \stackrel{\leftarrow}{C}$ correspond the same torsion free sheaf $F$, then they are related by the following
diagram:

where $i: F_{1} \rightarrow F_{1}^{\prime}$ (resp. $j: F_{2}^{\prime} \rightarrow F_{2}$ ) is a morphism of vector bundle which is an isomorphism outside the point $p$ and $\operatorname{ker}\left(i_{p}\right)=\operatorname{ker}(A) \operatorname{resp} \operatorname{Im}\left(j_{p}\right)=$ $\operatorname{Im}(A))\left(\right.$ see [13, Remark 2.5]). $F_{i}^{\prime}$ is called the Hecke-modification of $F_{i}$ for $i=1,2$.
2.1.1. Notion of semistability. Fix an ample line bundle $\mathscr{O}_{X_{0}}(1)$ on $X_{0}$. Let $\operatorname{deg}\left(\left.\mathscr{O}_{X_{0}}(1)\right|_{X_{i}}\right)=c_{i}, i=1,2$, and $a_{i}=\frac{c_{i}}{c_{1}+c_{2}}$. Then $0<a_{1}, a_{2}<1$ and $a_{1}+a_{2}=1$. We say $a=\left(a_{1}, a_{2}\right)$ a polarisation on $X_{0}$. A torsion free sheaf $F$ on $X_{0}$ is of rank type $\left(r_{1}, r_{2}\right)$ if the generic rank of the restrictions $\left.F\right|_{X_{i}}$ are $r_{i}, i=1,2$.

Definition 1. For a torsion free sheaf $F$ of rank type $\left(r_{1}, r_{2}\right)$, we define the rank $r:=a_{1} r_{1}+a_{2} r_{2}$ and the slope $\mu(F):=\frac{\chi(F)}{r}$, where $\chi(F):=h^{0}(F)-h^{1}(F)$. A torsion free sheaf $F$ is said to be semistable(resp. stable) with respect to the polarisation $a=\left(a_{1}, a_{2}\right)$ if $\mu(G) \leq \mu(F)($ resp. <) for all nontrivial proper subsheaves $G$ of $F$. We define the Euler characteristic and the slope of a triple $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ to be:

\chi\left(\left(F_{1}, F_{2}, A\right)\right)=\chi\left(F_{1}\right)+\chi\left(F_{2}\right)-r k\left(F_{2}\right) \text { and } \mu\left(F_{1}, F_{2}, A\right)=\frac{\chi\left(\left(F_{1}, F_{2}, A\right)\right)}{r} \tag{2.1.3}
\end{equation*}
$$

A triple $\left(F_{1}, F_{2}, A\right)$ is said to be semistable(resp. stable) if $\mu\left(G_{1}, G_{2}, B\right) \leq$ $\mu\left(F_{1}, F_{2}, A\right)$ for all nontrivial proper subtriples of $\left(F_{1}, F_{2}, A\right)$ (for definition of a subtriple see [13, Definition 2.3]).

Remark 2.2. If a torsion free sheaf $F$ is associated to a triple $\left(F_{1}, F_{2}, A\right)$ then $\chi(F)=\chi\left(F_{1}, F_{2}, A\right)$ (see [13, Remark 2.11]). We have already remarked the category of torsion free sheaves is equivalent to the category of triples in a fixed direction. Therefore, a torsion free sheaf $F$ is $a=\left(a_{1}, a_{2}\right)$-semistable (resp. stable) if and only if the corresponding triple $\left(F_{1}, F_{2}, A\right)$ is $a=\left(a_{1}, a_{2}\right)$-semistable (resp. stable).
2.2. Moduli space of rank 2 torsion free sheaves over a reducible nodal curve.
2.2.1. Euler Characteristic bounds for rank 2 semistable sheaves. Fix an integer $\chi$ and a polarisation $a=\left(a_{1}, a_{2}\right)$ on $X_{0}$ such that $a_{1} \chi$ is not an integer. Then we have the following Euler characteristic restrictions:

Lemma 2.1. Let $\chi_{1}, \chi_{2}$ be the unique integers satisfying

\begin{equation*}
a_{1} \chi<\chi_{1}<a_{1} \chi+1, a_{2} \chi+1<\chi_{2}<a_{2} \chi+2 \tag{2.2.1}
\end{equation*}
$$

and $\chi=\chi_{1}+\chi_{2}-2$. If $F$ is a rank $2, a=\left(a_{1}, a_{2}\right)$-semistable sheaf then $\chi\left(F_{1}\right)=\chi_{1}$, $\chi\left(F_{2}\right)=\chi_{2}$ or $\chi\left(F_{1}\right)=\chi_{1}+1, \chi\left(F_{2}\right)=\chi_{2}-1$ and $r k(A) \geq 1$ where $\left(F_{1}, F_{2}, A\right) \in C$ is the unique triple representing $F$. Moreover if $F$ is non-locally free then $\chi\left(F_{1}\right)=\chi_{1}$ and $\chi\left(F_{2}\right)=\chi_{2}$.

Proof. See [13, Theorem 3.1].

For the rest of the paper we fix an odd integer $\chi$ and a polarization $a:=$ $\left(a_{1}, a_{2}\right)\left(a_{1}<a_{2}\right)$ on $X_{0}$ such that $a_{1} \chi$ is not an integer. With these notations, one of the main results of [13] is the following:

Theorem 2.2. ([13, Theorem 4.1]) The moduli space $M(2, a, \chi)$ of isomorphism classes rank 2, $\left(a_{1}, a_{2}\right)$ stable torsion free sheaves exists as a reduced,connected, projective scheme. Moreover, it has two smooth, irreducible components meeting transversally along a smooth divisor $D$.
2.3. Fixed determinant moduli space. Let $J^{\chi_{i}-\left(1-g_{i}\right)}\left(X_{i}\right)$ be the Jacobian of isomorphism classes of line bundles over $X_{i}$ with Euler characteristic $\chi_{i}$ - (1$\left.g_{i}\right), i=1,2$ and $J_{0}:=J^{\chi_{1}-\left(1-g_{1}\right)}\left(X_{1}\right) \times J^{\chi_{2}-\left(1-g_{2}\right)}\left(X_{2}\right)$. In the Appendix we will show that there is a well defined determinant morphism det: $M(2, a, \chi) \rightarrow J_{0}$ whose fibres are again the union of two sooth, projective varieties intersecting transversally along a smooth divisor ( see Proposition 6.4).
2.4. Moduli space of triples. Fix $\xi \in J_{0}$ and let $\operatorname{det}^{-1}(\xi):=M_{0, \xi}$. In this subsection we will discuss a different description of the moduli spaces $M(2, a, \chi)$ and $M_{0, \xi}$ in terms of certain moduli space of triples glued along a certain divisor. This description is given in section 5 of the article [13]. This description will be useful for the cohomology computations later.

The following facts are well known. For the completeness we shall indicate a proof.

Fact 2.1. Let $(X, x)$ be a smooth,projective curve together with a marked point $x$ and $\left(E, 0 \subset F^{2} E(x) \subset E(x)\right)$ be a parabolic vector bundle with weights $0<\beta_{1}<$ $\beta_{2}<1$. Suppose the weights satisfy $\left|\beta_{1}-\beta_{2}\right|<\frac{1}{2}$. Then we have-
(a) $E$ is parabolic semistable implies $E$ is parabolic stable.
(b) $E$ is parabolic semistable implies $E$ is semistable.
(c) If $E$ is stable then any quasi parabolic structure $\left(E, 0 \subset F^{2} E(x) \subset E(x)\right)$ is parabolic semistable with respect to the weights $0<\beta_{1}<\beta_{2}<1$.

Proof. From our assumption on weights we get that $\left|\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i}\right|<\frac{1}{2}$ for $i=1,2$. Suppose $E$ is strictly parabolic semistable. Let $L$ be a parabolic line subbundle of $E$. Then we have-

$$
\operatorname{deg}(L)=\frac{\operatorname{deg}(E)}{2}+\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i} .
$$

Since $\left|\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i}\right|<\frac{1}{2}$ and $\operatorname{deg}(L)$ is an integer this is not possible. This completes the proof of $(a)$. Let $L$ be a line subbundle of $E$. The parabolic stability of $E$ implies

$$
\operatorname{deg}(L)<\frac{\operatorname{deg}(E)}{2}+\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i} .
$$

Therefore, $\operatorname{deg}(L)<\frac{\operatorname{deg}(E)}{2} \pm \frac{1}{2}$. Since $\operatorname{deg}(L)$ is an integer the above inequality will imply $\operatorname{deg}(L) \leq \frac{\operatorname{deg}(E)}{2}$. This completes the proof of $(b)$. Let $L$ be a subbundle of $E$. If $L(x) \cap F^{2} E(x) \neq 0$ then we associate the weight $\beta_{1}$ otherwise we associate the weight $\beta_{2}$. Now as $E$ is stable we have

$$
\operatorname{deg}(L)<\frac{\operatorname{deg}(E)}{2} .
$$

Since $\left|\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i}\right|<\frac{1}{2}$ and $\operatorname{deg}(L)$ is an integer we conclude that

$$
\operatorname{deg}(L)<\frac{\operatorname{deg}(E)}{2}+\frac{\beta_{1}+\beta_{2}}{2}-\beta_{i} .
$$

This completes the proof of $(c)$.
The following result is proved in [13]
Fact 2.2. Let $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ (resp. $\left.\left(F_{1}^{\prime}, F_{2}^{\prime}, B\right) \in \stackrel{\leftarrow}{C}\right)$ be a rank $2,\left(a_{1}, a_{2}\right)$-semistable and the Euler characteristic $\chi\left(F_{i}\right), i=1,2$, satisfy the inequality 2.2.1(resp. the inequality 2.4.2, then $F_{i}\left(\right.$ resp. $F_{i}^{\prime}$ ) are semistable over $X_{i}$ for $i=1,2$ (see [13, Theorem 5.1]).

Conversely we have the following:
Lemma 2.3. Let $F_{i}$ be rank 2 semistable bundles over $X_{i}$ and the Euler characteristic $\chi\left(F_{i}\right), i=1,2$, satisfy the inequalities 2.2.1. Let $A: F_{1}(p) \rightarrow F_{2}(p)$ be a linear map and $r k(A)=2$, then $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ is $\left(a_{1}, a_{2}\right)$-semistable. Moreover, if $F_{1}$ and $F_{2}$ are both stable then $\left(F_{1}, F_{2}, A\right)$ is $\left(a_{1}, a_{2}\right)$-semistable if $r k(A) \geq 1$.
Proof. Case 1: Let $r k(A)=2$ The proof of the statement (1) follows from [6, Lemma 3.1.12 page 39]. Now suppose $r k(A)=1$. In this case we need both $F_{i}$ to be stable.

Since $\operatorname{rk}(A)=1$ we get a parabolic structure on $F_{1}$ given by $0 \subset \operatorname{ker}(A) \subset$ $F_{1}(p)$ and a parabolic structure on $F_{2}(p)$ given by $0 \subset \operatorname{Im}(A) \subset F_{2}(p)$. By Fact $2.1(c)$ we conclude that the above two quasi parabolic structure are parabolic stable with respect to the weights $0<\frac{a_{1}}{2}<\frac{a_{2}}{2}<1$. Thus by [13, Theorem 6.1] we get that $\left(F_{1}, F_{2}, A\right)$ is semistable.
Remark 2.3. The same results hold true for the triples in the other direction i.e if $F_{i}$ are semistable over $X_{i}, i=1,2$ satisfying the inequality 2.4.2 and $r k(A)=2$ then the triple $\left(F_{1}, F_{2}, A\right) \in \overleftarrow{C}$ is $\left(a_{1}, a_{2}\right)$-semistable. Moreover, if $F_{i}$ are stable and $r k(A) \geq 1$ then $\left(F_{1}, F_{2}, A\right) \in \overleftarrow{C}$ is $\left(a_{1}, a_{2}\right)$-semistable.
(I) Semistable triple of type (I): We say a rank 2, $\left(a_{1}, a_{2}\right)$-semistable triple $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ is of type $(I)$ if $\chi\left(F_{i}\right), i=1,2$, satisfy the following inequalities:

$$
\begin{equation*}
a_{1} \chi<\chi_{X_{1}}\left(F_{1}\right)<a_{1} \chi+1, a_{2} \chi+1<\chi_{X_{2}}\left(F_{2}\right)<a_{2} \chi+2 \tag{2.4.1}
\end{equation*}
$$

and $r k(A) \geq 1$.
(II) Semistable triple of type (II): We say a $\left(a_{1}, a_{2}\right)$-semistable triple $\left(F_{1}, F_{1}, B\right) \in \overleftarrow{C}$ is of type $(I I)$ if $\chi\left(F_{i}\right), i=1,2$ satisfy the following inequalities:

$$
\begin{equation*}
a_{1} \chi+1<\chi_{X_{1}}\left(F_{1}^{\prime}\right)<a_{1} \chi+2, a_{2} \chi<\chi_{x_{2}}\left(F_{2}^{\prime}\right)<a_{2} \chi+1 \tag{2.4.2}
\end{equation*}
$$

and $r k(B) \geq 1$.
Let $S$ be a scheme. We say $\left(\mathscr{F}_{1}, \mathscr{F}_{2}, \mathscr{A}\right)$ a family of triples parametrised by $S$ if $\mathscr{F}_{i}$ 's are locally free sheaves on $X_{i} \times S, i=1,2$ and $\mathscr{A}:\left.\left.\mathscr{F}_{1}\right|_{p \times S} \rightarrow \mathscr{F}_{2}\right|_{p \times S}$ is a $\mathscr{O}_{S}$-module homomorphism of locally free sheaves.

Remark 2.4. Given a family of triples $\left(\mathscr{F}_{1}, \mathscr{F}_{2}, \mathscr{A}\right)$ parametrised by $S$ we can associate a family of torsion free sheaves $\mathscr{F}$ parametrised by $S$ i.e a coherent sheaf $\mathscr{F}$ on $X_{0} \times S$ which is flat over $S$ such that $\mathscr{F}_{s}$ is torsion free for all $s \in S$. The association is the following: Let $G$ be the locally free subsheaf of $\left.\left.\mathscr{F}_{1}\right|_{p \times s} \oplus \mathscr{F}_{2}\right|_{p \times s}$
generated by the graph of the homomorphism $\mathscr{A}$ and $\mathscr{L}_{s}:=\frac{\left.\left.\mathscr{F}_{1}\right|_{p \times S} \oplus \mathscr{F}_{2}\right|_{p \times S}}{G}$. Consider the exact sequence-

$$
0 \rightarrow \mathscr{F} \rightarrow \mathscr{F}_{1} \oplus \mathscr{F}_{2} \rightarrow \mathscr{L}_{S} \rightarrow 0 .
$$

Since, $\mathscr{F}_{1} \oplus \mathscr{F}_{2}$ and $\mathscr{L}_{S}$ are both flat over $S$. Hence $\mathscr{F}$ is flat over $S$.
In [13, Theorem 5.3] it is shown that there is a smooth, irreducible projective variety which has the coarse moduli property for family of semistable triple of type $I$. We denote this space by $M_{12}$. By the same construction one can construct another smooth, irreducible, projective variety which has the coarse moduli property of semistable triples of type (II). We denote this space by $M_{21}$. Let

$$
D_{1}:=\left\{\left[\left(F_{1}, F_{2}, A\right) \in M_{12} \mid \operatorname{rk}(A)=1\right\} .\right.
$$

and

$$
D_{2}:=\left\{\left[\left(F_{1}^{\prime}, F_{2}^{\prime}, B\right)\right] \in M_{21} \mid r k(B)=1\right\} .
$$

Then, by [13, Theorem 6.1] it follows $D_{1}$ (resp. $D_{2}$ ) is a smooth divisor in $M_{12}$ (resp. $M_{21}$ ). Now if $\left(F_{1}, F_{2}, A\right) \in \vec{C}$ and $r k(A)=1$, then by Remark 2.1, we get a unique triple $\left(F_{1}^{\prime}, F_{2}^{\prime}, B\right) \in \overleftarrow{C}$ such that $r k(B)=1$ and $\chi\left(F_{1}^{\prime}\right)=\chi\left(F_{1}\right)+1$, $\chi\left(F_{2}^{\prime}\right)=\chi\left(F_{2}\right)-1$. Therefore, this association defines a natural isomorphism between $D_{1}$ and $D_{2}$. Let us denote this isomorphism by $\Psi$ and $M_{0}$ be the variety obtained by identifying the closed subschemes $D_{1}$ and $D_{2}$ via the isomorphism $\Psi$. Now by Remark 2.4 we get a morphism $f_{1}: M_{12} \rightarrow M(2, a, \chi)$ (resp. $\left.f_{2}: M_{21} \rightarrow M(2, a, \chi)\right)$ by associating a triple $\left(F_{1}, F_{2}, A\right)$ to the corresponding torsion free sheaf $F$. Clearly $f_{1}$ and $f_{2}$ are compatible with the gluing morphism $\Psi$. Thus we get a morphism $M_{0} \rightarrow M(2, a, \chi)$. This morphism is bijective. Also this morphism induces an isomorphism on the dense open subvariety of $M_{0}$ consisting of rank 2 triples. Therefore it is a birational morphism. Thus by [24, Theorem 2.4] the variety $M_{0}$ is isomorphic to the moduli space $M(2, a, \chi)$ as the latter space is projective and seminormal, being the union of two smooth projective variety intersecting transversally, without any one dimensional component.

Let $S$ be a finite type scheme and $\chi_{i}^{\prime}=\chi_{i}-\left(1-g_{i}\right)$. Given a family of type (I), $\left(a_{1}, a_{2}\right)$ semistable triples $\left(\mathscr{F}_{1}, \mathscr{F}_{2}, \mathscr{A}\right)$ parametrised by $S$ we get two families of line bundles $\wedge^{2} \mathscr{F}_{i}$ over $X_{i} \times S, i=1,2$. Thus by the universal property of $J^{\chi_{i}^{\prime}}\left(X_{i}\right)$ we get a morphism

$$
\operatorname{det}_{1}: M_{12} \rightarrow J_{0}:=J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right) .
$$

such that $\operatorname{det}_{1}\left(\left(F_{1}, F_{2}, A\right)\right)=\left(\wedge^{2} F_{1}, \wedge^{2} F_{2}\right)$ for all closed points $\left(F_{1}, F_{2}, A\right) \in M_{12}$. Similarly, we get another morphism:

$$
\operatorname{det}_{2}: M_{21} \rightarrow J_{0}^{\prime}:=J^{\chi_{1}^{\prime}+1}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}-1}\left(X_{2}\right) .
$$

such that $\operatorname{det}_{2}\left(\left(F_{1}, F_{2}, A\right)\right)=\left(\wedge^{2} F_{1}, \wedge^{2} F_{2}\right)$ for all closed points $\left(F_{1}, F_{2}, A\right) \in M_{21}$.
Lemma 2.4. The fibres of det $_{i}$ are smooth and the fibres of det $_{i}$ intersect $D_{i}$ transversally, $i=1,2$.

Proof. The group $J^{0}\left(X_{1}\right) \times J^{0}\left(X_{2}\right)$ acts on $M_{21}$ (resp. $\left.M_{21}\right)$ by $\left(F_{1}, F_{2}, A\right) \mapsto\left(F_{1} \otimes\right.$ $\left.L_{1}, F_{2} \otimes F_{2} \otimes L_{2}, A\right)$ and on $J_{0}\left(r e s p . J_{0}^{\prime}\right)$ by $\left(M_{1}, M_{2}\right) \mapsto\left(M_{1} \otimes L_{1}, M_{2} \times L_{2}\right)$ where $\left(L_{1}, L_{2}\right) \in J^{0}\left(X_{1}\right) \times J^{0}\left(X_{2}\right)$. The morphism $\operatorname{det}_{1}$ (resp. $\operatorname{det}_{2}$ ) is clearly compatible
with the above actions. Thus $\operatorname{det}_{1}$ (resp. $\operatorname{det}_{2}$ ) is smooth. As $M_{12}$ (resp. $M_{21}$ ) and $J_{0}$ (resp. $J_{0}^{\prime}$ ) are smooth, the fibres of $\operatorname{det}_{1}$ (resp. $d e t_{2}$ ) are smooth. Clearly, the divisor $D_{1}$ (resp. $D_{2}$ ) is invariant under the above action. Therefore, $\left.\operatorname{det}_{i}\right|_{D_{i}}$ are smooth, $i=1,2$. Thus the fibres of $\left.d e t_{i}\right|_{D_{i}}$ are also smooth. Clearly, the intersection of a fibre of $\operatorname{det}_{i}$ with $D_{i}$ is the fibre of $\left.d e t_{i}\right|_{D_{i}}$. Hence we are done.

Fix $\xi=\left(\xi_{1}, \xi_{2}\right) \in J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$. Let $\operatorname{det}_{1}^{-1}(\xi):=M_{12}^{\xi}$ and $\operatorname{det}_{2}^{-1}\left(\xi^{\prime}\right):=M_{21}^{\xi^{\prime}}$ where $\xi^{\prime}=(\xi(p), \xi(-p))$. By Lemma 2.4 the fibre $\operatorname{det}_{1}^{-1}(\xi)$ (resp. $\left.\operatorname{det}_{2}^{-1}\left(\xi^{\prime}\right)\right)$ intersects $D_{1}$ (resp. $D_{2}$ ) transversally. Hence $D_{1}^{\xi}:=\operatorname{det}_{1}^{-1}(\xi) \cap D_{1}$ and $D_{2}^{\xi^{\prime}}:=$ det $t^{-1}\left(\xi^{\prime}\right) \cap D_{2}$. Let $M_{0, \xi}$ be the closed subvariety of $M_{0}$ obtained by gluing $M_{12}^{\xi}$ and $M_{21}^{\xi^{\prime}}$ along the closed subschemes $D_{1}^{\xi}$ and $D_{2}^{\xi^{\prime}}$ via the isomorphism $\Psi$.

Let det be the morphism defined in Proposition 6.4. We can easily show that $\operatorname{det}^{-1}(\xi), \xi \in J_{0}$ is isomorphic to the variety $M_{0, \xi}$. In the next section we will compute some of the cohomology groups of $M_{0, \xi}$.
2.4.1. Notation. Henceforth, we will denote by $M_{0, \xi}$, the moduli space of rank 2, $\left(a_{1}, a_{2}\right)$ - semistable bundles with $d e t \simeq \xi$ and its components by $M_{12}$ and $M_{21}$. We also denote the smooth divisor $D_{1}^{\xi}$ in $M_{12}$ by $D_{1}$ and the smooth divisor $D_{2}^{\xi}$ in $M_{21}$ by $D_{2}$.

We conclude this section by proving a geometric fact about the moduli space $M_{12}\left(\right.$ resp. $\left.M_{21}\right)$.

Lemma 2.5. The moduli space $M_{12}$ (resp, $M_{21}$ ) is a unirational variety.
Proof. To prove $M_{12}$ is unirational we can assume, after tensoring by line bundles, it consists of all triples $\left(F_{1}, F_{2}, A\right)$, where $F_{i}$ is semistable over $X_{i}$ such that $\operatorname{deg}\left(F_{i}\right)>2\left(2 g_{i}-1\right) i=1,2$. Then, any such $F_{i}$ can be obtained as an extension:

$$
0 \rightarrow \mathscr{O}_{X_{i}} \rightarrow F_{i} \rightarrow \xi_{i} \rightarrow 0,
$$

where $\xi_{i}=\operatorname{det}\left(F_{i}\right)$ for $i=1,2$. The exact sequences of this type are classified by $V_{\xi_{i}}:=\operatorname{Ext}^{1}\left(\mathscr{O}_{X_{i}}, \xi_{i}\right)=H^{1}\left(X_{i}, \xi_{i}^{*}\right)$. Let $\mathscr{E}_{i}$ be the universal extension over $X_{i} \times V_{\xi_{i}}$. We denote the restriction $\mathscr{E}_{i_{\mid p \times V_{\xi_{i}}}}$ by $\mathscr{E}_{i_{p}}$. Clearly, $\operatorname{Hom}\left(\mathscr{E}_{1}, \mathscr{E}_{2}\right)$ parametrises a family of triples in the sense we have defined family of triples and if ( $F_{1}, F_{2}, A$ ) be a triple corresponding to the closed point $A \in \operatorname{Hom}\left(\mathscr{E}_{1}, \mathscr{E}_{2}\right)$ then $F_{i}$ 's are the extensions of the type described before. Now as $F_{i}$ 's are semistable if we choose an isomorphism $A: F_{1}(p) \rightarrow F_{2}(p)$ then by Lemma 2.2, $\left(F_{1}, F_{2}, A\right)$ is semistable. Thus we conclude the set of points $W$ where the corresponding triple is semistable is a nonempty Zariski open set of $\operatorname{Hom}\left(\mathscr{E}_{1}, \mathscr{E}_{2}\right)$. Therefore, by the coarse moduli property of $M_{12}$, we get a morphism from $W$ to $M_{12}$. Clearly the morphism $W \rightarrow M_{12}$ is surjective. Hence, $M_{12}$ is a unirational variety. The same argument shows the moduli space $M_{21}$ is also a unirational variety.

## 3. TOPOLOGY OF $M_{0, \xi}$

In this section, our main aim is to outline a strategy to compute the cohomology groups of $M_{0, \xi}$ and compute explicitly the third cohomology group. We make the following convention: Let $X$ be a topological space. By $H^{k}(X)$ we mean the cohomology groups of $X$ with the coefficients in $\mathbb{Q}, k \geq 0$. Whenever
we obtain any results for other coefficients, e.g $\mathbb{Z}$, we will specifically mention it. Suppose $X$ and $Y$ be varities over $\mathbb{C}$. Whenever we say $X \rightarrow Y$ a topological fibre bundle, we assume the underlying topology of $X$ and $Y$ to be complex analytic topology.

Let $Y$ be a smooth,projective curve of genus $g_{Y} \geq 2$ and $M_{Y}$ be the moduli space of rank 2 semistable bundles with fixed determinant. The cohomology groups of $M_{Y}$ are quite well studied in the literature. When the determinant is odd $M_{Y}$ is a smooth projective variety of dimension $3 g_{Y}-3$ and the cohomology groups with integral coefficients are completely known. When the determinant is even $M_{Y}$ need not be smooth. In fact it is known that the singular locus of $M_{Y}$ is precisely the complement $M_{Y} \backslash M_{Y}^{s}$ if $g_{Y} \geq 3$ where $M_{Y}^{s}$ is the open subset consisting of stable bundles (see [14, Theorem 1]). In this case also the Betti numbers are determined in the work of [5]. We will summarize some of the results concerning the cohomology groups of $M_{Y}$ in both the cases i.e odd determinant and even determinant:

Lemma 3.1. (1) Let $M_{Y}$ be the moduli space of rank 2 semistable bundles with odd determinant. Then $M_{Y}$ is a smooth, projective rational variety ([16]) and hence it is simply connected and $H^{3}\left(M_{Y}, \mathbb{Z}\right)_{\text {tor }}=0$. Furthermore, $b_{1}\left(M_{Y}\right)=0, b_{2}\left(M_{Y}\right)=1, b_{3}\left(M_{Y}\right)=2 g_{Y}$, where $b_{i}$ are the Betti numbers ([15]).
(2) Let $M_{Y}$ be the moduli space of rank 2 semistable bundles with even determinant. Then $M_{Y}^{S}$ is a simply connected variety ([4, Proposition 1.2]). Furthermore, we have $b_{1}\left(M_{Y}\right)=0, b_{2}\left(M_{Y}\right)=1$ and $b_{3}\left(M_{Y}^{S}\right)=2 g_{Y}$, where $b_{i}$ are the Betti numbers ([17], [5, Section 3]).

Let $M_{1}\left(\right.$ resp. $\left.M_{1}^{\prime}\right)$ be the moduli space of rank 2, semistable bundles over $X_{1}$ with $\operatorname{det} \simeq \xi_{1}$ (resp. with $\left.\operatorname{det} \simeq \xi_{1}(p)\right)$ and $M_{2}$ (resp. $M_{2}^{\prime}$ ) be the moduli space of rank 2, semistable bundes over $X_{2}$ with $\operatorname{det} \simeq \xi_{2}$ (resp. det $\simeq \xi_{2}(-p)$ ) where $\xi_{i}$ 's are line bundles of degree $d_{i}=\chi_{i}-2\left(1-g_{i}\right)$ for $i=1,2$ and the integers $\chi_{1}, \chi_{2}$ satisfy the inequality 2.2 .1 . Since $\chi$ is odd, one of the integer in the pair $\left(d_{1}, d_{2}\right)$ is odd and the other is even. We assume that $d_{1}$ is odd and $d_{2}$ is even. Therefore, $M_{1}$ and $M_{2}^{\prime}$ are smooth projective varieties. Let $M_{2}^{s}$ be the open subvariety of $M_{2}$ consisting of all the isomorphism classes of stable bundles over $X_{2}$ and $M_{1}^{\prime s}$ be the open subvariety of $M_{1}^{\prime}$ consisting of all the isomorphism classes of stable bundles over $X_{1}$. Note that $M_{2} \backslash M_{2}^{s}$ is precisely the singular locus of $M_{2}$ if $g_{2} \geq 3$ and $M_{1}^{\prime} \backslash M_{1}^{\prime s}$ is precisely the singular locus of $M_{1}^{\prime}$ if $g_{1} \geq 3$.

Let us denote the open subvariety $M_{1} \times M_{2}^{s}$ of $M_{1} \times M_{2}$ by $B$. We will show the following,

Proposition 3.2. There is a surjective morphism $p: M_{12} \rightarrow M_{1} \times M_{2}$. Moreover, $p: P \rightarrow B$ is a topological $\mathbb{P}^{3}$-bundle where $P:=p^{-1}(B)$.

Proof. Let $S$ be a finite type scheme and $\left(\mathscr{F}_{1}, \mathscr{F}_{2}, \mathscr{A}\right)$ be a family of triples parametrised by $S$ such that $\left(\mathscr{F}_{1_{s}}, \mathscr{F}_{2_{s}}, \mathscr{A}_{s}\right)$ is ( $a_{1}, a_{2}$ )-semistable of type (I) for all $s \in S$ where $\mathscr{F}_{i_{s}}:=\left.\mathscr{F}_{i}\right|_{X_{0} \times s}$. We also assume $\wedge^{2} \mathscr{F}_{i_{s}} \simeq \xi_{i}, i=1,2$. Then by Fact $2.2 \mathscr{F}_{i_{s}}, i=1,2$, are semistable for all $s \in S$. Thus we get a morphism $p: M_{12} \rightarrow M_{1} \times M_{2}$. Let $\left(\left[F_{1}\right],\left[F_{2}\right]\right) \in M_{1} \times M_{2}$. Choose any isomorphism $A: F_{1}(p) \rightarrow F_{2}(p)$. Then, by Fact $2.3\left(F_{1}, F_{2}, A\right)$ is $\left(a_{1}, a_{2}\right)$-semistable. Therefore, $p$ is surjective.

Now we show that $p: P \rightarrow B$ is a topological $\mathbb{P}^{3}$-bundle. Let $b=\left(\left[F_{1}\right],\left[F_{2}\right]\right) \in$ $B$. Our first claim is the fibre $p^{-1}(b)$ is homeomorphic to $\mathbb{P} \operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right) \simeq$ $\mathbb{P}^{3}$. Let $A \in \operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right)$ and $A \neq 0$. Since both $F_{i}$ 's are stable, by Lemma 2.3, $\left(F_{1}, F_{2}, A\right)$ is $\left(a_{1}, a_{2}\right)$-stable. Thus we get a morphism $i_{b}: \operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right) \backslash$ $0 \rightarrow M_{12}$. Clearly, $\left.i_{b}\left(\operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right)\right) \backslash 0\right)=p^{-1}(b)$. Note that $\left(F_{1}, F_{2}, A\right)$ and $\left(F_{1}, F_{2}, \lambda A\right)$ are isomorphic for all $\lambda \in \mathbb{C}^{*}$. Thus $i_{b}$ descends to a morphism $i_{b}$ : $\mathbb{P} \operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right) \rightarrow p^{-1}(b)$. Now we show that $i_{b}$ is injective. Then the claim will follow. Let $A, B \in \mathbb{P} \operatorname{Hom}\left(F_{1}(p), F_{2}(p)\right)$ are disticnt points. Then the triples $\left.\left(F_{1}, F_{2}, A\right), F_{1}, F_{2}, B\right)$ are non isomorphic. Suppose, $\left(F_{1}, F_{2}, A\right)$ and $\left(F_{1}, F_{2}, B\right)$ are isomorphic as triples. Then there are isomorphisms $\phi_{i}: F_{i} \rightarrow F_{i}, i=1,2$ such that we have the following commutative diagram:


Since $F_{i}$ are stable the only isomorphisms of $F_{i}$ are $\lambda I$ for some scalor $\lambda$. Thus we have $\phi_{i}(p)=\lambda_{i} I, i=1,2$. From the commutativity of the above diagram we get $B \lambda_{1}=\lambda_{2} A$. Thus $B=\lambda_{1}^{-1} \lambda_{2} A$. Hence a contradiction as $A$ and $B$ are disticnt in $\mathbb{P H o m}\left(F_{1}(p), F_{2}(p)\right)$. Therefore, the morphism is injective. Since the fibres of $p: P \rightarrow B$ are compact, $p: P \rightarrow B$ is a proper, analytic map.

Our next claim is that the induced map $d p: T_{F} \rightarrow T_{p(F)}$ at the level of Zariski tangent space is surjective for all $F=\left(F_{1}, F_{2}, A\right) \in P$. Let $\left(F_{1}, F_{2}\right) \in B$. Since $F_{i}$ are both stable, $i=1,2$, the Zariski tangent space $T_{F_{i}} \simeq H^{1}\left(\operatorname{End}\left(F_{i}\right)\right)_{0}$ where $H^{1}\left(\operatorname{End}\left(F_{i}\right)\right)_{0}=\operatorname{Ker}\left(\operatorname{tr}^{1}: H^{1}\left(\operatorname{End}\left(F_{i}\right)\right) \rightarrow H^{1}\left(\mathscr{O}_{X_{i}}\right)\right)$ and $\operatorname{tr}^{1}$, the trace homomorphism (see [9, Theorem 4.5.4]). Thus the tangent space $T_{\left(F_{1}, F_{2}\right)} B \simeq$ $H^{1}\left(\operatorname{End}\left(F_{1}\right)\right)_{0} \times H^{1}\left(\operatorname{End}\left(F_{2}\right)\right)_{0}$. Now a cocycle in $H^{1}\left(\operatorname{End}\left(F_{i}\right)\right)$ corresponds to a locally free sheaf $\mathscr{F}_{i}$ over $X_{i} \times D$ such that $\mathscr{F}_{i t_{0}} \simeq F_{i}$ where $D=\operatorname{Spec} \frac{\mathbb{C}[\varepsilon]}{\varepsilon^{2}}$ and $t_{0}=(\varepsilon)$. Choose an isomorphism $\mathscr{A}: F_{1}(p) \rightarrow F_{2}(p)$. Then clearly, $A$ lifts to a $\mathscr{O}_{D^{-}}$ module homomorphism $\mathscr{A}:\left.\left.F_{1}\right|_{p \times D} \rightarrow F_{2}\right|_{p \times D}$. Thus we get a triple $\left(\mathscr{F}_{1}, \mathscr{F}_{2}, \mathscr{A}\right)$ parametrised by $D$ such that $\left(\mathscr{F}_{1 t_{0}}, \mathscr{F}_{2 t_{0}}, \mathscr{A}_{t_{0}}\right)=\left(F_{1}, F_{2}, A\right)$. By the coarse moduli property of $M_{12}$ we get a morphism $x: D \rightarrow M_{12}$ such that $x\left(t_{0}\right)=\left(F_{1}, F_{2}, A\right)$. In otherwords we get a point of the Zariski tangent space at $\left(F_{1}, F_{2}, A\right)$. Thus $d p$ is surjective. Therefore, $p$ is a proper, surjective, holomorphic submersion. Hence, $p: P \rightarrow B$ is a topological $\mathbb{P}^{3}$ - bundle.

Remark 3.1. By the same arguments as before we get a morphism $p^{\prime}: M_{21} \rightarrow$ $M_{1}^{\prime} \times M_{2}^{\prime}$, where $M_{1}^{\prime}$ is the moduli space of rank 2 semistable bundles over $X_{1}$ with det $\simeq \xi_{1}^{\prime}$ and $M_{2}^{\prime}$ be the moduli space of rank 2 semistable bundles over $X_{2}$ with de $t \simeq \xi_{2}^{\prime}$, where $\xi_{1}^{\prime}:=\xi_{1}(p)$ and $\xi_{2}^{\prime}:=\xi_{2}(-p)$. Moreover, $p^{\prime}: \bar{P} \rightarrow B^{\prime}$ is a $\mathbb{P}^{3}$-fibration where $B^{\prime}=M_{1}^{s} \times M_{2}$ and $\bar{P}=p^{\prime-1}\left(B^{\prime}\right)$.
3.1. Codimension computations. In the following proposition we compute the codimension of the complement of the open subvariety $P$ in $M_{12}$ (resp. the complement of $\bar{P}$ in $M_{21}$ ).

Let $K^{\prime}$ denote the complement of $P$ in $M_{12}$ and $K_{2}^{\prime}$ denote the complement of $\bar{P}$ in $M_{21}$. Then we have

## Proposition 3.3.

(a) $\operatorname{Codim}\left(K^{\prime}, M_{12}\right)=g_{2}-1$. where $g_{2}$ is the genus of $X_{2}$
(b) $\operatorname{Codim}\left(K_{2}^{\prime}, M_{21}\right)=g_{1}-1$ where $g_{1}$ is the genus of $X_{1}$.

Proof. We will only show $(a)$. The proof of $(b)$ is similar. Note that if $\left(F_{1}, F_{2}, A\right) \in$ $K^{\prime}$ then $F_{2}$ is a strictly semistable bundle on $X_{2}$. Therefore, $K^{\prime}=p^{-1}\left(M_{1} \times K\right)$, where $K=M_{2} \backslash M_{2}^{s}$ and $p$ is the morphism as in Proposition 3.2. . Now $F_{2} \in K$ if and only if there is a short exact sequence

$$
0 \rightarrow L_{2} \rightarrow F_{2} \rightarrow L_{1} \rightarrow 0
$$

for some line bundles $L_{1}, L_{2}$ with $\operatorname{deg}\left(L_{i}\right)=\frac{d_{2}}{2}, i=1,2$. Clearly, $L_{1} \otimes L_{2} \simeq$ $\operatorname{det}\left(F_{2}\right) \simeq \xi_{2}$. Thus $K$ consists of all S-equivalance classes $\left[L_{1} \oplus L_{2}\right]$ of semistable bundles on $X_{2}$ where $L_{1}, L_{2} \in J^{d_{2}^{\prime}}\left(X_{2}\right), d_{2}^{\prime}=\frac{d_{2}}{2}$ such that $L_{1} \otimes L_{2} \simeq \xi_{2}$. Let $K^{0}$ be the subset of $K$ consisting of all S- equivalence classes $\left[L_{1} \oplus L_{2}\right.$ ] such that $L_{1} \not \not L_{2}$. Then by [14, Lemma 4.3] $K^{0}$ is an open and dense subset of $K$. Let $K^{\prime \prime}=p^{-1}\left(M_{1} \times K^{0}\right)$. Then $K^{\prime \prime}$ is open and dense in $K^{\prime}$. Therefore, we get $\operatorname{dim}\left(K^{\prime}\right)=\operatorname{dim}\left(K^{\prime \prime}\right)$. Now we will find a parameter variety of isomorphism classes of all $\left(a_{1}, a_{2}\right)$-semistable triples ( $F_{1}, F_{2}, A$ ) where $F_{1} \in M_{1}$ and $F_{2} \in \mathbb{P} E x t^{1}\left(L_{1}, L_{2}\right)$ for some $L_{i} \in J^{d_{2}^{\prime}}\left(X_{2}\right), i=1,2$ with $L_{1} \not \neq L_{2}$ and show that this parameter variety has same dimension as $K^{\prime \prime}$.

Let $J^{\xi_{2}}=\left\{\left(L_{1}, L_{2}\right) \in J^{d_{2}^{\prime}}\left(X_{2}\right) \times J^{d_{2}^{\prime}}\left(X_{2}\right) \mid L_{1} \otimes L_{2} \simeq \xi_{2}\right\}$. Note that $J^{d_{2}^{\prime}}\left(X_{2}\right)$ is isomorphic to $J^{\xi_{2}}$ by $L \mapsto\left(L, \xi_{2} \otimes L^{-1}\right)$. Therefore, $J^{\xi_{2}}$ is a closed subvariety of $J^{d_{2}^{\prime}}\left(X_{2}\right) \times J^{d_{2}^{\prime}}\left(X_{2}\right)$ of dimension $g_{2}$. Let $J^{\prime}=\left\{\left(L_{1}, L_{2}\right) \in J^{d_{2}}\left(X_{2}\right) \times J^{d_{2}^{\prime}}\left(X_{2}\right) \mid L_{1} \not \approx L_{2}\right\}$. Then, clearly $J^{\prime}$ is an open and dense subvariety of $J^{d_{2}^{\prime}}\left(X_{2}\right) \times J^{d_{2}^{\prime}}\left(X_{2}\right)$. Let $J^{\prime \xi_{2}}:=J^{\prime} \cap J^{\xi_{2}}$.

We will construct a projective bundle $\mathbb{P}$ over $J^{\prime}$ such that the fibre over a point $\left(L_{1}, L_{2}\right) \in J^{\prime}$ is isomorphic to $\mathbb{P} E x t^{1}\left(L_{1}, L_{2}\right)$ : Let $\mathscr{L}$ be the Poincare line bundle over $X_{2} \times J^{d_{2}^{\prime}}\left(X_{2}\right)$ and $\mathscr{L}_{i}:=\left(i d \times p_{i}\right)^{*} \mathscr{L}$ where $p_{i}: J^{d_{2}^{\prime}}\left(X_{2}\right) \times J^{d_{2}^{\prime}}\left(X_{2}\right) \rightarrow$ $J^{d_{2}^{\prime}}\left(X_{2}\right)$ is the $i$ th projection for $i=1,2$. Then $V:=R^{1} p_{J^{\prime} *} \operatorname{Hom}\left(\mathscr{L}_{1}, \mathscr{L}_{2}\right)$ is a locally free sheaf of rank $g_{2}-1$ over $J^{\prime}$ where $p_{J^{\prime}}: X_{2} \times J^{\prime} \rightarrow J^{\prime}$ is the projection. Let $\mathbb{P}$ over $J^{\prime}$ be the projective bundle associated to $V$. Then the fibre over a point $\left(L_{1}, L_{2}\right) \in J^{\prime}$ is isomorphic to $\mathbb{P} E x t^{1}\left(L_{1}, L_{2}\right)$. Let $P^{\prime}=\left.\mathbb{P}\right|_{J^{\prime \xi} \xi_{2}}$. Let $\mathscr{G}$ be the universal extension over $X_{2} \times P^{\prime}$ (see [14, Proposition 3.1]) and $F$ be a universal bundle over $X_{2} \times M_{1}$ (note that $F$ exists as the degree and rank of the vector bundles in $M_{1}$ are coprime).

Let $\mathscr{G}_{p}:=\left.\mathscr{G}\right|_{p \times p^{\prime}}$ and $F_{p}:=\left.F\right|_{p \times M_{1}}$. Clearly, $\operatorname{Hom}\left(F_{p}, G_{p}\right)$ parametrises a family of triples of type (I) such that every closed point in $\operatorname{Hom}\left(F_{p}, G_{p}\right)$ corresponds to a triple $\left(F_{1}, F_{2}, A\right)$ where $F_{1} \in M_{1}$ and $F_{2} \in P^{\prime}$. Note that if $E \in$ $\mathbb{P} E x t^{1}\left(L_{1}, L_{2}\right)$ then $\operatorname{Aut}(E) \simeq \mathbb{C}^{*}$ whenever $L_{1} \not \equiv L_{2}$ (see [14, Lemma 4.1]). Let $A, B \in \mathbb{P} \operatorname{Hom}\left(F_{p}, \mathscr{G}_{p}\right)$ be two distinct closed points and $\left(F_{1}, F_{2}, A\right),\left(G_{1}, G_{2}, B\right)$ be the corresponding triples. Then $\left(F_{1}, F_{2}, A\right)$ and $\left(G_{1}, G_{2}, B\right)$ are non isomorphic. This follows from the two facts: if $E_{1} \in M_{1}$ and $E_{2} \in P^{\prime}$ then $\operatorname{Aut}\left(E_{i}\right) \simeq \mathbb{C}^{*}$. If $E_{1}, E_{2} \in \mathbb{P} E x t^{1}\left(L_{1}, L_{2}\right)$ are distinct then $E_{1}$ and $E_{2}$ are non isomorphic ( $[14$, Lemma 3.3]). Let $K_{1}$ be the subset of $\mathbb{P} \operatorname{Hom}\left(F_{p}, \mathscr{G}_{p}\right)$ whose closed points correspond to the triples $\left(F_{1}, \mathscr{G}_{2}, A\right)$ such that $r k(A)=2$. Then $K_{1}$ is an open subset in $\mathbb{P} \operatorname{Hom}\left(F_{p}, \mathscr{G}_{p}\right)$. Note that by Lemma 2.3, any closed point of $K_{1}$ is
semistable. Therefore, by the coarse moduli property of $M_{12}$, we get a morphism $i_{K}: K_{1} \rightarrow M_{12}$. By the above discussions $i_{K}$ is injective. Clearly, the image $i_{K}\left(K_{1}\right)$ is dense in $K^{\prime \prime}$ since if $\left(F_{1}, F_{2}, A\right) \in K^{\prime \prime} \backslash i_{K}\left(K_{1}\right)$ then $F_{2} \simeq L_{1} \oplus L_{2}$ for some $L_{1}, L_{2} \in J^{d_{2}^{\prime}}\left(X_{2}\right)$. Therefore, $\operatorname{dim}\left(K_{1}\right)=\operatorname{dim}\left(K^{\prime \prime}\right)$

We have $\operatorname{dim}\left(M_{1}\right)=3 g_{1}-3$ and $\operatorname{dim}\left(P^{\prime}\right)=2 g_{2}-2$. Therefore, $\mathbb{P} \operatorname{Hom}\left(F_{p}, \mathscr{G}_{p}\right)=$ $\operatorname{dim}\left(K_{1}\right)=3 g_{1}-3+2 g_{2}-2+3=3 g_{1}+2 g_{2}-2$. Note that $P$ is an dense open subvariety of $M_{12}$, therefore $\operatorname{dim}(P)=\operatorname{dim}\left(M_{12}\right)$. Now, from the proof of Proposition 3.2, $p: P \rightarrow B$ is flat with fibres isomorphic to $\mathbb{P}^{3}$ as algebraic varieties. Therefore, $\operatorname{dim}(P)=\operatorname{dim}(B)+3=3\left(g_{1}+g_{2}\right)-3$. Hence, we have $\operatorname{dim} M_{12}=3 g_{1}+3 g_{2}-3$. Since $\operatorname{Codim}\left(K^{\prime}, M_{12}\right)=\operatorname{dim}\left(M_{12}\right)-\operatorname{dim}\left(K^{\prime}\right)$ and $\operatorname{dim}\left(K_{1}\right)=\operatorname{dim}\left(K^{\prime \prime}\right)$, we see

$$
\begin{gathered}
\operatorname{Codim}\left(K^{\prime}, M_{12}\right)=3 g_{1}+3 g_{2}-3-3 g_{1}-2 g_{2}+2 \\
=g_{2}-1
\end{gathered}
$$

Now we recall a well-known fact (see [5, Lemma 12]).
Lemma 3.4. Let $X$ be a smooth projective variety and $k:=\operatorname{Codim}(X / U)$, where $U$ be an open subset of $X$. Then we have $H^{i}(X, \mathbb{Z}) \simeq H^{i}(U, \mathbb{Z})$ for all $i<2 k-1$.

Using the above Lemma and Proposition 3.3 we immediately get the following
Proposition 3.5. With the above notations,
(i) $H^{i}\left(M_{12}, \mathbb{Z}\right) \simeq H^{i}(P, \mathbb{Z})$ for $i<2 k-1$ where $k=g_{2}-1$.
(ii) $H^{i}\left(M_{21}, \mathbb{Z}\right) \simeq H^{i}(\bar{P}, \mathbb{Z})$ for $i<2 k^{\prime}-1$ where $k^{\prime}=g_{1}-1$.
3.2. Computation of cohomology groups of $M_{0, \xi}$. In this subsection we will outline the strategy to compute the Betti numbers of the component $M_{12}$ (resp. $M_{21}$ ) and compute the third cohomology of $M_{0, \xi}$ in full details. First we compute the Betti numbers of $P$ (resp. $\bar{P}$ ) using Leray-Hirsh Theorem:
Theorem 3.6. (Leray-Hirsh) Let $f: X \rightarrow Y$ be a topological fibre bundle with fibres isomorhic to $F$. Suppose, $e_{1}, \cdots, e_{n} \in H^{*}(X)$ such that $H^{*}\left(X_{y}\right)$ is freely generated by $i_{y}^{*} e_{1}, \cdots, i_{y}^{*} e_{n}$ for all $y \in Y$ where $X_{y}=f^{-1}(y)$ and $i_{y}: X_{y} \rightarrow X$ is the inclusion. Then $H^{*}(X)$ is freely generated as a $H^{*}(Y)$-module by $e_{1}, \cdots, e_{n}$.
Proposition 3.7. The $k$-th Betti number $b_{k}(P)=\sum_{l+m=k} b_{l}(B) b_{m}\left(\mathbb{P}^{3}\right)$ (resp. $b_{k}(\bar{P})=\sum_{l+m=k} b_{l}(\bar{B}) b_{m}\left(\mathbb{P}^{3}\right)$.

Proof. Since $P$ and $B$ are both smooth varieties and $p: P \rightarrow B$ is a submersion we get $p$ is smooth. Therefore, the fibres of $\left.p\right|_{p}$ are smooth. From the proof of Proposition 3.2, it follows that the fibres of $p$ are isomorphic to $\mathbb{P}^{3}$ as algebraic varieties. Choose a relatively ample line bundle $L$ over $P$. Now $p_{*} L$ is locally free by Zariski Main theorem. Therefore, we get that the dimension of $H^{0}\left(p^{-1}(b),\left.L\right|_{p^{-1}(b)}\right)$ is constant for all $b \in B$. Hence, $\left.L\right|_{p^{-1}(b)}=\mathscr{O}(k)$ for some $k>0$ for all $b \in B$. Consider the cohomolgy classes $c_{1}(L), c_{1}(L)^{2}, c_{1}(L)^{3}$. We denote by $j_{b}: p^{-1}(b) \rightarrow P$ the inclusion. Then $H^{*}\left(p^{-1}(b)\right)$ is freely generated by $j_{b}^{*} c_{1}(L)$, $j_{b}^{*} c_{1}(L)^{2}$ and $j_{b}^{*} c_{1}(L)^{3}$ for all $b \in B$. Thus using Leray-Hirsch theorem we get:

$$
b_{k}(P)=\sum_{l+m=k} b_{l}(B) b_{m}\left(\mathbb{P}^{3}\right) .
$$

where $b_{k}(X)$ denotes the $k$ th Betti number of a space $X$.

As a corollary of the above Proposition we immediately get:
Corollary 3.8. (i) $b_{1}(P)=0$ (resp. $\left.b_{1}(\bar{P})=0\right)$, (ii) $b_{2}(P)=3$ (resp. $\left.b_{2}(\bar{P})=3\right)$ and (iii) $b_{3}(P)=2 g\left(\right.$ resp. $\left.b_{3}(\bar{P})=2 g\right)$ where $g$ is the arithmatic genus of $X_{0}$ and $b_{i}$ 's are the Betti numbers, $i=1,2,3$.

Proof. By Lemma 3.1 and the Kunneth formula it follows that $b_{1}(B)=b_{1}\left(M_{1}\right)+$ $b_{1}\left(M_{2}^{S}\right)=0, b_{2}(B)=b_{2}\left(M_{1}\right)+b_{2}\left(M_{2}^{S}\right)=1+1=2$ and $b_{3}(B)=b_{3}\left(M_{1}\right)+b_{3}\left(M_{2}^{S}\right)=$ $2 g_{1}+2 g_{2}=2 g$. Thus by Proposition 3.7 we get $b_{1}(P)=0, b_{2}(P)=3$ and $b_{3}(P)=$ $2 g$.

Remark 3.2. By above proposition all the Betti numbers of $P$ can be computed using the above argument as the Betti numbers of the varities $M_{1}$ and $M_{2}^{s}$ are well known (see [5, page 113]).

Let $g_{1}, g_{2}>3$. Then as a consequence of Proposition 3.5 and Corollary 3.8 we immediately get:

Theorem 3.9. With the notations above,
(1) $H^{1}\left(M_{12}\right)=0\left(\right.$ resp. $\left.H^{1}\left(M_{21}\right)=0\right)$.
(2) $H^{2}\left(M_{12}\right) \simeq \mathbb{Q} \oplus \mathbb{Q} \oplus \mathbb{Q}\left(\right.$ resp. $\left.H^{2}\left(M_{21}\right) \simeq \mathbb{Q} \oplus \mathbb{Q} \oplus \mathbb{Q}\right)$.
(3) $H^{3}\left(M_{12}\right) \simeq \mathbb{Q}^{2 g}\left(\right.$ resp. $\left.H^{2}\left(M_{21}\right) \simeq \mathbb{Q}^{2 g}\right)$.

Remark 3.3. $M_{12}$ (resp. $M_{21}$ ) is a smooth, projective unirational variety by Lemma 2.4.1. Therefore, by a result of Serre ([20]) $M_{12}$ (resp. $M_{21}$ ) is a simply connected variety.
3.3. Continuation of the cohomology computation. We have $M_{0, \xi}=M_{12} \cup M_{21}$. Let $D=M_{12} \cap M_{21}$. We will compute the third cohomology group of $M_{0, \xi}$ using Mayer-Vietoris sequence. Before we compute the cohomology group we will make few more observations.

Let $P_{1}$ be the moduli space of rank 2, parabolic semistable bundles ( $F_{1}, 0 \subset$ $\left.F^{2} F_{1} \subset F_{1}(p)\right)$ on $X_{1}$ with parabolic weights $0<\frac{a_{1}}{2}<\frac{a_{2}}{2}<1$ and $\operatorname{det} F_{1} \simeq \xi_{1}$. Let $P_{2}$ be the moduli space of rank 2, parabolic semistable bundles $\left(F_{2}, 0 \subset\right.$ $\left.F^{2} F_{2}(p) \subset F_{2}(p)\right)$ on $X_{2}$ with parabolic weights $0<\frac{a_{1}}{2}<\frac{a_{2}}{2}<1$ and $\operatorname{det} F_{2} \simeq \xi_{2}$. By Fact $2.1(a)$ any parabolic semistable bundle in $P_{1}$ (resp. in $P_{2}$ ) is parabolic stable. Therefore, one can show that $P_{i}$ 's are smooth, $i=1,2$. Since $E \in P_{i}$ is semistable by Fact 2.1 (b), we get morphisms $q_{i}: P_{i} \rightarrow M_{i}, i=1,2$. Let $P_{2}^{s}=q_{2}^{-1}\left(M_{2}^{s}\right)$. Thus we get a morphism $q:=\left(q_{1}, q_{2}\right): P_{1} \times P_{2} \rightarrow M_{1} \times M_{2}$ such that $q^{-1}(B)=P_{1} \times P_{2}^{s}$ where $B:=M_{1} \times M_{2}^{s}$. Now by using the same argument given in [13, Theorem 6.1] we can show that there is an embedding $i: P_{1} \times P_{2} \rightarrow M_{12}$ such that the image is isomorphic to $D$. Thus we have a commutative diagram of morphisms:

where $p$ is the morphism in Proposition 3.2.

Let $q_{1}^{\prime}: P_{1} \rightarrow M_{1}^{\prime}$ be the morphism defined by $E_{1} \rightarrow E_{1}^{\prime}$ and $q_{2}^{\prime}: P_{2} \rightarrow M_{2}^{\prime}$ defined by $E_{2} \rightarrow E_{2}^{\prime}$ where $E_{i}^{\prime}$ are the Hecke modifications of $E_{i}, i=1,2$ (see Remark 2.1). Then we get another commutative diagram of morphisms:

where the morphism $q^{\prime}: P_{1} \times P_{2} \rightarrow M_{1}^{\prime} \times M_{2}^{\prime}$ is given by the association $\left(E_{1}, E_{2}\right) \mapsto$ ( $E_{1}^{\prime}, E_{2}^{\prime}$ ) and $p^{\prime}$ is the morphism in Remark 3.1.

In the following lemma we summarize some topological facts about the moduli spaces $P_{i}, i=1,2$.

Lemma 3.10. (i) $P_{i}, i=1,2$, are smooth, projective and rational variety being $\mathbb{P}^{1}$ - bundles associated to algebraic vector bundles over coprime moduli spaces (see Remark 5.1). In particular, $P_{i}$ are simply connected and Pic $\left(P_{i}\right) \simeq H^{2}\left(P_{i}, \mathbb{Z}\right)$ for $i=1,2$.
(ii) $H^{1}\left(P_{i}, \mathbb{Z}\right)=0, H^{2}\left(P_{i}, \mathbb{Z}\right) \simeq \mathbb{Z} \oplus \mathbb{Z}$ and $H^{3}\left(P_{i}, \mathbb{Z}\right) \simeq \mathbb{Z}^{2 g_{i}}$ for $i=1,2$ (follows from the previous statement).

Lemma 3.11. (1) $q^{*}: H^{3}\left(P_{1} \times P_{2}^{s}\right) \simeq H^{3}\left(M_{1} \times M_{2}^{s}\right)$.
(2) $p^{*}: H^{3}(P) \simeq H^{3}\left(M_{1} \times M_{2}^{s}\right)$.

Proof. (1) From the fact 2.1 (c) it follows that the topological fibre of $q: P_{1} \times$ $P_{2}^{s} \rightarrow M_{1} \times M_{2}^{s}$ is $\mathbb{P}^{1} \times \mathbb{P}^{1}$. Using the similar arguments given in 3.2 and 3.8 we can show that $q$ is a topological $\mathbb{P}^{1} \times \mathbb{P}^{1}$ - bundle satisfying the hypothesis of the Leray-Hirsch theorem. Thus by Leray-Hirsch theorem $q^{*}: H^{3}\left(P_{1} \times P_{2}^{s}\right) \simeq$ $H^{3}\left(M_{1} \times M_{2}^{S}\right)$.
(2) The proof is already given in 3.8.

Lemma 3.12. $i^{*}: H^{3}\left(P_{1} \times P_{2}\right) \simeq H^{3}\left(M_{12}\right)$ where $i: P_{1} \times P_{2} \rightarrow M_{12}$ is the inclusion.
Proof. First note that $i\left(P_{1} \times P_{2}^{s}\right) \subset P$. Therefore, we have-


By the commutativity of the above diagram we get $i^{*} p^{*}=q^{*}$. Since, by Lemma 3.11, $p^{*}$ and $q^{*}$ are isomorphisms, we get $i^{*}: H^{3}(P) \rightarrow H^{3}\left(P_{1} \times P_{2}^{s}\right)$ is an isomorphism. By an argument given in [1, Proposition 7] we can show that $\operatorname{Codim}\left(K, P_{1} \times P_{2}\right)=g_{2}-1$ where $K=P_{1} \times P_{2} \backslash P_{1} \times P_{2}^{s}$. Thus, by Lemma 3.4, we get $i_{1}^{*}: H^{3}\left(P_{1} \times P_{2}\right) \rightarrow H^{3}\left(P_{1} \times P_{2}^{s}\right)$ is an isomorphism where $i_{1}: P_{1} \times P_{2}^{s} \rightarrow P_{1} \times P_{2}$ is the inclusion. Also, we have shown $i_{2}^{*}: H^{3}\left(M_{12}\right) \rightarrow H^{3}(P)$ is an isomorphism where $i_{2}: P \rightarrow M_{21}$ is the inclusion. Thus $i^{*}: H^{3}\left(M_{12}\right) \rightarrow H^{3}\left(P_{1} \times P_{2}\right)$ is an isomorphism.

It is known the Picard groups $\operatorname{Pic}\left(M_{i}\right)$ (resp. $\operatorname{Pic}\left(M_{i}^{\prime}\right)$ ), $i=1,2$, are isomorphic to $\mathbb{Z}$. Let $\theta_{i}\left(\right.$ resp. $\left.\theta_{i}^{\prime}\right), i=1,2$, be the unique ample generators of $\operatorname{Pic}\left(M_{i}\right)$ (resp. $\operatorname{Pic}\left(M_{i}^{\prime}\right)$ ). Let us denote the projections $M_{1} \times M_{2} \rightarrow M_{i}$ by $s_{i}$; the projections $M_{1}^{\prime} \times M_{2}^{\prime} \rightarrow M_{i}^{\prime}$ by $s_{i}^{\prime}$ and the projections $P_{1} \times P_{2} \rightarrow P_{i}$ by $r_{i}, i=1,2$. Then we immediately get the following relations:

r_{2}^{*} q_{2}^{*} \theta_{2}=q^{*} s_{2}^{*} \theta_{2}, & r_{2}^{*} q_{2}^{\prime *} \theta_{2}^{\prime}=q^{\prime *} s_{2}^{\prime *} \theta_{2}^{\prime} .
\end{array}
$$

Let $\Theta_{1}:=q^{*} s_{1}^{*} \theta_{1}, \Theta_{2}:=q^{* *} s_{1}^{\prime *} \theta_{1}^{\prime}, \Theta_{3}:=q^{*} s_{2}^{*} \theta_{2}$ and $\Theta_{4}:=q^{\prime *} s_{2}^{\prime *} \theta_{2}^{\prime}$.
Lemma 3.13. The line bundles $\Theta_{i}, i=1, \cdots 4$ are linearly independent on $P_{1} \times P_{2}$.
Proof. Note that $q_{1}^{*} \theta_{1}^{\prime}$ and $q_{1}^{\prime *} \theta_{1}^{\prime}$ are linearly independent line bundles over $P_{1}$. This follows from the observation: The line bundles $\theta_{1}$ (resp. $\theta_{1}^{\prime}$ ) is ample over $M_{1}\left(\operatorname{resp} . M_{1}^{\prime}\right)$ and $M_{1}, M_{1}^{\prime}$ are normal varieties. Moreover, by Fact 2.1 the fibre $q_{1}^{-1}(F)$ is isomorphic to $\mathbb{P}^{1}$ for all $F \in M_{1}$ and the fibre $q_{1}^{\prime-1}(F)$ is isomorphic to $\mathbb{P}^{1}$ for all $F \in M_{1}^{\prime s}$. The image of the morphism, inside some projective space, defined by the linear system corresponding to the sufficiently large power of $q_{1}^{*} \theta_{1}\left(\right.$ resp. $\left.q_{1}^{\prime *} \theta_{1}^{\prime}\right)$ will be isomorphic to $M_{1}\left(\right.$ resp. $\left.M_{1}^{\prime}\right)$ (this follows by Lemma 5.2). Since $M_{1}$ and $M_{1}^{\prime}$ are not isomorphic we have $q_{1}^{*} \theta_{1}^{\prime}$ and $q_{1}^{*} \theta_{1}^{\prime}$ are linearly independent. Now $r_{i}: P_{1} \times P_{2} \rightarrow P_{i}$ are the projection maps, $i=1,2$. Therefore, $\Theta_{1}=r_{1}^{*} q_{1}^{*} \theta_{1}$ and $\Theta_{2}=r_{1}^{*} q_{1}^{\prime *} \theta_{1}^{\prime}$ are linearly independent. Similarly $\Theta_{3}$ and $\Theta_{4}$ are linearly independent. Next we will show that the relation $\Theta_{1}^{a_{1}} \otimes \Theta_{2}^{a_{2}}=\Theta_{3}^{a_{3}} \otimes \Theta_{4}^{a_{4}}$, with all $a_{i}$ non zero will never occur. The above relation would imply $r_{1}^{*} L=$ $r_{2}^{*} M$ where $L$ is a non trivial line bundle on $P_{1}$ and $M$ is a nontrivial line bunlde on $P_{2}$. But this is impossible as $\left.r_{1}^{*} L\right|_{q_{1}^{-1}(x)}$ is trivial but $\left.r_{2}^{*} M\right|_{q_{1}^{-1}(x) \sim P_{2}} \simeq M$ is non trivial for $x \in P_{1}$. From the above observation we conclude that $\Theta_{i}$ are linealy independent, $i=1,2,3,4$.

In section 5 we will observe that $P_{i}$ 's are rational varieties and $\operatorname{Pic}\left(P_{i}\right) \simeq$ $\mathbb{Z} \oplus \mathbb{Z}, i=1,2$. Thus $\operatorname{Pic}\left(P_{1} \times P_{2}\right) \simeq \operatorname{Pic}\left(P_{1}\right) \times \operatorname{Pic}\left(P_{2}\right) \simeq \mathbb{Z}^{4}$. Therefore, the line bundles $\Theta_{i}$ generate the picard group $\operatorname{Pic}\left(P_{1} \times P_{2}\right)$. Now we will prove the following:

Lemma 3.14. The morphism $i^{*}-j^{*}: H^{2}\left(M_{12}\right) \oplus H^{2}\left(M_{21}\right) \rightarrow H^{2}\left(P_{1} \times P_{2}\right) \simeq H^{2}(D)$, is surjective where $i$ and $j$ are the inclusions in the diagrams 3.3.1, 3.3.2.

Proof. Since $P_{i}$ are rational varieties, we have $c_{1}: \operatorname{Pic}\left(P_{1} \times P_{2}\right) \rightarrow H^{2}\left(P_{1} \times P_{2}, \mathbb{Z}\right)$ is an isomorphism where $c_{1}$ is the first chern class homomorphism. By Lemma 3.10 we get $\operatorname{Pic}\left(P_{1} \times P_{2}\right) \simeq H^{2}\left(P_{1} \times P_{2}, \mathbb{Z}\right) \simeq \mathbb{Z}^{4}$ Therefore, by Lemma 3.13 $H^{2}\left(P_{1} \times P_{2}\right)$ is generated by $c_{1}\left(\Theta_{1}\right), c_{1}\left(\Theta_{2}\right), c_{1}\left(\Theta_{3}\right)$ and $c_{1}\left(\Theta_{4}\right)$. From commutative diagrams 3.3.1 and 3.3.2 we get

$$
\Theta_{1}=i^{*}\left(p^{*} s_{1}^{*} \theta_{1}\right), \Theta_{2}=j^{*}\left(p^{\prime *} s_{1}^{*} \theta_{1}^{\prime}\right), \Theta_{3}=i^{*}\left(p^{*} s_{2}^{*} \theta_{2}\right) \text { and } \Theta_{4}=j^{*}\left(p^{\prime *} s_{2}^{\prime *} \theta_{2}^{\prime}\right)
$$

Therefore, $H^{2}\left(M_{12}\right) \oplus H^{2}\left(M_{21}\right) \rightarrow H^{2}\left(P_{1} \times P_{2}^{s}\right)$ is surjective.
We will now prove the main theorem of this section.
Theorem 3.15. (i) $H^{2}\left(M_{0, \xi}\right) \simeq \mathbb{Q}^{2}$ and $(i i) H^{3}\left(M_{0, \xi}\right) \simeq \mathbb{Q}^{2 g}$.

Proof. By Lemma 3.14, 3.12 and using Mayer-Vietoris sequence we get-

$$
0 \rightarrow H^{2}\left(M_{0, \xi}\right) \rightarrow H^{2}\left(M_{12}\right) \oplus H^{2}\left(M_{21}\right) \rightarrow H^{2}(D) \rightarrow 0
$$

and

$$
0 \rightarrow H^{3}\left(M_{0, \xi}\right) \rightarrow H^{3}\left(M_{12}\right) \oplus H^{3}\left(M_{21}\right) \rightarrow H^{3}(D) \rightarrow 0
$$

Now $b_{2}\left(M_{12}\right)=b_{2}\left(M_{21}\right)=2$ by Theorem 3.9 and $b_{2}(D)=b_{2}\left(P_{1} \times P_{2}\right)=4$ by Lemma 3.10. Therefore, $b_{2}\left(M_{0, \xi}\right)=2$.

Also we have $b_{3}\left(M_{12}\right)=b_{3}\left(M_{21}\right)=2 g$ by Theorem 3.9 and $b_{3}(D)=b_{3}\left(P_{1} \times P_{2}\right)=$ $2 g$ by Lemma 3.10. Therefore, $b_{3}\left(M_{0, \xi}\right)=b_{3}\left(M_{12}\right)+b_{3}\left(M_{21}\right)-b_{3}(D)=2 g$.
3.4. Hodge structure on $H^{3}\left(M_{0}, \mathbb{Z}\right)$.

Theorem 3.16. The Hodge structure on $H^{3}\left(M_{0}, \mathbb{Z}\right)$ is pure of weight 3 with $h^{3,0}=$ $h^{0,3}=0$.

Proof. We have the following short exact sequence:

$$
0 \rightarrow H^{3}\left(M_{0, \xi}, \mathbb{C}\right) \xrightarrow{r^{*}} H^{3}\left(M_{12}, \mathbb{C}\right) \oplus H^{3}\left(M_{21}, \mathbb{C}\right) \xrightarrow{i^{*}-j^{*}} H^{3}(D, \mathbb{C}) \rightarrow 0
$$

where all the morphisms are the morphism of Hodge structures. Thus $\operatorname{Ker}\left(i^{*}{ }^{-}\right.$ $\left.j^{*}\right)$ is a pure sub Hodge structure of $H^{3}\left(M_{12}, \mathbb{C}\right) \oplus H^{3}\left(M_{21}, \mathbb{C}\right)$ of weight 3 . This induce a Hodge structure of weight 3 on $H^{3}\left(M_{0, \xi}, \mathbb{C}\right)$ as $H^{3}\left(M_{0, \xi}, \mathbb{C}\right)$ is isomorphic to $\operatorname{Ker}\left(i^{*}-j^{*}\right)$. Since $M_{12}$ and $M_{21}$ are smooth unirational varieties (see Lemma 2.4.1) and their intersection $D=M_{12} \cap M_{21}$ is also a smooth unirational variety, we have $h^{3,0}\left(M_{12}\right)=h^{3,0}\left(M_{21}\right)=0$ and $h^{3,0}(D)=0$. Hence we conclude $h^{3,0}\left(\operatorname{Ker}\left(i^{*}-j^{*}\right)\right)=h^{3,0}\left(H^{3}\left(M_{0, \xi}, \mathbb{Z}\right)\right)=0$. This completes the proof.

Remark 3.4. Thus we can define the intermediate Jacobian as in 1.0 .1 corresponding to the Hodge structure on $H^{3}\left(M_{0, \xi}, \mathbb{Z}\right)$. We will denote this intermediate Jacobian by $J^{2}\left(M_{0}\right)$.

## 4. Degeneration of the intermediate Jacobian of the moduli space

Let $\pi: \mathscr{X} \rightarrow C$ be a proper, flat and surjective family of curves, parametrised by a smooth, irreducible curve $C$. We assume that $\mathscr{X}$ is a smooth variety over $\mathbb{C}$. Fix a point $0 \in C$. We assume that $\pi$ is smooth outside the point 0 and $\pi^{-1}(0)=X_{0}$ where $X_{0}$ is a reducible curve with two smooth, irreducible components meeting at a node. Fix a line bundle $\mathscr{L}$ over $\mathscr{X}$ such that the restriction $\mathscr{L}_{t}$ to $X_{t}$ is a line bundle with Euler characteristic $\chi-(1-g)$ for all $t \in C$ where $g$ is the genus of $X_{t}$. We denote the restriction $\left.\mathscr{L}\right|_{X_{0}}$ by $\xi$. In Appendix we will show that there is a proper, flat, surjective family $\pi^{\prime}: \mathscr{M}_{\mathscr{L}} \rightarrow C$ such that $\pi^{\prime-1}(0)=M_{0, \xi}$, the moduli space of rank 2, stable torsion free sheaves with determinant $\xi$ and for $t \neq 0, \pi^{\prime-1}(t)=M_{t, \mathscr{S}_{t}}$, the moduli space of rank 2 stable bundles on $X_{t}$ with determinant $L_{t}$ (see Proposition 6.6 and Remark 6.1 in the Appendix). Moreover, $\mathscr{M}_{\mathscr{L}}$ is smooth over $\mathbb{C}$. Choose a neighbourhood of the point 0 which is analytically isomorphic to the open unit disk $\Delta$ such that both the morphisms $\left.\pi^{\prime}\right|_{\Delta^{*}}$ and $\left.\pi\right|_{\Delta^{*}}$ are smooth, $\Delta^{*}:=\Delta-0$. Denote the family $\left.\pi^{\prime}\right|_{\Delta^{*}}: \pi^{\prime-1}\left(\Delta^{*}\right) \rightarrow \Delta^{*}$ by $\left\{M_{t}\right\}_{t \in \Delta^{*}}$ and the family $\left.\pi\right|_{\Delta^{*}}: \pi^{-1}\left(\Delta^{*}\right) \rightarrow \Delta^{*}$ by $\left\{X_{t}\right\}_{t \in \Delta^{*}}$.
4.0.1. Variation of Hodge structure corresponding to the family $\left\{M_{t}\right\}_{t \in \Lambda^{*}}$ and $\left\{X_{t}\right\}_{\epsilon \epsilon^{*}}$. Since $\left.\pi^{\prime}\right|_{\Delta^{*}}\left(\right.$ resp. $\left.\left.\pi\right|_{\Delta^{*}}\right)$ is smooth we get a local system $R^{i} \pi_{*}^{\prime} \mathbb{Z}$ (resp. $R^{i} \pi_{*} \mathbb{Z}$ ) for $i \geq 0$, of free abelian groups whose fibre over a point $t \in \Delta^{*}$ is isomorphic to $H^{i}\left(M_{t}, \mathbb{Z}\right)$ (resp. $H^{i}\left(X_{t}, \mathbb{Z}\right)$ ). Let $H_{\mathbb{Z}}(\mathscr{M}):=R^{3} \pi^{\prime} \mathbb{Z}$ and $H_{\mathbb{Z}}(\mathscr{X}):=$ $R^{1} \pi_{*} \mathbb{Z}$. Let $H_{\complement}(\mathscr{M})$ (resp. $H_{\complement}(\mathscr{X})$ ) be the holomorphic bundle over $\Delta^{*}$ whose sheaf of section is $H_{Z}(\mathscr{M}) \otimes_{\mathbb{Z}} \mathscr{O}_{\Delta^{*}}$ (resp. $H_{\mathbb{Z}}(\mathscr{X}) \otimes_{\mathbb{Z}} \mathscr{O}_{\Delta^{*}}$ ). Then $H_{\mathbb{C}}(\mathscr{M})$ (resp. $H_{\mathrm{c}}(\mathscr{X})$ ) admits a flat connection $\nabla_{\mathcal{H}}$ (resp. $\nabla_{\mathscr{X}}$ ). Let $T$ (resp. $T^{\prime}$ ) be the monodromy operator defined by the flat connection $\nabla_{\mu}$ (resp. $\nabla_{X X}$ ) corresponding to the positive generator of $\pi_{1}\left(\Delta^{*}, t_{0}\right)$. Since the fibre $\pi^{\prime-1}(0)$ (resp. $\left.\pi^{-1}(0)\right)$ is union of two smooth projective varities intersecting transversally, $T$ (resp. $T^{\prime}$ ) is unipotent. It is known that the unipotency index of $T$ is atmost 4 and $T^{\prime}$ is atmost 2 (see [11, Monodromy Theorem page 106]). Recall that there is a decreasing filtration $\left\{F^{p}\right\}, p=0,1,2,3$ (resp. $\left\{G^{q}\right\}, q=0,1$ ) of the holomorphic vector bundle $H_{\mathrm{c}}(\mathscr{M})$ (resp. $H_{\mathrm{c}}(\mathscr{X})$ ) by holomorphic subbundles such that
(1) for each $t \in \Delta^{*}$ the filtration $\left\{F^{p}(t)\right\}$ (resp. $\left.\left\{G^{p}(t)\right\}\right)$ gives the Hodge filtration on $H_{\mathbb{C}}(\mathscr{M})(t)=H^{3}\left(M_{t}, \mathbb{C}\right)$.
(2) the flat connection $\nabla_{\mu}$ (resp. $\nabla_{\mathscr{X}}$ ) satisfies $\nabla_{\mu}\left(F^{p}\right) \subset F^{p-1} \otimes \Omega_{\Delta^{*}}^{1}$ (resp. $\left.\nabla_{\mathscr{X}}\left(G^{q}\right) \subset G^{q-1} \otimes \Omega_{\Delta^{*}}^{1}\right)$ where $\Omega_{\Delta^{*}}^{1}$ is the sheaf of holomorphic 1 forms on $\Delta^{*}$.
We say the triple $\left(H_{\mathrm{C}}(\mathscr{M}), F^{p}, H_{\mathrm{z}}(\mathscr{M})\right)$ (resp. $\left(H_{\mathrm{c}}(\mathscr{M}), G^{q}, H_{\mathrm{z}}(\mathscr{M})\right)$ a variation of Hodge structure corresponding to the local system $H_{z}(\mathcal{M})$ (resp. $H_{z}(\mathscr{X})$ ). Set $V=H_{\mathrm{c}}(\mathscr{M}) / F^{2}$. Then $V$ is a holomorhic vector bundle over $\Delta^{*}$ of rank $2 g$. Since $H_{Z}(\mathscr{M})(t) \cap F^{2}(t)=(0)$ for all $t \in \Delta^{*}$, we get $H_{Z}(\mathscr{M})$ is a cocompact lattice inside $V$ i.e for each $t \in \Delta^{*} H_{\mathrm{Z}}(\mu)(t) \subset V(t)$ is a cocompact lattice of rank $2 g$. Therefore, we can construct a complex manifold $J^{2 *}:=V / H_{Z}(\mathcal{M})$ and a proper, surjective, holomorphic submersion $\pi_{1}: J^{2} \rightarrow \Delta^{*}$ such that $\pi_{1}^{-1}(t)=J^{2}\left(M_{t}\right)$ for all $t \in \Delta^{*}$. Similarly, we can construct a proper, holomorphic, submerssion $\pi^{\prime}: J^{0 *} \rightarrow \Delta^{*}$ such that $\pi^{\prime-1}(t)=J^{0}\left(X_{t}\right)$. Note that the principal polarisations $\left\{\Theta_{t^{\prime}}^{\prime}\right\}_{\in \mathrm{a}^{*}}$, induced by the intersection form (1.0.2), fit together to give a relative polarisation $\Theta^{\prime}$ on $J^{2 *}$. Also the family of Jacobians $\pi^{\prime}: J^{0 *} \rightarrow \Delta^{*}$ carries a canonical relative principal polarisation induced by the intersection pairing on $H^{1}\left(X_{t}, \mathbb{Z}\right), t \in \Delta^{*}$. We denote this relative polarisation by $\Theta$.

We recall that there is a unique extension $\bar{H}_{\mathrm{c}}(\mathscr{M})$ (resp. $\bar{H}_{\mathrm{c}}(\mathscr{X})$ ) of the holomorphic vector bundle $H_{\mathrm{c}}(\mathcal{M})$ such that the extended connection $\bar{\nabla}_{\mathcal{M}}$ (resp. $\bar{\nabla}_{x x}$ ) is regular singular and the residue $N=\log (T)$ (resp. $N^{\prime}=\log \left(T^{\prime}\right)$ ) of $\bar{\nabla}_{\mu}$ (resp. $\bar{\nabla}_{\mathscr{X}}$ ) is nilpotent ((see [7, Page 91-92]). There is also an extension $\frac{\mathscr{K}}{F^{2}}$ (resp. $\overline{G^{1}}$ ) of the subbundle $F^{2}$ (resp. $G^{1}$ ) such that $\bar{\nabla}_{\mu \mu}\left(\overline{F^{2}}\right) \subset \overline{F^{1}} \otimes \Omega_{\Delta}^{1}(\log (0))$ ([19], Nilpotent orbit Theorem). Let $\bar{H}_{Z}(\mathscr{M}):=j_{*}\left(H_{Z}(\mathscr{M})\right)$ (resp. $\bar{H}_{z}(\mathscr{X}):=$ $j_{*}\left(H_{\mathrm{Z}}(\mathscr{X})\right)$ where $j: \Delta^{*} \rightarrow \Delta$ is an inclusion. We denote by $\bar{H}(\mathscr{M})(0)$ (resp. $\bar{H}(\mathscr{X})(0))$ and $\bar{F}^{2}(0)\left(\bar{G}^{1}(0)\right)$ the fibre of $\bar{H}_{\mathrm{C}}(\mathscr{M})$ (resp. $\left.\bar{H}_{\mathrm{C}}(\mathscr{X})\right)$ and $\bar{F}^{2}$ (resp. $\bar{G}^{1}$ ) at 0 .
4.0.2. Limiting mixed Hodge structure on the fibre $\bar{H}(\mathscr{M})(0)$ and $\bar{H}(\mathscr{X})(0)$. In general the filtration $\left\{\overline{F^{p}}(0)\right\}$ (resp. $\left.\left\{\overline{G^{q}}(0)\right\}\right)$ does not define a Hodge structure on $\bar{H}(\mathscr{M})(0)$ (resp. $\bar{H}(\mathscr{X})(0)$ ). However, it follows that from a theorem of W Schmid [19] (see [8, Theorem 10] for the statement), for each $t \in \mathbb{C}^{*}$, the data $\left(t^{N} \bar{H}_{\mathrm{Z}}(\mathscr{M})(0), \overline{F^{p}}(0), W_{r}\right)$ (resp. $\left.\left(t^{N^{\prime}} \bar{H}_{\mathrm{Z}}(\mathscr{X})(0), \overline{G^{q}}(0), W_{r}^{\prime}\right)\right)$ defines a mixed

Hodge structure (see [8, definition 11] for the definition) where $N$ (resp. $N^{\prime}$ ) is the residue of the monodromy operator $T_{\mathcal{M}}\left(\operatorname{resp} . T_{\mathcal{M}}\right)$ and $W_{r}\left(\right.$ resp. $\left.W_{r}^{\prime}\right)$ is the weight filtration defined by $N$ (resp. $N^{\prime}$ ) (see also [11]). Thus, in particular, if the residue of the monodromy operator is trivial then there is no monodromy weight filtration and we have pure Hodge structure.

In the next lemma we will show that $N^{\prime}=0$. As a consequence of this we can extend the family $J^{0 *} \rightarrow \Delta^{*}$ to a family $J^{0} \rightarrow \Delta$.
Lemma 4.1. The limiting Hodge structure on $\bar{H}(\mathscr{X})(0)$ is pure and is isomorphic to the Hodge structure on $H^{1}\left(X_{1}, \mathbb{C}\right) \oplus H^{1}\left(X_{2}, \mathbb{C}\right)$.

Proof. Since the singular fiber $X_{0}$ is the union of two smooth curves meeting transversally at a node we have $N^{\prime}=0$ (see [11, page 111]). So, in this case, there is no weight filtration and hence the limiting Hodge structure on $\bar{H}(\mathscr{X})(0)$ is pure. Now we have a morphism of MHS, $i^{*}: H^{1}\left(X_{0}, \mathbb{Z}\right) \rightarrow \bar{H}(\mathscr{X})(0)$ of $(0,0)$ type (see [11, Clemens-Schmid I,page 108]). By Local Invariance Cycle Theorem [11, page 108]), it known that:

\operatorname{Ker}(N)=\operatorname{Im}\left(i^{*}\right)
$$

Since $\operatorname{Ker}\left(N^{\prime}\right)=\bar{H}(0), i^{*}$ is surjecive. Now $\left.r k\left(H^{1}\left(X_{0}, \mathbb{Z}\right)\right)=2 g=r k(\bar{H}(\mathscr{X})(0))\right)$. Therefore, $i^{*}: H^{1}\left(X_{0}, \mathbb{Z}\right) \rightarrow \overline{H(\mathscr{X})}(0)$ is an isomorphism of Hodge structure. (see [11, page 111]).
Corollary 4.2. There is a holomorphic family $\pi_{2}: J^{0} \rightarrow \Delta$ extending the family $\pi_{2}: J^{0 *} \rightarrow \Delta^{*}$ such that $\pi_{2}^{-1}(0)=J^{0}\left(X_{0}\right)$.

Proof. Since $N^{\prime}=0$, we get that $\overline{G^{1}}(0) \cap \bar{H}_{\mathbb{Z}}(\mathscr{X})(0)=(0)$. As a consequence $\bar{H}_{\mathbb{Z}}(\mathscr{X})(0)$ is a full lattice inside $\bar{H}_{\mathbb{C}}(\mathscr{X})(0) / \bar{G}^{1}(0)$. Thus there is a holomorphic family $\pi_{2}: J^{0}(\mathscr{X}) \rightarrow \Delta$ extending the family $\pi_{1}: J^{0 *} \rightarrow \Delta^{*}$ such that $\pi_{2}^{-1}(0)=V / \bar{H}_{\mathbb{Z}}(0)$ where $V:=\bar{H}_{\mathbb{C}}(0) / \overline{F^{1}}(0)$. By Lemma 4.1, it follows that $\pi_{2}^{-1}(0) \simeq J^{0}\left(X_{0}\right)$.

Next we shall show,
Lemma 4.3. There is an isomorphism $\bar{\phi}: \overline{H_{\mathbb{C}}}(\mathscr{X}) \rightarrow \overline{H_{\mathbb{C}}}(\mathscr{M})$ such that $\bar{\phi}\left(\overline{G^{q}}\right)=$ $\overline{F^{q+1}}$ and $\bar{\phi}\left(\overline{H_{\mathbb{Z}}}(\mathscr{X})\right)=\overline{H_{\mathbb{Z}}}(\mathscr{M}), q=0,1$.

Proof. Let $\mathscr{U}$ be the relative universal bundle over $\mathscr{X}^{*} \times_{\Delta^{*}} \mathscr{M}^{*}$ i.e $\mathscr{U}_{\mid X_{t} \times M_{t}}$ is the corresponding universal bundle. Now if we consider $(1,3)$ Kunneth-component $\left[\left.c_{2}(\mathscr{U})\right|_{X_{t} \times M_{t}}\right]_{1,3} \in H^{1}\left(X_{t}, \mathbb{Z}\right) \otimes H^{3}\left(M_{t}, \mathbb{Z}\right)$ of $c_{2}\left(\left.\mathscr{U}\right|_{X_{t} \times M_{t}}\right)$, then we get a morphism $\phi_{t}: H^{1}\left(X_{t}, \mathbb{Z}\right) \rightarrow H^{3}\left(M_{t}, \mathbb{Z}\right), t \in \Delta^{*}$ such that $\phi_{t}\left(G^{q}(t)\right) \subseteq F^{q+1}(t)$ for $q=0,1$ (see [12]). Thus we get a morphism $\phi: H_{\mathbb{Z}}(\mathscr{X}) \rightarrow H_{\mathbb{Z}}(\mathscr{M})$ of local systems, preserving the Hodge filtrations. Since the filtration $\left\{\bar{G}^{q}(0)\right\}$ (resp. $\left\{\overline{F^{p}}(0)\right\}$ ) is canonically determined by the filtrations $\left\{G^{q}(t)\right\}$ (resp. $\left.\left\{F^{q}(t)\right\}\right)$ (see [11, Theorem(Schmid), page 116]), we get a morphism $\phi_{0}: \bar{H}(\mathscr{X})(0) \rightarrow \bar{H}(\mathscr{M})(0)$ such that $\phi_{0}\left(\overline{G^{q}}(0)\right) \subseteq \overline{F^{q+1}}(0)$. Therefore, the morphism $\phi$ extends to a morphism $\bar{\phi}: \overline{H_{\mathbb{C}}}(\mathscr{X}) \rightarrow \overline{H_{\mathbb{C}}}(\mathscr{M})$ such that $\bar{\phi}\left(\bar{G}^{q}\right) \subseteq \overline{F^{q+1}}$; further, we have $\phi^{*}\left(\Theta^{\prime}\right)=\Theta$ (see [2, Section 5,page 625]). By the Mumford-Newstead theorem [12, Proposition 1 , page 1204] we conclude that $\bar{\phi}$ is an isomorphism.

Now we will state the main theorem of this section:

## Theorem 4.4.

(1) There is a holomorphic family $\left\{J^{2}\left(M_{t, \mathscr{L}_{t}}\right)\right\}_{t \in \Delta}$ of intermediate Jacobians corresponding to the family $\left\{M_{t, \mathscr{L}_{t}}\right\}_{t \in \Delta}$. In other words, there is a surjective, proper, holomorphic submersion

\pi_{2}: J^{2}\left(\mathscr{M}_{\mathscr{L}}\right) \longrightarrow \Delta
$$

such that $\pi_{2}^{-1}(t)=J^{2}\left(M_{t, \mathscr{L}_{t}}\right) \forall t \in \Delta^{*}:=\Delta \backslash\{0\}$ and $\pi_{2}^{-1}(0)=J^{2}\left(M_{0, \xi}\right)$. Further, we show that there exists a relative ample class $\Theta^{\prime}$ on $J^{2}\left(\mathscr{M}_{\mathscr{L}}\right)_{\mid \Delta^{*}}$ such that $\Theta_{\mid J^{2}\left(M_{t, \mathscr{L}_{t}}^{\prime}\right)}^{\prime}=\theta_{t}^{\prime}$, where $\Theta_{t}^{\prime}$ is the principal polarisation on $J^{2}\left(M_{t, \mathscr{L}_{t}}\right)$.
(2) There is an isomorphism

such that $\Phi^{*} \Theta_{\mid \pi_{1}^{-1}(t)}^{\prime}=\Theta_{t}$ for all $t \in \Delta^{*}$, where $\pi_{1}: J^{0}(\mathscr{X}) \rightarrow \Delta$ is the holomorphic family $\left\{J^{0}\left(X_{t}\right)\right\}_{t \in \Delta}$ of Jacobians and $\Theta_{t}$ is the canonical polarisation on $J^{0}\left(X_{t}\right)$. In particular, $J^{2}\left(\mathscr{M}_{\mathscr{L}}\right)_{0}:=\pi_{2}^{-1}(0)$ is an abelian variety.

Proof. Proof of (1): By Lemma 4.3 we get the local system $H_{\mathbb{Z}}(\mathscr{M})$ is isomorphic to the local system $H_{\mathrm{Z}}(\mathscr{X})$ over $\Delta^{*}$. Since by Lemma 4.1 the local system $H_{\mathbb{Z}}(\mathscr{X})$ has trivial monodromy, therefore the local system $H_{\mathbb{Z}}(\mathscr{M})$ also has trivial monodromy. Hence $N=0$. Thus we have $\overline{F^{2}}(0) \cap \bar{H}_{\mathbb{Z}}(\mathscr{M})(0)=(0)$. As a consequence we have a holomorphic family $\pi_{1}: J^{2}\left(\mathscr{M}_{\mathscr{L}}\right) \rightarrow \Delta$ extending the family $\pi_{1}: J^{2 *} \rightarrow \Delta^{*}$ such that $\pi^{-1}(0)=V^{\prime} / \bar{H}_{\mathbb{Z}}(\mathscr{M})(0)$ where $V^{\prime}=\bar{H}_{\mathrm{C}}(\mathscr{M})(0) / \bar{F}^{2}(0)$. Now we claim: $\pi_{1}^{-1}(0) \simeq J^{2}\left(M_{0, \xi}\right)$. By Theorem 3.16, we see that the Hodge structure on $H^{3}\left(M_{0, \xi}, \mathbb{Z}\right)$ is pure and it has rank $2 g$. Now there is a morphism $i^{*}: H^{3}\left(M_{0, \xi}, \mathbb{Z}\right) \rightarrow \bar{H}_{\mu}(0)$ of MHS of $(0,0)$ type and $\operatorname{Ker}(N)=\operatorname{Im}\left(i^{*}\right)$. Since $\operatorname{Im}(N)=0$ and both the Hodge structures have the same rank $2 g, \bar{H}_{\mathbb{Z}}(\mathscr{M})(0)$ and $H^{3}\left(M_{0, \xi}, \mathbb{Z}\right)$ are isomorphic as Hodge structures. This completes the proof of (1).

Proof of (2): This immediately follows from Lemma 4.3.
As a corollary of the theorem we get the following result:
Corollary 4.5. Let $X_{0}$ be a projective curve with exactly two smooth irreducible components $X_{1}$ and $X_{2}$ meeting at a simple node $p$. We further assume that $g_{i}>3, i=1,2$. Then, there is an isomorphism $J^{0}\left(X_{0}\right) \simeq J^{2}\left(M_{0, \xi}\right)$, where $\xi \in J^{\chi}\left(X_{0}\right)$. In particular, $J^{2}\left(M_{0, \xi}\right)$ is an abelian variety.

Proof. By our genus assumption: $g_{i}>3$ for $\mathrm{i}=1,2$, the curve $X_{0}$ is stable i.e, they have finite number of automorphisms. As the moduli space of stable curves is complete, we get an algebraic family $r: \mathscr{X} \rightarrow \mathbb{P}^{1}$ such that $r_{1}^{-1}(t)$ is smooth if $t \neq t_{0}$ and $r_{1}^{-1}\left(t_{0}\right)=X_{0}$. Moreover, we can choose $\mathscr{X}$ to be regular over $\mathbb{C}$. Therefore, by Theorem 4.4, we get $J^{2}\left(M_{0, \xi}\right) \simeq J\left(X_{0}\right)$. Hence, $J^{2}\left(M_{0, \xi}\right)$ is an abelian variety.

## 5. Torelli type Theorem for the moduli space of rank 2 Degree 1 FIXED DETERMINANT TORSION FREE SHEAVES OVER A REDUCIBLE CURVE

In this section our goal is to investigate the moduli space $M_{0, \xi}$ more carefully, and show that we can actually recover the curve $X_{0}$ i.e both the components as well as the node, from the moduli space $M_{0, \xi}$ following a strategy given in [3].

Let $\pi: \tilde{X}_{0} \rightarrow X_{0}$ be the normalization map and $\pi^{-1}(p)=\left\{x_{1}, x_{2}\right\}$, where $p \in X_{1} \cap X_{2}$. Note that $\tilde{X}_{0}=X_{1} \sqcup X_{2}$, the disjoint union of $X_{1}$ and $X_{2}$. Fix a line bundle $\xi$ on $X_{0}$ and let $\xi_{i}=\left.\xi\right|_{X_{i}}, i=1,2$. Recall that that the moduli space $M_{0, \xi}$ of rank 2 stable torsion free sheaves with determinant $\xi$ over $X_{0}$ is the union of two irreducible, smooth, projective varieties intersecting transversally along a divisor $D$. We have also observed that $D$ is isomorphic to the product $P_{1} \times P_{2}$, where $P_{1}$ is the moduli space of rank 2 parabolic semistable bundles ( $F_{1}, 0 \subset$ $\left.F^{2} F_{1}\left(x_{1}\right) \subset F_{1}\left(x_{1}\right)\right)$ over $X_{1}$ with det $\simeq \xi_{1}$ and weights $\left(\frac{a_{1}}{2}, \frac{a_{2}}{2}\right)$, and $P_{2}$ is the moduli space of rank 2 parabolic semistable bundles $\left(F_{2}, 0 \subset F^{2} F_{2}\left(x_{2}\right) \subset F_{2}\left(x_{2}\right)\right)$ over $X_{2}$ with det $\simeq \xi_{2}$ and weights $\left(\frac{a_{1}}{2}, \frac{a_{2}}{2}\right)$, where $a=\left(a_{1}, a_{2}\right)$ is the polarisation on $X_{0}$. Without loss of generality, we can assume that $\operatorname{deg}\left(\xi_{1}\right)=1$ and $\operatorname{deg}\left(\xi_{2}=0\right.$.

Let $M_{1}$ (resp. $M_{1}^{\prime}$ ) be the moduli space of rank 2, deg 1 , semistable bundles over $X_{1}$ with det $E \simeq \xi_{1}$ (resp. moduli space of rank 2, deg 0 semistable bundles over $X_{2}$ with $\operatorname{det} E \simeq \xi_{1}\left(-x_{1}\right)$ ).

Note that $\operatorname{Pic}\left(M_{1}\right) \simeq \mathbb{Z}$ (resp. $\operatorname{Pic}\left(M_{1}^{\prime}\right) \simeq \mathbb{Z}$ ). Let $\theta_{1}$ (resp. $\theta_{1}^{\prime}$ ) be the unique ample generator of $\operatorname{Pic}\left(M_{1}\right)$ (resp. of $\operatorname{Pic}\left(M_{1}^{\prime}\right)$ ). It is known that there exists a unique rank 2 bundle $\mathscr{E}$ over $X_{1} \times M_{1}$ such that $\wedge^{2} \mathscr{E}_{x_{1}} \simeq \theta_{1}$, where $\mathscr{E}_{x_{1}}:=\mathscr{E}_{\mid x_{1} \times M_{1}}$ (see [18, Definition 2.10]). Since the weights $0<\frac{a_{1}}{2}, \frac{a_{2}}{2}<1$ are very small, we can show that: $P_{1} \simeq \mathbb{P}\left(\mathscr{E}_{x_{1}}\right)$ (see [1, Proposition 6]). Therefore, it follows that $\operatorname{Pic}\left(P_{1}\right) \simeq \operatorname{Pic}\left(M_{1}\right) \oplus \operatorname{Pic}\left(\mathbb{P}^{1}\right) \simeq \mathbb{Z} \oplus \mathbb{Z}$.

We define a morphism $\pi_{1}^{\prime}: \mathbb{P}\left(\mathscr{E}_{x_{1}}\right) \rightarrow M_{1}^{\prime}$ as follows: Any closed point of $\mathbb{P}\left(\mathscr{E}_{x_{1}}\right)$ over $E \in M_{1}$ looks like $\left\{E, V\left(x_{1}\right)\right\}$, where $V\left(x_{1}\right)$ is a one dimensional subspace of the fibre $E\left(x_{1}\right)$. Consider the vector bundle $V$ which fits into the following exact sequence

$$
\begin{equation*}
0 \rightarrow V \rightarrow E \rightarrow\left(i_{x_{1}}\right)_{*}\left(E\left(x_{1}\right) / V\left(x_{1}\right)\right) \rightarrow 0 \tag{5.0.1}
\end{equation*}
$$

As $E\left(x_{1}\right) / V\left(x_{1}\right)$ is 1-dimensional vector space supported over the point $x_{1}$, it follows that $\operatorname{det}(V) \simeq \xi_{1}\left(-x_{1}\right)$. We can easily check that $V$ is semistable (see [1, page 11]).

Thus we get a Hecke correspondence:

\underset{\mathbb{P}\left(\mathscr{E}_{x_{1}}\right)}{\left.\right|_{1} ^{\pi_{1}}} \underset{\xrightarrow[l]{\pi_{1}^{\prime}}}{M_{1}^{\prime}} M^{\prime} \tag{5.0.2}
\end{equation*}
$$

Similarly, let $M_{2}$ (resp. $M_{2}^{\prime}$ ) be the moduli space of rank 2, deg 1 semistable bundles over $X_{2}$ with $\operatorname{det} E \simeq \xi_{2}\left(x_{2}\right)$ (resp. the moduli space of rank 2, deg 0 semistable bundles over $X_{2}$ with $\operatorname{det} E \simeq \xi_{2}$ ).

Let $\theta_{2}$ (resp. $\theta_{2}^{\prime}$ ) be the unique ample generator of $\operatorname{Pic}\left(M_{2}\right)$ (resp. $\operatorname{Pic}\left(M_{2}^{\prime}\right)$ ). Then there is a unique universal bundle $\mathscr{E}^{\prime}$ over $X_{2} \times M_{2}$ such that $\wedge^{2} \mathscr{E}_{x_{2}}^{\prime} \simeq \theta_{2}$ where $\mathscr{E}_{x_{2}}^{\prime}:=\mathscr{E}_{\mid x_{2} \times M_{2}}^{\prime}$.

Again, for the choice of weights $0<\frac{a_{1}}{2}, \frac{a_{2}}{2}<1$, we have $P_{2} \simeq \mathbb{P}\left(\mathscr{E}_{x_{2}}^{\prime}\right)$ and we have a Hecke correspondence as in the previous case:

\end{equation*}

So, we have the following:

\mathbb{P}\left(\mathscr{E}_{x_{1}}\right) \times \mathbb{P}\left(\mathscr{E}_{x_{2}}^{\prime}\right) \xrightarrow{p_{1}} \mathbb{P}\left(\mathscr{E}_{x_{1}}\right) \xrightarrow{\pi_{1}^{\prime}} M_{1}^{\prime} \tag{5.0.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathbb{P}\left(\mathscr{E}_{x_{1}}\right) \times \mathbb{P}\left(\mathscr{E}_{x_{2}}^{\prime}\right) \xrightarrow{p_{2}} \mathbb{P}\left(\mathscr{E}_{x_{2}}^{\prime}\right) \xrightarrow{\pi_{2}^{\prime}} M_{2}^{\prime} \tag{5.0.5}
\end{equation*}
$$

Remark 5.1. Note that $M_{1}$ and $M_{2}$ are smooth , projecive, rational varieties. Now $P_{1}\left(\right.$ resp. $\left.P_{2}\right)$ is isomorphic to the projective bundle $\mathbb{P}\left(\mathscr{E}_{x_{1}}\right)$ (resp. $\mathbb{P}\left(\mathscr{E}_{x_{2}}^{\prime}\right)$ ). Therefore, $P_{i}$ 's are rational varieties, $i=1,2$.

For the rest of the section we will fix the following notations:

\vartheta_{1}:=\left(\pi_{1} \circ p_{1}\right)^{*} \theta_{1}, & \vartheta_{2}:=\left(\pi_{1}^{\prime} \circ p_{1}\right)^{*} \theta_{1}^{\prime} \\
\vartheta_{3}:=\left(\pi_{2} \circ p_{2}\right)^{*} \theta_{2}, & \vartheta_{4}:=\left(\pi_{2}^{\prime} \circ p_{2}\right)^{*} \theta_{2}^{\prime}
\end{array}

Proposition 5.1. The numerically effective cone of $P_{1} \times P_{2}$ is generated by the line bundles $\vartheta_{i}, i=1,2,3,4$.

Proof. Clearly, $\vartheta_{i}, i=1, \cdots, 4$ are numerically effective (nef) line bundles as they are the pull backs of the ample line bundles. First we show that $\vartheta_{i}$, $i=1, \cdots, 4$, are linearly independent. Note that $\pi_{1}^{*} \theta_{1}$ and $\pi_{1}^{\prime *} \theta_{1}^{\prime}$ are linearly independent over $\mathbb{Z}$ (see the proof of [3, page 4 , Theorem 2.1] for an argument). Therefore, $\vartheta_{1}=p_{1}^{*} \pi_{1}^{*} \theta_{1}$ and $\vartheta_{2}:=p_{1}^{*} \pi^{\prime *} \theta_{1}^{\prime}$ are linearly independent. By similar reason $\vartheta_{3}$ and $\vartheta_{4}$ are linearly independnt. Now we show that the relation $\vartheta_{1}^{a_{1}} \otimes \vartheta_{2}^{a_{2}}=\vartheta_{3}^{a_{3}} \otimes \vartheta_{4}^{a_{4}}$ for some $a_{i} \neq 0, i=1, \cdots 4$ will not occur. Suppose, $\vartheta_{1}^{a_{1}} \otimes \vartheta_{2}^{a_{2}}=\vartheta_{3}^{a_{3}} \otimes \vartheta_{4}^{a_{4}}$. Then this would imply $p_{1}^{*}\left(\pi_{1}^{*} \theta_{1}^{a_{1}} \otimes \pi_{1}^{\prime *} \theta_{1}^{\prime a_{2}}\right)=$ $p_{2}^{*}\left(\pi_{2}^{*} \theta_{2}^{\left.a_{3} \otimes \pi_{2}^{\prime *} \theta_{2}^{\prime a_{4}}\right) \text {. But this is impossible for the following reason: The line }}\right.$ bundle $p_{1}^{*}\left(\pi_{1}^{*} \theta_{1} \otimes \pi_{1}^{\prime *} \theta_{1}^{\prime}\right)$ is trivial on the fibres of $p_{1}$. But as the fibres of $p_{1}$ are $P_{2}$ and $\pi_{2}^{*} \theta_{2} \otimes \pi_{2}^{\prime *} \theta_{2}^{\prime}$ is a non trivial line bundle on $P_{2}$ we get $p_{2}^{*}\left(\pi_{2}^{*} \theta_{2} \otimes \pi_{2}^{\prime *} \theta_{2}^{\prime}\right)$ is non trivial on the fibres of $p_{1}$. From the above observation, it follows that $\vartheta_{i}$, $i=1, \cdots 4$ are linearly independent. Since $P_{1}$ and $P_{2}$ are both rational varieties we get $\operatorname{Pic}\left(P_{1} \times P_{2}\right) \simeq \operatorname{Pic}\left(P_{1}\right) \times \operatorname{Pic}\left(P_{2}\right) \simeq \mathbb{Z}^{4}$. Therefore, any nef line bundle on $P_{1} \times P_{2}$ is a non negative linear combination of $\vartheta_{1}, \vartheta_{2}, \vartheta_{3}, \vartheta_{4}$.

Next we show that $\bigotimes_{i=1}^{4} \vartheta_{i}^{a_{i}}$ is ample if $a_{i}>0$ for all $i=1, \ldots, 4$. It is enough to show that $\otimes_{i=1}^{4} \vartheta_{i}$ is ample. We observe that $\pi_{1}^{*} \theta_{1} \otimes \pi_{1}^{\prime *} \theta_{1}^{\prime}$ (resp. $\pi_{2}^{*} \theta_{2} \otimes \pi_{2}^{\prime *} \theta_{2}^{\prime}$ ) is ample on $P_{1}$ (resp. on $P_{2}$ ) (see the proof of [3, Theorem 2.1, page 4, 3rd paragraph]). Therefore , $\bigotimes_{i=1}^{4} \vartheta_{i}$ is ample on $P_{1} \times P_{2}$.

Finally, we have to show $\bigotimes_{i=1}^{4} \vartheta_{i}^{a_{i}}$ is not ample if $a_{i}=0$ for some $i$. Now fix $j \in\{1, \ldots, 4\}$ such that $a_{j}=0$. Then $\bigotimes_{\substack{i=1 \\ i \neq j}}^{4} \vartheta_{i}$ is not ample as it is the pull back of an ample line bundle from $P_{k} \times M_{l}$ or $P_{k} \times M_{k}^{\prime}$ for $l, k \in\{1,2\}, k \neq l$. Next we observe that if $i \in\{1,2\}$ and $j \in\{3,4\}$, then $\vartheta_{i} \otimes \vartheta_{j}$ is not ample. Since in this case it is pull back of an ample line bundle from $M_{k} \times M_{l}$ or $M_{k}^{\prime} \times M_{l}^{\prime}$ for $k, l \in\{1,2\}, k \neq l$. We have already observed that $\vartheta_{1} \otimes \vartheta_{2}$ and $\vartheta_{3} \otimes \vartheta_{4}$ is not ample.

So, from the above observations, we conclude the proposition.
Lemma 5.2. Let $f: X \rightarrow Y$ be a projective morphism with $Y$, a normal variety. Suppose, each fibre of $f$ is a rational variety. Let $L$ be a line bundle on $Y$ then $H^{0}\left(X, f^{*} L\right) \simeq H^{0}(Y, L)$.

Proof. Since the fibres of $f$ are connected and $Y$ is normal we have $\mathscr{O}_{Y} \simeq f_{*} \mathscr{O}_{X}$. Thus $L \simeq f_{*} f^{*} L$. Since all the fibres of $f$ are rational we get $H^{i}\left(X_{y}, L_{y}\right)=$ $H^{i}\left(X_{y}, \mathscr{O}_{X_{y}}\right)=0$ for all $i>0$. Hence $H^{0}\left(X, f^{*} L\right) \simeq H^{0}\left(Y, f_{*} f^{*} L\right)=H^{0}(Y, L)$

Remark 5.2. Note that $\pi_{1}^{*} \theta_{1} \otimes \pi_{1}^{\prime *} \theta_{1}^{\prime}$ (resp. $\pi_{2}^{*} \theta_{2} \otimes \pi_{2}^{\prime *} \theta_{2}^{\prime}$ ) is ample on $P_{1}$ (resp. on $P_{2}$ ) (see the proof of 5.1). Now $\vartheta_{1} \otimes \vartheta_{2}=p_{1}^{*}\left(\pi_{1}^{*} \theta_{1} \otimes \pi_{1}^{\prime *} \theta_{1}^{\prime}\right)$ and $\vartheta_{3} \otimes \vartheta_{4}=p_{1}^{*}\left(\pi_{1}^{*} \theta_{3} \otimes\right.$ $\pi_{1}^{\prime *} \theta_{4}^{\prime}$ ). Since $P_{1}$ and $P_{2}$ are both rational varaities, by Lemma 5.2, the image of the morphism $\left|\left(\vartheta_{1} \otimes \vartheta_{2}\right)^{n}\right|: P_{1} \times P_{2} \rightarrow \mathbb{P}^{N}$ is isomorphic to $P_{1}$ for some $n \gg 0$. Similarly, the image of the morphism $\left(\vartheta_{3} \otimes \vartheta_{4}\right)^{m}: P_{1} \times P_{2} \rightarrow \mathbb{P}^{M}$ is isomorphic to $P_{2}$ for some $m \gg 0$.

Lemma 5.3. Let $\theta$ be a nef but not ample line bundle on $P_{1} \times P_{2}$ (i.e, $\theta$ lies in the boundary of the nef cone of $P_{1} \times P_{2}$ ) and $\theta \neq \vartheta_{1}^{a} \otimes \vartheta_{2}^{b}$ or $\vartheta_{3}^{c} \otimes \vartheta_{4}^{d}$, where $a, b, c$ and $d$ are some positive integers. Let $Z$ be the image of the morphism $P_{1} \times P_{2} \rightarrow \mathbb{P}^{N^{\prime}}$ induced by the linear system $\left|\theta^{n}\right|$ for some large $n$. Then we have $\operatorname{dim}(Z) \neq \operatorname{dim}\left(P_{i}\right)$ for $i=1,2$.
Proof. Assume that $\theta \neq \vartheta_{1} \otimes \vartheta_{2}$ or $\vartheta_{3} \otimes \vartheta_{4}$. Then $\theta$ is either of the form $\bigotimes_{i \neq j} \vartheta_{i}$ for $i, j \in\{1, \ldots, 4\}$ or $\vartheta_{i} \otimes \vartheta_{j}$ for $i \in\{1,2\}$ and $j \in\{3,4\}$ (see the proof of 5.1).

Fix $j \in\{1,2,3,4\}$. If $\theta$ is of the form $\underset{\substack{i=1 \\ i \neq j}}{4} \vartheta_{i}$, then the image $Z$ of the morphism $\left|\theta^{n}\right|$, for sufficiently large $n$, is either isomorphic to $P_{k} \times M_{l}$ or $P_{k} \times M_{l}^{\prime}$ for $k, l \in$ $\{1,2\}, k \neq l$.

If $\theta$ is of the form $\vartheta_{i} \otimes \vartheta_{j}$ then the image $Z$ of the morphism $\left|\theta^{n}\right|$ is either isomorphic to $M_{k} \times M_{l}$ or $M_{k} \times M_{l}^{\prime}$, for $k, l \in\{1,2\}, k \neq l$. In both the cases we see $\operatorname{dim}(Z) \neq \operatorname{dim}\left(P_{i}\right)$ and hence we are done.

Now we prove the main theorem of this section:

Let $X_{0}$ (resp. $Y_{0}$ ) be a reducible curve with two components $X_{1}, X_{2}$ (resp. $Y_{1}, Y_{2}$ ) meeting transversally at a point $p$ (resp. q). Let $\pi_{1}: \tilde{X}_{0} \rightarrow X_{0}$ (resp. $\pi_{2}: \tilde{Y}_{0} \rightarrow Y_{0}$ ) be the normalisation map and $\pi_{1}^{-1}(p)=\left\{x_{1}, x_{2}\right\}, \pi_{2}^{-1}(q)=\left\{y_{1}, y_{2}\right\}$. We will make the following assumption on the components of $X_{0}$ and $Y_{0}$.

- $g\left(X_{i}\right)=g\left(Y_{i}\right) \geq 2$ for $i=1,2$.
- $X_{1} \not \not \equiv X_{2}$ (resp. $Y_{1} \not \neq Y_{2}$ ).

Fix $\xi_{X_{0}} \in J^{\chi}\left(X_{0}\right)$ (resp. $\left.\xi_{Y_{0}} \in J^{\chi}\left(Y_{0}\right)\right)$. Let $M_{0, \xi_{X_{0}}}$ (resp. $M_{0, \xi_{Y_{0}}}$ ) be the moduli space of rank 2, $a=\left(a_{1}, a_{2}\right)$-stable torsion free sheaves with $\operatorname{det} E \simeq \xi_{x_{0}}$ (resp.det $E \simeq \xi_{Y_{0}}$ ) on $X_{0}$ (resp. on $Y_{0}$ ). Let $D \subset M_{0, \xi_{X_{0}}}$ (resp. $D^{\prime} \subset M_{0, \xi_{Y_{0}}}$ ) be the singular locus of $M_{0, \xi_{X_{0}}}$ (resp. $M_{0, \xi_{Y_{0}}}$ ) and $P_{i}$ (resp. $P_{i}^{\prime}$ ) be the parabolic moduli spaces, described before, with parabolic structure over $x_{i}$ (resp. $y_{i}$ ). Then $D \simeq P_{1} \times P_{2}$ and $D^{\prime} \simeq P_{1}^{\prime} \times P_{2}^{\prime}$. Now we have the following Torelli type theorem.

Theorem 5.4. If $M_{0, \xi_{X_{0}}} \simeq M_{0, \xi_{Y_{0}}}$ then we have $X_{0} \simeq Y_{0}$.
Proof. Let $\Psi: M_{0, \xi_{X_{0}}} \simeq M_{0, \xi_{Y_{0}}}$ be an isomorphism. Then $\Psi(D)=D^{\prime}$ as $D$ is the singular locus of $M_{0, \xi}$. Therefore, $\Psi$ induces an isomorphism $\Psi: P_{1} \times P_{2} \simeq P_{1}^{\prime} \times$ $P_{2}^{\prime}$. Now if we can show that the above statement will imply $P_{i} \simeq P_{\sigma(i)}^{\prime}$ for $i \in$ $\{1,2\}$ and $\sigma$ is a permutation on $\{1,2\}$. Then by [3, Theorem 2.1], we get an isomorphism $f_{i}: X_{i} \rightarrow Y_{\sigma(i)}$ such that $f_{i}\left(x_{i}\right)=y_{\sigma(i)}$. Hence, we get $X_{0} \simeq Y_{0}$. We will show that if $\Psi: P_{1} \times P_{2} \simeq P_{1}^{\prime} \times P_{2}^{\prime}$, then $P_{i} \simeq P_{\sigma(i)}^{\prime}$.

Let $\varsigma_{1}, \varsigma_{2}, \varsigma_{3}, \varsigma_{4}$ be the generators of the nef cone of $P_{1}^{\prime} \times P_{2}^{\prime}$ as in Proposition 5.1. Let $N:=\varsigma_{1} \otimes \varsigma_{2}$ and $N^{\prime}:=\varsigma_{3} \otimes \varsigma_{4}$. Then $\Psi^{*} N, \Psi^{*} N^{\prime}$ lie in the boundary of the nef cone of $P_{1} \times P_{2}$. Note that, for sufficiently large $n, m$, the image of the morphism $\left|\Psi^{*} N^{n}\right|$ is isomorphic to $P_{1}^{\prime}$ and the image of the morphism $\left|\Psi^{*} N^{\prime m}\right|$ is isomorphic to $P_{2}^{\prime}$.

Now we claim that $\Psi^{*}(N)=\vartheta_{1}^{a} \otimes \vartheta_{2}^{b}$ or $\vartheta_{3}^{c} \otimes \vartheta_{4}^{d}$ for some $a, b, c, d>0$. Otherwise, by Lemma 5.3, the dimension of the image of $\left|\Psi^{*}(N)^{n}\right|$ will be different from the dimension of $P_{1}^{\prime}$. Suppose that $\Psi^{*}(N)=\vartheta_{1}^{a} \otimes \vartheta_{2}^{b}$ for some $a, b>0$. Then, by our assumption $Y_{1} \not \not Y_{2}$, we have $\Psi^{*}\left(N^{\prime}\right)=\vartheta_{3}^{c} \otimes \vartheta_{4}^{d}$ for some $c, d>0$. Therefore, by Remark 5.2, for sufficiently large $n, m \gg 0$, the images of the morphisms defined by the linear systems $\left|\Psi^{*} N^{n}\right|$ and $\left|\Psi^{*} N^{\prime m}\right|$ will be isomorphic to $P_{1}$ and $P_{2}$. Hence, we have isomorphisms $\Phi_{1}: P_{1} \rightarrow P_{1}^{\prime}$ and $\Phi_{2}: P_{2} \rightarrow P_{2}^{\prime}$ such that the following diagrams commute:


Therefore, by [3, Theorem 2.1], there is an isomorphism $f_{1}: X_{1} \rightarrow Y_{1}$ such that $f_{1}\left(x_{1}\right)=y_{1}$ and an isomorphism $f_{2}: X_{2} \rightarrow Y_{2}$ such that $f_{2}\left(x_{2}\right)=y_{2}$.

Suppose that $\Psi^{*}(N)=\vartheta_{2}^{c} \otimes \vartheta_{4}^{d}, c, d>0$. Then, by similar arguments as above, we can show that $P_{2} \simeq P_{1}^{\prime}$ and $P_{1} \simeq P_{2}^{\prime}$. Therefore, there is an isomorphism $f_{1}^{\prime}: X_{2} \rightarrow Y_{1}$ such that $f_{1}^{\prime}\left(x_{2}\right)=y_{1}$ and an isomorphism $f_{2}^{\prime}\left(x_{1}\right)=y_{2}$ Hence, we conclude $X_{0} \simeq Y_{0}$. This completes the proof.

## 6. Appendix

In this section we will continue with the notations of the preleminary section. Fix an ample line bundle $\mathscr{O}_{X_{0}}(1)$ on $X_{0}$. Let $c_{i}=\operatorname{deg}\left(\left.\mathscr{O}_{X_{0}}(1)\right|_{X_{i}}\right)$, and $a_{i}=\frac{c_{i}}{c_{1}+c_{2}}, i=1,2$. Let $S(r, \chi)$ be the set of all rank $r, a=\left(a_{1}, a_{2}\right)$ semistable torsion free sheaves on $X_{0}$ with Euler charachteristic $\chi$. Note that the Hilbert polynomial $P(E, n)=\left(c_{1}+c_{2}\right) n+\chi(E)$ for all $E \in S(r, \chi)$ (this can be easily computed from equation (2.1.3)).

Lemma 6.1. ([13, Septieme Partie]) There exists an integer $m_{0}$ such that-
(1) $H^{1}(F(m))=0$ for all $F \in S(r, \chi)$ and $m \geq m_{0}$
(2) $F(m)$ is globally generated by its sections for all $F \in S(r, \chi)$.
6.1. Moduli space of rank 1 torsion free sheaves over a reducible nodal curve. In this subsection we prove that the moduli space of rank 1 ,semistable torsion free sheaves with respect to certain choice polarisation is isomorphic to the product of the Jacobians.
6.1.1. Euler Characteristic bounds for rank 1 semistable sheaves. Fix three integers $\chi \neq 0, \chi_{1}$ and $\chi_{2} \neq 1$ with $\chi>\chi_{i}$ such that $\chi=\chi_{1}+\chi_{2}-1$. Let $\mathscr{O}_{x_{0}}(1)$ be an ample line bundle such that $\operatorname{deg}\left(\left.\mathscr{O}_{X_{0}}(1)\right|_{X_{1}}\right)=\chi_{1}-1$ and $\operatorname{deg}\left(\left.\mathscr{O}_{X_{0}}(1)\right|_{X_{2}}\right)=\chi_{2}$. Since $\chi=\chi_{1}+\chi_{2}-1$, the Hilbert polynomial $P(L, n)=(n+1) \chi$ for all $L \in S(1, \chi)$.

Let $b_{1}=\frac{\chi_{1}-1}{\chi}$ and $b_{2}=\frac{\chi_{2}}{\chi}$. In this subsection whenever we say a semistable rank 1 torsion free sheaf we assume the semistability with respect to the polarisation $b=\left(b_{1}, b_{2}\right)$.

Lemma 6.2. Let $L \in S(1, \chi)$ and $\left(L_{1}, L_{2}, \lambda\right) \in \vec{C}$ be the unique triple representing $L$. Then $\chi\left(L_{i}\right)$, the Euler characteristic of $L_{i}$, satisfy the following:

$$
\chi_{1} \leq \chi\left(L_{1}\right) \leq \chi_{1}+1, \chi_{2}-1 \leq \chi\left(L_{2}\right) \leq \chi_{2} .
$$

Moreover if $L$ is semistable and non locally free then we have $\chi\left(L_{1}\right)=\chi_{1}$ and $\chi\left(L_{2}\right)=\chi_{2}$.

Conversely, suppose $L$ be a rank 1 torsion free sheaf with $\chi\left(L_{i}\right)$ satisfy the above conditions then $L \in S(1, \chi)$.

Proof. By Lemma [13, Lemma 5.2] we can easily derive the following: if $L$ is a rank 1,locally free and $\left(L_{1}, L_{2}, \lambda\right) \in \vec{C}$ be the unique triple representing $L$ then we only have to check the semistability condition for the subtriples $\left(L_{1}(-p), 0,0\right)$ and $\left(0, L_{2}, 0\right)$. If $L$ is a rank 1 , non locally free sheaf and $\left(L_{1}, L_{2}, 0\right)$ be the triple representing $L$ then we only have to check the semistability for the subtriples ( $L_{1}, 0,0$ ) and ( $0, L_{2}, 0$ ). Now by using the definition of semistability (see 1) we immediately get the above Lemma.

Fix an integer $m \geq m_{0}$ such that Lemma 6.1 holds for all $F \in S(1, \chi)$ and let $P(n)=(n+1) \chi$. Let $Q(1, \chi)$ be the Quot scheme parametrising all coherent quotients

$$
\mathscr{O}_{x_{0}}^{\oplus p(m)} \rightarrow L \rightarrow 0
$$

with Hilbert polynomial $P(n)$ and $\mathscr{U}^{1}$ be the universal quotient sheaf of $\mathscr{O}_{X_{0} \times Q(1, \chi)}^{\oplus p(m)}$ on $X_{0} \times Q(1, \chi)$. Let $R(1, \chi)^{s s}$ be the open subset of $Q(1, \chi)$ such that if $q \in R(1, \chi)^{s s}$ then $\mathscr{U}_{q}^{1}:=\left.\mathscr{U}^{1}\right|_{X_{0} \times q}$ is a rank 1 semistable torsion free quotient and the natural map

$$
H^{0}\left(\mathscr{O}_{X_{0} \times q}\right) \rightarrow H^{0}\left(\mathscr{U}_{q}^{1}\right)
$$

is an isomorphism. Note that if $L \in S(1, \chi)$ then ,by Lemma 6.1, $L(m)$ is globally generated. Thus $L(m)$ is a quotient of a trivial sheaf of rank $p(m):=h^{0}(L(m))$ and the natural map $H^{0}\left(\mathscr{O}_{x_{0}}^{\oplus p(m)}\right) \rightarrow H^{0}(L(m))$ is an isomorphism. Therefore $L(m) \simeq \mathscr{U}_{q}^{1}$ for some $q \in R(1, \chi)^{s s}$. The group $G L(p(m))$ acts on $Q(1, \chi)$ and $R(1, \chi)^{s s}$ is invariant under the action of $G L(p(m))$. Moreover, the action of $G L(p(m)$ ) goes down to an action of $P G L(p(m))$. By a general result in (see [21, Septieme partie,III, Theorem 15]) the good quotient $R(1, \chi)^{s s} / / P G L(p(m))$ exists as a reduced, projective scheme. Let $R_{0}$ be the open subset of $R(1, \chi)^{s s}$ consisting of only rank 1 , locally free sheaves. Then $R_{0}=R_{1} \sqcup R_{1}^{\prime}$ where $R_{1}$ consists of those rank 1 locally free sheaves $L$ such that $\chi\left(L_{1}\right)=\chi_{1}, \chi\left(L_{2}\right)=\chi_{2}$ and $R_{1}^{\prime}$ consists of those rank 1 locally free sheaves $L$ such that $\chi\left(L_{1}\right)=\chi_{1}+1$, $\chi\left(L_{2}\right)=\chi_{2}-1$. Let $J^{\chi_{i}}\left(X_{i}\right)$ be the Jacobian of isomorphism classes of line bundles over $X_{i}$ with Euler characteristic $\chi_{i}, i=1,2$. With these notations the main theorem of this subsection is:

Theorem 6.3. The good quotient $R(1, \chi)^{s s} \| P G L(p(m))$ is isomorphic to $J^{\chi_{1}}\left(X_{1}\right) \times J^{\chi_{2}}\left(X_{2}\right)$.

Proof. Let $q: R(1, \chi)^{s s} \rightarrow R(1, \chi)^{s s} \| P G L(p(m))$ be the quotient map. Note that, since $\operatorname{Hom}(L, L)=\mathbb{C}$ for all $L \in R_{1}, P G L(p(m))$ acts freely on $R_{1}$. Moreover, $R_{1}$ is smooth and irreducible. Therefore, the quotient $R_{1} / P G L(p(m))$ is smooth and irreducible (see [9, Corollary 4.2.13]). Claim 1: The quotient $q\left(R_{1}\right)=R_{1} / P G L\left(p(m)\right.$ is isomorphic to $J^{\chi_{1}}\left(X_{1}\right) \times J^{\chi_{2}}\left(X_{2}\right)$.

To see this consider $\mathscr{U}$ over $X_{0} \times R_{1}$. Then $\mathscr{U}$ is locally free and hence $\mathscr{U}_{i}=\left.\mathscr{U}\right|_{X_{i} \times R_{1}}$ is locally free. Moreover, $\chi\left(\left.\mathscr{U}_{i}\right|_{X_{i} \times q}\right)=\chi_{i}, i=1,2$. Thus by the universal property of $J^{\chi_{i}}\left(X_{i}\right)$ we get a morphism $f_{i}: R_{1} \rightarrow J^{\chi_{i}}, i=1,2$. Therefore, we get a morphism $f=\left(f_{1}, f_{2}\right): R_{1} \rightarrow J_{0}=J^{\chi_{1}}\left(X_{1}\right) \times J^{\chi_{2}}\left(X_{2}\right)$. Clearly, this morphism is $P G L(p(m))$-invariant and the fibres of this morphism are isomorphic to the orbits of the $P G L(p(m))$ action. Therefore, we get a bijective morphism $R_{1} / P G L(p(m)) \rightarrow J_{0}$. Since $R_{1} / P G L(p(m)), J_{0}$ are integral and $J_{0}$ is smooth, we have $R_{1} / P G L(p(m))$ is isomorphic to the variety $J_{0}=J^{\chi_{1}}\left(X_{1}\right) \times J^{\chi_{2}}\left(X_{2}\right)$. Claim 2: We have an equality:

$$
R_{1} / P G L(p(m))=R(1, \chi)^{s s} / / P G L(p(m)
$$

Note that Claims 1 and 2 together prove the theorem.
Let $\left[L_{0}\right] \in R(1, \chi)^{s s} / / P G L(p(m)$ where [] is orbit closure equivalence class. Then we want to show there is a $L \in R_{1}$ such that $q(L)=\left[L_{0}\right]$. In other words
the orbit closure $\overline{O(L)}$ intersects the orbit closure $\overline{O\left(L_{0}\right)}$. Suppose, $L_{0}$ is locally free with $\chi\left(\left.L_{0}\right|_{X_{i}}\right)=\chi_{i}, i=1,2$ then there is nothing to prove. So we assume that $L_{0}$ is a rank 1 torsion free but non-locally free sheaf. Then as $L_{0}$ is semistable, by Lemma 6.2, we get $\chi\left(L_{i}\right)=\chi_{i}, i=1,2$ where $\left(L_{1}, L_{2}, 0\right) \in \vec{C}$ is the unique triple representing $L_{0}$. Let $L$ be the rank 1 locally free sheaf corresponding to the triple $\left(L_{1}, L_{2}, \lambda\right) \in \vec{C}$ where $\lambda: L_{1}(p) \rightarrow L_{2}(p)$ is an isomorphism. We will show now the orbit closure $\overline{O(L)}$ intersects the orbit $O\left(L_{0}\right)$. For this, let $p_{i}: X_{i} \times \mathbb{A}^{1} \rightarrow X_{i}, i=1,2$, be the two projections. We again denote the pullback $p_{i}^{*} L_{i}$ by $L_{i}$. Since $L_{i}, i=1,2$, are free $\mathscr{O}_{\mathrm{A}^{1}}$-module, we can choose a $\mathscr{O}_{\mathrm{A}^{1}}$-module homomorphism $\lambda:\left.\left.L_{1}\right|_{p \times A^{1}} \rightarrow L_{2}\right|_{p \times A^{1}}$ such that $\lambda(t): L_{1}(p, t) \rightarrow L_{2}(p, t)$ is an isomorphism for all $t \neq 0$ and $\lambda(0)=0$. Let $G$ be the graph of the morphism $\lambda$ in $\left.\left.L_{1}\right|_{p \times \mathbb{A} 1} \oplus L_{1}\right|_{p \times \mathbb{A}^{1}}$ and $G^{\prime}:=\frac{\left.\left.L_{1}\right|_{p \times \mathbb{A}^{1}} \oplus L_{2}\right|_{p \times A^{1}}}{G}$. Let $\mathscr{L}:=\operatorname{Ker}\left(L_{1} \oplus L_{2} \rightarrow G^{\prime}\right)$ over $X_{0} \times \mathbb{A}^{1}$. Now $L_{1} \oplus L_{2}$ and $G^{\prime}$, being free $\mathscr{O}_{A}^{1}$-module, are flat over $\mathbb{A}^{1}$. Therefore, $\mathscr{L}$ is flat over $\mathbb{A}^{1}$. We also see that $\mathscr{L}_{t}$ is the torsion free sheaf corresponding to the triple $\left(L_{1}, L_{2}, \lambda(t)\right)$. Therefore, $\mathscr{L}_{t} \simeq L$ for all $t \neq 0$ and $\mathscr{L}_{0} \simeq L_{0}$. Note that, as $\mathscr{L}_{t} \in R(1, \chi)^{s s}$ for all $t \in \mathbb{A}^{1}, H^{1}\left(\mathscr{L}_{t}\right)=0$ and $\mathscr{L}_{t}$ is globally generated for all $t \in \mathrm{~A}^{1}$. By semicontinuity theorem, we get $p_{2 *} \mathscr{L}$ is locally free sheaf of rank $p(m)$ on $A^{1}$. Since any locally free sheaf on $A^{1}$ is free, $p_{2 *} \mathscr{L} \simeq \mathscr{O}_{A^{1}} \oplus p(m)$. Thus we get a quotient

$$
\mathscr{O}_{X_{0} \times A^{1}}^{\oplus p(m)} \simeq p_{2}^{*} p_{2 *} \mathscr{L} \rightarrow \mathscr{L} \rightarrow 0 .
$$

such that $H^{0}\left(\mathscr{O}_{x_{0} \times t}^{p(m)}\right) \rightarrow H^{0}\left(\mathscr{L}_{t}\right)$ is an isomorphism for all $t \in \mathbb{A}^{1}$. Hence we get a morphism $\phi: \mathbb{A}^{1} \rightarrow R(1, \chi)^{s s}$ such that $\phi^{*} \mathscr{U}^{1} \simeq \mathscr{L}$. Since $\mathscr{L}_{t} \simeq L$ for all $t \in \mathbb{A}^{1}-0$, $\phi\left(\mathrm{A}^{1}-0\right)$ lies in the $P G L(p(m))$ orbit of $L$ and $\phi(0)=L_{0}$. Therefore, $L_{0}$ is in the orbit closure of $L$. Clearly, $\chi\left(L_{i}\right)=\chi\left(\left.L_{i}\right|_{X_{i}}\right)=\chi_{i}, i=1,2$. Thus $L \in R_{1}$ and we are done.

Finally suppose, $L_{0}$ is rank 1, locally free sheaf such that $\chi\left(L_{1}\right)=\chi_{1}+1$ and $\chi\left(L_{2}\right)=\chi_{1}-1$ where $\left(L_{1}, L_{2}, \lambda\right), \lambda: L_{2}(p) \rightarrow L_{1}(p)$ an isomorphism, is the unique triple representing $L_{0}$. Let $L$ is the rank 1 locally free sheaf represented by $\left(L_{1}(-p), L_{2}(p), \lambda\right) \in \vec{C}$. Then the orbit closure $\overline{O\left(L_{0}\right)}$ intersects the orbit closure $\overline{O(L)}$ in $R(1, \chi)^{s s}$. This easily follows from the observation: The torsion free sheaf $L^{\prime}$ represented by the triple $\left(L_{1}, L_{2}, 0\right) \in \overleftarrow{C}$ is in the orbit closure of $L_{0}$. Note, by Remark 2.1, $L^{\prime}$ is isomorphic to the torsion free sheaf represented by $\left(L_{1}(-p), L_{2}(p), 0\right) \in \vec{C}$. Thus, by Lemma 6.2, $L^{\prime}$ is semistable and is also in the orbit closure of $L$. Thus given any $\left[L_{0}\right] \in R(1, \chi)^{s s} \| P G L(p(m)$ we have seen that there is a $L \in R_{1}$ such that $q(L)=\left[L_{0}\right]$.
6.2. Determinant morphism. Fix an odd integer $\chi$ and a polarisation ( $a_{1}, a_{2}$ ) on $X_{0}$ such that $a_{1} \chi$ is not an integer. We also fix an integer $m^{\prime}$ such that Lemma 6.1 holds for all $E \in S(2, \chi)$. Let $Q(2, \chi)$ be the Quot scheme parametrising all coherent quotients

\mathscr{O}_{x_{0}}^{\oplus p\left(m^{\prime}\right)} \rightarrow E \rightarrow 0
$$

and $\mathscr{U}^{2}$ be the universal quotients sheaf of $\mathscr{O}_{X_{0} \times Q(2, x)}^{\oplus p\left(m^{\prime}\right)}$ on $X_{0} \times Q(2, \chi)$. Let $R(2, \chi)^{s s}$ be the open subset of $Q(2, \chi)$ such that if $q \in R(2, \chi)^{s s}$ then $\mathscr{U}_{q}^{2}:=\left.\mathscr{U}^{2}\right|_{X_{0} \times q}$ is a
rank 2 semistable torsion free quotient and the natural map

$$
H^{0}\left(\mathscr{O}_{X_{0} \times q}\right) \rightarrow H^{0}\left(\mathscr{U}_{q}^{1}\right)
$$

is an isomorphism. The moduli space $M(2, a, \chi)$ is isomorphic to the quotient $R(2, \chi)^{s s} / P G L\left(p\left(m^{\prime}\right)\right)$. Let $M_{12}$ and $M_{21}$ be the two smooth components of $M(2, a, \chi)$. Let $M_{12}^{0} \subset M_{12}$ (resp. $M_{21}^{0} \subset M_{21}$ ) be the open subvariety of $M_{12}$ (resp. $M_{21}$ ) consisting of isomorphism classes of rank 2 semistable locally free sheaves.

Proposition 6.4. There exists a determinant morphism det : $M(2, a, \chi) \rightarrow$ $J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$ where $\chi_{i}^{\prime}=\chi_{i}-\left(1-g_{i}\right), i=1,2$.
Proof. Let $R_{2}$ be the open subset of $R(2, \chi)^{s s}$ such that for all $q \in R_{2}, \mathscr{U}_{q}$ is rank 2 semistable locally free and $\chi\left(\left.\mathscr{U}_{q}\right|_{X_{i}}\right)=\chi_{i}, i=1,2$. Then $M_{12}^{0} \simeq R_{2} / P G L\left(p\left(m^{\prime}\right)\right.$. Let $R_{1}$ be the open subset of $R\left(1, \chi^{\prime}\right)^{\text {ss }}$, where $\chi^{\prime}:=\chi-(1-g)$, such that for all $q \in R_{1}, \mathscr{U}_{q}^{1}$ is rank 1 , semistable locally free and $\chi\left(\left.\mathscr{U}_{q}^{1}\right|_{X_{i}}\right)=\chi_{i}-\left(1-g_{i}\right)$, $i=1,2$. Let us restrict the universal quotient sheaf $\mathscr{U}^{2}$ on $X_{0} \times R_{2}$. Then $\mathscr{U}^{2}$ is a rank 2 locally free shef on $X_{0} \times R_{2}$ such that $\mathscr{U}_{q}^{2}$ is semistable and $\chi\left(\left.\mathscr{U}_{q}^{2}\right|_{X_{i}}\right)=\chi_{i}$ for all $q \in R_{2}, i=1,2$. Thus $\wedge^{2} \mathscr{U}^{2}$ is a flat family of rank 1 locally free sheaves on $X_{0} \times R_{2}$ such that $\chi\left(\left.\wedge^{2} \mathscr{U}_{q}^{2}\right|_{X_{i}}\right)=\chi_{i}-\left(1-g_{i}\right)$ for all $q \in R_{2}$, $i=1,2$. By Lemma $6.2 \wedge^{2} \mathscr{U}_{q}^{2}$ is semistable for all $q \in R_{2}$. By Lemma 6.1 there exists an integer $m$ such that $H^{1}\left(\wedge^{2} \mathscr{U}_{q}^{2}(m)\right)=0$ and $\wedge^{2} \mathscr{U}_{q}^{2}(m)$ is globally generated for all $q \in R_{2}$. Therefore, there is an open covering $\left\{U_{i}\right\}$ of $R_{2}$ and morphisms $\operatorname{det}_{i}: U_{i} \rightarrow R_{1}$ such that, for any non-empty open set $U_{i j}:=U_{i} \cap U_{j}$ if we denote by $\operatorname{det}_{i j}=\left.\operatorname{det}_{i}\right|_{U_{i j}}$, then there exists $g \in P G L(n)\left(U_{i j}\right)$ with the property $\operatorname{det}_{i j}=g \operatorname{det}_{j i}$, where $n=h^{0}\left(\wedge^{2} \mathscr{U}_{q}^{2}(m)\right)$. Therefore, we get a well-defined morphism det $: R_{2} \rightarrow R_{1} / P G L(n)=J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$. Since $M_{12}$ is a smooth projective variety and $J_{0}$ is an abelian variety the morphism $d e t_{1}^{0}$ extends to a morphism det $_{1}: M_{12} \rightarrow J_{0}:=J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$. By similar arguments we get a morphism $\operatorname{det}_{2}: M_{21} \rightarrow J_{0}^{\prime}:=J^{\chi_{1}^{\prime}+1}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}-1}\left(X_{2}\right)$. Let $F \in M_{12} \cap M_{21}$. Then $F$ is represented by a unique triple $\left(F_{1}, F_{2}, A\right) \in C$ where $r k(A)=1 . F$ is also represented by another triple $\left(F_{1}^{\prime}, F_{2}^{\prime}, B\right) \in \overleftarrow{C}$ such that $F_{i}$ and $F_{i}^{\prime}$ are related by the diagram in Remark 2.1. Note that $\wedge^{2} F_{1}^{\prime} \simeq \wedge^{2} F_{1}(p)$ and $\wedge^{2} F_{2}^{\prime} \simeq \wedge^{2} F_{2}(-p)$. Claim $\operatorname{det}_{1}(F)=\left(\wedge^{2} F_{1}, \wedge^{2} F_{2}\right)$ and $\operatorname{det}_{2}(F)=\left(\wedge^{2} F_{1}^{\prime}, \wedge^{2} F_{2}^{\prime}\right)$. First we construct a flat family $\mathscr{F}$ over $X \times \mathbb{A}^{1}$ such that $\mathscr{F}_{t}$ is rank 2 , semistable locally free sheaf for all $t \neq 0$ and $\mathscr{F}_{0} \simeq F$. Moreover, $\left.\mathscr{F}_{t}\right|_{X_{1}} \simeq F_{1}$ and $\left.\mathscr{F}_{t}\right|_{X_{2}} \simeq F_{2}$ for all $t \neq 0$ (this can be done using the similar construction given in the proof of Theorem 6.3). Thus we get a morphism $\phi: \mathbb{A}^{1} \rightarrow M_{12}$ such that $\phi\left(\mathbb{A}^{1}-0\right) \subset M_{12}^{0}$ and $\phi(0)=F$. Denote the restriction of $\mathscr{F}$ over $X_{0} \times\left(\mathbb{A}^{1}-0\right)$ by $\mathscr{F}^{\prime}$. Then $\wedge^{2} \mathscr{F}^{\prime}$ induces a morphism $\wedge^{2} \phi: \mathbb{A}^{1}-0 \rightarrow J_{0}$. Since $\left.\mathscr{F}_{t}\right|_{X_{i}} \simeq F_{i}, i=1,2$, we get $\wedge^{2} \mathscr{F}_{t}^{\prime} \simeq L$ for all $t \neq 0$ where $L$ is the line bundle represented by the triple ( $\wedge^{2} F_{1}, \wedge^{2} F_{2}, \lambda$ ). Thus $\wedge^{2} \phi$ is constant for all $t \neq 0$. Thus $\wedge^{2} \phi$ extends as a constant morphism over whole $A^{1}$ and $\wedge^{2} \phi(t)=\left(\wedge^{2} F_{1}, \wedge^{2} F_{2}\right)$ for all $t \in \mathbb{A}^{1}$. Clearly, $\operatorname{det}_{1}(\phi(t))=\wedge^{2} \phi(t)$ for all $t \in A^{1}$. By similar arguments we can show that $\operatorname{det}_{2}(F)=\left(\wedge^{2} F_{1}^{\prime}, \wedge^{2} F_{2}^{\prime}\right)$. Now we define a morphism $\operatorname{det}: M(2, a, \chi) \rightarrow J_{0}$ in the following way:

\operatorname{det}(F):=\operatorname{det}_{1}(F) \text { if } F \in M_{12}
$$

$$
\operatorname{det}(F):=f^{-1}\left(\operatorname{det}_{2}(F)\right) \text { if } F \in M_{21}
$$

where $f: J_{0} \rightarrow J_{0}^{\prime}$ is an isomorphism defined by the association $\left(L_{1}, L_{2}\right) \rightarrow$ $\left(L_{1}(p), L_{2}(-p)\right)$. By the above discussion clearly, det is a well defined morphism.

Proposition 6.5. The fibres of the morphism det: $M(2, a, \chi) \rightarrow J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$ are the union of two smooth, irreducible projective varieties meeting transversally along a smooth divisor.

Proof. Let $J^{0}\left(X_{0}\right)$ be the variety parametrising all isomorphism classes of line bundles $L$ such that $\operatorname{deg}\left(\left.L\right|_{X_{i}}\right)=0, i=1,2$. Then we can show that $J^{0}\left(X_{0}\right):=$ $J^{0}\left(X_{1}\right) \times J^{0}\left(X_{2}\right)$ where $J^{0}\left(X_{i}\right)$ are the Jacobians of $X_{i}, i=1,2$. Now $J^{0}\left(X_{i}\right)$ acts on $M(2, a, \chi)$ by $F \rightarrow F \otimes L$. Clearly, both the components of $M(2, a, \chi)$ and the divisor $D$ are fixed by this action. Also we can easily check that the morphism det is compatible with action of $J^{0}\left(X_{0}\right)$ where action of $J^{0}\left(X_{0}\right)$ on $J_{0}$ is given by $\left(\eta_{1}, \eta_{2}\right) \mapsto\left(\eta_{1} \otimes L_{1}, \eta_{2} \otimes L_{2}\right)$. Now $\operatorname{det}_{M_{12}}=\operatorname{det}_{1}$ and $\operatorname{det}_{M_{21}}=f^{-1}$ odet $_{2}$. Clearly, the morphism $\operatorname{det}_{1}: M_{12} \rightarrow J_{0}$ is compatible with the action of $J^{0}\left(X_{0}\right)$. Thus it is a smooth morphism. Since both $M_{12}$ and $J_{0}$ are smooth we conclude that the fibres of $d e t_{1}$ are smooth. Also, by the same reasoning, the fibres of $\left.d e t_{1}\right|_{D}$, the restriction to the divisor $D$, are also smooth. Thus the fibres of $d e t_{1}$ intersects $D$ transversally. By the same arguments we can show that the fibres of det $_{2}$ intersects $D$ transversally. Hence, we conclude that the intersection of $\operatorname{det}_{1}^{-1}(\xi)$ with $\operatorname{det}_{2}^{-1}(f(\xi)), \xi \in J_{0}$ is smooth. Therefore, the fibres of $d e t$ are the union of two smooth, projective varieties intersecting transversally.
6.3. Relative moduli space and relative determinant morphism. Let $C=$ Spec $R$ where $R$ is a complete discrete valuation ring and $\mathscr{X} \rightarrow B$ be a flat family of proper, connected curves. We assume the generic fibre $\mathscr{X}_{\eta}$ is smooth and the closed fibre $\mathscr{X}_{0}$ is the curve $X_{0}$. We further assume that $\mathscr{X}$ is regular over $\mathbb{C}$. For any $C$ scheme $S$ we denote $\mathscr{X} \times{ }_{C} S$ by $\mathscr{X}_{S}$. Fix an integer $\chi$.
6.3.1. Relative moduli of rank 1, torsion free sheaves. : Fix a relatively ample line bundle $\mathscr{O}_{\mathscr{X}}(1)$ over $\mathscr{X}$ such that $\left.\mathscr{O}_{\mathscr{X}}(1)\right|_{X_{0}}$ gives the polarisation of type $\left(b_{1}, b_{2}\right)$. Let $\mathscr{Q}_{1} \rightarrow C$ be the relative Quot scheme parametrising all rank 1 coherent quotients

$$
\mathscr{O}_{\mathscr{X}}^{p(N)} \rightarrow \mathscr{L} \rightarrow 0 .
$$

which has the fixed Hilbert polynomial $p(n):=(n+1) \chi^{\prime}, \chi^{\prime}=\chi-(1-g)$, along the fibre of $\mathscr{X}$ and flat over $C$. Let $\mathscr{U}$ be the universal quotient sheaf of $\mathscr{O}_{\mathscr{X}_{\mathscr{Q}_{1}}}^{\oplus p(N)}$ on $\mathscr{X}_{\mathscr{Q}_{1}}$. Let $\mathscr{G}=\operatorname{Aut}\left(\mathscr{O}_{\mathscr{X}}^{p(N)}\right)$ be the reductive group scheme over $C$. Then $\mathscr{G}$ acts on $\mathscr{Q}_{1}$. Let $\mathscr{R}_{1}^{s s}$ be the open subvariety of $\mathscr{Q}_{1}$ consisting of those quotients $\mathscr{L}$ which are semistable along the fibre of $\mathscr{X}$ and the natural map $H^{0}\left(\mathscr{O}_{\mathscr{C}}^{p(N)}\right) \rightarrow H^{0}(\mathscr{L})$ is an isomorphism. We can construct a good quotient $\mathscr{J}:=\mathscr{R}_{1}^{s s} / \mid \mathscr{G}$, projective over $C$ using GIT over arbitrary base. Also note that $\left(\mathscr{R}_{1}{ }^{s s} \| \mathscr{G}\right)_{t}=\mathscr{R}_{1_{t}}{ }^{s s} \| \mathscr{G}$ for all $t \in C\left(\left[22\right.\right.$, Theorem 4]). Thus the general fibre $\mathscr{J}_{\eta}$ is the Jacobian $J^{\chi^{\prime}}\left(\mathscr{X}_{\eta}\right)$ and by Theorem 6.3 the closed fibre $\mathscr{J}_{0}$ is isomorphic to $J^{\chi_{1}^{\prime}}\left(X_{1}\right) \times J^{\chi_{2}^{\prime}}\left(X_{2}\right)$.
6.3.2. Relative moduli of rank 2, torsion free sheaves. : Fix a relatively ample line bundle $\mathscr{O}_{\mathscr{X}}(1)^{\prime}$ over $\mathscr{X}$ such that $\left.\mathscr{O}_{\mathscr{X}}(1)^{\prime}\right|_{X_{0}}=\mathscr{O}_{X_{0}}(1)$ gives the polarisation of type $\left(a_{1}, a_{2}\right)$ such that $a_{1} \chi$ is not an integer. Let $\mathscr{Q}_{2} \rightarrow C$ be the relative Quot scheme parametrising all rank 2 coherent quotients

$$
\mathscr{O}_{\mathscr{C}}^{p(N)} \rightarrow \mathscr{E} \rightarrow 0
$$

which has the fixed Hilbert polynomial $p(n):=\left(c_{1}+c_{2}\right) n+\chi$, where $c_{i}=$ $\operatorname{deg}\left(\left.\mathscr{O}_{X_{0}}(1)\right|_{X_{i}}\right.$, along the fibre of $\mathscr{X}$ and flat over C.Let $\mathscr{U}^{\prime \prime}$ be the universal quotient sheaf of $\mathscr{O}_{\mathscr{C}_{\mathscr{Q}_{1}}}^{\oplus p\left(m^{\prime}\right)}$ on $\mathscr{X}_{\mathscr{Q}_{2}}$. Let $\mathscr{G}^{\prime}=\operatorname{Aut}\left(\mathscr{O}_{\mathscr{C}}^{p(N)}\right)$ be the reductive group scheme over $C$. Then $\mathscr{G}^{\prime}$ acts on $\mathscr{Q}_{2}$. Let $\mathscr{R}_{2}^{s s}$ be the open subvariety of $\mathscr{Q}_{2}$ consisting of those quotients $\mathscr{E}$ which are semistable along the fibre of $\mathscr{X}$ and the natural map $H^{0}\left(\mathscr{O}_{\mathscr{C}}^{p(N)}\right) \rightarrow H^{0}(\mathscr{E})$ is an isomorphism. It is shown in [13, Theorem 4.2] a relative moduli space $\mathscr{M}:=\mathscr{R}_{2}^{s s} \| \mathscr{G}^{\prime}$ exists and it is projective over $C$ using GIT over arbitrary base. Thus the general fibre $\mathscr{M}_{\eta}$ is the moduli space $M_{\mathscr{X}_{\eta}}(2, \chi)$ of rank 2, semistable sheaves with Euler characteristic $\chi$ and $\mathscr{M}_{0}$ is the moduli space $M(2, a, \chi)$. Note that, if $\mathscr{X}$ is a regular surface, by [13, Remark 4.2], $\mathscr{R}_{2}^{s s}$ is smooth over $\mathbb{C}$. If we assume $\chi$ to be odd then $\mathscr{R}_{2}^{s s}=\mathscr{R}_{2}^{s}$. Therefore, $P \mathscr{G}^{\prime}$ acts on $\mathscr{R}_{2}^{s}$ freely. Since $\mathscr{R}_{2}^{s s}$ is smooth we conclude that $\mathscr{M}=\mathscr{R}_{2}^{s} / P \mathscr{G}^{\prime}$ is regular over $\mathbb{C}$ (see [9, Corollary 4.2.23]).

Proposition 6.6. There exists a morphism Det : $\mathcal{M} \rightarrow \mathscr{J}$ such that the following diagram commutes-


Moreover, we have Det $\left.\right|_{\mu_{0}}=$ det.
Proof. Let $\mathscr{R}_{2}^{0}$ be the open subscheme of $\mathscr{R}_{2}^{s s}$ such that if $q \in \mathscr{R}_{2}^{0}$ then $\mathscr{U}_{q}^{\prime \prime}$ is rank 2,locally free. Then by similar arguments as in the proof of Proposition 6.4 we get a morphism Det $^{\prime 0}: \mathscr{R}_{2}^{0} \rightarrow \mathscr{J}$ and this descends to a morphism $D e t^{0}$ : $\mathscr{M}^{0}=\mathscr{R}_{2}^{0} / P \mathscr{G}^{\prime} \rightarrow \mathscr{J}$. Let $Z=\mathscr{M} \backslash \mathscr{M}^{0}$. Then $Z$ is supported on the fibre $\mathscr{M}_{0}$ and $\mathscr{M}_{0} \backslash Z$ is a dense open set. Clearly, $\left.\operatorname{Det}^{0}\right|_{\mathscr{M}_{0} \backslash Z}=\operatorname{det}$. Thus if we can show that Det ${ }^{0}$ extends as a morphism Det: $\mathscr{M} \rightarrow \mathscr{J}$ then we have $\left.\operatorname{Det}\right|_{\mu_{0}}=\operatorname{det}$. Let $\Gamma$ be the graph of the morphism $D e t^{0}$ in $\mathscr{M} \times_{C} \mathscr{J}$ and $\bar{\Gamma}$ be the Zariski closure of $\Gamma$ in $\mathscr{M} \times_{C} \mathscr{J}$. Let $p_{1}, p_{2}$ be the restriction of the two projections to $\bar{\Gamma}$. Then the morphism $p_{1}: \bar{\Gamma} \rightarrow \mathscr{M}$ is clearly birational. We will show that it is bijective. Since $\mathscr{M}$ is smooth over $\mathbb{C}$ it will follow that $p_{1}$ is an isomorphism. Thus we define Det:= $p_{2} p_{1}^{-1}$ which clearly extends the morphism $\operatorname{Det}^{0}$. Let $\left(F, G_{1}\right)$ and $\left(F, G_{2}\right)$ be the closed points of $\bar{\Gamma} \backslash \Gamma$. Then we claim that $G_{1} \simeq G_{2}$. The claim follows from the following observation:

Let $\tilde{R}$ be a complete discrete valuation ring such that $\tilde{C} \rightarrow C$ is dominant, where $\tilde{C}:=\operatorname{Spec} \tilde{R}$. Let $t$ be the generic point of $\tilde{C}$ and 0 be the closed point of $\tilde{C}$,. Let $\mathscr{F}$ be a coherent sheaf on $\mathscr{X} \times{ }_{C} \tilde{C}$, flat over $\tilde{C}$ such that $\mathscr{F}_{t}$ is a rank 2 semistable bundle over $\mathscr{X}_{t}$ and $\mathscr{F}_{0} \simeq F$ and $\mathscr{G}$ be a locally free sheaf on $\mathscr{X}_{\tilde{C}}:=\mathscr{X} \times{ }_{C} \tilde{C}$ such that $\mathscr{G}_{t} \simeq \wedge^{2} \mathscr{F}_{t}$ and $\mathscr{G}_{0} \simeq G_{1}$. Let $\pi: \tilde{\mathscr{X}}_{\tilde{C}} \rightarrow \mathscr{X}_{\tilde{C}}$ be the disingularization of $\mathscr{X}_{\tilde{C}}$ at $p$. The exceptional divisor $\pi^{-1}(p)=\Sigma_{i} D_{i}$ is a chain
of ( -2 ) curves, and the special fibre $\tilde{\mathscr{X}}_{0}$ of $\tilde{\mathscr{X}}_{\tilde{C}} \rightarrow \tilde{C}$ at 0 is $X_{1}+X_{2}+\Sigma D_{i}$ and $X_{1} \cap\left(X_{2}+\Sigma D_{i}\right)=p_{1}, X_{2} \cap\left(X_{1}+\Sigma D_{i}\right)=p_{2}$. Let $\mathscr{F}^{\prime \prime}$ be the restriction of $\mathscr{F}$ on $(\mathscr{X}-p) \times_{C} \tilde{C}$. Identifying $\tilde{\mathscr{X}}_{\tilde{C}} \backslash \pi^{-1}(p) \simeq \mathscr{X}_{\tilde{C}} \backslash p=(\mathscr{X}-p)_{\tilde{C}}$, we can extend the line bundle $\wedge^{2} \mathscr{F}^{\prime \prime}$ into a line bundle $\overline{\wedge^{2} \mathscr{F}^{\prime \prime}}$ on $\tilde{\mathscr{X}}_{\tilde{C}}$. This is possible since $\tilde{\mathscr{X}}_{\tilde{C}}$ is non singular. Therefore, we can show $\operatorname{Pic}\left(\tilde{\mathscr{X}}_{\tilde{C}}\right)=\operatorname{Pic}\left(\mathscr{X}_{\tilde{C}} \backslash p\right) \oplus_{i} \mathbb{Z} D_{i}$. Clearly, we have $\overline{\wedge^{2} \mathscr{F}^{\prime \prime}}{ }_{t} \simeq \pi^{*} \mathscr{G}_{t}$. Thus one has

$$
\overline{\wedge^{2} \mathscr{F}^{\prime \prime}} \simeq \pi^{*} \mathscr{G} \otimes \mathscr{O}_{\tilde{X}_{\tilde{C}}}(V),
$$

where $V \varsubsetneqq \tilde{\mathscr{X}}_{0}$ is a vertical divisor i.e of the form $\Sigma n_{i} D_{i}$. Therefore, $\left.\overline{\wedge^{2} \mathscr{F}^{\prime \prime}}\right|_{X_{i}} \simeq$ $\left.\pi^{*} \mathscr{G}_{0}\right|_{X_{i}}\left(n_{i} p_{i}\right)$ for some integers $n_{i}, i=1,2$ since $\left.\mathscr{O}_{\tilde{\mathscr{X}}_{\tilde{C}}}(V)\right|_{X_{i}}=\mathscr{O}_{X_{i}}\left(n_{i} p_{i}\right)$. Let $e_{i}=\operatorname{deg}\left(\left.\overline{\wedge^{2} \mathscr{F}^{\prime \prime}}\right|_{X_{i}}\right), i=1,2$. Then $n_{i}=e_{i}-\operatorname{deg}\left(\left.\mathscr{G}_{0}\right|_{X_{i}}\right)$. Therefore the integers $n_{i}$ only depend on $\operatorname{deg}\left(\left.\mathscr{G}_{0}\right|_{X_{i}}\right)$. Let $L_{i}=\left.\overline{\wedge^{2} \mathscr{F}^{\prime \prime}}\right|_{X_{i}}\left(-n_{i} p_{i}\right)$. Then $G_{1}=\mathscr{G}_{0}$ is isomorphic to the line bundle $L$ which is uniquely represented by the triple $\left(L_{1}, L_{2}, \lambda\right)$. Suppose $\mathscr{G}^{\prime}$ be another locally free sheaf on $\mathscr{X}_{\tilde{C}}$ such that $\mathscr{G}_{t}^{\prime}=\Lambda^{2} \mathscr{F}_{t}$ and $\mathscr{G}_{0}^{\prime} \simeq G_{2}$. Since $\operatorname{deg}\left(\left.G_{1}\right|_{X_{i}}\right)=\operatorname{deg}\left(\left.G_{2}\right|_{X_{i}}\right)$, by the above argument, we can show that $G_{2} \simeq L$. Thus $G_{1} \simeq G_{2}$.

Remark 6.1. By similar arguments as in the proof of Proposition 6.5 we can show that Det is a smooth morphism. Fix a section $\sigma: C \rightarrow \mathscr{J}$ such that $\sigma(0)=\xi$. This corresponds to a line bundle $\mathscr{L}$ over $\mathscr{X}$ such that $\left.\mathscr{L}\right|_{\mathscr{X}_{0}}=\xi$. Let us denote $\operatorname{Det}^{-1}(\sigma(C))$ by $\mathscr{M}_{\mathscr{L}}$. Since both the varieties $\mathscr{M}$ and $\mathscr{J}$ are smooth we conclude that $\mathscr{M}_{\mathscr{L}}$ is smooth over $\mathbb{C}$.
