# Ground states for a coupled nonlinear Schrödinger system

#### Abstract

We study the existence of ground states for the coupled Schrödinger system $$
\begin{cases}-\Delta u+u & =|u|^{2 q-2} u+b|v|^{q}|u|^{q-2} u  \tag{1}\\ -\Delta v+\omega^{2} v & =|v|^{2 q-2} v+b|u|^{q}|v|^{q-2} v\end{cases}
$$ in $\mathbb{R}^{n}$, for $\omega \geq 1, b>0$ (the so-called "attractive case") and $q>1$ ( $q<\frac{n}{n-2}$ if $n \geq 3$ ). We improve for several ranges of ( $q, n, \omega$ ) the known results concerning the existence of positive ground state solutions to (1) with non-trivial components. In particular, we prove that for $1<q<2$ such ground states exist in all dimensions and for all values of $\omega$, which constitutes a drastic change of behaviour with respect to the case $q \geq 2$. Furthermore, for $q>2$ and in the one-dimensional case $n=1$, we improve the results in 14 . Keywords: Non-trivial ground states; Coupled nonlinear Schrödinger Systems; Nehari Manifold.

## 1 Introduction

In this paper we consider the system

$$
\left\{\begin{align*}
-\Delta u+\lambda_{1} u & =|u|^{2 q-2} u+b|v|^{q}|u|^{q-2} u  \tag{2}\\
-\Delta v+\lambda_{2} v & =|v|^{2 q-2} v+b|u|^{q}|v|^{q-2} v,
\end{align*}\right.
$$

[^0]with $u, v: \mathbb{R}^{n} \rightarrow \mathbb{R}(n \geq 1), q>1, b>0$ and $\lambda_{1}, \lambda_{2}>0$, which appears in several physical contexts, namely in nonlinear optics (see [1] and the references therein).

By rescaling the $x$ variable and/or inverting the roles of $u$ and $v$, it is easy to see that (2) can be reduced, without loss of generality, to the system

$$
\left\{\begin{align*}
-\Delta u+u & =|u|^{2 q-2} u+b|v|^{q}|u|^{q-2} u  \tag{3}\\
-\Delta v+\omega^{2} v & =|v|^{2 q-2} v+b|u|^{q}|v|^{q-2} v, \quad \omega \geq 1 .
\end{align*}\right.
$$

In the last years, this system has been extensively studied by many authors (see for instance [2], [11], [12], [17). In particular, in [4] and [5] the authors studied the case $q=2$ and $n=2,3$, proving the existence of a constant $\Lambda>0$ depending on $\omega$ such that for $b<\Lambda$ the system (3) admits a non-trivial radial solution $(u, v) \neq(0,0)$ (with $u, v>0$ if $b>0$ ). The authors also showed the existence of another constant $\Lambda^{\prime} \geq \Lambda$ such that for $b>\Lambda^{\prime}$ the system possesses a radial ground state solution $W_{*}=\left(u_{*}, v_{*}\right)\left(u_{*}, v_{*}>0\right)$, in the sense that $W_{*}$ minimizes the energy functional associated to (3) among all solutions in $(u, v) \in H^{1}\left(\mathbb{R}^{n}\right) \times H^{1}\left(\mathbb{R}^{n}\right) \backslash\{(0,0)\}$. In [9] Ikoma and Tamaka showed that for $0<b<\min \{\Lambda, 1\}$, the solutions found in [4], [5] are in fact also least energy solutions.

In [14], following some of the ideas presented in [15], the authors proved the existence of a radial non-trivial ground state solution $\left(u^{*}, v^{*}\right)\left(u^{*}, v^{*} \geq 0\right)$ for every $b>0$ and for $(q, n)$ satisfying

$$
1<q< \begin{cases}+\infty & \text { if } \quad n=1,2  \tag{4}\\ \frac{n}{n-2} & \text { if } \quad n \geq 3\end{cases}
$$

Furthermore, it is shown that for

$$
\begin{equation*}
b \geq \mathcal{C}_{\omega, n, q}:=\frac{1}{2}\left[1+\frac{n}{2}\left(1-\frac{1}{q}\right)+\frac{1}{w^{2}}\left(1-\frac{n}{2}\left(1-\frac{1}{q}\right)\right)\right]^{q} \omega^{2 q-n(q-1)}-1 \tag{5}
\end{equation*}
$$

there exists a ground state $\left(u^{*}, v^{*}\right)$ with $u^{*}, v^{*}>0$.
In the present paper we will prove the existence of a positive radial decreasing ground state solution to (3) for all $(q, n)$ satisfying the condition (44). Exploring this radial decay, we improve the constant $\mathcal{C}_{\omega, n, q}$ derived in [14] for all $q>1$ and large $\omega$ in the case $n=1$ and for all $1<q<2$ in any dimension, in fact replacing it by 0 in the latter case.

When dealing with the system (3) it is often necessary to treat the case $n=1$ separately due to the lack of compactness of the injection $H_{d}^{1}(\mathbb{R}) \hookrightarrow$ $L^{q}(\mathbb{R}), q>2$, where $H_{d}^{1}(\mathbb{R})$ denotes the space of the radially symmetric functions of $H^{1}(\mathbb{R})$. This lack of compactness is, in a sense, a consequence of the inequality

$$
\begin{equation*}
|u(x)| \leq C|x|^{\frac{1-n}{2}}\|u\|_{H^{1}\left(\mathbb{R}^{n}\right)} \tag{6}
\end{equation*}
$$

for $u \in H_{d}^{1}(\mathbb{R})$. Indeed, (6) gives no decay in the case $n=1$. However, if $u$ is also radially decreasing, it is easy to establish that

$$
|u(x)| \leq C|x|^{-\frac{n}{2}}\|u\|_{L^{2}\left(\mathbb{R}^{n}\right)},
$$

which provides decay in all space dimensions, hence compacity by applying the classical Strauss' compactness lemma ([16]). Hence, putting

$$
H_{r d}^{1}\left(\mathbb{R}^{n}\right)=\left\{u \in H_{d}^{1}\left(\mathbb{R}^{n}\right): u \text { is radially decreasing }\right\}
$$

we get the compactness of the injection $H_{r d}^{1}\left(\mathbb{R}^{n}\right) \hookrightarrow L^{q}\left(\mathbb{R}^{n}\right)$ for all $n \geq 1$ (see the Appendix of [3] for more details). We will use this fact to present a unified approach for the problem of the energy minimization of (3), valid in all space dimensions.

Before stating our results more precisely, and following the functional settings in [4], [5] and [14], let us introduce a few notations: we denote by $\|\cdot\|_{q}$ the standard $L^{q}\left(\mathbb{R}^{n}\right)$ norm and, for $(u, v) \in E:=H^{1}\left(\mathbb{R}^{n}\right) \times H^{1}\left(\mathbb{R}^{n}\right)$, we put

$$
\|(u, v)\|_{\dot{\omega}}^{2}:=\|u\|^{2}+\|v\|_{\dot{\omega}}^{2}:=\|u\|_{2}^{2}+\|\nabla u\|_{2}^{2}+\omega^{2}\|v\|_{2}^{2}+\|\nabla v\|_{2}^{2} .
$$

We introduce the energy functional associated to (3),

$$
I(u, v):=\frac{1}{2}\|(u, v)\|_{\dot{\omega}}^{2}-\frac{1}{2 q}\left(\|u\|_{2 q}^{2 q}+\|v\|_{2 q}^{2 q}+2 b\|u v\|_{q}^{q}\right),
$$

noticing that $(u, v)$ is a solution of (3) if and only if $\nabla I(u, v)=0$. We will study the minimization problem

$$
\begin{equation*}
\inf \{I(u, v):(u, v) \in \mathcal{N}\} \tag{7}
\end{equation*}
$$

where the so-called Nehari manifold $\mathcal{N}$ is defined by

$$
\mathcal{N}:=\left\{(u, v) \in H^{1}\left(\mathbb{R}^{n}\right) \times H^{1}\left(\mathbb{R}^{n}\right):(u, v) \neq(0,0), \nabla I(u, v) \perp(u, v)\right\}
$$

that is, $(u, v) \in \mathcal{N}$ if and only if $(u, v) \neq(0,0)$ and

$$
\tau(u, v):=\langle\nabla I(u, v),(u, v)\rangle_{L^{2}}=\|(u, v)\|_{\dot{\omega}}^{2}-\left(\|u\|_{2 q}^{2 q}+\|v\|_{2 q}^{2 q}+2 b\|u v\|_{q}^{q}\right)=0 .
$$

As pointed out in [4] for the case $q=2$, we notice that

$$
\langle\nabla \tau(u, v),(u, v)\rangle_{L^{2}}=2\|(u, v)\|_{\dot{\omega}}^{2}-2 q\left(\|u\|_{2 q}^{2 q}+\|v\|_{2 q}^{2 q}+2 b\|u v\|_{q}^{q}\right),
$$

and, if $(u, v) \in \mathcal{N}$,

$$
\begin{equation*}
\langle\nabla \tau(u, v),(u, v)\rangle_{L^{2}}=2(1-q)\|(u, v)\|_{\dot{\omega}}^{2}<0 \tag{8}
\end{equation*}
$$

which shows that $\mathcal{N}$ is locally smooth.
Furthermore, it is easy to check that $\left[h_{1}, h_{2}\right] \operatorname{Hess} \tau_{(0,0)}{ }^{t}\left[h_{1}, h_{2}\right]>0$ for all $\left(h_{1}, h_{2}\right) \neq(0,0):(0,0)$ is a strict minimizer of $\tau$, hence an isolated point of the set $\{\tau(u, v)=0\}$, implying that $\mathcal{N}$ is a complete manifold. Finally, any critical point of $I$ constrained to $\mathcal{N}$ is a critical point of $I$. Indeed, let us consider $(u, v) \in \mathcal{N}$ a critical point of $I$ constrained to $\mathcal{N}$. There exists a Lagrange multiplier $\lambda$ such that $\nabla I(u, v)=\lambda \nabla \tau(u, v)$.
By taking the $L^{2}$ scalar product with $(u, v)$,

$$
\langle\nabla I(u, v),(u, v)\rangle_{L^{2}}=\lambda\langle\nabla \tau(u, v),(u, v)\rangle_{L^{2}},
$$

that is, in view of (8), $0=\lambda(2-2 q)\|(u, v)\|_{\dot{\omega}}^{2}$, hence $\lambda=0$ and $\nabla I(u, v)=0$.
Putting $E_{r d}=H_{r d}^{1} \times H_{r d}^{1}$ the cone of symmetric radially decreasing nonnegative functions of $E$, we will prove the following result:

Theorem 1.1 Let $n \geq 1$ and $q>1$, with $q \leq \frac{n}{n-2}$ if $n>3$. There exists a minimizing sequence $\left(u_{n}, v_{n}\right) \in E_{r d}$ for the minimization problem (7). Furthermore, $\left(u_{n}, v_{n}\right) \rightarrow\left(u_{*}, v_{*}\right) \in E_{r d}$ strongly in $H^{1}\left(\mathbb{R}^{n}\right) \times H^{1}\left(\mathbb{R}^{n}\right)$. In particular

$$
\begin{align*}
& I\left(u_{*}, v_{*}\right)=\min _{\mathcal{N}} I(u, v)=\min _{\mathcal{N} E_{r d}} I(u, v) \\
& \quad=\min \{I(u, v):(u, v) \neq(0,0) \text { and } \nabla I(u, v)=0\} . \tag{9}
\end{align*}
$$

Concerning the existence of ground states with non-trivial components, we will show:

Theorem 1.2 Let $n \geq 1$ and $1<q<2$, with $q<\frac{n}{n-2}$ if $n \geq 3$.
Then for all $b>0$ there exists a ground state solution $(u, v) \in E_{r d}$ to (3) with $u>0$ and $v>0$.

Theorem 1.3 Let $n=1$ and $q \geq 2$. If

$$
\begin{equation*}
b \geq \mathcal{D}_{\omega, q}=\frac{2^{q}-1}{2} \omega^{1+\frac{q}{2}}-\frac{1}{2} \omega^{-\frac{q}{2}} \tag{10}
\end{equation*}
$$

there exists a ground state solution $(u, v) \in E_{r d}$ to (3) with $u>0$ and $v>0$.

Notice that

$$
\mathcal{D}_{\omega, q}<\mathcal{C}_{\omega, 1, q}=\frac{1}{2}\left(\frac{3}{2}-\frac{1}{2 q}+\frac{1}{\omega^{2}}\left(\frac{1}{2}+\frac{1}{2 q}\right)\right)^{q} \omega^{1+q}-1
$$

at least for large values of $\omega$.

## 2 Proof of Teorem 1.1

We begin by observing that for $(f, g) \in E,(f, g) \neq(0,0)$, with $\tau(f, g) \leq$ 0 , there exists $t \in] 0,1]$ such that $(t f, t g) \in \mathcal{N}$. Indeed, if $\tau(f, g)=0$, we choose $t=1$. If $\tau(f, g)<0$ we simply notice that

$$
\tau(t f, t g)=t^{2}\left(\|(f, g)\|_{\dot{\omega}}^{2}-t^{2 q-2}\left(\|f\|_{2 q}^{2 q}+\|g\|_{2 q}^{2 q}+2 b\|f g\|_{q}^{q}\right)\right):=t^{2} T_{f, g}(t)
$$

with $T_{f, g}(0)>0$ and $T_{f, g}(1)<0$.
Also, we notice that if $(f, g) \in \mathcal{N}$,

$$
\begin{equation*}
I(f, g)=\left(\frac{1}{2}-\frac{1}{2 q}\right)\|(f, g)\|_{\dot{\omega}}=\left(\frac{1}{2}-\frac{1}{2 q}\right)\left(\|f\|_{2 q}^{2 q}+\|g\|_{2 q}^{2 q}+2 b\|f g\|_{q}^{q}\right) . \tag{11}
\end{equation*}
$$

We now take a minimizing sequence $\left(u_{n}, v_{n}\right) \in \mathcal{N}$ for the problem

$$
m=\inf \{I(u, v):(u, v) \in \mathcal{N}\} .
$$

From (11), it is clear that $m \geq 0$ and that $\left(u_{n}, v_{n}\right)$ is bounded in $E$.
We put $u_{n}^{*}$ and $v_{n}^{*}$ the decreasing radial rearrangements of $\left|u_{n}\right|$ and $\left|v_{n}\right|$ respectively. It is well-known that this rearrangement preserves the $L^{p}$ norm $(1 \leq p \leq+\infty)$. Furthermore, the Pólya-Szegö inequality

$$
\left\|\nabla f^{*}\right\|_{2} \leq\|\nabla|f|\|_{2}
$$

in addition with the inequality $\|\nabla|f|\|_{2} \leq\|\nabla f\|_{2}$ (see [13]) shows that

$$
\left\|\left(u_{n}^{*}, v_{n}^{*}\right)\right\|_{\dot{\omega}}^{2} \leq\left\|\left(u_{n}, v_{n}\right)\right\|_{\dot{\omega}}^{2} .
$$

On the other hand, the Hardy-Littlewood inequality

$$
\int|f g| \leq \int f^{*} g^{*}
$$

combined with the monotonicity of the map $\lambda \rightarrow \lambda^{q}$ (see for instance [8] for details) yields $\|f g\|_{q} \leq\left\|f^{*} g^{*}\right\|_{q}$ and, finally,

$$
\tau\left(u_{n}^{*}, v_{n}^{*}\right) \leq \tau\left(u_{n}, v_{n}\right)=0 .
$$

Next, let $\left.\left.t_{n} \in\right] 0,1\right]$ such that $\left(t_{n} u_{n}^{*}, t_{n} v_{n}^{*}\right) \in \mathcal{N}$. We obtain

$$
I\left(t_{n} u_{n}^{*}, t_{n} v_{n}^{*}\right)=t_{n}^{2}\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|\left(u_{n}^{*}, v_{n}^{*}\right)\right\|_{\dot{\omega}}^{2} \leq\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|\left(u_{n}, v_{n}\right)\right\|_{\dot{\omega}}^{2}=I\left(u_{n}, v_{n}\right)
$$

and we obtained a minimizing sequence $\left(t_{n} u_{n}^{*}, t_{n} v_{n}^{*}\right)$ in $E_{r d}$, denoted again, in what follows, by $\left(u_{n}, v_{n}\right)$. Since this sequence is bounded in $H^{1}\left(\mathbb{R}^{n}\right)$, up to a subsequence, $\left(u_{n}, v_{n}\right) \rightharpoonup\left(u_{*}, v_{*}\right)$ in $H^{1}\left(\mathbb{R}^{n}\right)$ weak. Also, since the injection $E_{r d} \rightarrow L^{2 q}\left(\mathbb{R}^{n}\right)$ is compact, up to a subsequence, $\left(u_{n}, v_{n}\right) \rightarrow\left(u_{*}, v_{*}\right)$ in $L^{2 q}\left(\mathbb{R}^{n}\right)$ strong.
Hence, since $\left\|u_{n}\right\|_{2 q}^{2 q}+\left\|v_{n}\right\|_{2 q}^{2 q}+2 b\left\|u_{n} v_{n}\right\|_{q}^{q} \rightarrow\left\|u_{*}\right\|_{2 q}^{2 q}+\left\|v_{*}\right\|_{2 q}^{2 q}+2 b\left\|u_{*} v_{*}\right\|_{q}^{q}$, we deduce that

$$
\tau\left(u_{*}, v_{*}\right) \leq \liminf \tau\left(u_{n}, v_{n}\right)=0 .
$$

Once again, let $t \in] 0,1]$ such that $\left(t u_{*}, t v_{*}\right) \in \mathcal{N}$.

$$
\begin{aligned}
m \leq I\left(t u_{*}, t v_{*}\right)= & t^{2}\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|\left(u_{*}, v_{*}\right)\right\|_{\dot{\omega}}^{2} \\
& \leq\left(\frac{1}{2}-\frac{1}{2 q}\right) \liminf \left\|\left(u_{n}, v_{n}\right)\right\|_{\dot{\omega}}^{2} \leq \liminf I\left(u_{n}, v_{n}\right)=m
\end{aligned}
$$

This implies that $\left(t u_{*}, t v_{*}\right)$ is a minimizer. In particular, all inequalities above are in fact equalities: $t=1,\left(u_{*}, v_{*}\right) \in \mathcal{N},\left\|\left(u_{*}, v_{*}\right)\right\|_{\dot{\omega}}=\lim \left\|\left(u_{n}, v_{n}\right)\right\|_{\dot{\omega}}$, $\left\|u_{n}\right\|_{H^{1}} \rightarrow\left\|u_{*}\right\|_{H^{1}},\left\|v_{n}\right\|_{H^{1}} \rightarrow\left\|v_{*}\right\|_{H^{1}}$ and $\left(u_{n}, v_{n}\right) \rightarrow\left(u_{*}, v_{*}\right)$ in $H^{1}\left(\mathbb{R}^{n}\right)$ strong.
Finally, it is clear that $\left(u_{*}, v_{*}\right)$ is a ground state: if $\left(w_{1}, w_{2}\right) \neq(0,0)$ is a critical point of $I$ such that $I\left(w_{1}, w_{2}\right)<I\left(u_{*}, v_{*}\right)$, taking once again $w_{1}^{*}$ and $w_{2}^{*}$ the decreasing radial rearrangements of $\left|w_{1}\right|$ and $\left|w_{2}\right|$, there exists $t \in] 0,1]$ such that $\left(t w_{1}^{*}, t w_{2}^{*}\right) \in \mathcal{N}$ and $I\left(t w_{1}^{*}, t w_{2}^{*}\right) \leq I\left(w_{1}, w_{2}\right)$, which leads to a contradiction. This completes the proof of Theorem 1.1,

## 3 Ground states with non-trivial components

Let $\left(u_{*}, v_{*}\right) \in E_{r d}$ the ground state mentionned in Theorem 1.1. If $v_{*}=0$, $u_{*}=u_{0}$ is the unique positive radially symmetric solution of the elliptic equation $-\Delta u+u=u^{2 q-1}$ (see [10]).
Also, if $u_{*}=0, v_{*}=v_{0}$ is the unique positive radially symmetric solution of $-\Delta v+\omega^{2} v=v^{2 q-1}$, which relates to $u_{0}$ by the relation $v_{0}(x)=\omega^{\frac{1}{q-1}} u_{0}(\omega x)$. Hence, to show the existence of a ground state with nontrivial components, we only have to exhibit an element $(f, g) \in \mathcal{N} \cap E_{r d}, f \neq 0, g \neq 0$, such that

$$
\begin{equation*}
I(f, g) \leq \min \left\{I\left(u_{0}, 0\right), I\left(0, v_{0}\right)\right\} \tag{12}
\end{equation*}
$$

Since $I\left(u_{0}, 0\right)=\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|u_{0}\right\|_{2 q}^{2 q}, I\left(0, v_{0}\right)=\omega^{\frac{2 q}{q-1}-n}\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|u_{0}\right\|_{2 q}^{2 q}$ and $\frac{2 q}{q-1}-n>0$, for $\omega \geq 1$ the inequality (12) reduces to

$$
\begin{equation*}
I(f, g) \leq I\left(u_{0}, 0\right) \tag{13}
\end{equation*}
$$

We first compute $x>0$ such that $(f, g):=\left(x u_{0}, x \theta v_{0}\right) \in \mathcal{N}$, where $\theta>0$ will be chosen later (see [6] and [7] for a recent application of a related technique to the Schrödinger-KdV system):

$$
\tau(f, g)=x^{2}\left\|\left(u_{0}, \theta v_{0}\right)\right\|_{\dot{\omega}}^{2}-x^{2 q}\left(\left\|u_{0}\right\|_{2 q}^{2 q}+\theta^{2 q}\left\|v_{0}\right\|_{2 q}^{2 q}+2 b \theta^{q}\left\|u_{0} v_{0}\right\|_{q}^{q}\right)=0
$$

Since

$$
\left\|\theta v_{0}\right\|_{\dot{\omega}}^{2}=\omega^{2+\frac{2}{q-1}-n}\left\|\theta u_{0}\right\|_{2}^{2}+\omega^{2+\frac{2}{q-1}-n}\left\|\theta \nabla u_{0}\right\|_{2}^{2}=\omega^{\frac{2 q}{q-1}-n} \theta^{2}\left\|u_{0}\right\|^{2}
$$

and

$$
\left\|v_{0}\right\|_{2 q}^{2 q}=\omega^{\frac{2 q}{q-1}-n}\left\|u_{0}\right\|_{2 q}^{2 q},
$$

we obtain

$$
x^{2 q-2}=\frac{\left(1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}\right)\left\|u_{0}\right\|^{2}}{\left(1+\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}\right)\left\|u_{0}\right\|_{2 q}^{2 q}+2 b \theta^{q}\left\|u_{0} v_{0}\right\|_{q}^{q}}=\frac{1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}}{1+\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}+2 b \theta^{q} \frac{\left\|u_{0} v_{0}\right\|^{q}}{\left\|u_{0}\right\|_{2 q}^{q}}} .
$$

Since $u_{0}$ is radial and nonincreasing and $\omega \geq 1$,

$$
\left\|u_{0} v_{0}\right\|_{q}^{q}=\omega^{\frac{q}{q-1}} \int u_{0}^{q}(x) u_{0}^{q}(\omega x) d x \leq \omega^{\frac{q}{q-1}} \int u_{0}^{q}(x) u_{0}^{q}(x) d x=\omega^{\frac{q}{q-1}}\left\|u_{0}\right\|_{2 q}^{2 q} .
$$

Also,

$$
\left\|u_{0} v_{0}\right\|_{q}^{q} \geq \omega^{\frac{q}{q-1}} \int u_{0}^{2 q}(\omega x) d x=\omega^{\frac{q}{q-1}-n}\left\|u_{0}\right\|_{2 q}^{2 q} .
$$

Hence, we obtain

$$
\begin{equation*}
\frac{1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}}{1+\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}+2 b \theta^{q} \omega^{\frac{q}{q-1}}} \leq x^{2 q-2} \leq \frac{1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}}{1+\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}+2 b \theta^{q} \omega^{\frac{q}{q-1}-n}} \tag{14}
\end{equation*}
$$

and

$$
I(f, g)=x^{2}\left(\frac{1}{2}-\frac{1}{2 q}\right)\left\|\left(u_{0}, \theta v_{0}\right)\right\|_{\dot{\omega}}^{2}=x^{2}\left(\frac{1}{2}-\frac{1}{2 q}\right)\left(1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}\right)\left\|u_{0}\right\|^{2} .
$$

The condition (13)) then becomes $x^{2}\left(1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}\right) \leq 1$.
In view of (14), a sufficient condition is

$$
\frac{\left(1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}\right)^{q}}{1+\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}+2 b \theta^{q} \omega^{\frac{q}{q-1}-n}} \leq 1
$$

that is,

$$
b \geq \frac{\left(1+\theta^{2} \omega^{\frac{2 q}{q-1}-n}\right)^{q}-1-\theta^{2 q} \omega^{\frac{2 q}{q-1}-n}}{2 \theta^{q} \omega^{\frac{q}{q-1}-n}}
$$

We now put $\theta^{2}=\epsilon^{2} \omega^{n-\frac{2 q}{q-1}}$, for $\epsilon>0$, obtaining the condition

$$
b \geq \frac{\left(1+\epsilon^{2}\right)^{q}-1}{2 \epsilon^{q}} \omega^{q-\frac{n}{2}(q-2)}-\frac{1}{2} \epsilon^{q} \omega^{\left(\frac{n}{2}-1\right) q} .
$$

For $1<q<2, \lim _{\epsilon \rightarrow 0} \frac{\left(1+\epsilon^{2}\right)^{q}-1}{2 \epsilon^{q}}=0$.
Hence, the arbitrary value of $\epsilon$ establishes the sufficient condition $b>0$.
For $n=1$, putting $\epsilon=1$, we obtain the bound

$$
\begin{equation*}
b \geq \frac{2^{q}-1}{2} \omega^{1+\frac{q}{2}}-\frac{1}{2} \omega^{-\frac{q}{2}} \tag{15}
\end{equation*}
$$

as stated in Theorem 1.3.
We finish by making a few remarks:
Remark 3.1 For $\omega=1$ and $\theta=1$, we obtain, for all $n \geq 1$, the bound $2^{q-1}-1$ which is known to be optimal for $q \geq 2$, in the sense that for $b<2^{q-1}-1$ all ground states of (3) have one null component (see [14], Theorem 2.5).

Remark 3.2 The bound in (15) can be slightly improved for large values of $\omega$ by replacing the quantity $\frac{2^{q}-1}{2}$ by the minimum of $\frac{\left(1+\epsilon^{2}\right)^{q}-1}{2 \epsilon^{q}}$ for $\epsilon>0$.

Remark 3.3 For $n \geq 4$ we have $1<q<2$, hence the problem of the existence of ground states with non-trivial components is completely solved for these spatial dimensions.
