# Adiabatic approximation for the imaginary-time Schrödinger equation and its application to simulated annealing

#### Abstract

We formulate the adiabatic approximation for the imaginary-time Schrödinger equation. The obtained adiabatic condition consists of two inequalities, one of which coincides with the conventional adiabatic condition for the real-time Schrödinger equation, but the other does not. We apply this adiabatic approximation to the analysis of Markovian dynamics of the classical Ising model, which can be formulated as an imaginary-time Schrödinger equation, to obtain the asymptotic form of the probability that the system reaches the ground state in the limit of long annealing time in simulated annealing. Using this formula, we amend the theory of Somma, Batista and Ortiz for a convergence condition of simulated annealing.


## 1. Introduction

An optimization problem is a problem to find an element of some set which minimizes a real-valued function called the cost function. In this paper, we consider an optimization problem with discrete variables, which is known as a combinatorial optimization problem. The cost function of a combinatorial optimization problem is identified with the Hamiltonian of a classical Ising model whose ground state is the global minimum. Solving combinatorial optimization problems is hard in general because of the exponential increase of the number of elements with the problem size and frustrations in the problem. It is generally very difficult to find the exact solution within a practical time. We thus devise algorithms which give an approximate solution. Simulated annealing ${ }^{1,2}$ and quantum annealing ${ }^{3-5}$ are among such approximate algorithms.

The basic idea of these algorithms is to use a physical process to escape local minima of the cost function so that the state approaches the global minimum. In simulated annealing, we introduce a time-dependent temperature $T(t)$ as the control parameter. We initially set the temperature to the high value and reduce $T(t)$ slowly toward zero, and the system finally reaches the zero-temperature equilibrium, the ground state which corresponds to the solution of the combinatorial optimization problem. Quantum annealing was proposed in an analogy with simulated annealing. ${ }^{3}$ In quantum annealing, we introduce a time-dependent external magnetic field which induces quantum fluctuations. We reduce the external field from a very large value to zero, just like simulated annealing in which we reduce the temperature. A similar idea, adiabatic quantum computation, ${ }^{6}$ is often used in the literature of quantum information theory. However, there is a small difference between adiabatic quantum computation and quantum annealing in that adiabatic quantum computation only uses adiabatic time evolution, but non-adiabatic time evolution is also considered in quantum annealing. ${ }^{7}$ In this paper, we consider quantum annealing following adiabatic time evolution, i.e. adiabatic quantum computation.

A classical to quantum mapping discussed in Refs. 8-10 allows us to express thermodynamical properties of classical systems in terms of those of quantum systems in the same spatial dimension. Using this mapping, a slow change of the
temperature in simulated annealing corresponds to a slow change of the Hamiltonian in quantum annealing. We therefore can study simulated annealing and quantum annealing from the same perspective. However, the mapped quantum state does not follow the real time Schrödinger equation, and its dynamics is represented as the imaginary time Schrödinger equation. ${ }^{11}$ When we consider time-dependent quantities, we need careful analyses due to the difference of the dynamics. Somma et al. applied this classical to quantum mapping to simulated annealing, and re-derive the convergence condition originally proved in Ref. 12 by using the ordinary adiabatic condition for the real time Schrödinger equation. ${ }^{10}$ However, the adiabatic condition of the real time does not directly apply to the imaginary time Schrödinger equation, and their analysis should therefore be carefully re-examined.

In the present paper, we derive formulas for the adiabatic approximation for the imaginary-time Schrödinger equation. This was derived before in Ref. 13 for the norm-conserved but non-linear case as well as in Ref 14. Our approximation is applicable to the norm-non-conserved and linear case, which is related to classical Markovian dynamics. We apply this approximation to simulated annealing and obtain an asymptotic formula for the probability that the system reaches the ground state at zero temperature. Using this formula, we rederive the rate of convergence to the ground state discussed by Somma et al.

This paper is organized as follows. In the next section, we derive the adiabatic approximation for the imaginary-time Schrödinger equation. Then, in Sect. 3, we review classical-to-quantum mapping and rewrite classical Markovian dynamics as the imaginary-time Schrödinger equation. Applying the approximation discussed in Sect. 2 to the mapped quantum system, we analyze the probability to reach the ground state in Sect. 4. The convergence condition for simulated annealing is rederived from the imaginary-time adiabatic condition in Sect. 5. The final section is devoted to the conclusion.

## 2. Imaginary-time Schrödinger equation and its adiabatic approximation

Let us consider the imaginary-time Schrödinger equation

$$
\begin{equation*}
-\frac{d}{d t}|\psi(t)\rangle=H(t)|\psi(t)\rangle . \tag{1}
\end{equation*}
$$

We consider the time development of a system following this equation in the time scale $\tau, 0 \leq t \leq \tau$. We scale the time as $s=t / \tau$, where $s$ starts from 0 and ends at $s=1$. Then, eq. (1) reads

-\frac{d}{d s}|\psi(s)\rangle=\tau H(s)|\psi(s)\rangle \tag{2}
\end{equation*}
$$

Note that the norm of the wave function is not conserved, and $\langle\psi(s) \mid \psi(s)\rangle$ depends on $s$.

Following Refs. 13 and 14, we expand the wave function in terms of the set of instantaneous eigenstates, $H(s)|j(s)\rangle=$ $E_{j}(s)|j(s)\rangle$, as

|\psi(s)\rangle=\sum_{j} c_{j}(s)|j(s)\rangle=\sum_{j} e^{-\tau \phi_{j}(s)} \tilde{c}_{j}(s)|j(s)\rangle \tag{3}
\end{equation*}

where the second equality defines $\tilde{c}_{j}(s)$ with

\phi_{j}(s)=\int_{0}^{s} d s^{\prime} E_{j}\left(s^{\prime}\right) \tag{4}
\end{equation*}
$$

We assume $E_{0}(s)=0$ with an application in later sections in mind. The imaginary-time Schrödinger equation (2) can be rewritten in terms of the coefficients as

$$
\begin{equation*}
\frac{d \tilde{c}_{j}(s)}{d s}=\sum_{k \neq j} e^{\tau\left(\phi_{j}(s)-\phi_{k}(s)\right)} \frac{\langle j(s)| \frac{d H(s)}{d s}|k(s)\rangle}{\Delta_{j k}(s)} \tilde{c}_{k}(s) \tag{5}
\end{equation*}
$$

where $\Delta_{j k}(s)=E_{j}(s)-E_{k}(s)$. Integration of this differential equation and multiplication of the resulting expression by $e^{-\tau \phi_{j}(s)}$ yield

c_{j}(s)=c_{j}(0) & e^{-\tau \phi_{j}(s)} \\
& +e^{-\tau \phi_{j}(s)} \sum_{k \neq j} \int_{0}^{s} d s^{\prime} e^{\tau \phi_{j}\left(s^{\prime}\right)} \frac{\left\langle j\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\left|k\left(s^{\prime}\right)\right\rangle}{\Delta_{j k}\left(s^{\prime}\right)} c_{k}\left(s^{\prime}\right) . \tag{6}
\end{align*}
$$

Let us solve this integral equation iteratively, i.e. an asymptotic expansion for very large $\tau$. The initial condition is that $c_{0}(0)$ for the ground state is of $O(1)$, and the other coefficients are much smaller or even zero. Then, the zeroth-order solution $c_{j}^{(0)}$, which is obtained by ignoring the integral part in eq. (6), is

c_{0}^{(0)}(s)=c_{0}(0), \quad c_{j(\neq 0)}^{(0)}=c_{j}(0) e^{-\tau \phi_{j}(s)} \tag{7}
\end{equation*}
$$

Insertion of these relations into eq. (6) gives

& c_{j(\neq 0)}^{(1)}(s) \\
& =c_{j}(0) e^{-\tau \phi_{j}(s)} \\
& \quad+e^{-\tau \phi_{j}(s)} \sum_{k \neq j} c_{k}(0) \int_{0}^{s} d s^{\prime} e^{\tau\left(\phi_{j}\left(s^{\prime}\right)-\phi_{k}\left(s^{\prime}\right)\right)} \frac{\left\langle j\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\left|k\left(s^{\prime}\right)\right\rangle}{\Delta_{j k}\left(s^{\prime}\right)}  \tag{8}\\
& =c_{0}(0) e^{-\tau \phi_{j}(s)} \int_{0}^{s} d s^{\prime} e^{\tau \phi_{j}\left(s^{\prime}\right)} \frac{\left\langle j\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\left|0\left(s^{\prime}\right)\right\rangle}{\Delta_{j 0}\left(s^{\prime}\right)}+O\left(e^{-\tau}\right) \tag{9}
\end{align*}
$$

Integration by parts leads to

$$
c_{j(\neq 0)}^{(1)}(s)=c_{0}(0) e^{-\tau \phi_{j}(s)}\left\{\frac{1}{\tau}\left[e^{\tau \phi_{j}\left(s^{\prime}\right)} \frac{\left\langle j\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\left|0\left(s^{\prime}\right)\right\rangle}{\Delta_{j 0}\left(s^{\prime}\right)^{2}}\right]_{0}^{s}\right.
$$

$$
\begin{align*}
& \left.-\frac{1}{\tau} \int_{0}^{s} d s^{\prime} e^{\tau \phi_{j}\left(s^{\prime}\right)} \frac{d}{d s^{\prime}}\left(\frac{\left\langle j\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\left|0\left(s^{\prime}\right)\right\rangle}{\Delta_{j 0}\left(s^{\prime}\right)^{2}}\right)\right\}  \tag{10}\\
= & \frac{c_{0}(0)}{\tau} \frac{\langle j(s)| \frac{d H(s)}{d s}|0(s)\rangle}{\Delta_{j 0}(s)^{2}}+O\left(\tau^{-2}\right)  \tag{11}\\
\equiv & \frac{c_{0}(0) A_{j}(s)}{\tau}+O\left(\tau^{-2}\right) . \tag{12}
\end{align*}
$$

From this and eq. (6), we obtain

$$
\begin{align*}
c_{0}^{(1)}(s) & =c_{0}(0) \\
& -\frac{c_{0}(0)}{\tau} \sum_{k \neq 0} \int_{0}^{s} d s^{\prime} \frac{\left.\left|\left\langle k\left(s^{\prime}\right)\right| \frac{d H\left(s^{\prime}\right)}{d s^{\prime}}\right| 0\left(s^{\prime}\right)\right\rangle\left.\right|^{2}}{\Delta_{k 0}\left(s^{\prime}\right)^{3}}+O\left(\tau^{-2}\right)  \tag{13}\\
& \equiv c_{0}(0)\left(1-\frac{1}{\tau} \int_{0}^{s} d s^{\prime} B\left(s^{\prime}\right)\right)+O\left(\tau^{-2}\right) \tag{14}
\end{align*}
$$

Equations (12) and (14) represent the adiabatic approximation for the imaginary-time Schrödinger equation.

Equations (12) and (14) may seem to suggest that the adiabatic condition for the imaginary-time Schrödinger equation is

\left|\frac{A_{j}(s)}{\tau}\right| \ll 1, \quad\left|\frac{\int_{0}^{s} d s^{\prime} B\left(s^{\prime}\right)}{\tau}\right| \ll 1 \tag{15}
\end{equation*}
$$

The former of which coincides with the conventional adiabatic condition of the real-time Schrödinger equation. ${ }^{15}$ We must be careful, however, that the norm of the wave function is not conserved, and hence $\left|c_{j}(s)\right|^{2}$ does not directly represent the probability. We shall come back to this point later.

## 3. Master equation expressed as the imaginary-time Schrödinger equation

Non-equilibrium dynamics of the Ising model following the master equation can be rewritten as the imaginary-time Schrödinger equation as described in Refs. 10 and 11. The master equation is

$$
\begin{equation*}
\frac{1}{\tau} \frac{d P_{\sigma}(s)}{d s}=\sum_{\sigma^{\prime}} W_{\sigma \sigma^{\prime}}(s) P_{\sigma^{\prime}}(s) \tag{16}
\end{equation*}
$$

where we have scaled time as $s=t / \tau$ as before, $\sigma$ is a set of $N$ Ising spins $\sigma=\left\{\sigma_{1}, \sigma_{2}, \ldots, \sigma_{N}\right\}$, and $P_{\sigma}(s)$ is the probability that the system is in the state $\sigma$ at scaled time $s$. We have the Ising model with the Hamiltonian $H_{0}(\sigma)$ in mind, which is reflected in the transition matrix $W_{\sigma \sigma^{\prime}}(s)$ implicitly. Notice that the transition matrix $W_{\sigma \sigma^{\prime}}(s)$ may be time-dependent through time dependence of the temperature $T(s)$ or its inverse $\beta(s)$.

Suppose that the transition matrix follows the detailed balance condition

\begin{equation*}
W_{\sigma \sigma^{\prime}}(s) P_{\sigma^{\prime}}^{(0)}(s)=W_{\sigma^{\prime} \sigma}(s) P_{\sigma}^{(0)}(s) \quad\left(P_{\sigma}^{(0)}(s)=\frac{e^{-\beta(s) H_{0}(\sigma)}}{Z}\right) \tag{17}
\end{equation*}
$$

The right eigenvalues of the transition matrix will be denoted as $\lambda_{0}(=0)>\lambda_{1}>\lambda_{2}>\cdots$. The leading eigenvalue/eigenvector corresponds to thermal equilibrium, which does not change with time as suggested by $\lambda_{0}=0$.

The following 'similarity transformation' is the key to map the classical non-equilibrium dynamics to quantum mechan-
ics, ${ }^{8-11}$

\begin{align*}
H_{\mathrm{SA}}(s) & \equiv-e^{\frac{1}{2} \beta(s) H_{0}} W(s) e^{-\frac{1}{2} \beta(s) H_{0}}  \tag{18}\\
|\psi(s)\rangle & \equiv e^{\frac{1}{2} \beta(s) H_{0}} \sum_{\sigma} P_{\sigma}|\sigma\rangle \tag{19}
\end{align*}
$$

where $W(s)$ is a $2^{N} \times 2^{N}$ matrix with elements $W_{\sigma \sigma^{\prime}}(s)$, and $H_{\mathrm{SA}}(s)$ is also a matrix. Notice that $|\psi(s)\rangle$ is not normalized. It is easy to see that this $H_{\mathrm{SA}}(s)$ real and symmetric, $\left.H_{\mathrm{SA}}(s)\right)_{\sigma \sigma^{\prime}}=\left(H_{\mathrm{SA}}(s)\right)_{\sigma^{\prime} \sigma}$, i.e. Hermitian, and can therefore be regarded as a quantum-mechanical Hamiltonian. Two matrices, $W(s)$ and $H_{\mathrm{SA}}(s)$, share the spectrum and eigenstates, up to a trivial factor or sign,

W(s)\left|\lambda_{n}(s)\right\rangle & =\lambda_{n}(s)|\lambda(s)\rangle  \tag{20}\\
H_{\mathrm{SA}}(s)\left|\phi^{(n)}(s)\right\rangle & =E_{\mathrm{SA}}^{(n)}(s)\left|\phi^{(n)}(s)\right\rangle=-\lambda_{n}(s)\left|\phi^{(n)}(s)\right\rangle  \tag{21}\\
\left|\phi^{(n)}(s)\right\rangle & =e^{\frac{1}{2} \beta(s) H_{0}}\left|\lambda_{n}(s)\right\rangle, \tag{22}
\end{align*}
$$

as can be verified from the definitions (18) and (19). The vectors $|\psi(s)\rangle$ and $\left|\phi^{(n)}(s)\right\rangle$ are not normalized. The normalized eigenvector of $H_{\mathrm{SA}}(s)$ will be denoted as $\left|n_{\mathrm{SA}}(s)\right\rangle$. In particular, the normalized ground state is

$$
\begin{equation*}
\left|0_{\mathrm{SA}}(s)\right\rangle=\frac{e^{-\frac{1}{2} \beta(s) H_{0}}}{\sqrt{Z}} \sum_{\sigma}|\sigma\rangle, \tag{23}
\end{equation*}
$$

which corresponds to thermal equilibrium having $\lambda_{0}(s)=0$ and consequently $E_{\mathrm{SA}}^{(0)}(s)=0$. The expectation value of an arbitrary matrix diagonal in the $\sigma$-basis by the ground-state of $H_{\mathrm{SA}}(s)$ is equal to the expectation value by the Boltzmann distribution. This suggests that thermal fluctuations are mapped to quantum fluctuations of the ground state.

From the master equation (16), $|\psi(s)\rangle$ can be verified to satisfy the following differential equation,

\begin{equation*}
-\frac{d}{d s}|\psi(s)\rangle=\tau\left(H_{\mathrm{SA}}(s)-\frac{1}{2 \tau} \dot{\beta}(s) H_{0}\right)|\psi(s)\rangle, \tag{24}
\end{equation*}
$$

where $\dot{\beta}$ is for $d \beta / d s$. This is a type of the imaginary-time Schrödinger equation with the effective Hamiltonian

$$
\begin{equation*}
H_{\mathrm{tot}}(s) \equiv H_{\mathrm{SA}}(s)-\frac{\dot{\beta}(s)}{2 \tau} H_{0} \tag{25}
\end{equation*}
$$

The normalized instantaneous eigenstate of the effective Hamiltonian will be written as

$$
\begin{equation*}
H_{\text {tot }}(s)\left|j_{\text {tot }}(s)\right\rangle=E_{\text {tot }}(s)\left|j_{\text {tot }}(s)\right\rangle \tag{26}
\end{equation*}
$$

## 4. Probability to reach the ground state

Let us write the spin configuration of the ground state of $H_{0}$ as $\left|\sigma_{\mathrm{G}}\right\rangle$. The probability that the system reaches the ground state at time $s$ is

$$
\begin{align*}
P_{\sigma_{\mathrm{G}}}(s) & =\left\langle\sigma_{\mathrm{G}}\right| \sum_{\sigma} P_{\sigma}(s)|\sigma\rangle  \tag{27}\\
& =\left\langle\sigma_{\mathrm{G}}\right| e^{-\frac{1}{2} \beta(s) H_{0}}|\psi(s)\rangle  \tag{28}\\
& =e^{-\frac{1}{2} \beta(s) E_{\mathrm{G}}}\left\langle\sigma_{\mathrm{G}} \mid \psi(s)\right\rangle . \tag{29}
\end{align*}
$$

This expression can be decomposed as
$P_{\sigma_{\mathrm{G}}}(s)=e^{-\frac{1}{2} \beta(s) E_{\mathrm{G}}} \sum_{j, k}\left\langle\sigma_{\mathrm{G}} \mid k_{\mathrm{SA}}(s)\right\rangle\left\langle k_{\mathrm{SA}}(s) \mid j_{\mathrm{tot}}(s)\right\rangle\left\langle j_{\mathrm{tot}}(s) \mid \psi(s)\right\rangle$.

Now, we assume that the temperature is controlled such that it reaches $T=0(\beta \rightarrow \infty)$ at $s=1$ and that the ground state energy of $H_{0}$ is also zero, $E_{\mathrm{G}}=0$. Then, the instantaneous eigenstate of $H_{\mathrm{SA}}(s)$ at $s=1$ is the ground state, so $\left\langle\sigma_{\mathrm{G}} \mid k_{\mathrm{SA}}(1)\right\rangle=\delta_{k, 0}$. We therefore have

\begin{equation*}
P_{\sigma_{\mathrm{G}}}(1)=\sum_{j}\left\langle 0_{\mathrm{SA}}(1) \mid j_{\mathrm{tot}}(1)\right\rangle\left\langle j_{\mathrm{tot}}(1) \mid \psi(1)\right\rangle . \tag{31}
\end{equation*}
$$

According to the definition (25) and perturbation theory, the instantaneous eigenstate of the total Hamiltonian is related in the large $-\tau$ limit to $H_{\mathrm{SA}}$ as

\begin{equation*}
\left|j_{\mathrm{tot}}\right\rangle=\left|j_{\mathrm{SA}}\right\rangle-\frac{\dot{\beta}}{2 \tau} \sum_{l \neq j}\left|l_{\mathrm{SA}}\right\rangle \frac{\left\langle l_{\mathrm{SA}}\right| H_{0}\left|j_{\mathrm{SA}}\right\rangle}{E_{\mathrm{SA}}^{(j)}(s)-E_{\mathrm{SA}}^{(l)}(s)}+O\left(\tau^{-2}\right) \tag{32}
\end{equation*}
$$

We thus have

$$
\begin{equation*}
\left\langle 0_{\mathrm{SA}}(s) \mid 0_{\mathrm{tot}}(s)\right\rangle=1+O\left(\tau^{-2}\right) \tag{33}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\langle 0_{\mathrm{SA}}(s) \mid j_{\mathrm{tot}}(s)\right\rangle=-\frac{\dot{\beta}}{2 \tau} \frac{\left\langle 0_{\mathrm{SA}}\right| H_{0}\left|j_{\mathrm{SA}}\right\rangle}{E_{\mathrm{SA}}^{(j)}(s)-E_{\mathrm{SA}}^{(0)}(s)}+O\left(\tau^{-2}\right) \quad(j \neq 0) \tag{34}
\end{equation*}
$$

Then, from eq. (31),

\begin{align*}
P_{\sigma_{\mathrm{G}}}(1)= & \left\langle 0_{\mathrm{tot}}(1) \mid \psi(1)\right\rangle \\
& -\frac{\dot{\beta}}{2 \tau} \sum_{j \neq 0} \frac{\left\langle 0_{\mathrm{SA}}\right| H_{0}\left|j_{\mathrm{SA}}\right\rangle}{E_{\mathrm{SA}}^{(j)}(s)-E_{\mathrm{SA}}^{(0)}(s)}\left\langle j_{\mathrm{tot}}(1) \mid \psi(1)\right\rangle+O\left(\tau^{-2}\right) . \tag{35}
\end{align*}
$$

The asymptotic expansions (12) and (14) developed in Sect. 2 for the imaginary-time Schrödinger equation tell us

$$
\begin{align*}
& \left\langle 0_{\mathrm{tot}}(s) \mid \psi(s)\right\rangle=c_{0}^{\mathrm{tot}}(0)\left(1-\frac{1}{\tau} \int_{0}^{s} B_{\mathrm{tot}}\left(s^{\prime}\right) d s^{\prime}\right)+O\left(\tau^{-2}\right)  \tag{36}\\
& \left\langle\mathrm{j}_{\mathrm{tot}}(s) \mid \psi(s)\right\rangle=\frac{c_{0}^{\mathrm{tot}}(1) A_{\mathrm{tot}}^{(j)}}{\tau}+O\left(\tau^{-2}\right) \tag{37}
\end{align*}
$$

from which we have

$$
\begin{equation*}
P_{\sigma_{\mathrm{G}}}(1)=c_{0}^{\mathrm{tot}}(0)\left(1-\frac{1}{\tau} \int_{0}^{1} B_{\mathrm{tot}}(s) d s\right)+O\left(\tau^{-2}\right) \tag{38}
\end{equation*}
$$

where

$$
\begin{equation*}
B_{\mathrm{tot}}(s)=\sum_{j \neq 0} \frac{\left.\left|\left\langle j_{\mathrm{tot}}(s)\right| \frac{d H_{\mathrm{tot}}(s)}{d s}\right| 0_{\mathrm{tot}}(s)\right\rangle\left.\right|^{2}}{\left(E_{\mathrm{tot}}^{(j)}(s)-E_{\mathrm{tot}}^{(0)}(s)\right)^{3}} \tag{39}
\end{equation*}
$$

Since the difference between $H_{\text {tot }}$ and $H_{\mathrm{SA}}$ is of $O\left(\tau^{-1}\right)$, we finally find

P_{\sigma_{\mathrm{G}}}(1)=c_{0}^{\mathrm{SA}}(0)\left(1-\frac{1}{\tau} \int_{0}^{1} B_{\mathrm{SA}}(s) d s\right)+O\left(\tau^{-2}\right) \tag{40}
\end{equation*}
$$

where

$$
\begin{equation*}
B_{\mathrm{SA}}(s)=\sum_{j \neq 0} \frac{\left.\left|\left\langle j_{\mathrm{SA}}(s)\right| \frac{d H_{\mathrm{SA}}(s)}{d s}\right| 0_{\mathrm{SA}}(s)\right\rangle\left.\right|^{2}}{E_{\mathrm{SA}}^{(j)}(s)^{3}}, \tag{41}
\end{equation*}
$$

and we have replaced $c_{0}^{\text {tot }}(1)$ by $c_{0}^{\mathrm{SA}}(1)$ because the difference of these coefficients is of $O\left(\tau^{-2}\right)$ according to eq. (33). We hereafter assume $c_{0}^{\mathrm{SA}}(0)=1$, which means that the initial state was the ground state of $H_{\mathrm{SA}}(0)$, i.e. the thermal equilibrium state at inverse temperature $\beta(0)$.

We have also taken it into account that the ground-state en-
ergy of $H_{\mathrm{SA}}$ is $E_{\mathrm{SA}}^{(0)}(s)=0$,

$$
\begin{equation*}
H_{\mathrm{SA}}(s)\left(e^{-\frac{1}{2} \beta(s) H_{0}} \sum_{\sigma}|\sigma\rangle\right)=0 \tag{42}
\end{equation*}
$$

In order to simplify the expression of $B_{\mathrm{SA}}(s)$, we take the derivative of this above equation with respect to $s$,

$$
\begin{align*}
& \frac{d H_{\mathrm{SA}}(s)}{d s}\left(e^{-\frac{1}{2} \beta(s) H_{0}} \sum_{\sigma}|\sigma\rangle\right) \\
& \quad=H_{\mathrm{SA}}(s)\left(\frac{1}{2} \dot{\beta}(s) H_{0} e^{-\frac{1}{2} \beta(s) H_{0}} \sum_{\sigma}|\sigma\rangle\right) \tag{43}
\end{align*}
$$

Projection of this equation to $\left|j_{\mathrm{SA}}(s)\right\rangle$ gives

$$
\begin{equation*}
\left\langle j_{\mathrm{SA}}(s)\right| \frac{d H_{\mathrm{SA}}(s)}{d s}\left|0_{\mathrm{SA}}(s)\right\rangle=\frac{E_{\mathrm{SA}}^{(j)} \dot{\beta}(s)}{2}\left\langle j_{\mathrm{SA}}(s)\right| H_{0}\left|0_{\mathrm{SA}}(s)\right\rangle, \tag{44}
\end{equation*}
$$

from which we have a simplified expression

$$
\begin{equation*}
B_{\mathrm{SA}}(s)=\frac{\dot{\beta}^{2}}{4} \sum_{j \neq 0} \frac{\left.\left|\left\langle j_{\mathrm{SA}}(s)\right| H_{0}\right| 0_{\mathrm{SA}}(s)\right\rangle\left.\right|^{2}}{E_{\mathrm{SA}}^{(j)}(s)} \tag{45}
\end{equation*}
$$

## 5. Convergence condition of simulated annealing

We are now ready to analyze the problems of the analysis in Somma et al.. ${ }^{10}$ They used the classical-quantum mapping described in Sect. 3 to rewrite classical non-equilibrium dynamics to quantum mechanics. Then they applied the conventional adiabatic condition for the real-time Schrödinger equation to derive a differential equation for the temperature variable of the original classical system. By solving this differential equation, they 're-derived' the Geman-Geman ${ }^{12}$ condition

$$
\begin{equation*}
T(t) \approx \frac{p N}{\log t} \tag{46}
\end{equation*}
$$

for the original classical dynamics of the Ising model to reach the ground state with probability close to unity in the limit of long time scale, $t \gg O(1 / \Delta)$, where $\Delta$ is $\left|\lambda_{1}(s)\right|=E_{\mathrm{SA}}^{(1)}(s)$ in our notation. The quantity in the numerator $p$ is an $O(1)$ constant.

There are two points of incompleteness in their argument. First, we have to use the imaginary-time Schrödinger equation to analyze classical dynamics, not the real-time Schrödinger equation. The adiabatic conditions of those two cases have subtle differences as discussed in detail in Sect. 2. The second problem is that they did not use the exact expression of the mapped Hamiltonian $H_{\mathrm{SA}}(s)$ defined in eq. (18), but replaced it by a simpler form with the coefficient of the transverse-field term being constant,

$$
\begin{equation*}
H_{q}^{\prime}=H-\chi \sum_{j} \sigma_{x}^{j} \tag{47}
\end{equation*}
$$

in their notation, where $\chi=e^{-p \beta}$.
Let us discuss the second point first since it is not a very serious one. According to eq. (18), the mapped Hamiltonian $H_{\mathrm{SA}}$ is a generalized transverse-field Ising model where the coefficient of the transverse field generally depends on the spin configuration. For example, the simplest case of the onedimensional Ising model is mapped to ${ }^{11}$

$$
H_{\mathrm{SA}}=\frac{N}{2}-\frac{1}{2} \tanh 2 \beta J \sum_{j=1}^{N} \sigma_{j}^{z} \sigma_{j+1}^{z}
$$

$$
\begin{equation*}
-\frac{1}{2 \cosh 2 \beta J} \sum_{j=1}^{N}\left(\cosh ^{2} \beta J-\sinh ^{2} \beta J \sigma_{j-1}^{z} \sigma_{j+1}^{z}\right) \sigma_{j}^{x} \tag{48}
\end{equation*}
$$

There exists $\sigma^{z}$-dependence in the coefficient of $\sigma^{x}$. Nevertheless, for the purpose of evaluation of the smallest energy gap, it is allowed to replace the coefficients by their smallest values, which depend on $\beta$ exponentially as $e^{-p \beta}(=\chi)$. The reason is that the evaluation of the smallest energy gap using the Hopf theorem, ${ }^{16}$ as mentioned in Somma et al. ${ }^{10}$ and as described in detail in Lemma 3.3 of Morita and Nishimori, ${ }^{13}$ uses only the smallest values of the off-diagonal elements. Thus the resulting general lower bound of the energy gap

$$
\begin{equation*}
\Delta(s)=E_{\mathrm{SA}}^{(1)}(s) \geq a \sqrt{N} e^{-2(p \beta(s)+c) N} \tag{49}
\end{equation*}
$$

where $a$ and $c$ are $N$-independent positive constants can be used in the present context.

The first point on the difference between imaginary-time and real-time Schrödinger dynamics must be taken more seriously, for which reason we have developed a theory of the previous sections. If we are allowed to ignore higher-order terms than the first order in $\tau^{-1}$, which itself needs verification rigorously speaking, the condition that the ground state probability is sufficiently close to unity is, according to eqs. (40) and (45),

$$
\begin{array}{r}
\left|\frac{1}{\tau} \int_{0}^{1} B_{\mathrm{SA}}(s) d s\right| \ll 1 \\
B_{\mathrm{SA}}(s)=\frac{\dot{\beta}^{2}}{4} \sum_{j \neq 0} \frac{\left.\left|\left\langle j_{\mathrm{SA}}(s)\right| H_{0}\right| 0_{\mathrm{SA}}(s)\right\rangle\left.\right|^{2}}{E_{\mathrm{SA}}^{(j)}(s)} . \tag{51}
\end{array}
$$

To satisfy this condition, the largest term in the above sum (with $j=1$ ) must be very small. If we replace the denominator of the expression for $B_{\mathrm{SA}}(s)$ by its smallest value of eq. (49) and the matrix element in the numerator by its upper bound, constant times the system size $p N$, we obtain the following condition

$$
\begin{equation*}
\frac{4 e^{2 c N} p^{2} N^{2}}{a \sqrt{N}} \int_{0}^{\tau}(\dot{\beta})^{2} e^{2 \beta p N} d t=\delta \ll 1 \tag{52}
\end{equation*}
$$

where we have restored the original time scale $t=s \tau$. The dot over $\beta$ is now for the derivative with respect to $t$. We next take the limit of infinite time scale, $\tau \rightarrow \infty$, which is the situation where the Geman-Geman condition has been derived originally. Then, only the upper bound of the above integral relation is changed to infinity provided that $\beta$ is a function of $t$ only, i.e. without $\tau$-dependence. For the resulting condition

$$
\begin{equation*}
\frac{4 e^{2 c N} p^{2} N^{2}}{a \sqrt{N}} \int_{0}^{\infty}(\dot{\beta})^{2} e^{2 \beta p N} d t=\delta \ll 1 \tag{53}
\end{equation*}
$$

to hold, the integrand should approach zero sufficiently quickly in the large- $t$ limit. More explicitly, $\beta(t)$ is expected to asymptotically satisfy the differential equation

$$
\begin{equation*}
\frac{4 e^{2 c N} p^{2} N^{2}}{a \sqrt{N}}(\dot{\beta})^{2} e^{2 \beta p N}=b^{2} t^{-1-\epsilon}(\epsilon>0) \tag{54}
\end{equation*}
$$

with sufficiently small $b$. By rewriting the above as

$$
\begin{equation*}
\frac{2 e^{c N} p N}{\sqrt{a \sqrt{N}}} \frac{d \beta}{d t} e^{\beta p N}=b t^{-(1+\epsilon) / 2} \tag{55}
\end{equation*}
$$

we solve it for $\beta(t)$ as

$$
\begin{equation*}
\frac{2 e^{c N}}{\sqrt{a \sqrt{N}}} e^{\beta p N}=\frac{2 b}{1-\epsilon} t^{(1-\epsilon) / 2}+c^{\prime} \tag{56}
\end{equation*}
$$

or

$$
\begin{align*}
\beta p N=-c N+ & \frac{1}{2} \log (a \sqrt{N}) \\
& -\log 2+\log \left(\frac{2 b}{1-\epsilon} t^{(1-\epsilon) / 2}+c^{\prime}\right) \tag{57}
\end{align*}
$$

If we keep only the leading-order term for large $t$,

$$
\begin{equation*}
\beta(t) \approx \frac{1-\epsilon}{2 p N} \log t \tag{58}
\end{equation*}
$$

This agrees with Somma et al. except for a small correction $\epsilon(>0)$. Notice that their $p N$ is our $2 p N$.

## 6. Conclusion

We have established adiabatic-theorem-like relations for the imaginary-time Schrödinger dynamics. This was done before in Ref. 13 for norm-conserved dynamics, which is not necessarily suitable for the analysis of the master equation of classical Markovian dynamics. De Grandi et al. ${ }^{14}$ also discussed this problem. We pushed their calculations further to obtain a more compact expression as seen in eqs. (12) and (14). The result was applied to studying the validity of the analysis in Ref. 10, who re-derived the convergence condition of simulated annealing to the target ground state. We have
found that their conclusion is correct, but the process to reach there needs more careful analyses as developed here. Our theoretical framework may also be used to shed new light on the analysis of finite-temperature slow dynamics of classical Ising models, e.g. spin glasses.
