# Spinor description of <br> $D=5$ massless low-spin gauge fields

#### Abstract

Spinor description for the curvatures of $D=5$ Yang-Mills, Rarita-Schwinger and gravitational fields is elaborated. Restrictions imposed on the curvature spinors by the dynamical equations and Bianchi identities are analyzed. In the absence of sources symmetric curvature spinors with $2 s$ indices obey first-order equations that in the linearized limit reduce to Dirac-type equations for massless free fields. These equations allow for a higher-spin generalization similarly to $4 d$ case. Their solution in the form of the integral over Lorentz-harmonic variables parametrizing coset manifold $S O(1,4) /(S O(1,1) \times I S O(3))$ isomorphic to the three-sphere is considered. Superparticle model that contains such Lorentz harmonics as dynamical variables, as well as harmonics parametrizing the two-sphere $S U(2) / U(1)$ is proposed. The states in its spectrum are given by the functions on $S^{3}$ that upon integrating over the Lorentz harmonics reproduce on-shell symmetric curvature spinors for various massless supermultiplets of $D=5$ space-time supersymmetry.


## 1 Introduction

Spinor approach to the description of $4 d$ gravitational field initiated by R. Penrose [1] can be extended in the uniform way to other gauge fields that manifests itself in the construction of the contour integral solutions of free massless field equations [2] using the features of twocomponent $S L(2, \mathbb{C})$ spinors and $S U(2,2)$ twistors [3]. Symmetric curvature spinors with $2 s$ indices that appear in such an approach generalize linearized Weyl curvature spinor $(s=2)$ and were shown later to play an important role in the formulation of higher spin gauge theories extending Einstein [4] and Weyl [5] gravity theories. Generalizations of such a construction relying on twistors related to higher-dimensional conformal symmetries encounter difficulties (see, e.g., [6], [7]) because of the more complicated algebra of multicomponent spinors and the fact that in dimensions greater than four the requirement of conformal invariance turns out very restrictive.

That is why an approach, in which only Lorentz invariance is manifest, looks more preferable. In Ref. [8] there was constructed on-shell integral representation ${ }^{2}$ for the curvatures of massless free fields in dimensions $D=3,4,6,10$ that uses Lorentz vector and spinor harmonics $\sqrt[3]{3}$ so that the Lorentz-symmetry is built in. The integrand is a function of the rectangular

[^0]block of the spinor harmonics matrix and the projection of the space-time coordinate vector onto a null vector constructed out of those spinor harmonics. The form of the harmonic measure ensures invariance of the integral under $S O(1,1) \times I S O(D-2)$ gauge symmetry so that the integration is actually performed over the sphere $S^{D-2}$. Resultant curvature spinors are functions of the space-time coordinates and satisfy Dirac-type equations.

In the present paper we generalize this approach to the $5 d$ case. To this end we work out in detail the spinor description for $D=5$ Yang-Mills (YM), Rarita-Schwinger (RS) and gravitational fields. Their irreducible curvature spinors are characterized and contents of the dynamical equations and Bianchi identities written in terms of the curvature spinors is analyzed. It is shown that in the absence of sources there remain non-zero only totally symmetric curvature spinors with $2 s$ indices that satisfy first-order differential equations. In the linearized limit they are shown to reduce to the equations for the corresponding linearized curvatures of free massless fields and allow straight-forward higher-spin generalization. These equations may also be viewed as a $5 d$ generalization of $4 d$ first-order equations [20], 21], [22] obeyed by the generalized Weyl curvature spinors. It should be noted that in the gravitiational literature the spinor form of the $D=5$ Weyl tensor was considered in 23$]^{4}$ and the decomposition of the Riemann tensor on the irreducible curvature spinors was obtained in [25]. Independently in Ref. [26] spinor form of the linearized Weyl tensor and its higherspin counterparts was used in the unfolded formulation of equations of motions for free fields on $A d S_{5}$ that correspond to the unitary irreducible representation of certain higher-spin generalization of $\operatorname{su}(2,2)$ algebra and its supersymmetric extension pertinent to $A d S_{5} / C F T_{4}$ duality $5^{5}$

Then we present integral representation for Weyl curvature spinors of arbitrary spin free fields that makes use of $D=5$ Lorentz harmonic $4^{6}$ and solves Dirac-type equations analogously to the cases considered in Ref. [8].

In the last part of the paper we propose a superparticle model characterized by the set of simple irreducible constraints, whose first-quantized states are given by the multiplets of harmonic functions that correspond to Weyl curvature spinors of the fields from various $D=5$ supermultiplets. The model includes $D=5$ spinor harmonics parametrizing the coset $S O(1,4) /(S O(1,1) \times I S O(3))$ and harmonics of Ref. 11] parametrizing the two-sphere among the dynamical variables. In the appendices are collected relevant properties of spinors, $\gamma$-matrices and Lorentz harmonics.

## 2 Curvature spinors of $D=5$ massless gauge fields and equations for them

In this section we find $\operatorname{Spin}(1,4)$ spinor form of the curvatures for YM, RS and gravitational fields, study in detail the restrictions imposed on the curvature spinors by field equations and Bianchi identities and consider their linearized limit.

### 2.1 Spinor form of YM field equations and Bianchi identities

We start with the YM case 7 YM curvature tensor $F_{m n}$ is converted into the spinor form by contracting vector indices with those of $D=5 \gamma$-matrices

Charge conjugation matrix $C_{\alpha \beta}$ that appears on the r.h.s. is antisymmetric (see Appendix A for spinor algebra in 5 dimensions). For real Yang-Mills field symmetric curvature spinor $F_{\alpha \beta}=F_{\beta \alpha}$ satisfies Hermiticity condition

and thus has 10 real components. Spinor and vector representations of the curvature can be converted into one another using the relations

where $\nabla_{\alpha}{ }^{\beta}=\gamma^{m}{ }_{\alpha}{ }^{\beta} \nabla_{m}$ is the spinor form of the YM covariant derivative. Bianchi identity $\nabla \wedge F=0$ transforms into equation

Combining Eqs. (5) and (6) yields that the curvature spinor satisfies

In the linearized limit one obtains free spin- 1 field equation

### 2.2 Spinor form of RS field equations and Bianchi identities

In general the RS field $\Psi_{m \gamma}{ }^{a}$ carries Lorentz vector and spinor indices, we additionally endow it with the index $a$ to account for the case of gravitini fields in $N$-extended supergravity multiplets. Curvature spin-tensor

similarly to the YM curvature tensor can be converted to the spinor form

is symmetric in the first two indices that are therefore separated from the last one by vertical line and satisfies Hermiticity condition

where $\Omega_{a b}=-\Omega_{b a}$ is the symplectic metric tensor 9 It has $40 N$ components and can be presented as the sum of two summands having $20 N$ components each

Since its symmetry is the same as that of $\Phi_{\alpha(2) \mid \beta}{ }^{a}$, decomposition analogous to (13) applies also to $\varrho_{\alpha(2) \mid \beta}{ }^{a}$. Provided RS equation (19) is satisfied, the totally symmetric part $\varrho_{\alpha(3)}{ }^{a}$ is expressed in terms of the totally symmetric part of the curvature spinor (14)

### 2.3 Spinor form of gravitational field equations and Bianchi identities

This section culminates in a discussion of $D=5$ Einstein gravity. Spinor form of the Riemann tensor

can be viewed as the 'square' of the corresponding spinor form of the YM curvature (1). Riemann curvature spinor $R_{\alpha(2) \mid \beta(2)}$ is symmetric in the first and the second pairs of indices and under their interchange $R_{\alpha(2) \mid \beta(2)}=R_{\beta(2) \mid \alpha(2)}$. Inverse relation gives the Riemann tensor in terms of the Riemann spinor

Consider the properties of the Riemann curvature spinor. $R_{\alpha(2) \mid \beta(2)}$ has 55 components, as the Riemann tensor, and is reducible. It can be represented as the sum

has the same symmetries as $R_{\alpha(2) \mid \beta(2)}$ but its symmetrized part vanishes leaving 20 independent components. $\widehat{R}_{\alpha(2) \mid \beta(2)}$ can be further decomposed into three irreducible spinors

4-index irreducible curvature spinor $\bar{R}_{\alpha(2) \mid \beta(2)}$ has the same symmetries as $\widehat{R}_{\alpha(2) \mid \beta(2)}$ but additionally all possible traces that one can take using the charge conjugation matrix $C_{\gamma \delta}$ vanish thus leaving 14 independent components. Note that defined in Ref. [25] curvature spinor $\Omega_{\alpha_{1} \beta_{1} \mid \alpha_{2} \beta_{2}}$, that is antisymmetric in the first and the second pairs of indices, admits the following expression in terms of $\bar{R}_{\alpha(2) \mid \beta(2)}$

\end{equation*}

2-index curvature spinor $\widetilde{R}_{\alpha[2]}$ being antisymmetric and traceless has 5 components, while the scalar $\hat{R}$ equals

Substitution of (33) into (28) allows to express spinor form of the Ricci tensor via the irreducible curvature spinors

The contribution of the 2-index curvature spinor $\widetilde{R}_{\alpha[2]}$ drops out because of the relation

upon taking into account the realization of the totally antisymmetric 4-index spinor in terms of the charge conjugation matrices

\mathcal{E}_{\alpha[2] \beta[2]}=\bar{R}_{\alpha_{1} \beta_{2} \mid \alpha_{2} \beta_{1}}-\bar{R}_{\alpha_{1} \beta_{1} \mid \alpha_{2} \beta_{2}}+\frac{3}{20} \widehat{R}\left(C_{\alpha_{1} \alpha_{2}} C_{\beta_{1} \beta_{2}}-2 C_{\alpha_{1} \beta_{1}} C_{\alpha_{2} \beta_{2}}+2 C_{\alpha_{1} \beta_{2}} C_{\alpha_{2} \beta_{1}}\right) \tag{43}
\end{equation*}

So that vacuum Einstein equations yield $\bar{R}_{\alpha(2) \mid \beta(2)}=\hat{R}=0$ leaving Weyl curvature spinor as the only non-vanishing quantity.

We conclude the discussion of $D=5$ Einstein gravity with the analysis of the spinor form of the second Bianchi identity

4-index spinor $B_{\alpha(2) \mid \beta(2)}$ is symmetric in the first and the second pairs of indices. It can be presented as the sum of two 4-index spinors symmetric and antisymmetric under permutation of the pairs of indices

A_{\alpha(2) \mid \beta(2)} & =\frac{1}{2}\left(\mathscr{D}_{\alpha_{1}}{ }^{\lambda} R_{\lambda \alpha_{2} \mid \beta(2)}+\mathscr{D}_{\alpha_{2}}{ }^{\lambda} R_{\lambda \alpha_{1} \mid \beta(2)}-\mathscr{D}_{\beta_{1}}{ }^{\lambda} R_{\lambda \beta_{2} \mid \alpha(2)}-\mathscr{D}_{\beta_{2}}{ }^{\lambda} R_{\lambda \beta_{1} \mid \alpha(2)}\right) . \tag{46c}

$S_{\alpha(2) \mid \beta(2)}$ has exactly the same symmetries as the Riemann curvature spinor. So its decomposition into irreducible spinors parallels that of $R_{\alpha(2) \mid \beta(2)}$ (cf. Eqs. (30)-(33)). First one singles out totally symmetric part and that, whose symmetrization gives zero,

while $\widehat{S}_{\alpha(2) \mid \beta(2)}$ - by $\widehat{R}_{\alpha(2) \mid \beta(2)}$ (32)

is symmetric in the last three indices but its symmetrization over all the four indices gives zero. $\widehat{S}_{\alpha(2) \mid \beta(2)}$ analogously to (33) can be represented as the sum

& +\frac{1}{20} \widehat{S}\left(C_{\alpha_{1} \beta_{1}} C_{\alpha_{2} \beta_{2}}+C_{\alpha_{1} \beta_{2}} C_{\alpha_{2} \beta_{1}}\right)
\end{align*}
$$

Irreducible spinors on the r.h.s. have the same symmetries as corresponding curvature spinors on the r.h.s. of (33). Explicit expressions for them via the covariant derivatives of the curvature spinors are found to be

& +\frac{1}{12} \mathscr{D}^{\lambda \mu}\left(C_{\alpha_{1} \beta_{1}} \bar{R}_{\lambda \alpha_{2} \mid \mu \beta_{2}}+C_{\alpha_{1} \beta_{2}} \bar{R}_{\lambda \alpha_{2} \mid \mu \beta_{1}}+C_{\alpha_{2} \beta_{1}} \bar{R}_{\lambda \alpha_{1} \mid \mu \beta_{2}}+C_{\alpha_{2} \beta_{2}} \bar{R}_{\lambda \alpha_{1} \mid \mu \beta_{1}}\right)=0, \\
\widetilde{S}_{\alpha[2]} & =\frac{1}{2} \mathscr{D}^{\lambda \mu} \bar{R}_{\lambda \alpha_{1} \mid \mu \alpha_{2}}+\frac{3}{10} \mathscr{D} \alpha[2] \widehat{R}=0,  \tag{55}\\
\widehat{S} & =0

modulo terms proportional to the covariant derivative of the 2 -index curvature spinor $\mathscr{D} \widetilde{R}$ that vanish when the spinor form of the algebraic Bianchi identity (41) is taken into account. Thus symmetric under permutation of the pairs of indices part of the second Bianchi identity (46b) contains 54 non-trivial equations for the curvature spinors. For vacuum space-times there remain only 35 equations given by vanishing of (50).

Spinor $A_{\alpha(2) \mid \beta(2)}$ defined in (46c) can be decomposed into the traceless part and that contributing to the trace

Symmetric 2-index spinor $A_{\alpha(2)}$ vanishes, when the algebraic Bianchi identity is satisfied. For the traceless part we obtain

& +\frac{1}{2}\left(\mathscr{D}_{\alpha_{1}}{ }^{\lambda} \bar{R}_{\lambda \alpha_{2} \mid \beta(2)}+\mathscr{D}_{\alpha_{2}}{ }^{\lambda} \bar{R}_{\lambda \alpha_{1} \mid \beta(2)}-\mathscr{D}_{\beta_{1}}{ }^{\lambda} \bar{R}_{\lambda \beta_{2} \mid \alpha(2)}-\mathscr{D}_{\beta_{2}}{ }^{\lambda} \bar{R}_{\lambda \beta_{1} \mid \alpha(2)}\right)=0 . \tag{57}

For vacuum space-times it amounts to the vanishing of $\mathcal{W}_{\alpha \mid \beta(3)}$ so that recalling (52) we come to the following equation for the Weyl curvature spinor

Eq. (59) is the spin-2 counterpart of Eqs. (8), (24) for spin- 1 and spin- $3 / 2$ fields. In fact the sequence can be continued to accommodate (symmetric) higher-spin free fields. One can define a higher-spin generalization of the Weyl curvature spinor $W_{\alpha(2 s)}$ that should satisfy the equation generalizing (59)

This equation encompasses both low- and higher-spin cases and applies to arbitrary (half)integer $s \geq 1 / 2$. It can be shown [30] that for higher-spin fields on-shell there remains non-zero only the Weyl tensor similarly to the low-spin ones.

## 3 On-shell integral representation for Weyl curvature spinors of $D=5$ massless gauge fields

Equation (60) can be solved using the integral formula that maps functions $\phi_{i(2 s)}$ on $S^{3}$ that carry $2 s$ symmetrized indices of the fundamental representation of $S U(2)$ (and possibly
indices of the $R$-symmetry group representations) to Weyl curvature spinors of spin- $s$ fields in Minkowski space. The role of mediator is played by the $D=5$ Lorentz-harmonic spinor variables. Present section aims at giving the details of such a construction being the generalization of that elaborated in Ref. [8] for the string-theoretic dimensions $D=3,4,6,10,10$ To this end we start by recapitulating necessary properties of $D=5$ Lorentz-harmonic variables.

Vector Lorentz harmonics are given by $5 \times 5$ matrix $n_{m}{ }^{\mathbf{m}}$ subject to the constraint

so that it takes value in the Lorentz group $S O(1,4)$. Light-face indices are acted upon by the left $S O(1,4)_{L}$ rotations, while the bold-face ones transform under the right $S O(1,4)_{R}$ group, whose $S O(1,1) \times I S O(3)$ subgroup will be gauged. Taking the first and, e.g., the last columns of the harmonic matrix allows to define two light-like vectors

n_{m}{ }^{ \pm 2}=n_{m}{ }^{\mathbf{0}} \pm n_{m}{ }^{\mathbf{5}}: \quad n_{m}{ }^{ \pm 2} n^{m \pm 2}=0, \quad n_{m}{ }^{ \pm 2} n^{m \mp 2}=-2 . \tag{62}
\end{equation*}

This introduces decomposition of the vector harmonic matrix into three blocks

\end{equation*}

 ponents of the matrix $n_{m}{ }^{\mathbf{m}}$ transform in the following manner under infinitesimal $S O(1,4)_{R}$ rotation with parameters $L^{\mathbf{m n}}=\left(L^{+\mathbf{2 - 2}}, L^{ \pm \mathbf{2 I}}, L^{\mathbf{I J}}\right)$

$$
\begin{gather*}
\delta n_{m}{ }^{ \pm 2}= \pm L^{+2-2} n_{m}{ }^{ \pm 2}+L^{ \pm 2 \mathbf{I}} n_{m}{ }^{\mathbf{I}} \\
\delta n_{m}{ }^{\mathbf{I}}=-\frac{1}{2}\left(L^{+2 \mathbf{I}} n_{m}{ }^{-\mathbf{2}}+L^{-2 \mathbf{I}} n_{m}{ }^{+\mathbf{2}}\right)+L^{\mathbf{I J}} n_{m}{ }^{\mathbf{J}} \tag{64}
\end{gather*}
$$

Due to zero norm any of the vectors (62) can be set proportional to $D=5$ massless particle's momentum. For instance, $n_{m}{ }^{+2}$ is invariant under the transformations with parameters $L^{\mathrm{IJ}}$ and $L^{-\mathbf{2 I}}$, and covariant under those with the parameter $L^{+\mathbf{2 - 2}}$ in (64) corresponding to the $S O(1,1) \times I S O(3)$ subgroup of $S O(1,4)_{R}$. This subgroup can be gauged, so that the vector harmonic matrix will parametrize the $S O(1,4) / S O(1,1) \times I S O(3)$ coset-space isomorphic to the 3 -sphere. More explicitly one can write $n_{m}^{+2}=\left(q^{+2}, q^{+2} k_{\hat{m}}\right)$ with the Euclidean 4 -vector $k_{\hat{m}}: k^{2}=1$ parametrizing $S^{3}$.

Like in arbitrary dimension, $S O(1,4)$-valued matrix can be presented as the 'square' of the $\operatorname{Spin}(1,4)$ matrix $v^{\alpha \mu}$

\begin{equation*}
n_{m}{ }^{\mathrm{m}}=\frac{1}{4} v^{\alpha \mu} \gamma_{m \alpha}{ }^{\beta} \gamma^{\mathrm{m}}{ }_{\mu}{ }^{\nu} v_{\beta \nu}, \quad v_{\beta \nu}=C_{\beta \gamma} C_{\nu \lambda} v^{\gamma \lambda} . \tag{65}
\end{equation*}
$$

In analogy with the vector-harmonic matrix, the light-face index of $v^{\alpha \mu}$ transforms under the spinor representation of $S O(1,4)_{L}$ and the bold-face index under that of $S O(1,4)_{R}$. Orthonormality conditions (61) are then satisfied by virtue of six harmonicity conditions imposed on the $4 \times 4$ spinor-harmonic matrix

where $C_{\alpha \beta}$ and $C^{\mu \nu}$ are charge conjugation matrices acting on the $S O(1,4)_{L}$ and $S O(1,4)_{R}$ spinor indices respectively. Harmonicity conditions ensure that $v^{\alpha \mu}$ takes value in $\operatorname{Spin}(1,4)$.

[^4]Similarly to the decomposition (63) of the vector harmonic matrix on $S O(1,1) \times S O(3)$ covariant blocks spinor harmonics decompose into the following $4 \times 2$ blocks

where $i$ is the $S U(2)$ fundamental representation index. In terms of these $4 \times 2$ blocks null components of the vector harmonics $n_{m}{ }^{ \pm 2}$ acquire the form

More details on the properties of $D=5$ spinor harmonics can be found in Appendix B.
Harmonic variables can be used to construct $S O(1,4)_{L}$-invariant Cartan 1-forms. Those taking value in the Lie algebra of $S O(1,4)_{R}$ are defined by the relations

They further decompose on 4 irreducible components under the $S O(1,1) \times S O(3)$ subgroup of $S O(1,4)_{R}$. Explicit expressions for them in terms of the spinor harmonics will be used below

Proceed now to discussion of the integral representation for the Weyl curvature spinors of the gauge fields. It has the following form

Harmonic measure is given by the 3 -form

It is $I S O(3)$ invariant (corresponding parameters in (64) are $L^{-2 \boldsymbol{I}}$ and $L^{\boldsymbol{I J}}$ ) and $S O(1,1)$ covariant so that the integral is $S O(1,1) \times I S O(3)$ invariant. By appropriate parametrization of harmonics it reduces to the standard measure on $S^{3}$ written via angle variables. Integrand

transforms homogeneously under $S O(1,1)$ with weight $-6-2 s$ to compensate contributions of harmonic measure and spinor harmonics and depends on the space-time coordinates only through the projection $x^{+2}=x^{m} n_{m}^{+2}$. This ensures that $W_{\alpha(2 s)}$ defined by (72) satisfies Eq. (60)) for $s>0$ and $\square W_{\alpha(2 s)}=0$ for $s \geq 0$. Note that the integral representation analogous to that of Eq. (72) can also be constructed using $v_{\alpha}{ }^{-i}$ spinor. In that case homogeneity degree in $v_{\alpha}^{-i}$ of the integrand should be opposite to that in (74).

## 4 Massless particle model in doubly harmonic superspace

In this section we discuss a toy model of the massless superparticle, whose canonical quantization yields functions (74) with various values of $s$ assembled into multiplets of $D=5$ Poincare supersymmetry. It is characterized by the following action ${ }^{11}$

& +\Omega_{\tau}^{+2,0 I} y^{-2,0 I}+\omega_{\tau}^{0,0} \pi^{+,-a} \theta^{-,+}{ }_{a}+\omega_{\tau}^{0,+2} y^{0,-2}  \tag{75}\\
& +q \Omega_{\tau}^{+2-2,0}+\ell \omega_{\tau}^{0,0} .

Coordinate $x^{+2,0}$ (denoted as $x^{+2}$ in section (3) upon quantization will become the argument of the superparticle's wave-function (cf. (74)), Grassmann odd coordinate $\theta^{-,+}{ }_{a}$ in addition to $S O(1,1)$ and $U(1)$ weights of unit modulus carries index $a=1, \ldots, N$ labeling $D=5$ supersymmetries; $p^{-2,0}$ and $\pi^{+,-a}$ are their canonical momenta. Action (75) also contains four non-dynamic bosonic coordinates $y^{-2,0 I}$ and $y^{0,-2}$ and two sets of harmonic variables. $\operatorname{Spin}(1,4)$ Lorentz harmonics $v^{\alpha \pm, 0 i}$ enter via the world-line projections of Cartan forms $\Omega_{\tau}^{+2-2,0}$ and $\Omega_{\tau}^{+2,0 I}$ (cf. (71)). Due to the $I S O(3)$ gauge symmetry with parameters $L^{0,0 I J}(\tau)$ and $L^{-2,0 I}(\tau)$, under which variables entering the superparticle's Lagrangian transform as

Lorentz harmonics parametrize the $S O(1,4) / I S O(3)$ manifold. The action also depends on another set of harmonics $w^{0, \pm i}$ via the world-line projections of the Cartan forms

They are subject to the harmonicity condition

that is nothing but the unimodularity condition ensuring that harmonic matrix ( $w^{0,+i}, w^{0,-i}$ ) takes value in the $S U(2)$ group. Due to the gauge symmetry of the action (75) with the parameter $\Lambda^{0,-2}(\tau)$

these harmonics parametrize $S^{2}$ manifold. Two last summands in (75) are harmonic $1 d$ Wess-Zumino terms. The first depends on the Lorentz harmonics and the second - on the

[^5]$S U(2) / U(1)$ harmonics ${ }^{12}$ Values of the numerical coefficients $q$ and $\ell$ will be determined below in terms of $N$ and the maximal spin in the supermultiplet.

Systematic treatment of gauge symmetries is achieved in the framework of the canonical approach to the discussion of which we now turn. Definition of canonical momenta results in the following primary constraints

where $P^{+2,0 I}$ and $P^{0,+2}$ are momenta conjugate to $y^{-2,0 I}$ and $y^{0,-2}, P_{\alpha}{ }^{\mp, 0}{ }_{i}$ are momenta for the Lorentz harmonics $v^{\alpha \pm, 0 i}$ and $P^{0, \mp}{ }_{i}$ - for the $S U(2)$ harmonics $w^{0, \pm i}$. This set of constraints has to be supplemented by the harmonicity conditions (69) and (79) that in the canonical approach should be treated as weak equalities in the sense of Dirac. Since it is convenient to consider them holding as usual equalities, i.e. in the strong sense according to Dirac, the following technical trick can be applied. It is possible to single out part of the constraints on the harmonic momenta that form with the harmonicity conditions conjugate pairs of the second-class constraints and construct associated Dirac brackets. Remaining constraints on the harmonic momenta take value in the right Lorentz algebra and are called covariant momenta. Pivotal property of such Dirac brackets is that on the subspace of the harmonic phase-space spanned by harmonics themselves and covariant momenta they coincide with the Poisson brackets, while remaining constraints including the harmonicity conditions are then fulfilled in the strong sense ${ }^{13}$

Consider in more detail $4+1$ constraints (81e), (81f) and (79) in the sector of $S U(2)$ harmonics. Projecting constraints (81e) and (81f) onto the harmonics and taking their linear combinations it is easy to find that the constraint

forms with the harmonicity condition (79) the pair of the second-class constraints that can be converted into strong equalities by introducing Dirac brackets. So that in the sector of $S U(2)$ harmonics there remain three constraints corresponding to covariant momenta generating the $s u(2)_{R}$ algebra

[^6]In view of the constraints (81b) and (83c) canonical pair $\left(P^{0,+2}, y^{0,-2}\right)$ can be excluded from the consideration and in the sector of $S U(2)$ harmonics there remain just two constraints (83a) and (83b). The latter is the generator of the gauge symmetry (80).

In the sector of Lorentz harmonics there are $16+6$ constraints (81c), (81d) and (69). Like in the case of $S U(2)$ harmonics, one can single out six $S O(1,4)_{L}$-invariant constraints from (81c), (81d) that form conjugate pairs of the second-class constraints with the harmonicity conditions (69). 10 remaining constraints constitute covariant momenta taking value in the so $(1,4)_{R}$ algebra

One observes that due to the constraints (81a) and (84c) canonical variables ( $P^{+2,0 I}, y^{-2,0 I}$ ) can be excluded from consideration. So that in the sector of Lorentz harmonics one is left with seven constraints (84a), (84b), (84d). Constraints (84d) and (84b) are the generators of the discussed above gauge transformations (76) and (77) respectively.

Thus the constraints (83a), (83b) and (84a), (84b), (84d) form the set of the first-class constraints of our model. Associated quantum operators are imposed on the superparticle's wave function that in the coordinate representation depends on $x^{+2,0}, v^{\alpha \pm, 0 i}, w^{0, \pm i}$ and $\theta^{-,+}{ }_{a}$. Conjugate momenta then act as differential operators

Classical generator of the $S O(1,1)$ gauge symmetry (84a) in such a realization transforms into the following Hermitian operator

where $c_{s o(1,1)}=-1-4 q-\frac{N}{2}$ is an ordering constant. It is nothing but the dilatation operator acting on the variables with non-zero $S O(1,1)$ weights. Similarly quantum $U(1)$ generator associated with the constraint (83a) can be brought to the form

where $c_{u(1)}=\ell+\frac{N}{2}$. It 'measures' the $U(1)$ charges of the components of superparticle's wave function. Quantum operators corresponding to other constraints (84b), (84d) and (83b) are
free from the ordering ambiguities and can be defined in the following way

These operators act on the wave function that admits series expansion in $\theta$

where $\theta^{-k,+k}{ }_{a[k]} \equiv \theta^{-,+}{ }_{a_{1}} \theta^{-,+}{ }_{a_{2}} \cdots \theta^{-,+}{ }_{a_{k}}$ and the component functions depend on $x^{+2,0}$ and harmonics. In particular, one finds that for any $0 \leq k \leq N$

and the operator (89b) determines how the wave function components transform under the $S O(3) \sim S U(2)$. The first equation implies that the wave function is independent of $v^{\alpha-, 0 i}$ (cf. [8]) and the second allows to factorize the dependence on the $S U(2)$ harmonics. Namely, for any function with non-negative value of the $U(1)$ weight $c_{u(1)}-k \geq 0$ it was proved in [11] that the solution of Eq. (91b) is

where $w^{0,+i\left(c_{u(1)}-k\right)} \equiv w^{0,+i_{1}} w^{0,+i_{2}} \cdots w^{0,+i_{c_{u(1)}-k}}$, while if the $U(1)$ weight is negative the function $\varphi^{c_{s o(1,1)}+k, c_{u(1)}-k a[k]}$ vanishes. As a result component functions $\varphi^{c_{s o(1,1)}+k, 0 a[k]}{ }_{i\left(c_{u(1)}-k\right)}$ depend on $x^{+2,0}$ and $v^{\alpha+, 0 i}$ only. In order to identify them with the integrand in (72) the following relation between the ordering constants in (87) and (88) should hold

and then $c_{u(1)}-k=2 s_{k}$, where $s_{k}$ is the spin of the corresponding gauge field. Using that the field with the highest value of spin in the multiplet $s_{\max }$ corresponds to the leading component in the expansion (90), allows to express coefficients at the Wess-Zumino terms $q$ and $\ell$ through $s_{\text {max }}$.

Consider in more detail the case of $N=2$ supersymmetry. From equations

If the value of the maximal spin in the supermultiplet is set to $1 / 2$ we get two non-zero components of the wave function $\varphi^{-7,1}\left(x^{+2,0}, v^{\alpha+, 0 i}\right)$ and $\varphi^{-6,0 a}\left(x^{+2,0}, v^{\alpha+, 0 i}\right)$ corresponding to the component fields of $N=2$ hypermultiplet. For $s_{\max }=1$ one obtains three component
fields on $S^{3} \varphi^{-8,2}, \varphi^{-7,1 a}$ and $\varphi^{-6,0 a[2]}$ that correspond to the component fields of $N=2$ Maxwell supermultiplet. Similarly setting $s_{\max }=2$ yields the on-shell field strengths of $N=2$ supergravity multiplet $\left(W_{\alpha(4)}, \Phi_{\alpha(3)}{ }^{a}, F_{\alpha(2)}\right)\left(x^{m}\right)$ [34]. Choosing other values of the maximal spin gives massless higher-spin multiplets of $D=5 N=2$ supersymmetry. The model (75) is also capable to describe $D=5 N=4$ supergravity multiplet for $q=7 / 4$ and $\ell=2$. Corresponding components of the superparticle's wave function and associated fields on the space-time are listed in the Table.

## 5 Conclusion

Gauge invariant curvatures of YM and gravitational fields in $5 d$ are known to admit equivalent spinor representation similarly to corresponding $4 d$ fields. In particular, $D=5$ Riemann tensor amounts to the set of four irreducible (multi-index) spinors. We analyzed restrictions imposed by the dynamical equations and Bianchi identities on the curvature spinors for YM, gravitational and free massless spin- $3 / 2$ fields. In analogy with the $4 d$ case in the absence of sources there remain non-zero only symmetric curvature spinors with $2 s$ indices given by the Weyl curvature spinor and its lower-spin counterparts. These spinors satisfy first-order equations reducing in the linearized limit to Dirac-type equations that can be written in the uniform way for various spins. This suggests that they are the first members of the sequence of equations for higher-spin Weyl curvature spinors. These equations are solved using the integral representation based on writing the null-momentum as the square of spinors that are blocks of the spinor harmonic matrix parametrizing the coset $S O(1,4) /(S O(1,1) \times I S O(3))$ being the realization of the $S^{3}$ manifold and the integration is actually performed over this three-sphere. This integral representation for on-shell Weyl curvature spinors is the $D=5$ extension of that in dimensions $D=3,4,6,10$ described in [8]. The possibility to elaborate such an integral representation for Weyl curvature spinors in various dimensions and for fields of various spins is due to fact that only Lorentz symmetry is manifest. So it would be interesting to look for generalizations to the fields over curved backgrounds, particularly such as $(A) d S$ ones, and in other dimensions including the string/M-theoretic ones. Less straight-forward but potentially more promising is to promote proposed superparticle model to the string one, whose correlation functions would reproduce (tree-level) scattering amplitudes in $D=5 \mathrm{YM} /$ gravity theories similarly to the (ambi)twistor-string models [35], [36], [37], [38], [39]. The fact that spinorial (vectorial) constituents are Lorentz harmonics makes feasible also a generalization to other dimensions like in the case of the ambitwistor string of Ref. [38, in which Lorentz harmonics enter implicitly [40].

## Appendix A. $\gamma-$ matrices and spinors

$\gamma$-matrices $\gamma^{m}{ }_{\alpha}{ }^{\beta}(m=0,1,2,3,5, \alpha, \beta=1,2,3,4)$ satisfy the defining relations of the $D=5$ Clifford algebra

$$
\begin{equation*}
\gamma_{\alpha}^{m}{ }_{\alpha}^{\delta} \gamma^{n}{ }_{\delta}{ }^{\beta}+\gamma^{n}{ }_{\alpha}{ }^{\delta} \gamma^{m}{ }_{\delta}{ }^{\beta}=2 \eta^{m n} \delta_{\alpha}^{\beta} . \tag{96}
\end{equation*}
$$

Positions of the spinor indices can be changed with the aid of the charge conjugation matrices $C^{\alpha \beta}$ and $C_{\alpha \beta}: C^{\alpha \delta} C_{\delta \beta}=\delta_{\beta}^{\alpha}$ according to the rule

\psi^{\alpha}=C^{\alpha \beta} \psi_{\beta}, \quad \chi_{\alpha}=C_{\alpha \beta} \chi^{\beta} \tag{97}
\end{equation*}

Both charge conjugation and $\gamma$-matrices are antisymmetric in 5 dimensions.
Subsequent relations are widely used in the main text

$$
\begin{equation*}
\left(C^{\alpha \beta}\right)^{*}=-C_{\alpha \beta}, \quad\left(\gamma^{m}\right)^{\dagger}=\gamma^{0} \gamma^{m} \gamma^{0}, \quad\left(\gamma_{\alpha}^{m}{ }_{\alpha}^{\beta}\right)^{T}=-\gamma^{m \beta}{ }_{\alpha} \tag{98}
\end{equation*}
$$

where $\gamma^{m \beta}{ }_{\alpha}=-C^{\beta \gamma} \gamma^{m}{ }_{\gamma}{ }^{\delta} C_{\delta \alpha}$ and minus sign reflects antisymmetry of the charge conjugation matrices.

In discussion of the Lorentz harmonics used is the light-cone basis for $\gamma$-matrices, in which only $S O(1,1) \times S U(2)$ covariance is manifest. Let 0 and 5 be the light-cone directions, then $\gamma$-matrices exhibit the direct product structure

\gamma^{0}{ }_{\mu}{ }^{\nu}=\rho^{\mathrm{t}}{ }_{(\mu)}{ }^{(\nu)} \delta_{i}^{j}, \quad \gamma^{I}{ }_{\mu}{ }^{\nu}=\rho^{\mathrm{ts}}{ }_{(\mu)}{ }^{(\nu)} \tau^{I}{ }_{i}{ }^{j}, \quad \gamma^{5}=\rho^{\mathrm{s}}{ }_{(\mu)}{ }^{(\nu)} \delta_{i}^{j} . \tag{99}
\end{equation*}
$$

Non-relativistic Pauli matrices satisfy

$$
\begin{equation*}
\tau_{i}^{I}{ }_{i} \tau^{J}{ }_{k}{ }^{j}+\tau_{i}^{J}{ }_{i}{ }^{k} \tau^{I}{ }_{k}{ }^{j}=2 \delta^{I J} \delta_{i}^{j} . \tag{100}
\end{equation*}
$$

$\rho^{\mathrm{t}}$ and $\rho^{\mathrm{s}}$ are timelike and spacelike $\gamma$-matrices in $D=1+1$ dimensions

$$
\rho_{(\mu)}^{\mathrm{t}}{ }_{(\nu)}^{(\nu)}=\left(\begin{array}{cc}
0 & i  \tag{101}\\
i & 0
\end{array}\right), \quad \rho_{(\mu)}^{\mathrm{s}}{ }_{(\nu)}^{(\nu)}=\left(\begin{array}{cc}
0 & i \\
-i & 0
\end{array}\right)
$$

and $\rho^{\mathrm{ts}}=\rho^{\mathrm{t}} \rho^{\mathrm{s}}$. Similarly charge conjugation matrices acquire the direct product form

C^{\mu \nu}=C^{(\mu)(\nu)} \varepsilon^{i j}, \quad C_{\mu \nu}=C_{(\mu)(\nu)} \varepsilon_{i j} \tag{102}
\end{equation*}

where antisymmetric unit matrices $\varepsilon^{i j}$ and $\varepsilon_{i j}$ :

\varepsilon^{12}=\varepsilon_{21}=1, \quad\left(\varepsilon^{i j}\right)^{\dagger}=\varepsilon_{j i}, \quad \varepsilon^{i j} \varepsilon_{j k}=\delta_{k}^{i} \tag{103}

are used to move $S U(2)$ indices as $\psi^{i}=\varepsilon^{i j} \psi_{j}, \chi_{i}=\varepsilon_{i j} \chi^{j}$, and $D=1+1$ charge conjugation matrices equal

C^{(\mu)(\nu)}=\left(\begin{array}{cc}
0 & i  \tag{104}\\
i & 0
\end{array}\right), \quad C_{(\mu)(\nu)}=\left(\begin{array}{cc}
0 & -i \\
-i & 0
\end{array}\right)
$$

so that

\rho_{(\mu)(\nu)}^{\mathrm{t}}=\left(\begin{array}{ll}
1 & 0  \tag{105}\\
0 & 1
\end{array}\right), \quad \rho_{(\mu)(\nu)}^{\mathrm{s}}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right)
$$

as desired for expressing light-cone components of the vector Lorentz harmonics in terms of the spinor ones.

## Appendix B. Some properties of $D=5$ Lorentz harmonics

Discussion of the properties of the spinor harmonics $v^{\alpha \mu}$ in this section complements that in the main text.

Spinor harmonics satisfy generalized Majorana condition

\begin{equation*}
\bar{v}^{\alpha \boldsymbol{\mu}}=\left(v_{\beta \nu}\right)^{\dagger} \gamma^{0}{ }_{\beta}^{\alpha} \gamma_{\nu}^{0}{ }^{\boldsymbol{\mu}}=\left(C^{\alpha \beta} C^{\boldsymbol{\mu}} v_{\beta \boldsymbol{\nu}}\right)^{T}=\left(v^{\alpha \boldsymbol{\mu}}\right)^{T} \tag{106}
\end{equation*}
$$

reducing the number of (real) independent components from 32 to 16. Other forms of this condition are

$$
\begin{equation*}
\left(v_{\alpha \mu}\right)^{*}=\gamma^{0 \alpha}{ }_{\beta} \gamma^{0 \mu}{ }_{\nu} v^{\beta \nu}, \quad\left(v^{\alpha \mu}\right)^{*}=\gamma_{\alpha}^{0}{ }_{\alpha} \gamma^{0}{ }_{\mu}{ }^{\nu} v_{\beta \nu} \tag{107}
\end{equation*}
$$

can be used to check reality of the vector harmonics realized in terms of the spinor ones (65).
The light-cone basis realization for $D=5 \gamma$-matrices implies decomposition of $\operatorname{Spin}(1,4)$ spinor on $S O(1,1) \times S U(2)$ representations $\mathbf{4}=\mathbf{2}_{+} \oplus \mathbf{2}_{-}$. Applied to the index that transforms under $S O(1,4)_{R}$ introduces decomposition of the spinor harmonic matrix on $4 \times 2$ blocks (cf. Eq. (67))

$$
\begin{equation*}
v^{\alpha \mu}=v^{\alpha(\mu) i}=\binom{v^{\alpha+i}}{v^{\alpha-i}}, \quad v^{\alpha}{ }_{(\mu) i}=C_{(\mu)(\nu)} \varepsilon_{i j} v^{\alpha(\nu) j}=-i\binom{v^{\alpha-}{ }_{i}}{v^{\alpha+}{ }_{i}} \tag{108}
\end{equation*}
$$

For such blocks generalized Majorana condition reduces to the $S U(2)$-Majorana condition

$$
\begin{equation*}
\left(v^{\alpha \pm i}\right)^{*}=\gamma^{0}{ }_{\alpha}{ }^{\beta} v_{\beta}{ }^{ \pm}{ }_{i} . \tag{109}
\end{equation*}
$$
