# Estimation of the Hurst and the stability indices of a $H$-self-similar stable process

#### Abstract

In this paper we estimate both the Hurst and the stability indices of a $H$-self-similar stable process. More precisely, let $X$ be a $H$-sssi (self-similar stationary increments) symmetric $\alpha$-stable process. The process $X$ is observed at points $\frac{k}{n}, k=0, \ldots, n$. Our estimate is based on $\beta$-negative power variations with $-\frac{1}{2}<\beta<0$. We obtain consistent estimators, with rate of convergence, for several classical $H$-sssi $\alpha$-stable processes (fractional Brownian motion, well-balanced linear fractional stable motion, Takenaka's process, Lévy motion). Moreover, we obtain asymptotic normality of our estimators for fractional Brownian motion and Lévy motion.


Keywords: H-sssi processes; stable processes; self-similarity parameter estimator; stability parameter estimator.

## 1 Introduction

Self-similar processes play an important role in probability because of their connection to limit theorems and they are widely used to model natural phenomena. For instance, persistent phenomena in internet traffic, hydrology, geophysics or financial markets, e.g., [9, [17, [21, are known to be self-similar. Stable processes have attracted growing interest in recent years: data with "heavy tails" have been collected in fields as diverse as economics, telecommunications, hydrology and physics of condensed matter, which suggests using non-Gaussian stable processes as possible models, e.g., [21]. Self-similar $\alpha$-stable processes have been proposed to model some natural phenomena with heavy tails, as in [21] and references therein.

The estimation of various indices of $H$-sssi $\alpha$-stable processes has been a problem studied since several decades ago and, even nowadays, it continues to be a challenge. In the case of fractional Brownian motion, the estimation of the self-similarity index $H$ has attracted attention to many authors and many methods have been proposed for solving this problem. Among these, one can mention the quadratic variation method (see e.g. [6], [7, 9], [13]), the $p$-variation method (see e.g. [8], [18), the wavelet coefficients method (see e.g. [1], [5], [14]), the log-variation method (see e.g. [9], [12]). Other references, like the works of J. Istas, recommend the use of complex variations for estimating the self-similarity index $H$ of $H$-sssi processes, but not for estimating $\alpha$, (see e.g. [11]. For linear fractional stable motions, strongly consistent estimators of the self-similarity index $H$, based on the discrete wavelet transform of the processes, have been proposed without requirement that $\alpha$ to be known, as in [2], [20], [23], [24]. Thus, regarding the estimation of the stability index $\alpha$, in [3], the authors presented a wavelet estimator for linear fractional stable motions assuming that $H$ is known. Recently, the corresponding estimation problem of the stability function and the localisability function for a class of multistable processes was considered in the discussion paper of R. Le Guével, see [15], based on some conditions that involve the consistency of the estimators. For linear multifractional stable motions, in [4], the authors presented strongly consistent estimators of the localisability function $H($.$) and the stability index \alpha$ using wavelet coefficients when $\alpha \in(1,2)$ and $H($.$) is a Hölder function smooth enough, with values in a compact$ subinterval $[\underline{H}, \bar{H}]$ of $(1 / \alpha, 1)$.

The aim of this work is to construct consistent estimators of the self-similar index $H$ and the stable index $\alpha$ of $H$-sssi, $S \alpha S$-stable processes using a new framework. In the view of the fact that a stable random variable has a density function, $\beta$ - negative power variations have expectations and covariances for $-1 / 2<\beta<0$. Our estimates are thus based on these variations. This new approach provides estimators of $H$ and $\alpha$ without assumptions on the existence moments of the underlying processes. It also allows us to give an estimator for the self-similarity parameter $H$ without assumption on $\alpha$ and vice versa, we can estimate the stability index $\alpha$ without assumption on $H$. In other words, using $\beta$ - negative power variations ( $-1 / 2<\beta<0$ ), one can obtain the estimators of $H$ and $\alpha$ separately. We prove the consistency and rates of convergence of the proposed estimators for $H$ and $\alpha$ for the underlying processes under an assumption on the series of covariances of $\beta$-negative power variations $(-1 / 2<\beta<0)$. Then obtained results were illustrated by some classical examples: fractional Brownian motions, $S \alpha S$-stable Lévy motions, well-balanced linear fractional stable motions and Takenaka's processes. We then show that the asymptotic normality of our estimates can be ascertained for the proposed estimators when the underlying process is a fractional Brownian motion or an $S \alpha S$-stable Lévy motion.

The remainder part of this article is organized as follows: in the next section, we present the setting, the assumption and main results to construct the estimators of $H$ and $\alpha$. In Section 3, some classical examples for the obtained results in Section 2 are given: fractional Brownian motions, $S \alpha S$-stable Lévy
motions, well-balanced linear fractional stable motions, Takenaka's processes. In this Section, we also show the central limit theorem for the cases of the fractional Brownian motion and the $S \alpha S$-stable Lévy motion. Finally, in Section 4, we gather all the proofs of the main results and of the illustrated examples: Subsection 4.1 contains auxiliary results on negative power variations which play an important role in the proofs in Subsection 4.2 of the main results and in the proofs in Subsection 4.3 of the results of four examples.

## 2 Main results

Let us recall the definition of a $H$-sssi process and an $\alpha$ - stable process (see e.g., [21]): A real-valued process $X$

- is $H$-self-similar ( $H$-ss) if for all $a>0,\{X(a t), t \in \mathbb{R}\} \stackrel{(d)}{=} a^{H}\{X(t), t \in \mathbb{R}\}$,
- has stationary increments (si) if, for all $s \in \mathbb{R},\{X(t+s)-X(s), t \in \mathbb{R}\} \stackrel{(d)}{=}\{X(t)-X(0), t \in \mathbb{R}\}$
where $\stackrel{(d)}{=}$ stands for equality of finite dimensional distributions. A random variable $X$ is said to have a symmetric $\alpha$-stable distribution $(S \alpha S)$ if there are parameters $\alpha \in(0,2]$ and $\sigma>0$ such that its characteristic function has the form:

$$
\mathbb{E} e^{i \theta X}=\exp \left(-\sigma^{\alpha}|\theta|^{\alpha}\right)
$$

When $\sigma=1$, a $S \alpha S$ is said to be standard. Let $X$ be a $H$-sssi, $S \alpha S$ random process with $0<\alpha \leq 2$.
Let $L \geq 1, K \geq 1$ be fixed integers, $a=\left(a_{0}, \ldots, a_{K}\right)$ be a finite sequence with exactly $L$ vanishing first moments, that is for all $q \in\{0, \ldots, L\}$, one has

$$
\begin{equation*}
\sum_{k=0}^{K} k^{q} a_{k}=0, \sum_{k=0}^{K} k^{L+1} a_{k} \neq 0 \tag{1}
\end{equation*}
$$

with convention $0^{0}=1$. For example, here we can choose $K=L+1$ and

$$
\begin{equation*}
a_{k}=(-1)^{L+1-k} \frac{(L+1)!}{k!(L+1-k)!} \tag{2}
\end{equation*}
$$

The increments of $X$ with respect to the sequence $a$ are defined by

$$
\begin{equation*}
\triangle_{p, n} X=\sum_{k=0}^{K} a_{k} X\left(\frac{k+p}{n}\right) \tag{3}
\end{equation*}
$$

We define now an estimator of $H$. Let $\beta \in \mathbb{R},-\frac{1}{2}<\beta<0$, we set

$$
\begin{align*}
V_{n}(\beta) & =\frac{1}{n-K+1} \sum_{p=0}^{n-K}\left|\triangle_{p, n} X\right|^{\beta}  \tag{4}\\
W_{n}(\beta) & =n^{\beta H} V_{n}(\beta) \tag{5}
\end{align*}
$$

Notice that $V_{n}(\beta)$ is the empirical mean of order $\beta$ and $W_{n}(\beta)$ is expected to converge to its mean. The estimator of $H$ is defined by

$$
\begin{equation*}
\widehat{H}_{n}=\frac{1}{\beta} \cdot \log _{2} \frac{V_{n / 2}(\beta)}{V_{n}(\beta)} \tag{6}
\end{equation*}
$$

We are now in position to define an estimator of $\alpha$. We define first auxiliary functions $\psi_{u, v}, h_{u, v}, \varphi_{u, v}$ before introducing the estimator of $\alpha$, where $u>v>0$.
Let $\psi_{u, v}: \mathbb{R}^{+} \times \mathbb{R}^{+} \rightarrow \mathbb{R}$ be the function defined by

\psi_{u, v}(x, y)=-v \ln x+u \ln y+C(u, v) \tag{7}
\end{equation*}
$$

where $C(u, v)=\frac{u-v}{2} \ln (\pi)+u \ln \left(\Gamma\left(1+\frac{v}{2}\right)\right)+v \ln \left(\Gamma\left(\frac{1-u}{2}\right)\right)-v \ln \left(\Gamma\left(1+\frac{u}{2}\right)\right)-u \ln \left(\Gamma\left(\frac{1-v}{2}\right)\right)$.
Let $h_{u, v}:(0,+\infty) \rightarrow(-\infty, 0)$ be the function defined by

$$
\begin{equation*}
h_{u, v}(x)=u \ln \left(\Gamma\left(1+\frac{v}{x}\right)\right)-v \ln \left(\Gamma\left(1+\frac{u}{x}\right)\right) \tag{8}
\end{equation*}
$$

We will prove later that $h_{u, v}$ is bijective. Let $\varphi_{u, v}: \mathbb{R} \rightarrow[0,+\infty)$ be the function defined by

$$
\varphi_{u, v}(x)= \begin{cases}0 & \text { if } x \geq 0  \tag{9}\\ h_{u, v}^{-1}(x) & \text { if } x<0\end{cases}
$$

where $h_{u, v}$ is defined as in (8).
Let $\beta_{1}, \beta_{2}$ be in $\mathbb{R}$ such that $-1 / 2<\beta_{1}<\beta_{2}<0$. The estimator of $\alpha$ is defined by

$$
\begin{equation*}
\hat{\alpha}_{n}=\varphi_{-\beta_{1},-\beta_{2}}\left(\psi_{-\beta_{1},-\beta_{2}}\left(W_{n}\left(\beta_{1}\right), W_{n}\left(\beta_{2}\right)\right)\right) \tag{10}
\end{equation*}
$$

where $\psi_{u, v}, \varphi_{u, v}$ are defined as in (7) and (9), respectively.
With $\beta \in\left(-\frac{1}{2}, 0\right)$ fixed, we will make the following assumption: There exist a sequence $\left\{b_{n}, n \in \mathbb{N}\right\}$ and a constant $C$ such that $\lim _{n \rightarrow+\infty} b_{n}=0, b_{n / 2}=O\left(b_{n}\right)$ and

$$
\begin{equation*}
\limsup _{n \rightarrow+\infty} \frac{1}{n b_{n}^{2}} \sum_{k \in \mathbb{Z},|k| \leq n}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \leq C^{2} \tag{11}
\end{equation*}
$$

Remark 2.1. The assumption (11) is important to prove the consistency of the estimators of the selfsimilarity and the stability indices. We will see its role in the main theorem below.

Now we are in position to present our main results for the estimation of $H$ and $\alpha$, based on the assumption (11).

Theorem 2.1. Let $X$ be a $H$-sssi, $S \alpha S$ random process that satisfies assumption (11). Also, let $\beta, \beta_{1}, \beta_{2} \in \mathbb{R},-\frac{1}{2}<\beta<0,-\frac{1}{2}<\beta_{1}<\beta_{2}<0$ and $\widehat{H}_{n}, \hat{\alpha}_{n}$ be defined as in (6) and (10), respectively. Then as $n \rightarrow+\infty$, one has

$$
\widehat{H}_{n} \xrightarrow{\mathbb{P}} H, \hat{\alpha}_{n} \xrightarrow{\mathbb{P}} \alpha,
$$

moreover $\hat{H}_{n}-H=O_{\mathbb{P}}\left(b_{n}\right), \hat{\alpha}_{n}-\alpha=O_{\mathbb{P}}\left(b_{n}\right)$, where $O_{\mathbb{P}}$ is defined by:
$\bullet X_{n}=O_{\mathbb{P}}(1)$ iff for all $\epsilon>0$, there exists $M>0$ such that $\sup _{n} \mathbb{P}\left(\left|X_{n}\right|>M\right)<\epsilon$,
$\bullet Y_{n}=O_{\mathbb{P}}\left(a_{n}\right)$ means $Y_{n}=a_{n} X_{n}$ with $X_{n}=O_{\mathbb{P}}(1)$.
See Subsection 4.2 for the proof of Theorem 2.1.

## 3 Examples

In this section, we study four classical examples: fractional Brownian motion, $S \alpha S$-stable Lévy motion, well-balanced linear fractional stable motion, Takenaka's process. For these, we will show in Section 4 that (11) is valid, so that the conclusion of Theorem 2.1]holds. We precise this theorem by providing the rate of convergence defined in (11) and a central limit theorem for the first two cases.

### 3.1 Fractional Brownian motion

Definition 3.1. Fractional Brownian motion
Fractional Brownian motion is a centered Gaussian process with covariance given by

$$
\mathbb{E} X(t) X(s)=\frac{\mathbb{E} X(1)^{2}}{2}\left\{|s|^{2 H}+|t|^{2 H}-|s-t|^{2 H}\right\}
$$

Fractional Brownian motion is a $H$-sssi 2 -stable process (see, e.g., [9, p. 59). We will prove that the condition (11) is satisfied with $b_{n}=n^{-1 / 2}$, then the results in Theorem 2.1 are obtained. Moreover, we can obtain the asymptotic normality of the estimators of the self-similarity index $H$ and the stability index $\alpha=2$.
Let $X$ be a $H$ fractional Brownian motion with $H \in(0,1)$. We first present the variances $\Xi_{1}, \Sigma_{1}$ for the limit distributions of the central limit theorems for the estimators of $H$ and $\alpha$.
We will mimic the Breuer-Major's theorem (see e.g., Theorem 7.2.4 in [19) to define these variances. For $\beta \in \mathbb{R},-1 / 2<\beta<0$, let us introduce the following function

$$
\begin{equation*}
f_{\beta}(x)={\sqrt{\operatorname{var} \triangle_{0,1} X}}^{\beta}\left(|x|^{\beta}-\mathbb{E}\left|Z_{0}\right|^{\beta}\right), \tag{12}
\end{equation*}
$$

where $Z_{0}=\frac{\Delta_{0,1} X}{\sqrt{\operatorname{var} \Delta_{0,1} X}}$.
Following Proposition 5.1]in Appendix, we can write $f_{\beta}$ in terms of Hermite polynomials in a unique way

$$
\begin{equation*}
f_{\beta}(x)=\sum_{q \geq d} f_{\beta, q} H_{q}(x), \tag{13}
\end{equation*}
$$

where $d$ is the Hermite rank of $f_{\beta}$ and $d \geq 2, \sum_{q \geq d} q!f_{\beta, q}^{2}<+\infty$. Let

\rho_{1}(r)=\frac{\sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left|r+p-2 p^{\prime}\right|^{2 H}}{2^{H} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left|p-p^{\prime}\right|^{2 H}},  \tag{15}\\
\Gamma_{1}=\left(\begin{array}{ll}
\sum_{q \geq d} q!f_{\beta, q}^{2} \sum_{r \in \mathbb{Z}} \rho^{q}(r) & \sum_{q \geq d} q!f_{\beta, q}^{2} \sum_{r \in \mathbb{Z}} \rho_{1}^{q}(r) \\
\sum_{q \geq d} q!f_{\beta, q}^{2} \sum_{r \in \mathbb{Z}} \rho_{1}^{q}(r) & 2 \sum_{q \geq d} q!f_{\beta, q}^{2} \sum_{r \in \mathbb{Z}} \rho^{q}(r) .
\end{array}\right) \tag{16}
\end{gather*}
$$

and $\phi: \mathbb{R}^{+} \times \mathbb{R}^{+} \rightarrow \mathbb{R}$ be defined by

$$
\begin{equation*}
\phi(x, y)=\frac{1}{\beta} \log _{2} \frac{x}{y} . \tag{17}
\end{equation*}
$$

Then $\Xi_{1}$ is defined by

$$
\begin{equation*}
\Xi_{1}=\phi^{\prime}\left(x_{0}, y_{0}\right) \Gamma_{1} \phi^{\prime}\left(x_{0}, y_{0}\right)^{t} \tag{18}
\end{equation*}
$$

where

$$
\begin{equation*}
\left(x_{0}, y_{0}\right)=\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}\right) . \tag{19}
\end{equation*}
$$

To define $\Sigma_{1}$, let $-1 / 2<\beta_{1}<\beta_{2}<0$, following Proposition 5.1 in Appendix, we can write $f_{\beta_{1}}, f_{\beta_{2}}$ in terms of Hermite polynomials in a unique way

f_{\beta_{1}}(x)=\sum_{q \geq d_{1}} f_{\beta_{1}, q} H_{q}(x), f_{\beta_{2}}(x)=\sum_{q \geq d_{1}} f_{\beta_{2}, q} H_{q}(x) \tag{20}

where $d_{1}$ is the minimum of the Hermite ranks of $f_{\beta_{1}}$ and $f_{\beta_{2}}, d_{1} \geq 2$ and

\sum_{q \geq d} q!f_{\beta_{1}, q}^{2}<+\infty, \sum_{q \geq d} q!f_{\beta_{2}, q}^{2}<+\infty .
$$

Let
where $\psi_{u, v}, \varphi_{u, v}$ are defined by (7), (9) respectively, $\nabla$ is the differential operator and

&\left(x_{1}, y_{1}\right)=\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{2}}\right),  \tag{22}\\
& \Gamma_{2}=\left(\begin{array}{cc}
\sigma_{\beta_{1}}^{2} & \rho_{\beta_{1}, \beta_{2}} \\
\rho_{\beta_{1}, \beta_{2}} & \sigma_{\beta_{2}}^{2}
\end{array}\right),  \tag{23}\\
& \sigma_{\beta_{1}}^{2}=\sum_{q=d_{1}}^{+\infty} q!f_{\beta_{1}, q}^{2} \sum_{k \in \mathbb{Z}} \rho(k)^{q}, \sigma_{\beta_{2}}^{2}=\sum_{q=d_{1}}^{+\infty} q!f_{\beta_{2}, q}^{2} \sum_{k \in \mathbb{Z}} \rho(k)^{q}, \rho_{\beta_{1}, \beta_{2}}=\sum_{q=d_{1}}^{+\infty} q!f_{\beta_{1}, q} f_{\beta_{2}, q} \sum_{k \in \mathbb{Z}} \rho(k)^{q} . \tag{24}

We can now state the following theorem, which precises the results for the estimation of $H$ and $\alpha$ in the case of fractional Brownian motion.

Theorem 3.1. Let $X$ be a fractional Brownian motion. Then
a)

$$
\widehat{H}_{n}-H=O_{\mathbb{P}}\left(n^{-1 / 2}\right), \hat{\alpha}_{n}-2=O_{\mathbb{P}}\left(n^{-1 / 2}\right),
$$

b)

$$
\left.\sqrt{n}\left(\widehat{H}_{n}-H\right) \xrightarrow{(d)} \mathcal{N}_{1}\left(0, \Xi_{1}\right)\right), \sqrt{n}\left(\hat{\alpha}_{n}-2\right) \xrightarrow{(d)} \mathcal{N}_{1}\left(0, \Sigma_{1}\right)
$$

as $n \rightarrow+\infty$, where $\Xi_{1}, \Sigma_{1}$ are defined by (18) and (21), respectively.
See Subsection 4.3 for the proof of Theorem 3.1 .

## 3.2 $S \alpha S$-stable Lévy motion

Definition 3.2. S $\alpha S$-stable Lévy motion
A stochastic process $\{X(t), t \geq 0\}$ is called (standard) $S \alpha S$-stable Lévy motion if $X(0)=0$ (a.s.), $X$ has independent increments and, for all $0 \leq s<t<\infty$ and for some $0<\alpha \leq 2, X(t)-X(s)$ is a $S \alpha S$ random variable with characteristic function given by

$$
\mathbb{E} e^{i \theta(X(t)-X(s))}=\exp \left(-(t-s)|\theta|^{\alpha}\right) .
$$

The condition (11) is proved to be satisfied with $b_{n}=n^{-1 / 2}$, then the results in Theorem 2.1 are ascertained. Similar to the case of fractional Brownian motion, we obtain the asymptotic normality of $H$ and $\alpha$.
The variances $\Xi_{2}, \Sigma_{2}$ for the limit distributions of the central limit theorems for the estimators of $H$ and $\alpha$ are defined as follows.
Let $X$ be a $S \alpha S$-stable Lévy motion, we define the variance for the limit distribution of the central limit theorem for the estimator of $H$ by

\Xi_{2}=\phi^{\prime}\left(x_{0}, y_{0}\right) \Gamma_{3} \phi^{\prime}\left(x_{0}, y_{0}\right)^{t} \tag{25}
\end{equation*}

where $\phi(x, y),\left(x_{0}, y_{0}\right)$ are defined by (17), (19), respectively and

$$
\Gamma_{3}=\left(\begin{array}{cc}
\sigma_{1}^{2} & \sigma_{1,2}  \tag{26}\\
\sigma_{1,2} & \sigma_{2}^{2}
\end{array}\right)
$$

\begin{align*}

& +2 \sum_{p=1}^{K-1}\left(\operatorname{cov}\left(\left|\triangle_{0,1} X\right|^{\beta},\left|\triangle_{2 p, 1} X\right|^{\beta}\right)+\operatorname{cov}\left(\left|\triangle_{0,1} X\right|^{\beta},\left|\triangle_{2 p+1,1} X\right|^{\beta}\right)\right) \\
& +2 \sum_{p=1}^{K-1}\left(\operatorname{cov}\left(\left|\triangle_{1,1} X\right|^{\beta},\left|\triangle_{2 p, 1} X\right|^{\beta}\right)+\operatorname{cov}\left(\left|\triangle_{1,1} X\right|^{\beta},\left|\triangle_{2 p+1,1} X\right|^{\beta}\right)\right)  \tag{27}\\
\sigma_{2}^{2} & =2\left(\operatorname{var}\left|\triangle_{0,1} X\right|^{\beta}+2 \sum_{p=1}^{K-1} \operatorname{cov}\left(\left|\triangle_{0,1} X\right|^{\beta},\left|\triangle_{p, 1} X\right|^{\beta}\right)\right)  \tag{28}\\
\sigma_{1,2} & =2^{\beta H}\left(\operatorname{cov}\left(\left|\triangle_{0,2} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)+\operatorname{cov}\left(\left|\triangle_{1,2} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right) \\
& +2^{\beta H} \sum_{p=1}^{K-1}\left(\operatorname{cov}\left(\left|\triangle_{0,2} X\right|^{\beta},\left|\triangle_{p, 1} X\right|^{\beta}\right)+\operatorname{cov}\left(\left|\triangle_{1,2} X\right|^{\beta},\left|\triangle_{p, 1} X\right|^{\beta}\right)\right) \\
& +2^{\beta H} \sum_{p=1}^{K-1}\left(\operatorname{cov}\left(\left|\triangle_{0,1} X\right|^{\beta},\left|\triangle_{2 p, 2} X\right|^{\beta}\right)+\operatorname{cov}\left(\left|\triangle_{0,1} X\right|^{\beta},\left|\triangle_{2 p+1,2} X\right|^{\beta}\right)\right) \tag{29}

The variance for the limit distribution of the central limit theorem for the estimator of $\alpha$ is defined by
where $\psi_{u, v}, \varphi_{u, v},\left(x_{1}, y_{1}\right)$ are defined as in (77), (9) and (22), respectively,

We now present the results on the asymptotic normality for the case of $S \alpha S$-stable Lévy motion.
Theorem 3.2. Let $X$ be a SoS-stable Lévy motion. Then
a)

\widehat{H}_{n}-H=O_{\mathbb{P}}\left(n^{-1 / 2}\right), \hat{\alpha}_{n}-\alpha=O_{\mathbb{P}}\left(n^{-1 / 2}\right)
$$

b)

$$
\left.\sqrt{n}\left(\widehat{H}_{n}-H\right) \xrightarrow{(d)} \mathcal{N}_{1}\left(0, \Xi_{2}\right)\right), \sqrt{n}\left(\hat{\alpha}_{n}-\alpha\right) \xrightarrow{(d)} \mathcal{N}_{1}\left(0, \Sigma_{2}\right)
$$

as $n \rightarrow+\infty$, where $\Xi_{2}, \Sigma_{2}$ are defined by (25) and (30), respectively.
The proof of Theorem 3.2 is given in Subsection 4.3,

### 3.3 Well-balanced linear fractional stable motion

Definition 3.3. Well-balanced linear fractional stable motion
Let $M$ be a $S \alpha S$ random measure, $0<\alpha \leq 2$, with Lebesgue control measure and consider

X(t)=\int_{-\infty}^{+\infty}\left(|t-x|^{H-1 / \alpha}-|x|^{H-1 / \alpha}\right) M(d x),-\infty<t<+\infty
$$

where $0<H<1, H \neq 1 / \alpha$. The process $X$ is called the well-balanced linear fractional stable motion. Then $X$ is a $H$-sssi process (Proposition 7.4.2, [21]).

Let

$$
b_{n}= \begin{cases}n^{-1 / 2} & \text { if } H<L+1-\frac{2}{\alpha}  \tag{35}\\ n^{\frac{\alpha H-(L+1) \alpha}{4}} & \text { if } H>L+1-\frac{2}{\alpha} \\ \sqrt{\frac{\ln n}{n}} & \text { if } H=L+1-\frac{2}{\alpha}\end{cases}
$$

It is clear that $\lim _{n \rightarrow+\infty} b_{n}=0$ and $b_{n / 2}=O\left(b_{n}\right)$. We get the following results for the estimation of $H$ and $\alpha$.

Theorem 3.3. Let $\{X(t)\}_{t \in \mathbb{R}}$ be a well-balanced linear fractional stable motion with $0<H<1, H \neq 1 / \alpha$ and $0<\alpha<2$. Then for every $\beta \in(-1 / 2,0)$, Theorem 2.1 is true with $b_{n}$ defined by (35).

See Subsection 4.3 for the proof of Theorem 3.3.

### 3.4 Takenaka's processes

Definition 3.4. Takenaka's process
Let $M$ be a symmetric $\alpha$ - stable random measure $(0<\alpha<2)$ with control measure

m(d x, d r)=r^{\nu-2} d x d r,(0<\nu<1)
$$

Let $t \in \mathbb{R}$, set

$$
C_{t}=\left\{(x, r) \in \mathbb{R} \times \mathbb{R}^{+},|x-t| \leq r\right\}, S_{t}=C_{t} \Delta C_{0}
$$

where $\Delta$ denotes the symmetric difference between two sets.
Takenaka's process is defined by

$$
\begin{equation*}
X(t)=\int_{\mathbb{R} \times \mathbb{R}^{+}} \mathbb{1}_{S_{t}}(x, r) M(d x, d r) \tag{36}
\end{equation*}
$$

Following Theorem 4 in [25], the process $X$ is $\nu / \alpha$-sssi. Let

$$
\begin{equation*}
b_{n}=n^{\frac{\nu-1}{2}} \tag{37}
\end{equation*}
$$

We can now ascertain the following.
Theorem 3.4. Let $\left\{X_{t}, t \in \mathbb{R}\right\}$ be a Takenaka's process defined by (361). Then for every $\beta, \beta \in(-1 / 2,0)$, Theorem 2.1 is true with $b_{n}$ defined by (37).

The proof of Theorem 3.4 is given in Subsection 4.3.

## 4 Proofs

First, we give results on expectation of negative power variations of $H$-sssi, $S \alpha S$ random processes in Subsection 4.1. Then we apply these results in Subsection 4.2 to the estimation of $H$ and $\alpha$, in order to prove Theorem 2.1. Finally, we prove that Theorem 2.1 is true for four classical examples presented in Section 3

### 4.1 Negative power expectation and auxiliary results

Now we present some results on expectation of negative power variations of $H$-sssi, $S \alpha S$ random processes proved by using theory of distribution. These results are the tools to prove assumptions (11) for four examples in Section 3 and to prove the main result on the estimation for $\alpha$.

### 4.1.1 Auxiliary results

We start with the following lemma which confirms the existence of the expectation of $\beta$-negative power variation of a symmetric stable random variable when $\beta \in \mathbb{C}, \operatorname{Re}(\beta) \in(-1,0)$.

Lemma 4.1. Let $X$ be a $S \alpha S$ random variable, $\beta \in \mathbb{C}, \operatorname{Re}(\beta) \in(-1,0)$, then $\left.|\mathbb{E}| X\right|^{\beta} \mid<+\infty$.
The proof of Lemma 4.1 is given in Subsection 4.1.2
The next two important results will be used to prove the condition (11) for our examples in next section. Theorem4.1 gives a way to determine the expectation of $\beta$-negative power variation of a symmetric stable random variable whereas Theorem 4.2 helps to establish the inequality of (11) for illustrated examples. Let $(S, \mu)$ be a measure space, $h, g \in L^{\alpha}(S, \mu)$ and $M$ be a symmetric $\alpha$-stable random measure on $S$ with control measure $\mu, \alpha \in(0,2)$. Set

$$
\begin{equation*}
U=\int_{S} h(s) M(d s), V=\int_{S} g(s) M(d s) \tag{38}
\end{equation*}
$$

Let

$$
\begin{equation*}
C_{\beta}=\frac{2^{\beta+1 / 2} \Gamma\left(\frac{\beta+1}{2}\right)}{\Gamma\left(-\frac{\beta}{2}\right)} \tag{39}
\end{equation*}
$$

where $\beta \in \mathbb{C}$ such that $\operatorname{Re}(\beta) \in(-1,0)$.
Theorem 4.1. For $\beta \in \mathbb{C}, \operatorname{Re}(\beta) \in(-1,0)$, we have

$$
\begin{equation*}
\mathbb{E}|U|^{\beta}=\frac{1}{\sqrt{2 \pi}} \int_{\mathbb{R}} \mathcal{F} T(y) \mathbb{E} e^{i U y} d y=\frac{C_{\beta}}{\sqrt{2 \pi}} \int_{\mathbb{R}} \frac{\mathbb{E} e^{i U y}}{|y|^{\beta+1}} d y \tag{40}
\end{equation*}
$$

in the sense of distributions, where $U, V$ are defined by (38), $T=|x|^{\beta}$ and $\mathcal{F} T$ is Fourier transform of $T$.

See Subsection 4.1.3 for the proof of Theorem 4.1.
Theorem 4.2. Assume that

$$
\begin{aligned}
\|U\|_{\alpha}^{\alpha} & =\int_{S}|h(s)|^{\alpha} \mu(d s)=1,\|V\|_{\alpha}^{\alpha}=\int_{S}|g(s)|^{\alpha} \mu(d s)=1 \\
{[U, V]_{2} } & =\int_{S}|h(s) g(s)|^{\alpha / 2} \leq \eta<1
\end{aligned}
$$

where $U, V$ are defined as in (38). Then for $-1 / 2<\operatorname{Re}(\beta)<0$, we have

$$
\begin{equation*}
\mathbb{E}|U|^{\beta}|V|^{\bar{\beta}}=\frac{C_{\beta} C_{\bar{\beta}}}{2 \pi} \int_{\mathbb{R}^{2}} \frac{\mathbb{E} e^{i x U+i y V}}{|x|^{1+\beta}|y|^{1+\bar{\beta}}} d x d y \tag{41}
\end{equation*}
$$

Moreover, there exists a constant $C(\eta)$ such that

$$
\begin{equation*}
\left|\operatorname{cov}\left(|U|^{\beta},|V|^{\beta}\right)\right| \leq C(\eta) \int_{S}|h(s) g(s)|^{\alpha / 2} d s \tag{42}
\end{equation*}
$$

The proof of Theorem 4.2 is given in Subsection 4.1.4,
The following two lemmas follow from Theorem 4.1 in which Lemma 4.2 provides an important formula to construct the estimator for $\alpha$.

Lemma 4.2. Let $X$ be a standard $S \alpha S$ variable with $0<\alpha \leq 2$ and $\beta \in \mathbb{C},-1<\operatorname{Re}(\beta)<0$, then

$$
\begin{equation*}
\mathbb{E}|X|^{\beta}=\frac{2^{\beta} \Gamma\left(\frac{\beta+1}{2}\right) \Gamma\left(1-\frac{\beta}{\alpha}\right)}{\sqrt{\pi} \Gamma\left(1-\frac{\beta}{2}\right)} . \tag{43}
\end{equation*}
$$

See Subsection 4.1.5 for the proof of Lemma 4.2,
Lemma 4.3. Let $X$ be a SoS process where $0<\alpha \leq 2, \beta \in \mathbb{C},-\frac{1}{2}<\operatorname{Re}(\beta)<0$, then

$$
\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta} \neq 0
$$

See Subsection 4.1.6 for the proof of Lemma 4.3, Now we will give the proofs for the latter results.

### 4.1.2 Proof of Lemma 4.1

Since $X$ is a $S \alpha S$-stable random variable, $X$ has a density function $f(x)$ that is even and continuous on $\mathbb{R}$. We first consider the case $\beta \in \mathbb{R}$ and $-1<\beta<0$.
For $-1<\beta<0$, we can write:

$$
\mathbb{E}|X|^{\beta}=\int_{\mathbb{R}}|x|^{\beta} f(x) d x=\int_{|x| \leq 1}|x|^{\beta} f(x) d x+\int_{|x| \geq 1}|x|^{\beta} f(x) d x:=A+B .
$$

We have

$$
A=\int_{|x| \leq 1}|x|^{\beta} f(x) d x \leq \sup _{|x| \leq 1}|f(x)| \int_{|x| \leq 1}|x|^{\beta} d x<+\infty, B=2 \int_{1}^{\infty} x^{\beta} f(x) d x \leq 2
$$

It follows that $\mathbb{E}|X|^{\beta}<+\infty$. For $\beta \in \mathbb{C},-1<\operatorname{Re}(\beta)<0$, we have

$$
\left.\left.|\mathbb{E}| X\right|^{\beta}\left|=\left|\int_{\mathbb{R}}\right| x\right|^{a+i b} f(x) d x\left|\leq \int_{\mathbb{R}}\right| x\right|^{R e(\beta)} f(x) d x<+\infty
$$

Then we obtain the conclusion.

### 4.1.3 Proof of Theorem 4.1

To prove Theorem 4.1, we start with the following lemma.
Lemma 4.4. For all $x \in \mathbb{R}, \beta \in \mathbb{C},-1<\operatorname{Re}(\beta)<0$, let $T(x)=|x|^{\beta}$. Then $T$ has Fourier transform defined by

$$
\begin{equation*}
\mathcal{F} T(y)=\frac{C_{\beta}}{|y|^{\beta+1}} \tag{44}
\end{equation*}
$$

in the sense of distributions, where $C_{\beta}$ is defined as in (39).
Proof. For $\beta \in \mathbb{C},-1<\operatorname{Re}(\beta)<0$, following example 5, $\S 7$, chapter VII of [22], then $T$ is a distribution and it has Fourier transform $\mathcal{F} T(y)=C|y|^{-(\beta+1)}$, where $C$ is a constant. We will find $C$ using function $k(x)=e^{-x^{2} / 2}$. Since $T \in L_{l o c}^{1}(\mathbb{R})$ and $k \in S(\mathbb{R})$, in the sense of distributions, we have $\langle\mathcal{F} T, k\rangle=\langle T, \mathcal{F} k\rangle$. On the other hand,

$$
\mathcal{F} k(y)=\frac{1}{\sqrt{2 \pi}} \int_{\mathbb{R}} e^{-i x y} e^{-x^{2} / 2} d x=e^{-y^{2} / 2}
$$

then

$$
\int_{\mathbb{R}}|x|^{\beta} e^{-x^{2} / 2} d x=\int_{\mathbb{R}} C|y|^{-(\beta+1)} e^{-y^{2} / 2} d y
$$

By taking the change of variable, we obtain that

$$
\int_{\mathbb{R}}|x|^{\beta} e^{-x^{2} / 2} d x=2^{\frac{\beta+1}{2}} \Gamma\left(\frac{\beta+1}{2}\right), \int_{\mathbb{R}}|y|^{-(\beta+1)} e^{-y^{2} / 2} d y=2^{-\beta / 2} \Gamma\left(-\frac{\beta}{2}\right) .
$$

It follows that

$$
C=\frac{2^{\beta+1 / 2} \Gamma\left(\frac{\beta+1}{2}\right)}{\Gamma\left(-\frac{\beta}{2}\right)}=C_{\beta} .
$$

From Lemma4.4, we have $\mathcal{F} T(y)=\frac{C_{\beta}}{|y|^{1+\beta}}$, where $f$ is the density function of $U$ and $C_{u}=2^{u+1 / 2} \frac{\Gamma\left(\frac{u+1}{}\right)}{\Gamma\left(-\frac{u}{2}\right)}$. Let $\varphi$ be a non-negative, even function, $\varphi \in C_{0}^{\infty}(\mathbb{R}), \operatorname{supp} \varphi \subset[-1,1], \int_{\mathbb{R}} \varphi(y) d y=1$. Set $\varphi_{\epsilon}(x)=\frac{\varphi(x / \epsilon)}{\epsilon}$, we will prove that $g_{\epsilon}=\mathcal{F}^{-1} f * \varphi_{\epsilon} \in S(\mathbb{R})$.
Indeed, let $\chi(x)$ be a function in $C_{0}^{\infty}(\mathbb{R})$ such that $\chi(x)=1$ for $|x| \leq 1$ and $\chi(x)=0$ for $|x| \geq 2$.
We can write the characteristic function corresponding with the density function $f$ as

$$
e^{-\sigma^{\alpha}|x|^{\alpha}}=\sqrt{2 \pi} \mathcal{F}^{-1} f(x):=g(x)=\chi(x) g(x)+(1-\chi(x)) g(x):=g_{1}(x)+g_{2}(x)
$$

and

$$
g * \varphi_{\epsilon}(x)=g_{1} * \varphi_{\epsilon}(x)+g_{2} * \varphi_{\epsilon}(x) .
$$

It is clearly that $g_{1} \in L^{1}(\mathbb{R})$, $g_{1}$ has compact support, $\varphi_{\epsilon} \in C_{0}^{\infty}(R)$, so $g_{1} * \varphi_{\epsilon} \in S(\mathbb{R})$.
We also have $g_{2} * \varphi \in S(\mathbb{R})$ since $g_{2}$ and $\varphi_{\epsilon}(x)$ are in $S(\mathbb{R})$.
Then we get $g_{\epsilon} \in S(\mathbb{R})$.
We have

$$
\mathcal{F} g_{\epsilon}(x)=\sqrt{2 \pi} f(x) \mathcal{F} \varphi_{\epsilon}(x) .
$$

Since

$$
\left\langle T, \mathcal{F} g_{\epsilon}\right\rangle=\left\langle\mathcal{F} T, g_{\epsilon}\right\rangle,
$$

we obtain

$$
\begin{align*}
\int_{\mathbb{R}} \sqrt{2 \pi}|x|^{\beta} f(x) \mathcal{F} \varphi_{\epsilon}(x) d x & =\int_{\mathbb{R}} \mathcal{F} T(y) \mathcal{F}^{-1} f * \varphi_{\epsilon}(y) d y  \tag{45}\\
& =\int_{\mathbb{R}} \mathcal{F}^{-1} f(y) \mathcal{F} T * \varphi_{\epsilon}(y) d y \tag{46}
\end{align*}
$$

Here we used Fubini's theorem since $\mathcal{F} T, \mathcal{F}^{-1} f \in L_{l o c}^{1}(\mathbb{R}), \varphi_{\epsilon} \in C_{0}^{\infty}(\mathbb{R})$ and $\varphi_{\epsilon}$ is an even function.
Now we will find the limits of two sides of the equation (46) when $\epsilon \rightarrow 0$. We first consider the left hand side of (46). One has

$$
\lim _{\epsilon \rightarrow 0} \mathcal{F} \varphi_{\epsilon}(x)=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{R}} \frac{1}{\sqrt{2 \pi}} e^{-i t x} \varphi_{\epsilon}(t) d t=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{R}} \frac{1}{\sqrt{2 \pi}} e^{-i t x} \frac{\varphi(t / \epsilon)}{\epsilon} d t=\lim _{\epsilon \rightarrow 0} \int_{\mathbb{R}} \frac{1}{\sqrt{2 \pi}} e^{-i \epsilon u x} \varphi(u) d u .
$$

For $x, u \in \mathbb{R}, e^{-i \epsilon u x} \varphi(u) \rightarrow \varphi(u)$ when $\epsilon \rightarrow 0$, and $\left|e^{-i \epsilon u x} \varphi(u)\right|=\varphi(u), \int_{\mathbb{R}} \varphi(u) d u=1$, following Lebesgue dominated convergence theorem, one gets

$$
\lim _{\epsilon \rightarrow 0} \mathcal{F} \varphi_{\epsilon}(x)=\int_{\mathbb{R}} \frac{1}{\sqrt{2 \pi}} \varphi(u) d u=\frac{1}{\sqrt{2 \pi}} .
$$

Therefore, for $x \neq 0, \sqrt{2 \pi}|x|^{\beta} f(x) \mathcal{F} \varphi_{\epsilon}(x) \rightarrow \sqrt{2 \pi}|x|^{\beta} f(x)$ pointwise when $\epsilon \rightarrow 0$. We have

$$
\begin{aligned}
\left||x|^{\beta} f(x) \mathcal{F} \varphi_{\epsilon}(x)\right| & =\frac{1}{\sqrt{2 \pi}}|x|^{R e(\beta)} f(x)\left|\int_{\mathbb{R}} e^{-i t x} \frac{\varphi(t / \epsilon)}{\epsilon} d t\right|=\frac{1}{\sqrt{2 \pi}}|x|^{e(\beta)} f(x)\left|\int_{\mathbb{R}} e^{-i \epsilon u x} \varphi(u) d u\right| \\
& \leq \frac{1}{\sqrt{2 \pi}}|x|^{R e(\beta)} f(x)\left|\int_{\mathbb{R}} \varphi(u) d u\right|=\frac{1}{\sqrt{2 \pi}}|x|^{R e(\beta)} f(x) .
\end{aligned}
$$

Moreover, applying Lemma 4.1, it follows that $\int_{\mathbb{R}}|x|^{R e(\beta)} f(x) d x<\infty$. Thus applying Lebesgue dominated convergence theorem, the left hand side of (46) converges to $\int_{\mathbb{R}}|x|^{\operatorname{Re}(\beta)} f(x) d x$.
Turning back to the right hand side of (46), since $\mathcal{F} T$ is continuous at $y \neq 0$ and $\mathcal{F} T \in L_{l o c}^{1}(\mathbb{R})$, we get

$$
\lim _{\epsilon \rightarrow 0} \mathcal{F} T * \varphi_{\epsilon}(y)=\mathcal{F} T(y)
$$

for $y \in \mathbb{R}^{*}$. It follows that

$$
\lim _{\epsilon \rightarrow 0} \mathcal{F}^{-1} f(y) \mathcal{F} T * \varphi_{\epsilon}(y)=\mathcal{F}^{-1} f(y) \mathcal{F} T(y)
$$

pointwise almost everywhere. We have the following inequality on $\mathcal{F} T$ and $\varphi_{\epsilon}$.
Lemma 4.5. There exists a constant $C>0$ such that for all $\epsilon>0, x \neq 0$, we have

$$
|\mathcal{F} T| * \varphi_{\epsilon}(x) \leq C|\mathcal{F} T|(x) .
$$

Proof. Since $\mathcal{F} T$ and $\varphi_{\epsilon}$ are even functions, we just need to prove this lemma for $x>0$. From the fact that $\varphi$ has compact support, then there exists a constant $C$ such that for all $x>0, \varphi(x) \leq C \mathbb{1}_{[-1,1]}(x)$. We consider first the case $x>2 \epsilon$. One has

$$
\begin{aligned}
|\mathcal{F} T| * \varphi_{\epsilon}(x) & =\int_{\mathbb{R}}|\mathcal{F} T|(y) \varphi_{\epsilon}(x-y) d y \leq \frac{C}{\epsilon} \int_{x-\epsilon}^{x+\epsilon}|\mathcal{F} T|(y) d y \\
& \leq 2 C|\mathcal{F} T|(x-\epsilon) \leq 2 C|\mathcal{F} T|(x / 2)=C_{1}|\mathcal{F} T|(x) .
\end{aligned}
$$

If $x \leq 2 \epsilon$, then

$$
\begin{aligned}
|\mathcal{F} T| * \varphi_{\epsilon}(x) & \leq \frac{C}{\epsilon} \int_{x-\epsilon}^{x+\epsilon}|\mathcal{F} T|(y) d y \leq \frac{C}{\epsilon} \int_{-3 \epsilon}^{3 \epsilon}|\mathcal{F} T|(y) d y \\
& =\frac{2 C}{\epsilon} \int_{0}^{3 \epsilon} \frac{\left|F_{\beta}\right|}{|y|^{1+R e(\beta)}} d y=\frac{C_{1}}{\epsilon} \frac{1}{(3 \epsilon)^{R e(\beta)}} \leq C_{2}|\mathcal{F} T|(x) .
\end{aligned}
$$

Applying Lemma 4.5, then we deduce that

$$
\left|\mathcal{F}^{-1} f(y) \mathcal{F} T * \varphi_{\epsilon}(y)\right| \leq C\left|\mathcal{F}^{-1} f(y) \| \mathcal{F} T\right|(y)
$$

almost everywhere. But

$$
\int_{\mathbb{R}}\left|\mathcal{F}^{-1} f(y) \| \mathcal{F} T\right|(y) d y=\int_{\mathbb{R}} \frac{e^{-|y|^{\alpha}}}{\sqrt{2 \pi}} \frac{\left|C_{\beta}\right|}{|y|^{1+\operatorname{Re}(\beta)}} d y=\frac{\left|C_{\beta}\right|}{\sqrt{2 \pi}} \int_{\mathbb{R}} \frac{e^{-|y|^{\alpha}}}{|y|^{1+\operatorname{Re}(\beta)}} d y<\infty
$$

since $\operatorname{Re}(\beta) \in(-1,0)$. Applying Lebesgue dominated convergence theorem again, the right hand side of (46) converges to $\int_{\mathbb{R}} \mathcal{F}^{-1} f(y) \mathcal{F} T(y) d y$. So we get (40).

### 4.1.4 Proof of Theorem 4.2

Let $\chi$ be in $C_{0}^{\infty}(\mathbb{R}), \chi \geq 0, \chi(x)=1$ if $x \in[-1,1]$, supp $\chi \in[-2,2]$. For $\epsilon>0$, we define

$$
\phi_{\epsilon}(x)=(1-\chi(x / \epsilon)) \chi(\epsilon x)
$$

Let $\mu$ be the distribution of random vector $(U, V)$, then $\mu$ is a probability measure on $\mathbb{R}^{2}$.
Let $T_{1}(x)=|x|^{\beta}, T_{2}(x)=|y|^{\bar{\beta}}$. Following Lemma4.4, $T_{1}, T_{2}$ are distributions and have Fourier transforms

$$
\mathcal{F} T_{1}(y)=\frac{C_{\beta}}{|y|^{1+\beta}}, \mathcal{F} T_{2}(x)=\frac{C_{\bar{\beta}}}{|x|^{1+\bar{\beta}}}
$$

respectively, in the sense of distributions, where $C_{u}=2^{u+1 / 2} \frac{\Gamma\left(\frac{u+1}{2}\right)}{\Gamma\left(\frac{-u}{2}\right)}$.
Set $F_{1 \epsilon}(x)=T_{1}(x) \phi_{\epsilon}(x), F_{2 \epsilon}(y)=T_{2}(y) \phi_{\epsilon}(y)$. It is clearly that $F_{1 \epsilon}(x) \in S(\mathbb{R}), F_{2 \epsilon}(y) \in S(\mathbb{R})$. Then $F_{1 \epsilon} \otimes F_{2 \epsilon}(x, y) \in S\left(\mathbb{R}^{2}\right)$. It follows that

$$
\begin{equation*}
\int_{\mathbb{R}^{2}} F_{1 \epsilon} \otimes F_{2 \epsilon}(x, y) d \mu(x, y)=\int_{\mathbb{R}^{2}} \mathcal{F}^{-1}(d \mu)(x, y) \mathcal{F}\left(F_{1 \epsilon} \otimes F_{2 \epsilon}\right)(x, y) d x d y \tag{47}
\end{equation*}
$$

Now we consider the right-hand side of (47). We have

$$
\mathcal{F}\left(F_{1 \epsilon} \otimes F_{2 \epsilon}\right)(x, y)=\mathcal{F} F_{1 \epsilon} \otimes \mathcal{F} F_{2 \epsilon}(x, y)
$$

We can write

$$
F_{1 \epsilon}(x)=T_{1}(x) \chi(\epsilon x)-T_{1}(x) \chi(\epsilon x) \chi\left(\frac{x}{\epsilon}\right) .
$$

Set $\psi(x)=\mathcal{F} \chi(x)$. One has

$$
\mathcal{F} F_{1 \epsilon}(x)=\frac{1}{\sqrt{2 \pi}} \mathcal{F} T_{1} * \psi_{\epsilon}-\frac{1}{2 \pi} \mathcal{F} T_{1} * \psi_{\epsilon} * \psi_{1 / \epsilon}=\mathcal{F} T_{1} *\left(\frac{1}{\sqrt{2 \pi}} \psi_{\epsilon}\right)-\frac{1}{\sqrt{2 \pi}} \mathcal{F} T_{1} *\left(\frac{1}{\sqrt{2 \pi}} \psi_{\epsilon}\right) * \psi_{1 / \epsilon}
$$

We will use the following lemma.
Lemma 4.6. Let $\psi$ be a function in the Schwartz class, $T(t)=|t|^{\beta}$ where $\operatorname{Re}(\beta) \in(-1,0)$. Then for all $x \neq 0$, there exists a constant $C>0$ such that

$$
|T * \psi(x)| \leq C|T(x)|
$$

Proof. We denote $C$ a running constant which may change from an occurrence to another occurrence. For $\epsilon>0$, set

$$
\psi_{\epsilon}(x)=\frac{1}{\epsilon} \psi\left(\frac{x}{\epsilon}\right) .
$$

We first prove that there exists a constant $C>0$ such that for all $\epsilon>0$,

$$
\left|T * \psi_{\epsilon}(x)\right| \leq C \sup _{a>0} \frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| d t
$$

Let $k(y)=|T(x-y)|, I_{\epsilon}=T * \psi_{\epsilon}(x)$.
By taking the change of variable $u=\frac{y}{\epsilon}$, we obtain that $I_{\epsilon}=\int_{\mathbb{R}} k(\epsilon u) \psi(u) d u$. Set $F(x)=\int_{0}^{x} k(\epsilon u) d u$, one has

$$
F(x)=\frac{1}{\epsilon} \int_{0}^{\epsilon x} k(t) d t, F^{\prime}(x)=k(\epsilon x) .
$$

Combining with the fact that $\lim _{x \rightarrow \infty} F(x) \psi(x)=0$ and $F(0)=0$, we deduce that

$$
\begin{aligned}
\int_{0}^{+\infty} k(\epsilon u) \psi(u) d u & =\int_{0}^{+\infty} F^{\prime}(u) \psi(u) d u=-\int_{0}^{+\infty} F(u) \psi^{\prime}(u) d u \\
& =-\int_{0}^{+\infty}\left\{\frac{1}{\epsilon u} \int_{0}^{\epsilon u} k(t) d t\right\} u \psi^{\prime}(u) d u .
\end{aligned}
$$

Since $k(u) \geq 0$, it follows that

$$
\frac{1}{\epsilon u} \int_{0}^{\epsilon u} k(t) d t \leq \sup _{a>0} \frac{1}{a} \int_{-a}^{+a} k(t) d t
$$

We also have $\psi$ is a function in the Schwartz class, then

$$
\left|\int_{0}^{+\infty} k(\epsilon u) \psi(u) d u\right| \leq\left|\int_{0}^{+\infty} u \psi^{\prime}(u) d u\right| \sup _{a>0} \frac{1}{a} \int_{-a}^{+a} k(t) d t=C \sup _{a>0} \frac{1}{2 a} \int_{-a}^{+a} k(t) d t .
$$

We can get a similar bound for the integral $\left|\int_{-\infty}^{0} k(\epsilon u) \psi(u) d u\right|$. Therefore we obtain

$$
\left|I_{\epsilon}\right| \leq C \sup _{a>0} \frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| d t .
$$

Taking $\epsilon=1$, it follows that

$$
|T * \psi(x)| \leq C \sup _{a>0} \frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| d t
$$

Now we will prove that there exists a constant $C>0$ such that for all $a>0$, then

$$
\frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| d t \leq C|T(x)|
$$

We first consider the case $x>0$.
If $x>2 a$, then $0<\frac{x}{2}<x-a<x+a$ and $T(t)$ decreases over $[x-a, x+a]$. We get

$$
\begin{aligned}
\frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| d t & \leq \frac{1}{2 a}(x+a-(x-a))(x-a)^{\operatorname{Re}(\beta)} \\
& \leq \frac{(x / 2)^{\operatorname{Re}(\beta)}}{2}=C|T(x)|
\end{aligned}
$$

If $0<x \leq 2 a<3 a$, then

$$
\begin{aligned}
\frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| & \leq \frac{1}{2 a} \int_{-3 a}^{3 a}|T(t)| d t \\
& =\frac{1}{a} \int_{0}^{3 a} t^{\operatorname{Re}(\beta)} d t=\frac{(3 a)^{1+\operatorname{Re}(\beta)}}{a(1+\operatorname{Re}(\beta))} \\
& \leq C(3 a)^{\operatorname{Re}(\beta)} \leq C x^{\operatorname{Re}(\beta)}=C|T(x)| .
\end{aligned}
$$

For the case $x<0$, if $x \leq-2 a$, then $x-a<x+a<x / 2<0$, we obtain

$$
\begin{aligned}
\frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| & \leq \frac{(x+a-(x-a))|x+a|^{\operatorname{Re}(\beta)}}{2 a} \\
& \leq|x / 2|^{\operatorname{Re}(\beta)}=C|T(x)|
\end{aligned}
$$

If $-2 a<x<0$, then $-3 a<x-a<x+a<3 a$, one gets

$$
\begin{aligned}
\frac{1}{2 a} \int_{x-a}^{x+a}|T(t)| & \leq \frac{1}{2 a} \int_{-3 a}^{3 a}|T(t)| d t \\
& =\frac{1}{a} \int_{0}^{3 a} t^{\operatorname{Re}(\beta)} \leq C|x|^{\operatorname{Re}(\beta)}=C|T(x)|
\end{aligned}
$$

One can therefore obtain the conclusion.
Since $\psi_{\epsilon} * \psi_{1 / \epsilon} \in S(\mathbb{R})$, following Lemma 4.6, we have

$$
\left|\mathcal{F} T_{1} *\left(\psi_{\epsilon} * \psi_{1 / \epsilon}\right)(x)\right| \leq C\left|\mathcal{F} T_{1}(x)\right|
$$

Then, there exists a constant $C>0$ such that

$$
\left|\mathcal{F} F_{1 \epsilon}(x)\right| \leq C\left|\mathcal{F} T_{1}(x)\right|
$$

In a similar way, we also get $\left|\mathcal{F} F_{2 \epsilon}(y)\right| \leq C\left|\mathcal{F} T_{2}(y)\right|$. It follows that

$$
\left|\mathcal{F}^{-1}(d \mu)(x, y) \mathcal{F}\left(F_{1 \epsilon} \otimes F_{2 \epsilon}\right)(x, y)\right| \leq C\left|\mathcal{F}^{-1}(d \mu)(x, y)\right|\left|\mathcal{F} T_{1}(x) \mathcal{F} T_{2}(y)\right|
$$

Let us recall that $\int_{\mathbb{R}} \frac{\psi(t)}{\sqrt{2 \pi}} d t=\chi(0)=1$. We will use the two following lemmas to get

$$
\begin{equation*}
\lim _{\epsilon \rightarrow 0} \mathcal{F} F_{1 \epsilon}(x)=\mathcal{F} T_{1}(x), \lim _{\epsilon \rightarrow 0} \mathcal{F} F_{2 \epsilon}(y)=\mathcal{F} T_{2}(y) \tag{48}
\end{equation*}
$$

Lemma 4.7. Let $T(x)=|x|^{\beta}$ where $\operatorname{Re}(\beta) \in(-1,0), \psi$ be a function in Schwartz class. Then almost everywhere,

$$
\lim _{\epsilon \rightarrow 0} T * \psi_{1 / \epsilon}(x)=0
$$

where $\psi_{1 / \epsilon}(x)=\epsilon \psi(\epsilon x)$.
Proof. Let $x \in \mathbb{R}, x \neq 0$, we have

$$
T * \psi_{1 / \epsilon}(x)=\int_{\mathbb{R}} T(y) \epsilon \psi(\epsilon(x-y)) d y=\int_{\mathbb{R}}|y|^{\beta} \epsilon \psi(\epsilon(x-y)) d y
$$

By taking the change of variable $t=\epsilon y$, one gets

$$
\left|T * \psi_{1 / \epsilon}(x)\right| \leq \int_{\mathbb{R}}|t / \epsilon|^{\operatorname{Re}(\beta)}|\psi(\epsilon x-t)| d t=\epsilon^{-\operatorname{Re}(\beta)} \int_{\mathbb{R}}|t|^{\operatorname{Re}(\beta)}|\psi(\epsilon x-t)| d t
$$

We write

$$
\int_{\mathbb{R}}|t|^{R e(\beta)}|\psi(\epsilon x-t)| d t=\int_{-1}^{1}|t|^{R e(\beta)}|\psi(\epsilon x-t)| d t+\int_{|t| \geq 1}|t|^{R e(\beta)}|\psi(\epsilon x-t)| d t:=I_{1}+I_{2}
$$

We consider $I_{1}$ and $I_{2}$. Since $\psi$ is a function in Schwartz class, one gets $\|\psi\|_{\infty}<\infty,\|\psi\|_{1}<\infty$. Then

$$
\begin{gathered}
I_{1} \leq 2\|\psi\|_{\infty} \int_{0}^{1} t^{\operatorname{Re}(\beta)} d t=C<+\infty \\
I_{2}=\int_{|t| \geq 1}|t|^{R e(\beta)}|\psi(\epsilon x-t)| d t \leq \int_{|t| \geq 1}|\psi(\epsilon x-t)| d t \leq\|\psi\|_{1}=C<+\infty .
\end{gathered}
$$

Since then $\left|T * \psi_{1 / \epsilon}(x)\right| \leq C \epsilon^{-R e(\beta)} \rightarrow 0$ as $\epsilon \rightarrow 0$. It follows that $T * \psi_{1 / \epsilon}(x) \rightarrow 0$ almost everywhere as $\epsilon \rightarrow 0$.

Lemma 4.8. Let $\psi$ be a function in Schwartz class such that $\int_{\mathbb{R}} \psi(t) d t=1, T(t)=|t|^{\beta}$ where $\operatorname{Re}(\beta) \in$ $(-1,0)$. Then we have $\lim _{\epsilon \rightarrow 0} T * \psi_{\epsilon}(x)=T(x)$ almost everywhere, where $\psi_{\epsilon}(x)=\frac{\psi(x / \epsilon)}{\epsilon}$.

Proof. Let $x \in \mathbb{R}, x \neq 0$, we consider $I=T * \psi_{\epsilon}(x)-T(x)$. Let us recall that

$$
\int_{\mathbb{R}} \psi_{\epsilon}(t) d t=\int_{\mathbb{R}} \frac{\psi(t / \epsilon)}{\epsilon} d t=\int_{\mathbb{R}} \psi(u) d u=1
$$

Therefore $I=\int_{\mathbb{R}}\{T(x-y)-T(x)\} \frac{1}{\epsilon} \psi(y / \epsilon) d y$.
Let $\theta>0$ be a constant. There exists $0<\delta<|x|$ such that for $|y| \leq \delta$, we have $|T(x-y)-T(x)| \leq \frac{\theta}{2\|\psi\|_{1}}$. Then

$$
\begin{aligned}
& |I| \leq \int_{|y| \leq \delta}|T(x-y)-T(x)| \frac{|\psi(y / \epsilon)|}{\epsilon} d y+\int_{|y| \geq \delta}|T(x-y)-T(x)| \frac{|\psi(y / \epsilon)|}{\epsilon} d y:=I_{1}+I_{2} . \\
& I_{1} \leq \frac{\theta}{2 \epsilon\|\psi\|_{1}} \int_{|y| \leq \delta}|\psi(y / \epsilon)| d y=\frac{\theta}{2 \epsilon\|\psi\|_{1}} \int_{|u| \leq \epsilon \delta} \epsilon|\psi(u)| d u \leq \frac{\theta}{2 \epsilon\|\psi\|_{1}} \int_{\mathbb{R}} \epsilon|\psi(u)| d u=\frac{\theta}{2} .
\end{aligned}
$$

Now we consider $I_{2}$. Since $\psi$ is a function in Schwartz class, there exists a constant $C>0$ such that for $|t| \geq 1$ then $|\psi(t)| \leq \frac{C}{t^{2}}$.
We choose $\epsilon>0$ such that $\frac{\delta}{\epsilon} \geq 1$. By taking the change of variable $t=y / \epsilon$, we get

$$
\begin{aligned}
I_{2} & =\int_{|t| \geq \frac{\delta}{\epsilon}}\left|T(x-\epsilon t)-T(x)\left\|\psi(t)\left|d t \leq \int_{|t| \geq \frac{\delta}{\epsilon}}\right| T(x-\epsilon t)\right\| \psi(t)\right| d t+\int_{|t| \geq \frac{\delta}{\epsilon}}|T(x) \| \psi(t)| d t \\
& =\int_{|t| \geq \frac{\delta}{\epsilon},|x-\epsilon| \leq 1}\left|T(x-\epsilon t)\left\|\psi(t)\left|d t+\int_{|t| \geq \frac{\delta}{\epsilon},|x-\epsilon t| \geq 1}\right| T(x-\epsilon t)\right\| \psi(t)\right| d t+\int_{|t| \geq \frac{\delta}{\epsilon}}|T(x) \| \psi(t)| d t \\
& :=J_{1}+J_{2}+J_{3} .
\end{aligned}
$$

We have

$$
J_{1}=\int_{|t| \geq \frac{\delta}{\epsilon},|x-\epsilon t| \leq 1}|T(x-\epsilon t) \| \psi(t)| d t \leq C \int_{|x-\epsilon t| \leq 1}|T(x-\epsilon t)|(\epsilon / \delta)^{2} d t
$$

By taking the change of variable $u=\epsilon t-x$, one gets

$$
J_{1} \leq \frac{C \epsilon^{2}}{\delta^{2}} \int_{|u| \leq 1} \frac{|T(u)|}{\epsilon} d u=C_{1} \epsilon
$$

Here $C_{1}$ is a constant depending on $\delta$.
Let us consider $J_{2}$. Since $|T(t)|=|t|^{\operatorname{Re}(\beta)}$ and $\operatorname{Re}(\beta) \in(-1,0)$, if $|x-\epsilon t| \geq 1$ we get $|T(x-\epsilon t)| \leq 1$.
Moreover $\delta / \epsilon \geq 1$, it follows that

$$
J_{2} \leq \int_{|t| \geq \delta / \epsilon} \frac{C}{t^{2}} d t=C_{2} \frac{\epsilon}{\delta}
$$

where $C_{2}$ is a constant depending on $\delta$. Similarly, since $\delta / \epsilon \geq 1$, we get

$$
J_{3} \leq|T(x)| \int_{|t| \geq \delta / \epsilon} \frac{C}{t^{2}} d t=C_{3} \epsilon
$$

where $C_{3}$ is a constant depending on $x, \delta$. So we get $I_{2} \leq C \epsilon$ where $C$ is a constant depending on $x, \delta$. We can choose $\epsilon$ small enough to get $I_{2} \leq \frac{\theta}{2}$.
Then for all $\theta>0$, there exists $\epsilon_{0}$ such that for all $0<\epsilon<\epsilon_{0}$, we have $|I| \leq \theta$. Therefore we get the conclusion.

From (48), one gets

$$
\lim _{\epsilon \rightarrow 0} \mathcal{F}\left(F_{1 \epsilon} \otimes F_{2 \epsilon}\right)(x, y)=\mathcal{F} T_{1}(x) \mathcal{F} T_{2}(y)=\frac{C_{\beta} C_{\bar{\beta}}}{|x|^{1+\beta}|y|^{1+\bar{\beta}}} .
$$

Moreover $\mathcal{F}^{-1}(d \mu)(x, y)=\frac{\mathbb{E} e^{i x U+i y V}}{2 \pi}$. We use Theorem4.1, Lemma4.1 and the following lemma to deduce that

$$
\int_{\mathbb{R}^{2}} \frac{\left|\mathcal{F}^{-1}(d \mu)(x, y)\right|}{|x|^{1+\operatorname{Re}(\beta)}|y|^{1+R e(\bar{\beta})}} d x d y=\int_{\mathbb{R}^{2}} \frac{\mathbb{E} e^{i x U+i y V}}{2 \pi|x|^{1+\operatorname{Re}(\beta)}|y|^{1+\operatorname{Re}(\bar{\beta})}} d x d y<+\infty .
$$

Lemma 4.9. Set

$$
\begin{aligned}
M_{U, V}(x, y) & =\mathbb{E} e^{i x U+i y V}-\mathbb{E} e^{i x U} \mathbb{E} e^{i y V}, I=\int_{\mathbb{R}^{2}} \frac{\left|M_{U, V}(x, y)\right|}{|x y|^{1+R e(\beta)}} d x d y . \\
{[U, V]_{2} } & =\int_{S}|h(s) g(s)|^{\alpha / 2} \leq \eta<1,
\end{aligned}
$$

where $U, V$ are defined as in Theorem 4.2. Then $I \leq C(\eta)[U, V]_{2}<\infty$, where the constant $C(\eta)$ depends on $\eta$.

Proof. We just need to consider the integral only over $(0,+\infty) \times(0,+\infty)$. We divide this domain into four regions $(0,1) \times(0,1),(0,1) \times(1,+\infty),(1,+\infty) \times(0,1),(1,+\infty) \times(1,+\infty)$ and let $I_{1}, I_{2}, I_{3}, I_{4}$ be the integrals over those domains, respectively.
Over $(0,1) \times(0,1)$, by using inequality (3.4) in [20] we get

$$
I_{1} \leq \int_{0}^{1} \int_{0}^{1} \frac{\left|M_{U, V}(x, y)\right|}{|x y|^{1+\operatorname{Re}(\beta)}} d x d y \leq 2 \int_{0}^{1} \int_{0}^{1}(x y)^{\alpha / 2-1-\operatorname{Re}(\beta)} d x d y[U, V]_{2}=C[U, V]_{2}
$$

Over $(1,+\infty) \times(1,+\infty)$, by using inequality (3.6) in [20] and assumptions

$$
\|U\|_{\alpha}^{\alpha}=1,\|V\|_{\alpha}^{\alpha}=1,[U, V]_{2}=\int_{S}|f(s) g(s)|^{\alpha / 2} \leq \eta<1,
$$

we can bound the integral over this domain by

$$
I_{2} \leq 2 \int_{1}^{+\infty} \int_{1}^{+\infty}(x y)^{\alpha / 2-1-R e(\beta)} e^{-2(1-\eta)(x y)^{\alpha / 2}} d x d y[U, V]_{2} .
$$

Here we can bound $e^{-2(1-\eta)(x y)^{\alpha / 2}}$ up to a constant depending on $\eta$ by $(x y)^{-p}$ for arbitrarily large $p>0$. So $I_{2} \leq C(\eta)[U, V]_{2}$. Over $(0,1) \times(1,+\infty)$, by using inequality (3.5) in [20] we obtain a bound

I_{3} & \leq 2 \int_{0}^{1} \int_{1}^{+\infty}(x y)^{\alpha / 2-1-R e(\beta)} e^{-\left(x^{\alpha / 2}-y^{\alpha / 2}\right)^{2}} d x d y[U, V]_{2} \\
& \leq 2 \int_{0}^{1} \int_{1}^{+\infty}(x y)^{\alpha / 2-1-R e(\beta)} e^{-\left(y^{\alpha / 2}-1\right)^{2}} d x d y[U, V]_{2} \\
& \leq C \int_{1}^{+\infty}(x y)^{\alpha / 2-1-\operatorname{Re}(\beta)} e^{-\left(y^{\alpha / 2}-1\right)^{2}} d x d y[U, V]_{2} \\
& =C \int_{1}^{+\infty} y^{\alpha / 2-1-\operatorname{Re}(\beta)} e^{-\left(y^{\alpha / 2}-1\right)^{2}} d y[U, V]_{2} .
\end{aligned}
$$

Since $\int_{1}^{+\infty} y^{\alpha / 2-1-\operatorname{Re}(\beta)} e^{-\left(y^{\alpha / 2}-1\right)^{2}} d y<+\infty$, we get $I_{3} \leq C[U, V]_{2}$.
A similar bound holds for $I_{4}$. Then we have the conclusion.
By Lebesgue dominated convergence theorem, as $\epsilon \rightarrow 0$, the right-hand side of (47) converges to

It is clear that $\left|F_{1 \epsilon}(x)\right| \leq C|x|^{\operatorname{Re}(\beta)},\left|F_{2 \epsilon}(y)\right| \leq C|y|^{\operatorname{Re}(\bar{\beta})}$. Moreover

$$

since $\operatorname{Re}(\beta) \in(-1 / 2,0)$.
We can therefore apply Lebesgue dominated convergence theorem for the left-hand side of (47). As $\epsilon \rightarrow 0$, it converges to

This proves the result (411). Now we prove (42).

\mathbb{E}|U|^{\beta}|V|^{\bar{\beta}} & =\frac{C_{\beta} C_{\bar{\beta}}}{2 \pi} \int_{\mathbb{R}^{2}} \frac{\mathbb{E} e^{i x U+i y V}}{|x|^{1+\beta}|y|^{1+\bar{\beta}}} d x d y .
\end{aligned}
$$

Then

$$
\begin{aligned}
\left|\operatorname{cov}\left(|U|^{\beta},|V|^{\beta}\right)\right| & =\left.|\mathbb{E}| U\right|^{\beta}|V|^{\bar{\beta}}-\mathbb{E}|U|^{\beta} \mathbb{E}|V|^{\bar{\beta}}\left|=\left|C_{\beta} C_{\bar{\beta}} \int_{\mathbb{R}^{2}} \frac{\mathbb{E} e^{i x U+i y V}-\mathbb{E} e^{i x U} \mathbb{E} e^{i y V}}{|x|^{1+\beta}|y|^{1+\bar{\beta}}} d x d y\right|\right. \\
& \leq\left|C_{\beta} C_{\bar{\beta}}\right| \int_{\mathbb{R}^{2}} \frac{\left|\mathbb{E} e^{i x U+i y V}-\mathbb{E} e^{i x U} \mathbb{E} e^{i y V}\right|}{|x y|^{1+\operatorname{Re}(\beta)}} d x d y
\end{aligned}
$$

Applying Lemma 4.9, we obtain (42).

### 4.1.5 Proof of Lemma 4.2

For the case $\alpha=2$, let $Y$ be a standard $S 2 S$ variable. Then for $-1<\operatorname{Re}(\beta)<0$, we have

$$

By making the change of variable $y^{\alpha}=t$, then

\mathbb{E}|X|^{\beta}=\frac{2 C_{\beta}}{\sqrt{2 \pi}} \int_{0}^{+\infty} t^{-\beta / \alpha-1} e^{-t} d t=\frac{2 C_{\beta}}{\sqrt{2 \pi}} \int_{0}^{+\infty} t^{-\beta / \alpha-1} e^{-t} d t=\frac{\sqrt{2} C_{\beta} \Gamma(-\beta / \alpha)}{\alpha \sqrt{\pi}}
$$

Since $\Gamma(x+1)=x \Gamma(x)$, one gets

From the fact that $X$ is a $S \alpha S$ process, one can write

Proof of Theorem 2.1. In this proof, we shall denote by $C$ a generic constant which may change from occurrence to occurrence.
We will prove that $W_{n}(\beta)-\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}=O_{\mathbb{P}}\left(b_{n}\right)$ where $b_{n}$ is defined by (11).
Indeed, from Lemma 4.1, it follows that $\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}<+\infty$.
Because of $H$-self similarity and stationary increment properties of $X$, one has

We get $\mathbb{E}\left|\triangle_{p, n} X\right|^{\beta}=\frac{\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}}{n^{\beta} H}$ and $\mathbb{E} W_{n}(\beta)=\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}$. Now we will prove that $W_{n}(\beta) \xrightarrow{(\mathbb{P})} \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}$ when $n \rightarrow \infty$.
We have

\mathbb{E}\left|W_{n}(\beta)\right|^{2}=\frac{n^{2 \beta H}}{(n-K+1)^{2}} \sum_{p, p^{\prime}=0}^{n-K} \mathbb{E}\left|\triangle_{p, n} X\right|^{\beta}\left|\triangle_{p^{\prime}, n} X\right|^{\beta} .
$$

Moreover

$$
\begin{aligned}
\left|\triangle_{p, n} X\right|^{\beta}\left|\triangle_{p^{\prime}, n} X\right|^{\beta} & \stackrel{(d)}{=}\left|\sum_{k=0}^{K} \frac{a_{k}}{n^{H}} X(k+p)\right|^{\beta}\left|\sum_{k=0}^{K} \frac{a_{k}}{n^{H}} X\left(k+p^{\prime}\right)\right|^{\beta} \\
& =\frac{1}{n^{2 \beta H}}\left|\sum_{k=0}^{K} a_{p}\left[X(k+p)-X\left(p^{\prime}\right)\right]\right|^{\beta}\left|\sum_{k=0}^{K} a_{k}\left[X\left(k+p^{\prime}\right)-X\left(p^{\prime}\right)\right]\right|^{\beta} \\
& \stackrel{(d)}{=} \frac{1}{n^{2 \beta H}}\left|\sum_{k=0}^{K} a_{k} X\left(k+p-p^{\prime}\right)\right|^{\beta}\left|\sum_{k=0}^{K} a_{k} X(k)\right|^{\beta} \\
& =\frac{1}{n^{2 \beta H}}\left|\triangle_{p-p^{\prime}, 1} X\right|^{\beta}\left|\triangle_{0,1} X\right|^{\beta} .
\end{aligned}
$$

It follows that

$$
\mathbb{E}\left|\triangle_{p, n} X\right|^{\beta}\left|\triangle_{p^{\prime}, n} X\right|^{\beta}=\frac{\mathbb{E}\left|\triangle_{p-p^{\prime}, 1} X\right|^{\beta}\left|\triangle_{0,1} X\right|^{\beta}}{n^{2 \beta H}}=\frac{\mathbb{E}\left|\triangle_{k, 1} X\right|^{\beta}\left|\triangle_{0,1} X\right|^{\beta}}{n^{2 \beta H}}
$$

with $k=p-p^{\prime}$. Thus

\mathbb{E}\left|W_{n}(\beta)\right|^{2}=\frac{1}{n-K+1} \sum_{|k| \leq n-K}\left(1-\frac{|k|}{n-K+1}\right) \mathbb{E}\left|\triangle_{k, 1} X\right|^{\beta}\left|\triangle_{0,1} X\right|^{\beta} .
$$

One has

\left.\left.\mathbb{E}\left|W_{n}(\beta)-\mathbb{E}\right| \triangle_{0,1} X\right|^{\beta}\right|^{2}=\mathbb{E}\left|W_{n}(\beta)\right|^{2}-\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta} \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta} .
$$

On the other hand, since $\mathbb{E}\left|\triangle_{k, 1} X\right|^{\beta}=\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}$ and $\frac{1}{n-K+1} \sum_{|k| \leq n-K}\left(1-\frac{|k|}{n-K+1}\right)=1$, it follows that

\left.\left.\mathbb{E}\left|W_{n}(\beta)-\mathbb{E}\right| \triangle_{0,1} X\right|^{\beta}\right|^{2}=\frac{1}{n-K+1} \sum_{|k| \leq n-K}\left(1-\frac{|k|}{n-K+1}\right) \operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right) \tag{49}
\end{equation*}
$$

Using (49) and the assumption (11), one obtains

Then $f\left(X_{n}, Y_{n}\right)-f(a, b)=O_{\mathbb{P}}\left(b_{n}\right)$.

By applying Lemma 2.12 in [26] for $R(x, y)=f(a+x, b+y)-f(a, b)-x \frac{\partial f}{\partial x}(a, b)-y \frac{\partial f}{\partial y}(a, b)$ and the sequence random vector $\left(X_{n}-a, Y_{n}-b\right)$, we get

& =\left(X_{n}-a\right) O_{\mathbb{P}}(1)+\left(Y_{n}-a\right) O_{\mathbb{P}}(1)+o_{\mathbb{P}}\left(\left\|\left(X_{n}-a, Y_{n}-b\right)\right\|\right) \\
& =b_{n} O_{\mathbb{P}}(1) O_{\mathbb{P}}(1)+b_{n} O_{\mathbb{P}}(1) O_{\mathbb{P}}(1)+b_{n} O_{\mathbb{P}}(1) o_{\mathbb{P}}(1) \\
& =b_{n} O_{\mathbb{P}}(1)+b_{n} O_{\mathbb{P}}(1)+b_{n} o_{\mathbb{P}}(1) \\
& =b_{n} O_{\mathbb{P}}(1)
\end{aligned}
$$

Applying Lemma 4.10 with $f=\phi$ and vector $\left(\mathbb{E}\left|\triangle_{0,1} X\right| \beta, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}\right)$, combining with (50), (51) and the fact that $\phi\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}\right)=0$, it follows that $\widehat{H}_{n}-H=O_{\mathbb{P}}\left(b_{n}\right)$.
Since $\lim _{n \rightarrow+\infty} b_{n}=0$, it induces that $\lim _{n \rightarrow+\infty} \widehat{H}_{n} \stackrel{(\mathbb{P})}{=} H$.
To prove that $\widehat{\alpha}_{n}-\alpha=O_{\mathbb{P}}\left(b_{n}\right)$, we first prove that

where $h_{u, v}, \psi_{u, v}$ are defined by (8), (7), respectively.
Indeed, since $\left\{X_{t}, t \in \mathbb{R}\right\}$ is a $H$-sssi $S \alpha S$-stable process, there exists a constant $\sigma>0$ such that $\triangle_{0,1} X=\sigma Y$, where $Y$ is the standard $H$-sssi, $S \alpha S$ random variable. For $\beta_{1}, \beta_{2} \in \mathbb{R},-1 / 2<\beta_{1}, \beta_{2}<0$, from Lemma 4.2, we have

\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}=\sigma^{\beta_{1}} \mathbb{E}|Y|^{\beta_{1}}=\sigma^{\beta_{1}} \frac{2^{\beta_{1}} \Gamma\left(\frac{\beta_{1}+1}{2}\right) \Gamma\left(1-\frac{\beta_{1}}{\alpha}\right)}{\sqrt{\pi} \Gamma\left(1-\frac{\beta_{1}}{2}\right)}
$$

Thus

\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}\right)^{\beta_{2}}=\sigma^{\beta_{1} \beta_{2}}\left(\frac{2^{\beta_{1}} \Gamma\left(\frac{\beta_{1}+1}{2}\right) \Gamma\left(1-\frac{\beta_{1}}{\alpha}\right)}{\sqrt{\pi} \Gamma\left(1-\frac{\beta_{1}}{2}\right)}\right)^{\beta_{2}}
$$

Similarly, we also get

Moreover, from Lemma 4.3, $\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta} \neq 0$ for all $-1 / 2<\beta<0$, then it induces

& \beta_{2} \ln \left(\Gamma\left(\frac{\beta_{1}+1}{2}\right)\right)+\beta_{2} \ln \left(\Gamma\left(1-\frac{\beta_{1}}{\alpha}\right)\right) \\
& -\beta_{2} \ln \left(\Gamma\left(1-\frac{\beta_{1}}{2}\right)\right)-\beta_{1} \ln \left(\Gamma\left(\frac{\beta_{2}+1}{2}\right)\right)-\beta_{1} \ln \left(\Gamma\left(1-\frac{\beta_{2}}{\alpha}\right)\right) .
\end{aligned}
$$

It follows that

\beta_{2} \ln \left(\Gamma\left(1-\frac{\beta_{1}}{\alpha}\right)\right)-\beta_{1} \ln \left(\Gamma\left(1-\frac{\beta_{2}}{\alpha}\right)\right)= & \beta_{2} \ln \left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}\right)-\beta_{1} \ln \left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{2}}\right) \\
& +\frac{\beta_{2}-\beta_{1}}{2} \ln (\pi)-\beta_{1} \ln \left(\Gamma\left(1-\frac{\beta_{2}}{2}\right)\right)-\beta_{2} \ln \left(\Gamma\left(\frac{\beta_{1}+1}{2}\right)\right) \\
& +\beta_{2} \ln \left(\Gamma\left(1-\frac{\beta_{1}}{2}\right)\right)+\beta_{1} \ln \left(\Gamma\left(\frac{\beta_{2}+1}{2}\right)\right)
\end{aligned}
$$

or $h_{-\beta_{1},-\beta_{2}}(\alpha)=\psi_{-\beta_{1},-\beta_{2}}\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{2}}\right)$.
From the following lemma, we can deduce that $h_{u, v}$ is a strictly increasing function on $(0,+\infty)$ and $\lim _{x \rightarrow+\infty} h_{u, v}(x)=0, \lim _{x \rightarrow 0} h_{u, v}(x)=-\infty$. Moreover, there exists an inverse function

which is continuous and on $(-\infty, 0)$.

Since $\Gamma(x+1)=x \Gamma(x)$, we have $\Gamma^{\prime}(x+1)=\Gamma(x)+x \Gamma^{\prime}(x)$. We obtain

However, $x_{0}+1<y_{0}+1$, then $\psi\left(x_{0}+1\right) \leq \psi\left(y_{0}+1\right)$ but this could not happen. Thus $\psi$ is a strictly increasing function.
We also have $1<1+v x<1+u x$, so $\frac{\Gamma^{\prime}(1+v x)}{\Gamma(1+v x)}-\frac{\Gamma^{\prime}(1+u x)}{\Gamma(1+u x)}<0$.
It induces that $g_{u, v}^{\prime}(x)<0$ for all $0<v<u$ and $x>0$. This proves that $g_{u, v}(x)$ is a strictly decreasing function.
It is clear that $\lim _{x \rightarrow 0} g_{u, v}(x)=0$. Now we need to prove that $\lim _{x \rightarrow+\infty} g_{u, v}(x)=-\infty$.
Applying Stirling's formula, we have

Since $0<v<u$ we deduce $u v(\ln v-\ln u)<0$. Moreover $\lim _{x \rightarrow+\infty} \frac{\ln x}{x}=0$, it follows that

We deduce that

\hat{\alpha}_{n}-\alpha & =\varphi_{-\beta_{1},-\beta_{2}}\left(\psi_{-\beta_{1},-\beta_{2}}\left(W_{n}\left(\beta_{1}\right), W_{n}\left(\beta_{2}\right)\right)\right)-h_{-\beta_{1},-\beta_{2}}^{-1}\left(h_{-\beta_{1},-\beta_{2}}(\alpha)\right) \\
& =\varphi_{-\beta_{1},-\beta_{2}}\left(\psi_{-\beta_{1},-\beta_{2}}\left(W_{n}\left(\beta_{1}\right), W_{n}\left(\beta_{2}\right)\right)\right)-\varphi_{-\beta_{1},-\beta_{2}}\left(h_{-\beta_{1},-\beta_{2}}(\alpha)\right) \\
& =\varphi_{-\beta_{1},-\beta_{2}}\left(\psi_{-\beta_{1},-\beta_{2}}\left(W_{n}\left(\beta_{1}\right), W_{n}\left(\beta_{2}\right)\right)\right)-\varphi_{-\beta_{1},-\beta_{2}}\left(\psi_{-\beta_{1},-\beta_{2}}\left(\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{1}}, \mathbb{E}\left|\triangle_{0,1} X\right|^{\beta_{2}}\right)\right)
\end{aligned}
$$

Moreover, $\varphi_{-\beta_{1},-\beta_{2}} \circ \psi_{-\beta_{1},-\beta_{2}}$ is continuous and differentiable at

& =\left(\operatorname{var} \triangle_{0,1} X\right)^{\beta / 2}\left(\frac{\sqrt{n}}{n-K+1} \sum_{k=0}^{n-K}\left(\left|Y_{k}\right|^{\beta}-\mathbb{E}\left|Z_{0}\right|^{\beta}\right), \frac{\sqrt{n}}{n / 2-K+1} \sum_{l=0}^{n / 2-K}\left(\left|Z_{l}\right|^{\beta}-\mathbb{E}\left|Z_{0}\right|^{\beta}\right)\right) \\
& =\left(\frac{\sqrt{n}}{n-K+1} \sum_{k=0}^{n-K} f_{\beta}\left(Y_{k}\right), \frac{\sqrt{n}}{n / 2-K+1} \sum_{l=0}^{n / 2-K} f_{\beta}\left(Z_{l}\right)\right)
\end{aligned}
$$

where $Y_{k}=\frac{\Delta_{k, 2} X}{\sqrt{\operatorname{var} \Delta_{k, 2} X}}, Z_{l}=\frac{\Delta_{l, 1} X}{\sqrt{\operatorname{var} \Delta_{l, 1} X}}$ and $f_{\beta}$ is defined by (12).

We can therefore apply Theorem 3.1 of [10] to get the conclusion.

Proof of Theorem 3.2, a) We will check the assumption (11).

\sum_{k \in \mathbb{Z},|k| \leq n}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right| & =\sum_{k \in \mathbb{Z},|k| \leq k_{0}}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right|+\sum_{k \in \mathbb{Z}, k_{0}<|k| \leq n}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right| \\
& \leq C \sum_{k \in \mathbb{Z},|k| \leq k_{0} \mathbb{R}} \int_{k \in \mathbb{Z}, k_{0}<|k| \leq n}|f(s-k) f(s)|^{\alpha / 2} d s+\left.C\right|^{\frac{\alpha H-(L+1) \alpha}{2}} .
\end{aligned}
$$

Because $f(x) \in L^{\alpha}(\mathbb{R}, d x)$, one has $\sum_{k \in \mathbb{Z},|k| \leq k_{0}} \int_{\mathbb{R}}|f(s-k) f(s)|^{\alpha / 2} d s<+\infty$.
Then $S_{n}=\frac{C}{n} \sum_{k \in \mathbb{Z}, k_{0}<|k| \leq n}|k|^{\frac{\alpha H-(L+1) \alpha}{2}}$.
Since $\alpha H-(L+1) \alpha<0$, using Lemma 5.4 in Appendix, we also get

$$
S_{n}= \begin{cases}O\left(n^{-1}\right) & \text { if } H<L+1-\frac{2}{\alpha} \\ O\left(n^{\frac{\alpha H-(L+1) \alpha}{2}}\right) & \text { if } H>L+1-\frac{2}{\alpha}, \\ O\left(\frac{\ln n}{n}\right) & \text { if } H=L+1-\frac{2}{\alpha}\end{cases}
$$

where $S_{n}$ is defined by (66). Applying Theorem 2.1, we have

$$
W_{n}(\beta)-\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}=O_{\mathbb{P}}\left(b_{n}\right), \widehat{H}_{n}-H=O_{\mathbb{P}}\left(b_{n}\right),
$$

where $b_{n}$ is defined by (355).
Proof of Theorem 3.4, We have

$$
\begin{aligned}
\triangle_{k, 1} X & =\int_{0}^{+\infty} \int_{\mathbb{R}}\left(\sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{k+i}}(x, r)\right) M(d x, d r) \\
\left\|\triangle_{k, 1} X\right\|_{\alpha}^{\alpha} & =\int_{0}^{+\infty} \int_{\mathbb{R}}\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{k+i}}(x, r)\right|^{\alpha}\left(r^{\nu-2}\right)^{\alpha} d x d r \\
& =\int_{0}^{+\infty} \int_{\mathbb{R}}\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{i}}(x-k, r)\right|^{\alpha}\left(r^{\nu-2}\right)^{\alpha} d(x-k) d r .
\end{aligned}
$$

By taking the change of variable $u=x-k$, one obtains that

$$
\left\|\triangle_{k, 1} X\right\|_{\alpha}^{\alpha}=\int_{0}^{+\infty} \int_{\mathbb{R}}\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{i}}(u, r)\right|^{\alpha}\left(r^{\nu-2}\right)^{\alpha} d u d r=\left\|\triangle_{0,1} X\right\|_{\alpha}^{\alpha} .
$$

Set $U_{k}=\frac{\Delta_{k, 1} X}{\left\|\Delta_{k, 1} X\right\|_{\alpha}}=\frac{\Delta_{k, 1} X}{\left\|\Delta_{0,1} X\right\|_{\alpha}}$. Obviously, $\left\|U_{k}\right\|_{\alpha}^{\alpha}=1$. We now prove that the condition (11) is satisfied. Set

$$
I_{n}=\sum_{k \in \mathbb{Z},|k| \leq n}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right|=\left\|\triangle_{0,1} X\right\|_{\alpha}^{\beta} \sum_{k \in \mathbb{Z},|k| \leq n}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right| .
$$

For $n>2 K$, applying Lemma 5.3 in Appendix, one gets

$$
\begin{aligned}
I_{n} & \leq C\left(\sum_{k \in \mathbb{Z},|k| \leq 2 K}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right|+\sum_{k \in \mathbb{Z}, 2 K<|k| \leq n}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right|\right) \\
& \leq C\left(\sum_{k \in \mathbb{Z},|k| \leq 2 K}\left|\operatorname{cov}\left(\left|U_{k}\right|^{\beta},\left|U_{0}\right|^{\beta}\right)\right|+\sum_{k \in \mathbb{Z}, 2 K<|k| \leq n}|k|^{\nu-1}\right) .
\end{aligned}
$$

Since $0<\nu<1$, one gets $-1<\nu-1<0$. Following Lemma 5.4 in Appendix, one obtains

$$
\frac{1}{n} \sum_{k \in \mathbb{Z}, 2 K<|k| \leq n}|k|^{\nu-1}=O\left(n^{\nu-1}\right) .
$$

Then we get the condition (11). Applying Theorem [2.1, we obtain that $W_{n}(X)-\mathbb{E}\left|\triangle_{0,1} X\right|^{\beta}=O_{\mathbb{P}}\left(b_{n}\right)$ and

$$
\widehat{H}_{n}-H=O_{\mathbb{P}}\left(b_{n}\right), \hat{\alpha}_{n}-\alpha=O_{\mathbb{P}}\left(b_{n}\right)
$$

where $b_{n}$ is defined as in (37).

## 5 Appendix

We present here some technical results related to examples introduced in Section [3,

### 5.1 Auxiliary results related to Fractional Brownian motion

We are in position to provide and prove some technical results related to fractional Brownian motion. These results are used to present the variances for the limit distributions of the central limit theorems for the estimators of $H$ and $\alpha$ and to prove Theorem [3.1 in Subsection 4.3],
Proposition 5.1. Let $X$ be a $H$ fractional Brownian motion with $H \in(0,1)$. For $\beta \in \mathbb{R},-1 / 2<\beta<0$, let $f_{\beta}$ be defined as in (12),

$$
f_{\beta}={\sqrt{\operatorname{var} \triangle_{0,1} X}}^{\beta}\left(|x|^{\beta}-\mathbb{E}\left|Z_{0}\right|^{\beta}\right)
$$

where $Z_{0}=\frac{\Delta_{0,1} X}{\sqrt{\text { var } \triangle_{0,1} X}}$. Then $f_{\beta}$ can be expanded in a unique way into series of Hermite polynomials

$$
f_{\beta}(x)=\sum_{q \geq d} f_{\beta, q} H_{q}(x)
$$

and $\sum_{q \geq d} q!f_{\beta, q}^{2}<+\infty$, where $d$ is the Hermite rank of $f_{\beta}$, moreover $d \geq 2$.
Proof. Since $-1 / 2<\beta<0$, one has $\frac{1}{\sqrt{2 \pi}} \int_{\mathbb{R}} f_{\beta}(x) e^{-x^{2} / 2} d x=0$ and $\frac{1}{\sqrt{2 \pi}} \int_{\mathbb{R}} f_{\beta}^{2}(x) e^{-x^{2} / 2} d x<+\infty$. Then following Proposition 1.4.2-(iv) in [19, we can write $f_{\beta}$ in terms of Hermite polynomials in a unique way

$$
f_{\beta}(x)=\sum_{q \geq d} f_{\beta, q} H_{q}(x),
$$

where $d \geq 1$ is the Hermite rank of $f_{\beta}$ and $H_{q}$ s are the Hermite polynomials.
Moreover, it is clear that $Z_{0} \sim \mathcal{N}(0,1)$. From Proposition 2.2.1 in [19], we get

$$
\mathbb{E}\left[H_{p}\left(Z_{0}\right) H_{q}\left(Z_{0}\right)\right]= \begin{cases}0 & \text { if } p \neq q \\ p! & \text { if } p=q\end{cases}
$$

Then since $H_{1}(x)=x$, one has $\mathbb{E} H_{1}\left(Z_{0}\right) f_{\beta}\left(Z_{0}\right)=\mathbb{E} Z_{0} f_{\beta}\left(Z_{0}\right)=f_{\beta, 1} \mathbb{E} Z_{0}^{2}=f_{\beta, 1}$. Combining with the fact that

$$
\mathbb{E} H_{1}\left(Z_{0}\right) f_{\beta}\left(Z_{0}\right)=\frac{\left(\operatorname{var} \triangle_{0,1} X\right)^{\beta}}{\sqrt{2 \pi}} \int_{\mathbb{R}} x\left(|x|^{\beta}-\mathbb{E}\left|Z_{0}\right|^{\beta}\right) e^{-x^{2} / 2} d x=0,
$$

we deduce that $f_{\beta, 1}=0$. It follows that $d \geq 2$.
Moreover,

$$
\mathbb{E} f_{\beta}^{2}\left(Z_{0}\right)=\frac{1}{\sqrt{2 \pi}} \int_{\mathbb{R}} f_{\beta}^{2}(x) e^{-x^{2} / 2} d x<+\infty
$$

On the other hand,

$$
\mathbb{E} f_{\beta}^{2}\left(Z_{0}\right)=\sum_{p, q \geq d} f_{\beta, p} f_{\beta, q} \mathbb{E}\left[H_{p}\left(Z_{0}\right) H_{q}\left(Z_{0}\right)\right]=\sum_{q \geq d} q!f_{\beta, q}^{2}
$$

It follows that $\sum_{q \geq d} q!f_{\beta, q}^{2}<+\infty$.
Lemma 5.1. Let $(U, V) \stackrel{(d)}{=} \mathcal{N}_{2}\left((0,0),\left(\begin{array}{ll}1 & \rho \\ \rho & 1\end{array}\right)\right),|\rho| \leq 1$. Then for each $\beta \in \mathbb{C}, \operatorname{Re}(\beta) \in(-1 / 2,0)$, there exists a constant $C>0$ such that $\forall|\rho| \leq 1$, we have:

$$
\left|\operatorname{cov}\left(|U|^{\beta},|V|^{\beta}\right)\right| \leq C \rho^{2}
$$

Proof. Let $\Sigma=\left(\begin{array}{ll}1 & \rho \\ \rho & 1\end{array}\right)$. We have $\operatorname{det}(\Sigma)=1-\rho^{2}$ and $\Sigma^{-1}=\frac{1}{1-\rho^{2}}\left(\begin{array}{ll}1 & \rho \\ \rho & 1\end{array}\right)$. The density function of ( $U, V)$ :

$$
f(x, y)=|2 \pi \Sigma|^{-1 / 2} \exp \left[-\frac{1}{2}(x y) \Sigma^{-1}\binom{x}{y}\right]=\left((2 \pi)^{2} \operatorname{det} \Sigma\right)^{-1 / 2} \exp \left[-\frac{1}{2\left(1-\rho^{2}\right)}\left(x^{2}+y^{2}-2 \rho x y\right)\right]
$$

We get

$$
\begin{aligned}
& \mathbb{E}\left(|U|^{\beta}|V|^{\bar{\beta}}\right)=\frac{1}{2 \pi \sqrt{1-\rho^{2}}} \int_{\mathbb{R}^{2}}|x|^{\beta}|y|^{\bar{\beta}} \exp \left[-\frac{1}{2\left(1-\rho^{2}\right)}\left(x^{2}+y^{2}-2 \rho x y\right)\right] d x d y \\
& \mathbb{E}|U|^{\beta} \mathbb{E}|V|^{\bar{\beta}}=\frac{1}{2 \pi} \int_{\mathbb{R}^{2}}|x|^{\beta}|y|^{\bar{\beta}} \exp \left(-\frac{x^{2}+y^{2}}{2}\right) d x d y
\end{aligned}
$$

and

$$
\begin{aligned}
\operatorname{cov}\left(|U|^{\beta},|V|^{\beta}\right) & =\mathbb{E}\left(|U|^{\beta}|V|^{\bar{\beta}}\right)-\mathbb{E}|U|^{\beta} \mathbb{E}|V|^{\bar{\beta}} \\
& =\frac{1}{2 \pi} \int_{\mathbb{R}^{2}}|x|^{\beta}|y|^{\bar{\beta}} \exp \left(-\frac{x^{2}+y^{2}}{2}\right) A_{\rho}(x, y) d x d y
\end{aligned}
$$

where

$$
A_{\rho}(x, y)=\frac{1}{\sqrt{1-\rho^{2}}} \exp \left(-\frac{\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\rho x y}{1-\rho^{2}}\right)-1 .
$$

Since $\int_{\mathbb{R}}|x|^{\beta} x e^{-x^{2} / 2} d x=0$ we obtain that

$$
\operatorname{cov}\left(|U|^{\beta},|V|^{\beta}\right)=\frac{1}{2 \pi} \int_{\mathbb{R}^{2}}|x|^{\beta}|y|^{\bar{\beta}} \exp \left(-\frac{x^{2}+y^{2}}{2}\right) B_{\rho}(x, y) d x d y
$$

with

$$
B_{\rho}(x, y)=A_{\rho}(x, y)-\rho x y=\frac{1}{\sqrt{1-\rho^{2}}} \exp \left(-\frac{\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\rho x y}{1-\rho^{2}}\right)-1-\rho x y .
$$

Using L'Hôpital rule, we get:

$$
\begin{aligned}
\lim _{\rho \rightarrow 0} \frac{B_{\rho}}{\rho^{2}} & =\lim _{\rho \rightarrow 0} \frac{B_{\rho}^{\prime}}{2 \rho} \\
B_{\rho}^{\prime} & =A_{\rho}^{\prime}(x, y)-x y \\
& =\left[\left(\rho\left(1-\rho^{2}\right)^{\frac{-3}{2}}-\left(x^{2}+y^{2}\right)\left[2 \rho\left(1-\rho^{2}\right)^{-1}+2 \rho^{3}\left(1-\rho^{2}\right)^{-2}\right]\right)+x y\left(\left(1-\rho^{2}\right)^{-1}+2 \rho^{2}\left(1-\rho^{2}\right)^{-2}\right)\right] \\
& \times \exp \left(-\frac{\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\rho x y}{1-\rho^{2}}\right)-x y \\
\lim _{\rho \rightarrow 0} \frac{B_{\rho}^{\prime}}{2 \rho} & =x y \cdot \lim _{\rho \rightarrow 0} \frac{\left[\exp \left(\frac{-\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)+\frac{\rho x y}{1-\rho^{2}}\right)\left(1-\rho^{2}\right)^{-1}-1\right]}{2 \rho}+\frac{1}{2}-\left(x^{2}+y^{2}\right):=A+\frac{1}{2}-\left(x^{2}+y^{2}\right) .
\end{aligned}
$$

Then we continue using L'Hôpital rule for the remaining limit:

$$
\begin{aligned}
A= & \frac{x y}{2} \lim _{\rho \rightarrow 0} \exp \left(\frac{-\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)+\frac{\rho x y}{1-\rho^{2}}\right) \times \\
& {\left[\frac{2 \rho}{\left(1-\rho^{2}\right)^{2}}-\left(x^{2}+y^{2}\right)\left(\frac{2 \rho}{1-\rho^{2}}+\frac{2 \rho^{3}}{\left(1-\rho^{2}\right)^{2}}\right)+x y\left(\frac{1}{1-\rho^{2}}+\frac{2 \rho^{2}}{(1-\rho)^{2}}\right)\right] } \\
= & \frac{x^{2} y^{2}}{2} .
\end{aligned}
$$

One has

$$
\begin{aligned}
\lim _{\rho \rightarrow 0} \frac{B_{\rho}}{\rho^{2}} & =\frac{x^{2} y^{2}+1}{2}-\left(x^{2}+y^{2}\right) \\
\frac{\partial^{2} B_{\rho}(x, y)}{\partial \rho^{2}} & =P_{\rho}(x, y) \exp \left(-\frac{\rho^{2}}{1-\rho^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\rho x y}{1-\rho^{2}}\right) .
\end{aligned}
$$

where $P_{\rho}(x, y)$ is a fourth degree polynomial that depends continuously on $\rho$. We also have

$$
B_{0}(x, y)=0,\left.B_{\rho}^{\prime}(x, y)\right|_{\rho=0}=0 .
$$

A Taylor expansion up to order 2 leads to

$$
B_{\rho}(x, y)=\rho^{2} P_{\tilde{\rho}}(x, y) \exp \left(-\frac{\tilde{\rho}^{2}}{1-\tilde{\rho}^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\tilde{\rho} x y}{1-\tilde{\rho}^{2}}\right)
$$

with $\tilde{\rho} \in(0, \rho)$. On the compact set $|\rho| \leq 1 / 2$, the polynomial $P_{\rho}(x, y)$ can be bounded by a fourth degree polynomial $P(x, y)$, for all $x, y \in \mathbb{R},\left|P_{\rho}(x, y)\right| \leq|P(|x|,|y|)|$. Moreover

$$
\exp \left(-\frac{\tilde{\rho}^{2}}{1-\tilde{\rho}^{2}}\left(x^{2}+y^{2}\right)\right) \exp \left(\frac{\tilde{\rho} x y}{1-\tilde{\rho}^{2}}\right) \leq \exp \left(\frac{\tilde{\rho} x y}{1-\tilde{\rho}^{2}}\right) .
$$

But with $|\tilde{\rho}| \leq 1 / 2$, we get $\left|\frac{\tilde{\rho}}{1-\tilde{\rho}^{2}}\right| \leq 2 / 3$. So $\exp \left(\frac{\tilde{\rho} x y}{1-\tilde{\rho}^{2}}\right) \leq \exp \left(\frac{2|x y|}{3}\right)$. Thus

$$
\left|B_{\rho}(x, y)\right| \leq \rho^{2}|P(|x|,|y|)| \exp \left(\frac{2|x y|}{3}\right) .
$$

Because the power function grows faster than the polynomial function, we have

$$
\left.\int_{\mathbb{R}^{2}}|x y|^{R e(\beta)} \exp \left(-\frac{x^{2}+y^{2}}{2}\right) P(|x|,|y|) \right\rvert\, \exp \left(\frac{2|x y|}{3}\right) d x d y<\infty .
$$

So we have the conclusion.

Lemma 5.2. Let $X$ be a fractional Brownian motion, $\beta \in \mathbb{C}, \operatorname{Re}(\beta) \in(-1 / 2,0)$. Then

$$
\sum_{k \in \mathbb{Z}}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right|<+\infty
$$

Proof. We have

$$
\operatorname{cov}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)=-\frac{1}{2} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left|k+p-p^{\prime}\right|^{2 H}=-\frac{k^{2 H}}{2} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left|1+\frac{p-p^{\prime}}{k}\right|^{2 H} .
$$

We just need to consider $\operatorname{cov}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)$ when $|k| \geq K$. Since $1+\frac{p-p^{\prime}}{k} \geq 0$, we get

$$
\operatorname{cov}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)=-\frac{k^{2 H}}{2} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left(1+\frac{p-p^{\prime}}{k}\right)^{2 H}
$$

Set

$$
g(x)=-\frac{1}{2} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left(1+\left(p-p^{\prime}\right) x\right)^{2 H} .
$$

If $H=\frac{1}{2}$ then $g(x)=0$. If $H \neq \frac{1}{2}$, using Taylor expansion as $x \rightarrow 0$, we get

$$
\begin{aligned}
g^{\prime}(x) & =-H \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left(p-p^{\prime}\right)\left(1+\left(p-p^{\prime}\right) x\right)^{2 H-1} \\
g^{\prime \prime}(x) & =-H(2 H-1) \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left(p-p^{\prime}\right)^{2}\left(1+\left(p-p^{\prime}\right) x\right)^{2 H-2} \\
g^{(3)}(x) & =-H(2 H-1)(2 H-2) \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left(p-p^{\prime}\right)^{3}\left(1+\left(p-p^{\prime}\right) x\right)^{2 H-3} .
\end{aligned}
$$

Thus $g(0)=0, g^{\prime}(0)=0, g^{\prime \prime}(0)=0, g^{(3)}(0)=0$ and we obtain that $g(x)=o\left(x^{3}\right)$ as $x \rightarrow 0$. It follows that

$$
\operatorname{cov}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right) \sim k^{2 H} \cdot o\left(\frac{1}{k^{3}}\right) \sim o\left(k^{2 H-3}\right)
$$

as $k \rightarrow+\infty$. We can apply similarly as $k \rightarrow-\infty$. Then there exists a constant $C$ such that for all $k,|k| \geq K$ and for all $H \in(0,1)$,

$$
\begin{equation*}
\left|\operatorname{cov}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)\right| \leq C|k|^{2 H-3} . \tag{67}
\end{equation*}
$$

For all $k \in \mathbb{Z}$, we have

$$
\operatorname{var} \triangle_{k, 1} X=\mathbb{E}\left[\sum_{p=0}^{K} a_{p} X(k+p) \sum_{p^{\prime}=0}^{K} a_{p^{\prime}} X\left(k+p^{\prime}\right)\right]=-\frac{1}{2} \sum_{p, p^{\prime}=0}^{K} a_{p} a_{p^{\prime}}\left|p-p^{\prime}\right|^{2 H} .
$$

We now apply the Lemma 5.1 with $U=\frac{\Delta_{k, 1} X}{\sqrt{\operatorname{var}\left(\triangle_{k, 1} X\right)}}, V=\frac{\Delta_{0,1} X}{\sqrt{\operatorname{var}\left(\triangle_{0,1} X\right)}}$. Then

$$
\left|\operatorname{cov}\left(\left|\frac{\triangle_{k, 1} X}{\sqrt{\operatorname{var}\left(\triangle_{k, 1} X\right)}}\right|^{\beta},\left|\frac{\triangle_{0,1} X}{\sqrt{\operatorname{var}\left(\triangle_{0,1} X\right)}}\right|^{\beta}\right)\right| \leq C \cdot \frac{\operatorname{cov}^{2}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)}{\operatorname{var}^{2} \triangle_{0,1} X} .
$$

It follows that

$$
\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \leq \operatorname{Cov}^{2}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right), \forall k, k \in \mathbb{Z} .
$$

Since $H \in(0,1)$, we get $\sum_{k \in \mathbb{Z}}|k|^{4 H-6}<+\infty$. Applying inequality (67), we obtain

$$
\begin{aligned}
\sum_{k \in \mathbb{Z}}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right|= & \sum_{k \in \mathbb{Z},|k|<K}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \\
& +\sum_{k \in \mathbb{Z},|k| \geq K}\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \\
\leq & C \sum_{k \in \mathbb{Z},|k|<K} \operatorname{cov}^{2}\left(\triangle_{k, 1} X, \triangle_{0,1} X\right)+C \sum_{k \in \mathbb{Z},|k| \geq K}|k|^{4 H-6}<+\infty .
\end{aligned}
$$

### 5.2 Auxiliary results related to Takenaka's process

Lemma 5.3. Let $\left\{X_{t}, t \in \mathbb{R}\right\}$ be a Takenaka's process defined by (366). Then for $\beta \in \mathbb{R}, \beta \in(-1 / 2,0)$ and $|k|>2 K$, we have

$$
\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \leq C k^{\nu-1} .
$$

Proof. One has

$$
\triangle_{k, 1} X=\sum_{i=0}^{K} a_{i} X(k+i)=\int_{\mathbb{R} \times \mathbb{R}^{+}} \sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{k+i}}(x, r) M(d x, d r)
$$

where $f_{k}=\sum_{i=0}^{K} a_{i} \mathbb{1}_{S_{k+i}}=\sum_{i=0}^{K} a_{i}\left(\mathbb{1}_{C_{k+i}}-\mathbb{1}_{C_{0}}\right)^{2}$. From the fact that $\sum_{i=0}^{K} a_{i}=0$ and $\left|1-2 \mathbb{1}_{C_{0}}\right|=1$, it induces

$$
\left|f_{k}\right|=\left|1-2 \mathbb{1}_{C_{0}}\right|\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{C_{k+i}}\right|=\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{C_{k+i}}\right|
$$

Therefore we have to estimate, as $|k| \rightarrow+\infty$,

$$
I_{k}=\left[\triangle_{k, 1} X, \triangle_{0,1} X\right]_{2}=\int_{0}^{+\infty} r^{\nu-2} \int_{\mathbb{R}}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r .
$$

We will find an upper bound for $I_{k}$ when $|k| \geq 2 K$.
If $x>K+r$ then $\mathbb{1}_{C_{i}}(x, r)=0$ for all $i=0, \ldots, K$, thus $f_{0}(x, r)=0$. If $x<k-r, \mathbb{1}_{C_{k+i}}(x, r)=0$ for all $i=0, \ldots, K$, it follows that $f_{k}(x, r)=0$.
As a result, $f_{k}(x, r) f_{0}(x, r)=0$ for all $x \in(-\infty, k-r) \cup(K+r,+\infty)$.
Let $k>2 K$. If $r<\frac{k-K}{2} \Leftrightarrow k-r>K+r$ then $f_{k}(x, r) f_{0}(x, r)=0$ for all $x$. Thus one gets

$$
\begin{aligned}
I_{k} & =\int_{\mathbb{R}}\left(\int_{0}^{\frac{k-K}{2}} r^{\nu-2}\left|f_{k}(x, r) f_{0}(x, r)\right| d r+\int_{\frac{k-K}{2}}^{+\infty} r^{\nu-2}\left|f_{k}(x, r) f_{0}(x, r)\right| d r\right) d x \\
& =\int_{\mathbb{R} \frac{k-K}{2}} \int_{\frac{+\infty}{2}}^{+\infty} r^{\nu-2}\left|f_{k}(x, r) f_{0}(x, r)\right| d r d x=\int_{\frac{k-K}{2}}^{+\infty} r^{\nu-2} \int_{\mathbb{R}}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r .
\end{aligned}
$$

Here we consider $f_{k}(x, r) f_{0}(x, r)$.
Since $k>2 K$, then $k+K-r \leq k+r$. For $k+K-r \leq x \leq k+r,|x-k-i| \leq r$ for all $i=0, \ldots, K$, it follows that $\mathbb{1}_{C_{k+i}}(x, r)=1$ and $f_{k}(x, r)=\sum_{i=0}^{K} a_{i}=0$.
Therefore $f_{k}(x, r) f_{0}(x, r)=0$ if $x \in(-\infty, k-r) \cup(k+K-r,+\infty)$. We also have

$$
\left|f_{k}(x, r)\right|=\left|\sum_{i=0}^{K} a_{i} \mathbb{1}_{C_{k+i}}(x, r)\right| \leq \sum_{i=0}^{K}\left|a_{i}\right|
$$

for all $k \in \mathbb{N}$. Thus

$$
\begin{aligned}
I_{k} & \leq \int_{\frac{k-K}{2}}^{+\infty} r^{\nu-2} \int_{k-r}^{k+K-r}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r \\
& \leq C \int_{\frac{k-K}{2}}^{+\infty} r^{\nu-2} \int_{k-r}^{k+K-r} d x d r=C\left(\frac{k-K}{2}\right)^{\nu-1} \leq C k^{\nu-1}
\end{aligned}
$$

since $\frac{k-K}{2} \geq \frac{k}{4}$ and $0<\nu<1$.
Let $k<-2 K$. If $r<-\frac{k+K}{2} \Leftrightarrow k+K+r<-r$, then for all $i=1, \ldots, K$,

$$
\mathbb{1}_{C_{k+i}}(x, r)=0, \forall x \in(k+K+r,+\infty), \mathbb{1}_{C_{i}}(x, r)=0, \forall x \in(-\infty,-r)
$$

It follows that $f_{k}(x, r) f_{0}(x, r)=0$, for all $x \in(-\infty,-r) \cup(k+K+r,+\infty)=\mathbb{R}$. Therefore

$$
I_{k}=\int_{-\frac{k+K}{2}}^{+\infty} r^{\nu-2} \int_{\mathbb{R}}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r
$$

For $r>-\frac{k+K}{2}, r>K-K / 2=K / 2$. We have $f_{k}(x, r) f_{0}(x, r)=0$ for all $x \in(-\infty, k-r) \cup(k-r+$ $K, k+r) \cup(k+r+K, K+r) \cup(K+r,+\infty)$. It induces that

$$
\begin{aligned}
I_{k} & =\int_{-\frac{k+K}{2}}^{+\infty} r^{\nu-2} \int_{\mathbb{R}}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r \\
& =\int_{-\frac{k+K}{2}}^{+\infty} r^{\nu-2}\left(\int_{k-r}^{k-r+K}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r+\int_{k+r}^{k+r+K}\left|f_{k}(x, r) f_{0}(x, r)\right| d x d r\right) \\
& \leq C \int_{-\frac{k+K}{2}}^{+\infty} r^{\nu-2} d r \leq C|k|^{\nu-1} .
\end{aligned}
$$

Putting together with Theorem 4.2, for $|k|>2 K$ we obtain that

$$
\left|\operatorname{cov}\left(\left|\triangle_{k, 1} X\right|^{\beta},\left|\triangle_{0,1} X\right|^{\beta}\right)\right| \leq C k^{\nu-1}
$$

### 5.3 Auxiliary results related to rate of convergence

We present here a lemma used to determine rate of convergence in the proofs of Theorems 3.3 and 3.4.
Lemma 5.4. For $p<0$, let $S_{n}=\frac{1}{n} \sum_{|k| \leq n}|k|^{p}$, then $\lim _{n \rightarrow+\infty} S_{n}=0$. Moreover

$$
S_{n}= \begin{cases}O\left(n^{-1}\right) & \text { if } p<-1 \\ O\left(n^{p}\right) & \text { if }-1<p<0 \\ O\left(\frac{\ln n}{n}\right) & \text { if } p=-1\end{cases}
$$

Proof. Set

$$
S_{n}=\frac{1}{n} \sum_{k=1}^{n} k^{p}
$$

If $p<-1$, since $\int_{1}^{\infty} x^{p} d x<+\infty$, following the integral test for convergence, we get $\sum_{k=1}^{\infty} k^{p}<+\infty$. Then

$$
S_{n}=O\left(n^{-1}\right)
$$

If $-1<p<0$, we take a constant $\epsilon$ such that $0<\epsilon<-p$, then

$$
S_{n}=\frac{1}{n} \sum_{k=1}^{n} \frac{k^{1+\epsilon+p}}{k^{1+\epsilon}} \leq \frac{1}{n} \sum_{k=1}^{n} \frac{n^{1+\epsilon+p}}{k^{1+\epsilon}}=n^{p+\epsilon} \sum_{k=1}^{n} \frac{1}{k^{1+\epsilon}}
$$

Since $p+\epsilon<0$, we get $\sum_{k=1}^{n} \frac{1}{k^{1+\epsilon}}<+\infty$. Then $S_{n}=O\left(n^{p+\epsilon}\right)$ for all $0<\epsilon<-p$. Thus $S_{n}=O\left(n^{p}\right)$.
If $p=-1$, then $S_{n}=\frac{1}{n} \sum_{k=1}^{n} \frac{1}{k}=O\left(\frac{\ln n}{n}\right)$.
In all cases, we have $\lim _{n \rightarrow+\infty} S_{n}=0$.
