Combining cluster sampling and link-tracing sampling to estimate the size of a hidden population: asymptotic properties of the estimators

Abstract

Félix-Medina and Thompson (2004) proposed a variant of link-tracing sampling to estimate the size of a hidden population such as drug users, sexual workers or homeless people. In their variant a sampling frame of sites where the members of the population tend to gather is constructed. The frame is not assumed to cover the whole population, but only a portion of it. A simple random sample of sites is selected; the people in the sampled sites are identified and are asked to name other members of the population which are added to the sample. Those authors proposed maximum likelihood estimators of the population size which derived from a multinomial model for the numbers of people found in the sampled sites and a model that considers that the probability that a person is named by any element in a particular sampled site (link-probability) does not depend on the named person, that is, that the probabilities are homogeneous. Later, Félix-Medina et al. (2015) proposed unconditional and conditional maximum likelihood estimators of the population size which derived from a model that takes into account the heterogeneity of the link-probabilities. In this work we consider this sampling design and set conditions for a general model for the link-probabilities that guarantee the consistency and asymptotic normality of the estimators of the population size and of the estimators of the parameters of the model for the link-probabilities. In particular we showed that both the unconditional and conditional maximum likelihood estimators of the population size are consistent and have asymptotic normal distributions which are different from each other.

1 Introduction

Conventional sampling methods are not appropriate for sampling hidden or hard-to-reach human populations, such as drug users, sexual-workers and homeless people, because of the lack of suitable sampling frames. For this reason, several specific sampling methods for this type of population have been proposed. See Magnani et al. (2005) and Kalton (2009) for reviews of some of them. One of this methods is snowball sampling, also known as link-tracing sampling (LTS) or chain referral sampling. In LTS an initial sample of members of the population is selected and the sample size is increased by asking the people in the initial sample to name other members of the populations. The named people who are not in the initial sample are added to the sample and they are asked to name other members of the population. The sampling process might continue in this way until a stopping rule is satisfied. For reviews of several variants of LTS see Spreen (1992), Thompson and Frank (2000) and Johnston and Sabin (2010).

Félix-Medina and Thompson (2004) proposed a variant of link-tracing sampling (LTS) to estimate the size of a hidden population. In their variant they supposed that a sampling frame of sites where the members of the target population tend to gather can be constructed. As a examples of sites are public parks, bars and blocks. It is worth nothing that they do not supposed that the frame covers the whole population, but only a portion of it. Then an initial sample of sites is selected by a simple random sampling without replacement design and the members of the population who belong to the sampled sites are identified. Finally the people in the initial sample are asked to named other members of the population and the named persons who are not in the initial sample are included in the sample. Those authors proposed models to describe the number of members of the population who belong to each site in the frame and to describe the probability that a person is linked to a sampled site, that is, that he or she was named by at least one person who belongs to that site. From those models they derived maximum likelihood estimators of the population size. In that work those authors considered that the probability that a person is linked to a site (link-probability) does not depend on the person, but does on the site, that is, they consider homogeneous link-probabilities.

Félix-Medina and Monjardin (2006) considered this same variant of LTS and derived estimators of the population size using a Bayesian-assisted approach, that is, they derived the estimators using the Bayesian approach, but the inferences were made under a frequentist approach. Those authors considered an homogeneous two-stage normal model for the logits of the link-probabilities.

Later Félix-Medina et al. (2015) extended the work by Félix-Medina and Thompson (2004) to the case in which the link-probabilities are heterogeneous, that is, that they depend on the named people. Those authors modeled the heterogeneity of the link-probabilities by means of a mixed logistic normal model proposed by Coull and Agresti (1999) in the context of capture-recapture studies. From this model they derived unconditional and conditional maximum likelihood estimators of the population size.

In this work we consider the variant of the LTS proposed by Félix-Medina and Thompson (2004) and a general model for the link-probabilities from which we derive the forms of the

unconditional and conditional maximum likelihood estimators of the population size. We state conditions that guarantee the consistency and asymptotic normality of both types of estimators, and we proposed estimators of the variances of the estimators of the population size. It is worth noting that our work is based on that by Sanathanan (1972) in which she derived asymptotic properties of both unconditional and conditional maximum likelihood estimators of the size of a multinomial distribution from an incomplete observation of the cell totals which is a situation that occurs in capture-recapture studies. Thus, our work is basically an adaptation of that by Sanathanan (1972) to the estimators used in the sampling variant proposed by Félix-Medina and Thompson (2004).

The structure of this document is the following. In section 2 we describe the variant of LTS proposed by Félix-Medina and Thompson (2004). In section 3 we present probability models that describe the numbers of people that belong to the sites in the frame and the probabilities of links between the members of the population and the sites. From these models we construct the likelihood function that allows us to derive the unconditional and conditional maximum likelihood estimators of the parameters of the assumed model for the link-probabilities and of the population size. In addition, we present conditions that guarantee the consistency of the proposed estimators. In section 4, which is the central part of this paper, we define the asymptotic framework under which are derived the asymptotic properties of the proposed estimators of the different vectors of parameters that appear in the assumed models. Finally, in section 6 we discuss some points to be considered whenever the results of this paper want to be used in actual situations.

2 Link-tracing sampling design

In this section we will describe the LTS variant proposed by Félix-Medina and Thompson (2004). Thus, let U be a finite population of τ people. Let U_1 be the portion of U that is covered by a sampling frame of N sites A_1, \ldots, A_N , which are places where members of the population tend to gather. We will assume that each one of the τ_1 persons who are in U_1 belongs to only one site A_i in the frame. Notice that this does not imply that a person cannot be found in distinct places, but that, as in ordinary cluster sampling, the researcher has a criterion that allows him or her to assign a person to only one site. Let M_i be the number of people in U_1 that belong to the site A_i , $i = 1, \ldots, N$. The previous assumption implies that $\tau_1 = \sum_{1}^{N} M_i$. Let $\tau_2 = \tau - \tau_1$ be the number of people that belong to the portion $U_2 = U - U_1$ of U that is not covered by the sampling frame.

The sampling procedure is as follows. An initial simple random sample without replacement (SRSWOR) S_A of n sites A_1, \ldots, A_n is selected from the frame and the members of the population who belong to each sampled site are identified. Let S_0 be the set of people in the initial sample. Notice that the size of S_0 is $M = \sum_{i=1}^{n} M_i$. Then from each sampled site A_i , $i = 1, \ldots, n$, the people who belong to that site are asked to name other members of the population. A person and a sampled site are said to be linked if any of the persons who belong to that site names that person. Let S_1 and S_2 be the sets of people in $U_1 - S_0$ and in U_2 , respectively, who are linked to at least one site in S_A . Finally, from each named person the following information is obtained: the portion of U where that person is located, that is, $U_1 - S_0$, $A_i \in S_A$ or U_2 , and the subset of sampled sites that are linked to him or her.

3 Unconditional and conditional maximum likelihood estimators

3.1 Probability models

As in Félix-Medina and Thompson (2004), we will suppose that the numbers M_1, \ldots, M_N of people who belong to the sites A_1, \ldots, A_N are independent Poisson random variables with mean λ_1 . Therefore, the joint conditional distribution of $(M_1, \ldots, M_n, \tau_1 - M)$ given that $\sum_{i=1}^{N} M_i = \tau_1$ is multinomial with probability mass function (pmf):

$$f(m_1, \dots, m_n, \tau_1 - m | \tau_1) = \frac{\tau_1!}{\prod_1^n m_i! (\tau_1 - m)!} \left(\frac{1}{N}\right)^m \left(1 - \frac{n}{N}\right)^{\tau_1 - m}.$$

To model the links between the members of the population and the sampled sites we will define for person j in $U_k - S_0$ the vector of link-indicator variables $\mathbf{X}_j^{(k)} = (X_{1j}^{(k)}, \ldots, X_{nj}^{(k)})$, where $X_{ij}^{(k)} = 1$ if person j is linked to site A_i and $X_{ij}^{(k)} = 0$ otherwise. Notice that $\mathbf{X}_j^{(k)}$ indicates which sites in S_A are linked to person j. We will suppose that given S_A , and consequently the values M_i s of the sampled sites, the $X_{ij}^{(k)}$ s are Bernoulli random variables with means $p_{ij}^{(k)}$ s and that the vectors $\mathbf{X}_j^{(k)}$ are independent. Let $\Omega = \{(x_1, \ldots, x_n) : x_i = 0, 1; i = 1, \ldots, n\}$, that is, the set of all the n-dimensional vectors such that each one of their elements is 0 or 1. For $\mathbf{x} = (x_1, \ldots, x_n) \in \Omega$ we will denote by $\pi_{\mathbf{x}}^{(k)}$ the probability that the vector of link-indicator variables associated with a randomly selected person from $U_k - S_0$ equals \mathbf{x} , that is, the probability that the person is linked only to the sites A_i such that the *i*-th element x_i of \mathbf{x} equals 1. We will suppose that $\pi_{\mathbf{x}}^{(k)}$ depends on a q_k -dimensional parameter $\boldsymbol{\theta}_k = (\theta_1^{(k)}, \ldots, \theta_{q_k}^{(k)}) \in \boldsymbol{\Theta}_k \subseteq \mathbb{R}^{q_k}$, that is, $\pi_{\mathbf{x}}^{(k)} = \pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_k)$, k = 1, 2. In this work we will assume that $\boldsymbol{\theta}_k$ does not depend on the observed M_i s.

Similarly, for person j in $A_i \in S_A$, we will define the vector of link-indicator variables $\mathbf{X}_j^{(A_i)} = (X_{1j}^{(A_i)}, \ldots, X_{i-1j}^{(A_i)}, X_{i+1j}^{(A_i)}, \ldots, X_{nj}^{(A_i)})$, where $X_{i'j}^{(A_i)} = 1$ if person j is linked to site $A_{i'}$, $i' = 1, \ldots, n$, $i' \neq i$ and $X_{i'j}^{(k)} = 0$ otherwise. We will suppose that given S_A the $X_{i'j}^{(A_i)}$ s are Bernoulli random variables with means $p_{i'j}^{(1)}$ s and that the vectors $\mathbf{X}_j^{(A_i)}$ are independent. For each $A_i \in S_A$, let $\Omega_{-i} = \{(x_1, \ldots, x_{i-1}, x_{i+1}, \ldots, x_n) : x_{i'} = 0, 1; i' \neq i, i' = 1, \ldots, n\}$, that is, the set of all (n-1)-dimensional vectors obtained from the vectors in Ω by omitting their *i*-th coordinate. For $\mathbf{x} = (x_1, \ldots, x_{i-1}, x_{i+1}, \ldots, x_n) \in \Omega_{-i}$ we will denote by $\pi_{\mathbf{x}}^{(A_i)}$ the probability that the vector of link-indicator variables associated with a randomly selected person from A_i equals \mathbf{x} . We will suppose that $\pi_{\mathbf{x}}^{(A_i)}$ depends on the q_1 -dimensional parameter $\boldsymbol{\theta}_1 = (\boldsymbol{\theta}_1^{(1)}, \ldots, \boldsymbol{\theta}_{q_1}^{(1)}) \in \boldsymbol{\Theta}_1$, that is, $\pi_{\mathbf{x}}^{(A_i)} = \pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1)$, $i = 1, \ldots, n$.

For instance, Félix-Medina and Monjardin (2006) modeled the link-probability between person j in $U_k - A_i$ and site $A_i \in S_A$ by $p_{ij}^{(k)} = \Pr\left(X_{ij}^{(k)} = 1|S_A\right) = \exp\left(\alpha_i^{(k)}\right) / \left[1 + \exp\left(\alpha_i^{(k)}\right)\right]$, where the conditional distribution of $\alpha_i^{(k)}$ given ψ_k is normal with mean ψ_k and variance σ_k^2 , which we denote by $\alpha_i^{(k)}|\psi_k \sim N\left(\psi_k, \sigma_k^2\right)$ and $\psi_k \sim N\left(\mu_k, \gamma_k^2\right)$. Thus, in this case $\boldsymbol{\theta}_k = (\mu_k, \gamma_k, \sigma_k) \in \boldsymbol{\Theta}_k = \mathbb{R} \times (0, \infty) \times (0, \infty)$, and

$$\pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_{k}) = \left[\int \int \frac{\exp(\alpha)}{1 + \exp(\alpha)} f_{k}(\alpha|\psi) f_{k}(\psi) d\alpha d\psi \right]^{t} \\ \times \left[\int \int \frac{1}{1 + \exp(\alpha)} f_{k}(\alpha|\psi) f_{k}(\psi) d\alpha d\psi \right]^{n-t}$$

where $\mathbf{x} = (x_1, \ldots, x_n) \in \mathbf{\Omega}$, $t = \sum_{1}^{n} x_i$, and $f_k(\alpha | \psi)$ and $f_k(\psi)$ denote the probability density functions of the distributions $N(\psi_k, \sigma_k^2)$ and $N(\mu_k, \gamma_k^2)$, respectively. It is worth noting that those authors did not compute $\pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_k)$ because they followed a Bayesian approach and focused on computing the posterior distribution of the parameters.

As another example, Félix-Medina et al. (2015) modeled the link-probability between person j in $U_k - A_i$ and site $A_i \in S_A$ by the following Rasch model: $p_{ij}^{(k)} = \Pr\left(X_{ij}^{(k)} = 1|S_A\right)$ $= \exp\left(\alpha_i^{(k)} + \beta_j^{(k)}\right) / \left[1 + \exp\left(\alpha_i^{(k)} + \beta_j^{(k)}\right)\right]$, where $\alpha_i^{(k)}$ is a fixed (not random) effect associated with the site A_i and $\beta_j^{(k)}$ is a normal random effect with mean zero and variance σ_k^2 associated with person j in $U_k - A_i$. Therefore

$$\pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_k) = \int \prod_{i=1}^n \frac{\exp\left[x_i\left(\alpha_i^{(k)} + \sigma_k z\right)\right]}{1 + \exp\left(\alpha_i^{(k)} + \sigma_k z\right)} \phi(z) dz,$$

where $\mathbf{x} = (x_1, \ldots, x_n) \in \mathbf{\Omega}$, $\boldsymbol{\theta}_k = (\alpha_1^{(k)}, \ldots, \alpha_n^{(k)}, \sigma_k) \in \boldsymbol{\Theta}_k = \mathbb{R}^n \times (0, \infty)$ and $\phi(\cdot)$ denotes the probability density function of the standard normal distribution. Those authors compute $\pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_k)$ by means of Gaussian quadrature formula.

Notice that in the first example the parameter θ_k is defined previously to the selection of the initial sample because the $\alpha_i^{(k)}$ s are a random sample from a probability distribution indexed by θ_k and consequently this parameter does not represent characteristics of the particular selected sample. On the other hand, in the second example the parameter θ_k is defined once the initial sample of sites is selected because the $\alpha_i^{(k)}$ s represent characteristics of the particular sites in S_A . Therefore, as long as θ_k does not depend on the M_i s the results derived in this work are valid for both cases.

3.2 Likelihood function

To compute the likelihood function we will factorize it into different components. One component, $L_{MULT}(\tau_1)$, is given by the probability of observing the particular sizes m_1, \ldots, m_n of the sites in S_A ; therefore, it is specified by the multinomial distribution (1). Two additional factors are given by the probabilities of the configurations of the links between the people in $U_k - S_0$, k = 1, 2, and the sites $A_i \in S_A$. To obtain those factors we will denote by $R_{\mathbf{x}}^{(k)}$, $\mathbf{x} = (x_1, \ldots, x_n) \in \Omega$, the random variable that indicates the number of distinct people in $U_k - S_0$ whose vectors of link-indicator variables are equal to \mathbf{x} , and by R_k the random variable that indicates the number of distinct people in $U_k - S_0$ who are linked to at least one site $A_i \in S_A$. Notice that $R_k = \sum_{\mathbf{x} \in \Omega - \{\mathbf{0}\}} R_{\mathbf{x}}^{(k)}$, where **0** denotes the *n*-dimensional vector of zeros.

Because of the assumptions we made about the vectors $\mathbf{X}_{j}^{(k)}$ of link-indicator variables we have that the conditional joint probability distribution of the variables $\{R_{\mathbf{x}}^{(1)}\}_{\mathbf{x}\in\Omega}$ given S_A is a multinomial distribution with parameter of size $\tau_1 - m$ and probabilities $\{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1)\}_{\mathbf{x}\in\Omega}$, whereas that of the variables $\{R_{\mathbf{x}}^{(2)}\}_{\mathbf{x}\in\Omega}$ is a multinomial distribution with parameter of size τ_2 and probabilities $\{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_2)\}_{\mathbf{x}\in\Omega}$. Therefore, the factors of the likelihood function associated with the probabilities of the configurations of links between the people in $U_k - S_0$, k = 1, 2, and the sites $A_i \in S_A$ are

$$L_{1}(\tau_{1}, \boldsymbol{\theta}_{1}) = \frac{(\tau_{1} - m)!}{(\tau_{1} - m - r_{1})! \prod_{\mathbf{x} \in \Omega} r_{\mathbf{x}}^{(1)}!} \prod_{\mathbf{x} \in \Omega} \left[\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}) \right]^{r_{\mathbf{x}}^{(1)}}$$

and

$$L_{2}(\tau_{2}, \boldsymbol{\theta}_{2}) = \frac{\tau_{2}!}{(\tau_{2} - r_{2})! \prod_{\mathbf{x} \in \Omega} r_{\mathbf{x}}^{(2)}!} \prod_{\mathbf{x} \in \Omega} \left[\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}) \right]^{r_{\mathbf{x}}^{(2)}}$$

Notice that $r_0^{(1)} = \tau_1 - m - r_1$ and $r_0^{(2)} = \tau_2 - r_2$.

The last factor of the likelihood function is given by the probability of the configuration of links between the people in S_0 and the sites $A_i \in S_A$. To obtain this factor, we will denote by $R_{\mathbf{x}}^{(A_i)}$, $\mathbf{x} = (x_1, \ldots, x_{i-1}, x_{i+1}, \ldots, x_n) \in \Omega_{-i}$, the random variable that indicates the number of distinct people in $A_i \in S_A$ such that their vectors of link-indicator variables equal \mathbf{x} and by $R^{(A_i)}$ the random variable that indicates the number of distinct people in $A_i \in S_A$ who are linked to at least one site $A_j \in S_A$, $j \neq i$. Notice that $R^{(A_i)} = \sum_{\mathbf{x} \in \Omega_{-i} - \{\mathbf{0}\}} R_{\mathbf{x}}^{(A_i)}$, where **0** denotes the (n-1)-dimensional vector of zeros and $R_{\mathbf{0}}^{(A_i)} = m_i - R^{(A_i)}$. Then, as in the previous cases, the conditional joint probability distribution of the variables $\{R_{\mathbf{x}}^{(A_i)}\}_{\mathbf{x} \in \Omega_{-i}}$ given S_A is a multinomial distribution with parameter of size m_i and probabilities $\{\pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1)\}_{\mathbf{x} \in \Omega_{-i}}$. Therefore, the probability of the configuration of links between the people in S_0 and the sites $A_i \in S_A$ is given by the product of the previous multinomial probabilities (one for each $A_i \in S_A$), and consequently the factor of the likelihood function associated with that probability is

$$L_0(\boldsymbol{\theta}_1) = \prod_{i=1}^n \frac{m_i!}{\prod_{\mathbf{x}\in\Omega} r_{\mathbf{x}}^{(A_i)}!} \prod_{\mathbf{x}\in\Omega_{-i}} \left[\pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1)\right]^{r_{\mathbf{x}}^{(A_i)}} \left[\pi_{\mathbf{0}}^{(A_i)}(\boldsymbol{\theta}_1)\right]^{m_i - r^{(A_i)}}$$

From the previous results we have that the maximum likelihood function is given by

$$L(\tau_1, \tau_2, \theta_1, \theta_2) = L_{(1)}(\tau_1, \theta_1) L_{(2)}(\tau_2, \theta_2)$$

where

$$L_{(1)}(\tau_{1}, \theta_{1}) = L_{MULT}(\tau_{1})L_{1}(\tau_{1}, \theta_{1})L_{0}(\theta_{1}) \text{ and } (3)$$

$$L_{(2)}(\tau_{2}, \theta_{2}) = L_{2}(\tau_{2}, \theta_{2}).$$

3.3 Unconditional and conditional maximum likelihood estimators of $(\tau_k, \boldsymbol{\theta}_k^*)$

In this section we will derive unconditional and conditional maximum likelihood estimators of the parameters of the previously specified models. Henceforth we will suppose that conditional on the initial sample S_A of sites the following "regularity conditions" are satisfied:

- (1) θ_k^* is the true value of θ_k .
- (2) θ_k^* is an interior point of Θ_k .
- (3) $\pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_{k}^{*}) > 0, \mathbf{x} \in \Omega \text{ and } \pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1}^{*}) > 0, \mathbf{x} \in \Omega_{-i}, i = 1, \dots, n.$
- (4) $\partial \pi_{\mathbf{x}}^{(k)}(\boldsymbol{\theta}_k) / \partial \theta_j^{(k)}$, $\mathbf{x} \in \Omega$ and $\partial \pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1) / \partial \theta_j^{(1)}$, $\mathbf{x} \in \Omega_{-i}$, i = 1, ..., n; $j = 1, ..., q_k$, exist at any $\boldsymbol{\theta}_k \in \boldsymbol{\Theta}_k$ and $\boldsymbol{\theta}_1 \in \boldsymbol{\Theta}_1$, and are continuous in neighborhoods of $\boldsymbol{\theta}_k^*$ and $\boldsymbol{\theta}_1^*$, respectively.
- (5) Given a $\delta_1 > 0$, it is possible to find an $\varepsilon_1 > 0$ such that

$$\inf_{\|\boldsymbol{\theta}_{1}-\boldsymbol{\theta}_{1}^{*}\|>\delta_{1}} \sum_{\mathbf{x}\in\Omega-\{\mathbf{0}\}} \frac{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*})}{1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})} \ln \left\{ \frac{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*})/\left[1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]}{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})/\left[1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})\right]} \right\} + \frac{1}{(N-n)\left[1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]} \sum_{i=1}^{n} \sum_{\mathbf{x}\in\Omega_{-i}} \pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1}^{*}) \ln \left[\frac{\pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1}^{*})}{\pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1})}\right] \ge \varepsilon_{1}.$$

(6) Given a $\delta_2 > 0$, it is possible to find an $\varepsilon_2 > 0$ such that

$$\inf_{\|\boldsymbol{\theta}_{2}-\boldsymbol{\theta}_{2}^{*}\|>\delta_{2}}\sum_{\mathbf{x}\in\Omega-\{\mathbf{0}\}}\frac{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*})}{1-\pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*})}\ln\left\{\frac{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*})/\left[1-\pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*})\right]}{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2})/\left[1-\pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2})\right]}\right\}\geq\varepsilon_{2}.$$

Remark 1. For a differentiable function $f : \mathbb{R}^q \to \mathbb{R}$, the notation $\partial f(\mathbf{x}_0) / \partial x_j$ represents $\partial f(\mathbf{x}) / \partial x_j|_{\mathbf{x}=\mathbf{x}_0}$.

The regularity conditions (1)-(4) and (6) or conditions equivalent to them have been assumed by several authors such as Birch (1964), Rao (1973, Ch. 5), Bishop et al. (1975, Ch. 14), Sanathanan (1972) and Agresti (2002, Ch. 14), among others, in the context of deriving asymptotic properties of estimators of the parameters of models for the probabilities of a multinomial distribution. The particular form of condition (6) comes from Sanathanan (1972) who took it from the first edition of Rao (1973, Ch. 5) and it is known as a *strong identifiability* condition. Condition (5) is a modification of (6) to meet the requirements of our particular sampling design. In general, these conditions imply the existence and consistency of the UMLEs and CMLEs of θ_1^* and θ_2^* , and that they can be obtained deriving the likelihood function with respect to θ_1 and θ_2 .

3.3.1 Unconditional and conditional maximum likelihood estimators of τ_1 and θ_1^*

Let us firstly consider the unconditional maximum likelihood estimators (UMLEs) $\hat{\tau}_1^{(U)}$ and $\hat{\theta}_1^{(U)}$ of τ_1 and θ_1^* . The log-likelihood function of τ_1 and θ_1 is

$$l_{(1)}(\tau_{1},\boldsymbol{\theta}_{1}) = \ln[L_{(1)}(\tau_{1},\boldsymbol{\theta}_{1})] \\ = \ln(\tau_{1}!) - \ln[(\tau_{1} - m - r_{1})!] + \tau_{1}\ln(1 - n/N) \\ + \sum_{\mathbf{x}\in\Omega} r_{\mathbf{x}}^{(1)}\ln\left[\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})\right] + \sum_{i=1}^{n}\sum_{\mathbf{x}\in\Omega_{-i}} r_{\mathbf{x}}^{(A_{i})}\ln\left[\pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1})\right] + C,$$

where C does not depend on τ_1 and θ_1 , and recall that $r_0^{(1)} = \tau_1 - m - r_1$ and $r_0^{(A_i)} = m_i - r^{(A_i)}$. Then, the UMLE $\hat{\theta}_1^{(U)}$ of θ_1^* is the solution to the following equations:

$$\frac{\partial l_{(1)}(\tau_1, \boldsymbol{\theta}_1)}{\partial \theta_j^{(1)}} = \sum_{\mathbf{x} \in \Omega} \frac{r_{\mathbf{x}}^{(1)}}{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1)} \frac{\partial \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1)}{\partial \theta_j^{(1)}} + \sum_{i=1}^n \sum_{\mathbf{x} \in \Omega_{-i}} \frac{r_{\mathbf{x}}^{(A_i)}}{\pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1)} \frac{\partial \pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1)}{\partial \theta_j^{(1)}} = 0, \ j = 1, \dots, q_1.$$
(4)

Since τ_1 is an integer we will use the "ratio method" to maximize $L_{(1)}(\tau_1, \theta_1)$. [See Feller (1968, Ch. 3).] Thus

$$\frac{L_{(1)}(\tau_1, \boldsymbol{\theta}_1)}{L_{(1)}(\tau_1 - 1, \boldsymbol{\theta}_1)} = \frac{\tau_1(1 - n/N)\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1)}{(\tau_1 - m - r_1)}.$$

Since this ratio is greater than or equal to 1 if $\tau_1 \leq (m+r_1)/\left[1-(1-n/N)\pi_0^{(1)}(\boldsymbol{\theta}_1)\right]$ and it is smaller than or equal to 1 if τ_1 is greater than or equal to that quantity, it follows that $\hat{\tau}_1^{(U)}$ is given by

$$\hat{\tau}_{1}^{(U)} = \left[\frac{M + R_{1}}{1 - (1 - n/N)\pi_{0}^{(1)} \left(\hat{\boldsymbol{\theta}}_{1}^{(U)}\right)} \right],$$
(5)

where $\lfloor x \rfloor$ denotes the largest integer not greater than x. Notice that the right hand-side of (5) is not a closed form for $\hat{\tau}_1^{(U)}$ since this expression depends on $\hat{\theta}_1^{(U)}$. In fact, $\hat{\tau}_1^{(U)}$ and $\hat{\theta}_1^{(U)}$ are

obtained by simultaneously solving the set of equations (4) and (5), which is generally done by numerical methods.

Let us now consider the conditional maximum likelihood estimators (CMLEs) $\hat{\tau}_1^{(C)}$ and $\hat{\theta}_1^{(C)}$ of τ_1 and θ_1^* . It is worth noting that this type of estimators was proposed by Sanathanan (1972) in the context of estimating the parameter of size of a multinomial distribution from an incomplete observation of the cell frequencies. The approach we will follow to derive $\hat{\tau}_1^{(C)}$ and $\hat{\theta}_1^{(C)}$ is an adaptation of Sanathanan's (1972) approach to our case. Thus, from (2) we have that

$$L_{1}(\tau_{1},\boldsymbol{\theta}_{1}) = f\left(\{r_{\mathbf{x}}^{(1)}\}_{\mathbf{x}\in\Omega}|\{m_{i}\},\tau_{1},\boldsymbol{\theta}_{1}\right)$$

$$= f\left(\{r_{\mathbf{x}}^{(1)}\}_{\mathbf{x}\in\Omega-\{\mathbf{0}\}}|r_{1},\{m_{i}\},\tau_{1},\boldsymbol{\theta}_{1}\right)f\left(r_{1}|\{m_{i}\},\tau_{1},\boldsymbol{\theta}_{1}\right)$$

$$= \frac{r_{1}!}{\prod_{\mathbf{x}\in\Omega-\{\mathbf{0}\}}r_{\mathbf{x}}^{(1)}!}\prod_{\mathbf{x}\in\Omega-\{\mathbf{0}\}}\left[\frac{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})}{1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})}\right]^{r_{\mathbf{x}}^{(1)}}$$

$$\times \frac{(\tau_{1}-m)!}{(\tau_{1}-m-r_{1})!r_{1}!}\left[1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})\right]^{r_{1}}\left[\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})\right]^{\tau_{1}-m-r_{1}}$$

$$= L_{11}(\boldsymbol{\theta}_{1})L_{12}(\tau_{1},\boldsymbol{\theta}_{1})$$
(6)

Notice that the first factor $L_{11}(\boldsymbol{\theta}_1)$ is given by the joint pmf of the multinomial distribution with parameter of size r_1 and probabilities $\left\{ \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1) / \left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1) \right] \right\}_{\mathbf{x}\in\Omega-\{\mathbf{0}\}}$ and that this distribution does not depend on τ_1 . Note also that the second factor $L_{12}(\tau_1, \boldsymbol{\theta}_1)$ is given by the pmf of the binomial distribution with parameter of size $\tau_1 - m$ and probability $1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1)$. Thus, the CMLE $\hat{\boldsymbol{\theta}}_1^{(C)}$ of $\boldsymbol{\theta}_1^*$ is the solution to the following system of equations:

$$\frac{\partial}{\partial \theta_{j}^{(1)}} \ln[L_{11}(\boldsymbol{\theta}_{1})L_{0}(\boldsymbol{\theta}_{1})] = \sum_{\mathbf{x}\in\Omega-\{\mathbf{0}\}} \frac{r_{\mathbf{x}}^{(1)}}{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})} \frac{\partial \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})}{\partial \theta_{j}^{(1)}} + \frac{r_{1}}{1-\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})} \frac{\partial \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})}{\partial \theta_{j}^{(1)}} \\
+ \sum_{i=1}^{n} \sum_{\mathbf{x}\in\Omega_{-i}} \frac{r_{\mathbf{x}}^{(A_{i})}}{\pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1})} \frac{\partial \pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1})}{\partial \theta_{j}^{(1)}} = 0, \ j = 1, \dots, q_{1}.$$
(7)

The CMLE $\hat{\tau}_1^{(C)}$ of τ_1 is obtained by the ratio method. Thus, since

$$\frac{L_{MULT}(\tau_1)L_{12}(\tau_1,\boldsymbol{\theta}_1)}{L_{MULT}(\tau_1-1)L_{12}(\tau_1-1,\boldsymbol{\theta}_1)} = \frac{\tau_1(1-n/N)\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1)}{(\tau_1-m-r_1)},$$

it follows that

$$\hat{\tau}_{1}^{(C)} = \left[\frac{M + R_{1}}{1 - (1 - n/N)\pi_{\mathbf{0}}^{(1)} \left(\hat{\boldsymbol{\theta}}_{1}^{(C)}\right)} \right].$$
(8)

Note that (8) is a closed form for $\hat{\tau}_1^{(C)}$ since $\hat{\theta}_1^{(C)}$ is firstly obtained from (7).

3.3.2 Unconditional and conditional maximum likelihood estimators of τ_2 and θ_2^*

By a similar analysis as that conducted in the previous subsection we have that the UMLEs $\hat{\tau}_2^{(U)}$ and $\hat{\theta}_2^{(U)}$ of τ_2 and θ_2^* are the solution to the following equations:

$$\sum_{\mathbf{x}\in\Omega} \frac{r_{\mathbf{x}}^{(2)}}{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_2)} \frac{\partial \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_2)}{\partial \theta_j^{(2)}} = 0, \ j = 1, \dots, q_2$$

and

$$\hat{\tau}_{2}^{(U)} = \left[\frac{R_{2}}{1 - \pi_{0}^{(2)} \left(\hat{\boldsymbol{\theta}}_{2}^{(U)} \right)} \right].$$
(9)

where recall that $r_{\mathbf{0}}^{(2)} = \tau_2 - r_2$.

With respect to the conditional estimators, we have that the CMLE $\hat{\theta}_2^{(C)}$ of θ_2^* is the solution to the following equations:

$$\sum_{\mathbf{x}\in\Omega-\{\mathbf{0}\}} \frac{r_{\mathbf{x}}^{(2)}}{\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_2)} \frac{\partial \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_2)}{\partial \theta_j^{(2)}} + \frac{r_2}{1-\pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_2)} \frac{\partial \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_2)}{\partial \theta_j^{(2)}} = 0, \ j = 1, \dots, q_2.$$

The CMLE $\hat{\tau}_2^{(C)}$ of τ_2 is given by (9), but replacing $\hat{\theta}_2^{(U)}$ by $\hat{\theta}_2^{(C)}$. Note that in this case (9) is a closed form for $\hat{\tau}_2^{(C)}$.

3.3.3 Unconditional and conditional maximum likelihood estimators of $\tau = \tau_1 + \tau_2$

The UMLE and CMLE of $\tau = \tau_1 + \tau_2$ are given by $\hat{\tau}^{(U)} = \hat{\tau}_1^{(U)} + \hat{\tau}_2^{(U)}$ and $\hat{\tau}^{(C)} = \hat{\tau}_1^{(C)} + \hat{\tau}_2^{(C)}$, respectively.

4 Asymptotic properties of the unconditional and conditional maximum likelihood estimators

The structure of this section is as follows. Firstly we will define the asymptotic framework under which we will derive the asymptotic properties of the estimators. Next we will state and proof a theorem that guarantees the asymptotic multivariate normal distribution of any estimator of (τ_1, θ_1^*) that satisfies the conditions expressed in the theorem. Since not any estimator of (τ_1, θ_1^*) satisfies the conditions of the theorem, in particular the CMLE does not, we will state and proof another theorem that guarantees the asymptotic multivariate normal distribution of any estimator of θ_1^* that satisfies the conditions of that theorem. Then, we will prove that the UMLE of (τ_1, θ_1^*) satisfies the conditions of the first theorem, whereas the CMLE of θ_1^* satisfies those of the second one. In addition, we will prove that in spite of that result, the CMLE $\hat{\tau}_1^{(C)}$ does have an asymptotic normal distribution although it is not the same as that of $\hat{\tau}_1^{(U)}$. After that we will consider the asymptotic properties of estimators of (τ_2, θ_2^*) . Since this problem is exactly the same as that considered by Sanathanan (1972), we will only state a theorem that guarantees the asymptotic multivariate normal distribution of any estimator of (τ_2, θ_2^*) that satisfies the conditions expressed in the theorem, but we will omit its proof, as well as the proofs that both the UMLE and the CMLE of (τ_2, θ_2^*) satisfy the conditions of that theorem. Finally, we will obtain the asymptotic properties of the estimators $\hat{\tau}^{(U)}$ and $\hat{\tau}^{(C)}$ of τ .

4.1 **Basic assumptions**

To derive the asymptotic properties of the UMLEs and CMLEs of τ_k and θ_k^* , k = 1, 2, we will make the following assumptions:

- A. $\tau_k \to \infty, k = 1, 2.$
- **B.** $\tau_k / \tau \to \alpha_k, 0 < \alpha_k < 1, k = 1, 2.$
- C. N and n are fixed positive integer numbers.

For convenience of notation, we will put τ_k either as a subscript or a superscript of every term that depends on τ_k , k = 1, 2. In addition, convergence in distribution will be denoted by \xrightarrow{D} and convergence in probability by \xrightarrow{P} .

Notice that from (1) it follows that the conditional distribution of $M_i^{(\tau_1)}$ given τ_1 is binomial with parameter of size τ_1 and probability 1/N, that is $M_i^{(\tau_1)} | \tau_1 \sim \operatorname{Bin}(\tau_1, 1/N)$; consequently $M_i^{(\tau_1)} / \tau_1$ is stochastically bounded, that is, $M_i^{(\tau_1)} = O_p(\tau_1)$. This means that the size of $U_1^{(\tau_1)}$ is increased by increasing the sizes of the clusters, even though their number N is kept fixed. In the same manner, the number of people in the initial sample $S_0^{(\tau_1)}$, given by $M^{(\tau_1)} = \sum_{1}^{n} M_i^{(\tau_1)} | \tau_1 \sim \operatorname{Bin}(\tau_1, n/N)$, is increased because of the increasing of $M_i^{(\tau_1)}$, $i = 1, \ldots, n$, even though n is kept fixed. On the other hand, since $\tau_1 - M^{(\tau_1)} | \tau_1 \sim \operatorname{Bin}(\tau_1 - M^{(\tau_1)}, 1 - \pi_0^{(1)})$ and $R_2^{(\tau_2)} | S_A^{(\tau_1)} \sim \operatorname{Bin}(\tau_2, 1 - \pi_0^{(2)})$, it follows that $R_1^{(\tau_1)} | \tau_1 \sim \operatorname{Bin}\left[\tau_1, (1 - n/N)\left(1 - \pi_0^{(1)}\right)\right]$ and $R_2^{(\tau_2)} | \tau_2 \sim \operatorname{Bin}(\tau_2, 1 - \pi_0^{(2)})$; therefore $R_1^{(\tau_1)} = O_p(\tau_1)$ and $R_2^{(\tau_2)} = O_p(\tau_2)$. Thus, the sizes of the sets $S_1^{(\tau_1)}$ and $S_2^{(\tau_2)}$ are increased because τ_1 and τ_2 are increased even though the probabilities $\{\pi_x^{(1)}\}_{\mathbf{x}\in\Omega}$ and $\{\pi_x^{(2)}\}_{\mathbf{x}\in\Omega}$ are kept fixed.

We will end this subsection presenting the conditional and unconditional distributions of the variables $R_{\mathbf{x}}^{(\tau_1)}$, $R_{\mathbf{x}}^{(A_i)}$ and $R_{\mathbf{x}}^{(\tau_2)}$ which will be used later in this work. Thus, from the multinomial distributions indicated in Subsection 3.1 it follows that $R_{\mathbf{x}}^{(\tau_1)}|S_A^{(\tau_1)} \sim \operatorname{Bin}(\tau_1 - M^{(\tau_1)}, \pi_{\mathbf{x}}^{(1)})$, $R_{\mathbf{x}}^{(A_i)}|M_i^{(\tau_1)} \sim \operatorname{Bin}(M_i^{(\tau_1)}, \pi_{\mathbf{x}}^{(A_i)})$ and $R_{\mathbf{x}}^{(\tau_2)}|S_A^{(\tau_1)} \sim \operatorname{Bin}(\tau_2, \pi_{\mathbf{x}}^{(2)})$; therefore $R_{\mathbf{x}}^{(\tau_1)}|\tau_1 \sim \operatorname{Bin}\left[\tau_1, (1 - n/N)\pi_{\mathbf{x}}^{(1)}\right]$, $R_{\mathbf{x}}^{(A_i)}|\tau_1 \sim \operatorname{Bin}\left(\tau_1, \pi_{\mathbf{x}}^{(A_i)}/N\right)$ and $R_{\mathbf{x}}^{(\tau_2)}|\tau_2 \sim \operatorname{Bin}(\tau_2, \pi_{\mathbf{x}}^{(2)})$.

4.2 Asymptotic multivariate normal distribution of estimators of $(\tau_1, \boldsymbol{\theta}_1^*)$

Theorem 1. Let $\boldsymbol{\theta}_1^* = (\theta_1^*, \dots, \theta_{q_1}^*)$ be the true value of $\boldsymbol{\theta}_1$. Let $\hat{\tau}_1^{(\tau_1)}$ and $\hat{\boldsymbol{\theta}}_1^{(\tau_1)} = (\hat{\theta}_{11}^{(\tau_1)}, \dots, \hat{\theta}_{1q_1}^{(\tau_1)})$ be estimators of τ_1 and $\boldsymbol{\theta}_1^*$, such that

(i)
$$\hat{\boldsymbol{\theta}}_{1}^{(\tau_{1})} \xrightarrow{P} \boldsymbol{\theta}_{1}^{*}$$
.
(ii) $\tau_{1}^{-1/2} \left\{ \hat{\tau}_{1}^{(\tau_{1})} - \left(M^{(\tau_{1})} + R_{1}^{(\tau_{1})} \right) / \left[1 - (1 - n/N) \pi_{\mathbf{0}}^{(1)} \left(\hat{\boldsymbol{\theta}}_{1}^{(\tau_{1})} \right) \right] \right\} \xrightarrow{P} 0$.
(iii) $\tau_{1}^{-1/2} \left[\frac{\partial}{\partial \theta_{j}^{(1)}} l_{(1)}^{(\tau_{1})} (\hat{\tau}_{1}^{(\tau_{1})}, \hat{\boldsymbol{\theta}}_{1}^{(\tau_{1})}) \right] \xrightarrow{P} 0, j = 1, \dots, q_{1}$.

In addition, let Σ_1^{-1} be the $(q_1 + 1) \times (q_1 + 1)$ matrix whose elements are

By condition (ii) of the theorem it follows that the left hand-side of the previous equation converges to zero in probability. Therefore, if we divide the right hand-side of this equation by $(1 - n/N)\pi_0^{(1)}(\theta_1^*)$ and use (14), we will get that the following expression also converges to zero in probability, that is

Since $\tau_1^{-1/2} Y_{\mathbf{x}}^{(\tau_1)} = O_p(1)$ and $\tau_1^{-1/2} Y_{\mathbf{x}}^{(A_l,\tau_1)} = O_p(1)$, these results along with conditions (3)-(4) and conditions (i) and (ii) of the theorem imply that (24) converges to zero in probability.

- (b) $V_{t,j}^{(1)} = 0, j = 1, ..., q_1$, and $V_t^{(1)} = -\left[1 (1 n/N)\pi_0^{(1)}(\boldsymbol{\theta}_1^*)\right] / \left[(1 n/N)\pi_0^{(1)}(\boldsymbol{\theta}_1^*)\right]$, if $t \in U_1 - S_0$ and its associated vector $\mathbf{X}_t^{(1)}$ of link-indicator variables equals the vector $\mathbf{0} \in \Omega$, and

4.4 Consistency of the UMLE and CMLE of (τ_1, θ_1^*)

To prove the consistency of the UMLE and CMLE we will use condition (5) and the following inequality of information theory: If $\sum a_i$ and $\sum b_i$ are convergent series of positive numbers such that $\sum a_i \ge \sum b_i$, then $\sum a_i \log(b_i) \le \sum a_i \log(a_i)$, and the equality is attained if and only if $a_i = b_i$. See Rao (1973, p. 58).

From the unconditional distributions of $M_i^{(\tau_1)}$, $M^{(\tau_1)}$ and $R_1^{(\tau_1)}$, $R_{\mathbf{x}}^{(A_i,\tau_1)}$ and $R_{\mathbf{x}}^{(A_i,\tau_1)}$ indicated in Subsection 4.1, it follows that $R_{\mathbf{x}}^{(\tau_1)}/R_1^{(\tau_1)} \xrightarrow{P} \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1^*)/[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1^*)]$, $R_{\mathbf{x}}^{(A_i,\tau_1)}/M_i^{(\tau_1)} \xrightarrow{P} \pi_{\mathbf{x}}^{(A_i)}(\boldsymbol{\theta}_1^*)$ and $M_i^{(\tau_1)}/R_1^{(\tau_1)} \xrightarrow{P} 1/\{(N-n)[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1^*)]\}$. Therefore, the first two summands of the last term of the double inequality (33) converges to zero in probability, In addition, since $R_1^{(\tau_1)}/\tau_1 \xrightarrow{P} 1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1^*)$, and from well known results of large deviations theory (see Varadhan, 2008), we have that for the binomial probability $L_{12}(\tau_1, \boldsymbol{\theta}_1^*)$:

and for the multinomial probability $L_{MULT}(\tau_1)$:

The previous results imply that the last term of the double inequality (33) converges to zero in probability, and consequently so does the middle term.

Thus,

as $\ln \left\{ \left[\pi_{\mathbf{x}}^{(1)} \left(\hat{\boldsymbol{\theta}}_{1}^{(U)} \right) / \left(1 - \pi_{\mathbf{0}}^{(1)} \left(\hat{\boldsymbol{\theta}}_{1}^{(U)} \right) \right) \right] / \left[R_{\mathbf{x}}^{(\tau_{1})} / R_{1}^{(\tau_{1})} \right] \right\}$ and $\ln \left[\pi_{\mathbf{x}}^{(A_{i})} \left(\hat{\boldsymbol{\theta}}_{1}^{(U)} \right) / \left(R_{\mathbf{x}}^{(A_{i},\tau_{1})} / M_{i}^{(\tau_{1})} \right) \right]$ are bounded as $\tau_{1} \to \infty$ (otherwise the middle term of the inequality (33) would not converge to zero). Finally, condition (5) implies that for any $\delta_{1} > 0$ we have that $\Pr \left\{ \left\| \hat{\boldsymbol{\theta}}_{1}^{(U)} - \boldsymbol{\theta}_{1}^{*} \right\| \le \delta_{1} \right\} \to 1$, that is, $\hat{\boldsymbol{\theta}}_{1}^{(U)} \stackrel{P}{\to} \boldsymbol{\theta}_{1}^{*}$.

Straightforward results of the previous one are the following: $\pi_{\mathbf{x}}^{(1)}\left(\hat{\boldsymbol{\theta}}_{1}^{(U)}\right) \xrightarrow{P} \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*}),$ $\mathbf{x} \in \Omega$, and $\pi_{\mathbf{x}}^{(A_{i})}\left(\hat{\boldsymbol{\theta}}_{1}^{(U)}\right) \xrightarrow{P} \pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1}^{*}), \mathbf{x} \in \Omega_{-i}, i = 1, ..., n$, as $\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1})$ and $\pi_{\mathbf{x}}^{(A_{i})}(\boldsymbol{\theta}_{1})$ are assumed to be continuous functions of $\boldsymbol{\theta}_{1}$.

assumed to be continuous functions of $\boldsymbol{\theta}_1$. With respect to $\hat{\tau}_1^{(U)}$, from expression (5) we have that the difference between $\hat{\tau}_1^{(U)}$ and $\left(M^{(\tau_1)} + R_1^{(\tau_1)}\right) / \left[1 - (1 - n/N)\pi_{\mathbf{0}}^{(1)}\left(\hat{\boldsymbol{\theta}}_1^{(U)}\right)\right]$ is less than 1. Thus, $\left\{\hat{\tau}_1^{(U)} - \left(M^{(\tau_1)} + R_1^{(\tau_1)}\right) / \left[1 - (1 - n/N)\pi_{\mathbf{0}}^{(1)}\left(\hat{\boldsymbol{\theta}}_1^{(U)}\right)\right]\right\} / \tau_1 = \hat{\tau}_1^{(U)} / \tau_1 - \left[\left(M^{(\tau_1)} + R_1^{(\tau_1)}\right) / \tau_1\right] / \left[1 - (1 - n/N)\pi_{\mathbf{0}}^{(1)}\left(\hat{\boldsymbol{\theta}}_1^{(U)}\right)\right]\right\}$ $\pi_{\mathbf{0}}^{(1)}\left(\hat{\boldsymbol{\theta}}_{1}^{(U)}\right) \xrightarrow{P} 0$, and since the second term of the last difference converges to 1 in probability so does $\hat{\tau}_{1}^{(U)}/\tau_{1}$.

4.4.2 Consistency of the CMLE

By the definition of the CMLE $\hat{\theta}_1^{(C)}$, we have that

$$\geq \sum_{\mathbf{x}\in\Omega-\{\mathbf{0}\}} \frac{R_{\mathbf{x}}^{(\tau_{1})}}{R_{1}^{(\tau_{1})}} \ln\left[\frac{\pi_{\mathbf{x}}^{(1)}\left(\theta_{1}^{*}\right)}{1-\pi_{\mathbf{0}}^{(1)}\left(\theta_{1}^{*}\right)}\right] + C$$

$$= \frac{\ln[L_{11}(\theta_{1}^{*})L_{0}(\theta_{1}^{*})]}{R_{1}^{(\tau_{1})}},$$

where C depends only on observable variables.

Using the same procedure as that used in the case of the UMLE $\hat{\boldsymbol{\theta}}_{1}^{(U)}$ we will get the double inequality (33) but in terms of $\hat{\boldsymbol{\theta}}_{1}^{(C)}$ instead of $\hat{\boldsymbol{\theta}}_{1}^{(U)}$ and without the terms $\ln[L_{MULT}(\tau_1)]/R_1^{(\tau_1)}$ and $\ln[L_{12}(\tau_1, \boldsymbol{\theta}_1^*)]/R_1^{(\tau_1)}$. Consequently, we will also have that $\hat{\boldsymbol{\theta}}_{1}^{(C)} \xrightarrow{P} \boldsymbol{\theta}_{1}^*, \pi_{\mathbf{x}}^{(1)}(\hat{\boldsymbol{\theta}}_{1}^{(C)}) \xrightarrow{P} \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^*), \mathbf{x} \in \boldsymbol{\Omega}_{-i}, i = 1, \ldots, n, \text{ and } \hat{\tau}_{1}^{(C)}/\tau_1 \xrightarrow{P} 1$, where the last result is obtained by using expression (8) and the same arguments as those used to prove that $\hat{\tau}_{1}^{(U)}/\tau_1 \xrightarrow{P} 1$.

4.5 Asymptotic distributions of the UMLEs and CMLEs of τ_1 and θ_1^*

4.5.1 Asymptotic multivariate normal distribution of the UMLE of (τ_1, θ_1^*)

We will prove the asymptotic multivariate normal distribution of $\left(\tau_1^{-1/2}\hat{\tau}_1^{(U)}, \tau_1^{1/2}\hat{\theta}_1^{(U)}\right)$ by proving that this estimator satisfies the conditions of Theorem 1. Condition (i) was already proved in the previous section. From expression (5) it follows that $\left(\hat{\tau}_1^{(U)}, \hat{\theta}_1^{(U)}\right)$ satisfies condition (ii). Finally, by the definition of the UMLEs we have that condition (iii) is also satisfied. Thus, by Theorem 1, $\left[\tau_1^{-1/2}\left(\hat{\tau}_1^{(U)} - \tau_1\right), \tau_1^{1/2}\left(\hat{\theta}_1^{(U)} - \theta_1^*\right)\right] \xrightarrow{D} N_{q_1+1}(\mathbf{0}, \Sigma_1)$. This result implies that $\tau_1^{-1/2} \left(\hat{\tau}_1^{(U)} - \tau_1 \right) \xrightarrow{D} N(0, \sigma_{1U}^2)$ and $\tau_1^{1/2} \left(\hat{\theta}_1^{(U)} - \theta_1^* \right) \xrightarrow{D} N_{q_1} \left(\mathbf{0}, \boldsymbol{\Sigma}_{1_{22}} \right)$, where

 $\nabla \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})$ is the gradient of $\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1})$ evaluated at $\boldsymbol{\theta}_{1}^{*}$ and $\Sigma_{1_{22}}^{-1}$ is the $q_{1} \times q_{1}$ submatrix of Σ_{1}^{-1} obtained by removing its first row and first column.

4.5.2 Asymptotic multivariate normal distribution of the CMLE $\hat{\theta}_1^{(U)}$ and asymptotic normal distribution of the CMLE $\hat{\tau}_1^{(C)}$

The CMLE $\left(\tau_1^{-1/2}\hat{\tau}_1^{(C)}, \tau_1^{1/2}\hat{\theta}_1^{(C)}\right)$ does not have an asymptotic multivariate normal distribution since this estimator does not satisfy condition (iii) of Theorem 1. To see this, notice that by (7) it follows that $\partial \left\{ \ln \left[L_{11} \left(\hat{\theta}_1^{(C)} \right) L_0 \left(\hat{\theta}_1^{(C)} \right) \right] \right\} / \partial \theta_j^{(1)} = 0$. Therefore,

By using expression (8) and after some algebraic steps we get that

From (8) and the fact that $\pi_{\mathbf{0}}^{(1)}\left(\hat{\boldsymbol{\theta}}_{1}^{(C)}\right) \xrightarrow{P} \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})$, it follows that the order of magnitude of the first term in the curly brackets of (36) is $O_p\left(\tau_1^{-1/2}\right)$. On the other hand, since $M^{(\tau_1)}/\tau_1 = n/N + O_p\left(\tau_1^{-1/2}\right)$, $R_1^{(\tau_1)}/\tau_1 = (1 - n/N)\left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1^{*})\right] + O_p\left(\tau_1^{-1/2}\right)$ and, as we will show in the next paragraph, $\hat{\boldsymbol{\theta}}_1^{(C)} = \boldsymbol{\theta}_1^* + O_p\left(\tau_1^{-1/2}\right)$, it follows that the order of the second term in the curly brackets of (36) is $O_p(1)$; therefore (36) does not converge to zero in probability.

Nevertheless, although $\left[\tau_1^{-1/2}\left(\hat{\tau}_1^{(C)} - \tau_1\right), \tau_1^{1/2}\left(\hat{\theta}_1^{(C)} - \theta_1^*\right)\right]$ does not have an asymptotic multivariate normal distribution, $\tau_1^{1/2}\left(\hat{\theta}_1^{(C)} - \theta_1^*\right)$ does have. To prove this, we will show that conditions (i) and (ii) of Theorem 2 are satisfied. In the previous section we proved that $\hat{\theta}_1^{(C)}$ satisfies condition (i), and from (7) we have that $\hat{\theta}_1^{(C)}$ satisfies condition (ii). Thus by Theorem 2, $\tau_1^{1/2}\left(\hat{\theta}_1^{(C)} - \theta_1^*\right) \stackrel{D}{\to} N_{q_1}(\mathbf{0}, \Psi_1)$.

Now, $\tau_1^{-1/2} \left(\hat{\tau}_1^{(C)} - \tau_1 \right)$ has also an asymptotic normal distribution because in addition that $\hat{\theta}_1^{(C)}$ satisfies conditions (i) and (ii) of Theorem 2, $\hat{\tau}_1^{(C)}$ satisfies condition (iii). Thus by Theorem 2, $\tau_1^{-1/2} \left(\hat{\tau}_1^{(C)} - \tau_1 \right) \xrightarrow{D} N(0, \sigma_{1C}^2)$, where σ_{1C}^2 is given by (20).

It is worth noting that the asymptotic marginal distributions of $\tau_1^{-1/2} \left(\hat{\tau}_1^{(C)} - \tau_1 \right)$ and $\tau_1^{1/2} \left(\hat{\theta}_1^{(C)} - \theta_1^* \right)$ are not the same as those of $\tau_1^{-1/2} \left(\hat{\tau}_1^{(U)} - \tau_1 \right)$ and $\tau_1^{1/2} \left(\hat{\theta}_1^{(U)} - \theta_1^* \right)$. To show this, we will firstly prove that

$$\Psi_{1}^{-1} = \Sigma_{1_{22}}^{-1} - \frac{1 - n/N}{\pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*}) \left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]} \left[\nabla \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right] \left[\nabla \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]', \quad (37)$$

where Ψ_1^{-1} is the $q_1 \times q_1$ matrix defined in the statement of Theorem 2 and $\Sigma_{1_{22}}^{-1}$ is the $q_1 \times q_1$ submatrix of the matrix Σ_1^{-1} , defined in the statement of Theorem 1, obtained by removing its first row and first column. Since $\tilde{\pi}_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1^*) = \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_1^*) / \left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_1^*)\right]$, it follows that

$$\frac{\partial \tilde{\pi}_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*})}{\partial \theta_{j}^{(1)}} = \frac{\left[\partial \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*}) / \partial \theta_{j}^{(1)}\right] \left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right] + \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*}) \left[\partial \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*}) / \partial \theta_{j}^{(1)}\right]}{\left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]^{2}} \\ = \frac{1}{1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})} \frac{\partial \pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*})}{\partial \theta_{j}^{(1)}} + \frac{\pi_{\mathbf{x}}^{(1)}(\boldsymbol{\theta}_{1}^{*})}{\left[1 - \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})\right]^{2}} \frac{\partial \pi_{\mathbf{0}}^{(1)}(\boldsymbol{\theta}_{1}^{*})}{\partial \theta_{j}^{(1)}}.$$

Then

Therefore, from the definitions of Ψ_1^{-1} and $\Sigma_{1_{22}}^{-1}$ we have that

$$\left[\boldsymbol{\Psi}_{1}^{-1}\right]_{i,j} = \left[\boldsymbol{\Sigma}_{122}^{-1}\right]_{i,j} - \frac{1 - n/N}{\pi_{\mathbf{0}}^{(1)}\left(\boldsymbol{\theta}_{1}^{*}\right)\left[1 - \pi_{\mathbf{0}}^{(1)}\left(\boldsymbol{\theta}_{1}^{*}\right)\right]} \frac{\partial \pi_{\mathbf{0}}^{(1)}\left(\boldsymbol{\theta}_{1}^{*}\right)}{\partial \theta_{i}^{(1)}} \frac{\partial \pi_{\mathbf{0}}^{(1)}\left(\boldsymbol{\theta}_{1}^{*}\right)}{\partial \theta_{j}^{(1)}},$$

and (37) is proved.

From (34) and (37) it follows that $\sigma_{1C}^2 \neq \sigma_{1U}^2$, and hence $\tau_1^{-1/2} \left(\hat{\tau}_1^{(U)} - \tau_1 \right)$ and $\tau_1^{-1/2} \left(\hat{\tau}_1^{(C)} - \tau_1 \right)$

 τ_1) do not have the same asymptotic normal distribution. In addition, (35) and (37) imply that $\Psi_1 \neq \Sigma_{1_{22}}$, and consequently that $\tau_1^{1/2} \left(\hat{\theta}_1^{(U)} - \theta_1^* \right)$ and $\tau_1^{1/2} \left(\hat{\theta}_1^{(C)} - \theta_1^* \right)$ do not have the same asymptotic normal distribution. Notice also that even though the asymptotic marginal distributions of the UMLEs and CMLEs of τ_1 and θ_1^* are not the same, from (37) it follows that if n/N were small enough so that $1 - (1 - n/N)\pi_0^{(1)} (\theta_1^*) \approx 1 - \pi_0^{(1)} (\theta_1^*)$, then $\Psi_1 \approx \Sigma_{1_{22}}$ and their asymptotic marginal distributions would be very similar to each other.

4.6 Asymptotic properties of unconditional and conditional maximum likelihood estimators of (τ_2, θ_2^*)

The unconditional and conditional maximum likelihood estimators of (τ_2, θ_2^*) are exactly the same as those used in capture-recapture studies. Sanathanan (1972) assumed conditions similar to (1)-(4) and (6) and proved the following results:

(i) $\hat{\boldsymbol{\theta}}_2^{(U)} \xrightarrow{P} \boldsymbol{\theta}_2^*$ and $\hat{\boldsymbol{\theta}}_2^{(C)} \xrightarrow{P} \boldsymbol{\theta}_2^*$ as $\tau_2 \to \infty$.

 and $\hat{\tau}_2^{(C)}/\tau_2 \xrightarrow{P} 1$ as $\tau_2 \to \infty$.

(iii)
$$\left[\tau_2^{-1/2}\left(\hat{\tau}_2^{(U)} - \tau_2\right), \tau_2^{1/2}\left(\hat{\boldsymbol{\theta}}_2^{(U)} - \boldsymbol{\theta}_2^*\right)\right] \xrightarrow{D} N_{q_2}\left(\mathbf{0}, \boldsymbol{\Sigma}_2\right) \text{ and } \left[\tau_2^{-1/2}\left(\hat{\tau}_2^{(C)} - \tau_2\right), \tau_2^{1/2}\left(\hat{\boldsymbol{\theta}}_2^{(C)} - \boldsymbol{\theta}_2^*\right)\right] \xrightarrow{D} N_{q_2}\left(\mathbf{0}, \boldsymbol{\Sigma}_2\right) \text{ as } \tau_2 \to \infty,$$

where Σ_2 is the inverse of the $(q_2 + 1) \times (q_2 + 1)$ matrix Σ_2^{-1} defined by

$$\begin{split} \left[\boldsymbol{\Sigma}_{2}^{-1} \right]_{1,1} &= \left[1 - \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] / \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*}), \\ \left[\boldsymbol{\Sigma}_{2}^{-1} \right]_{1,j+1} &= \left[\boldsymbol{\Sigma}_{2}^{-1} \right]_{j+1,1} = - \left[1 / \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] \left[\partial \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) / \partial \theta_{j}^{(2)} \right], \ j = 1, \dots, q_{2}, \\ \left[\boldsymbol{\Sigma}_{2}^{-1} \right]_{i+1,j+1} &= \left[\boldsymbol{\Sigma}_{2}^{-1} \right]_{j+1,i+1} = \sum_{\mathbf{x} \in \Omega} \left[1 / \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] \left[\partial \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) / \partial \theta_{i}^{(2)} \right] \left[\partial \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) / \partial \theta_{i}^{(2)} \right] \\ &\quad i, j = 1, \dots, q_{2}, \end{split}$$

and which is assumed to be a non-singular matrix.

Because the proofs of these results are exactly the same as those given by Sanathanan (1972), we will omit them. It is worth noting that unlike the CMLE $\left(\tau_1^{-1/2}\hat{\tau}_1^{(C)}, \tau_1^{1/2}\hat{\theta}_1^{(C)}\right)$, the estimator $\left(\tau_2^{-1/2}\hat{\tau}_2^{(C)}, \tau_2^{1/2}\hat{\theta}_2^{(C)}\right)$ does have an asymptotic multivariate normal distribution.

The previous results imply that $\tau_2^{-1/2} \left(\hat{\tau}_2^{(U)} - \tau_2 \right) \xrightarrow{D} N(0, \sigma_2^2)$ and $\tau_2^{-1/2} \left(\hat{\tau}_2^{(C)} - \tau_2 \right) \xrightarrow{D} N(0, \sigma_2^2)$, where

$$\sigma_{2}^{2} = \frac{1}{1 - \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*})} \left\{ \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) + \frac{1}{1 - \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*})} \left[\nabla \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right]' \left[\Sigma_{222}^{-1} - \frac{1}{\pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*})} \left[1 - \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] \left[\nabla \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] \left[\nabla \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right]' \right]^{-1} \left[\nabla \pi_{0}^{(2)}(\boldsymbol{\theta}_{2}^{*}) \right] \right\}$$

where $\nabla \pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2}^{*})$ is the gradient of $\pi_{\mathbf{0}}^{(2)}(\boldsymbol{\theta}_{2})$ evaluated at $\boldsymbol{\theta}_{2}^{*}$ and Σ_{222}^{-1} is the $q_{2} \times q_{2}$ submatrix of $\boldsymbol{\Sigma}_{2}^{-1}$ obtained by removing its first row and first column.

4.7 Consistency and asymptotic normality of the unconditional and conditional maximum likelihood estimators of $\tau = \tau_1 + \tau_2$

The UMLE and CMLE of $\tau = \tau_1 + \tau_2$ were defined in Subsection 3.3.3 by $\hat{\tau}^{(U)} = \hat{\tau}_1^{(U)} + \hat{\tau}_2^{(U)}$ and $\hat{\tau}^{(C)} = \hat{\tau}_1^{(C)} + \hat{\tau}_2^{(C)}$. From assumptions **A** and **B** and the previous results we have that $\hat{\tau}^{(U)}/\tau = (\tau_1/\tau) \left(\hat{\tau}_1^{(U)}/\tau_1\right) + (\tau_2/\tau) \left(\hat{\tau}_2^{(U)}/\tau_2\right) \xrightarrow{P} \alpha_1 \times 1 + \alpha_2 \times 1 = 1$, as $\tau_1 \to \infty$ and $\tau_2 \to \infty$. Similarly, $\hat{\tau}^{(C)}/\tau \xrightarrow{P} 1$ as $\tau_1 \to \infty$ and $\tau_2 \to \infty$. Furthermore, $\tau^{-1/2} (\hat{\tau}^{(U)} - \tau) = (\tau/\tau_1)^{-1/2} \tau_1^{-1/2} \left(\hat{\tau}_1^{(U)} - \tau_1\right) + (\tau/\tau_2)^{-1/2} \tau_2^{-1/2} \left(\hat{\tau}_2^{(U)} - \tau_2\right) \xrightarrow{P} N(0, \sigma_U^2)$, as $\tau_1 \to \infty$ and $\tau_2 \to \infty$, where $\sigma_U^2 = \alpha_1 \sigma_{1U}^2 + \alpha_2 \sigma_2^2$. Likewise, $\tau^{-1/2} (\hat{\tau}^{(C)} - \tau) \xrightarrow{P} N(0, \sigma_U^2)$.

5 Estimation of the matrices Σ_k^{-1} and Ψ_1^{-1}

Although estimates of Σ_k^{-1} , k = 1, 2, and Ψ_1^{-1} can be obtained by replacing the parameters θ_k^* and θ_1^* by their respective estimates in the expressions for these matrices, this procedure requires the computation of sums of 2^n terms. This is not a problem if n is small, but if n is large enough, say greater than or equal to 20, the number of these terms is very large and the calculation of the estimates of Σ_k^{-1} and Ψ_1^{-1} could be computationally expensive.

A procedure that requires a much smaller number of calculations is based on estimates of the vectors $\mathbf{V}_t^{(k)}$, $t = 1, \ldots, \tau_k$, k = 1, 2. Vectors $\mathbf{V}_t^{(1)}$ s were defined in the proofs of Theorems 1 and 2, whereas vectors $\mathbf{V}_t^{(2)}$ s are defined in Sanathanan (1972) and we will give their definition later in this section. As was shown in the proofs of Theorem 1 and 2, the vectors $\mathbf{V}_t^{(1)}$ s are independent and equally distributed with mean vector equal to the vector zero and covariance matrix equal to Σ_1^{-1} in the case of Theorem 1, and Ψ_1^{-1} in the case of Theorem 2. The same result holds in the case of the vectors $\mathbf{V}_t^{(2)}$ s, but the covariance matrix is Σ_2^{-1} . Therefore, the sample covariance matrix of the vectors $\mathbf{V}_t^{(k)}$ s is an estimate of their covariance matrix (Σ_k^{-1} or Ψ_1^{-1}) based only on τ_k observations. To implement this procedure we need to estimate the $\mathbf{V}_t^{(k)}$ s (they are unknown because depend on $\boldsymbol{\theta}_k^*$ and τ_k). In the case of the $\mathbf{V}_t^{(1)}$ s defined in Theorem 1 an estimate $\hat{\mathbf{V}}_t^{(1)}$ of $\mathbf{V}_t^{(1)}$ could be obtained by replacing $\boldsymbol{\theta}_1^*$ by $\hat{\boldsymbol{\theta}}_1^{(U)}$ in the expression for $\mathbf{V}_t^{(1)}$, and τ_1 could be estimated by $\hat{\tau}_1^{(U)}$. In the case of the $\mathbf{V}_t^{(1)}$ s defined in Theorem 2 estimates of $\mathbf{V}_t^{(1)}$ could be obtained by replacing $\boldsymbol{\theta}_1^*$ by $\hat{\boldsymbol{\theta}}_1^{(C)}$ in the expression for $\mathbf{V}_t^{(1)}$, and τ_1 could be estimated by $\hat{\tau}_1^{(C)}$. Estimates of $\mathbf{V}_t^{(2)}$ s and τ_2 could be obtained as in the case of Theorem 1, and in this situation both UMLE and CMLE could be used. Thus, once $\hat{\tau}_k$ and the vectors $\hat{\mathbf{V}}_t^{(k)}$ s are obtained, their sample covariance matrix can be computed and used as an estimate of $\boldsymbol{\Sigma}_k^{-1}$ or $\boldsymbol{\Psi}_1^{-1}$.

The vectors $\mathbf{V}_t^{(2)} = [V_{t,1}^{(2)}, \dots, V_{t,q_2+1}^{(2)}]', t = 1, \dots, \tau_2$, are defined as follows:

- (a) $V_{t,1}^{(2)} = 1$ and $V_{t,j+1}^{(2)} = [\pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*})]^{-1} \partial \pi_{\mathbf{x}}^{(2)}(\boldsymbol{\theta}_{2}^{*}) / \partial \theta_{j}^{(2)}, j = 1, \dots, q_{2}$, if the vector $X_{t}^{(2)}$ of link-indicator variables associated with the *t*-th element in U_{2} equals the vector $\mathbf{x} \in \Omega \{\mathbf{0}\}$;
- (b) $V_{t,1}^{(2)} = -\left[1 \pi_0^{(2)}(\boldsymbol{\theta}_2^*)\right] / \pi_0^{(2)}(\boldsymbol{\theta}_2^*)$ and $V_{t,j+1}^{(2)} = [\pi_0^{(2)}(\boldsymbol{\theta}_2^*)]^{-1} \partial \pi_0^{(2)}(\boldsymbol{\theta}_2^*) / \partial \theta_j^{(2)}, j = 1, \ldots, q_2$, if the vector $X_t^{(2)}$ of link-indicator variables associated with the *t*-th element in U_2 equals the vector $\mathbf{0} \in \Omega$.

6 Conclusions

Whenever we want to apply the results that we have obtained in this research to an actual situation we need to determine whether or not the assumed conditions are reasonably well satisfied by those observed in the actual scenario. In particular we have assumed that the numbers M_i s of people found in the sampled sites follow a multinomial distribution with homogeneous cell probabilities and that the M_i s go to infinity while the number of sites n in the sample and N in the frame are fixed. These assumptions imply that in the actual scenario the M_i s should be relatively large and not very variable. However, we do not know how large they should be so that the results can be safely used. Therefore, Monte Carlo studies are required to assess the reliability of the asymptotic results under different scenarios with finite samples and populations. In addition, although we have assumed a general parametric model for the link-probabilities which allows the possibility that the parameter depends or not on the sampled sites, the model precludes that the probabilities depend on the M_i s as they go to infinity. Furthermore, this assumption assures that the estimators of τ_1 and τ_2 be independent and not only conditionally independent given the M_i s.

An alternative asymptotic framework to the one considered in this work is to assume that the numbers of sites n in the sample and N in the frame go to infinity whereas the M_i s are fixed. However, this would involve dealing with multinomial distributions with infinite numbers of cells. An approach that could be used to derive asymptotic properties of estimators under this framework is the one considered by Rao (1958) who derived asymptotic properties of a maximum likelihood estimator of a parameter on which depend the cell probabilities of a multinomial distribution with infinite number of cells. However, this is a topic of a future research.
