The Neumann Problem for Hessian Equations

Abstract

In this paper, we prove the existence of a classical solution to a Neumann boundary problem for Hessian equations in uniformly convex domain. The methods depend upon the established of a priori derivative estimates up to second order. So we give a affirmative answer to a conjecture of N. Trudinger in 1986.

Keywords: Hessian equations, Neumann problem, Uniformly convex domain.

1 Introduction

In this paper, we study the existence of the classical solution for the following Neumann problem:

$$\begin{cases} \sigma_k(D^2u) = f(x,u) & \text{in } \Omega, \\ u_\nu = \varphi(x,u) & \text{on } \partial\Omega, \end{cases}$$

where $\sigma_k(D^2u)$ is the k-th elementary symmetric function of eigenvalues of D^2u , and ν is outer unit normal vector of $\partial\Omega$. When k = 1, this is well-known Laplace equation with Neumann boundary condition, for priori estimates and the existence theorem we refer to the book [12]. For k = n, the priori estimates and existence result were obtained by Lions, Trudinger and Urbas [31]. But for $2 \leq k \leq n - 1$, Trudinger [38] established the existence theorem when the domain is a ball, and he conjectured (in [38], page 305) that one can solve the problem in sufficiently smooth uniformly convex domains. Now we give a positive answer to this problem.

Theorem 1.1. Let Ω be a C^4 bounded uniformly convex domain in \mathbb{R}^n . Where $f \in C^2(\overline{\Omega})$ is positive function and $\varphi \in C^3(\overline{\Omega})$. Then there exists a unique k admissible solution $u \in C^{3,\alpha}(\overline{\Omega})$ of the boundary value problem,

$$\begin{cases} \sigma_k(D^2u) = f(x) & \text{in } \Omega, \\ u_\nu = -u + \varphi(x) & \text{on } \partial\Omega. \end{cases}$$

Remark 1: For simplicity we only states this particular form of existence theorem, due to the C^0 estimate is easy to handle in this case while we do not want to emphasize C^0 estimate in this paper (see [31] for more general cases).

Hessian equation is an important nonlinear elliptic partial differential equation. It appears naturally in classical geometry, conformal geometry and Kähler geometry. Now let us brief recall some history and development for this equation, for more detail please see the paper by Wang [45].

First for the Hessian equation on \mathbb{R}^n , its Dirichlet boundary value problem

$$\begin{cases} \sigma_k(D^2 u) = f(x) & \text{in } \Omega, \\ u = \varphi(x) & \text{on } \partial\Omega, \end{cases}$$
(3)

was studied by Caffrelli-Nirenberg-Spruck [2], Ivochkina [19] and Trudinger [39]. Chou-Wang [7] got the Pogorelov type interior estimates and the existence of variational solution. Trudinger-Wang [40] developed a Hessian measure theory for Hessian operator.

For the curvature equations in classical geometry, the existence of hypersurfaces with prescribed Weingarten curvature was studied by Pogorelov [34], Caffarelli-Nirenberg-Spruck [3, 4], Guan-Guan [14], Guan-Ma [15] and the later work by Sheng-Trudinger-Wang [35]. The Hessian equation on Riemannian manifolds was also studied by Y.Y.Li [22], Urbas [44] and Guan [13]. In recent years the Hessian type equation also appears in conformal geometry, which started from Chang-Gursky-Yang [5] and the related development by ([16], [23], [17], [36], [10]). In Kähler geometry, the Hessian equation was studied by Hou-Ma-Wu [18] and Dinew-Kolodziej [8].

The Yamabe problem on manifolds with boundary was first studied by Escobar [9], he shows that (almost) every compact Riemannian manifold (M, g) is conformally equivalent to one of constant scalar curvature, whose boundary is minimal. The problem reduces to solving the semilinear elliptic critical Sobolev exponent equation with the Neumann boundary condition. It is naturally, the Neumann boundary value problem for Hessian type equations also appears in the fully nonlinear Yamabe problem for manifolds with boundary, which is to find a conformal metric $\hat{g} = \exp(-2u)g$ such that the k-th elementary symmetric function of eigenvalues of Schouten tensor is constant and with the constant mean curvature on the boundary of manifold. See for Jin-Li-Li [21], Chen [6] and Li-Luc [24, 25], but in all these papers they need to impose the manifold are umbilic or total geodesic boundary for $k \geq 2$, which are more like the condition in Trudinger [38] that the domain is ball.

The Neumann or oblique derivative problem on linear and quasilinear elliptic equations was widely studied for a long time, one can see the recent book written by Lieberman [27]. Especially for the mean curvature equation with prescribed contact angle boundary value problem, Ural'tseva [41], Simon-Spruck [37] and Gerhardt [11] got the boundary gradient estimates and the corresponding existence theorem. Recently in [33], Ma-Xu got the boundary gradient estimates and the corresponding existence theorem for the Neumann boundary value problem on mean curvature equation. For related results on the Neumann or oblique derivative problem for some class fully nonlinear elliptic equations can be found in Urbas [42, 43].

We give a brief description of our procedures and ideas to this problem. By the standard theory of Lieberman-Trudinger [28] (see also [30], [27]), it is well known that the solvability of the Hessian equations with Neumann boundary value can be reduced to the priori global second order derivative estimates. We have done C^1 estimate (jointed with J.J. Xu) in [32] a year ago, there we constructed a suitable auxiliary function and use particular coordinate to let the estimate computable. For C^2 estimate, we first reduce the global estimate to the boundary double normal derivative, this estimate also plays an important role in our boundary double normal estimate. The main difficulty lies to construct the barrier functions of u_{ν} . The Neumann boundary condition will bring us a trouble term as " $\sum_{ijk} F^{ij} u_{ik} D_j \nu^{k}$ ". Motivated by Lions-

Trudinger-Urbas [31], Trudinger [38], Ivochkina- Trudinger-Wang [20] and Urbas [42], we introduce a new barrier function, then we can extract a good term and control this trouble term. For C^0 estimate, we deal with a particular form of f and φ as in [38] for simplicity.

The rest of the paper is organized as follows. In section 2, we first give the definitions and some notations. We get the C^0 and C^1 , which was obtained by Trudinger [38] and Ma-Qiu-Xu [32]. In section 4, we obtain the C^2 estimates, which is the main estimates in this paper. In last section 5, we prove the main Theorem 1.1.

2 Preliminaries

In this section, we introduce the admissible solution and some element properties for k-th elementary symmetric function.

Definition For any $k = 1, 2, \dots, n$, and $\lambda = (\lambda_1, \dots, \lambda_n) \in \mathbb{R}^n$ we set

$$\sigma_k(\lambda) = \sum_{1 \le i_1 < \dots < i_k \le n} \lambda_{i_1} \lambda_{i_2} \cdots \lambda_{i_k}.$$

We denote by $\sigma_k(\lambda|i)$ the symmetric function with $\lambda_i = 0$ and $\sigma_k(\lambda|ij)$ the symmetric function with $\lambda_i = \lambda_j = 0$. Let $\lambda(D^2u)$ be the eigenvalue of D^2u and $\sigma_k(D^2u) = \sigma_k(\lambda(D^2u))$. And we let

$$\Gamma_k = \{ (\lambda_1, \cdots, \lambda_n) \in \mathbb{R}^n | \quad \sigma_j(\lambda) > 0 \quad \forall \quad j = 1, \cdots, k \}.$$

We say a function u is k admissible if $\lambda(D^2 u) \in \Gamma_k$.

Denote $F^{ij} := \frac{\partial \sigma_k(D^2 u)}{\partial u_{ij}}, \ \mathcal{F} := \sum_{1 \le i \le n} F^{ii}$. Sometimes we write the equation (1) in the form

$$\widetilde{F}(D^2u) := \sigma_k^{\frac{1}{k}}(D^2u) = f^{\frac{1}{k}} =: \widetilde{f},$$

and use the notation

$$\widetilde{F}^{ij} := \frac{\partial \widetilde{F}}{\partial u_{ij}}, \ \widetilde{F}^{ij,pq} := \frac{\partial^2 \widetilde{F}}{\partial u_{ij} \partial u_{pq}}.$$

 σ_k operator has following simple properties.

Proposition 2.1.

$$\sigma_k(\lambda) = \sigma_k(\lambda|i) + \lambda_i \sigma_{k-1}(\lambda|i), \forall 1 \le i \le n,$$
(8)

$$F^{ij}u_{ij} = k\sigma_k,\tag{9}$$

and

$$\mathcal{F} = (n-k+1)\sigma_{k-1}.\tag{10}$$

Proof. See [26].

Proposition 2.2. If $\lambda \in \Gamma_k$, then we have

$$\sigma_h(\lambda|i) > 0, \quad \forall h < k \quad and \quad 1 \le i \le n, \tag{11}$$

and $\sigma_k^{\frac{1}{k}}$ is a concave function in Γ_k .

Proof. See [26].

The following proposition is so called MacLaurin inequality.

Proposition 2.3. For $\lambda \in \Gamma_k$ and $k \ge l \ge 1$, we have

$$\left[\frac{\sigma_k(\lambda)}{C_n^k}\right]^{\frac{1}{k}} \le \left[\frac{\sigma_l(\lambda)}{C_n^l}\right]^{\frac{1}{l}}.$$
(12)

Moreover,

$$\sum_{1}^{n} \frac{\partial \sigma_{k}^{\frac{1}{k}}(\lambda)}{\partial \lambda_{i}} \ge [C_{n}^{k}]^{\frac{1}{k}}.$$
(13)

Proof. See [26].

Proposition 2.4. Let $\lambda \in \Gamma_k$. Suppose that

$$\lambda_1 \geq \cdots \geq \lambda_k \geq \cdots \geq \lambda_n,$$

then we have

$$\lambda_1 \sigma_{k-1}(\lambda|1) \ge \frac{k}{n} \sigma_k(\lambda), \tag{14}$$

for $\forall i < k$

$$\sigma_{k-1}(\lambda|i) \ge \sigma_{k-1}(\lambda|k) \ge c(n,k)\sigma_{k-1}(\lambda) > 0, \tag{15}$$

and

$$\lambda_1 \ge \lambda_2 \ge \dots \ge \lambda_k > 0. \tag{16}$$

Proof. See [29] for these inequalities, one can also see [18] for the first inequality. The third one can be induced by the first inequality and (11).

3 C^0 and C^1 estimates

In this section we get the a priori bounded estimates and gradient estimates for the k- admissible solution of the equation (2). For the C^0 estimates, which was gotten by Trudinger [38].

Theorem 3.1. [38] Let $\Omega \subset \mathbb{R}^n$ be a bounded C^1 domain, and ν is the outer unit normal vector of $\partial\Omega$. Suppose $u \in C^2(\overline{\Omega}) \cap C^3(\Omega)$ is an k-admissible solution of the following Neumann boundary problems of Hessian equation

$$\begin{cases} \sigma_k(D^2u) = f(x) & \text{in } \Omega, \\ u_\nu = -u + \varphi(x) & \text{on } \partial\Omega. \end{cases}$$
(17)

Then

$$\sup_{\overline{\Omega}} |u| \le M_0,\tag{18}$$

where M_0 depends on k, n, diam Ω , φ , sup f.

Proof. Taking $o \in \Omega$ and let us consider $u - A|x|^2$. Fixing A large depend on k, n and $\sup f$ so that we have

$$F[D^{2}u] = f \le F[D^{2}(A|x|^{2})].$$
(19)

Comparison principle tells us $u - A|x|^2$ attains its minimum point at x_0 on the boundary.

$$0 \ge (u - A|x|^2)_{\nu}(x_0) = -u + \varphi - 2Ax \cdot \nu.$$
(20)

Similarly we consider u which attains its maximum on the boundary. Then we get

$$\inf_{\partial\Omega} \varphi - 2A \operatorname{diam}\Omega \le u \le \sup_{\partial\Omega} \varphi.$$
(21)

The gradient estimate was done in [32], since that paper was written in Chinese, for completeness we contain its proof in this section. We set

$$d(x) = \mathtt{dist}(x, \partial\Omega),$$

and

$$\Omega_{\mu} := \{ x \in \Omega : d(x) < \mu \}.$$

Then it is well known that there exists a positive constant $1 \geq \tilde{\mu} > 0$ such that $d(x) \in C^4(\overline{\Omega}_{\tilde{\mu}})$. As in Simon-Spruck [37] or Lieberman [27] (in page 331), we can extend ν by $\nu = -Dd$ in $\Omega_{\tilde{\mu}}$ and note that ν is a $C^2(\overline{\Omega}_{\tilde{\mu}})$ vector field. As mentioned in the book [27], we also have the following formulas

$$|D\nu| + |D^{2}\nu| \le C_{0}(n,\Omega) \quad \text{in} \quad \Omega_{\widetilde{\mu}},$$

$$\sum_{1 \le i \le n} \nu^{i} D_{j} \nu^{i} = 0, \sum_{1 \le i \le n} \nu^{i} D_{i} \nu^{j} = 0, |\nu| = 1 \quad \text{in} \quad \Omega_{\widetilde{\mu}}.$$
(22)

As in [27], we define

$$c^{ij} = \delta_{ij} - \nu^i \nu^j \quad \text{in} \quad \Omega_{\widetilde{\mu}}, \tag{23}$$

and for a vector $\zeta \in \mathbb{R}^n$, we write ζ' for the vector with *i*-th component $\sum_{1 \leq j \leq n} c^{ij} \zeta^j$. Then we have

$$|D'u|^2 = \sum_{1 \le i,j \le n} c^{ij} u_i u_j.$$
(24)

We first state an useful lemma from [7].

Lemma 3.1. (Chou-Wang) [7] If u is k -admissible and $u_{11} < -\frac{h'|Du|^2}{128}$, here h' is any positive function. Then

$$\frac{1}{n-k+1}\mathcal{F} \le F^{11},\tag{25}$$

and

$$\mathcal{F} \ge C_{n-1}^{k-1} \left[\frac{h'}{128C_{n-1}^k} \right]^{k-1} |Du|^{2k-2}.$$
(26)

To state the gradient estimate on Neumann problems, we need first recall an interior estimate in [7].

Lemma 3.2. (Chou-Wang) [7] Let $\Omega \subset \mathbb{R}^n$ be a bounded domain. Suppose $u \in C^3(\Omega)$ is a k-admissible solution of Hessian equation

$$\sigma_k(D^2u) = f(x,u) \quad in \quad \Omega \tag{27}$$

satisfying $|u| \leq M_0$. If $f \in C^2(\overline{\Omega} \times [-M_0, M_0])$ satisfies the conditions that there exist positive constant L_1 such that

$$f(x,z) \ge 0 \quad in \quad \bar{\Omega} \times [-M_0, M_0], |f(x,z)| + |f_x(x,z)| + |f_z(x,z)| \le L_1 \quad in \quad \bar{\Omega} \times [-M_0, M_0].$$
(28)

Then for $\forall \Omega' \subset \subset \Omega$, it has

$$\sup_{\Omega'} |Du| \le \widetilde{M}_1,\tag{29}$$

where \widetilde{M}_1 is a positive constant which depends on $n, k, M_0, dist(\Omega', \partial\Omega), L_1$.

Now we get the global gradient estimate which was done in [32].

Theorem 3.2. Let $\Omega \subset \mathbb{R}^n$ be a bounded C^3 domain, and ν is the outer unit normal vector of $\partial\Omega$. Suppose $u \in C^2(\overline{\Omega}) \bigcap C^3(\Omega)$ is an k-admissible solution of the following Neumann boundary problems of Hessian equation

$$\begin{cases} \sigma_k(D^2u) = f(x,u) & \text{in } \Omega, \\ u_\nu = \varphi(x,u) & \text{on } \partial\Omega, \end{cases}$$
(30)

satisfying $|u| \leq M_0$, where f, φ are given functions defined on $\overline{\Omega} \times [-M_0, M_0]$. If f, φ satisfy the conditions: \exists positive constants L_1, L_2 such that

$$\begin{aligned} f(x,z) &> 0 \quad in \quad \bar{\Omega} \times [-M_0, M_0], \\ |f(x,z)| + |f_x(x,z)| + |f_z(x,z)| &\leq L_1 \quad in \quad \bar{\Omega} \times [-M_0, M_0], \\ |\varphi(x,z)|_{C^3(\bar{\Omega} \times [-M_0, M_0])} &\leq L_2. \end{aligned} \tag{31}$$

Then there exists a small positive constant μ_0 which depends only on n, k, Ω , M_0, L_1, L_2 such that $\sim \sim \sim$

$$\sup_{\bar{\Omega}_{\mu_0}} |Du| \le \max\{\tilde{M}_1, \tilde{M}_2\},\tag{32}$$

where \widetilde{M}_1 is a positive constant depending only on n, k, μ_0, M_0, L_1 , which is from the interior gradient estimates; \widetilde{M}_2 is a positive constant depending only on $n, k, \Omega, \mu_0, M_0, L_1, L_2$.

3.1 Proof of Theorem 3.2

Proof. We consider the auxiliary function

$$G(x) := \log |Dw|^2 + h(u) + g(d), \tag{33}$$

where

$$w(x) := u(x) + \varphi(x, u)d(x); \tag{34}$$

$$h(u) := -\log(1 + 4M_0 - u); \tag{35}$$

and

$$g(d) := \alpha_0 d, \tag{36}$$

in which α_0 large to be chosen later. By (35) we have

$$-log(1+5M_0) \le h \le -log(1+3M_0), \tag{37}$$

$$\frac{1}{1+5M_0} \le h' \le \frac{1}{1+3M_0},\tag{38}$$

$$\frac{1}{(1+5M_0)^2} \le h'' \le \frac{1}{(1+3M_0)^2}.$$
(39)

By (34) we have

$$w_i = u_i + (\varphi_i + \varphi_z u_i)d + \varphi d_i.$$
(40)

If we assume that $|Du| > 8nL_2$ and $\mu_0 \leq \frac{1}{2L_2}$, it follows from (40) that

$$\frac{1}{4}|Du| \le |Dw| \le 2|Du|. \tag{41}$$

These inequalities will be used below.

We assume that G(x) attains its maximum at $x_0 \in \overline{\Omega}_{\mu_0}$, where $0 < \mu_0 < \widetilde{\mu} \leq 1$ is a sufficiently small number which we shall decide it later.

Now we divide three cases to complete the proof of Theorem 3.2.

Case I: If G(x) attains its maximum at $x_0 \in \partial \Omega$, then we shall use the Hopf Lemma to get the bound of $G(x_0)$.

Case II: If G(x) attains its maximum at $x_0 \in \Omega_{\mu_0}$, in this case for the sufficiently small constant $\mu_0 > 0$, then we can use the maximum principle to get the bound of $G(x_0)$.

Case III: If G(x) attains its maximum at $x_0 \in \partial \Omega_{\mu_0} \bigcap \Omega$, then we shall get the estimates of $|Du|(x_0)$ via the standard interior gradient bound as in [7]. Which in turn give the bound for G at point x_0 .

Since $G(x) \leq G(x_0)$, we get the bound of G, which in turn give the bound of $|\nabla u|$ in $\overline{\Omega}_{\mu_0}$.

Now all computations work at the point x_0 . We use Einstein's summation convention. All repeated indices come from 1 to n.

3.2 Case I: boundary estimates

If maximum of G is attained on the boundary, at the maximum point we have

$$0 \le G_{\nu} = \frac{|Dw|_{p}^{2}\nu^{p}}{|Dw|^{2}} - g' + h'u_{\nu}.$$
(42)

We have decomposition $|Dw|^2 = |D'w|^2 + w_{\nu}^2$. Becuse $w_{\nu} = u_{\nu} + D_{\nu}\varphi d - \varphi = 0$ on the boundary, so we have

$$Dw|_{p}^{2}\nu^{p} = C_{p}^{ij}w_{i}w_{j}\nu^{p} + 2C^{ij}w_{ip}w_{j}\nu^{p} + 2w_{\nu}D_{p}w_{\nu}\nu^{p},$$

$$= C_{p}^{ij}w_{i}w_{j}\nu^{p} + 2C^{ij}(u_{ip} + D_{ip}\varphi d + D_{i}\varphi d_{p} + D_{p}\varphi d_{i} + \varphi d_{ip})w_{j}\nu^{p},$$

$$= C_{p}^{ij}w_{i}w_{j}\nu^{p} + 2C^{ij}u_{i\nu}w_{j} - 2C^{ij}D_{i}\varphi w_{j} + 2C^{ij}D_{p}\varphi\nu^{p}d_{i}w_{j} + 2C^{ij}\varphi d_{ip}w_{j}\nu^{p}.$$
(43)

On the other hand, take tangential derivative to the Neumann boundary condition:

$$C^{pq}D_q(u_i\nu^i) = C^{pq}D_q\varphi,$$

then we have

$$C^{pq}u_{q\nu} + C^{pq}u_i D_q \nu^i = C^{pq} D_q \varphi.$$

$$\tag{44}$$

Then contracting (44) with w_p , and inserting it into (43), we can cancel the term with the second derivative of u,

$$|Dw|_{p}^{2}\nu^{p} \leq C(n,\Omega,L_{2})|Dw|^{2} + C(n,\Omega,L_{2})|Dw|.$$
(45)

So we choose $\alpha_0 = 2C + \frac{L_2}{1+3M_0} + 1$, such that

$$0 \le G_{\nu} \le -\alpha_0 + C + \frac{C}{|Dw|} + h' |\varphi|_{C^0} \le -C + \frac{C}{|Dw|}.$$
(46)

Thus we have estimate $|Dw|(x_0) \le 1$, and $G(x_0) \le -\log(1+3M_0) + 2C + \frac{L_2}{1+3M_0} + 1$.

3.3 Case II: Near boundary estimates

If G attains its maximum in Ω_{μ_0} . We take the first derivatives and second derivatives to the auxiliary function:

$$0 = G_{i} = \frac{2\sum_{p=1}^{n} w_{p}w_{pi}}{|Dw|^{2}} + g'D_{i}d + h'u_{i},$$

$$G_{ij} = \frac{\sum_{p=1}^{n} 2w_{pj}w_{pi} + 2w_{p}w_{pji}}{|Dw|^{2}} - \frac{4\sum_{p,q=1}^{n} w_{p}w_{pi}w_{q}w_{qj}}{|Dw|^{4}} + g''D_{i}dD_{j}d + g'D_{ij}d + h''u_{i}u_{j} + h'u_{ij}.$$
(47)
(47)
(47)

Because $F^{ij}(D^2u) > 0$ if we assume u is k- admissible solution. At maximum point of G, we get

$$0 \ge F^{ij}G_{ij} = \frac{2\sum_{p=1}^{n} F^{ij}w_{pi}w_{pj}}{|Dw|^2} + \frac{2\sum_{p=1}^{n} F^{ij}w_pw_{pij}}{|Dw|^2} - \frac{4\sum_{p,q=1}^{n} F^{ij}w_pw_{pi}w_qw_{qj}}{|Dw|^4} + g''F^{ij}D_idD_jd + g'F^{ij}D_{ij}d + h''F^{ij}u_{ij}.$$

$$(49)$$

Recalling $w = u + \varphi d$, its second derivatives is

$$w_{ij} = u_{ij} + (\varphi_{ij} + \varphi_{iz}u_j + \varphi_{zj}u_i + \varphi_{zz}u_iu_j + \varphi_z u_{ij})d + (\varphi_i + \varphi_z u_i)d_j + \varphi_j d_i + \varphi_z u_j d_i + \varphi d_{ij}.$$
(50)

 w_{ij} has relation with u_{ij} that

$$w_{ij} \le (1 + \varphi_z d)u_{ij} + C(L_2, n)\mu_0 |Du|^2 + C(L_2, n)|Du| + C(L_2, n),$$
(51)

and

$$w_{ij} \ge (1 + \varphi_z d)u_{ij} - C(L_2, n)\mu_0 |Du|^2 - C(L_2, n)|Du| - C(L_2, n).$$
(52)

Differential w_{ij} again,

$$w_{ijp} = u_{ijp} + (\varphi_{ijp} + \varphi_{ijz}u_p + \varphi_{izp}u_j + \varphi_{izz}u_pu_j + \varphi_{iz}u_{jp} + \varphi_{zjp}u_i + \varphi_{zzj}u_pu_i + \varphi_{zj}u_{ip} + \varphi_{zzp}u_iu_j + \varphi_{zzz}u_pu_iu_j + \varphi_{zz}u_{ip}u_j + \varphi_{zz}u_iu_{jp} + \varphi_{zp}u_{ij} + \varphi_{zz}u_pu_{ij} + \varphi_{z}u_{ijp})d + (\varphi_{ij} + \varphi_{iz}u_j + \varphi_{zj}u_i + \varphi_{zz}u_iu_j + \varphi_{z}u_{ij})d_p + (\varphi_{ip} + \varphi_{iz}u_p + \varphi_{zp}u_i + \varphi_{zz}u_pu_i + \varphi_{z}u_{ip})d_j + (\varphi_i + \varphi_{zu})d_{jp} + \varphi_{jp}d_i + \varphi_{jz}u_pd_i + \varphi_{j}d_{ip} + \varphi_{zp}u_jd_i + \varphi_{zz}u_pu_jd_i + \varphi_{z}u_{jp}d_i + \varphi_{z}u_jd_{ip} + \varphi_{p}d_{ij} + \varphi_{z}u_pd_{ij} + \varphi_{d_{ijp}}.$$

Now we choose coordinate at x_0 such that $|\nabla w| = w_1$ and $(u_{ij})_{2 \le i,j \le n}$ is diagonal. So from (40) and (47), we have for i = 1,

$$u_1 = \frac{w_1 - \varphi_1 d - \varphi d_1}{1 + \varphi_z d},\tag{54}$$

$$w_{11} = -\frac{1}{2}(g'd_1 + h'u_1)w_1, \tag{55}$$

and for $2 \leq i \leq n$,

$$u_i = \frac{-\varphi_i d - \varphi d_i}{1 + \varphi_z d},\tag{56}$$

$$w_{1i} = -\frac{1}{2}(g'd_i + h'u_i)w_1, \tag{57}$$

here we assume $\mu_0 \leq \mu_1 := \frac{1}{2L_2}$, such that $\frac{3}{2} \geq 1 + \varphi_z d \geq \frac{1}{2}$. Suppose that $|Du|(x_0) > M_1 := 64nL_2$, we have for $i \geq 2$,

$$|u_i| \le \frac{1}{16n} |Du|,\tag{58}$$

and

$$u_1 \ge \frac{1}{2}|Du|. \tag{59}$$

Moreover,

$$F^{ij}G_{ij} \geq -C(n,k,L_2,\Omega)\mu_0 \mathcal{F}|Du|^2 + \frac{2F^{ij}u_{ij1}(1-\varphi_z d)}{w_1} - \frac{4F^{ij}(\varphi_{iz}u_{j1}d + \varphi_{zz}u_{i1}u_j d + \varphi_z u_{i1}d_j)}{w_1} - \frac{2F^{ij}u_{ij}[(\varphi_{zp} + \varphi_{zz}u_p)d + \varphi_z d_p]}{w_1} - 2\frac{F^{ij}w_{1i}w_{1j}}{w_1^2} - C(n,k,L_2,\alpha_0,\Omega)\mathcal{F}|Du| + h''F^{11}u_1^2 + h'F^{ij}u_{ij}.$$
(65)

The equation (1) is k-homogenous, and differentiating it gives

$$F^{ij}u_{ij1} = f_1 + f_u u_1. ag{67}$$

We obtain from (63), (64), (66), and (67) that

$$F^{ij}G_{ij} \ge -C(n,k,L_2,M_0,\Omega)\mu_0\mathcal{F}|Du|^2 + h''F^{11}u_1^2 - \frac{(h')^2\mathcal{F}|Dw|^2}{32} - C(n,k,L_2,L_1,M_0,\alpha_0,\Omega)\mathcal{F}|Du| - C(L_1,n,L_2).$$
(68)

(25) tells us if $\mu_0 \le \mu_3 := \frac{1}{32C(1+5M_0)^2(n-k+1)}$ small, we get

By definition of h, we have $h'' = (h')^2$. Thus from (25)

Inequality (73) is a contradiction.

We conclude that if $\mu_0 = \min\{\widetilde{\mu}, \mu_1, \mu_2, \mu_3\}$, we have the estimate

Thus we get the estimate of $G(x_0)$.

Because G attains its maximum at x_0 and h, g is bounded from below, the gradient estimate of u follows the above three cases.

4 C^2 priori estimates

We come now to the a priori estimates of second derivative necessary for our existence theorem. For these bounds we restrict attention to the following problem

$$\begin{cases} \sigma_k(D^2u) = f(x,u) & \text{in } \Omega \subset \mathbb{R}^n, \\ u_\nu = \varphi(x,u) & \text{on } \partial\Omega. \end{cases}$$
(75)

Theorem 4.1. Let Ω be a bounded C^4 uniformly convex domain in \mathbb{R}^n , ν is the outer unit normal vector of $\partial\Omega$. If $u \in C^4(\Omega) \cap C^3(\overline{\Omega})$ a k- admissible solution of Neumann problem (75). Where $f \in C^2(\overline{\Omega} \times \mathbb{R})$ is positive and $\varphi \in C^3(\overline{\Omega} \times \mathbb{R})$ is non-increasing in z. Then we have

$$\sup_{\overline{\Omega}} |D^2 u| \le C,\tag{76}$$

where C depends only on n, k, $||u||_{C^1(\overline{\Omega})}$, $||f||_{C^2(\overline{\Omega}\times[-M_0,M_0])}$, $\min f$, $||\varphi||_{C^3(\overline{\Omega}\times[-M_0,M_0])}$ and convexity of Ω , where $M_0 = \sup_{\Omega} |u|$.

It is well known that it is easy to get the estimates for second tangential-normal derivative of the solution on the boundary. We here follow the same line as in Lions-Trudinger-Urbas [31] with minor changes.

Lemma 4.1. Denoting the tangential direction τ at any point $y \in \partial \Omega$, we have

$$|D_{\tau\nu}u(y)| \le C,\tag{77}$$

where the constant C only depends on $||u||_{C^1}$, $||\varphi||_{C^1}$ and $||\partial \Omega||_{C^2}$.

Proof. Taking tangential derivative to the boundary condition

Now we again use the technique of Lions-Trudinger-Urbas [31], we can reduce the second derivative estimates of the solution to the boundary double normal derivative bounds.

Lemma 4.2. Let $M = \sup_{\partial \Omega} |u_{\nu\nu}|$. Then

$$\sup_{\overline{\Omega},\xi\in\mathbb{S}^{n-1}}u_{\xi\xi}\leq C_0(1+M),\tag{82}$$

where C_0 depends only on $||u||_{C^1}, ||\varphi||_{C^3}, ||\partial \Omega||_{C^4}, ||f||_{C^2}, \min f, and convexity of <math>\partial \Omega$.

Proof. We consider the function

and

$$v_{ij} = u_{\xi\xi ij} - D_{ij}a^{l}u_{l} - D_{i}a^{l}u_{lj} - D_{j}a^{l}u_{li} - a^{l}u_{lij} - D_{ij}b + 2K_{1}\delta_{ij} + 2K_{2}\sum_{l}u_{li}u_{lj} + 2K_{2}\sum_{l}u_{l}u_{lij}.$$
(85)

Taking first derivative of equation (6), we have

$$\widetilde{F}^{ij}u_{ijl} = \widetilde{f}_{x_l} + \widetilde{f}_z u_l.$$
(86)

And we have from the concavity of $\sigma_k^{\frac{1}{k}}$

$$\widetilde{F}^{ij}u_{ij\xi\xi} \ge \widetilde{F}^{ij}u_{ij\xi\xi} + \widetilde{F}^{ij,pq}u_{ij\xi}u_{pq\xi} = \widetilde{f}_{x_{\xi}x_{\xi}} + 2\widetilde{f}_{x_{\xi}z}u_{\xi} + \widetilde{f}_{z}u_{\xi\xi}.$$
(87)

Then we contract (85) with the \tilde{F}^{ij} , using (87) and (86),

-\widetilde{F}^{ij}D_{ij}b + 2K_{1}\sum_{i}\widetilde{F}^{ii} + 2K_{2}\sum_{l}\widetilde{F}^{ij}u_{lj}u_{li} + 2K_{2}\sum_{ijl}\widetilde{F}^{ij}u_{lij}u_{l}
\geq -C_{1}(||u||_{C^{1}}, ||\varphi||_{C^{3}}, ||\partial\Omega||_{C^{4}}, ||f||_{C^{2}}, \min f, K_{2})(\sum_{i}\widetilde{F}^{ii} + 1)
+\widetilde{f}_{z}u_{\xi\xi} + 2K_{1}\sum_{i}\widetilde{F}^{ii} + 2K_{2}\sum_{l}\widetilde{F}^{ij}u_{li}u_{lj} - 2\widetilde{F}^{ij}u_{lj}D_{i}a^{l}.$$
(88)

At interior maximum point, we assume (u_{ij}) is diagonal and $u_{11} \ge u_{22} \ge \cdots \ge u_{nn}$. So we have by (14)

$$2K_{2}\sum_{i}\widetilde{F}^{ii}u_{ii}^{2} \geq 2K_{2}\sigma_{k}^{\frac{1}{k}-1}F^{11}u_{11}^{2}$$
$$\geq 2K_{2}\frac{\sigma_{k}^{\frac{1}{k}}}{n}u_{11}$$
$$\geq 2K_{2}\frac{\sigma_{k}^{\frac{1}{k}}}{n}u_{\xi\xi}.$$
(89)

We can assume $u_{\xi\xi} \ge 0$, otherwise we have the estimate (82). If we choose $K_2 \ge \frac{n|\tilde{f}_z|}{2\min \tilde{f}} + 2$, we continue

$$\sum_{ij} \widetilde{F}^{ij} v_{ij} \geq 2 \sum_{i} \widetilde{F}^{ii} u_{ii}^2 - 2C_2(||u||_{C^1}, ||\varphi||_{C^3}, ||\partial\Omega||_{C^3}) \sum_{i} \widetilde{F}^{ii} |u_{ii}| + 2K_1 \sum_{i} \widetilde{F}^{ii} - C_1(\sum_{i} \widetilde{F}^{ii} + 1) \\ \geq 2 \sum_{i} \widetilde{F}^{ii} (|u_{ii}| - \frac{C_2}{2})^2 + (2K_1 - \frac{C_2^2}{2} - C_1) \sum_{i} \widetilde{F}^{ii} - C_1.$$
(90)

Now if we choose K_1 large, such that $K_1 \geq \frac{C_2^2}{2} + C_1$ and $K_1(C_n^k)^{\frac{1}{k}} > C_1$, by (13) we have

So $v(x,\xi)$ attains its maximum on $\partial\Omega$. Case a: ξ is tangential. We shall take tangential derivative twice to the boundary condition, first we rewrite (79) as following

and in above formula we take sum with $\xi^i \xi^p$, then we obtain

$$u_{\xi\xi\nu} = -2\xi^{p}\xi^{i}u_{li}D_{p}\nu^{l} - u_{l}\xi^{p}D_{ip}\nu^{l}\xi^{i} + u_{\nu\nu}\sum_{i}\xi^{p}D_{p}\nu^{i}\xi^{i}$$
$$-\sum_{i}\xi^{p}\xi^{i}\nu^{j}D_{p}\nu^{i}D_{j}\varphi + \varphi_{z}u_{\xi\xi} + \xi^{p}\xi^{i}\varphi_{ip}$$
$$+\varphi_{zz}u_{\xi}^{2} + 2u_{\xi}\xi^{i}\varphi_{zi}.$$
(94)

So we have

$$u_{\xi\xi\nu} \leq -2\xi^{p}\xi^{i}u_{li}D_{p}\nu^{l} + \varphi_{z}u_{\xi\xi} + C(||u||_{C^{1}}, ||\partial\Omega||_{C^{3}}, ||\varphi||_{C^{2}}) + C(||\partial\Omega||_{C^{2}})|u_{\nu\nu}| \leq -2\xi^{p}\xi^{i}u_{li}D_{p}\nu^{l} + C + C|u_{\nu\nu}|.$$
(95)

Here in the second inequality we assume that φ is non-increasing in z. If we assume $\xi = e_1$, it is easy to get the bound for $u_{1i}(x_0)$ for $i \neq 1$ from the maximum of $v(x,\xi)$ in the ξ direction. In fact, we can assume $\xi(t) = \frac{(1,t,0,\cdots,0)}{\sqrt{1+t^2}}$. Because $v(x,\xi)$ attains its maximum at $\xi(0)$. Then we have

$$0 = \frac{\partial v(x_0, \xi(t))}{\partial t}|_{t=0}$$

= $2u_{ij}(x_0)\frac{d\xi^i(t)}{dt}|_{t=0}\xi^j(0) - \frac{\partial v'(x_0, \xi(t))}{\partial t}|_{t=0}$
= $2u_{11}\frac{-t}{(1+t^2)^{\frac{3}{2}}}|_{t=0} + 2u_{12}(\frac{1}{\sqrt{1+t^2}} + \frac{-t^2}{(1+t^2)^{\frac{3}{2}}})|_{t=0} - \frac{\partial v'}{\partial t}|_{t=0}.$ (96)

So we have

$$|u_{12}| \le C(||\varphi||_{C^1}, ||u||_{C^1}, ||\partial\Omega||_{C^2}).$$

Similarly, we have for all $i \neq 1$,

Due to $D_1\nu_1 \ge \kappa > 0$, we have

$$u_{\xi\xi\nu} \le -2\kappa u_{\xi\xi} + C(1 + |u_{\nu\nu}|).$$

On the other hand, we have from the Hopf lemma, (77) and $\sum_{i} a^{i} \nu^{i} = 0$,

&= u_{\xi\xi\nu} - D_{\nu}a^{l}u_{l} - a^{l}u_{l\nu} - b_{\nu} + 2K_{1}(x \cdot \nu) + 2K_{2}\sum_{l}u_{l}u_{l\nu} \\
&\leq u_{\xi\xi\nu} + C(||u||_{C^{1}}, ||\partial\Omega||_{C^{2}}, ||\varphi||_{C^{2}}, K_{1}, K_{2}) + 2K_{2}\varphi u_{\nu\nu}.
\end{array}$$
(100)

Combining (99) and (100), we therefore deduce

$$u_{\xi\xi}(x_0) \le C(1 + |u_{\nu\nu}|(x_0)). \tag{101}$$

Case b: ξ is non-tangential.

We write $\xi = \alpha \tau + \beta \nu$, where $\alpha = \xi \cdot \tau$, $|\tau| = 1$, $\tau \cdot \nu = 0$, $\beta = \xi \cdot \nu \neq 0$ and $\alpha^2 + \beta^2 = 1$.

By definition of $v(x,\xi)$, we have

&\leq \alpha^2 v(x_0,\xi) + \beta^2 v(x_0,\nu).

Then we get the estimate,

so that this case is also reduced to the purely normal case.

4.1 Second Normal Derivative Bounds On The Boundary

In this section, we consider the double normal derivative estimate which is the most difficulty part in the Neumann problem for Hessian equations. Note we do not know boundary double tangential bound apriori, or it is hard to get this estimate due to the Neumann boundary condition in general. Compare this with Dirichlet problem in ([1], [2], [39]).

We give some definitions first. Let

$$h(x) = -d(x) + d^{2}(x).$$
(106)

We know from the classic book [12] section 14.6 that h is C^4 in Ω_{μ} for some constant $\mu \leq \tilde{\mu}$ small depending on Ω . In terms of a principal coordinate system, see [12] section 14.6, we have

$$[-D^2 d(x_0)] = diag[\frac{\kappa_1(y_0)}{1 - \kappa_1(y_0)d(x_0)}, \cdots, \frac{\kappa_{n-1}(y_0)}{1 - \kappa_{n-1}(y_0)d(x_0)}, 0],$$
(107)

and

$$-Dd(x_0) = \nu(y_0). \tag{108}$$

So h also satisfied the following properties in Ω_{μ} :

$$2 \ge |Dh| \ge \frac{1}{2},\tag{110}$$

$$F^{ij}h_{ij} \ge k_0(\mathcal{F}+1),\tag{112}$$

provided $\mu \leq \tilde{\mu}$ small depend on $||\partial \Omega||_{C^2}$. Here k_1 and k_0 are positive constants depend on $\kappa := (\kappa_1, \cdots, \kappa_n)$. It is easy to see

$$\frac{Dh}{|Dh|} = \nu,\tag{113}$$

for unit outer normal ν on the boundary.

In order to do this estimate we construct barrier functions of u_{ν} on the boundary. Motivated by [31], [38], [20] and [42], we introduce the following functions. In $\overline{\Omega}_{\mu}$, we denote

$$g(x) := 1 - \beta h, \tag{114}$$

$$G(x) := (A + \sigma M)h(x), \tag{115}$$

$$\psi(x) := |Dh|(x)\varphi(x,u). \tag{116}$$

where σ , β , μ , A are positive constants to be chosen later. Now we consider the sub barrier function,

$$P(x) := g(x)(Du \cdot Dh(x) - \psi(x)) - G(x).$$

And we want to prove the following lemma.

Lemma 4.3. Fix $\sigma = \frac{1}{2}$, for any $x \in \overline{\Omega}_{\mu}$, if chosen β large, μ small, A large in proper sequence, we have

$$P(x) \ge 0. \tag{118}$$

Proof. We use maximum principle to prove this lemma. First we assume the function attains its minimum point x_0 in the interior of Ω_{μ} . We derivative this function twice,

(120)

At the minimum point x_0 , as before we can assume $(u_{ij}(x_0))$ is diagonal. Contracting (120) with F^{ij} , we get

$$F^{ij}P_{ij} = F^{ij}g_{ij}(\sum_{l}u_{l}h_{l} - \psi) + 2g_{i}F^{ij}(\sum_{l}u_{l}j_{h}h_{l} + \sum_{l}u_{l}h_{lj} - \psi_{j}) +gF^{ij}(\sum_{l}u_{lij}h_{l} + 2\sum_{l}u_{li}h_{lj} + \sum_{l}u_{l}h_{lij} - \psi_{ij}) -F^{ij}G_{ij} \leq \beta C_{3}(||u||_{C^{1}}, ||\partial\Omega||_{C^{3}}, ||\varphi||_{C^{2}}, ||f||_{C^{1}})(\mathcal{F} + 1) -(A + \sigma M)k_{0}(\mathcal{F} + 1) - 2\beta F^{ii}u_{ii}h_{i}^{2} + 2F^{ii}u_{ii}h_{ii}g.$$

Where in the second inequality we use

$$\leq -n\delta_{1}u_{nn}u_{22}\sigma_{k-2}(\lambda|1n) - u_{nn}^{2}\sigma_{k-2}(\lambda|1n). \quad (147)$$

By chosen A large such that $\frac{A}{3} \ge \beta C_4$, we infer

Due to $2 \ge |Dh| \ge \frac{1}{2}$ and (159), there is a $i_0 \in \mathbf{G}$, say $i_0 = 1$, such that

$$\sup_{\partial \Omega} u_{\nu\nu} \le C + \sigma M. \tag{178}$$

Similarly, by $0 \leq \overline{P}_{\nu}(z_0)$ here z_0 is the minimum point of $u_{\nu\nu}$, we get

$$\inf_{\partial\Omega} u_{\nu\nu} \ge -C - \sigma M. \tag{179}$$

So chosen $\sigma = \frac{1}{2}$ as in the previous lemmas, we get the estimate

$$\sup_{\partial\Omega} |u_{\nu\nu}| \le C. \tag{180}$$

Proof of The Theorem 4.1: Combining Lemma 4.1, Lemma 4.2 and the Theorem 4.2, we complete the proof of the Theorem 4.1.

5 Existence of the boundary problem

In this section we complete the proof of the Theorem 1.1. As in [31], by combining Theorems 3.1, 3.2 and 4.1 with the global second derivative Hölder estimates (see [30] or [28]), we get a global estimate

$$||u||_{C^{2,\alpha}(\overline{\Omega})} \le C \tag{181}$$

for k- admissible solution, where C, α depending on k, n, Ω , $||\Omega||_{C^4}$, $||f||_{C^2}$, min f and $||\varphi||_{C^3}$. Applying the method of continuity (see [12], Theorem 17.28), we complete the proof of Theorem 1.1.
