# ON THE LAGRANGIAN ANGLE AND THE KÄHLER ANGLE OF IMMERSED SURFACES IN THE COMPLEX PLANE $\mathbb{C}^{2}$

#### Abstract

In this paper, we discuss the Lagrangian angle and the Kähler angle of immersed surfaces in $\mathbb{C}^{2}$. Firstly, we provide an extension of Lagrangian angle, Maslov form and Maslov class to more general surfaces in $\mathbb{C}^{2}$ than Lagrangian surfaces, and then naturally extend a theorem by J.-M. Morvan to surfaces of constant Kähler angle, together with an application showing that the Maslov class of a compact self-shrinker surface with constant Kähler angle is generally non-vanishing. Secondly, we obtain two pinching results for the Kähler angle which imply rigidity theorems of self-shrinkers with Kähler angle under the condition that $\int_{M}|h|^{2} e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty$, where $h$ and $x$ denote, respectively, the second fundamental form and the position vector of the surface.


## 1. Introduction

Suppose that $(N, \mathbf{J})$ is an (almost) Hermitian manifold with $\omega$ its Kähler form. Then the Riemannian metric $\langle\cdot, \cdot\rangle$ on $N$ is related with $\omega$ by

$$
\begin{equation*}
\langle U, V\rangle=\omega(U, \mathbf{J} V), \quad U, V \in T N . \tag{1.1}
\end{equation*}
$$

Let $x: M^{m} \rightarrow N$ be an immersed submanifold with tangent space $T M^{m}$, normal space $T^{\perp} M^{m}$ and volume form $d V_{M}$ of the induced metric. Then we call $x$ to be totally real if $J\left(x_{*} T M^{m}\right) \subset T^{\perp} M^{m}$; if, furthermore, $\operatorname{dim}_{\mathbb{C}} N=m$, then $x$ is called Lagrangian. In the special case of $m=2$, we can introduce the concept of Kähler angle to define alternatively the totally real surfaces and Lagrangian surfaces. According to [9], the Kähler angle $\theta$ of an immersed surface $x: M^{2} \rightarrow N$ is defined by

$$
\begin{equation*}
x^{*} \omega=\cos \theta d V_{M}, \quad \theta \in[0, \pi] . \tag{1.2}
\end{equation*}
$$

Then $x$ is totally real if and only if $\cos \theta \equiv 0$, or equivalently, the Kähler angle $\theta$ of $x$ is identical to $\frac{\pi}{2}$; $x$ is Lagrangian in $N$ if and only if $\theta \equiv \frac{\pi}{2}$ and $\operatorname{dim}_{\mathbb{C}} N=2$. By the way, if $\cos \theta>0$ everywhere, then $x$ is called symplectic.

The Kähler angle of conformal minimal surfaces in complex projective space $\mathbb{C} P^{n}$ has been extensively studied. For example, each of the maps in the Veronese sequence gives a minimal immersion of 2 -sphere into $\mathbb{C} P^{n}$ that has a constant Kähler angle (see [3], [19], [21). The Kähler angle of surfaces immersed in the nearly Kähler manifold $\mathbb{S}^{6}$ is studied, for example, in [17] and [16].

[^0]Now put $N=\mathbb{C}^{m}$, the complex Euclidean space with complex coordinates $\left(z^{1}, \cdots, z^{m}\right)$. Let $\Omega=d z^{1} \wedge \cdots \wedge d z^{m}$ be the globally defined holomorphic volume form. For a Lagrangian submanifold $x: M^{m} \rightarrow \mathbb{C}^{m}$, the Lagrangian angle of $x$ is by definition a multi-valued function $\beta_{x}: M^{m} \rightarrow \mathbb{R} / 2 \pi \mathbb{Z}$ given by

$$
\Omega_{M}:=x^{*} \Omega=e^{\sqrt{-1} \beta_{x}} d V_{M} .
$$

Note that, although the Lagrangian angle $\beta_{x}$ can not be determined globally in general, its gradient $\nabla \beta_{x}$ is clearly a well-defined vector field on $M^{m}$.

In [18], J.-M. Morvan proved an important formula by which the mean curvature and the Lagrangian angle of a Lagrangian submanifold are linked to each other. Precisely we have

Theorem 1.1 ([18]). Let $x: M^{m} \rightarrow \mathbb{C}^{m}$ be a Lagrangian submanifold and $\mathbf{J}$ be the canonical complex structure of $\mathbb{C}^{m}$. Then the mean curvature vector $H$ and the Lagrangian angle $\beta_{x}$ meet the following formula:

$$
\begin{equation*}
H=\mathbf{J} x_{*}\left(\nabla \beta_{x}\right) \tag{1.3}
\end{equation*}
$$

where $\nabla$ denotes the gradient operator on $M^{m}$.
Consequently, $x$ is minimal if and only if its Maslov form $\alpha:=-d \beta_{x}$ vanishes identically, implying that $x$ has a trivial Maslov class $[\alpha] \in H^{1}(M)$, where $H^{1}(M)$ is the first homology group of $M^{m}$.

Remark 1.1. Formulas similar or related to (1.3) have also been obtained by some other authors, say, in [10], [20] and etc. In particular, A. Arsie has extended Theorem 1.1 in [2] to Lagrangian submanifolds in general Calabi-Yau manifolds.

Theorem 1.1 and its various extensions have many applications and citations in a lot of literatures, including papers on the Lagrangian mean curvature flow. As mentioned in [5], there is a direct interesting application of (1.3) first given by Smoczyk, and then by Castro and Lermain ([5]) using a different method: No compact and orientable Lagrangian self-shrinkers to the Lagrangian mean curvature flow in $\mathbb{C}^{m}$ with trivial Maslov class.

In this paper, we consider the Lagrangian angle and Kähler angle of immersed surfaces in $\mathbb{C}^{2}$. As the first part, we provide an extension of Lagrangian angle, Maslov form and Maslov class to more general surfaces in $\mathbb{C}^{2}$ than Lagrangian surfaces, and then naturally extend Theorem 1.1 of J.-M. Morvan to surfaces of constant Kähler angle, together with an application showing that the Maslov class of a compact self-shrinker surface with constant Kähler angle is generally non-vanishing. Precisely, we shall prove

Theorem 1.2. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be an immersed surface with constant Kähler angle $\theta$. Then the mean curvature vector $H$, the canonical complex structure $\mathbf{J}$ of $\mathbb{C}^{2}$ and the Lagrangian angle $\beta_{x}$ meet the following formula:

$$
\begin{equation*}
\sin ^{2} \theta x_{*}\left(\nabla \beta_{x}\right)=-(\mathbf{J} H)^{\top} \tag{1.4}
\end{equation*}
$$

where ${ }^{\top}$ denotes the projection onto the tangent space $x_{*}\left(T M^{2}\right)$.

Clearly, if $x$ is a Lagrangian surface then (1.4) agrees with (1.3).
Note that an immersion $x: M^{m} \rightarrow \mathbb{R}^{m+p}$ is called a self-shrinker (of the mean curvature flow) if $H=-x^{\perp}$, where ${ }^{\perp}$ denotes the orthogonal projection to the normal bundle of $x$. Thus an application of Theorem 1.2 proves the following

Theorem 1.3. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a self-shrinker with constant Kähler angle $\theta \in$ $(0, \pi)$. If $M$ is compact and orientable, then the Maslov class $[\alpha] \neq 0$.

Corollary 1.4. There are no self-shrinkers with constant Kähler angle $\theta \in(0, \pi)$ in $\mathbb{C}^{2}$ with the topology of a sphere.

As for symplectic surfaces there has been a fairly large amount of work. In particular, if the initial surface of a mean curvature flow in a Kähler -Einstein surface is symplectic, then the surface $M_{t}$ at every time $t$ is also symplectic ([6], [7]). So this kind of flow is referred to as a symplectic mean curvature flow. In [1], by using the self-adjoint property of a stability operator, Arezzo-Sun prove the following gap theorem (restated for the different definition of self-shrinkers here):

Theorem 1.5 ([1). Suppose that $x: M^{2} \rightarrow \mathbb{C}^{2}$ is a complete symplectic self-shrinker with polynomial volume growth. If $|h|^{2} \leq 2$, then $|h|^{2} \equiv 0$ and $x\left(M^{2}\right)$ must be a plane.

Moreover, Han-Sun prove a theorem in [13] that a translating soliton to the symplectic mean curvature flow in $\mathbb{C}^{2}$ with polynomial volume growth, non-positive normal curvature and bounded second fundamental form must be minimal in case that $\cos \theta \geq \delta>0$. The following is a similar result for symplectic self-shrinkers:

Theorem 1.6 ([1]). Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a complete symplectic self-shrinker with Kähler angle $\theta$ and polynomial volume growth. If $|h|^{2}$ is bounded and $\cos \theta \geq \delta>0$, then $x\left(M^{2}\right)$ must be a plane.

Recently Li-Wang proved the following theorem which can be viewed as a complement of the above theorems:

Theorem 1.7 ([14). Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a compact orientable Lagrangian selfshrinker, and $h$ be the second fundamental form of $x$. If $|h|^{2} \leq 2$, then $|h|^{2} \equiv 2$ and $x\left(M^{2}\right)$ is the Clifford torus $S^{1}(1) \times S^{1}(1)$.

Remark 1.2. Castro and Lerma also proved Theorem 1.7 in [5] under the additional condition that the Gauss curvature $K$ of $M^{2}$ is either non-negative or non-positive.

To extend the above theorems, we provide in this paper the following main results:
Theorem 1.8. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a complete self-shrinker with Kähler angle $\theta$ satisfying $\cos \theta \geq 0$. If

$$
\int_{M}|h|^{2} e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty
$$

then $\theta$ is constant and $x\left(M^{2}\right)$ is either a Lagrangian surface or a plane.

To state the next main theorem, we need to introduce, as is done in [6] and [8], an almost complex structure $\mathbf{J}_{M}$ on $\mathbb{C}^{2}$ along $x$. Let $\left\{e_{1}, e_{2}\right\}$ be an oriented orthonormal frame field on $M^{2}$ of which $\left\{\omega^{i}\right\}$ is the dual frame, and $\left\{e_{3}, e_{4}\right\}$ be an oriented orthonormal normal frame field of $x$. Define

$$
\mathbf{J}_{M}\left(x_{*} e_{1}\right)=x_{*} e_{2}, \quad \mathbf{J}_{M}\left(x_{*} e_{2}\right)=-x_{*} e_{1}, \quad \mathbf{J}_{M} e_{3}=-e_{4}, \quad \mathbf{J}_{M} e_{4}=e_{3}
$$

Then, if we write

$$
h=\sum_{i, j}\left(h_{i j}^{3} \omega^{i} \omega^{j} e_{3}+h_{i j}^{4} \omega^{i} \omega^{j} e_{4}\right),
$$

then it holds that

$$
\begin{aligned}
\left(\bar{D}_{e_{i}} \mathbf{J}_{M}\right)\left(x_{*} e_{1}\right) & =\bar{D}_{e_{i}}\left(x_{*} e_{2}\right)-\mathbf{J}_{M} \bar{D}_{e_{i}}\left(x_{*} e_{1}\right) \\
& =-\left(h_{1 i}^{4}-h_{2 i}^{3}\right) e_{3}+\left(h_{2 i}^{4}+h_{1 i}^{3}\right) e_{4}, \\
\left(\bar{D}_{e_{i}} \mathbf{J}_{M}\right)\left(x_{*} e_{2}\right) & =-\bar{D}_{e_{i}}\left(x_{*} e_{1}\right)-\mathbf{J}_{M} \bar{D}_{e_{i}}\left(x_{*} e_{2}\right) \\
& =-\left(h_{2 i}^{4}+h_{1 i}^{3}\right) e_{3}-\left(h_{1 i}^{4}-h_{2 i}^{3}\right) e_{4}, \\
\left(\bar{D}_{e_{i}} \mathbf{J}_{M}\right)\left(e_{3}\right) & =-\bar{D}_{e_{i}} e_{4}-\mathbf{J}_{M} \bar{D}_{e_{i}} e_{3} \\
& =\left(h_{1 i}^{4}-h_{2 i}^{3}\right)\left(x_{*} e_{1}\right)+\left(h_{2 i}^{4}+h_{1 i}^{3}\right)\left(x_{*} e_{2}\right), \\
\left(\bar{D}_{e_{i}} \mathbf{J}_{M}\right)\left(e_{4}\right) & =\bar{D}_{e_{i}} e_{3}-\mathbf{J}_{M} \bar{D}_{e_{i}} e_{4}, \\
& =-\left(h_{2 i}^{4}+h_{1 i}^{3}\right)\left(x_{*} e_{1}\right)+\left(h_{1 i}^{4}-h_{2 i}^{3}\right)\left(x_{*} e_{2}\right) .
\end{aligned}
$$

Consequently, we have

$$
\left|\bar{D} \mathbf{J}_{M}\right|^{2}=4 \sum_{i}\left(\left(h_{2 i}^{4}+h_{1 i}^{3}\right)^{2}+\left(h_{1 i}^{4}-h_{2 i}^{3}\right)^{2}\right) .
$$

Note that $\left|\bar{D} \mathbf{J}_{M}\right|^{2}$ is globally defined on $M^{2}$ and thus is free of the choice of $\left\{e_{1}, e_{2}\right\}$ and $\left\{e_{3}, e_{4}\right\}$.

Theorem 1.9. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a complete self-shrinker with Kähler angle $\theta$. If

$$
\int_{M}|h|^{2} e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty
$$

and there exists a number $\lambda \in[0,1)$ such that

$$
\begin{equation*}
|\nabla \theta|^{2} \leq \frac{\lambda \cos ^{2} \theta\left|\bar{D} J_{M}\right|^{2}}{4\left(1-\lambda \cos ^{2} \theta\right)} \tag{1.5}
\end{equation*}
$$

then $\theta$ is constant and $x\left(M^{2}\right)$ is either a Lagrangian surface or a plane.
Corollary 1.10. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a compact orientable self-shrinker with Kähler angle $\theta$ satisfying either $\cos \theta \geq 0$ or

$$
|\nabla \theta|^{2} \leq \frac{\lambda \cos ^{2} \theta\left|\bar{D} J_{M}\right|^{2}}{4\left(1-\lambda \cos ^{2} \theta\right)}
$$

for some $\lambda \in[0,1)$. If $|h|^{2} \leq 2$, then

$$
\theta=\frac{\pi}{2}, \quad|h|^{2}=2
$$

and $x\left(M^{2}\right)$ is the Clifford torus $S^{1}(1) \times S^{1}(1)$.
Proof of Corollary 1.10: Since $M^{2}$ is compact, by Theorem 1.8 or Theorem 1.9, we know that $x: M^{2} \rightarrow \mathbb{C}^{2}$ is a Lagrangian surface. Then it follows from Theorem 1.7 that $x\left(M^{2}\right)$ must be the Clifford torus $S^{1}(1) \times S^{1}(1)$.

## 2. KÄHLER ANGLES OF SURFACES AND SELF-SHRINKERS OF MEAN CURVATURE FLOW

In this section, we recall some necessary basics and formulas about the Kähler angle and self-shrinkers. First we make the following convention for the ranges of indices which are to be agreed with, if no other specification, throughout this present paper:

$$
1 \leq i, j, k \leq 2, \quad 3 \leq a, b, c \leq 4, \quad 1 \leq A, B, C \leq 4
$$

On $\mathbb{C}^{2}$ we use the standard complex coordinates

$$
z_{1}=x_{1}+\sqrt{-1} y_{1}, \quad z_{2}=x_{2}+\sqrt{-1} y_{2}
$$

The canonical complex structure $\mathbf{J}$ on $\mathbb{C}^{2}$ is given by

$$
\mathbf{J} \frac{\partial}{\partial x_{i}}=\frac{\partial}{\partial y_{i}}, \quad \mathbf{J} \frac{\partial}{\partial y_{i}}=-\frac{\partial}{\partial x_{i}} .
$$

Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be an immersed surface and $\omega,\langle\cdot, \cdot\rangle$ be the Kähler form and the Riemannian metric on $\mathbb{C}^{2}$, respectively. The Kähler angle $\theta$ of $x$ in $\mathbb{C}^{2}$ is defined by (1.2) which is equivalent to

$$
\begin{equation*}
\cos \theta=\left\langle\mathbf{J}\left(x_{*} e_{1}\right), x_{*} e_{2}\right\rangle \tag{2.1}
\end{equation*}
$$

where $\left\{e_{1}, e_{2}\right\}$ is an oriented orthonormal frame field on $M^{2}$.
Starting from any given $\left\{e_{1}, e_{2}\right\}$ on $M^{2}$, we can construct along $x$ an orthonormal frame field $\left\{x_{*} e_{1}, x_{*} e_{2}, e_{3}, e_{4}\right\}$ of $\mathbb{C}^{2}$, such that the following are satisfied in case $\theta \neq 0, \pi$ [17]:

$$
\begin{array}{ll}
\mathbf{J}\left(x_{*} e_{1}\right)=\left(x_{*} e_{2}\right) \cos \theta+e_{3} \sin \theta, & \mathbf{J}\left(x_{*} e_{2}\right)=-\left(x_{*} e_{1}\right) \cos \theta+e_{4} \sin \theta, \\
\mathbf{J}\left(e_{3}\right)=-\left(x_{*} e_{1}\right) \sin \theta-e_{4} \cos \theta, & \mathbf{J}\left(e_{4}\right)=-\left(x_{*} e_{2}\right) \sin \theta+e_{3} \cos \theta \tag{2.2}
\end{array}
$$

Denote by $D, \bar{D}$ and $D^{\perp}$ the Levi-Civita connections on $M^{2}, \mathbb{C}^{2}$ and the normal bundle, respectively. Then the formulas of Gauss and Weingarten are given by

$$
\bar{D}_{X}\left(x_{*} Y\right)=x_{*}\left(D_{X} Y\right)+h(X, Y), \quad \bar{D}_{X} \xi=-x_{*}\left(A_{\xi} X\right)+D_{X}^{\perp} \xi
$$

where $X$ and $Y$ are tangent vector fields, $\xi$ is a normal vector field on $x, h$ denotes the second fundamental form and $A$ is the shape operator.

In what follows we identify $M^{2}$ with $x\left(M^{2}\right)$ and omit $x_{*}$ from some formulas and equations.

Let $\left\{\omega^{A}\right\}$ be the dual frame field of $\left\{e_{A}\right\}$, and $\left\{\omega_{A}^{B}\right\}$ the components of the Levi-Civita connection of $\mathbb{C}^{2}$ with respect to $\left\{e_{A}\right\}$. Then a direct computation similar to that in [17] using (2.2) shows

Lemma 2.1 (cf. [17]). If $\sin \theta \neq 0$, then the following identities hold for an immersed surface $x: M^{2} \rightarrow \mathbb{C}^{2}$ :

$$
\begin{gather*}
d \theta=\omega_{1}^{4}-\omega_{2}^{3}  \tag{2.3}\\
\left(\omega_{1}^{3}+\omega_{2}^{4}\right) \cos \theta+\left(\omega_{3}^{4}-\omega_{1}^{2}\right) \sin \theta=0 \tag{2.4}
\end{gather*}
$$

Note that $\omega_{i}^{a}=\sum_{j} h_{i j}^{a} \omega^{j}$, where $h_{i j}^{a}$ are components of the second fundamental form $h$ of $x$. Then by (2.3), the Kähler angle $\theta$ of $x$ is constant if and only if

$$
\begin{equation*}
h_{11}^{4}=h_{12}^{3}, \quad h_{12}^{4}=h_{22}^{3} . \tag{2.5}
\end{equation*}
$$

Now we turn to self-shrinkers of the mean curvature flow in Euclidean space.
Let $x: M^{m} \rightarrow \mathbb{R}^{m+p}$ be an immersed $n$-dimensional submanifold in the $(m+p)$ dimensional Euclidean space with the mean curvature vector $H$. Then $x$ is called a self-shrinker (of the mean curvature flow) if $H=-x^{\perp}$, where ${ }^{\perp}$ denotes the orthogonal projection to the normal bundle of $x$.

For a self-shrinker $x: M^{m} \rightarrow \mathbb{R}^{m+p}$, there is an important operator $\mathcal{L}$ acting on smooth functions that was first introduced and used by Colding and Minicozzi ([11]) to study self-shrinkers. The definition of $\mathcal{L}$ is as follows:

$$
\begin{equation*}
\mathcal{L}=\Delta-\langle x, \nabla \cdot\rangle=e^{\frac{|x|^{2}}{2}} \operatorname{div}\left(e^{-\frac{|x|^{2}}{2}} \nabla \cdot\right), \tag{2.6}
\end{equation*}
$$

where $\Delta, \nabla$ and div denote the Laplacian, gradient and divergence on $M^{m}$, respectively.
Given an orthonormal tangent frame field $\left\{e_{i} ; 1 \leq i \leq m\right\}$ on $M^{m}$ with the dual $\left\{\omega^{i}\right\}$ and a normal frame field $\left\{e_{\alpha} ; m+1 \leq \alpha \leq m+p\right\}$, write $h=\sum_{\alpha, i, j} h_{i j}^{\alpha} \omega^{i} \omega^{j} e_{\alpha}$. Then the mean curvature vector is by definition $H=\sum_{\alpha} H^{\alpha} e_{\alpha}$ with $H^{\alpha}=\sum_{i} h_{i i}^{\alpha}$.

The following lemma is fundamental for study of self-shrinkers.
Lemma 2.2 ([4]). Let $x: M^{m} \rightarrow \mathbb{R}^{m+p}$ be a self-shrinker. Then

$$
\begin{equation*}
H_{, i}^{\alpha}=\sum_{j} h_{i j}^{\alpha}\left\langle x, e_{j}\right\rangle . \tag{2.7}
\end{equation*}
$$

We end this section with another lemma which is essential to our argument.
Lemma 2.3 ([15]). Let $x: M^{m} \rightarrow \mathbb{R}^{m+p}$ be a complete immersed submanifold. If $u$ and $v$ are $C^{2}$-smooth functions with

$$
\int_{M}(|u \nabla v|+|\nabla u \nabla v|+|u \mathcal{L} v|) e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty
$$

then it holds that

$$
\int_{M} u \mathcal{L} v e^{-\frac{|x|^{2}}{2}} d V_{M}=-\int_{M}\langle\nabla u, \nabla v\rangle e^{-\frac{|x|^{2}}{2}} d V_{M}
$$

## 3. The Lagrangian angle for immersed surfaces in $\mathbb{C}^{2}$

In this section, we first define a natural extension of the concept of Lagrangian angles to general immersed surfaces in $\mathbb{C}^{2}$, and then provide a proof of Theorem 1.2,

Given such a surface $x: M^{2} \rightarrow \mathbb{C}^{2}$ with an orthonormal tangent frame field $\left\{e_{1}, e_{2}\right\}$ and its dual $\left\{\omega^{1}, \omega^{2}\right\}$. As mentioned in the introduction, let $\Omega$ denote the holomorphic volume form on $\mathbb{C}^{2}$ given by $\Omega=d z_{1} \wedge d z_{2}$, where $z_{1}=x_{1}+\sqrt{-1} y_{1}, z_{2}=x_{2}+\sqrt{-1} y_{2}$.

Lemma 3.1. When pulling back by $x, \Omega$ is a complex multiple of the volume form $d V_{M}$. More precisely, there exists a complex function $\eta_{x}$ such that $x^{*} \Omega=\eta_{x} d V_{M}$.

Proof. In fact, $\eta_{x}=x^{*} \Omega\left(e_{1}, e_{2}\right)=\Omega\left(x_{*} e_{1}, x_{*} e_{2}\right)$ since $d V_{M}=\omega^{1} \wedge \omega^{2}$.
Therefore, when $x^{*} \Omega \neq 0$, or the same, $\eta_{x} \neq 0$, there determined (up to a multiple of $2 \pi$ ) is a multi-valued angle function $\beta_{x}$, usually called the argument of $\eta_{x}$, by $\eta_{x}=\left|\eta_{x}\right| e^{\sqrt{-1} \beta_{x}}$.

Thus the following definition is natural:
Definition 3.1. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be an immersed surface with $x^{*} \Omega \neq 0$. Then the multi-valued angle function $\beta_{x}$ is called the Lagrangian angle of $x$.

Remark 3.1. Clearly, $\alpha:=-d \beta_{x}$ is a well defined closed 1-form on $M^{2}$ which is called the Maslov form of $x$ and represents a cohomology class $[\alpha] \in H^{1}\left(M^{2}\right)$, referred to as the Maslov class of $x$.

Next we are to find how the Kähler angle $\theta$ influences the Lagrangian angle $\beta_{x}$ for an immersion $x: M^{2} \rightarrow \mathbb{C}^{2}$. To this end, we need the following simple lemma:

Lemma 3.2. For any $A \in S U(2)$, it holds that $\eta_{A x}=\eta_{x}$. In particular, $\beta_{A x}=\beta_{x}$ in case that $\eta_{x} \neq 0$.

Proof. Note that

$$
S U(2)=\left\{\left(\begin{array}{cc}
a & b \\
-\bar{b} & \bar{a}
\end{array}\right)\left|a, b \in \mathbb{C},|a|^{2}+|b|^{2}=1\right\} .\right.
$$

Write $z=\left(z_{1}, z_{2}\right) \in \mathbb{C}^{2}$ and, for any $A=\left(\begin{array}{cc}a & b \\ -\bar{b} & \bar{a}\end{array}\right) \in S U(2), \tilde{z} \equiv A z=\left(\tilde{z}_{1}, \tilde{z}_{2}\right)$. Since $\operatorname{det} A=1$, we find

$$
\begin{equation*}
A^{*} \Omega=d \tilde{z}_{1} \wedge d \tilde{z}_{2}=(\operatorname{det} A) d z_{1} \wedge d z_{2}=\Omega \tag{3.1}
\end{equation*}
$$

On the other hand, by Lemma 3.1, we have

$$
x^{*} \Omega=\eta_{x} d V_{M}, \quad(A x)^{*} \Omega=\eta_{A x} d V_{M} .
$$

Hence by (3.1)

$$
\eta_{A x}=\left((A x)^{*} \Omega\right)\left(e_{1}, e_{2}\right)=\left(x^{*}\left(A^{*} \Omega\right)\right)\left(e_{1}, e_{2}\right)=\left(x^{*} \Omega\right)\left(e_{1}, e_{2}\right)=\eta_{x} \text {. }
$$

Now we suppose that the Kähler angle $\theta \in(0, \pi)$. For any $p \in M^{2}$, we can find an $A \in S U(2)$ to rotate $\mathbb{C}^{2}$ such that $(A x)_{*} e_{1}=\frac{\partial}{\partial x_{1}}$ at $p$. Then, since $(A x)_{*} e_{1}$ and $(A x)_{*} e_{2}$ are orthogonal, we obtain from (2.1) that

$$
(A x)_{*} e_{2}=\cos \theta \frac{\partial}{\partial y_{1}}+\sin \theta\left(\cos \beta_{A x} \frac{\partial}{\partial x_{2}}+\sin \beta_{A x} \frac{\partial}{\partial y_{2}}\right) .
$$

Since

$$
\begin{equation*}
\Omega=\left(d x_{1}+\sqrt{-1} d y_{1}\right) \wedge\left(d x_{2}+\sqrt{-1} d y_{2}\right), \tag{3.2}
\end{equation*}
$$

we compute

$$
\Omega\left((A x)_{*} e_{1},(A x)_{*} e_{2}\right)=\sin \theta\left(\cos \beta_{A x}+\sqrt{-1} \sin \beta_{A x}\right)=\sin \theta e^{\sqrt{-1} \beta_{A x}} .
$$

Hence

$$
\begin{equation*}
(A x)^{*} \Omega=\sin \theta e^{\sqrt{-1} \beta_{A x}} d V_{M}, \quad \text { at } p \tag{3.3}
\end{equation*}
$$

According to Lemma 3.2, we can get

$$
\begin{equation*}
x^{*} \Omega=\sin \theta e^{\sqrt{-1} \beta_{x}} d V_{M}, \quad \text { at } p . \tag{3.4}
\end{equation*}
$$

Thus we have proved
Proposition 3.3. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be an immersed surface with Kähler angle $\theta \in$ $(0, \pi)$. Then $\left|\eta_{x}\right|^{2}=\sin ^{2} \theta$. In particular, $\eta_{x} \neq 0$ everywhere on $M^{2}$.

We are in a position to give a proof of Theorem 1.2,
First we assume that $\sin \theta \neq 0$.
Note that, for any orthonormal frame field $\left\{e_{1}, e_{2}\right\}$, we can find a unique normal frame $\left\{e_{3}, e_{4}\right\}$ by (2.2). So, along $x\left(M^{2}\right)$, we have an orthonormal frame $\left\{x_{*} e_{i}, e_{a}\right\}$ of $\mathbb{C}^{2}$ with the dual frame field $\left\{\omega^{A}, 1 \leq A \leq 4\right\}$. As the first step to prove Theorem 1.2, we claim that

$$
\begin{equation*}
\Omega \circ x=\frac{1}{\sin \theta} e^{\sqrt{-1} \beta_{x}}\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right) \wedge\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right) \tag{3.5}
\end{equation*}
$$

In fact, since $\Omega$ is a $(2,0)$-form and $\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}, \omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}$ are two linearly independent $(1,0)$-forms, we can write

$$
\Omega \circ x=\mu\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right) \wedge\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right)
$$

for some complex-valued function $\mu$ on $M^{2}$.
Since by (2.2)

$$
\begin{array}{ll}
\mathbf{J}\left(\omega^{1}\right)=-\omega^{2} \cos \theta-\omega^{3} \sin \theta, & \mathbf{J}\left(\omega^{2}\right)=\omega^{1} \cos \theta-\omega^{4} \sin \theta, \\
\mathbf{J}\left(\omega^{3}\right)=\omega^{1} \sin \theta+\omega^{4} \cos \theta, & \mathbf{J}\left(\omega^{4}\right)=\omega^{2} \sin \theta-\omega^{3} \cos \theta \tag{3.6}
\end{array}
$$

it follows that

$$
\begin{align*}
& \frac{1}{2}\left(\omega^{i}-\sqrt{-1} \mathbf{J} \omega^{i}\right)\left(x_{*} e_{i}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{i}\right)\right)=1, \quad i=1,2  \tag{3.7}\\
& \begin{aligned}
& \frac{1}{2}\left(\omega^{1}\right.\left.-\sqrt{-1} \mathbf{J} \omega^{1}\right)\left(x_{*} e_{2}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{2}\right)\right) \\
&=-\frac{1}{2}\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right)\left(x_{*} e_{1}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{1}\right)\right) \\
& \quad=\sqrt{-1} \cos \theta
\end{aligned}
\end{align*}
$$

So that

$$
\begin{equation*}
\Omega\left(\frac{x_{*} e_{1}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{1}\right)}{2}, \frac{x_{*} e_{2}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{2}\right)}{2}\right)=\mu \sin ^{2} \theta . \tag{3.9}
\end{equation*}
$$

On the other hand, for any given $p \in M^{2}$, we can assume that $x_{* p} e_{1}=\left.\frac{\partial}{\partial x_{1}}\right|_{x(p)}$ because $A^{*} \Omega=\Omega$ for any $A \in S U(2)$. Then it holds that

$$
\begin{align*}
& x_{*} e_{1}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{1}\right)=\frac{\partial}{\partial x_{1}}-\sqrt{-1} \frac{\partial}{\partial y_{1}}  \tag{3.10}\\
& x_{*} e_{2}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{2}\right)=\cos \theta \frac{\partial}{\partial y_{1}}+\sin \theta\left(\cos \beta_{x} \frac{\partial}{\partial x_{2}}+\sin \beta_{x} \frac{\partial}{\partial y_{2}}\right) \\
&+\sqrt{-1} \cos \theta \frac{\partial}{\partial x_{1}}-\sqrt{-1} \sin \theta\left(\cos \beta_{x} \frac{\partial}{\partial y_{2}}-\sin \beta_{x} \frac{\partial}{\partial x_{2}}\right) \tag{3.11}
\end{align*}
$$

at $p$. Substitute (3.10) and (3.11) into (3.2) and obtain

$$
\begin{equation*}
\Omega\left(\frac{x_{*} e_{1}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{1}\right)}{2}, \frac{x_{*} e_{2}-\sqrt{-1} \mathbf{J}\left(x_{*} e_{2}\right)}{2}\right)=\sin \theta e^{\sqrt{-1} \beta_{x}} \text { at } p . \tag{3.12}
\end{equation*}
$$

Comparing (3.9) with (3.12), we obtain

$$
\mu(p)=\frac{1}{\sin \theta} e^{\sqrt{-1} \beta_{x}(p)}
$$

Thus (3.5) is proved by the arbitrariness of the point $p$.
The second step is to make use of the fact that $\Omega$ is parallel on $\mathbb{C}^{2}$. For any tangent vector field $X \in T M^{2}$, we have

$$
\begin{equation*}
\bar{D}_{X} \Omega=0 . \tag{3.13}
\end{equation*}
$$

Note that the Kähler angle $\theta$ is constant. (3.13) is equivelant to

$$
\begin{align*}
0= & \sqrt{-1} \sin ^{2} \theta d \beta_{x}(X) \Omega+\sin \theta e^{\sqrt{-1} \beta_{x}}\left(\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}\right) \wedge\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right) \\
& +\sin \theta e^{\sqrt{-1} \beta_{x}}\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right) \wedge\left(\bar{D}_{X} \omega^{2}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{2}\right) \tag{3.14}
\end{align*}
$$

Since the Levi-Civita connection $\bar{D}$ is also a complex one, that is, $\bar{D} \mathbf{J}=\mathbf{J} \bar{D}$, we know that $\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}$ is a linear combination of

$$
\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1} \quad \text { and } \quad \omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}
$$

or

$$
\begin{equation*}
\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}=\rho_{1}\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right)+\rho_{2}\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right) \tag{3.15}
\end{equation*}
$$

for two complex-valued functions $\rho_{1}$ and $\rho_{2}$.
Moreover, from $\bar{D} \mathbf{J}=\mathbf{J} \bar{D}$ and (3.6), we have

$$
\begin{aligned}
\omega^{1}\left(\bar{D}_{X} \mathbf{J} e_{1}\right) & =\omega^{1}\left(\mathbf{J}\left(\bar{D}_{X} e_{1}\right)\right)=\left(\mathbf{J} \omega^{1}\right)\left(\bar{D}_{X} e_{1}\right) \\
& =\left(-\omega^{2} \cos \theta-\omega^{3} \sin \theta\right)\left(\bar{D}_{X} e_{1}\right) \\
& =-\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{2}\right\rangle-\sin \theta\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle \\
\omega^{1}\left(\bar{D}_{X} \mathbf{J} e_{2}\right) & =\omega^{1}\left(\mathbf{J}\left(\bar{D}_{X} e_{2}\right)\right)=\left(\mathbf{J} \omega^{1}\right)\left(\bar{D}_{X} e_{2}\right) \\
& =\left(-\omega^{2} \cos \theta-\omega^{3} \sin \theta\right)\left(\bar{D}_{X} e_{2}\right)=-\sin \theta\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle .
\end{aligned}
$$

From (3.7), (3.8) and (3.15) it follows that

$$
\begin{align*}
\rho_{1}-\sqrt{-1} \rho_{2} \cos \theta & =\left(\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}\right)\left(\left(e_{1}-\sqrt{-1} \mathbf{J} e_{1}\right) / 2\right) \\
& =-\sqrt{-1}\left(\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{2}\right\rangle+\sin \theta\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle\right)  \tag{3.16}\\
\sqrt{-1} \rho_{1} \cos \theta+\rho_{2} & =\left(\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}\right)\left(\left(e_{2}-\sqrt{-1} \mathbf{J} e_{2}\right) / 2\right) \\
& =-\sqrt{-1} \sin \theta\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle-\left\langle\bar{D}_{X} e_{2}, e_{1}\right\rangle . \tag{3.17}
\end{align*}
$$

Combining(3.16) and (3.17) we can find $\rho_{1}$ and $\rho_{2}$ to obtain

$$
\begin{align*}
& \sin \theta\left(\bar{D}_{X} \omega^{1}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{1}\right) \\
= & \left(\cos \theta\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle-\sqrt{-1}\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle\right)\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right) \\
& -\left(\sin \theta\left\langle\bar{D}_{X} e_{2}, e_{1}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle+\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle\right)\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right) \tag{3.18}
\end{align*}
$$

Similarly we have

$$
\begin{align*}
& \sin \theta\left(\bar{D}_{X} \omega^{2}-\sqrt{-1} \bar{D}_{X} \mathbf{J} \omega^{2}\right) \\
= & \left(-\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{4}\right\rangle-\sqrt{-1}\left\langle\bar{D}_{X} e_{2}, e_{4}\right\rangle\right)\left(\omega^{2}-\sqrt{-1} \mathbf{J} \omega^{2}\right) \\
& -\left(\sin \theta\left\langle\bar{D}_{X} e_{1}, e_{2}\right\rangle-\cos \theta\left\langle\bar{D}_{X} e_{2}, e_{4}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{X} e_{1}, e_{4}\right\rangle\right)\left(\omega^{1}-\sqrt{-1} \mathbf{J} \omega^{1}\right) \tag{3.19}
\end{align*}
$$

Therefore we can rewrite (3.14) as

$$
\begin{align*}
0= & \left(\sqrt{-1} \sin \theta d \beta_{x}(X)+\cos \theta\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle-\sqrt{-1}\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle\right. \\
& \left.-\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{4}\right\rangle-\sqrt{-1}\left\langle\bar{D}_{X} e_{2}, e_{4}\right\rangle\right) \Omega . \tag{3.20}
\end{align*}
$$

Using Gauss formula and (3.20), we find

$$
\begin{align*}
\sqrt{-1} \sin \theta d \beta_{x}(X)= & -\cos \theta\left\langle\bar{D}_{X} e_{2}, e_{3}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{X} e_{1}, e_{3}\right\rangle \\
& +\cos \theta\left\langle\bar{D}_{X} e_{1}, e_{4}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{X} e_{2}, e_{4}\right\rangle \\
= & -\cos \theta\left\langle h\left(X, e_{2}\right), e_{3}\right\rangle+\sqrt{-1}\left\langle h\left(X, e_{1}\right), e_{3}\right\rangle \\
& +\cos \theta\left\langle h\left(X, e_{1}\right), e_{4}\right\rangle+\sqrt{-1}\left\langle h\left(X, e_{2}\right), e_{4}\right\rangle \\
= & -\cos \theta\left\langle\bar{D}_{e_{2}} X, e_{3}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{e_{1}} X, e_{3}\right\rangle \\
& +\cos \theta\left\langle\bar{D}_{e_{1}} X, e_{4}\right\rangle+\sqrt{-1}\left\langle\bar{D}_{e_{2}} X, e_{4}\right\rangle \\
= & \cos \theta\left\langle\bar{D}_{e_{2}} e_{3}, X\right\rangle-\sqrt{-1}\left\langle\bar{D}_{e_{1}} e_{3}, X\right\rangle \\
& -\cos \theta\left\langle\bar{D}_{e_{1}} e_{4}, X\right\rangle-\sqrt{-1}\left\langle\bar{D}_{e_{2}} e_{4}, X\right\rangle \tag{3.21}
\end{align*}
$$

But from (2.2) it is easily seen that

$$
\begin{equation*}
e_{3}=\frac{1}{\sin \theta} \mathbf{J} e_{1}-\frac{\cos \theta}{\sin \theta} e_{2}, \quad e_{4}=\frac{1}{\sin \theta} \mathbf{J} e_{2}+\frac{\cos \theta}{\sin \theta} e_{1} \tag{3.22}
\end{equation*}
$$

Inserting (3.22) to (3.21), we obtain

$$
\begin{aligned}
\sqrt{-1} \sin ^{2} \theta d \beta_{x}(X)= & \cos \theta\left\langle\bar{D}_{e_{2}}\left(\mathbf{J} e_{1}\right), X\right\rangle-\cos \theta\left\langle\bar{D}_{e_{2}}\left(\cos \theta e_{2}\right), X\right\rangle \\
& -\sqrt{-1}\left\langle\bar{D}_{e_{1}}\left(\mathbf{J} e_{1}\right), X\right\rangle+\sqrt{-1}\left\langle\bar{D}_{e_{1}}\left(\cos \theta e_{2}\right), X\right\rangle \\
& -\cos \theta\left\langle\bar{D}_{e_{1}}\left(\mathbf{J} e_{2}\right), X\right\rangle-\cos \theta\left\langle\bar{D}_{e_{1}}\left(\cos \theta e_{1}\right), X\right\rangle \\
& -\sqrt{-1}\left\langle\bar{D}_{e_{2}}\left(\mathbf{J} e_{2}\right), X\right\rangle-\sqrt{-1}\left\langle\bar{D}_{e_{2}}\left(\cos \theta e_{1}\right), X\right\rangle \\
= & \cos \theta\left\langle\mathbf{J} D_{e_{2}} e_{1}, X\right\rangle+\cos \theta\left\langle\mathbf{J} h\left(e_{2}, e_{1}\right), X\right\rangle-\cos ^{2} \theta\left\langle D_{e_{2}} e_{2}, X\right\rangle \\
& -\sqrt{-1}\left\langle\mathbf{J} D_{e_{1}} e_{1}, X\right\rangle-\sqrt{-1}\left\langle\mathbf{J} h\left(e_{1}, e_{1}\right), X\right\rangle+\sqrt{-1} \cos \theta\left\langle D_{e_{1}} e_{2}, X\right\rangle \\
& -\cos \theta\left\langle\mathbf{J} D_{e_{1}} e_{2}, X\right\rangle-\cos \theta\left\langle\mathbf{J} h\left(e_{1}, e_{2}\right), X\right\rangle-\cos ^{2} \theta\left\langle D_{e_{1}} e_{1}, X\right\rangle \\
& -\sqrt{-1}\left\langle\mathbf{J} D_{e_{2}} e_{2}, X\right\rangle-\sqrt{-1}\left\langle\mathbf{J} h\left(e_{2}, e_{2}\right), X\right\rangle-\sqrt{-1} \cos \theta\left\langle D_{e_{2}} e_{1}, X\right\rangle .
\end{aligned}
$$

For any given point $p \in M^{2}$, choose proper frame field $\left\{e_{i}\right\}$ satisfying $D_{e_{i}} e_{j}=0$ at $p$. Then

$$
\begin{aligned}
\sin ^{2} \theta d \beta_{x}(X) & =-\left\langle\mathbf{J}\left(h\left(e_{1}, e_{1}\right)\right), X\right\rangle-\left\langle\mathbf{J}\left(h\left(e_{2}, e_{2}\right)\right), X\right\rangle \\
& =-\left\langle\mathbf{J}\left(h\left(e_{1}, e_{1}\right)+h\left(e_{2}, e_{2}\right)\right), X\right\rangle \\
& =-\left\langle(\mathbf{J} H)^{\top}, X\right\rangle \text { at } p
\end{aligned}
$$

Since both $d \beta_{x}(X)$ and $\left\langle(\mathbf{J} H)^{\top}, X\right\rangle$ are globally defined functions and thus free of the choice of the frame field $\left\{e_{i}\right\}$, and $X$ is an arbitrary vector field on $M^{2}$, we have $\sin ^{2} \theta \nabla \beta_{x}=$ $-(\mathbf{J} H)^{\top}$ and Theorem 1.2 is proved for $\sin \theta \neq 0$.

When $\sin \theta=0$, both sides of (1.4) vanish identically since any holomorphic curve in $\mathbb{C}^{2}$ is necessarily minimal.

## 4. Examples

In this section, we provide three examples of surfaces in $\mathbb{C}^{2}$. Example 4.1 and 4.2 are quoted from lecture notes by Jason Lotay.

Example 4.1. Let $x: \mathbb{R}^{2} \rightarrow \mathbb{C}^{2}$ be given by

$$
x\left(u_{1}, u_{2}\right)=\left(e^{\sqrt{-1} u_{1}}, e^{\sqrt{-1} u_{2}}\right), \quad\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2} .
$$

A short calculation shows that the immersion is an immersed Lagrangian self-shrinker with the image $x\left(\mathbb{R}^{2}\right)=S^{1}(1) \times S^{1}(1)$, a standard torus. Furthermore, if we denote $e_{1}=\frac{\partial}{\partial u_{1}}, e_{2}=\frac{\partial}{\partial u_{2}}$, then

$$
x_{*} e_{1}=\left(\sqrt{-1} e^{\sqrt{-1} u_{1}}, 0\right), \quad x_{*} e_{2}=\left(0, \sqrt{-1} e^{\sqrt{-1} u_{2}}\right)
$$

It is easy to check that

$$
\left(x^{*} \Omega\right)\left(e_{1}, e_{2}\right)=e^{\sqrt{-1}\left(u_{1}+u_{2}+\pi\right)}
$$

implying that the Lagrangian angle of $x$ is given by $\beta_{x}=u_{1}+u_{2}+\pi$ up to multiples of $2 \pi$. Obviously, the Maslov class $\left[-d \beta_{x}\right]$ of $x$ is nontrivial and, by Theorem $1.2 x$ is not minimal.

Example 4.2. Let $x: \mathbb{R}^{2} \backslash\{0\} \rightarrow \mathbb{C}^{2}$ be given by $\left(z_{1}, z_{2}\right)=x\left(u_{1}, u_{2}\right)$ with

$$
z_{1}=u_{1}+\frac{u_{1}}{u_{1}^{2}+u_{2}^{2}} \sqrt{-1}, \quad z_{2}=u_{2}+\frac{u_{2}}{u_{1}^{2}+u_{2}^{2}} \sqrt{-1}, \quad\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2} .
$$

This is known as the Lagrangian catenoid and, with respect to the induced metric $g$, an orthonormal frame field can be chosen as

$$
e_{1}=\frac{u_{1}^{2}+u_{2}^{2}}{\sqrt{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}} \frac{\partial}{\partial u_{1}}, \quad e_{2}=\frac{u_{1}^{2}+u_{2}^{2}}{\sqrt{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}} \frac{\partial}{\partial u_{2}} .
$$

Then

$$
d V_{M}=\frac{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}} d u_{1} \wedge d u_{2}, \quad \text { where } M^{2}=\left(\mathbb{R}^{2}, g\right)
$$

and

$$
\begin{aligned}
& x_{*} e_{1}=\frac{u_{1}^{2}+u_{2}^{2}}{\sqrt{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}}\left(1,0, \frac{u_{2}^{2}-u_{1}^{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}, \frac{-2 u_{1} u_{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}\right), \\
& x_{*} e_{2}=\frac{u_{1}^{2}+u_{2}^{2}}{\sqrt{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}}\left(0,1, \frac{-2 u_{1} u_{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}, \frac{u_{1}^{2}-u_{2}^{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}\right) .
\end{aligned}
$$

A direct computation shows that

$$
x^{*} \Omega=x^{*}\left(d z_{1} \wedge d z_{2}\right)=\frac{1+\left(u_{1}^{2}+u_{2}^{2}\right)^{2}}{\left(u_{1}^{2}+u_{2}^{2}\right)^{2}} d u_{1} \wedge d u_{2}=d V_{M}
$$

Thus

$$
\eta_{x} \equiv 1 \quad \text { and } \quad \operatorname{Arg}\left(\eta_{x}\right)=2 k \pi, k \in \mathbb{Z}
$$

Therefore, the Lagrangian angle $\beta_{x}=0$ up to multiples of $2 \pi$. Consequently by Theorem 1.2, $x$ is a minimal immersion.

Example 4.3. For any given two real constants $\theta_{1}$ and $\theta_{2}$, denote $\theta:=\theta_{1}+\theta_{2}$. Let $x: \mathbb{R}^{2} \rightarrow \mathbb{C}^{2}$ be defined by $\left(z_{1}, z_{2}\right)=x\left(u_{1}, u_{2}\right)$ with

$$
z_{1}=u_{1} \cos \theta_{1}+\sqrt{-1} u_{2} \cos \theta_{2}, \quad z_{2}=-u_{2} \sin \theta_{2}-\sqrt{-1} u_{1} \sin \theta_{1}, \quad\left(u_{1}, u_{2}\right) \in \mathbb{R}^{2}
$$

Choose $e_{1}=\frac{\partial}{\partial u_{1}}$ and $e_{2}=\frac{\partial}{\partial u_{2}}$. Then

$$
\begin{equation*}
x_{*} e_{1}=\left(\cos \theta_{1}, 0,0,-\sin \theta_{1}\right), \quad x_{*} e_{2}=\left(0,-\sin \theta_{2}, \cos \theta_{2}, 0\right) . \tag{4.1}
\end{equation*}
$$

Thus

$$
\begin{equation*}
\mathbf{J}\left(x_{*} e_{1}\right)=\left(0, \sin \theta_{1}, \cos \theta_{1}, 0\right), \quad \mathbf{J}\left(x_{*} e_{2}\right)=\left(-\cos \theta_{2}, 0,0,-\sin \theta_{2}\right) \tag{4.2}
\end{equation*}
$$

It follows that

$$
\left\langle\mathbf{J}\left(x_{*} e_{1}\right), x_{*} e_{2}\right\rangle=\cos \left(\theta_{1}+\theta_{2}\right)=\cos \theta,
$$

implying that $x$ is of constant Kähler angle $\theta$.

On the other hand, since

$$
\begin{aligned}
x^{*} \Omega=x^{*}\left(d z_{1} \wedge d z_{2}\right) & =\left(\cos \theta_{1} d u_{1}+\sqrt{-1} \cos \theta_{2} d u_{2}\right) \wedge\left(-\sin \theta_{2} d u_{2}-\sqrt{-1} \sin \theta_{1} d u_{1}\right) \\
& =-\sin \left(\theta_{1}+\theta_{2}\right) d u_{1} \wedge d u_{2}=-\sin \left(\theta_{1}+\theta_{2}\right) d V_{\mathbb{R}},
\end{aligned}
$$

we know that the Lagrangian angle of $x$ is $\beta_{x}=\pi$ up to multiples of $2 \pi$. So by Theorem 1.2, $H=0$. Clearly, $x\left(\mathbb{R}^{2}\right)$ is actually a 2 -plane in $\mathbb{C}^{2}$ and is indeed totally geodesic.

## 5. Proof of the other main theorems

In this section, we give proofs of other main theorems.
(1) Proof of Theorem 1.3.

For any tangent vector $v \in T M^{2}$, by the definition of a self-shrinker and the fundamental equations we find

$$
-A_{H} v+D_{v}^{\perp} H=\bar{D}_{v} H=\bar{D}_{v}\left(-x^{\perp}\right)=\bar{D}_{v}\left(x^{\top}-x\right)=D_{v} x^{\top}+h\left(v, x^{\top}\right)-v
$$

So that

A_{H} v=v-D_{v} x^{\top}, \quad D_{v}^{\perp} H=h\left(v, x^{\top}\right) . \tag{5.1}
\end{equation*}
$$

For a given orthonormal frame field $\left\{e_{1}, e_{2}\right\}$ on $M^{2}$, let the normal frame $\left\{e_{3}, e_{4}\right\}$ be defined via (2.2). Then a direct computation shows that

\mathbf{J} H=-\sin \theta\left(H^{3} x_{*} e_{1}+H^{4} x_{*} e_{2}\right)+\cos \theta\left(H^{4} e_{3}-H^{3} e_{4}\right) \tag{5.2}
\end{equation*}
$$

which implies that

\begin{align*}
(\mathbf{J} H)^{\top} & =-\sin \theta\left(H^{3} x_{*} e_{1}+H^{4} x_{*} e_{2}\right)  \tag{5.3}\\
(\mathbf{J} H)^{\perp} & =\cos \theta\left(H^{4} e_{3}-H^{3} e_{4}\right) \tag{5.4}
\end{align*}
$$

Since the Kähler angle $\theta$ is constant, by Lemma 2.1 and (2.5), we know that

h_{11}^{4}=h_{12}^{3}, \quad h_{12}^{4}=h_{22}^{3}, \quad \omega_{1}^{2}=\omega_{3}^{4}+\cot \theta\left(\omega_{1}^{3}+\omega_{2}^{4}\right) . \tag{5.5}
\end{equation*}
$$

Applying (5.3) - (5.5), we have

D_{e_{i}}(\mathbf{J} H)^{\top}= & -\sin \theta D_{e_{i}}\left(H^{3} e_{1}+H^{4} e_{2}\right) \\
= & -\sin \theta\left(e_{i}\left(H^{3}\right) e_{1}+e_{i}\left(H^{4}\right) e_{2}+H^{3} \omega_{1}^{2}\left(e_{i}\right) e_{2}+H^{4} \omega_{2}^{1}\left(e_{i}\right) e_{1}\right) \\
= & -\sin \theta\left(e_{i}\left(H^{3}\right) e_{1}+e_{i}\left(H^{4}\right) e_{2}+\left(H^{3} e_{2}-H^{4} e_{1}\right) \omega_{1}^{2}\left(e_{i}\right)\right) \\
= & -\sin \theta\left(e_{i}\left(H^{3}\right) e_{1}+e_{i}\left(H^{4}\right) e_{2}+\left(H^{3} e_{2}-H^{4} e_{1}\right) \omega_{3}^{4}\left(e_{i}\right)\right. \\
& \left.+\cot \theta\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(\omega_{1}^{3}+\omega_{2}^{4}\right)\left(e_{i}\right)\right) \\
= & -\sin \theta\left(e_{i}\left(H^{3}\right) e_{1}+e_{i}\left(H^{4}\right) e_{2}+\left(H^{3} e_{2}-H^{4} e_{1}\right) \omega_{3}^{4}\left(e_{i}\right)\right) \\
& -\cos \theta\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(h_{1 i}^{3}+h_{2 i}^{4}\right) ;
\end{aligned}
$$

and

$$
\begin{aligned}
\mathbf{J} D_{e_{i}}^{\perp} H= & \mathbf{J} D_{e_{i}}^{\perp}\left(H^{3} e_{3}+H^{4} e_{4}\right) \\
= & \mathbf{J}\left(e_{i}\left(H^{3}\right) e_{3}+e_{i}\left(H^{4}\right) e_{4}+H^{3} D_{e_{i}}^{\perp} e_{3}+H^{4} D_{e_{i}}^{\perp} e_{4}\right) \\
= & \mathbf{J}\left(e_{i}\left(H^{3}\right) e_{3}+e_{i}\left(H^{4}\right) e_{4}+H^{3} \omega_{3}^{4}\left(e_{i}\right) e_{4}+H^{4} \omega_{4}^{3}\left(e_{i}\right) e_{3}\right) \\
= & \left(e_{i}\left(H^{3}\right)-H^{4} \omega_{3}^{4}\left(e_{i}\right)\right)\left(-\sin \theta e_{1}-\cos \theta e_{4}\right) \\
& +\left(e_{i}\left(H^{4}\right)+H^{3} \omega_{3}^{4}\left(e_{i}\right)\right)\left(-\sin \theta e_{2}+\cos \theta e_{3}\right) .
\end{aligned}
$$

Comparing the above two equations, we find

$$
\begin{equation*}
D_{e_{i}}(\mathbf{J} H)^{\top}=\left(\mathbf{J} D_{e_{i}}^{\perp} H\right)^{\top}-\cos \theta\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(h_{1 i}^{3}+h_{2 i}^{4}\right) . \tag{5.6}
\end{equation*}
$$

Consequently, from (5.1), (5.5) and (5.6) it follows that

$$
\begin{aligned}
\operatorname{div}(\mathbf{J} H)^{\top}= & \sum_{i}\left\langle D_{e_{i}}(\mathbf{J} H)^{\top}, e_{i}\right\rangle \\
= & \sum_{i}\left\langle\mathbf{J}\left(D_{e_{i}}^{\perp} H\right)-\cos \theta\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(h_{1 i}^{3}+h_{2 i}^{4}\right), e_{i}\right\rangle \\
= & \sum_{i}\left\langle\mathbf{J}\left(D_{e_{i}}^{\perp} H\right), e_{i}\right\rangle-\cos \theta\left(\left\langle\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(h_{11}^{3}+h_{21}^{4}\right), e_{1}\right\rangle\right. \\
& \left.+\left\langle\left(H^{3} e_{2}-H^{4} e_{1}\right)\left(h_{12}^{3}+h_{22}^{4}\right), e_{2}\right\rangle\right) \\
= & \sum_{i}\left\langle\mathbf{J}\left(D_{e_{i}}^{\perp} H\right), e_{i}\right\rangle-\cos \theta\left(-H^{4}\left(h_{11}^{3}+h_{22}^{3}\right)+H^{3}\left(h_{11}^{4}+h_{22}^{4}\right)\right) \\
= & \sum_{i}\left\langle\mathbf{J}\left(D_{e_{i}}^{\perp} H\right), e_{i}\right\rangle-\cos \theta\left(-H^{4} H^{3}+H^{3} H^{4}\right) \\
= & -\sum_{i}\left\langle\left(D_{e_{i}}^{\perp} H\right), \mathbf{J} e_{i}\right\rangle=-\sum_{i}\left\langle h\left(e_{i}, x^{\top}\right), \mathbf{J} e_{i}\right\rangle \\
= & -\left\langle h\left(e_{1}, x^{\top}\right), \sin \theta e_{3}\right\rangle-\left\langle h\left(e_{2}, x^{\top}\right), \sin \theta e_{4}\right\rangle \\
= & -\left\langle h\left(e_{1}, x^{1} e_{1}+x^{2} e_{2}\right), \sin \theta e_{3}\right\rangle-\left\langle h\left(e_{2}, x^{1} e_{1}+x^{2} e_{2}\right), \sin \theta e_{4}\right\rangle \\
= & -\sin \theta\left(x^{1} h_{11}^{3}+x^{2} h_{12}^{3}+x^{1} h_{21}^{4}+x^{2} h_{22}^{4}\right) \\
= & -\sin \theta\left(x^{1}\left(h_{11}^{3}+h_{22}^{3}\right)+x^{2}\left(h_{11}^{4}+h_{22}^{4}\right)\right) \\
= & -\sin \theta\left(x^{1} H^{3}+x^{2} H^{4}\right) \\
= & \left\langle(\mathbf{J} H)^{\top}, x^{\top}\right\rangle,
\end{aligned}
$$

where $x^{\top}=\sum_{i} x^{i} e_{i}$. If $[\alpha]=0$, there exists a globally defined smooth function $\varphi$ satisfying $\alpha=-d \varphi$, or equivalently, $\nabla \varphi=\nabla \beta_{x}$. By Theorem 1.2, we obtain an elliptic linear equation

$$
\left.\Delta \varphi=\left.\frac{1}{2}\langle\nabla \varphi, \nabla| x\right|^{2}\right\rangle .
$$

Then according to the maximum principle (see for example, [12]), $\varphi$ must be a constant and thus $\alpha=-d \varphi \equiv 0$ which with Theorem [1.2 implies $H \equiv 0$, contradicting the fact that there are no compact minimal submanifolds in an Euclidean space.

To prove Theorem 1.8 and Theorem 1.9, the following lemma is needed:
Lemma 5.1. Let $x: M^{2} \rightarrow \mathbb{C}^{2}$ be a self-shrinker with Kähler angle $\theta$. Then

Proof. Around each point of the open subset

$$
M^{*}:=\left\{p \in M^{2} ; \sin \theta(p) \neq 0\right\}
$$

we choose an orthonormal frame field $\left\{e_{1}, e_{2}\right\}$ on $M^{2}$ which via (2.2) defines the normal frame $\left\{e_{3}, e_{4}\right\}$. Then by (2.3) and (2.4)

\begin{equation*}
\nabla \theta=\sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right) e_{i}, \quad \Gamma_{1 i}^{2}-\Gamma_{3 i}^{4}=\cot \theta\left(h_{1 i}^{3}+h_{2 i}^{4}\right), \tag{5.9}
\end{equation*}
$$

where $\Gamma_{A B}^{C}$ are determined by $\omega_{A}^{C}=\sum_{B} \Gamma_{A B}^{C} \omega^{B}$. From Codazzi equation and (5.9), it follows that

\Delta \theta & =\sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right)_{, i} \\
& =\sum_{i}\left(e_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right)-\left(h_{1 j}^{4}-h_{2 j}^{3}\right) \Gamma_{i i}^{j}\right) \\
& =\sum_{i}\left(h_{1 i i}^{4}-h_{2 i i}^{3}+h_{2 i}^{4} \Gamma_{1 i}^{2}-h_{1 i}^{3} \Gamma_{2 i}^{1}-h_{1 i}^{3} \Gamma_{3 i}^{4}+h_{2 i}^{4} \Gamma_{4 i}^{3}\right) \\
& =\sum_{i}\left(H_{, 1}^{4}-H_{, 2}^{3}+\left(h_{2 i}^{4}+h_{1 i}^{3}\right) \Gamma_{1 i}^{2}-\left(h_{2 i}^{4}+h_{1 i}^{3}\right) \Gamma_{3 i}^{4}\right) \\
& =\sum_{i}\left(H_{, 1}^{4}-H_{, 2}^{3}+\left(h_{2 i}^{4}+h_{1 i}^{3}\right)\left(\Gamma_{1 i}^{2}-\Gamma_{3 i}^{4}\right)\right) \\
& =\sum_{i}\left(H_{, 1}^{4}-H_{, 2}^{3}+\cot \theta\left(h_{2 i}^{4}+h_{1 i}^{3}\right)^{2}\right) . \tag{5.10}
\end{align*}
$$

Consequently, by (5.9) and (5.10),

\begin{align*}
\Delta \cos \theta & =-\cos \theta|\nabla \theta|^{2}-\sin \theta \Delta \theta \\
& =-\cos \theta \sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right)^{2}-\sin \theta\left(H_{, 1}^{4}-H_{, 2}^{3}\right)-\cos \theta \sum_{i}\left(h_{2 i}^{4}+h_{1 i}^{3}\right)^{2} \\
& =-\cos \theta\left(\sum_{i}\left(\left(h_{1 i}^{4}-h_{2 i}^{3}\right)^{2}+\left(h_{2 i}^{4}+h_{1 i}^{3}\right)^{2}\right)\right)-\sin \theta\left(H_{, 1}^{4}-H_{, 2}^{3}\right) \\
& =-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}-\sin \theta\left(H_{, 1}^{4}-H_{, 2}^{3}\right), \tag{5.11}
\end{align*}
$$

and thus

$$
\begin{align*}
\frac{1}{2} \Delta\left(\cos ^{2} \theta\right) & =|\nabla \cos \theta|^{2}+\cos \theta(\Delta \cos \theta) \\
& =\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}-\cos \theta \sin \theta\left(H_{, 1}^{4}-H_{, 2}^{3}\right) \tag{5.12}
\end{align*}
$$

By Lemma 2.2, we have

\begin{equation*}
H_{, 1}^{4}-H_{, 2}^{3}=\sum_{i} h_{1 i}^{4}\left\langle x, e_{i}\right\rangle-\sum_{i} h_{2 i}^{3}\left\langle x, e_{i}\right\rangle=\sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right)\left\langle x, e_{i}\right\rangle . \tag{5.13}
\end{equation*}
$$

Inserting (5.13) to (5.11) and (5.12), respectively, we obtain

\Delta \cos \theta & =-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}-\sin \theta \sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right)\left\langle x, e_{i}\right\rangle \\
& =-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}-\left\langle x, \sin \theta \sum_{i}\left(h_{1 i}^{4}-h_{2 i}^{3}\right) e_{i}\right\rangle \\
& =-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}+\langle x, \nabla \cos \theta\rangle \tag{5.14}
\end{align*}
$$

and

$$
\begin{align*}
\frac{1}{2} \Delta \cos ^{2} \theta & =|\nabla \cos \theta|^{2}+\cos \theta(\Delta \cos \theta) \\
& =\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}+\cos \theta\langle x, \nabla \cos \theta\rangle \\
& =\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}+\cos \theta\langle x, \nabla \cos \theta\rangle \\
& =\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}+\frac{1}{2}\left\langle x, \nabla \cos ^{2} \theta\right\rangle \tag{5.15}
\end{align*}
$$

By the definition of $\mathcal{L}$, (5.14) and (5.15) become, respectively,

\mathcal{L} \cos \theta=\Delta \cos \theta-\langle x, \nabla \cos \theta\rangle=-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}  \tag{5.16}\\
\frac{1}{2} \mathcal{L} \cos ^{2} \theta=\frac{1}{2} \Delta \cos ^{2} \theta-\frac{1}{2}\left\langle x, \nabla \cos ^{2} \theta\right\rangle=\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2} \tag{5.17}
\end{gather*}
$$

Thus (5.7) and (5.8) hold on the open set $M^{*}$.
At a point $p \notin M^{*}$, there are two cases that need to be considered:
Case $1^{\circ}: p$ is an accumulation point of $M^{*}$.
Because both $\mathcal{L} \cos \theta$ and $-\cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}$ are globally defined and smooth, we can take the limits of the two sides of (5.7) to find (5.7) still holds at the point $p$. Similarly (5.8) holds at $p$.

Case $2^{\circ}: p$ is not an accumulation point of $M^{*}$.
In this case, $\mathbf{J}_{M}=\mathbf{J}$ around $p$. So $\left|\bar{D} \mathbf{J}_{M}\right|^{2}=0$. Since $\cos \theta \equiv 1$ around $p, \mathcal{L} \cos \theta=0$. Therefore both (5.7) and (5.8) still hold at $p$.
(2) Proof of Theorem 1.8

Take $v=\cos \theta$. Then

$$
\begin{align*}
|\nabla v|^{2} & =\sin ^{2} \theta|\nabla \theta|^{2}=\sin ^{2} \theta \sum_{i}\left|h_{1 i}^{4}-h_{2 i}^{3}\right|^{2} \\
& \leq 2 \sin ^{2} \theta \sum_{i}\left(\left(h_{1 i}^{4}\right)^{2}+\left(h_{2 i}^{3}\right)^{2}\right) \leq 2|h|^{2}  \tag{5.18}\\
|\mathcal{L} v| & =|\mathcal{L} \cos \theta|=\left.\left.\frac{1}{4}|\cos \theta| \bar{D} \mathbf{J}_{M}\right|^{2}|\leq 4| h\right|^{2} \tag{5.19}
\end{align*}
$$

Since $\int_{M}|h|^{2} e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty,(5.18)$ and (5.19) show that, for $u \equiv 1$,

$$
\int_{M}(|u \nabla v|+|\nabla u \nabla v|+|u \mathcal{L} v|) e^{-\frac{|x|^{2}}{2}} d V_{M}<\infty
$$

Thus by Lemma 2.3, we obtain

$$
\begin{equation*}
\int_{M} \mathcal{L} \cos \theta e^{-\frac{|x|^{2}}{2}} d V_{M}=0 \tag{5.20}
\end{equation*}
$$

Since, by the assumption, $\cos \theta \geq 0$, it follows by (5.7) that $\mathcal{L} \cos \theta \leq 0$. Therefore,

$$
\begin{equation*}
\mathcal{L} \cos \theta=-\frac{1}{4} \cos \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2} \equiv 0 \tag{5.21}
\end{equation*}
$$

Consider the function $\varphi=|\nabla \theta|^{2}$. If $\varphi$ is not identically zero on $M^{2}$, then there exists a point $p_{0}$ such that $\varphi \neq 0$ and we can find a connected domain $U$ containing $p_{0}$ where $\varphi$ is non-zero identically. Denote $U_{0}=\{p \in U \mid \cos \theta(p)=0\}$. Then $U_{0}$ obviously contains no interior points. Therefore $U \backslash U_{0}$ is a dense set. By (5.21), $\left|\bar{D} \mathbf{J}_{M}\right|^{2} \equiv 0$ on $U \backslash U_{0}$ implying $h_{1 i}^{4}=h_{2 i}^{3}$ and $h_{2 i}^{4}=-h_{1 i}^{3}$ on $U \backslash U_{0}$. Thus, by (2.5), we have $\nabla \theta \equiv 0$ on $U \backslash U_{0}$ which contradicts the definition of $U$. This shows that $\varphi \equiv 0$ on $M^{2}$, that is, $\theta$ is constant.

If $\cos \theta=0$, then $x$ is a Lagrangian immersion;
If $\cos \theta \neq 0$, then $\left|\bar{D} \mathbf{J}_{M}\right|^{2} \equiv 0$. It follows that $h_{1 i}^{4}=h_{2 i}^{3}, h_{2 i}^{4}=-h_{1 i}^{3}$, that is,

$$
h_{11}^{4}=h_{21}^{3}=-h_{22}^{4}, \quad h_{22}^{3}=h_{21}^{4}=-h_{11}^{3}
$$

which implies that $H \equiv 0$. Since $x$ is a self-shrinker, we obtain

$$
\begin{equation*}
\left\langle x, e_{3}\right\rangle=0, \quad\left\langle x, e_{4}\right\rangle=0 \tag{5.22}
\end{equation*}
$$

Hence, for $a=3,4$,

$$
\left\langle x, \bar{D}_{e_{i}} e_{a}\right\rangle=e_{i}\left\langle x, e_{a}\right\rangle-\left\langle\bar{D}_{e_{i}} x, e_{a}\right\rangle=0-\left\langle e_{i}, e_{a}\right\rangle=0
$$

namely

$$
\left\langle x,-A_{e_{a}} e_{i}+\sum_{b} \Gamma_{a i}^{b} e_{b}\right\rangle=0
$$

So that

$$
\begin{equation*}
\sum_{j} h_{i j}^{a}\left\langle x, e_{j}\right\rangle=0, \quad a=3,4 . \tag{5.23}
\end{equation*}
$$

From (5.23), it is easily seen that

$$
\left|\begin{array}{ll}
h_{11}^{3} & h_{21}^{3} \\
h_{12}^{3} & h_{22}^{3}
\end{array}\right|=\left|\begin{array}{ll}
h_{11}^{4} & h_{21}^{4} \\
h_{12}^{4} & h_{22}^{4}
\end{array}\right|=0 .
$$

It follows that

$$
h_{11}^{3} h_{22}^{3}-\left(h_{21}^{3}\right)^{2}=h_{11}^{4} h_{22}^{4}-\left(h_{21}^{4}\right)^{2}=0
$$

which with $H=0$ shows that

$$
h_{11}^{3}=h_{21}^{3}=h_{11}^{4}=h_{21}^{4}=0 .
$$

That is, $M^{2}$ is totally geodesic and thus, by the completeness, $M^{2}$ must be a plane.
(3) Proof of Theorem 1.9

Similar to those in (2), we take $u \equiv 1$ and $v=\frac{1}{2} \cos ^{2} \theta$. Since

$$
\begin{align*}
|\nabla v|^{2} & =\cos ^{2} \theta \sin ^{2} \theta|\nabla \theta|^{2}=\cos ^{2} \sin ^{2} \theta \sum_{i}\left|h_{1 i}^{4}-h_{2 i}^{3}\right|^{2} \\
& \leq 2 \sin ^{2} \theta \sum_{i}\left(\left(h_{1 i}^{4}\right)^{2}+\left(h_{2 i}^{3}\right)^{2}\right) \leq 2|h|^{2}  \tag{5.24}\\
|\mathcal{L} v| & =\frac{1}{2}\left|\mathcal{L} \cos ^{2} \theta\right|=\left.\left|\sin ^{2} \theta\right| \nabla \theta\right|^{2}-\left.\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}|\leq 6| h\right|^{2}, \tag{5.25}
\end{align*}
$$

we can use Lemma 2.3 to get

$$
\begin{equation*}
\frac{1}{2} \int_{M}\left(\mathcal{L} \cos ^{2} \theta\right) e^{-\frac{|x|^{2}}{2}} d V_{M}=0 \tag{5.26}
\end{equation*}
$$

On the other hand, by (1.5) and (5.8), we find

$$
\begin{aligned}
\frac{1}{2} \mathcal{L} \cos ^{2} \theta & =\sin ^{2} \theta|\nabla \theta|^{2}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2} \\
& \leq \sin ^{2} \theta \frac{\lambda \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}}{4\left(1-\lambda \cos ^{2} \theta\right)}-\frac{1}{4} \cos ^{2} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2} \\
& =-\frac{(1-\lambda) \cos ^{4} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}}{4\left(1-\lambda \cos ^{2} \theta\right)} \leq 0 .
\end{aligned}
$$

Therefore

$$
\cos ^{4} \theta\left|\bar{D} \mathbf{J}_{M}\right|^{2}=0
$$

By using an argument similar to that in (2), we can conclude that either $\cos \theta \equiv 0$ or $\left|\bar{D} \mathbf{J}_{M}\right|^{2} \equiv 0$. Then the rest of the proof is omitted here since it is the same as that of the proof of Theorem 1.8.
