# Discrete Lossy Gray-Wyner Revisited: Second-Order Asymptotics, Large and Moderate Deviations

#### Abstract

In this paper, we revisit the discrete lossy Gray-Wyner problem. In particular, we derive its optimal second-order coding rate region, its error exponent (reliability function) and its moderate deviations constant under mild conditions on the source. To obtain the second-order asymptotics, we extend some ideas from Watanabe's work (2015). In particular, we leverage the properties of an appropriate generalization of the conditional distortion-tilted information density, which was first introduced by Kostina and Verdú (2012). The converse part uses a perturbation argument by Gu and Effros (2009) in their strong converse proof of the discrete Gray-Wyner problem. The achievability part uses two novel elements: (i) a generalization of various type covering lemmas; and (ii) the uniform continuity of the conditional rate-distortion function in both the source (joint) distribution and the distortion level. To obtain the error exponent, for the achievability part, we use the same generalized type covering lemma and for the converse, we use the strong converse together with a change-of-measure technique. Finally, to obtain the moderate deviations constant, we apply the moderate deviations theorem to probabilities defined in terms of information spectrum quantities.


## I. Introduction

The lossy Gray-Wyner source coding problem [2] is shown in Figure 1. There are three encoders and two decoders. Encoder $f_{i}$ has access to a source sequence pair $\left(X^{n}, Y^{n}\right)$ and compresses it into a message $S_{i}$. Decoder $\phi_{1}$ aims to recover source sequence $X^{n}$ under fidelity criterion $d_{X}$ and distortion level $D_{1}$ with the encoded message $S_{0}$ from encoder $f_{0}$ and $S_{1}$ from encoder $f_{1}$. Similarly, the decoder $\phi_{2}$ aims to recover $Y^{n}$ with messages $S_{0}$ and $S_{2}$. The optimal rate region for lossless and lossy Gray-Wyner source coding problem was characterized in [2]. However, because an auxiliary random variable is involved in the description of the rate region, it is non-trivial to characterize the second-order coding rate region, the error exponent as well as the moderate deviations constant.

## A. Related Works

The most relevant work to ours is [3], in which Watanabe derived the optimal second-order coding region for the lossless Gray-Wyner source coding problem. Several of the techniques contained herein mirror those in [3]. However, we also combine techniques from other works, develop some new results, and make several new observations for this lossy problem. We briefly summarize some other works that are related to Gray-Wyner's seminal work. Gu and Effros derived a strong converse for discrete memoryless sources in [4]. Viswanatha, Akyol and Rose [5] derived a single-letter formula for the lossy version of Wyner's common information and also properties of the optimal test channel (which we exploit in our proofs). Xu, Liu and Chen [6] presented an alternative expression for lossy version of Wyner's common information.

There are several works that consider second-order asymptotics for lossy source coding. These include the study of point-to-point lossy source coding by Ingber and Kochman [7] and Kostina and Verdú [8], the Wyner-Ziv problem by Watanabe, Kuzuoka and Tan in [9] and by Yassaee, Aref and Gohari in [10]; the successive refinement source coding problem (which is closely related to the Gray-Wyner problem) by No, Ingber and Weissman in [11].

In terms of error exponent analyses for lossy source coding, there are several related works. For point-to-point lossy source coding, Marton [12] derived the error exponent for discrete memoryless sources while Ihara and Kubo [13] considered Gaussian memoryless sources. For successive refinement source coding, Kanlis and Narayan derived the error exponent in [14] under joint excess-distortion criterion while Tuncel and Rose [15] derived the error exponent under separate excess-distortion ceiteria.

We also recall the related works on moderate deviations analysis. Chen et al. [16] and He et al. [17] initiated the study of moderate deviations for fixed-to-variable length source coding with decoder side information. For fixed-to-fixed length analysis, Altuğ and Wagner [18] initiated the study of moderate deviations in the context of discrete memoryless channels. Polyanksiy and Verdú [19] relaxed some assumptions in the conference version of Altuğ and Wagner's work [20] and they also considered moderate deviations for AWGN channels. Altuğ, Wagner and Kontoyiannis [21] considered moderate deviations for lossless source coding. For lossy source coding, the moderate deviations analysis was done by Tan in [22] using ideas from Euclidean information theory [23].

## B. Main Contributions

In this paper, we derive the optimal second-order coding region, the error exponent and moderate deviations constant for discrete lossy Gray-Wyner source coding problem under some mild conditions. To the best of our knowledge, even the error exponent for the lossy Gray-Wyner problem has not been established in the literature. We highlight some of the salient features of our analyses.
(i) As shown in Figure 2, the achievability proofs for all three asymptotic regimes can be done in a unified manner and all of them hinge on a single covering lemma (Lemma 8) designed specifically for the discrete lossy Gray-Wyner source coding problem. While the proof of this type covering lemma itself hinges on various other works [11], [12], [3], piecing the ingredients together and ensuring that the resultant asymptotic results are tight is non-trivial.
(ii) One of the main challenges here in proving the type covering lemma is the requirement to establish the uniform continuity of the conditional rate-distortion function in both the source distribution and distortion level, which we do in Lemmas 18, 19 and 20. Palaiyanur and Sahai [24] only established this uniformity in the source distribution for the rate-distortion function.
(iii) Several observations need to be made to establish the optimal second-order coding region. We define a generalized distortion-tilted information density, leverage on its properties and make proper use of Taylor expansions and the BerryEsseen Theorem. We encountered a slight obstacle on whether to define the distortion-tilted information density according to the Gray-Wyner region defined in terms of conditional rate-distortion functions as in [2] or (conditional) mutual information quantities as in [25, Exercise 14.9]. These are equivalent as stated in Theorem 1 and equation (13). However, it turns out that the latter is more amenable since it does not explicitly involve an optimization (which is present in the characterization of the conditional rate-distortion function). In the converse part, as shown in Figure 2, we prove a type-based strong converse by using perturbation approach in [4] and similar analysis in [3].
(iv) To evaluate the optimal second-order coding region for rate triplets on the Pangloss plane [2], we leverage a result in Viswanatha, Akyol, and Rose [5] which establishes several Markov chains for the Gray-Wyner problem. This helps to simplify the relevant tilted information densities.
(v) For the error exponent analysis, we combine our type covering lemma with Marton's technique for establishing the reliability function of lossy data compression [12]. The converse part follows from strong converse [4] and the change-of-measure technique by Haroutunian [26], [27].
(vi) Finally, for our moderate deviations analysis, we use an information spectrum calculation [19] similar to that used for the second-order asymptotic analysis. We also invoke the moderate deviations principle/theorem in [28, Theorem 3.7.1]. Further, in the analysis of moderate deviations, compared with previous result for lossy source coding [22], we removed the additional requirement that $\lim _{n \rightarrow \infty} \frac{n \rho_{n}^{2}}{\log n} \rightarrow \infty$ where $\rho_{n}$ controls the speed of convergence of rate to a boundary rate (pair) in the moderate deviations regime. Instead, all we need is the usual condition that $\lim _{n \rightarrow \infty} n \rho_{n}^{2}=\infty$.

## C. Organization of the Paper

The rest of the paper is organized as follows. In Section II, we set up the notation, formulate the discrete lossy Gray-Wyner problem and recapitulate the optimal rate region (first-order result). In Section III, we define the second-order coding region formally and present the main theorem which expresses the optimal second-order coding region in terms of a rate-dispersion function [8]. In addition, we simplify the calculation of the region for rate triplets on the Pangloss region and provide an numerical example for a doubly symmetric binary source with hamming distortion measures. In Section IV, we present the proof for second-order asymptotics. For the achievability part, we present a type covering lemma for discrete lossy GrayWyner problem which is used extensively in various achievability proofs throughout the paper. In Section V, we define the error exponent formally, present the result and provide a detailed proof. In Section VI, we provide a formal definition of

moderate deviations constant, present the main result on moderate deviations as well as its detailed proof. Finally, we conclude the paper in Section VII. To ensure that the main ideas of the paper are presented seamlessly, we defer the proof of all supporting technical lemmas to the appendices.

## II. Problem Formulation and Existing Results

## A. Notation

Random variables and their realizations are in capital (e.g., $X$ ) and lower case (e.g., $x$ ) respectively. All sets (e.g., alphabets of random variables) are denoted in calligraphic font (e.g., $\mathcal{X}$ ). Let $X^{n}:=\left(X_{1}, \ldots, X_{n}\right)$ be a random vector of length $n$. The set of all probability distribution on $\mathcal{X}$ is denoted as $\mathcal{P}(\mathcal{X})$ and the set of all conditional probability distribution from $\mathcal{X}$ to $\mathcal{Y}$ is denoted as $\mathcal{P}(\mathcal{Y} \mid \mathcal{X})$. Given $P \in \mathcal{P}(\mathcal{X})$ and $V \in \mathcal{P}(\mathcal{Y} \mid \mathcal{X})$, we use $P \times V$ to denote the joint distribution induced by $P$ and $V$. In terms of the method of types, we use the notations as [29]. Given sequence $x^{n}$, the empirical distribution is denoted as $\hat{T}_{x^{n}}$. The set of types formed from length $n$ sequences in $\mathcal{X}$ is denoted as $\mathcal{P}_{n}(\mathcal{X})$. Given $P \in \mathcal{P}_{n}(\mathcal{X})$, the set of all sequences of length $n$ with type $P$ is denoted as $\mathcal{T}_{P}$. Given $x^{n} \in \mathcal{T}_{P}$, the set of all sequences $y^{n} \in \mathcal{Y}^{n}$ such that the joint type of $\left(x^{n}, y^{n}\right)$ is $P \times V$ is denoted as $\mathcal{T}_{V}\left(x^{n}\right)$. The set of all $V \in \mathcal{P}(\mathcal{Y} \mid \mathcal{X})$ for which $\mathcal{T}_{V}\left(x^{n}\right)$ is not empty for $x^{n} \in \mathcal{T}_{P}$ is denoted as $\mathcal{V}_{n}(\mathcal{Y} ; P)$.

In terms of information theoretic quantities, we use $H(X)$ and $H\left(P_{X}\right)$ interchangeably to denote the entropy of a random variable $X$ with distribution $P_{X}$. Similarly, we use $H(X \mid Y)$ and $H\left(P_{X \mid Y} \mid P_{Y}\right)$ interchangeably. For mutual information, we use $I(X ; Y)$ and $I\left(P_{X}, P_{Y \mid X}\right)$ interchangeably. For conditional mutual information, we use $I(X ; Y \mid W)$ and $I\left(P_{X \mid W}, P_{Y \mid X W} \mid P_{W}\right)$ interchangeably.

We use $\exp (x)$ to denote $2^{x}$. We let $\mathrm{Q}(t):=\int_{t}^{\infty} \frac{1}{\sqrt{2 \pi}} e^{-u^{2} / 2} \mathrm{~d} u$ be the complementary cumulative distribution function of the standard Gaussian. We let $\mathrm{Q}^{-1}$ be the inverse of Q . Given two integers $a$ and $b$, we use $[a: b]$ to denote all the integers between $a$ and $b$. We use standard asymptotic notation such as $O(\cdot)$ and $o(\cdot)$.

Given a joint probability mass function (pmf) $P_{X Y}$, let $\mathcal{S}=\operatorname{supp}\left(P_{X Y}\right)$ and $|\mathcal{S}|=m$. Let us sort $P_{X Y}(x, y)$ in an decreasing order for all $(x, y) \in \mathcal{X} \times \mathcal{Y}$, and for all $i \in[1: m]$, let $\left(x_{i}, y_{i}\right)$ be the pair such that $P_{X Y}\left(x_{i}, y_{i}\right)$ is the $i$-th largest. Let $\Gamma\left(P_{X Y}\right)$ be a joint distribution defined on $\mathcal{S}$ such that $\Gamma_{i}\left(P_{X Y}\right)=P_{X Y}\left(x_{i}, y_{i}\right)$ for all $i \in[1: m]$.

## B. Problem Formulation

We consider a correlated source $(X, Y)$ with joint distribution $P_{X Y}$ and a finite alphabet $\mathcal{X} \times \mathcal{Y}$. The correlated source is assumed to be stationary and memoryless, hence $\left(X^{n}, Y^{n}\right)$ is an i.i.d. sequence where each $\left(X_{i}, Y_{i}\right)$ is generated according to $P_{X Y}$. The basic definitions are as follows.
Definition 1. An $\left(n, M_{0}, M_{1}, M_{2}\right)$-code for lossy Gray-Wyner source coding consists of three encoders:

Define two distortion measures: $d_{X}: \mathcal{X} \times \hat{\mathcal{X}} \rightarrow[0, \infty)$ and $d_{Y}: \mathcal{Y} \times \hat{\mathcal{Y}} \rightarrow[0, \infty)$ such that for each $(x, y) \in \mathcal{X} \times$ $\mathcal{Y}$, there exists $(\hat{x}, \hat{y}) \in \hat{\mathcal{X}} \times \hat{\mathcal{Y}}$ satisfying $d_{X}(x, \hat{x})=0$ and $d_{Y}(y, \hat{y})=0$. Define $\bar{d}_{X}:=\max _{x, \hat{x}} d_{X}(x, \hat{x})$ and $\underline{d}_{X}:=$ $\min _{x, \hat{x}: d_{X}(x, \hat{x})>0} d_{X}(x, \hat{x})$. Similarly, we define $\bar{d}_{Y}$ and $\underline{d}_{Y}$. Let the average distortion between $x^{n}$ and $\hat{x}^{n}$ be defined as $d_{X}\left(x^{n}, \hat{x}^{n}\right):=\frac{1}{n} \sum_{i=1}^{n} d_{X}\left(x_{i}, \hat{x}_{i}\right)$ and the average distortion $d_{Y}\left(y^{n}, \hat{y}^{n}\right)$ be defined in a similar manner. Throughout the paper, we consider the case where $D_{1}>0$ and $D_{2}>0$ (but we will remark on how our results apply to the case where either or both $\left.D_{i}=0(i=1,2)\right)$. The first-order fundamental limit is defined as follows.

Definition 2 (First-order Region). A rate triplet $\left(R_{0}, R_{1}, R_{2}\right)$ is said to be ( $D_{1}, D_{2}$ )-achievable if there exists a sequence of ( $n, M_{0}, M_{1}, M_{2}$ )-codes such that

The closure of the set of all $\left(D_{1}, D_{2}\right)$-achievable rate triplets is the $\left(D_{1}, D_{2}\right)$-optimal rate region and denoted as $\mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$.

## C. Existing Results

Gray and Wyner characterized the $\left(D_{1}, D_{2}\right)$-achievable rate region in [2]. Let $\mathcal{P}\left(P_{X Y}\right)$ be the set of all joint distributions $P_{X Y W}$ such that the $\mathcal{X} \times \mathcal{Y}$-marginal of $P_{X Y W}$ is the source distribution $P_{X Y}$ and $|\mathcal{W}| \leq|\mathcal{X}| \cdot|\mathcal{Y}|+2$. Denote the $\mathcal{X} \times \mathcal{W}$ marginal distribution as $P_{X W}$ and the $\mathcal{Y} \times \mathcal{W}$ marginal distribution as $P_{Y W}$.
Theorem 1 (Gray-Wyner [2]). The ( $D_{1}, D_{2}$ )-achievable rate region for lossy Gray-Wyner source coding is

where $R_{X \mid W}\left(P_{X W}, D_{1}\right)$ and $R_{Y \mid W}\left(P_{Y W}, D_{2}\right)$ are conditional rate-distortion functions [25, pp. 275, Chapter 11], i.e.,

An equivalent version of the first-order coding region for Gray-Wyner problem was given in [25, Exercise 14.9] and states that

## III. Second-order Asymptotics

## A. Definition of Second-Order Coding Region

In this subsection, we define the second-order coding region for lossy Gray-Wyner problem. First, define the excess-distortion probability for distortion pair $\left(D_{1}, D_{2}\right)$ as

Definition 3 (Second-Order Region). A triplet $\left(L_{0}, L_{1}, L_{2}\right)$ is said to be second-order $\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$-achievable if there exists a sequence of $\left(n, M_{0}, M_{1}, M_{2}\right)$-codes such that

The closure of the set of all second-order $\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$-achievable triplets is called the optimal second-order $\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$ coding region and denoted as $\mathcal{L}\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$.

The central goal for this section is to characterize $\mathcal{L}\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$. Note that in Definition 2 , the expected distortion measure is considered whereas in Definition 3, the excess-distortion probability is considered. For the purposes of second-order asymptotics, error exponents and moderate deviations, the formulation in Definition 3 is preferred since there is a probability to quantify.

## B. Tilted Information Density

We now introduce the tilted information density which takes on a similar role as it did in the lossless case [3]. Given distortion pair $\left(D_{1}, D_{2}\right)$ and rate pair $\left(R_{1}, R_{2}\right)$, let

where (20) follows from Theorem 1 and (21) follows from (13).
Since $\mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$ is a convex set [2], the minimization in (20) is attained when $R_{1}=R_{X \mid W}\left(P_{X W}, D_{1}\right)$ and $R_{2}=$ $R_{Y \mid W}\left(P_{Y W}, D_{2}\right)$ for some optimal test channel $P_{W \mid X Y}$ unless $\mathrm{R}_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid P_{X Y}\right)=0$ or $\mathrm{R}_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid P_{X Y}\right)=$ $\infty$. However, in the following, we assume $\mathrm{R}_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid P_{X Y}\right)>0$ is finite. Given distortion levels $\left(D_{1}, D_{2}\right)$, we are interested in the rate triplets $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$ such that $R_{0}^{*}=\mathrm{R}_{0}\left(R_{0}^{*}, R_{1}^{*}, D_{1}, D_{2}\right)$ throughout the section. Further, as in [3], we assume $\mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$ is smooth at a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$ of our interest, i.e.,

are well-defined for $i \in\{1,2\}$. Note that $\lambda_{i}^{*}, \gamma_{i}^{*} \geq 0$ since $R_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid P_{X Y}\right)$ is a non-increasing in $\left(R_{1}, R_{2}, D_{1}, D_{2}\right)$. Throughout the paper, we assume $\left(\lambda_{1}^{*}, \lambda_{2}^{*}, \gamma_{1}^{*}, \gamma_{2}^{*}\right)$ are strictly positive, i.e., we consider a rate triplet where $R_{0}^{*}=R_{0}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ is positive and finite.

Let $P_{W \mid X Y}^{*} P_{\hat{X} \mid X W}^{*} P_{\hat{Y} \mid Y W}^{*}$ be the optimal test channel ${ }^{1}$ that achieves the $\mathrm{R}_{0}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ in (21). Let $P_{\hat{X} \mid W}^{*}, P_{\hat{Y} \mid W}^{*}, P_{W}^{*}$ be the induced (conditional) distributions. Define

Definition 4. For a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$, given distortion threshold pair $\left(D_{1}, D_{2}\right)$, the tilted information density for lossy Gray-Wyner source coding is defined as

We remark that there are two equivalent characterizations of the Gray-Wyner region, one defined in terms of conditional rate-distortion functions in Theorem 1 and the other defined solely in terms of (conditional) mutual information quantities in (13). For the lossless Gray-Wyner problem [3], the two regions are exactly the same. The tilted information densities derived based on these two regions are subtly different. We find that the tilted information density derived from the second region in (13) is more amenable to subsequent second-order analyses on the Pangloss plane (Lemma 6). Thus the "correct" nonasymptotic fundamental quantity for the lossy Gray-Wyner problem is the tilted information density we identified based on the second Gray-Wyner region in (26).

Next, we show that the tilted information density for lossy Gray-Wyner source coding has properties similarly like [30, Properties 1-3] and [3, Lemma 1].
Lemma 2. The tilted information density $\jmath_{X Y}\left(x, y \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, P_{X Y}\right)$ has the following properties:

The proof of Lemma 2 is similar to [3, Lemma 1], [31, Lemma 1] and is provided in Appendix A.
In the following lemma, we relate the derivative of the minimum common rate function with the tilted information density where notation $\Gamma$ is defined in Section II-A (See also [3]). For any $Q_{X Y}$, let $Q_{W \mid X Y}^{*} Q_{\hat{X} \mid X W}^{*} Q_{\hat{Y} \mid Y W}^{*}$ be the optimal test channel for $\mathrm{R}_{0}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid \Gamma\left(Q_{X Y}\right)\right)$ (see (21)). Let $Q_{W}^{*}, Q_{\hat{X} \mid W}^{*}, Q_{\hat{Y} \mid W}^{*}$ be the corresponding induced distributions.
Lemma 3. Suppose that for all $Q_{X Y}$ in some neighborhood of $P_{X Y}, \operatorname{supp}\left(Q_{W}^{*}\right) \subset \operatorname{supp}\left(P_{W}^{*}\right), \operatorname{supp}\left(Q_{\hat{X} \mid W}^{*}\right) \subset \operatorname{supp}\left(P_{\hat{X} \mid W}^{*}\right)$ and $\operatorname{supp}\left(Q_{\hat{Y} \mid W}^{*}\right) \subset \operatorname{supp}\left(P_{\hat{X} \mid W}^{*}\right)$. Then for $i \in[1: m-1]$,

where $\jmath_{X Y}\left(i \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \Gamma\left(P_{X Y}\right)\right)$ is short for $\jmath_{X Y}\left(x_{i}, y_{i} \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \Gamma\left(P_{X Y}\right)\right)$ where $P_{X Y}\left(x_{i}, y_{i}\right)=\Gamma_{i}\left(P_{X Y}\right)$, and similarly for $\jmath_{X Y}\left(m \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \Gamma\left(P_{X Y}\right)\right)$.

The proof of Lemma 3 is similar to the proof in [3, Lemma 3] and [32, Theorem 2.2] and provided in Appendix B. In particular, we need to re-parametrize probability distributions on the simplex as in [3, Lemma 3].

## C. Main Result

Given a particular rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right) \in \mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$, we impose the following conditions:
(i) $R_{0}^{*}=\mathrm{R}_{0}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ is positive and finite;
(ii) For $i=1,2, \lambda_{i}$ in (22) and $\gamma_{i}^{*}$ in (23) are well-defined and positive;
(iii) $\left(R_{1}, R_{2}, Q_{X Y}\right) \mapsto \mathrm{R}_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid Q_{X Y}\right)$ is twice differentiable in the neighborhood of $\left(R_{1}^{*}, R_{2}^{*}, P_{X Y}\right)$ and the derivative is bounded (i.e., the spectral norm of the Hessian matrix is bounded).
Let the rate-dispersion function [8] be

Theorem 4. Under conditions (i) to (iii), the optimal second-order $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \epsilon\right)$ coding region is

We observe that the rate-dispersion function $\mathrm{V}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ is a fundamental quantity that governs the speed of convergence of the rates of optimal code to the rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$. Theorem 4 is proved in Section IV.

Remark 1. To obtain the corresponding results for $D_{1}=0$ or $D_{2}=0$, we need to define the conditional $D_{i}$-tilted information densities (cf. (24) and (25)) when $D_{i}=0$ (cf. [8, Remark 1]). Define $\jmath\left(x, D_{1} \mid w\right):=-\log P_{X \mid W}^{*}(x \mid w)$ when $D_{1}=0$. Similarly, define $\jmath\left(y, D_{2} \mid w\right):=-\log P_{Y \mid W}^{*}(y \mid w)$ when $D_{2}=0$. Combining the techniques used in this paper and the lossless case in [3], it is not hard to verify that Theorem 4 is still valid when $D_{1}=0$ and/or $D_{2}=0$.

## D. On the Pangloss Plane for the Lossy Gray-Wyner Problem

In general, it is not easy to calculate $\mathcal{L}\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \epsilon\right)$. Here we consider calculating $\mathcal{L}\left(R_{0}, R_{1}, R_{2}, D_{1}, D_{2}, \epsilon\right)$ for a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$ on the Pangloss plane [2]. It is shown in Theorem 6 in [2] that $\left(R_{0}, R_{1}, R_{2}\right)$ is $\left(D_{1}, D_{2}\right)$-achievable if

where $R_{X Y}\left(P_{X Y}, D_{1}, D_{2}\right)$ is joint rate-distortion function and $R_{X}\left(P_{X}, D_{1}\right), R_{Y}\left(P_{Y}, D_{2}\right)$ are rate-distortion functions [25], i.e.,

The condition in (32) is called the Pangloss bound since the optimal performance is obtained when the receivers cooperate. The set of $D_{1}, D_{2}$-achievable rate triplets $\left(R_{0}, R_{1}, R_{2}\right)$ satisfying $R_{0}+R_{1}+R_{2}=R_{X Y}\left(P_{X Y}, D_{1}, D_{2}\right)$ is called the Pangloss plane, denoted as $\mathcal{R}_{\mathrm{pg}}\left(D_{1}, D_{2} \mid P_{X Y}\right)$, i.e.,

Let $P_{\hat{X} \hat{Y} \mid X Y}^{*}$ be the optimal conditional distribution achieving $R_{X Y}\left(P_{X Y}, D_{1}, D_{2}\right)$. Let $P_{\hat{X} \hat{Y}}^{*}$ be induced by $P_{\hat{X} \hat{Y} \mid X Y}^{*}$ and $P_{X Y}$. Define the joint $\left(D_{1}, D_{2}\right)$-tilted information density as

The proof of Lemma 5 is provided in Appendix C. Lemma 5 can be proved in a similar manner as [3, Lemma 1] and [33, Lemma 1.4]. By considering a fixed rate triplet on the Pangloss plane, we can relate $\jmath_{X Y}\left(x, y \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, P_{X Y}\right)$ to $\imath_{X Y}\left(x, y \mid D_{1}, D_{2}, P_{X Y}\right)$.
Lemma 6. When $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right) \in \mathcal{R}_{\mathrm{pg}}\left(D_{1}, D_{2} \mid P_{X Y}\right)$ and $R_{0}^{*}>0$,

We defer the proof of Lemma 6 to Appendix D. The proof of Lemma 6 invokes Lemma 2. Besides, we use an idea from [5] in which it was shown that the following Markov chains hold for the optimal test channels $P_{W \mid X Y}^{*}$ achieving
$\mathcal{R}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ and $P_{\hat{X} \mid X W}^{*}$ as well as $P_{\hat{Y} \mid Y W}^{*}$ achieving conditional rate-distortion functions $R_{X \mid W}\left(P_{X W}^{*}, D_{1}\right)$ and $R_{Y \mid W}\left(P_{Y W}^{*}, D_{2}\right):$

Invoking Lemma 6, for a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$ on the Pangloss plane, we can significantly simplify the calculation of $\mathcal{L}\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, \epsilon\right)$.
Proposition 7. When $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right) \in \mathcal{R}_{\mathrm{pg}}\left(D_{1}, D_{2} \mid P_{X Y}\right)$ and the conditions in Theorem 4 are satisfied, we have

Remark 2. To obtain the corresponding results for $D_{1}=0$ or $D_{2}=0$, we need to define the joint $\left(D_{1}, D_{2}\right)$-tilted information density correspondingly. Define

Combining the techniques used in this paper and the lossless case in [3], it is not hard to verify that Proposition 7 is still valid when $D_{1}=0$ and/or $D_{2}=0$. We provide a justification for $D_{1}=0$ and $D_{2}>0$ in Appendix $E$.

## E. A Numerical Example for Boundary Points on the Pangloss Plane

We consider a doubly symmetric binary source (DSBS), where $\mathcal{X}=\mathcal{Y}=\{0,1\}, P_{X Y}(0,0)=P_{X Y}(1,1)=\frac{1-p}{2}$ and $P_{X Y}(0,1)=P_{X Y}(1,0)=\frac{p}{2}$ for $p \in\left[0, \frac{1}{2}\right]$. We consider $\hat{\mathcal{X}}=\hat{\mathcal{Y}}=\{0,1\}$ and Hamming distortion for both sources, i.e., $d_{X}(x, \hat{x})=1\{x=\hat{x}\}$ and $d_{Y}(y, \hat{y})=1\{y=\hat{y}\}$. Under this setting, we consider $R_{1}=R_{2}=R$ and $D_{1}=D_{2}=D$. Denote $h(\delta)=-\delta \log (\delta)-(1-\delta) \log (1-\delta)$ as the binary entropy function and define $f(x):=-x \log x$. Define $p_{1}:=\frac{1}{2}-\frac{1}{2} \sqrt{1-2 p}$. From Exercise 2.7.2 in [34], we obtain

When $D \leq p_{1}$, the joint $(D, D)$-tilted information density is

For $p=0.48$ and $D=0.15$, we plot $R_{\text {sum }}(n)$ in Figure 3 for $\epsilon=0.01$ and $\epsilon=0.99$ where the blue line corresponds to the first-order sum rate $R_{0}^{*}+R_{1}^{*}+R_{2}^{*}$. This figure demonstrates the convergence of an approximation of the finite blocklength fundamental limit to the first-order fundamental limit.

## IV. Proof of Second-Order Asymptotics (Theorem 4)

## A. Achievability Proof

In this part, we first prove that for any given joint type $Q_{X Y} \in \mathcal{P}_{n}(\mathcal{X} \times \mathcal{Y})$, there exists an $\left(n, M_{0}, M_{1}, M_{2}\right)$-code such that the excess-distortion probability is mainly due to the incorrect decoding of side information $W$. To do so, we present a novel type covering lemma for discrete lossy Gray-Wyner problem. Using this result, we then prove an upper bound of the excess-distortion probability for the $\left(n, M_{0}, M_{1}, M_{2}\right)$-code. Finally, we establish the achievable second-order coding region by estimating this probability.

Define four constants

We begin by presenting a type covering lemma that is suited to the needs of second-order analysis for the lossy Gray-Wyner problem.

The proof of Lemma 8 is given in Appendix F. Lemma 8 is proved by combining a few ideas from the literature: a type covering lemma for the conditional rate-distortion problem (modified from Lemma 4.1 in [26] for the standard ratedistortion problem and Lemma 8 in [11] for the successive refinement problem), a type covering lemma for the common side information for the Gray-Wyner problem (Lemma 4 in [3]) and finally, a uniform continuity lemma for the conditional rate-distortion function (modified from [11], [24]).

The proof of Lemma 8 adopts similar idea as the proof of the first-order coding region [2]. The main idea is that we first send the common information via the common link carry $S_{0}$ and then we consider two conditional rate-distortion problems on the two private links carrying $S_{1}, S_{2}$ using the common information as the side information.

Invoking Lemma 8 , we show that there exists an $\left(n, M_{0}, M_{1}, M_{2}\right)$-code whose excess-distortion probability can be upper bounded as follows. Recall the definitions of $c_{0}^{\prime}$ in (59), $c_{1}$ in (60) and $c_{2}$ in (61). Define three rates

From the conditions in Theorem 4, we conclude that $\mathrm{T}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}\right)$ is finite. Therefore, if $\left(L_{0}, L_{1}, L_{2}\right)$ satisfies

## B. Converse Proof

In this part, we prove an outer bound for the second-order region under conditions stated in Theorem 4 . We follow the method in [3] closely. First, we invoke the strong converse in [4] to establish a type-based strong converse. Second, we prove a lower bound on excess-distortion probability $\epsilon_{n}\left(D_{1}, D_{2}\right)$ by using the type-based strong converse. Finally, we use Taylor expansion and apply Berry-Esseen Theorem to obtain a outer region expressed essentially using $\mathrm{V}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$, i.e., the variance of $\jmath_{X Y}\left(X, Y \mid R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}, P_{X Y}\right)$ for a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right)$.

We now consider an $\left(n, M_{0}, M_{1}, M_{2}\right)$-code for the correlated source $\left(X^{n}, Y^{n}\right)$ with joint distribution $U_{\mathcal{T}_{Q_{X Y}}}\left(x^{n}, y^{n}\right)=$ $\left|\mathcal{T}_{Q_{X Y}}\right|^{-1}$, the uniform distribution over the type class $\mathcal{T}_{Q_{X Y}}$.

The proof of Lemma 10 is given in Appendix K. The proof of Lemma 10 is similar to [3, Lemma 6] but we need to also combine this with the (weak) converse proof for lossy Gray-Wyner problem under the expected distortion criterion in [2]. See Definition 2.

We then prove a lower bound on the excess-distortion probability $\epsilon_{n}\left(D_{1}, D_{2}\right)$ in (14). Define the constant $c=\frac{|\mathcal{X}| \cdot|\mathcal{Y}|+2}{n}$ and the three quantities

Since $\mathcal{R}\left(D_{1}, D_{2} \mid Q_{X Y}\right)$ is closed, this means that $\mathrm{R}_{0}\left(R_{1}, R_{2}, D_{1}, D_{2} \mid Q_{X Y}\right) \geq R_{0}+\delta$ for some $\delta>0$. By invoking the strong converse for the lossy Gray-Wyner problem [4], we obtain that

## VI. Moderate Deviations Analysis

In this section, we define the moderate deviations constant and present the main results as well as the proof. Fix a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right) \in \mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$.

Definition 6 (Moderate Deviations Constant). Consider any correlated source with joint probability mass function $P_{X Y}$ and any positive sequence $\left\{\rho_{n}\right\}_{n=1}^{\infty}$ satisfying

A number $\nu \geq 0$ is said to be a $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2}\right)$-achievable moderate deviations constant (with respect to $\left\{\rho_{n}\right\}_{n=1}^{\infty}$ ) if there exists a sequence of ( $n, M_{0}, M_{1}, M_{2}$ )-codes such that

Theorem 13. Given a rate triplet $\left(R_{0}^{*}, R_{1}^{*}, R_{2}^{*}\right) \in \mathcal{R}\left(D_{1}, D_{2} \mid P_{X Y}\right)$ satisfying $\mathrm{V}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)>0$ and the conditions in Theorem 4, the moderate deviations constant is

We observe that similarly to second-order asymptotics (Theorem 4), the rate-dispersion function $\mathrm{V}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)$ is a fundamental quantity that governs the speed of convergence of the excess-distortion probability to zero.

The proof of Theorem 13 can be done in similar manner as [22] using Euclidean information theory [23]. Here we provide an alternative (and more direct) proof using the moderate deviations principle/theorem. See Dembo and Zeitouni [28, Theorem 3.7.1].

We bound the term in (135) at the end of this section. We show that this term is of the same order as that in (131). Hence, the moderate deviations constant is lower bounded by $\theta^{2} \log e /\left(2 \mathrm{~V}\left(R_{1}^{*}, R_{2}^{*}, D_{1}, D_{2} \mid P_{X Y}\right)\right)$.

## B. Converse

Recall the definitions of $R_{i, n}$ in (124) for $i=0,1,2$. To prove the converse part, we first define

Note that this calculation applies to both (135) and (144). This completes the proof.

## VII. CONCLUSION

In this paper, we derived the second-order coding region, the error exponent and moderate deviations constant for the discrete lossy Gray-Wyner problem under mild conditions on the source. In general, it is not easy to calculate the second-order coding region but we provide an example where the second-order region calculation can be simplified. The proofs make use of a novel type covering lemma that is suited to the discrete lossy Gray-Wyner problem. We also establish new results on the uniform continuity of conditional rate-distortion function that may be of independent interest elsewhere. We hope the solution to this problem may lead to the solution of second-order regions for other multi-terminal lossy source coding problems [9], [25].

In the future, we aim to solve for the second-order asymptotics of the lossy Gray-Wyner problem with correlated Gaussian sources and the quadratic distortion measure [2, Example 2.5(B)]. Lastly, we hope to derive the exact asymptotics for this problem [38], [39].

\Lambda\left(x, y \mid P_{\hat{X} \hat{Y}}^{*}, \nu_{1}^{*}, \nu_{2}^{*}\right)=\log \frac{P_{\hat{X} \hat{Y} \mid X Y}^{*}(\hat{x}, \hat{y} \mid x, y)}{P_{\hat{X} \hat{Y}}^{*}(\hat{x}, \hat{y})}+\nu_{1}^{*}\left(d_{X}(x, \hat{X})-D_{1}\right)-\nu_{2}^{*}\left(d_{Y}(y, \hat{Y})-D_{2}\right) \tag{200}
\end{equation*}

Note that $\imath_{X Y}\left(x, y \mid D_{1}, D_{2}, P_{X Y}\right)=\Lambda\left(x, y \mid P_{\hat{X} \hat{Y}}^{*}, \nu_{1}^{*}, \nu_{2}^{*}\right)$. The proof is now complete.

Let $P_{X W}^{*}$ be the joint distribution induced by $Q_{X Y}$ and $P_{W \mid X Y}^{*}$. Note that $R_{1} \geq R_{X \mid W}\left(P_{X W}^{*}, D_{1}\right)$ and $R_{2} \geq R_{Y \mid W}\left(P_{Y W}^{*}, D_{2}\right)$. Lemma 15 shows that there exists a conditional type $Q_{W \mid X Y}$ such that for every $(x, y, w)$ with $Q_{X Y}(x, y) P_{W \mid X Y}^{*}(w \mid x y)>0$,

Define the set of source sequences in $\mathcal{X}^{n}$ that are not $D_{1}$-covered by the codebook $\mathcal{Z}^{M_{1}}\left(w^{n}\right)$ as

& \leq \exp \left(-M_{1}(n+1)^{-|\mathcal{X}| \cdot|\mathcal{W}| \cdot \mid \hat{\mathcal{X} \mid}} \exp \left(-n I\left(Q_{X \mid W}, Q_{\hat{X} \mid X W} \mid Q_{W}\right)\right)+n H\left(Q_{X \mid W} \mid Q_{W}\right)\right) \tag{232}

\frac{1}{n} \log \left|\mathcal{B}_{\hat{X}}\left(w^{n}\right)\right| & \leq I\left(Q_{X \mid W}, Q_{\hat{X} \mid X W}^{*} \mid Q_{W}\right)+\frac{(3|\mathcal{X}| \cdot|\mathcal{W}| \cdot|\hat{\mathcal{X}}|+4) \log n}{n}  \tag{237}\\
& =R_{X \mid W}\left(Q_{X W}, D_{1}^{*}\right)+\frac{(3|\mathcal{X}| \cdot|\mathcal{W}| \cdot|\hat{\mathcal{X}}|+4) \log n}{n} \tag{238}
\end{align*}
$$

The next step to prove Lemma 8 is to bound the difference between $R_{X \mid W}\left(Q_{X W}, D_{1}^{*}\right)$ and $R_{X \mid W}\left(Q_{X W}, D_{1}\right)$.

& \leq R_{1}+\left(\frac{11 \bar{d}_{X}}{\underline{d}_{X}}|\mathcal{X}| \cdot|\mathcal{Y}| \cdot|\mathcal{W}|+3|\mathcal{X}| \cdot|\mathcal{W}| \cdot|\hat{\mathcal{X}}|+5\right) \frac{\log n}{n} \tag{250}
\end{align*}

where (248) follows from (238) and (239).
We now present the proofs of Lemmas 16 and 18.

## J. Proof of Lemma 9

Set $\left(R_{0}, R_{1}, R_{2}\right)=\left(R_{0, n}, R_{1, n}, R_{2, n}\right)$. We achieve the excess-distortion probability by considering the following coding scheme. Given $\left(x^{n}, y^{n}\right)$, the encoder 0 first calculates the joint type $Q_{X Y}$ and transmits the type using at most $|\mathcal{X}| \cdot|\mathcal{Y}| \log (n+1)$ bits. Then, encoder 0 finds the optimal test channel $P_{W \mid X Y}^{*}\left(Q_{X Y}\right)$ which achieves $\mathrm{R}_{0}\left(R_{0, n}, R_{1, n}, D_{1}, D_{2} \mid Q_{X Y}\right)$ and chooses a conditional distribution $Q_{W \mid X Y}$ satisfying Lemma 8 for test channel $P_{W \mid X Y}^{*}\left(Q_{X Y}\right)$. If there is no such optimal test channel $P_{W \mid X Y}^{*}\left(Q_{X Y}\right)$, the system declares an error. Given conditional type $Q_{W \mid X Y}$, the encoder 0 choose a set $\mathcal{C}_{n} \subset \mathcal{T}_{Q_{W}}$ satisfying properties in Lemma 8 with $\left(R_{1}, R_{2}\right)$ replaced by $\left(R_{1, n}, R_{2, n}\right)$. Note that the choice of $\mathcal{C}_{n}$ and mapping function $\phi_{0}$ are known by all the encoders and decoders. If $\log \left|\mathcal{C}_{n}\right|>\log M_{0}-|\mathcal{X}| \cdot|\mathcal{Y}| \log (n+1)$, the encoder 0 declares an error directly, otherwise sends $w^{n} \in \mathcal{C}_{n}$. From Lemma 8 , we know that $\left(x^{n}, y^{n}, w^{n}\right) \in \mathcal{T}_{Q_{X Y W}}$ where $Q_{X Y W}$ is induced by $Q_{X Y}$ and $Q_{W \mid X Y}$. Hence, we obtain $x^{n} \in \mathcal{T}_{Q_{X \mid W}}\left(w^{n}\right)$ and $y^{n} \in \mathcal{T}_{Q_{Y \mid W}}\left(w^{n}\right)$. According to Lemma 8, there exist sets $\mathcal{B}_{\hat{X}}\left(w^{n}\right)$ and $\mathcal{B}_{\hat{Y}}\left(w^{n}\right)$ satisfying that for each $\left(x^{n}, y^{n}\right)$, there exist $\hat{x}^{n} \in \mathcal{B}_{\hat{X}}\left(w^{n}\right)$ and $\hat{y}^{n} \in \mathcal{B}_{\hat{Y}}\left(w^{n}\right)$ with $d_{X}\left(x^{n}, \hat{x}^{n}\right) \leq D_{1}$ and $d_{Y}\left(y^{n}, \hat{y}^{n}\right) \leq D_{2}$. Therefore, encoder 1 sends $\hat{x}^{n} \in \mathcal{B}_{\hat{X}}\left(w^{n}\right)$ such that $\hat{x}^{n}$ minimizes $d_{X}\left(x^{n}, \hat{x}^{n}\right)$ and encoder 2 sends $\hat{y}^{n} \in \mathcal{B}_{\hat{Y}}\left(w^{n}\right)$ such that $\hat{y}^{n}$ minimizes $d_{Y}\left(y^{n}, \hat{y}^{n}\right)$. Invoking Lemma 8 , the size of $\mathcal{B}_{\hat{X}}\left(w^{n}\right)$ and $\mathcal{B}_{\hat{Y}}\left(w^{n}\right)$ are upper bounded by

The excess-distortion event occurs only if $\log \left|\mathcal{C}_{n}\right|>\log M-|\mathcal{X}| \cdot|\mathcal{Y}| \log (n+1)$ or $\mathrm{R}_{0}\left(R_{1, n}, R_{2, n}, D_{1}, D_{2} \mid Q_{X Y}\right)$ is not achieved by any test channel, which means $\mathrm{R}_{0}\left(R_{1, n}, R_{2, n}, D_{1}, D_{2} \mid Q_{X Y}\right)=\infty$. Hence, according to Lemma 8 , the excess-distortion probability is upper bounded as in (68).

\mathbb{E}\left[d_{Y}\left(Y^{n}, \hat{Y}^{n}\right)\right] \leq D_{2}+\frac{\bar{d}_{Y}}{n}:=D_{2, n} \tag{353}
\end{equation*}
$$

Then we can follow the weak converse argument to lower bound ( $M_{0}, M_{1}, M_{2}$ ) as follows. Denote the encoded message from encoder $i$ as random variable $S_{i}$, i.e., $S_{i}=\phi_{i}\left(X^{n}, Y^{n}\right)$. In the following, all information densities are according to $Q_{\mathcal{T}_{Q_{X Y}}}$. Following similar steps as (134)-(142) in [3], we obtain

$$
\begin{equation*}
\log M_{0} \geq n\left(I\left(X_{J}, Y_{J} ; J, W_{J}\right)-\left(H\left(X_{J} Y_{J}\right)-\frac{1}{n} H\left(X^{n} \mid Y^{n}\right)\right)\right) \tag{354}
\end{equation*}
$$

where $W_{i}=\left(S_{0}, X^{i-1}, Y^{i-1}\right)$ and $J$ is uniformly distributed on $\{1, \ldots, n\}$ which is independent of all other random variables. Modifying the "weak converse" proof in [2] in a similar manner as [3], we obtain

$$
\begin{align*}
\log M_{1} & \geq H\left(\hat{X}^{n} \mid S_{0}\right)  \tag{355}\\
& \geq I\left(X^{n} ; \hat{X}^{n} \mid S_{0}\right)  \tag{356}\\
& =\sum_{i=1}^{n} I\left(X_{i} ; \hat{X}^{n} \mid S_{0}, X^{i-1}\right)  \tag{357}\\
& \geq \sum_{i=1}^{n} I\left(X_{i} ; \hat{X}_{i} \mid S_{0}, X^{i-1}\right)  \tag{358}\\
& =\sum_{i=1}^{n} I\left(X_{i} ; \hat{X}_{i} \mid V_{i}\right)  \tag{359}\\
& \geq \sum_{i=1}^{n} R_{X_{i} \mid V_{i}}\left(Q_{X_{i} V_{i}}, D_{1, n}\right)  \tag{360}\\
& =\sum_{i=1}^{n} R_{X_{i} \mid W_{i}}\left(Q_{X_{i} W_{i}}, D_{1, n}\right)  \tag{361}\\
& =n R_{X_{J} \mid W_{J}, J}\left(Q_{X_{J} W_{J}}, D_{1, n}\right) \tag{362}
\end{align*}
$$

where $V_{i}=\left(S_{0}, X^{i-1}\right)$, (356) holds since $\hat{X}^{n}$ is a function of $S_{0}$ and $S_{1}$ and given $S_{0}=s_{0}, H\left(\hat{X}^{n} \mid S_{0}=s_{0}\right) \leq \log M_{1}$ [2] and (360) follows from the definition of the conditional rate-distortion function (that it is a minimization of the conditional mutual information). Similarly, we obtain

\log M_{2} \geq n R_{Y_{J} \mid W_{J}, J}\left(Q_{Y_{J} W_{J}}, D_{2, n}\right) \tag{363}
\end{equation*}
$$

According to [4], there exists $P_{W \mid X_{J} Y_{J}}$ such that $|\mathcal{W}| \leq|\mathcal{X}| \cdot|\mathcal{Y}|+2$ and

$$
\begin{align*}
I\left(X_{J}, Y_{J} ; J, W_{J}\right) & \geq I\left(X_{J}, Y_{J} ; W\right)  \tag{364}\\
R_{X_{J} \mid W_{J}, J}\left(P_{X_{J} W_{J}}, D_{1, n}\right) & \geq R_{X_{J} \mid W}\left(P_{X_{J} W}, D_{1, n}\right)  \tag{365}\\
R_{Y_{J} \mid W_{J}, J}\left(P_{Y_{J} W_{J}}, D_{2, n}\right) & \geq R_{Y_{J} \mid W}\left(P_{Y_{J} W}, D_{2, n}\right) \tag{366}
\end{align*}
$$

Following equations (155)-(167) in [3], we obtain that $P_{X_{J} Y_{J}}(a, b)=Q_{X Y}(a, b)$, and there exists $Q_{W \mid X Y}$ such that $|\mathcal{W}| \leq$ $|\mathcal{X}| \cdot|\mathcal{Y}|+2$ and

$$
\begin{align*}
I\left(X_{J}, Y_{J} ; W\right) & =I(X, Y ; W)  \tag{367}\\
R_{X_{J} \mid W}\left(P_{X_{J} W}, D_{1, n}\right) & =R_{X \mid W}\left(Q_{X W}, D_{1, n}\right)  \tag{368}\\
R_{Y_{J} \mid W}\left(P_{Y_{J} W}, D_{2, n}\right) & =R_{Y \mid W}\left(Q_{Y W}, D_{2, n}\right) \tag{369}
\end{align*}
$$

and

$$
\begin{align*}
\left|H\left(X_{J} Y_{J}\right)-\frac{1}{n} H\left(X^{n} \mid Y^{n}\right)\right| & \leq \frac{|\mathcal{X}| \cdot|\mathcal{Y}| \log (n+1)}{n}+(\alpha+\beta)  \tag{370}\\
& \leq \frac{(|\mathcal{X}| \cdot|\mathcal{Y}|+1) \log (n+1)}{n}+\alpha \tag{371}
\end{align*}
$$

where (371) follows from that $\beta=\frac{\log n}{n}<\frac{\log (n+1)}{n}$.
Invoking (352), (353) and Lemma 18, we obtain

$$
\begin{equation*}
R_{X \mid W}\left(Q_{X W}, D_{1}\right)-R_{X \mid W}\left(Q_{X W}, D_{1, n}\right) \leq \frac{\log n}{n} \tag{372}
\end{equation*}
$$

when $\log n \geq \bar{d}_{X} \log |\mathcal{X}|$, and

$$
\begin{equation*}
R_{Y \mid W}\left(Q_{Y W}, D_{2}\right)-R_{X \mid W}\left(Q_{Y W}, D_{2, n}\right) \leq \frac{\log n}{n} \tag{373}
\end{equation*}
$$

when $\log n \geq \bar{d}_{Y} \log |\mathcal{Y}|$.
Therefore, invoking (362), (365), (368) and (372), we conclude that

$$
\begin{equation*}
\log M_{1} \geq n R_{X \mid W}\left(Q_{X W}, D_{1}\right)-\frac{\log n}{n} \tag{374}
\end{equation*}
$$

when $\log n \geq \bar{d}_{X} \log |\mathcal{X}|$, and similarly, we obtain

$$
\begin{equation*}
\log M_{2} \geq n R_{X \mid W}\left(Q_{Y W}, D_{2}\right)-\frac{\log n}{n} \tag{375}
\end{equation*}
$$

when $\log n \geq \bar{d}_{Y} \log |\mathcal{Y}|$.
The proof of Lemma 10 is now complete.

## L. Proof of Lemma 11

Invoking Lemma 10 by setting $\alpha=\frac{\log n}{n}$, we obtain that if $\left(R_{0, n}, R_{1, n}, R_{2, n}\right) \notin \mathcal{R}\left(D_{1}, D_{2} \mid Q_{X Y}\right)$,

\operatorname{Pr}\left(d_{X}\left(X^{n}, \hat{X}^{n}\right) \leq D_{1}, d_{Y}\left(Y^{n}, \hat{Y}^{n}\right) \leq D_{2} \mid\left(X^{n}, Y^{n}\right) \in \mathcal{T}_{Q_{X Y}}\right)<\exp (-\log n)=\frac{1}{n} \tag{376}
\end{equation*}
$$

or equivalently

$$
\begin{equation*}
\operatorname{Pr}\left(d_{X}\left(X^{n}, \hat{X}^{n}\right)>D_{1}, \text { or } d_{Y}\left(Y^{n}, \hat{Y}^{n}\right)>D_{2} \mid\left(X^{n}, Y^{n}\right) \in \mathcal{T}_{Q_{X Y}}\right) \geq 1-\frac{1}{n} \tag{377}
\end{equation*}
$$

Note that when $\left(X^{n}, Y^{n}\right) \in \mathcal{T}_{Q_{X Y}}$, each sequence has the same probability. Hence, the probability in (376) and (377) is calculated with respect to uniform distribution over the type class $\mathcal{T}_{Q_{X Y}}$. Hence,

\begin{align*}
\epsilon_{n}\left(D_{1}, D_{2}\right)= & \sum_{\left(x^{n}, y^{n}\right)} P_{X Y}^{n}\left(x^{n}, y^{n}\right) 1\left\{d_{X}\left(x^{n}, \hat{x}^{n}\right)>D_{1} \text { or } d_{Y}\left(y^{n}, \hat{y}^{n}\right)>D_{2}\right\}  \tag{378}\\
= & \sum_{Q_{X Y} \in \mathcal{P}_{n}(\mathcal{X} \times \mathcal{Y})} \sum_{\left(x^{n}, y^{n}\right) \in \mathcal{T}_{Q_{X Y}}} P_{X Y}^{n}\left(x^{n}, y^{n}\right) 1\left\{d_{X}\left(x^{n}, \hat{x}^{n}\right)>D_{1} \text { or } d_{Y}\left(y^{n}, \hat{y}^{n}\right)>D_{2}\right\}  \tag{379}\\
= & \sum_{Q_{X Y} \in \mathcal{P}_{n}(\mathcal{X} \times \mathcal{Y})} P_{X Y}^{n}\left(\mathcal{T}_{Q_{X Y}}\right) \operatorname{Pr}\left(d_{X}\left(X^{n}, \hat{X}^{n}\right)>D_{1}, \text { or } d_{Y}\left(Y^{n}, \hat{Y}^{n}\right)>D_{2} \mid\left(X^{n}, Y^{n}\right) \in \mathcal{T}_{Q_{X Y}}\right)  \tag{380}\\
\geq & \sum_{\substack{Q_{X Y} \in \mathcal{P}_{n}(\mathcal{X} \times \mathcal{Y}):}} P_{X Y}^{n}\left(\mathcal{T}_{Q_{X Y}}\right) \operatorname{Pr}\left(d_{X}\left(X^{n}, \hat{X}^{n}\right)>D_{1}, \text { or } d_{Y}\left(Y^{n}, \hat{Y}^{n}\right)>D_{2} \mid\left(X^{n}, Y^{n}\right) \in \mathcal{T}_{Q_{X Y}}\right)  \tag{381}\\
\geq & P_{\left(R_{0, n}, R_{1, n}, R_{2, n}\right) \notin \mathcal{R}\left(D_{1}, D_{2} \mid Q_{X Y}\right)} \sum_{\substack{Q_{X Y} \in \mathcal{P}_{n}(\mathcal{X} \times \mathcal{Y}): \\
\geq}} P_{\left.R_{0, n}, R_{1, n}, R_{2, n}\right) \notin \mathcal{R}\left(D_{1}, D_{2} \mid Q_{X Y}\right)}\left(\mathcal{T}_{Q_{X Y}}\right)\left(1-\frac{1}{n}\right)  \tag{382}\\
& \sum_{\left(R_{0, n}, R_{1, n}, R_{2, n}\right) \notin \mathcal{R}\left(D_{1}, D_{2} \mid Q_{X Y}\right)}\left(\mathcal{T}_{Q_{X Y}}\right)-\frac{1}{n}  \tag{383}\\
= & \operatorname{Pr}\left(\left(R_{0, n}, R_{1, n}, R_{2, n}\right) \notin \mathcal{R}\left(D_{1}, D_{2} \mid \hat{T}_{X^{n} Y^{n}}\right)\right)-\frac{1}{n}  \tag{384}\\
= & \operatorname{Pr}\left(R_{0, n}<\mathrm{R}_{0}\left(R_{1, n}, R_{2, n}, D_{1}, D_{2} \mid \hat{T}_{X^{n} Y^{n}}\right)\right)-\frac{1}{n} . \tag{385}
\end{align*}
$$
