# Quasi likelihood analysis of point processes for ultra high frequency data*

#### Abstract

We introduce a point process regression model that is applicable to price models and limit order book models. Hawkes type autoregression in the intensity process is generalized to a stochastic regression to covariate processes. We establish the so-called quasi likelihood analysis, which gives a polynomial type large deviation estimate for the statistical random field. We derive large sample properties of the maximum likelihood type estimator and the Bayesian type estimator when the intensity processes become large under a finite time horizon. There appears non-ergodic statistics. A classical approach is also mentioned.


Key words and phrases: point process, regression, quasi likelihood analysis, maximum likelihood estimator, Bayesian estimator, Hawkes process, price model, limit order book, polynomial type large deviation, statistical random field, convergence of moments.

## 1 Introduction

High-frequency financial data is one of the latest objects to be challenged by the most advanced statistics. Ad hoc descriptive methods often mislead and fail data analysis. For two stochastic processes observed high-frequently and asynchronously, the estimated covariance between them almost vanishes if one applies the realized covariance with a "natural" interpolation method, even if the real covariance

[^0]is not null. Recently it was recognized that the non-synchronicity of sampling schemes, though it is inevitable for real financial data, causes such phenomena generically called the Epps effect. Theory of non-synchronous estimation has been dramatically developing for the last decade and successfully applied to actual data analyses. Market microstructure is another main factor that causes the Epps effect. Remarkable progresses were recently made in volatility estimation problems by proposing effective filters that remove microstructure noises and at the same time treat non-synchronous sampling schemes. Non-synchronicity and microstructure are now the point where theoretical statistics, probability theory and real data analysis are confluent (Epps [11], Malliavin and Mancino [24, 25], Hayashi and Yoshida [13, 14, 15], Voev and Lunde [35], Griffin and Oomen [12], Mykland [27], Zhou [39], Zhang et al. [37, Zhang [38], Podolskij and Better [31], Jacod et al. [18] Christensen et al. [9, Bibinger [5, 6], Ogihara and Yoshida [30], Koike [20, 22, 21, Ogihara [29, 28] among many others).

The very latest issue is modeling of ultra high frequency phenomena by point processes. It enables us to model microstructure itself rather than eliminating it as noise. In ultra high frequency sampling, the central limit theorem does not work and there is no longer Brownian motion as the driving factor of asset prices, differently from the standard mathematical finance. The world of real data is already beyond a standard theory but this is the reality statisticians are confronted with.

Statistical theory of non-synchronous data suggests relativity of time. Theory of lead-lag estimation emerged against this background. When observing two time series, we often find lead-lag between them, namely, one is the leader and the other is the follower. If these series are stock prices, this means the existence of statistical arbitrage. Some developments for high frequency data are in de Jong and Nijman [19], [17] and Abergel and Huss [1].

In this article, we consider a point process regression model that enables us to express nonsynchronicity of observations, lead-lag relation and microstructure. Our model can describe self-exciting/self-correcting effects of the point processes as well as exogenous effects. Non-ergodic statistics is constructed in the QLA (quasi likelihood analysis) framework. The point process regression model has applications to price models and limit order book models.

## 2 Point process regression model

The d-dimensional point process $N^{n}=\left(N^{n, \alpha}\right)_{\alpha \in \mathcal{I}}$ on the interval $I=\left[T_{0}, T_{1}\right], \mathcal{I}=\{1, \ldots, \mathrm{~d}\}$, is assumed to have a d-dimensional intensity process $n \lambda^{n}(t, \theta)$ defined by

\lambda^{n}(t, \theta)=g^{n}(t, \theta)+\int_{\hat{T}_{0}}^{t-} K^{n}(t, s, \theta) d X_{s}^{n}
$$

where $\theta$ is a parameter. The point process $N^{n}$ forms a model whose intensity processes refer to the covariates $g^{n}$ and $K^{n}$ as well as the explanatory process $X^{n} 1$ More precisely, we will work on a stochastic basis $\mathcal{B}=(\Omega, \mathcal{F}, \mathbf{F}, P), \mathbf{F}=\left(\mathcal{F}_{t}\right)_{t \in \hat{I}}$ being a filtration on $(\Omega, \mathcal{F})$, where $\hat{I}=\left[\hat{T}_{0}, T_{1}\right] \supset I$. For each $n \in \mathbb{N}$ and $\theta \in \Theta,\left(g^{n}(t, \theta)\right)_{t \in I}$ is a d-dimensional predictable process, $\left(K^{n}(t, s, \theta)\right)_{s \in\left[\hat{T}_{0}, t\right)}$ is a $\mathrm{d} \times \mathrm{d}_{0}$ matrix-valued optional process for $t \in I, \mathcal{I}_{0}=\left\{1, \ldots, \mathrm{~d}_{0}\right\}$, and $\left(X_{t}^{n}\right)_{t \in \hat{I}}$ is a $\mathrm{d}_{0}$-dimensional $\mathbf{F}$-adapted right-continuous increasing (i.e., non-decreasing) process on $\mathcal{B}$. We will impose conditions that ensure the existence of those stochastic integrals later. The multivariate point process $N^{n}$ is

[^1]compensated by the process $\left(\int_{T_{0}}^{t} n \lambda^{n}(s, \theta) d s\right)_{t \in I}$ when $\theta$ is the true value of the unknown parameter. We will assume that any two elements of $N^{n}$ do not share common jumps. ${ }^{2}$

Applications of point processes to financial data were in Hewlett [16] on the clustered arrivals of buy and sell trades using Hawkes processes, Large [23] on extension by using a fine description of orders, Bowsher [7] on a generalized Hawkes model, and in Bacry et al. [4] on a price model. Chen and Hall [8] investigated the maximum likelihood estimator of a non-stationary self-exciting point process when the intensity goes up.

Obviously, the transaction times of stocks whose occurrence intensities possibly depend on their own or exogenous randomly changing factors can be described by a point process regression model. The point process regression model also applies to micro-scale modeling of the movements of the stock prices, incorporating information of covariate processes.

Recently, point processes are applied to order-book modeling; see Cont et al. [10] and Abergel and Jedidi [2, 3], and also Smith et al. [32]. Abergel and Jedidi [2, 3] presented an order book model by a multivariate point process and proved ergodicity of the system in infinite time horizon by using the drift condition for the Markov chain. Muni Toke and Pomponio [26] gave a model of trades-through in a limited order book using Hawkes processes.

Our point process regression model has finite time horizon and the resulting statistics becomes non-ergodic. We shall give short descriptions of the last two examples, before going into the main part of this article.

### 2.1 Modeling digital movements of stock prices

The point process $N^{n}$ is fairly generic. For ultra high-frequency financial data, we model the movements of the prices $Y_{t}$ by the combination of the components of the multi-variate point process $N^{n}=\left(N^{n, \alpha}\right)_{\alpha \in \mathcal{I}}$, e.g., by

where $A$ is a constant matrix. In the following examples, $N$ denotes $N^{n}$ for notational simplicity.
Example 2.1. ( $\pm$ one-unit jumps) Let $a$ denote a monetary unit. Let

Example 2.2. ( $\pm$ one/two-unit jumps) Let

Example 2.3. (simultaneous jumps) Let

Then

for $N^{n}=\left[N^{0}, \ldots, N^{5}\right]^{\prime}$.
In this way, ultimately, we can assume that our data is described by a multi-variate point process.
Example 2.4. The Hawkes type process is an example if one takes $X_{t}^{n}=n^{-1} N_{t}^{n}$. Our setting also includes the models with $X_{t}^{n}=n^{-1} V_{t}^{n}$ and $X_{t}^{n}=\left(n^{-1} N_{t}^{n}, n^{-1} V_{t}^{n}\right)$ for covariates subordinator $V_{t}^{n}$ like the cumulative volume of the trades.

Example 2.5. An example of the kernel function is $K^{n}(t, s, \theta)=c\left(\theta_{1}, \theta_{2}\right)(t-s)^{\theta_{2}} e^{-\theta_{1}(t-s)}$. This extends the original Hawkes process and it will be important when we discuss the lead-lag estimation in our framework.

### 2.2 Limit oder book

Multivariate point processes give an approach to modeling of the limit order book. For simplicity, we will assume the volumes of limit orders, market orders and cancellation are a common value $q$ for all prices. The state of the limit order book is described by the multi-dimensional process

$$
\mathbb{X}=\left(\left(A^{\alpha}\right)_{\alpha=1, \ldots, k_{A}},\left(B^{\beta}\right)_{\beta=1, \ldots, k_{B}}\right),
$$

where the process $A^{\alpha}$ counts the number of shares available at price $p_{A}^{\alpha}$ at time $t$ on the ask side and the process $B_{t}^{\beta}$ counts the number of shares available at price $p_{B}^{\beta}$ at time $t$ on the bid side. In this modeling, the state space of $\mathbb{X}$ is absolute or fixed. The price $p_{A}^{\alpha}$ may denote a relative quoted price if one defines $p_{A}^{\alpha}$ as the price $\alpha$ ticks away from the best opposite quote, while it is also possible to consider a fixed state space. The random evolution of $\mathbb{X}$ is determined by the processes $M^{A}$ counting number of arrivals of market orders on the ask side, $M^{B}$ of market orders on the bid side, $L^{\alpha}$ of limit orders at level $\alpha$ on the ask side, $L^{\beta}$ of limit orders at level $\beta$ on the bid side, $C^{\alpha}$ of cancellation at level $\alpha$ on the ask side, and $C^{\beta}$ of cancellation at level $\beta$ on the bid side. The multivariate counting process $N^{n}$ consists of these counting processes. Here prices can be recognized as a function of $\mathbb{X}$.

## 3 Quasi likelihood

We shall consider estimation for the unknown parameter $\theta$. Suppose that we have observations

\left(N_{t}^{n, \alpha}\right)_{t \in I, \alpha \in \mathcal{I}}, \quad\left(X_{t}^{n, \beta}\right)_{t \in \hat{I}, \beta \in \mathcal{I}_{0}}, \quad\left(g^{n, \alpha}(t, \theta)\right)_{t \in I, \alpha \in \mathcal{I}, \theta \in \Theta}, \quad\left(K_{\beta}^{n, \alpha}(t, s, \theta)\right)_{t \in I, s \in\left[\hat{T}_{0}, t\right), \alpha \in \mathcal{I}, \beta \in \mathcal{I}_{0}, \theta \in \Theta}
$$

up to $\theta$. This is the case, for example, when $g^{n, \alpha}(t, \theta)$ is a function of $\theta$ and some observable covariate process, that is, $g^{n, \alpha}(t, \theta)=\mathfrak{g}\left(Z_{t}, \theta\right)$ for some observable covariate process $Z_{t}$ and a given function $\mathfrak{g}$. A statistician models the phenomena by the point processes $N^{\alpha}$ with intensity processes $n \lambda^{n, \alpha}(t, \theta)$, choosing a large number $n$. Only the estimated function $n \lambda^{n, \alpha}$, not $\lambda^{n, \alpha}$, makes sense as a result of statistical analysis.

We adopt the quasi log likelihood

$$
l_{n}(\theta)=\sum_{\alpha \in \mathcal{I}}\left(\int_{T_{0}}^{T_{1}} \log \left[n \lambda^{n, \alpha}(t, \theta)\right] d N_{t}^{n, \alpha}-\int_{T_{0}}^{T_{1}}\left[n \lambda^{n, \alpha}(t, \theta)-1\right] d t\right)
$$

for observed point process $N^{n}$. Obviously, " -1 " in the second integral can be eliminated for maximization. The factor " $n$ " in the first integral is also unnecessary. Thus we can use

$$

\ell_{n}(\theta)=\sum_{\alpha \in \mathcal{I}}\left(\int_{T_{0}}^{T_{1}} \log \lambda^{n, \alpha}(t, \theta) d N_{t}^{n, \alpha}-\int_{T_{0}}^{T_{1}} n \lambda^{n, \alpha}(t, \theta) d t\right) \tag{3.1}

instead of $l_{n}(\theta)$. To estimate $\theta$, we will consider the quasi maximum likelihood estimator (QMLE), that is, a sequence of estimators $\hat{\theta}_{n}$ that maximizes or asymptotically maximizes $\ell_{n}(\theta)$. The quasi Bayesian estimator (QBE) is another option, as discussed later.

Hereafter, we suppose that $\Theta$ is a bounded open set in $\mathbb{R}^{\mathbf{p}}$ and satisfies

for some positive constant $a_{0}$, where Leb is the Lebesgue measure. The true value of $\theta$ will be denoted by $\theta^{*}$.

## 4 Quasi maximum likelihood estimator by a classical approach

### 4.1 Consistency of the quasi maximum likelihood estimator

In Section 4.1, we suppose that the function $\Theta \ni \theta \mapsto \lambda^{n}(t, \theta)$ has continuous extension to $\bar{\Theta}$. Let $J=\left\{(t, s) ; s \in\left[\hat{T}_{0}, t\right), t \in I\right\}$. Denote by $\mathfrak{I}$ the set of $\mathbb{R}_{+}$-valued left-continuous non-decreasing adapted processes on $\Omega \times I$.
$[\mathbf{A 1}]_{\bar{j}}$ For each $n \in \mathbb{N}, K^{n}(t, s, \theta)$ is an $\mathbb{R}_{+}^{\mathrm{d}} \otimes \mathbb{R}_{+}^{\mathrm{d}_{0}}$-valued $\mathcal{F} \times \mathbb{B}(J) \times \mathbb{B}(\Theta)$-measurable 3 function satisfying the following conditions.

[^3](i) For each $(n, t, \theta) \in \mathbb{N} \times I \times \Theta$, the process $\left[\hat{T}_{0}, t\right) \ni s \mapsto K^{n}(t, s, \theta)$ is optional on $\Omega \times\left[\hat{T}_{0}, t\right)$, and each path is continuous or has jump discontinuity at every point $s .4$

Remark 4.1. If one assumes separability for random fields on $(t, s, \theta)$ or $(t, \theta)$, it is possible to avoid introducing the envelope processes $\dot{K}^{n}$ etc. However, finding envelope processes is easier than verifying separability involving many intervals of variables.

We do not assume continuity of $K^{\infty}$ in $s$, which is necessary to treat a kernel looking back a finite-length of history.

Remark 4.7. Theorems 4.6 and 4.12 are regarded as generalizations of Theorems 1 and 2 of Chen and Hall [8], respectively. The consistency result given here is asserted for any sequence of quasi maximum likelihood estimator. The limit theorem gives asymptotic mixed normality in a general regression scheme in non-ergodic statistics. Though the treatments are simpler in the classical methods, they are not sufficient to develop advanced themes such as prediction, information criteria and higher-order asymptotic theory. In particular, convergence of the moments of the quasi likelihood estimators or equivalently sharp estimates of tail probability of them is indispensable. The quasi likelihood analysis with the polynomial type large deviation inequalities for statistical random fields will be established in Section 5, the main part of this article. This construction of inferential theory enables us to approach the above mentioned problems. Indeed, the reader can find in [34] and [33] such a flow from non-ergodic statistical inference for volatility to an information criterion for volatility model selection. When the input intensities of the Hawkes type processes are time-varying, the question of non-degeneracy of the statistical model becomes complicated than expected. We will give a sufficient condition for non-degeneracy. Asymptotic properties of the quasi Bayesian estimator will be elucidated as well.

### 4.2 Asymptotic mixed normality of the QMLE: a classical approach

We shall investigate the asymptotic distribution of the QMLE. In Section 4.2, the parameter space $\Theta$ is assumed only to be open without Condition (3.2) because only local properties are discussed.

Under regularity conditions stated later, we have

## 5 The quasi likelihood analysis: QMLE and QBE

In Theorem4.12, we obtained a limit theorem for the quasi maximum likelihood estimator $\hat{\theta}_{n}$. It is the first step of analysis of the estimator, however, more precise estimates for the tail of the distribution of the estimator will be indispensable to develop basic theory of statistical inference such as asymptotic decision theory, prediction, higher-order efficiency, information criteria, etc. This section presents the so-called quasi likelihood analysis, that gives certain tail probability estimates of the quasi maximum likelihood estimator (QMLE) and the quasi Bayesian estimator (QBE).

### 5.1 Polynomial type large deviation inequality for the quasi likelihood random field

We shall work with the statistical random field

Then Condition $\left[\mathrm{A} 4^{\prime}\right]$ of 36 is satisfied. Lemmas 5.1 and 5.2 ensure [A1"] of [36]. Condition [B5] implies Conditions [A2] and [A5] of [36]. Condition [A3] of [36] obviously holds. Condition [A6] of [36] is checked by Lemmas 5.3] and 5.4. Apply Theorem 2 of [36] to obtain the result.

A quasi maximum likelihood estimator is any estimator that satisfies

## 6 Hawkes type processes

In this section, the point process regression model will be applied to a feedback system of point processes. We will consider the explanatory variables $X^{n}=n^{-1} N^{n}$, that is, the the process $\lambda^{n}(t, \theta)$ will be

for $t \in I$. The Hawkes process is a special case of this model. It should be remarked that Hawkes processes are often used to describe ergodic systems in long-run, whereas we will work with non-ergodic processes with finite time horizon and the intensities diverge.

Here a QLA will be formulated according to Section 5. Other formulations are obviously possible under milder assumptions if one applies previous sections. Hereafter, we will consider the case where $g^{n}(t, \theta)=g(t, \theta)$ and $K^{n}(t, s, \theta)=K(t, s, \theta)$ for simplicity of presentation.

Consider the following conditions.

In what follows, we shall discuss a two-dimensional Hawkes type process $N=\left(N_{t}\right)_{t \in[0, T]}$ as an illustrative example. Consider the parametric model of two-dimensional Hawkes process with intensity processes

It is remarked that in practice, we need $n \lambda^{n}(t, \theta)$ to make the function $\ell_{n}(\theta)$, and what is estimated is $n g$, not $g$, for the underlying intensity parameter. The asymptotics about the estimator of the parameter in $g$ is relative in the sense that its value can depends on the value of $n$ the user chooses. However it is rather natural because the baseline intensity is very changeable even interday and possibly randomly changing. There consistent estimation of the baseline intensity has no important meaning. We are rather interested in finding relations between $N^{n}$ and $X^{n}$, and then $g$ serves as a nuisance parameter. In statistical theory, similar treatments of scaling are found in change point problems and in volatility parameter estimation for small diffusions.

At the true values $\theta^{*}=\left(b^{*}, \gamma^{*}, A^{*}\right)$ of the parameters, it has two-dimensional intensity process expressed by

& -A^{*} e^{-t C^{*}} \int_{\hat{T}_{0}}^{t} e^{-b^{*}(t-s)} A^{*} \lambda^{\infty}\left(s, \theta^{*}\right) d s .+e^{-t C^{*}} A^{*} \lambda^{\infty}\left(t, \theta^{*}\right) \\
= & e^{-t C^{*}} \partial_{t} g_{t}^{*}-C^{*} e^{-t C^{*}} g_{t}^{*}+e^{-t C^{*}} A^{*} g_{t}^{*} \\
= & e^{-t C^{*}} \partial_{t} g_{t}^{*}+b^{*} e^{-t C^{*}} g_{t}^{*},
\end{aligned}
$$

which gives the first equality of (6.11). The second equality is due to integration-by-parts. Simple calculus gives (6.12) when $C^{*}$ is invertible and $g_{t}^{*}$ is constant.

Lemma 6.3. Suppose that $b I+C^{*}$ is invertible. Then

$$
\lambda^{\infty}(t, \theta)=g(t, \gamma)+A\left(b-b^{*}\right)\left(b I+C^{*}\right)^{-1} G(-b I)_{t}+A A^{*}\left(b I+C^{*}\right)^{-1} G\left(C^{*}\right)_{t} .
$$

Proof. From (6.3), we have

$$
\begin{aligned}
\lambda^{\infty}(t, \theta) & =g(t, \gamma)+\int_{\hat{T}_{0}}^{t} e^{-b(t-s)} A \lambda^{\infty}\left(s, \theta^{*}\right) d s \\
& =g(t, \gamma)+\int_{\hat{T}_{0}}^{t} e^{-b(t-s)} A\left\{g_{s}^{*}+A^{*} G\left(C^{*}\right)_{s}\right\} d s \\
& =g(t, \gamma)+A G(-b I)_{t}+e^{-b t} \int_{\hat{T}_{0}}^{t} \int_{u}^{t} A A^{*} e^{s\left(b I+C^{*}\right)} e^{-u C^{*}} g_{u}^{*} d s d u \\
& =g(t, \gamma)+A G(-b I)_{t}+e^{-b t} A A^{*} \int_{\hat{T}_{0}}^{t}\left(b I+C^{*}\right)^{-1}\left(e^{t\left(b I+C^{*}\right)}-e^{u\left(b I+C^{*}\right)}\right) e^{-u C^{*}} g_{u}^{*} d u \\
& =g(t, \gamma)+A G(-b I)_{t}+A A^{*}\left(b I+C^{*}\right)^{-1}\left(G\left(C^{*}\right)_{t}-G(-b I)_{t}\right) \\
& =g(t, \gamma)+A\left(b-b^{*}\right)\left(b I+C^{*}\right)^{-1} G(-b I)_{t}+A A^{*}\left(b I+C^{*}\right)^{-1} G\left(C^{*}\right)_{t} .
\end{aligned}
$$

Lemma 6.4. Let $\beta \in \mathbb{R}, v_{1}, v_{2} \in \mathbb{R}^{2}$ and let $B_{1}, B_{2}, C \in M_{2}(\mathbb{R})$. Suppose that $\operatorname{span}\left\{v_{2}, C v_{2}\right\}=\mathbb{R}^{2}$, $\beta I+C$ is invertible, and that

$$
\begin{equation*}
B_{1} e^{-\beta t} v_{1}+B_{2} e^{t C} v_{2}=0 \tag{6.13}
\end{equation*}
$$

for any $t$ in an interval of $\mathbb{R}$. Then $B_{2}=O$ and $B_{1} v_{1}=0$.
Proof. The equation (6.13) holds for all $t \in \mathbb{R}$. Differentiating $B_{1} v_{1}+B_{2} e^{t(\beta I+C)} v_{2}=0$ in $t$, we see $B_{2}(\beta I+C) e^{-t(\beta I+C)} v_{2}=0$ for all $t$. Since span $\left\{v_{2}, e^{-t(\beta I+C)} v_{2}\right\}=\mathbb{R}^{2}$ for small $t>0, B_{2}(\beta I+C)=O$. Therefore $B_{2}=O$ by the invertibility of $\beta I+C$. This entails $B_{1} v_{1}=0$ from (6.13).

Remark 6.5. The claim of Lemma 6.4 is not valid without the invertibility of $\beta I_{2}+C$. For example, the assumptions are satisfied for

$$
C=\left[\begin{array}{cc}
-1 & 0 \\
0 & 1
\end{array}\right], \quad B_{1}=\left[\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right], \quad B_{2}=\left[\begin{array}{cc}
-1 & 0 \\
0 & 0
\end{array}\right], \quad v_{1}=\left[\begin{array}{l}
1 \\
0
\end{array}\right], \quad v_{2}=\left[\begin{array}{l}
1 \\
1
\end{array}\right]
$$

and $\beta=1$. However, $B_{2} \neq O$ and $B_{1} v_{1} \neq 0$.
Suppose that $g_{t}^{*}=g\left(t, \gamma^{*}\right)$ is an $\mathbb{R}^{2}$-valued polynomial in $t$ of degree $p$. Then, for any $M \in \operatorname{GL}\left(\mathbb{R}^{2}\right)$, there exist $\mathbb{R}^{2}$-valued smooth (in $M$ ) mappings $c_{\ell}(M)$ such that

$$
\partial_{s}\left(\sum_{\ell=0}^{p}\left(s-\hat{T}_{0}\right)^{\ell} e^{-\left(s-\hat{T}_{0}\right) M} c_{\ell}(M)\right)=e^{-\left(s-\hat{T}_{0}\right) M} g_{s}^{*} .
$$

Then

$$
\begin{equation*}
G(M)_{t}=\sum_{\ell=0}^{p}\left(t-\hat{T}_{0}\right)^{\ell} c_{\ell}(M)-e^{\left(t-\hat{T}_{0}\right) M} c_{0}(M) \tag{6.14}
\end{equation*}
$$

In particular,

$$
g_{\hat{T}_{0}}^{*}=c_{1}(M)-M c_{0}(M)
$$

and

$$
\partial_{t}^{p+1} G(M)_{t}=-M^{p+1} e^{\left(t-\hat{T}_{0}\right) M} c_{0}(M)
$$

Suppose that $g(t, \gamma)$ is an $\mathbb{R}^{2}$-valued polynomial in $t$ of degree $p$ and that

$$
\begin{equation*}
\lambda^{\infty}(t, \theta)=\lambda^{\infty}\left(t, \theta^{*}\right) \quad(\forall t \in I) \tag{6.15}
\end{equation*}
$$

Differentiating $\lambda^{\infty}(t, \theta)-\lambda^{\infty}\left(t, \theta^{*}\right) \equiv 0(p+1)$-times in $t$ with the expression of $\lambda^{\infty}(t, \theta)$ given in Lemma 6.3, we obtain

$$
\begin{aligned}
& A\left(b-b^{*}\right)\left(b I+C^{*}\right)^{-1}(-1)^{p+2} b^{p+1} e^{-\left(t-\hat{T}_{0}\right) b I} c_{0}(-b I) \\
& \quad-\left(C-C^{*}\right) A^{*}\left(b I+C^{*}\right)^{-1}\left(C^{*}\right)^{p+1} e^{\left(t-\hat{T}_{0}\right) C^{*}} c_{0}\left(C^{*}\right)=0
\end{aligned}
$$

for all $t$.
Let us consider the following condition.
[M] The parametric model admits a continuous extension to $\bar{\Theta}$ and that the following conditions are satisfied on $\bar{\Theta}$ :
(i) $b \neq 0$,
(ii) the matrices $C^{*}$ and $b I+C^{*}$ are invertible,
(iii) $c_{0}(-b I) \neq 0$,
(iv) $c_{0}\left(C^{*}\right)$ is not an eigenvector of $C^{*}$.
(v) $g(t, \gamma)=\sum_{\ell=0}^{p} a_{\ell}(\gamma) t^{\ell}$, and $g$ is identifiable, i.e., $\gamma=\gamma^{*}$ if $g(t, \gamma)=g\left(t, \gamma^{*}\right)$ for all $t \in I$.
(vi) $\inf _{t \in I, \theta \in \bar{\Theta}} g(t, \gamma)>0$.
(vii) The mapping $\gamma \mapsto g(t, \gamma)$ is of class $C^{4}$ with each derivative admitting a continuous extension to $\bar{\Theta}$. Moreover $\sum_{\alpha=1}^{2}\left(\partial_{\gamma} g^{\alpha}\right)^{\otimes 2}\left(t, \gamma^{*}\right)$ is positive definite for some $t \in I$.

Lemma 6.6. Under $[M]$, the matrix $\Gamma$ is positive definite.
Proof. Let $x$ satisfy $x^{\top} \Gamma x=0$. Then it is sufficient to show $x=0$. Condition [M] (vi) in particular ensures $\inf _{t \in I} g\left(t, \gamma^{*}\right)>0$, therefore $\inf _{t \in I} \lambda^{\infty, \alpha}\left(t, \theta^{*}\right)>0$ for $\alpha=1,2$. Thus $\Gamma$ of (4.13) is well defined and we obtain

$$
\begin{equation*}
\partial_{\theta} \lambda^{\infty, \alpha}\left(t, \theta^{*}\right) \cdot x=0 \tag{6.16}
\end{equation*}
$$

for any $t, \alpha$. Simple calculations with the formula in Lemma 6.3 show

$$
\begin{aligned}
\partial_{\gamma} \lambda^{\infty}\left(t, \theta^{*}\right)=\partial_{\gamma} g\left(t, \gamma^{*}\right), \quad \partial_{b} \lambda^{\infty}\left(t, \theta_{*}\right) & =G\left(-b_{*} I\right)_{t}-G\left(C^{*}\right)_{t}, \\
\left(\partial_{A_{\alpha^{\prime}}} \lambda^{\infty, \alpha}, \partial_{A_{\alpha^{\prime}} 2} \lambda^{\infty, \alpha}\right)^{\top}\left(t, \theta^{*}\right) & =\delta_{\alpha, \alpha^{\prime}} G\left(C^{*}\right)_{t}
\end{aligned}
$$

for $1 \leq \alpha, \alpha^{\prime} \leq 2$. Rewriting (6.16) with these expressions, we have

$$
\partial_{\gamma} g\left(t, \gamma^{*}\right) \cdot x_{\gamma}+\left(\begin{array}{ll}
x_{A_{11}} & x_{A_{12}} \\
x_{A_{21}} & x_{A_{22}}
\end{array}\right) G\left(C^{*}\right)_{t}+x_{b}\left(\left(G\left(-b_{*} I\right)_{t}-G\left(C^{*}\right)_{t}\right)=0\right.
$$

for any $t$, where $x=\left(x_{b},\left(x_{A_{\alpha, \alpha^{\prime}}}\right)_{\alpha, \alpha^{\prime}}, x_{\gamma}\right)$. Moreover, by differentiating the both sides of the above equation $p+1$ times with respect to $t$, we obtain

$$
\left(x_{b} I-\left(\begin{array}{ll}
x_{A_{11}} & x_{A_{12}} \\
x_{A_{21}} & x_{A_{22}}
\end{array}\right)\right)\left(C^{*}\right)^{p+1} e^{\left(t-\hat{T}_{0}\right) C^{*}} c_{0}\left(C^{*}\right)+x_{b}(-1)^{p} b^{p+1} e^{-b^{*}\left(t-\hat{T}_{0}\right)} c_{0}\left(-b^{*} I\right)=0
$$

for any $t$. Here the expression (6.14) was used.
Now Lemma 6.4 and [ $M$ ] (i)-(iv) yield $x_{b}=0$ and $x_{A_{\alpha, \alpha^{\prime}}}=0$ for $1 \leq \alpha, \alpha^{\prime} \leq 2$. Therefore $\partial_{\gamma} g\left(t, \gamma^{*}\right) \cdot x_{\gamma}=0$ for any $t$ by (6.16). Then [M] (vii) implies $x_{\gamma}=0$.

Theorem 6.7. Under Condition $[M$, the same results as Theorems 5.6 and 5.7 hold for the Hawkes type model (6.10).

Proof. Under [M] (i)-(v), Lemma 6.4 implies that $C-C^{*}=O$ and that $b-b^{*}=0$ since $A=b I+C=$ $b I+C^{*}$ is invertible and $c_{0}(b I) \neq 0$ as well as $b \neq 0$. Therefore $g(t, \gamma)=g\left(t, \gamma^{*}\right)$ from (6.15), which entails $\gamma=\gamma^{*}$.

Since $\bar{\Theta}$ is compact and $\mathbb{Y}$ has a continuous extension to it, we see from Lemma 6.6 that there exists a positive canstant $c$ such that $\mathbb{Y}(\theta) \leq-c\left|\theta-\theta^{*}\right|^{2}$ for all $\theta \in \Theta$. Therefore Condition [H4] is satisfied, obviously.
Example 6.8. Let us consider a mapping

$$
g(t, \gamma)=\gamma_{1}\left(t-T^{*}\right)^{2}+\gamma_{2}
$$

taking values in $(0, \infty)^{2}$ for $t \in\left[T_{0}, T_{1}\right]$, where $T^{*}=\left(T_{1}+T_{0}\right) / 2$ and $\gamma_{i}(i=1,2)$ are parameters in $(0, \infty)^{2}$. By definition,

$$
\begin{aligned}
& c_{2}(M)=-M^{-1} \boldsymbol{\gamma}_{1}^{*} \\
& c_{1}(M)=2\left(T^{*}-\hat{T}_{0}\right) M^{-1} \boldsymbol{\gamma}_{1}^{*}-2 M^{-2} \boldsymbol{\gamma}_{1}^{*} \\
& c_{0}(M)=-\left(T^{*}-\hat{T}_{0}\right)^{2} M^{-1} \boldsymbol{\gamma}_{1}^{*}-M^{-1} \boldsymbol{\gamma}_{2}^{*}+2\left(T^{*}-\hat{T}_{0}\right) M^{-2} \boldsymbol{\gamma}_{1}^{*}-2 M^{-3} \boldsymbol{\gamma}_{1}^{*} .
\end{aligned}
$$

Then, for $[\mathrm{M}]$ (iii), $c_{0}(-b I) \in(0, \infty)^{2}$ whenever $\beta>0$. Condition $[\mathrm{M}]$ (iv) requires that

$$
c_{0}\left(C^{*}\right)=\left\{-\left(T^{*}-\hat{T}_{0}\right)^{2}\left(C^{*}\right)^{-1}+2\left(T^{*}-\hat{T}_{0}\right)\left(C^{*}\right)^{-2}-2\left(C^{*}\right)^{-3}\right\} \gamma_{1}^{*}-M^{-1} \gamma_{2}^{*}
$$

is not an eigenvector of $C^{*}$.

## 7 Appendix

Proof of Lemma 4.10. In the present situation,

$$
\left\langle L^{n}, L^{n}\right\rangle=\sum_{\alpha} \int_{T_{0}} \int_{\mathrm{E}_{\alpha}} c_{\alpha}^{n, i}(s, x)^{\otimes 2} \nu^{n, \alpha}(d s, d x) .
$$

Therefore, $\left\langle L^{n}, L^{n}\right\rangle_{t} \rightarrow^{p} \int_{T_{0}}^{t} g_{s}^{\otimes 2} d s$ for each $t$.
Let $\mathbf{M}$ be an $\mathbf{F}$-locally square-integrable purely discontinous martingale. For $\epsilon>0$, there is a canonical representation

$$
\mathrm{M}_{t}=B_{t}^{\epsilon}+\mathrm{M}_{t}^{\bar{\epsilon}}+\mathrm{M}_{t}^{\epsilon}
$$

with $\mathrm{M}_{t}^{\epsilon}=\int_{T_{0}}^{t} \int z 1_{\{|z|>\epsilon\}} \mu(d s, d z)$ and $\mathrm{M}_{t}^{\bar{\epsilon}}=\int_{T_{0}}^{t} \int z 1_{\{|z| \leq \epsilon\}}(\mu-\nu)(d s, d z)$, where $B_{t}^{\epsilon}$ is a predictable bounded variational process and $\mu=\mu^{M}$ is the integer-valued random measure of jumps of $M$ and compensated by $\nu$.

Since a sequence of predictable times exhausts the jumps of $B^{\epsilon}$ and $\Delta L_{T}^{n}=0$ for any predictable time $T$ for the quasi-left continuous $L^{n}=\left(L^{n, i}\right)_{i}$, we have $\left[L^{n, i}, B^{\epsilon}\right]=0$. Then the variation

$$
\begin{align*}
\operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]= & \operatorname{Var}\left[L^{n, i}, \mathrm{M}^{\epsilon}\right]+\operatorname{Var}\left[L^{n, i}, \mathrm{M}^{\bar{\epsilon}}\right] \\
\leq & \sum_{s \leq \cdot}\left|\Delta L_{s}^{n, i}\right|\left|\Delta \mathrm{M}_{s}^{\epsilon}\right| 1_{\left\{\left|\Delta \mathrm{M}_{s}^{\epsilon}\right|>\epsilon\right\}}+\left[L^{n, i}, L^{n, i}\right]^{1 / 2}\left[\mathrm{M}^{\bar{\epsilon}}, \mathrm{M}^{\bar{\epsilon}}\right]^{1 / 2} \\
\leq & \sup _{s \leq T_{1}}\left|\Delta L_{s}^{n, i}\right|\left(2 \sup _{s \leq T_{1}}\left|\mathrm{M}_{s}\right|\right) \#\left\{s \leq T_{1} ;\left|\Delta \mathrm{M} \frac{\epsilon}{s}\right|>\epsilon\right\} \\
& +\left[L^{n, i}, L^{n, i}\right]^{1 / 2}\left[\mathrm{M}^{\bar{\epsilon}}, \mathrm{M}^{\bar{\epsilon}}\right]_{T_{1}}^{1 / 2} . \tag{7.1}
\end{align*}
$$

For $\eta>0$,

$$
\begin{aligned}
\sup _{s}\left|\Delta L_{s}^{n}\right|^{2} & \leq \eta^{2}+\sup _{s}\left(\left|\Delta L_{s}^{n}\right|^{2} 1_{\left\{\left|\Delta L_{s}^{n}\right| \geq \eta\right\}}\right) \\
& \leq \eta^{2}+\sum_{\alpha} \int_{T_{0}}^{T_{1}}\left|c_{\alpha}^{n}(s, x)\right|^{2} 1_{\left\{\left|c_{\alpha}^{n}(s, x)\right| \geq \eta\right\}}\left(\mu^{n, \alpha}+\nu^{n, \alpha}\right)(d s, d x)
\end{aligned}
$$

Thus, the Lenglart inequality gives $\sup _{s}\left|\Delta L_{s}^{n}\right| \rightarrow^{p} 0$ as $n \rightarrow \infty$ under (iii).
Moreover, the family

$$
\left[L^{n, i}, L^{n, i}\right]_{T_{1}}=\sum_{\alpha} \int_{T_{0}}^{T_{1}} \int\left|c^{n, \alpha}(s, x)\right|^{2} \mu^{n, \alpha}(d s, d x) \quad(n \in \mathbb{N})
$$

is stochastically bounded due to (ii) and the Lenglart inequality. By definition, $\lim _{\epsilon \downarrow 0}\left[\mathrm{M}^{\bar{\epsilon}}, \mathrm{M}^{\bar{\epsilon}}\right]_{T_{1}}=0$ a.s. These properties applied to (7.1) entail

$$
\begin{equation*}
\operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]_{T_{1}} \rightarrow^{p} 0 \tag{7.2}
\end{equation*}
$$

as $n \rightarrow \infty$.
Since the signed measure $\left\langle L^{n, i}, \mathrm{M}\right\rangle \ll\langle\mathrm{M}, \mathrm{M}\rangle$, there is a predictable process $d\left\langle L^{n, i}, \mathrm{M}\right\rangle / d\langle\mathrm{M}, \mathrm{M}\rangle(t)$ that is a version of the Radon-Nikodym derivative. Define an increasing process $\left\langle L^{n, i}, \mathrm{M}\right\rangle^{+}$by

$$
\left\langle L^{n, i}, \mathrm{M}\right\rangle_{t}^{+}=\int_{T_{0}}^{t} 1_{\left\{\frac{d\left\langle L^{n, i, \mathrm{M}\rangle}(s) \geq \mathrm{M}\right\rangle}{d\langle\mathrm{M}\rangle}( \}^{2}\right.} d\left\langle L^{n, i}, \mathrm{M}\right\rangle_{s} \equiv \int_{T_{0}}^{t} 1_{\left\{\frac{d\left\langle L^{n, i, \mathrm{M}\rangle}\right.}{d\langle\mathrm{M}, \mathrm{M}\rangle}(s) \geq 0\right\}} \frac{d\left\langle L^{n, i}, \mathrm{M}\right\rangle}{d\langle\mathrm{M}, \mathrm{M}\rangle}(s) d\langle\mathrm{M}, \mathrm{M}\rangle_{s} .
$$

The process $\left\langle L^{n, i}, \mathrm{M}\right\rangle^{+}$is L-dominated by the optional process $\operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]$. In fact, there exists a reducing sequence $\tau_{m}$ of stopping times for which both $\operatorname{Var}\left\langle L^{n, i}, \mathrm{M}\right\rangle$ and $\operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]$ are integrable. Then for any stopping time $\tau$,

$$
\begin{aligned}
E\left[\left\langle L^{n, i}, \mathrm{M}\right\rangle_{\tau_{m} \wedge \tau}^{+}\right] & =E\left[\int_{T_{0}}^{\tau_{m} \wedge \tau} 1_{\left\{\frac{d\left\langle L^{n, i}, \mathrm{M}\right\rangle}{d\langle\mathrm{M}, \mathrm{M}\rangle}(s) \geq 0\right\}} d\left[L^{n, i}, \mathrm{M}\right]_{s}\right] \\
& \leq E\left[\int_{T_{0}}^{\tau_{m} \wedge \tau} 1_{\left\{\frac{d\left\langle L^{n, i, \mathrm{M}\rangle}\right.}{d\langle\mathrm{M}, \mathrm{M}\rangle}(s) \geq 0\right\}} d \operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]_{s}\right] \\
& \leq E\left[\operatorname{Var}\left[L^{n, i}, \mathrm{M}\right]_{\tau_{m} \wedge \tau}\right]
\end{aligned}
$$

and let $m \nearrow \infty$ to obtain the L-domination. Since we know that $\left\{\sup _{s} \Delta \operatorname{Var}\left[L^{n, i}, M\right]_{s}\right\}_{n}$ is stochastically bounded, we obtain $\left\langle L^{n, i}, \mathrm{M}\right\rangle_{t}^{+} \rightarrow^{p} 0$ as $n \rightarrow \infty$ from (7.2) by the Lenglart inequality. In the same fashion, we can prove

$$
\left\langle L^{n, i}, \mathrm{M}\right\rangle_{t}^{-}:=-\int_{T_{0}}^{t} 1_{\left\{\frac{d\left\langle L^{n, i, M\rangle}\right.}{d\langle\mathrm{M}, \mathrm{M}\rangle}(s)<0\right\}} d\left\langle L^{n, i}, \mathrm{M}\right\rangle_{s} \rightarrow^{p} 0
$$

Thus we obtained $\left\langle L^{n, i}, \mathrm{M}\right\rangle_{t} \rightarrow^{p} 0$.
Obviously, $\left\langle L^{n}, \mathrm{M}\right\rangle=0$ for $\mathbf{F}$-continuous martingales M . Under the properties shown above, the result follows from Jacod's theorem.
