# UNIFORMLY VALID POST-REGULARIZATION CONFIDENCE REGIONS FOR MANY FUNCTIONAL PARAMETERS IN Z-ESTIMATION FRAMEWORK*

#### Abstract

In this paper we develop procedures to construct simultaneous confidence bands for $\tilde{p}$ potentially infinite-dimensional parameters after model selection for general moment condition models where $\tilde{p}$ is potentially much larger than the sample size of available data, $n$. This allows us to cover settings with functional response data where each of the $\tilde{p}$ parameters is a function. The procedure is based on the construction of score functions that satisfy certain orthogonality condition. The proposed simultaneous confidence bands rely on uniform central limit theorems for high-dimensional vectors (and not on Donsker arguments as we allow for $\tilde{p} \gg n$ ). To construct the bands, we employ a multiplier bootstrap procedure which is computationally efficient as it only involves resampling the estimated score functions (and does not require resolving the high-dimensional optimization problems). We formally apply the general theory to inference on regression coefficient process in the distribution regression model with a logistic link, where two implementations are analyzed in detail. Simulations and an application to real data are provided to help illustrate the applicability of the results.


1. Introduction. High-dimensional models have become increasingly popular in the last two decades. Much research has been conducted on estimation of these models. However, inference about parameters in these models is much less understood, although the literature on inference is growing quickly; see the list of references below. In particular, despite its practical relevance, there are few papers trying to solve the problem of construction of simultaneous confidence bands on many target parameters in these models. (One exception is [9]. Simultaneous confidence bands have been constructed by Bonferroni adjustments but the resulting confidence bands are often conservative, see, e.g., simulation results in [42].) In this paper we provide a solution to this problem by constructing simultaneous confidence bands for parameters in a very general framework of moment condition models, al-

[^0]lowing for many functional parameters, where each parameter itself can be an infinite-dimensional object, and the number of parameters can be much larger than the sample size of available data.

As a substantive application, we apply our general results to provide simultaneous confidence bands for parameters in a logistic regression model with functional response data

where $D=\left(D_{1}, \ldots, D_{\tilde{p}}\right)^{\prime}$ is a $\tilde{p}$-vector of covariates whose effects are of interest, $X=\left(X_{1}, \ldots, X_{p}\right)^{\prime}$ is a $p$-vector of controls, $\Lambda: \mathbb{R} \rightarrow \mathbb{R}$ is the logistic link function, $\mathcal{U}=[0,1]$ is a set of indices, and for each $u \in \mathcal{U}, Y_{u}=$ $1\{Y \leqslant(1-u) \underline{y}+u \bar{y}\}$ for some constants $\underline{y} \leqslant \bar{y}$ and the response variable $Y$, $\theta_{u}=\left(\theta_{u 1}, \ldots, \theta_{u \tilde{p}}\right)^{\prime}$ is a vector of target parameters, and $\beta_{u}=\left(\beta_{u 1}, \ldots, \beta_{u p}\right)^{\prime}$ is a vector of nuisance parameters. Here, both $\tilde{p}$ and $p$ are allowed to be potentially much larger than the sample size $n$, and we have $\tilde{p}$ functional target parameters $\left(\theta_{u j}\right)_{u \in \mathcal{U}}$ and $p$ functional nuisance parameters $\left(\beta_{u j}\right)_{u \in \mathcal{U}}$. This example is important because it demonstrates that our methods can be used for inference about the whole distribution of the response variable $Y$ given $D$ and $X$ in a high-dimensional setting, and not only about some particular features of it such as mean or median. This model is called a distribution regression model in [21] and a conditional transformation model in [25], who argue that the model provides a rich class of models for conditional distributions, and offers a useful generalization of traditional proportional hazard models as well as a useful alternative to quantile regression. We develop inference methods to construct simultaneous confidence bands for many functional parameters of this model in Section 3. Toward this goal, our contributions include to effectively estimate a continuum of high-dimensional nuisance parameters, allow for approximately sparse models, control sparse eigenvalues of a continuum of random matrices, and establish the validity of a multiplier bootstrap for the construction of confidence bands for the many functional parameters of interest. In particular, these contributions go much beyond [9], which considers the special case of many scalar parameters.

Our general results refer to the problem of estimating the set of parameters $\left(\theta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ in the moment condition model,

where $W$ is a random element that takes values in a measurable space $\left(\mathcal{W}, \mathcal{A}_{\mathcal{W}}\right)$ according to a probability measure $P, \mathcal{U} \subset \mathbb{R}^{d_{u}}$ and $[\tilde{p}]:=\{1, \ldots, \tilde{p}\}$ are sets of indices, and for each $u \in \mathcal{U}$ and $j \in[\tilde{p}], \psi_{u j}$ is a known score
function, $\theta_{u j}$ is a scalar parameter of interest, and $\eta_{u j}$ is a potentially highdimensional (or infinite-dimensional) nuisance parameter. Assuming that a random sample of size $n,\left(W_{i}\right)_{i=1}^{n}$, from the distribution of $W$ is available together with suitable estimators $\widehat{\eta}_{u j}$ of $\eta_{u j}$, we aim to construct simultaneous confidence bands for $\left(\theta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ that are valid uniformly over a large class of probability measures $P$, say $\mathcal{P}_{n}$. Specifically, for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, we construct an appropriate estimator $\check{\theta}_{u j}$ of $\theta_{u j}$ along with an estimator of the standard deviation of $\sqrt{n}\left(\check{\theta}_{u j}-\theta_{u j}\right), \widehat{\sigma}_{u j}$, such that

uniformly over $P \in \mathcal{P}_{n}$, where $\alpha \in(0,1)$ and $c_{\alpha}$ is an appropriate critical value, which we choose to construct using a multiplier bootstrap method. The left- and the right-hand sides of the inequalities inside the probability statement (1.3) then can be used as bounds in simultaneous confidence bands for $\theta_{u j}$ 's. In this paper, we are particularly interested in the case when $\tilde{p}$ is potentially much larger than $n$ and $\mathcal{U}$ is an uncountable subset of $\mathbb{R}^{d_{u}}$, so that for each $j \in[\tilde{p}],\left(\theta_{u j}\right)_{u \in \mathcal{U}}$ is an infinite-dimensional (that is, functional) parameter.

In the presence of high-dimensional nuisance parameters, construction of valid confidence bands is delicate. Dealing with high-dimensional parameters requires relying upon regularization that leads to lack of asymptotic linearization of the estimators of target parameters since regularized estimators of nuisance parameters suffer from a substantial bias and this bias spreads into the estimators of the target parameters. This lack of asymptotic linearization in turn typically translates into severe distortions in coverage probability of the confidence bands constructed by traditional techniques that are based on perfect model selection; see [29], [30], [31], [39]. To deal with this problem, we assume that the score functions $\psi_{u j}$ are constructed to satisfy a near-orthogonality condition that makes them immune to firstorder changes in the value of the nuisance parameter, namely

for all $\tilde{\eta}$ in an appropriate set where $\partial_{r}$ denotes the derivative with respect to $r$. We shall often refer to this condition as Neyman orthogonality, since in low-dimensional parametric settings the orthogonality property originates in the work of Neyman on the $C(\alpha)$ test in the 50s. In Section 2 below, we describe a few general methods for constructing the score functions $\psi_{u j}$ obeying the Neyman orthogonality condition.

The Neyman orthogonality condition (1.4) is important because it helps to make sure that the bias from the estimators of the high-dimensional nuisance parameters does not spread into the estimators of the target parameters. In particular, under (1.4), it follows that

at least up to the first order, where the index $W$ in $\mathrm{E}_{P, W}[\cdot]$ means that the expectation is taken over $W$ only. This makes the estimators of the target parameters $\theta_{u j}$ immune to the bias in the estimators $\widehat{\eta}_{u j}$, which in turn improves their statistical properties and opens up the possibilities for valid inference.

As the framework (1.2) covers a broad variety of applications, it is instructive to revisit the logistic regression model with functional response data (1.1). To construct score functions $\psi_{u j}$ that satisfy both the moment conditions (1.2) and the Neyman orthogonality condition (1.4) in this example, for $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, define a ( $\tilde{p}+p-1$ )-vector of additional nuisance parameters

where $X^{j}=\left(D_{[\tilde{p} \backslash j}^{\prime}, X^{\prime}\right), D_{[\tilde{p}] \backslash j}=\left(D_{1}, \ldots, D_{j-1}, D_{j+1}, \ldots, D_{\tilde{p}}\right)^{\prime}$, and

Then, denoting $W=(Y, D, X)$ and splitting $\theta_{u}$ into $\theta_{u j}$ and $\theta_{u[\tilde{p}] \backslash j}=$ $\left(\theta_{u 1}, \ldots, \theta_{u j-1}, \theta_{u j+1}, \ldots, \theta_{u[\tilde{p}]^{\prime}}\right)^{\prime}$, we set

\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)=\left\{Y_{u}-\Lambda\left(D_{j} \theta_{u j}+X^{j} \beta_{u}^{j}\right)\right\}\left(D_{j}-X^{j} \gamma_{u}^{j}\right),
$$

where $\eta_{u j}=\left(\beta_{u}^{j}, \gamma_{u}^{j}\right)$ and $\beta_{u}^{j}=\left(\theta_{u[\tilde{p} \backslash \backslash j}^{\prime}, \beta_{u}^{\prime}\right)^{\prime}$. It is straightforward to see that these score functions $\psi_{u j}$ satisfy the moment conditions (1.2) and to see that they also satisfy the Neyman orthogonality condition (1.4), observe that

& \left.\partial_{\gamma}\left\{\mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta_{u j}, \beta_{u}^{j}, \gamma\right)\right]\right\}\right|_{\gamma=\gamma_{u}^{j}}=-\mathrm{E}_{P}\left[\left\{Y_{u}-\Lambda\left(D^{\prime} \theta_{u}+X^{\prime} \beta_{u}\right)\right\}\left(X^{j}\right)^{\prime}\right]=0,
\end{aligned}
$$

where the first line holds by definition of $f_{u}^{2}$ and $\gamma_{u}^{j}$ since $\operatorname{Var}_{P}\left(Y_{u} \mid D, X\right)=$ $\Lambda^{\prime}\left(D^{\prime} \theta_{u}+X^{\prime} \beta_{u}\right)$, and the second by (1.1). Because of this orthogonality
condition, we can exploit the moment conditions (1.2) to construct regular, $\sqrt{n}$-consistent, estimators of $\theta_{u j}$ even if non-regular, regularized or post-regularized, estimators of $\eta_{u j}=\left(\beta_{u}^{j}, \gamma_{u}^{j}\right)$ are used to cope with highdimensionality. Using these regular estimators of $\theta_{u j}$, we then can construct valid confidence bands (1.3).

Our general approach to construct simultaneous confidence bands, which is developed in Section 2, can be described as follows. First, we construct the moment conditions (1.2) that satisfy the Neyman orthogonality condition (1.4), and use these moment conditions to construct estimators $\check{\theta}_{u j}$ of $\theta_{u j}$ for all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$. Second, under appropriate regularity conditions, we establish a Bahadur representation for $\check{\theta}_{u j}$ 's. Third, employing the Bahadur representation, we are able to derive a suitable Gaussian approximation for the distribution of $\check{\theta}_{u j}$ 's. Importantly, the Gaussian approximation is possible even if both $\tilde{p}$ and the dimension of the index set $\mathcal{U}, d_{u}$, are allowed to grow with $n$, and $\tilde{p}$ asymptotically remains much larger than $n$. Finally, from the Gaussian approximation, we construct simultaneous confidence bands using a multiplier bootstrap method. Here, the Gaussian and bootstrap approximations are constructed by applying the results on high-dimensional central limit and bootstrap theorems established in [15], [17], [9], [19], and [10] by verifying the conditions there.

Although regularity conditions underlying our approach can be verified for many models defined by moment conditions, for illustration purposes, we explicitly verify these conditions for the logistic regression model with functional response data (1.1) in Section 3. We also note that the regularity conditions, in particular those related to the entropy of the nuisance parameter estimators, can be substantially relaxed if we use sample splitting, so that the nuisance parameters and parameters of interest are estimated on separate samples; see [14]. In addition, we examine the performance of the proposed procedures in a Monte Carlo simulation study and provide an example based on real data in Section 5. Moreover, in the Supplementary Material, we discuss the construction of simultaneous confidence bands based on a double-selection estimator. This estimator does not require to explicitly construct the score functions satisfying the Neyman orthogonality condition but nonetheless is first-order equivalent to the estimator based on such functions.

We also develop new results for $\ell_{1}$-penalized $M$-estimators in Section 4 to handle functional data and criterion functions that depend on nuisance functions for which only estimates are available (for brevity of the paper, generic results are deferred to Appendix J of the Supplementary Material, and Section 4 only contains results that are relevant for the logistic regression
model studied in Section 3). Specifically, we develop a method to select penalty parameters for these estimators and extend the existing theory to cover functional data to achieve rates of convergence and sparsity guarantees that hold uniformly over $u \in \mathcal{U}$. The ability to allow both for functional data and for nuisance functions is crucial in the implementation and in theoretical analysis of the methods proposed in this paper.

Orthogonality conditions like that in (1.4) have played an important role in statistics and econometrics. In low-dimensional settings, a similar condition was used by Neyman in [36] and [37] while in semiparametric models the orthogonality conditions were used in [34], [1], [35], [40] and [32]. In high-dimensional settings, [5] and [2] were the first to use the orthogonality condition (1.4) in a linear instrumental variables model with many instruments. Related ideas have also been used in the literature to construct confidence bands in high-dimensional linear models, generalized linear models, and other non-linear models; see [6], [45], [7], [42], [12], [27], [26], [9], [3], [5], [46], and [38]. We contribute to this quickly growing literature by providing procedures to construct simultaneous confidence bands for many infinite-dimensional parameters identified by moment conditions.

Throughout the paper, we use the standard notation from the empirical process theory. In particular, we use $\mathbb{E}_{n}$ to denote the expectation with respect to the empirical measure associated with the data $\left(W_{i}\right)_{i=1}^{n}$, and we use $\mathbb{G}_{n}$ to denote the empirical process $\sqrt{n}\left(\mathbb{E}_{n}-\mathrm{E}_{P}\right)$. More details about the notation are given in Appendix B of the Supplementary Material.

## 2. Confidence Regions for Function-Valued Parameters Based on Moment Conditions.

2.1. Generic Construction of Confidence Regions. In this section, we state our results under high-level conditions. In the next section, we will apply these results to construct simultaneous confidence bands for many infinite-dimensional parameters in the logistic regression model with functional response data.

Recall that we are interested in constructing simultaneous confidence bands for a set of target parameters $\left(\theta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ where for each $u \in \mathcal{U} \subset$ $\mathbb{R}^{d_{u}}$ and $j \in[\tilde{p}]=\{1, \ldots, \tilde{p}\}$, the parameter $\theta_{u j}$ satisfies the moment condition (1.2) with $\eta_{u j}$ being a potentially high-dimensional (or infinitedimensional) nuisance parameter. Assume that $\theta_{u j} \in \Theta_{u j}$, a finite or infinite interval in $\mathbb{R}$, and that $\eta_{u j} \in T_{u j}$, a convex set in a normed space equipped with a norm $\|\cdot\|_{e}$. We allow $\mathcal{U}$ to be a possibly uncountable set of indices, and $\tilde{p}$ to be potentially large.

We assume that a random sample $\left(W_{i}\right)_{i=1}^{n}$ from the distribution of $W$ is available for constructing the confidence bands. We also assume that for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, the nuisance parameter $\eta_{u j}$ can be estimated by $\widehat{\eta}_{u j}$ using the same data $\left(W_{i}\right)_{i=1}^{n}$. In the next section, we discuss examples where $\widehat{\eta}_{u j}$ 's are based on Lasso or Post-Lasso methods (although other modern regularization and post-regularization methods can be applied). Our confidence bands will be based on the estimators $\check{\theta}_{u j}$ of $\theta_{u j}$ that are for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ defined as approximate $\epsilon_{n}$-solutions in $\Theta_{u j}$ to sample analogs of the moment conditions (1.2), that is,

\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left\{\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]\right|-\inf _{\theta \in \Theta_{u j}}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)\right]\right|\right\} \leqslant \epsilon_{n}, \tag{2.1}
\end{equation*}

where $\epsilon_{n}=o\left(\delta_{n} n^{-1 / 2}\right)$ for all $n \geqslant 1$ and some sequence $\left(\delta_{n}\right)_{n \geqslant 1}$ of positive constants converging to zero.

To motivate the construction of the confidence bands based on the estimators $\check{\theta}_{u j}$, we first study distributional properties of these estimators. To do that, we will employ the following regularity conditions. Let $C_{0}$ be a strictly positive (and finite) constant, and for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, let $\mathcal{T}_{u j}$ be some subset of $T_{u j}$, whose properties are specified below in assumptions. In particular, we will choose the sets $\mathcal{T}_{u j}$ so that, on the one hand, their complexity does not grow too fast with $n$ but, on the other hand, for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, the estimator $\widehat{\eta}_{u j}$ takes values in $\mathcal{T}_{u j}$ with high probability. As discussed before, we rely on the following near-orthogonality condition:

Definition 2.1 (Near-orthogonality condition). For each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, we say that $\psi_{u j}$ obeys the near-orthogonality condition with respect to $\mathcal{T}_{u j} \subset T_{u j}$ if the following conditions hold: The Gateaux derivative map

exists for all $\bar{r} \in[0,1)$ and $\eta \in \mathcal{T}_{u j}$ and (nearly) vanishes at $\bar{r}=0$, namely,

for all $\eta \in \mathcal{T}_{u j}$.
At the end of this section, we describe several methods to obtain score functions $\psi_{u j}$ that obey the near-orthogonality condition. Together these methods cover a wide variety of applications.

Let $\omega$ and $c_{0}$ be some strictly positive (and finite) constants, and let $n_{0} \geqslant 3$ be some positive integer. Also, let $\left(B_{1 n}\right)_{n \geqslant 1}$ and $\left(B_{2 n}\right)_{n \geqslant 1}$ be some sequences of positive constants, possibly growing to infinity, where $B_{1 n} \geqslant 1$ for all $n \geqslant 1$. In addition, denote

\mathcal{S}_{n}:= & \mathrm{E}_{P}\left[\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\sqrt{n} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]\right|\right] \\
& J_{u j}:=\left.\partial_{\theta}\left\{\mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta, \eta_{u j}\right)\right]\right\}\right|_{\theta=\theta_{u j}} \tag{2.3}
\end{align*}

The quantity $\mathcal{S}_{n}$ measures how rich the process $\left\{\psi_{u j}\left(\cdot, \theta_{u j}, \eta_{u j}\right): u \in \mathcal{U}, j \in\right.$ $[\tilde{p}]\}$ is. The quantity $J_{u j}$ measures the degree of identifiability of $\theta_{u j}$ by the moment condition (1.2). In many applications, it is bounded in absolute value from above and away from zero. Finally, let $\mathcal{P}_{n}$ be a set of probability measures $P$ of possible distributions of $W$ on the measurable space $\left(\mathcal{W}, \mathcal{A}_{\mathcal{W}}\right)$.

We collect our main conditions on the score functions $\psi_{u j}$ and the true values of the target parameters $\theta_{u j}$ in the following assumption.

Assumption 2.1 (Moment condition problem). For all $n \geqslant n_{0}, P \in \mathcal{P}_{n}$, $u \in \mathcal{U}$, and $j \in[\tilde{p}]$, the following conditions hold: (i) The true parameter value $\theta_{u j}$ obeys (1.2), and $\Theta_{u j}$ contains a ball of radius $C_{0} n^{-1 / 2} \mathcal{S}_{n} \log n$ centered at $\theta_{u j}$. (ii) The map $(\theta, \eta) \mapsto \mathrm{E}_{P}\left[\psi_{u j}(W, \theta, \eta)\right]$ is twice continuously Gateaux-differentiable on $\Theta_{u j} \times \mathcal{T}_{u j}$. (iiii) The score function $\psi_{u j}$ obeys the near-orthogonality condition given in Definition 2.1 for the set $\mathcal{T}_{u j} \subset T_{u j}$. (iv) For all $\theta \in \Theta_{u j},\left|\mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta, \eta_{u j}\right)\right]\right| \geqslant 2^{-1}\left|J_{u j}\left(\theta-\theta_{u j}\right)\right| \wedge c_{0}$, where $J_{u j}$ satisfies $c_{0} \leqslant\left|J_{u j}\right| \leqslant C_{0}$. (v) For all $r \in[0,1), \theta \in \Theta_{u j}$, and $\eta \in \mathcal{T}_{u j}$,
(a) $\mathrm{E}_{P}\left[\left(\psi_{u j}(W, \theta, \eta)-\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right)^{2}\right] \leqslant C_{0}\left(\left|\theta-\theta_{u j}\right| \vee\left\|\eta-\eta_{u j}\right\|_{e}\right)^{\omega}$,
(b) $\left|\partial_{r} \mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta, \eta_{u j}+r\left(\eta-\eta_{u j}\right)\right)\right]\right| \leqslant B_{1 n}\left\|\eta-\eta_{u j}\right\|_{e}$,
(c) $\left|\partial_{r}^{2} \mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta_{u j}+r\left(\theta-\theta_{u j}\right), \eta_{u j}+r\left(\eta-\eta_{u j}\right)\right)\right]\right| \leqslant B_{2 n}\left(\left|\theta-\theta_{u j}\right|^{2} \vee\right.$ $\left.\left\|\eta-\eta_{u j}\right\|_{e}^{2}\right)$.

Assumption 2.1 is mild and standard in moment condition problems. Assumption 2.1(i) requires $\theta_{u j}$ to be sufficiently separated from the boundary of $\Theta_{u j}$. Assumption 2.1(ii) requires that the functions $(\theta, \eta) \mapsto \mathrm{E}_{P}\left[\psi_{u j}(W, \theta, \eta)\right]$ are smooth. It is a mild condition because it does not require smoothness of the functions $(\theta, \eta) \mapsto \psi_{u j}(W, \theta, \eta)$. Assumption 2.1(iii) is our key condition and is discussed above. Assumption 2.1(iv) implies sufficient identifiability of $\theta_{u j}$. In particular, it implies that the equation $\mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta, \eta_{u j}\right)\right]=0$ has only one solution $\theta=\theta_{u j}$. If this equation has multiple solutions, Assumption 2.1(iv) implies that the set $\Theta_{u j}$ is restricted enough so that there is only one solution in $\Theta_{u j}$. Assumption 2.1(v-a) means that the functions $(\theta, \eta) \mapsto \psi_{u j}(W, \theta, \eta)$ mapping $\Theta_{u j} \times T_{u j}$ into $L^{2}(P)$ are Lipschitz-continuous
at $(\theta, \eta)=\left(\theta_{u j}, \eta_{u j}\right)$ with Lipschitz order $\omega / 2$. In most applications, we can set $\omega=2$. Assumptions $2.1(\mathrm{v}-\mathrm{b}, \mathrm{v}-\mathrm{c})$ impose smoothness bounds on the functions $(\theta, \eta) \mapsto \mathrm{E}_{P}\left[\psi_{u j}(W, \theta, \eta)\right]$.

Next, we state our conditions related to the estimators $\widehat{\eta}_{u j}$. Let $\left(\Delta_{n}\right)_{n \geqslant 1}$ and $\left(\tau_{n}\right)_{n \geqslant 1}$ be some sequences of positive constants converging to zero. Also, let $\left(a_{n}\right)_{n \geqslant 1},\left(v_{n}\right)_{n \geqslant 1}$, and $\left(K_{n}\right)_{n \geqslant 1}$ be some sequences of positive constants, possibly growing to infinity, where $a_{n} \geqslant n \vee K_{n}$ and $v_{n} \geqslant 1$ for all $n \geqslant 1$. Finally, let $q \geqslant 2$ be some constant.

ASSUMPTION 2.2 (Estimation of nuisance parameters). For all $n \geqslant n_{0}$ and $P \in \mathcal{P}_{n}$, the following conditions hold: (i) With probability at least $1-\Delta_{n}$, we have $\widehat{\eta}_{u j} \in \mathcal{T}_{u j}$ for all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$. (ii) For all $u \in \mathcal{U}$, $j \in[\tilde{p}]$, and $\eta \in \mathcal{T}_{u j},\left\|\eta-\eta_{u j}\right\|_{e} \leqslant \tau_{n}$. (iii) For all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, we have $\eta_{u j} \in \mathcal{T}_{u j}$. (iv) The function class $\mathcal{F}_{1}=\left\{\psi_{u j}(\cdot, \theta, \eta): u \in \mathcal{U}, j \in[\tilde{p}], \theta \in\right.$ $\left.\Theta_{u j}, \eta \in \mathcal{T}_{u j}\right\}$ is suitably measurable and its uniform entropy numbers obey

where $F_{1}$ is a measurable envelope for $\mathcal{F}_{1}$ that satisfies $\left\|F_{1}\right\|_{P, q} \leqslant K_{n}$. (v) For all $f \in \mathcal{F}_{1}$, we have $c_{0} \leqslant\|f\|_{P, 2} \leqslant C_{0}$. (vi) The complexity characteristics $a_{n}$ and $v_{n}$ satisfy
(a) $\left(v_{n} \log a_{n} / n\right)^{1 / 2} \leqslant C_{0} \tau_{n}$,
(b) $\left(B_{1 n} \tau_{n}+\mathcal{S}_{n} \log n / \sqrt{n}\right)^{\omega / 2}\left(v_{n} \log a_{n}\right)^{1 / 2}+n^{-1 / 2+1 / q} v_{n} K_{n} \log a_{n} \leqslant C_{0} \delta_{n}$,
(c) $n^{1 / 2} B_{1 n}^{2} B_{2 n} \tau_{n}^{2} \leqslant C_{0} \delta_{n}$.

Assumption 2.2 provides sufficient conditions for the estimation of the nuisance parameters $\left(\eta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$. Assumption $2.2(\mathrm{i})$ requires that the set $\mathcal{T}_{u j}$ is large enough so that $\widehat{\eta}_{u j} \in \mathcal{T}_{u j}$ with high probability. Assumptions $2.2(\mathrm{i}, \mathrm{ii})$ together require that the estimator $\widehat{\eta}_{u j}$ converges to $\eta_{u j}$ with the rate $\tau_{n}$. This rate should be fast enough so that Assumptions 2.2(vi-b,vi-c) are satisfied. Assumption $2.2(\mathrm{iv})$ gives a bound on the complexity of the set $\mathcal{T}_{u j}$ expressed via uniform entropy numbers, and Assumptions 2.2(vi-a,vi-b) require that the set $\mathcal{T}_{u j}$ is small enough so that its complexity does not grow too fast. Assumption $2.2(\mathrm{v})$ requires that the functions $(\theta, \eta) \mapsto$ $\psi_{u j}(W, \theta, \eta)$ are scaled properly. Suitable measurability of $\mathcal{F}_{1}$, required in Assumption 2.2 (iv), is a mild condition that is satisfied in most practical cases; see Supplementary Material B for clarifications. Overall, Assumption 2.2 shows the trade-off in the choice of the sets $\mathcal{T}_{u j}$ : setting $\mathcal{T}_{u j}$ large, on the one hand, makes it easy to satisfy Assumption 2.2(i) but, on the other hand, yields large values of $a_{n}$ and $v_{n}$ in Assumption 2.2(iv) making it difficult to satisfy Assumption 2.2(vi).

We stress that the class $\mathcal{F}_{1}$ does not need to be Donsker because its uniform entropy numbers are allowed to increase with $n$. This is important because allowing for non-Donsker classes is necessary to deal with highdimensional nuisance parameters. Note also that our conditions are very different from the conditions imposed in various settings with nonparametrically estimated nuisance functions; see, e.g., [16], [43], and [28].

In addition, we emphasize that the conditions stated in Assumption 2.2 are sufficient for our results for the general model (1.2) but can often be relaxed if the structure of the functions $\psi_{u j}(W, \theta, \eta)$ is known. For example, it is possible to relax Assumption 2.2(vi) if the functions $\psi_{u j}(W, \theta, \eta)$ are linear in $\theta$, which happens in the linear regression model with $\theta$ being the coefficient on the covariate of interest; see [7]. Moreover, it is possible to relax the entropy condition (2.4) of Assumption 2.2 by relying upon sample splitting, where a part of the data is used to estimate $\eta_{u j}$, and the other part is used to estimate $\theta_{u j}$ given an estimate $\widehat{\eta}_{u j}$ of $\eta_{u j}$; see [2].

The following theorem is our first main result in this paper:
Theorem 2.1 (Uniform Bahadur representation). Under Assumptions 2.1 and 2.2, for an estimator $\left(\check{\theta}_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ that obeys (2.1), we have

uniformly over $P \in \mathcal{P}_{n}$, where $\bar{\psi}_{u j}(\cdot):=-\sigma_{u j}^{-1} J_{u j}^{-1} \psi_{u j}\left(\cdot, \theta_{u j}, \eta_{u j}\right)$ and $\sigma_{u j}^{2}:=$ $J_{u j}^{-2} \mathrm{E}_{P}\left[\psi_{u j}^{2}\left(W, \theta_{u j}, \eta_{u j}\right)\right]$.

Comment 2.1 (On the proof of Theorem 2.1). To prove this theorem, we use the following identity:

& \sqrt{n} \mathbb{E}_{P, W}\left[\psi_{u j}\left(W, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right)-\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]=-\sqrt{n} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]  \tag{2.6}\\
& \quad+\sqrt{n} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]+\mathbb{G}_{n} \psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)-\mathbb{G}_{n} \psi_{u j}\left(W, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right) . \tag{2.7}
\end{align*}
$$

Here, the term on the right-hand side of (2.6) is the main term on the righthand side of (2.5), up to a normalization $\left(\sigma_{u j} J_{u j}\right)^{-1}$. Also, we show that the first term in (2.7) is $O_{P}\left(\delta_{n}\right)$ since $\check{\theta}_{u j}$ satisfies (2.1). Moreover, using a rather standard theory of $Z$-estimators, we show that $\check{\theta}_{u j}-\theta_{u j}=O_{P}\left(B_{1 n} \tau_{n}\right)$. This in turn allows us to show with the help of empirical process arguments that the difference of the last two terms in (2.7) is $O_{P}\left(\delta_{n}\right)$ as well. (In [14], we also point out that this difference is $O_{P}\left(\delta_{n}\right)$ under much weaker entropy conditions than those in Assumption 2.2 if $\widehat{\eta}_{u j}$ and $\check{\theta}_{u j}$ are obtained using separate samples.) Thus, it remains to show that the left-hand side of (2.6) is equal to the left-hand side of (2.5) up to an approximation error $O_{P}\left(\delta_{n}\right)$
and up to a normalization $\left(\sigma_{u j} J_{u j}\right)^{-1}$. To do so, we use second-order Taylor's expansion of the function

& \quad=\sqrt{n} J_{u j}\left(\check{\theta}_{u j}-\theta_{u j}\right)+\sqrt{n} D_{u, j, 0}\left[{ }_{\eta_{u j}}-\eta_{u j}\right]+\sqrt{n} f^{\prime \prime}(\bar{r}) / 2
\end{aligned}
$$

for some $\bar{r} \in(0,1)$. Here, $\sqrt{n} f^{\prime \prime}(\bar{r})=O_{P}\left(\delta_{n}\right)$ follows from Assumptions 2.1 and 2.2 and the key near-orthogonality condition also allows us to show that $\sqrt{n} D_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]=O_{P}\left(\delta_{n}\right)$. Without this condition, the term $\sqrt{n} D_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]$ would give first-order bias and lead to slower-than- $\sqrt{n}$ rate of convergence of the estimator $\check{\theta}_{u j}$. Finally, again using the empirical process arguments, we can show that all the bounds including the term $O_{P}\left(\delta_{n}\right)$ hold uniformly over $u \in \mathcal{U}$ and $j \in[\tilde{p}]$.

Comment 2.2 (On uniformity in $u$ in Theorem 2.1). When the functions $u \mapsto \sqrt{n} \sigma_{u j}^{-1}\left(\check{\theta}_{u j}-\theta_{u j}\right)-\mathbb{G}_{n} \bar{\psi}_{u j}$ are Lipschitz-continuous, one can use a simple discretization argument to conclude that the approximation in (2.5) holds uniformly over $(u, j) \in \mathcal{U} \times[\tilde{p}]$ as long as we can show that it holds for each $(u, j) \in \mathcal{U} \times[\tilde{p}]$. However, in many applications, including the logistic regression model with functional response data discussed in Section 3, this function is actually not continuous, and the location of jumps depends on the data. Therefore, we have to rely on a more complicated argument to establish uniformity in $u$ in the bound (2.5).

The uniform Bahadur representation derived in Theorem 2.1 is useful for the construction of simultaneous confidence bands for $\left(\theta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ as in (1.3). For this purpose, we apply new high-dimensional central limit and bootstrap theorems that have been recently developed in a sequence of papers [15], [17], [9], [19], and [10]. To apply these theorems, we make use of the following regularity condition.

Let $\left(\bar{\delta}_{n}\right)_{n \geqslant 1}$ be a sequence of positive constants converging to zero. Also, let $\left(\varrho_{n}\right)_{n \geqslant 1},\left(\bar{\varrho}_{n}\right)_{n \geqslant 1},\left(A_{n}\right)_{n \geqslant 1},\left(\bar{A}_{n}\right)_{n \geqslant 1}$, and $\left(L_{n}\right)_{n \geqslant 1}$ be some sequences of positive constants, possibly growing to infinity, where $\varrho_{n} \geqslant 1, A_{n} \geqslant n$, and $\bar{A}_{n} \geqslant n$ for all $n \geqslant 1$. In addition, from now on, we assume that $q>4$. Denote by $\widehat{\psi}_{u j}(\cdot):=-\widehat{\sigma}_{u j}^{-1} \widehat{J}_{u j}^{-1} \psi_{u j}\left(\cdot, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right)$ an estimator of $\bar{\psi}_{u j}(\cdot)$, with $\widehat{J}_{u j}$ and $\widehat{\sigma}_{u j}$ being suitable estimators of $J_{u j}$ and $\sigma_{u j}$.

Assumption 2.3 (Additional score regularity). For all $n \geqslant n_{0}$ and $P \in$ $\mathcal{P}_{n}$, the following conditions hold: (i) The function class $\mathcal{F}_{0}=\left\{\bar{\psi}_{u j}(\cdot): u \in\right.$ $\mathcal{U}, j \in[\tilde{p}]\}$ is suitably measurable and its uniform entropy numbers obey

\sup _{Q} \log N\left(\epsilon\left\|F_{0}\right\|_{Q, 2}, \mathcal{F}_{0},\|\cdot\|_{Q, 2}\right) \leqslant \varrho_{n} \log \left(A_{n} / \epsilon\right), \quad \text { for all } 0<\epsilon \leqslant 1,
$$

where $F_{0}$ is a measurable envelope for $\mathcal{F}_{0}$ that satisfies $\left\|F_{0}\right\|_{P, q} \leqslant L_{n}$. (ii) For all $f \in \mathcal{F}_{0}$ and $k=3,4$, we have $\mathrm{E}_{P}\left[|f(W)|^{k}\right] \leqslant C_{0} L_{n}^{k-2}$. (iii) The function class $\widehat{\mathcal{F}}_{0}=\left\{\bar{\psi}_{u j}(\cdot)-\widehat{\psi}_{u j}(\cdot): u \in \mathcal{U}, j \in[\tilde{p}]\right\}$ satisfies with probability $1-\Delta_{n}$ : $\log N\left(\epsilon, \widehat{\mathcal{F}}_{0},\|\cdot\|_{\mathbb{P}_{n}, 2}\right) \leqslant \bar{\varrho}_{n} \log \left(\bar{A}_{n} / \epsilon\right)$ for all $0<\epsilon \leqslant 1$ and $\|f\|_{\mathbb{P}_{n}, 2} \leqslant \bar{\delta}_{n}$ for all $f \in \widehat{\mathcal{F}}_{0}$.

This assumption is technical, and its verification in applications is rather standard. For the Gaussian approximation result below, we actually only need the first and the second part of this assumption. The third part will be needed for establishing validity of the simultaneous confidence bands based on the multiplier bootstrap procedure. As a side note, observe that Assumption 2.3 allows to bound $\mathcal{S}_{n}$ defined in (2.3) and used in Assumptions 2.1 and 2.2 ; see Appendix D of the Supplementary Material.

Next, let $\left(\mathcal{N}_{u j}\right)_{u \in \mathcal{U}, j \in[\hat{p}]}$ denote a tight zero-mean Gaussian_process indexed by $\mathcal{U} \times[\tilde{p}]$ with covariance operator given by $\mathrm{E}_{P}\left[\bar{\psi}_{u j}(W) \bar{\psi}_{u^{\prime} j^{\prime}}(W)\right]$ for $u, u^{\prime} \in \mathcal{U}$ and $j, j^{\prime} \in[\tilde{p}]$. We have the following corollary of Theorem 2.1, which is our second main result in this paper.

Corollary 2.1 (Gaussian approximation). Suppose that Assumptions 2.1, 2.2, and 2.3(i,ii) hold. In addition, suppose that the following growth conditions are satisfied: $\delta_{n}^{2} \varrho_{n} \log A_{n}=o(1), L_{n}^{2 / 7} \varrho_{n} \log A_{n}=o\left(n^{1 / 7}\right)$, and $L_{n}^{2 / 3} \varrho_{n} \log A_{n}=o\left(n^{1 / 3-2 /(3 q)}\right)$. Then

$$
\sup _{t \in \mathbb{R}}\left|\mathrm{P}_{P}\left(\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\sqrt{n} \sigma_{u j}^{-1}\left(\check{\theta}_{u j}-\theta_{u j}\right)\right| \leqslant t\right)-\mathrm{P}_{P}\left(\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\mathcal{N}_{u j}\right| \leqslant t\right)\right|=o(1)
$$

uniformly over $P \in \mathcal{P}_{n}$.
Based on Corollary 2.1, we are now able to construct simultaneous confidence bands for $\theta_{u j}$ 's as in (1.3). In particular, we will use the Gaussian multiplier bootstrap method employing the estimates $\widehat{\psi}_{u j}$ of $\bar{\psi}_{u j}$. To describe the method, define the process

\begin{equation*}
\widehat{\mathcal{G}}=\left(\widehat{\mathcal{G}}_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}=\left(\frac{1}{\sqrt{n}} \sum_{i=1}^{n} \xi_{i} \widehat{\psi}_{u j}\left(W_{i}\right)\right)_{u \in \mathcal{U}, j \in[\tilde{p}]} \tag{2.8}
\end{equation*}
$$

where $\left(\xi_{i}\right)_{i=1}^{n}$ are independent standard normal random variables which are independent from the data $\left(W_{i}\right)_{i=1}^{n}$. Then the multiplier bootstrap critical value $c_{\alpha}$ is defined as the $(1-\alpha)$ quantile of the conditional distribution of $\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left|\widehat{\mathcal{G}}_{u j}\right|$ given the data $\left(W_{i}\right)_{i=1}^{n}$. To prove validity of this critical value for the construction of simultaneous confidence bands of the form (1.3), we will impose the following additional assumption. Let $\left(\varepsilon_{n}\right)_{n \geqslant 1}$ be a sequence of positive constants converging to zero.

Assumption 2.4 (Variation estimation). For all $n \geqslant n_{0}$ and $P \in \mathcal{P}_{n}$,

\mathrm{P}_{P}\left(\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left|\frac{\widehat{\sigma}_{u j}}{\sigma_{u j}}-1\right|>\varepsilon_{n}\right) \leqslant \Delta_{n} .

The following corollary establishing validity of the multiplier bootstrap critical value $c_{\alpha}$ for the simultaneous confidence bands construction is our third main result in this paper.

Corollary 2.2 (Simultaneous confidence bands). Suppose that Assumptions 2.1 - 2.4 hold. In addition, suppose that the growth conditions of Corollary 2.1 hold. Finally, suppose that $\varepsilon_{n} \varrho_{n} \log A_{n}=o(1)$, and $\bar{\delta}_{n}^{2} \bar{\varrho}_{n} \varrho_{n}\left(\log \bar{A}_{n}\right)$. $\left(\log A_{n}\right)=o(1)$. Then (1.3) holds uniformly over $P \in \mathcal{P}_{n}$.

Comment 2.3 (Confidence bands based on other bootstrap schemes). Results in [23] suggest that the conditions of Corollary 2.2 can be somewhat relaxed if, instead of using the Gaussian weights in the multiplier bootstrap method, we use Mammen's weights as in [33] or if we use the empirical bootstrap instead of the multiplier bootstrap. Since the results in [23] apply only to high-dimensional random vectors and do not apply to infinite-dimensional random processes, we leave a formal discussion of the results under these alternative bootstrap schemes to future work.
2.2. Construction of score functions satisfying the orthogonality condition. Here we discuss several methods for generating orthogonal scores in a wide variety of settings, including the classical Neyman's construction. In what follows, since the argument applies to each $u$ and $j$, it is convenient to omit the indices $u$ and $j$ and also to use the subscript 0 to indicate the true values of the parameters. For simplicity we also focus the discussion on the exactly orthogonal case. With these simplifications, we can restate the orthogonality condition as follows: we say that the score $\psi$ obeys the Neyman orthogonality condition with respect to $\eta_{0} \in \mathcal{T}$ if the following conditions
hold: The Gateaux derivative map

$$
\mathrm{D}_{\bar{r}}\left[\eta-\eta_{0}\right]:=\partial_{r}\left\{\left.\mathrm{E}_{P}\left[\psi\left(W, \theta_{0}, \eta_{0}+r\left(\eta-\eta_{0}\right)\right]\right\}\right|_{r=\bar{r}}\right.
$$

exists for all $\bar{r} \in[0,1)$ and $\eta \in \mathcal{T}$ and vanishes at $\bar{r}=0$, namely,

$$
\begin{equation*}
\mathrm{D}_{u, j, 0}\left[\eta-\eta_{0}\right]=0, \tag{2.9}
\end{equation*}
$$

for all $\eta \in \mathcal{T}$.

1) Orthogonal Scores for Likelihood Problems with Finite-Dimensional Nuisance Parameters. In likelihood settings with finite-dimensional parameters, the construction of orthogonal equations was proposed by Neyman [36] who used them in construction of his celebrated $C(\alpha)$-statistic. ${ }^{1}$

To describe the construction, suppose that the log-likelihood function associated to observation $W$ is $(\theta, \beta) \mapsto \ell(W, \theta, \beta)$, where $\theta \in \Theta \subset \mathbb{R}^{d}$ is the target parameter and $\beta \in T \subset \mathbb{R}^{p_{0}}$ is the nuisance parameter. Under regularity conditions, the true parameter values $\theta_{0}$ and $\beta_{0}$ obey

$$
\begin{equation*}
\mathrm{E}_{P}\left[\partial_{\theta} \ell\left(W, \theta_{0}, \beta_{0}\right)\right]=0, \quad \mathrm{E}_{P}\left[\partial_{\beta} \ell\left(W, \theta_{0}, \beta_{0}\right)\right]=0 \tag{2.10}
\end{equation*}
$$

Now consider the new score function

$$
\begin{equation*}
\psi(W, \theta, \eta)=\partial_{\theta} \ell(W, \theta, \beta)-\mu \partial_{\beta} \ell(W, \theta, \beta), \tag{2.11}
\end{equation*}
$$

where the nuisance parameter is

$$
\eta=\left(\beta^{\prime}, \operatorname{vec}(\mu)^{\prime}\right)^{\prime} \in T \times \mathcal{D} \subset \mathbb{R}^{p}, \quad p=p_{0}+d p_{0}
$$

$\mu$ is the $d \times p_{0}$ orthogonalization parameter matrix whose true value $\mu_{0}$ solves the equation

$$
J_{\theta \beta}-\mu J_{\beta \beta}=0 \text { (i.e., } \mu_{0}=J_{\theta \beta} J_{\beta \beta}^{-1} \text { ), }
$$

and

$$
J=\left(\begin{array}{ll}
J_{\theta \theta} & J_{\theta \beta} \\
J_{\beta \theta} & J_{\beta \beta}
\end{array}\right)=\left.\partial_{\left(\theta^{\prime}, \beta^{\prime}\right)} \mathrm{E}_{P}\left[\partial_{\left(\theta^{\prime}, \beta^{\prime}\right)^{\prime}} \ell(W, \theta, \beta)\right]\right|_{\theta=\theta_{0} ; \beta=\beta_{0}}
$$

[^1]Provided that $\mu_{0}$ is well-defined, we have by (2.10) that $\mathrm{E}_{P}\left[\psi\left(W, \theta_{0}, \eta_{0}\right)\right]=0$, where $\eta_{0}=\left(\beta_{0}^{\prime}, \operatorname{vec}\left(\mu_{0}\right)^{\prime}\right)^{\prime}$. Moreover, it is trivial to verify that under standard regularity conditions the score function $\psi$ obeys the near orthogonality condition (2.2) exactly (i.e., with $C_{0}=0$ ), i.e.

$$
\left.\partial_{\eta} \mathrm{E}_{P}\left[\psi\left(W, \theta_{0}, \eta\right)\right]\right|_{\eta=\eta_{0}}=0 .
$$

Note that in this example, $\mu_{0}$ not only creates the necessary orthogonality but also creates the efficient score for inference on the main parameter $\theta$, as emphasized by Neyman.
2) Orthogonal Scores for Likelihood Problems with Infinite-Dimensional Nuisance Parameters. The Neyman's construction can be extended to semiparametric models, where the nuisance parameter $\beta$ is a function. In this case, the original score functions $(\theta, \beta) \mapsto \partial_{\theta} \ell(W, \theta, \beta)$ corresponding to the log-likelihood function $(\theta, \beta) \mapsto \ell(W, \theta, \beta)$ associated to observation $W$ can be transformed into efficient score functions $\psi$ that obey the exact orthogonality condition (2.9) by projecting the original score functions onto the orthocomplement of the tangent space induced by the nuisance parameter $\beta$; see Chapter 25 of [43] for a detailed description of this construction. Note that the projection may create additional nuisance parameters, so that the new nuisance parameter $\eta$ could be of larger dimension than $\beta$. Other relevant references include [16], [28], [7], and [9]. The approach is related to Neyman's construction in the sense that the score $\psi$ arising in this model is actually the Neyman's score arising in a one-dimensional least favorable parametric subfamily, [41]; see Chapter 25 of [43] for details.
3) Orthogonal Scores for Conditional Moment Problems with InfiniteDimensional Nuisance Parameters. Next, consider a conditional moment restrictions framework studied by Chamberlain [13]. To define the framework, let $W, D$, and $V$ be random vectors in $\mathbb{R}^{d_{W}}, \mathbb{R}^{d_{D}}$, and $\mathbb{R}^{d_{V}}$, respectively, with $D$ and $V$ being sub-vectors of $W$, so that $d_{D}+d_{V} \leqslant d_{W}$. Also, let $\theta \in \Theta \subset \mathbb{R}^{d_{\theta}}$ be a finite-dimensional parameter whose true value $\theta_{0}$ is of interest, and let $h: \mathbb{R}^{d_{V}} \rightarrow \mathbb{R}^{d_{h}}$ be a vector-valued functional nuisance parameter, with the true value being $h_{0}: \mathbb{R}^{d_{V}} \rightarrow \mathbb{R}^{d_{h}}$. The conditional moment restrictions framework assumes that $\theta_{0}$ and $h_{0}$ satisfy the following equation:

$$
\begin{equation*}
\mathrm{E}_{P}\left[m\left(W, \theta_{0}, h_{0}(V)\right) \mid D, V\right]=0, \tag{2.12}
\end{equation*}
$$

where $m: \mathbb{R}^{d_{W}} \times \mathbb{R}^{d_{\theta}} \times \mathbb{R}^{d_{h}} \rightarrow \mathbb{R}^{d_{m}}$ is some known function. This framework is of interest because it covers an extremely rich variety of models, without
having to explicitly rely on the likelihood formulation. For example, it covers the partial linear model,

$$
\begin{equation*}
Y=D \theta_{0}+h_{0}(V)+U, \quad \mathrm{E}_{P}[U \mid D, V]=0, \tag{2.13}
\end{equation*}
$$

where $Y$ is a scalar dependent random variable, $D$ is a scalar independent treatment random variable, $V$ is a vector of control random variables, and $U$ is a scalar unobservable noise random variable. Indeed, (2.13) implies (2.12) by setting $W=\left(Y, D, V^{\prime}\right)^{\prime}$ and $m(W, \theta, h)=Y-D \theta-h$.

Here we would like to build a (generalized) score function $(\theta, \eta) \mapsto \psi(W, \theta, \eta)$ for estimating $\theta_{0}$, the true value of parameter $\theta$, where $\eta$ is a new nuisance parameter with true value $\eta_{0}$, that obeys the near orthogonality condition (2.2). There are many ways to do so but one particularly useful way is the following. Consider the functional parameters $\Sigma: \mathbb{R}^{d_{D}+d_{V}} \rightarrow \mathbb{R}^{d_{m} \times d_{m}}$ and $\varphi: \mathbb{R}^{d_{D}+d_{V}} \rightarrow \mathbb{R}^{d_{\theta} \times d_{m}}$ whose true values are given by

$$
\begin{gathered}
\Sigma_{0}(D, V)=\mathrm{E}_{P}\left[m\left(W, \theta_{0}, h_{0}(V)\right) m\left(W, \theta_{0}, h_{0}(V)\right)^{\prime} \mid D, V\right], \\
\varphi_{0}(D, V)=\left(A_{0}(D, V)-\Gamma_{0}(D, V) G_{0}(V)\right)^{\prime},
\end{gathered}
$$

where

$$
\begin{aligned}
A_{0}(D, V)= & \left.\partial_{\theta^{\prime}} \mathrm{E}_{P}\left[m\left(W, \theta, h_{0}(V)\right) \mid D, V\right]\right|_{\theta=\theta_{0}}, \\
\Gamma_{0}(D, V)= & \left.\partial_{h^{\prime}} \mathrm{E}_{P}\left[m\left(W, \theta_{0}, h\right) \mid D, V\right]\right|_{h=h_{0}(V)}, \\
G_{0}(V)= & \left(\mathrm{E}_{P}\left[\Gamma_{0}(D, V)^{\prime} \Sigma_{0}(D, V)^{-1} \Gamma_{0}(D, V) \mid V\right]\right)^{-1} \\
& \times \mathrm{E}_{P}\left[\Gamma_{0}(D, V)^{\prime} \Sigma_{0}(D, V)^{-1} A_{0}(D, V) \mid V\right] .
\end{aligned}
$$

Then set $\eta=(h, \varphi, \Sigma)$ and $\eta_{0}=\left(h_{0}, \varphi_{0}, \Sigma_{0}\right)$, and define the score function

$$
\psi(W, \theta, \eta)=\varphi_{\text {instrument" }} \frac{\varphi(D, V)}{\text { weight }} \frac{\Sigma(D, V)^{-1}}{\text { residual }} .
$$

It is rather straightforward to verify that under mild regularity conditions, the score function $\psi$ satisfies the moment condition, $\mathrm{E}_{P}\left[\psi\left(W, \theta_{0}, \eta_{0}\right)\right]=0$, and in addition, the orthogonality condition,

$$
\left.\partial_{\eta} \mathrm{E}_{P}\left[\psi\left(W, \theta_{0}, \eta\right)\right]\right|_{\eta=\eta_{0}}=0 .
$$

Note that this construction gives the efficient score function $\psi$ that yields an estimator of $\theta_{0}$ achieving the semi-parametric efficiency bound, as calculated by Chamberlain [13].

## 3. Application to Logistic Regression Model with Functional

 Response Data. In this section we apply our main results to a logistic regression model with functional response data described in the Introduction.3.1. Model. We consider a response variable $Y \in \mathbb{R}$ that induces a functional response $\left(Y_{u}\right)_{u \in \mathcal{U}}$ by $Y_{u}=1\{Y \leqslant(1-u) \underline{y}+u \bar{y}\}$ for a set of indices $\mathcal{U}=[0,1]$ and some constants $\underline{y} \leqslant \bar{y}$. We are interested in the dependence of this functional response on a $\tilde{p}$-vector of covariates, $D=\left(D_{1}, \ldots, D_{\tilde{p}}\right)^{\prime} \in \mathbb{R}^{\tilde{p}}$, controlling for a $p$-vector of additional covariates $X=\left(X_{1}, \ldots, X_{p}\right)^{\prime} \in \mathbb{R}^{p}$. We allow both $\tilde{p}$ and $p$ to be (much) larger than the sample size of available data, $n$.

For each $u \in \mathcal{U}$, we assume that $Y_{u}$ satisfies the generalized linear model with the logistic link function

$$
\begin{equation*}
\mathrm{E}_{P}\left[Y_{u} \mid D, X\right]=\Lambda\left(D^{\prime} \theta_{u}+X^{\prime} \beta_{u}\right)+r_{u}, \tag{3.1}
\end{equation*}
$$

where $\theta_{u}=\left(\theta_{u 1}, \ldots, \theta_{u \tilde{p}}\right)^{\prime}$ is a vector of parameters that are of interest, $\beta_{u}=\left(\beta_{u 1}, \ldots, \beta_{u p}\right)^{\prime}$ is a vector of nuisance parameters, $r_{u}=r_{u}(D, X)$ is an approximation error, $\Lambda: \mathbb{R} \rightarrow \mathbb{R}$ is the logistic link function defined by

$$
\Lambda(t)=\frac{\exp (t)}{1+\exp (t)}, \quad t \in \mathbb{R}
$$

and $P \in \mathcal{P}_{n}$ is the distribution of the triple $W=(Y, D, X)$. As in the previous section, we construct simultaneous confidence bands for the parameters $\left(\theta_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ based on a random sample $\left(W_{i}\right)_{i=1}^{n}=\left(Y_{i}, D_{i}, X_{i}\right)_{i=1}^{n}$ from the distribution of $W=(Y, D, X)$.
3.2. Orthogonal Score Functions. Before setting up score functions that satisfy both the moment conditions (1.2) and the orthogonality condition (1.4), observe that "naive" score functions that follow directly from the model (3.1),

$$
m_{u j}\left(W, \theta_{u j}, \theta_{u[\tilde{p} \backslash j}, \beta_{u}, r_{u}\right)=\left\{Y_{u}-\Lambda\left(D_{j} \theta+X^{j}\left(\theta_{u[\tilde{p} \backslash \backslash j}^{\prime}, \beta_{u}^{\prime}\right)^{\prime}\right)-r_{u}\right\} D_{j},
$$

where $X^{j}=\left(D_{[\tilde{p} \backslash \backslash j}^{\prime}, X^{\prime}\right)$, satisfy the moment conditions $\mathrm{E}_{P}\left[m_{u j}\left(W, \theta_{u j}\right)\right]=0$ but violate the orthogonality condition (1.4) (with $m_{u j}$ replacing $\psi_{u j}$ and $\left.\eta_{u j}=\left(\theta_{u[\tilde{p}] \backslash j}, \beta_{u}, r_{u}\right)\right)$. To satisfy the orthogonality condition (1.4), we proceed using an approach from Section 2.2 as in the Introduction. Specifically, for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, define the ( $\tilde{p}+p-1)$-vector of additional nuisance
parameters $\gamma_{u}^{j}$ by (1.5) where $f_{u}^{2}=f_{u}^{2}(D, X)$ is defined in (1.6). Thus, by the first order condition of (1.5), the nuisance parameters $\gamma_{u}^{j}$ satisfy

$$
\begin{equation*}
f_{u} D_{j}=f_{u} X^{j} \gamma_{u}^{j}+v_{u}^{j}, \quad \mathrm{E}_{P}\left[f_{u} X^{j} v_{u}^{j}\right]=0 \tag{3.2}
\end{equation*}
$$

Also, denote $\beta_{u}^{j}=\left(\theta_{u[\tilde{p}] \backslash j}^{\prime}, \beta_{u}^{\prime}\right)^{\prime}$. Then we set

$$
\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)=\left\{Y_{u}-\Lambda\left(D_{j} \theta_{u j}+X^{j} \beta_{u}^{j}\right)-r_{u}\right\}\left(D_{j}-X^{j} \gamma_{u}^{j}\right),
$$

where the nuisance parameter is $\eta_{u j}=\left(r_{u}, \beta_{u}^{j}, \gamma_{u}^{j}\right)$. As we formally demonstrate in the proof of Theorem 3.1 below, this function satisfies the nearorthogonality condition (1.4).
3.3. Estimation Using Orthogonal Score Functions. Next, we discuss estimation of $\eta_{u j}$ 's and $\theta_{u j}$ 's. First, we assume that the approximation error $r_{u}=r_{u}(D, X)$ is asymptotically negligible, so that it can be estimated by $\mathcal{O}=\mathcal{O}(D, X)$, the identically zero function of $D$ and $X$. Second, for $\gamma_{u}^{j}$, we consider an estimator $\widetilde{\gamma}_{u}^{j}$ defined as a post-regularization weighted least squares estimator corresponding to the problem (1.5). Third, for $\beta_{u}^{j}$, we consider a plug-in estimator $\widehat{\beta}_{u}^{j}=\left(\widetilde{\theta}_{u[\tilde{p}] \backslash j}^{\prime}, \widetilde{\beta}_{u}^{\prime}\right)^{\prime}$, where $\widetilde{\theta}_{u}$ and $\widetilde{\beta}_{u}$ are suitable estimators of $\theta_{u}$ and $\beta_{u}$. In particular, we assume that $\widetilde{\theta}_{u}$ and $\widetilde{\beta}_{u}$ are post-regularization maximum likelihood estimators corresponding to the log-likelihood function $(\theta, \beta) \mapsto-M_{u}(W, \theta, \beta)$ where

$$
\begin{align*}
& M_{u}(W, \theta, \beta)=-\left(1\left\{Y_{u}=1\right\} \log \Lambda\left(D^{\prime} \theta+X^{\prime} \beta\right)\right. \\
& \left.\quad+1\left\{Y_{u}=0\right\} \log \left(1-\Lambda\left(D^{\prime} \theta+X^{\prime} \beta\right)\right)\right) . \tag{3.3}
\end{align*}
$$

The details of the estimators $\widetilde{\theta}_{u}, \widetilde{\beta}_{u}$, and $\widetilde{\gamma}_{u}^{j}$ are given in Algorithm 1 below. The results in this paper can also be easily extended to the case where $\widetilde{\theta}_{u}$, $\widetilde{\beta}_{u}$, and $\widetilde{\gamma}_{u}^{j}$ are replaced by penalized maximum likelihood estimators $\widehat{\theta}_{u}$ and $\widehat{\beta}_{u}$ and penalized weighted least squares estimator $\widehat{\gamma}_{u}^{j}$, respectively.

Then our estimator of $\eta_{u j}$ is $\widehat{\eta}_{u j}=\left(\mathcal{O}, \widehat{\beta}_{u}^{j}, \widetilde{\gamma}_{u}^{j}\right)$. Substituting this estimator into the score function $\psi_{u j}$ gives

$$
\begin{equation*}
\psi_{u j}\left(W, \theta_{u j}, \widehat{\eta}_{u j}\right)=\left\{Y_{u}-\Lambda\left(D_{j} \theta_{u j}+X^{j} \widehat{\beta}_{u}^{j}\right)\right\}\left(D_{j}-X^{j} \widetilde{\gamma}_{u}^{j}\right) \tag{3.4}
\end{equation*}
$$

which, using the sample analog (2.1) of the moment conditions (1.2), gives the following estimator of $\theta_{u j}$ :

$$
\begin{equation*}
\check{\theta}_{u j} \in \arg \inf _{\theta \in \Theta_{u j}}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)\right]\right| \tag{3.5}
\end{equation*}
$$

The algorithm is summarized as follows.

Algorithm 1. For each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ :
Step 1. Run post- $\ell_{1}$-penalized logistic estimator (4.2) of $Y_{u}$ on $D$ and $X$ to compute $\left(\widetilde{\theta}_{u}, \widetilde{\beta}_{u}\right)$.
Step 2. Define the weights $\widehat{f}_{u}^{2}=\widehat{f}_{u}^{2}(D, X)=\Lambda^{\prime}\left(D^{\prime} \widetilde{\theta}_{u}+X^{\prime} \widetilde{\beta}_{u}\right)$.
Step 3. Run the post-lasso estimator (4.5) of $\widehat{f}_{u} D_{j}$ on $\widehat{f}_{u} X^{j}$ to compute $\widetilde{\gamma}_{u}^{j}$. Step 4. Compute $\widehat{\beta}_{u}^{j}=\left(\widetilde{\theta}_{u[\tilde{p}] \backslash j}^{\prime}, \widetilde{\beta}_{u}^{\prime}\right)^{\prime}$.
Step 5. Solve (3.5) with $\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)$ defined in (3.4) to compute $\check{\theta}_{u j}$.
3.4. Regularity Conditions. Next, we specify our regularity conditions. For all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, denote $Z_{u}^{j}=D_{j}-X^{j} \gamma_{u}^{j}$. Also, denote $a_{n}=p \vee \tilde{p} \vee n$. Let $q, c_{1}$, and $C_{1}$ be some strictly positive (and finite) constants where $q>4$. Moreover, let $\left(\delta_{n}\right)_{n \geqslant 1}$ and $\left(\bar{\Delta}_{n}\right)_{n \geqslant 1}$ be some sequences of positive constants converging to zero. Finally, let $\left(M_{n, 1}\right)_{n \geqslant 1}$ and $\left(M_{n, 2}\right)_{n \geqslant 1}$ be some sequences of positive constants, possibly growing to infinity, where $M_{n, 1} \geqslant 1$ and $M_{n, 2} \geqslant 1$ for all $n$.

Assumption 3.1 (Parameters). For all $u \in \mathcal{U}$, we have $\left\|\theta_{u}\right\|+\left\|\beta_{u}\right\|+$ $\max _{j \in[\tilde{p}]}\left\|\gamma_{u}^{j}\right\| \leqslant C_{1}$ and $\max _{j \in[\tilde{p}]} \sup _{\theta \in \Theta_{u j}}|\theta| \leqslant C_{1}$. In addition, for all $u_{1}, u_{2} \in \mathcal{U}$, we have $\left(\left\|\theta_{u_{2}}-\theta_{u_{1}}\right\|+\left\|\beta_{u_{2}}-\beta_{u_{1}}\right\|\right) \leqslant C_{1}\left|u_{2}-u_{1}\right|$. Finally, for all $u \in \mathcal{U}$ and $j \in[\tilde{p}], \Theta_{u j}$ contains a ball of radius $(\log \log n)\left(\log a_{n}\right)^{3 / 2} / n^{1 / 2}$ centered at $\theta_{u j}$.

Assumption 3.2 (Sparsity). There exist $s=s_{n}$ and $\bar{\gamma}_{u}^{j}, u \in \mathcal{U}$ and $j \in[\tilde{p}]$, such that for all $u \in \mathcal{U},\left\|\beta_{u}\right\|_{0}+\left\|\theta_{u}\right\|_{0}+\max _{j \in[\tilde{p}]}\left\|\bar{\gamma}_{u}^{j}\right\|_{0} \leqslant s_{n}$ and $\max _{j \in[\hat{p}]}\left(\left\|\bar{\gamma}_{u}^{j}-\gamma_{u}^{j}\right\|+s_{n}^{-1 / 2}\left\|\bar{\gamma}_{u}^{j}-\gamma_{u}^{j}\right\|_{1}\right) \leqslant C_{1}\left(s_{n} \log a_{n} / n\right)^{1 / 2}$.

Assumption 3.3 (Distribution of $Y$ ). The conditional pdf of $Y$ given $(D, X)$ is bounded by $C_{1}$.

Assumptions 3.1-3.3 are mild and standard in the literature. In particular, Assumption 3.1 requires the parameter spaces $\Theta_{u j}$ to be bounded, and also requires that for each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, the parameter $\theta_{u j}$ to be sufficiently separated from the boundaries of the parameter space $\Theta_{u j}$. Assumption 3.2 requires approximate sparsity of the model (3.1). Note that in Assumption 3.2 , given that $\bar{\gamma}_{u}^{j}$,s exist, we can and will assume without loss of generality that $\bar{\gamma}_{u}^{j}=\gamma_{u T}^{j}$ for some $T \subset\{1, \ldots, p+\tilde{p}-1\}$ with $|T| \leqslant s_{n}$, where $T=T_{u}^{j}$ is allowed to depend on $u$ and $j$. Here the $(p+\tilde{p}-1)$-vector $\gamma_{u T}^{j}$ is defined from $\gamma_{u}^{j}$ by keeping all components of $\gamma_{u}^{j}$ that are in $T$ and setting all other components to be zero. Assumption 3.3 can be relaxed at the expense of more technicalities.

Assumption 3.4 (Covariates). For all $u \in \mathcal{U}$, the following inequalities hold: (i) $\inf _{\|\xi\|=1} \mathrm{E}_{P}\left[f_{u}^{2}\left\{\left(D^{\prime}, X^{\prime}\right) \xi\right\}^{2}\right] \geqslant c_{1}$, (ii) $\min _{j, k}\left(\mathrm{E}_{P}\left[\left|f_{u}^{2} Z_{u}^{j} X_{k}^{j}\right|^{2}\right] \wedge\right.$ $\left.\mathrm{E}_{P}\left[\left|f_{u}^{2} D_{j} X_{k}^{j}\right|^{2}\right]\right) \geqslant c_{1}$, and (iii) $\max _{j, k} \mathrm{E}_{P}\left[\left|Z_{u}^{j} X_{k}^{j}\right|^{3}\right]^{1 / 3} \log ^{1 / 2} a_{n} \leqslant \delta_{n} n^{1 / 6}$. In addition, we have that (iv) $\sup _{\|\xi\|=1} \mathrm{E}_{P}\left[\left\{\left(D^{\prime}, X^{\prime}\right) \xi\right\}^{4}\right] \leqslant C_{1}$, (v) $M_{n, 1} \geqslant$ $\mathrm{E}_{P}\left[\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|Z_{u}^{j}\right|^{2 q}\right]^{1 /(2 q)}$, (vi) $M_{n, 1}^{2} s_{n} \log a_{n} \leqslant \delta_{n} n^{1 / 2-1 / q}$, (vii) $M_{n, 2} \geqslant$ $\left\{\mathrm{E}_{P}\left[\left(\|D\|_{\infty} \vee\|X\|_{\infty}\right)^{2 q}\right]\right\}^{1 /(2 q)}$, (viii) $M_{n, 2}^{2} s_{n} \log ^{1 / 2} a_{n} \leqslant \delta_{n} n^{1 / 2-1 / q}$, and (ix) $M_{n, 1}^{2} M_{n, 2}^{4} s_{n} \leqslant \delta_{n} n^{1-3 / q}$.

This assumption requires that there is no multicollinearity between covariates in vectors $D$ and $X$. In addition, it requires that the constants $\underline{y}$ and $\bar{y}$ are chosen so that the probabilities of $Y<\bar{y}$ and $Y>y$ are both non-vanishing since otherwise we would have $\mathrm{E}\left[f_{u}^{2}\right]=\mathrm{E}\left[\operatorname{Var}_{P}\left(\overline{Y_{u}} \mid D, X\right)\right]$ vanishing either for $u=0$ or $u=1$ violating Assumption 3.4(i). Intuitively, sending $\underline{y}$ and $\bar{y}$ to the left and to the right tails of the distribution of $Y$, respectively, would blow up the variance of the estimators $\check{\theta}_{u j}$, given by $\sigma_{u j}^{2}$ in Theorem 2.1, and leading eventually to the estimators with slower-than$\sqrt{n}$ rate of convergence. Although our results could be extended to allow for the case where $y$ and $\bar{y}$ are sent to the tails of the distribution of $Y$ slowly, we skip this extension for the sake of clarity. Moreover, Assumption 3.4 imposes constraints on various moments of covariates. Since these constraints might be difficult to grasp, at the end of this section, in Corollary 3.3, we provide an example for which these constraints simplify into easily interpretable conditions.

Assumption 3.5 (Approximation error). For all $u \in \mathcal{U}$, we have (i) $\sup _{\|\xi\|=1} \mathrm{E}_{P}\left[r_{u}^{2}\left\{\left(D^{\prime}, X^{\prime}\right) \xi\right\}^{2}\right] \leqslant C_{1} \mathrm{E}_{P}\left[r_{u}^{2}\right]$, (ii) $\mathrm{E}_{P}\left[r_{u}^{2}\right] \leqslant C_{1} s_{n} \log a_{n} / n$, (iii) $\max _{j \in[\tilde{p}]}\left|\mathrm{E}_{P}\left[r_{u} Z_{u}^{j}\right]\right| \leqslant \delta_{n} n^{-1 / 2}$, and (iv) $\left|r_{u}(D, X)\right| \leqslant f_{u}^{2}(D, X) / 4$ almost surely. In addition, with probability $1-\bar{\Delta}_{n}$, (v) $\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left(\mathbb{E}_{n}\left[\left(r_{u} Z_{u}^{j} / f_{u}\right)^{2}\right]+\right.$ $\left.\mathbb{E}_{n}\left[r_{u}^{2} / f_{u}^{6}\right]\right) \leqslant C_{1} s_{n} \log a_{n} / n$.

This assumption requires the approximation error $r_{u}=r_{u}(D, X)$ to be sufficiently small. Under Assumption 3.4, the first condition of Assumption 3.5 holds if the approximation error is such that $r_{u}^{2} \leqslant C \mathrm{E}_{P}\left[r_{u}^{2}\right]$ almost surely for some constant $C$.
3.5. Formal Results. Under specified assumptions, our estimators $\check{\theta}_{u j}$ satisfy the following uniform Bahadur representation theorem.

Theorem 3.1 (Uniform Bahadur representation for logistic model). Suppose that Assumptions 3.1-3.5 hold for all $P \in \mathcal{P}_{n}$. In addition, suppose
that the following growth condition holds: $\delta_{n}^{2} \log a_{n}=o(1)$. Then for the estimators $\check{\theta}_{u j}$ satisfying (3.5), we have

$$
\begin{equation*}
\sqrt{n} \sigma_{u j}^{-1}\left(\check{\theta}_{u j}-\theta_{u j}\right)=\mathbb{G}_{n} \bar{\psi}_{u j}+O_{P}\left(\delta_{n}\right) \text { in } \ell^{\infty}(\mathcal{U} \times[\tilde{p}]) \tag{3.6}
\end{equation*}
$$

uniformly over $P \in \mathcal{P}_{n}$, where $\bar{\psi}_{u j}(W):=-\sigma_{u j}^{-1} J_{u j}^{-1} \psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right), \sigma_{u j}^{2}:=$ $\mathrm{E}_{P}\left[J_{u j}^{-2} \psi_{u j}^{2}\left(W, \theta_{u j}, \eta_{u j}\right)\right]$, and $J_{u j}$ is defined in (2.3).

This theorem allows us to establish a Gaussian approximation result for the supremum of the process $\left\{\sqrt{n} \sigma_{u j}^{-1}\left(\check{\theta}_{u j}-\theta_{u j}\right): u \in \mathcal{U}, j \in[\tilde{p}]\right\}$ :

Corollary 3.1 (Gaussian approximation for logistic model). Suppose that Assumptions $3.1-3.5$ hold for all $P \in \mathcal{P}_{n}$. In addition, suppose that the following growth conditions hold: $\delta_{n}^{2} \log a_{n}=o(1), M_{n, 1}^{2 / 7} \log a_{n}=o\left(n^{1 / 7}\right)$, and $M_{n, 1}^{2 / 3} \log a_{n}=o\left(n^{1 / 3-2 /(3 q)}\right)$. Then

$$
\sup _{t \in \mathbb{R}}\left|\mathrm{P}_{P}\left(\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\sqrt{n} \sigma_{u j}^{-1}\left(\check{\theta}_{u j}-\theta_{u j}\right)\right| \leqslant t\right)-\mathrm{P}_{P}\left(\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\mathcal{N}_{u j}\right| \leqslant t\right)\right|=o(1)
$$

uniformly over $P \in \mathcal{P}_{n}$, where $\left(\mathcal{N}_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$ is a tight zero-mean Gaussian process indexed by $\mathcal{U} \times[\tilde{p}]$ with the covariance given by $\mathrm{E}_{P}\left[\bar{\psi}_{u j}(W) \bar{\psi}_{u^{\prime} j^{\prime}}(W)\right]$ for $u, u^{\prime} \in \mathcal{U}$ and $j, j^{\prime} \in[\tilde{p}]$.

Based on this corollary, we are now able to construct simultaneous confidence bands for the parameters $\theta_{u j}$. Observe that

$$
J_{u j}=-\mathrm{E}_{P}\left[\Lambda^{\prime}\left(D_{j} \theta_{u j}+X^{j} \beta_{u}^{j}\right) D_{j}\left(D_{j}-X^{j} \gamma_{u}^{j}\right)\right], \quad u \in \mathcal{U}, j \in[\tilde{p}]
$$

and so it can be estimated by

$$
\widehat{J}_{u j}=-\mathbb{E}_{n}\left[\Lambda^{\prime}\left(D_{j} \widetilde{\theta}_{u j}+X^{j} \widehat{\beta}_{u}^{j}\right) D_{j}\left(D_{j}-X^{j} \widetilde{\gamma}_{u}^{j}\right)\right], \quad u \in \mathcal{U}, j \in[\tilde{p}],
$$

In addition, $\sigma_{u j}^{2}=\mathrm{E}_{P}\left[J_{u j}^{-2} \psi_{u j}^{2}\left(W, \theta_{u j}, \eta_{u j}\right)\right]$, and so it can be estimated by

$$
\widehat{\sigma}_{u j}^{2}=\mathbb{E}_{n}\left[\widehat{J}_{u j}^{-2} \psi_{u j}^{2}\left(W, \widetilde{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right], \quad u \in \mathcal{U}, j \in[\tilde{p}],
$$

Moreover, as in Section 2, define $\widehat{\psi}_{u j}(W)=-\widehat{\sigma}_{u j}^{-1} \widehat{J}_{u j}^{-1} \psi_{u j}\left(W, \check{\theta}_{u j}, \widehat{\eta}_{u j}\right)$, and let $c_{\alpha}$ be the $(1-\alpha)$ quantile of the conditional distribution of $\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\widehat{\mathcal{G}}_{u j}\right|$ given the data $\left(W_{i}\right)_{i=1}^{n}$ where the process $\widehat{\mathcal{G}}=\left(\widehat{\mathcal{G}}_{u j}\right)_{u \in \mathcal{U}, j \in[\hat{p}]}$ is defined in (2.8). Then we have

Corollary 3.2 (Simultaneous confidence bands for logistic model). Suppose that Assumptions 3.1-3.5 hold for all $P \in \mathcal{P}_{n}$. In addition, suppose that the following growth conditions hold: $\delta_{n}^{2} \log a_{n}=o(1), M_{n, 1}^{2 / 7} \log a_{n}=$ $o\left(n^{1 / 7}\right), M_{n, 1}^{2 / 3} \log a_{n}=o\left(n^{1 / 3-2 /(3 q)}\right)$, and $s_{n} \log ^{3} a_{n}=o(n)$. Then (1.3) holds uniformly over $P \in \mathcal{P}_{n}$.

To conclude this section, we provide an example for which conditions of Corollary 3.2 are easy to interpret. Recall that $a_{n}=n \vee p \vee \tilde{p}$.

Corollary 3.3 (Uniform confidence bands for logistic regression model under simple conditions). Suppose that Assumptions 3.1-3.3, 3.4(i,ii,iv), and 3.5(i,ii,iv,v) hold for $q>4$ for all $P \in \mathcal{P}_{n}$. In addition, suppose that $\left\{\mathrm{E}_{P}\left[\left(\|D\|_{\infty} \vee\|X\|_{\infty}\right)^{2 q}\right]\right\}^{1 /(2 q)} \leqslant C_{1}$ and $\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left\|\gamma_{u}^{j}\right\|_{1} \leqslant C_{1}$. Moreover, suppose that the following growth conditions hold: $\log ^{7} a_{n} / n=o(1)$, $s_{n}^{2} \log ^{3} a_{n} / n^{1-2 / q}=o(1)$, and $\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\mathrm{E}_{P}\left[r_{u} Z_{u}^{j}\right]\right|=o\left(\left(n \log a_{n}\right)^{-1 / 2}\right)$. Then (1.3) holds uniformly over $P \in \mathcal{P}_{n}$.

Comment 3.1 (Estimation of variance). When constructing the confidence bands based on (1.3), we find in simulations that it is beneficial to replace the estimators $\widehat{\sigma}_{u j}^{2}$ of $\sigma_{u j}^{2}$ by $\max \left\{\widehat{\sigma}_{u j}^{2}, \widehat{\Sigma}_{u j}^{2}\right\}$ where $\widehat{\Sigma}_{u j}^{2}=\mathbb{E}_{n}\left[\widehat{f}_{u}^{2}(D-\right.$ $\left.\left.X^{j} \widetilde{\gamma}_{u}^{j}\right)^{2}\right]$ is an alternative consistent estimator of $\sigma_{u j}^{2}$.

Comment 3.2 (Alternative implementations, double selection). We note that the theory developed here is applicable for different estimators that construct the new score function with the desired orthogonality condition implicitly. For example, the double selection idea yields an implementation of an estimator that is first-order equivalent to the estimator based on the score function. The algorithm yielding the double selection estimator is as follows.

Algorithm 2. For each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ :
Step $1^{\prime}$. Run post- $\ell_{1}$-penalized logistic estimator (4.2) of $Y_{u}$ on $D$ and $X$ to compute $\left(\widetilde{\theta}_{u}, \widetilde{\beta}_{u}\right)$.
Step $2^{\prime}$. Define the weights $\widehat{f}_{u}^{2}=\widehat{f}_{u}^{2}(D, X)=\Lambda^{\prime}\left(D_{i}^{\prime} \widetilde{\theta}_{u}+X_{i}^{\prime} \widetilde{\beta}_{u}\right)$.
Step $3^{\prime}$. Run the lasso estimator (4.4) of $\widehat{f}_{u} D_{j}$ on $\widehat{f}_{u} X$ to compute $\widehat{\gamma}_{u}^{j}$.
Step $4^{\prime}$. Run logistic regression of $Y_{u}$ on $D_{j}$ and all the selected variables in Steps $1^{\prime}$ and $3^{\prime}$ to compute $\check{\theta}_{u j}$.

As mentioned by a referee, it is surprising that the double selection procedure has uniform validity. The use of the additional variables selected in Step

3', through the first order conditions of the optimization problem, induces the necessary near-orthogonality condition. We refer to the Supplementary Material for a more detailed discussion.

Comment 3.3 (Alternative implementations, one-step correction). Another implementation for which the theory developed here applies is to replace Step 5 in Algorithm 1 with a one-step procedure. This relates to the debiasing procedure proposed in [42] to the case when the set $\mathcal{U}$ is a singleton. In this case instead of minimizing the criterion (3.5) in Step 5, the method makes a full Newton step from the initial estimate, Step $5^{\prime \prime}$. Compute $\bar{\theta}_{u j}=\widehat{\theta}_{u j}-\widehat{J}_{u j}^{-1} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \widehat{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]$.
The theory developed here directly apply to those estimators as well.
Comment 3.4 (Extension to other approximately sparse generalized linear models). Inspecting the proofs of Theorem 3.1 and Corollaries 3.1-3.3 reveals that these results can be extended with minor modifications to cover other approximately sparse generalized linear models. For example, the results can be extended to cover the model (3.1) where we use the probit link function instead of the logit link function $\Lambda$.
4. $\ell_{1}$-Penalized M-Estimators: Nuisance Functions $\underset{\sim}{\text { and }}$ Functional Data. In this section, we define the estimators $\widetilde{\theta}_{u}, \widetilde{\beta}_{u}$, and $\widetilde{\gamma}_{u}^{j}$, which were used in the previous section, and study their properties. We consider the same setting as that in the previous section. The results in this section rely upon a set of new results for $\ell_{1}$-penalized $M$-estimators with functional data presented in Appendix J of the Supplementary Material.
4.1. $\ell_{1}$-Penalized Logistic Regression for Functional Response Data: Asymptotic Properties. Here we consider the generalized linear model with the logistic link function and functional response data (3.1). As explained in the previous section, we assume that $\widetilde{\theta}_{u}$ and $\widetilde{\beta}_{u}$ are post-regularization maximum likelihood estimators of $\theta_{u}$ and $\beta_{u}$ corresponding to the log-likelihood function $M_{u}(W, \theta, \beta)=M_{u}\left(Y_{u}, D, X, \theta, \beta\right)$ defined in (3.3). To define these estimators, let $\widehat{\theta}_{u}$ and $\widehat{\beta}_{u}$ be $\ell_{1}$-penalized maximum likelihood (logistic regression) estimators

$$
\begin{equation*}
\left(\widehat{\theta}_{u}, \widehat{\beta}_{u}\right) \in \arg \min _{\theta, \beta}\left(\mathbb{E}_{n}\left[M_{u}\left(Y_{u}, D, X, \theta, \beta\right)\right]+\frac{\lambda}{n}\left\|\widehat{\Psi}_{u}\left(\theta^{\prime}, \beta^{\prime}\right)^{\prime}\right\|_{1}\right) \tag{4.1}
\end{equation*}
$$

where $\lambda$ is a penalty level and $\widehat{\Psi}_{u}$ a diagonal matrix of penalty loadings. We choose parameters $\lambda$ and $\widehat{\Psi}_{u}$ according to Algorithm 3 described below. Using the $\ell_{1}$-penalized estimators $\widehat{\theta}_{u}$ and $\widehat{\beta}_{u}$, we then define post-regularization
estimators $\widetilde{\theta}_{u}$ and $\widetilde{\beta}_{u}$ by

$$
\begin{equation*}
\left(\widetilde{\theta}_{u}, \widetilde{\beta}_{u}\right) \in \arg \min _{\theta} \mathbb{E}_{n}\left[M_{u}\left(Y_{u}, D, X, \theta, \beta\right)\right]: \operatorname{supp}(\theta, \beta) \subseteq \operatorname{supp}\left(\widehat{\theta}_{u}, \widehat{\beta}_{u}\right) \tag{4.2}
\end{equation*}
$$

We derive the rate of convergence and sparsity properties of $\widetilde{\theta}_{u}$ and $\widetilde{\beta}_{u}$ as well as of $\widehat{\theta}_{u}$ and $\widehat{\beta}_{u}$ in Theorem 4.1 below. Recall that $a_{n}=n \vee p \vee \tilde{p}$.

Algorithm 3 (Penalty Level and Loadings for Logistic Regression). Choose $\gamma \in[1 / n, 1 / \log n]$ and $c>1$ (in practice, we set $c=1.1$ and $\gamma=.1 / \log n)$. Define $\lambda=c \sqrt{n} \Phi^{-1}\left(1-\gamma /\left(2(p+\tilde{p}) N_{n}\right)\right)$ with $N_{n}=n$. To select $\widehat{\Psi}_{u}$, choose a constant $\bar{m} \geqslant 0$ as an upper bound on the number of loops and proceed as follows: (0) Let $\widetilde{X}=\left(D^{\prime}, X^{\prime}\right)^{\prime}, m=0$, and initialize $\widehat{l}_{u k, 0}=\frac{1}{2}\left\{\mathbb{E}_{n}\left[\widetilde{X}_{k}^{2}\right]\right\}^{1 / 2}$ for $k \in[p+\tilde{p}]$. (1) Compute $\left(\widehat{\theta}_{u}, \widehat{\beta}_{u}\right)$ and $\left(\widetilde{\theta}_{u}, \widetilde{\beta}_{u}\right)$ based on $\widehat{\Psi}_{u}=\operatorname{diag}\left(\left\{\widehat{l}_{u k, m}, k \in[p+\tilde{p}]\right\}\right)$. (2) Set $\widehat{l}_{u k, m+1}:=\left\{\mathbb{E}_{n}\left[\widetilde{X}_{k}^{2}\left(Y_{u}-\right.\right.\right.$ $\left.\left.\left.\Lambda\left(D^{\prime} \widetilde{\theta}_{u}+X^{\prime} \widetilde{\beta}_{u}\right)\right)^{2}\right]\right\}^{1 / 2}$. (3) If $m \geqslant \bar{m}$, report the current value of $\widehat{\Psi}_{u}$ and stop; otherwise set $m \leftarrow m+1$ and go to step (1).

Theorem 4.1 (Rates and Sparsity for Functional Response under Logistic Link). Suppose that Assumptions 3.1-3.5 hold for all $P \in \mathcal{P}_{n}$. In addition, suppose that the penalty level $\lambda$ and the matrices of penalty loadings $\widehat{\Psi}_{u}$ are chosen according to Algorithm 3. Moreover, suppose that the following growth condition holds: $\delta_{n}^{2} \log a_{n}=o(1)$. Then there exists a constant $\bar{C}$ such that uniformly over all $P \in \mathcal{P}_{n}$ with probability $1-o(1)$,

$$
\begin{aligned}
& \sup _{u \in \mathcal{U}}\left(\left\|\widehat{\theta}_{u}-\theta_{u}\right\|+\left\|\widehat{\beta}_{u}-\beta_{u}\right\|\right) \leqslant \bar{C} \sqrt{\frac{s_{n} \log a_{n}}{n}} \\
& \sup _{u \in \mathcal{U}}\left(\left\|\widehat{\theta}_{u}-\theta_{u}\right\|_{1}+\left\|\widehat{\beta}_{u}-\beta_{u}\right\|_{1}\right) \leqslant \bar{C} \sqrt{\frac{s_{n}^{2} \log a_{n}}{n}}
\end{aligned}
$$

and the estimators $\widehat{\theta}_{u}$ and $\widehat{\beta}_{u}$ are uniformly sparse: $\sup _{u \in \mathcal{U}}\left\|\widehat{\theta}_{u}\right\|_{0}+\left\|\widehat{\beta}_{u}\right\|_{0} \leqslant$ $\bar{C} s_{n}$. Also, uniformly over all $P \in \mathcal{P}_{n}$, with probability $1-o(1)$,

$$
\begin{aligned}
& \sup _{u \in \mathcal{U}}\left(\left\|\widetilde{\theta}_{u}-\theta_{u}\right\|+\left\|\widetilde{\beta}_{u}-\beta_{u}\right\|\right) \leqslant \bar{C} \sqrt{\frac{s_{n} \log a_{n}}{n}}, \\
& \sup _{u \in \mathcal{U}}\left(\left\|\widetilde{\theta}_{u}-\theta_{u}\right\|_{1}+\left\|\widetilde{\beta}_{u}-\beta_{u}\right\|_{1}\right) \leqslant \bar{C} \sqrt{\frac{s_{n}^{2} \log a_{n}}{n}} .
\end{aligned}
$$

4.2. Lasso with Estimated Weights: Asymptotic Properties. Here we consider the weighted linear model (3.2) for $u \in \mathcal{U}$ and $j \in[\tilde{p}]$. Using the parameter $\bar{\gamma}_{u}^{j}$ appearing in Assumption 3.2, it will be convenient to rewrite
this model as

$$
\begin{equation*}
f_{u} D_{j}=f_{u} X^{j} \bar{\gamma}_{u}^{j}+f_{u} \bar{r}_{u j}+v_{u}^{j}, \quad \mathrm{E}_{P}\left[f_{u} X^{j} v_{u}^{j}\right]=0 \tag{4.3}
\end{equation*}
$$

where $\bar{r}_{u j}=X^{j}\left(\gamma_{u}^{j}-\bar{\gamma}_{u}^{j}\right)$ is an approximation error, which is asymptotically negligible under Assumption 3.2. As explained in the previous section, we assume that $\widetilde{\gamma}_{u}^{J}$ is a post-regularization weighted least squares estimator of $\gamma_{u}^{j}$ (or $\bar{\gamma}_{u}^{j}$ ). To define this estimator, let $\widehat{\gamma}_{u}^{j}$ be an $\ell_{1}$-penalized (weighted Lasso) estimator

$$
\begin{equation*}
\widehat{\gamma}_{u}^{j} \in \arg \min _{\gamma}\left(\frac{1}{2} \mathbb{E}_{n}\left[\hat{f}_{u}^{2}\left(D_{j}-X^{j} \gamma\right)^{2}\right]+\frac{\lambda}{n}\left\|\widehat{\Psi}_{u j} \gamma\right\|_{1}\right) \tag{4.4}
\end{equation*}
$$

where $\lambda$ and $\widehat{\Psi}_{u j}$ are the associated penalty level and the diagonal matrix of penalty loadings specified below in Algorithm 4 and where $\widehat{f}_{u}^{2}$ 's are estimated weights. As in Algorithm 1 in the previous section, we set $\widehat{f}_{u}^{2}=\widehat{f}_{u}^{2}(D, X)=\Lambda^{\prime}\left(D^{\prime} \widetilde{\theta}_{u}+X^{\prime} \widetilde{\beta}_{u}\right)$. Using $\widehat{\gamma}_{u}^{j}$, we define a post-regularized weighted least squares estimator

We derive the rate of convergence and sparsity properties of $\widetilde{\gamma}_{u}^{j}$ as well as of $\widehat{\gamma}_{u}^{j}$ in Theorem 4.2 below.

Algorithm 4 (Penalty Level and Loadings for Weighted Lasso). Choose $\gamma \in[1 / n, 1 / \log n]$ and $c>1$ (in practice, we set $c=1.1$ and $\gamma=.1 / \log n$ ). Define $\lambda=c \sqrt{n} \Phi^{-1}\left(1-\gamma /\left(2(p+\tilde{p}) N_{n}\right)\right)$ with $N_{n}=p \tilde{p}^{2} n^{2}$. To select $\widehat{\Psi}_{u j}$, choose a constant $\bar{m} \geqslant 1$ as an upper bound on the number of loops and proceed as follows: (0) Set $m=0$ and $\widehat{l}_{u j k, 0}=\max _{1 \leqslant i \leqslant n}\left\|\widehat{f}_{u i} X_{i}^{j}\right\|_{\infty}\left\{\mathbb{E}_{n}\left[\widehat{f}_{u}^{2} D_{j}^{2}\right]\right\}^{1 / 2}$. (1) Compute $\widehat{\gamma}_{u}^{j}$ and $\widetilde{\gamma}_{u}^{j}$ based on $\widehat{\Psi}_{u j}=\operatorname{diag}\left(\left\{\widehat{l}_{u j k, m}, k \in[p+\tilde{p}-1]\right\}\right)$. (2) Set $\widehat{l}_{u j k, m+1}:=\left\{\mathbb{E}_{n}\left[\widehat{f}_{u}^{4}\left(D_{j}-X^{j} \widetilde{\gamma}_{u}^{j}\right)^{2}\left(X_{k}^{j}\right)^{2}\right]\right\}^{1 / 2}$. (3) If $m \geqslant \bar{m}$, report the current value of $\widehat{\Psi}_{u}^{j}$ and stop; otherwise set $m \leftarrow m+1$ and go to step (1).

Theorem 4.2 (Rates and Sparsity for Lasso with Estimated Weights). Suppose that Assumptions 3.1-3.5 hold for all $P \in \mathcal{P}_{n}$. In addition, suppose that the penalty level $\lambda$ and the matrices of penalty loadings $\widehat{\Psi}_{u j}$ are chosen according to Algorithm 4. Moreover, suppose that the following growth condition holds: $\delta_{n}^{2} \log a_{n}=o(1)$. Then there exists a constant $\bar{C}$ such that uniformly over all $P \in \mathcal{P}_{n}$ with probability $1-o(1)$,

and the estimator $\widehat{\gamma}_{u}^{j}$ is uniformly sparse, $\max _{j \in[\hat{p}]} \sup _{u \in \mathcal{U}}\left\|\widehat{\gamma}_{u}^{j}\right\|_{0} \leqslant \bar{C} s_{n}$. Also, uniformly over all $P \in \mathcal{P}_{n}$, with probability $1-o(1)$,

5. Monte Carlo Simulations. In this section we provide a simulation study to investigate the finite sample properties of the proposed estimators and the associated confidence regions. We report only the performance of the estimator based on the double selection procedure due to space constraints and note that it is very similar to the performance of the estimator based on score functions with near-orthogonality property. We will compare the proposed procedure with the traditional estimator that refits the model selected by the corresponding $\ell_{1}$-penalized M -estimator (naive post-selection estimator).

We consider a logistic regression model with functional response data where the response $Y_{u}=1\{y \leqslant u\}$ for $u \in \mathcal{U}$ a compact set. We specify two different designs: (1) a location model, $y=x^{\prime} \beta_{0}+\xi$, where $\xi$ is distributed as a logistic random variable, the first component of $x$ is the intercept and the other $p-1$ components are distributed as $N(0, \Sigma)$ with $\Sigma_{k, j}=|0.5|^{|k-j|}$; (2) a location-shift model, $y=\left\{\left(x^{\prime} \beta_{0}+\xi\right) / x^{\prime} \vartheta_{0}\right\}^{3}$, where $\xi$ is distributed as a logistic random variable, $x_{j}=\left|w_{j}\right|$ where $w$ is a $p$-vector distributed as $N(0, \Sigma)$ with $\Sigma_{k, j}=|0.5|^{|k-j|}$, and $\vartheta_{0}$ has non-negative components. Such specification implies that for each $u \in \mathcal{U}$

Design 1: $\theta_{u}=u(1,0, \ldots, 0)^{\prime}-\beta_{0}$ and Design 2: $\theta_{u}=u^{1 / 3} \vartheta_{0}-\beta_{0}$.
In our simulations we will consider $n=500$ and $p=2000$. For the location model (Design 1) we will consider two different choices for $\beta_{0}$ : (i) $\beta_{0 j}^{(i)}=2 / j^{2}$ for $j=1, \ldots, p$, and (ii) $\beta_{0 j}^{(i i)}=(1 / 2) /\{j-3.5\}^{2}$ for $j>1$ with the intercept coefficient $\beta_{01}^{(i i)}=-10$. (These choices ensure $\max _{j>1}\left|\beta_{0 j}\right|=2$ and that $y$ is around zero in Design 2(ii).) We set $\vartheta_{0}=\frac{1}{8}(1,1,1,1,0,0, \ldots, 0,0,1,1,1,1)^{\prime}$. For Design 1 we have $\mathcal{U}=[1,2.5]$ and for Design 2 we have $\mathcal{U}=[-.5, .5]$. The results are based on 500 replications (the bootstrap procedure is performed 5000 times for each replication).

We report the (empirical) rejection frequencies for confidence regions with $95 \%$ nominal coverage. That is, the fraction of simulations the confidence regions of a particular method did not cover the true value (thus 0.05 rejection frequency is the ideal performance). We report the rejection frequencies for the proposed estimator and the post-naive selection estimator.

We report the pointwise rejection frequencies of each method for (pointwise) confidence intervals for each $j \in\{1, \ldots, 5\}$. For Design 1 we used $\mathcal{U}=\{1\}$ and for Design 2 we used $\mathcal{U}=\{.5\}$. The results are based on 500 replications.

Table 1 presents the performance of the methods when applied to construct a confidence interval for a single parameter ( $\tilde{p}=1$ and $\mathcal{U}$ is a singleton). Since the setting is not symmetric we investigate the performance for different components. Specifically, we consider $\{u\} \times\{j\}$ for $j=1, \ldots, 5$. First consider the location model (Design 1). The difference between the performance of the naive estimator for Design 1(i) and 1(ii) highlights its fragile performance which is highly dependent on the unknown parameters. We can see from Table 1 that in Design 1(i) the Naive method achieve (pointwise) rejection frequencies up to 0.162 when the nominal level is 0.05 . In Design 1(ii) it can be as high as 0.886 . We also note that it is important to look at the performance of each component and avoid averaging across components (large $j$ components are essentially not in the model, indeed for $j>50$ we obtain rejection frequencies very close to 0.05 regardless of the model selection procedure). In contrast the proposed estimator exhibits a much more robust behavior. For Design 1(i) the rejection frequencies are between 0.040 and 0.062 while for Design 1(ii) the rejection frequencies of the proposed estimator are between 0.040 and 0.056 .

Table 2 presents the performance for simultaneous confidence bands of the form $\left\{\left[\tilde{\theta}_{u j}-\operatorname{cv} \tilde{\sigma}_{u j}, \tilde{\theta}_{u j}+\operatorname{cv} \tilde{\sigma}_{u j}\right]\right.$ for $\left.u \in \mathcal{U} \times[\tilde{p}]\right\}$ where $\tilde{\theta}_{u j}$ is a point estimate, $\tilde{\sigma}_{u j}$ is an estimate of the pointwise standard deviation, and cv is a critical value that accounts for the uniform estimation. For the point estimate we consider the proposed estimator and the post-naive selection estimator which have estimates of standard deviation. We consider two critical values: from the multiplier bootstrap (MB) procedure and the Bonferroni (BF) correction (which we expect to be conservative). For each of the four different designs (1(i), 1(ii), 2(i) and 2(ii) described above), we consider four different choices of $\mathcal{U} \times[\tilde{p}]$. Table 2 displays rejection frequencies for confidence regions with

We report the rejection frequencies of each method for the (uniform) confidence bands for $\mathcal{U} \times[\tilde{p}]$. The proposed estimator computes the critical value based on the multiplier bootstrap procedure. For the naive post-selection estimator we report the results for two choices of critical values, one choice based on the multiplier bootstrap (MB), and another based on Bonferroni (BF) correction. The results are based on 500 replications.
$95 \%$ nominal coverage (and again .05 would be the ideal performance). The simulation results confirms the differences between the performance of the methods and overall the proposed procedure is closer to the nominal value of .05 . The proposed estimator performed within a factor of two to the nominal value in 10 out of the 16 designs considered (and 13 out 16 within a factor of three). The post-naive selection estimator performed within a factor of two only in 3 out of the 16 designs when using the multiplier bootstrap as critical value ( 7 out of 16 within a factor of three) and similarly with the Bonferroni correction as the critical value.

## APPENDIX A: PROOFS FOR SECTION 2

In this appendix, we use $C$ to denote a strictly positive constant that is independent of $n$ and $P \in \mathcal{P}_{n}$. The value of $C$ may change at each appearance. Also, the notation $a_{n} \lesssim b_{n}$ means that $a_{n} \leqslant C b_{n}$ for all $n$ and some $C$. The notation $a_{n} \gtrsim b_{n}$ means that $b_{n} \lesssim a_{n}$. Moreover, the notation $a_{n}=o(1)$ means that there exists a sequence $\left(b_{n}\right)_{n \geqslant 1}$ of positive numbers such that (i) $\left|a_{n}\right| \leqslant b_{n}$ for all $n$, (ii) $b_{n}$ is independent of $P \in \mathcal{P}_{n}$ for all $n$, and (iii) $b_{n} \rightarrow 0$ as $n \rightarrow \infty$. Finally, the notation $a_{n}=O_{P}\left(b_{n}\right)$ means that for all $\epsilon>0$, there exists $C$ such that $\mathrm{P}_{P}\left(a_{n}>C b_{n}\right) \leqslant 1-\epsilon$ for all $n$. Using this notation allows us to avoid repeating "uniformly over $P \in \mathcal{P}_{n}$ " many times in the proofs of Theorem 2.1 and Corollaries 2.1 and 2.2. Throughout this
appendix, we assume that $n \geqslant n_{0}$.
Proof of Theorem 2.1. We split the proof into five steps.
Step 1. (Preliminary Rate Result). We claim that with probability 1 $o(1), \sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\check{\theta}_{u j}-\theta_{u j}\right| \lesssim B_{1 n} \tau_{n}$. \begin{gather*}
\mathrm{E}_{P}\left[\psi_{u j}(W, \theta, \eta)\right]-\mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]=J_{u j}\left(\theta-\theta_{u j}\right)+\mathrm{D}_{u, j, 0}\left[\eta-\eta_{u j}\right] \\
\quad+\left.2^{-1} \partial_{r}^{2} \mathrm{E}_{P}\left[W, \theta_{u j}+r\left(\theta-\theta_{u j}\right), \eta_{u j}+r\left(\eta-\eta_{u j}\right)\right]\right|_{r=\bar{r}} \tag{A.6}
\end{gather*}
$$

for some $\bar{r} \in(0,1)$. Substituting this equality into (A.5), taking $\theta=\check{\theta}_{u j}$ and $\eta=\widehat{\eta}_{u j}$, and using (A.4) gives

$$
\begin{align*}
& \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]+J_{u j}\left(\check{\theta}_{u j}-\theta_{u j}\right)+\mathrm{D}_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]\right| \\
& \quad \leqslant \epsilon_{n} \sqrt{n}+\inf _{\theta \in \Theta_{u j}} \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)\right]\right|+\left|I I_{1}(u, j)\right|+\left|I I_{2}(u, j)\right|, \tag{A.7}
\end{align*}
$$

where

$$
\begin{aligned}
& I I_{1}(u, j):=\sqrt{n} \sup _{r \in[0,1)}\left|\partial_{r}^{2} \mathrm{E}_{P}\left[\psi_{u j}\left(W, \theta_{u j}+r\left(\theta-\theta_{u j}\right), \eta_{u j}+r\left\{\eta-\eta_{u j}\right\}\right)\right]\right| \\
& I I_{2}(u, j):=\mathbb{G}_{n}\left(\psi_{u j}(W, \theta, \eta)-\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right)
\end{aligned}
$$

with $\theta=\check{\theta}_{u j}$ and $\eta=\widehat{\eta}_{u j}$. It will be shown in Step 4 that

$$
\begin{equation*}
\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left(\left|I I_{1}(u, j)\right|+\left|I I_{2}(u, j)\right|\right)=O_{P}\left(\delta_{n}\right) . \tag{A.8}
\end{equation*}
$$

In addition, it will be shown in Step 5 that

$$
\begin{equation*}
\sup _{u \in \mathcal{U}, j \in[\hat{p}]} \inf _{\theta \in \Theta_{u j}} \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)\right]\right|=O_{P}\left(\delta_{n}\right) . \tag{A.9}
\end{equation*}
$$

Moreover, $\epsilon_{n} \sqrt{n}=o\left(\delta_{n}\right)$ by construction of the estimator. Therefore, the expression in (A.7) is $O_{P}\left(\delta_{n}\right)$. Also, $\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left|\mathrm{D}_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]\right|=O_{P}\left(\delta_{n} n^{-1 / 2}\right)$ by the near-orthogonality condition since $\widehat{\eta}_{u j} \in \mathcal{T}_{u j}$ for all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ with probability $1-o(1)$ by Assumption 2.2(i). Therefore, Assumption 2.1(iv) gives

$$
\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|J_{u j}^{-1} \sqrt{n} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]+\sqrt{n}\left(\check{\theta}_{u j}-\theta_{u j}\right)\right|=O_{P}\left(\delta_{n}\right)
$$

The asserted claim now follows by dividing both parts of the display above by $\sigma_{u j}$ (under the supremum on the left-hand side) and noting that $\sigma_{u j}$ is bounded below from zero uniformly over $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ by Assumptions 2.2 (iii) and $2.2(\mathrm{v})$.

Step 4. (Bounds on $I I_{1}(u, j)$ and $\left.I I_{2}(u, j)\right)$. Here we prove (A.8). First, with probability $1-o(1)$,

$$
\begin{aligned}
\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|I I_{1}(u, j)\right| & \leqslant \sqrt{n} B_{2 n} \sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\check{\theta}_{u j}-\theta_{u j}\right|^{2} \vee\left\|\widehat{\eta}_{u j}-\eta_{u j}\right\|_{e}^{2} \\
& \lesssim \sqrt{n} B_{1 n}^{2} B_{2 n} \tau_{n}^{2} \lesssim \delta_{n},
\end{aligned}
$$

where the first inequality follows from Assumptions 2.1(v) and 2.2(i), the second from Step 1 and Assumptions 2.2(ii) and 2.2(vi), and the third from Assumption 2.2(vi).

Second, we have with probability $1-o(1)$ that $\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left|I I_{2}(u, j)\right| \lesssim$ $\sup _{f \in \mathcal{F}_{2}}\left|\mathbb{G}_{n}(f)\right|$, where

$$
\mathcal{F}_{2}=\left\{\psi_{u j}(\cdot, \theta, \eta)-\psi_{u j}\left(\cdot, \theta_{u j}, \eta_{u j}\right): u \in \mathcal{U}, j \in[\tilde{p}], \eta \in \mathcal{T}_{u j},\left|\theta-\theta_{u j}\right| \leqslant C B_{1 n} \tau_{n}\right\}
$$

for sufficiently large constant $C$. To bound $\sup _{f \in \mathcal{F}_{2}}\left|\mathbb{G}_{n}(f)\right|$, we apply Lemma M.2. Observe that

$$
\begin{aligned}
\sup _{f \in \mathcal{F}_{2}}\|f\|_{P, 2}^{2} & \leqslant \sup _{u \in \mathcal{U}, j \in\left[\tilde{p},\left|\theta-\theta_{u j}\right| \leqslant C B_{1 n} \tau_{n}, \eta \in \mathcal{T}_{u j}\right.} \mathrm{E}_{P}\left[\left(\psi_{u j}(W, \theta, \eta)-\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right)^{2}\right] \\
& \leqslant \sup _{u \in \mathcal{U}, j \in\left[\tilde{p},\left|\theta-\theta_{u j}\right| \leqslant C B_{1 n} \tau_{n}, \eta \in \mathcal{T}_{u j}\right.} C_{0}\left(\left|\theta-\theta_{u j}\right| \vee\left\|\eta-\eta_{u j}\right\|_{e}\right)^{\omega} \lesssim\left(B_{1 n} \tau_{n}\right)^{\omega},
\end{aligned}
$$

where we used Assumption 2.1(v) and Assumption 2.2(ii). Also, observe that $\left(B_{1 n} \tau_{n}\right)^{\omega / 2} \geqslant n^{-\omega / 4}$ by Assumption 2.2(vi) since $B_{1 n} \geqslant 1$. Therefore, an application of Lemma M. 2 with an envelope $F_{2}=2 F_{1}$ and $\sigma=\left(C B_{1 n} \tau_{n}\right)^{\omega / 2}$ for sufficiently large constant $C$ gives with probability $1-o(1)$,

$$
\begin{equation*}
\sup _{f \in \mathcal{F}_{2}}\left|\mathbb{G}_{n}(f)\right| \lesssim\left(B_{1 n} \tau_{n}\right)^{\omega / 2} \sqrt{v_{n} \log a_{n}}+n^{-1 / 2+1 / q} v_{n} K_{n} \log a_{n} \tag{A.10}
\end{equation*}
$$

since $\sup _{f \in \mathcal{F}_{2}}|f| \leqslant 2 \sup _{f \in \mathcal{F}_{1}}|f| \leqslant 2 F_{1}$ and $\left\|F_{1}\right\|_{P, q} \leqslant K_{n}$ by Assumption 2.2(iv) and

$$
\log \sup _{Q} N\left(\epsilon\left\|F_{2}\right\|_{Q, 2}, \mathcal{F}_{2},\|\cdot\|_{Q, 2}\right) \lesssim v_{n} \log \left(a_{n} / \epsilon\right), \quad \text { for all } 0<\epsilon \leqslant 1
$$

by Lemma L. 1 because $\mathcal{F}_{2} \subset \mathcal{F}_{1}-\mathcal{F}_{1}$ for $\mathcal{F}_{1}$ defined in Assumption 2.2(iv). The claim of this step now follows from an application of Assumption 2.2(vi) to bound the right-hand side of (A.10).

Step 5. Here we prove (A.9). For all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, let $\bar{\theta}_{u j}=$ $\theta_{u j}-J_{u j}^{-1} \mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]$. Then $\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\bar{\theta}_{u j}-\theta_{u j}\right|=O_{P}\left(\mathcal{S}_{n} / \sqrt{n}\right)$ since $\mathcal{S}_{n}=\mathrm{E}_{P}\left[\sup _{u \in \mathcal{U}, j \in[\tilde{p}}\left|\sqrt{n} \mathbb{E}_{n}\left[\psi_{u j}\left(W_{u j}, \theta_{u j}, \eta_{u j}\right)\right]\right|\right]$ and $J_{u j}$ is bounded in absolute value below from zero uniformly over $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ by Assumption 2.1(iv). Therefore, $\bar{\theta}_{u j} \in \Theta_{u j}$ for all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ with probability $1-o(1)$ by Assumption 2.1(i). Hence, with the same probability, for all $u \in \mathcal{U}$ and $j \in[\tilde{p}]$,

$$
\inf _{\theta \in \Theta_{u j}} \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta, \widehat{\eta}_{u j}\right)\right]\right| \leqslant \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \bar{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]\right|
$$

and so it suffices to show that

$$
\begin{equation*}
\sup _{u \in \mathcal{U}, j \in[\tilde{p}]} \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \bar{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]\right|=O_{P}\left(\delta_{n}\right) \tag{A.11}
\end{equation*}
$$

To prove (A.11), for given $u \in \mathcal{U}$ and $j \in[\tilde{p}]$, substitute $\theta=\bar{\theta}_{u j}$ and $\eta=\widehat{\eta}_{u j}$ into (A.5) and use Taylor's expansion in (A.6). This gives

\begin{aligned}
& \sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \bar{\theta}_{u j}, \widehat{\eta}_{u j}\right)\right]\right| \leqslant\left|\widetilde{I I}_{1}(u, j)\right|+\left|\widetilde{I I}_{2}(u, j)\right| \\
& \quad+\sqrt{n}\left|\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]+J_{u j}\left(\bar{\theta}_{u j}-\theta_{u j}\right)+\mathrm{D}_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]\right|
\end{aligned}
$$

where $\widetilde{I I}_{1}(u, j)$ and $\widetilde{I I}_{2}(u, j)$ are defined as $I I_{1}(u, j)$ and $I I_{2}(u, j)$ in Step 3 but with $\check{\theta}_{u j}$ replaced by $\bar{\theta}_{u j}$. Then, given that $\sup _{u \in \mathcal{U}, j \in[\tilde{p} \mid}\left|\bar{\theta}_{u j}-\theta_{u j}\right| \lesssim$ $\mathcal{S}_{n} \log n / \sqrt{n}$ with probability $1-o(1)$, the argument in Step 4 shows that

$$
\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left(\left|\widetilde{I I}_{1}(u, j)\right|+\left|\widetilde{I}_{2}(u, j)\right|\right)=O_{P}\left(\delta_{n}\right) .
$$

In addition, $\mathbb{E}_{n}\left[\psi_{u j}\left(W, \theta_{u j}, \eta_{u j}\right)\right]+J_{u j}\left(\bar{\theta}_{u j}-\theta_{u j}\right)=0$ by the definition of $\bar{\theta}_{u j}$ and $\sup _{u \in \mathcal{U}, j \in[\hat{p}]}\left|\mathrm{D}_{u, j, 0}\left[\widehat{\eta}_{u j}-\eta_{u j}\right]\right|=O_{P}\left(\delta_{n} n^{-1 / 2}\right)$ by the near-orthogonality condition. Combining these bounds gives (A.11), so that the claim of this step follows, and completes the proof of the theorem.

## APPENDIX B: NOTATION

Throughout the paper, the symbols P and E denote probability and expectation operators with respect to a generic probability measure. If we need to signify the dependence on a probability measure $P$, we use $P$ as a subscript in $\mathrm{P}_{P}$ and $\mathrm{E}_{P}$. Note also that we use capital letters such as $W$ to denote random elements and use the corresponding lower case letters such as $w$ to denote fixed values that these random elements can take. For a positive integer $k,[k]$ denotes the set $\{1, \ldots, k\}$.

We denote by $\mathbb{P}_{n}$ the (random) empirical probability measure that assigns probability $n^{-1}$ to each $W_{i} \in\left(W_{i}\right)_{i=1}^{n}$. $\mathbb{E}_{n}$ denotes the expectation with respect to the empirical measure, and $\mathbb{G}_{n}=\mathbb{G}_{n, P}$ denotes the empirical process $\sqrt{n}\left(\mathbb{E}_{n}-\mathrm{E}_{P}\right)$, that is,

indexed by a class of measurable functions $\mathcal{F}: \mathcal{W} \rightarrow \mathbb{R}$; see [16, chap. 2.3]. In what follows, we use $\|\cdot\|_{P, q}$ to denote the $L^{q}(P)$ norm; for example, we use $\|f(W)\|_{P, q}=\left(\int|f(w)|^{q} d P(w)\right)^{1 / q}$ and $\|f(W)\|_{\mathbb{P}_{n}, q}=\left(n^{-1} \sum_{i=1}^{n}\left|f\left(W_{i}\right)\right|^{q}\right)^{1 / q}$. For a vector $v=\left(v_{1}, \ldots, v_{p}\right)^{\prime} \in \mathbb{R}^{p},\|v\|_{0}$ denotes the $\ell_{0}$ - "norm" of $v$, that is, the number of non-zero components of $v,\|v\|_{1}$ denotes the $\ell_{1}$-norm of $v$, that is, $\|v\|_{1}=\left|v_{1}\right|+\cdots+\left|v_{p}\right|$, and $\|v\|$ denotes the Euclidean norm of $v$, that is, $\|v\|=\sqrt{v^{\prime} v}$.

We say that a class of functions $\mathcal{F}=\{f(\cdot, t): t \in T\}$, where $f: \mathcal{W} \times T \rightarrow$ $\mathbb{R}$, is suitably measurable if it is an image admissible Suslin class, as defined in [11], p 186. In particular, $\mathcal{F}$ is suitably measurable if $f: \mathcal{W} \times T \rightarrow \mathbb{R}$ is measurable and $T$ is a Polish space equipped with its Borel $\sigma$-field, see [11], p 186.

## APPENDIX C: EMPIRICAL APPLICATION: US PRESIDENTIAL APPROVAL RATINGS

In this section we illustrate the applicability of the tools proposed in this work with data on US presidential approval ratings used in [6]. There several economic and political factors that impact presidential approval ratings. In this illustration, we are interested on the impact of unemployment rates
and on the impact of time in office on the approval rate of a sitting president. However, the impact of such factors might not be homogeneous and in fact depend on current ratings. For example, a sitting president is likely to have a fraction of voters who would support him regardless of economic factors. Thus, a low unemployment rate might not have an effect when approval ratings are low and have a significant effect when approval ratings are high. This would imply a different effect on different parts of the conditional distribution of the approval rating.

To study the distributional effect of these factors we use a logistic regression model with functional data as described in Section 3. Letting $Y$ denote the approval rating, we define $Y_{u}=1\{Y \leqslant u\}$ to be the binary variable that indicates if the approval rating is below the threshold $u \in \mathcal{U}=[.45, .65]$. For each level of approval rating $u \in \mathcal{U}$ we estimate the model

where $D_{\text {unemp }}$ denotes the unemployment rate, $D_{\text {time }}$ the number of months the president has been in office, $r_{u}$ a (small) approximation error, and $X$ denotes several additional control variables. In addition to the linear terms for the variables ${ }^{2}$ used in [6], we also consider interactions among controls. Therefore, for each $u \in \mathcal{U}$ we have a generalized linear model using logistic link function with 160 variables and 603 observations.

We construct simultaneous confidence bands for both coefficients ( $\tilde{p}=2$ ) uniformly over $u \in \mathcal{U}$. Although $p<n$ for every $u \in \mathcal{U}$, the full model (applying logistic regression with all regressors) led to numerical instabilities and other numerical failures. We proceed to construct (asymptotically) valid confidence regions based on the double selection procedure for functional logistic regression.

Figure 1 displays the estimation results. Specifically, the figure displays point estimates of each coefficient for every $u \in \mathcal{U}$ (solid line), pointwise confidence intervals (dotted line), and uniform confidence bands (dot-dash lines). Point estimates account for model selection mistakes and are computed based the double selection procedure. For $95 \%$ coverage, the pointwise critical value is taken to be $\Phi^{-1}(.975) \approx 1.96$ from the normal approximation and the critical value for uniform confidence bands (uniformly over both coefficients and over $u \in \mathcal{U}$ ) was calculated to be 3.003 based on 5000 repetitions of the multiplier bootstrap.

At $95 \%$ confidence level, the uniform confidence band rule out "no effect" over $\mathcal{U}$ for both variables. Indeed, the straight line at 0 is not contained in the

uniform confidence bands for either variable. Next consider the process of the unemployment coefficient. The analysis suggests that the unemployment rate has an overall negative effect on the approval rate of a sitting president (as the coefficient is positive increasing the probability to be below a threshold). Regarding time-in-office, the effect also seems to be predominantly negative. However, the impact is not homogeneous across $u \in \mathcal{U}$. Indeed, the lowest value of the upper confidence band ( $0.007, u=0.584$ ) is smaller than the largest value of the lower confidence band ( $0.013, u=0.647$ ), see the circles in the plot of the process of the time-in-office coefficient. The impact seems to be greater for the lower and higher values of $u \in \mathcal{U}$ while the effect of seems negligible in the range of $u \in[.575, .625]$. In particular, at $95 \%$ level, no effect is ruled out for large values of $u$.

Moreover, the notation $a_{n}=o(1)$ means that there exists a sequence $\left(b_{n}\right)_{n \geqslant 1}$ of positive numbers such that (i) $\left|a_{n}\right| \leqslant b_{n}$ for all $n$, (ii) $b_{n}$ is independent of $P \in \mathcal{P}_{n}$ for all $n$, and (iii) $b_{n} \rightarrow 0$ as $n \rightarrow \infty$. Finally, the notation $a_{n}=o_{P}\left(b_{n}\right)$ means that for any $C$, we have $\mathrm{P}_{P}\left(a_{n}>C b_{n}\right)=o(1)$. Using this notation allows us to avoid repeating "uniformly over $P \in \mathcal{P}_{n}$ " and "uniformly over $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ " many times in the proofs of Theorem 3.1 and Corollaries 3.1-3.3.

where its envelope $F_{0}$ satisfies $\left\|F_{0}\right\|_{P, q} \lesssim M_{n, 1}$. Thus, Assumption 2.3(i) holds with $\varrho_{n}=C, A_{n}=a_{n}=p \vee \tilde{p} \vee n$, and $L_{n}=C M_{n, 1}$.

Next, we verify Assumption 2.3 (ii). For $k=3,4, u \in \mathcal{U}$, and $j \in[\tilde{p}]$, we have

Proof of Corollary 3.2. The asserted claim will follow from Corollary 2.2 as long as we can verify its conditions. Assumptions 2.1 and 2.2 were verified in the proof of Theorem 3.1. Assumption 2.3(i,ii) was verified in the proof of Corollary 3.1. Therefore, it suffices to verify Assumptions 2.3(iii) and 2.4 and the growth conditions of Corollary 2.2.

We split the proof into six steps. In Steps 1-3, we verify Assumption 2.4. In Steps 4 and 5, we verify Assumption 2.3(iii). In Step 6, we verify the growth conditions of Corollary 2.2.

Proof of Corollary 3.3. To prove the asserted claim, we will apply Corollary 3.2. Below we will verify Assumptions 3.4(iii,v,vi,vii,viii,ix), 3.5(iii), and the growth conditions of Corollary 3.2.

Further, Assumption 3.4(vii) holds with $M_{n, 2}=\bar{M}_{n}$ by definition of $\bar{M}_{n}$. In addition, since $s_{n}^{2} \log ^{2} a_{n}=o\left(n^{1-2 / q}\right)$, Assumption 3.4 (viii) holds for some $\delta_{n}$ satisfying $\delta_{n}^{2} \log a_{n}=o(1)$. Also, Assumption 3.4(ix) holds for some $\delta_{n}$ satisfying $\delta_{n}^{2} \log a_{n}=o(1)$ since $M_{n, 2}=\bar{M}_{n} \leqslant C_{1}, M_{n, 1} \leqslant C, s_{n} \leqslant \delta_{n} n^{1 / 2-1 / q}$, and $q>4$.

Moreover, since $\sup _{u \in \mathcal{U}, j \in[\tilde{p}]}\left|\mathrm{E}_{P}\left[r_{u} Z_{u}^{j}\right]\right|=o\left(\left(n \log a_{n}\right)^{-1 / 2}\right)$, Assumption 3.5 (iii) holds for some $\delta_{n}$ satisfying $\delta_{n}^{2} \log a_{n}=o(1)$. Finally, the growth conditions $M_{n, 1}^{2 / 7} \log a_{n}=o\left(n^{1 / 7}\right)$ and $M_{n, 1}^{2 / 3} \log a_{n}=o\left(n^{1 / 3-2 /(3 q)}\right)$ hold because $M_{n, 1} \lesssim \bar{C}_{n} \bar{M}_{n} \lesssim C, \log ^{7} a_{n}=o(n)$, and $\log ^{3} a_{n}=o\left(n^{1-2 / q}\right)$.

Thus, there exists $\delta_{n}$ such that Assumptions 3.4(iii,v,vi,vii,viii,ix) and 3.5 (iii) as well as all growth conditions of Corollary 3.2 are satisfied. Since all other conditions of Corollary 3.2 are assumed, the asserted claim follows from that in Corollary 3.2.

## APPENDIX G: PROOFS FOR SECTION 4

In this appendix, we use $C$ to denote a strictly positive constant that is independent of $n$ and $P \in \mathcal{P}_{n}$. The value of $C$ may change at each appearance. Also, the notation $a_{n} \lesssim b_{n}$ means that $a_{n} \leqslant C b_{n}$ for all $n$ and some $C$. The notation $a_{n} \gtrsim b_{n}$ means that $b_{n} \lesssim a_{n}$. Moreover, the notation $a_{n}=o(1)$ means that there exists a sequence $\left(b_{n}\right)_{n \geqslant 1}$ of positive numbers such that (i) $\left|a_{n}\right| \leqslant b_{n}$ for all $n$, (ii) $b_{n}$ is independent of $P \in \mathcal{P}_{n}$ for all $n$, and (iii) $b_{n} \rightarrow 0$ as $n \rightarrow \infty$. Finally, the notation $a_{n} \lesssim_{P} b_{n}$ means that for any $\epsilon>0$, there exists $C$ such that $\mathrm{P}_{P}\left(a_{n}>C b_{n}\right) \leqslant \epsilon$ for all $n$, and the notation $a_{n} \gtrsim_{P} b_{n}$ means that $b_{n} \lesssim_{P} a_{n}$. Using this notation allows us to avoid repeating "uniformly over $P \in \mathcal{P}_{n}$ " many times in the proofs of Theorems 4.1 and 4.2.

Proof of Theorem 4.1. In this proof, we will rely upon results in Appendix J. In particular, the asserted claims will follow from an application of Lemmas J.1, J.2, and J. 3 (with some extra work). To follow the notation in Appendix J, define $X_{u}=\left(D^{\prime}, X^{\prime}\right)^{\prime}$ and $w_{u}=f_{u}^{2}$ and redefine $\theta_{u}=\left(\theta_{u}^{\prime}, \beta_{u}^{\prime}\right)^{\prime}$, $\widehat{\theta}_{u}=\left(\widehat{\theta}_{u}^{\prime}, \widehat{\beta}_{u}^{\prime}\right)^{\prime}$, and $p=\tilde{p}+p$. Also, define $a_{u}=a_{u}\left(X_{u}\right)$ as a solution to the
following equation:

To apply Lemmas J.1, J.2, and J.3, we need to verify Assumption J.1. In addition, one of the conditions in these lemmas is that (J.5) holds with probability $1-o(1)$. Verification of this condition will be done with the help of Lemma J.4, which in turn relies upon Condition WL. Therefore, below we also verify this condition.

\left|\left[\partial_{\theta} M_{\tilde{u}}\left(Y_{\tilde{u}}, X_{\tilde{u}}, \widehat{\theta}_{\tilde{u}}\right)-\partial_{\theta} M_{\tilde{u}}\left(Y_{\tilde{u}}, X_{\tilde{u}}, \theta_{\tilde{u}}\right)\right]^{\prime} \delta\right| \leqslant\left|\widehat{f}_{u} X^{j}\left(\widehat{\theta}_{\tilde{u}}-\theta_{\tilde{u}}\right)\right| \cdot\left|\widehat{f}_{u} X^{j} \delta\right| .

Therefore, by the Cauchy-Schwarz inequality and since $\widehat{f}_{u} \leqslant 1$,

with probability $1-o(1)$ uniformly over $\tilde{u}=(u, j) \in \widetilde{\mathcal{U}}$ for some $L_{n}$ satisfying $L_{n} \lesssim\left(s_{n} \log a_{n} / n\right)^{1 / 2}$. since $\ell_{n} \rightarrow \infty$ slowly enough and $\log ^{1 / 2} a_{n} \lesssim \delta_{n} n^{1 / 6}$ by Assumption 3.4(ii,iii). Combining presented bounds gives the asserted claim.

## APPENDIX I: DOUBLE SELECTION METHOD FOR LOGISTIC REGRESSION WITH FUNCTIONAL RESPONSE DATA

In this section we discuss in details and provide formal results for the double selection estimator for logistic regression with functional response data.

Algorithm 5. (Based on double selection) For each $u \in \mathcal{U}$ and $j \in[\tilde{p}]$ : Step 1'. Run post- $\ell_{1}$-penalized logistic estimator (4.2) of $Y_{u}$ on $D$ and $X$ to compute $\left(\widetilde{\theta}_{u}, \widetilde{\beta}_{u}\right)$.
Step 2'. Define the weights $\widehat{f}_{u}^{2}=\hat{f}_{u}^{2}(D, X)=\Lambda^{\prime}\left(D_{i}^{\prime} \widetilde{\theta}_{u}+X_{i}^{\prime} \widetilde{\beta}_{u}\right)$.
Step 3'. Run the lasso estimator (4.4) of $\widehat{f}_{u} D_{j}$ on $\widehat{f}_{u} X$ to compute $\widehat{\gamma}_{u}^{j}$.
Step 4'. Run logistic regression of $Y_{u}$ on $D_{j}$ and all the selected variables in Steps 1' and 2'
to compute $\check{\theta}_{u j}$.
The following result establishes the Bahadur representation for the double selection estimator (analog to Theorem 3.1 for score functions).

Theorem I. 1 (Uniform Bahadur representation, double selection). Suppose that Assumptions 3.1-3.5 hold for all $P \in \mathcal{P}_{n}$. Then, the estimator $\left(\check{\theta}_{u j}\right)_{u \in \mathcal{U}, j \in[\tilde{p}]}$, based on the double selection, obeys as $n \rightarrow \infty$

uniformly over $u \in \mathcal{U}$, where $\Sigma_{u j}^{2}:=\mathrm{E}_{P}\left[f_{u}^{2}\left(D-X^{j} \gamma_{u}^{j}\right)^{2}\right]^{-1}$.
Proof of Theorem I.1. The analysis is reduced to the proof of Theorem 3.1. Let $\widehat{T}_{u j}=\operatorname{supp}\left(\widehat{\theta}_{u}\right) \cup \operatorname{supp}\left(\widehat{\beta}_{u}\right) \cup \operatorname{supp}\left(\widehat{\gamma}_{u}^{j}\right)$ for which by Theorems 4.1 and 4.2 satisfies $\sup _{u \in \mathcal{U}, j \in[\tilde{p} \mid}\left|\widehat{T}_{u j}\right| \lesssim s_{n}$ with probability $1-o(1)$. Therefore Step 3 is a post-selection logistic regression which yields an initial rate of convergence $\left|\check{\theta}_{u j}-\theta_{u j}\right|+\left\|\bar{\theta}_{u[\tilde{p} \backslash \backslash j}-\theta_{u[\tilde{p} \backslash j}\right\|+\left\|\bar{\beta}_{u}-\beta_{u}\right\| \lesssim\left(s_{n} \log a_{n} / n\right)^{1 / 2}$. Moreover, by the first order condition of Step 3 we have

\mathbb{E}_{n}\left[\left\{Y_{u i}-\Lambda\left(D_{j} \check{\theta}_{u j}+D_{[\tilde{p} \backslash j}^{\prime} \bar{\theta}_{u[\tilde{p} \backslash j}+X^{\prime} \bar{\beta}_{u}\right)\right\}\left(D_{j}, X_{\widehat{T}_{u j}}^{j}\right)^{\prime}\right]=0 \tag{I.1}
\end{equation*}
$$

so that any linear combination yields zero. Setting the parameters $\left(\widetilde{\theta}_{u}^{\prime}, \widetilde{\beta}_{u}^{\prime}\right)=$ $\left(\bar{\theta}_{u[\tilde{p}] \backslash j}, \bar{\theta}_{u[\tilde{p} \backslash \backslash j}^{\prime}, \bar{\beta}_{u}^{\prime}\right)$, and $\widehat{z}_{u}^{j}=\left(D_{j}, X_{\widehat{T}_{u j}}^{j}\right)\left(1,-\widetilde{\gamma}_{u}^{j}\right)=D_{j}-X^{j} \widetilde{\gamma}_{u}^{j}$, we recover the setting in the proof of Theorem 3.1. The rest of the proof follows similarly.

The double selection procedure benefits from additional variables selected in Step 2. The (estimated) weights used in the equation ensure that selection will ensure a near-orthogonality condition that is required to remove first order bias. In contrast, (naive) Post- $\ell_{1}$-logistic regression does not select such variables which in turn translates in to first order bias in the estimation of $\theta_{u j}$. We stress that Step 2 is tailored to the estimation of each coefficient $\theta_{u j}$ which enables the additional adaptivity.

The double selection achieves orthogonality conditions relative to all selected variables in finite samples. Although first-order equivalent to other estimator discussed here, this additional orthogonality could potentially lead to a better finite sample performance. To provide intuition why, consider the logistic regression case with $\tilde{p}=\operatorname{dim}(D)=1$ and $\mathcal{U}=\{0\}$ for simplicity. In this case we have

E[Y \mid D, X]=\Lambda\left(D \theta_{0}+X^{\prime} \beta_{0}\right) \text { and let } f=\Lambda^{\prime}\left(D \theta_{0}+X^{\prime} \beta_{0}\right) .
$$

Letting $\hat{\gamma}$ be the Lasso estimate of $f D$ on $f X$ we have that the one step estimator

\left.\bar{\theta}=\widehat{\theta}-\mathbb{E}_{n}\left[\left(D-X^{\prime} \widehat{\gamma}\right)^{2}\right]^{-1} \mathbb{E}_{n}\left[\left\{Y-\Lambda\left(D \widehat{\theta}+X^{\prime} \widehat{\beta}\right)\right)\right\}\left(D-X^{\prime} \widehat{\gamma}\right)\right]
$$

is an approximate solution for the moment condition

$$
\begin{equation*}
\mathbb{E}_{n}\left[\left\{Y-\Lambda\left(D \theta+X^{\prime} \widehat{\beta}\right)\right\}\left(D-X^{\prime} \widehat{\gamma}\right)\right]=0 \tag{I.2}
\end{equation*}
$$

Indeed, it is one Newton step from $\widehat{\theta}$. Our proposed estimator based on estimated score functions defines $\check{\theta}$ as an exact solution for (I.2), namely

The double selection achieves that implicitly. Indeed, letting $\widehat{T}=\operatorname{support}(\breve{\beta}) \cup$ support $(\widehat{\gamma})$, the first order condition of running a logistic regression of $Y$ on $D$ and $X_{\widehat{T}}$ yields

where $(\check{\theta}, \breve{\beta})$ is the solution of the logistic regression. By multiplying the vector $\left(1,-\widehat{\gamma}^{\prime}\right)^{\prime}$, the relation above implies

since support $(\widehat{\gamma}) \subset \widehat{T}$ (the condition support $(\widehat{\beta}) \subset \widehat{T}$ ensures that $\check{\beta}$ is a good approximation of $\beta_{0}$ ). Note that (I.3) provides a more robust orthogonality condition and does not need to explicitly create the new score functions as the other two methods.

## APPENDIX J: GENERIC FINITE SAMPLE BOUNDS FOR $\ell_{1}$-PENALIZED M-ESTIMATORS: NUISANCE FUNCTIONS AND FUNCTIONAL DATA

In this section, we establish a set of results for $\ell_{1}$-penalized M -estimators with functional data and high-dimensional parameters. These results are used in the proofs of Theorems 4.1 and 4.2 and may be of independent interest.

We start with specifying the setting. Consider a data generating process with a functional response variable $\left(Y_{u}\right)_{u \in \mathcal{U}}$ and observable covariates $\left(X_{u}\right)_{u \in \mathcal{U}}$ satisfying for each $u \in \mathcal{U} \subset \mathbb{R}^{d_{u}}$,

\begin{equation*}
\theta_{u} \in \arg \min _{\theta \in \mathbb{R}^{p}} \mathrm{E}_{P}\left[M_{u}\left(Y_{u}, X_{u}, \theta, a_{u}\right)\right], \tag{J.1}
\end{equation*}
$$

where $\theta_{u}$ is a $p$-dimensional vector of parameters, $a_{u}$ is a nuisance parameter that captures potential misspecification of the model, and $M_{u}$ is a known function. Here for all $u \in \mathcal{U}, Y_{u}$ is a scalar random variable and $X_{u}$ is a
$p_{u}$-dimensional random vector with $p_{u} \leqslant p$ for some $p$. We assume that the solution $\theta_{u}$ is sparse in the sense that the process $\left(\theta_{u}\right)_{u \in \mathcal{U}}$ satisfies

$$
\left\|\theta_{u}\right\|_{0} \leqslant s, \quad \text { for all } u \in \mathcal{U} .
$$

Because the model (J.1) allows for the nuisance parameter $a_{u}$, such sparsity assumption is very mild and formulation (J.1) encompasses many cases of interest including approximately sparse models.

Throughout this section, we assume that we have $n$ i.i.d. observations, $\left\{\left(Y_{u i}, X_{u i}\right)_{u \in \mathcal{U}}\right\}_{i=1}^{n}$, from the distribution of $\left(Y_{u}, X_{u}\right)_{u \in \mathcal{U}}$ to estimate $\left(\theta_{u}\right)_{u \in \mathcal{U}}$. In addition, we assume that an estimate $\widehat{a}_{u}$ of the nuisance parameter $a_{u}$ is available for all $u \in \mathcal{U}$. Using the estimate $\widehat{a}_{u}$, we use the criterion function

$$
M_{u}\left(Y_{u}, X_{u}, \theta\right):=M_{u}\left(Y_{u}, X_{u}, \theta, \widehat{a}_{u}\right)
$$

as a proxy for $M_{u}\left(Y_{u}, X_{u}, \theta_{u}, a_{u}\right)$. We allow for the case where $p$ is much larger than $n$.

Since $p$ is potentially larger $n$, and the parameters $\theta_{u}$ are assumed to be sparse, we consider an $\ell_{1}$-penalized $M_{u}$-estimator (Lasso) of $\theta_{u}$ :

\widehat{\theta}_{u} \in \arg \min _{\theta}\left(\mathbb{E}_{n}\left[M_{u}\left(Y_{u}, X_{u}, \theta\right)\right]+\frac{\lambda}{n}\left\|\widehat{\Psi}_{u} \theta\right\|_{1}\right) \tag{J.2}
\end{equation*}

where $\lambda$ is a penalty level and $\widehat{\Psi}_{u}$ a diagonal matrix of penalty loadings. Further, for each $u \in \mathcal{U}$, we also consider a post-regularized (Post-Lasso) estimator of $\theta_{u}$ :

where $\widehat{T}_{u}=\operatorname{supp}\left(\widehat{\theta}_{u}\right)$.
We assume that for each $u \in \mathcal{U}$, the matrix of penalty loadings $\widehat{\Psi}_{u}$ is chosen as an appropriate estimator of the following "ideal" matrix of penalty loadings: $\widehat{\Psi}_{u 0}=\operatorname{diag}\left(\left\{l_{u 0 k}, k=1, \ldots, p\right\}\right)$, where

l_{u 0 k}=\left(\mathbb{E}_{n}\left[\left(\partial_{\theta_{k}} M_{u}\left(Y_{u}, X_{u}, \theta_{u}, a_{u}\right)\right)^{2}\right]\right)^{1 / 2} \tag{J.4}
\end{equation*}
$$

where $\partial_{\theta_{k}} M_{u}\left(Y_{u}, X_{u}, \theta_{u}, a_{u}\right)$ denotes a sub-gradient of the function $\theta \mapsto$ $M_{u}\left(Y_{u}, X_{u}, \theta, a_{u}\right)$ with respect to the $k$ th coordinate of $\theta$ and evaluated at $\theta=\theta_{u}$. The properties of $\widehat{\Psi}_{u}$ will be specified below in lemmas. Also, we assume that the penalty level $\lambda$ is chosen such that with high probability,

\end{equation*}

where $c>1$ is a fixed constant. When $\mathcal{U}$ is a singleton, the condition (J.5) is similar to that in [7], [2], and [4]. When $\mathcal{U}$ is a continuum of indices, a similar condition was previously used in [1] in the context of $\ell_{1}$-penalized quantile regression.

For $u \in \mathcal{U}$, denote $T_{u}=\operatorname{supp}\left(\theta_{u}\right)$. Let $\ell$ and $L$ be some constants satisfying $L \geqslant \ell>1 / c$. Also, let

where for any diagonal matrix $A=\operatorname{diag}\left(\left\{a_{k}, k=1, \ldots, p\right\}\right)$, we denote $\|A\|_{\infty}=\max _{1 \leqslant k \leqslant p}\left|a_{k}\right|$. Let $\left(\Delta_{n}\right)_{n \geqslant 1}$ be a sequence of positive constants converging to zero, and let $\left(C_{n}\right)_{n \geqslant 1}$ be a sequence of random variables. Also, let $w_{u}=w_{u}\left(X_{u}\right)$ be some weights satisfying $0 \leqslant w_{u} \leqslant 1$ almost surely. Finally, let $A_{u}$ be some random subset of $\mathbb{R}^{p}$ and $\bar{q}_{A_{u}}$ be a random variable possibly depending on $A_{u}$, where both $A_{u}$ and $\bar{q}_{A_{u}}$ are specified in the lemmas below. To state our results in this section, we need the following assumption:

Assumption J. 1 (M-Estimation). The function $\theta \mapsto M_{u}\left(Y_{u}, X_{u}, \theta\right)$ is convex almost surely, and with probability at least $1-\Delta_{n}$, the following inequalities hold for all $u \in \mathcal{U}$ :

(b) $\ell \widehat{\Psi}_{u 0} \leqslant \widehat{\Psi}_{u} \leqslant L \widehat{\Psi}_{u 0}$;
(c) for all $\delta \in A_{u}$,

In many applications one can take the weights to be $w_{u}=w_{u}\left(X_{u}\right)=1$ but we allow for more general weights since it is useful for our results on the weighted Lasso with estimated weights. Also, in applications, we typically have $C_{n} \lesssim\left\{n^{-1} s \log (p n)\right\}^{1 / 2}$. Assumption J.1(a) bounds the impact of estimating the nuisance functions uniformly over $u \in \mathcal{U}$. The loadings $\widehat{\Psi}_{u}$ are assumed larger (but not too much larger) than the ideal choice $\widehat{\Psi}_{u 0}$ defined in (J.4). This is formalized in Assumption J.1(b). Assumption J.1(c) is an identification condition that will be imposed for particular choices of $A_{u}$ and $\bar{q}_{A_{u}}$. It relates to conditions in the literature derived for the case of a singleton $\mathcal{U}$ and no nuisance functions, see the restricted strong convexity ${ }^{3}$ used in [14] and the non-linear impact coefficients used in [1] and [3].

& \mathcal{F}_{j}=\left\{(Y, X) \mapsto Y_{u} X_{j}: u \in \mathcal{U}\right\}, \mathcal{F}_{j}^{\prime}=\left\{(Y, X) \mapsto X_{j} \mathrm{E}_{P}\left[Y_{u} \mid X\right]: u \in \mathcal{U}\right\}, \\
& \mathcal{G}_{j}=\left\{(Y, X) \mapsto X_{j}^{2} \zeta_{u}^{2}: u \in \mathcal{U}\right\}
\end{aligned}
$$

where $\zeta_{u}=Y_{u}-\mathrm{E}_{P}\left[Y_{u} \mid X\right]$. Note that the function $F(Y, X)=\|X\|_{\infty}$ is an envelope both for $\mathcal{F}_{j}$ and for $\mathcal{F}_{j}^{\prime}$ for all $j \in[\tilde{p}]$. By assumption, $F$ can be chosen to satisfy $\|F\|_{P, q} \leqslant K_{n}$.

Because $\mathcal{F}_{j}$ is a product of a VC-subgraph class of functions with index bounded by $C_{Y}$ and a single function, Lemma L.1(1) implies that its uniform entropy numbers obey

Further, since $\mathcal{G}_{j} \subset\left(\mathcal{F}_{j}-\mathcal{F}_{j}^{\prime}\right)^{2}, G=4 F^{2}$ is an envelope for $\mathcal{G}_{j}$, and the uniform entropy numbers of $\mathcal{G}_{j}$ obey for all $\epsilon \in(0,1]$,
(K.15) $\log N\left(\epsilon\|G\|_{Q, 2}, \mathcal{G}_{j},\|\cdot\|_{Q, 2}\right) \leqslant 2 \log N\left(\frac{\epsilon}{2}\|2 F\|_{Q, 2}, \mathcal{F}_{j}-\mathcal{F}_{j}^{\prime},\|\cdot\|_{Q, 2}\right)$

$$
\begin{aligned}
\leqslant & 2 \log N\left(\frac{\epsilon}{4}\|F\|_{Q, 2}, \mathcal{F}_{j},\|\cdot\|_{Q, 2}\right) \\
& +2 \log N\left(\frac{\epsilon}{4}\|F\|_{Q, 2}, \mathcal{F}_{j}^{\prime},\|\cdot\| \|_{Q, 2}\right) \\
\leqslant & 4 \log \sup _{Q} N\left(\frac{\epsilon}{8}\|F\|_{Q, 2}, \mathcal{F}_{j},\|\cdot\|_{Q, 2}\right),
\end{aligned}
$$

where the first and the second inequalities follow from Lemma L.1(2), and the third from the bound on uniform entropy numbers of $\mathcal{F}_{j}^{\prime}$ above. Hence, Lemma L.1(2) implies that the uniform entropy numbers of $\mathcal{G}=\cup_{j \in[p]} \mathcal{G}_{j}$ obey

where $G=4 F^{2}$ is its envelope. Therefore, since $\left|S_{u j}\right| \leqslant 2\left|X_{j}\right|$ and also $\max _{j \leqslant p} \mathrm{E}_{P}\left[X_{j}^{4}\right] \leqslant \bar{C}$ by assumption, Lemma M. 2 implies that with probability at least $1-(\log n)^{-1}$,

& \leqslant \sup _{d_{\mathcal{U}}\left(u, u^{\prime}\right) \leqslant 1 / n} \max _{j \in[p]} \mathrm{E}_{P}\left[X_{j}^{2}\left(Y_{u}-Y_{u^{\prime}}\right)^{2}\right] \\
& \leqslant \sup _{d_{\mathcal{U}}\left(u, u^{\prime}\right) \leqslant 1 / n} \max _{j \leqslant p}\left\{\mathrm{E}_{P}\left[X_{j}^{4}\right]\right\}^{1 / 2}\left\{\mathrm{E}_{P}\left[\left(Y_{u}-Y_{u^{\prime}}\right)^{4}\right]\right\}^{1 / 2} \\
& \lesssim \sup _{d_{\mathcal{U}}\left(u, u^{\prime}\right) \leqslant 1 / n}\left|u-u^{\prime}\right|^{\nu / 2} \lesssim n^{-\nu / 2} .
\end{aligned}
$$

Therefore, Lemma M. 2 implies that we have with probability at least 1 $(\log n)^{-1}$,

& \lesssim \sqrt{\frac{\log \left(n p K_{n}\right)}{n^{1+\nu / 2}}}+\frac{n^{1 / q} K_{n} \log \left(n p K_{n}\right)}{n},
\end{aligned}

& \lesssim\left(\mathrm{E}_{P}\left[X_{j}^{4}\right]\right)^{1 / 4} \cdot\left(\mathrm{E}_{P}\left[\left(Y_{u}-Y_{u^{\prime}}\right)^{4}\right]\right)^{1 / 4} \lesssim d \mathcal{U}\left(u, u^{\prime}\right)^{\nu / 4}
\end{aligned}

Lemma L. 1 (Algebra for Covering Entropies).
(1) Let $\mathcal{F}$ be a VC subgraph class with a finite VC index $k$ or any other class
whose entropy is bounded above by that of such a VC subgraph class, then the uniform entropy numbers of $\mathcal{F}$ obey

& \log N\left(\epsilon\left\|F \cdot F^{\prime}\right\|_{Q, 2}, \mathcal{F} \cdot \mathcal{F}^{\prime},\|\cdot\|_{Q, 2}\right) \\
& \quad \leqslant \log N\left(\frac{\epsilon}{2}\|F\|_{Q, 2}, \mathcal{F},\|\cdot\|_{Q, 2}\right)+\log N\left(\frac{\epsilon}{2}\left\|F^{\prime}\right\|_{Q, 2}, \mathcal{F}^{\prime},\|\cdot\|_{Q, 2}\right), \\

& \quad \leqslant N\left(\epsilon\|F\|_{Q, 2}, \mathcal{F},\|\cdot\|_{Q, 2}\right)+N\left(\epsilon\left\|F^{\prime}\right\|_{Q, 2}, \mathcal{F}^{\prime},\|\cdot\|_{Q, 2}\right) .

(3) For any measurable class of functions $\mathcal{F}$ and a fixed function $f$ mapping $\mathcal{W}$ to $\mathbb{R}$,

(4) Given measurable classes $\mathcal{F}_{j}$ and envelopes $F_{j}, j=1, \ldots, k$, mapping $\mathcal{W}$ to $\mathbb{R}$, a function $\phi: \mathbb{R}^{k} \rightarrow \mathbb{R}$ such that for $f_{j}, g_{j} \in \mathcal{F}_{j}, \mid \phi\left(f_{1}, \ldots, f_{k}\right)$ $\phi\left(g_{1}, \ldots, g_{k}\right)\left|\leqslant \sum_{j=1}^{k} L_{j}(x)\right| f_{j}(x)-g_{j}(x) \mid, L_{j}(x) \geqslant 0$, and fixed functions $\bar{f}_{j} \in \mathcal{F}_{j}$, the class of functions $\mathcal{L}=\left\{\phi\left(f_{1}, \ldots, f_{k}\right)-\phi\left(\bar{f}_{1}, \ldots, \bar{f}_{k}\right): f_{j} \in\right.$ $\left.\mathcal{F}_{j}, j=1, \ldots, k\right\}$ satisfies

& \log \sup _{Q} N\left(\epsilon\left\|\sum_{j=1}^{k} L_{j} F_{j}\right\|_{Q, 2}, \mathcal{L},\|\cdot\|_{Q, 2}\right) \\
& \quad \leqslant \sum_{j=1}^{k} \log \sup _{Q} N\left(\frac{\epsilon}{k}\left\|F_{j}\right\|_{Q, 2}, \mathcal{F}_{j},\|\cdot\|_{Q, 2}\right) .
\end{aligned}
$$

Proof. See Lemma L. 1 in [5].
Lemma L. 2 (Covering Entropy for Classes obtained as Conditional Expectations). Let $\mathcal{F}$ denote a class of measurable functions $f: \mathcal{W} \times \mathcal{Y} \rightarrow \mathbb{R}$ with a measurable envelope $F$. For a given $f \in \mathcal{F}$, let $\bar{f}: \mathcal{W} \rightarrow \mathbb{R}$ be the function $\bar{f}(w):=\int f(w, y) d \mu_{w}(y)$ where $\mu_{w}$ is a regular conditional probability distribution over $y \in \mathcal{Y}$ conditional on $w \in \mathcal{W}$. Set $\overline{\mathcal{F}}=\{\bar{f}: f \in \mathcal{F}\}$ and let $\bar{F}(w):=\int F(w, y) d \mu_{w}(y)$ be an envelope for $\overline{\mathcal{F}}$. Then, for $r, s \geqslant 1$,

\log \sup _{Q} N\left(\epsilon\|\bar{F}\|_{Q, r}, \overline{\mathcal{F}},\|\cdot\|_{Q, r}\right) \leqslant \log \sup _{\widetilde{Q}} N\left((\epsilon / 4)^{r}\|F\|_{\widetilde{Q}, s}, \mathcal{F},\|\cdot\|_{\widetilde{Q}, s}\right),
$$

where $Q$ belongs to the set of finitely-discrete probability measures over $\mathcal{W}$ such that $0<\|\bar{F}\|_{Q, r}<\infty$, and $\widetilde{Q}$ belongs to the set of finitely-discrete probability measures over $\mathcal{W} \times \mathcal{Y}$ such that $0<\|F\|_{\tilde{Q}, s}<\infty$. In particular, for every $\epsilon>0$ and any $k \geqslant 1$,

Lemma L.3. Consider a mapping $\tilde{u} \mapsto \xi_{\tilde{u}}$ from $\tilde{\mathcal{U}}=[0,1]^{k}$ into $\mathbb{R}^{p}$ and the class of functions $\mathcal{F}=\left\{x \mapsto \mathcal{M}\left(x^{\prime} \xi_{\tilde{u}}\right): \tilde{u} \in \widetilde{\mathcal{U}}\right\}$ mapping $\mathbb{R}^{p}$ into $\mathbb{R}$ where $\mathcal{M}: \mathbb{R} \rightarrow \mathbb{R}$ is L-Lipschitz. Assume that $\left\|\xi_{\tilde{u}_{2}}-\xi_{\tilde{u}_{1}}\right\|_{1} \leqslant C\left\|\tilde{u}_{2}-\tilde{u}_{1}\right\|$ for all $\tilde{u}_{1}, \tilde{u}_{2} \in \tilde{\mathcal{U}}$ for some constant $C>0$. Then, for any $M>0$ the uniform entropy numbers of $\mathcal{F}$ satisfy

where $F(x)=\sup _{\tilde{u} \in \tilde{\mathcal{U}}}\left|\mathcal{M}\left(x^{\prime} \xi_{\tilde{u}}\right)\right|+M^{-1}\|x\|_{\infty}, x \in \mathbb{R}^{p}$, is its envelope.
Proof. Consider any $f_{1}, f_{2} \in \mathcal{F}$. There exist $\tilde{u}_{1}, \tilde{u}_{2} \in \tilde{\mathcal{U}}$ such that $f_{1}(x)=\mathcal{M}\left(x^{\prime} \xi_{\tilde{u}_{1}}\right)$ and $f_{2}(x)=\mathcal{M}\left(x^{\prime} \xi_{\tilde{u}_{2}}\right)$ for all $x \in \mathbb{R}^{p}$. Therefore, since $\mathcal{M}$ is $L$-Lipschitz, we have

& \leqslant L C M\left\|\tilde{u}_{2}-\tilde{u}_{1}\right\|\left\{M^{-1}\|x\|_{\infty}+\sup _{\tilde{u} \in \tilde{\mathcal{U}}}\left|\mathcal{M}\left(x^{\prime} \xi_{\tilde{u}}\right)\right|\right\} \\
& \leqslant L C M\left\|\tilde{u}_{2}-\tilde{u}_{1}\right\| F(x)
\end{aligned}
$$

by definition of the envelope $F(x)=M^{-1}\|x\|_{\infty}+\sup _{\tilde{u} \in \tilde{\mathcal{U}}}\left|\mathcal{M}\left(x^{\prime} \xi_{\tilde{u}}\right)\right|$. Thus, for any finitely discrete probability measure $Q$ on $\mathbb{R}^{p}$,

Recall that since $B_{\infty} \subset B_{2} \sqrt{k}$ we have $N\left(B_{\infty},\|\cdot\|, \epsilon\right) \leqslant N\left(B_{2} \sqrt{k},\|\cdot\|, \epsilon\right) \leqslant$ $(1+2 \sqrt{k} / \epsilon)^{k}$ where the last inequality follows from standard volume arguments. Furthermore, for any $\epsilon \leqslant \sqrt{k}$ we have $1+2 \sqrt{k} / \epsilon \leqslant 3 k / \epsilon$. Therefore $\log N\left(\epsilon\|F\|_{Q, 2}, \mathcal{F},\|\cdot\|_{Q, 2}\right) \leqslant k \log (3 L C M k / \epsilon)$.

Lemma L.4. Let $\mathcal{F}$ be a class of functions with an envelope $F$. Also, let $\mathcal{M}: \mathbb{R} \rightarrow \mathbb{R}$ be an L-Lipschitz function bounded in absolute value by a
constant $M$. Assume that for some positive constants $C_{1}$ and $C_{2}$, the uniform entropy numbers of $\mathcal{F}$ obey

Then for any constant $K>0$, the uniform entropy numbers of the class of functions $\mathcal{M}(\mathcal{F})=\{\mathcal{M}(f): f \in \mathcal{F}\}$ obey
$\sup _{Q} \log N\left(\epsilon\left\|F_{\mathcal{M}(\mathcal{F})}\right\|_{Q, 2}, \mathcal{M}(\mathcal{F}),\|\cdot\|_{Q, 2}\right) \leqslant C_{1} \log \left(C_{2} K / \epsilon\right), \quad$ for all $0<\epsilon \leqslant 1$,
where $F_{\mathcal{M}(\mathcal{F})}=M+L F / K$ is its envelope.
Proof. The result follows from the observation that for any $f^{\prime}, f^{\prime \prime} \in \mathcal{F}$ and any finitely-discrete probability measure $Q$,

Let $\left(W_{i}\right)_{i=1}^{n}$ be a sequence of independent copies of a random element $W$ taking values in a measurable space $\left(\mathcal{W}, \mathcal{A}_{\mathcal{W}}\right)$ according to a probability law $P$. Let $\mathcal{F}$ be a set of suitably measurable functions $f: \mathcal{W} \rightarrow \mathbb{R}$, equipped with a measurable envelope $F: \mathcal{W} \rightarrow \mathbb{R}$.

Lemma M. 2 (Maximal Inequality I, [9]). Work with the setup above. Suppose that $F \geqslant \sup _{f \in \mathcal{F}}|f|$ is a measurable envelope for $\mathcal{F}$ with $\|F\|_{P, q}<$ $\infty$ for some $q \geqslant 2$. Let $M=\max _{i \leqslant n} F\left(W_{i}\right)$ and $\sigma^{2}>0$ be any positive constant such that $\sup _{f \in \mathcal{F}}\|f\|_{P, 2}^{2} \leqslant \sigma^{2} \leqslant\|F\|_{P, 2}^{2}$. \mathrm{E}_{P}\left[\left\|\mathbb{G}_{n}\right\|_{\mathcal{F}}\right] \leqslant K\left(\sqrt{v \sigma^{2} \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)}+\frac{v\|M\|_{P, 2}}{\sqrt{n}} \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)\right),
$$

where $K$ is an absolute constant. Moreover, for every $t \geqslant 1$, with probability $>1-t^{-q / 2}$,

$$
\begin{aligned}
\left\|\mathbb{G}_{n}\right\|_{\mathcal{F}} \leqslant & (1+\alpha) \mathrm{E}_{P}\left[\left\|\mathbb{G}_{n}\right\|_{\mathcal{F}}\right] \\
& +K(q)\left[\left(\sigma+n^{-1 / 2}\|M\|_{P, q}\right) \sqrt{t}+\alpha^{-1} n^{-1 / 2}\|M\|_{P, 2} t\right], \forall \alpha>0
\end{aligned}
$$

where $K(q)>0$ is a constant depending only on $q$. In particular, setting $a \geqslant n$ and $t=\log n$, with probability $>1-c(\log n)^{-1}$,

$$
\begin{equation*}
\left\|\mathbb{G}_{n}\right\|_{\mathcal{F}} \leqslant K(q, c)\left(\sigma \sqrt{v \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)}+\frac{v\|M\|_{P, q}}{\sqrt{n}} \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)\right) \tag{M.1}
\end{equation*}
$$

where $\|M\|_{P, q} \leqslant n^{1 / q}\|F\|_{P, q}$ and $K(q, c)>0$ is a constant depending only on $q$ and $c$.

Lemma M. 3 (Maximal Inequality II, [9]). Work with the setup above. Suppose that the conditions of Lemma M. 2 are satisfied. Then

$$
\begin{aligned}
& \mathrm{E}_{P}\left[\left\|\mathbb{E}_{n}\left[f^{2}(W)\right]\right\|_{\mathcal{F}}\right]-\sup _{f \in \mathcal{F}} \mathrm{E}_{P}\left[f^{2}(W)\right] \\
& \quad \leqslant \frac{K\|M\|_{P, 2}}{\sqrt{n}}\left(\sigma \sqrt{v \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)}+\frac{v\|M\|_{P, 2} \log \left(\frac{a\|F\|_{P, 2}}{\sigma}\right)}{\sqrt{n}}\right),
\end{aligned}
$$

where $K$ is an absolute constant.
Proof. The proof of the asserted claim coincides one-by-one with that given for the corresponding inequality in Lemma 2.2 of [9], with the constant

3 replaced everywhere by the constant 2 . At the end of the proof, the entropy integral

$$
J(\delta)=\int_{0}^{\delta} \sup _{Q} \sqrt{1+\log N\left(\epsilon\|F\|_{Q, 2}, \mathcal{F},\|\cdot\|_{Q, 2}\right)} d \epsilon
$$

is bounded by $\delta(v \log (a / \delta))^{1 / 2}$ under our condition on the uniform entropy numbers of $\mathcal{F}$.

## APPENDIX N: A BOUND ON SPARSE EIGENVALUES FOR MANY RANDOM MATRICES

The following lemma is a generalization of the main result in [15] to many matrices.

Lemma N.1. Let $\mathcal{U}$ denote a finite set and $\left(X_{u i}\right)_{u \in \mathcal{U}}, i=1, \ldots, n$, be independent (across i) random vectors such that $X_{u i} \in \mathbb{R}^{p}$ with $p \geqslant 2$ and $\left(\mathrm{E}\left[\max _{1 \leqslant i \leqslant n} \max _{u \in \mathcal{U}}\left\|X_{u i}\right\|_{\infty}^{2}\right]\right)^{1 / 2} \leqslant K$. Furthermore, for $k \geqslant 1$, define

$$
\delta_{n}:=\frac{K \sqrt{k}}{\sqrt{n}}\left(\log ^{1 / 2}|\mathcal{U}|+\log ^{1 / 2} p+(\log k)\left(\log ^{1 / 2} p\right)\left(\log ^{1 / 2} n\right)\right)
$$

Then

$$
\begin{gathered}
\mathrm{E}\left[\sup _{\|\theta\|_{0} \leqslant k,\|\theta\|=1} \max _{u \in \mathcal{U}}\left|\mathbb{E}_{n}\left[\left(\theta^{\prime} X_{u}\right)^{2}-\mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]\right]\right|\right] \\
\lesssim \delta_{n}^{2}+\delta_{n} \sup _{\|\theta\|_{0} \leqslant k,\|\theta\|=1, u \in \mathcal{U}} \sqrt{\mathbb{E}_{n} \mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]}
\end{gathered}
$$

up to a universal constant.
Proof. For $T \subset\{1, \ldots, p\}$, let $B_{T}=\left\{\theta \in \mathbb{R}^{p}:\|\theta\|=1, \operatorname{supp}(\theta) \subseteq T\right\}$. Also, for $\mathcal{T}=\cup_{|T|=k} B_{T} \times \mathcal{U}$, let $R:=\sup _{(\theta, u) \in \mathcal{T}}\left(\sum_{i=1}^{n}\left(\theta^{\prime} X_{u i}\right)^{2}\right)^{1 / 2}$ and $M:=\max _{1 \leqslant i \leqslant n, u \in \mathcal{U}}\left\|X_{u i}\right\|_{\infty}$. By symmetrization inequality, Lemma 6.3 in [13], we have

$$
\begin{aligned}
& n \mathrm{E}\left[\sup _{\|\theta\|_{0} \leqslant k,\|\theta\|=1} \max _{u \in \mathcal{U}}\left|\mathbb{E}_{n}\left[\left(\theta^{\prime} X_{u}\right)^{2}-\mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]\right]\right|\right] \\
& \quad \leqslant 2 \mathrm{E}\left[\mathrm{E}\left[\sup _{(\theta, u) \in \mathcal{T}}\left|\sum_{i=1}^{n} \varepsilon_{i}\left(\theta^{\prime} X_{u i}\right)^{2}\right| \mid X\right]\right]
\end{aligned}
$$

where $X=\left(X_{u i}\right)_{u \in \mathcal{U}, 1 \leqslant i \leqslant n}$ and $\left(\varepsilon_{i}\right)_{i=1}^{n}$ is a sequence of independent Rademacher random variables that are independent of $X$. A consequence of Lemma 4.5
in [13] (see equation (4.8)) gives

$$
\mathrm{E}\left[\sup _{(\theta, u) \in \mathcal{T}}\left|\sum_{i=1}^{n} \varepsilon_{i}\left(\theta^{\prime} X_{u i}\right)^{2}\right| \mid X\right] \leqslant(\pi / 2)^{1 / 2} \mathrm{E}\left[\sup _{(\theta, u) \in \mathcal{T}}\left|\sum_{i=1}^{n} g_{i}\left(\theta^{\prime} X_{u i}\right)^{2}\right| \mid X\right]
$$

where $\left(g_{i}\right)_{i=1}^{n}$ is a sequence of independent standard normal random variables that are independent of $X$. In turn, an application of Dudley's integral gives

$$
I_{1}:=\mathrm{E}\left[\sup _{(\theta, u) \in \mathcal{T}}\left|\sum_{i=1}^{n} g_{i}\left(\theta^{\prime} X_{u i}\right)^{2}\right| \mid X\right] \leqslant 8 \int_{0}^{\operatorname{diam}(\mathcal{T})} \log ^{1 / 2} N(\mathcal{T}, d, \epsilon) d \epsilon
$$

where

$$
\operatorname{diam}(\mathcal{T}) \leqslant 2 \sup _{(\theta, u) \in \mathcal{T}}\left(\sum_{i=1}^{n}\left(\theta^{\prime} X_{u i}\right)^{4}\right)^{1 / 2} \leqslant 2 \sqrt{k} M R
$$

using that $\left|\theta^{\prime} X_{u i}\right| \leqslant\left\|X_{u i}\right\|_{\infty}\|\theta\|_{1} \leqslant M \sqrt{k}$, and $d$ is the corresponding Gaussian semi-metric. Furthermore, we have

$$
\log N(\mathcal{T}, d, \epsilon) \leqslant \log |\mathcal{U}|+\max _{u \in \mathcal{U}} \log N\left(\cup_{|T|=k} B_{T} \times\{u\}, d, \epsilon\right)
$$

so that
$I_{1} \leqslant 16 \sqrt{k} M R \log ^{1 / 2}|\mathcal{U}|+8 \int_{0}^{\operatorname{diam}(\mathcal{T})} \max _{u \in \mathcal{U}} \log ^{1 / 2} N\left(\cup_{|T|=k} B_{T} \times\{u\}, d, \epsilon\right) d \epsilon$.
Now, for any $(\theta, u)$ and $(\bar{\theta}, u)$ in $D_{u}^{k}:=\cup_{|T|=k} B_{T} \times\{u\}$, we have

$$
\begin{aligned}
d((\theta, u),(\bar{\theta}, u)) & =\left(\sum_{i=1}^{n}\left\{\left(\theta^{\prime} X_{u i}\right)^{2}-\left(\bar{\theta}^{\prime} X_{u i}\right)^{2}\right\}^{2}\right)^{1 / 2} \\
& \leqslant\left(\sum_{i=1}^{n}\left\{\left(\theta^{\prime} X_{u i}\right)+\left(\bar{\theta}^{\prime} X_{u i}\right)\right\}^{2}\right)^{1 / 2} \max _{1 \leqslant i \leqslant n}\left|(\theta-\bar{\theta})^{\prime} X_{u i}\right| \\
& \leqslant 2 \sup _{(\theta, u) \in \mathcal{T}}\left(\sum_{i=1}^{n}\left(\theta^{\prime} X_{u i}\right)^{2}\right)^{1 / 2} \max _{1 \leqslant i \leqslant n}\left|(\theta-\bar{\theta})^{\prime} X_{u i}\right|=2 R\|\theta-\bar{\theta}\|_{X_{u}}
\end{aligned}
$$

where we let $\|\delta\|_{X_{u}}:=\max _{1 \leqslant i \leqslant n}\left|\delta^{\prime} X_{u i}\right|$. This implies that

$$
N\left(D_{u}^{k}, d, \epsilon\right) \leqslant N\left(D_{u}^{k} / \sqrt{k},\|\cdot\|_{X_{u}}, \epsilon /\{2 \sqrt{k} R\}\right)
$$

Therefore, since $\operatorname{diam}(\mathcal{T}) \leqslant 2 \sqrt{k} M R$, we have

$$
\begin{aligned}
\int_{0}^{\operatorname{diam}(\mathcal{T})} & \max _{u \in \mathcal{U}} \log ^{1 / 2} N\left(D_{u}^{k}, d, \epsilon\right) d \epsilon \\
& \leqslant \int_{0}^{2 \sqrt{k} M R} \max _{u \in \mathcal{U}} \log ^{1 / 2} N\left(D_{u}^{k} / \sqrt{k},\|\cdot\|_{X_{u}}, \epsilon /\{2 \sqrt{k} R\}\right) d \epsilon \\
& =2 \sqrt{k} R \int_{0}^{M} \max _{u \in \mathcal{U}} \log ^{1 / 2} N\left(D_{u}^{k} / \sqrt{k},\|\cdot\|_{X_{u}}, \epsilon\right) d \epsilon .
\end{aligned}
$$

Note that $B_{T} / \sqrt{k} \subset B_{T}^{1}$ and $D_{u}^{k} / \sqrt{k} \subset B^{1} \times\{u\}$ where $B^{1}:=\{\theta \in$ $\left.\mathbb{R}^{p}:\|\theta\|_{1} \leqslant 1\right\}$ and $B_{T}^{1}=\left\{\theta \in B^{1}: \operatorname{supp}(\theta) \subseteq T\right\}$. It follows from Lemma 3.9 in [15] that $N\left(B^{1},\|\cdot\|_{X_{u}}, \epsilon\right) \leqslant(2 p)^{A \epsilon^{-2} M^{2} \log n}$ for all $\epsilon>0$ and some universal constant $A$. Moreover, as in the discussion after Lemma 3.9 in [15], we have $N\left(B_{T}^{1},\|\cdot\|_{X_{u}}, \epsilon\right) \leqslant(1+2 M / \epsilon)^{k}$ for all $\epsilon>0$ and all $T \subset\{1, \ldots, p\}$ with $|T|=k$, so that $N\left(D_{u}^{k} / \sqrt{k},\|\cdot\|_{X_{u}}, \epsilon\right) \leqslant\binom{ p}{k}(1+2 M / \epsilon)^{k}$ for all $\epsilon>0$. Therefore,

$$
\begin{aligned}
\int_{0}^{M} & \max _{u \in \mathcal{U}} \log ^{1 / 2} N\left(D_{u}^{k} / \sqrt{k},\|\cdot\|_{X_{u}}, \epsilon\right) d \epsilon \\
\leqslant & \int_{0}^{M / \sqrt{k}} \log ^{1 / 2}\left(\binom{p}{k}(1+2 M / \epsilon)^{k}\right) d \epsilon \\
& +\int_{M / \sqrt{k}}^{M} \log ^{1 / 2}\left((2 p)^{A \epsilon^{-2} M^{2} \log n}\right) d \epsilon \\
\leqslant & \frac{M}{\sqrt{k}} \log ^{1 / 2}\binom{p}{k}+\sqrt{k} \int_{0}^{M / \sqrt{k}} \log ^{1 / 2}(1+2 M / \epsilon) d \epsilon \\
& +A^{1 / 2} M\left(\log ^{1 / 2} n\right)\left(\log ^{1 / 2}(2 p)\right) \int_{M / \sqrt{k}}^{M} \frac{d \epsilon}{\epsilon} \\
\leqslant & M \log ^{1 / 2} p+M\left(1 / 2+\log ^{1 / 2}(1+2 \sqrt{k})\right) \\
& +A^{1 / 2} M\left(\log ^{1 / 2} n\right)\left(\log ^{1 / 2}(2 p)\right)(\log M-\log (M / \sqrt{k})) \\
\lesssim & M\left(\log ^{1 / 2} p+(\log k)\left(\log ^{1 / 2} n\right)\left(\log ^{1 / 2} p\right)\right)
\end{aligned}
$$

up to a universal constant where in the third inequality, we used the fact that integrating by parts gives

$$
\sqrt{k} \int_{0}^{M / \sqrt{k}} \log ^{1 / 2}(1+2 M / \epsilon) d \epsilon \leqslant M\left(1 / 2+\log ^{1 / 2}(1+2 \sqrt{k})\right)
$$

Collecting the terms, we obtain

$$
I_{1} \lesssim \sqrt{k} M R\left(\log ^{1 / 2}|\mathcal{U}|+\log ^{1 / 2} p+(\log k)\left(\log ^{1 / 2} n\right)\left(\log ^{1 / 2} p\right)\right)
$$

Therefore, since $K \geqslant\left(\mathrm{E}\left[M^{2}\right]\right)^{1 / 2}$, setting

$$
\delta_{n}=\frac{K \sqrt{k}}{\sqrt{n}}\left(\log ^{1 / 2}|\mathcal{U}|+\log ^{1 / 2} p+(\log k)\left(\log ^{1 / 2} n\right)\left(\log ^{1 / 2} p\right)\right)
$$

gives

$$
\begin{aligned}
I_{2} & =\mathrm{E}\left[\sup _{\|\theta\|_{0} \leqslant k,\|\theta\|=1} \max _{u \in \mathcal{U}}\left|\mathbb{E}_{n}\left[\left(\theta^{\prime} X_{u}\right)^{2}-\mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]\right]\right|\right] \\
& \lesssim \frac{\delta_{n} \mathrm{E}[M R]}{K \sqrt{n}} \leqslant\left(\delta_{n} / K\right)\left(\mathrm{E}\left[M^{2}\right]\right)^{1 / 2}\left(\mathrm{E}\left[R^{2} / n\right]\right)^{1 / 2} \leqslant \delta_{n}\left(E\left[R^{2} / n\right]\right)^{1 / 2} \\
& \lesssim \delta_{n}\left(I_{2}+\sup _{\|\theta\|_{0} \leqslant k,\|\theta\|=1, u \in \mathcal{U}} \mathbb{E}_{n} \mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]\right)^{1 / 2} .
\end{aligned}
$$

Thus, because $a \leqslant \delta_{n}(a+b)^{1 / 2}$ implies $a \leqslant \delta_{n}^{2}+\delta_{n} b^{1 / 2}$, we have

$$
I_{2} \lesssim \delta_{n}^{2}+\delta_{n} \sup _{\|\theta\|_{0 \leqslant k},\|\theta\|=1, u \in \mathcal{U}} \sqrt{\mathbb{E}_{n} \mathrm{E}\left[\left(\theta^{\prime} X_{u}\right)^{2}\right]}
$$

up to an absolute constant. This completes the proof.
