THE TRAPPING EFFECT ON DEGENERATE HORIZONS

ABSTRACT. We show that degenerate horizons exhibit a new trapping effect. Specifically, we obtain a non-degenerate Morawetz estimate for the wave equation in the domain of outer communications of extremal Reissner-Nordström up to and including the future event horizon. We show that such an estimate requires 1) a higher degree of regularity for the initial data, reminiscent of the regularity loss in the high-frequency trapping estimates on the photon sphere, and 2) the vanishing of an explicit quantity that depends on the restriction of the initial data on the horizon. The latter condition demonstrates that degenerate horizons exhibit a new L^2 concentration phenomenon (namely, a *global* trapping effect, in the sense that this effect is not due to individual underlying null geodesics as in the case of the photon sphere). We moreover uncover a new *stable* higher-order trapping effect; we show that higher-order estimates do not hold regardless of the degree of regularity and the support of the initial data. We connect our findings to the spectrum of the stability operator in the theory of marginally outer trapped surfaces (MOTS). Our methods and results play a crucial role in our upcoming works on linear and non-linear wave equations on extremal black hole backgrounds.

1. INTRODUCTION

1.1. **Overview.** Black holes are one of the most celebrated predictions of general relativity and as such their stability properties are of fundamental importance. The first step in resolving the non-linear stability problem for black holes is to establish quantitative decay estimates for the wave equation

$$(1.1) \qquad \qquad \Box_a \psi = 0$$

on fixed black hole backgrounds. One of the main difficulties in the analysis of the wave equation on such backgrounds is the so-called *trapping effect* due to the existence of a family of *trapped null geodesics* in the domain of outer communications whose limit point is the future timelike infinity. In the well-known Kerr-Newman family of black holes, there is a family of trapped null geodesics with constant Boyer-Lindquist coordinate r. In the special subfamily consisting of Schwarzschild backgrounds these trapped null geodesics span the hypersurface r = 3M known as the photon sphere. Here M is the mass parameter. From every other point in the Schwarzschild exterior region there is a codimension-one subset of future-directed null directions whose corresponding geodesics approach the photon sphere, and all other null geodesics either cross the event horizon $\mathcal{H} = \{r = r_{hor}\}$ or terminate at null infinity.

The trapped null geodesics pose a well-known high-frequency obstruction, known as the trapping effect, for the existence of a non-degenerate Morawetz estimate for the wave equation of the form

(1.2)
$$\int_0^\tau \int_{\Sigma_t \cap \{r_{hor} < R_1 \le r \le R_2\}} |\partial \psi|^2 \, dg_{\Sigma_t} \, dt \le C \int_{\Sigma_0} |\partial \psi|^2 \, dg_{\Sigma_0},$$

where the trapped null geodesics exist in the region $\{r_{hor} < R_1 \le r \le R_2\}$. The obstruction for (1.2) originates from the existence of high-frequency solutions to the wave equation with finite initial energy which are supported in a neighborhood of trapped null geodesics for arbitrarily long times. This phenomenon has long been studied in the context of the obstacle problem for the wave equation in Minkowski space, where the analogue of trapped null geodesics are null lines which reflect off the obstacle's boundary. Recently, Sbierski [32], building on previous work of Ralston [30] on the Gaussian beam approximation, showed that, on general Lorentzian manifolds, the energy at time t of the localized high frequency solutions is comparable to the energy of the underlying null geodesic at time t. The fact that the energy of the trapped null geodesics in the Kerr–Newman family is constant immediately contradicts estimate (1.2). On the other hand, it can be shown (see, for instance, [13, 14, 17, 36] and references there-in) that on sub-extremal backgrounds estimate (1.2) holds if the right hand side loses derivatives (i.e includes higher order energies).

Having introduced the trapping effect on the photon sphere we next consider the event horizon. The event horizon is a null hypersurface ruled by null geodesics, known as the *null generators*. In the *sub-extremal* case, however, one can show a local integrated decay Morawetz estimate in a neighborhood of the event horizon without any loss of differentiation (see [13]). This is possible because the energy of the null generators *decays exponentially* in time t, in view of the so-called *redshift effect* which in turn is based on the positivity of the *surface gravity* (see Section 2 for an introduction to these notions). Hence, no trapping takes place on the event horizon of sub-extremal black holes, even though the latter is ruled by null geodesics.

Nonethelesss, the situation is drastically different for *degenerate horizons*, which are null hypersurfaces with vanishing surface gravity. This is the case for the event horizon of *extremal* black holes. In this case the null generators have energy that is constant in time. Hence, Sbierski's result implies that loss of regularity is a *necessary* condition for the existence of a non-degenerate Morawetz estimate up to and including the event horizon. However, until now there had not been any works providing *sufficient* conditions. In fact, it was not known if generic solutions satisfy a Morawetz estimate.

In a series of papers [3, 4, 5] the second author initiated the mathematical study of the wave equation on extremal black holes and obtained a mixture of stability and instability results. Specifically, it was shown that solutions to the wave equation decay in time towards the future, first-order derivatives remain bounded but do not decay along the event horizon whereas higher order derivatives asymptotically blow up along the event horizon. The derivatives are here taken with respect to the Eddington– Finkelstein coordinate system (v, r, θ, ϕ) ; indeed, it is the $\partial_r \psi$ derivative of solutions ϕ to the wave equation that does not decay along the horizon. Note that this is a natural derivative to consider since in the extremal case v is an affine parameter along null geodesics (this is in contrast to the situation in subextremal black holes, where the corresponding parameter is logarithmically related to the geodesic parameter). Hence, the previous instability results hold in Gaussian (geodesic) coordinates and are not merely an effect of imposing coordinates based on the Killing vector and observers at null infinity.

We remark that these stability and instability results do **not** suffice to determine whether a non-degenerate Morawetz estimate up to and including the event horizon holds for general smooth solutions to the wave equation on extremal black holes (see Section 1.3 for more details). It is important to emphasize that such a Morawetz estimate would play a crucial role in rigorously testing the validity of the aforementioned stability and instability features in non-linear settings.

1.2. Summary of results and techniques. In this paper we derive necessary and sufficient conditions for the existence of a non-degenerate Morawetz estimate in the domain of outer communications of extremal Reissner–Nordström backgrounds up to and including the event horizon. Such estimates play a fundamental role in the analysis of non-linear wave equations and hence necessary and sufficient conditions for their existence are relevant for the study of the black hole stability problem.

Summary of results

We obtain a complete characterization of the trapping effect on the event horizon of extremal Reissner–Nordström. Specifically, we obtain a non-degenerate Morawetz estimate (see Theorem 3.1 in Section 3) in the domain of outer communications of extremal Reissner–Nordström up to and including the future event horizon. We show that such an estimate requires

- (1) a higher degree of regularity for the initial data,
- (2) the vanishing of the quantity $H[\psi]$ given by (3.7). We remark that $H[\psi]$ depends only on the restriction of the initial data on the horizon.

Note that the first condition is reminiscent of the regularity loss in the high-frequency trapping estimates on the photon sphere. In fact, we will show a result in the converse direction (see Theorem 3.3 in Section 3):

• if a weighted higher-order norm of the initial data is infinite then no nondegenerate Morawetz estimate holds.

This implies that the loss of regularity of our result is *optimal*. We also prove that the vanishing of the quantity $H[\psi]$ is *necessary* in the following sense (see Theorem 3.2 in Section 3):

• if the quantity $H[\psi]$ given by (3.7) is initially non-zero then no non-degenerate Morawetz estimate holds, regardless of the degree of regularity of the initial data.

The above result demonstrates that degenerate horizons exhibit a new *global trapping effect*, in the sense that this effect is not due to individual underlying null geodesics as in the case of the photon sphere. This global trapping effect is closely related to the spectrum of the *stability operator* for the sections of the event horizon (see Section 6).

Furthermore, a new stable higher order trapping effect is uncovered (see Theorem 3.4 in Section 3), in the sense that

• higher order estimates up to and including the event horizon generically do **not** hold regardless of the degree of regularity and the support of the initial data.

Summary of techniques

We decompose ψ as follows (see Section 4.1)

$$\psi = \left(\int_{\mathbb{S}^2} \psi\right) + \left(\psi - \int_{\mathbb{S}^2} \psi\right)$$

and for each componenet we use novel physical space¹ vector field multipliers.

For the spherical mean we use the singular vector field

$$S = -\frac{1}{r - r_{hor}} \cdot Y$$

as a *multiplier* vector field (see Section 2.4 for an introduction to the vector field method). Here r_{hor} is the radius of the event horizon and Y is a regular translation-invariant *transversal* to the event horizon vector field (see Section 2). Clearly, S is singular on the event horizon. The choice of this singular multiplier is motivated by the spectral properties of the stability operator for MOTS (see Section 6). It seems that it is the first time that properties of the stability operators are used to yield estimates for hyperbolic equations.

We apply the divergence identity in regions \mathcal{A}_{r_0} (see Section 2, figure 2.1) which do not include the event horizon if $r_0 > r_{hor}$ and study the limiting behavior of the resulting equations are $r_0 \rightarrow r_{hor}$. We uncover a special structure of the geometry of degenerate horizons to show that all the resulting singular terms can be estimated by singular norms of the initial data. The boundedness of these singular norms (which is an assumption on the initial data only) implies a non-degenerate Morawetz estimate.

an assumption on the initial data only) implies a non-degenerate Morawetz estimate. One of the most critical terms is the integral $\int_{\mathcal{A}_{r_0}} \frac{1}{r-r_{hor}} T\psi \cdot Y\psi$, where T is the stationary Killing field (see (4.24)). Clearly the integral of the integrand quantity $\frac{1}{r-r_{hor}}T\psi \cdot Y\psi$ over a spacial slice Σ_{τ} is infinite. However, we were able to show that if we first integrate $\frac{1}{r-r_{hor}}T\psi \cdot Y\psi$ over time and then over space then the resulting expression has a finite limit as $r \to r_{hor}$. In Section 4.6 it is shown that in the sub-extremal case the corresponding limit is infinite demonstrating thus a new distinctive feature of degenerate horizons.

For the component $\psi - \int_{\mathbb{S}^2} \psi$, we use the vector field Y as a *commutator* vector field (see Section 2.4) and the *degenerate* vector field $\bar{\partial} = -(r - r_{hor}) \cdot Y$ as multiplier vector field. Our estimates rely on appropriate use of Hardy and Poincaré inequalities and a novel structure of the wave equation in a neighborhood of the degenerate event horizon which yields various cancellations of the most dangerous terms. It is worth contrasting this with the trapping estimate at the photon sphere where one is required to commute with either the Killing field T or the standard Killing fields Ω_i , i = 1, 2, 3of the sphere. All these vector fields are tangential to the photon sphere.

We note that our methods and results play a crucial role in our upcoming works on linear and non-linear wave equations on extremal black hole backgrounds.

1.3. **Previous results.** To put our results into context, we briefly summarize previous work on the wave equation on black hole backgrounds. The study of the wave equation (1.1) on black hole backgrounds has a long history, starting in 1957 with the pioneering work of Regge–Wheeler [31] on the mode stability of (1.1) on Schwarzschild (a = 0). The first quantitative result in Schwarzschild was obtained in 1987 by Kay–Wald [20], who proved uniform boundedness of solutions to the wave equation. In the last two decades there have been many (partial) results on the asymptotic behaviour of linear waves in the domain of outer communication of sub-extremal Kerr backgrounds, for which |a| < M, culminating in the proof of polynomial decay in time for solutions to (1.1) on the full sub-extremal range |a| < M of Kerr backgrounds by Dafermos–Rodnianski–Shlapentokh-Rothman [14]; see also [14, 13, 1, 34] for a comprehensive list of references to earlier works. We also refer the reader to the inverse logarithmic decay results for solutions to the wave equation on spacetimes exhibiting *stable* trapping [19, 26, 21].

The rigorous study of mathematical properties of the wave equation on extremal black holes was initiated in a series of papers [4, 5, 6, 11] where a mixture of stability and instability results was presented. Subsequent works of Reall, Murata, Lucietti et al [28, 27, 23, 24] studied in a series of papers these instability properties on more general linear and non-linear settings. The authors of [28] numerically investigated spherically symmetric perturbations of extremal Reissner–Nordström in the context of the Cauchy problem for the Einstein–Maxwell-scalar field system and discovered that, even for arbitrarilly small initial perturbations, derivatives of the scalar field grow (in complete agreement with the work in the linear case). Ori [29] and Sela [33] have numerically investigated the relation of long time dynamics of scalar fields and the conservation laws. Rigorous non-linear results have appeared in [10, 2]. Further applications and extensions have been presented in [19, 35, 16, 8]. For work in the interior of extremal black holes we refer to [18].

2. Background on the geometry of extremal R-N

2.1. The extremal R–N spacetime. We define the extremal Reissner–Nordström spacetime as the Lorentzian manifold (\mathcal{M}, g) , where $\mathcal{M} = \mathbb{R} \times \mathbb{R}_+ \times \mathbb{S}^2$. We introduce the *ingoing Eddington–Finkelstein coordinate chart* (v, r, θ, φ) , where $v \in \mathbb{R}, r \in \mathbb{R}_+$ and (θ, φ) are the standard polar coordinates on the round sphere \mathbb{S}^2 . In these coordinates, the metric can be expressed as:

$$g = -Ddv^2 + 2dvdr + r^2(d\theta^2 + \sin^2\theta d\varphi^2),$$

where $D := r^{-2}(M - r)^2$. This metric, along with the associated Faraday tensor

$$F = M/r^2 dr \wedge dv + M \sin \theta d\theta \wedge d\phi,$$

is a solution to the Einstein–Maxwell equations.

The null hypersurface $\mathcal{H} := \{r = M\}$ is called the *future event horizon*. The region $\mathcal{M}_{ext} \doteq \mathcal{M} \cap \{r > M\}$ is known as the *exterior region* or *domain of outer communica*tions of extremal Reissner–Nordström. The interior region $\mathcal{M}_{int} \doteq \mathcal{M} \cap \{0 < r < M\}$ will not feature in the remainder of this paper.

We will refer to the coordinate v as the *advanced null coordinate*. We can introduce a *retarded null coordinate* u, given by $u = v - 2r_*$, where r_* is defined as a solution to $\frac{dr_*}{dr} = D^{-1}$ and is given explicitly by

$$r_*(r) = \frac{M^2}{M-r} + 2M\log(M-r) + r.$$

The tuple (u, v, θ, φ) constitutes a coordinate chart on \mathcal{M}_{ext} , commonly referred to as *Eddington–Finkelstein double-null coordinates*. In these coordinates, the metric is given by

$$g = -Ddudv + r^2(d\theta^2 + \sin^2\theta d\varphi^2).$$

Let Σ be a spherically symmetric asymptotically flat spacelike hypersurface in \mathcal{M} such that $\Sigma \cap \mathcal{H} \neq \emptyset$. Let $M < R < R_2$. We define Σ_0 as:

$$\Sigma_0 \doteq (\Sigma \cap \{R \le r \le R_2\}) \cup \{v = v_{\Sigma}(R), M \le r \le R\} \cup \{u = u_{\Sigma}(R_2), v_{\Sigma}(R_2) \le v < \infty\}$$

Here, v_{Σ} and u_{Σ} denote the restrictions to Σ of the functions v and u to, respectively. See Figure 2.1. In this paper, we will only consider the region $J^+(\Sigma_0)$, which is foliated by the hypersurfaces $\Sigma_{\tau} = \varphi_{\tau}^{\partial_v}(\Sigma_0)$, where $\varphi_{\tau}^{\partial_v}$ is the flow generated by the vector field ∂_v , the latter being taken with respect to the ingoing E–F coordinates. We next define several regions and hypersurfaces that will be very important in our analysis. Consider the outgoing hypersurfaces H_{r_0} which are defined as follows:

$$H_{r_0} \doteq J^+(\Sigma_0) \cap \{ u = u_{\Sigma_0}(r_0), r \le R \}$$

and the following timelike hypersurface:

$$B_R \doteq \{r = R\} \cap J^+(\Sigma_0).$$




FIGURE 1. The Penrose diagram of extremal Reissner–Nordström




FIGURE 2. Representation of spacetime regions

We will frequently restrict to the region $\mathcal{A}_{r_0} \subset J^+(\Sigma_0)$, where

$$\mathcal{A}_{r_0} \doteq J^+(\Sigma_0) \cap \{r \le R\} \cap J^-(H_{r_0})$$

and we vary $r_0 \in (M, R)$. Here, u_{Σ_0} denotes the function u restricted to Σ_0 . Note that H_{r_0} approaches \mathcal{H} in the limit $r_0 \downarrow M$. We define the corresponding limiting region \mathcal{A} as follows:

$$\mathcal{A} \doteq J^+(\Sigma_0) \cap \{M \le r \le R\}$$

Let, finally, \mathbf{n}_{Σ} denote the (future) normal to the hypersurface Σ .

2.2. Photon sphere. By the causal geometry of \mathcal{M}_{ext} , one can easily infer the existence of geodesics that do not cross \mathcal{M} or approach future null infinity \mathcal{I}^+ . A class of these geodesics $\gamma : \mathbb{R} \to \mathcal{M}_{ext}$ can be parametrized as follows:

$$\gamma(\tau) = (v(\tau), 2M, \frac{\pi}{2}, \varphi(\tau)),$$

where $v(\tau)$ and $\varphi(\tau)$ depend linearly on τ . The timelike hypersurface $\{r = 2M\}$ is called the *photon sphere*. As was mentioned before, the existence of these geodesics gives rise to the trapping effect of the photon sphere. This is manifested in the loss of regularity to Morawetz estimates for the wave equation (1.1) (see estimate 3.2).

2.3. The red-shift effect. The vector field $T \doteq \partial_v$ is a causal Killing vector field that is timelike in \mathcal{M}_{ext} and null on \mathcal{H} . Correspondingly, we can define the *surface* gravity of \mathcal{H} with respect to T as the function $\kappa : \mathcal{H} \to \mathbb{R}$, such that

$$\nabla_T T|_{\mathcal{H}} = \kappa \cdot T|_{\mathcal{H}}.$$

In sub-extremal Reissner–Nordström spacetimes, the surface gravity, which is analogously defined, is strictly positive. However, in extremal Reissner–Nordström we have that $\kappa = 0$. A horizon with a corresponding vanishing surface gravity is called a *degenerate horizon*.

The relevance of the sign of κ can be understood geometrically by considering the null geodesics γ that generate \mathcal{H} . The energy of null geodesics in Reissner–Nordström with respect to the timelike ∂_v -invariant vector field $\partial_v - \partial_r$ decays exponentially in time with an exponent proportional to κ . The corresponding physical interpretation is that the frequency of a light signal sent by an observer crossing the event horizon to another observer crossing the event horizon at a later time is red-shifted. This redshift effect in the context of decay results for the wave equation was first used by Dafermos and Rodnianski in [12]. The degenaracy of the redshift effect in the extremal case introduces an additional difficulty in the analysis of the wave equation on such backgrounds.

2.4. Energy currents and the vector field method. The energy-momentum tensor \mathbf{T} corresponding to the wave equation (1.1) is a symmetric 2-tensor with components

$$\mathbf{T}_{\alpha\beta}[f] = \partial_{\alpha}f\partial_{\beta}f - \frac{1}{2}g_{\alpha\beta}(g^{-1})^{\gamma\delta}\partial_{\gamma}f\partial_{\delta}f.$$

Moreover,

$$\nabla^{\beta} \mathbf{T}_{\alpha\beta}[f] = \partial_{\alpha} f \Box_g f,$$

so $\mathbf{T}[\psi]$ is divergence-free for solutions ψ to (1.1).

Let V be a vector field. Then we denote the energy current with respect to V by J^V , where $J^V = \mathbf{T}(V, \cdot)$. Let W be another vector field, then we denote

$$J^{V}[f] \cdot W = \mathbf{T}[f](V, W).$$

An immediate calculation yields

$$\operatorname{div} J^{V}[f] = K^{V}[f] + \mathcal{E}^{V}[f],$$

where

$$K^{V}[f] \doteq \mathbf{T}^{\alpha\beta} \nabla_{\alpha} V_{\beta},$$

$$\mathcal{E}^{V}[f] \doteq V^{\alpha} \nabla^{\beta} \mathbf{T}_{\alpha\beta}[f] = V(f) \Box_{g} f.$$

Note that $\mathcal{E}^{V}[\psi] = 0$ for solutions ψ to (1.1). Furthermore, $K^{V}[f] = 0$ if V is a Killing vector field. The vector field method (see also [22]) comprises a careful choice of the vector field V (the vector field multiplier) and W, where $f = W\psi$ (the commutation

vector field), so as to obtain suitable energy estimates after applying Stokes' theorem in appropriate spacetime regions.

Consider the vector fields

$$(2.1) T := \partial_v, \quad Y := \partial_r$$

with respect to the (v, r, θ, ϕ) coordinate system. The vector field T is timelike in \mathcal{M}_{ext} and null along \mathcal{H} . The vector field Y is regular and transversal to \mathcal{H} .

We introduce the vector fields P, N (see also [4, 5]), which *close* to the event horizon satisfy the following

$$P \sim T - (r - M) \cdot Y,$$

$$N \sim T - Y,$$

Observe that N is future-directed and *strictly* timelike in $J^+(\Sigma_0)$. On the other hand, the vector field P is timelike in \mathcal{M}_{ext} and null at \mathcal{H}^+ .

One can easily check that close to the event horizon it holds

(2.2)
$$J^{T}[f] \cdot N \sim (Tf)^{2} + (r - M)^{2} \cdot (Yf)^{2} + |\nabla f|^{2},$$
$$J^{P}[f] \cdot N \sim (Tf)^{2} + (r - M) \cdot (Yf)^{2} + |\nabla f|^{2},$$
$$J^{N}[f] \cdot N \sim (Tf)^{2} + (Yf)^{2} + |\nabla f|^{2},$$

where ∇ denotes the covariant derivative restricted to the spheres of constant v and r.

3. The main theorems

For the definition of relevant notions and notation and, in particular, for the definition of specific regions, hypersurfaces, vector fields and their fluxes, see section 2.

We study the Cauchy problem for the linear wave equation (1.1) on the exterior \mathcal{M} of the extreme Reissner–Nordström spacetime up to and including the event horizon \mathcal{H} with initial data

$$\psi|_{\Sigma_0} \in H^s_{\operatorname{loc}}(\Sigma_0), \ D_{\operatorname{tran}}\psi|_{\Sigma_0} \in H^{s-1}_{\operatorname{loc}}(\Sigma_0),$$

where D_{tran} is a transversal to Σ_0 vector field. The hypersurface Σ_0 is as defined in Section 2. We assume that s is sufficiently large so that all the weighted norms of our estimates are finite.

3.1. Summary of previous results. For the reader's convenience we recall some of the key results of [4, 5] for solutions ψ to (1.1) on extremal Reissner–Nordström:

(1) Energy boundedness.

(3.1)
$$\int_{\Sigma_{\tau}} \left(J^{V}[\psi] \cdot \mathbf{n}_{\Sigma_{\tau}} \right) dg_{\Sigma_{\tau}} \leqslant C \int_{\Sigma_{0}} \left(J^{V}[\psi] \cdot \mathbf{n}_{\Sigma_{0}} \right) dg_{\Sigma_{0}},$$
where $V \in \{T, P, N\}$

where $V \in \{T, P, N\}$.

(2) Integrated local energy decay.

(3.2)
$$\int_{\{M \le r \le r_0\}} \left((T\psi)^2 + |\nabla\psi|^2 + (r - M) \cdot (Y\psi)^2 \right) + \int_{\{r_0 \le r \le r_1\}} \left((\partial_{r^*}\psi)^2 + (r - 2M)^2 \cdot \left((T\psi)^2 + |\nabla\psi|^2 \right) \right) \leqslant C \int_{\Sigma_0} \left(J^N[\psi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0},$$

where $M < r_0 < 2M < r_1$. Note that this estimate degenerates both on the photon sphere and on the horizon. Specifically, the degeneracy applies to

- the *tangential* derivatives to the photon sphere,
- the *transversal* derivatives to the event horizon.

Removing the degeneracy at the photon sphere comes at the expense commuting with the Killing field T. Theorem 3.1 below provides an estimate which does not degenerate at the horizon.

(3) Energy decay

(3.3)
$$\int_{\Sigma_{\tau}} \left(J^T[\psi] \cdot \mathbf{n}_{\Sigma_{\tau}} \right) dg_{\Sigma_{\tau}} \leqslant \frac{C}{\tau^2} \cdot I[\psi]$$

where $I[\psi]$ is a suitable weighted norm of the initial data.

(4) Conserved quantities and instabilities on the horizon.

a) The quantity

(3.4)
$$\int_{\Sigma_{\tau} \cap \mathcal{H}} \left(Y\psi + \frac{1}{M}\psi \right)$$

is conserved along the event horizon (i.e. independent of τ). In fact, in [5] a hierarchy of conservation laws was established for each angular frequency.

b) For generic solutions we have the following blow-up result

$$\max_{\Sigma_{\tau}\cap\mathcal{H}}|Y^kT^m\psi|\to\infty,$$

asymptotically along \mathcal{H} as $\tau \to \infty$, for $k \ge m+2$.

3.2. The statements of the main theorems. The main results of the present paper concern non-degenerate Morawetz estimates up to and including the event horizon \mathcal{H} .

Theorem 3.1 (The trapping estimate). Consider the following weighted norm on the Cauchy hypersurface Σ_0

$$D_{\Sigma_{0}}^{w}[\psi] := \int_{\Sigma_{0} \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(Y\psi + \frac{1}{r}\psi \right)^{2} \right] dr \, d\omega$$

$$(3.5) \qquad \qquad + \int_{\Sigma_{0}} \left(J^{P}[\psi] \cdot \boldsymbol{n}_{\Sigma_{0}} \right) dg_{\Sigma_{0}} + \int_{\Sigma_{0}} \left(J^{P}[T\psi] \cdot \boldsymbol{n}_{\Sigma_{0}} \right) dg_{\Sigma_{0}}$$

$$+ \int_{\Sigma_{0} \cap \{r \le R\}} \left(J^{P}[Y\psi] \cdot \boldsymbol{n}_{\Sigma_{0}} \right) dg_{\Sigma_{0}},$$

where the J^P flux and the constant R are as defined in Section 2.

Then, there is a constant C > 0 that depends only on the mass parameter M such that for all solutions ψ to the wave equation on extremal Reissner-Nordström which arise from initial data with bounded $D_{\Sigma_0}^w$ norm the following non-degenerate Morawetz estimate holds

(3.6)
$$\int_{\mathcal{A}} \left[\psi^2 + (Y\psi)^2 + (T\psi)^2 + |\nabla \psi|^2 \right] dg_{\mathcal{A}} \leq C \cdot D^w_{\Sigma_0}[\psi].$$

Here \mathcal{A} is the spacetime region $\{M \leq r \leq R\}$ which, in particular, contains the future event horizon $\mathcal{H} = \{r = M\}$.

Remark 3.1. Observe that the right hand side of (3.6) requires higher regularity than its left hand side. Furthermore, the boundedness of the $D_{\Sigma_0}^w$ norm forces the conserved charge

$$H[\psi] = \int_{\Sigma_0 \cap \mathcal{H}} \left(Y\psi + \frac{1}{M}\psi \right) d\omega$$

to vanish. Note that if the data are in C^2 and the conserved charge $H[\psi]$ vanishes, then the integral

$$\int_{\Sigma_0 \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(Y\psi + \frac{1}{r}\psi \right)^2 \right] dr \, d\omega$$

is bounded by the remaining three integrals in (3.5).

Hence not only Theorem 3.1 requires high regularity for the initial data but also requires the vanishing of the conserved charge $H[\psi]$. The next two theorems show that this result is optimal by providing results in the converse direction.

Theorem 3.2 (Trapping and conserved charges). If ψ is a solution to the wave equation on extremal Reissner–Nordström with smooth compactly supported initial data for which the conserved charge

(3.7)
$$H[\psi] := \int_{\Sigma_0 \cap \mathcal{H}} \left(Y\psi + \frac{1}{M}\psi \right) d\omega \neq 0$$

then

$$\int_{\mathcal{A}} (Y\psi)^2 \, dg_{\mathcal{A}} = \infty.$$

Hence, no non-degenerate Morawetz estimate holds for such solutions ψ to the wave equation.

Remark 3.2. Theorem 3.2 shows that trapping takes place on degenerate horizons even for smooth solutions as long as their conserved charge is non-vanishing. It, in particular, implies that the trapping effect on degenerate horizon is not only due to a high frequency obstruction that requires loss of regularity but also due to global properties of the horizon which are independent of the degree of regularity of the initial data. This yields a new L^2 -concentration phenomenon for degenerate horizon. Hence, the degenerate horizon \mathcal{H} should be thought of as being trapped as a whole. This is in stark contrast with the trapping effect at the photon sphere where trapping is due to high frequency solutions which are supported for arbitrarily long times in small neighborhoods of individual null geodesics on the photon sphere.

The next theorem shows that the regularity required in Theorem 3.1 for the nondegenerate estimate (3.6) to hold is in fact *optimal*. Specifically, we will show that the non-degenerate spacetime integral $\int_{\mathcal{A}} |\partial \psi|^2$ is not bounded if we assume that the initial data are less regular than required for the boundedness of $D_{\Sigma_0}^w$. We have the following

Theorem 3.3 (Trapping and optimal loss of regularity). Consider initial data for the wave equation on extremal Reissner–Nordström such that the conserved charge is vanishing

$$(3.8) H[\psi] = 0$$

and

(3.9)
$$\int_{\Sigma_0 \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(Y\psi + \frac{1}{r}\psi \right)^2 \right] dr \, d\omega = \infty.$$

Clearly condition (3.9) implies that

$$D^w_{\Sigma_0}[\psi] = \infty$$

Then, no non-degenerate Morawetz estimate holds for ψ , that is

$$\int_{\mathcal{A}} \left(Y\psi \right)^2 \, dg_{\mathcal{A}} = \infty$$

The last theorem concerns higher order trapping estimates. Specifically, we show that *higher order stable trapping takes place on degenerate horizons*. We have the following

Theorem 3.4 (Stable higher-order trapping). Generic solutions to the wave equation on extremal Reissner–Nordström with generic smooth initial data which are supported in $\{M < R_1 \leq r \leq R_2\}$ satisfy

$$\int_{\mathcal{A}} \left(Y^k \psi \right)^2 dg_{\mathcal{A}} = \infty, \text{ for } k \ge 2$$

and hence no non-degenerate higher order Morawetz estimate holds.

Hence, no non-degenerate higher order Morawetz estimate holds even for initial data which are compactly supported and supported away from the horizon and as such any charge on the event horizon initially vanishes and any weighted higher order norm is finite. This implies that stable higher order trapping takes place on degenerate horizons.

Remark 3.3. As will become evident from the proof, the divergence of the above integrals arises from spherically symmetric solutions to the wave equation. Given that the spacetime metric is spherically symmetric, one can decompose a smooth solution ψ to the wave equation to solutions ψ_{ℓ} supported on individual spherical harmonic parameters $\ell \ge 0$ (see Section 4.1 below). Then, using the techniques developed in this paper, one expects to be able to show **blow-up for higher spherical harmonic parameters**: If $\psi_{\ge \ell}$ is a smooth solution to the wave equation supported on angular frequencies greater or equal to ℓ such that the higher-order conserved charge (defined in [5]) satisfies the generic condition $H_{\ell}[\psi_{>\ell}] \ne 0$ then

$$\int_{\mathcal{A}} \left(Y^k \psi_{\geq \ell} \right)^2 = \infty,$$

for $k \ge \ell + 1$. This extended result would be particularly useful for $\ell \ge 2$, since as is well known there are no dynamical solutions of the linearized Einstein equations with spherical harmonic parameter $\ell = 0, 1$ (see [15]).

4. The non-degenerate Morawetz estimate

4.1. Elliptic theory and Poincaré's inequality. We recall briefly some basic facts of the spectral theory of a standard sphere $\mathbb{S}^2(r)$ of radius r > 0. The space $L^2(\mathbb{S}^2(r))$ admits the following orthogonal decomposition:

$$L^2(\mathbb{S}^2(r)) = \bigoplus_{l=0}^{\infty} E_l,$$

where the eigenspaces E_l are of dimension 2l + 1, and their corresponding eigenfunctions are denoted by $Y^{m,\ell}$ for $m \in \mathbb{Z} \cap [-\ell, \ell]$ (the functions $Y^{m,\ell}$ are usually referred to as *spherical harmonics*). The eigenvalues of the spherical Laplacian Δ are equal to $-\frac{\ell(\ell+1)}{r^2}$.

Hence, any function $f \in L^2(\mathbb{S}^2(r))$ can be written as:

$$f = \sum_{\ell=0}^{\infty} \sum_{m=-\ell}^{\ell} f_{m,\ell}(r) \cdot Y^{m,\ell} \doteq \sum_{\ell=0}^{\infty} f_{\ell} \doteq \left(\sum_{\ell=0}^{K-1} f_{\ell}\right) + f_{\geqslant K},$$

for any $K \ge 1$, where we denote by f_{ℓ} the projection of f on the eigenspace E_{ℓ} .

In view of the spherical symmetry of the extremal Reissner–Nordström spacetime \mathcal{M} , if decompose any solution ψ of the linear wave equation on \mathcal{M} :

(4.1)
$$\psi = \sum_{\ell=0}^{\infty} \psi_{\ell}$$

then every projection ψ_{ℓ} will also satisfy the wave equation. For example, ψ can be uniquelly written as

(4.2)
$$\psi = \psi_0 + \psi_{\geq 1},$$

where $\psi_0 = \int_{\mathbb{S}^2} \psi \, d\omega$ is the spherical mean of ψ .

From now on, we will say that ψ is supported on angular frequencies $\ell \ge K$ for some $K \ge 0$ if initially we have that $\psi_k = 0$ for $k \in \mathbf{N} \cap [0, K-1]$, and that ψ is supported on angular frequency K if $\psi \in E_K$. Finally we record here Poincaré's inequality

Proposition 4.1.1. Let $f \in L^2(\mathbb{S}^2(r))$ for some r > 0, and let $f_{\ell} = 0$ for $\ell \in \mathbb{N} \cap [0, K-1]$ for some $K \in \mathbb{N}$, $K \ge 1$. Then we have that:

(4.3)
$$\int_{\mathbb{S}^2(r)} f^2 d\omega \leqslant \frac{r^2}{K(K+1)} \int_{\mathbb{S}^2(r)} |\nabla f|^2 d\omega$$

Additionally we note that equality in (4.3) holds if $f_{\ell} = 0$ for all $\ell \neq K$.

4.2. Hardy inequalities. We here list a few Hardy-type inequalities for functions defined on the exterior \mathcal{M} of the extremal Reissner–Nordström spacetime.

The regions $\mathcal{A}, \mathcal{A}_{r_0}$ and the hypersurfaces B_R, H_{r_0} are as defined in Section 2.

Proposition 4.2.1 (First Hardy inequality). Let $f : \mathcal{M} \to \mathbb{R}$ be a C^1 function. Let $p \in \mathbb{R} \setminus \{-1\}$ and suppose that the pointwise limit $\lim_{r \to M} (r-M)^{p+1} f^2(v, r, \theta, \phi) = 0$. Then

(4.4)
$$\int_{\mathcal{A}} (r-M)^p f^2 d\omega dr dv \leq \frac{4}{(p+1)^2} \int_{\mathcal{A}} (r-M)^{p+2} (\partial_r f)^2 d\omega dr dv + \frac{2}{p+1} \int_{B_R} (r-M)^{p+1} f^2 d\omega dv.$$

In particular, if p < -1, then we have that

(4.5)
$$\int_{\mathcal{A}} (r-M)^p f^2 \, d\omega dr dv \leq \frac{4}{(p+1)^2} \int_{\mathcal{A}} (r-M)^{p+2} (\partial_r f)^2 \, d\omega dr dv.$$

Proof. Integrate first $\partial_r((r-M)^{p+1}f^2)$ along constant- v, θ, ϕ curves in \mathcal{A} with $p \neq -1$ and use that $\lim_{r \to M} (r-M)^{p+1}f^2(v, r, \theta, \phi) = 0$ to obtain:

(4.6)
$$\int_{M \le r \le r_0} (p+1)(r-M)^p f^2 + 2(r-M)^{p+1} f \partial_r f \, dr = (p+1)^{-1} \int_{r=R} (r-M)^{p+1} f^2.$$

Clearly the constants are independent of v, θ, ϕ and hence we can integrate in v, θ, ϕ to obtain: (4.7)

$$\int_{\mathcal{A}}^{(4,7)} \int_{\mathcal{A}}^{(p+1)} (r-M)^p f^2 + 2(r-M)^{p+1} f \partial_r f \, d\omega dr dv = (p+1)^{-1} \int_{B_R} (r-M)^{p+1} f^2 \, d\omega dv.$$

We rearrange the terms above and multiply both sides by $(p+1)^{-1}$:

(4.8)
$$\int_{\mathcal{A}} (r-M)^p f^2 \, d\omega dr dv = (p+1)^{-1} \int_{B_R} (r-M)^{p+1} f^2 \, d\omega dv -2(p+1)^{-1} \int_{\mathcal{A}} (r-M)^{p+1} f \partial_r f \, d\omega dr dv.$$

We apply a weighted Cauchy–Schwarz inequality to estimate

$$2(p+1)^{-1} \int_{\mathcal{A}} (r-M)^{p+1} |f| |\partial_r f| \, d\omega dr dv$$

$$\leq \alpha \int_{\mathcal{A}} (r-M)^p f^2 \, d\omega dr dv + \alpha^{-1} (p+1)^{-2} \int_{\mathcal{A}} (r-M)^{p+2} (\partial_r f)^2 \, d\omega dr dv,$$

where $0 < \alpha < 1$. We use the above inequality together with (4.7) to obtain:

$$\begin{aligned} \int_{\mathcal{A}} (r-M)^p f^2 \, d\omega dr dv &\leq \alpha^{-1} (1-\alpha)^{-1} (p+1)^{-2} \int_{\mathcal{A}} (r-M)^{p+2} (\partial_r f)^2 \, d\omega dr dv \\ &+ (1-\alpha)^{-1} (p+1)^{-1} \int_{B_R} (r-M)^{p+1} f^2 \, d\omega dv. \end{aligned}$$

The function $\alpha^{-1}(1-\alpha)^{-1}$ attains its minimum at $\alpha = \frac{1}{2}$. By taking $\alpha = \frac{1}{2}$ in the above inequality, we arrive at (4.4).

Proposition 4.2.2 (Second Hardy inequality). Let $f : \mathcal{M} \to \mathbb{R}$ be a C^1 function. Let $r_1 > r_0$. Then, for any $\epsilon > 0$ we can estimate

(4.9)
$$\int_{H_{r_0}} f^2 d\omega dv \leq \epsilon \int_{\mathcal{A}_{r_0}} (\partial_r f)^2 d\omega dr dv + (1 + \epsilon^{-1}) \int_{\mathcal{A}_{r_0}} f^2 d\omega dr dv + \int_{B_R} f^2 d\omega dv$$

Proof. In a similar fashion as above, we integrate $\partial_r(f^2)$ over \mathcal{A}_{r_0} to obtain:

$$\int_{H_{r_0}} f^2 d\omega dv = -2 \int_{\mathcal{A}_{r_0}} f \partial_r f d\omega dr dv + \int_{B_R} f^2 d\omega dv.$$

The inequality (4.9) follows immediately after applying a weighted Cauchy–Schwarz inequality on the first term. $\hfill \Box$

We finally state yet another Hardy inequality, the proof of which can be found in [3] (Proposition 6.0.4):

Proposition 4.2.3 (Third Hardy inequality). Let $f : \mathcal{M} \to \mathbb{R}$ be a C^1 function. Let $r_1 > r_0$ such that $M < r_0 < r_1 < 2M$. We define the regions

$$\mathcal{A} = \mathcal{R}(0,\tau) \cap \{M \le r \le r_0\},\$$
$$\mathcal{B} = \mathcal{R}(0,\tau) \cap \{r_0 \le r \le r_1\}.$$

Then,

(4.10)
$$\int_{\mathcal{A}} f^2 \leq C \int_{\mathcal{B}} f^2 + C \int_{\mathcal{A} \cup \mathcal{B}} D \cdot [(\partial_v f)^2 + (\partial_r f)^2],$$

where the constant C depends only on M, r_0, r_1 and Σ_0 .

4.3. The estimate for the spherical mean. Let ψ_0 denote the spherical mean of ψ , that is

$$\psi_0(v,r) = \int_{\mathbb{S}^2} \psi(v,r,\omega) \, d\omega,$$

where $\omega = (\theta, \phi)$ and $d\omega = \sin \theta d\theta d\phi$. We will prove the following proposition for ψ_0 .

Proposition 4.3.1. There is a constant C > 0 that depends only on the mass parameter M such that for spherically symmetric solutions ψ_0 to the wave equation on extremal Reissner–Nordström which arise from initial data with bounded norm

$$(4.11) \quad D_{\Sigma_0}[\psi_0] := \int_{\Sigma_0 \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(\partial_r(r\psi_0) \right)^2 \right] dr \, d\omega + \int_{\Sigma_0} \left(J^T[\psi_0] \cdot \boldsymbol{n}_{\Sigma_0} \right) dg_{\Sigma_0}$$

the following estimate holds

(4.12)
$$\int_{\mathcal{A}} \left[\psi_0^2 + (\partial_r \psi_0)^2 + (\partial_v \psi_0)^2 \right] dg_{\mathcal{A}} \leq C \cdot D_{\Sigma_0}[\psi]$$

Here the J^T flux is as defined in Section 2.

Proof. We apply the *singular* vector field

(4.13)
$$S = -\frac{1}{(r-M)} \cdot \partial_r$$

as our *multiplier* vector field in the spacetime region \mathcal{A}_{r_0} bounded by the hypersurfaces $\Sigma_0 = \{v = 0\} \cap \{r \leq R\}, B_R = \{r = R\}$, for some large R > M, and $H_{r_0} = \{u = u_0\}$, where $v_0 = v(p)$ and the point p is on the hypersurface Σ_0 such that $R > r(p) = r_0 > M$. Here u is the retarded null coordinate and v is the advanced null coordinate (see Section 2). Clearly, we have that $H_{r_0} \to \mathcal{H}$ as $r_0 \to M$. We therefore use that

(4.14)
$$\int_{\mathcal{A}_{r_0}} \left(\frac{1}{(r-M)} \cdot \partial_r \psi_0 \cdot \Box_g \psi_0 \right) \cdot r^2 dr \, dv \, d\omega = 0.$$

Since ψ_0 is spherically symmetric we have

(4.15)
$$\Box_g \psi_0 = D \cdot \partial_r \partial_r \psi_0 + 2 \partial_v \Big(H[\psi_0] \Big) + R \cdot \partial_r \psi_0 = 0$$

where the partial derivatives are taken with respect to the ingoing Eddington– Finkelstein coordinates (v, r, θ, ϕ) and

(4.16)
$$D = \left(\frac{r-M}{r}\right)^2, \quad R = \frac{2}{r^2}(r-M), \quad H[\psi_0] = \partial_r \psi_0 + \frac{1}{r}\psi_0.$$

We therefore obtain that

$$(4.17) I_1 + I_2 + I_3 = 0,$$

where

(4.18)
$$I_1 = \int_{\mathcal{A}_{r_0}} (r - M) \cdot \partial_{rr} \psi_0 \cdot \partial_r \psi_0 \, dr \, dv \, d\omega,$$

(4.19)
$$I_2 = \int_{\mathcal{A}_{r_0}} \frac{2r^2}{(r-M)} \cdot \partial_r \psi_0 \cdot \partial_v \Big(H[\psi_0] \Big) \, dr \, dv \, d\omega,$$

(4.20)
$$I_3 = \int_{\mathcal{A}_{r_0}} 2(\partial_r \psi_0)^2 \, dr \, dv \, d\omega.$$

By integrating by parts² with respect to ∂_r in \mathcal{A}_{r_0} we obtain

(4.21)
$$I_{1} = \int_{\mathcal{A}_{r_{0}}} \left(\partial_{r} \left(\frac{1}{2} (r - M) \cdot (\partial_{r} \psi_{0})^{2} \right)^{2} - \frac{1}{2} (\partial_{r} \psi_{0})^{2} \right) dr dv d\omega$$
$$= -\frac{1}{2} \int_{\mathcal{A}_{r_{0}}} (\partial_{r} \psi_{0})^{2} dr dv d\omega + \int_{B_{R}} \frac{1}{2} (r - M) \cdot (\partial_{r} \psi_{0})^{2} dv d\omega$$
$$- \int_{H_{r_{0}}} \frac{1}{2} (r - M) \cdot (\partial_{r} \psi_{0})^{2} dv d\omega.$$

Note that the coefficient of the spacetime integral on the right hand side has the wrong sign and hence its precise value plays a fundamental role in our analysis. Specifically, it is crucial that the coefficient of the spacetime integral is stictly less than 2 and hence this integral can be absorbed by the integral I_3 (see equation (4.20)).

By integrating by parts³ with respect to ∂_v in \mathcal{A}_{r_0} , and using equations (4.16), (4.20) and that

(4.22)
$$dr = \frac{(r-M)^2}{2r^2} dv : \text{ along } H_{r_0}$$

we obtain

$$\begin{aligned} (4.23) \\ I_2 &= I_4 + \int_{\mathcal{A}_{r_0}} \partial_v \left(\frac{r^2}{(r-M)} \cdot (\partial_r \psi_0)^2 \right) \, dv \, dr \, d\omega \\ &= I_4 + \int_{H_{r_0}} \frac{r^2}{(r-M)} \cdot (\partial_r \psi_0)^2 \, dr \, d\omega - \int_{\Sigma_0 \cap \{r_0 \le r \le R\}} \frac{r^2}{(r-M)} \cdot (\partial_r \psi_0)^2 \, dr \, d\omega \\ \stackrel{(4.22)}{=} I_4 + \int_{H_{r_0}} \frac{1}{2} \cdot (r-M) (\partial_r \psi_0)^2 \, dv \, d\omega - \int_{\Sigma_0 \cap \{r_0 \le r \le R\}} \frac{r^2}{(r-M)} \cdot (\partial_r \psi_0)^2 \, dr \, d\omega, \end{aligned}$$

where

(4.24)
$$I_4 = \int_{\mathcal{A}_{r_0}} \frac{2r}{(r-M)} \cdot (\partial_v \psi_0) \cdot (\partial_r \psi_0) \, dr \, dv \, d\omega.$$

Clearly, all the terms are regular apart from the term I_4 which is singular when we take the limit $r_0 \to M$. We will show that in view of the special structure of the geometry of degenerate horizons we are able to bound this integral in terms of a weighted norm of the initial data on Σ_0 only (see also the discussion in Section 4.6). Indeed, by integrating by parts with respect to ∂_v we

 $\begin{array}{c} \text{obtain} \\ (4.25) \end{array}$

$$I_{4} = I_{5} + \int_{\mathcal{A}_{r_{0}}} \partial_{v} \left(\frac{2r}{(r-M)} \cdot \psi_{0} \cdot \partial_{r} \psi_{0} \right) dv dr d\omega$$

Clearly, all the constants are independent of the constant r_0 in the definition of the spacetime region \mathcal{A}_{r_0} . Therefore, by taking $r_0 \to M$ in (4.50) we obtain Proposition (4.3.1). The bound on the zeroth order term follow from the first Hardy inequality (4.4).

4.4. The estimate for angular frequencies $\ell \geq 1$. For the projection on angular frequencies $\ell \geq 1$ we apply *regular multiplier* and *commutator* vector fields in the spacetime region $\mathcal{R}(0,\tau)$ bounded by the hypersurfaces Σ_0 and Σ_{τ} .

Proposition 4.4.1. Let ψ be a solution of the linear wave equation $\Box_g \psi = 0$. Then for any $\tau > 0$ we have that for the part of ψ that is localized in angular frequencies ≥ 1 the following estimate holds true:

where

where \mathcal{A} is as defined in Section 2.

Proof. We consider the equation for $\partial_r \psi_{\geq 1}$, we have that:

Applying Stokes' Theorem for $J^{L_P}[\partial_r \psi_{\geq 1}]$ we have that the following spacetime terms:

where close to the horizon

Here the functions D(r), R(r) are given by (4.16). We will not deal with the terms away from the horizon since they can be bounded by a *degenerate* Morawetz estimate away from the photon sphere for $J^T[\partial_v \psi_{\geq 1}]$.

The boundary fluxes are given by equation (2.2) (recall that $L_P \sim P$).

We next bound the spacetime terms. Note that H_1, H_2, H_3 are positive, have desired asymptotics at the horizon and are thus the most relevant terms. We next consider the terms $H_4 - H_{10}$, which will be shown to be error terms relative to H_1, H_2, H_3 .

 H_4 : We have that

and now we absorb the first term in the right hand by a choice of a $\beta = \beta(M)$ that is small enough, and we bound the second term by the Morawetz estimate.

Note that the H_4 term introduced only a β loss (for β very small) from the H_1 term.

and it is chosen to be small enough but much bigger than σ , so that the first term of (4.53) can be absorbed in the right hand side, while for the second one we apply the third Hardy inequality (4.10)

$$\beta \int_{\mathcal{A}_{0}^{\tau}} (\partial_{r}\psi_{\geqslant 1})^{2} dg_{\mathcal{A}} \leq \\ \leq C\beta \int_{\mathcal{R}(0,\tau) \cap \{r_{0} \leq r_{1} < 2M\}} (\partial_{r}\psi_{\geqslant 1})^{2} dg_{\mathcal{R}} + C\beta \int_{\mathcal{A}_{0}^{\tau}} D\left((\partial_{v}\partial_{r}\psi_{\geqslant 1})^{2} + (\partial_{r}\partial_{r}\psi_{\geqslant 1})^{2} \right) dg_{\mathcal{A}} + \\ + C\beta \int_{\mathcal{R}(0,\tau) \cap \{r_{0} \leq r_{1} < 2M\}} D\left((\partial_{v}\partial_{r}\psi_{\geqslant 1})^{2} + (\partial_{r}\partial_{r}\psi_{\geqslant 1})^{2} \right) dg_{\mathcal{R}},$$

where the first and the third term of the above estimate can be bounded by the Morawetz estimate for $\psi_{\geq 1}$ and $\partial_v \psi_{\geq 1}$ respectively, while the second one can be absorbed in the right hand side as

$$C\beta D \le \frac{H_1}{10} \text{ and } C\beta D \le \frac{H_2}{10}$$

in \mathcal{A}_0^{τ} , due to the higher degeneracy of D on the horizon compared to the other terms for the first inequality, and due to the smallness of β for the second one.

Note that the H_5 term introduced only a β loss (for β very small) from the H_1 and H_2 terms.

 H_6 : We have that

$$\int_{\mathcal{A}_{0}^{\tau}} H_{6}(\partial_{r}\partial_{r}\psi_{\geqslant 1}) \cdot (\partial_{v}\psi_{\geqslant 1}) dg_{\mathcal{A}} = -\int_{\mathcal{A}_{0}^{\tau}} \frac{2M\sqrt{D}}{r^{2}} (\partial_{r}\partial_{r}\psi_{\geqslant 1}) \cdot (\partial_{v}\psi_{\geqslant 1}) dg_{\mathcal{A}} \leqslant \beta \int_{\mathcal{A}_{0}^{\tau}} D(\partial_{r}\partial_{r}\psi_{\geqslant 1})^{2} dg_{\mathcal{A}} + \frac{1}{\beta} \int_{\mathcal{A}_{0}^{\tau}} (\partial_{v}\psi_{\geqslant 1})^{2} dg_{\mathcal{A}},$$

for $\beta = \beta(M)$ small enough, and the first term can be absorbed in the right hand side, while the second one is bounded by the Morawetz estimate.

Note that H_6 term introduced only a β loss (for β very small) from the H_1 term. H_7 : We have that

$$(4.54) \qquad \int_{\mathcal{A}_{0}^{\tau}} H_{7}(\partial_{v}\partial_{r}\psi_{\geqslant 1}) \cdot (\not\Delta\psi_{\geqslant 1})dg_{\mathcal{A}} \simeq \int_{\mathcal{A}_{0}^{\tau}} \frac{2}{r} (\partial_{v}\partial_{r}\psi_{\geqslant 1}) \cdot (\not\Delta\psi_{\geqslant 1})dg_{\mathcal{A}} = \\ = \int_{\Sigma_{0}} \frac{2}{r} (\partial_{r}\psi_{\geqslant 1}) \cdot (\not\Delta\psi_{\geqslant 1}) \cdot (\partial_{v} \cdot \mathbf{n}_{\Sigma})dg_{\Sigma} - \int_{\Sigma_{\tau}} \frac{2}{r} (\partial_{r}\psi_{\geqslant 1}) \cdot (\not\Delta\psi_{\geqslant 1}) \cdot (\partial_{v} \cdot \mathbf{n}_{\Sigma})dg_{\Sigma} - \\ - \int_{\mathcal{A}_{0}^{\tau}} \frac{2}{r} (\partial_{r}\psi_{\geqslant 1}) \cdot (\partial_{v}\not\Delta\psi_{\geqslant 1})dg_{\mathcal{A}},$$

by an application of Stokes' Theorem.

For the last term of (4.54) we have after integrating by parts on the sphere that

$$-\int_{\mathcal{A}_{0}^{\tau}}\frac{2}{r}(\partial_{r}\psi_{\geqslant 1})\cdot(\partial_{v}\not\Delta\psi_{\geqslant 1})dg_{\mathcal{A}} = \int_{\mathcal{A}_{0}^{\tau}}\frac{2}{r}\langle(\nabla\partial_{r}\psi_{\geqslant 1}),(\nabla\partial_{v}\psi_{\geqslant 1})\rangle dg_{\mathcal{A}} \leqslant \\ \leqslant \beta_{1}\int_{\mathcal{A}_{0}^{\tau}}|\nabla\partial_{r}\psi_{\geqslant 1}|^{2}dg_{\mathcal{A}} + \frac{1}{\beta_{1}}\int_{\mathcal{A}_{0}^{\tau}}|\nabla\partial_{v}\psi_{\geqslant 1}|^{2}dg_{\mathcal{A}},$$

for some $\beta_1 = \beta_1(M)$ that is chosen to be small enough so that the first term can be absorbed from the right hand side (from H_3), while the second term can be bounded by the *T*-flux of $\partial_v \psi_{\geq 1}$.

For the second term of (4.54) we have after integrating by parts on the sphere that

$$\begin{split} -\int_{\Sigma_{\tau}} \frac{2}{r} (\partial_r \psi_{\geqslant 1}) \cdot (\not \Delta \psi_{\geqslant 1}) \cdot (\partial_v \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} &= \int_{\Sigma_{\tau}} \frac{2}{r} \langle \not \nabla \partial_r \psi_{\geqslant 1}, \not \nabla \psi_{\geqslant 1} \rangle \cdot (\partial_v \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} \leqslant \\ &\leqslant \beta_2 \int_{\Sigma_{\tau}} | \not \nabla \partial_r \psi_{\geqslant 1} |^2 dg_{\Sigma} + \frac{1}{\beta_2} \int_{\Sigma_{\tau}} | \not \nabla \psi_{\geqslant 1} |^2 dg_{\Sigma}, \end{split}$$

where $\beta_2 = \beta_2(M)$ is chosen to be small enough so that the first term can be absorbed from the flux term of the energy identity for for $J^{L_P}[\partial_r \psi_{\geq 1}]$ (recall that $L_p \sim P$ and hence the fluxes are given by (2.2)), while the second term can be bounded by the *T*-flux of $\psi_{\geq 1}$. The first term of (4.54) can be treated in a similar manner.

Note that the H_7 term introduced only a β loss (for β very small) from the H_3 term.

 H_8 : We have that

$$\int_{\mathcal{A}_0^{\tau}} H_8(\partial_r \partial_r \psi_{\geq 1}) \cdot (\not\Delta \psi_{\geq 1}) dg_{\mathcal{A}} = -\int_{\mathcal{A}_0^{\tau}} \frac{2M\sqrt{D}}{r} (\partial_r \partial_r \psi_{\geq 1}) \cdot (\not\Delta \psi_{\geq 1}) dg_{\mathcal{A}}$$

and so

(4.55)
$$-\int_{\mathcal{A}_0^{\tau}} \frac{2M\sqrt{D}}{r} (\partial_r \partial_r \psi_{\geq 1}) \cdot (\not \Delta \psi_{\geq 1}) dg_{\mathcal{A}} =$$

$$= -\int_{\Sigma_0} \frac{2M\sqrt{D}}{r} (\partial_r \psi_{\geqslant 1}) \cdot (\not\Delta \psi_{\geqslant 1}) \cdot (\partial_r \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} + \int_{\Sigma_\tau} \frac{2M\sqrt{D}}{r} (\partial_r \psi_{\geqslant 1}) \cdot (\not\Delta \psi_{\geqslant 1}) \cdot (\partial_r \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} + \int_{\mathcal{A}_0^\tau} \partial_r \left(\frac{2M\sqrt{D}}{r} \not\Delta \psi_{\geqslant 1} \right) \cdot (\partial_r \psi_{\geqslant 1}) dg_{\mathcal{A}} + \int_{\mathcal{A}_0^\tau} \frac{2M\sqrt{D}}{r} (\partial_r \psi_{\geqslant 1}) \cdot (\not\Delta \psi_{\geqslant 1}) \cdot \frac{2}{r} dg_{\mathcal{A}},$$

by an application of Stokes' Theorem.

For the last two spacetime terms we have that (after also using Stokes' Theorem on the sphere)

$$(4.56) \int_{\mathcal{A}_{0}^{\tau}} \partial_{r} \left(\frac{2M\sqrt{D}}{r} \Delta \psi_{\geqslant 1} \right) \cdot (\partial_{r}\psi_{\geqslant 1}) dg_{\mathcal{A}} + \int_{\mathcal{A}_{0}^{\tau}} \frac{2M\sqrt{D}}{r} (\partial_{r}\psi_{\geqslant 1}) \cdot (\Delta \psi_{\geqslant 1}) \cdot \frac{2}{r} dg_{\mathcal{A}} = \\ = \int_{\mathcal{A}_{0}^{\tau}} \frac{2M\sqrt{D}}{r} (\Delta \partial_{r}\psi_{\geqslant 1} - [\Delta, \partial_{r}]\psi_{\geqslant 1}) \cdot (\partial_{r}\psi_{\geqslant 1}) dg_{\mathcal{A}} + \\ + \int_{\mathcal{A}_{0}^{\tau}} \left(\partial_{r} \left(\frac{2M\sqrt{D}}{r} \right) + \frac{2}{r} \cdot \frac{2M\sqrt{D}}{r} \right) (\partial_{r}\psi_{\geqslant 1}) \cdot (\Delta \psi_{\geqslant 1}) dg_{\mathcal{A}} = \\ = \int_{\mathcal{A}_{0}^{\tau}} \frac{2M\sqrt{D}}{r} (\partial_{r}\psi_{\geqslant 1}) \cdot (\Delta \partial_{r}\psi_{\geqslant 1}) dg_{\mathcal{A}} + \int_{\mathcal{A}_{0}^{\tau}} \partial_{r} \left(\frac{2M\sqrt{D}}{r} \right) (\partial_{r}\psi_{\geqslant 1}) \cdot (\Delta \psi_{\geqslant 1}) dg_{\mathcal{A}} = \\ = -\int_{\mathcal{A}_{0}^{\tau}} \frac{2M\sqrt{D}}{r} |\nabla \partial_{r}\psi_{\geqslant 1}|^{2} dg_{\mathcal{A}} - \int_{\mathcal{A}_{0}^{\tau}} \partial_{r} \left(\frac{2M\sqrt{D}}{r} \right) \langle \nabla \psi_{\geqslant 1}, \nabla \partial_{r}\psi_{\geqslant 1} \rangle dg_{\mathcal{A}}, \end{aligned}$$

where we used that $[\Delta, \partial_r]\psi_{\geq 1} = \frac{2}{r}\Delta\psi_{\geq 1}$. Since

$$\partial_r \left(\frac{2M\sqrt{D}}{r}\right) = -\frac{2M\sqrt{D}}{r^2} + \frac{2M^2}{r^3} \simeq \frac{2}{M} \text{ in } \mathcal{A},$$

the second term on the right hand side of (4.56) can be treated as follows:

where $\beta_1 = \beta_1(M)$ is chosen to be small enough so that the first term can be absorbed from the right hand (from H_3), while the second term can be bounded by the Morawetz estimate.

The first term on the right hand side of (4.56) can be absorbed as well from H_3 since $\frac{2M\sqrt{D}}{r} \ll H_3$ close to the horizon. Finally for the second term on the right hand side of (4.55) we have after integrating by parts on the sphere that

$$\begin{split} &\int_{\Sigma_{\tau}} \frac{2M\sqrt{D}}{r} (\partial_r \psi_{\geqslant 1}) \cdot (\not\Delta \psi_{\geqslant 1}) \cdot (\partial_r \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} = \\ &= -\int_{\Sigma_{\tau}} \frac{2M\sqrt{D}}{r} \langle \nabla \partial_r \psi_{\geqslant 1} \rangle, \nabla \psi_{\geqslant 1} \rangle \cdot (\partial_r \cdot \mathbf{n}_{\Sigma}) dg_{\Sigma} \leqslant \\ &\leqslant \int_{\Sigma_{\tau}} \frac{4M^2 D}{r^2} |\nabla \partial_r \psi_{\geqslant 1}|^2 dg_{\Sigma} + \int_{\Sigma_{\tau}} |\nabla \psi_{\geqslant 1}|^2 dg_{\Sigma}, \end{split}$$

where we can absorb the first term from the energy identity for $J^{L_P}[\partial_r \psi_{\geq 1}]$ (since $\frac{4M^2D}{r^2} \to 0$ as $r \to M$), and the second one is bounded by the *T*-flux of $\psi_{\geq 1}$. We can treat the first term of the right hand side of (4.55) similarly.

Note that the H_8 term introduced only a β loss (for β very small) from the H_3 term.

 H_9 : We have that

$$\int_{\mathcal{A}_{0}^{\tau}} H_{9}(\partial_{v}\partial_{r}\psi_{\geqslant 1}) \cdot (\partial_{r}\partial_{r}\psi_{\geqslant 1}) dg_{\mathcal{A}} \leqslant$$

$$\leqslant \int_{\mathcal{A}_{0}^{\tau}} \sqrt{D} \left(\frac{\sqrt{D}}{\sigma} + \frac{2M}{r^{2}} + \frac{2}{r}\right) (\partial_{v}\partial_{r}\psi_{\geqslant 1}) \cdot (\partial_{r}\partial_{r}\psi_{\geqslant 1}) dg_{\mathcal{A}} \leqslant$$

$$\leqslant \beta \int_{\mathcal{A}_{0}^{\tau}} D(\partial_{r}\partial_{r}\psi_{\geqslant 1})^{2} dg_{\mathcal{A}} + \frac{1}{\beta} \int_{\mathcal{A}_{0}^{\tau}} (\partial_{v}\partial_{r}\psi_{\geqslant 1})^{2} dg_{\mathcal{A}},$$

where $\beta = \beta(M)$ is chosen to be very small so that the first term of the last inequality can be absorbed by H_2 , but also to satisfy $\frac{1}{\beta} \ll \frac{1}{\sigma}$ (which is possible by choosing σ to be extremely small from the beginning) so that the second term can be absorbed by H_1 as well.

Note that the H_9 term introduced only a β loss (for β very small) from the H_1 and H_2 terms.

 H_{10} : We have that

(4.57)
$$\int_{\mathcal{A}_{0}^{\tau}} H_{10}(\partial_{r}\partial_{r}\psi_{\geq 1}) \cdot (\partial_{r}\psi_{\geq 1}) dg_{\mathcal{A}} \leq \\ \leq \frac{1}{2\beta} \int_{\mathcal{A}_{0}^{\tau}} (H_{10})^{2} \frac{M^{2}}{2} (\partial_{r}\partial_{r}\psi_{\geq 1})^{2} dg_{\mathcal{A}} + \frac{\beta}{2} \int_{\mathcal{A}_{0}^{\tau}} \frac{2}{M^{2}} (\partial_{r}\psi_{\geq 1})^{2} dg_{\mathcal{A}}$$

where we just applied the Cauchy–Schwarz inequality, for some β that will be chosen later.

We deal first with the second term for which we apply Poincaré's inequality:

$$\frac{\beta}{2} \int_{\mathcal{A}_0^\tau} \frac{2}{M^2} (\partial_r \psi_{\geqslant 1})^2 dg_{\mathcal{A}} \leqslant \frac{\beta}{2} \frac{(M+\beta')^2}{M^2} \int_{\mathcal{A}_0^\tau} |\nabla \partial_r \psi_{\geqslant 1}|^2 dg_{\mathcal{A}},$$

where we denoted the r_0 given in the definition of \mathcal{A} by $r_0 = M + \beta'$ for some very small $\beta' > 0$. Now we note that for an appropriate choice of β close to 1 we can have that:

$$H_3 = \frac{M^2}{2r^2} > \frac{\beta}{2} \frac{(M+\beta')^2}{M^2} \Rightarrow H_3 - \frac{\beta}{2} \frac{(M+\beta')^2}{M^2} > c > 0,$$

so in the end the second term of the right hand side of (4.57) can be absorbed by the H_3 term. Note that this is possible also because of the fact that from all the previous terms H terms that we examined, we only had β'' loss in H_3 for $\beta'' > 0$ being extremely small.

We now look at the first term of the right hand side of (4.57). We have that:

$$(H_{10})^2 = M^2 D(R')^2 = M^2 D\left(\frac{6M^2}{r^4} - \frac{4M}{r^3} + \frac{2M\sqrt{D}}{r^3} - \frac{2MD}{r^2}\right)^2.$$

In \mathcal{A} , the first two terms of R' are the important ones, since they are much bigger than the last two. We recall the following precise estimate:

$$\frac{6M^2}{r^4} - \frac{4M}{r^3} + \frac{2M\sqrt{D}}{r^3} - \frac{2MD}{r^2} \simeq \frac{2M^2}{r^4} \text{ in } \mathcal{A},$$

that we also used in the estimate for H_4 .

We would like to show that:

$$H_2 = \frac{5M^2D}{2r^2} + \frac{MD^{3/2}}{r} > \frac{1}{2\beta} \cdot \frac{M^2}{2} \cdot \frac{4M^6D}{r^8} = \frac{M^8D}{\beta r^8}$$

Indeed, by our choice of β (which as we mentioned it is chosen to be close to 1), we can have that:

$$\frac{5M^2}{2r^2} > \frac{M^8D}{\beta r^8},$$

and this proves the required estimate (note that the term $\frac{MD^{3/2}}{r}$ is of lower order in (r-M) and hence cannot be used in the proof of the estimates).

Remark 4.1. It is important to emphasize that the exact value of the coefficients plays a crucial role in bounding the above terms. This reveals a new structure of degenerate horizons.

4.5. Finishing the proofs of the theorems. We now have all the tools necessary to complete the proofs of Theorems 3.1, 3.2 and 3.3.

Proof of Theorem 3.1. Clearly, in view of the degenerate Morawetz estimate (3.2) and the Hardy inequality (4.4) (that controls the zeroth order term) it suffices to show that

(4.58)
$$\int_{\mathcal{A}} (\partial_r \psi)^2 \, dg_{\mathcal{A}} \le C \cdot D^w_{\Sigma_0}[\psi],$$

where the norm $D_{\Sigma_0}^w[\psi]$ is defined by (3.5). We decompose

$$\psi = \psi_0 + \psi_{\geq 1}$$

as in Section 4.1. In view of the orthogonality of ψ_0 and $\psi_{>1}$ in $L^2(\mathbb{S}^2)$ we have

(4.59)
$$\int_{\mathcal{A}} (\partial_r \psi)^2 \, dg_{\mathcal{A}} = \int_{\mathcal{A}} (\partial_r \psi_0)^2 \, dg_{\mathcal{A}} + \int_{\mathcal{A}} (\partial_r \psi_{\geq 1})^2 \, dg_{\mathcal{A}}.$$

For the spherically symmetric term we apply Proposition 4.3.1. For the term $\psi_{\geq 1}$ we apply the Hardy inequality (4.4) for p = 0 combined with the degenerate Morawetz estimate to get

$$(4.60) \quad \int_{\mathcal{A}} (\partial_r \psi_{\geq 1})^2 \, dg_{\mathcal{A}} \leq C \int_{\mathcal{A}} (r - M)^2 \cdot \left(\partial_r \partial_r \psi_{\geq 1}\right)^2 \, dg_{\mathcal{A}} + C \int_{\Sigma_0} \left(J^T[\psi_{\geq 1}] \cdot \mathbf{n}_{\Sigma_0}\right) \, dg_{\Sigma_0}.$$

The first integral on the right hand side can be bounded by Proposition 4.4.1. By adding the two estimates and using (4.59) we obtain the desired results.

Proof of Theorem 3.2. Let ψ be a spherically symmetric solution to the wave equation with smooth compactly supported initial data such that the conserved charge

(4.61)
$$H[\psi] = \int_{\Sigma_0 \cap \mathcal{H}} \left(\partial_r \psi + \frac{1}{M} \psi \right) \, d\omega = 1$$

Then we clearly have that

(4.62)
$$\int_{\Sigma_0 \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(\partial_r \psi + \frac{1}{r} \psi \right)^2 \right] dr \, d\omega = \infty.$$

On the other hand, we have established that for the spherically symmetric solution ψ the exact **identity** (4.38) holds, which can be re-written as

$$(4.63) \qquad \int_{\mathcal{A}_{r_0}} \left[\left(\frac{3}{2} - \frac{(r-M)}{r} \right) \cdot (\partial_r \psi_0)^2 + \left(\frac{r-M}{r^3} \right) \cdot \psi_0^2 \right] dr \, dv \, d\omega$$
$$(4.63) \qquad + \int_{H_{r_0}} \left[\frac{1}{2r^2} \cdot \psi_0^2 \right] dv \, d\omega + \int_{B_R} \left[K_R[\psi_0] \right] dv \, d\omega$$
$$= \int_{\Sigma_0 \cap \{r_0 \le r \le R\}} \left[\frac{r^2}{(r-M)} \cdot \left(\partial_r \psi_0 + \frac{1}{r} \psi_0 \right)^2 \right] dr \, d\omega$$

where $K_R[\psi]$ is given by (4.37). In view of (4.62), the right hand side of (4.63) tends to infinity as $r_0 \to M$. Since the initial data of ψ are assumed to be smooth and compactly supported, we have that the *T*-flux of ψ through Σ_0 is finite. Hence, the integrals in (4.63) over the hypersurface B_R is uniformly (in r_0) bounded using the averaging principle and the degenerate Morawetz estimate (3.2). On the other hand, if we assume that

(4.64)
$$\int_{\mathcal{A}} (\partial_r \psi)^2 \, dg_{\mathcal{A}} < \infty$$

then the integral in (4.63) over the hypersurface H_{r_0} is uniformly (in r_0) bounded using the Hardy inequality (4.9) and the zeroth order term in the integral over \mathcal{A}_{r_0} is uniformly (in r_0) bounded using the Hardy inequality (4.4). Hence, if we assume (4.64) then the limit as $r_0 \to M$ of left hand side of (4.63) is finite, which, since \mathcal{A}_{r_0} tends to \mathcal{A} as $r_0 \to M$, contradicts (4.64)! This completes the proof of the theorem.

Proof of Theorem 3.3. We consider initial data for ψ with vanishing conserved charge $H[\psi] = 0$ but which are singular in the sense that (3.9) holds. Clearly such the data are not C^2 .

The proof in this case mimics that of the proof of Theorem 3.2. Indeed we use the identity (4.63) for the spherical mean of ψ and argue by contradiction. Assuming that (4.64) holds we obtain that left hand side of (4.63) is uniformly bounded in r_0 . This however contradicts the fact that the right hand side of (4.63) blows up as $r_0 \to M$.

4.6. Remarks about the singular multiplier S. The proof of Theorem 3.1 heavily relies on the use of the singular vector field

$$S = -\frac{1}{r - r_{hor}} \cdot \partial_r$$

as a multiplier vector field. Here r_{hor} is the radius of the event horizon and hence this vector field is singular on the event horizon.

As was noted in Section 4.3, the most critical term in the analysis is the integral I_4 given by (4.24). Note that the boundeness of the limit as $r_0 \rightarrow r_{hor}$ (where the event horizon is located at $r = r_{hor}$) of this integral in the extremal case is a new feature of the geometry of degenerate horizons. In other words, the product $\partial_r \psi \cdot \partial_v \psi$ oscillates in time faster and faster as we approach the event horizon forcing thus the singular integral I_4 to have a finite limit. Such an oscillation cease to hold in the sub-extremal case. Indeed, we will next show that for generic solutions to the wave equation on sub-extremal black holes we have

(4.65)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \psi \cdot \partial_v \psi \, dg_{\mathcal{A}_{r_0}} = \infty.$$

Let us consider initial data in the class C_{data} given by

 $\mathcal{C}_{data} = \left\{ \text{smooth data supported on } \Sigma_0 \cap \{ r_{hor} < R_1 \le r \le R_2 \} \right\},\$

for some constants $R_1, R_2 > r_{hor}$. Note that in the sub-extremal case we schematically have

(4.66)
$$\Box_g \psi = (r - r_{hor}) \cdot \partial_r \partial_r \psi + \partial_r \partial_v \psi + \partial_v \psi + \partial_r \psi + \not\Delta \psi = 0$$

and

$$(4.67) dr = (r - r_{hor}) \cdot dv : \text{ on } H_{r_0}.$$

We next restrict our attention to spherically symmetric solutions to the wave equation on subextremal backgrounds. Let us assume that for <u>all</u> such solutions with initial data in the class C_{data} the following integral is in fact bounded:

(4.68)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \psi \cdot \partial_v \psi \, dg_{\mathcal{A}_{r_0}} < \infty,$$

Then, we clearly have that if ψ has data in the class C_{data} then

 $\varphi = \partial_v \psi$

also has data in C_{data} . Hence,

(4.69)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \varphi \cdot \partial_v \varphi \, dg_{\mathcal{A}_{r_0}} < \infty.$$

By integrating with respect to ∂_v we obtain

(4.70)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \varphi \cdot \partial_v \varphi \, dr \, dv \, d\omega$$
$$= \int_{H_{r_0}} \frac{1}{r - r_{hor}} \cdot \varphi \cdot \partial_r \varphi \, dr \, d\omega - \int_{\Sigma_0} \frac{1}{r - r_{hor}} \cdot \varphi \cdot \partial_r \varphi \, dr \, d\omega$$
$$- \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \partial_v \varphi \cdot \varphi \, dr \, dv \, d\omega.$$

In view of (4.67) we have

(4.71)

$$\int_{H_{r_0}} \frac{1}{r - r_{hor}} \cdot \varphi \cdot \partial_r \varphi \, dr \, d\omega = \int_{H_{r_0}} \varphi \cdot \partial_r \varphi \, dv \, d\omega$$

$$\leq \int_{H_{r_0}} \left[\varphi^2 + (\partial_r \varphi)^2 \right] dv \, d\omega$$

$$\leq C \int_{\Sigma_0} \left(\sum_{k=1,2} J^N [N^k \varphi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0} < \infty,$$

where in the last step we used the redshift estimate of Dafermos and Rodnianski [13]. Note that the bound is uniform in r_0 .

The integral over Σ_0 in (4.70) is finite since the integrand quantity depends only on the initial data of φ and by assumption these data are supported away from the horizon. Furthermore, in view of (4.66), we schematically obtain

$$(4.72) \qquad \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \partial_r \partial_v \varphi \cdot \varphi \, dr \, dv \, d\omega$$
$$= \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \Big[(r-r_{hor}) \cdot \partial_r \partial_r \varphi + \partial_v \varphi + \partial_r \varphi \Big] \cdot \varphi \, dr \, dv \, d\omega$$
$$= \int_{\mathcal{A}_{r_0}} \Big[\partial_r \partial_r \varphi + \frac{1}{(r-r_{hor})} \partial_v \varphi + \frac{1}{(r-r_{hor})} \partial_r \varphi \Big] \cdot \varphi \, dr \, dv \, d\omega$$

Similarly as above we have

(4.73)

$$\int_{\mathcal{A}_{r_0}} \partial_r \varphi \cdot \varphi \, dr \, dv \, d\omega$$

$$\leq \int_{\mathcal{A}_{r_0}} \left[\varphi^2 + (\partial_r \partial_r \varphi)^2 \right] dv \, d\omega$$

$$\leq C \int_{\Sigma_0} \left(\sum_{k=1,2} J^N [N^k \varphi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0} < \infty,$$

where we used once again the redshift estimate. Furthermore, in view of (4.67)

$$(4.74) \qquad \begin{aligned} \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \partial_v(\varphi^2) \, dr \, dv \, d\omega \\ &= \int_{H_{r_0}} \frac{1}{(r-r_{hor})} \varphi^2 \, dr \, d\omega - \int_{\Sigma_0} \frac{1}{(r-r_{hor})} \varphi^2 \, dr \, d\omega \\ &= \int_{H_{r_0}} \varphi^2 \, dv \, d\omega - \int_{\Sigma_0} \frac{1}{(r-r_{hor})} \varphi^2 \, dr \, d\omega \\ &\leq C \int_{\Sigma_0} \left(J^N[\varphi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0} - \int_{\Sigma_0} \frac{1}{(r-r_{hor})} \varphi^2 \, dr \, d\omega < \infty \end{aligned}$$

since φ is initially supported away from the horizon, where to bound the first integral we have used the Hardy inequality (4.9) and the non-degenerate Morawetz estimate for sub-extremal black holes. Regarding the remaining term we schematically have the following

$$(4.75) \qquad \begin{aligned} \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \cdot \partial_r \varphi \cdot \varphi \, dr \, dv \, d\omega \\ &= \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \cdot \partial_r \partial_v \psi \cdot \partial_v \psi \, dr \, dv \, d\omega \\ &= \int_{\mathcal{A}_{r_0}} \frac{1}{(r-r_{hor})} \cdot \left[(r-r_{hor}) \cdot \partial_r \partial_r \psi + \partial_v \psi + \partial_r \psi \right] \cdot \partial_v \psi \, dr \, dv \, d\omega \\ &= \int_{\mathcal{A}_{r_0}} \left[\partial_r \partial_r \psi + \frac{1}{(r-r_{hor})} \cdot \partial_v \psi + \frac{1}{(r-r_{hor})} \cdot \partial_r \psi \right] \cdot \partial_v \psi \, dr \, dv \, d\omega. \end{aligned}$$

As before, by Cauchy–Schwarz and the redshift estimate we have

$$\int_{\mathcal{A}_{r_0}} \partial_r \partial_r \psi \cdot \partial_v \psi \, dr \, dv \, d\omega \leq C \int_{\Sigma_0} \Big(\sum_{k=1,2} J^N[N^k \varphi] \cdot \mathbf{n}_{\Sigma_0} \Big) dg_{\Sigma_0} < \infty.$$

By our assumption (4.68) we also have

(4.76)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \partial_r \psi \cdot \partial_v \psi \, dr \, dv \, d\omega < \infty$$

Hence, in view of (4.69), (4.70), (4.71), (4.72), (4.73), (4.74), (4.75) and (4.76), finally obtain that

(4.77)
$$\lim_{r_0 \to r_{hor}} \int_{\mathcal{A}_{r_0}} \frac{1}{(r - r_{hor})} \cdot (\partial_v \psi)^2 \, dr \, dv \, d\omega < \infty.$$

However, the integrand quantity is non-negative definite and moreover for generic ψ we have that there is a $v_1 > 0$ such that

(4.78)
$$(\partial_v \psi)(v_1, r = r_{hor}) \neq 0.$$

One can explicitly construct such a solution to the wave equation by imposing appropriate characteristic initial data. Since the function $\frac{1}{(r-r_{hor})}$ is not in L^1_{loc} in \mathcal{A} , the condition (4.78) immediately forces the limit on the left hand side of (4.77) to be infinite, which is a contradiction.

5. Higher order estimates and stable trapping


In this section we prove Theorem 3.4. We show that for generic smooth initial data there is no non-degenerate higher order Morawetz estimate for solutions arising from smooth initial data on a Cauchy hypersurface Σ_0 supported in a compact region $\left\{M < \tilde{R}_1 \leq r \leq r \leq \tilde{R}_2\right\}$ away from $\Sigma_0 \cap \mathcal{H}$, where $\mathcal{H} = \{r = M\}$ denotes the event horizon.

Proof of Theorem 3.4. First divide Σ_0 in the following regions:

$$\Sigma_0 \doteq \Sigma_0^1 \cup \Sigma_0^2 \cup \Sigma_0^3$$

where

 $\Sigma_0^1 = \Sigma_0 \cap \{ M \leqslant r \leqslant \tilde{R_1} \}, \quad \Sigma_0^2 = \Sigma_0 \cap \{ \tilde{R_1} \leqslant r \leqslant \tilde{R_2} \}, \quad \Sigma_0^3 = \Sigma_0 \cap \{ r \geqslant \tilde{R_2} \},$ where $M < \tilde{R_1} < \tilde{R_2} < \infty$.



We consider the following data on Σ_0 :

(5.1)
$$\begin{aligned} \phi|_{\Sigma_0^1} &= 1, \qquad \phi|_{\Sigma_0^3} &= 0, \\ \partial_v \phi|_{\Sigma_0^1} &= 0, \qquad \partial_v \phi|_{\Sigma_0^3} &= 0, \end{aligned}$$

and $\phi|_{\Sigma_0^2}$ and $\partial_v \phi|_{\Sigma_0^2}$ are smooth and spherically symmetric. There data give rise to a spherically symmetric solution ϕ that is smooth in the domain of outer communications. Note also that

(5.2)
$$H[\phi] = \frac{1}{M} \neq 0$$

We now consider:

(5.3)
$$\psi := \partial_v \phi$$

which is also a solution to the wave equation by the fact that $[\partial_v, \Box_g] = 0$. By Proposition 1 of [8] we have that the initial data of ψ on Σ_0 are smooth and supported in a compact region $\{M < \tilde{R}_1 \leq r \leq \tilde{R}_2\}$. Hence, it follows that $H[\psi] = 0$. More specifically we have that:

$$\psi|_{\Sigma_0^1} = 0, \qquad \psi|_{\Sigma_0^3} = 0,$$

$$\partial_v \psi|_{\Sigma_0^1} = 0, \qquad \partial_v \psi|_{\Sigma_0^3} = 0$$

and $\psi|_{\Sigma_0^2}$ and $\partial_v \psi|_{\Sigma_0^2}$ are smooth and spherically symmetric.

We will next show that for ψ given by (5.3) we have

(5.4)
$$\int_{\mathcal{A}} \left(\partial_r \partial_r \psi\right)^2 dg_{\mathcal{A}} = \infty.$$

In view of the wave equation for ϕ we have

(5.5)
$$-2\partial_r\partial_v\phi = D\cdot\partial_r\partial_r\phi + \frac{2}{r}\partial_v\phi + R\cdot\partial_r\phi$$

and hence commuting with the vector field ∂_r we obtain

(5.6)
$$-2\partial_r\partial_r\partial_v\phi = D\cdot\partial_r\partial_r\phi + \left(\partial_rD + R\right)\cdot\partial_r\partial_r\phi + \partial_rR\cdot\partial_r\phi + \partial_r\left(\frac{2}{r}\partial_v\phi\right).$$

By virtue of (4.16) we have

$$r^{2} \cdot \left(\partial_{r} D + R\right) = 2M \frac{(r-M)}{r} + 2(r-M) = 4(r-M) - \frac{2}{r} \cdot (r-M)^{2}$$

and

$$r^2 \cdot \partial_r R = 2 - \frac{4}{r} \cdot (r - M).$$

Hence, if we define

(5.7)
$$\mathcal{E}_1[\phi] := 2r \cdot \partial_r \partial_v \phi - 2\partial_v \phi - \frac{2}{r}(r-M)^2 \cdot \partial_r \partial_r \phi - \frac{4}{r}(r-M) \cdot \partial_r \phi.$$

then we obtain

(5.8)
$$4r^2 \cdot |\partial_r \partial_r \partial_v \phi| = (r - M)^2 \cdot \partial_r \partial_r \phi + 4(r - M) \cdot \partial_r \partial_r \phi + 2 \cdot \partial_r \phi + \mathcal{E}_1[\phi]$$

and therefore

and, therefore,

(5.9)
$$4r^2 \cdot |\partial_r \partial_r \partial_v \phi| = \partial_r \partial_r \Big((r - M)^2 \cdot \partial_r \phi \Big) + \mathcal{E}_1[\phi].$$

By the Cauchy–Schwarz inequality we obtain

$$(5.10) \ 16r^4 \cdot \left(\left|\partial_r \partial_r \partial_v \phi\right|\right)^2 \ge (1-\epsilon) \cdot \left(\partial_r \partial_r \left((r-M)^2 \cdot \partial_r \phi\right)\right)^2 + \left(1-\frac{1}{\epsilon}\right) \cdot \left(\mathcal{E}_1[\phi]\right)^2$$

for sufficiently small $\frac{1}{2} > \epsilon > 0$. Therefore, after choosing such ϵ and using that r is bounded in \mathcal{A} , there exists a positive constant C that depends only on M such that

(5.11)
$$\int_{\mathcal{A}} \left(\partial_r \partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \right)^2 dg_{\mathcal{A}} \leq C \int_{\mathcal{A}} r^4 \cdot \left(|\partial_r \partial_r \partial_v \phi| \right)^2 dg_{\mathcal{A}} + C \int_{\mathcal{A}} \left(\mathcal{E}_1[\phi] \right)^2 dg_{\mathcal{A}}$$

We will next show that

(5.12)
$$\int_{\mathcal{A}} \left(\mathcal{E}_1[\phi] \right)^2 dg_{\mathcal{A}} < \infty.$$

First we observe that in view of the wave equation (4.15) for ϕ we can write

$$-\frac{2}{r}(r-M)^2 \cdot \partial_r \partial_r \phi = 4r \cdot \partial_r \partial_v \phi + 4\partial_v \phi + \frac{4}{r}(r-M) \cdot \partial_r \phi$$

and hence $\mathcal{E}_1[\phi]$ becomes

(5.13)
$$\mathcal{E}_1[\phi] = 6r \cdot \partial_r \partial_v \phi + 2\partial_v \phi.$$

Therefore,

(5.14)
$$\int_{\mathcal{A}} \left(\mathcal{E}_{1}[\phi] \right)^{2} dg_{\mathcal{A}} \leq C \int_{\mathcal{A}} \left((\partial_{v}\phi)^{2} + (\partial_{r}\partial_{v}\phi) \right)^{2} dg_{\mathcal{A}} \\ \leq C \int_{\mathcal{A}} \left((\partial_{v}\phi)^{2} + (\partial_{r}\psi) \right)^{2} dg_{\mathcal{A}}.$$

In view of the degenerate Morawetz theorem established in [5] we have

(5.15)
$$\int_{\mathcal{A}} (\partial_v \phi)^2 \, dg_{\mathcal{A}} \leq C \int_{\Sigma_0} \left(J^N[\phi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0} < \infty$$

since ϕ is a smooth on Σ_0 . Furthermore, in view of the Proposition 4.3.1 we have

(5.16)
$$\int_{\mathcal{A}} (\partial_r \psi)^2 \, dg_{\mathcal{A}} \le C \cdot D_{\Sigma_0}[\psi] < \infty$$

since

$$D_{\Sigma_0}[\psi] = \int_{\Sigma_0 \cap \{r \le R\}} \left[\frac{1}{(r-M)} \cdot \left(\partial_r(r\psi) \right)^2 \right] dr \, d\omega + \int_{\Sigma_0} \left(J^T[\psi] \cdot \mathbf{n}_{\Sigma_0} \right) dg_{\Sigma_0} < \infty$$

since ψ is a smooth function on Σ_0 supported on the set $\left\{ M < \tilde{R}_1 \leq r \leq \tilde{R}_2 \right\}$. Clearly, (5.12) follows from (5.15) and (5.16).

Arguing by contradiction, let us assume that we in fact have

(5.17)
$$\int_{\mathcal{A}} (\partial_r \partial_r \psi)^2 \, dg_{\mathcal{A}} < \infty.$$

Then, in view of (5.11), (5.12) and (5.17), we have

(5.18)
$$\int_{\mathcal{A}} \left(\partial_r \partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \right)^2 dg_{\mathcal{A}} < \infty.$$

Since

$$\partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \sim (r-M)$$

in ${\mathcal A}$, we can apply the Hardy inequality (4.10) for p=-2 to get (5.19)

$$\int_{\mathcal{A}} \frac{1}{(r-M)^2} \cdot \left(\partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \right)^2 dg_{\mathcal{A}} \le C \int_{\mathcal{A}} \left(\partial_r \partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \right)^2 dg_{\mathcal{A}}$$

Since

$$\left((r-M)^2\cdot\partial_r\phi\right)^2\sim(r-M)^4$$

in \mathcal{A} , we can apply once again the Hardy inequality (4.10) for p = -4 to get (5.20)

$$\int_{\mathcal{A}} \frac{1}{(r-M)^4} \cdot \left((r-M)^2 \cdot \partial_r \phi \right)^2 dg_{\mathcal{A}} \le C \int_{\mathcal{A}} \frac{1}{(r-M)^2} \cdot \left(\partial_r \left((r-M)^2 \cdot \partial_r \phi \right) \right)^2 dg_{\mathcal{A}}$$

Hence, in view of the estimates (5.17), (5.19) and (5.20) we get

(5.21)
$$\int_{\mathcal{A}} \left(\partial_r \phi\right)^2 < \infty$$

On the other hand, by virtue of (5.2) we have that the conserved charge $H[\phi] \neq 0$ and hence by Theorem 3.2 it follows that

(5.22)
$$\int_{\mathcal{A}} \left(\partial_r \phi\right)^2 = \infty$$

which of course contradicts (5.21). Hence, our assumption that the integral (5.17) is finite is wrong and this completes the proof for k = 2.

For $k \geq 3$ we simply argue by repeatedly using the Hardy inequality (4.4) to obtain

$$\int_{\mathcal{A}} \left(\partial_r \partial_r \psi\right)^2 dg_{\mathcal{A}} \le C_k \int_{\mathcal{A}} \left(\partial_r^k \psi\right)^2 dg_{\mathcal{A}}$$

which implies that the integral on the left hand side must also be infinite.

Clearly, (5.4) holds generically. Indeed, if we consider a solutions Ψ to the wave equation such that

$$\int_{\mathcal{A}} \left(\partial_r \partial_r \Psi \right)^2 dg_{\mathcal{A}} < \infty$$

then (5.4) holds for $\Psi + \epsilon \psi$ for arbitrarily small ϵ and ψ given by (5.3) above. This completes the proof.

6. Relation with the stability theory of MOTS

In this section we provide a connection of our findings to the stability theory of marginally outer trapped surfaces (MOTS).

Our analysis shows that a necessary condition for the existence of a non-degenerate Morawetz estimate up to and including the event horizon for solutions ψ to (1.1) is the vanishing of the conserved charge

(6.1)
$$H[\psi] = \int_{S_{\tau}} \left(Y\psi + \frac{1}{M}\psi \right),$$

where $S_{\tau} = \Sigma_{\tau} \cap \mathcal{H}$. If the conserved charge does not vanish then ψ fails to satisfy a Morawetz estimate regardless of its degree of regularity. This is in stark contrast with the trapping effect on the photon sphere where Morawetz estimates hold as long as loss of regularity is allowed. The necessity of the vanishing of the charge (6.1) on **each** section S_{τ} implies that a global trapping effect takes place on degenerate horizons. We shall interpret this in terms of the stability theory of the sections S_v , the latter seen as marginally outer trapped surfaces on extremal Reissner–Nordström.

0

It was shown in [7] that the conserved charge (6.1) arises from the kernel of the elliptic operator

where ζ denotes the torsion of the section S_{τ} and $tr\chi$, $tr\chi$ the outgoing and ingoing null mean expansions, respectively. This operator was introduced in [9] where it was shown that in the case of Killing horizons it reduces to

(6.2)
$$\mathcal{O}_{S_{\tau}}\Psi = \not \Delta \Psi + \mathrm{d} v (2\Psi \cdot \zeta) + tr \chi \cdot \kappa \cdot \Psi,$$

where κ is the surface gravity.

In view of work of Mars⁴ [25] the operator (6.2) coincides with the stability operator on the marginally outer trapped surface S_{τ} . In the case of sub-extremal black holes we have that $tr\underline{\chi} < 0$ and $\kappa > 0$ and hence the principal eigenvalue of the operator $\mathcal{O}_{S_{\tau}}$ must be strictly negative. Hence the whole spectrum of the operator $\mathcal{O}_{S_{\tau}}$ is strictly negative. This implies that all sections S_{τ} of sub-extremal event horizons are stable as MOTS.

On the other hand, in the extremal case we have $\kappa = 0$ which implies that the principal eigenvalue of $\mathcal{O}_{S_{\tau}}$ is zero. Hence, there is a *unique function* (up to a constant) that belongs in the kernel of $\mathcal{O}_{S_{\tau}}$ and all the other eigenfunctions correspond to strictly negative eigenvalues. Hence, the sections S_{τ} of are stable as MOTS in all but **exactly one** transversal perturbation with respect to which they are marginally stable. That is, there is a transversal perturbation $S_{f_{kernel}}$ of the degenerate horizon with respect to which the outgoing null mean expansion is stationary (i.e. has a critical point).




FIGURE 3. The perturbation $S_{f_{kernel}}$ of the degenerate horizon with respect to which the outgoing null mean expansion is stationary.

In other words, there is a unique perturbation of the degenerate horizon with respect to which the futures of the sections do **not** expand to **second** order. Waves follow these non-expanding characteristic hypersurfaces leading to the L^2 -concentration of Theorem 3.2.

Recalling that the conserved charge (6.1) arises from the same perturbation (due to the kernel of $\mathcal{O}_{S_{\tau}}$), we conclude the failure of the expansion of the horizon in this direction induces the *global* trapping effect.
