Empirical phi-divergence test-statistics for the equality of means of two populations

Abstract

Empirical phi-divergence test-statistics have demostrated to be a useful technique for the simple null hypothesis to improve the finite sample behaviour of the classical likelihood ratio test-statistic, as well as for model misspecification problems, in both cases for the one population problem. This paper introduces this methodology for two sample problems. A simulation study illustrates situations in which the new teststatistics become a competitive tool with respect to the classical z-test and the likelihood ratio test-statistic.

1 Introduction

The method of likelihood introduced by Fisher is certainly one of the most commonly used techniques for parametric models. The likelihood has been also shown to be very useful in non-parametric context. More concretely Owen (1988, 1990, 1991) introduced the empirical likelihood ratio statistics for non-parametric problems. Two sample problems are frequently encountered in many areas of statistics, generally performed under the assumption of normality. The most commonly used test in this connection is the two sample t-test for the equality of means, performed under the assumption of equality of variances. If the variances are unknown, we have the so-called Behrens-Fisher problem. It is well-known that the two sample t-test has cone major drawback; it is highly sensitive to deviations from the ideal conditions, and may perform miserably under model misspecification and the presence of outliers. Recently Basu et al. (2014) presented a new family of test statistics to overcome the problem of non-robustness of the t-statistic.

Empirical likelihood methods for two-sample problems have been studied by different researchers since Owen (1988) introduced the empirical likelihood as a non-parametric likelihood-based alternative approach to inference on the mean of a single population. The monograph of Owen (2001) is an excellent overview of developments on empirical likelihood and considers a multi-sample empirical likelihood theorem, which includes the two-sample problem as a special case. Some important contributions for the two-sample problem are given in Owen (1991), Adimiri (1995), Jin (1995), Qin (1994, 1998), Qin and Zhao (2000), Zhang (2000), Liu et al. (2008), Baklizi and Kibria (2009), Wu and Yan (2012) and references therein.

Consider two independent unidimensional random variables X with unknown mean μ_1 and variance σ_1^2 and Y with unknown mean μ_2 and variance σ_2^2 . Let $X_1, ..., X_m$ be a random sample of size m from the population denoted by X, with distribution function F, and $Y_1, ..., Y_n$ be a random sample of size n from the population denoted by Y, with distribution function G. We shall assume that F and G are unknown, therefore we are interested in a non-parametric approach, more concretely we shall use empirical likelihood methods. If we denote $\mu_1 = \mu$ and $\mu_2 = \mu + \delta$, our interest will be in testing

$$H_0: \ \delta = \delta_0 \text{ vs. } H_1: \ \delta \neq \delta_0, \tag{1}$$

being δ_0 a known real number. Since $\delta = \mu_2 - \mu_1$ becomes the parameter of interest, apart from testing (1), we might also be interested in constructing the confidence interval for δ .

In this paper we are going to introduce a new family of empirical test statistics for the two-sample problem introduced in (1): Empirical phi-divergence test statistics. This family of test statistics is based on phidivergence measures and it contains the empirical log-likelihood ratio test statistic as a particular case. In this sense, we can think that the family of empirical phi-divergence test statistics presented and studied in this paper is a generalization of the empirical log-likelihood ratio statistic.

Let N = m + n, assume that

$$\frac{m}{N} \underset{m,n \to \infty}{\longrightarrow} \nu \in (0,1), \qquad (2)$$

and $x_1, ..., x_m, y_1, ..., y_n$ a realization of $X_1, ..., X_m, Y_1, ..., Y_n$. We denote

$$\mathcal{L}(\delta) = \prod_{i=1}^{m} \prod_{j=1}^{n} p_i q_j \text{ s.t. } \sum_{i=1}^{m} p_i (x_i - \mu) = 0, \ \sum_{i=1}^{m} p_i = 1, \ \sum_{j=1}^{n} q_j (y_j - \mu - \delta) = 0, \ \sum_{j=1}^{n} q_j = 1,$$

and

$$\mathcal{L}(\mathbf{p}, \mathbf{q}) = \prod_{i=1}^{m} \prod_{j=1}^{n} p_i q_j \text{ s.t. } \sum_{i=1}^{m} p_i = \sum_{j=1}^{n} q_j = 1, \ p_i, q_j \ge 0,$$

with $p_i = p_i(\mu) = F(x_i) - F(x_i^-), q_j = q_j(\mu, \delta) = G(y_j) - G(y_j^-)$ and $\boldsymbol{p} = (p_1, ..., p_m)^T, \boldsymbol{q} = (q_1, ..., q_n)^T$.

The empirical log-likelihood ratio statistic for testing (1) is given by

$$\ell(\delta_0) = -2\log \frac{\sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}(\delta_0)}{\sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}(\boldsymbol{p},\boldsymbol{q})}.$$
(3)

Using the standard Lagrange multiplier method we might obtain $\sup_{p,q} \mathcal{L}(\delta_0)$, as well as $\sup_{p,q} \mathcal{L}(p,q)$. For $\sup_{p,q} \mathcal{L}(\delta_0)$, taking derivatives on

$$\mathcal{L}_{1} = \sum_{i=1}^{m} \log p_{i} + \sum_{j=1}^{n} \log q_{j} + s_{1} \left(1 - \sum_{i=1}^{m} p_{i} \right) + s_{2} \left(1 - \sum_{j=1}^{n} q_{j} \right) - \lambda_{1} m \sum_{i=1}^{m} p_{i} (x_{i} - \mu) - \lambda_{2} n \sum_{j=1}^{n} q_{j} (y_{j} - \mu - \delta_{0}),$$

we obtain

$$\frac{\partial \mathcal{L}_1}{\partial p_i} = 0 \Leftrightarrow p_i = \frac{1}{m} \frac{1}{1 + \lambda_1 \left(x_i - \mu \right)}, \ i = 1, ..., m, \tag{4}$$

$$\frac{\partial \mathcal{L}_1}{\partial q_j} = 0 \Leftrightarrow q_j = \frac{1}{n} \frac{1}{1 + \lambda_2 \left(y_j - \mu - \delta_0 \right)}, \ j = 1, ..., n,$$
(5)

and

$$\frac{\partial \mathcal{L}_1}{\partial \mu} = 0 \Leftrightarrow m\lambda_1 + n\lambda_2 = 0.$$

Therefore, the empirical maximum likelihood estimates $\tilde{\lambda}_1$, $\tilde{\lambda}_2$ and $\tilde{\mu}$ of λ_1 , λ_2 and μ , under H_0 , are obtained as the solution of the equations

$$\begin{pmatrix}
\frac{1}{m} \sum_{i=1}^{m} \frac{1}{1+\lambda_1(x_i-\mu)} = 1 \\
\frac{1}{n} \sum_{j=1}^{n} \frac{1}{1+\lambda_2(y_j-\mu-\delta_0)} = 1 \\
m\lambda_1 + n\lambda_2 = 0
\end{cases}$$
(6)

and

$$\log \sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}\left(\delta_{0}\right) = -m\log m - \sum_{i=1}^{m} \log\left(1 + \widetilde{\lambda}_{1}\left(x_{i} - \widetilde{\mu}\right)\right) - n\log n - \sum_{j=1}^{n} \log\left(1 + \widetilde{\lambda}_{2}\left(y_{j} - \widetilde{\mu} - \delta_{0}\right)\right).$$
(7)

In relation $\sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}(\boldsymbol{p},\boldsymbol{q})$, taking derivatives on

$$\mathcal{L}_2 = \sum_{i=1}^m \log p_i + \sum_{j=1}^n \log q_j + s_1 \left(1 - \sum_{i=1}^m p_i \right) + s_2 \left(1 - \sum_{j=1}^n q_j \right),\tag{8}$$

we have

$$\frac{\partial \mathcal{L}_2}{\partial p_i} = 0 \Leftrightarrow p_i = \frac{1}{m}, \ i = 1, ..., m \text{ and } \frac{\partial \mathcal{L}_2}{\partial q_j} = 0 \Leftrightarrow q_j = \frac{1}{n}, \ j = 1, ..., n,$$
(9)

and

$$\log \sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}\left(\boldsymbol{p},\boldsymbol{q}\right) = -m\log m - n\log n.$$
(10)

Therefore, the empirical log-likelihood ratio statistic (3), for testing (1), can be written as

$$\ell(\delta_0) = -2\left(-m\log m - \sum_{i=1}^m \log\left(1 + \widetilde{\lambda}_1 \left(X_i - \widetilde{\mu}\right)\right) - n\log n - \sum_{j=1}^n \log\left(1 + \widetilde{\lambda}_2 \left(Y_j - \widetilde{\mu} - \delta_0\right)\right) + m\log m + n\log n\right)$$
$$= 2\left\{\sum_{i=1}^m \log\left(1 + \widetilde{\lambda}_1 \left(X_i - \widetilde{\mu}\right)\right) + \sum_{j=1}^n \log\left(1 + \widetilde{\lambda}_2 \left(Y_j - \widetilde{\mu} - \delta_0\right)\right)\right\}.$$
(11)

Under some regularity conditions, Jing (1995) established that

$$\Pr\left(\ell\left(\delta_{0}\right) > \chi_{1,\alpha}^{2}\right) = \alpha + O(n^{-1}),$$

where $\chi^2_{1,\alpha}$ is the 100(1 - α)-th percentile of the χ^2_1 distribution.

Our interest in this paper is to study the problem of testing given in (1) and at the same time to construct confidence intervals for δ on the basis of the empirical phi-divergence test statistics. Empirical phi-divergence test statistics in the context of the empirical likelihood have studied by Baggerly (1998), Broniatowski and Keizou (2012), Balakhrishnan et al. (2013), Felipe et al. (2015) and references therein. The family of empirical phidivergence test statistics, considered in this paper, contains the classical empirical log-likelihood ratio statistic as a particular case. In Section 2, the empirical phi-divergence test statistics are introduced and the corresponding asymptotic distributions are obtained. A simulation study is carried out in Section 3. Section 4 is devoted to develop a numerical example. In Section 5 the previous results, devoted to univariate populations, are extended to k-dimensional populations.

2 Empirical phi-divergence test statistics

For the hypothesis testing considered in (1), in this section the family of empirical phi-divergence test statistics are introduced as a natural extension of the empirical log-likelihood ratio statistic given in (3).

We consider the N-dimensional probability vectors

$$\boldsymbol{U} = \left(\frac{1}{N}, \stackrel{N}{\dots}, \frac{1}{N}\right)^T \tag{12}$$

and

$$\boldsymbol{P} = (p_1\nu, ..., p_m\nu, q_1(1-\nu), ..., q_n(1-\nu))^T$$
(13)

where p_i , i = 1, ..., m, q_j , j = 1, ..., n were defined in (4) and (5), respectively, and ν in (2). Let \tilde{P} be the *N*-dimensional vector obtained from P with p_i , q_j replaced by the corresponding empirical maximum likelihood estimators \tilde{p}_i , \tilde{q}_j and ν by $\frac{m}{N}$. The Kullback-Leibler divergence between the probability vectors U and \tilde{P} is given by

$$D_{Kullback}(\boldsymbol{U}, \widetilde{\boldsymbol{P}}) = \sum_{i=1}^{m} \frac{1}{N} \log \frac{\frac{1}{N}}{\widetilde{p}_i \frac{m}{N}} + \sum_{j=1}^{n} \frac{1}{N} \log \frac{\frac{1}{N}}{\widetilde{q}_j \left(1 - \frac{m}{N}\right)}$$
$$= -\frac{1}{N} \left\{ \sum_{i=1}^{m} \log m \widetilde{p} + \sum_{j=1}^{n} \log n \widetilde{q}_j \right\}$$
$$= \frac{1}{N} \left\{ \sum_{i=1}^{m} \log \left(1 + \widetilde{\lambda}_1 \left(x_i - \widetilde{\mu}\right)\right) + \sum_{j=1}^{n} \log \left(1 + \widetilde{\lambda}_2 \left(y_j - \widetilde{\mu} - \delta_0\right)\right) \right\},$$

where

$$\tilde{p}_{i} = \frac{1}{m} \frac{1}{1 + \tilde{\lambda}_{1} \left(x_{i} - \tilde{\mu} \right)}, \ i = 1, ..., m,$$
(14)

$$\widetilde{q}_{j} = \frac{1}{n} \frac{1}{1 + \widetilde{\lambda}_{2} \left(y_{j} - \widetilde{\mu} - \delta_{0} \right)}, \ j = 1, ..., n.$$
(15)

Therefore, the relationship between $\ell(\delta_0)$ and $D_{Kullback}(\boldsymbol{U}, \boldsymbol{\tilde{P}})$ is

$$\ell(\delta_0) = 2ND_{Kullback}(\boldsymbol{U}, \tilde{\boldsymbol{P}}).$$
(16)

Based on (16), in this paper the empirical phi-divergence test statistics for (1) are introduced for the first time. This family of empirical phi-divergence test statistics is obtained replacing the Kullback-Leibler divergence by a phi-divergence measure in (16), i.e.,

$$T_{\phi}(\delta_0) = \frac{2N}{\phi''(1)} D_{\phi}(\boldsymbol{U}, \widetilde{\boldsymbol{P}}), \qquad (17)$$

where

$$D_{\phi}(\boldsymbol{U}, \widetilde{\boldsymbol{P}}) = \sum_{i=1}^{m} \widetilde{p}_{i} \frac{m}{N} \phi\left(\frac{1}{\widetilde{p}_{i} \frac{m}{N}}\right) + \sum_{j=1}^{n} \left(1 - \frac{m}{N}\right) \widetilde{q}_{j} \phi\left(\frac{1}{\left(1 - \frac{m}{N}\right)} \widetilde{q}_{j}\right)$$

with $\phi : \mathbb{R}^+ \longrightarrow \mathbb{R}$ being any convex function such that at x = 1, $\phi(1) = 0$, $\phi''(1) > 0$ and at x = 0, $0\phi(0/0) = 0$ and $0\phi(p/0) = p \lim_{u \to \infty} \frac{\phi(u)}{u}$. For more details see Cressie and Pardo (2002) and Pardo (2006). Therefore, (17) can be rewritten as

$$T_{\phi}\left(\delta_{0}\right) = \frac{2}{\phi''(1)} \left\{ \sum_{i=1}^{m} m \widetilde{p}_{i} \phi\left(\frac{1}{m \widetilde{p}_{i}}\right) + \sum_{j=1}^{n} n \widetilde{q}_{j} \phi\left(\frac{1}{n \widetilde{q}_{j}}\right) \right\}$$
(18)

$$=\frac{2}{\phi''(1)}\left\{\sum_{i=1}^{m}\frac{1}{1+\widetilde{\lambda}_{1}\left(x_{i}-\widetilde{\mu}\right)}\phi\left(1+\widetilde{\lambda}_{1}\left(x_{i}-\widetilde{\mu}\right)\right)+\sum_{j=1}^{n}\frac{1}{1+\widetilde{\lambda}_{2}\left(y_{j}-\widetilde{\mu}-\delta_{0}\right)}\phi\left(1+\widetilde{\lambda}_{2}\left(y_{j}-(\widetilde{\mu}+\delta_{0})\right)\right)\right\}.$$

If $\phi(x) = x \log x - x + 1$ is chosen in $D_{\phi}(\boldsymbol{U}, \widetilde{\boldsymbol{P}})$, we get the Kullback-Leibler divergence and $T_{\phi}(\delta_0)$ coincides with the empirical log-likelihood ratio statistic $\ell(\delta_0)$ given in (16).

Let $\hat{\mu}(\sigma_1^2, \sigma_2^2)$ be the optimal estimator of μ under the assumption of having the known values of σ_1^2, σ_2^2 , i.e. it is given by the shape $\pi \overline{X} + (1 - \pi)\overline{Y}$ and has minimum variance. It is well-known that

$$\widehat{\mu}(\sigma_1^2, \sigma_2^2) = \frac{\frac{m\overline{X}}{\sigma_1^2} + n\frac{(\overline{Y} - \delta_0)}{\sigma_2^2}}{\frac{m}{\sigma_1^2} + \frac{n}{\sigma_2^2}}.$$
(19)

Similarly, an asymptotically optimal estimator of μ having unknown values of σ_1^2 , σ_2^2 , is given by

$$\widehat{\mu}(S_1^2, S_2^2) = \frac{\frac{m\overline{X}}{S_1^2} + n\frac{(\overline{Y} - \delta_0)}{S_1^2}}{\frac{m}{S_1^2} + \frac{n}{S_1^2}}$$

where $S_1^2 = \frac{1}{m-1} \sum_{i=1}^m (X_i - \overline{X})^2$, $S_2^2 = \frac{1}{n-1} \sum_{j=1}^n (Y_j - \overline{Y})^2$ are consistent estimators of σ_1^2 , σ_2^2 respectively. In the following lemma an important relationship is established, useful to get the asymptotic distribution of $T_{\phi}(\delta_0)$.

Lemma 1 Let $\tilde{\mu}$ the empirical likelihood estimator of μ . Then, we have

$$\widetilde{\mu} = \widehat{\mu}(\sigma_1^2, \sigma_2^2) + O_p(1) = \widehat{\mu}(S_1^2, S_2^2) + O_p(1).$$

Proof. See Appendix 5.3. ■

Theorem 2 Suppose that $\sigma_1^2 < \infty$, $\sigma_2^2 < \infty$ and (2). Then,

$$T_{\phi}\left(\delta_{0}\right) \xrightarrow[n,m\to\infty]{\mathcal{L}} \chi_{1}^{2}.$$

Proof. See Appendix 5.4.

Remark 3 A $(1 - \alpha)$ -level confidence interval on δ can be constructed as

$$CI_{1-\alpha}(\delta) = \left\{ \delta : T_{\phi}(\delta) \le \chi_{1,\alpha}^2 \right\}.$$

The lower and upper bounds of the interval $CI_{1-\alpha}(\delta)$ require a bisection search algorithm. This is a computationally challenging task, because for every selected grid point on δ , one needs to maximize the empirical phi-divergence $T_{\phi}(\delta)$ over the nuisance parameter, μ , and there is no closed-form solution to the maximum point $\hat{\mu}$ for any given δ . The computational difficulties under the standard two-sample empirical likelihood formulation are due to the fact that the involved Lagrange multipliers, which are determined through the set of equations (6), have to be computed based on two separate samples with an added nuisance parameter μ . Such difficulties can be avoided through an alternative formulation of the empirical likelihood function, for which computation procedures are virtually identical to those for one-sample of size N = m + n empirical likelihood problems. Through the transformations

$$\boldsymbol{v}_{i} = \left(1 - \omega_{1}, \frac{x_{i}}{\omega_{1}} - \delta\right)^{T}, \ i = 1, ..., m$$
$$\boldsymbol{w}_{j} = \left(-\omega_{1}, \frac{y_{j}}{\omega_{2}} - \delta\right)^{T}, \ j = 1, ..., n,$$
$$\omega_{1} = \omega_{1} = \frac{1}{2},$$

(14) and (15) can be alternatively obtained as

$$\widetilde{p}_i = \frac{1}{m} \frac{1}{1 + \widetilde{\boldsymbol{\lambda}}_*^T \boldsymbol{v}_i}, \ i = 1, ..., m,$$
(20)

$$\widetilde{q}_j = \frac{1}{n} \frac{1}{1 + \widetilde{\boldsymbol{\lambda}}_*^T \boldsymbol{w}_j}, \ j = 1, ..., n,$$
(21)

where the estimates of the Lagrange multipliers $\widetilde{\lambda}_* = (\widetilde{\lambda}_{1,*}, \widetilde{\lambda}_{2,*})^T$ are the solution in λ_* of

$$\sum_{i=1}^{m} \frac{\boldsymbol{v}_i}{1+\boldsymbol{\lambda}_*^T \boldsymbol{v}_i} + \sum_{j=1}^{n} \frac{\boldsymbol{w}_j}{1+\boldsymbol{\lambda}_*^T \boldsymbol{w}_j} = \boldsymbol{0}_2.$$

Remark 4 In the particular case that m = n, the two samples might be understood as a random sample of size n from a unique bidimensional population. In this setting the two sample problem can be considered to be a particular case of Balakrishnan et al. (2015).

Remark 5 Fu et al. (2009), Yan (2010) and Wu and Yan (2012) pointed out that empirical log-likelihood ratio statistic, $\ell(\delta_0)$, given in (11) for testing (1), does not perform well when the distribution associated to the samples are quite skewed or samples sizes are not large or sample sizes from each population are quite different. To overcome this problem Fu et al. (2009) considered the weighted empirical log-likelihood function defined by

$$\ell_w(\boldsymbol{p}, \boldsymbol{q}) = \frac{\omega_1}{m} \sum_{i=1}^m \log p_i + \frac{\omega_2}{n} \sum_{j=1}^n \log q_j,$$
(22)

with $\omega_1 = \omega_2 = \frac{1}{2}$, and obtained the weighted empirical likelihood (WEL) estimator as well as the weighted empirical log-likelihood ratio statistic. In order to get the WEL estimator, it is necessary to maximize (22) subject to

$$\sum_{i=1}^{m} p_i = \sum_{j=1}^{n} q_j = 1,$$
(23)

$$\sum_{i=1}^{m} p_i x_i - \sum_{j=1}^{n} y_j q_j = \delta_0.$$
(24)

They obtained that the WEL estimates of p_i and q_j are given by

$${}^{w}\widetilde{p}_{i} = \frac{1}{m} \frac{1}{1 + {}^{w}\widetilde{\boldsymbol{\lambda}}^{T}\boldsymbol{v}_{i}}, \quad i = 1, ..., m,$$
$${}^{w}\widetilde{q}_{j} = \frac{1}{n} \frac{1}{1 + {}^{w}\widetilde{\boldsymbol{\lambda}}^{T}\boldsymbol{w}_{j}}, \quad j = 1, ..., n,$$

where \mathbf{v}_i and \mathbf{w}_j are the same transformations given in Remark 3 with $\delta = \delta_0$ and the estimates of the Lagrange multipliers ${}^{w}\widetilde{\lambda}_* = ({}^{w}\widetilde{\lambda}_{1,*}, {}^{w}\widetilde{\lambda}_{2,*})^T$ are the solution in ${}^{w}\lambda_*$ of

$$\frac{\omega_1}{m}\sum_{i=1}^m \frac{\boldsymbol{v}_i}{1+w} \frac{\boldsymbol{v}_i}{\boldsymbol{\lambda}_*^T \boldsymbol{v}_i} + \frac{\omega_2}{n}\sum_{j=1}^n \frac{\boldsymbol{w}_j}{1+w} \frac{\boldsymbol{\lambda}_j^T \boldsymbol{w}_j}{\boldsymbol{\lambda}_*^T \boldsymbol{w}_j} = \boldsymbol{0}_2.$$

Now, if we define the probability vectors

$${}^{w}\boldsymbol{U} = \left(\omega_{1}(\frac{1}{m}, \overset{m}{\dots}, \frac{1}{m}), \omega_{2}(\frac{1}{n}, , \overset{n}{\dots}, , \frac{1}{n})\right)^{T},$$
$${}^{w}\boldsymbol{P} = \left(\omega_{1}\boldsymbol{p}^{T}, \omega_{2}\boldsymbol{q}^{T}\right)^{T} = \left(\omega_{1}\left(p_{1}, ..., p_{m}\right), \omega_{2}(q_{1}, ..., q_{n})\right)^{T},$$

the weighted empirical log-likelihood ratio test $\ell_w(\delta_0)$ presented in Wu and Yan (2012) can be written as

$$-2\ell_w(\delta_0) = D_{Kullback}(^w \boldsymbol{U},^w \boldsymbol{P}).$$

The weighted empirical log-likelihood ratio test can be extended by defining the family of weighted empirical phi-divergence test statistics as

$$S_{\phi}\left(\delta_{0}\right) = \frac{2D_{\phi}(^{w}\boldsymbol{U},^{w}\boldsymbol{P})}{\phi''(1)}$$

where $D_{\phi}(^{w}\boldsymbol{U},^{w}\boldsymbol{P})$ is the phi-divergence measure between the probability vectors $^{w}\boldsymbol{U}$ and $^{w}\boldsymbol{P}$, i.e.,

$$D_{\phi}(^{w}\boldsymbol{U},^{w}\boldsymbol{P}) = \omega_{1}\sum_{i=1}^{m}\widetilde{p}_{i}\phi\left(\frac{1}{m\widetilde{p}_{i}}\right) + \omega_{2}\sum_{j=1}^{n}\widetilde{q}_{j}\phi\left(\frac{1}{n\widetilde{q}_{j}}\right)$$
$$= \frac{\omega_{1}}{m}\sum_{i=1}^{m}\frac{\phi\left(1 + {}^{w}\widetilde{\boldsymbol{\lambda}}_{*}^{T}\boldsymbol{v}_{i}\right)}{1 + {}^{w}\widetilde{\boldsymbol{\lambda}}_{*}^{T}\boldsymbol{v}_{i}} + \frac{\omega_{2}}{n}\sum_{j=1}^{n}\frac{\phi\left(1 + {}^{w}\widetilde{\boldsymbol{\lambda}}_{*}^{T}\boldsymbol{w}_{j}\right)}{1 + {}^{w}\widetilde{\boldsymbol{\lambda}}_{*}^{T}\boldsymbol{w}_{j}}.$$

Taking into account

$$D_{\phi}(^{w}\boldsymbol{U},^{w}\boldsymbol{P}) = \ ^{w}\widetilde{\boldsymbol{\lambda}}_{*}^{T}\boldsymbol{D}\ ^{w}\widetilde{\boldsymbol{\lambda}}_{*} + o_{p}(N),$$

where

$$\boldsymbol{D} = \frac{\omega_1}{m} \sum_{i=1}^m \boldsymbol{v}_i \boldsymbol{v}_i^T + \frac{\omega_2}{n} \sum_{j=1}^n \boldsymbol{w}_j \boldsymbol{w}_j^T,$$

and based on Theorem 2.2. in Wu and Yan (2012), we have that

where c is the second diagonal element of the matrix D^{-1} .

3 Simulation Study

The square of the classical z-test statistic for two sample problems,

$$t\left(\delta_{0}\right) = \frac{\left(\overline{X} - \overline{Y} + \delta_{0}\right)^{2}}{\frac{1}{m}S_{1}^{2} + \frac{1}{n}S_{2}^{2}},$$

has asymptotically χ_1^2 distribution, the same as the empirical phi-divergence test statistics, according to Theorem 2. In order to compare the finite sample performance of the confidence interval (CI) of δ based on $T_{\phi}(\delta)$ with respect to the ones based on $t(\delta)$ as well as the empirical log-likelihood ratio test-statistic $\ell(\delta)$ given in (3), we count on a subfamily of phi-divergence measures, the so-called power divergence measures $\phi_{\gamma}(x) = \frac{x^{1+\gamma}-x-\gamma(x-1)}{\gamma(1+\gamma)}$, dependent of tuning parameter $\gamma \in \mathbb{R}$, i.e.

$$T_{\gamma}\left(\delta\right) = \begin{cases} \frac{2}{\gamma(\gamma+1)} \left(\sum_{i=1}^{m} (m\widetilde{p}_{i})^{-\gamma} + \sum_{j=1}^{n} (n\widetilde{q}_{j})^{-\gamma} - N\right), & \gamma \in \mathbb{R} - \{0, -1\} \\ -2 \left(m\log m + n\log n + m\sum_{i=1}^{m}\log\widetilde{p}_{i} + n\sum_{j=1}^{n}\log\widetilde{q}_{j}\right), & \gamma = 0, \\ 2 \left(m\log m + n\log n + m\sum_{i=1}^{m}\widetilde{p}_{i}\log\widetilde{p}_{i} + n\sum_{j=1}^{n}\widetilde{q}_{j}\log\widetilde{q}_{j}\right), & \gamma = -1, \end{cases}$$

where \tilde{p}_i and \tilde{q}_j can be obtained from (20)-(21). We analyzed five new test-statistics, the empirical powerdivergence test statistics taking $\gamma \in \{-1, -0.5, \frac{2}{3}, 1, 2\}$. The case of $\gamma = 0$ is not new, since the empirical log-likelihood ratio test-statistic $\ell(\delta)$ is a member of the empirical power-divergence test statistics, i.e. $\ell(\delta) = T_{\gamma=0}(\delta)$. The CI of δ based on $t(\delta_0)$ with $100(1-\alpha)\%$ confidence level is essentially the CI of z-test statistic, $(\tilde{\delta}_L, \tilde{\delta}_U) = (\overline{x} - \overline{y} - z_{\frac{\alpha}{2}}\sqrt{\frac{1}{m}s_1^2 + \frac{1}{n}s_2^2}, \overline{x} - \overline{y} + z_{\frac{\alpha}{2}}\sqrt{\frac{1}{m}s_1^2 + \frac{1}{n}s_2^2})$. For $T \in \{T_{\gamma}(\delta)\}_{\gamma \in \Lambda}$, $\Lambda = \{-1, -0.5, 0, \frac{2}{3}, 1, 2\}$, as mentioned in Remark 3, since there is no explicit expression for $(\tilde{\delta}_L, \tilde{\delta}_U)$ the bisection method should be followed. The simulated coverage probabilities of the CI of δ based on $T \in \{t(\delta)\} \cup \{T_{\gamma}(\delta)\}_{\gamma \in \Lambda}$ were obtained with R = 15,000 replications by

$$100 \times \frac{1}{R} \sum_{r=1}^{R} I(T^{(r)} \le \chi^2_{1,\alpha}),$$

with $I(\cdot)$ being the indicator function. The simulated expected width of the CI of δ based on $T \in \{t(\delta)\} \cup \{T_{\gamma}(\delta)\}_{\gamma \in \Lambda}$ were obtained with R = 3,000 replications by

$$100 \times \frac{1}{R} \sum_{r=1}^{R} (\widetilde{\delta}_{U}^{(r)} - \widetilde{\delta}_{L}^{(r)}).$$

The reason why two different values of R were followed is twofold. On one hand calculating $\tilde{\delta}_U^{(r)} - \tilde{\delta}_L^{(r)}$ is much more time consuming than $I(T^{(r)} \leq \chi^2_{1,\alpha})$ and on the other hand for the designed simulation experiment the replications needed to obtain a good precision is less for the expected width than for the coverage probability.

The simulation experiment is designed in a similar manner as in Wu and Yan (2012). The true distributions, unknown in practice, are generated from:

i)
$$X \sim \mathcal{N}(\mu, \sigma_1^2), Y \sim \mathcal{N}(\mu + \delta_0, \sigma_2^2)$$
, with $\mu = 1, \sigma_1^2 = \sigma_2^2 = 1.5, \delta_0 = 0$;

ii) $X \sim \text{lognormal}(\vartheta_1, \theta_1), Y \sim \text{lognormal}(\vartheta_2, \theta_2)$, with $\vartheta_1 = 1.1, \theta_1 = 0.4, \vartheta_2 = 1.2, \theta_2 = 0.2$.

Notice that in case ii) $\delta_0 = 0$ since E[X] = E[Y]. Depending on the sample sizes, six scenarios were considered, $(m, n) \in \{(15, 30), (30, 15), (30, 30), (30, 60), (60, 30), (60, 60)\}$. Table 1 summarizes the results of the described simulation experiment with $\alpha = 0.05$. In all the cases and scenarios the narrower width is obtained with $T_{\gamma=-1}(\delta)$, but the coverage probabilities closest to 95% depends on the case or scenario. For the case of the lognormal distribution the CI based on $t(\delta)$ test-statistic has the closest coverage probability to 95%, but for the case of the normal distribution $T_{\gamma=2/3}(\delta)$ and $T_{\gamma=1}(\delta)$ power divergence based tend to have the closest coverage probability to 95%.

In order to complement this study, the power functions have been drawn through R = 15,000 replications and taking δ as abscissa. For case i) the power functions exhibit a symmetric shape with respect to the center and also a parallel shape, in such a way that the test statistics with better approximation of the size have worse power. For case ii), fixing the values of the two parameters of X and changing the two parameter of Y as

$$\vartheta'_1 = k\vartheta'_1, \quad \theta'_1 = k\theta_1, \quad k = \frac{\log(\delta + \exp\{\vartheta_1 + \frac{1}{2}\theta_1\})}{\vartheta_2 + \frac{1}{2}\theta_2},$$

 δ is displaced from $\delta_0 = 0$ to the right when k > 1 and from $\delta_0 = 0$ to the left when 0 < k < 1 ($\delta > -\exp\{\vartheta_1 + \frac{1}{2}\theta_1\}$). Unlike case i), the power function of case ii) exhibits a different shape on both sides from the center of abscissa, and the most prominent differences are on the left hand size. Clearly in case ii), even though the approximated size for $t(\delta_0)$ is the best one, it has the worst approximated power function, in particular there is an area of the approximated power function on the left hand side of $\delta_0 = 0$ with smaller value than the approximated size. Hence, in case ii) the power functions of $T \in \{T_{\gamma}(\delta)\}_{\gamma \in \Lambda}$ are more acceptable than the power function of $t(\delta_0)$. Taking into account the strong and weak point of $t(\delta_0)$ in case ii), $T_{\gamma=2/3}(\delta_0)$ could be a good choice for moderate sample sizes and $\ell(\delta_0) = T_{\gamma=0}(\delta_0)$ for small sample sizes.




Figure 1: Power functions for two normal pupulations.




Figure 2: Power functions for two log-normal pupulations.

4 Numerical Example

Yu et al. (2002) presented a data set on evaluating gasoline quality based on what is known as Reid vapor pressure, collected by the Environmental Protection Agency of the United States. Two types of Reid vapor pressure measurements X and Y are included in the data set. Values of X are obtained by an Agency inspector who visits gas pumps in a city, takes samples of gasoline of a particular brand, and measures the Reid vapor pressure right on the spot; values of Y, on the other hand, are produced by shipping gasoline samples to the laboratory for measurements of presumably higher precision at a high cost. The original data set has a double sampling structure, with a subset of the sample units having measurements on both X and Y. Table 2 contains two independent samples of a new reformulated gasoline, one related to X with sample size 30 and the other, to Y with sample size 15.

One of the assumptions of Yu et al. (2002) is that the field measurement X and the lab measurement Y have common mean μ . The two types of measurements differ, however, in terms of precision. Yu et al. (2002) also assumed that (X, Y) was bivariate normal, which would not be required under our proposed empirical likelihood approach. In Tsao and Wu (2006) this example was studied on the basis of the empirical log-likelihood ratio test. The 95% CIs of δ based on $T \in \{t(\delta)\} \cup \{T_{\gamma}(\delta)\}_{\gamma \in \Lambda}$ are summarized in Table 3. As in the simulation study, the narrowest CI width is obtained with $T_{\gamma=-1}(\delta)$. In all the test-statistics used to construct the CIs $\delta_0 = 0$ is not contained, so the null hypothesis of equal means is rejected with 0.05 significance level.

5 Further extensions

5.1 Extension of the dimension for the random variable

Let $X_1, ..., X_m$ and $Y_1, ..., Y_n$ be two mutually independent random samples with common distribution function F and G respectively. Assuming that X_i and Y_j take values in \mathbb{R}^k and

$$E[\mathbf{X}_{i}] = \boldsymbol{\mu}_{1}, \ Cov[\mathbf{X}_{i}] = \boldsymbol{\Sigma}_{1}, \ i = 1, ..., m,$$
$$E[\mathbf{Y}_{j}] = \boldsymbol{\mu}_{2}, \ Cov[\mathbf{Y}_{j}] = \boldsymbol{\Sigma}_{2}, \ j = 1, ..., n,$$

with $\mu_1 = \mu$ and $\mu_2 = \mu + \delta$, our interest is in testing

$$H_0: \, \boldsymbol{\delta} = \boldsymbol{\delta}_0 \, \text{vs.} \, H_1: \, \boldsymbol{\delta} \neq \boldsymbol{\delta}_0, \tag{26}$$

where $\boldsymbol{\delta}_0 \in \mathbb{R}^k$ and known.

The empirical likelihood under H_0 is

$$\mathcal{L}(\boldsymbol{\delta}) = \prod_{i=1}^{m} \prod_{j=1}^{n} p_i q_j \text{ s.t. } \sum_{i=1}^{m} p_i(\boldsymbol{x}_i - \boldsymbol{\mu}) = \mathbf{0}_k, \ \sum_{i=1}^{m} p_i = 1, \ \sum_{j=1}^{n} q_j(\boldsymbol{y}_j - \boldsymbol{\mu} - \boldsymbol{\delta}) = \mathbf{0}_k, \ \sum_{j=1}^{n} q_j = 1,$$

and in the whole parameter space,

$$\mathcal{L}(\boldsymbol{p}, \boldsymbol{q}) = \prod_{i=1}^{m} \prod_{j=1}^{n} p_i q_j : \sum_{i=1}^{m} p_i = \sum_{j=1}^{n} q_j = 1, \ p_i, q_j \ge 0,$$

with $p_i = F(\boldsymbol{x}_i) - F(\boldsymbol{x}_i^-)$, $q_j = G(\boldsymbol{y}_j) - G(\boldsymbol{y}_j^-)$ and $\boldsymbol{p} = (p_1, ..., p_m)^T$, $\boldsymbol{q} = (q_1, ..., q_n)^T$. The empirical log-likelihood ratio statistic for testing (26) is given by

$$\ell\left(\boldsymbol{\delta}_{0}\right) = -2\log\frac{\sup_{\boldsymbol{p},\boldsymbol{q}}\mathcal{L}\left(\boldsymbol{\delta}_{0}\right)}{\sup_{\boldsymbol{p},\boldsymbol{q}}\mathcal{L}\left(\boldsymbol{p},\boldsymbol{q}\right)}$$

Based on Lagrange multiplier methods, $\sup_{\boldsymbol{p},\boldsymbol{q}} \mathcal{L}(\boldsymbol{\delta}_0)$ is obtained for

where $m\lambda_1^T + n\lambda_2^T = 0$. The empirical maximum likelihood estimates $\tilde{\lambda}_1$, $\tilde{\lambda}_2$ and $\tilde{\mu}$ of λ_1 , λ_2 and μ , under H_0 , can be obtained as the solution of

On the other hand $\sup_{\boldsymbol{p},\boldsymbol{q}}\mathcal{L}\left(\boldsymbol{p},\boldsymbol{q}\right)$ is obtained for

$$p_i = \frac{1}{m}, i = 1, ..., m \text{ and } q_j = \frac{1}{n}, j = 1, ..., n.$$
 (29)

.

After some algebra, we obtain

$$\ell(\boldsymbol{\delta}_{0}) = -2\log \frac{\sup \mathcal{L}(\boldsymbol{\delta}_{0})}{\sup \mathcal{L}(\boldsymbol{p}, \boldsymbol{q})} = -2\left(-m\log m - \sum_{i=1}^{m}\log\left(1 + \widetilde{\boldsymbol{\lambda}}_{1}^{T}(\boldsymbol{X}_{i} - \boldsymbol{\mu})\right) - n\log n\right)$$
$$-\sum_{j=1}^{n}\log\left(1 + \widetilde{\boldsymbol{\lambda}}_{2}^{T}(\boldsymbol{Y}_{j} - \boldsymbol{\mu} - \boldsymbol{\delta}_{0})\right) + m\log m + n\log n\right)$$
$$= 2\left(\sum_{i=1}^{m}\log\left(1 + \widetilde{\boldsymbol{\lambda}}_{1}^{T}(\boldsymbol{X}_{i} - \boldsymbol{\mu})\right) + \sum_{j=1}^{n}\log\left(1 + \widetilde{\boldsymbol{\lambda}}_{2}^{T}(\boldsymbol{Y}_{j} - \boldsymbol{\mu} - \boldsymbol{\delta})\right)\right).$$
(30)

Under some regularity conditions, it follows that

$$\Pr\left(\ell\left(\boldsymbol{\delta}_{0}\right) < \chi^{2}_{k,\alpha}\right) = \alpha + O(n^{-1}),$$

where $\chi^2_{k,\alpha}$ is the $\alpha\text{-th}$ order quantile of the χ^2_k distribution.

Let

$$\widetilde{\boldsymbol{P}} = \left(\widetilde{p}_1 \frac{m}{N}, ..., \widetilde{p}_m \nu, \widetilde{q}_1 \left(1 - \frac{m}{N}\right), ..., \widetilde{q}_n \left(1 - \frac{m}{N}\right)\right)^T$$

be the estimate the probability vector

$$\mathbf{P} = (p_1\nu, ..., p_m\nu, q_1(1-\nu), ..., q_n(1-\nu))^T$$

where \tilde{p}_i and \tilde{q}_j are obtained from (27) and (28) replacing λ_1 , λ_2 and μ by $\tilde{\lambda}_1$, $\tilde{\lambda}_2$ and $\tilde{\mu}$, respectively. In this *k*-dimensional case, the Kullback-Leibler divergence between the probability vectors \boldsymbol{U} and $\tilde{\boldsymbol{P}}$ is given by

$$D_{Kullback}(\boldsymbol{U}, \widetilde{\boldsymbol{P}}) = \sum_{i=1}^{m} \frac{1}{N} \log \frac{\frac{1}{N}}{\widetilde{p}_i \frac{m}{N}} + \sum_{j=1}^{n} \frac{1}{N} \log \frac{\frac{1}{N}}{\widetilde{q}_j \frac{n}{N}}$$
$$= \frac{1}{N} \left\{ \sum_{i=1}^{m} \log \left(1 + \widetilde{\boldsymbol{\lambda}}_1^T (\boldsymbol{X}_i - \boldsymbol{\mu}) \right) + \sum_{j=1}^{n} \log \left(1 + \widetilde{\boldsymbol{\lambda}}_2^T (\boldsymbol{Y}_j - \boldsymbol{\mu} - \boldsymbol{\delta}) \right) \right\}.$$

Therefore, the relationship between $\ell\left(\boldsymbol{\delta}_{0}
ight)$ and the Kullback-Leibler divergence is

$$\ell(\boldsymbol{\delta}_0) = 2ND_{Kullback}(\boldsymbol{U}, \boldsymbol{\tilde{P}}).$$
(31)

Based on (31) the family of empirical phi-divergence test statistics are defined as

$$T_{\phi}\left(\boldsymbol{\delta}_{0}
ight)=rac{2N}{\phi^{\prime\prime}(1)}D_{\phi}(\boldsymbol{U},\widetilde{\boldsymbol{P}}),$$

with

$$D_{\phi}(\boldsymbol{U}, \widetilde{\boldsymbol{P}}) = \sum_{i=1}^{m} \widetilde{p}_{i} \frac{m}{m+n} \phi\left(\frac{1}{\widetilde{p}_{i}} \frac{m}{m+n}\right) + \sum_{j=1}^{n} \frac{n}{m+n} \widetilde{q}_{j} \phi\left(\frac{1}{\frac{n}{m+n}}\widetilde{q}_{j}\right)$$

Therefore the expression of $T_{\phi}\left(\boldsymbol{\delta}_{0}\right)$ is

$$T_{\phi}\left(\boldsymbol{\delta}_{0}\right) = \frac{2}{\phi''(1)} \left\{ \sum_{i=1}^{m} m \widetilde{p}_{i} \phi\left(\frac{1}{m \widetilde{p}_{i}}\right) + \sum_{j=1}^{n} n \widetilde{q}_{j} \phi\left(\frac{1}{n \widetilde{q}_{j}}\right) \right\}$$
$$= \frac{2}{\phi''(1)} \left\{ \sum_{i=1}^{m} \frac{1}{1 + \widetilde{\boldsymbol{\lambda}}_{1}^{T}(\boldsymbol{X}_{i} - \boldsymbol{\mu})} \phi\left(1 + \widetilde{\boldsymbol{\lambda}}_{1}^{T}(\boldsymbol{X}_{i} - \boldsymbol{\mu})\right) + \sum_{j=1}^{n} \frac{1}{1 + \widetilde{\boldsymbol{\lambda}}_{2}^{T}(\boldsymbol{Y}_{j} - \boldsymbol{\mu} - \boldsymbol{\delta})} \phi\left(1 + \widetilde{\boldsymbol{\lambda}}_{2}^{T}(\boldsymbol{Y}_{j} - \boldsymbol{\mu} - \boldsymbol{\delta}_{0})\right) \right\}.$$
(32)

A result similar to the one given in Lemma 1 for the k-dimensional case is

$$\widetilde{\boldsymbol{\mu}} = \left(m\boldsymbol{\Sigma}_{1}^{-1} + n\boldsymbol{\Sigma}_{2}^{-1}\right)^{-1} \left(m\boldsymbol{\Sigma}_{1}^{-1}\overline{\boldsymbol{X}} + n\boldsymbol{\Sigma}_{2}^{-1}\left(\overline{\boldsymbol{Y}} - \boldsymbol{\delta}\right)\right) + O_{p}(\boldsymbol{1}_{k}),$$

where $\overline{X} = \frac{1}{m} \sum_{i=1}^{m} X_i$ and $\overline{Y} = \frac{1}{n} \sum_{j=1}^{n} Y_j$. Finally, based in this result it is possible to establish

$$T_{\phi}\left(\boldsymbol{\delta}_{0}\right) \overset{\mathcal{L}}{\underset{n,m\to\infty}{\longrightarrow}} \chi_{k}^{2}$$

5.2 Extension of the test-statistic using the Rényi's divergence

Rényi (1961) introduced the Rényi's divergence measure as an extension of the Kullback-Leibler divergence. Unfortunately this divergence measure is not a member of the family of phi-divergence measures considered in this paper. Menéndez et al. (1995, 1997) introduced and studied the (h,phi)-divergence measures in order to have a family of divergence measures in which the phi-divergence measures as well as the Rényi divergence measure are included. But not only the Rényi divergence measure is included in this new family but another important divergence measures not include in the family of phi-divergence measures are included. For more details about the different divergence measures included in the (h,phi)-divergence see for instance, Pardo (2006). Based on the (h,phi)-divergence measures between the probability vectors U and P, defined in (12) and (13) respectively, we can consider the following family of empirical (h,phi)-divergence test statistics for the two-sample problem considered in (1)

$$T^{h}_{\phi}\left(\delta_{0}\right) = h\left(T_{\phi}\left(\delta_{0}\right)\right),\tag{33}$$

where h is a differentiable increasing function from $[0,\infty)$ onto $[0,\infty)$ with h(0) = 0 and h'(0) > 0. If we consider

$$h(x) = \frac{1}{a(a-1)} \log \left(a(a-1)x + 1 \right), \ a \neq 0, 1$$

in (33), and

$$\phi(x) = \frac{x^a - a(x-1) - 1}{a(a-1)}, \ a \neq 0, 1,$$

we get

$$T_{R\acute{e}nyi}(\delta_0) = T^h_{\phi}(\delta_0) = \frac{1}{a(a-1)} \log \left(a(a-1)T_{\phi}(\delta_0) + 1 \right)$$

= $\frac{1}{a(a-1)} \log \left\{ \sum_{i=1}^m \left(1 + \widetilde{\lambda}_1 \left(x_i - \widetilde{\mu} \right) \right)^{a-1} + \sum_{j=1}^n \left(1 + \widetilde{\lambda}_2 \left(y_j - (\widetilde{\mu} + \delta_0) \right) \right)^{a-1} \right\},$

i.e., the empirical Rényi's divergence test statistics for testing (1). For a = 0 and a = 1, we get

$$\lim_{a \to 0} T_{R\acute{e}nyi}\left(\delta_{0}\right) = 2ND_{Kullback}\left(\boldsymbol{U},\boldsymbol{P}\right)$$

and

$$\lim_{a \to 1} T_{R\acute{e}nyi} \left(\delta_0 \right) = 2N D_{Kullback} \left(\boldsymbol{P}, \boldsymbol{U} \right).$$

It is clear that

$$h(T_{\phi}(\delta_{0})) = h(0) + h'(0)T_{\phi}(\delta_{0}) + o(T_{\phi}(\delta_{0}))$$

Therefore

$$\frac{T^h_{\phi}\left(\delta_0\right)}{h'(0)} \xrightarrow[n,m \to \infty]{\mathcal{L}} \chi_1^2.$$

In the same way can be established for the problem considered in (26) that

$$\frac{T^{h}_{\phi}\left(\boldsymbol{\delta}_{0}\right)}{h'(0)} \xrightarrow[n,m \to \infty]{\mathcal{L}} \chi^{2}_{k}$$

where

$$T_{\phi}^{h}\left(\boldsymbol{\delta}_{0}\right) = h(T_{\phi}\left(\boldsymbol{\delta}_{0}\right))$$

with $T_{\phi}(\boldsymbol{\delta}_0)$ defined in (32).

Appendix

5.3 Proof of Lemma 1

In a similar way as in Hall and Scala (1990), we can establish

$$\lambda_1 = \lambda_1(\mu) = -\sigma_1^{-2}(\overline{X} - \mu) + O_p(m^{-1}) \text{ and } \lambda_2 = \lambda_2(\mu) = -\sigma_2^{-2}(\overline{Y} - \mu - \delta_0) + O_p(n^{-1}).$$

Now applying that

$$m\lambda_1\left(\mu\right) + n\lambda_2\left(\mu\right) = 0,$$

we have

$$m\sigma_1^{-2}\left(\overline{X} - \mu\right) + O_p(1) + n\sigma_2^{-2}\left(\overline{Y} - \mu - \delta_0\right) + O_p(1) = 0.$$
(34)

Solving the equation for μ we have the enunciated result.

5.4 Proof of Theorem 2

First we are going to establish

$$\frac{2}{\phi''(1)}\sum_{i=1}^{m} m p_i \phi\left(\frac{1}{m p_i}\right) = m\left(\frac{\overline{X} - \mu}{\sigma_1}\right)^2 + o_p(1) \tag{35}$$

$$\frac{2}{\phi''(1)}\sum_{j=1}^{n} nq_j \phi\left(\frac{1}{nq_j}\right) = n\left(\frac{\overline{Y} - \mu - \delta_0}{\sigma_2}\right)^2 + o_p(1).$$
(36)

If we denote $W_i = \lambda_1(\mu) (X_i - \mu)$ we have $\phi\left(\frac{1}{mp_i}\right) = \phi(1 + W_i)$. A Taylor expansion gives

$$\phi(1+W_i) = \phi(1) + \phi'(1) W_i + \frac{1}{2} \phi''(1) W_i^2 + o(W_i^2).$$

On the other hand

$$mp_{i} = \frac{1}{1 + \lambda_{1}(\mu)(X_{i} - \mu)} = \frac{1}{1 + W_{i}} = 1 - W_{i} + W_{i}^{2} + o(W_{i}^{2})$$

Then

$$\begin{aligned} \frac{2}{\phi''(1)} \sum_{i=1}^{m} m p_i \phi\left(\frac{1}{m p_i}\right) &= \frac{2}{\phi''(1)} \sum_{i=1}^{m} \left(1 - W_i + W_i^2 + o\left(W_i^2\right)\right) \left(\frac{1}{2} \phi''(1) W_i^2 + o\left(W_i^2\right)\right) \\ &= \frac{2}{\phi''(1)} \left(\frac{1}{2} \phi''(1) \sum_{i=1}^{m} W_i^2 + \sum_{i=1}^{m} o\left(W_i^2\right) - \frac{1}{2} \phi''(1) \sum_{i=1}^{m} W_i^3 \\ &- \sum_{i=1}^{m} o\left(W_i^2\right) W_i + \frac{1}{2} \phi''(1) \sum_{i=1}^{m} W_i^4 + \sum_{i=1}^{m} o\left(W_i^2\right) W_i^2 \\ &+ \frac{1}{2} \phi''(1) \sum_{i=1}^{m} o\left(W_i^2\right) W_i^2 + \sum_{i=1}^{m} o\left(W_i^2\right) o\left(W_i^2\right) \right) \\ &= \sum_{i=1}^{m} W_i^2 + \frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(W_i^2\right) - \sum_{i=1}^{m} W_i^3 - \sum_{i=1}^{m} o\left(W_i^2\right) W_i + \sum_{i=1}^{m} W_i^4 \\ &+ \frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(W_i^2\right) + \sum_{i=1}^{m} o\left(W_i^2\right) W_i^2 + \frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(W_i^2\right) o\left(W_i^2\right). \end{aligned}$$

But

$$\frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(W_i^2\right) = \frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(\lambda_1^2\left(\mu\right) \left(X_i - \mu\right)^2\right) = \frac{2}{\phi''(1)} m \frac{1}{m} \sum_{i=1}^{m} \left(X_i - \mu\right)^2 o\left(\lambda_1^2\left(\mu\right)\right)$$

= $m o_p(1) o\left(O_p\left(m^{-1}\right)\right) = o_p(1)$, because

$$\lambda_1\left(\mu\right) = O_p(m^{-1/2})$$

(see page 220 in Owen (2001)), and

$$\frac{1}{m}\sum_{i=1}^{m} (X_i - \mu)^2 = o_p(1)$$

applying the strong law of large numbers.

$$\left|\sum_{i=1}^{m} W_{i}^{3}\right| \leq \left|\lambda_{1}\left(\mu\right)^{3}\right| m \frac{1}{m} \sum_{i=1}^{m} |X_{i} - \mu|^{3} = O_{p}(m^{-3/2}) mo\left(m^{1/2}\right) = o_{p}(1), \text{ because}$$

$$\frac{1}{m} \sum_{i=1}^{m} |X_{i} - \mu|^{3} = o\left(m^{1/2}\right),$$

by Lemma 11.3 in page 218 in Owen (2001).

$$\left|\sum_{i=1}^{m} o\left(W_{i}^{2}\right) W_{i}\right| \leq o\left(\lambda_{1}^{2}\left(\mu\right)\right) \lambda_{1}\left(\mu\right) m \frac{1}{m} \sum_{i=1}^{m} |X_{i} - \mu|^{3} = o\left(O_{p}\left(m^{-1}\right) O_{p}\left(m^{-1/2}\right) o\left(m^{3/2}\right) = o_{p}(1).$$

• $\left|\sum_{i=1}^{m} W_{i}^{4}\right| \leq \left|\lambda_{1}\left(\mu\right)^{4}\right| \sum_{i=1}^{m} |X_{i} - \mu|^{4} \leq O_{p}\left(m^{-2}\right) m Z_{m} \frac{1}{m} \sum_{i=1}^{m} |X_{i} - \mu|^{3} = O_{p}\left(m^{-2}\right) m o(m^{1/2}) O(m^{1/2}) = o_{p}(1),$
because

$$Z_m = \max_{1 \le i \le m} |X_i - \mu| = O(m^{1/2})$$

applying Lemma 11.2 in page 218 in Owen (2001).

$$\left| \frac{2}{\phi''(1)} \sum_{i=1}^{m} o\left(W_{i}^{2}\right) o\left(W_{i}^{2}\right) \right| \leq \frac{2}{\phi''(1)} \left| \lambda_{1}\left(\mu\right)^{4} \right| \sum_{i=1}^{m} |X_{i} - \mu|^{4} = o_{p}(1).$$

$$= m\left(\frac{\overline{X} - \widetilde{\mu}}{\sigma_{1}^{2}}\right)\left(\overline{X} - \widetilde{\mu} - \overline{Y} + \widetilde{\mu} + \delta_{0}\right) + o_{p}(1)$$

$$= -n\sigma_{2}^{-2}\left(\overline{Y} - \widetilde{\mu} - \delta_{0}\right)\left(\overline{X} - \overline{Y} + \delta_{0}\right) + o_{p}(1).$$

From (19) we have

$$= \frac{1}{\frac{m}{m+n}\sigma_{2}^{2} + \frac{n}{m+n}\sigma_{1}^{2}}\frac{mn}{m+n}(\overline{X} - (\overline{Y} - \delta_{0}))^{2} + o_{p}(1).$$
