# Matrix-Product Complementary dual Codes

#### Abstract

Linear complementary dual codes (LCD) are linear codes satisfying $C \cap C^{\perp}=\{0\}$. Under suitable conditions, matrix-product codes that are complementary dual codes are characterized. We construct LCD codes using quasi-orthogonal matrices. Some asymptotic results are derived.


Key Words: LCD codes; Matrix-product codes; dual codes

## 1 Introduction

Linear complementary dual codes (which is abbreviated to LCD codes) are linear codes that meet their dual trivially. These codes were introduced by Massey in [3] and showed that asymptotically good LCD codes exist, and provide an optimum linear coding solution for the two-user binary adder channel. They are also used in counter measure to passive and active side channel analyses on embedded cryto-systems(See[2]). It was proven by Sendrier [5] that LCD codes meet the Gilbert-Varshamov bound. Necessary and sufficient conditions for cyclic codes to be LCD codes were obtained(See[6]).

Matrix-product codes over finite fields were introduced in [1]. Many well-known constructions can be formulated as matrix-product codes, for example, the $(a \mid a+b)$-construction and the $(a+x|b+x| a+b+x)$-construction, and some quasi-cyclic codes can be rewritten as matrix-product codes(See[1,8]). In [4], the authors studied complementary-dual quasi-cyclic codes. Necessary and sufficient conditions for certain classes of quasi-cyclic codes to be LCD codes were obtained. Motivated by this work, we will investigate necessary and sufficient conditions for certain classes of matrix-product codes to be LCD codes.

We finish this introduction with a description of each section in this paper. Section 2 reviews the basics about linear codes, matrix-product codes and LCD codes. In section 3, we propose new constructions of LCD codes by using matrix-product codes, and, in section 4, using methods of the section 3, concrete examples are presented to construct good parameters LCD codes of the section 3. Finally, a brief summary of this work is described in section 5 .

## 2 Preliminaries

In order for the exposition in this paper to be self-contained, we introduce some basic concepts and results about linear codes, LCD codes and matrix-product codes. For more details, we refer to $[1,3,10]$.

Starting from this section till the end of this paper, we assume that $\mathbb{F}_{q}$ is a finite field with $q=p^{m}$ elements, where $p$ is a prime number and $m \geq 1$ is an integer. For a positive integer $n$, let $\mathbb{F}_{q}^{n}$ denote the vector space of all $n$-tuples over $\mathbb{F}_{q}$. A linear $[n, k]_{q}$ code $C$ over $\mathbb{F}_{q}$ is a $k$-dimensional subspace of $\mathbb{F}_{q}^{n}$. The Hamming weight $w_{H}(c)$ of a codeword $c \in C$ is the number of nonzero components of $c$. The Hamming distance of two codewords $c_{1}, c_{2} \in C$ is $d_{H}\left(c_{1}, c_{2}\right)=w_{H}\left(c_{1}-c_{2}\right)$. The minimum Hamming distance $d(C)$ of $C$ is the minimum Hamming distance between any two distinct codewords of $C$. An $[n, k, d]_{q}$ code is an $[n, k]_{q}$ code with the minimum Hamming distance $d$.

For two vectors $a=\left(a_{1}, a_{2}, \ldots, a_{n}\right)$ and $b=\left(b_{1}, b_{2}, \ldots, b_{n}\right)$ in $\mathbb{F}_{q}^{n}$, we define the Euclidean inner product $\langle a, b\rangle$ to be $\langle a, b\rangle=\sum_{i=1}^{n} a_{i} b_{i}$. For a linear $[n, k]_{q}$ code $C$ over $\mathbb{F}_{q}^{n}$, we define the Euclidean dual code as

$$
C^{\perp}=\left\{a \in \mathbb{F}_{q}^{n} \mid<a, b>=0 \text { for all } b \in C\right\}
$$

To define the Hermitian inner product, we will assume that $m=2 k$ and $l=p^{k}$. Then $\mathbb{F}_{q}=\mathbb{F}_{l^{2}}$. For two vectors $a=\left(a_{1}, a_{2}, \ldots, a_{n}\right)$ and $b=\left(b_{1}, b_{2}, \ldots, b_{n}\right)$ in $\mathbb{F}_{l^{2}}^{n}$, we define the Hermitian inner product $<a, b>_{h}$ to be $<a, b>_{h}=\sum_{i=1}^{n} a_{i} b_{i}^{l}$. For a linear $[n, k]_{l^{2}}$ code $C$ over $\mathbb{F}_{l^{2}}^{n}$, we define the Hermitian dual code as

$$
C^{\perp_{h}}=\left\{a \in \mathbb{F}_{l^{2}}^{n} \mid<a, b>_{h}=0 \text { for all } b \in C\right\}
$$

From the fact that the Hermitian inner product is nondegenerate, it follows immediately that $\left(C^{\perp_{h}}\right)^{\perp_{h}}=C$ holds. Moreover, one has $\operatorname{dim}_{\mathbb{F}^{2}} C^{\perp_{h}}+\operatorname{dim}_{\mathbb{F}_{l^{2}}} C=n$.

A linear code $C$ is called Hermitian LCD if $C^{\perp_{h}} \cap C=\{0\}$.
Given a vector $a=\left(a_{1}, a_{2}, \ldots, a_{n}\right)$, we define the $l$ th power of $a$ as

$$
a^{l}=\left(a_{1}^{l}, a_{2}^{l}, \ldots, a_{n}^{l}\right)
$$

For a linear code $C$ of length $n$ over $\mathbb{F}_{l^{2}}^{n}$, we define $C^{l}$ to be the set $\left\{a^{l} \mid\right.$ for all $\left.a \in C\right\}$. Then, it is easy to see that for a linear code $C$ of length $n$ over $\mathbb{F}_{l^{2}}^{n}$, the Hermitian dual $C^{\perp_{h}}$ is equal to the Euclidean $\left(C^{l}\right)^{\perp}$ dual of $C^{l}$. Therefore, $C$ is a Hermitian LCD code if and only if $\left(C^{l}\right)^{\perp} \cap C=\{0\}$.

### 2.1 The Matrix-Product Codes

The matrix-product codes $C=\left[C_{1}, \ldots, C_{s}\right] A$ consists of all matrix product $\left[c_{1}, \ldots, c_{s}\right] A$ where $c_{i} \in C_{i}$ is an $n \times 1$ column vector and $A=\left(a_{i j}\right)_{s \times m}$ is an $s \times m$ matrix over $\mathbb{F}_{q}$. Here $s \leq m$ and $C_{i}$ is an $\left(n,\left|C_{i}\right|, d_{i}\right)_{q}$ code over $\mathbb{F}_{q}$. If $C_{1}, \ldots, C_{s}$ are linear with generator matrices $G_{1}, \ldots, G_{s}$, respectively, then $\left[C_{1}, \ldots, C_{s}\right] A$ is linear with generator matrix

$$
G=\left(\begin{array}{cccc}
a_{11} G_{1} & a_{12} G_{1} & \cdots & a_{1 m} G_{1} \\
a_{21} G_{2} & a_{22} G_{2} & \cdots & a_{2 m} G_{2} \\
\vdots & \vdots & \cdots & \vdots \\
a_{s 1} G_{s} & a_{s 2} G_{s} & \cdots & a_{s m} G_{s}
\end{array}\right)
$$

A matrix-product code $C=\left[C_{1}, \ldots, C_{s}\right] A$ over $\mathbb{F}_{q}$ is said to be a matrix-product LCD (MPLCD) code if the matrix-product code $C=\left[C_{1}, \ldots, C_{s}\right] A$ is an LCD code over $\mathbb{F}_{q}$.

Let $A=\left(a_{i j}\right)_{s \times m}$ be a matrix over $\mathbb{F}_{q}$. For any index $1 \leq k \leq s$, we denote by $U_{A}(k)$ the linear code of length $m$ over $\mathbb{F}_{q}$ generated by the $i$ th rows of $A$, for $i=1,2, \ldots, k$. Let $A_{t}$ be the matrix consisting of the first $t$ rows of $A=\left(a_{i j}\right)_{s \times m}$. For $1 \leq j_{1}<j_{2}<\cdots<j_{t} \leq m$, we write $A\left(j_{1}, j_{2}, \ldots, j_{t}\right)$ for the $t \times t$ matrix consisting of columns $j_{1}, j_{2}, \ldots, j_{t}$ of $A_{t}$.

Definition 2.1. [1, Definition 3.1] Let $A=\left(a_{i j}\right)_{s \times l}$ be a matrix over $\mathbb{F}_{q}$.
(1) If the rows of $A$ are linearly independent, then we say $A$ is a full-row-rank(FRR) matrix.
(2) We call $A$ non-singular by columns (NSC) if $A\left(j_{1}, j_{2}, \ldots, j_{t}\right)$ is non-singular for each $1 \leq t \leq s$ and $1 \leq j_{1}<j_{2}<\cdots<j_{t} \leq m$.

The codes in this paper are based on matrix-product codes, whose parameters are described in the following result.

Lemma 2.2. [7] If $C_{i}$ is a linear code over $\mathbb{F}_{q}$ with parameters $\left[n, k_{i}, d_{i}\right]_{q}$ for $1 \leq i \leq s, A=$ $\left(a_{i j}\right)_{s \times m}$ is an FRR matrix over $\mathbb{F}_{q}$ and $C=\left[C_{1}, \ldots, C_{s}\right] A$, then $C$ is an $\left[n m, \sum_{i=1}^{s} k_{i}, d(C)\right]_{q}$
linear code over $\mathbb{F}_{q}$ whose minimum distance $d(C)$ satisfying

$$
d(C) \geq \min \left\{d_{1} d\left(U_{A}(1)\right), d_{2} d\left(U_{A}(2)\right), \ldots, d_{s} d\left(U_{A}(s)\right\}\right.
$$

Lemma 2.3. [1, Theorem 3.7, Proposition 6.2] If $C_{i}$ is a linear code over $\mathbb{F}_{q}$ with parameters $\left[n, k_{i}, d_{i}\right]_{q}$ for $1 \leq i \leq s, A$ is an $s \times m$ NSC matrix and $C=\left[C_{1}, \ldots, C_{s}\right] A$, then
(1) $d(C) \geq d^{*}=\min \left\{m d_{1},(m-1) d_{2}, \ldots,(m-s+1) d_{s}\right\}$;
(2) If $A$ is also upper-triangular then $d(C)=d^{*}$.

Lemma 2.4. [1, Theorem 6.6, Proposition 6.2] Let $A$ be an $s \times s$ non-singular matrix and $C_{1}, \ldots, C_{s}$ are linear codes over $\mathbb{F}_{q}$. If $C=\left[C_{1}, \ldots, C_{s}\right] A$, then
(1) $\left(\left[C_{1}, \ldots, C_{s}\right] A\right)^{\perp}=\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(A^{-1}\right)^{T}$;
(2) If $A$ is also $s \times s$ NSC matrix, then $d\left(C^{\perp}\right) \geq\left(d^{\perp}\right)^{*}=\min \left\{s d_{s}^{\perp},(s-1) d_{s-1}^{\perp}, \ldots, d_{1}^{\perp}\right\}$ where $d_{j}^{\perp}=d\left(C_{j}^{\perp}\right)$, for $j=1,2, \ldots, s$;
(3) If $A$ is also upper-triangular then $d\left(C^{\perp}\right)=\left(d^{\perp}\right)^{*}$.

### 2.2 Cyclic LCD Codes

We first reviews the basics about Euclidean LCD codes.
Given a ring $\widetilde{R}$, for a nonempty subset $S$ of $\widetilde{R}$, the annihilator of $S$, denoted by ann $(\mathrm{S})$, is the set

$$
\operatorname{ann}(S)=\{f \in \widetilde{R} \mid f g=0, \text { for all } g \in S\}
$$

If, in addition, $S$ is an ideal of $\widetilde{R}$, then $\operatorname{ann}(S)$ is also an ideal of $\widetilde{R}$.
For any polynomial $f(x)=\sum_{i=0}^{k} a_{i} x^{i}$ of degree $k\left(a_{k} \neq 0\right)$ over $\mathbb{F}_{q}$, let $f^{*}(x)$ denote the reciprocal polynomial of $f(x)$ given by

$$
f^{*}(x)=x^{k} f\left(\frac{1}{x}\right)=\sum_{i=0}^{k} a_{k-i} x^{i} .
$$

Note that $\left(f^{*}\right)^{*}=f$ if and only if the constant term of $f$ is nonzero, if and only if $\operatorname{deg}(f)=\operatorname{deg}\left(f^{*}\right)$. Furthermore, by definition, it is easy to see that $(f g)^{*}=f^{*} g^{*}$. We denote $N^{*}=\left\{f^{*}(x) \mid f(x) \in N \subset \mathbb{F}_{q}[x]\right\}$. It is easy to see that if $N$ is an ideal, then $N^{*}$ is also an ideal. Hereafter, we will use $a n n^{*}(C)$ to denote $(\operatorname{ann}(C))^{*}$.

The following Proposition can be found in [10].
Proposition 2.5. If $C$ is a cyclic code of length $n$ over $\mathbb{F}_{q}$, then the dual $C^{\perp}$ of $C$ is $a n n^{*}(C)$.

Suppose that $f(x)$ is a monic (i.e., leading coefficient 1) polynomial of degree $k$ with $f(0)=c \neq 0$. Then by monic reciprocal polynomial of $f(x)$ we mean the polynomial $\widetilde{f}(x)=c^{-1} f^{*}(x)$.

We recall a result about cyclic LCD codes which can be found in [6].

Proposition 2.6. If $g_{1}(x)$ is the generator polynomial of a cyclic code $C$ of length $n$ over $\mathbb{F}_{q}$, then $C$ is an LCD code if and only if $g_{1}(x)$ is self-reciprocal (i.e., $\left.\widetilde{g}_{1}(x)=g_{1}(x)\right)$ and all the monic irreducible factors of $g_{1}(x)$ have the same multiplicity in $g_{1}(x)$ and in $x^{n}-1$.

In the following we investigate the generator polynomials of the repeated-root cyclic LCD codes over $\mathbb{F}_{q}$ where $q=p^{m}$.

It is well known that each cyclic code over $\mathbb{F}_{q}$ is uniquely determined by its generator polynomial, a monic divisor of $x^{n}-1$ over $\mathbb{F}_{q}$. In order to describe the generator polynomials of the repeated-root cyclic LCD codes, we need to know the factorization of the polynomial $x^{n}-1$ over $\mathbb{F}_{q}$. Write

$$
n=p^{t} l,
$$

where $t$ is a nonnegative integer depending on $n$ and $\operatorname{gcd}(l, p)=1$. Then

$$
x^{n}-1=\left(x^{l}-1\right)^{p^{t}} .
$$

For any irreducible polynomial dividing $x^{l}-1$ over $\mathbb{F}_{q}$, its reciprocal polynomial also divides $x^{l}-1$ over $\mathbb{F}_{q}$ and is also irreducible over $\mathbb{F}_{q}$. Since $\operatorname{gcd}(l, p)=1$, the polynomial $x^{l}-1$ factors completely into nonassociated irreducible factors in $\mathbb{F}_{q}[x]$ as

$$
x^{l}-1=\delta f_{1}(x) f_{2}(x) \cdots f_{k}(x) h_{1}(x) h_{1}^{*}(x) \cdots h_{s}(x) h_{s}^{*}(x)
$$

where $\delta \neq 0$ in $\mathbb{F}_{q}, f_{1}(x), f_{2}(x), \cdots, f_{k}(x)$ are irreducible polynomials that are associates to their own reciprocals, and $h_{1}(x), h_{1}^{*}(x) ; \cdots ; h_{s}(x), h_{s}^{*}(x)$ are pairs of mutually reciprocal irreducible polynomials. Therefore

$$
\begin{equation*}
x^{n}-1=\delta^{p^{t}}\left(f_{1}(x)\right)^{p^{t}}\left(f_{2}(x)\right)^{p^{t}} \cdots\left(f_{k}(x)\right)^{p^{t}}\left(h_{1}(x)\right)^{p^{t}}\left(h_{1}^{*}(x)\right)^{p^{t}} \cdots\left(h_{s}(x)\right)^{p^{t}}\left(h_{s}^{*}(x)\right)^{p^{t}} . \tag{2.1}
\end{equation*}
$$

We can describe the generator polynomials of the repeated-root cyclic LCD codes as soon as we know the factorization of $x^{n}-1$ over $\mathbb{F}_{q}$.

Proposition 2.7. Let $x^{n}-1$ be factorized as in (2.1). A repeated-root cyclic code $C$ of length $n$ over $\mathbb{F}_{q}$ is an LCD code if and only if its generator polynomial is of the form

$$
\begin{equation*}
\left(f_{1}(x)\right)^{\alpha_{1}}\left(f_{2}(x)\right)^{\alpha_{2}} \cdots\left(f_{k}(x)\right)^{\alpha_{k}}\left(h_{1}(x)\right)^{\beta_{1}}\left(h_{1}^{*}(x)\right)^{\beta_{1}} \cdots\left(h_{s}(x)\right)^{\beta_{s}}\left(h_{s}^{*}(x)\right)^{\beta_{s}} . \tag{2.2}
\end{equation*}
$$

where $\alpha_{i} \in\left\{0, p^{t}\right\}$ for each $1 \leq i \leq k$, and $\beta_{j} \in\left\{0, p^{t}\right\}$ for each $1 \leq j \leq s$.
Proof. Let $C$ be a cyclic code of length $n$ over $\mathbb{F}_{q}$, and let $g(x)$ be its generator polynomial. We need to show that $C$ is an LCD code if and only if $g(x)$ is of the form as in (2.2).

Suppose that

$$
g(x)=\varepsilon\left(f_{1}(x)\right)^{\alpha_{1}}\left(f_{2}(x)\right)^{\alpha_{2}} \cdots\left(f_{k}(x)\right)^{\alpha_{k}}\left(h_{1}(x)\right)^{\beta_{1}}\left(h_{1}^{*}(x)\right)^{\gamma_{1}} \cdots\left(h_{s}(x)\right)^{\beta_{s}}\left(h_{s}^{*}(x)\right)^{\gamma_{s}}
$$

with leading coefficient 1 , where $0 \leq \alpha_{i} \leq p^{t}$ for each $1 \leq i \leq k$, and $0 \leq \beta_{j}, \gamma_{j} \leq p^{t}$ for each $1 \leq j \leq s$, where $\varepsilon \in \mathbb{F}_{q}$. Then

$$
g^{*}(x)=\eta\left(f_{1}(x)\right)^{\alpha_{1}}\left(f_{2}(x)\right)^{\alpha_{2}} \cdots\left(f_{k}(x)\right)^{\alpha_{k}}\left(h_{1}(x)\right)^{\gamma_{1}}\left(h_{1}^{*}(x)\right)^{\beta_{1}} \cdots\left(h_{s}(x)\right)^{\gamma_{s}}\left(h_{s}^{*}(x)\right)^{\beta_{s}},
$$

where $\eta \in \mathbb{F}_{q}$. Therefore,
$\widetilde{g}(x)=\frac{1}{g(0)} g^{*}(x)=\varepsilon\left(f_{1}(x)\right)^{\alpha_{1}}\left(f_{2}(x)\right)^{\alpha_{2}} \cdots\left(f_{k}(x)\right)^{\alpha_{k}}\left(h_{1}(x)\right)^{\gamma_{1}}\left(h_{1}^{*}(x)\right)^{\beta_{1}} \cdots\left(h_{s}(x)\right)^{\gamma_{s}}\left(h_{s}^{*}(x)\right)^{\beta_{s}}$.
By Proposition 2.6, $C$ is an LCD code if and only if $g(x)=\widetilde{g}(x)$ and all the monic irreducible factors of $g(x)$ have the same multiplicity in $g(x)$ and in $x^{n}-1$, i.e., $\beta_{j}=\gamma_{j}$ for each $1 \leq j \leq s, \alpha_{i} \in\left\{0, p^{t}\right\}$ for each $1 \leq i \leq k$, and $\beta_{j} \in\left\{0, p^{t}\right\}$ for each $1 \leq j \leq s$.

Therefore, $C$ is an LCD code if and only if its generator polynomial $g(x)$ is of the form as in (3.2).

Next, we reviews the basics about Hermitian LCD codes which can be found in [8].
Let $f(x)=a_{0}+a_{1} x+\ldots+a_{k} x^{k} \in \mathbb{F}_{l^{2}}[x]$ with a nonzero constant coefficient $a_{0}$, let us denote the monic polynomial by

$$
f^{\perp}(x)=a_{0}^{-l}\left(a_{k}^{l}+a_{k-1}^{l} x+\ldots+a_{0}^{l} x^{k}\right)
$$

Then $f^{\perp}(x)$ is called conjugate-reciprocal polynomial of $f(x)$.
Lemma 2.8. [9, Lemma 7] Assume that $C=\langle g(x)\rangle$ is a cyclic code of length $n$ over $\mathbb{F}_{l^{2}}$ with generator polynomial $g(x)$. Define $h(x)=\frac{x^{n}-1}{g(x)}$. Then we have that $C^{\perp_{h}}=\left\langle h^{\perp}(x)\right\rangle$.

Similar to the discussions in [3], we have the following proposition.
Proposition 2.9. If $g(x)$ is the generator polynomial of a cyclic code $C$ of length $n$ over $\mathbb{F}_{l^{2}}$, then $C$ is an LCD cyclic code with respect to Hermitian inner product if and only if $g(x)$ is conjugate-self-reciprocal (i.e., $g(x)=g^{\perp}(x)$ ) and all the monic irreducible factors of $g(x)$ have the same multiplicity in $g(x)$ and in $x^{n}-1$.

## 3 Matrix-Product LCD Codes

Let $A=\left(a_{i j}\right)$ be an $s \times m$ matrix with entries in $\mathbb{F}_{q}$. $A$ is said to be a quasi-orthogonal matrix if $A A^{T}$ is a diagonal square matrix where all the diagonal entries are non-zeros of $\mathbb{F}_{q}$. Then we have the following result.

Theorem 3.1. Let $C_{1}, C_{2}, \ldots, C_{s}$ be linear codes over $\mathbb{F}_{q}$, and let $A$ is an $s \times s$ quasiorthogonal matrix over $\mathbb{F}_{q}$. Then $C=\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is an MPLCD code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all LCD codes. In particular, if $\left(A^{-1}\right)^{T}=a A$, where $a \in \mathbb{F}_{q}^{*}$, then $C=\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is an MPLCD code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all $L C D$ codes.

Proof. Assume that $A A^{T}=\left(\begin{array}{cccc}r_{1} & 0 & \cdots & 0 \\ 0 & r_{2} & \cdots & 0 \\ \vdots & \vdots & \cdots & \vdots \\ 0 & 0 & \cdots & r_{s}\end{array}\right)$, with $r_{i}$ being non-zeros of $\mathbb{F}_{q}$. Then

$$
\left(A^{-1}\right)^{T}=\left(\begin{array}{cccc}
r_{1}^{-1} & 0 & \cdots & 0 \\
0 & r_{2}^{-1} & \cdots & 0 \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s}^{-1}
\end{array}\right) A
$$

Therefore, by Lemma 2.4, the dual code

$$
\begin{aligned}
C^{\perp} & =\left(\left[C_{1}, \ldots, C_{s}\right] A\right)^{\perp} \\
& =\left(\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(A^{-1}\right)^{T}\right. \\
& =\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(\begin{array}{cccc}
r_{1}^{-1} & 0 & \cdots & 0 \\
0 & r_{2}^{-1} & \cdots & 0 \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s}^{-1}
\end{array}\right) A .
\end{aligned}
$$

Since $C_{j}$ is a linear code, so also is $C_{j}^{\perp}$. This implies that $r_{j}^{-1} C_{j}^{\perp}=C_{j}^{\perp}$, for $j=1,2, \ldots, s$. Hence,

$$
C^{\perp}=\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(\begin{array}{cccc}
r_{1}^{-1} & 0 & \cdots & 0  \tag{3.1}\\
0 & r_{2}^{-1} & \cdots & 0 \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s}^{-1}
\end{array}\right) A=\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right] A
$$

$\Rightarrow$ : If $C$ is not an MPLCD code over $\mathbb{F}_{q}$, then there exists a nonzero codeword $\alpha$ in $C$ such that $\alpha=\left(c_{1}, \ldots, c_{s}\right) A \in C \cap C^{\perp}$, where $c_{1} \in C_{1}, \ldots, c_{s} \in C_{s}$. Obviously, there exists some positive integer $j$ such that $c_{j} \neq 0$ where $1 \leq j \leq s$.

As $\alpha \in C^{\perp}$, by above equality (3.1), there exist $c_{1}^{\perp} \in C_{1}^{\perp}, \ldots, c_{j}^{\perp} \in C_{j}^{\perp}, \ldots, c_{s}^{\perp} \in C_{s}^{\perp}$ such that

$$
\alpha=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right) A
$$

Therefore

$$
\left(c_{1}, \ldots, c_{j}, \ldots, c_{s}\right) A=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right) A
$$

Since A is an $s \times s$ non-singular matrix, we obtain

$$
\left(c_{1}, \ldots, c_{j}, \ldots, c_{s}\right)=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right)
$$

which implies that $0 \neq c_{j}=c_{j}^{\perp} \in C_{j} \cap C_{j}^{\perp}$. This is a contradiction.
$\Longleftarrow$ : Otherwise, we assume that $C_{j}$ is not an LCD code for some $1 \leq j \leq s$. Then there exits a nonzero codeword $c_{j}$ in $C_{j}$ such that $c_{j} \in C_{j}^{\perp}$.

Taking $\beta=\left(0, \ldots, 0, c_{j}, 0, \ldots, 0\right) A$, then $\beta \neq 0$ since A is an $s \times s$ non-singular matrix. By definition of matrix-product code and above equality (3.1), we have $\beta \in C \cap C^{\perp}$. This is a contradiction.

Theorem 3.2. Assume that $A$ is an $s \times s$ non-singular lower-triangular matrix over $\mathbb{F}_{q}$. If $C_{1} \supset C_{2} \supset \cdots \supset C_{s}$ are linear codes over $\mathbb{F}_{q}$, then $C=\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is an MPLCD code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all $L C D$ codes.

Proof. Suppose that $A=\left(\begin{array}{ccccc}r_{11} & 0 & 0 & \cdots & 0 \\ r_{21} & r_{22} & 0 & \cdots & 0 \\ \vdots & \vdots & \vdots & \cdots & \vdots \\ r_{s 1} & r_{s 2} & r_{s 3} & \cdots & r_{s s}\end{array}\right)$. Then, for $i=1, \ldots, s, r_{i i}$ is non-zeros of $\mathbb{F}_{q}$ since $A$ is an $s \times s$ non-singular lower-triangular matrix. Therefore

$$
\left(A^{-1}\right)^{T}=\left(\begin{array}{cccc}
r_{11}^{-1} & r_{12}^{\prime} & \cdots & r_{1 s}^{\prime} \\
0 & r_{22}^{-1} & \cdots & r_{2 s}^{\prime} \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s s}^{-1}
\end{array}\right)
$$

where $r_{i j}^{\prime} \in \mathbb{F}_{q}, i<j, i=1, \ldots, s-1, j=2, \ldots, s$. Hence, by Lemma 2.4, the dual code

$$
\begin{aligned}
C^{\perp}=\left(\left[C_{1}, \ldots, C_{s}\right] A\right)^{\perp} & =\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(A^{-1}\right)^{T} \\
& =\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(\begin{array}{cccc}
r_{11}^{-1} & r_{12}^{\prime} & \cdots & r_{1,}^{\prime} \\
0 & r_{22}^{-1} & \cdots & r_{2 s}^{\prime} \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s s}^{-1}
\end{array}\right) \\
& =\left[r_{11}^{-1} C_{1}^{\perp}, r_{12}^{\prime} C_{1}^{\perp}+r_{22}^{-1} C_{2}^{\perp}, \ldots, r_{1 s}^{\prime} C_{1}^{\perp}+r_{2 s}^{\prime} C_{2}^{\perp}+\ldots+r_{s s}^{-1} C_{s}^{\perp}\right]
\end{aligned}
$$

Since $C_{1} \supset C_{2} \supset \cdots \supset C_{s}$ are linear codes, so $C_{1}^{\perp} \subset C_{2}^{\perp} \subset \cdots \subset C_{s}^{\perp}$ also are linear codes. Then we obtain

$$
r_{11}^{-1} C_{1}^{\perp}=C_{1}^{\perp}, \quad r_{12}^{\prime} C_{1}^{\perp}+r_{22}^{-1} C_{2}^{\perp}=C_{2}^{\perp}, \quad \ldots, \quad r_{1 s}^{\prime} C_{1}^{\perp}+r_{2 s}^{\prime} C_{2}^{\perp}+\ldots+r_{s s}^{-1} C_{s}^{\perp}=C_{s}^{\perp} .
$$

Hence,

$$
C^{\perp}=\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right]\left(\begin{array}{cccc}
r_{11}^{-1} & r_{12}^{\prime} & \cdots & r_{1 s}^{\prime}  \tag{3.2}\\
0 & r_{22}^{-1} & \cdots & r_{2 s}^{\prime} \\
\vdots & \vdots & \cdots & \vdots \\
0 & 0 & \cdots & r_{s s}^{-1}
\end{array}\right)=\left[C_{1}^{\perp}, \ldots, C_{s}^{\perp}\right] .
$$

$\Rightarrow$ : If $C$ is not an MPLCD code over $\mathbb{F}_{q}$, then there exists a nonzero codeword $\alpha=$ $\left(c_{1}, \ldots, c_{s}\right) A$ in $C$ such that $\alpha \in C^{\perp}$, where $c_{1} \in C_{1}, \ldots, c_{s} \in C_{s}$. Obviously, there exists some positive integer $j$ such that $c_{j} \neq 0$ where $1 \leq j \leq s$.

As $\alpha \in C^{\perp}$, by above equality (3.2), there exist $c_{1}^{\perp} \in C_{1}^{\perp}, \ldots, c_{j}^{\perp} \in C_{j}^{\perp}, \ldots, c_{s}^{\perp} \in C_{s}^{\perp}$ such that

$$
\alpha=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right) .
$$

Therefore

$$
\left(c_{1}, \ldots, c_{j}, \ldots, c_{s}\right) A=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right)
$$

or

$$
\left(r_{11} c_{1}+\cdots+r_{s 1} c_{s}, \ldots, r_{j j} c_{j}+\cdots+r_{s j} c_{s}, \ldots, r_{s s} c_{s}\right)=\left(c_{1}^{\perp}, \ldots, c_{j}^{\perp}, \ldots, c_{s}^{\perp}\right)
$$

Since $C_{1} \supset C_{2} \supset \cdots \supset C_{s}$ are linear codes, we obtain

$$
r_{11} c_{1}+\cdots+r_{s 1} c_{s}=c_{1}^{\prime} \in C_{1}, \quad \ldots, \quad r_{j j} c_{j}+\cdots+r_{s j} c_{s}=c_{j}^{\prime} \in C_{j}, \quad \ldots, \quad r_{s s} c_{s}=c_{s}^{\prime} \in C_{s}
$$

This implies that $0 \neq c_{j}^{\prime}=c_{j}^{\perp} \in C_{j} \cap C_{j}^{\perp}$. This is a contradiction.
$\Longleftarrow$ : Otherwise, we assume that $C_{j}$ is not an LCD code for some $1 \leq j \leq s$. Then there exits a nonzero codeword $c_{j}$ in $C_{j}$ such that $c_{j} \in C_{j}^{\perp}$.

Taking $\beta=\left(0, \ldots, 0, c_{j}, 0, \ldots, 0\right)$, then $\beta \neq 0$ and $\beta \in C^{\perp}$ by (3.2). Since A is an $s \times s$ non-singular matrix, linear equations over $\mathbb{F}_{q}$
have unique solution $x_{1}=v_{1}, x_{2}=v_{2}, \ldots, x_{j}=v_{j}$.
It is easy to check that $\beta=\left(v_{1} c_{j}, v_{2} c_{j}, \ldots, v_{j-1} c_{j}, v_{j} c_{j}, 0, \ldots, 0\right) A$. Hence, $\beta \in C$, i.e., $\beta \in C \cap C^{\perp}$, which is a contradiction.

Let $A=\left(a_{i j}\right)$ be an $s \times s$ matrix with entries in $\mathbb{F}_{l^{2}}$, we define $A^{(l)}=\left(a_{i j}^{l}\right)$. Similarly, We can prove the following two theorems.

Theorem 3.3. Let $C_{j} \subset \mathbb{F}_{l^{2}}^{n}$ be a linear code over $\mathbb{F}_{l^{2}}$ for $1 \leq i \leq s$, and let $C=$ $\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ where $A$ is an $s \times s$ matrix. If $A^{(l)} A^{T}$ is a diagonal square matrix where all the diagonal entries are non-zeros of $\mathbb{F}_{l^{2}}$. Then $C=\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is a Hermitian $L C D$ code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all Hermitian $L C D$ codes. In particular, if $\left[\left(A^{(l)}\right)^{-1}\right]^{T}=a A$, where $a \in \mathbb{F}_{l^{2}}^{*}$, then $\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is a Hermitian $L C D$ code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all Hermitian LCD codes.

Theorem 3.4. Assume that $A$ is an $s \times s$ non-singular lower-triangular matrix over $\mathbb{F}_{l^{2}}$. If $C_{1} \supset C_{2} \supset \cdots \supset C_{s}$ are linear codes over $\mathbb{F}_{l^{2}}$, then $C=\left[C_{1}, C_{2}, \ldots, C_{s}\right] A$ is a Hermitian $L C D$ code if and only if $C_{1}, C_{2}, \ldots, C_{s}$ are all Hermitian LCD codes.

In the following, we will prove the existence of an asymptotically good sequence of MPLCD codes by Theorem 3.1.

Theorem 3.5. MPLCD codes over $\mathbb{F}_{q}$ are asymptotically good.
Proof. It is well known that LCD codes over $\mathbb{F}_{q}$ are asymptotically good (See [3]). let $C_{1}, \ldots, C_{j}, \ldots$, be an asymptotically good sequence of LCD codes over $\mathbb{F}_{q}$, and let $C_{j}$ be an $\left[n_{j}, k_{j}, d_{j}\right]$ code over $\mathbb{F}_{q}$. We have two case.

Case 1. $q=p^{m}$ where $p$ is an odd prime. In the case, For each $j \geq 1$, we define the matrix-product code $M_{j}$ as

$$
M_{j}:=\left[C_{j}, C_{j}\right]\left(\begin{array}{cc}
1 & 1  \tag{3.3}\\
1 & p-1
\end{array}\right)
$$

Since $\left(\left(\begin{array}{cc}1 & 1 \\ 1 & p-1\end{array}\right)^{-1}\right)^{T}=\frac{1}{2}\left(\begin{array}{cc}1 & 1 \\ 1 & p-1\end{array}\right), M_{j}$ is an MPLCD code over $\mathbb{F}_{q}$ by Theorem 3.1. According to Lemma 2.2, $M_{j}$ is an $\left[2 n_{j}, 2 k_{j}, \geq d_{j}\right]_{q}$ MPLCD code over $\mathbb{F}_{q}$ respectively.

For the sequence of MPLCD codes $M_{1}, \ldots, M_{j}, \ldots$, the asymptotic rate is

$$
R_{1}=\lim _{j \rightarrow \infty} \frac{2 k_{j}}{2 n_{j}}=\lim _{j \rightarrow \infty} \frac{k_{j}}{n_{j}}
$$

and this quantity is positive since $C_{1}, \ldots, C_{j}, \ldots$, is asymptotically good. For the asymptotic distance, we have

$$
\delta_{1}=\lim _{j \rightarrow \infty} \frac{d\left(M_{j}\right)}{2 n_{j}} \geq \lim _{j \rightarrow \infty} \frac{d_{j}}{2 n_{j}}
$$

Note again that $\delta_{1}$ is positive since $C_{1}, \ldots, C_{j}, \ldots$, is asymptotically good. Proving the theorem in $p$ odd prime.

Case 2. $q=2^{m}$. In the case, For each $j \geq 1$, we define the matrix-product code $M_{j}$ as

$$
M_{j}:=\left[C_{j}, C_{j}\right]\left(\begin{array}{ll}
1 & 1  \tag{3.4}\\
0 & 1
\end{array}\right) .
$$

We first prove that if $C_{j}$ is an LCD code over $\mathbb{F}_{2^{m}}$ then $M_{j}$ is an MPLCD code over $\mathbb{F}_{2^{m}}$.
In fact, $\left(\left(\begin{array}{ll}1 & 1 \\ 0 & 1\end{array}\right)^{-1}\right)^{T}=\left(\begin{array}{ll}1 & 0 \\ 1 & 1\end{array}\right)$. Hence, we have

$$
M_{j}^{\perp}=\left[C_{j}^{\perp}, C_{j}^{\perp}\right]\left(\begin{array}{ll}
1 & 0 \\
1 & 1
\end{array}\right)
$$

Suppose that $\eta \in M_{j} \cap M_{j}^{\perp}$. Then there exist $c_{j}, c_{j}^{\prime} \in C_{j}$ and $c_{j}^{\perp},\left(c_{j}^{\prime}\right)^{\perp} \in C_{j}^{\perp}$ such that $\eta=\left(c_{j}, c_{j}+c_{j}^{\prime}\right)=\left(c_{j}^{\perp}+\left(c_{j}^{\prime}\right)^{\perp},\left(c_{j}^{\prime}\right)^{\perp}\right)$ by the definition of matrix-product code. This implies that $c_{j}=c_{j}^{\perp}+\left(c_{j}^{\prime}\right)^{\perp}$ and $c_{j}+c_{j}^{\prime}=\left(c_{j}^{\prime}\right)^{\perp}$. By $c_{j}=c_{j}^{\perp}+\left(c_{j}^{\prime}\right)^{\perp}$ and $C_{j}^{\perp}$ linearly, we have $c_{j} \in C_{j} \cap C_{j}^{\perp}=\{0\}$, i.e., $c_{j}=0$. On other hand, by $c_{j}=c_{j}^{\perp}+\left(c_{j}^{\prime}\right)^{\perp}$ and $c_{j}+c_{j}^{\prime}=\left(c_{j}^{\prime}\right)^{\perp}$, we obtain $c_{j}^{\prime}=c_{j}^{\perp} \in C_{j} \cap C_{j}^{\perp}=\{0\}$, i.e., $c_{j}^{\prime}=0$, which proves $\eta=0$. This means that $M_{j}$ is an MPLCD code over $\mathbb{F}_{2^{m}}$.

According to Lemma 2.3, $M_{j}$ is an $\left[2 n_{j}, 2 k_{j}, d_{j}\right]_{2^{m}}$ MPLCD code over $\mathbb{F}_{2^{m}}$ respectively.
For the sequence of MPLCD codes $M_{1}, \ldots, M_{j}, \ldots$, the asymptotic rate is

$$
R_{2}=\lim _{j \rightarrow \infty} \frac{2 k_{j}}{2 n_{j}}=\lim _{j \rightarrow \infty} \frac{k_{j}}{n_{j}}
$$

and this quantity is positive since $C_{1}, \ldots, C_{j}, \ldots$, is asymptotically good. For the asymptotic distance, we have

$$
\delta_{2}=\lim _{j \rightarrow \infty} \frac{d\left(M_{j}\right)}{2 n_{j}}=\lim _{j \rightarrow \infty} \frac{d_{j}}{2 n_{j}} .
$$

Note again that $\delta_{2}$ is positive since $C_{1}, \ldots, C_{j}, \ldots$, is asymptotically good. This proves the expected result.

Similarly, We can prove the following theorem by Theorem 3.3.
Theorem 3.6. Matrix-product Hermitian $L C D$ codes over $\mathbb{F}_{l^{2}}$ are asymptotically good.

## 4 Examples

In this section, we first construct a class of matrix $A=\left(a_{i j}\right)_{s \times s}$ whose satisfy $\left[\left(A^{(l)}\right)^{-1}\right]^{T}=s A$ (or $\left(A^{-1}\right)^{T}=s A$ ) over $\mathbb{F}_{l^{2}}\left(\right.$ or $\left.\mathbb{F}_{q}\right)$, then we will provide examples of LCD codes by Theorem $3.13 .2,3.3$, and 3.4.

For $\mathbb{F}_{l^{2}}$ with $l$ an odd prime power, let $G=\underbrace{G_{2} \times G_{2} \times \cdots \times G_{2}}_{r}$, be abelian group where $G_{2}=<a: a^{2}=1>$. Set $s=2 r$, and we assume that $s \mid\left(l^{2}-1\right)$. Let $\widehat{G}$ be the set of characters for $G$ with respect to $\mathbb{F}_{l^{2}}$. Then $\widehat{G}=\left\{\chi_{0}, \chi_{1}, \ldots, \chi_{s-1}\right\}$ where $\chi_{0}, \chi_{1}, \ldots, \chi_{s-1}$ are the irreducible characters of $G$. For any $g \in G$, it is easy to see that $\chi_{j}(g)^{2}=1$ for $j=0,1, \ldots, s-1$. Therefore, the character table of $G$ is

$$
A=\left(\begin{array}{cccc}
\chi_{0}\left(g_{0}\right) & \chi_{1}\left(g_{0}\right) & \cdots & \chi_{s-1}\left(g_{0}\right) \\
\chi_{0}\left(g_{1}\right) & \chi_{1}\left(g_{1}\right) & \cdots & \chi_{s-1}\left(g_{1}\right) \\
\vdots & \vdots & \cdots & \vdots \\
\chi_{0}\left(g_{s-1}\right) & \chi_{1}\left(g_{s-1}\right) & \cdots & \chi_{s-1}\left(g_{s-1}\right)
\end{array}\right)
$$

where $g_{0}, g_{1}, \ldots, g_{s-1} \in G$. Suppose that $l=2 t+1$ for some positive integer $t$ since $l$ is an odd number. Then

$$
\begin{aligned}
A^{(l)} & =\left(\begin{array}{cccc}
\left(\chi_{0}\left(g_{0}\right)\right)^{l} & \left(\chi_{1}\left(g_{0}\right)\right)^{l} & \cdots & \left(\chi_{s-1}\left(g_{0}\right)\right)^{l} \\
\left(\chi_{0}\left(g_{1}\right)\right)^{l} & \left(\chi_{1}\left(g_{1}\right)\right)^{l} & \cdots & \left(\chi_{s-1}\left(g_{1}\right)\right)^{l} \\
\vdots & \vdots & \cdots & \vdots \\
\left(\chi_{0}\left(g_{s-1}\right)\right)^{l} & \left(\chi_{1}\left(g_{s-1}\right)\right)^{l} & \cdots & \left(\chi_{s-1}\left(g_{s-1}\right)\right)^{l}
\end{array}\right) \\
& =\left(\begin{array}{cccc}
\left(\chi_{0}\left(g_{0}\right)\right)^{2 t+1} & \left(\chi_{1}\left(g_{0}\right)\right)^{2 t+1} & \cdots & \left(\chi_{s-1}\left(g_{0}\right)\right)^{2 t+1} \\
\left(\chi_{0}\left(g_{1}\right)\right)^{2 t+1} & \left(\chi_{1}\left(g_{1}\right)\right)^{2 t+1} & \cdots & \left(\chi_{s-1}\left(g_{1}\right)\right)^{2 t+1} \\
\vdots & \vdots & \cdots & \vdots \\
\left(\chi_{0}\left(g_{s-1}\right)\right)^{2 t+1} & \left(\chi_{1}\left(g_{s-1}\right)\right)^{2 t+1} & \cdots & \left(\chi_{s-1}\left(g_{s-1}\right)\right)^{2 t+1}
\end{array}\right) \\
& =\left(\begin{array}{cccc}
\chi_{0}\left(g_{0}\right) & \chi_{1}\left(g_{0}\right) & \cdots & \chi_{s-1}\left(g_{0}\right) \\
\chi_{0}\left(g_{1}\right) & \chi_{1}\left(g_{1}\right) & \cdots & \chi_{s-1}\left(g_{1}\right) \\
\vdots & \vdots & \cdots & \vdots \\
\chi_{0}\left(g_{s-1}\right) & \chi_{1}\left(g_{s-1}\right) & \cdots & \chi_{s-1}\left(g_{s-1}\right)
\end{array}\right)=A .
\end{aligned}
$$

It is well-known that $A$ is invertible, and we have

$$
\left(A^{(l)}\right)^{-1}=A^{-1}=\frac{1}{s}\left(\begin{array}{cccc}
\chi_{0}\left(g_{0}\right)^{-1} & \chi_{0}\left(g_{1}\right)^{-1} & \cdots & \chi_{0}\left(g_{s-1}\right)^{-1} \\
\chi_{1}\left(g_{0}\right)^{-1} & \chi_{1}\left(g_{1}\right)^{-1} & \cdots & \chi_{1}\left(g_{s-1}\right)^{-1} \\
\vdots & \vdots & \cdots & \vdots \\
\chi_{s-1}\left(g_{0}\right)^{-1} & \chi_{s-1}\left(g_{1}\right)^{-1} & \cdots & \chi_{s-1}\left(g_{s-1}\right)^{-1}
\end{array}\right)
$$

For any $g \in G, \chi_{j}(g)^{2}=1$, i.e., $\chi_{j}(g)^{-1}=\chi_{j}(g)$ for $j=0,1, \ldots, s-1$. This implies that $\left[\left(A^{(l)}\right)^{-1}\right]^{T}=\frac{1}{s} A$.

Remark 4.1. For $\mathbb{F}_{q}$, let $G=\underbrace{G_{2} \times G_{2} \times \cdots \times G_{2}}_{r}$, be abelian group where $G_{2}=<a: a^{2}=$ $1>$. Set $s=2 r$, we assume that $s \mid(q-1)$. Let $\widehat{G}$ be the set of characters for $G$ with respect to $\mathbb{F}_{q}$. Then $\widehat{G}=\left\{\chi_{0}, \chi_{1}, \ldots, \chi_{s-1}\right\}$ where $\chi_{0}, \chi_{1}, \ldots, \chi_{s-1}$ are the irreducible characters of $G$. Therefore, the character table of $G$ is

$$
A=\left(\begin{array}{cccc}
\chi_{0}\left(g_{0}\right) & \chi_{1}\left(g_{0}\right) & \cdots & \chi_{s-1}\left(g_{0}\right) \\
\chi_{0}\left(g_{1}\right) & \chi_{1}\left(g_{1}\right) & \cdots & \chi_{s-1}\left(g_{1}\right) \\
\vdots & \vdots & \cdots & \vdots \\
\chi_{0}\left(g_{s-1}\right) & \chi_{1}\left(g_{s-1}\right) & \cdots & \chi_{s-1}\left(g_{s-1}\right)
\end{array}\right) .
$$

where $g_{0}, g_{1}, \ldots, g_{s-1} \in G$. From above to see that $\left(A^{-1}\right)^{T}=\frac{1}{s} A$.
Now we would like to use matrix-product codes to construct LCD codes.

Corollary 4.2. Let $l^{2} \equiv 1 \bmod 4$ where $l$ is an odd prime power, and let $C_{1}, C_{2}, C_{3}, C_{4}$ be Hermitain $L C D$ codes over $\mathbb{F}_{l^{2}}$ with parameters $\left[n, k_{i}, d_{i}\right]_{l^{2}}$. Then there exists a Hermitian $L C D$ code over $\mathbb{F}_{l^{2}}$ with parameters $\left[4 n, k_{1}+k_{2}+k_{3}+k_{4}, \geq \min \left\{4 d_{1}, 2 d_{2}, 2 d_{3}, d_{4}\right\}\right]_{l^{2}}$.

Proof. Suppose that $G=G_{2} \times G_{2}=\left\{(1,1),(x, 1)(1, y),(x, y): x^{2}=y^{2}=1\right\}$. Then the character table of $G$ is

$$
A=\left(\begin{array}{cccc}
1 & 1 & 1 & 1 \\
1 & 1 & -1 & -1 \\
1 & -1 & 1 & -1 \\
1 & -1 & -1 & 1
\end{array}\right)
$$

By above construction of the matrix $A$, Theorem 3.3, and Lemma 2.3, we know that the matrix product code $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right] A$ is Hermitain LCD with parameters $\left[4 n, k_{1}+k_{2}+\right.$ $\left.k_{3}+k_{4}, \geq \min \left\{4 d_{1}, 2 d_{2}, 2 d_{3}, d_{4}\right\}\right]_{l^{2}}$.

Similarly, We have the following Corollary.
Corollary 4.3. Let $q \equiv 1 \bmod 4$, and let $C_{1}, C_{2}, C_{3}, C_{4}$ be LCD codes over $\mathbb{F}_{q}$ with parameters $\left[n, k_{i}, d_{i}\right]_{q}$. Then there exists a MPLCD code over $\mathbb{F}_{q}$ with parameters $\left[4 n, k_{1}+k_{2}+\right.$ $\left.k_{3}+k_{4}, \geq \min \left\{4 d_{1}, 2 d_{2}, 2 d_{3}, d_{4}\right\}\right]_{q}$.

Example 1. Let $p=5$. Then
$x^{12}-1=(x+1)(x+2)(x+3)(x+4)\left(x^{2}+x+1\right)\left(x^{2}+2 x+4\right)\left(x^{2}+3 x+4\right)\left(x^{2}+4 x+1\right)$,
is the factorization of $x^{12}-1$ into irreducible factors over $\mathbb{F}_{5}$. It follows from Proposition 2.6 that $C_{1}=C_{2}=C_{3}=\langle x+1\rangle$ and $C_{4}=\left\langle(x+1)\left(x^{2}+2 x+4\right)\left(x^{2}+3 x+4\right)\right\rangle$ are all LCD codes over $\mathbb{F}_{5}$ with parameters $[12,11,2]_{5}$ and $[12,7,4]_{5}$ respectively. By Corollary 4.3, matrix-product code $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 1 & 1 & -1 & -1 \\ 1 & -1 & 1 & -1 \\ 1 & -1 & -1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{5}$ with parameters $[48,40, \geq 4]_{5}$.

Example 2. Let $p=5$. Then

$$
x^{13}-1=(x+4)\left(x^{4}+x^{3}+4 x^{2}+x+1\right)\left(x^{4}+2 x^{3}+x^{2}+2 x+1\right)\left(x^{4}+3 x^{3}+3 x+1\right),
$$

is the factorization of $x^{13}-1$ into irreducible factors over $\mathbb{F}_{5}$. It follows from Proposition 2.6 that $C_{1}=\langle x+1\rangle, C_{2}=C_{3}=\left\langle x^{4}+x^{3}+4 x^{2}+x+1\right\rangle$ and $C_{4}=\left\langle(x+4)\left(x^{4}+\right.\right.$ $\left.\left.x^{3}+4 x^{2}+x+1\right)\left(x^{4}+2 x^{3}+x^{2}+2 x+1\right)\right\rangle$ are all LCD codes over $\mathbb{F}_{5}$ with parameters $[13,12,2]_{5},[13,9,4]_{5}$ and $[13,4,8]_{5}$ respectively. By Corollary 4.3, matrix-product code $C=$ $\left[C_{1}, C_{2}, C_{3}, C_{4}\right]\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 1 & 1 & -1 & -1 \\ 1 & -1 & 1 & -1 \\ 1 & -1 & -1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{5}$ with parameters $[52,34, \geq 8]_{5}$.

Example 3. Let $p=5$. Then

$$
x^{18}-1=(x+1)(x+4)\left(x^{2}+x+1\right)\left(x^{2}+4 x+1\right)\left(x^{6}+x^{3}+1\right)\left(x^{6}+4 x^{3}+1\right),
$$

is the factorization of $x^{18}-1$ into irreducible factors over $\mathbb{F}_{5}$. It follows from Proposition 2.6 that $C_{1}=\langle x+1\rangle, C_{2}=C_{3}=\left\langle(x+1)\left(x^{6}+x^{3}+1\right)\right\rangle$ and $C_{4}=\left\langle\left(x^{2}+x+\right.\right.$ 1) $\left.\left(x^{2}+4 x+1\right)\left(x^{6}+x^{3}+1\right)\left(x^{6}+4 x^{3}+1\right)\right\rangle$ are all LCD codes over $\mathbb{F}_{5}$ with parameters $[18,17,2]_{5},[18,11,4]_{5}$ and $[18,2,9]_{5}$ respectively. By Corollary 4.3, matrix-product code $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 1 & 1 & -1 & -1 \\ 1 & -1 & 1 & -1 \\ 1 & -1 & -1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{5}$ with parameters $[72,41, \geq 8]_{5}$.

Example 4. Let $p=13$. Then

$$
x^{10}-1=(x+1)(x+12)\left(x^{4}+12 x^{3}+x^{2}+12 x+1\right)\left(x^{4}+x^{3}+x^{2}+x+1\right)
$$

is the factorization of $x^{10}-1$ into irreducible factors over $\mathbb{F}_{13}$. It follows from Proposition 2.6 that $C_{1}=\left\langle\left(x^{4}+x^{3}+x^{2}+x+1\right)\right\rangle, C_{2}=C_{3}=\left\langle\left(x^{4}+12 x^{3}+x^{2}+12 x+1\right)\left(x^{4}+\right.\right.$ $\left.\left.x^{3}+x^{2}+x+1\right)\right\rangle$ and $C_{4}=\left\langle(x+1)\left(x^{4}+12 x^{3}+x^{2}+12 x+1\right)\left(x^{4}+x^{3}+x^{2}+x+1\right)\right\rangle$ are all LCD codes over $\mathbb{F}_{13}$ with parameters $[10,6,2]_{13},[10,2,5]_{13}$ and $[10,1,10]_{13}$ respectively. By Corollary 4.3, matrix-product code $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 1 & 1 & -1 & -1 \\ 1 & -1 & 1 & -1 \\ 1 & -1 & -1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{13}$ with parameters $[40,11, \geq 8]_{13}$, and by Theorem 3,2, matrix-product code $C=\left[C_{1}, C_{2}, C_{2}, C_{4}\right]\left(\begin{array}{cccc}1 & 0 & 0 & 0 \\ 1 & 1 & 0 & 0 \\ 1 & 1 & 1 & 0 \\ 1 & 1 & 1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{13}$ with parameters $[40,11, \geq 2]_{13}$

Example 5. Let $p=5^{2}$, $\omega$ is a 25 -th primitive root of unity. Then

$$
\begin{aligned}
x^{17}-1= & (x+4)\left(x^{8}+w^{4} x^{7}+w^{21} x^{6}+w^{7} x^{5}+w^{13} x^{4}+w^{7} x^{3}+w^{21} x^{2}+w^{4} x+1\right) \\
& \left(x^{8}+w^{20} x^{7}+w^{9} x^{6}+w^{11} x^{5}+w^{17} x^{4}+w^{11} x^{3}+w^{9} x^{2}+w^{20}+1\right) .
\end{aligned}
$$

is the factorization of $x^{17}-1$ into irreducible factors over $\mathbb{F}_{5^{2}}$. It follows from Proposition 2.9 that $C_{1}=\left\langle x^{8}+w^{4} x^{7}+w^{21} x^{6}+w^{7} x^{5}+w^{13} x^{4}+w^{7} x^{3}+w^{21} x^{2}+w^{4} x+1\right\rangle, C_{2}=C_{3}=\left\langle(x+4)\left(x^{8}+\right.\right.$ $\left.\left.w^{4} x^{7}+w^{21} x^{6}+w^{7} x^{5}+w^{13} x^{4}+w^{7} x^{3}+w^{21} x^{2}+w^{4} x+1\right)\right\rangle$ and $C_{4}=\left\langle\left(x^{8}+w^{4} x^{7}+w^{21} x^{6}+w^{7} x^{5}+\right.\right.$ $\left.\left.w^{13} x^{4}+w^{7} x^{3}+w^{21} x^{2}+w^{4} x+1\right)\left(x^{8}+w^{20} x^{7}+w^{9} x^{6}+w^{11} x^{5}+w^{17} x^{4}+w^{11} x^{3}+w^{9} x^{2}+w^{20}+1\right)\right\rangle$
are all Hermitain LCD codes over $\mathbb{F}_{5^{2}}$ with parameters $[17,9,9]_{5^{2}},[17,8,10]_{5^{2}}$ and $[17,1,17]_{5^{2}}$ respectively. By Corollary 4.3, matrix-product code $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]\left(\begin{array}{cccc}1 & 1 & 1 & 1 \\ 1 & 1 & -1 & -1 \\ 1 & -1 & 1 & -1 \\ 1 & -1 & -1 & 1\end{array}\right)$ is a Hermitain $L C D$ code over $\mathbb{F}_{5^{2}}$ with parameters $[68,26, \geq 17]_{5^{2}}$, and by Theorem 3,4, matrix-product code $C=\left[C_{1}, C_{1}, C_{2}, C_{2}\right]\left(\begin{array}{cccc}1 & 0 & 0 & 0 \\ 1 & 1 & 0 & 0 \\ 1 & 1 & 1 & 0 \\ 1 & 1 & 1 & 1\end{array}\right)$ is a Hermitain LCD code over $\mathbb{F}_{5^{2}}$ with parameters $[68,34, \geq 9]_{5^{2}}$.

Theorem 4.4. Let $C_{1}$ and $C_{2}$ be $L C D$ codes over $\mathbb{F}_{2}$ with parameters $\left[n, k_{1}, d_{1}\right]_{2}$ and $\left[n, k_{2}, d_{2}\right]_{2}$ respectively. If $A=\left(\begin{array}{lll}1 & 0 & 1 \\ 1 & 1 & 0 \\ 1 & 1 & 1\end{array}\right)$, then matrix-product code $C=\left[C_{1}, C_{1}, C_{2}\right] A$ is MPLCD over $\mathbb{F}_{2}$ with parameters $\left[3 n, 2 k_{1}+k_{2}, \geq \min \left\{2 d_{1}, d_{2}\right\}\right]_{2}$.

Proof. Since $A=\left(\begin{array}{lll}1 & 0 & 1 \\ 1 & 1 & 0 \\ 1 & 1 & 1\end{array}\right)$, we have $\left(A^{-1}\right)^{T}=\left(\begin{array}{lll}1 & 1 & 0 \\ 1 & 0 & 1 \\ 1 & 1 & 1\end{array}\right)$. Hence,

$$
C^{\perp}=\left[C_{1}^{\perp}, C_{1}^{\perp}, C_{2}^{\perp}\right]\left(\begin{array}{ccc}
1 & 1 & 0 \\
1 & 0 & 1 \\
1 & 1 & 1
\end{array}\right)
$$

Suppose that $\eta \in C \cap C^{\perp}$. Then there exist $c_{1}, c_{1}^{\prime} \in C_{1}, c_{2} \in C_{2}$ and $c_{1}^{\perp},\left(c_{1}^{\prime}\right)^{\perp} \in C_{1}^{\perp}, c_{2}^{\perp} \in$ $C_{2}^{\perp}$ such that $\left(c_{1}+c_{1}^{\prime}+c_{2}, c_{1}^{\prime}+c_{2}, c_{1}+c_{2}\right)=\left(c_{1}^{\perp}+\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp}, c_{1}^{\perp}+c_{2}^{\perp},\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp}\right)$ by the definition of matrix-product code. This implies that

$$
\begin{aligned}
& c_{1}+c_{1}^{\prime}+c_{2}=c_{1}^{\perp}+\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp} \\
& c_{1}^{\prime}+c_{2}=c_{1}^{\perp}+c_{2}^{\perp} \\
& c_{1}+c_{2}=\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp} .
\end{aligned}
$$

By $c_{1}^{\prime}+c_{2}=c_{1}^{\perp}+c_{2}^{\perp}, c_{1}+c_{2}=\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp}$, and $C_{1}, C_{1}^{\perp}$ linearly, we have $c_{1}-c_{1}^{\prime}=\left(c_{1}^{\prime}\right)^{\perp}+c_{1}^{\perp} \in$ $C_{1} \cap C_{1}^{\perp}=\{0\}$, i.e., $c_{1}=c_{1}^{\prime}$, $\left(c_{1}^{\prime}\right)^{\perp}=c_{1}^{\perp}$. On other hand, by $c_{1}+c_{1}^{\prime}+c_{2}=c_{1}^{\perp}+\left(c_{1}^{\prime}\right)^{\perp}+c_{2}^{\perp}$, we obtain $c_{2}=c_{2}^{\perp} \in C_{2} \cap C_{2}^{\perp}=\{0\}$, i.e., $c_{2}=c_{2}^{\perp}=0$, which prove $c_{1}=c_{1}^{\prime}=0$. Therefore, $\eta=0$. This means that $C$ is a matrix-product LCD code over $\mathbb{F}_{2}$.

Example 6. Let $p=2$. Then

$$
x^{10}-1=(x+1)^{2}\left(x^{4}+x^{3}+x^{2}+x+1\right)^{2} .
$$

is the factorization of $x^{10}-1$ into irreducible factors over $\mathbb{F}_{2}$. It follows from Proposition 2.7 that $C_{1}=\left\langle(x+1)^{2}\right\rangle, C_{2}=\left\langle\left(x^{4}+x^{3}+x^{2}+x+1\right)^{2}\right\rangle$ are $L C D$ codes over $\mathbb{F}_{2}$ with parameters $[10,8,2]_{2}$ and $[10,2,5]_{2}$ respectively. By Theorem 4.4, matrix-product code $C=$ $\left[C_{1}, C_{1}, C_{2}\right]\left(\begin{array}{lll}1 & 0 & 1 \\ 1 & 1 & 0 \\ 1 & 1 & 1\end{array}\right)$ is an LCD code over $\mathbb{F}_{2}$ with parameters $[30,18, \geq 4]_{2}$.

## 5 Conclusion

We have developed new methods of constructing LCD codes from matrix-product codes over finite field $\mathbb{F}_{q}$. Using those methods, we have constructed good LCD codes. We believe that matrix-product codes over finite field $\mathbb{F}_{q}$ will be a good source for constructing good LCD codes. In a future work, we will use the computer algebra system MAGMA to find more good LCD codes.
