# Uniqueness Theorems for Subharmonic and Holomorphic Functions of Several Variables on a Domain

#### Abstract

We establish a general uniqueness theorem for subharmonic functions of several variables on a domain. A corollary from this uniqueness theorem for holomorphic functions is formulated in terms of the zero subset of holomorphic functions and restrictions on the growth of functions near the boundary of domain.

## 1. Introduction

### 1.1. Definitions and notations

We use an information and definitions from [1]-[5]. As usual, $\mathbb{N}:=\{1,2, \ldots\}, \mathbb{R}$ and $\mathbb{C}$ are the sets of all natural, real and complex numbers, resp. We set

\mathbb{R}^{+}:=\{x \in \mathbb{R}: x \geqslant 0\}, \mathbb{R}_{-\infty}:=\{-\infty\} \cup \mathbb{R}, \mathbb{R}_{+\infty}:=\mathbb{R} \cup\{+\infty\}, \mathbb{R}_{ \pm \infty}:=\mathbb{R}_{-\infty} \cup \mathbb{R}_{+\infty}, \tag{1}
\end{equation*}
$$

where the usual order relation $\leqslant$ on $\mathbb{R}$ is complemented by the inequalities $-\infty \leqslant x \leqslant+\infty$ for all $x \in \mathbb{R}_{ \pm \infty}$. Let $f: X \rightarrow Y$ be a function. Given $S \subset X$, we denote by $\left.f\right|_{S}$ the restriction of $f$ to $S$. For $Y \subset \mathbb{R}_{ \pm \infty}, g: X \rightarrow \mathbb{R}_{ \pm \infty}$ and $S \subset X$, we write " $f \leqslant g$ on $S$ " if $f(x) \leqslant g(x)$ for all $x \in S$.

Let $m \in \mathbb{N}$. Denote by $\mathbb{R}^{m}$ the $m$-dimensional Euclidian real space. Then $\mathbb{R}_{\infty}^{m}:=$ $\mathbb{R}^{m} \cup\{\infty\}$ is the Alexandroff ( $\Leftrightarrow$ one-point) compactification of $\mathbb{R}^{m}$. Given a subset $S$ of $\mathbb{R}^{m}$ (or $\mathbb{R}_{\infty}^{m}$ ), the closure clos $S$, the interior int $S$ and the boundary $\partial S$ will always be taken relative $\mathbb{R}_{\infty}^{m}$. Let $S_{0} \subset S \subset \mathbb{R}_{\infty}^{m}$. If the closure clos $S_{0}$ is a compact subset of $S$ in the topology induced on $S$ from $\mathbb{R}_{\infty}^{m}$, then the set $S_{0}$ is a relatively compact subset of $S$, and we write $S_{0} \Subset S$.

Let $n \in \mathbb{N}$. Denote by $\mathbb{C}^{n}$ the $n$-dimensional Euclidian complex space. Then $\mathbb{C}_{\infty}^{n}:=$ $\mathbb{C}^{n} \cup\{\infty\}$ is the Alexandroff ( $\Leftrightarrow$ one-point) compactification of $\mathbb{C}^{n}$. If it is necessary, we

[^0]identify $\mathbb{C}^{n}\left(\right.$ or $\left.\mathbb{C}_{\infty}^{n}\right)$ with $\mathbb{R}^{2 n}\left(\right.$ or $\left.\mathbb{R}_{\infty}^{2 n}\right)$. Given a subset $S$ of $\mathbb{C}^{n}$ (or $\mathbb{C}_{\infty}^{n}$ ), its closure $\operatorname{clos} S$ and its boundary $\partial S$ will always be taken relative to $\mathbb{C}_{\infty}^{n}$.

Let $A, B$ are sets, and $A \subset B$. The set $A$ is a non-trivial subset of the set $B$ if the subset $A \subset B$ is non-empty $(A \neq \varnothing)$ and $\operatorname{proper}(A \neq B)$.

We understand always the "positivity" or "positive" as $\geqslant 0$, where the symbol 0 denotes the number zero, the zero function, the zero measure, etc. So, a function $f: X \rightarrow R \stackrel{(1)}{\subset}$ $\mathbb{R}_{ \pm \infty}$ is positive on $X$ if $f(x) \geqslant 0$ for all $x \in X$. In such case we write " $f \geqslant 0$ on $X$ ".

The class of all Borel real measures on local compact space $X$ is denoted by $\mathcal{M}(X)$, $\mathcal{M}_{\mathrm{c}}(X)$ is the subclass of all Borel measures $\mu$ on $X$ with compact support supp $\mu \subset X$, and $\mathcal{M}^{+}(X) \subset \mathcal{M}(X)$ is the subclass of all Borel positive measures on $X, \mathcal{M}_{\mathrm{c}}^{+}(X):=$ $\mathcal{M}^{+}(X) \cap \mathcal{M}_{\mathrm{c}}(X)$. Given $\mu \in \mathcal{M}(X)$ and $S \subset X$, we denote by $\left.\mu\right|_{S}$ the restriction of $\nu$ to $S$. For $\nu \in \mathcal{M}(X)$, we write " $\nu \geqslant \mu$ on $S$ " if $\left(\left.\nu\right|_{S}-\left.\mu\right|_{S}\right) \in \mathcal{M}^{+}(S)$.

Let $\mathcal{O}$ be a non-trivial open subset of $\mathbb{R}_{\infty}^{m}$. We denote by $\operatorname{sbh}(\mathcal{O})$ the class of all subharmonic functions $u: \mathcal{O} \rightarrow \mathbb{R}_{-\infty}$ on $\mathcal{O}$ for $m \geqslant 2$, and all (local) convex functions $u: \mathcal{O} \rightarrow \mathbb{R}_{-\infty}$ on $\mathcal{O}$ for $m=1$. The class $\operatorname{sbh}(\mathcal{O})$ contains the function $-\infty: x \mapsto-\infty$, $x \in \mathcal{O}$ (identical to $-\infty) ; \operatorname{sbh}^{+}(\mathcal{O}):=\{u \in \operatorname{sbh}(\mathcal{O}): u \geqslant 0$ on $\mathcal{O}\}$. We set $\operatorname{sbh}_{*}(\mathcal{O}):=$ $\operatorname{sbh}(\mathcal{O}) \backslash\{-\infty\}$. For $u \in \operatorname{sbh}_{*}(\mathcal{O})$, the Riesz measure of $u$ is the Borel positive measure

\nu_{u}:=c_{m} \Delta u \in \mathcal{M}^{+}(\mathcal{O}), \quad c_{m}:=\frac{\Gamma(m / 2)}{2 \pi^{m / 2} \max \{1,(m-2)\}} \tag{2}
\end{equation*}
$$

where $\Delta$ is the Laplace operator acting in the sense of distribution theory, and $\Gamma$ is the gamma function. Such measures $\nu_{u}$ is Radon measures, i. e. $\nu_{u}(S)<+\infty$ for each subset $S \Subset \mathcal{O}$. By definition, $\nu_{-\infty}(S):=+\infty$ for all $S \subset \mathcal{O}$.

Let $\mathcal{O}$ be a non-trivial open subset of $\mathbb{C}_{\infty}^{n}$. We denote by $\operatorname{Hol}(\mathcal{O})$ and $\operatorname{sbh}(\mathcal{O})$ the class of holomorphic and subharmonic functions on $\mathcal{O}$, resp. For $u \in \operatorname{sbh}_{*}(\mathcal{O})$, the Riesz measure of $u$ is the Borel (and Radon) positive measure

\nu_{u}:=c_{2 n} \Delta u \in \mathcal{M}^{+}(\mathcal{O}), \quad c_{2 n}=\frac{(n-1)!}{2 \pi^{n} \max \{1,2 n-2\}}
$$

### 1.2. Main Theorem and Corollary

Definition 1. Let $D$ be a non-trivial open connected subset of $\mathbb{R}_{\infty}^{m}$, i. e. $D$ is a non-trivial domain in $\mathbb{R}_{\infty}^{m}$. Let $K$ be a non-trivial compact subset of $D$, i. e. $\varnothing \neq K=\operatorname{clos} K \subset D$. $A$ function $v \in \operatorname{sbh}^{+}(D \backslash K)$ is called a test function for $D$ outside of $K$ if

\begin{equation*}
\lim _{D \ni x^{\prime} \rightarrow x} v\left(x^{\prime}\right)=0 \quad \text { for each } x \in \partial D \quad \text { and } \quad \sup _{x \in D \backslash K} v(x)<+\infty \tag{3}
\end{equation*}
$$

The class of all such test functions for $D$ outside of $K$ is denoted by $\operatorname{sbh}_{0}^{+}(D \backslash K)$.
Our main result for subharmonic functions is the following

Theorem 1 (see [6, Corollary 1.1] for the case $m=2$ ). Let $D$ be a non-trivial domain in $\mathbb{R}_{\infty}^{m}, K$ a compact subset of $D$ with non-empty interior int $K \neq \varnothing$. Let $M \in \operatorname{sbh}_{*}(D)$ be a function with the Riesz measure $\nu_{M} \in \mathcal{M}^{+}(D), v \in \operatorname{sbh}_{0}^{+}(D \backslash K)$ a test function for $D$ outside of $K$. Assume that

$$
\begin{equation*}
\int_{D \backslash K} v \mathrm{~d} \nu_{M}<+\infty \tag{4}
\end{equation*}
$$

If $u \in \operatorname{sbh}(D)$ is a function with the Riesz measure $\nu_{u} \in \mathcal{M}^{+}(D)$ such that

$$
\begin{align*}
\nu_{u} & \geqslant \nu \in \mathcal{M}^{+}(D \backslash K) \text { on } D \backslash K  \tag{5a}\\
\int_{D \backslash K} v \mathrm{~d} \nu & =+\infty,  \tag{5b}\\
u & \leqslant M+\text { const on } D, \tag{5c}
\end{align*}
$$

where const is a constant, then $u=-\infty$.
We denote by $\sigma_{2 n-2}$ the ( $2 n-2$ )-dimensional surface ( $\Leftrightarrow$ Hausdorff) measure on $\mathbb{C}^{n}$ and its restrictions to subsets of $\mathbb{C}^{n}$. So, if $n=1$, i. e. $2 n-2=0$, then $\sigma_{0}(S)=\sum_{z \in S} 1$ for each $S \subset \mathbb{C}$, i. e. $\sigma_{0}(S)$ is equal to the number of points in the set $S \subset \mathbb{C}$.

Below we identify $\mathbb{C}^{n}$ (or $\mathbb{C}_{\infty}^{n}$ ) with $\mathbb{R}^{m}\left(\right.$ or $\left.\mathbb{R}_{\infty}^{m}\right)$ where $m=2 n$.
Our main result for holomorphic functions is the following
Corollary 1. Let all conditions of Theorem 1 are fulfilled including (4). Let $f \in \operatorname{Hol}(D)$ be a holomorphic function on $D$ and $\operatorname{Zero}_{f}:=\{z \in D: f(z)=0\}$. If

\begin{align*}
\mathrm{Z} & \subset(D \backslash K) \cap \mathrm{Zero}_{f}  \tag{6a}\\
\int_{\mathrm{Z}} v \mathrm{~d} \sigma_{2 n-2} & =+\infty  \tag{6b}\\
|f| & \leqslant \operatorname{const} e^{M} \text { on } D \tag{6c}
\end{align*}
$$

where const is a constant, then $f \equiv 0$ on $D$, i. e. Zero $_{f}=D$.
Proof. Under the conditions of Corollary 1, suppose that $f \neq 0$. Then we have $\log |f| \in \operatorname{sbh}_{*}(D)$ with the Riesz measure $\nu_{\log |f|} \in \mathcal{M}^{+}(D)$. Let $n_{f}: D \rightarrow\{0\} \cup \mathbb{N}$ be the multiplicity function of $f[8,4]$. It is known that supp $n_{f}=$ Zero $_{f}$. By the classical Poincaré - Lelong formula [9] we have $n_{f} \mathrm{~d} \sigma_{2 n-2}=\mathrm{d} \nu_{\log |f|}$ on $D$. Hence, if the condition (6a) is fulfilled then we get

\int_{\mathrm{Z}} v \mathrm{~d} \sigma_{2 n-2} \stackrel{(6 \mathrm{a})}{\leqslant} \int v n_{f} \mathrm{~d} \sigma_{2 n-2} \leqslant \int v \mathrm{~d} \nu_{\log |f|} \tag{7}
\end{equation*}
$$

If the condition (6c) is also fulfilled, then for $u:=\log |f|$ we have (5c) together with (5a) for $\nu=\nu_{u}=\nu_{\log |f|}$. Since $u \neq-\infty$, by Theorem 1 we obtain the negation of the equality (5b). Therefore we get

\int_{\mathrm{Z}} v \mathrm{~d} \sigma_{2 n-2} \stackrel{(7)}{\leqslant} \int v \mathrm{~d} \nu_{\log |f|}=\int v \mathrm{~d} \nu_{u}<+\infty
$$

what contradicts (6b). Corollary 1 is proved.

## 2. Main results

### 2.1. Gluing Theorem for $m \in \mathbb{N}$

The next result shows how two subharmonic functions can be glued together.
Theorem 2 (see [4, Corollary 2.4.5], and [2, Theorem 2.4.5] for $m=2$ ). Let $\mathcal{O}, O_{0}$ are open sets in $\mathbb{R}_{\infty}^{m}$, and $\mathcal{O} \subset \mathcal{O}_{0}$. Let $v_{0} \in \operatorname{sbh}\left(\mathcal{O}_{0}\right)$, and $v \in \operatorname{sbh}(\mathcal{O})$. If

$$
\begin{equation*}
\limsup _{\mathcal{O} \ni x^{\prime} \rightarrow x} v\left(x^{\prime}\right) \leqslant v_{0}(x) \quad \text { for all points } x \in \mathcal{O}_{0} \cap \partial \mathcal{O}, \tag{8}
\end{equation*}
$$

then the function

$$
\widetilde{v}:= \begin{cases}\max \left\{v, v_{0}\right\} & \text { on } \mathcal{O},  \tag{9}\\ v_{0} & \text { on } \mathcal{O}_{0} \backslash \mathcal{O},\end{cases}
$$

belong to the class $\operatorname{sbh}\left(\mathcal{O}_{0}\right)$.
Remark 1. A similar gluing theorem true also for classes of plurisubharmonic functions [4, Corollary 2.9.5].

### 2.2. Jensen measures and potentials

Let $m \in \mathbb{N}$. Given $t \in \mathbb{R}_{*}:=\mathbb{R} \backslash\{0\}$, we set

h_{m}(t):= \begin{cases}|t| & \text { for } m=1, \\ \log |t| & \text { for } m=2, \\ -\frac{1}{|t|^{m-2}} & \text { for } m \geqslant 3\end{cases}
$$

For simplicity, we consider only domains $D$ in $\mathbb{R}^{m} \subset \mathbb{R}_{\infty}^{m}$, i. e. $\infty \notin D$.
Definition 2 ([10]-[14]). Let $D \subset \mathbb{R}^{m}$ be a subdomain, $x_{0} \in D$. A measure $\mu \in \mathcal{M}_{\mathrm{c}}^{+}(D)$ is called the Jensen measure for $\operatorname{sbh}(D)$ at $x_{0} \in D$ if

$$
u\left(x_{0}\right) \leqslant \int u \mathrm{~d} \mu \quad \text { for all } u \in \operatorname{sbh}(D)
$$

By $J_{x_{0}}(D)$ we denote the class of all Jensen measures for $D$ at $x_{0}$. Each Jensen measure $\mu \in J_{x_{0}}(D)$ is a probability measure, i.e. $\mu(D)=1$.

For $\mu \in J_{x_{0}}(D)$ we shall say that the function

$$
\begin{equation*}
V_{\mu}(x):=\int h_{m}(x-y) \mathrm{d} \mu(y)-h_{m}\left(x-x_{0}\right), \quad x \in \mathbb{R}_{\infty}^{m} \backslash\left\{x_{0}\right\}, \tag{10}
\end{equation*}
$$

is a potential of the Jensen measure $\mu \in J_{0}(D)$.
A function $V \in \operatorname{sbh}^{+}\left(\mathbb{R}_{\infty}^{m} \backslash\left\{x_{0}\right\}\right)$ is called the Jensen potential inside of $D$ with pole at $x_{0} \in D$ if the following two conditions hold:
(i) there is a compact subset $K_{V} \subset D$ such that $V \equiv 0$ on $\mathbb{R}_{\infty}^{m} \backslash K_{V}$ (finiteness),
(ii) and $\limsup _{x_{0} \neq x \rightarrow x_{0}} \frac{V(x)}{\left|h_{m}\left(x-x_{0}\right)\right|} \leqslant 1$ (semi-normalization at $x_{0}$ ).

By $P J_{x_{0}}(D)$ we denote the class of all Jensen potentials inside of $D$ with pole at $x_{0} \in D$.
We present interrelations between Jensen measures and potentials. The first is
Proposition 1 ([14, Proposition 1.4, Duality Theorem]). The map

$$
\begin{equation*}
\mathcal{P}: J_{x_{0}}(D) \rightarrow P J_{x_{0}}(D), \quad \mathcal{P}(\mu) \stackrel{(10)}{=} V_{\mu}, \quad \mu \in J_{z_{0}}(D), \tag{11}
\end{equation*}
$$

is the bijection from $J_{x_{0}}(D)$ to $P J_{x_{0}}(D)$ such that $\mathcal{P}\left(t \mu_{1}+(1-t) \mu_{2}\right)=t \mathcal{P}\left(\mu_{1}\right)+(1-t) \mathcal{P}\left(\mu_{2}\right)$ for all $t \in[0,1]$ and for all $\mu_{1}, \mu_{2} \in J_{x_{0}}(D)$. Besides,

$$
\begin{equation*}
\left.\mathcal{P}^{-1}(V) \stackrel{(2)}{=} c_{m} \Delta V\right|_{D \backslash\left\{x_{0}\right\}}+\left(1-\limsup _{x_{0} \neq x \rightarrow x_{0}} \frac{V(x)}{\left|h_{m}\left(x-x_{0}\right)\right|}\right) \cdot \delta_{x_{0}}, \quad V \in P J_{x_{0}}(D), \tag{12}
\end{equation*}
$$

where $\delta_{x_{0}}$ is the Dirac measure at the point $x_{0}$, i. e. $\operatorname{supp} \delta_{x_{0}}=\left\{x_{0}\right\}$ and $\delta_{x_{0}}\left(\left\{x_{0}\right\}\right)=1$.
The second is a generalized Poisson-Jensen formula.
Proposition 2 ([14, Proposition 1.2]). Let $\mu \in J_{x_{0}}(D)$. For each function $u \in \operatorname{sbh}(D)$ with $u\left(x_{0}\right) \neq-\infty$ and the Riesz measure $\nu_{u} \in \mathcal{M}^{+}(D)$ we have the equality

$$
\begin{equation*}
u\left(x_{0}\right)+\int_{D \backslash\left\{x_{0}\right\}} V_{\mu} d \nu_{u}=\int_{D} u d \mu \tag{13}
\end{equation*}
$$

Given $x \in \mathbb{R}^{m}$ and $r \stackrel{(1)}{\in} \mathbb{R}^{+}$, we set $B(x, r):=\left\{x^{\prime} \in \mathbb{R}^{m}:\left|x^{\prime}-x\right|<r\right\}$, where $|\cdot|$ is the Euclidean norm on $\mathbb{R}^{m} ; B_{*}(x, r):=B(x, r) \backslash\{x\} ; \bar{B}(x, r):=\operatorname{clos} B(x, r)$.

By $\operatorname{har}(\mathcal{O})$ denote the class of all harmonic functions on an open subset $\mathcal{O} \subset \mathbb{R}^{m}$.
Corollary 2. Let $D$ be a domain in $\mathbb{R}^{m}, x_{0} \in D, r_{0}>0$, and $B\left(x_{0}, r_{0}\right) \Subset D ; b \in \mathbb{R}^{+}$. If functions $u \in \operatorname{sbh}_{*}(D)$ with the Riesz measure $\nu_{u}$ and $M \in \operatorname{sbh}_{*}(D)$ with the Riesz measure $\nu_{M}$ satisfy the inequality

$$
\begin{equation*}
u \leqslant M+\text { const } \text { on } D, \tag{14}
\end{equation*}
$$

then there is a constant $C \in \mathbb{R}$ such that

$$
\begin{equation*}
\int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{u} \leqslant \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M}+C \tag{15}
\end{equation*}
$$

for all functions $V \in P J_{x_{0}}(D)$ satisfying the following three conditions:

\begin{align*}
&\left.V\right|_{B_{*}\left(x_{0}, r_{0}\right)} \in \operatorname{har}\left(B_{*}\left(x_{0}, r_{0}\right)\right), \\
& \limsup _{x_{0} \neq x \rightarrow x_{0}} \frac{V(x)}{\left|h_{m}\left(x-x_{0}\right)\right|} \stackrel{(\text { ii })}{=} 1 \quad\left(\text { normalization at } x_{0}\right), \\
& \sup _{x \in \partial B\left(x_{0}, r_{0}\right)} V(x) \leqslant b . \tag{16}
\end{align*}
$$

Proof. The technique of balayage out from the ball $B\left(x_{0}, r_{0}\right)$ gives two functions $u_{0} \in \operatorname{sbh}_{*}(D)$ with the Riesz measure $\nu_{u_{0}}$ and $M_{0} \in \operatorname{sbh}_{*}(D)$ with the Riesz measure $\nu_{M_{0}}$ such that

\begin{align*}
&\left.u_{0}\right|_{B\left(x_{0}, r_{0}\right)} \in \operatorname{har}\left(B\left(x_{0}, r_{0}\right)\right), u_{0}=u \text { on } D \backslash B\left(x_{0}, r_{0}\right),  \tag{17u}\\
&\left.M_{0}\right|_{B\left(x_{0}, r_{0}\right)} \in \operatorname{har}\left(B\left(x_{0}, r_{0}\right)\right), M_{0}=M \text { on } D \backslash B\left(x_{0}, r_{0}\right), \\
& u_{0} \stackrel{(14)}{\leqslant} M_{0}+C_{0} \quad \text { on } D \quad \text { where } C_{0} \in \mathbb{R}^{+} \text {is a constant, }  \tag{17b}\\
& \operatorname{supp} \nu_{M_{0}} \subset D \backslash B\left(x_{0}, r_{0}\right), \nu_{M_{0}}\left(\partial B\left(x_{0}, r_{0}\right)\right)=\nu_{M}\left(\bar{B}\left(x_{0}, r_{0}\right)\right)  \tag{17n}\\
&\left.\nu_{M_{0}}\right|_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)}=\left.\quad \nu_{M}\right|_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} . \tag{17r}
\end{align*}
$$

By Proposition 1 the measure $\mu \stackrel{(12)}{=} \mathcal{P}^{-1}(V) \stackrel{(11)}{\in} J_{x_{0}}(D)$ satisfies the following conditions: $\operatorname{supp} \mu \stackrel{(16)}{\subset} D \backslash B\left(x_{0}, r_{0}\right), \mu(D)=1$. The inequality (17b) entails the inequality

\int u_{0} \mathrm{~d} \mu \leqslant \int M_{0} \mathrm{~d} \mu+C_{0}
$$

Hence by Proposition 2

$$
\int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{u} \stackrel{(17 \mathrm{u})}{\leqslant} \int_{D} V \mathrm{~d} \nu_{u_{0}} \stackrel{(13)}{\leqslant} \int_{D} V \mathrm{~d} \nu_{M_{0}}+\left(C_{0}-u_{0}\left(x_{0}\right)+M_{0}\left(x_{0}\right)\right)
$$

Put $C_{1}:=C_{0}-u_{0}\left(x_{0}\right)+M_{0}\left(x_{0}\right) \in \mathbb{R}$. We continue this inequality as

$$
\begin{aligned}
& \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{u} \stackrel{(17 \mathrm{n})}{\leqslant} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M_{0}}+\int_{B\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M_{0}}+C_{1} \\
& \stackrel{(17 \mathrm{r})}{=} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M}+\int_{\partial B\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M_{0}}+C_{1} \\
& \stackrel{(16)}{\leqslant} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \stackrel{\mathrm{~d} \nu_{M}+b \nu_{M_{0}}\left(\bar{B}\left(x_{0}, r_{0}\right)\right)+C_{1}}{\stackrel{(17 \mathrm{n})}{=} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M}+b \nu_{M}\left(\bar{B}\left(x_{0}, r_{0}\right)\right)+C_{1}} .
\end{aligned}
$$

We choose $C:=b \nu_{M}\left(\bar{B}\left(x_{0}, r_{0}\right)\right)+C_{1}$ and obtain the inequality (15).

### 2.3. Continuation of test functions

Proposition 3. Let $v \in \operatorname{sbh}_{0}^{+}(D \backslash K)$ be a test function for $D$ outside of $K, r_{0}>0$, and $B\left(x_{0}, 2 r_{0}\right) \subset K$. Then there are subdomains $D_{0} \Subset D_{1} \Subset D$, a number $r_{0}>0$ and a function $\widetilde{v} \in \operatorname{sbh}^{+}\left(D \backslash\left\{x_{0}\right\}\right)$ such that

$$
\begin{equation*}
\bar{B}\left(x_{0}, 2 r_{0}\right) \subset K \subset D_{0} \tag{18a}
\end{equation*}
$$

$$
\begin{align*}
& \left.\widetilde{v}\right|_{B_{*}\left(x_{0}, 2 r_{0}\right)} \in \operatorname{har}\left(B_{*}\left(x_{0}, 2 r_{0}\right)\right),  \tag{18b}\\
& \exists \lim _{x_{0} \neq x \rightarrow x_{0}} \frac{\widetilde{v}(x)}{\left|h_{m}\left(x-x_{0}\right)\right|} \in(0,+\infty),  \tag{18c}\\
& \widetilde{v}=v \text { on } D \backslash D_{1} \tag{18d}
\end{align*}
$$

Proof. Obviously, there is a subdomain $D_{0} \Subset D$ satisfying (18a). There is a subdomain $D_{1}$ that regular for Dirichlet problem and $D_{0} \Subset D_{1} \Subset D$. Let $g_{D_{1}}\left(\cdot, x_{0}\right)$ be the Green's function of $D_{1}$ with the pole $x_{0}$ where $g_{D_{1}}\left(x, x_{0}\right) \equiv 0$ for all $x \in D \backslash D_{1}$. Then $g_{D_{1}}\left(\cdot, x_{0}\right) \in$ $\operatorname{sbh}\left(D \backslash\left\{x_{0}\right\}\right)$. Put

$$
q:=\sup _{x \in \partial D_{0}} v(x), \quad a:=\inf _{x \in \partial D_{0}} g_{D_{1}}\left(x, x_{0}\right)>0, \quad v_{0}:=\frac{q}{a} g_{D_{1}}\left(\cdot, x_{0}\right)
$$

and $\mathcal{O}:=D \backslash \operatorname{clos} D_{0}, \mathcal{O}_{0}:=D \backslash\left\{x_{0}\right\}$. Then the condition (8) is fulfilled. By Theorem 2 the function (9) is required according to the known properties of the Green's function.

### 2.4. Proof of Theorem 1

Proof. Let $B\left(x_{0}, 2 r_{0}\right) \subset K$ where $r_{0}>0$. Suppose that the properties (5a), (5c) are fulfilled for $u \neq-\infty$. We must prove that the integral from (5b) with $\nu:=\nu_{u}$ is finite. Consider the function $\widetilde{v}$ from Proposition 3 where

$$
0<c \stackrel{(18 \mathrm{c})}{:} \lim _{x_{0} \neq x \rightarrow x_{0}} \frac{\widetilde{v}(x)}{\left|h_{m}\left(x-x_{0}\right)\right|}<+\infty
$$

Then the function $V:=\frac{1}{c} \widetilde{v}$ satisfies the following conditions

$$
\begin{gather*}
\left.V\right|_{B_{*}\left(x_{0}, 2 r_{0}\right)} \stackrel{(18 \mathrm{~b})}{\in} \operatorname{har}\left(B_{*}\left(x_{0}, 2 r_{0}\right)\right)  \tag{19b}\\
\lim _{x_{0} \neq x \rightarrow x_{0}} \frac{V(x)}{\left|h_{m}\left(x-x_{0}\right)\right|} \stackrel{(18 \mathrm{c})}{=} 1  \tag{19c}\\
V \stackrel{(18 \mathrm{~d})}{=} \frac{1}{c} v \text { on } D \backslash D_{1} .  \tag{19~d}\\
\lim _{D \ni x^{\prime} \rightarrow x} V\left(x^{\prime}\right) \stackrel{(3)}{=} 0 \quad \text { for each } x \in \partial D  \tag{19e}\\
\sup _{x \in \partial B\left(x_{0}, r_{0}\right)} V(x)=: b \stackrel{(3)}{<}+\infty . \tag{19f}
\end{gather*}
$$

We put $V(x) \equiv 0$ at $x \in \mathbb{R}_{\infty}^{m} \backslash D$. Then $V \stackrel{(19 \mathrm{e})}{\in} \operatorname{sbh}^{+}\left(\mathbb{R}_{\infty}^{m} \backslash\left\{x_{0}\right\}\right)$. Consider the sequence of functions $V_{n}:=\max \{0, V-1 / n\}, \quad n \in \mathbb{N}$. If $n_{0} \in \mathbb{N}$ is a sufficiently large number, then every function $V_{n}, n \geqslant n_{0}$, is a Jensen function inside of $D$ with the pole at $x_{0} \in D$ such that
$\left.V_{n}\right|_{B_{*}\left(x_{0}, r_{0}\right)} \stackrel{(19 \mathrm{~b})}{\in} \operatorname{har}\left(B_{*}\left(x_{0}, r_{0}\right)\right), \quad \lim _{x_{0} \neq x \rightarrow x_{0}} \frac{V_{n}(x)}{\left|h_{m}\left(x-x_{0}\right)\right|} \stackrel{(19 \mathrm{c})}{=} 1, \sup _{x \in \partial B\left(x_{0}, r_{0}\right)} V_{n}(x) \stackrel{(19 \mathrm{f})}{\leqslant} b$,

$$
\begin{equation*}
\frac{1}{c} v(x)=V(x) \geqslant V_{n}(x) \nearrow \frac{1}{c} v(x), \quad \text { for all } x \stackrel{(19 \mathrm{~d})}{\in} D \backslash D_{1} \text { when } n \rightarrow \infty \tag{20}
\end{equation*}
$$

Hence by Corollary 2 there is a constant $C \in \mathbb{R}^{+}$such that

$$
\int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V_{n} \mathrm{~d} \nu_{u} \stackrel{(15)}{\leqslant} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V_{n} \mathrm{~d} \nu_{M}+C \quad \text { for all } n \geqslant n_{0}
$$

Therefore, for all $n \geqslant n_{0}$,

$$
\begin{aligned}
& \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V_{n} \mathrm{~d} \nu_{u} \stackrel{(15)}{\leqslant} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V_{n} \mathrm{~d} \nu_{M}+C \stackrel{(20)}{\leqslant} \int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M}+C \\
\leqslant & \int_{D \backslash D_{1}} V \mathrm{~d} \nu_{M}+\int_{D_{1} \backslash \bar{B}\left(x_{0}, r_{0}\right)} V \mathrm{~d} \nu_{M}+C \stackrel{(19 f)}{\leqslant} \int_{D \backslash D_{1}} V \mathrm{~d} \nu_{M}+b \nu_{M}\left(D_{1} \backslash \bar{B}\left(x_{0}, r_{0}\right)\right)+C
\end{aligned}
$$

where we use the maximum principle for $V \in \operatorname{sbh}\left(\mathbb{R}_{\infty}^{m} \backslash\left\{x_{0}\right\}\right)$ in $\mathbb{R}_{\infty}^{m} \backslash B\left(x_{0}, r_{0}\right)$. Further, we put $C_{1}:=b \nu_{M}\left(D_{1} \backslash \bar{B}\left(x_{0}, r_{0}\right)\right)+C \in \mathbb{R}$ and continue as

$$
\int_{D \backslash \bar{B}\left(x_{0}, r_{0}\right)} V_{n} \mathrm{~d} \nu_{u} \leqslant \int_{D \backslash D_{1}} V \mathrm{~d} \nu_{M}+C_{1} \stackrel{(20)}{=} \frac{1}{c} \int_{D \backslash D_{1}} v \mathrm{~d} \nu_{M}+C_{1} \leqslant \frac{1}{c} \int_{D \backslash K} v \mathrm{~d} \nu_{M}+C_{1}
$$

So, when $n \rightarrow \infty$, we obtain in view of (20)

$$
\frac{1}{c} \int_{D \backslash D_{1}} v \mathrm{~d} \nu_{u} \stackrel{(20)}{=} \int_{D \backslash D_{1}} V \mathrm{~d} \nu_{u} \leqslant C_{2}:=\frac{1}{c} \int_{D \backslash K} v \mathrm{~d} \nu_{M}+C_{1} \stackrel{(4)}{\in} \mathbb{R}
$$

Hence

$$
\int_{D \backslash K} v \mathrm{~d} \nu_{u} \leqslant \int_{D_{1} \backslash K} v \mathrm{~d} \nu_{u}+c C_{2} \leqslant \nu_{u}\left(D_{1} \backslash K\right) \sup _{x \in D \backslash K} v(x)+c C_{2} \stackrel{(3)}{<}+\infty
$$

This completes proof of Theorem 1.

Remark 2. Our results show that the construction of test functions in the sense of Definition 2 is important. For $m=2=2 n$ such constructions developed in [6]. We consider the case $m \neq 2$ in another place.
