# ON FOMIN-KIRILLOV ALGEBRAS FOR COMPLEX REFLECTION GROUPS 

ROBERT LAUGWITZ


#### Abstract

This note is an application of classification results for finite-dimensional Nichols algebras over groups. We apply these results to generalizations of Fomin-Kirillov algebras to complex reflection groups. First, we focus on the case of cyclic groups where the corresponding Nichols algebras are only finite-dimensional up to order four, and we include results about the existence of Weyl groupoids and finite-dimensional Nichols subalgebras for this class. Second, recent results by HeckenbergerVendramin [ArXiv e-prints, 1412.0857 (December 2014)] on the classification of Nichols algebras of semisimple group type can be used to find that these algebras are infinite-dimensional for many non-exceptional complex reflection groups in the Shephard-Todd classification.


## 1. Introduction

The quadratic algebras $\mathcal{E}_{n}$ were introduced by S. Fomin and A. N. Kirillov as an algebraic tool to study Schubert calculus and the cohomology of flag varieties in [FK99]. This class of algebras attracted attention in the study of pointed Hopf algebras as they are quadratic covers of certain Nichols algebras $\mathcal{B}_{n}$ (and hence are braided Hopf algebras generated by primitive elements). It this framework, the Nichols algebras $\mathcal{B}_{n}$ appeared independently in [MS00, Section 5] in larger generality. The Hopf algebra structure on the bosonization of $\mathcal{E}_{n}$ with the group algebra was also observed in [FP00]. It was conjectured in $[\operatorname{Maj} 05,3.1]$ that $\mathcal{E}_{n}$ is infinite-dimensional for $n \geqslant 6$. This question, as well as the question whether $\mathcal{B}_{n}$ is quadratic (and hence equals $\mathcal{E}_{n}$ ), remain open (cf. [AFGV11, Introduction]).

Fuelled by the fact that the positive parts $u_{q}\left(\mathfrak{n}^{+}\right)$of the small quantum groups appear as examples, the question of classifying all finite-dimensional Nichols algebras has been a topic of active research (see surveys [AS02, AS10]). The classification of finite-dimensional Nichols algebras over abelian groups has been completed in [Hec09] (in characteristic zero). While the classification of finite-dimension Nichols algebras of group type has been completed in the case of a semisimple Yetter-Drinfeld module in [HLV15, HV14], it remains open in general (see also [HLV15]).

Generalizations $\mathcal{E}_{G}$ of the Fomin-Kirillov algebras (and their corresponding Nichols algebras $\mathcal{B}_{G}$, already defined in [MS00]), were considered in [Baz06] (these are related to the bracket algebras of [KM04]) and provide a generalization of the algebras $\mathcal{E}_{n}$ (respectively, $\mathcal{B}_{n}$ ), which constitute the $S_{n^{-}}$ case, to general Coxeter groups $G$. The Nichols algebras $\mathcal{B}_{G}$ were studied more generally for complex reflection groups $G$ in [BB09].

- In particular, it is possible to consider analogues of $\mathcal{B}_{G}$ over the cyclic groups $C_{n}$, which can be viewed as complex reflection groups (of rank 1 ), where $C_{n} \leqslant \operatorname{GL}(\mathbb{C})$ via a primitive $n$-th root of unity. As $C_{n}$ is abelian, this class of examples can be study using the machinery of classification of finite arithmetic root systems via the Weyl groupoid [Hec06, Hec09].
- More generally, looking at the non-exceptional series of complex reflection groups $G(m, p, n)$ in the Shephard-Todd classification [ST54] we can use the results of [HV14] to show that $\mathcal{B}_{n}$ is infinite-dimensional for large classes of complex reflection groups (and hence dim $\mathcal{E}_{n}=\infty$ for many Coxeter groups).
Investigating these two points is the purpose of this note.
In the cyclic group case treated in Section 2, we derive that-similarly to the algebras $\mathcal{E}_{n}$-the Nichols algebras $\mathcal{B}\left(Y_{C_{n}}\right)$ associated to cyclic groups by the construction of [BB09] also display rapid growth. In fact, they are infinite-dimensional for $n \geqslant 5$. We see that this class of Nichols algebras gives examples of different types depending on $n$ : some are of Cartan type, others are not, and it is further shown that the associated Weyl groupoid is not of even well-defined in general for these

[^0]examples, by showing that this e.g. fails for $n=6$ already. This means that no convenient PBW bases are available for these algebras in all cases, and the Gelfand-Kirillov dimension is not finite in general. In fact, only for $n=p$ a prime number do we obtain Nichols algebras of Cartan type. We conjecture that the Weyl groupoid exists if and only if $n$ is prime or equal to 4 . Computational evidence is used to verify this claim up to $n=1000$.

From the point of view of the theory of Nichols algebras, this means that we investigate examples of diagonal type, such that the braiding is given by scalars

where $I$ is an indexing set for a diagonal basis with respect to the braiding and $\xi$ is a primitive $n$-th root of unity. The classification in [Hec06] can be used to identify for which $n$ such braidings of rank at least two exist that have a finite root system, hence giving finite-dimensional Nichols algebras (which are Nichols subalgebras of $\mathcal{B}_{C_{n}}$ coming from Yetter-Drinfeld submodules). We see that the maximal rank of such a Nichols algebra is three, and they only exist for $n$ divisible by one of the primes $p=2,3,5$ or 7 (Corollary 2.4, Table 2). Note that the classification of pointed Hopf algebras via the lifting method also appear as exceptions [AS10].

For the case of a complex reflection group $G=G(m, p, n)$ we see in Section 3 that the rank of the associated Nichols algebra $\mathcal{B}_{G}$ equals $m / p$ if $n \geqslant 3$ or $p$ is odd. Otherwise, the rank is $m / p+1$. One can see using results of [HV14] that the associated Nichols algebra $\mathcal{B}_{G}$ is infinite-dimensional whenever this rank is larger than one, except for the the groups $D_{2}=G(2,2,2)$ and $B_{2}=G(2,1,2) \cong G(4,4,2)$. However, in the $B_{2}$-case, $\mathcal{E}_{B_{2}}$ is also infinite-dimensional according to [KM04]. Finite-dimensionality remains open in cases where the rank of $\mathcal{B}_{G}$ equals one. Hence the only open cases left are among the groups $G(m, m, n)$ with $n \geqslant 3$ or $m$ odd. A conjecture in [HLV15] would imply that a full list of finite-dimensional elementary Fomin-Kirillov Nichols algebra from non-exceptional complex reflection groups (up to isomorphism) will be given by $\mathcal{B}_{G}$ for $G=S_{2}, S_{3}, S_{4}, S_{5}$.

## 2. The Cyclic Group Case

In the following, we work over a field $k$ of characteristic zero in order to apply [Hec09]. However, the definition and some of the results hold more generally.
2.1. Definitions. We fix a generator $g$ for the cyclic group $C_{n}$, a primitive $n$-th root of unity $\xi$, and let $C_{n} \leqslant \mathrm{GL}_{1}(\mathbb{C})$ via $\xi$. Hence $C_{n}$ is an irreducible complex reflection group with reflections $g, \ldots, g^{n-1}$. The Yetter-Drinfeld module $Y_{C_{n}}=\operatorname{span}_{\mathbb{C}}\left\langle s_{1}, \ldots, s_{n-1}\right\rangle$ is given by the $C_{n}$ action $g \cdot s_{i}=\xi s_{i}$ and the grading $\delta\left(s_{i}\right)=g^{i} \otimes s_{i}$. We denote the corresponding Nichols algebra of rank $n-1$ by

$$
\mathcal{B}_{C_{n}}:=\mathcal{B}\left(Y_{C_{n}}\right)
$$

This is a special case of the general definition of [BB09, Section 7] for a complex reflection group (cf. [MS00, Section 5]), and the investigation of $\mathcal{B}_{C_{n}}$ will occupy the remainder of this section, while we will look at the more general case $G=G(m, p, n)$ in Section 3. We refer to the algebras $\mathcal{B}_{C_{n}}$ as Fomin-Kirillov Nichols algebras (or FK Nichols algebras) ${ }^{1}$ for $C_{n}$. We observe that the braidings have the form

\begin{equation*}
\Psi\left(s_{i} \otimes s_{j}\right)=\xi^{i} s_{j} \otimes s_{i} . \tag{2.1}
\end{equation*}
$$

Hence $\mathcal{B}_{C_{n}}$ is of diagonal type (cf. [AS02, (1-11)]), where $q_{i j}=\xi^{i}$. This implies that the generalized Dynkin diagram (cf. [Hec09, Definition 1]) of $\mathcal{B}_{C_{n}}$ consists of vertices labelled by $\xi^{i}$ for $i=1, \ldots, n-1$ and edges


The underlying graph is almost complete, apart from there not being an edge between the vertices labelled $\xi^{i}$ and $\xi^{n-i}$ for all $i=1, \ldots, n-1$.
Example 2.1. We list the examples of small rank in Table 1. We recognize the smallest rank cases

[^1]as follows: $\mathcal{B}_{C_{2}}$ is the positive part of the small quantum group of $\mathfrak{s l}_{2}$ for $q=-1$, while $\mathcal{B}_{C_{3}}$ is the braided tensor product two copies of the positive part of the small quantum group $\mathfrak{s l}_{2}$ for $q=e^{2 / 3 \pi i}$. The case $n=4$ appears in [Hec07, Table 2, Row 8] (cf. also [Hec09, Table 2, Row 8]) and is hence finite-dimensional. Using techniques of [Kha07, Theorem 2], we can show that a PBW basis for $\mathcal{B}_{C_{4}}$ can be given by generators $s_{\alpha_{i}}$, labelled by six roots $\alpha_{i}$, and

\mathcal{B}_{C_{4}}=\operatorname{span}_{k}\left\langle s_{\alpha_{1}}^{b_{1}} \ldots s_{\alpha_{6}}^{b_{6}} \mid 0 \leqslant b_{1}, b_{3} \leqslant 3,0 \leqslant b_{2}, b_{4}, b_{5}, b_{6} \leqslant 1\right\rangle \tag{2.3}
\end{equation*}

\]

where $\alpha_{1}, \alpha_{2}, \alpha_{3}$ are simple roots (corresponding to the generators $s_{\alpha_{i}}=s_{i}$ for $i=1,2,3$ ), and $\alpha_{4}=\alpha_{1}+\alpha_{2}, \alpha_{5}=\alpha_{2}+\alpha_{3}, \alpha_{6}=\alpha_{1}+\alpha_{2}+\alpha_{3}$.

Lemma 2.2. The braiding on the Nichols algebra $\mathcal{B}_{C_{n}}$ is of Cartan type if and only if $n=p$ is prime.
Proof. A braiding is of Cartan type if $q_{i i} \neq 1$ for all $i$, and if $i \neq j$, then

$$
a_{i j}=-\min \left\{r \geqslant 0 \mid q_{i i}^{r} q_{i j} q_{j i}=1\right\}
$$

exists and satisfies $0 \leqslant-a_{i j}<\operatorname{ord} q_{i i}$, i.e. $a_{i i}=2$ and $\left(a_{i j}\right)$ is a generalized Cartan matrix (cf. [AS00, 1.2]). In the series $\mathcal{B}_{C_{n}}$ this means that we need $k$ such that

$$

\xi^{i k+j}=1 \tag{2.4}
\end{equation*}

\Longleftrightarrow \quad i k \equiv-j \quad \bmod n
$$

in which case we set $a_{i j}=-k+1$. This division modulo $n$ can always be solved if and only if $n$ is a prime $p$, in which case we choose $1 \leqslant k \leqslant$ ord $q_{i i}=p$.

Corollary 2.3. The algebra $\mathcal{B}_{C_{n}}$ is finite-dimensional if and only if $n \leqslant 4$.
Proof. We can see, using the classification of finite arithmetic root systems [Hec09], that for $n=2,3,4$ we obtain finite-dimensional Nichols algebras. The previous observations about the braiding imply that for $n \geqslant 5$ there always exists a cycle of length $n-1$ within the generalized Dynkin diagram of the braiding of $\mathcal{B}_{C_{n}}$. Again using the classification in loc.cit. we find that all such braidings give infinite-dimensional arithmetic root systems and hence infinite-dimensional Nichols algebras.
2.2. Finite-dimensional Nichols subalgebras. The more general point of view to find all braidings of diagonal type which are of the form that

where $I$ is a subset of $\{1, \ldots, n-1\}$ and have a finite arithmetic root system is equivalent to finding the finite-dimensional Nichols subalgebras of $\mathcal{B}_{C_{n}}$. That is, Nichols algebras that are braided (and


Table 1. Small rank examples: $\mathcal{B}_{C_{n}}, n=2,3,4,5$
graded) Hopf subalgebras of $\mathcal{B}_{C_{n}}$ which arise from considering a restriction of the defining YetterDrinfeld module $Y_{C_{n}}$ to a subset of the diagonal basis. Again, a full answer to this question can be directly obtained from the classification of finite arithmetic root systems in [Hec09, Table 1-4].

## Corollary 2.4.

(i) There are indecomposable finite-dimensional Nichols subalgebras in $\mathcal{B}_{C_{n}}$ of rank 2 or higher if and only if $n$ is divisible by $p=3,5,7$ or 4 .
(ii) $\mathcal{B}_{C_{4}}$ is the only indecomposable Nichols subalgebras of the above form of rank 3.
(iii) There are no finite-dimensional indecomposable Nichols subalgebras of the above form of rank 4 or higher.

Proof. As a proof, consider the explicit list ${ }^{2}$ in Table 2 of the indecomposable finite arithmetic ${ }^{3}$ root systems of Nichols subalgebras of $\mathcal{B}_{C_{n}}$ that appear in the classification in [Hec09]. As $m$ dividing $n$ implies $\mathcal{B}_{C_{m}} \leqslant \mathcal{B}_{C_{n}}$, we only list those subsystems that are strictly smaller than the smallest $\mathcal{B}_{C_{n}}$ in which they appear. The list only contains rank 2 systems (cf. [Hec09, Table 1] or [Hec08, Table 1]) as it is clear that each vertex gives a rank 1 subsystem for any $\mathcal{B}_{C_{n}}$, and apart from $\mathcal{B}_{C_{4}}$ itself no higher rank systems of this form exist.

We note that the non-existence of finite-dimensional Nichols algebras with connected generalized Dynkin diagram of rank strictly larger than three over cyclic groups was shown in [WZZ14] using results of [Hec09].
2.3. Existence of Weyl groupoids. Note that the construction of the Weyl groupoid as defined in [Hec06, Section 5], see also [Hec09, Section 2], is valid for a large class, but not all diagonal braidings. It fails if, after reflecting at a vertex, we find that the new scalar $q_{i i}^{\prime}=1$. We now investigate the question for which $n$ the Weyl groupoid can be defined for the diagonal type braiding of $\mathcal{B}_{C_{n}}$.

Lemma 2.5. The Weyl groupoid associated to the braiding on $\mathcal{B}_{C_{n}}$ is not defined at least in the cases where $p r$ divides $n$, and $p$ is a prime dividing $2 r-1$.

Proof. First, consider the case $n=6=2 \cdot 3$ separately. In this case, consider e.g. the sub-diagram of the generalized Dynkin diagram and Cartan matrix given by

where $\xi^{3}=-1$. The first vertex $-\xi$ is not Cartan and reflecting at it, using the generalized Cartan matrix, gives

Here the second vertex is not Cartan, and reflecting at it gives $\xi^{0}=1$ at the first vertex.
Now let $n=p r$ where $p>2$ is a prime and $p$ does not divide $r>2$. In this case, we can consider the sub-diagram of the form


$$
\left(\begin{array}{ccc}
2 & -(r-1) & 0  \tag{2.8}\\
a_{21} & 2 & a_{23} \\
0 & -(r-1) & 2
\end{array}\right)
$$

The first and third vertex are not Cartan as $p$ does not divide $r$. Note that iterated reflection at these vertices (denoted by $s_{1}$ and $s_{3}$ ) will leave the first and third, as well as the entries in the first and third row of the Cartan matrix unchanged. Further observe that the reflection $s_{1}$ gives the label $\xi^{r^{2}}$ at the second vertex, $s_{3} s_{1}$ gives $\xi^{(2 r-1) r}$. However, if $p$ divides $2 r-1$, then this vertex has label 1, i.e. the reflection does not exist. Finally, note that if $p$ divides $2 r-1$, it never divides $r$ as the numbers are coprime.

[^2]In particular, we see that $\mathcal{B}_{C_{n}}$ does not have a Weyl groupoid for $n=6$, which is the smallest such value. This also fails for multiples of $n=6,15,28,33,40,51,65,77,91$, etc. We expect this to fail for other non-prime $n$ too as Lemma 2.5 only uses a small part of the reflections for $\mathcal{B}_{C_{p r}}$. As an example, we provide the full Weyl groupoid for the exceptional case 4.

Example 2.6. The case $n=4$ is of standard type, i.e. the Cartan matrix is the same at each object of the groupoid (namely, of type $A_{3}$ ). The full Weyl groupoid is displayed in Figure 1.


Figure 1. Weyl groupoid of $\mathcal{B}_{C_{4}}$
Here, all endomorphisms are the identity. If an arrow $s_{1}, s_{2}, s_{3}$ is not drawn from some object, then it is the identity on that object. The generalized Dynkin diagrams at the objects are:


Further, $b_{i}$ corresponds to $a_{i}$ where $\xi$ is interchanged with $\xi^{-1}$.
2.4. Computation results. We can use a MATLAB ${ }^{\circledR}$ script to verify if there are any other $n$ for which the Weyl groupoid does not exists. This is possible, as computing the reflection in the Weyl groupoid (cf. [Hec06, (13)]) for the braiding of $\mathcal{B}_{C_{n}}$ reduces to $\bmod n$ computations. We checked that for $n \leqslant 1000$ the Weyl groupoid is only defined for $n$ a prime number or $n=4$. This leads to the following conjecture:

Conjecture 2.7. The Weyl groupoid associated to the braiding of $\mathcal{B}_{C_{n}}$ is only defined for $n$ a prime number or $n=4$.

The computer check is based on the following method: We do not need to check the statement for $n=k r$, if the Weyl groupoid does not exist for $r$. We can also rule out all $n=p r$ for $p$ prime covered by Lemma 2.5 as well as cases where $n$ is prime (in these cases, the groupoid always exists as it is of Cartan type). This implies that the computer will only check the cases $n=p q$ prime pairs $p, q$ from some point onwards (unless the conjecture is false). We found that for most $n$ it is quickest to compute the reflections $s_{j} s_{i} s_{p}$ where $p$ is the smallest prime dividing $n$ and $i \neq j$ start from 1,2 and increase until some reflection fails to exist. This can be identified as a situation in which $q_{i i}^{\prime}=1$ after applying $s_{j} s_{i} s_{p}$. Computational complexity is often larger if $n=p q$ for two distinct primes $q \gg p$ and $p>2$.

Conjecture 2.7 would imply that $\mathcal{B}_{C_{n}}$ has infinite Gelfand-Kirillov dimension for $n \geqslant 5$ not prime. This follows from the observations in [Hec06, Section 3]. In fact, finite Gelfand-Kirillov dimension implies that for $i \neq j$ the number

\begin{equation*}
-a_{i j}=\min \left\{m \in \mathbb{N}_{0} \mid(m+1)_{q_{i i}}\left(q_{i i}^{m} q_{i j} q_{j i}-1\right)=0\right\} \tag{2.12}
\end{equation*}
$$

is well-defined. If $q=1$, and $q_{i j} q_{j i} \neq 1$, then this is not the case. In our computations for $n>4$ not prime, we obtain that $q_{i i}=1$ for some $i$ after reflection, but there always exists $j \neq i$ with $q_{i j} q_{j i} \neq 0$ as the connected components of the generalized Dynkin diagram are preserved under reflection. ${ }^{4}$

## 3. The General Case $G=G(m, p, n)$

We conclude this note by applying classification results for finite-dimensional Nichols algebras [HV14] of semisimple group type to Fomin-Kirillov algebras associated to more general non-exceptional complex reflection groups, which we study here more explicitly. In the rank one case of elementary Nichols algebras, which is not covered by these methods, we include a conjecture derived from [HLV15].
3.1. Definition and Description. We consider complex reflection groups of the series $G(m, p, n)$ appearing in the classification of [ST54] and investigate their associated Nichols algebras generalizing the Fomin-Kirillov Nichols algebras. There are also 34 exceptional groups, which we do not consider here.

Definition 3.1. Let $m, n$ be integers and $p$ a divisor of $m$. The group $G(m, p, n)$ is defined as all transformations of $\mathbb{C}^{n}$ of the form

$$
x_{i} \mapsto \theta^{\nu_{i}} x_{\sigma(i)}, \quad \sigma \in S_{n}
$$

where $\theta$ is a fixed primitive $n$-th root of unity and $\sum_{i} \nu_{i}=0 \bmod p$. We denote this group element by $\theta^{\nu} \sigma$. The group $G(m, p, n)$ naturally acts on $\mathbb{C}^{n}$ by definition and contains $S_{n}$ as a subgroup.

Example 3.2. We can recognize some of the classical series of Coxeter groups in $G(m, p, n)$ :

- $G(1,1, n)=S_{n}$
- $G(2,1, n)$ has $\theta=-1$ and any sign change given by powers $\nu=\left(\nu_{1}, \ldots, \nu_{n}\right) \in C_{2}^{n}$ appears in the group. Hence this groups is the Weyl group $B_{n} \cong C_{2}^{n} \rtimes S_{n}$.
- In $G(2,2, n)$ the sum $\sum_{i} \mu_{i}=0 \bmod 2$. Hence this group is $D_{n} \cong C_{2}^{n-1} \rtimes S_{n}$.
- The group $G(m, m, 2)$ gives the Coxeter group $I_{2}(m)$, the $n$th dihedral group $\operatorname{Dih}_{n}$ of order $2 n$. As a special case, $G_{2}$ appears for $m=6$.

A full list of reflections $\mathcal{S}_{G}$ of $G$ can be given as follows: First, let $s=\theta^{\nu} 1$. In this case,

$$
\begin{equation*}
(1-s) x_{i}=\left(1-\theta^{\nu_{i}}\right) x_{i}, \quad \forall i \tag{3.2}
\end{equation*}
$$

which has a one-dimensional image if and only if $\nu_{i}=0$ for all but precisely one $i$, denote $k:=\nu_{i}$. Then, however, we require $k=0 \bmod p$. Hence $p$ divides $k$. Consider the order $d$ of $k$ modulo $m$. This is a divisor of $m / p$. For each $d$, there are $n \varphi(d)$ reflections, and their order is $d$. We denote such a reflection by $s_{i}^{k}$, it maps $x_{i} \mapsto \theta^{k} x_{i}$. Second, if $\sigma=(i j)$ is a transposition, then $\theta^{\nu}(i j)$ is a reflection if and only if $\nu_{i}=-\nu_{j} \bmod m$, and $\nu_{k}=0 \bmod m$ for all $k \neq i, j$. We denote this reflection of order two by $\theta^{k}(i j)$, for $k=\nu_{i}$. These two types describe all complex reflections in $G$.

Now, for a given reflection $s \in \mathcal{S}_{G}$ we specify a choice of roots $\alpha_{s}^{*}$ and coroots $\alpha_{s}$ satisfying

s x_{i}=x_{i}-\left(\alpha_{s}^{*}, x_{i}\right) \alpha_{s}, \quad \forall i=1, \ldots, n \tag{3.3}
\end{equation*}
$$

For this, we denote generators of the dual space of $\mathbb{C}^{n}$ by $y_{1}, \ldots, y_{n}$. First, for $s_{i}^{k}$, we choose

$$
\begin{equation*}
\alpha_{s_{i}^{k}}^{*}=y_{i}, \quad \quad \alpha_{s_{i}^{k}}:=\left(1-\theta^{k}\right) x_{i} \tag{3.4}
\end{equation*}
$$

Second, for the reflection $\theta^{k}(i j)$, we can choose

$$
\begin{equation*}
\alpha_{\theta^{k}(i j)}^{*}=y_{i}-\theta^{-k} y_{j}, x_{i}, \quad \quad \alpha_{\theta^{k}(i j)}=x_{i}-\theta^{k} x_{j} \tag{3.5}
\end{equation*}
$$

[^3]To study Fomin-Kirillov algebras associated to $G=G(m, p, n)$, we need to understand the conjugation action of reflections on reflections (note that $\left(\theta^{k}(i j)\right)^{2}=1$ ).

Following [BB09, 7.8-7.10] can make a convenient choice of $\operatorname{Drin}(k G)$-character $\lambda$ in order to define the Fomin-Kirillov algebras. This character can be chosen to take values $\pm 1$ for Coxeter group. Given a choice of roots and coroots for $G$, the character $\lambda$ is determined by $g \triangleright \alpha_{s}^{*}=\lambda(g, s) \alpha_{g s g^{-1}}^{*}$. We compute its values for reflections (which is sufficient):

& \lambda\left(s_{i}^{l}, s_{j}^{k}\right)= \begin{cases}\theta^{-l} & i=j \\
1 & i \neq j,\end{cases}  \tag{3.21}\\
& \lambda\left(\theta^{k}(i j), s_{t}\right)= \begin{cases}1, & t \neq i, j, \\
\theta^{-k}, & t=i, \\
\theta^{k}, & t=j .\end{cases}  \tag{3.22}\\
& \lambda\left(\theta^{k}(i j), \theta^{l}(i t)\right)=\left\{\begin{array}{ll}
\theta^{-k}, & j<t \\
-\theta^{-l}, & j>t,
\end{array}, \quad \lambda\left(\theta^{k}(i j), \theta^{l}(t i)\right)=1,\right.  \tag{3.23}\\
& \lambda\left(\theta^{k}(i j), \theta^{l}(t j)\right)=\left\{\begin{array}{ll}
-\theta^{k-l}, & i<t \\
1, & i>t,
\end{array} \quad \lambda\left(\theta^{k}(i j), \theta^{l}(j t)\right)=\theta^{k},\right.  \tag{3.24}\\
& \lambda\left(\theta^{k}(i j), \theta^{l}(i j)\right)=-\theta^{k-l}, \quad \lambda\left(\theta^{k}(i j), \theta^{l}(a b)\right)=1, \tag{3.25}

where $\{i, j\} \cap\{a, b\}=\varnothing$.
Definition 3.3 ([BB09]). Let $G$ be a complex reflection group with reflections $\mathcal{S}_{G}$.
(i) Define the Yetter-Drinfeld module $Y_{G}$ to be $\operatorname{span}_{k}\left\langle r_{s} \mid s \in \mathcal{S}\right\rangle$, with coaction $\delta\left(r_{s}\right)=s \otimes r_{s}$ and action $g \triangleright r_{s}=\lambda(g, s) r_{g s g^{-1}}$. It comes with the braiding $\Psi_{G}\left(r_{s} \otimes r_{t}\right)=\left(s \triangleright r_{t}\right) \otimes t_{s}$.
(ii) We refer to the Nichols algebra $\mathcal{B}_{G}:=\mathcal{B}\left(Y_{G}\right)$ of $Y_{G}$ as the Fomin-Kirillov Nichols algebra (or FK Nichols algebra) of $G$.
(iii) Let $G$ be a Coxeter group. Then the quadratic algebra $\mathcal{E}_{G}:=T\left(Y_{G}\right) /\left(\operatorname{ker} \Psi_{G}+\operatorname{Id}_{Y_{G} \otimes Y_{G}}\right)$ associated to the Yetter-Drinfeld module $Y_{G}$ is called the Fomin-Kirillov algebra (or FK algebra) of $G$.

Note that the FK Nichols algebra of the cyclic group with $m$ elements considered in Section 2 arises as $\mathcal{B}_{G}$ in the case $G=G(m p, p, 1)$, while the algebras $\mathcal{E}_{n}=\mathcal{E}_{S_{n}}$ are the original algebras studied in [FK99].
3.2. Semisimple Decomposition. In this section, we consider complex reflection groups $G=$ $G(m, p, n)$ where $n \geqslant 2$, i.e. not cyclic groups and work over a field $k$ of characteristic zero.

Lemma 3.4. The $F K$ Nichols algebras $\mathcal{B}_{G}$ for the complex reflection groups $G=G(m, p, n)$ have the following ranks, with corresponding dimensions of the simple $Y D$ modules $Y_{G}$. Note that

$$
\begin{equation*}
\operatorname{dim} Y_{G}=n\left(m \frac{(n-1)}{2}+\frac{m}{p}-1\right) \tag{3.26}
\end{equation*}
$$

(i) If $n \geqslant 3$, the rank of $\mathcal{B}_{G}$ is $m / p$. There is one YD summand of dimension $m n(n-1) / 2$ spanned by $r_{s}$ for the order two reflections $s=\theta^{k}(i j)$. For each $d \mid(m / p), d>1$, we have $\varphi(n)$ $n$-dimensional YD summands generated by the reflections $\left\{r_{s} \mid s=s_{i}^{k}, i=1, \ldots, m\right\}$ for $k$ of order $d$ modulo $m$.
(ii) If $n=2$, and $p$ is odd, then the same as in (i) applies.
(iii) If $n=2$ and $p=2 b$ is even, then $\mathcal{B}_{G}$ for $G=G(2 a, 2 b, 2)$ has rank $a / b+1$. The YD summand of order two reflections splits as a direct sum of two submodules $V^{\text {odd }} \oplus V^{\mathrm{even}}$, $V^{\text {even }}$ is spanned by $\left\{r_{s} \mid s=\theta^{2 k}(12), k=0, \ldots, a-1\right\}$, and $V^{\text {odd }}$ is spanned by $\left\{r_{s} \mid s=\right.$ $\left.\theta^{2 k+1}(12), k=0, \ldots, a-1\right\}$.

Proof. This follows from considering the relations (3.6-3.20) and distinguishing cases. Note that the action in the YD modules $Y_{G}$ is given by conjugation up to scalars (given by $\lambda$ ). Hence, in order to find a direct sum decomposition into simples of $Y_{G}$, we need to determine the conjugacy classes of reflections in $G$. We write $r \sim s$ if the reflections $r$ and $s$ are conjugate. First, note that, if $p \neq m$, we have reflections of the form $s_{i}^{k}$, for any $k \neq 0 \bmod m$ that is divisible by $p$. Relations (3.6), (3.18)(3.20) show that these form a simple YD submodule (for fixed $k$ ), denoted by $V_{k}$. All reflections $s_{i}^{k}$ have order $d>1$, where $d$ is the order of $k$ modulo $m$, a divisor of $m / p$. For fixed $d$, there are $\varphi(d)$ such $k$, each giving a direct summand.

Second, we are given reflections of the form $\theta^{k}(i j)$. It is clear from relations (3.7)-(3.17) that these determine a YD submodule, denoted by $V_{0}$. Hence, $Y_{G}$ decomposes as a direct sum

$$
Y_{G}=V_{0} \oplus \bigoplus_{i=1}^{m / p-1} V_{i p}
$$

We will treat the cases $n=2$ and $n \geqslant 3$ separately. If $n=2$, the module $V_{0}$ is only simple if $p$ is odd. To prove this assertion, we consider relations (3.7)-(3.10) and note that by (3.10), $\theta^{l}(12) \sim \theta^{k}(12)$ if and only if $l, k$ have the same parity (using conjugation by $\theta(12)$ if $m>1$, otherwise the assertion is clear). But by (3.8), two reflections $\theta^{k}(12), \theta^{l}(12)$ are also conjugate if $k=l \bmod p$. This links $k$ and $l$ of opposite parity if and only if $p$ is odd. Since in the $n=2$ case these are all relevant $\sim$ relations, we find that $V_{0}$ is simple if $p$ is odd, and splits as a direct sum $V^{\text {odd }} \oplus V^{\text {even }}$ of simples if $p$ is even.

It remains to show that if $n \geqslant 3$, we have $\theta^{k}(i j) \sim \theta^{l}(s t)$ for all possible choices of $s, t, i, j, k, l$. We prove this by distinguishing several cases (assume $i, j, s, t$ pairwise distinct). For example, $\theta^{k}(i j) \sim$ $\theta^{l}(s t)$ for $i<j<s<t$, or $i<s<j<t$ follows from

$$
\begin{aligned}
\theta^{k-l}(i s) \theta^{l}(s t) \theta^{k-l}(i s) & =\theta^{k}(i t) \\
(j t) \theta^{k}(i t)(j t) & =\theta^{k}(i j),
\end{aligned}
$$

using (3.17) and (3.16). The other cases to consider follow using appropriate combinations of the relations (3.10)-(3.17).
3.3. Dimensionality. As the YD module $Y_{G}$ often decomposes as a direct sum of more than one absolutely simple YD module, we can use the classification results of [HV13] in the rank two case, and [HV14] in higher rank cases to determine which $G=G(m, p, n)$ give infinite-dimensional Nichols algebras $\mathcal{B}_{G}$. This will not provide a complete answer as the rank one case - of elementary Nichols algebras - is not completely solved, but we will be able to derive conjectures from the conjecture made in [HLV15, 1.1].

Lemma 3.5. Let $n \geqslant 2$. The $Y D$ module $Y_{G}$ is braid-indecomposable if and only if $G \neq G(2,2,2)$.
Proof. Case 1: Let $n \geqslant 3$ or $p$ odd so that $V_{0}$ from the proof of Lemma 3.4 is absolutely simple. Simple YD modules are braid-indecomposable, so assume $m \neq p$. Then $Y_{G}$ contains reflections of the
form $s_{i}^{k} \in V_{k}$ and $\theta^{l}(i j) \in V_{0}$. Assume that $Y_{G}=M^{\prime} \oplus M^{\prime \prime}, M^{\prime}, M^{\prime \prime} \neq 0$. Then wlog $V_{k} \leqslant M^{\prime}$, and $V_{0} \leqslant M^{\prime \prime}$. But we compute

$$
\begin{align*}
\operatorname{ad}\left(s_{i}^{k}\right)\left(\theta^{l}(i j)\right)=\left(\operatorname{Id}-\Psi^{2}\right) s_{i}^{k} \otimes \theta^{l}(i j) & =s_{i}^{k} \otimes \theta^{l}(i j)+\lambda^{\prime} \Psi\left(\theta^{l-k}(i j) \otimes s_{i}^{k}\right),  \tag{3.27}\\
& =s_{i}^{k} \otimes \theta^{l}(i j)-\lambda^{\prime \prime} s_{j}^{k} \otimes \theta^{l-k}(i j) \neq 0 \tag{3.28}
\end{align*}
$$

where $\lambda^{\prime}, \lambda^{\prime \prime}$ are scalars. This implies that $Y_{G}$ is braid-indecomposable.
Case 2: Let $n=2$ and $p=2 a$ even. In this case, $V_{0}=V^{\text {odd }} \oplus V^{\text {even }}$. It remains to check the case where $Y_{G}$ has rank two, as if the rank is larger than two, there exist reflections of the form $\theta_{i}^{k}$ and the computation used in Case 1 can be applied. The rank two case applies to groups of the form $G(2 a, 2 a, 2)$. Consider $\operatorname{ad}\left(V^{\text {odd }}\right)\left(V^{\text {even }}\right)$ :

$$
\left(\operatorname{Id}-\Psi^{2}\right) \theta(i j) \otimes(i j)=\theta(i j) \otimes(i j)-\theta^{2} \cdot \theta^{3}(i j) \otimes \theta^{2}(i j)
$$

This vanishes if and only if $\theta^{2}=1$, i.e. $m=2$. Hence $Y_{G}$ is braid-indecomposable unless $G=$ $G(2,2,2)$.

## Corollary 3.6.

(i) If $n \geqslant 3$, then all $G(m, p, n)$ where the rank of $Y_{G}$ is strictly larger than one give infinitedimensional $F K$ Nichols algebras $\mathcal{B}_{G}$ and hence also infinite-dimensional $F K$ algebras $\mathcal{E}_{G}$.

In particular, this is true for all $G(m, p, n)$ where $n \geqslant 3$, and $m \neq p$.
(ii) If $n=2$, then all $G(m, p, n)$ where $m \neq p$ or $p$ even have that $\mathcal{B}_{G}$ is infinite-dimensional, with the exceptions of

$$
D_{2}=S_{2} \times S_{2}=G(2,2,2), \quad B_{2}=G(2,1,2) \cong \operatorname{Dih}_{4}=I_{2}(4)=G(4,4,2) .
$$

Proof. This is an application of the classification results of [HV13, HV14].
Proof of (i), $\operatorname{rank} Y_{G} \geqslant 3$ : This uses [HV14, Theorem 2.5], which applies by braid-indecomposability proved in Lemma 3.5 and the fact that complex reflection groups are generated by their set of reflections, which are the support of $Y_{G}$. Note that in this classification the maximal dimension of a simple YD summand is three, and rank three only appears together with two one-dimensional summands (type $\beta_{3}^{\prime}$ ), or one one-dimensional and one two-dimensional summand (type $\beta_{3}^{\prime \prime}$ ). However, for $n \geqslant 3$ there is always an absolutely simple summand of dimension $m n(n-1) / 2$, and the other summands have dimension $n$. Hence all such $Y_{G}$ of rank greater or equal to three are infinite-dimensional.

Proof for $\operatorname{rank} Y_{G}=2$ : For the rank to be two, assuming that $n \geqslant 3$, we need $m / p=2$. Then there exist a YD summand of dimension $n$ and one of dimension $m n(n-1) / 2$, and $\operatorname{dim} Y_{G}=n+m n(n-1) / 2$. According to [HV13, Table 1] all rank two braid-indecomposable finite-dimensional Nichols algebras of rank two have dimension between 4 and 6 . No such $m, n$ exist in this case.

Proof of (ii), $\operatorname{rank} Y_{G} \geqslant 3$ : If $p$ is odd, we are in this case if and only if $m / p \geqslant 3$. But then there is a YD summand of dimension $m \geqslant 3$, while the other summands have dimension two. Again using [HV14, Theorem 2.5], we find that no such braid-indecomposable semisimple YD module has a finite-dimensional Nichols algebra. If $p=2 a$, we require $m / p \geqslant 2$ and have two YD summands of dimension $2 a n(n-1) / 4=a$, and at least one of dimension two. Finite-dimensionality can only occur if $a \leqslant 2$ by the same result. This leaves us to only consider the case $G(4,2,2)$ which either has a skeleton of type $\alpha_{3}$ or is infinite-dimensional. It is in fact infinite-dimensional - see Example 3.7(iii).

Proof for $\operatorname{rank} Y_{G}=2$ : If $p$ is odd, we need $m / p=2$, and $4 \leqslant m+2 \leqslant 6$. This leaves the group $G(2,1,2)$. If $p=2 a$, we need $m / p=1$ and $4 \leqslant m \leqslant 6$. Hence it suffices to consider the groups $G(4,4,2)$ and $G(6,6,2)$. But following [HV14, Appendix B] $Y_{G(6,6,2)}$ is not of finite type as there is no skeleton with two dimension three vertices.

To complete the proof, we will treat the unanswered cases $G(2,1,2), G(4,2,2)$, and $G(4,4,2)$ in Example 3.7 below. Finally, note that $\mathcal{B}_{D_{2}}$ is finite-dimensional as it is isomorphic to $\mathcal{B}_{S_{2}} \otimes \mathcal{B}_{S_{2}}$.

## Example 3.7.

(i) $G=G(2,1,2)=B_{2}$ : We can check explicitly, using the table of actions in [HV13, Example 1.2 ] that $\mathcal{B}_{B_{2}}$ is isomorphic to a 64-dimensional Hopf algebra with skeleton of type $\alpha_{2}$ (cf. [HV14, B.1]). The simple YD modules $V_{0}$ and $V_{1}$ (using the notation from Lemma 3.4) have support given by the conjugacy classes $\{g=(12), \epsilon g=\theta(12)\}$ and $\left\{h=s_{1}^{1}, \epsilon h=s_{2}^{1}\right\}$, respectively. Here, $\epsilon=s_{1}^{-1} s_{2}^{1}$. The characters are given by $\rho(\epsilon)=\rho(g)=\theta=-1$ and $\sigma(\epsilon)=\sigma(h)=\theta=-1$ (using the notation from [HV13]).

The Nichols algebra $\mathcal{B}_{B_{2}}$ hence has the Hilbert polynomial (cf. [HV13, 1.1])

$$
\mathcal{H}_{B_{2}}^{\mathcal{B}}\left(t_{1}, t_{2}\right)=\left(1+t_{1}\right)^{2}\left(1+t_{1} t_{2}\right)^{2}\left(1+t_{2}\right)^{2} .
$$

Computations with MAGMA show that the corresponding FK algebra $\mathcal{E}_{B_{2}}$ has a different Hilbert polynomial:

$$
\begin{equation*}
\mathcal{H}_{B_{2}}^{\mathcal{E}}=1+4 t+8 t^{2}+12 t^{3}+16 t^{4}+20 t^{5}+24 t^{6}+28 t^{7}+\ldots \tag{3.30}
\end{equation*}
$$

Hence the Hilbert polynomials differ from degree 4 onwards, and thus $\mathcal{B}_{B_{2}} \nsupseteq \mathcal{E}_{B_{2}}$. This is the first Weyl group for which the two algebras differ. ${ }^{5}$ Note that according to [KM04], $\mathcal{B}_{B_{2}}$ is in fact infinite-dimensional.
(ii) $G=I_{2}(4)=G(4,4,2)$ : Similarly to (i) we again see that this rank two YD module gives [HV13, Example 1.2], with the same centralizer characters $\rho, \sigma$. Hence $\mathcal{B}_{B_{2}}$ and $\mathcal{B}_{I_{2}(4)}$ are isomorphic. This is not surprising as both groups are isomorphic to the dihedral group $\operatorname{Dih}_{4}$. An explicit isomorphism is given by mapping (12) $\in B_{2} \mapsto(12) \in I_{2}(4), s_{1}^{1} \in B_{2} \mapsto \theta(12) \in$ $I_{2}(4)$.
(iii) $G=G(4,2,2)$ : We claim that $\mathcal{B}_{G}$ in this case is infinite-dimensional. As it is of rank three, we can look at all possible pairs of YD summands. The summands are given by

$$
\operatorname{Supp} V^{\text {even }}=\left\{(12), \theta^{2}(12)\right\}, \quad \operatorname{Supp} V^{\text {odd }}=\left\{\theta(12), \theta^{3}(12)\right\}, \quad \operatorname{Supp} V_{2}=\left\{s_{1}^{2}, s_{2}^{2}\right\}
$$

The pair $V^{\text {odd }}, V_{2}$ gives example (i), $V^{\text {even }}, V^{\text {odd }}$ gives example (ii), and it can be show that $V^{\text {even }}, V_{2}$ again gives the same YD module as in [HV13, Example 1.2]. Hence the skeleton of $\mathcal{B}_{G}$ is


Such a skeleton is not of finite type (cf. [HV14, Theorem 2.5]) and hence $\mathcal{B}_{G}$ is infinitedimensional.

Conjecture 3.8. Up to isomorphism, the only finite-dimensional elementary Fomin-Kirillov Nichols algebras $\mathcal{B}_{G}$, for $G=G(m, p, n)$, are those of the symmetric groups $G=S_{2}, S_{3}, S_{4}, S_{5}$.

Hence, the only finite-dimensional $F K$ Nichols algebras for complex reflection groups $G(m, p, n)$ are those of $S_{2} \cong C_{2}, S_{3} \cong \operatorname{Dih}_{3}, S_{4} \cong D_{3}, S_{5}, B_{2} \cong \operatorname{Dih}_{4}, C_{3}, C_{4}, D_{2} \cong S_{2} \times S_{2}$.

Remark 3.9. Conjecture 3.8 is derived from the above results, combined with [HLV15, Conjecture 1.1]. We observe that only $G=S_{2}, S_{3}, S_{4}, S_{5}$ give elementary Nichols algebras that occur in the table [HLV15, Table 9.1]. In fact, the support of $Y_{G}$ always generates $G$, and $A_{n}$ is not a complex reflection group. It remains to check that the examples associated to $\operatorname{Aff}(5,2), \operatorname{Aff}(5,3), \operatorname{Aff}(7,3)$, and $\operatorname{Aff}(7,5)$ occurring in the list are not of the form $\mathcal{B}_{G}$. For this, note that the dimensions of the corresponding YD modules are 5 and 7 . The only simple YD modules $Y_{G}$ of these dimensions belong to the dihedral groups $D i h_{5}=G(5,5,2)$ and $D i h_{7}=G(7,7,2)$. These however correspond to the affine groups Aff $(5,-1)$ and $\operatorname{Aff}(7,-1)$, which are not isomorphic to the ones listed. In fact, MAGMA computations show that the Hilbert series are
(3.32) $\mathcal{H}_{D i h_{5}}^{\mathcal{E}}(t)=1+5 t+16 t^{3}+45 t^{3}+121 t^{4}+O\left(t^{5}\right), \quad \mathcal{H}_{D i h_{7}}^{\mathcal{E}}(t)=1+7 t+36 t^{2}+175 t^{3}+O\left(t^{4}\right)$,
which differ from all Hilbert series stated in [HLV15, Table 9.1] in degree two already. The groups $D i h_{3}=G(3,3,2)$ and $D_{3}=G(2,2,3)$ also give finite-dimensional FK Nichols algebras, however are isomorphic to $\mathcal{B}_{3}$ and $\mathcal{B}_{4}$, respectively. Hence, up to isomorphisms, $\mathcal{B}_{2}, \mathcal{B}_{3}, \mathcal{B}_{4}, \mathcal{B}_{5}$ would be the only finite-dimensional elementary FK Nichols algebras according to [HLV15, Conjecture 1.1].

Conjecture 3.10. Up to isomorphism, the only finite-dimensional Fomin-Kirillov algebras $\mathcal{E}_{G}$ for non-exceptional indecomposable Coxeter groups are those for $G=S_{2}, S_{3}, S_{4}, S_{5}$.
Remark 3.11. The only cases left to check in Conjectures 3.8 and 3.10 are among the groups $G(m, m, n)$, where $n \geqslant 3$ or $m$ odd. Recall that the algebra $\mathcal{B}_{B_{2}}$ is finite-dimensional, but $\mathcal{E}_{B_{2}}$ is not.

It is unknown whether the Nichols algebras themselves are quadratic in the symmetric group case ( $n \geqslant 6$ ). However, for cyclic groups most relations are not quadratic so we do not consider the quadratic cover.

[^2]:    ${ }^{2}$ In the table, $\xi$ is a primitive $n$-th root of unity. We omit reflections that invert given ones, or remain at one generalized Dynkin diagram.
