# Rate-Optimal Perturbation Bounds for Singular Subspaces with Applications to High-Dimensional Statistics *

#### Abstract

Perturbation bounds for singular spaces, in particular Wedin's $\sin \Theta$ theorem, are a fundamental tool in many fields including high-dimensional statistics, machine learning, and applied mathematics. In this paper, we establish separate perturbation bounds, measured in both spectral and Frobenius $\sin \Theta$ distances, for the left and right singular subspaces. Lower bounds, which show that the individual perturbation bounds are rate-optimal, are also given.

The new perturbation bounds are applicable to a wide range of problems. In this paper, we consider in detail applications to low-rank matrix denoising and singular space estimation, high-dimensional clustering, and canonical correlation analysis (CCA). In particular, separate matching upper and lower bounds are obtained for estimating the left and right singular spaces. To the best of our knowledge, this is the first result that gives different optimal rates for the left and right singular spaces under the same perturbation. In addition to these problems, applications to other high-dimensional problems such as community detection in bipartite networks, multidimensional scaling, and cross-covariance matrix estimation are also discussed.

## 1 Introduction

Singular value decomposition (SVD) and spectral methods have been widely used in statistics, probability, machine learning, and applied mathematics as well as many applications. Examples include low-rank matrix denoising (Shabalin and Nobel, 2013; Yang et al., 2014 , Donoho and Gavish, 2014), matrix completion (Candès and Recht, 2009; Candès and Tao, 2010; Keshavan et al., 2010, Gross, 2011, Chatterjee, 2014), principle component analysis (Anderson, 2003; Johnstone and Lu, 2009; Cai et al., 2013), canonical correlation analysis (Hotelling, 1936, Hardoon et al., 2004, Gao et al., 2014, 2015), community detection (von Luxburg et al., 2008; Rohe et al., 2011; Balakrishnan et al., 2011; Lei and Rinaldo, 2015). Specific applications include collaborative filtering (the Netflix problem) (Goldberg et al. 1992), multi-task learning (Argyriou et al., 2008), system identification (Liu and Vandenberghe, 2009), and sensor localization (Singer and Cucuringu, 2010, Candes and Plan, 2010), among many others. In addition, the SVD is often used to find a "warm start" for more delicate iterative algorithms, see, e.g., Cai et al. (2015b); Sun and Luo (2015).

Perturbation bounds, which concern how the spectrum changes after a small perturbation to a matrix, often play a critical role in the analysis of the SVD and spectral methods. To be more specific, for an approximately low-rank matrix $X$ and a perturbation matrix $Z$, it is crucial in many applications to understand how much the left or right singular spaces of $X$ and $X+Z$ differ from each other. This problem has been widely studied in the literature (Davis and Kahan, 1970; Wedin, 1972; Weyl, 1912; Stewart, 1991, 2006; Yu et al., 2015). Among these results, the $\sin \Theta$ theorems, established by Davis and Kahan (1970) and Wedin (1972), have become fundamental tools and are commonly used in applications. While Davis and Kahan (1970) focused on eigenvectors of symmetric matrices, Wedin's $\sin \Theta$ theorem studies the more general singular vectors for asymmetric matrices and provides a uniform perturbation bound for both the left and right singular spaces in terms of the singular value gap and perturbation level.

Several generalizations and extensions have been made in different settings after the seminal work of Wedin (1972). For example, Vu (2011), Shabalin and Nobel (2013), O'Rourke et al. (2013), Wang (2015) considered the rotations of singular vectors after random perturbations; Fan et al. (2016) gave an $\ell_{\infty}$ eigenvector perturbation bound and used the result for robust covariance estimation. See also Dopico (2000); Stewart (2006).

Despite its wide applicability, Wedin's perturbation bound is not sufficiently precise for some analyses, as the bound is uniform for both the left and right singular spaces. It clearly leads to sub-optimal bound if the left and right singular spaces change in different orders of magnitude after the perturbation. In a range of applications, especially when the row and column dimensions of the matrix differ significantly, it is even possible that one side of the singular space can be accurately recovered, while the other side cannot. The numerical
experiment given in Section 2.3 provides a good illustration for this point. It can be seen from the experiment that the left and right singular perturbation bounds behave distinctly when the row and column dimensions are significantly different. Furthermore, for a range of applications, the primary interest only lies in one of the singular spaces. For example, in the analysis of bipartite network data, such as the Facebook user-public-page-subscription network, the interest is often focused on grouping the public pages (or grouping the users). This is the case for many clustering problems. See Section 4 for further discussions.

In this paper, we establish separate perturbation bounds for the left and right singular subspaces. The bounds are measured in both the spectral and Frobenius $\sin \Theta$ distances, which are equivalent to several widely used losses in the literature. We also derive lower bounds that are within a constant factor of the corresponding upper bounds. These results together show that the obtained perturbation bounds are rate-optimal.

The newly established perturbation bounds are applicable to a wide range of problems in high-dimensional statistics. In this paper, we discuss in detail the applications of the perturbation bounds to the following high-dimensional statistical problems.

1. Low-rank matrix denoising and singular space estimation: Suppose one observes a low-rank matrix with random noise and wishes to estimate the mean matrix or its left or right singular spaces. Such a problem arises in many applications. We apply the obtained perturbation bounds to study this problem. Separate matching upper and lower bounds are given for estimating the left and right singular spaces. These results together establish the optimal rates of convergence. Our analysis shows an interesting phenomenon that in some settings it is possible to accurately estimate the left singular space but not the right one and vice versa. To the best of our knowledge, this is the first result that gives different optimal rates for the left and right singular spaces under the same perturbation. Another fact we observe is that in certain class of low-rank matrices, one can stably recover the original matrix if and only if one can accurately recover both its left and right singular spaces.
2. High-dimensional clustering: Unsupervised learning is an important problem in statistics and machine learning with a wide range of applications. We apply the perturbation bounds to the analysis of clustering high-dimensional Gaussian mixtures. Particularly in a high-dimensional two-class clustering setting, we propose a simple PCA-based clustering method and use the obtained perturbation bounds to prove matching upper and lower bounds for the misclassification rates.
3. Canonical correlation analysis (CCA): CCA is a commonly used tools in multivariate analysis to identify and measure the associations among two sets of random variables. The perturbation bounds are also applied to analyze CCA. Specifically, we
develop sharper upper bounds for estimating the left and right canonical correlation directions. To the best of our knowledge, this is the first result that captures the phenomenon that in some settings it is possible to accurately estimate one side of canonical correlation directions but not the other side.

In addition to these applications, the perturbation bounds can also be applied to the analysis of community detection in bipartite networks, multidimensional scaling, cross-covariance matrix estimation, and singular space estimation for matrix completion, and other problems to yield better results than what are known in the literature. These applications demonstrate the usefulness of the newly established perturbation bounds.

The rest of the paper is organized as follows. In Section 2, after basic notation and definitions are introduced, the perturbation bounds are presented separately for the left and right singular subspaces. Both the upper bounds and lower bounds are provided. We then apply the newly established perturbation bounds to low-rank matrix denoising and singular space estimation, high-dimensional clustering, and canonical correlation analysis in Sections 355. Other potential applications are briefly discussed in Section 6. The main theorems are proved in Section 7 and the proofs of some additional technical results are given in the Appendix.

## 2 Rate-Optimal Perturbation Bounds for Singular Subspaces

We establish in this section rate-optimal perturbation bounds for singular subspaces. We begin with basic notation and definitions that will be used in the rest of the paper.

### 2.1 Notation and Definitions

For $a, b \in \mathbb{R}$, let $a \wedge b=\min (a, b), a \vee b=\max (a, b)$. Let $\mathbb{O}_{p, r}=\left\{V \in \mathbb{R}^{p \times r}: V^{\top} V=I_{r}\right\}$ be the set of all $p \times r$ orthonormal columns and write $\mathbb{O}_{p}$ for $\mathbb{O}_{p, p}$, the set of $p$-dimensional orthogonal matrices. For a matrix $A \in \mathbb{R}^{p_{1} \times p_{2}}$, write the SVD as $A=U \Sigma V^{\top}$, where $\Sigma=\operatorname{diag}\left\{\sigma_{1}(A), \sigma_{2}(A), \cdots\right\}$ with the singular values $\sigma_{1}(A) \geq \sigma_{2}(A) \geq \cdots \geq 0$ in descending order. In particular, we use $\sigma_{\min }(A)=\sigma_{\min \left(p_{1}, p_{2}\right)}(A), \sigma_{\max }(A)=\sigma_{1}(A)$ as the smallest and largest non-trivial singular values of $A$. Several matrix norms will be used in the paper: $\|A\|=\sigma_{1}(A)$ is the spectral norm; $\|A\|_{F}=\sqrt{\sum_{i} \sigma_{i}^{2}(A)}$ is the Frobenius norm; and $\|A\|_{*}=\sum_{i} \sigma_{i}(A)$ is the nuclear norm. We denote $\mathbb{P}_{A} \in \mathbb{R}^{p_{1} \times p_{1}}$ as the projection operator onto the column space of $A$, which can be written as $\mathbb{P}_{A}=A\left(A^{\top} A\right)^{\dagger} A^{\top}$. Here $(\cdot)^{\dagger}$ represent the Moore-Penrose pseudoinverse. Given the SVD $A=U \Sigma V^{\top}$ with $\Sigma$ non-singular, a simpler form for $\mathbb{P}_{A}$ is $\mathbb{P}_{A}=U U^{\top}$. We adopt the R convention to denote the submatrix: $A_{[a: b, c: d]}$ represents the $a$-to- $b$-th row, $c$-to- $d$-th column of matrix $A$; we also use $A_{[a: b,]]}$ and $A_{[, c: c d]}$ to represent $a$-to- $b$-th full rows of $A$ and $c$-to- $d$-th full columns of $A$, respectively. We
use $C, C_{0}, c, c_{0}, \cdots$ to denote generic constants, whose actual values may vary from time to time.

We use the $\sin \Theta$ distance to measure the difference between two $p \times r$ orthogonal columns $V$ and $\hat{V}$. Suppose the singular values of $V^{\top} \hat{V}$ are $\sigma_{1} \geq \sigma_{2} \geq \cdots \geq \sigma_{r} \geq 0$, then we call $\Theta(V, \hat{V})=\operatorname{diag}\left(\cos ^{-1}\left(\sigma_{1}\right), \cos ^{-1}\left(\sigma_{2}\right), \cdots, \cos ^{-1}\left(\sigma_{r}\right)\right)$ as the principle angles. A quantitative measure of distance between the column spaces of $V$ and $\hat{V}$ is then $\|\sin \Theta(\hat{V}, V)\|$ or $\|\sin \Theta(\hat{V}, V)\|_{F}$. Some more convenient characterizations and properties of the $\sin \Theta$ distances will be given in Lemma 1 in Section 7.1.

### 2.2 Perturbation Upper Bounds and Lower Bounds

We are now ready to present the perturbation bounds for the singular subspaces. Let $X \in$ $\mathbb{R}^{p_{1} \times p_{2}}$ be an approximately low-rank matrix and let $Z \in \mathbb{R}^{p_{1} \times p_{2}}$ be a "small" perturbation matrix. Our goal is to provide separate and rate-sharp bounds for the $\sin \Theta$ distances between the left singular subspaces of $X$ and $X+Z$ and between the right singular subspaces of $X$ and $X+Z$.

Suppose $X$ is approximately rank- $r$ with the SVD $X=U \Sigma V^{\top}$, where a significant gap exists between $\sigma_{r}(X)$ and $\sigma_{r+1}(X)$. The leading $r$ left and right singular vectors of $X$ are of particular interest. We decompose $X$ as follows,

where $U \in \mathbb{O}_{p_{1}, r}, V \in \mathbb{O}_{p_{2}, r}, \Sigma_{1}=\operatorname{diag}\left(\sigma_{1}(X), \cdots, \sigma_{r}(X)\right) \in \mathbb{R}^{r \times r}, \Sigma_{2}=\operatorname{diag}\left(\sigma_{r+1}(X), \cdots\right) \in$ $\mathbb{R}^{\left(p_{1}-r\right) \times\left(p_{2}-r\right)},\left[U U_{\perp}\right] \in \mathbb{O}_{p_{1}},\left[V V_{\perp}\right] \in \mathbb{O}_{p_{2}}$ are orthogonal matrices.

Let $Z$ be a perturbation matrix and let $\hat{X}=X+Z$. Partition the SVD of $\hat{X}$ in the same way as in (1),

while $\hat{U}, \hat{U}_{\perp}, \hat{\Sigma}_{1}, \hat{\Sigma}_{2}, \hat{V}$ and $\hat{V}_{\perp}$ have the same structures as $U, U_{\perp}, \Sigma_{1}, \Sigma_{2}, V$, and $V_{\perp}$. Decompose the perturbation $Z$ into four blocks

Define

$$
z_{i j}:=\left\|Z_{i j}\right\| \quad \text { for } \quad i, j=1,2 .

Theorem 1 below provides separate perturbation bounds for the left and right singular subspaces in terms of both spectral and Frobenius $\sin \Theta$ distances.

Theorem 1 (Perturbation bounds for singular subspaces). Let $X, \hat{X}, Z$ be given as (1)-(3). Denote

\alpha:=\sigma_{\min }\left(U^{\top} \hat{X} V\right) \quad \text { and } \quad \beta:=\left\|U_{\perp}^{\top} \hat{X} V_{\perp}\right\|
$$

If $\alpha^{2}>\beta^{2}+z_{12}^{2} \wedge z_{21}^{2}$, then

& \|\sin \Theta(V, \hat{V})\| \leq \frac{\alpha z_{12}+\beta z_{21}}{\alpha^{2}-\beta^{2}-z_{21}^{2} \wedge z_{12}^{2}} \wedge 1, \quad\|\sin \Theta(V, \hat{V})\|_{F} \leq \frac{\alpha\left\|Z_{12}\right\|_{F}+\beta\left\|Z_{21}\right\|_{F}}{\alpha^{2}-\beta^{2}-z_{21}^{2} \wedge z_{12}^{2}} \wedge \sqrt{r} \\
& \|\sin \Theta(U, \hat{U})\| \leq \frac{\alpha z_{21}+\beta z_{12}}{\alpha^{2}-\beta^{2}-z_{21}^{2} \wedge z_{12}^{2}} \wedge 1, \quad\|\sin \Theta(U, \hat{U})\|_{F} \leq \frac{\alpha\left\|Z_{21}\right\|_{F}+\beta\left\|Z_{12}\right\|_{F}}{\alpha^{2}-\beta^{2}-z_{21}^{2} \wedge z_{12}^{2}} \wedge \sqrt{r} \tag{4}

One can see the respective effects of the perturbation on the left and right singular spaces. In particularly, if $z_{12} \geq z_{21}$ (which is typically the case when $p_{2} \gg p_{1}$ ), then Theorem 3 gives a sharper bound for $\|\sin \Theta(U, \hat{U})\|$ than for $\|\sin \Theta(V, \hat{V})\|$.

Remark 1. Consider the setting where $X \in \mathbb{R}^{p_{1} \times p_{2}}$ is a fixed rank- $r$ matrix with $r \leq$ $p_{1} \ll p_{2}$, and $Z \in \mathbb{R}^{p_{1} \times p_{2}}$ is a random matrix with i.i.d. standard normal entries. In this case, $Z_{11}, Z_{12}, Z_{21}$, and $Z_{22}$ are all i.i.d. standard normal matrices of dimensions $r \times r$, $r \times\left(p_{2}-r\right),\left(p_{1}-r\right) \times r$, and $\left(p_{1}-r\right) \times\left(p_{2}-r\right)$, respectively. By random matrix theory, $\alpha \geq \sigma_{r}(X)-\left\|Z_{11}\right\| \geq \sigma_{r}(X)-C\left(\sqrt{p_{1}}+\sqrt{p_{2}}\right), \beta \leq C\left(\sqrt{p_{1}}+\sqrt{p_{2}}\right), z_{12} \leq C \sqrt{p_{2}}$, and $z_{21} \leq C \sqrt{p_{1}}$ with high probability. When $\sigma_{r}(X) \geq C_{\text {gap }} p_{2} / \sqrt{p_{1}}$ for some large constant $C_{\text {gap }}$, Theorem 3 immediately implies

\|\sin \Theta(V, \hat{V})\| \leq \frac{C \sqrt{p_{2}}}{\sigma_{r}(X)}, \quad\|\sin \Theta(U, \hat{U})\| \leq \frac{C \sqrt{p_{1}}}{\sigma_{r}(X)}

Further discussions on perturbation bounds for the general i.i.d. sub-Gaussian perturbation matrix with matching lower bounds with be discussed in Section 3 .

Theorem 1 gives upper bounds for the perturbation effects. We now establish lower bounds for differences as measured by the $\sin \Theta$ distances. The lower bounds given in Theorem 2 match those in $\sqrt[10]{ }$ and $\sqrt[11]{ }$, proving that our results in Theorem 1 cannot be essentially improved. For the lower bound, it is sufficient to consider the class of exact rank$r$ matrices as the approximate low-rank matrices perturbation can be discussed similarly.

Theorem 2 (Perturbation Lower Bound). We define the following class of $(X, Z)$ pairs of $p_{1} \times p_{2}$ rank-r matrices and perturbations,
$\mathcal{F}_{r, \alpha, \beta, z_{21}, z_{12}}=\left\{(X, Z): \operatorname{rank}(X)=r, \sigma_{\min }\left(U^{\top} \hat{X} V\right) \geq \alpha,\left\|Z_{22}\right\| \leq \beta,\left\|Z_{12}\right\| \leq z_{12},\left\|Z_{21}\right\| \leq z_{21}\right\}$.

Provided that $\alpha^{2}>\beta^{2}+z_{12}^{2}+z_{21}^{2}, r<\frac{p_{1} \wedge p_{2}}{2}$ we have the following lower bound for all estimate $\tilde{V} \in O_{p_{2} \times r}$ based on the observations $\hat{X}$.

\inf _{\tilde{V}} \sup _{(X, Z) \in \mathcal{F}_{\alpha, \beta, z_{21}, z_{12}}}\|\sin \Theta(V, \tilde{V})\| \geq \frac{1}{2 \sqrt{10}}\left(\frac{\alpha z_{12}+\beta z_{21}}{\alpha^{2}-\beta^{2}-z_{12}^{2} \wedge z_{21}^{2}} \wedge 1\right) \tag{7}
\end{equation*}

Now we further define

\mathcal{G}_{r, \alpha, \beta, z_{21}, z_{12}, \tilde{z}_{21}, \tilde{z}_{12}}=\left\{(X, Z):\left\|Z_{21}\right\|_{F} \leq \tilde{z}_{21},\left\|Z_{12}\right\|_{F} \leq \tilde{z}_{12},(X, Z) \in \mathcal{F}_{\left.r, \alpha, \beta, z_{21}, z_{12}, \tilde{z}_{21}, \tilde{z}_{12}\right\}}\right\} . \tag{8}

Provided that $\alpha^{2}>\beta^{2}+z_{12}^{2}+z_{21}^{2}, \tilde{z}_{21}^{2} \leq r z_{21}^{2}, \tilde{z}_{12}^{2} \leq r z_{12}^{2}, r \leq \frac{p_{1} \wedge p_{2}}{2}$, we have the following lower bound for all estimator $\tilde{V}_{1} \in \mathbb{O}_{p_{2} \times r}$ based on the observations $\hat{X}$.

\inf _{\tilde{\tilde{V}}_{1}(X, Z) \in \mathcal{G}_{\alpha, \beta, z_{21}, z_{12}, \tilde{z}_{21}, \tilde{z}_{12}}}\|\sin \Theta(V, \tilde{V})\|_{F} \geq \frac{1}{2 \sqrt{10}}\left(\frac{\alpha \tilde{z}_{12}+\beta \tilde{z}_{21}}{\alpha^{2}-\beta^{2}-z_{12}^{2} \wedge z_{21}^{2}} \wedge \sqrt{r}\right) . \tag{9}

The following Proposition 1, which provides upper bounds for the $\sin \Theta$ distances between leading singular vectors of a matrix $A$ and arbitrary orthogonal columns $W$, can be viewed as another version of Theorem 1. For some applications, applying Proposition 1 might be more convenient than using Theorem 1 directly.

Proposition 1. Suppose $A \in \mathbb{R}^{p_{1} \times p_{2}}, \tilde{V}=\left[V V_{\perp}\right] \in \mathbb{O}_{p_{2}}$ are right singular vectors of A, $V \in \mathbb{O}_{p_{2}, r}, V_{\perp} \in \mathbb{O}_{p_{2}, p_{2}-r}$ correspond to the first $r$ and last $\left(p_{2}-r\right)$ singular vectors respectively. $\tilde{W}=\left[W W_{\perp}\right] \in \mathbb{O}_{p_{2}}$ is any orthogonal matrix with $W \in \mathbb{O}_{p_{2}, r}, W_{\perp} \in \mathbb{O}_{p_{2}, p_{2}-r}$. Given that $\sigma_{r}(A W)>\sigma_{r+1}(A)$, we have

\|\sin \Theta(V, W)\| \leq \frac{\sigma_{r+1}(A)\left\|\mathbb{P}_{(A W)} A W_{\perp}\right\|}{\sigma_{r}^{2}(A W)-\sigma_{r+1}^{2}(A)} \wedge 1,  \tag{10}\\
\|\sin \Theta(V, W)\|_{F} \leq \frac{\sigma_{r+1}(A)\left\|\mathbb{P}_{(A W)} A W_{\perp}\right\|_{F}}{\sigma_{r}^{2}(A W)-\sigma_{r+1}^{2}(A)} \wedge \sqrt{r} . \tag{11}
\end{gather*}

### 2.3 Comparisons with Wedin's sin $\Theta$ Theorem

Theorems 1 and 2 together establish separate rate-optimal perturbation bounds for the left and right singular subspaces. We now compare the results with the well-known Wedin's $\sin \Theta$ Theorem, which gives uniform upper bounds for the singular subspaces on both sides. Specifically, using the same notation as in Section 2.2, Wedin's $\sin \Theta$ Theorem states that if $\sigma_{\min }\left(\hat{\Sigma}_{1}\right)-\sigma_{\max }\left(\Sigma_{2}\right)=\delta>0$, then

\max \left\{\|\sin \Theta(V, \hat{V})\|_{F},\|\sin \Theta(U, \hat{U})\|_{F}\right\} & \leq \frac{\max \left\{\|Z \hat{V}\|_{F},\left\|\hat{U}^{\top} Z\right\|_{F}\right\}}{\delta} .

As mentioned in the introduction, the union bound on both left and right singular subspaces in Wedin's $\sin \Theta$ Theorem might be sub-optimal in some cases. For example, in the setting discussed in Remark 1, applying Wedin's theorem leads to

$$
\max \{\|\sin \Theta(V, \hat{V})\|,\|\sin \Theta(U, \hat{U})\|\} \leq \frac{C \max \left\{\sqrt{p_{1}}, \sqrt{p_{2}}\right\}}{\sigma_{r}(X)}
$$

which is sub-optimal for $\|\sin \Theta(U, \hat{U})\|$ if $p_{2} \gg p_{1}$.
We now further illustrate the advantages of having separate bounds for the left and right singular subspaces over uniform bounds through a numerical experiment. In a range of cases, especially when the numbers of rows and columns of the matrix differ significantly, it is even possible that one side of singular space can be stably recovered, while the other side cannot. The following simple numerical experiment illustrates this point. We randomly generate $X=t U V^{\top} \in \mathbb{R}^{p_{1} \times p_{2}}$ and perturbation $Z$, where $t \in \mathbb{R}, U, V$ are $p_{1} \times r$ and $p_{2} \times r$ random uniform orthonormal columns with respect to the Haar measure, and $Z=$ $\left(Z_{i j}\right)_{p_{1} \times p_{2}}$ with $Z_{i j} \stackrel{i i d}{\sim} N(0,1)$. We calculate the SVD of $X+Z$ and form the first $r$ left and right singular vectors as $\hat{U}$ and $\hat{V}$. The average losses in Frobenius and spectral $\sin \Theta$ distances for both the left and right singular space estimates with 1,000 repetitions are given in Table 2.3 for various values of $\left(p_{1}, p_{2}, r, t\right)$. It can be easily seen from this experiment that the left and right singular perturbation bounds behave very distinctly when $p_{1} \gg p_{2}$.

Table 1: Average losses in Frobenius and spectral $\sin \Theta$ distances for both the left and right singular space changes after Gaussian noise perturbations.

## 3 Low-rank Matrix Denoising and Singular-Space Estimation

In this section, we apply the perturbation bounds given in Theorem 1 for low-rank matrix denoising. It can be seen that the new perturbation bounds are particularly powerful when the matrix dimensions differ significantly. We also establish a matching lower bound for matrix low-rank matrix denoising which shows that the results are rate-optimal.

As mentioned in the introduction, accurate recovery of a low-rank matrix based on noisy observations has a wide range of applications, including magnetic resonance imaging (MRI) and relaxometry. See, e.g., Candes et al. (2013); Shabalin and Nobel (2013) and the reference therein. This problem is also important in the context of dimensional reduction. Suppose one observes a low-rank matrix with additive noise,

$$
Y=X+Z
$$

where $X=U \Sigma V^{\top} \in \mathbb{R}^{p_{1} \times p_{2}}$ is a low-rank matrix with $U \in \mathbb{O}_{p_{1}, r}, V \in \mathbb{O}_{p_{2}, r}$, and $\Sigma=$ $\operatorname{diag}\left\{\sigma_{1}(X), \ldots, \sigma_{r}(X)\right\} \in \mathbb{R}^{r \times r}$, and $Z \in \mathbb{R}^{p_{1} \times p_{2}}$ is an i.i.d. mean-zero sub-Gaussian matrix. The goal is to estimate the underlying low-rank matrix $X$ or its singular values or singular vectors.

This problem has been actively studied. For example, Bura and Pfeiffer (2008), Capitaine et al. (2009), Benaych-Georges and Nadakuditi (2012), Shabalin and Nobel (2013) focused on the asymptotic distributions of single singular values and vectors when $p_{1}, p_{2}$ and the singular values grows proportionally. Vu (2011) discussed the squared matrix perturbed by i.i.d Bernoulli matrix and derived an upper bound on the rotation angle of singular vectors. O'Rourke et al. (2013) further generalized the results in $\mathrm{Vu}(2011)$ and proposed a trio-concentrated random matrix perturbation setting. Recently, Wang (2015) provides the $\ell_{\infty}$ distance under relatively complicated settings when matrix is perturbed by i.i.d. Gaussian noise. Donoho and Gavish (2014); Gavish and Donoho (2014); Candes et al. (2013) studied the algorithm for recovering $X$, where singular value thresholding (SVT) and hard singular value thresholding (HSVT), stated as

$$
\begin{align*}
& S V T(Y)_{\lambda}=\underset{X}{\arg \min }\left\{\frac{1}{2}\|Y-X\|_{F}^{2}+\lambda\|X\|_{*}\right\}, \\
& H S V T(Y)_{\lambda}=\underset{X}{\arg \min }\left\{\frac{1}{2}\|Y-X\|_{F}^{2}+\lambda \operatorname{rank}(X)\right\} \tag{12}
\end{align*}
$$

were proposed. The optimal choice of thresholding level $\lambda^{*}$ was further discussed in Donoho and Gavish (2014) and Gavish and Donoho (2014). Especially, Donoho and Gavish (2014) proves that

$$
\inf _{\hat{X}} \sup _{\substack{X \in \mathbb{R}^{p} \times p_{2} \\ \operatorname{rank}(X) \leq r}} \mathbf{E}\|\hat{X}-X\|_{F}^{2} \asymp r\left(p_{1}+p_{2}\right),
$$

when $Z$ is i.i.d. standard normal random matrix. If one defines the class of rank- $r$ matrices, $\mathcal{F}_{r, t}=\left\{X \in \mathbb{R}^{p_{1} \times p_{2}}: \sigma_{r}(X) \geq t\right\}$, we can immediately show that the following upper bound of relative error,

$$
\begin{equation*}
\sup _{X \in \mathcal{F}_{r, t}} \mathbf{E} \frac{\|\hat{X}-X\|_{F}^{2}}{\|X\|_{F}^{2}} \leq \frac{C\left(p_{1}+p_{2}\right)}{t^{2}} \wedge 1 . \tag{13}
\end{equation*}
$$

where

$$
\hat{X}= \begin{cases}S V T(Y)_{\lambda^{*}}, & \text { if } t^{2} \geq C\left(p_{1}+p_{2}\right) \\ 0, & \text { if } t^{2}<C\left(p_{1}+p_{2}\right)\end{cases}
$$

In the following discussion, we assume that the entries of $Z=\left(Z_{i j}\right)$ have unit variance (which can be simply achieved by normalization). To be more precise, we define the class of distributions $\mathcal{G}_{\tau}$ for some $\tau>0$ as follows.

$$
\begin{equation*}
\text { If } Z \sim \mathcal{G}_{\tau} \text {, then } \mathbf{E} Z=0, \operatorname{Var}(Z)=1, \mathbf{E} \exp (t Z) \leq \exp (\tau t), \forall t \in \mathbb{R} \tag{14}
\end{equation*}
$$

The distribution of the entries of $Z, Z_{i j}$, is assumed to satisfy

$$
Z_{i j} \stackrel{i i d}{\sim} \mathcal{G}_{\tau}, \quad 1 \leq i \leq p_{1}, 1 \leq j \leq p_{2}
$$

Suppose $\hat{U}$ and $\hat{V}$ are respectively the first $r$ left and right singular vectors of $Y$. We use $\hat{U}$ and $\hat{V}$ as the estimators of $U$ and $V$ respectively. Then the perturbation bounds for singular spaces yield the following results.

Theorem 3 (Upper Bound). Suppose $X=U \Sigma V^{\top} \in \mathbb{R}^{p_{1} \times p_{2}}$ is of rank-r. There exists constants $C>0$ that only depends on $\tau$ such that

$$
\begin{array}{ll}
\mathbf{E}\|\sin \Theta(V, \hat{V})\|^{2} \leq \frac{C p_{2}\left(\sigma_{r}^{2}(X)+p_{1}\right)}{\sigma_{r}^{4}(X)} \wedge 1, & \mathbf{E}\|\sin \Theta(V, \hat{V})\|_{F}^{2} \leq \frac{C p_{2} r\left(\sigma_{r}^{2}(X)+p_{1}\right)}{\sigma_{r}^{4}(X)} \wedge r . \\
\mathbf{E}\|\sin \Theta(U, \hat{U})\|^{2} \leq \frac{C p_{1}\left(\sigma_{r}^{2}(X)+p_{2}\right)}{\sigma_{r}^{4}(X)} \wedge 1, & \mathbf{E}\|\sin \Theta(U, \hat{U})\|_{F}^{2} \leq \frac{C p_{1} r\left(\sigma_{r}^{2}(X)+p_{2}\right)}{\sigma_{r}^{4}(X)} \wedge r .
\end{array}
$$

Theorem 3 provides a non-trivial perturbation upper bound for $\sin \Theta(V, \hat{V})$ (or $\sin \Theta(U, \hat{U})$ ) if there exists a constant $C_{\text {gap }}>0$ such that

$$
\sigma_{r}^{2} \geq C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)
$$

(or $\left.\sigma_{r}^{2} \geq C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{1}\right)\right)$. In contrast, Wedin's $\sin \Theta$ Theorem requires the singular value gap $\sigma_{r}^{2}(X) \geq C_{\text {gap }}\left(p_{1}+p_{2}\right)$, which shows the power of the proposed unilateral perturbation bound.

Furthermore, the upper bounds in Theorem 3 are rate-sharp in the sense that the following matching lower bounds hold. To the best of our knowledge, this is the first result that gives different optimal rates for the left and right singular spaces under the same perturbation.

Theorem 4 (Lower Bound). Define the following class of low-rank matrices

$$
\begin{equation*}
\mathcal{F}_{r, t}=\left\{X \in \mathbb{R}^{p_{1} \times p_{2}}: \sigma_{r}(X) \geq t\right\} \tag{15}
\end{equation*}
$$

If $r \leq \frac{p_{1}}{16} \wedge \frac{p_{2}}{2}$, then

$$
\begin{aligned}
& \inf _{\tilde{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(V, \tilde{V})\|^{2} \geq c\left(\frac{p_{2}\left(t^{2}+p_{1}\right)}{t^{4}} \wedge 1\right) \\
& \inf _{\tilde{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(V, \tilde{V})\|_{F}^{2} \geq c\left(\frac{p_{2} r\left(t^{2}+p_{1}\right)}{t^{4}} \wedge r\right) \\
& \inf _{\tilde{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(U, \tilde{U})\|^{2} \geq c\left(\frac{p_{1}\left(t^{2}+p_{2}\right)}{t^{4}} \wedge 1\right) \\
& \inf _{\tilde{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(U, \tilde{U})\|_{F}^{2} \geq c\left(\frac{p_{1} r\left(t^{2}+p_{2}\right)}{t^{4}} \wedge r\right) .
\end{aligned}
$$

Remark 2. Using similar technical arguments, we can also obtain the following lower bound for estimating the low-rank matrix $X$ over $\mathcal{F}_{r, t}$ under a relative error loss,

$$
\begin{equation*}
\inf _{\tilde{X}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E} \frac{\|\tilde{X}-X\|_{F}^{2}}{\|X\|_{F}^{2}} \geq c\left(\frac{p_{1}+p_{2}}{t^{2}} \wedge 1\right) . \tag{16}
\end{equation*}
$$

Combining equations (13) and (16) yields the minimax optimal rate for relative error in matrix denoising,

$$
\inf _{\tilde{X}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E} \frac{\|\tilde{X}-X\|_{F}^{2}}{\|X\|_{F}^{2}} \asymp c\left(\frac{p_{1}+p_{2}}{t^{2}} \wedge 1\right)
$$

A interesting fact is that

$$
c\left(\frac{p_{1}+p_{2}}{t^{2}} \wedge 1\right) \asymp c\left(\frac{p_{2}\left(t^{2}+p_{1}\right)}{t^{4}} \wedge 1\right)+c\left(\frac{p_{1}\left(t^{2}+p_{2}\right)}{t^{4}} \wedge 1\right),
$$

which yields directly

$$
\inf _{\tilde{U}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(U, \tilde{U})\|^{2}+\inf _{\tilde{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(V, \tilde{V})\|^{2} \asymp \inf _{\tilde{X}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E} \frac{\|\tilde{X}-X\|_{F}^{2}}{\|X\|_{F}} .
$$

Hence, for the class of $\mathcal{F}_{r, t}$, one can stably recover $X$ in relative Frobenius norm loss if and only if one can stably recover both $U$ and $V$ in spectral $\sin \Theta$ norm.

Another interesting aspect of Theorems 3 and 4 is that, when $p_{1} \gg p_{2},\left(p_{1} p_{2}\right)^{\frac{1}{2}} \ll t^{2} \ll$ $p_{1}$, there is no stable algorithm for recovery of either the left singular space $U$ or whole matrix $X$ in the sense that there exists uniform constant $c>0$ such that

$$
\inf _{\tilde{U}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(U, \tilde{U})\|^{2} \geq c, \quad \inf _{\tilde{X}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E} \frac{\|\tilde{X}-X\|_{F}^{2}}{\|X\|_{F}^{2}} \geq c
$$

In fact, for $X=t U V^{\top} \in \mathcal{F}_{r, t}$, if we simply apply SVT or HSVT algorithms with optimal choice of $\lambda$ as proposed in Donoho and Gavish (2014) and Gavish and Donoho (2014), with high probability, $S V T_{\lambda}(\hat{X})=\operatorname{HSV} T_{\lambda}(\hat{X})=0$. On the other hand, the spectral method does provide a consistent recovery of the right singular-space according to Theorem 3.

$$
\mathbf{E}\|\sin \Theta(V, \hat{V})\|^{2} \rightarrow 0
$$

This phenomenon is well demonstrated by the simulation result (Table 2.3) provided in Section 1 .

## 4 High-dimensional Clustering

Unsupervised learning, or clustering, is an ubiquitous problem in statistics and machine learning (Hastie et al., 2009). The perturbation bounds given in Theorem 1 as well as the results in Theorems 3 and 4 have a direct implication in high-dimensional clustering. Suppose the locations of $n$ points, $X=\left[X_{1} \cdots X_{n}\right] \in \mathbb{R}^{p \times n}$, which lie in a certain $r$ dimensional subspace $\mathcal{S}$ in $\mathbb{R}^{p}$, are observed with noise

$$
Y_{i}=X_{i}+\varepsilon_{i}, \quad i=1, \cdots, n .
$$

Here $X_{i} \in \mathcal{S} \subseteq \mathbb{R}^{p}$ are fixed coordinates, $\varepsilon_{i} \in \mathbb{R}^{p}$ are random noises. The goal is to cluster the observations $Y$. Let the SVD of $X$ be given by $X=U \Sigma V^{\top}$, where $U \in \mathbb{O}_{p, r}$, $V \in \mathbb{O}_{n, r}$, and $\Sigma \in \mathbb{R}^{r \times r}$. When $p_{2} \gg p_{1} \gg r$, applying the standard algorithms (e.g. $k$-means) directly to the coordinates $Y$ may lead to sub-optimal results with expensive computational costs due to the high-dimensionality. A better approach is to first perform dimension reduction by computing the SVD of $Y$ directly or on its random projections, and then carry out clustering based on the first $r$ right singular vectors $\hat{V} \in \mathbb{O}_{n, r}$. See, e.g. Feldman et al. (2013) and Boutsidis et al. (2015), and the reference therein. It is important to note that the left singular space $U$ are not directly used in the clustering procedure. Thus Theorem 3 is more suitable for the analysis of the clustering method than Wedin's $\sin \Theta$ theorem as the method main depends on the accuracy of $\hat{V}$ as an estimate of $V$.

Let us consider the following two-class clustering problem in more detail (see Hastie et al. (2009); Azizyan et al. (2013); Jin and Wang (2014); Jin et al. (2015)). Suppose $l_{i} \in\{-1,1\}, i=1, \ldots, n$, are indicators representing the class label of the $n$-th nodes and let $\mu \in \mathbb{R}^{p}$ be a fixed vector. Suppose one observes $Y=\left[Y_{1}, \cdots, Y_{n}\right]$ where

$$
Y_{i}=l_{i} \mu+Z_{i}, \quad Z_{i} \stackrel{i i d}{\sim} N\left(0, I_{p}\right), \quad 1 \leq i \leq n,
$$

where neither the labels $l_{i}$ nor the mean vector $\mu$ are observable. The goal is to cluster the data into two groups. The accuracy of any clustering algorithm is measured by the
misclassification rate

$$
\begin{equation*}
\mathcal{M}(l, \hat{l}):=\frac{1}{n} \min _{\pi}\left|\left\{i: l_{i} \neq \pi\left(\hat{l}_{i}\right)\right\}\right| \tag{17}
\end{equation*}
$$

Here $\pi$ is any permutations on $\{-1,1\}$, as any permutation of the labels $\{-1,1\}$ does not change the clustering outcome.

In this case, $E Y_{i}$ is either $\mu$ or $-\mu$, which lies on a straight line. A simple PCA-based clustering method is to set

$$
\begin{equation*}
\hat{l}=\operatorname{sgn}(\hat{v}) \tag{18}
\end{equation*}
$$

where $\hat{v} \in \mathbb{R}^{n}$ is the first right singular vector of $Y$. We now apply the $\sin \Theta$ upper bound in Theorem 3 to analyze the performance guarantees of this clustering method. We are particularly interested in the high-dimensional case where $p \geq n$. The case where $p<n$ can be handled similarly.

Theorem 5. Suppose $p \geq n, \pi$ is any permutation on $\{-1,1\}$. When $\|\mu\|_{2} \geq C_{\text {gap }}(p / n)^{\frac{1}{4}}$ for some large constant $C_{\text {gap }}>0$, then for some other constant $C>0$ the mis-classification rate for the PCA-based clustering method $\hat{l}$ given in (18) satisfies

$$
\mathbf{E} \mathcal{M}(\hat{l}, l) \leq C \frac{n\|\mu\|_{2}^{2}+p}{n\|\mu\|_{2}^{4}}
$$

It is intuitively clear that the clustering accuracy depends on the signal strength $\|\mu\|_{2}$. The stronger the signal, the easier to cluster. In particular, Theorem 5 requires the minimum signal strength condition $\|\mu\|_{2} \geq C_{\text {gap }}(p / n)^{\frac{1}{4}}$. The following lower bound result shows that this condition is necessary for consistent clustering: When the condition $\|\mu\|_{2} \geq C_{\text {gap }}(p / n)^{\frac{1}{4}}$ does not hold, it is not possible to essentially do better than random guessing.

Theorem 6. Suppose $p \geq n$, there exists $c_{g a p}, C_{n}>0$ such that if $n \geq C_{n}$,

Remark 3. Azizyan et al. (2013) considered a similar setting when $n \geq p, l_{i}$ 's are i.i.d. Rademacher variables and derived rates of convergence for both the upper and lower bounds with a logarithmic gap between the upper and lower bounds. In contrast, with the help of the newly obtained perturbation bounds, we are able to establish the optimal misclassification rate for high-dimensional setting when $n \leq p$.

Moreover, Jin and Wang (2014) and Jin et al. (2015) considered the sparse and highly structured setting, where the contrast mean vector $\mu$ is assumed to be sparse and the nonzero coordinates are all equal. Their method is based on feature selection and PCA.

Our setting is close to the "less sparse/weak signal" case in Jin et al. (2015). In this case, they introduced a simple aggregation method with

$$
\hat{l}^{(s a)}=\operatorname{sgn}(X \hat{\mu}),
$$

where $\hat{\mu}=\arg \max _{\mu \in\{-1,0,1\}^{p}}\|X \mu\|_{q}$ for some $q>0$. The statistical limit, i.e. the necessary condition for obtaining correct labels for most of the points, is $\|\mu\|_{2}>C$ in their setting, which is smaller than the boundary $\|\mu\|_{2}>C(p / n)^{\frac{1}{4}}$ in Theorem 5. As shown in Theorem 66 the bound $\|\mu\|_{2}>C(p / n)^{\frac{1}{4}}$ is necessary. The reason for this difference is that they focused on highly structured contrast mean vector $\mu$ which only takes two values $\{0, \nu\}$. In contrast, we considered the general $\mu \in \mathbb{R}^{p}$, which leads to stronger condition and larger statistical limit. Moreover, the simple aggregation algorithm is computational difficult for a general signal $\mu$, thus the PCA-based method considered in this paper is preferred under the general dense $\mu$ setting.

## 5 Canonical Correlation Analysis

In this section, we consider an application of the perturbation bounds given in Theorem 1 to the canonical correlation analysis (CCA), which is one of the most important tools in multivariate analysis in exploring the relationship between two sets of variables (Hotelling, 1936; Anderson, 2003; Gao et al., 2014, 2015). Given two random vectors $X$ and $Y$ with a certain joint distribution, the CCA first looks for the pair of vectors $\alpha^{(1)} \in \mathbb{R}^{p_{1}}, \beta^{(2)} \in \mathbb{R}^{p_{2}}$ that maximize $\operatorname{corr}\left(\left(\alpha^{(1)}\right)^{\top} X,\left(\beta^{(1)}\right)^{\top} Y\right)$. After obtaining the first pair of canonical directions, one can further obtain the second pair $\alpha^{(2)} \in \mathbb{R}^{p_{1}}, \beta^{(2)} \in \mathbb{R}^{p_{2}}$ such that $\operatorname{Cov}\left(\left(\alpha^{(1)}\right)^{\top} X,\left(\alpha^{(2)}\right)^{\top} X\right)=\operatorname{Cov}\left(\left(\beta^{(1)}\right)^{\top} Y,\left(\beta^{(2)}\right)^{\top} Y\right)=0$, and $\operatorname{Corr}\left(\left(\alpha^{(2)}\right)^{\top} X,\left(\beta^{(2)}\right)^{\top} Y\right)$ is maximized. The higher order canonical directions can be obtained by repeating this process. If $(X, Y)$ is further assumed to have joint covariance, say

$$
\operatorname{Cov}\binom{X}{Y}=\Sigma=\left[\begin{array}{cc}
\Sigma_{X} & \Sigma_{X Y} \\
\Sigma_{Y X} & \Sigma_{Y Y}
\end{array}\right]
$$

the population canonical correlation directions can be inductively defined as the following optimization problem. For $k=1,2, \cdots$,

$$
\begin{aligned}
\left(\alpha^{(k)}, \beta^{(k)}\right)=\underset{a \in \mathbb{R}^{p_{1}, b \in \mathbb{R}^{p_{2}}}}{\arg \max } & a^{\top} \Sigma_{X Y} b, \\
& \text { subject to } \quad a^{\top} \Sigma_{X} a=b^{\top} \Sigma_{Y} b=1, a^{\top} \Sigma_{X} \alpha^{(l)}=b^{\top} \Sigma_{Y} \beta^{(l)}=0, \forall 1 \leq l \leq k-1 .
\end{aligned}
$$

A more explicit form for the canonical correlation directions is given in Hotelling (1936): $\left(\Sigma_{X}^{\frac{1}{2}} \alpha^{(k)}, \Sigma_{Y}^{\frac{1}{2}} \beta^{(k)}\right)$ is the $k$-th pair of singular vectors of $\Sigma_{X}^{-\frac{1}{2}} \Sigma_{X Y} \Sigma_{Y}^{-\frac{1}{2}}$. We combine the
leading $r$ population canonical correlation directions and write

Suppose one observes i.i.d.samples $\left(X_{i}^{\top}, Y_{i}^{\top}\right)^{\top} \sim N(0, \Sigma)$. Then the sample covariance and cross-covariance for $X$ and $Y$ can be calculated as

The standard approach to estimate the canonical correlation directions $\alpha^{(k)}, \beta^{(k)}$ is via the SVD of $\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{\Sigma}_{X Y} \hat{\Sigma}_{Y}^{-\frac{1}{2}}$

Then the leading $r$ sample canonical correlation directions can be calculated as

\hat{A}=\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{U}_{[:, 1: r]}, \quad \hat{A}=\left[\hat{\alpha}^{(1)}, \hat{\alpha}^{(2)}, \cdots, \hat{\alpha}^{(r)}\right], \quad \hat{B}=\hat{\Sigma}_{Y}^{-\frac{1}{2}} \hat{V}_{[:, 1: r]}, \quad \hat{B}=\left[\hat{\beta}^{(1)}, \hat{\beta}^{(2)}, \cdots, \hat{\beta}^{(r)}\right] . \tag{19}
\end{equation*}
$$

$\hat{A}, \hat{B}$ are consistent estimators for the first $r$ left and right canonical directions in the classical fixed dimension case.

Let $X^{*} \in \mathbb{R}^{p_{1}}$ be an independent copy of the original sample $X$, we define the following two losses to measure the accuracy of the estimator of the canonical correlation directions,

These two losses quantify how well the estimator $(\hat{A} O)^{\top} X^{*}$ can predict the values of the canonical variables $A^{\top} X^{*}$, where $O \in \mathbb{O}_{r}$ is a rotation matrix as the objects of interest here are the directions.

The following theorem gives the upper bound for one side of the canonical correlation directions. The main technical tool is the perturbation bounds proposed in Section 2 .
Theorem 7. Suppose $\left(X_{i}, Y_{i}\right) \sim N(0, \Sigma), i=1, \cdots, n$, where $S=\Sigma_{X}^{-\frac{1}{2}} \Sigma_{X Y} \Sigma_{Y}^{-\frac{1}{2}}$ is of rank$r$. Suppose $\hat{A} \in \mathbb{R}^{p_{1} \times r}$ is given by (19). Then there exist uniform constants $C_{\text {gap }}, C, c>0$ such that whenever $\sigma_{r}(S)^{2} \geq \frac{C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{1}+p_{2}^{3 / 2} n^{-\frac{1}{2}}\right)}{n}$,

\mathbf{P}\left(L_{\mathrm{sp}}(\hat{A}, A) \leq \frac{C p_{1}\left(n \sigma_{r}^{2}(S)+p_{2}\right)}{n^{2} \sigma_{r}^{4}(S)}\right) \geq 1-C \exp \left(-c p_{1} \wedge p_{2}\right), \\
\mathbf{P}\left(L_{F}(\hat{A}, A) \leq \frac{C p_{1} r\left(n \sigma_{r}^{2}(S)+p_{2}\right)}{n^{2} \sigma_{r}^{4}(S)}\right) \geq 1-C \exp \left(-c p_{1} \wedge p_{2}\right) .
\end{gathered}

The results for $\hat{B}$ can be written down similarly.

Remark 4. Chen et al. (2013) and Gao et al. (2014, 2015) considered sparse CCA, where the canonical correlation directions $A$ and $B$ are assumed to be jointly sparse. In particular, Chen et al. (2013) and Gao et al. (2015) proposed estimators under different settings and provided a unified rate-optimal bound for jointly estimating left and right canonical correlations. Gao et al. (2014) proposed another computationally feasible estimators $\hat{A}^{*}$ and $\hat{B}^{*}$ and provided minimax rate-optimal bound for $L_{F}\left(\hat{A}^{*}, A\right)$ under regularity conditions that in fact enable us to also prove the consistency of $\hat{B}^{*}$.

Now let us consider the setting where $p_{2} \gg p_{1}, \frac{p_{2}}{n} \gg \sigma_{r}^{2}(S)=t^{2} \gg \frac{\left(p_{1} p_{2}\right)^{\frac{1}{2}}}{n}$. The lower bound result in Theorem 3.3 by Gao et al. (2014) implies that there is no consistent estimator for the right canonical correlation directions $B$. While Theorem 7 given above shows that the left sample canonical correlation directions $\hat{A}$ are a consistent estimator of $A$. This interesting phenomena again shows the merit of our proposed unilateral perturbation bound.

## 6 Discussions

We have established in the present paper new and rate-optimal perturbation bounds, measured in both spectral and Frobenius $\sin \Theta$ distances, for the left and right singular subspaces separately. These perturbation bounds are widely applicable to the analysis of many highdimensional problems. In particular, we applied the perturbation bounds to study three important problems in high-dimensional statistics: low-rank matrix denoising and singular space estimation, high-dimensional clustering and CCA. As mentioned in the introduction, in addition to these problems and possible extensions discussed in the previous sections, the obtained perturbation bounds can be used in a range of other applications including community detection in bipartite networks, multidimensional scaling, cross-covariance matrix estimation, and singular space estimation for matrix completion. We briefly discuss these problems here.

An interesting application of the perturbation bounds given in Section 2 is community detection in bipartite graphs. Community detection in networks has attracted much recent attention. The focus of the current community detection literature has been mainly on unipartite graph (i.e., there are only one type of nodes). However in some applications, the nodes can be divided into different types and only the interactions between the different types of nodes are available or of interest, such as people vs. committees, Facebook users vs. public pages (see Melamed (2014); Alzahrani and Horadam (2016)). The observations on the connectivity of the network between two types of nodes can be described by an adjacency matrix $A$, where $A_{i j}=1$ if the $i$-th Type 1 node and $j$-th Type 2 node are connected, and $A_{i j}=0$ otherwise. The spectral method is one of the most commonly
used approaches in the literature with theoretical guarantees (Rohe et al., 2011; Lei and Rinaldo, 2015). In a bipartite network, the left and right singular subspaces could behave very differently from each other. Our perturbation bounds can be used for community detection in bipartite graph and potentially lead to sharper results in some settings.

Another possible application lies in multidimensional scaling (MDS) with distance matrix between two sets of points. MDS is a popular method of visualizing the data points embedded in low-dimensional space based on the distance matrices Borg and Groenen, 2005). Traditionally MDS deals with unipartite distance matrix, where all distances between any pairs of points are observed. In some applications, the data points are from two groups and one is only able to observe its biparitite distance matrix formed by the pairwise distances between points from different groups. As the SVD is a commonly used technique for dimension reduction in MDS, the perturbation bounds developed in this paper can be potentially used for the analysis of MDS with bipartite distance matrix.

In some applications, the cross-covariance matrix, not the overall covariance matrix, is of particular interest. (Cai et al., 2015a) considered multiple testing of cross-covariances in the context of the phenome-wide association studies (PheWAS). Suppose $X \in \mathbb{R}^{p_{1}}$ and $Y \in \mathbb{R}^{p_{2}}$ are jointly distributed with covariance matrix $\Sigma$. Given $n$ i.i.d. samples $\left(X_{i}, Y_{i}\right)$, $i=1, \cdots, n$, from the joint distribution, one wishes to make statistical inference for the cross-covariance matrix $\Sigma_{X Y}$. If $\Sigma_{X Y}$ has low-rank structure, the perturbation bounds established in Section 2 could be potentially applied to make statistical inference for $\Sigma_{X Y}$.

Matrix completion, whose central goal is to recover a large low-rank matrix based on a limited number of observable entries, has been widely studied in last decade. Among various methods for matrix completion, spectral method is fast, easy to implement and achieves good performance (Keshavan et al., 2010; Chatterjee, 2014, Cho et al., 2015). The new perturbation bounds can potentially used for singular space estimation under the matrix completion setting to yield better results.

## 7 Proofs

We prove the main results in Sections 2, 3 and 4 in this section. The proofs for CCA and the additional technical results are given in the Appendix.

### 7.1 Proofs of General Unilateral Perturbation Bounds

Some technical tools are needed to prove Theorems 1. 2 and Proposition 1. In particular, we need a few useful properties of $\sin \Theta$ distances given below in Lemma 1. Specifically, Lemma 1 provides some more convenient expressions than the definitions for the $\sin \Theta$ distances. It also shows that they are indeed distances as they satisfy triangular inequality.

Some other widely used metrics for orthogonal spaces, including

are shown to be equivalent to the $\sin \Theta$ distances.
Lemma 1 (Properties of the $\sin \Theta$ Distances). The following properties hold for the $\sin \Theta$ distances.

1. (Equivalent Expressions) Suppose $V, \hat{V} \in \mathbb{O}_{p, r}$. If $V_{\perp}$ is an orthogonal extension of $V$, namely $\left[V V_{\perp}\right] \in \mathbb{O}_{p}$, we have the following equivalent forms for $\|\sin \Theta(\hat{V}, V)\|$ and $\|\sin \Theta(\hat{V}, V)\|_{F}$,

2. (Triangular Inequality) For any $V_{1}, V_{2}, V_{3} \in \mathbb{O}_{p, r}$,

Proof of Proposition 1. First, we can rotate the right singular space by right multiplying the whole matrices $A, V^{\top}, W^{\top}$ by $\left[W W_{\perp}\right]$ without changing the singular values and left singular vectors. Thus without loss of generality, we assume that

$\left[\bar{U} \quad \bar{U}_{\perp}\right]^{\top}$, then rotate the right singular space by right multiplying $A_{[:, 1: r]}$ by $\bar{V}$. After this rotation, the singular structure of $A, A W$ are unchanged. Again without loss of generality, we can assume that $\left[\bar{U} \bar{U}_{\perp}\right]^{\top}=I_{p_{1}}, \bar{V}=I_{r}$. After these two steps of rotations, the formation of $A$ is much simplified,

By basic theory in algebra, the $i$-th eigenvalue of $A^{\top} A$ is equal to $\sigma_{i}^{2}(A)$, and the $i$-th eigenvector of $A^{\top} A$ is equal to the $i$-th right singular vector of $A$ (up-to-sign). Suppose the singular vectors of $A$ are $\tilde{V}=\left[v^{(1)}, v^{(2)}, \cdots, v^{\left(p_{2}\right)}\right]$, where the singular values can be further decomposed into two parts as

It is more complicated to give a upper bound for the spectral norm of $\left[\alpha^{(r+1)} \ldots \alpha^{\left(p_{2}\right)}\right]$.
Suppose $s=\left(s_{r+1}, \cdots, s_{p_{2}}\right) \in \mathbb{R}^{p_{2}-r}$ is any vector with $\|s\|_{2}=1$. Based on (30),

\stackrel{\text { 311 }}{=} \sum_{k=r+1}^{p_{2}} \sum_{l=0}^{\infty} \frac{-s_{k} \sigma_{k}^{2 l}(A)}{\sigma_{i}^{2 l+1}(A W)} y^{(i) \top} \beta^{(k)}=\sum_{l=0}^{\infty} \frac{-y^{(i) \top}}{\sigma_{i}^{2 l+1}(A W)}\left(\sum_{k=r+1}^{p_{2}} s_{k} \sigma_{k}^{2 l}(A) \beta^{(k)}\right) .
\end{array}
$$

Hence,

& \leq \sum_{l=0}^{\infty} \frac{\left\|\left[y^{(1)} y^{(2)} \cdots y^{(r)}\right]\right\|}{\sigma_{r}^{2 l+1}(A W)} \cdot\left\|\left[\beta^{(r+1)} \beta^{(r+2)} \cdots \beta^{\left(p_{2}\right)}\right]\right\| \\
& \cdot\left\|\left(s_{r+1} \sigma_{r+1}^{2 l}(A), \cdots, s_{p_{2}} \sigma_{p_{2}}^{2 l}(A)\right)\right\|_{2} \\
& \stackrel{\text { (27) (33) (31) }}{\leq} \sum_{l=0}^{\infty} \frac{\left\|\tilde{U}^{\top} A W_{\perp}\right\|}{\sigma_{r}^{2 l+1}(A W)} \cdot \sigma_{r+1}^{2 l}(A)\|s\|_{2} \\

\left\|\left[\alpha^{(r+1)} \cdots \alpha^{\left(p_{2}\right)}\right]\right\| \leq \frac{\left\|\tilde{U}^{\top} A W_{\perp}\right\| \sigma_{r}(A W)}{\sigma_{r}^{2}(A W)-\sigma_{r+1}^{2}(A)}
$$

Note the definition of $\alpha^{(i)}$ in (29), we know $\left[\alpha^{(r+1)} \alpha^{(r+2)} \cdots \alpha^{\left(p_{2}\right)}\right]=\tilde{V}_{\left[1: r,(r+1): p_{2}\right]}=\left(V_{\perp}\right)_{[1: r,]]}$. Thus,

\|\sin \Theta(V, W)\| \stackrel{\sqrt[222]{=}}{\|} W^{\top} V_{\perp}\|=\|\left[\alpha^{(r+1)} \cdots \alpha^{\left(p_{2}\right)}\right] \| \leq \frac{\left\|\tilde{U}^{\top} A W_{\perp}\right\| \sigma_{r}(A W)}{\sigma_{r}^{2}(A W)-\sigma_{r+1}^{2}(A)}, \\
\|\sin \Theta(V, W)\|_{F}^{2} \stackrel{\sqrt[23]{=}}{=}\left\|W^{\top} V_{\perp}\right\|_{F}^{2}=\left\|\left[\alpha^{(r+1)} \cdots \alpha^{\left(p_{2}\right)}\right]\right\|_{F}^{2} \leq \frac{\left\|\tilde{U}^{\top} A W_{\perp}\right\|_{F}^{2} \sigma_{r}^{2}(A W)}{\left(\sigma_{r}^{2}(A W)-\sigma_{r+1}^{2}(A)\right)^{2}} . \tag{34}
\end{gather*}
$$

Finally, since $\bar{U}$ is the left singular vectors of $A W$,

The upper bounds 1 in 10 and $\sqrt{r}$ on (11) are trivial. Therefore, we have finished the proof of Proposition 1.

Proof of Theorem 1. Before proving this theorem, we introduce the following lemma on the inequalities of the singular values in the perturbed matrix.

Lemma 2. Suppose $X \in \mathbb{R}^{p \times n}, Y \in \mathbb{R}^{p \times n}, \operatorname{rank}(X)=a, \operatorname{rank}(Y)=b$,

1. $\sigma_{a+b+1-r}(X+Y) \leq \min \left(\sigma_{a+1-r}(X), \sigma_{b+1-r}(Y)\right)$ for $r \geq 1$;
2. if we further have $X^{\top} Y=0$ or $X Y^{\top}=0$, we must have $a+b \leq n \wedge p$, and

for any $r \geq 1$. Also,

The proof of Lemma 2 is provided in the Appendix. Applying Lemma 2 we get $\sigma_{\text {min }}^{2}(\hat{X} V)=\sigma_{r}^{2}(\hat{X} V)=\sigma_{r}^{2}\left(U^{\top} \hat{X} V+U_{\perp}^{\top} \hat{X} V\right) \geq \sigma_{r}^{2}\left(U^{\top} \hat{X} V\right)=\alpha^{2}, \quad$ (by Lemma 2Part 2.)

Since $\hat{X}=U_{\perp} U_{\perp}^{\top} \hat{X}+U U^{\top} \hat{X}=\hat{X} V_{\perp} V_{\perp}^{\top}+\hat{X} V V^{\top}$, and $\operatorname{rank}\left(\hat{X} V V^{\top}\right), \operatorname{rank}\left(U U^{\top} \hat{X}\right) \leq r$, we have

& =\min \left\{\sigma_{1}\left(Z_{21}+U_{\perp}^{\top} \hat{X} V_{\perp}\right), \sigma_{1}\left(Z_{12}+U_{\perp}^{\top} \hat{X} V_{\perp}\right)\right\} \\
& \leq\left(\beta^{2}+z_{12}^{2}\right) \wedge\left(\beta^{2}+z_{21}^{2}\right) \quad(\text { by Lemma } 2 \text { Part 2.) } \\
& =\beta^{2}+z_{12}^{2} \wedge z_{21}^{2} .
\end{aligned}
$$

We shall also note the fact that for any matrix $A \in \mathbb{R}^{p \times r}$ with $r \leq p$, denote the SVD as $A=U_{A} \Sigma_{A} V_{A}^{\top}$, then

& \leq\left\|V^{\top} \hat{X}^{\top}\left(V^{\top} \hat{X}^{\top} \hat{X} V\right)^{\dagger}\right\| \cdot\left\|(\hat{X} V)^{\top} \hat{X} V_{\perp}\right\| \frac{\sqrt[37]{37}}{\leq} \sigma_{\min }^{-1}(\hat{X} V)\left\|V^{\top} \hat{X}^{\top} \hat{X} V_{\perp}\right\| \\
& \leq \frac{1}{\alpha}\left(\left\|V^{\top} \hat{X}^{\top} U\right\| \cdot\left\|Z_{12}\right\|+\left\|Z_{21}^{\top}\right\| \cdot\left\|U_{\perp}^{\top} \hat{X} V_{\perp}^{\top}\right\|\right) \leq \frac{\alpha z_{12}+\beta z_{21}}{\alpha} .
\end{aligned}
$$

Similarly,

\left\|P_{(\hat{X} V)} \hat{X} V_{\perp}\right\|_{F} \leq \sigma_{\min }^{-1}(\hat{X} V)\left\|V^{\top} \hat{X}^{\top} \hat{X} V_{\perp}\right\|_{F} \leq \frac{\alpha\left\|Z_{12}\right\|_{F}+\beta\left\|Z_{21}\right\|_{F}}{\alpha} .

Next, applying Proposition 1 by setting $A=\hat{X}, \tilde{W}=\left[V V_{\perp}\right], \tilde{V}=\left[\hat{V} \hat{V}_{\perp}\right]$, we could obtain (4).

## Proof of Theorem 2,

The construction of lower bound relies on the following design of 2-by-2 blocks.
Lemma 3 (SVD of 2-by-2 matrices). Suppose 2-by-2 matrix A satisfies

\end{array}\left[\begin{array}{ccc}
r & r & p_{2}-2 r \\
\sigma_{2} u_{12} v_{12} I_{r} & \sigma_{2} u_{12} v_{22} I_{r} & 0 \\
\sigma_{2} u_{22} v_{12} I_{r} & \sigma_{2} u_{22} v_{22} I_{r} & 0 \\
0 & 0 & 0
\end{array}\right] ;
\end{aligned}
$$

We can see $\operatorname{rank}\left(X_{1}\right)=\operatorname{rank}\left(X_{2}\right)=r$,

\end{gathered}\left[\begin{array}{ccc}

It is easy to check that both $\left(X_{1}, Z_{1}\right)$ and $\left(X_{2}, Z_{2}\right)$ are both in $\mathcal{F}_{r, \alpha, \beta, z_{12}, z_{21}}$. Assume $V_{1}$, $V_{2}$ are the first $r$ singular vectors of $X_{1}$ and $X_{2}$, respectively. Based on the structure of $X_{1}, X_{2}$, we know

\geq \frac{1}{2}\left(\left\|\sin \Theta\left(\tilde{V}, V_{1}\right)\right\|+\left\|\sin \Theta\left(\tilde{V}, V_{2}\right)\right\|\right)  \tag{42}\\
\stackrel{\text { Lemma }}{\geq} \frac{1}{2}\left\|\sin \Theta\left(V_{1}, V_{2}\right)\right\| \stackrel{40 p}{\geq} \frac{1}{2 \sqrt{10}}\left(\frac{\alpha z_{12}+\beta z_{21}}{\alpha^{2}-\beta^{2}-z_{12}^{2} \wedge z_{21}^{2}} \wedge 1\right),
\end{gather*}
$$

which gives us (7). For the proof of the Frobenius norm loss lower bound (8), the construction of pairs $\left(X_{1}, Z_{1}\right),\left(X_{2}, Z_{2}\right)$ is essentially the same. We just need to construct similar pairs of $\left(X_{1}, Z_{1}\right)$ and $\left(X_{2}, Z_{2}\right)$ by replacing $z_{12}, z_{21}$ by $\tilde{z}_{12} / \sqrt{r}, \tilde{z}_{21} / \sqrt{r}$. Based on the similar calculation, we can finish the proof of Theorem 2.

### 7.2 Proofs for Matrix Denoising

Proof of Theorem 3. We need some technical results for the proof of this theorem. Specifically, the following lemma relating to random matrix theory plays an important part.

Lemma 4 (Properties related to Random Matrix Theory). Suppose $X \in \mathbb{R}^{p_{1} \times p_{2}}$ is a rank-r matrix with right singular space as $V \in \mathbb{O}_{n, r}, Z \in \mathbb{R}^{p_{1} \times p_{2}}, Z \stackrel{i i d}{\sim} \mathcal{G}_{\tau}$ is an i.i.d. sub-Gaussian random matrix. $Y=X+Z$. Then there exists constants $C, c$ only depending on $\tau$ such that for any $x>0$,

& \mathbf{P}\left(\sigma_{r+1}^{2}(Y) \leq p_{1}(1+x)\right) \leq C \exp \left\{C p_{2}-c p_{1} \cdot x^{2} \wedge x\right\} . \tag{44}
\end{align*}
$$

Moreover, there exists $C_{\text {gap }}, C, c$ which only depends on $\tau$, such that whenever $\sigma_{r}^{2}(X) \geq$ $C_{\text {gap }} p_{2}$, for any $x>0$ we have

\end{align*}

The following lemma provides an upper bound for matrix spectral norm based on an $\varepsilon$-net argument.

Lemma 5 ( $\varepsilon$-net Argument for Unit Ball). For any $p \geq 1$, denote $\mathbb{B}^{p}=\left\{x: x \in \mathbb{R}^{p},\|x\|_{2} \leq\right.$ $1\}$ as the $p$-dimensional unit ball. Suppose $K \in \mathbb{R}^{p_{1} \times p_{2}}$ is a random matrix. Then we have for $t>0$,

Now we start to prove Theorem 3. We only need to focus on the losses of $\hat{V}$ since the results for $\hat{U}$ are symmetric. Besides, we only need to prove the spectral norm loss, as $\sin \Theta(\hat{V}, V)$ is a $r \times r$ matrix $\|\sin \Theta(V, \hat{V})\|_{F}^{2} \leq r\|\sin \Theta(V, \hat{V})\|^{2}$. Throughout the proof, we use $C$ and $c$ to represent generic "large" and "small" constants, respectively. These constants $C, c$ are uniform and only relying on $\tau$, while the actual values may vary in different formulas.

Next, we focus on the scenario that $\sigma_{r}^{2}(X) \geq C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)$ for some large constant $C_{\text {gap }}>0$ only relying on $\tau$. The other case will be considered later. By Lemma 4, there exists constants $C, c$ only depending on $\tau$ such that

\mathbf{P}\left(\sigma_{r}^{2}(Y V) \geq \sigma_{r}^{2}(X)+p_{1}-\frac{\sigma_{r}^{2}(X)}{3}\right) \leq C \exp \left\{C r-c \min \left(\sigma_{r}^{2}(X), \frac{\sigma_{r}^{4}(X)}{\sigma_{r}^{2}(X)+p_{1}}\right)\right\}, \\
\mathbf{P}\left(\sigma_{r+1}^{2}(Y) \leq p_{1}+\frac{1}{3} \sigma_{r}^{2}(X)\right) \leq C \exp \left\{C p_{2}-c \min \left(\sigma_{r}^{2}(X), \frac{\sigma_{r}^{4}(X)}{p_{1}}\right)\right\}, \\
\mathbf{P}\left\{\left\|\mathbb{P}_{Y V} Y V_{\perp}\right\| \geq x\right\} \leq C \exp \left\{C p_{2}-c \min \left(x^{2}, x \sqrt{\sigma_{r}^{2}(X)+p_{1}}\right)\right\}+C \exp \left\{-c\left(\sigma_{r}^{2}(X)+p_{1}\right)\right\} . \tag{47}
\end{gather*}
$$

When $C_{\text {gap }}$ is large enough, it holds that $\sigma_{r}^{4}(X) /\left(\sigma_{r}^{2}(X)+p_{1}\right) \geq C p_{2}$. Then

& \quad c \min \left(\sigma_{r}^{2}(X), \frac{\sigma_{r}^{4}(X)}{p_{1}}\right)-C p_{2} \geq c \frac{\sigma_{r}^{4}(X)}{\sigma_{r}^{2}(X)+p_{1}}-C p_{2} \geq \frac{c}{2} \frac{\sigma_{r}^{4}(x)}{\sigma_{r}^{2}(X)+p_{1}} . \\
& c \min \left(x^{2}, \sqrt{\sigma_{r}^{2}(X)+p_{1}} x\right)-C p_{2}=c\left(\sigma_{r}^{2}(X)+p_{1}\right)-C p_{2} \geq \frac{c}{2}\left(\sigma_{r}^{2}(X)+p_{1}\right), \\
& \geq \frac{c}{2} \frac{\sigma_{r}^{4}(X)}{\sigma_{r}^{2}(X)+p_{1}} \text { if } x=\sqrt{\sigma_{r}^{2}(X)+p_{1}} .
\end{aligned}
$$

To sum up, if we denote the event $Q$ as
$Q=\left\{\sigma_{r}^{2}(Y V) \geq \sigma_{r}^{2}(X)+p_{1}-\frac{\sigma_{r}^{2}(X)}{3}, \sigma_{r+1}^{2}(Y) \leq p_{1}+\frac{1}{3} \sigma_{r}^{2}(X),\left\|\mathbb{P}_{Y V} Y V_{\perp}\right\| \leq \sqrt{\sigma_{r}^{2}(X)+p_{1}}\right\}$,
when $\sigma_{r}^{2}(X) \geq C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)$ for some large constant $C_{\text {gap }}>0$,

$$
\begin{equation*}
\mathbf{P}\left(Q^{c}\right) \leq C \exp \left\{-c \frac{\sigma_{r}^{4}(X)}{\sigma_{r}^{2}(X)+p_{1}}\right\} . \tag{48}
\end{equation*}
$$

Under event $Q$, we can apply Proposition 1 and obtain

Here we used the fact that $\frac{x^{2}}{\left(x^{2}-y^{2}\right)^{2}}$ is a decreasing function of $x$ and increasing function of $y$ when $x>y \geq 0$.

Next we shall note that $\|\sin \Theta(\hat{V}, V)\| \leq 1$ for any $\hat{V}, V \in \mathbb{O}_{p_{2}, r}$. Therefore,

\leq & \frac{C\left(\sigma_{r}^{2}(X)+p_{1}\right)}{\sigma_{r}^{4}(X)} \mathbf{E}\left\|\mathbb{P}_{Y V} Y V_{\perp}\right\|^{2} 1_{Q}+\mathbf{P}\left(Q^{c}\right) . \tag{49}
\end{align*}

By basic property of exponential function,

\mathbf{P}\left(Q^{c}\right) \stackrel{48}{\leq} \exp \left\{-c \frac{\sigma_{r}^{4}(X)}{\sigma_{r}^{2}(X)+p_{1}}\right\} \leq C \frac{\sigma_{r}^{2}(X)+p_{1}}{\sigma_{r}^{4}(X)} \leq C \frac{p_{2}\left(\sigma_{r}^{2}(X)+p_{1}\right)}{\sigma_{r}^{4}(X)} \tag{50}
\end{equation*}
$$

It remains to consider $\mathbf{E}\left\|\mathbb{P}_{Y V} Y V_{\perp}\right\|^{2} 1_{Q}$. Denote $T=\left\|\mathbb{P}_{Y V} Y V_{\perp}\right\|$. Applying Lemma 4 again, we have for some constant $C_{x}$ to be determined a little while later that

& \leq C_{x} p_{2}+\int_{C_{x} p_{2}}^{\sigma_{r}^{2}(X)+p_{1}} \mathbf{P}\left(T^{2} 1_{\left\{T^{2} \leq \sigma_{r}^{2}(X)+p_{1}\right\}} \geq t\right) d t \\
& \stackrel{477}{\leq} C_{x} p_{2}+\int_{C_{x} p_{2}}^{\sigma_{r}^{2}(X)+p_{1}} C\left(\exp \left\{C p_{2}-c t\right\} d t+\exp \left\{-c\left(\sigma_{r}^{2}(X)+p_{1}\right)\right\}\right) d t \\
& \leq C_{x} p_{2}+C\left(\sigma_{r}^{2}(X)+p_{1}\right) \exp \left\{-c\left(\sigma_{r}^{2}(X)+p_{1}\right)\right\}+C \exp \left(C p_{2}\right) \cdot \exp \left(-c C_{x} p_{2}\right) \frac{1}{c} \\
& \leq C_{x} p_{2}+C+\frac{C}{c} \exp \left(\left(C-c C_{x}\right) p_{2}\right) .
\end{aligned}
$$

As we could see we can choose $C_{x}$ large enough, but only relying on other constants $C, c$ in the inequalities above, to ensure that

for large constant $C>0$ as long as $p_{2} \geq 1$. Now, combining (49), (50), (51) as well as the trivial upper bound 1 , we obtain

as long as $\sigma_{r}^{2}(X) \geq C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)$ for some large enough $C_{\text {gap }}$.
Finally when $\sigma_{r}^{2}(X)<C_{\text {gap }}\left(\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)$, we have

= & \frac{p_{1}+C_{\text {gap }}\left(p_{1} p_{2}\right)^{\frac{1}{2}}+C_{\text {gap }} p_{2}}{C_{\text {gap }}^{2}\left(p_{1}+2\left(p_{1} p_{2}\right)^{\frac{1}{2}}+p_{2}\right)} \geq \min \left(1, \frac{1}{C_{\text {gap }}}\right), \tag{52}
\end{align*}
$$

then

$$
\mathbf{E}\|\sin \theta(\hat{V}, V)\|^{2} \leq 1 \leq \frac{C p_{2}\left(\sigma_{r}^{2}(X)+p_{1}\right)}{\sigma_{r}^{4}(X)} \wedge 1
$$

when $C \geq \min ^{-1}\left(1,1 / C_{\text {gap }}\right)$. In summary, no matter what value $\sigma_{r}^{2}(X)$ takes, we always have

Proof of Theorem 4. Since $\|\sin \Theta(\hat{V}, V)\| \geq \frac{1}{\sqrt{r}}\|\sin \Theta(\hat{V}, V)\|_{F}$, we only need to prove the Frobenius norm lower bound. Particularly we focus on the case with Gaussian noise with mean 0 and variance 1, i.e. $Z_{i j} \stackrel{i i d}{\sim} N(0,1)$. The technical tool we use to develop such lower bound include the generalized Fano's Lemma.

One interesting aspect of this singular space estimation problem is that, multiple sampling distribution $P_{X}$ correspond to one target parameter $V$. In order to proceed, we select one "representative", either a distribution $P_{V}$ or a mixture distribution $\bar{P}_{V, t}$ for each $V$, and consider the estimation with samples from "representative" distribution. In order to bridge the representative estimation and the original estimation problem, we introduce the following lower bound lemma.

Lemma 6. Let $\left\{P_{\theta}: \theta \in \Theta\right\}$ be a set of probability measures in Euclidean space $\mathbb{R}^{p}$, let $T: \Theta \rightarrow \Phi$ be a function which maps $\theta$ into another metric space $\phi \in(\Phi, d)$. For each $\phi \in \Phi$, denote $\operatorname{co}\left(\mathcal{P}_{\phi}\right)$ as the convex hull of the set of probability measures $\mathcal{P}_{\phi}=\left\{P_{\theta}: T(\theta)=\phi\right\}$. If we choose a representative $P_{\phi}$ in each co $\left(P_{\phi}\right)$, then for any estimator $\hat{\phi}$ based on the sample generated from $P_{\theta}$ with $\phi=T(\theta)$, and any estimator $\hat{\phi}^{\prime}$ based on the samples generated from $P_{\theta_{\phi}}$, we have

\inf _{\hat{\phi}} \sup _{\theta \in \Theta} \mathbf{E}_{P_{\theta}}\left[d^{2}(T(\theta), \hat{\phi})\right] \geq \inf _{\hat{\phi}} \sup _{\phi \in \Phi} \mathbf{E}_{P_{\phi}}\left[d^{2}(\phi, \hat{\phi})\right] . \tag{53}
\end{equation*}
$$

We will prove this theorem separately in two cases according to $t: t^{2} \leq p_{1} / 4$ or $t^{2}>p_{1} / 4$.

- First we consider when $t^{2} \leq p_{1} / 4$. For each $V \in \mathbb{O}_{p_{2}, r}$, we define the following class of density $P_{Y}$, where $Y=X+Z$ and the right singular space of $X$ is $V$.

X \in \mathcal{F}_{r, t}, \text { the right singular vectors of } X \text { is } V O, O \in \mathbb{O}_{r}
\end{array}\right\} .
$$

For each $V \in \mathbb{O}_{p_{2}, r}$, we construct the following Gaussian mixture measure $\bar{P}_{V, t} \in$ $\mathbb{R}^{p_{1} \times p_{2}}$.

$$
\begin{align*}
& \bar{P}_{V, t}(Y)=C_{V, t} \int_{W \in \mathbb{R}^{p_{1} \times r: \sigma_{\min }(W) \geq 1 / 2}} \frac{1}{(2 \pi)^{p_{1} p_{2} / 2}} \exp \left(-\left\|Y-2 t W V^{\boldsymbol{\top}}\right\|_{F}^{2} / 2\right)  \tag{55}\\
& \cdot\left(\frac{p_{1}}{2 \pi}\right)^{p_{1} r / 2} \exp \left(-p_{1}\|W\|_{F}^{2} / 2\right) d W
\end{align*}
$$

Here $C_{V, t}$ is the constant which normalizes the integral and makes $\bar{P}_{V, t}$ a valid probability density. To be specific

C_{V, t}^{-1}=\int_{Y} P_{V, t}(Y) d Y=\mathbf{P}\left(\sigma_{\min }(W) \geq 1 / 2 \mid W \in \mathbb{R}^{p_{1} \times r}, W \stackrel{i i d}{\sim} N\left(0,1 / p_{1}\right)\right) .
$$

Moreover, since $2 t W V^{\top}$ is rank- $r$ with the least singular value no less than $t$ in the event that $\sigma_{\min }(W) \geq 1 / 2, \bar{P}_{V, t}$ is a mixture density of $\mathcal{P}_{V, t}$, i.e. $\bar{P}_{V, t} \in \operatorname{co}\left(\mathcal{P}_{V, t}\right)$.

The following lemma, whose proof is provided in the Appendix, gives a upper bound for the KL divergence between $\bar{P}_{V, t}$ and $\bar{P}_{V^{\prime}, t}$.

Lemma 7. Under the assumption of Theorem 4 and $t^{2} \leq p_{1} / 4$, for any $V, V^{\prime} \in \mathbb{O}_{p_{2}, r}$, we have

D\left(\bar{P}_{V, t} \| \bar{P}_{V^{\prime}, t}\right) \leq \frac{16 t^{4}}{2\left(4 t^{2}+p_{1}\right)}\left\|\sin \Theta\left(V, V^{\prime}\right)\right\|_{F}^{2}+C_{K L} \tag{56}
\end{equation*}
$$

where $C_{K L}$ is some uniform constant.
We then consider the metric $\left(\mathbb{O}_{p_{2}, r},\|\sin \Theta(\cdot, \cdot)\|_{F}\right)$. Especially we consider the ball with radius $0<\varepsilon<\sqrt{2 r}$ and center $V \in \mathbb{O}_{p_{2}, r}$

B(V, \varepsilon)=\left\{V^{\prime} \in \mathbb{O}_{p_{2}, r}:\left\|\sin \Theta\left(V^{\prime}, V\right)\right\|_{F} \leq \varepsilon\right\} .

Note that $r \leq p_{2} / 2,\left\|\sin \Theta\left(V^{\prime}, V\right)\right\|_{F}=\frac{1}{\sqrt{2}}\left\|V^{\prime} V^{\top}-V V^{\top}\right\|_{F}$, based on Lemma 1 in Cai et al. (2013), one can show for any $\alpha \in(0,1), \varepsilon \in(0, \sqrt{2 r})$, there exists $V_{1}, \cdots, V_{m} \subseteq B(V, \varepsilon)$, such that

By $\left\{V_{1}, \cdots, V_{m}\right\} \subseteq B(V, \varepsilon),\left\|\sin \Theta\left(V_{i}, V_{j}\right)\right\| \leq 2 \varepsilon$, along with (56),

D\left(\bar{P}_{V_{i}, t} \| \bar{P}_{V_{j}, t}\right) \leq \frac{32 \varepsilon^{2} t^{4}}{4 t^{2}+p_{1}}+C_{K L}
$$

Fano's Lemma (Yu, 1997) leads to the following lower bound

\inf _{\hat{V}} \sup _{V \in \Theta} \mathbf{E}_{\bar{P}_{V, t}}\|\sin \Theta(\hat{V}, V)\|_{F}^{2} \geq \alpha^{2} \varepsilon^{2}\left(1-\frac{\frac{32 \varepsilon^{2} t^{4}}{4 t^{2}+p_{1}}+C_{K L}+\log 2}{r\left(p_{2}-r\right) \log \frac{c}{\alpha}}\right) \tag{57}
\end{equation*}
$$

We particularly select $\alpha=c \exp \left(-\left(1+C_{K L}+\log (2)\right)\right), \varepsilon=\sqrt{\frac{r\left(p_{2}-r\right)\left(4 t^{2}+p_{1}\right)}{32 t^{4}}} \wedge \sqrt{2 r}$. Note that $r \leq p_{2} / 2$, we further have

\end{equation*}

Finally, note that $\bar{P}_{V, t}$ is a mixture distribution from $\mathcal{P}_{V, t}$ defined in (54). Lemma 6 implies

The two inequalities above together imply the desired lower bound.

- Then we consider when $t^{2}>p_{1} / 4$. This case is simpler than the previous as we do not have to mix the multivariate Gaussian measures. Suppose

and denote $P_{V}$ as the probability measure of $Y$ when $Y=X_{V}+Z, Z \in \mathbb{R}^{p_{1} \times p_{2}}$, $Z \stackrel{i i d}{\sim} N(0,1)$. Based on (114), we have

D\left(P_{V} \| P_{V^{\prime}}\right)=\frac{1}{2}\left\|t U_{0} V^{\top}-t U_{0}\left(V^{\prime}\right)^{\top}\right\|_{F}^{2}=\frac{t^{2}}{2}\left\|V-V^{\prime}\right\|_{F}^{2} \tag{61}
\end{equation*}
$$

Based on the same procedure Step 5 in the case $t^{2}<p_{1} / 4$, one can construct the ball of radius $\varepsilon$ centered at $V_{0} \in \mathbb{O}_{p_{2}, r}$,

B\left(V_{0}, \varepsilon\right)=\left\{V^{\prime}:\left\|\sin \Theta\left(V^{\prime}, V_{0}\right)\right\|_{F} \leq \varepsilon\right\}
$$

and for $0<\alpha<1$, there exist $\left\{V_{1}^{\prime}, \cdots, V_{m}^{\prime}\right\} \subseteq B\left(V_{0}, \varepsilon\right)$ such that

m \geq\left(\frac{c}{\alpha}\right)^{r\left(p_{2}-r\right)}, \quad \max _{1 \leq i \neq j \leq m}\left\|\sin \theta\left(V_{i}^{\prime}, V_{j}^{\prime}\right)\right\|_{F} \geq \varepsilon \alpha
$$

By basic property of $\sin \Theta$ distances (Lemma 1 in this paper), we can find $O_{i} \in \mathbb{O}_{r}$ such that

\left\|V_{0}-V_{i}^{\prime} O_{i}\right\|_{F} \leq \sqrt{2}\left\|\sin \Theta\left(V_{0}, V_{i}^{\prime}\right)\right\| \leq \sqrt{2} \varepsilon
$$

Denote $V_{i}=V_{i}^{\prime} O_{i} \in \mathbb{O}_{p_{2}, r}$, then

& \max _{1 \leq i \neq j \leq m} D\left(P_{V_{i}} \| P_{V_{j}}\right) \stackrel{\sqrt{61}}{=} \max _{1 \leq i \neq j \leq m} \frac{t^{2}}{2}\left\|V_{i}-V_{j}\right\|_{F}^{2} \\
\leq & \frac{t^{2}}{2} \max _{1 \leq i \neq j \leq m} 2\left(\left\|V_{0}-V_{i}\right\|_{F}^{2}+\left\|V_{0}-V_{i}\right\|_{F}^{2}\right) \leq 4 t^{2} \varepsilon^{2} .
\end{aligned}
$$

Follow the same procedure as Step 5 in the case $t^{2}<p_{1} / 4$, we have

$$
\begin{equation*}
\inf _{\hat{V}} \sup _{V \in \mathbb{O}_{p_{2}, r}} \mathbf{E}_{P_{V}}\|\sin \Theta(\hat{V}, V)\|_{F}^{2} \geq \alpha^{2} \varepsilon^{2}\left(1-\frac{4 \varepsilon^{2} t^{2}+\log 2}{r\left(p_{2}-r\right) \log \frac{c}{\alpha}}\right) . \tag{62}
\end{equation*}
$$

for any $\alpha \in(0,1), \varepsilon<\sqrt{2 r}$. By selecting $\alpha=\frac{c}{4}, \varepsilon^{2}=\sqrt{\frac{r\left(p_{2}-r\right)}{2 t^{2}}} \wedge \sqrt{2 r}$, we have

\inf _{\hat{V}} \sup _{V \in \Theta} \mathbf{E}_{\bar{P}_{V}}\|\sin \Theta(\hat{V}, V)\|_{F}^{2} \geq c\left(\frac{p_{2} r}{t^{2}} \wedge r\right)

Based on the assumption that $t^{2}>p_{1} / 4$,

$$
\frac{p_{2} r}{t^{2}} \geq \frac{p_{2} r\left(t^{2} / 2+p_{1} / 8\right)}{t^{4}} \geq \frac{1}{8}\left(\frac{p_{2} r\left(t^{2}+p_{1}\right)}{t^{4}}\right)
$$

Similarly by Lemma 6, we have

\inf _{\hat{V}} \sup _{X \in \mathcal{F}_{r, t}} \mathbf{E}\|\sin \Theta(\hat{V}, V)\|_{F}^{2} \geq c\left(\frac{p_{2} r\left(t^{2}+p_{1}\right)}{t^{4}} \wedge r\right)
$$

Finally, combining these two cases for $t^{2}<p_{1} / 4$ and $t^{2}>p_{1} / 4$, we have finished the proof of Theorem 4.

### 7.3 Proofs in High-dimensional Clustering

Proof of Theorem 5. Since $E Y=\mu l^{\top}=\sqrt{n}\|\mu\|_{2} \cdot \frac{l}{\sqrt{n}}$, by Theorem 3, we know

\mathbf{E}\left(\min _{o \in\{-1,1\}}\|\hat{v}-o \cdot l / \sqrt{n}\|_{2}^{2}\right) \leq 2 \mathbf{E}\left(\left.\left\|\sin \Theta\left(\frac{l}{\sqrt{n}}, \hat{v}\right)\right\|^{2} \right\rvert\, l\right) \leq \frac{C\left(n\|\mu\|_{2}^{2}+p\right)}{n\|\mu\|_{2}^{4}}
$$

Finally, by definition that $\hat{l}=\operatorname{sgn}(\hat{v})$ and $l_{i} / \sqrt{n}= \pm 1 / \sqrt{n}$, we can obtain

& \frac{1}{n} \mathbf{E} \min _{\pi}\left|\left\{i: l_{i} \neq \pi\left(\hat{l}_{i}\right)\right\}\right| \leq \frac{1}{n} \mathbf{E} \min _{\pi}\left|\left\{i: \frac{l_{i}}{\sqrt{n}} \neq \pi\left(\operatorname{sgn}\left(\hat{v}_{i}\right)\right) / \sqrt{n}\right\}\right| \\
\leq & \frac{1}{n} \mathbf{E} \min _{o \in\{-1,1\}}\left|\left\{i:\left|\frac{l_{i}}{\sqrt{n}}-o \hat{v}_{i}\right| \geq 1 / \sqrt{n}\right\}\right| \leq \frac{1}{n} \mathbf{E} \min _{o \in\{-1,1\}} \sum_{i=1}^{n}\left(l_{i} / \sqrt{n}-o \hat{v}_{i}\right)^{2} n \\
= & \mathbf{E}\left(\min _{o \in\{-1,1\}}\|\hat{v}-o \cdot l / \sqrt{n}\|_{2}^{2}\right) \leq \frac{C\left(n\|\mu\|_{2}^{2}+p\right)}{n\|\mu\|_{2}^{4}} .
\end{aligned}
$$

which has finished the proof of this theorem.

Proof of Theorem 6. We first consider the metric space $\{-1,1\}^{n}$, where each pair of $l$ and $-l$ are considered as the same element. For any $l_{1}, l_{2} \in\{-1,1\}^{n}$, it is easy to see that

$$

$$
\left\|l_{1}+l_{2}\right\|_{\infty} \leq \min \left\{\left\|l_{1}-l_{3}\right\|_{\infty}+\left\|l_{3}+l_{2}\right\|_{\infty},\left\|l_{1}+l_{3}\right\|_{\infty}+\left\|l_{3}-l_{2}\right\|_{\infty}\right\}
$$

we have

$$
\begin{aligned}
& \mathcal{M}\left(l_{1}, l_{2}\right)=\frac{1}{2 n} \min \left\{\left\|l_{1}-l_{2}\right\|_{\infty},\left\|l_{1}+l_{2}\right\|_{\infty}\right\} \leq \\
& \leq \frac{1}{2 n} \min \left\{\left\|l_{1}-l_{3}\right\|_{\infty}+\left\|l_{3}-l_{2}\right\|_{\infty},\left\|l_{1}+l_{3}\right\|_{\infty}+\left\|l_{3}+l_{2}\right\|_{\infty}\right. \\
& \left.\quad+\left\|l_{1}-l_{3}\right\|_{\infty}+\left\|l_{3}+l_{2}\right\|_{\infty},\left\|l_{1}+l_{3}\right\|_{\infty}+\left\|l_{3}-l_{2}\right\|_{\infty}\right\}=\mathcal{M}\left(l_{1}, l_{3}\right)+\mathcal{M}\left(l_{2}, l_{3}\right) .
\end{aligned}
$$

In other words, $\mathcal{M}$ is a metric in the space of $\{-1,1\}^{n}$. Similarly to Lemma 4 in Yu (1997), we can show that there exists universal positive constant $c_{0}, C_{n}$, such that when $n \geq C_{n}$, there exists a subset $A$ of $\{-1,+1\}^{n}$ satisfying

Denote $t^{2}=c_{\text {gap }}(p / n)^{\frac{1}{4}}$. Next, we need to discuss separately according to the value of $t^{2}$.

- When $n t^{2} \leq p / 4$, for each $l \in\{-1,1\}^{n}$, similarly to the proof to Theorem 6, we define the following class of density $P_{Y}$, where $Y=X+Z$ and the right singular space of $X$ is $l / \sqrt{n}$,

We construct the following Gaussian mixture measure $\bar{P}_{l, t}$,

\bar{P}_{l, t}(Y)=C_{l, t} \int_{\mu_{0} \in \mathbb{R}^{p}:\left\|\mu_{0}\right\| \geq 1 / 2} \frac{1}{(2 \pi)^{p n / 2}} \exp \left(-\left\|Y-2 t \mu_{0} l^{\top}\right\|_{F}^{2} / 2\right)  \tag{64}\\
\cdot\left(\frac{p}{2 \pi}\right)^{p_{1} r / 2} \exp \left(-p\left\|\mu_{0}\right\|_{2}^{2} / 2\right) d \mu_{0} .
\end{array}
$$

Here $C_{l, t}$ is the constant which normalize the integral and make $\bar{P}_{l, t}$ a valid probability density. To be specific, $C_{l, t}^{-1}=\int_{Y} P_{l, t}(Y) d Y$. Moreover, since $\left\|2 t \mu_{0}\right\| \geq t$ in the event that $\left\|\mu_{0}\right\|_{2} \geq 1 / 2, \bar{P}_{l, t}$ is a mixture density in $\mathcal{P}_{l, t}$, i.e. $\bar{P}_{l, t} \in \operatorname{co}\left(\mathcal{P}_{l, t}\right)$. By Lemma 7 , for any two $l, l^{\prime} \in\{-1,1\}^{n}$, the KL-divergence between $\bar{P}_{l, t}$ and $\bar{P}_{l^{\prime}, t}$ have the following upper bound

$$
\begin{aligned}
& D\left(\bar{P}_{l, t} \| \bar{P}_{l^{\prime}, t}\right) \leq \frac{16 n^{2} t^{4}}{2\left(4 n t^{2}+p\right)}\left\|\sin \Theta\left(l / \sqrt{n}, l^{\prime} / \sqrt{n}\right)\right\|_{F}^{2}+C_{K L} \leq C\left(\frac{n^{2} t^{4}}{n t^{2}+p}+1\right) \\
\leq & C\left(\frac{n^{2} c_{g a p}^{4}(p / n)}{p}+1\right)
\end{aligned}
$$

for some uniform constant $C>0$. Then we can set $c_{g a p}, C_{n}>0$, such that whenever $t \leq c(p / n)^{\frac{1}{4}}, n \geq C_{n}$,

$$
\begin{equation*}
D\left(\bar{P}_{l, t}| | \bar{P}_{l^{\prime}, t}\right) \leq c_{0} n / 5 \tag{65}
\end{equation*}
$$

Finally, combining (63) and 65), the generalized Fano's lemma (Lemma 3 in Yu (1997)) along with Lemma 6 lead to

$$
\begin{equation*}
\inf _{\hat{l}} \max _{\substack{\|\mu\|_{2} \leq c_{g a p}(p / n)^{\frac{1}{4}} \\ l \in\{-1,1\}^{n}}} \mathbf{E M}(\hat{l}, l) \geq \frac{1}{3}\left(1-\frac{c_{0} n / 5+\log 2}{c_{0} n}\right) \geq \frac{1}{4}, \tag{66}
\end{equation*}
$$

where the last inequality hold when $n \geq C_{n}$ for large enough $C_{n}$.

- When $n t^{2}>p / 4$, we fix $\mu=(t, 0, \ldots, 0)^{T} \in \mathbb{R}^{p}$, introduce

$$
X_{l}=\mu l^{\top}, \quad l \in\{-1,1\}^{n}
$$

and denote $P_{l}$ as the probability of $Y$ if $Y=X_{l}+Z$ with $Z \stackrel{i i d}{\sim} N(0,1)$. Based on the calculation in Theorem 4, the KL-divergence between $P_{l}$ and $P_{l^{\prime}}$ satisfies

$$
D\left(P_{l} \| P_{l^{\prime}}\right)=\frac{t^{2}}{2}\left\|l-l^{\prime}\right\|_{2}^{2} \leq 2 t^{2} n .
$$

Applying the generalized Fano's lemma on $\{-1,1\}^{n}$, we have

$$
\inf _{\hat{l}} \max _{l \in\{-1,1\}^{n}} \mathbf{E} \mathcal{M}(\hat{l}, l) \geq \frac{1}{3}\left(1-\frac{2 t^{2} n+\log 2}{c_{0} n}\right) .
$$

When $n t^{2}>p / 4, t \leq c_{\text {gap }}(p / n)^{\frac{1}{4}}$, we know

$$
\frac{1}{2}(p / n)^{\frac{1}{2}} \leq t \leq c_{\text {gap }}(p / n)^{\frac{1}{4}}, \quad \text { thus } \quad t^{2} \leq \frac{\left(c_{g a p}(p / n)^{\frac{1}{4}}\right)^{2}}{\frac{1}{2}(p / n)} \leq 2 c_{\text {gap }}^{2}
$$

Finally if $n \geq C_{n}$ for some large constant $C_{n}>0$, and $c_{g a p}$ is small enough, we have

$$
\frac{2 t^{2} n+\log 2}{c_{0} n} \leq \frac{4 c_{g a p}^{2} n+\log 2}{c_{0} n} \leq \frac{1}{4},
$$

which implies

$$
\inf _{\hat{l}} \max _{\substack{\|\mu\|_{2} \leq c_{\text {gap }}(p / n)^{\frac{1}{4}} \\ l \in\{-1,1\}^{n}}} \operatorname{EM}(\hat{l}, l) \geq \frac{1}{4} .
$$

To sum up, we have finished the proof of this theorem.

## Appendix: Additional Proofs

In this Appendix, we provide the proofs for Theorem 7 (canonical correlation analysis) and all the technical lemmas.

## Proofs in Canonical Correlation Analysis

Proof of Theorem 7. The proof of Theorem 7 is relatively complicated, which we shall divide into steps.

1. (Analysis of Loss) Suppose the SVD of $\hat{S}$ and $S$ are

\hat{S}=\hat{U}_{S} \hat{\Sigma}_{S} \hat{V}_{S}^{\top}, & \hat{U}_{S} \in \mathbb{O}_{p_{1}}, \hat{\Sigma}_{S} \in \mathbb{R}^{p_{1} \times p_{2}}, \hat{V}_{S} \in \mathbb{O}_{p_{2}} \\
S=U_{S} \Sigma_{S} V_{S}^{\top}, & U_{S} \in \mathbb{O}_{p_{1}, r}, \Sigma_{S} \in \mathbb{R}^{r \times r}, V_{S} \in \mathbb{O}_{p_{2}, r} \tag{67}
\end{array} \quad \text { (we shall note } \operatorname{rank}(S)=r .\right)
$$

respectively. Recall that $A=\Sigma_{X}^{-\frac{1}{2}} U_{S}, \hat{A}=\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{U}_{S,[; ; 1: r]}$. Invertible multiplication to all $X$ 's or $Y$ 's does not change the loss of the procedure, thus without loss of generality we could assume that $\Sigma_{X}=I_{p_{1}}$. Under this assumption, we have following expansions for the loss $L_{F}$ and $L_{\text {sp }}$.

\begin{aligned}
L_{F}(\hat{A}, A) & =\min _{O \in \mathbb{O}_{r}} \mathbf{E}_{X^{*}}\left\|(\hat{A} O-A)^{\top} X^{*}\right\|_{2}^{2}=\max _{O \in \mathbb{O}_{r}} \mathbf{E}_{X^{*}} \operatorname{tr}\left((\hat{A} O-A)^{\top} X^{*}\left(X^{*}\right)^{\top}(\hat{A} O-A)\right) \\
& =\min _{O \in \mathbb{O}^{r}} \operatorname{tr}\left(\left(\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{U}_{S:[:, 1: r]} O-U_{S}\right)^{\top} I_{p_{1}}\left(\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{U}_{S,[;, 1: r]} O-U_{S}\right)\right) \\
& =\min _{O \in \mathbb{O}^{r}}\left\|\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{U}_{S,[;, 1: r]} O-U_{S}\right\|_{F}^{2} \\
& \leq 2 \min _{O \in \mathbb{O}^{r}}\left\{\left\|\hat{U}_{S,[: ; 1: r]} O-U_{S}\right\|_{F}^{2}+\left\|\left(\hat{\Sigma}_{X^{-2}}^{-\frac{1}{2}}-I\right) \hat{U}_{S,[: ; 1: r]} O\right\|_{F}^{2}\right\} \\
& \left.\leq 4\left\|\sin \Theta\left(\hat{U}_{S,[: ; 1: r]}, U_{S}\right)\right\|_{F}^{2}+2\left\|\left(\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right) \hat{U}_{S,[:, 1: r]} O\right\|_{F}^{2} \quad \text { (by Lemma } \mathbb{1}\right) .
\end{aligned}
$$

Similarly,

$$
\begin{align*}
L_{\mathrm{sp}}(\hat{A}, A) & =\max _{\substack{O \in \oplus_{r} \\
v \in \mathbb{R}_{r}^{r}}}\left\|\sin \Theta\left(\hat{U}_{S,[;, 1: r]}, U_{S}\right)\right\|^{2}  \tag{68}\\
& \leq 4\left\|\sin \Theta\left(\hat{U}_{S,[;, 1: r]}, U_{S}\right)\right\|^{2}+2\left\|\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right\|^{2} .
\end{align*}
$$

We use the bold symbols $\mathbf{X} \in \mathbb{R}^{p_{1} \times n}, \mathbf{Y} \in \mathbb{R}^{p_{2} \times n}$ to denote those $n$ samples. Since $\hat{\Sigma}=\frac{1}{n} \mathbf{X} \mathbf{X}^{\top}$, where $\mathbf{X} \in \mathbb{R}^{p_{1} \times n}$ is a i.i.d. Gaussian matrix, by random matrix theory (Corollary 5.35 in Vershynin (2012)), there exists constant $C, c$ such that

$$
\begin{equation*}
1-C \sqrt{p_{1} / n} \leq \sigma_{\min }\left(\hat{\Sigma}_{X}\right) \leq \sigma_{\max }\left(\hat{\Sigma}_{X}\right) \leq 1+C \sqrt{p_{1} / n} . \tag{69}
\end{equation*}
$$

with probability at least $1-C \exp \left(c p_{1}\right)$. Since

$$
1 \stackrel{\text { property of correlation matrix }}{\geq} \sigma_{r}^{2}(S) \stackrel{\text { problem assumption }}{\geq} \frac{C_{\text {gap }} p_{1}}{n}
$$

we can find large $C_{\text {gap }}>0$ to ensure $n \geq C p_{1}$ for any large $C>0$. In addition, we could have

$$
\begin{equation*}
\mathbf{P}\left(\left\|\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right\|^{2} \leq C p_{1} / n \leq \frac{C p_{1}}{n \sigma_{r}^{2}(S)}\right) \geq 1-C \exp \left(-c p_{1}\right) \tag{70}
\end{equation*}
$$

Moreover, as $\hat{U}_{S,[:, 1: r]} O \in \mathbb{O}_{p_{1}, r}$, we have $r\left\|\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right\|^{2} \geq\left\|\left(\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right) \hat{U}_{S,[:, 1: r]} O\right\|_{F}^{2}$, thus

$$
\begin{equation*}
\mathbf{P}\left(\left\|\left(\hat{\Sigma}_{X}^{-\frac{1}{2}}-I\right) \hat{U}_{S,[:, 1: r]} O\right\|_{F}^{2} \leq C p_{1} r / n \leq \frac{C p_{1} r}{n \sigma_{r}^{2}(S)}\right) \geq 1-C \exp \left(-c p_{1}\right) \tag{71}
\end{equation*}
$$

Now the central goal in our analysis moves to bound

$$
\left\|\sin \Theta\left(\hat{U}_{S,[:, 1: r]}, U_{S}\right)\right\|_{F}^{2} \text { and }\left\|\sin \Theta\left(\hat{U}_{S,[;, 1: r]}, U_{S}\right)\right\|^{2}
$$

namely to compare the singular spectrum between the population $S=\Sigma_{X}^{-\frac{1}{2}} \Sigma_{X Y} \Sigma_{Y}^{-\frac{1}{2}}$ and the sample version $\hat{S}=\hat{\Sigma}_{X}^{-\frac{1}{2}} \hat{\Sigma}_{X Y} \hat{\Sigma}_{Y}^{-\frac{1}{2}}$ in $\sin \Theta$ distance. Since $\sin \Theta\left(\hat{U}_{S,[;, 1: r]}, U_{S}\right)$ is $r \times r,\left\|\sin \Theta\left(\hat{U}_{S,[: 1: 1: r]}, U_{S}\right)\right\|_{F}^{2} \leq\left\|\sin \Theta\left(\hat{U}_{S,[:, 1: r]}, U_{S}\right)\right\|^{2}$. We only need to consider the $\sin \Theta$ spectral distance below.
2. (Reformation of the Model Set-up) In this step, we transform $X, Y$ to a better formulation to simplify the further analysis. First, any invertible affine transformation on $\mathbf{X}$ and $\mathbf{Y}$ separately will not essentially change the problem. We specifically do transformation as follows

$$
\mathbf{X} \rightarrow\left[U_{S} U_{S \perp}\right]^{\top} \Sigma_{X}^{-\frac{1}{2}} \mathbf{X}, \quad \mathbf{Y} \rightarrow\left(I_{p_{2}}-\Sigma_{S}^{2}\right)^{-\frac{1}{2}}\left[V_{S} V_{S \perp}\right]^{\top} \Sigma_{Y}^{-\frac{1}{2}} \mathbf{Y}
$$

Simple calculation shows that after transformation, $\operatorname{Var}(X), \operatorname{Var}(Y), \operatorname{Cov}(X, Y)$ become $I_{p_{1}},\left(I_{p_{2}}-\Sigma_{S}^{2}\right)^{-1}, \Sigma_{S}\left(I_{p_{2}}-\Sigma_{S}^{2}\right)^{-\frac{1}{2}}$ respectively. Therefore, without loss of generality we can assume that

$$
\begin{gather*}
\qquad \Sigma_{X}=I_{p_{1}}, \quad \Sigma_{Y}=\left(I_{p_{2}}-\Sigma_{S}^{2}\right)^{-1} .  \tag{72}\\
S \in \mathbb{R}^{p_{1} \times p_{2}} \text { is diagonal, such that } S_{i j}= \begin{cases}\sigma_{i}(S), & i=j=1, \cdots, r \\
0, & \text { otherwise }\end{cases} \tag{73}
\end{gather*}
$$

throughout the proof. (It will be explained a while later why we want to transform $\Sigma_{Y}$ into this form.)

Since $X, Y$ are jointly Gaussian, we can relate them as $Y=W^{\top} X+Z$, where $W \in$ $\mathbb{R}^{p_{1} \times p_{2}}$ is a fixed matrix, $X \in \mathbb{R}^{p_{1}}$ and $Z \in \mathbb{R}^{p_{2}}$ are independent random vectors. Based on simple calculation, $\Sigma_{X Y}=\mathbf{E} X Y^{\top}=\Sigma_{X} W, \Sigma_{Y}=W^{\top} \Sigma_{X} W+\operatorname{Var}(Z)$. Combining (72), we can calculate that

0 & \text { otherwise }

\operatorname{Var}(Z)=\Sigma_{Y}-\Sigma_{Y}^{\frac{1}{2}} S^{\top} S \Sigma_{Y}^{\frac{1}{2}}=\Sigma_{Y}^{\frac{1}{2}}\left(I_{p_{2}}-S^{\top} S\right) \Sigma_{Y}^{\frac{1}{2}}=I_{p_{2}} . \tag{75}

In other words, $Z$ is i.i.d. standard normal and $W$ is diagonal. By rescaling, the analysis could be much more simplified and easier to read.
3. (Expression for $\hat{S}$ ) In this step, we move from the population to the samples and find out a useful expression for $\hat{S}$. We use bold symbols $\mathbf{X} \in \mathbb{R}^{p_{1} \times n}, \mathbf{Y} \in \mathbb{R}^{p_{2} \times n}$, $\mathbf{Z} \in \mathbb{R}^{p_{2} \times n}$ to denote the compiled data such that $\mathbf{Y}=W^{\top} \mathbf{X}+\mathbf{Z}$. Denote the singular decomposition for $\mathbf{X}$ and $\mathbf{Y}$ are

4. (Useful Characterization of the left Singular Space of $\hat{S}$ ) Since $\mathbf{X}$ is a i.i.d. Gaussian matrix at this moment, from the random matrix theory, we know $\hat{U}_{X}$, $\hat{V}_{X}$ are randomly distributed with Haar measure on $\mathbb{O}_{p_{1}}$ and $\mathbb{O}_{n, p_{1}}$ respectively and $\hat{U}_{X}, \hat{\Sigma}_{X}, \hat{V}_{X}, Z$ are independent. We can extend $\hat{V}_{X} \hat{U}_{X}^{\top} \in \mathbb{O}_{n, p_{1}}$ to orthogonal matrix $\tilde{R}_{X}=\left[\hat{V}_{X} \hat{U}_{X}^{\top}, \hat{R}_{X \perp}\right] \in O_{n}$ such that $\hat{R}_{X \perp} \in \mathbb{O}_{n, n-p_{1}}$. Introduce $\tilde{\mathbf{Z}}=\mathbf{Z} \cdot \tilde{R}_{X}, \tilde{\mathbf{Y}}=$ $\mathbf{Y} \cdot \tilde{R}_{X}, \tilde{\mathbf{X}}=\mathbf{X} \tilde{R}_{X} \cdot \tilde{\mathbf{Y}}^{\boldsymbol{\top}}$ can be explicitly written as the following clean form

\tilde{\mathbf{Z}} \stackrel{i i d}{\sim} N(0,1), \quad \tilde{\mathbf{Z}}, \hat{U}_{X}, \hat{\Sigma}_{X} \text { are independent; } \mathbf{G}, \tilde{\mathbf{Z}} \text { are independent. } \tag{76}
\end{equation*}

Meanwhile, since $\hat{V}_{Y}$ is the left singular vectors for $\mathbf{Y}^{\boldsymbol{\top}}$, we have

The characterization above is the baseline we shall use later to compare the spectrum of $\hat{S}$ and $S$.
5. (Split of $\sin \Theta$ Norm Distance) Recall Step 1, the central goal of analysis now is to find the $\sin \Theta$ distance between the leading $r$ left singular vectors of $\hat{S}$ and $S$. It is easy to see that the left singular space of $S$ is

6. (Left Singular Space of $\mathbf{G}_{\left[1: p_{1}, 1: r\right]}$ ) Recall the definition of $\mathbf{G}$ in $(76]$, since $W$ is with only first $r$ diagonal entries non-zero, only the submatrix $\mathbf{G}_{\left[1: p_{1}, 1: r\right]}$ of $\mathbf{G}$ is non-zero. Suppose

Furthermore, due to the diagonal structure of $W, \mathbf{G}_{\left[1: p_{1}, 1: r\right]}$ has the same left singular space as $\hat{U}_{X} \hat{\Sigma}_{X}\left(\hat{U}_{X}^{\top}\right)_{[:, 1: r]}$. Since $\hat{\Sigma}_{X}$ is the singular values of i.i.d. Gaussian matrix $X \in \mathbb{R}^{p_{1} \times n}$, by random matrix theory (Vershynin, 2012),

By Lemma 9 , the left singular space of $\hat{U}_{X} \hat{\Sigma}_{X}\left(\hat{U}_{X}^{\top}\right)_{[:, 1: r]}$, which is also the left singular vectors of $G_{\left[1: p_{1}, 1: r\right]}$ satisfies

Finally, combining (80), (82), (88), 70), (71) and (68), we have completed the proof of Theorem 7 .

The following Lemmas 8,9 and 10 are used in the proof of Theorem 7. To be specific, Lemma 8 provides a $\sin \Theta$ upper bound for the singular vectors of a sub-matrix; Lemma 10 gives both upper and lower bounds for the singular values of a sub-matrix; Lemma 10 propose a spectral norm upper bound for any matrix after a random projection.

## Proofs of Technical Lemmas

## Proof of Lemma 1 .

- (Expressions) Suppose $V^{\top} \hat{V}=A \Sigma B^{\top}$ is the SVD, where $\Sigma=\operatorname{diag}\left(\sigma_{1}, \cdots, \sigma_{r}\right)$, $A, B \in \mathbb{O}_{r}$. By definition of $\sin \Theta$ distances,

$$
\begin{equation*}
\|\sin \Theta(\hat{V}, V)\|=\sin \left(\cos ^{-1}\left(\sigma_{r}\right)\right)=\sqrt{1-\sigma_{r}^{2}}=\sqrt{1-\sigma_{\min }^{2}\left(V^{\top} \hat{V}\right)}, \tag{95}
\end{equation*}
$$

$$
\begin{equation*}
\|\sin \Theta(\hat{V}, V)\|_{F}^{2}=\sum_{i=1}^{r} \sin ^{2}\left(\cos ^{-1}\left(\sigma_{r}\right)\right)=\sum_{i=1}^{r}\left(1-\sigma_{r}^{2}\right)=r-\sum_{i=1}^{r} \sigma_{i}^{2}=r-\left\|\hat{V}^{\top} V\right\|_{F}^{2} \tag{96}
\end{equation*}
$$

On the other hand, since $\hat{V}, V, V_{\perp}$ are orthonormal,

$$
\begin{align*}
& \sigma_{\text {min }}^{2}\left(\hat{V}^{\top} V\right)=\min _{x \in \mathbb{R}^{r}} \frac{\left\|\hat{V}^{\top} V x\right\|_{2}^{2}}{\|x\|_{2}^{2}}=\min _{x \in \mathbb{R}^{r}} \frac{\|V x\|_{2}^{2}-\left\|\hat{V}_{\perp}^{\top} V x\right\|_{2}^{2}}{\|x\|_{2}^{2}}=1-\max _{x \in \mathbb{R}^{r}} \frac{\left\|\hat{V}_{\perp} V x\right\|_{2}^{2}}{\|x\|_{2}^{2}}=1-\left\|\hat{V}_{\perp}^{\top} V\right\|^{2}, \\
& \left\|\hat{V}^{\top} V\right\|_{F}^{2}=\operatorname{tr}\left(\hat{V}^{\top} V V^{\top} \hat{V}\right)=\operatorname{tr}\left(\hat{V} \hat{V}^{\top} V V^{\top}\right)=\operatorname{tr}\left(V V^{\top}-\hat{V}_{\perp} \hat{V}_{\perp}^{\top} V V^{\top}\right)=r-\left\|\hat{V}_{\perp}^{\top} V\right\|_{F}^{2}, \tag{98}
\end{align*}
$$

we conclude that $\|\sin \Theta(\hat{V}, V)\|=\left\|\hat{V}_{\perp}^{\top} V\right\|,\|\sin \Theta(\hat{V}, V)\|_{F}=\left\|\hat{V}_{\perp}^{\top} V\right\|_{F}$.

- (Triangular Inequality) Next we consider the triangular inequality under spectral norm (24). Denote

$$
x=\left\|\sin \Theta\left(V_{1}, V_{2}\right)\right\|, \quad y=\left\|\sin \Theta\left(V_{1}, V_{3}\right)\right\| .
$$

For each $i=1,2,3$, we can expand $V_{i}$ to the full orthogonal matrix as $\left[V_{i} V_{i \perp}\right] \in \mathbb{O}_{p}$. Thus,

$$
\sigma_{\min }\left(V_{1}^{\top} V_{2}\right) \stackrel{\text { 95] }}{=} \sqrt{1-x^{2}}, \quad \sigma_{\max }^{2}\left(V_{1 \perp}^{\top} V_{2}\right) \stackrel{\text { 97] }}{=} 1-\sigma_{\min }^{2}\left(V_{1}^{\top} V_{2}\right)=x^{2}
$$

Similarly

$$
\sigma_{\min }\left(V_{1}^{\top} V_{3}\right)=\sqrt{1-y^{2}}, \quad \sigma_{1}^{2}\left(V_{1 \perp}^{\top} V_{3}\right)=y^{2}
$$

Thus,

$$
\begin{aligned}
\sigma_{\min }\left(V_{2}^{\top} V_{3}\right) & =\sigma_{\min }\left(V_{2}^{\top} V_{1} V_{1}^{\top} V_{3}+V_{2}^{\top} V_{1 \perp} V_{1 \perp}^{\top} V_{3}\right) \geq \sigma_{\min }\left(V_{2}^{\top} V_{1} V_{1}^{\top} V_{3}\right)-\sigma_{\max }\left(V_{2}^{\top} V_{1 \perp} V_{1 \perp}^{\top} V_{3}\right) \\
& \geq \sigma_{\min }\left(V_{2}^{\top} V_{1}\right) \sigma_{\min }\left(V_{1}^{\top} V_{3}\right)-\sigma_{\max }\left(V_{2}^{\top} V_{1 \perp}\right) \cdot \sigma_{\max }\left(V_{1 \perp}^{\top} V_{3}\right) \\
& \geq \sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)}-x y .
\end{aligned}
$$

Therefore,

$$
\begin{equation*}
\left\|\sin \Theta\left(V_{2}, V_{3}\right)\right\| \leq \sqrt{1-\left(\sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)}-x y\right)_{+}^{2}} \tag{99}
\end{equation*}
$$

Now, we discuss under two situations.

1. If $\sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)} \geq x y$, we have

$$
1-\left(\sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)}-x y\right)_{+}^{2}=x^{2}+y^{2}-x^{2} y^{2}+2 x y \sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)}-x^{2} y^{2} \leq(x+y)^{2} .
$$

Thus, $\left\|\sin \Theta\left(V_{2}, V_{3}\right)\right\| \leq x+y$.
2. If $\sqrt{\left(1-x^{2}\right)\left(1-y^{2}\right)}>x y$, we have $x^{2}+y^{2}>1$. Provided that $0 \leq x, y \leq 1$, this implies $x+y>1$. Thus, $\left\|\sin \Theta\left(V_{2}, V_{3}\right)\right\| \leq 1 \leq x+y$.

To sum up, we always have (24). The proof for triangular inequality under Frobenius norm is slightly simpler.

$$
\begin{align*}
& \left\|\sin \Theta\left(V_{2}, V_{3}\right)\right\|_{F}{ }^{[96], 988}\left\|V_{2 \perp}^{\top} V_{3}\right\|_{F}=\left\|V_{2 \perp}^{\top}\left(\mathbb{P}_{V_{1}}+\mathbb{P}_{V_{1 \perp}}\right) V_{3}\right\|_{F} \\
& \leq\left\|V_{2 \perp}^{\top} V_{1} V_{1}^{\top} V_{3}\right\|_{F}+\left\|V_{2 \perp}^{\top} V_{1 \perp} V_{1 \perp}^{\top} V_{3}\right\|_{F} \\
& \leq\left\|V_{2 \perp}^{\top} V_{1}\right\|_{F} \cdot\left\|V_{1}^{\top} V_{3}\right\|+\left\|V_{2 \perp}^{\top} V_{1 \perp}\right\| \cdot\left\|V_{1 \perp}^{\top} V_{3}\right\|_{F} \\
& \leq\left\|V_{2 \perp}^{\top} V_{1}\right\|_{F}+\left\|V_{1 \perp}^{\top} V_{3}\right\|_{F} \leq\left\|\sin \Theta\left(V_{1}, V_{3}\right)\right\|_{F}+\left\|\sin \Theta\left(V_{1}, V_{2}\right)\right\|_{F} \text {. } \tag{100}
\end{align*}
$$

- (Equivalence with Other Metrics) Since all metrics mentioned in Lemma 1 is rotation invariant, i.e. for any $J \in \mathbb{O}_{p}, \sin \Theta(\hat{V}, V)=\sin \Theta(J \hat{V}, J V)$, so does the other metrics. Without loss of generality, we can assume that

$$
V=\left[\begin{array}{c}
I_{r} \\
0_{(p-r) \times r}
\end{array}\right]_{p \times r}
$$

In this case,

$$
D_{\mathrm{sp}}(\hat{V}, V)=\inf _{O \in \mathbb{O}_{r}}\|\hat{V}-V O\| \geq\left\|\hat{V}_{[(r+1): p, ;]}\right\|=\left\|V_{\perp}^{\top} \hat{V}\right\|=\|\sin \Theta(\hat{V}, V)\|
$$

Recall $V^{\top} \hat{V}=A \Sigma B^{\top}$ is the singular decomposition.

$$
\begin{aligned}
& D_{\mathrm{sp}}(\hat{V}, V)=\inf _{O \in \mathbb{O}_{r}}\|\hat{V}-V O\| \leq\left\|\hat{V}-V A B^{\top}\right\| \\
\leq & \sqrt{\left\|V^{\top}\left(\hat{V}-V A B^{\top}\right)\right\|^{2}+\left\|V_{\perp}^{\top}\left(\hat{V}-V A B^{\top}\right)\right\|^{2}}=\sqrt{\left\|A\left(\Sigma-I_{r}\right) B^{\top}\right\|^{2}+\left\|\hat{V}_{\perp}^{\top} \hat{V}\right\|^{2}} \\
\leq & \sqrt{\left(1-\sigma_{r}\right)^{2}+\|\sin \Theta(\hat{V}, V)\|^{2}} \leq \sqrt{1-\sigma_{r}^{2}+\|\sin \Theta(\hat{V}, V)\|^{2}} \stackrel{\sqrt{95}}{\leq} \sqrt{2}\|\sin \Theta(\hat{V}, V)\| .
\end{aligned}
$$

Similarly, we can show $\|\sin \Theta(\hat{V}, V)\|_{F} \leq D_{F}(\hat{V}, V) \leq \sqrt{2}\|\sin \Theta(\hat{V}, V)\|_{F}$.
For $\left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\|$, one can show

$$
\begin{aligned}
& \left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\| \geq\left\|V_{\perp}^{\top} \hat{V} \hat{V}^{\top}-V_{\perp}^{\top} V V^{\top}\right\| \\
= & \left\|\left(V_{\perp}^{\top} \hat{V}\right) \hat{V}^{\top}\right\|=\left\|V_{\perp}^{\top} \hat{V}\right\|=\|\sin \Theta(\hat{V}, V)\| \quad \text { since } V \text { is orthonormal. }
\end{aligned}
$$

Besides,

$$
\begin{aligned}
& \hat{V} \hat{V}^{\top}-V V^{\top}=\left(\mathbb{P}_{V}+\mathbb{P}_{V_{\perp}}\right) \hat{V} \hat{V}^{\top}\left(\mathbb{P}_{V}+\mathbb{P}_{V_{\perp}}\right)-V V^{\top} \\
= & V\left(\left(V^{\top} \hat{V}\right)\left(V^{\top} \hat{V}\right)^{\top}-I_{r}\right) V^{\top}+V_{\perp} V_{\perp}^{\top} \hat{V} \hat{V}^{\top} V V^{\top}+V V^{\top} \hat{V} \hat{V}^{\top} V_{\perp} V_{\perp}^{\top}+V_{\perp} V_{\perp}^{\top} \hat{V} \hat{V}^{\top} V_{\perp} V_{\perp}^{\top} .
\end{aligned}
$$

For any vector $x \in \mathbb{R}^{p}$, we denote $x_{1}=V^{\top} x, x_{2}=V_{\perp}^{\top} x$. We also denote $t=\left\|V_{\perp}^{\top} V\right\|$. Recall that we have proved in part 1 that $\sigma_{\min }^{2}\left(V^{\top} \hat{V}\right)=1-\sigma_{\max }\left(V_{\perp} \hat{V}\right)$, then $1 \geq$

$$
\begin{aligned}
& \sigma_{\max }\left(V^{\top} \hat{V}\right) \geq \sigma_{\min }\left(V^{\top} \hat{V}\right) \geq \sqrt{1-t^{2}} . \text { Thus, } \\
& \left\lvert\, \begin{aligned}
\left|x^{\top}\left(\hat{V} \hat{V}^{\top}-V V^{\top}\right) x\right|= & \mid x_{1}\left(\left(V^{\top} \hat{V}\right)\left(V^{\top} \hat{V}\right)^{\top}-I_{r}\right) x_{1}+x_{2}^{\top}\left(V_{\perp}^{\top} \hat{V}\right) \hat{V}^{\top} V x_{1} \\
& +x_{1}^{\top}\left(V^{\top} \hat{V}\right) \hat{V}^{\top} V_{\perp} x_{2}+x_{2}^{\top}\left(V_{\perp}^{\top} \hat{V}\right)\left(\hat{V}^{\top} V_{\perp}\right) x_{2} \mid \\
& \leq t^{2}\left\|x_{1}\right\|_{2}^{2}+2 t \sqrt{1-t^{2}}\left\|x_{2}\right\|_{2}\left\|x_{1}\right\|_{2}+t^{2}\left\|x_{2}\right\|_{2}^{2} \\
& \leq\left(t^{2}+t \sqrt{1-t^{2}}\right)\left(\left\|x_{1}\right\|_{2}^{2}+\left\|x_{2}\right\|_{2}^{2}\right)=t\left(1+\sqrt{1-t^{2}}\right)\|x\|_{2}^{2}
\end{aligned}\right.
\end{aligned}
$$

By Cauchy-Schwarz inequality,

$$
t\left(t+\sqrt{1-t^{2}}\right) \leq t\left(\sqrt{2\left(t^{2}+1-t^{2}\right)}\right)=\sqrt{2} t
$$

which implies

$$
\left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\| \leq \sqrt{2} t=\sqrt{2}\|\sin \Theta(\hat{V}, V)\|
$$

This has proved the equivalence between $\|\sin \theta(\hat{V}, V)\|$ and $\left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\|$. Finally for $\left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\|_{F}$, one has

$$
\begin{aligned}
\left\|\hat{V} \hat{V}^{\top}-V V^{\top}\right\|_{F}^{2} & =\operatorname{tr}\left(\left(\hat{V} \hat{V}^{\top}-V V^{\top}\right)^{2}\right)=\operatorname{tr}\left(\hat{V} \hat{V}^{\top} \hat{V} \hat{V}^{\top}+V V^{\top} V V^{\top}-\hat{V} \hat{V}^{\top} V V^{\top}-V V^{\top} \hat{V} \hat{V}^{\top}\right) \\
& =r+r-2\left\|\hat{V}^{\top} V\right\|_{F}^{2}=2\|\sin \Theta(\hat{V}, V)\|_{F}^{2}
\end{aligned}
$$

Proof of Lemma 2. Before starting the proof, we introduce some useful notations. For any matrix $M \in \mathbb{R}^{p_{1} \times p_{2}}$ with the SVD $M=\sum_{i=1}^{p_{1} \wedge p_{2}} u_{i} \sigma_{i}(M) v_{i}^{\top}$ we use $M_{\max (r)}$ to denote its leading $r$ principle components, i.e. $M_{\max (r)}=\sum_{i=1}^{r} u_{i} \sigma_{i}(M) v_{i}^{\top} ; M_{-\max (r)}$ denotes the remainder, i.e. $M_{-\max (r)}=\sum_{i=r+1}^{p_{1} \wedge p_{2}} u_{i} \sigma_{i}(M) v_{i}^{\top}$.

1. First, by a well-known fact about best low-rank matrix approximation,

$$
\sigma_{a+b+1-r}(X+Y)=\min _{M \in \mathbb{R}^{p \times n, \operatorname{rank}(M) \leq a+b-r}}\|X+Y-M\| .
$$

Hence,

$$
\sigma_{a+b+1-r}(X+Y) \leq\left\|X+Y-\left(X_{\max (a-r)}+Y\right)\right\|=\left\|X_{-\max (a-r)}\right\|=\sigma_{a+1-r}(X) ;
$$

similarly $\sigma_{a+b+1-r}(X+Y) \leq \sigma_{b+1-r}(Y)$.
2. When we further have $X^{\top} Y=0$ or $X Y^{\top}=0$, without loss of generality we can assume $X^{\top} Y=0$. Then the column space of $X$ and $Y$ are orthogonal, and $\operatorname{rank}(X+Y)=$ $\operatorname{rank}(X)+\operatorname{rank}(Y)=a+b$, which means $a+b \leq n$. Next, note that

$$
(X+Y)^{\top}(X+Y)=X^{\top} X+Y^{\top} Y+X^{\top} Y+Y^{\top} X=X^{\top} X+Y^{\top} Y,
$$

if we note $\lambda_{i}(\cdot)$ as the $r$-th largest eigenvalue of the matrix, then we have

$$
\begin{aligned}
\sigma_{i}^{2}(X+Y)= & \lambda_{i}\left((X+Y)^{\top}(X+Y)\right)=\lambda_{i}\left(X^{\top} X+Y^{\top} Y\right) \\
\geq & \max \left(\lambda_{i}\left(X^{\top} X\right),\right. \\
= & \left.\lambda_{i}\left(Y^{\top} Y\right)\right) \quad\left(\text { since } X^{\top} X, Y^{\top} Y \text { are semi-positive definite }\right) \\
& \max \left(\sigma_{i}^{2}(X), \sigma_{i}^{2}(Y)\right) \\
& \sigma_{1}^{2}(X+Y)= \\
& \lambda_{1}\left((X+Y)^{\top}(X+Y)\right)=\left\|X^{\top} X+Y^{\top} Y\right\| \\
& \leq\left\|X^{\top} X\right\|+\left\|Y^{\top} Y\right\|=\sigma_{1}^{2}(X)+\sigma_{1}^{2}(Y)
\end{aligned}
$$

Proof of Lemma 3. Since

$$
A^{\top} A=\left[\begin{array}{ll}
a^{2}+c^{2} & a b+c d \\
a b+c d & b^{2}+d^{2}
\end{array}\right]
$$

If its eigenvalues are $\lambda_{1} \geq \lambda_{2}$, clearly $\lambda_{1}+\lambda_{2}=a^{2}+b^{2}+c^{2}+d^{2}, \lambda_{1} \lambda_{2}=(a d-b c)^{2}$. We can solve that its singular values $\lambda_{1}, \lambda_{2}$ are

$$
\begin{align*}
\left\{\lambda_{1}, \lambda_{2}\right\} & =\frac{a^{2}+b^{2}+c^{2}+d^{2} \pm \sqrt{\left(a^{2}+b^{2}+c^{2}+d^{2}\right)^{2}-4(a d-b c)^{2}}}{2}  \tag{101}\\
& =\frac{a^{2}+b^{2}+c^{2}+d^{2} \pm \sqrt{\left(a^{2}+c^{2}-b^{2}-d^{2}\right)^{2}+4(a b-c d)^{2}}}{2}
\end{align*}
$$

Thus, $\lambda_{2}=\frac{a^{2}+b^{2}+c^{2}+d^{2}-\sqrt{\left(a^{2}+c^{2}-b^{2}-d^{2}\right)^{2}+4(a b-c d)^{2}}}{2} \leq \frac{a^{2}+b^{2}+c^{2}+d^{2}-\left(a^{2}+c^{2}-b^{2}-d^{2}\right)}{2}=b^{2}+d^{2}$.
Also,

$$
\lambda_{2} \geq \frac{a^{2}+b^{2}+c^{2}+d^{2}-\left(a^{2}+c^{2}-b^{2}-d^{2}\right)-2|a b-c d|}{2} \geq b^{2}+d^{2}-|a b-c d|
$$

Thus,

$$
\begin{aligned}
& a^{2}+c^{2}-\lambda_{2} \leq a^{2}+c^{2}-b^{2}-d^{2}+|a b-c d| \\
\leq & 2\left(a^{2}-b^{2}-d^{2}\right)-\left(a^{2}-b^{2}-c^{2}-d^{2}\right)+|a b+c d| \\
\leq & 2\left(a^{2}-d^{2}-b^{2} \wedge c^{2}\right)+|a b+c d|
\end{aligned}
$$

By the definition of singular vectors, we have $\left(A^{\top} A-\lambda_{2} I_{2}\right)\left[\begin{array}{l}v_{12} \\ v_{22}\end{array}\right]=0$. Thus,

$$
\left(a^{2}+c^{2}-\lambda_{2}\right) v_{12}+(a b+c d) v_{22}=0
$$

Given $v_{12}^{2}+v_{22}^{2}=1$, we have

$$
\begin{aligned}
\left|v_{12}\right| & =\frac{a b+c d}{\sqrt{\left(a^{2}+c^{2}-\lambda_{2}\right)^{2}+(a b+c d)^{2}}} \geq \frac{a b+c d}{\sqrt{\left(2\left(a^{2}-d^{2}-b^{2} \wedge c^{2}\right)+|a b+c d|\right)^{2}+(a b+c d)^{2}}} \\
& \geq \frac{a b+c d}{\sqrt{4\left(a^{2}-d^{2}-b^{2} \wedge c^{2}\right)^{2}+4\left(a^{2}-d^{2}-b^{2} \wedge c^{2}\right)|a b+c d|+2(a b+c d)^{2}}} \\
& \geq \frac{a b+c d}{\sqrt{10 \max \left\{\left(a^{2}-d^{2}-b^{2} \wedge c^{2}\right)^{2},(a b+c d)^{2}\right\}}} \\
& \geq \frac{1}{\sqrt{10}}\left(\frac{a b+c d}{a^{2}-d^{2}-b^{2} \wedge c^{2}} \wedge 1\right) .
\end{aligned}
$$

This finished the proof of Lemma 3 .

Proof of Lemma 4. Suppose the SVD of $X$ is $X=U \Sigma V^{\top}$, where $U \in \mathbb{O}_{p_{1}, r}, V \in$ $\mathbb{O}_{p_{2}, r}, \Sigma=\operatorname{diag}\left(\sigma_{1}, \cdots, \sigma_{r}\right) \in \mathbb{R}^{r \times r}$. We can extend $V \in \mathbb{O}_{p_{2}, r}$ into the full $p_{2} \times p_{2}$ orthogonal matrix

$$
\left[V V_{\perp}\right]=V_{0} \in \mathbb{O}_{p_{2}}, \quad V_{\perp} \in \mathbb{O}_{p_{2}, p_{2}-r} .
$$

For convenience, denote $Y V \triangleq Y_{1}$. Since,

$$
\begin{equation*}
E Y^{\top} Y=X^{\top} X+p_{1} I_{p_{2}}=V \Sigma^{2} V^{\top}+p_{1} I_{p_{2}}, \quad E V^{\top} Y^{\top} Y V=\Sigma^{2}+p_{1} I_{p_{2}} \tag{102}
\end{equation*}
$$

we introduce fixed normalization matrix $M \in \mathbb{R}^{p_{2} \times r}$ as

$$
M=\left[\begin{array}{lll}
\left(\sigma_{1}^{2}(X)+p_{1}\right)^{-\frac{1}{2}} & & \\
& \ddots & \\
& & \left(\sigma_{r}^{2}(X)+p_{1}\right)^{-\frac{1}{2}}
\end{array}\right]_{r \times r} .
$$

By 102, this design yields

$$
M^{\top} E Y_{1}^{\top} Y_{1} M=I_{r} .
$$

In other words, by right multiplying $M$ to $Y_{1}$, we can normalize its second moment. Now we are ready to show (43), (44) and (45).

1. We target on (43) in this step. Note that the maximum diagonal entry of $M$ is $\left(\sigma_{r}^{2}(X)+p_{1}\right)^{-\frac{1}{2}}$, thus

$$
\begin{aligned}
\sigma_{r}^{2}\left(Y_{1}\right) & \geq\left(\sigma_{r}^{2}(X)+p_{1}\right) \sigma_{r}^{2}\left(Y_{1} M\right) \geq\left(\sigma_{r}^{2}(X)+p_{1}\right) \sigma_{r}\left(M^{\top} Y_{1}^{\top} Y_{1} M\right) \\
& \geq\left(\sigma_{r}^{2}(X)+p_{1}\right)-\left(\sigma_{r}^{2}(X)+p_{1}\right)\left\|M^{\top} Y_{1}^{\top} Y_{1} M-I_{r}\right\|,
\end{aligned}
$$

(43) could be implied by

$$
\begin{equation*}

The main idea to proceed is to use $\varepsilon$-net to split the spectral norm deviation control to single random variable deviation control. Then use Hanson-Wright inequality to control the single random variable. To be specific, for any unit vector $u \in \mathbb{R}^{r}$, by expansion $Y_{1}=Y V=X V+Z V$, we have

We shall emphasize that the only random variable in the equation above is $Z \in \mathbb{R}^{p_{1} \times p_{2}}$. Our plan is to bound the two terms in (104) separately as follows.

By Hanson-Wright Inequality (Theorem 1 in Rudelson and Vershynin (2013)),

where $c$ only depends on $\tau$.

\frac{\bar{P}_{V, t}(Y)}{\tilde{P}_{V, t}(Y)}= & C_{V, t} \int_{\sigma_{\min }(W) \geq \frac{1}{2}} \exp \left(-\operatorname{tr}\left(Y Y^{\top}-2 t Y V W^{\boldsymbol{\top}}-2 t W V^{\boldsymbol{\top}} Y^{\top}+\left(4 t^{2}+p_{1}\right) W W^{\boldsymbol{\top}}\right) / 2\right) \\
& \cdot \exp \left(\operatorname{tr}\left(Y\left(I-\frac{4 t^{2}}{4 t^{2}+p_{1}} V V^{\boldsymbol{\top}}\right) Y^{\boldsymbol{\top}}\right) / 2\right) \cdot\left(\frac{4 t^{2}+p_{1}}{2 \pi}\right)^{p_{1} r / 2} d W \\
= & C_{V, t} \int_{\sigma_{\min }(W) \geq \frac{1}{2}}\left(\frac{4 t^{2}+p_{1}}{2 \pi}\right)^{p_{1} r / 2} \exp \left(-\left(4 t^{2}+p_{1}\right)\left\|W-\frac{2 t}{4 t^{2}+p_{1}} Y V\right\|_{F}^{2} / 2\right) d W \\
= & C_{V, t} \mathbf{P}\left(\left.\sigma_{\min }(\tilde{W}) \geq \frac{1}{2} \right\rvert\, \tilde{W} \in \mathbb{R}^{p_{1} \times r}, \tilde{W} \sim N\left(\frac{2 t}{4 t^{2}+p_{1}} Y V, \frac{I_{\left(p_{1} r\right)}}{4 t^{2}+p_{1}}\right)\right) . \tag{116}
\end{align*}
$$

For fixed $Y \in \mathbb{R}^{p_{1} \times p_{2}}, Y V \in \mathbb{R}^{p_{1} \times r}$, we can find $Q \in \mathbb{O}_{p_{1}, p_{1}-r}$ which is orthogonal to $Y V$, i.e. $Q^{\top} Y V=0$. Then $Q^{\top} \tilde{W} \in \mathbb{R}^{\left(p_{1}-r\right) \times r}$ and $Q^{\top} \tilde{W}$ are i.i.d. normal distributed with mean 0 and variance $1 /\left(4 t^{2}+p_{1}\right)$. By standard result in random matrix (e.g. Corollary 5.35 in Vershynin (2012)), we have

\leq & \int_{Y} \bar{P}_{V, t}(Y)\left(\log \left(\frac{\tilde{P}_{V, t}(Y)}{\tilde{P}_{V^{\prime}, t}(Y)}\right)+2 \log \left(1+\exp \left(-c p_{1}\right)\right)\right) d Y \\

& +\int_{Y}\left|\left(\tilde{P}_{V, t}(Y)-\bar{P}_{V, t}(Y)\right) \log \left(\frac{\tilde{P}_{V, t}(Y)}{\tilde{P}_{V^{\prime}, t}(Y)}\right)\right| d Y \\
\leq & \frac{16 t^{4}}{2\left(4 t^{2}+p_{1}\right)}\left\|\sin \Theta\left(V, V^{\prime}\right)\right\|_{F}^{2}+C \exp \left(-c p_{1}\right) \\
& +\exp \left(-c p_{1}\right) \int_{Y}\left|\tilde{P}_{V, t}(Y) \log \left(\frac{\tilde{P}_{V, t}(Y)}{\tilde{P}_{V^{\prime}, t}(Y)}\right)\right| d Y
\end{aligned}

For the last term in the formula above, we can calculate accordingly as

= & p_{1} \cdot \frac{4 t^{2}}{2\left(4 t^{2}+p_{1}\right)} \operatorname{tr}\left(\left(V V^{\top}+V^{\prime}\left(V^{\prime}\right)^{\top}\right) \cdot\left(I_{p_{2}}+\frac{4 t^{2}}{p_{1}} V V^{\top}\right)\right) \\
\leq & p_{1} \cdot \frac{4 t^{2}}{2\left(4 t^{2}+p_{1}\right)} \operatorname{tr}\left(2 V^{\top}\left(I_{p_{2}}+\frac{4 t^{2}}{p_{1}} V V^{\top}\right) V\right) \\

& 2 \exp (-t) \geq \mathbf{P}\left(v^{\top}\left(R_{[1: p,:]}^{\top} R_{[1: p,:]}-\frac{p}{n} I_{r}\right) v \leq \frac{p-\sqrt{2 p t}}{n+\sqrt{2 n t}+2 t}-\frac{p}{n}\right) .
\end{aligned}
$$

We set $t=C d$ for large enough $C>0$ and apply $\varepsilon$-net method (Lemma 5), the following result hold for true.
$C \exp (-c d) \geq \mathbf{P}\left(\left\|R_{1: d .:}^{\top} R_{1: d,:}-\frac{d}{n} I_{r}\right\| \geq 3 \max \left\{\frac{p+C \sqrt{p d}+C d}{n-C \sqrt{n d}}-\frac{p}{n}, \frac{p}{n}-\frac{p-C \sqrt{p d}}{n+C \sqrt{n d}+C d}\right\}\right)$.
Note that

$$
\begin{aligned}
& \max \left\{\frac{p+C \sqrt{p d}+C d}{n-C \sqrt{n d}}-\frac{p}{n}, \frac{p}{n}-\frac{p-C \sqrt{p d}}{n+C \sqrt{n d}+C d}\right\} \\
\leq & \max \left\{\frac{C(\sqrt{p d}+d+p \sqrt{d / n})}{n-C \sqrt{n d}}, \frac{C(p \sqrt{d / n}+p d / n+\sqrt{p d})}{n+C \sqrt{n d}+C d}\right\} . \\
\leq & \max \left\{\frac{C(2 \sqrt{p d}+d)}{n-C \sqrt{n d}}, \frac{C(3 \sqrt{p d})}{n+C \sqrt{n d}+C d}\right\}
\end{aligned}
$$

Thus there exists $C_{0}>0$ such that when $n>C_{0} r, n-C \sqrt{n r}>n / 2$, and additionally,

$$
\max \left\{\frac{d+C \sqrt{d r}+C r}{n-C \sqrt{n r}}-\frac{d}{n}, \frac{d}{n}-\frac{d-C \sqrt{d r}}{n+C \sqrt{n r}+C r}\right\} \leq \frac{C\left((p d)^{\frac{1}{2}}+d\right)}{n} .
$$

To sum up, we have finished the proof of Lemma 10.
