# THE COHOMOLOGY OF $(S(n, k))$ RELEVANT TO MORAVA STABILIZER ALGEBRA

#### Abstract

In this paper we redefine a increasing filtration on the the Hopf algebra $S(n, k)$, From which we get a spectral sequence called May spectral sequence. As an application we computed $H^{*, *} S(n, n)$ at prime $2, H^{*, *} S(3,2)$ at prime 3 and $H^{*, *} S(4,2)$ at prime $p \geqslant 5$


## 1. Introduction

In stable homotopy theory, the "chromatic" point of view plays an important role (cf. 33, 11, 14). Fix a prime $p$. Let $E(n)_{*}, n \geqslant 0$ be the Johnson-Wilson homology theories and let $L_{n}$ be localization functor with respect to $E(n)_{*}$. Then there are natural transformations $L_{n} X \longrightarrow L_{n-1} X$, and the chromatic tower

$$
\cdots \longrightarrow L_{n} X \longrightarrow L_{n-1} X \longrightarrow L_{2} X \longrightarrow L_{1} X \longrightarrow L_{0} X
$$

By the Hopkins-Ravenel chromatic convergence theorem, the homotopy inverse limit of this tower is the $p$-localization of $X$

$$
X \longrightarrow \operatorname{Holim} L_{n} X
$$

Thus the homotopy groups $\pi_{*}\left(L_{n} X\right)$ is the part of homotopy groups $\pi_{*}(X)$ one could see from $E(n)_{*}$.

To determine the homotopy groups $\pi_{*}\left(L_{n} X\right)$, one has the Adams-Novikov spectral sequence based on the Brown-Peterson spectrum $B P$, whose $E_{2}$-term is

E_{2}^{s, t}=E x t_{B P_{*} B P}^{s, t}\left(B P_{*}, B P_{*}\left(L_{n} X\right)\right)
$$

(cf. [1, 10, 11, 14])
To determine the Adams-Novikov $E_{2}$-term $E x t_{B P_{*} B P}^{s, t}\left(B P_{*}, B P_{*}\left(L_{n} X\right)\right)$ one has the Bockstein spectral sequence. This is an argument based on the cohomology of the Morava stabilizer algebra $S(n)$ at each prime $p(c f$. [11, 16, 17, 19]). Here the Hopf algebra $S(n)$ is defined as

S(n)=Z / p \otimes_{K(n)_{*}} K(n)_{*} K(n) \otimes_{K(n)_{*}} Z / p
$$

where $K(n)_{*}=Z / p\left[v_{n}, v_{n}^{-1}\right]$,

$$
K(n)_{*} K(n)=K(n)_{*} \otimes_{B P_{*}} B P_{*} B P \otimes_{B P_{*}} K(n)_{*}=K(n)_{*}\left[t_{1}, t_{2}, \cdots\right] /\left(v_{n} t_{s}^{p^{n}}-v_{n}^{p^{s}} t_{s}\right)
$$

$K(n)_{*}$ acts on $Z / p$ by sending $v_{n}$ to 1 . Thus

$$
S(n)=Z / p\left[t_{1}, t_{2}, \cdots, t_{s}, \cdots\right] /\left(t_{s}^{p^{n}}-t_{s}\right)
$$

[^0]We write $S(n, k)=S(n) /\left(t_{j}: j<k\right)=Z / p\left[t_{k}, t_{k+1}, \cdots t_{s}, \cdots\right] /\left(t_{s}^{p^{n}}-t_{s}\right)$. The Hopf algebra structure of $S(n)$ determines that of $S(n, k)$, while $S(n, 1)=S(n)$. Let $V(n-1)$ and $T(k-1)$ denote the Smith-Toda spectra and the Ravenel spectra respectively characterized by

B P_{*} V(n-1) & =B P_{*} / I_{n}=B P_{*} /\left(p, v_{1}, \cdots, v_{n-1}\right) \quad \text { and } \\
B P_{*} T(k-1) & =B P_{*}\left[t_{1}, t_{2}, \cdots, t_{k-1}\right]
\end{aligned}

If $L_{n} V(n-1) \wedge T(k-1)$ exist, (although $V(n-1)$ does not exist (cf. 6]), but $V(n-$ 1) $\wedge T(k-1)$ might exist), then by the change of rings theorem, the $E_{2}$-term of the Adams-Novikov spectral sequence converging to $\pi_{*}\left(L_{n} V(n-1) \wedge T(k-1)\right)$ is

& E x t_{B P_{*} B P}^{s, t}\left(B P_{*}, B P_{*}\left(L_{n} V(n-1) \wedge T(k-1)\right)\right) \\
\cong & E x t_{S(n, k)}^{s, t}(Z / p, Z / p) \otimes K(n)_{*}\left[v_{n+1}, \cdots, v_{n+k-1}\right]
\end{aligned}
$$

In this paper, we will use $H^{s, *} S(n, k)$ to denote the Ext groups Ext ${ }_{S(n, k)}^{s, *}(Z / p, Z / p)$. In [5, 13], Ravenel and Henn determined $H^{s, *} S(1), H^{s, *} S(2)$ at all primes, and $H^{s, *} S(3)$ at the odd primes $p \geqslant 5 . H^{s, *} S(n, k)$ is known from 11 for $k \geqslant n$ at odd primes and $k>n$ at the prime 2 . In 15 Shimomura and Tokashiki computed $H^{s, *} S(n, n-1)$ at odd primes $p>3$. In this paper we will be concentrated on the case $k \leqslant n$.

Consider the cohomology of the Hopf algebra $S(n, k)$ at all primes. In section 2 of this paper, we follow Ravenel's ideal ( $c f$. [11] 3.2.5 Theorem), redefined the May filtration in $S(n, k)$ and its cobar complex $C^{s, *} S(n, k)$. This filtration induces a spectral sequence so called May spectral sequence $\left\{E_{r}^{s, *, M}(n, k), d_{r}\right\}$ that converges to $H^{s, *} S(n, k)$. Then in section 3 we prove that the $E_{2}$-term of the May spectral sequence is isomorphic to the cohomology of

\left\{E\left[h_{i, j} \mid k \leqslant i \leqslant s_{0}, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i \leqslant s_{0}-n, j \in Z / n\right], d_{1}\right\}
$$

where $s_{0}=\max \left\{\left[\frac{2 p n+p-2}{2(p-1)}\right], n+k-1\right\}$ and $\left[\frac{2 p n+p-2}{2(p-1)}\right]$ is the integer part of $\frac{2 p n+p-2}{2(p-1)}$. In particular, if

$$
n+k-1 \geqslant\left[\frac{2 p n+p-2}{2(p-1)}\right]
$$

the May's $E_{2}$-term becomes the cohomology of

$$
\left\{E\left[h_{i, j} \mid k \leqslant i \leqslant n+k-1, j \in Z / n\right], d_{1}\right\} .
$$

The homological dimension of each element is given by

$$
s\left(h_{i, j}\right)=1, \quad s\left(b_{i, j}\right)=2
$$

For the May differentials, one has $d_{r}: E_{r}^{s, t, M} S(n, k) \longrightarrow E_{r}^{s+1, t, M-r} S(n, k)$ and if $x \in$ $E_{r}^{s, *, *} S(n, k)$ then

d_{r}(x \cdot y)=d_{r}(x) \cdot y+(-1)^{s} x \cdot d_{r}(y)
$$

The first May differential $d_{1}$ is given by

$$
d_{1}\left(h_{i, j}\right)=-\sum_{k \leqslant m \leqslant i-k} h_{m, j} h_{i-m, j+m}, \quad \text { and } \quad d_{1}\left(b_{i, j}\right)=0
$$

We analyze the higher May differentials and give a collapse theorem in section 4. As an consequence we compute the cohomology of $S(n, n)$ at the prime $2, S(3,2)$ at the prime 3 and $S(4,2)$ at the prime $p \geqslant 5$ in section 5 .

## 2. The May spectral sequence

Let $p$ be a prime, $B P_{*}=Z_{(p)}\left[v_{1}, v_{2}, \cdots\right]$ and $B P_{*} B P=B P_{*}\left[t_{1}, t_{2}, \cdots\right]$. For the Hazewinkel's generators described inductively by $v_{s}=p m_{s}-\sum_{i=1}^{s-1} v_{s-i}^{p^{i}} m_{i}$ (cf. [4] and [10] 1.2), the diagonal map $\Delta: B P_{*} B P \rightarrow B P_{*} B P \otimes_{B P_{*}} B P_{*} B P$ is given by

\sum_{i+j=s} m_{i}\left(\Delta t_{j}\right)=\sum_{i+j+k=s} m_{i} t_{j}^{p^{i}} \otimes t_{k}^{p^{i+j}}
$$

One can easily prove that

$$

& \Delta\left(t_{1}\right)=t_{1} \otimes 1+1 \otimes t_{1} \\
& \Delta\left(t_{2}\right)=\sum_{i+j=2} t_{i} \otimes t_{j}^{p^{i}}-v_{1} b_{1,0}
\end{aligned}
$$

where $p \cdot b_{1,0}=\Delta\left(t_{1}^{p}\right)-t_{1}^{p} \otimes 1-1 \otimes t_{1}^{p}$. Inductively define

$$
p \cdot b_{s, k-1}=\Delta\left(t_{s}^{p^{k}}\right)-\sum_{i+j=s} t_{i}^{p^{k}} \otimes t_{j}^{p^{i+k}}+\sum_{0<i<s} v_{i}^{p^{k}} b_{s-i, k+i-1}
$$

one has

$$
\begin{equation*}
\Delta\left(t_{s+1}\right)=\sum_{i+j=s+1} t_{i} \otimes t_{j}^{p^{i}}-\sum_{0<i<s+1} v_{i} b_{s+1-i, i-1} \tag{2.1}
\end{equation*}
$$

Thus for the $n$-th Morava K-theory $K(n)=Z / p\left[v_{n}, v_{n}^{-1}\right]$, the Hopf algebra

$$
K(n)_{*} K(n)=K(n)_{*} \otimes_{B P_{*}} B P_{*} B P \otimes_{B P_{*}} K(n)_{*}
$$

is isomorphic to

$$
K(n)_{*} K(n)=Z / p\left[t_{1}, t_{2}, \cdots, t_{s}, \cdots\right] /\left(v_{n} t_{s}^{p^{n}}-v_{n}^{p^{s}} t_{s}\right)
$$

And $S(n)=Z / p \otimes_{K(n)_{*}} K(n)_{*} K(n) \otimes_{K(n)_{*}} Z / p$ is isomorphic to

$$
S(n)=Z / p\left[t_{1}, t_{2}, \cdots, t_{n}, t_{n+1}, \cdots\right] /\left(t_{s}^{p^{n}}-t_{s}\right)
$$

The inner degree of $t_{s}$ in $S(n)$ is

$$
\left|t_{s}\right| \equiv 2(p-1)\left(1+p+\cdots+p^{s-1}\right) \quad \bmod 2(p-1)\left(1+p+\cdots+p^{n-1}\right)
$$

because $v_{n}$ is sent to 1 . The structure map $\Delta: S(n) \longrightarrow S(n) \otimes S(n)$ acts on $t_{s}$ as follows

\Delta\left(t_{s}\right)=\sum_{0 \leqslant i \leqslant s} t_{i} \otimes t_{s-i}^{p^{i}} & \text { for } s \leqslant n \\
\Delta\left(t_{s}\right)=\sum_{0 \leqslant i \leqslant s} t_{i} \otimes t_{s-i}^{p^{i}}-b_{s-n, n-1} & \text { for } s>n
\end{array}
$$

where $b_{i, j}=\sum_{0<m<p}\binom{p}{m} / p \cdot t_{i}^{m p^{j}} \otimes t_{i}^{(p-m) p^{j}}$ at odd primes and $b_{i, j}=t_{i}^{2^{j}} \otimes t_{i}^{2^{j}}$ at the prime 2. For the integer $k \geqslant 1$, let $S(n, k)=S(n) /\left(t_{s} \mid s<k\right)$. We have

$$
S(n, k)=Z / p\left[t_{k}, t_{k+1}, \cdots, t_{n+k}, t_{n+k+1}, \cdots\right] /\left(t_{s}^{p^{n}}-t_{s}\right)
$$

the structure map $\Delta: S(n, k) \longrightarrow S(n, k) \otimes S(n, k)$ acts on $t_{s}$ as

$$
\begin{array}{ll}
\Delta\left(t_{s}\right)=1 \otimes t_{s}+\sum_{k \leqslant i \leqslant s-k} t_{i} \otimes t_{s-i}^{p^{i}}+t_{s} \otimes 1 & \text { for } s \leqslant n+k-1, \\
\Delta\left(t_{s}\right)=1 \otimes t_{s}+\sum_{k \leqslant i \leqslant s-k} t_{i} \otimes t_{s-i}^{p^{i}}+t_{s} \otimes 1-b_{s-n, n-1} & \text { for } s \geqslant n+k \tag{2.2}
\end{array}
$$

In the resulting May spectral sequence, we want to have the 0-th May differential is

$$
d_{0}\left(t_{s}^{p^{j}}\right)=0
$$

and the first May differential is given by

$$
d_{1}\left(t_{s}\right)=t_{k} \otimes t_{s-k}^{p^{k}}+t_{k+1} \otimes t_{s-k-1}^{p^{k+1}}+\cdots+t_{s-k} \otimes t_{k}^{p^{s-k}} \quad \text { for } s \leqslant n+k-1,
$$

and for $s \geqslant n+k$
$d_{1}\left(t_{s}\right)= \begin{cases}t_{k} \otimes t_{s-k}^{p^{k}}+\cdots+t_{s-k} \otimes t_{k}^{p^{s-k}} & \text { if the May flitration } M\left(t_{k} \otimes t_{s-k}^{p^{k}}\right)>M\left(b_{s-n, n-1}\right), \\ -b_{s-n, n-1} & \text { if the May flitration } M\left(t_{k} \otimes t_{s-k}^{p^{k}}\right) \leqslant M\left(b_{s-n, n-1}\right) .\end{cases}$
So we define the May filtration on $S(n, k)$ as:
Definition 2.3 In the Hopf algebra $S(n, k)$, we define May filtration $M$ as follows:
(1) For $k \leqslant s \leqslant n+k-1$, set the May filtration of $t_{s}^{p^{j}}$ as $M\left(t_{s}^{p^{j}}\right)=2 s-1$.
(2) For $n+k \leqslant s$, inductively set the May filtration of $t_{s}^{p^{j}}$ as

M\left(t_{s}^{p^{j}}\right)=\max \left\{2 s-1, \quad p M\left(t_{s-n}^{p^{j+n-1}}\right)+1\right\} .
$$

(3) For the monomial $t_{s}^{j}$, express $j$ by the $p-a d i c ~ n u m b e r ~ a s ~ j=j_{0}+j_{1} p+\cdots+j_{m} p^{m}$, where $0 \leqslant j_{i}<p$. Set the May filtration of $t_{s}^{j}$ as

M\left(t_{s}^{j}\right)=\sum_{0 \leqslant i \leqslant m} j_{i} M\left(t_{s}^{p^{i}}\right)
$$

(4) And for $t_{s_{1}}^{j_{1}} \cdot t_{s_{2}}^{j_{2}} \cdots t_{s_{m}}^{j_{m}}$, where $s_{i} \neq s_{j}$ define its May filtration as

$$
M\left(t_{s_{1}}^{j_{1}} \cdot t_{s_{2}}^{j_{2}} \cdots t_{s_{m}}^{j_{m}}\right)=\sum_{1 \leqslant i \leqslant m} M\left(t_{s_{i}}^{j_{i}}\right) .
$$

Lemma 2.4 Let $s_{0}=\max \left\{\left[\frac{2 p n+p-2}{2(p-1)}\right], n+k-1\right\}$ where $\left[\frac{2 p n+p-2}{2(p-1)}\right]$ is the integer part of $\frac{2 p n+p-2}{2(p-1)}$. Then the May filtration of $t_{s}^{p^{j}}$ satisfies
(1) $M\left(t_{s}^{p^{j}}\right)>M\left(t_{s-1}^{p^{j}}\right)+1$ and
(2) For $s \leqslant s_{0}$, the May filtration $M\left(t_{s}^{p^{j}}\right)=2 s-1$.
(3) For $s>s_{0}, p M\left(t_{s-n}^{p^{j}}\right)+1 \geqslant 2 s-1$ and the May filtration $M\left(t_{s}^{p^{j}}\right)=p M\left(t_{s-n}^{p^{j}}\right)+1$.

Proof. 1) If $s_{0}=\max \left\{\left[\frac{2 p n+p-2}{2(p-1)}\right], n+k-1\right\}=n+k-1$. From its definition, we see that for $s \leqslant n+k-1=s_{0}$, the May filtration of $t_{s}^{p^{j}}$ is $2 s-1$ and $M\left(t_{s}^{p^{j}}\right)>M\left(t_{s-1}^{p^{j}}\right)+1$. From $n+k-1 \geqslant\left[\frac{2 p n+p-2}{2(p-1)}\right]$, one sees that

$$
s_{0}+1=n+k>\frac{2 p n+p-2}{2(p-1)} \quad \text { and } \quad p(2 k-1)+1>2(n+k)-1
$$

Thus from $M\left(t_{k}^{p^{j}}\right)=2 k-1$, one knows that the May filtration of $t_{n+k}^{p^{j}}$ is $p M\left(t_{k}^{p^{j}}\right)+1$ and

$$
M\left(t_{n+k}^{p^{j}}\right)=p(2 k-1)+1>2(n+k)-1=M\left(t_{n+k-1}^{p^{j}}\right)+1
$$

Inductively suppose that $M\left(t_{s}^{p^{j}}\right)>M\left(t_{s-1}^{p^{j}}\right)+1$ and for $s_{0}<s \leqslant m$,

$$
p M\left(t_{s-n}^{p^{j}}\right)+1>2 s-1
$$

so the May filtration $M\left(t_{s}^{p^{j}}\right)=p M\left(t_{s-n}^{p^{j}}\right)+1$. Then from $M\left(t_{m+1-n}^{p^{j}}\right)>M\left(t_{m-n}^{p^{j}}\right)+1$ one get

$$
\begin{aligned}
p M\left(t_{m+1-n}^{p^{j}}\right)+1 & >p\left(M\left(t_{m-n}^{p^{j}}\right)+1\right)+1=p M\left(t_{m-n}^{p^{j}}\right)+p+1 \\
& >2 m-1+p \geqslant 2(m+1)-1
\end{aligned}
$$

The May filtration of $t_{m+1}^{p^{j}}$ is $p M\left(t_{m+1-n}^{p^{j}}\right)+1$.
If $s_{0}=\left[\frac{2 p n+p-2}{2(p-1)}\right]>n+k-1$, then for $k \leqslant s \leqslant s_{0}, s \leqslant \frac{2 p n+p-2}{2(p-1)}$. This implies

$$
p(2(s-n)-1)+1 \leqslant 2 s-1
$$

From $\frac{2 p n+p-2}{2(p-1)} \leqslant 2 n$ we see that $s-n \leqslant n \leqslant n+k-1$. Thus the May filtration $M\left(t_{s-n}^{p^{j}}\right)=2(s-n)-1$ and $p M\left(t_{s-n}^{p^{j}}\right)+1<2 s-1$. This implies that the May filtration of $t_{s}^{p^{j}}$ is $2 s-1$ and $M\left(t_{s}^{p^{j}}\right)>M\left(t_{s-1}^{p^{j}}\right)+1$.

Notice that $s_{0}+1=\left[\frac{2 p n+p-2}{2(p-1)}\right]+1>\frac{2 p n+p-2}{2(p-1)}$, this implies

$$
p\left(2\left(s_{0}+1-n\right)-1\right)+1>2\left(s_{0}+1\right)-1
$$

The May filtration of $t_{s_{0}+1-n}^{p^{j}}$ is $2\left(s_{0}+1-n\right)-1$, so the May filtration

$$
M\left(t_{s_{0}+1}^{p^{j}}\right)=p M\left(t_{s_{0}+1-n}^{p^{j}}\right)+1
$$

Similarly, by induction we get the Lemma.
Example: The May filtration in $S(4,2)$ is given by:

Let $F^{*, M}(n, k)$ be the sub-module of $S(n, k)$ generated by the elements with May filtration $\leqslant M$. Set $E^{*, M}(n, k)=F^{*, M}(n, k) / F^{*, M-1}(n, k)$. One can see from Lemma 2.4 that

$$
\begin{equation*}
E^{*, *}(n, k) \cong \bigotimes_{k \leqslant s} T\left[t_{s}^{p^{j}} \mid j \in Z / n\right] \tag{2.5}
\end{equation*}
$$

is a bigraded Hopf algebra, where $T[$ ] denote the truncated polynomial algebra of height $p$ on the indicated generators. The structure map

$$
\Delta: E^{*, *}(n, k) \longrightarrow E^{*, *}(n, k) \otimes E^{*, *}(n, k)
$$

acts the the generators $t_{s}^{p^{j}}$ as $\Delta\left(t_{s}^{p^{j}}\right)=1 \otimes t_{s}^{p^{j}}+t_{s}^{p^{j}} \otimes 1$.

Let $C^{s, t} S(n, k)=\otimes^{s} \bar{S}(n, k)$ denote the cobar construction of $S(n, k)$ where $\bar{S}(n, k)=$ Ker $\epsilon$ denote the augmentation ideal of $S(n, k)$. The differential

$$
d: C^{s, t} S(n, k) \longrightarrow C^{s+1, t} S(n, k)
$$

is given on the generators as

$$
\begin{align*}
& d\left(\alpha_{1} \otimes \cdots \otimes \alpha_{s}\right) \\
= & \sum_{1 \leqslant i \leqslant s}(-1)^{i} \alpha_{1} \otimes \cdots \otimes\left(\Delta\left(\alpha_{i}\right)-\alpha_{i} \otimes 1-1 \otimes \alpha_{i}\right) \otimes \cdots \otimes \alpha_{s} \tag{2.6}
\end{align*}
$$

In general, the generator $\alpha_{1} \otimes \alpha_{2} \otimes \cdots \otimes \alpha_{s}$ of $C^{s, t} S(n, k)$ is denoted by $\left[\alpha_{1}\left|\alpha_{2}\right| \cdots \mid \alpha_{s}\right]$. For the generator $\left[\alpha_{1}\left|\alpha_{2}\right| \cdots \mid \alpha_{s}\right]$, define its May filtration as

$$
M\left(\left[\alpha_{1}\left|\alpha_{2}\right| \cdots \mid \alpha_{s}\right]\right)=M\left(\alpha_{1}\right)+M\left(\alpha_{2}\right)+\cdots+M\left(\alpha_{s}\right)
$$

Let $F C^{*, *, M} S(n, k)$ denote the sub-complex of $C^{*, *} S(n, k)$ generated by the elements with May filtration $\leqslant M$. Then we get a short exact sequence

$$
\begin{equation*}
0 \longrightarrow F C^{*, *, M-1} S(n, k) \longrightarrow F C^{*, *, M} S(n, k) \longrightarrow E_{0}^{*, *, M} S(n, k) \longrightarrow 0 \tag{2.7}
\end{equation*}
$$

of cochain complexes. The cochain complex

$$
E_{0}^{*, *, M} S(n, k)=F C^{*, *, M} S(n, k) / F C^{*, *, M-1} S(n, k)
$$

is isomorphic to the cobar complex of $E^{*, *}(n, k)$ given in (2.5). Let $E_{1}^{*, *, M} S(n, k)$ be the homology of ( $\left.E_{0}^{*, *, M} S(n, k), d_{0}\right)$. Then (2.7) gives rise to a spectral sequence (so called the May spectral sequence)

$$
\left\{E_{r}^{s, t, M}(n, k), d_{r}\right\}
$$

that converges to

$$
H^{s, t}\left(C^{*, t} S(n, k), d\right)=E x t_{S(n, k)}^{s, t}(Z / p, Z / p)
$$

Theorem 2.8 For $k \leqslant n$ the Hopf algebra $S(n, k)$ can be given an increasing filtration as in Definition (2.3). The associated bigraded Hopf algebra $E^{*, M}(n, k)$ is primitively generated with the algebra structure of (2.5). In the associated spectral sequence, the $E_{1}$-term $E_{1}^{s, t, M} S(n, k)$ is isomorphic to

$$
E\left[h_{i, j} \mid k \leqslant i, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i, j \in Z / n\right] .
$$

The homological dimension of each element is given by $s\left(h_{i, j}\right)=1, s\left(b_{i, j}\right)=2$ and the degree is given by

$$
\begin{aligned}
h_{i, j} & \in E_{1}^{1,2\left(p^{i}-1\right) p^{j}, *}(n, k), \\
b_{i, j} & \in E_{1}^{2,2\left(p^{i}-1\right) p^{j+1}, *}(n, k)
\end{aligned}
$$

here $h_{i, j}$ corresponds to $t_{i}^{p^{j}}$ and $b_{i, j}$ corresponds to $\sum\binom{p}{m} / p t_{i}^{m p^{j}} \otimes t_{i}^{(p-m) p^{j}}$. One has $d_{r}: E_{r}^{s, t, M} S(n, k) \longrightarrow E_{r}^{s+1, t, M-r} S(n, k)$ and if $x \in E_{r}^{s, *, *} S(n, k)$ then

$$
d_{r}(x \cdot y)=d_{r}(x) \cdot y+(-1)^{s} x \cdot d_{r}(y)
$$

In the $E_{1}$-term of this spectral sequence, we have the following relations:

$$
h_{i, j} \cdot h_{i_{1}, j_{1}}=-h_{i_{1}, j_{1}} h_{i, j} \quad h_{i, j} \cdot b_{i_{1}, j_{1}}=b_{i_{1}, j_{1}} \cdot h_{i, j} \quad b_{i, j} \cdot b_{i_{1}, j_{1}}=b_{i_{1}, j_{1}} \cdot b_{i, j}
$$

Proof. It is a routine calculation in homology algebra that for the truncated polynomial algebra $\Gamma=T[x]$ with $|x| \equiv 0 \bmod 2$ and $x$ primitive,

$$
\operatorname{Ext}_{\Gamma}(Z / p, Z / p)=E[h] \otimes P[b]
$$

where $h \in E x t^{1}$ is represented in the cobar complex by $x$ and $b \in E x t^{2}$ is represented by $\sum\binom{p}{m} / p\left(x^{m} \otimes x^{(p-m)}\right)\left(b=h^{2}\right.$ represented by $x \otimes x$ at the prime 2$)$. Notice that the $E_{0}$-term of the spectral sequence is isomorphic to the cobar complex of $E^{*, M}(n, k)$. Then from (2.5) we see that

$$
H^{s, *, M}\left(E_{0}^{*, t, M} S(n, k), d_{0}\right)=E x t_{E^{*, *}(n, k)}^{s, t}(Z / p, Z / p)=\bigotimes_{k \leqslant s} E x t_{T\left[t_{s}^{\left.p_{j}^{j}\right]}\right.}^{*, *}(Z / p, Z / p)
$$

Thus the May's $E_{1}$-term

$$
E_{1}^{s, t, M} S(n, k)=E\left[h_{i, j} \mid k \leqslant i, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i, j \in Z / n\right]
$$

Notice that $d_{0}\left(t_{i}^{p^{j}} \cdot t_{i_{1}}^{p_{1}}\right)=-t_{i}^{p^{j}} \otimes t_{i_{1}}^{p_{1}}-t_{i_{1}}^{p_{1}} \otimes t_{i}^{p^{j}}$, we get $h_{i, j} h_{i_{1}, j_{1}}=-h_{i_{1}, j_{1}} h_{i, j}$. In a similar way, one can proof that $h_{i, j} \cdot b_{i_{1}, j_{1}}=b_{i_{1}, j_{1}} \cdot h_{i, j}$ and $b_{i, j} \cdot b_{i_{1}, j_{1}}=b_{i_{1}, j_{1}} \cdot b_{i, j}(c f$. [6] Lemma 3.4 and 3.8).

## 3. The first May differentials

Now suppose $k \leqslant n$, then $s_{0} \leqslant 2 n$. From (2.2) and Lemma 2.4 one has

$$
\begin{array}{ll}
d_{1}\left(h_{i, j}\right)=-\sum_{k \leqslant r \leqslant i-k} h_{r, j} h_{i-r, j+r} & \text { for } i \leqslant s_{0}  \tag{3.1}\\
d_{1}\left(h_{i, j}\right)=b_{i-n, j+n-1} & \text { for } s_{0}<i
\end{array}
$$

Thus for $i>s_{0}-n, b_{i, j}$ is the boundary of the first May differentials. Recall from [10] Theorem 4.3.22, in the cobar complex of $B P / I_{n}$ one has

$$
\begin{equation*}
d\left(b_{i, j}\right)=\sum_{0<r<i}\left(b_{r, j} \otimes t_{i-r}^{p^{r+j+1}}-t_{r}^{p^{j+1}} \otimes b_{i-r, r+j}\right) \tag{3.2}
\end{equation*}
$$

Thus for $i \leqslant s_{0}-n$, the first May differential $d_{1}\left(b_{i, j}\right)=0$. This implies:
Theorem 3.3 Let $k \leqslant n$ and $s_{0}$ be given in Lemma 2.4. The $E_{2}$-term of the May spectral sequence is isomorphic to the cohomology of

$$
\widetilde{E}_{1}^{*, *, *} S(n, k)=E\left[h_{i, j} \mid k \leqslant i \leqslant s_{0}, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i \leqslant s_{0}-n, j \in Z / n\right]
$$

The first May differential are given by

$$
\begin{array}{ll}
d_{1}\left(h_{i, j}\right)=-\sum_{k \leqslant r \leqslant i-k} h_{r, j} h_{i-r, r+j} & \text { for } i \leqslant s_{0} \\
d_{1}\left(b_{i, j}\right)=0 & \text { for } k \leqslant i \leqslant s_{0}-n
\end{array}
$$

At the prime $p=2, s_{0}=2 n$. The reduced May $E_{1}$-term becomes

$$
\widetilde{E}_{1}^{*, *, *} S(n, k)=E\left[h_{i, j} \mid n<i \leqslant 2 n, j \in Z / n\right] \otimes P\left[h_{i, j} \mid k \leqslant i \leqslant n, j \in Z / n\right]
$$

and the first May differential of $h_{2 n, j}$ is given by

$$
d_{1}\left(h_{2 n, j}\right)=-\sum_{k \leqslant i \leqslant 2 n-k} h_{i, j} h_{2 n-i, i+j}+h_{n, j+n-1}^{2}
$$

Proof. We define a filtration in the May's $E_{1}$-term

$$
E_{1}^{*, *, *} S(n, k)=E\left[h_{i, j} \mid k \leqslant i, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i, j \in Z / n\right]
$$

as follows: for each $s \geqslant k$, define

$$
F^{s}(n, k)= \begin{cases}E\left[h_{i, j} \mid k \leqslant i \leqslant s\right] & \text { for } k \leqslant s \leqslant n+k-1 \\ E\left[h_{i, j} \mid k \leqslant i \leqslant s\right] \otimes P\left[b_{i, j} \mid k \leqslant i \leqslant s-n\right] & \text { for } n+k-1<s\end{cases}
$$

From (3.1), we see that for each $s \geqslant k, F^{s}(n, k)$ is a sub-complex of $E_{1}^{*, *, *} S(n, k)$ that satisfies

$$
F^{s_{0}}(n, k)=\widetilde{E}_{1}^{*, *, *}(n, k)=E\left[h_{i, j} \mid k \leqslant i \leqslant s_{0}, j \in Z / n\right] \otimes P\left[b_{i, j} \mid k \leqslant i \leqslant s_{0}-n, j \in Z / n\right]
$$

and

$$
F^{k}(n, k) \hookrightarrow F^{k+1}(n, k) \hookrightarrow \cdots \hookrightarrow F^{s}(n, k) \hookrightarrow F^{s+1}(n, k) \hookrightarrow \cdots \hookrightarrow E_{1}^{*, *, *}(n, k) .
$$

Indeed, for $s>n+k-1$,

$$
F^{s}(n, k)=F^{s-1}(n, k) \bigotimes\left(E\left[h_{s, j} \mid j \in Z / n\right] \otimes P\left[b_{s-n, j} \mid j \in Z / n\right]\right)
$$

For $s>s_{0}$ one has $d_{1}\left(h_{s, j}\right)=b_{s-n, j+n-1}$. Thus

$$
E\left[h_{s, j} \mid j \in Z / n\right] \otimes P\left[b_{s-n, j} \mid j \in Z / n\right]
$$

is a sub-complex of $F^{s}(n, k)$ whose cohomology is $Z / p$ concentrated at dimensional 0 . This implies

$$
H^{*} F^{s_{0}}(n, k) \cong H^{*} F^{s_{0}+1}(n, k) \cong \cdots \cong H^{*} F^{s}(n, k) \cong \cdots \cong H^{*} E_{1}^{*, *, *} S(n, k)
$$

At prime $p=2, s_{0}=\left[\frac{2 \times 2 n}{2}\right]=2 n>n+k-1$. The first May differentials are deduced from (2.2).

As a corollary one can easily see that if $\frac{2 p n+p-2}{2(p-1)} \leqslant n+k-1$, then the reduced May's $E_{1}$-term becomes

$$
\widetilde{E}_{1}^{*, *, *} S(n, k)=E\left[h_{i, j} \mid k \leqslant i \leqslant n+k-1, j \in Z / n\right] .
$$

Theorem 3.4 If $\frac{2 p n+p-2}{2(p-1)} \leqslant n+k-1$, then the cohomology of $S(n, k)$ is of dimensional $n^{2}$.

## 4. The higher May differentials in the MSS for $S(n, k)$

From (3.2) we see that the first non-trivial May differential of $b_{i, j}$ appears at

$$
d_{r}\left(b_{i, j}\right)= \begin{cases}0 & \text { if } i<2 k  \tag{4.1}\\ b_{i-k, j} h_{k, j+k+1}-h_{k, j+1} b_{i-k, j+k} & \text { if } i \geqslant 2 k\end{cases}
$$

In [6] (2.10) and (2.11), a collapse theorem is given for the higher May differentials in the exterior part $E\left[h_{i, j} \mid i>0, j \geqslant 0\right]$ of the MSS for the steenrod algebra $A$ at odd primes. In this section, we will give a similar collapse theorem for the higher May differentials of $E_{r}^{*, *, *} S(n, k)$.

Let $p$ be an odd prime. We define a Hopf algebra $T(n, k)$ as

$$
\begin{equation*}
T(n, k)=P\left[\xi_{i} \mid k \leqslant i \leqslant n+k-1\right] . \tag{4.2}
\end{equation*}
$$

The inner degree of $\xi_{i}$ is defined to be $\left|\xi_{i}\right|=2(p-1)\left(1+p+\cdots+p^{i-1}\right)$ and the structure $\operatorname{map} \Delta: T(n, k) \longrightarrow T(n, k) \otimes T(n, k)$ acts on $\xi_{i}$ by

$$
\Delta\left(\xi_{i}\right)=\xi_{i} \otimes 1+\sum_{k \leqslant r \leqslant i-k} \xi_{r} \otimes \xi_{i-r}^{p^{r}}+1 \otimes \xi_{i}
$$

There is a Hopf algebra reduction homomorphism $\Phi: T(n, k) \rightarrow S(n, k)$ which send $\xi_{i}$ to $t_{i}$. The image of $\Phi$ is $P\left[t_{i} \mid k \leqslant i \leqslant n+k-1\right] /\left(t_{i}^{p^{n}}-t_{i}\right)$ and $\operatorname{Ker} \Phi$ is the idea generated by $\left(\xi_{i}^{p^{n}}-\xi_{i}\right)$. Further more the homomorphism $\Phi$ also induces homomorphism in cobar complexes and cohomologies

$$
\Phi: E x t_{T(n, k)}^{s, *}(Z / p, Z / p) \longrightarrow E x t_{S(n, k)}^{s, *}(Z / p, Z / p)
$$

Similar to that of definition 2.3, we set May filtration on $T(n, k)$ as

$$
M\left(\xi_{i}^{p^{j}}\right)=2 i-1
$$

and let $F^{*, M} T(n, k)$ be the sub-module of $T(n, k)$ generated by the elements with May filtration $\leqslant M$. Then $E^{*, M} T(n, k)=F^{*, M} T(n, k) / F^{*, M-1} T(n, k)$ becomes a bigraded Hopf algebra with the structure of

$$
E^{*, *} T(n, k)=\bigotimes T\left[\xi_{i}^{p^{j}} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right]
$$

and $\Delta\left(\xi_{i}^{p^{j}}\right)=\xi_{i}^{p^{j}} \otimes 1+1 \otimes \xi_{i}^{p^{j}}$.
Consider the cobar construction $C^{s, *} T(n, k)$ of $T(n, k)$. Similarly for the generator $\left[\beta_{1}\left|\beta_{2}\right| \cdots \mid \beta_{s}\right]$ of $C^{s, *} T(n, k)$ define its May filtration as

$$
M\left(\left[\beta_{1}\left|\beta_{2}\right| \cdots \mid \beta_{s}\right]\right)=M\left(\beta_{1}\right)+M\left(\beta_{2}\right)+\cdots+M\left(\beta_{s}\right)
$$

and let $F C^{*, *, M} T(n, k)$ denote the sun-complex generated by elements with May filtration $\leqslant M$. We get a spectral sequence $\left\{E_{r}^{s, *, M} T(n, k), d_{r}\right\}$ with $E_{0}$-term

$$
E_{0}^{*, *, M} T(n, k)=F C^{*, *, M} T(n, k) / F C^{*, *, M-1} T(n, k)
$$

which is isomorphic to the cobar complex of $E^{*, M} T(n, k)$. The $E_{1}$-term of this spectral sequence is isomorphic to

$$
\begin{equation*}
E_{1}^{*, *, *} T(k, n)=E\left[h_{i, j}^{\prime} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right] \otimes P\left[b_{i, j}^{\prime} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right] . \tag{4.3}
\end{equation*}
$$

Noticed that the reduction map $\Phi: T(n, k) \rightarrow S(n, k)$ is May filtration preserving, it induces a homomorphism of May spectral sequences

$$
\Phi: E_{r}^{*, *, *} T(n, k) \longrightarrow E_{r}^{*, *, *} S(n, k) .
$$

Theorem 4.4 The reduction map $\Phi: T(n, k) \longrightarrow S(n, k)$ induces a homomorphism between May spectral sequences $\Phi: E_{1}^{*, *, *} T(n, k) \longrightarrow E_{1}^{*, *, *} S(n, k)$ which sends $h_{i, j}^{\prime}$ and $b_{i, j}^{\prime}$ to $h_{i, j}$ and $b_{i, j}$ respectively. It sends infinite cocycles of $E_{r}^{*, *, *} T(n, k)$ to that of $E_{r}^{*, *, *} S(n, k)$.

Similar to [6] (2.10) and (2.11) we give a collapse theorem in the MSS for $T(n, k)$. To the generators $h_{i, j}^{\prime}, b_{i, j}^{\prime} \in E_{1}^{*, *, *} T(n, k)$ define their index as

$$
S I\left(h_{i, j}^{\prime}\right)=S I\left(b_{i, j}^{\prime}\right)=i
$$

Given a monomial $g=x_{1} x_{2} \cdots x_{m} \in E_{1}^{*, *, *} T(n, k)$ where each $x_{i}$ is of the generators $h_{i, j}^{\prime}$ or $b_{i, j}^{\prime}$, define its sum of index as

$$
\begin{equation*}
S I(g)=S I\left(x_{1}\right)+S I\left(x_{2}\right)+\cdots+S I\left(x_{m}\right) \tag{4.5}
\end{equation*}
$$

For example the sum of index of $h_{4,0}^{\prime} h_{3,0}^{\prime} b_{2,1}^{\prime}$ is 9

We use $s(x)$ to denote the homological dimension of $x$. Noticed that the May filtration of $h_{i, j}^{\prime}, b_{i, j}^{\prime}$ satisfies

$$
\begin{aligned}
& M\left(h_{i, j}^{\prime}\right)=2 i-1=2 S I\left(h_{i, j}^{\prime}\right)-1=2 S I\left(h_{i, j}^{\prime}\right)-s\left(h_{i, j}^{\prime}\right) \\
& M\left(b_{i, j}^{\prime}\right)=p(2 i-1)>2 S I\left(b_{i, j}^{\prime}\right)-2=2 S I\left(b_{i, j}^{\prime}\right)-s\left(b_{i, j}^{\prime}\right)
\end{aligned}
$$

we see that for the monomial $g=x_{1} x_{2} \cdots x_{m} \in E_{1}^{s, *, *} T(n, k)$ of homological dimension $s$, its May filtration satisfies

$$
\begin{align*}
M(g) & =M\left(x_{1}\right)+M\left(x_{2}\right)+\cdots+M\left(x_{m}\right) \\
& \geqslant 2 S I\left(x_{1}\right)-s\left(x_{1}\right)+2 S I\left(x_{2}\right)-s\left(x_{2}\right)+\cdots+2 S I\left(x_{m}\right)-s\left(x_{m}\right)  \tag{4.6}\\
& =2 S I(g)-s
\end{align*}
$$

and the equality holds if and only if $g$ is a monomial in $E\left[h_{i, j}^{\prime} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right]$.
Given an integer $t=2(p-1)\left(c_{0}+c_{1} p+\cdots+c_{m} p^{m}\right)$ with $0 \leqslant c_{i}<p$, we define its sum of degree as

$$
S d(t)=c_{0}+c_{1}+\cdots+c_{m}
$$

and for an element $g \in E_{1}^{*, *, *} T(n, k)$, express its inner degree $|g|$ as $|g|=2(p-1)\left(c_{0}+\right.$ $c_{1} p+\cdots+c_{m} p^{m}$ ), where $0 \leqslant c_{i}<p$ and define its sum of degree to be

$$
\begin{equation*}
S d(g)=S d(|g|)=c_{0}+c_{1}+\cdots+c_{m} . \tag{4.7}
\end{equation*}
$$

Then from

$$
\begin{aligned}
\left|h_{i, j}^{\prime}\right| & =2(p-1)\left(p^{j}+p^{j+1}+\cdots p^{i+j-1}\right) \\
\left|b_{i, j}^{\prime}\right| & =2(p-1)\left(p^{j+1}+p^{j+2}+\cdots+p^{i+j}\right)
\end{aligned}
$$

we see that $S I\left(h_{i, j}^{\prime}\right)=S d\left(h_{i, j}^{\prime}\right), S I\left(b_{i, j}^{\prime}\right)=S d\left(b_{i, j}^{\prime}\right)$. But for the reason of the $p$-adic numbers one has

$$
\begin{equation*}
S I\left(x_{1} x_{2} \cdots x_{s}\right) \geqslant S d\left(x_{1} x_{2} \cdots x_{m}\right) \tag{4.8}
\end{equation*}
$$

Theorem 4.9 In the May spectral sequence for $T(n, k)$,
(1) If the inner degree $t=2(p-1)\left(c_{0}+c_{1} p+\cdots c_{m} p^{m}\right)$ and the May filtration

$$
M<2 S d(t)-s=2\left(c_{0}+c_{1}+\cdots+c_{m}\right)-s
$$

then the May's $E_{1}$-term $E_{1}^{s, t, M} T(n, k)=0$.
(2) If a cocycle $g \in E\left[h_{i, j}^{\prime} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right]$ in the exterior part of May's $E_{1}$-term satisfies $S I(g)=S d(g)$, then it is an infinite cocycle in the MSS for $T(n, k)$ and $\Phi(g)$ is an infinite cocycle in the MSS for $S(n, k)$.

Proof. (1) follows from (4.6) and (4.8).
Suppose $g \in E\left[h_{i, j}^{\prime} \mid k \leqslant i \leqslant n+k-1, j \geqslant 0\right]$ is a cocycle in the exterior part of May's $E_{1}$-term $E_{1}^{s, t, M} T(n, k)$ that satisfies $S I(g)=S d(g)$. Then its May filtration $M=2 S I(g)-s=2 S d(t)-s$. Consider the higher May differentials

$$
d_{r}: E_{r}^{s, t, M} T(n, k) \rightarrow E_{r}^{s+1, t, M-r} T(n, k),
$$

we see that $M-r<2 S d(t)-(s+1)$ for $r>1$. Thus the target $E_{1}^{s+1, t, M-r} T(n, k)$ and then $E_{r}^{s+1, t, M-r} T(n, k)$ is zero.

Example Let $p \geqslant 5$. The $E_{2}$-term of the May spectral sequence for $H^{s, *} S(4,2)$ is isomorphic to the homology of

$$
E\left[h_{2, j}, h_{3, j}, h_{4, j}, h_{5, j} \mid j \in Z / 4\right]
$$

with first May differentials

$$
\begin{array}{ll}
d_{1}\left(h_{2, j}\right)=0, & d_{1}\left(h_{3, j}\right)=0 \\
d_{1}\left(h_{4, j}\right)=h_{2, j} h_{2, j+2}, & d_{1}\left(h_{5, j}\right)=h_{2, j} h_{3, j+2}+h_{3, j} h_{2, j+3}
\end{array}
$$

So $h_{5,0} h_{4,0} h_{3,0} h_{2,0}$ is a cohomology class in May's $E_{2}$-term.
To prove that $h_{5,0} h_{4,0} h_{3,0} h_{2,0}$ is a infinite cocycle in the MSS $E_{r}^{4, *} S(4,2)$, consider the MSS for $T(4,2) . h_{5,0} h_{4,0}^{\prime} h_{3,0}^{\prime} h_{2,0}^{\prime}$ is a 4-dimensional cocycle in the exterior part of May's $E_{1}$-term $E_{1}^{4, t, M} T(4,2)$.

$$
\begin{gathered}
\operatorname{deg}\left(h_{5,0}^{\prime} h_{4,0}^{\prime} h_{3,0}^{\prime} h_{2,0}^{\prime}\right)=2(p-1)\left(4+4 p+3 p^{2}+2 p^{3}+p^{4}\right) \\
S I\left(h_{5,0}^{\prime} h_{4,0}^{\prime} h_{3,0}^{\prime} h_{2,0}^{\prime}\right)=14=S d\left(h_{5,0}^{\prime} h_{4,0}^{\prime} h_{3,0}^{\prime} h_{2,0}^{\prime}\right)
\end{gathered}
$$

Thus it is an infinite cocycle in the MSS for $T(4,2)$ and $h_{5.0} h_{4,0} h_{3,0} h_{2,0}=\Phi\left(h_{5,0}^{\prime} h_{4,0}^{\prime} h_{3,0}^{\prime} h_{2,0}^{\prime}\right)$ is an infinite cocycle in the MSS for $S(4,2)$.
5. The Cohomology of $S(n, n)$ at $p=2$ and of $S(3,2)$ at $p=3$

As an application of Theorem 3.3, we will compute $H^{*, *} S(n, n)$ at $p=2, H^{*, *} S(3,2)$ at prime $p=3$ and $H^{*, *} S(4,2)$ at prime $p \geqslant 5$ in this section.
5.1. The cohomology of $S(n, n)$ at prime two. Consider the cohomology of $S(n, n)$ at $p=2$. The reduced Mays $E_{1}$-term becomes

$$
\widetilde{E}_{1}^{*, *, *} S(n, n)=P\left[h_{n, j} \mid j \in Z / n\right] \otimes E\left[h_{s, j} \mid n<s \leqslant 2 n, j \in Z / n\right]
$$

(cf. Theorem 3.3). Noticed that the only non-trivial first May differential is

$$
\begin{equation*}
d_{1}\left(h_{2 n, j}\right)=h_{n, j-1}^{2}+h_{n, j}^{2} \tag{5.1}
\end{equation*}
$$

We see that the $E_{2}$-term is the tensor product of $E\left[h_{s, j} \mid n<s<2 n\right]$ and the cohomology of

$$
\left\{P\left[h_{n, j} \mid j \in Z / n\right] \otimes E\left[h_{2 n, j} \mid j \in Z / n\right], d_{1}\right\}
$$

Lemma 5.2 The May's $E_{2}$-term $E_{2}^{*, *, *} S(n, n)$ at $p=2$ is isomorphic to the tensor product of $E\left[h_{s, j} \mid n<s<2 n, j \in Z / n\right]$ and $E\left[h_{n, j}, \rho_{2 n} \mid j \in Z / n\right] \otimes P\left[h_{n, n-1}\right]$, where $\rho_{2 n}=\sum_{0 \leqslant j<n} h_{2 n, j}$ and $h_{n, j}^{2}=h_{n, n-1}^{2}$.

Proof. We define $b_{n, j}=h_{n, j}^{2}+h_{n, j+1}^{2}$ for $0 \leqslant j \leqslant n-2$ and define $b_{n, n-1}=h_{n, n-1}^{2}$. It is easy to see that $P\left[h_{n, j} \mid j \in Z / n\right]$ could be divided as the tensor product of $P\left[b_{n, j} \mid 0 \leqslant\right.$ $j<n]$ and $E\left[h_{n, j} \mid j \in Z / n\right]$ as $Z / 2$-modules.

$$
P\left[h_{n, j} \mid 0 \leqslant j \leqslant n-1\right]=P\left[b_{n, j} \mid 0 \leqslant j \leqslant n-1\right] \otimes E\left[h_{n, j} \mid 0 \leqslant j \leqslant n-1\right] .
$$

From (5.1) we see that

$$
d_{1}\left(h_{2 n, j}\right)= \begin{cases}b_{n, j-1} & \text { if } 1 \leqslant j<n \\ \sum_{0 \leqslant i<n-2} b_{n, i} & \text { if } j=n\end{cases}
$$

The cohomology of $\left\{P\left[h_{n, j} \mid j \in Z / n\right] \otimes E\left[h_{2 n, j} \mid j \in Z / n\right], d_{1}\right\}$ is isomorphic to the tensor product of $E\left[h_{n, j} \mid j \in Z / n\right]$ and the cohomology of

$$
P\left[b_{n, j} \mid 0 \leqslant j<n\right] \otimes E\left[h_{2 n, j} \mid j \in Z / n\right] .
$$

The generator of $P\left[b_{n, j} \mid j \in Z / n\right]$ are denoted as

$$
b_{n, i_{1}}^{s_{1}} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}
$$

subject to $s_{i}>0,0 \leqslant i_{1}<i_{2}<\cdots i_{m}<n$ and the generators of $E\left[h_{2 n, j} \mid j \in Z / n\right]$ are denoted as

$$
h_{2 n, j_{k}} \cdots h_{2 n, j_{2}} h_{2 n, j_{1}}
$$

subject to $n \geqslant j_{k}>\cdots>j_{2}>j_{1}>0$.
For the generators of $E\left[h_{2 n, j} \mid 0<j \leqslant n\right] \otimes P\left[b_{n, j} \mid 0 \leqslant j<n\right]$ described as above, one has
(1) For $j_{1}>i_{1}+1$,

$$
h_{2 n, j_{k}} \cdots h_{2 n, j_{2}} h_{2 n, j_{1}} b_{n, i_{1}}^{s_{1}} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}
$$

is the leading term of the first May differential

$$
d_{1}\left(h_{2 n, j_{k}} \cdots h_{2 n, j_{2}} h_{2 n, j_{1}} h_{2 n, i_{1}-1} b_{n, i_{1}}^{s_{1}-1} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}\right) .
$$

While for $i_{1}<n-1$,

$$
b_{n, i_{1}}^{s_{1}} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}
$$

is the leading term of the first May differential

$$
d_{1}\left(h_{2 n, i_{1}+1} b_{n, i_{1}}^{s_{1}-1} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}\right)
$$

(2) For $j_{1} \leqslant i_{1}+1$ and $j_{1}<n$, the leading term of the first May differential

$$
d_{1}\left(h_{2 n, j_{k}} \cdots h_{2 n, j_{2}} h_{2 n, j_{1}} b_{n, i_{1}}^{s_{1}} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}}\right)
$$

is

$$
h_{2 n, j_{k}} \cdots h_{2 n, j_{2}} b_{2 n, j_{1}-1} b_{n, i_{1}}^{s_{1}} b_{n, i_{2}}^{s_{2}} \cdots b_{n, i_{m}}^{s_{m}} .
$$

(3) For $j_{1}=n=i_{1}+1$,

$$
d_{1}\left(h_{2 n, n} b_{n, n-1}^{s_{1}} \cdot x\right)=\sum_{i=0}^{n-2} b_{n, i} i_{n, n-1}^{s_{1}} \cdot x=d_{1}\left(\sum_{i=0}^{n-2} h_{2 n, i+1} b_{n, n-1}^{s_{1}} \cdot x\right)
$$

Thus the cohomology of $E\left[h_{2 n, j} \mid j \in Z / n\right] \otimes P\left[b_{n, j} \mid j \in Z / n\right]$ is isomorphic to $E\left[\rho_{2 n} \mid j \in\right.$ $Z / n] \otimes P\left[b_{n, n-1}\right]$, where $\rho_{2 n}=\sum_{0 \leqslant i<n} h_{2 n, i}$. The Lemma follows.

Theorem 5.3 The May $E_{\infty}$-term $E_{\infty}^{*, *, *} S(n, n)$ is isomorphic to its $E_{2}$-term. Thus the cohomology of $S(n, n)$ at prime 2 isomorphic to the tensor product of $E\left[h_{s, j} \mid n<s<2 n\right]$ and $E\left[h_{n, j}, \rho_{2 n} \mid j \in Z / p\right] \otimes P\left[h_{n, 0}\right]$

Proof. It is easy to see from (2.2) that for $n \leqslant s<2 n, h_{s, j}$ is an infinite cocycle. From $d\left(t_{2 n}+t_{2 n}^{2}+\cdots t_{2 n}^{2^{n-1}}\right)=0$ we get the infinite cocycle $\rho_{2 n}$. The Theorem follows.
5.2. The cohomology of $S(3,2)$ at prime 3. Now consider the cohomology of $S(3,2)$ at prime $p=3$. From Lemma 2.4 we see that the $s_{0}=4$. Thus from Theorem 3.3 we see that the reduced May's $E_{1}$-term is

$$
\widetilde{E}_{1}^{*, *, *} S(3,2)=E\left[h_{2, j}, h_{3, j}, h_{4, j} \mid j \in Z / 3\right]
$$

and the first May differentials are given by

$$
\begin{array}{ll}
d_{1}\left(h_{2, j}\right)=0 & d_{1}\left(h_{3, j}\right)=0 \\
d_{1}\left(h_{4, j}\right)=-h_{2, j} h_{2, j+2} . & \tag{5.4}
\end{array}
$$

The May's $E_{2}$-term is isomorphic to

$$
E_{2}^{*, *, *} S(3,2)=H^{*, *, *}\left(E\left[h_{2, j}, h_{4, j} \mid j \in Z / 3\right], d_{1}\right) \otimes E\left[h_{3, j} \mid j \in Z / 3\right]
$$

Lemma 5.5 The May $E_{2}$-term for $H^{*} S(3,2)$ at $p=3$ has Poincare series $\left(x^{6}+3 x^{5}+\right.$ $\left.6 x^{4}+9 x^{3}+6 x^{2}+3 x+1\right)(x+1)^{3}$. It is the tensor product of $E\left[h_{3, j} \mid j \in Z / 3\right]$ and the $Z / 3$ module $\mathcal{C}$ generated by the following element.
The generators of $\mathcal{C}$

where $j \in Z / 3, g_{j}=h_{4, j} h_{2, j}, k_{j}=h_{4, j} h_{2, j+2}, l_{j}=h_{4, j} h_{4, j+1} h_{2, j}$ and

$$
\begin{aligned}
& l_{j}^{\prime}=h_{4, j} h_{4, j+1} h_{2, j+1}+h_{4, j+1} h_{4, j+2} h_{2, j} \\
& A=h_{4,0} h_{4,1} h_{4,2} h_{2,0} h_{2,1} h_{2,2}=-g_{0} g_{1} g_{2}
\end{aligned}
$$

Proof. From (5.4), it is easy to see that $d_{1}\left(h_{4, j} h_{2, j}\right)=0, d_{1}\left(h_{4, j} h_{2, j+2}\right)=0$ and from $d_{1}\left(h_{4, j+1}\right)=h_{2, j+1} h_{2, j+3}=h_{2, j+1} h_{2, j}$ we see that $d_{1}\left(h_{4, j} h_{4, j+1} h_{2, j}\right)=0$. These gives the cohomology classes $g_{j}, k_{j}$ and $l_{j}$. From

$$
\begin{aligned}
& d_{1}\left(h_{4, j} h_{4, j+1} h_{2, j+1}\right)=-h_{2, j} h_{2, j+2} h_{4, j+1} h_{2, j+1}=-h_{4, j+1} h_{2, j} h_{2, j+1} h_{2, j+2} \\
& d_{1}\left(h_{4, j+1} h_{4, j+2} h_{2, j}\right)=h_{4, j+1} h_{2, j+2} h_{2, j+4} h_{2, j}=h_{4, j+1} h_{2, j} h_{2, j+1} h_{2, j+2}
\end{aligned}
$$

we get $l_{j}^{\prime}$. A routine computation shows that $H^{*}\left(E\left[h_{2, j}, h_{4, j} \mid j \in Z / 3\right]\right)=\mathcal{C}$.
Theorem 5.6 The May $E_{2}$-term for $H^{*, *} S(3,2)$ at $p=3$ is the $E_{\infty}$-term, thus $H^{*, *} S(3,2)$ is the tensor product of $E\left[h_{3, j} \mid j \in Z / 3\right]$ and $\mathcal{C}$.

Proof. It is easy to see that $h_{2, j}$ and $h_{3, j}$ are infinite cycles. To prove that all the higher May differentials are trivial, consider the May filtration of each generator in the $E_{2}$-term and the differentials

$$
d_{r}: E_{r}^{s, t, M} S(3,2) \longrightarrow E_{r}^{s+1, t, M-r} S(3,2)
$$

One has

$$
\begin{aligned}
& g_{j} \in E_{2}^{2, *, 10} S(3,2) \quad k_{j} \in E_{2}^{2, *, 10} S(3,2) \\
& l_{j} \in E_{2}^{3, *, 17} S(3,2) \quad l_{j}^{\prime} \in E_{2}^{3, *, 17} S(3,2) \\
& h_{2, j} \in E_{2}^{1, *, 3} S(3,2) \\
& h_{3, j} \in E_{2}^{1,0,5} S(3,2) \text {. }
\end{aligned}
$$

The May filtration of $g_{j}$ and $k_{j}$ are 10. Beside, it is easy to check that each generator in the 3 rd dimension $E_{2}^{3, *, *} S(3,2)$ listed as below

$$
l_{j}, \quad l_{j}^{\prime}, \quad k_{j} h_{2, j}, \quad g_{j} h_{3, i}, \quad k_{j} h_{3, i}, \quad h_{3, i} h_{3, j} h_{2, k}, \quad h_{3,0} h_{3,1} h_{3,2}
$$

has May filtration $\geqslant 10$. Thus $g_{j}$ and $k_{j}$ are infinite cycles. Similarly one can prove that $l_{j}$ and $l_{j}^{\prime}$ are infinite cycles. This complete the proof.
5.3. The cohomology of $S(4,2)$ at the primes $p>3$. In this case, $s_{0}=5$ and the reduced May's $E_{1}$-term is

$$
\widetilde{E}_{1}^{*, *, *} S(4,2)=E\left[h_{2, j}, h_{3, j}, h_{4, j}, h_{5, j} \mid j \in Z / 4\right] .
$$

To compute the $E_{2}$-term, we set a filtration on the exterior algebra $E\left[h_{2, j}, h_{3, j}, h_{4, j}, h_{5, j} \mid j \in\right.$ $Z / 4]$ as follows:

$$
F^{k}=\bigoplus_{0 \leqslant r \leqslant k} Z / p\left\{h_{5, j_{1}} \cdots h_{5, j_{r}}\right\} \otimes E\left[h_{2, j}, h_{3, j}, h_{4, j} \mid j \in Z / 4\right]
$$

where $h_{5, j_{1}} \cdots h_{5, j_{r}}$ 's are the generators of the $r$-dimensional module of the exterior algebra $E\left[h_{5, j} \mid j \in Z / 4\right]$. This filtration gives raise to a spectral sequence with

$$
E_{0}^{k}=F^{k} / F^{k-1}=Z / p\left\{h_{5, j_{1}} \cdots h_{5, j_{k}}\right\} \otimes E\left[h_{2, j}, h_{3, j}, h_{4, j} \mid j \in Z / 4\right] .
$$

The $E_{1}$-term of this spectral sequence is

$$
E_{1}^{k}=Z / p\left\{h_{5, j_{1}} \cdots h_{5, j_{r}}\right\} \otimes H^{*} E\left[h_{2, j}, h_{3, j}, h_{4, j} \mid j \in Z / 4\right]
$$

and the differentials are given by

$$
d_{r}: E_{r}^{k} \longrightarrow E_{r}^{k-r}
$$

By a routine computation, we get
Theorem 5.7 The cohomology of $E\left[h_{2, j}, h_{3, j}, h_{4, j} \mid j \in Z / 4\right]$ is the tensor product of $E\left[h_{3, j}, \rho_{0}, \rho_{1}\right]$ and $\aleph$, where

$$
\rho_{0}=h_{4,0}+h_{4,2}, \quad \rho_{1}=h_{4,1}+h_{4,3}
$$

and $\aleph$ is the direct sum of the modules generated by the following cohomology classes:

$$
\begin{array}{llll}
1 ; & h_{2, j} ; & e_{j}=h_{2, j} h_{2, j+1}, & g_{j}=h_{4, j} h_{2, j} \\
h_{2, j} g_{j+1}, & h_{2, j} g_{j+2}, & h_{2, j} g_{j+3} ; & \\
g_{j} g_{j+1}, & e_{j} g_{j+2} ; & h_{2, j} g_{j+1} g_{j+2} ; & e_{0} g_{2} g_{3}
\end{array}
$$

with $j \in Z / 4$. Beside, we also have the following relations:

$$
h_{2, i} h_{2, i+2}=0, \quad h_{2, i} g_{i+2}=h_{2, i+2} g_{i}, \quad h_{2, i} g_{i+2} g_{i+3}=h_{2, i+2} g_{i+3} g_{i}
$$

With the add of a personal computer, we compute that
Theorem 5.8 The cohomology of the exterior algebra $E\left[h_{2, j}, h_{3, j}, h_{4, j}, h_{5, j}\right]$ has Poincarè series
$(1+t)^{4}\left(1+6 t+18 t^{2}+59 t^{3}+92 t^{4}+176 t^{5}+161 t^{6}+176 t^{7}+92 t^{8}+59 t^{9}+18 t^{10}+6 t^{11}+t^{12}\right)$.
The ranks at each cohomological dimension are listed as
$\left.\begin{array}{ccccccccccc}0, & 1, & 2, & 3, & 4, & 5, & 6, & 7, & 8, & 9, & \cdots \\ 1, & 10, & 48, & 171, & 461, & 976, & 1671, & 2303, & 2558, & 2303, & \cdots\end{array}\right)$
From the collapse Theorem 4.9, we claim that the MSS for the cohomology of $S(4,2)$ collapse at $E_{2}$-term.
