# On the arithmetic of the endomorphism ring $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$

#### Abstract

For a prime $p$, let $E_{p, p^{m}}=\left\{\left.\left(\begin{array}{cc}a & b \\ p^{m-1} c & d\end{array}\right) \right\rvert\, a, b, c \in \mathbb{Z}_{p}\right.$, and $\left.d \in \mathbb{Z}_{p^{m}}\right\}$. We first establish a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p}^{m}\right)$ onto $E_{p, p^{m}}$. We then provide the way to compute $-d$ and $d^{-1}$ using arithmetic in $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p^{m}}$, and characterize invertible elements in $E_{p, p^{m}}$. Moreover, we introduce the minimal polynomial for each element in $E_{p, p^{m}}$ and given its applications.

## 1 Introduction

Throughout this paper, $p$ denotes a prime number. Bergman[2] established the End $\left(\mathbb{Z}_{p} \times\right.$ $\mathbb{Z}_{p^{2}}$ ) is a semilocal ring with $p^{3}$ elements that cannot be embedded in matrices over any commutative ring. Climent et al. [1] identitied the elements of $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{2}}\right)$ with elements
in a new set, denoted by $E_{p}$, of matrices of size $2 \times 2$, whose elements in the first row belong to $\mathbb{Z}_{p}$ and the elements in the second row belong to $\mathbb{Z}_{p^{2}}$; also, using the arithmetic in $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p^{2}}$, then characterized the invertible elements of $E_{p}$. In this paper, we propose an approach following [1] to investigate the arithmetic of the generalized of endomorphism rings $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$.

Recall that $\mathbb{Z}_{n}=\{0,1,2, \ldots, n-1\}$ is a commutative unitary ring with the addition and multiplication $\bmod n$, i.e., for any $a, b \in \mathbb{Z}_{n}$

$$
\left.(a+b) \text { in } \mathbb{Z}_{n}=((a+b) \text { in } \mathbb{Z}) \bmod n\right)
$$

and

$$
\left.(a b) \text { in } \mathbb{Z}_{n}=((a b) \text { in } \mathbb{Z}) \bmod n\right)
$$

From now on, let we assume that $m$ is a positive integer and discuss the ring $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p^{m}}$. Clearly, we can also assume that $\mathbb{Z}_{p} \subset \mathbb{Z}_{p^{m}}$, even though $\mathbb{Z}_{p}$ is not a subring of $\mathbb{Z}_{p^{m}}$. Then, it follows that notation is utmost important to prevent errors like the following. Suppose that $p=7$, then

$$
\mathbb{Z}_{7}=\{0,1,2,4,5,6\}, \text { and } \mathbb{Z}_{7^{2}}=\{0,1,2, \ldots, 48\}
$$

Note that $3,5 \in \mathbb{Z}_{7}$ and $3+5=1 \in \mathbb{Z}_{7}$; but $3,5 \in \mathbb{Z}_{7^{2}}$ equally. However when $3,5 \in \mathbb{Z}_{7^{2}}$, $3+5=8 \in \mathbb{Z}_{7^{2}}$. Obviously, $1 \neq 8$ in $\mathbb{Z}_{7^{2}}$. Such error can be easily avoidable if we write, when necessary, $x \bmod p$ and $x \bmod p^{m}$ to refer the element $x$ when $x \in \mathbb{Z}_{p}$ and $x \in \mathbb{Z}_{p^{m}}$, respectively. In this light, the above example could be written as

$$
(3 \bmod 7)+(5 \bmod 7)=1 \bmod 7,
$$

whereas

$$
\left(3 \bmod 7^{2}\right)+\left(5 \bmod 7^{2}\right)=8 \bmod 7^{2}
$$

This paper is structured as follows. In section 2, we construct a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ onto $E_{p, p^{m}}$. In section 3, we first provide the way to compute $-d$ and $d^{-1}$ using arithmetic in $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p^{m}}$ ). Then we characterize invertible elements in $E_{p, p^{m}}$. Finally, in section 4, we introduce the minimal polynomial for each element in $E_{p, p^{m}}$ and consider its applications.

## 2 A characterization of the ring $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$

In this section, we denote by $1_{p}$ and $1_{p^{m}}$ the identity of $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p}^{m}$, respectively. In order to establish a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p}^{m}\right)$ onto $E_{p, p^{m}}$, let us recall a well-known result from ring theory (See [3]).

The ring $\mathbb{Z}_{p^{m}}$ is a Galois ring of characteristic $p^{m}$. Each element $d \in \mathbb{Z}_{p^{m}}$ can be written uniquely as a finite sun

$$
d=p^{m-1} u_{m-1}+\cdots+p u_{1}+u_{0}
$$

where $u_{i} \in \mathbb{Z}_{p}$, for $i=0,1, \ldots, m-1$. The invertible elements in $\mathbb{Z}_{p^{m}}$ are precisely the $d$ for which $u_{0} \neq 0$, and $p d=0$ if and only if $d=p^{m-1} a$, i.e., $d$ is not invertible in $\mathbb{Z}_{p^{m}}$.

Since $\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}$ is a $\mathbb{Z}_{p^{m}}$-module, an element $(u, v) \in \mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}$ may be written uniquely as

$$
r\left(1_{p}, 0\right)+s\left(0,1_{p^{m}}\right)
$$

where $r \in \mathbb{Z}_{p}$, and $s \in \mathbb{Z}_{p^{m}}$.
Let $\alpha \in \operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$. Since $\alpha$ is $\mathbb{Z}_{p^{m}}$-linear, we have

$$
\alpha\left(r\left(1_{p}, 0\right)+s\left(0,1_{p^{m}}\right)\right)=r \alpha\left(1_{p}, 0\right)+s \alpha\left(0,1_{p^{m}}\right)
$$

for any $r \in \mathbb{Z}_{p}$, and $s \in \mathbb{Z}_{p^{m}}$. Therefore, $\alpha$ is uniquely determined by two elements $\alpha\left(1_{p}, 0\right)$ and $\alpha\left(0,1_{p^{m}}\right)$ of $\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}$.

Now, suppose that $\alpha\left(1_{p}, 0\right)=(a, e)$ and $\alpha\left(0,1_{p^{m}}\right)=(b, d)$ with $a, b \in \mathbb{Z}_{p}$ and $e, d \in \mathbb{Z}_{p^{m}}$. Since $p a=p 1_{p}=0$, we have $(0, p e)=(p a, p e)=p\left(\alpha\left(1_{p}, 0\right)\right)=\alpha\left(p 1_{p}, p 0\right)=(0,0)$, which implies $p e=0$ in $\mathbb{Z}_{p^{m}}$. Hence there exists a uniquely $c \in \mathbb{Z}_{p}$ such that $e=p^{m-1} c$. This means that

$$
\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)=\left\{\alpha \mid \alpha\left(1_{p}, 0\right)=\left(a, p^{m-1} c\right), \alpha\left(0,1_{p^{m}}\right)=(b, d)\right\}
$$

where $a, b, c \in \mathbb{Z}_{p}$, and $d \in \mathbb{Z}_{p^{m}}$.
Obviously, $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ is a nonccommutative unitary ring with the usual addition and composition of endomorphisms.

The proof in following Theorem is similar to that for [2] Theorem 3.
Theorem 2.1. If $p$ is a prime number, then the ring of endomorphism $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ has $p^{m+3}$ elements and is semilocal, but cannot be embedded in matrices over any commutative ring.

Theorem 2.1 establishes that the ring $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ cannot be embedded in matrices over any commutative ring. Nevertheless, we can obtain a matrix representation of the elements of this ring.

Let

$$
E_{p, p^{m}}=\left\{\left.\left(\begin{array}{cc}
a & b \\
p^{m-1} c & d
\end{array}\right) \right\rvert\, a, b, c \in \mathbb{Z}_{p}, \text { and } d \in \mathbb{Z}_{p^{m}}\right\}
$$

where $p^{m-1} c$ represses an element of $\mathbb{Z}_{p^{m}}$ for any $c \in \mathbb{Z}_{p}$.
Lemma 2.2. The set $E_{p, p^{m}}$ is a nonccommutative unitary ring where addition is defined by

\end{array}\right)+\left(\begin{array}{cc}
a_{2} & b_{2} \\
p^{m-1} c_{2} & d_{2}
\end{array}\right)=\left(\begin{array}{cc}
\left(a_{1}+a_{2}\right) \bmod p & \left(b_{1}+b_{2}\right) \bmod p \\
p^{m-1}\left(c_{1}+c_{2}\right) \bmod p^{m} & \left(d_{1}+d_{2}\right) \bmod p^{m}
\end{array}\right)
$$

and multiplication is defined by

$$
\left(\begin{array}{cc}
a_{1} & b_{1} \\
p^{m-1} c_{1} & d_{1}
\end{array}\right) \cdot\left(\begin{array}{cc}
a_{2} & b_{2} \\
p^{m-1} c_{2} & d_{2}
\end{array}\right)=\left(\begin{array}{cc}
\left(a_{1} a_{2}\right) \bmod p & \left(a_{1} b_{2}+b_{1} d_{2}\right) \bmod p \\
p^{m-1}\left(c_{1} a_{2}+c_{2} d_{1}\right) \bmod p^{m} & \left(p^{m-1} c_{1} b_{2}+d_{1} d_{2}\right) \bmod p^{m}
\end{array}\right) .
$$

Proof. The proof is straightforward.
Following these results above, we now construct a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ onto $E_{p, p^{m}}$.

Theorem 2.3. With notations as above. Define the map $\varphi$ as follows

$$
\begin{array}{ll}
\varphi: \quad & \operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right) \rightarrow E_{p, p^{m}} \\
& \alpha \mapsto \varphi(\alpha)=\left(\begin{array}{cc}
a & b \\
p^{m-1} c & d
\end{array}\right)
\end{array}
$$

where $\alpha\left(1_{p}, 0\right)=\left(a, p^{m-1} c\right), \alpha\left(0,1_{p^{m}}\right)=(b, d)$ and $a, b, c \in \mathbb{Z}_{p}, d \in \mathbb{Z}_{p^{m}}$. Then $\varphi$ is a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ onto $E_{p, p^{m}}$.

Proof. Obviously, $\varphi$ is a well-defined and an bijective mapping from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ onto $E_{p, p^{m}}$.

Next, suppose that $\alpha_{i} \in \operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ with $\alpha_{i}\left(1_{p}, 0\right)=\left(a_{i}, p^{m-1} c_{i}\right)$, and $\alpha_{i}\left(0,1_{p^{m}}\right)=$ $\left(b_{i}, d_{i}\right)$ for $i=1,2$. Then we have $\varphi\left(\alpha_{i}\right)=\left(\begin{array}{cc}a_{i} & b_{i} \\ p^{m-1} c_{i} & d_{i}\end{array}\right)$ for $i=1,2$. From

$$
\begin{gathered}
\left(\alpha_{1}+\alpha_{2}\right)\left(1_{p}, 0\right)=\left(a_{1}, p^{m-1} c_{1}\right)+\left(a_{2}, p^{m-1} c_{2}\right)=\left(\left(a_{1}+a_{2}\right) \bmod p, p^{m-1}\left(c_{1}+c_{2}\right) \bmod p^{m}\right) \\
\left(\alpha_{1}+\alpha_{2}\right)\left(0,1_{p m}\right)=\left(b_{1}, d_{1}\right)+\left(b_{2}, d_{2}\right)=\left(\left(b_{1}+b_{2}\right) \bmod p,\left(d_{1}+d_{2}\right) \bmod p^{m}\right)
\end{gathered}
$$

and by the defenition of $\varphi$ and Lemma 2.2, we obtain

$$
\begin{aligned}
\varphi\left(\alpha_{1}+\alpha_{2}\right) & =\left(\begin{array}{cc}
\left(a_{1}+a_{2}\right) \bmod p & \left(b_{1}+b_{2}\right) \bmod p \\
p^{m-1}\left(c_{1}+c_{2}\right) \bmod p^{m} & \left(d_{1}+d_{2}\right) \bmod p^{m}
\end{array}\right) \\
& =\left(\begin{array}{cc}
a_{1} & b_{1} \\
p^{m-1} c_{1} & d_{1}
\end{array}\right)+\left(\begin{array}{cc}
a_{2} & b_{2} \\
p^{m-1} c_{2} & d_{2}
\end{array}\right)=\varphi\left(\alpha_{1}\right)+\varphi\left(\alpha_{2}\right) .
\end{aligned}
$$

Moreover, by the definition of composition of endormorphism, we have

$$
\begin{aligned}
\left(\alpha_{1} \alpha_{2}\right)\left(1_{p}, 0\right) & =\alpha_{1}\left(a_{2}, p^{m-1} c_{2}\right)=\alpha_{1}\left(a_{2}\left(1_{p}, 0\right)+p^{m-1} c_{2}\left(0,1_{p^{m}}\right)\right) \\
& =\left(a_{2}\right) \alpha_{1}\left(1_{p}, 0\right)+p^{m-1} c_{2} \alpha_{1}\left(0,1_{p^{m}}\right) \\
& =a_{2}\left(\left(a_{1}, p^{m-1} c_{1}\right)+p^{m-1} c_{2}\left(b_{1}, d_{1}\right)\right. \\
& =\left(\left(a_{1} a_{2}\right) \bmod p, p^{m-1}\left(a_{2} c_{1}+d_{1} c_{2}\right) \bmod p^{m}\right)
\end{aligned}
$$

and

$$
\begin{aligned}
& \left(\alpha_{1} \alpha_{2}\right)\left(0,1_{p^{m}},\right)=\alpha_{1}\left(b_{2}, d_{2}\right)=\alpha_{1}\left(b_{2}\left(1_{p}, 0\right)+d_{2}\left(0,1_{p^{m}}\right)\right) \\
& \quad=b_{2} \alpha_{1}\left(1_{p}, 0\right)+d_{2} \alpha_{1}\left(0,1_{p^{m}}\right) \\
& \quad=b_{2}\left(\left(a_{1}, p^{m-1} c_{1}\right)+d_{2}\left(b_{1}, d_{1}\right)\right. \\
& \quad=\left(\left(a_{1} b_{2}+d_{2} b_{1}\right) \bmod p,\left(p^{m-1} b_{2} c_{1}+d_{1} d_{2}\right) \bmod p^{m}\right) .
\end{aligned}
$$

From these and by Lemma 2.2, we obtain

$$
\begin{aligned}
\varphi\left(\alpha_{1} \alpha_{2}\right) & =\left(\begin{array}{cc}
\left(a_{1} a_{2}\right) \bmod p & \left(b_{2} a_{1}+d_{1} d_{2}\right) \bmod p \\
p^{m-1}\left(c_{1} a_{2}+c_{2} d_{1}\right) \bmod p^{m} & \left(p^{m-1} c_{1} b_{2}+d_{1} d_{2}\right) \bmod p^{m}
\end{array}\right) \\
& =\left(\begin{array}{cc}
a_{1} & b_{1} \\
p^{m-1} c_{1} & d_{1}
\end{array}\right) \cdot\left(\begin{array}{cc}
a_{2} & b_{2} \\
p^{m-1} c_{2} & d_{2}
\end{array}\right)=\varphi\left(\alpha_{1}\right) \cdot \varphi\left(\alpha_{2}\right) .
\end{aligned}
$$

This means that $\varphi$ is a ring isomorphism from $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ onto $E_{p, p^{m}}$.
Remark 2.4. $\left|\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)\right|=\left|E_{p, p^{m}}\right|$.
From now on, we identity the elements of $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ with the elements of $E_{p, p^{m}}$, and the arithmetic of $\operatorname{End}\left(\mathbb{Z}_{p} \times \mathbb{Z}_{p^{m}}\right)$ with the arithmetic of $E_{p, p^{m}}$.

## 3 The arithmetic of invertible elements in the ring $E_{p, p^{m}}$

In this section we present our contributions, i.e., we first provide the way to compute $-d$ and $d^{-1}$ using arithmetic in $\mathbb{Z}_{p}$ and $\mathbb{Z}_{p^{m}}$. We then characterize invertible elements in the ring $E_{p, p^{m}}$.

As usual, if $a, b \in \mathbb{Z}$, with $b \neq 0$, we denote by $\left\lfloor\frac{a}{b}\right\rfloor$ and $a \bmod b$ the quotient and the remainder of the division of $a$ by $b$, respectively.

We first observe four helpful lemmas.
Lemma 3.1. Suppose that $d_{i}=p^{m-1} u_{m-1}^{(i)}+\cdots+p u_{1}^{(i)}+u_{0}^{(i)}$ with $u_{m-1}^{(i)}, \ldots, u_{1}^{(i)}, u_{0}^{(i)} \in \mathbb{Z}_{p}$, for $i=1,2$. Let

$$
\begin{gathered}
v_{0}=\left(u_{0}^{(1)}+u_{0}^{(2)}\right) \bmod p^{m}, \\
v_{1}=\left(u_{1}^{(1)}+u_{1}^{(2)}+\left\lfloor\frac{v_{0}}{p}\right\rfloor\right) \bmod p^{m}, \\
v_{2}=\left(u_{2}^{(1)}+u_{2}^{(2)}+\left\lfloor\frac{v_{1}}{p}\right\rfloor\right) \bmod p^{m}, \\
\cdots \\
v_{m-2}=\left(u_{m-2}^{(1)}+u_{m-2}^{(2)}+\left\lfloor\frac{v_{m-3}}{p}\right\rfloor\right) \bmod p^{m},
\end{gathered}
$$

$$
v_{m-1}=\left(u_{m-1}^{(1)}+u_{m-1}^{(2)}+\left\lfloor\frac{v_{m-2}}{p}\right\rfloor\right) \bmod p^{m}
$$

Then $d_{1}+d_{2}=p^{m-1}\left(v_{m-1} \bmod p\right)+\cdots+p\left(v_{1} \bmod p\right)+\left(v_{0} \bmod p\right)$.
Proof. Obviously,

d_{1}+d_{2}=\left[p^{m-1}\left(u_{m-1}^{(1)}+u_{m-1}^{(2)}\right)+\cdots+p\left(u_{1}^{(1)}+u_{1}^{(2)}\right)+\left(u_{0}^{(1)}+u_{0}^{(2)}\right)\right] \bmod p^{m}
$$

According to the definition of $v_{i}$ we have

$$
\begin{aligned}
d_{1}+d_{2}= & p^{m-1}\left[\left(u_{m-1}^{(1)}+u_{m-1}^{(2)}+\left\lfloor\frac{v_{m-2}}{p}\right\rfloor\right) \bmod p\right]+ \\
& \cdots+p\left[\left(u_{1}^{(1)}+u_{1}^{(2)}+\left\lfloor\frac{v_{0}}{p}\right\rfloor\right) \bmod p\right]+\left(u_{0}^{(1)}+u_{0}^{(2)}\right) \bmod p \\
= & p^{m-1}\left(v_{m-1} \bmod p\right)+\cdots+p\left(v_{1} \bmod p\right)+\left(v_{0} \bmod p\right)
\end{aligned}
$$

Lemma 3.2. Suppose that $d=p^{m-1} u_{m-1}+\cdots+p u_{1}+u_{0}$ with $u_{m-1}, \ldots, u_{1}, u_{0} \in \mathbb{Z}_{p}$. Let

& v_{0}=-u_{0} \bmod p, \\
& w_{0}=\left(u_{0}-u_{0}\right) \bmod p^{m} \\
& v_{1}=\left(-u_{1}-\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p, \\
& w_{1}=\left(u_{1}+v_{1}+\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p^{m} \\
& v_{2}=\left(-u_{2}-\left\lfloor\frac{w_{1}}{p}\right\rfloor\right) \bmod p, \\
& w_{2}=\left(u_{2}+v_{2}\right)+\left\lfloor\frac{w_{1}}{p}\right\rfloor \bmod p^{m} \\
& \quad \cdots \\
& v_{m-2}=\left(-u_{m-2}-\left\lfloor\frac{w_{m-3}}{p}\right\rfloor\right) \bmod p, \\
& w_{m-2}=\left(u_{m-2}+v_{m-2}+\left\lfloor\frac{w_{m-3}}{p}\right\rfloor, \bmod p^{m}\right. \\
& v_{m-1}=\left(-u_{m-1}-\left\lfloor\frac{w_{m-2}}{p}\right\rfloor\right) \bmod p .
\end{aligned}
$$

Then $-d=p^{m-1} v_{m-1}+\cdots+p v_{1}+v_{0}$.

Proof. In light of Lemma 3.1,

d-d=p^{m-1}\left(s_{m-1} \bmod p\right)+\cdots+p\left(s_{1} \bmod p\right)+\left(s_{0} \bmod p\right)
$$

where

\begin{gathered}
s_{0}=\left(u_{0}-u_{0}\right) \bmod p^{m}, \\
s_{1}=\left(u_{1}+\left[\left(-u_{1}-\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p\right]+\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p^{m}, \\
s_{2}=\left(u_{2}+\left[\left(-u_{2}-\left\lfloor\frac{w_{1}}{p}\right\rfloor\right) \bmod p\right]+\left\lfloor\frac{w_{1}}{p}\right\rfloor\right) \bmod p^{m}, \\
\ldots \\
s_{m-1}=\left(u_{m-1}+\left[\left(-u_{m-1}-\left\lfloor\frac{w_{m-2}}{p}\right\rfloor\right) \bmod p\right]+\left\lfloor\frac{w_{m-2}}{p}\right\rfloor\right) \bmod p^{m} .
\end{gathered}
$$

we have

$$
\begin{gathered}
s_{0}=\left(u_{0}-u_{0}\right) \bmod p=0, \\
s_{1}=\left[u_{1}+\left(\left(-u_{1}-\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p\right)+\left\lfloor\frac{w_{0}}{p}\right\rfloor\right] \bmod p=0, \\
s_{2}=\left[u_{2}+\left(\left(-u_{2}-\left\lfloor\frac{w_{1}}{p}\right\rfloor\right) \bmod p\right)+\left\lfloor\frac{w_{1}}{p}\right\rfloor\right] \bmod p=0, \\
\ldots \\
s_{m-1}=\left[u_{m-1}+\left(\left(-u_{m-1}-\left\lfloor\frac{w_{m-2}}{p}\right\rfloor\right) \bmod p\right)+\left\lfloor\frac{w_{m-2}}{p}\right\rfloor\right] \bmod p=0 .
\end{gathered}
$$

Therefore,

$$
d-d=p^{m-1}\left(s_{m-1} \bmod p\right)+\cdots+p\left(s_{1} \bmod p\right)+\left(s_{0} \bmod p\right)=0
$$

This proves the expected result.
Lemma 3.3. Suppose that $d_{i}=p^{m-1} u_{m-1}^{(i)}+\cdots+p u_{1}^{(i)}+u_{0}^{(i)}$ with $u_{m-1}^{(i)}, \ldots, u_{1}^{(i)}, u_{0}^{(i)} \in \mathbb{Z}_{p}$, for $i=1,2$. Let

$$
\begin{gathered}
w_{0}=u_{0}^{(1)} u_{0}^{(2)} \bmod p^{m} \\
w_{1}=\left(\sum_{i+j=1} u_{i}^{(1)} u_{j}^{(2)}+\left\lfloor\frac{w_{0}}{p}\right\rfloor\right) \bmod p^{m}, \\
w_{2}=\left(\sum_{i+j=2} u_{i}^{(1)} u_{j}^{(2)}+\left\lfloor\frac{w_{1}}{p}\right\rfloor\right) \bmod p^{m}, \\
\ldots \\
w_{m-2}=\left(\sum_{i+j=m-2} u_{i}^{(1)} u_{j}^{(2)}+\left\lfloor\frac{w_{m-3}}{p}\right\rfloor\right) \bmod p^{m} \\
w_{m-1}=\left(\sum_{i+j=m-1} u_{i}^{(1)} u_{j}^{(2)}+\left\lfloor\frac{w_{m-1}}{p}\right\rfloor\right) \bmod p^{m} .
\end{gathered}
$$

Then $d_{1} d_{2}=p^{m-1}\left(w_{m-1} \bmod p\right)+\cdots+p\left(w_{1} \bmod p\right)+\left(w_{0} \bmod p\right)$.

Proof. The proof is similar to Lemma 3.1.
Lemma 3.4. Suppose that $d=p^{m-1} u_{m-1}+\cdots+p u_{1}+u_{0}$ with $u_{m-1}, \ldots, u_{1}, u_{0} \in \mathbb{Z}_{p}$. If $u_{0} \neq 0$, then $d$ is invertible in $\mathrm{Z}_{\mathrm{p}^{\mathrm{m}}}$. Further, write

$$
\begin{gathered}
s_{0}=u_{0}^{-1} \bmod p \\
w_{0}=u_{0} u_{0}^{-1} \bmod p^{m} \\
s_{1}=-u_{0}^{-1}\left(u_{1}, 1\right)\left(s_{0},\left\lfloor\frac{w_{0}}{p}\right\rfloor\right)^{T} \bmod p \\
w_{1}=\left(u_{1}, u_{0}\right)\left(s_{0}, s_{1}\right)^{T}+\left\lfloor\frac{w_{0}}{p}\right\rfloor \bmod p^{m} \\
s_{2}=-u_{0}^{-1}\left(u_{2}, u_{1}, 1\right)\left(s_{0}, s_{1},\left\lfloor\frac{w_{1}}{p}\right\rfloor\right)^{T} \bmod p \\
w_{2}=\left(u_{2}, u_{1}, u_{0}\right)\left(s_{0}, s_{1}, s_{2}\right)^{T}+\left\lfloor\frac{w_{1}}{p}\right\rfloor \bmod p^{m}
\end{gathered}
$$

in general, for $3 \leq k \leq m-1$

$$
s_{k}=-u_{0}^{-1}\left(\left(u_{k}, \ldots, u_{1}, 1\right)\left(s_{0}, \ldots, s_{k-1},\left\lfloor\frac{w_{k-1}}{p}\right\rfloor\right)^{T} \bmod p\right.
$$

and,

$$
w_{k}=\left(u_{k}, \ldots, u_{0}\right)\left(s_{0}, \ldots, s_{k-1}\right)^{T}+\left\lfloor\frac{w_{k-1}}{p}\right\rfloor \bmod p^{m} .
$$

where T denotes transpose of matrix. Then $d^{-1}=p^{m-1} s_{m-1}+\cdots+p s_{1}+s_{0}$.
Proof. Since $0 \neq u_{0} \in \mathbb{Z}_{p}$, there is a unique inverse $u_{0}^{-1} \in \mathbb{Z}_{p}$ of $u_{0}$ such that $u_{0} u_{0}^{-1}=1$ in $\mathbb{Z}_{p}$. Take, $a=p^{m-1} t_{m-1}+\cdots+p t_{1}+t_{0}$ with $t_{m-1}, \cdots, t_{1}, t_{0} \in \mathrm{Z}_{p^{m}}$, then by Lemma 3.2, we have $a d=p^{m-1}\left(h_{m-1} \bmod p\right)+\cdots+p\left(h_{1} \bmod p\right)+\left(h_{0} \bmod p\right)$, where

$$
\begin{aligned}
& h_{0}=u_{0} t_{0}, \\
& h_{1}=\sum_{i+j=1} u_{i} t_{j}+\left\lfloor\frac{h_{0}}{p}\right\rfloor, \\
& h_{2}=\sum_{i+j=2} u_{i} t_{j}+\left\lfloor\frac{h_{1}}{p}\right\rfloor, \\
& \ldots \\
& h_{m-2}=\sum_{i+j=m-2} u_{i} t_{j}+\left\lfloor\frac{h_{m-3}}{p}\right\rfloor, \\
& h_{m-1}=\sum_{i+j=m-1} u_{i} t_{j}+\left\lfloor\frac{h_{m-2}}{p}\right\rfloor .
\end{aligned}
$$

In order to get $a d=1$ in $\mathrm{Z}_{\mathrm{p}}^{\mathrm{m}}$, first taking $t_{0}=s_{0}=u_{0}^{-1}$, we have $h_{0}=w_{0}=u_{0} u_{0}^{-1}=1$ in $\mathbb{Z}_{p}$.

Next, taking, $t_{1}=s_{1}$, we have $h_{1}=w_{1}=0$ in $\mathbb{Z}_{p}$, but $h_{1}=w_{1}$ in $\mathbb{Z}_{p}^{m}$.
Continuing this process, taking $t_{k}=s_{k}$, we have $h_{k}=w_{k}=0$ in $\mathbb{Z}_{p}$, but $h_{k}=w_{k}$ in $\mathbb{Z}_{p}^{m}$, for $k=2,3, \ldots, m-1$. This means that

$$
a=p^{m-1} s_{m-1}+\cdots+p s_{1}+s_{0} .
$$

Therefore $a d=1$ in $\mathbb{Z}_{p}^{m}$, i.e., $d^{-1}=p^{m-1} s_{m-1}+\cdots+p s_{1}+s_{0}$.
In the following we establish a characterization of the invertible element of $E_{p, p^{m}}$. First, by Lemma 3.1 and Lemma 3.2, we obtain the following characterization of addition and multiplication in $Z_{p, p^{m}}$ in terms of the arithmetic of $\mathbb{Z}_{1}$ and $\mathbb{Z}_{p^{m}}$.

Corollary 3.5. Assume that all hypothesis of Lemma 3.1 and Lemma 3.3 are valid. Let

$$
A_{1}=\left(\begin{array}{cc}
a_{1} & b_{1} \\
p^{m-1} c_{1} & p^{m-1} u_{m-1}^{(1)}+\ldots+p u_{1}^{(1)}+u_{0}^{(1)}
\end{array}\right)
$$

and

$$
A_{2}=\left(\begin{array}{cc}
a_{2} & b_{2} \\
p^{m-1} c_{2} & p^{m-1} u_{m-1}^{(2)}+\ldots+p u_{1}^{(2)}+u_{0}^{(2)}
\end{array}\right)
$$

be two elements of $E_{p, p^{m}}$. Then
$A_{1}+A_{2}=\left(\begin{array}{cc}\left(a_{1}+a_{2}\right) \bmod p & \left.\left(b_{1}+b_{2}\right)\right) \bmod p \\ p^{m-1}\left(\left(c_{1}+c_{2}\right) \bmod p\right) & p^{m-1}\left(v_{m-1} \bmod p\right)+\ldots+p\left(v_{1} \bmod p\right)+v_{o} \bmod p\end{array}\right)$,
and

$$
A_{1} A_{2}=\left(\begin{array}{cc}
\left(a_{1} a_{2}\right) \bmod p & \left.\left(a_{1} b_{2}+b_{1} u_{0}^{(2)}\right)\right) \bmod p \\
p^{m-1}\left(\left(c_{1} a_{2}+u_{0}^{(1)} c_{2}\right) \bmod p\right) & \delta
\end{array}\right)
$$

where $\delta=p^{m-1}\left(\left(c_{1} b_{2}+w_{m-1}\right) \bmod p\right)+\ldots+p w_{1}+w_{0}$.
Next, combining Lemma 3.4 and Corollary 3.5, we can now to establish a characterization of the invertible element of $E_{p, p^{m}}$.

Theorem 3.6. Suppose that

$$
M=\left(\begin{array}{cc}
a & b \\
p^{m-1} c & p^{m-1} u_{m-1}+\ldots+p u_{1}+u_{0}
\end{array}\right) \in E_{p, p^{m}}
$$

where $a, b, c, u_{0}, u_{1}, \ldots, u_{m-1} \in \mathbb{Z}_{p}$. Then $M$ is invertible if and only if $a \neq 0$ and $u_{0} \neq 0$, and in this case the inverse $M^{-1}$ of $M$ in $E_{p, p^{m}}$ is given by
$\left.M^{-1}=\left(\begin{array}{c}a^{-1} \bmod p \\ p^{m-1}\left(\left(-a^{-1} c u_{0}^{-1}\right) \bmod p\right)\end{array} p^{m-1}\left[\left(c a^{-1} b u_{0}^{-1}\right) \bmod p, s_{m-1}\right) \bmod p\right]+p^{m-2} s_{m-2}+\ldots+p s_{1}+s_{0}\right), ~$
where $p^{m-1} s_{m-1}+\ldots+p s_{1}+s_{0}$ is invertible of $p^{m-1} u_{m-1}+\ldots+p u_{1}+u_{0}$.

Proof. If $M$ is invertible, the there exists

$$
N=\left(\begin{array}{cc}
x & y \\
p^{m-1} z & p^{m-1} t_{m-1}+\ldots+p t_{1}+t_{0}
\end{array}\right) \in E_{p, p^{m}}
$$

with $x, y, z, t_{0}, t_{1}, \ldots, t_{m-1} \in \mathbb{Z}_{p}$, such that $M N=I$, where $I=\left(\begin{array}{ll}1 & 0 \\ 0 & 1\end{array}\right)$. In light of Corollary 3.4 , we obtain

$$
1=(a x) \bmod p \text { and } 1=\left(u_{0} t_{0}\right) \bmod p .
$$

Therefore $a \neq 0$ and $u_{0} \neq 0$.
Reciprocally, let $a \neq 0$ and $u_{0} \neq 0$. Then there exist $a^{-1}, u_{0}^{-1} \in \mathbb{Z}_{p}$. Taking
$N=\left(\begin{array}{cc}a^{-1} \bmod p & \left(-a^{-1} b u_{0}^{-1}\right) \bmod p \\ p^{m-1}\left(\left(-a^{-1} c u_{0}^{-1}\right) \bmod p\right) & p^{m-1}\left[\left(c a^{-1} b u_{0}^{-2}+s_{m-1}\right) \bmod p\right]+p^{m-2} s_{m-2}+\ldots+p s_{1}+s_{0}\end{array}\right)$,
where $p^{m-1} s_{m-1}+\ldots+p s_{1}+s_{0}$ is invertible of $p^{m-1} u_{m-1}+\ldots+p u_{1}+u_{0}$. From Corollary 3.5 , we have that $I=\left(\begin{array}{cc}h & r \\ p^{m-1} l & t\end{array}\right)$, where

$$
\begin{gathered}
h=\left(a a^{-1} \bmod p=1,\right. \\
r=\left(a\left(-a^{-1} b u_{0}^{-1}\right)+b u_{0}^{-1}\right) \bmod p=0, \\
l=\left(c a^{-1}-u_{0}^{-1} c a^{-1} u_{0}\right) \bmod p=0
\end{gathered}
$$

and

$$
\begin{aligned}
t= & p^{m-1} c\left(-a^{-1} b u_{0}^{-1}\right)+\left[p^{m-1}\left(c a^{-1} b u_{0}^{-2}+s_{m-1}\right)+\right. \\
& \left.p^{m-2} s_{m-1}+\ldots+p s_{1}+s_{0}\right]\left[p^{m-1} u_{m-1}+\ldots+p u_{1}+u_{0}\right]=1 .
\end{aligned}
$$

And consequently, $M N=I$.
Similar to prove $N M=I$. therefore, $M$ is invertible in $E_{p, p^{m}}$ and $M^{-1}=N$.
The following result gives the number of invertible elements of $E_{p, p^{m}}$.
Corollary 3.7. Let $U_{p, p^{m}}$ be the set of all invertible elements of $E_{p, p^{m}}$. Then $\left|U_{p, p^{m}}\right|=$ $p^{m+1}(p-1)^{2}$.

Proof. By Theorem 3.6, the number of invertible elements of $E_{p, p^{m}}$ equals $\left|U_{p, p^{m}}\right|=$ $\left|\mathbb{Z}_{p}\right|^{m-1}\left|\mathbb{Z}_{p}-0\right|^{2}=p^{m+1}(p-1)^{2}$.

Note that $\frac{U_{p, p^{m}}}{E_{p, p^{m}}}=\frac{p^{m+1}(p-1)^{2}}{p^{m+3}}=\left(1-\frac{1}{p}\right)^{2} \approx 1$. This means that for large values of $p$, almost all the elements of $E_{p, p^{m}}$ are invertible.

## 4 The minimal polynomial of each element in $E_{p, p^{m}}$

In this section, we introduce a concept of the minimal polynomial for each element in $E_{p, p^{m}}$. We start by showing Theorem 4.1.

Theorem 4.1. Suppose that $A=\left(\begin{array}{cc}a & b \\ p^{m-1} c & d\end{array}\right) \in E_{p, p^{m}}$ with $a, b, c \in \mathbb{Z}_{p}$ and $d=p^{m-1} u_{m-1}+$ $\ldots+p u_{1}+u_{0}$ where $u_{0}, u_{1}, \ldots, u_{m-1} \in \mathbb{Z}_{p}$. Let

$$
r=-(a+d) \bmod p^{m}, \quad s=\left(a d-p^{m-1} b c\right) \bmod p^{m}
$$

and denote $f_{A}(x)=x^{2}+r x+s \in \mathbb{Z}[x]$. Then $f_{A}(A)=A^{2}+r A+s I=0$.
Proof. By assumption, we have

$$
\begin{gathered}
M^{2}=\left(\begin{array}{cc}
a^{2} \bmod p & \left(a b+b u_{0}\right) \bmod p \\
p^{m-1}\left[\left(c a+c u_{0}\right) \bmod p\right] & \left.\left(p^{m-1} c b+d^{2}\right)\right) \bmod p^{m}
\end{array}\right) \in E_{p, p^{m}}, \\
r M= \\
=\left(\begin{array}{cc}
{\left[\left(-a^{2}-a d\right) \bmod p^{m}\right] \bmod p} & {\left[(-a b+b d) \bmod p^{m}\right] \bmod p} \\
\left.-p^{m-1}\left[\left(c a+c u_{0}\right) \bmod p^{m}\right] \bmod p\right] & -\left((a+d) \bmod p^{m}\right) \cdot\left(d \bmod p^{m}\right)
\end{array}\right) \\
=\left(\begin{array}{cc}
\left(-a^{2}-a u_{0}\right) \bmod p & \left(-a b+b u_{0}\right) \bmod p \\
-p^{m-1}\left[\left(c a+c u_{0}\right) \bmod p\right] & -(a d) \bmod p^{m}-d^{2} \bmod p^{m}
\end{array}\right),
\end{gathered}
$$

and

$$
s I=\left(\begin{array}{cc}
{\left[\left(a d-p^{m-1} b c\right) \bmod p^{m}\right] \bmod p} & 0 \\
0 & \left(a d-p^{m-1} b c\right) \bmod p^{m}
\end{array}\right)
$$

Therefore $f_{A}(A)=A^{2}+r A+s I=0$.
Definition 4.2. For $A \in E_{p, p^{m}}$, we call monic polynomial $f_{A}(x) \in \mathbb{Z}[x]$ the minimal polynomial of $A$ if $f_{A}(A)=0$ in $E_{p, p^{m}}$ and $g(A)=0$ if and only if $f_{A}(x)$ divides $g(x)$ in $\mathbb{Z}[x]$.

Corollary 4.3. In the notation of Theorem 4.1, $f_{A}(x)=x^{2}+r x+s$ is the minimal polynomial of $A$.

In $\mathbb{Z}[x]$ or $\mathbb{Z}_{p^{m}}[x]$, for any $g(x) \in \mathbb{Z}[x]$, by the polynomial division with remainder algorithm over $\mathbb{Z}[x]$, we obtain

$$
g(x)=q(x) f_{A}(x)+r(x),
$$

where $q(x), r(x) \in \mathbb{Z}[x]$, and $r(x)=0$ or $\operatorname{deg}(r(x))<\operatorname{deg}\left(f_{A}(x)\right)$. Hence

$$
g(A)=q(A) f_{A}(A)+r(A)=r(A)
$$

This means that we can simplify the computations of $g(A)$ for any $g(x) \in \mathbb{Z}[x]$ and $M^{-1}$ in $E_{p, p^{m}}$.

Corollary 4.4. With notations of Theorem 4.1. If $a \neq 0$ and $u_{0} \neq 0$, then $A^{-1}=-s^{-1}(A+$ $r I)$.

Proof. Since $A^{2}+r A+s I=0$, we have $(A+r I) A=(-s) I$. By $a \neq 0$ and $u_{0} \neq 0$. Therefore,

$$
A^{-1}=(-s)^{-1}(A+r I)=-s^{-1}(A+r I)
$$

We finish this section by showing how Corollary 4.4 works for computing invertible elements in $E_{p, p^{m}}$.

Example 1. Suppose that $A=\left(\begin{array}{cc}2 & 3 \\ 5^{2} \cdot 3 & 5^{2} \cdot 2+5 \cdot 3+2\end{array}\right) \in E_{5,5^{3}}$. Then by Theorem 4.1 we have

$$
r=-\left(2+5^{2} \cdot 2+5 \cdot 3+2\right) \bmod 5^{3}=56 \bmod 5^{3}=5^{2} \cdot 2+5 \cdot 1+1
$$

and

$$
s=\left[2\left(5^{2} \cdot 2+5 \cdot 3+2\right)-5^{2} \cdot 3 \cdot 3\right] \bmod 5^{3}=34 \bmod 5^{3}=5^{2} \cdot 1+5 \cdot 1+4
$$

In light of Lemma 3.3, we obtain

$$
s^{-1}=5^{2} \cdot 4+\cdot 2+4
$$

hence, $-s^{-1}=5 \cdot 2+1$.
Now, by Corollary 4.4, we have

$$
\begin{aligned}
A^{-1} & =(5 \cdot 2+1)\left[\left(\begin{array}{cc}
2 & 3 \\
5^{2} \cdot 3 & 5^{2} \cdot 2+5 \cdot 3+2
\end{array}\right)+\left(\begin{array}{cc}
4 & 0 \\
0 & 5^{2} \cdot 2+5 \cdot 1+1
\end{array}\right)\right] \\
& =(5 \cdot 2+1)\left(\begin{array}{cc}
3 & 3 \\
5^{2} \cdot 3 & 5^{2} \cdot 4+5 \cdot 4+3
\end{array}\right)=\left(\begin{array}{cc}
3 & 3 \\
5^{2} \cdot 3 & 5^{2} \cdot 4+3
\end{array}\right) .
\end{aligned}
$$
