# $z$-CLASSES IN FINITE GROUPS OF CONJUGATE TYPE $(n, 1)$

#### Abstract

Two elements in a group $G$ are said to $z$-equivalent or to be in the same $z$-class if their centralizers are conjugate in $G$. In KKJ16, it was proved that a non-abelian $p$-group $G$ can have at most $\frac{p^{k}-1}{p-1}+1$ number of $z$-classes, where $|G / Z(G)|=p^{k}$. In this note, we characterize the $p$-groups of conjugate type $(n, 1)$ attaining this maximal number. As a corollary, we characterize $p$-groups having prime order commutator subgroup and maximal number of $z$-classes.


## 1. Introduction

Two elements in a group $G$ are said to $z$-equivalent or to be in the same $z$-class if their centralizers are conjugate in $G$. The $z$-equivalence is an equivalence relation in $G$ and give a partition of $G$ into disjoint subsets. It is coarser than the conjugacy relation. An infinite group may have infinitely many conjugacy classes, but often the number of $z$-classes is finite and this finiteness of $z$-classes give a rough idea about dynamical types in a homogeneous space on which $G$ acts, see Kul07. There have been some recent work where $z$-classes in various groups have been investigated, see [Gou06, Kul08, Sin08, GK09, Gon13, GK16]. We note here that a closely related problem is to compute the genus number that has been investigated in Bos13. Jadhav and Kitture has classified $z$-classses in $p$-groups of order up to $p^{5}$, JK14.

In a recent work Jadhav, Kitture and Kulkarni KKJ16 has investigated $z$-classes in finite $p$-groups. They proved that a non-abelian $p$-group has at least $p+2 z$ classes and characterized the groups that attains this lower bound. They also proved that a non-abelian $p$-group can have at most $\frac{p^{k}-1}{p-1}+1$ number of $z$-classes, where $|G / Z(G)|=p^{k}$. They proved the following theorem that gives necessary conditions for a $p$-group $G$ to attain this maximal number of $z$-classes.

Theorem JKK. KKJ16 Let $G$ be a non-abelian group with $|G / Z(G)|=p^{k}$. If the number of $z$-classes in $G$ is $\frac{p^{k}-1}{p-1}+1$ then either $G / Z(G) \cong C_{p} \times C_{p}$ or the following holds:
(1) $G$ has no abelian subgroup of index $p$.
(2) $G / Z(G)$ is an elementary abelian p-group.

[^0]The authors further gave a counterexample to show that conditions (1) and (2) are not sufficient to attain this bound. It would be interesting to obtain sufficient conditions for a group $G$ to attain the maximal number of $z$-classes and to characterize such groups.

In this note, we characterize groups of type $(n, 1)$ attaining this bound. To state our result, we recall the following definition by Ito [Ito53].

Definition. [Ito53] Let $G$ be a finite group. Let $n_{1}, n_{2}, \ldots, n_{r}$, where $n_{1}>n_{2}>$ $\ldots>n_{r}=1$, be all the numbers which are the indices of the centralizers of elements of $G$ in $G$. The vector $\left(n_{1}, n_{2}, \ldots, n_{r}\right)$ is called conjugate type vector of $G$. A group with the conjugate type vector $\left(n_{1}, n_{2}, \ldots, n_{r}\right)$ is called a group of type $\left(n_{1}, n_{2}, \ldots, n_{r}\right)$.

In Ito53, Ito characterizes the groups of type ( $n, 1$ ). Any such group is nilpotent and $n=p^{a}$ for some prime $p$. A group of type $\left(p^{a}, 1\right)$ is the direct product of a $p$-group of the same type and of an abelian group. Thus, the study of groups of type $(n, 1)$ can be reduced to that of $p$-groups of type $\left(p^{a}, 1\right)$. Ito showed that such a group $G$ contains an abelian normal subgroup $A$ such that $G / A$ is of exponent $p$.

Here we prove the following.
Theorem 1.1. Let $G$ be a non-abelian group of type $(n, 1)$ and $[G: Z(G)]=p^{k}$. Then $G$ has $\frac{p^{k}-1}{p-1}+1 z$-classes if and only if
(1) $G / Z(G)$ is elementary abelian, and
(2) for all $x \in G \backslash Z(G), Z\left(C_{G}(x)\right)=\langle x, Z(G)\rangle$.

As an application of the above result we have the following.
Corollary 1.2. Let $G$ be a non-abelian group with $|G / Z(G)|=p^{k},(k \geq 2)$ and $\left|G^{\prime}\right|=p$. Then the number of $z$-classes in $G$ is $\frac{p^{k}-1}{p-1}+1$ if and only if $G$ is isoclinic to an extraspecial p-group.

We prove these results in Section 3,
We note that Corollary 1.2 may be compared with Theorem 5.3.1 of Kitture [Kit14, Section 5.3]. We thank Kitture for letting us know about his result and many comments. We are also thankful to Silvio Dolfi for useful comments and suggestions on a first draft of this note.

## 2. Preliminaries

We recall here a few basic facts from Kulkarni Kul07 that will be used in the proof.

Let $G$ be a group. We denote $C_{G}(x)$ to be the centralizer of an element $x$ in $G$.
Definition 2.1. Let $G$ be a group. Two elements $x, y \in G$ are said to be $z$-equivalent if their centralizers are conjugate, i.e. there exist $g \in G$ such that,

$$
g^{-1} C_{G}(x) g=C_{G}(y)
$$

Let $G$ be a group acting on a set $X$. For $x \in X$ let $G(x)$ denote the orbit of $x$ and $G_{x}$ be the stabilizer subgroup of $x$ :

$$
\begin{gathered}
G(x)=\{y \in X: \text { there exists } g \in G \text { and } y=g x\} . \\
G_{x}=\{g \in G: g x=x\} .
\end{gathered}
$$

We have a partition of $X$ as:

$$
X=\bigcup_{x \in X} G(x)
$$

Let $y \in G(x)$ be some element, then for some $g \in G$ we have $y=g x$ and $G_{y}=$ $g G(x) g^{-1}$.

For subgroups $A$ and $B$ in $G$ write $A \sim_{g} B$ if they are conjugate. This gives us the following.
Definition 2.2. Let $x, y \in X$ be any two element, they are said to be in same orbit class if $G_{x} \sim_{g} G_{y}$. Denote this equivalence relation as $x \sim_{0} y$ and denote $R(x)$ as the equivalence class of $x$.

This gives another partition of $X$ :

$$
X=\bigcup_{G_{x} \sim g G_{y}} R(x)=\bigcup_{G_{x}=G_{y}} R(x) .
$$

The second inequality is easy to note, since if $x \sim_{0} y$ then for some $z \in X$, we have $C_{G}(x)=C_{G}(z)$.

Let $F_{x}$ denotes the points fixed by $G_{x}$ i.e.

$$
F_{x}=\left\{y \in X: G_{y} \supset G_{x}\right\} .
$$

Let $F_{x}^{\prime}$ denotes the set $F_{x}^{\prime}=\left\{y \in X: G_{y}=G_{x}\right\}$. Define $W_{x}=N_{x} / G_{x}$, where $N_{x}$ is the normalizer of the $G_{x}$ in $G$. Then we have the following theorem(refer [Kul07]).
Theorem 2.3. Let $G$ act on a set $X$. Then the map $\phi: G / G_{x} \times F_{x}^{\prime} \rightarrow R(x)$, $\phi\left(g G_{x}, y\right)=g y$ is well defined and induces a bijection, $\bar{\phi}:\left(G / G_{x} \times F_{x}^{\prime}\right) / W_{x} \rightarrow R(x)$.
When we take our space $X=G$, the group itself, then $R(x)$ in above notation becomes the $z$-classes and the above theorem gives us the following equation, which is used to calculate the size of a $z$-class: for any $x \in G$ we have

$$
\mid z-\text { class of } x\left|=\left[G: N_{G}\left(C_{G}(x)\right)\right] \cdot\right| F_{x}^{\prime} \mid,
$$

where $C_{G}(x)$ is the centralizer of $x$ and $F_{x}^{\prime}=\left\{y \in G: C_{G}(y)=C_{G}(x)\right\}$.
The following theorem states that that number of $z$-classes is invariant under the isoclinism. For basic notions on isoclinism, see Hal40, KKJ16].
Theorem 2.4. KKJ16] Let $G_{1}$ and $G_{2}$ be isoclinic groups, with an isoclinism $(\phi, \psi)$. Then the isoclinism $(\phi, \psi)$ induces a bijection between the $z$-classes in $G_{1}$ and $G_{2}$.

Finally we note the following theorem by Hall Hal40 that is used in proof of Theorem 1.2 ,

Theorem 2.5. Every group is isoclinic to a group whose center is contained in the commutator subgroup.

## 3. Proof of The Main Results

It was proved in [KKJ16, Lemma 3.1] that if $G$ is a finite group with $|G / Z(G)|=$ $p^{k}$, then $G$ is isoclinic to a finite $p$-group. Since number of $z$-classes is invariant under isoclinism, hence it is enough to prove our results assuming that $G$ is a $p$-group.
Lemma 3.1. Let $G$ be a non-abelian p-group with $[G: Z(G)]=p^{k}$. If
(1) $G / Z(G)$ is elementary abelian, and
(2) for all $z \in G \backslash Z(G), Z\left(C_{G}(x)\right)=\langle x, Z(G)\rangle$,
then $G$ has $\frac{p^{k}-1}{p-1}+1$ z-classes.
Proof. Let $x \in G \backslash Z(G)$. Since $G / Z(G)$ is abelian, hence $C_{G}(x) \unlhd G$, i.e. $\quad[G$ : $N\left(C_{G}(x)\right]=1$. Consider

$$
F_{x}^{\prime}=\left\{y \in G: C_{G}(y)=C_{G}(x)\right\}
$$

By definition $F_{x}^{\prime} \subseteq Z\left(C_{G}(x)\right) \backslash Z(G)=\langle x, Z(G)\rangle \backslash Z(G)$. Obviously $C_{G}(x)=C_{G}(x t)$ for $t \in Z(G)$. Also since exponent of $G / Z(G)$ is $p$, thus $C_{G}(x)=C_{G}\left(x^{i}\right)$ for any $i \in\{1,2, . ., p-1\}$. Hence $\langle x, Z(G)\rangle \backslash Z(G) \subseteq F_{x}^{\prime}$. Hence

$$
F_{x}^{\prime}=Z\left(C_{G}(x)\right) \backslash Z(G)=\langle x, Z(G)\rangle \backslash Z(G)=x Z(G) \cup \ldots \cup x^{p-1} Z(G)
$$

This implies, $\left|F_{x}^{\prime}\right|=(p-1)|Z(G)|$. Therefore,

$$
\mid z-\text { class of } x\left|=\left[G: N_{G}\left(C_{G}(x)\right)\right] \cdot\right| F_{x}^{\prime}|=1 .(p-1)| Z(G) \mid
$$

Thus $G \backslash Z(G)$ contributes to a total $\frac{p^{k}-1}{p-1}$ number of $z$-classes of $G$. Clearly, $Z(G)$ is also a $z$-class. Hence, $G$ has $\frac{p^{k}-1}{p-1}+1 z$-classes.

Corollary 3.2. Let $G$ be a non-abelian p-group with $|G / Z(G)|=p^{k}$. If
(1) $G$ has no abelian subgroup of order exceeding $p|Z(G)|$.
(2) $G / Z(G)$ is an elementary abelian p-group.

Then $G$ has $\frac{p^{k}-1}{p-1}+1$ number of $z$-classes.
Proof. We claim $C_{G}(x)=\langle x, Z(G)\rangle$, and the rest follow from Lemma 3.1.
Clearly $\langle x, Z(G)\rangle \subseteq C_{G}(x)$. Let us assume $y \notin\langle x, Z(G)\rangle$ and $y \in C_{G}(x)$. But then $\langle x, y, Z(G)\rangle$ is an abelian subgroup and $|\langle x, y, Z(G)\rangle|>p|Z(G)|$. Thus $C_{G}(x)=$ $\langle x, Z(G)\rangle$.

### 3.1. Proof of Theorem 1.1.

Proof. Let $G$ be an non-abelian group of type $(n, 1)$ and $G$ has $\frac{p^{k}-1}{p-1}+1 z$-classes, where $[G: Z(G)]=p^{k}$. (1) follows from the Theorem JKK. We prove (2).

Let $x \in G \backslash Z(G)$, then for any $t \in Z(G), C_{G}(x)=C_{G}(x t)$. Also for any $m$ relatively prime to order of $x$, we have

$$
C_{G}(x)=C_{G}(\langle x\rangle)=C_{G}\left(\left\langle x^{m}\right\rangle\right)
$$

Thus $z$-class of $x$ contains,

$$
x Z(G) \cup x^{2} Z(G) \cup \ldots . \cup x^{p-1} Z(G)
$$

and hence, for all $x \in G \backslash Z(G)$, the size of $z$ class is at least $(p-1)|Z(G)|$. Since $Z(G)$ is also a $z$-class, hence it follows from the hypothesis that $G \backslash Z(G)$ constitute exactly $\frac{p^{k}-1}{p-1} z$-classes. Now, $|G \backslash Z(G)|=|G|-|Z(G)|$. Hence, we must have for $x \in G \backslash Z(G)$,

$$
\mid z-\text { class of } x|=(p-1)| Z(G) \mid .
$$

Now, it is clear that for $x \in G \backslash Z(G),\langle x, Z(G)\rangle \subseteq Z\left(C_{G}(x)\right)$. Now let $y \in$ $Z\left(C_{G}(x)\right)$ such that $y \notin\langle x, Z(G)\rangle$. Then a simple observation shows that $C_{G}(y) \supseteq$ $C_{G}(x)$. But since $G$ is of type $(n, 1)$ we have $\left|C_{G}(x)\right|=\left|C_{G}(y)\right|$, thus we must have $C_{G}(x)=C_{G}(y)$. This implies $y \in(z-$ class of $x)$ and since $y \notin\langle x, Z(G)\rangle$, thus $\mid z-$ class of $x|>(p-1)| Z(G) \mid$, which is a contradiction. Thus our assumption is incorrect and $Z\left(C_{G}(x)\right)=\langle x, Z(G)\rangle$ for all $x \in G \backslash Z(G)$.

The converse part follows from Lemma 3.1. This completes the proof.

### 3.2. Proof of Corollary $\mathbf{1 . 2}$.

Proof. : Without loss of generality, using Theorem [2.5, we assume up to isoclinism that, $G$ is a group such that $Z(G) \subseteq G^{\prime}$. Let $G$ has $\frac{p^{k}-1}{p-1}+1 z$-classes. Since $\left|G^{\prime}\right|=p$ and in a non-abelian $p$-group $|Z(G)|>1$, it follows that $G^{\prime}=Z(G)$; hence, $\left|G^{\prime}\right|=|Z(G)|=p$. Therefore $G$ and $G / Z(G)$ have the same exponent. Thus $G$ is an extra-special $p$-group.

Conversely, let $G$ be an extraspecial $p$-group. So, $|Z(G)|=\left|G^{\prime}\right|=p$. For $x \in$ $G \backslash Z(G)$, define the map:

$$
\begin{aligned}
\phi_{x} & : G \rightarrow G^{\prime} \\
g & \mapsto[x, g]
\end{aligned}
$$

As $G / Z(G)$ is elementary abelian, $\phi_{x}$ is a homomorphism with $\operatorname{ker}\left(\phi_{x}\right)=C_{G}(x)$ and since $\left|G^{\prime}\right|=p$, the map is also surjective. Hence we get

$$
G / C_{G}(x) \cong G^{\prime}
$$

Thus each $C_{G}(x)$ is a maximal subgroup of index $p$ in $G$. This shows that extraspecial $p$-groups are of type $(n, 1)$.

Now, we claim that $Z\left(C_{G}(x)\right)=\langle x, Z(G)\rangle$. This follows from the fact that $G / Z(G)$ can be equipped with an alternating non-degenerate form induced by the commutator, see the proof of [Cra08, Theorem 3.14] or [Wil09, p. 83]. The claim follows from [Cra08, Lemma 3.11] noting that $Z\left(C_{G}(x)\right) / Z(G)$ is the radical of codimension one subspace $C_{G}(x) / Z(G)$.

The result now follows from Theorem 1.1.
