# CLASSICAL LIMITS OF QUANTUM TOROIDAL AND AFFINE YANGIAN ALGEBRAS

#### Abstract

In this short article, we compute the classical limits of the quantum toroidal and affine Yangian algebras of $\mathfrak{s l}_{n}$ by generalizing our arguments for $\mathfrak{g l}_{1}$ from T1 (an alternative proof for $n>2$ is given in $[\mathrm{VV}]$ ). We also discuss some consequences of these results.


## Introduction

The primary purpose of this note is to provide proofs for the description of the classical limits of the algebras $\mathcal{U}_{q, d}^{(n)}$ and $y_{h, \beta}^{(n)}$ from [FT, TB]. Here $\mathcal{U}_{q, d}^{(n)}$ and $y_{h, \beta}^{(n)}$ are the quantum toroidal and the affine Yangian algebras of $\mathfrak{s l}_{n}$ (if $n \geq 2$ ) or $\mathfrak{g l}_{1}$ (if $n=1$ ), while classical limits refer to the limits of these algebras as $q \rightarrow 1$ or $h \rightarrow 0$, respectively. We also discuss the classical limits of certain constructions for $\mathcal{U}_{q, d}^{(n)}$.

The case $n=1$ has been essentially worked out in T1]. In this note, we follow the same approach to prove the $n>1$ generalizations. While writing down this note, we found that the $n \geq 3$ case has been considered in [VV] long time ago (to deduce our Theorems 2.1] and 2.2, one needs to combine [VV] with [BGK]). Hence, the only essentially new case is $n=2$. Meanwhile, we expect our direct arguments to be applicable in some other situations of interest.

This paper is organized as follows:

- In Section 1, we recall explicit definitions of the Lie algebras $\ddot{u}_{d}^{(n)}$ and $\ddot{y}_{\beta}^{(n)}$, whose universal enveloping algebras coincide with the classical limits of $\mathcal{U}_{q, d}^{(n)}$ and $y_{h, \beta}^{(n)}$. We also recall the notion of $n \times n$ matrix algebras over the algebras of difference/differential operators on $\mathbb{C}^{\times}$and their central extensions, denoted by $\overline{\mathfrak{d}}_{t}^{(n)}$ and $\overline{\mathfrak{D}}_{s}^{(n)}$, respectively.
- In Section 2, we establish two key isomorphisms relating the classical limit Lie algebras $\ddot{u}_{d}^{(n)}, \ddot{y}_{\beta}^{(n)}$ to the aforementioned Lie algebras $\overline{\mathfrak{d}}_{d^{n}}^{(n)}, \overline{\mathfrak{D}}_{n \beta}^{(n)}$.
- In Section 3, we discuss the classical limits of the following constructions for $\mathcal{U}_{q, d}^{(n)}(n \geq 2)$ : - the vertical and horizontal copies of a quantum affine algebra $U_{q}\left(\widehat{\mathfrak{g l}}_{n}\right)$ inside $\mathcal{U}_{q, d}^{(n)}$ from [FJMM], - the Miki's automorphism $\varpi: \mathcal{U}_{q, d}^{(n)} \xrightarrow{\sim} \mathcal{U}_{q, d}^{(n)}$ from $[\mathrm{M}]$,
- the commutative subalgebras $\mathcal{A}\left(s_{0}, \ldots, s_{n-1}\right)$ of $\mathcal{U}_{q, d}^{(n),+}$ from [FT].

## 1. Basic constructions

1.1. The quantum toroidal algebra $\mathcal{U}_{q, d}^{(n)}$ and the affine Yangian $y_{h, \beta}^{(n)}$.

For $n \in \mathbb{N}$, set $[n]:=\{0,1, \ldots, n-1\}$ viewed as a set of $\bmod n$ residues and $[n]^{\times}:=[n] \backslash\{0\}$. For $n \geq 2$, we set $a_{i, j}:=2 \delta_{i, j}-\delta_{i, j+1}-\delta_{i, j-1}$ and $m_{i, j}:=\delta_{i, j+1}-\delta_{i, j-1}$ for all $i, j \in[n]$.

- Given $h, \beta \in \mathbb{C}$, let $y_{h, \beta}^{(n)}$ be the affine Yangian of $\mathfrak{s l}_{n}($ if $n \geq 2)$ or $\mathfrak{g l}_{1}$ (if $n=1$ ) as considered in TB], where it was denoted by $y_{\beta-h, 2 h,-\beta-h}^{(n)}$. These are unital associative $\mathbb{C}$-algebras generated by $\left\{x_{i, r}^{ \pm}, \xi_{i, r}\right\}_{i \in[n]}^{r \in \mathbb{Z}_{+}}$(here $\mathbb{Z}_{+}:=\mathbb{N} \cup\{0\}$ ) and with the defining relations as in $\overline{T B}$, Sect. 1.2]. We will list these relations only for $h=0$, which is of main interest in the current paper.
- Given $q, d \in \mathbb{C}^{\times}$, let $\mathcal{U}_{q, d}^{(n)}$ be the quantum toroidal algebra of $\mathfrak{s l}_{n}$ (if $n \geq 2$ ) or $\mathfrak{g l}_{1}$ (if $n=1$ ) as considered in [FT] but without the generators $q^{ \pm d_{1}}, q^{ \pm d_{2}}$ and with $\gamma^{ \pm 1 / 2}=q^{ \pm c / 2}$. These are unital associative $\mathbb{C}$-algebras generated by $\left\{e_{i, k}, f_{i, k}, h_{i, k}, c\right\}_{i \in[n]}^{k \in \mathbb{Z}}$ and with the defining relations specified in [FT]. We note that algebras $\mathcal{U}_{\frac{d}{q}, q^{2}, \frac{1}{d q}}^{(n)}$ from [TB, Sect. 1.1] are their central quotients.
1.2. The Lie algebra $\ddot{u}_{d}^{(n)}$.

In the $q \rightarrow 1$ limit, all the defining relations of $\mathcal{U}_{q, d}^{(n)}$ become of Lie type. Therefore, the $q \rightarrow 1$ limit of $\mathcal{U}_{q, d}^{(n)}$ is isomorphic to the universal enveloping algebra $U\left(\ddot{u}_{d}^{(n)}\right)$. The Lie algebra $\ddot{u}_{d}^{(n)}$ is generated by $\left\{\bar{e}_{i, k}, \bar{f}_{i, k}, \bar{h}_{i, k}, \bar{c}\right\}_{i \in[n]}^{k \in \mathbb{Z}}$ with $\bar{c}$ being a central element and the rest of the defining relations (u1-u7.2) to be given below in each of the 3 cases of interest: $n>2, n=2$, and $n=1$.

- For $n>2$, the defining relations are

- For $n=2$, the defining relations are

In the above relations $l, k, k_{1}, k_{2}, k_{3} \in \mathbb{Z}$ and $\Sigma_{s}$ is the symmetric group on $s$ letters.

### 1.3. The Lie algebra $\ddot{y}_{\beta}^{(n)}$.

All the defining relations of $y_{h, \beta}^{(n)}$ are well-defined for $h=0$ and become of Lie type. Therefore, $y_{0, \beta}^{(n)} \simeq U\left(\ddot{y}_{\beta}^{(n)}\right)$ where the Lie algebra $\ddot{y}_{\beta}^{(n)}$ is generated by $\left\{\bar{x}_{i, r}^{ \pm}, \bar{\xi}_{i, r}\right\}_{i \in[n]}^{r \in \mathbb{Z}_{+}}$with the defining relations (y1-y6) to be given below. The first two of them are independent of $n \in \mathbb{N}$ :

Let us now specify (y3-y6) in each of the 3 cases of interest: $n>2, n=2$, and $n=1$.

In the above relations $s, r, r_{1}, r_{2}, r_{3} \in \mathbb{Z}_{+}$and $i, j \in[n]$.
Remark 1.1. For $\beta \neq 0$, the assignment $\bar{x}_{i, r}^{ \pm} \mapsto \beta^{r} \bar{x}_{i, r}^{ \pm}, \bar{\xi}_{i, r} \mapsto \beta^{r} \bar{\xi}_{i, r}$ (with $i \in[n], r \in \mathbb{Z}_{+}$) provides an isomorphism of Lie algebras $\ddot{y}_{\beta}^{(n)} \xrightarrow{\sim} \ddot{y}_{1}^{(n)}$.

### 1.4. Difference operators on $\mathbb{C}^{\times}$.

For $t \in \mathbb{C}^{\times}$, define the algebra of $t$-difference operators on $\mathbb{C}^{\times}$, denoted by $\mathfrak{d}_{t}$, to be the unital associative $\mathbb{C}$-algebra generated by $Z^{ \pm 1}, D^{ \pm 1}$ with the defining relations

Define the associative algebra $\mathfrak{d}_{t}^{(n)}:=\mathbb{M}_{n} \otimes \mathfrak{d}_{t}$, where $\mathbb{M}_{n}$ stands for the algebra of $n \times n$ matrices (so that $\mathfrak{d}_{t}^{(n)}$ is the algebra of $n \times n$ matrices with values in $\mathfrak{d}_{t}$ ). We will view $\mathfrak{d}_{t}^{(n)}$ as a Lie algebra with the natural commutator-Lie bracket $[\cdot, \cdot]$. It is easy to check that the following formulas define two 2-cocycles $\phi^{(1)}, \phi^{(2)} \in C^{2}\left(\mathfrak{d}_{t}^{(n)}, \mathbb{C}\right)$ :

\end{aligned}
$$

for any $M_{1}, M_{2} \in \mathbb{M}_{n}$ and $k_{1}, k_{2}, l_{1}, l_{2} \in \mathbb{Z}$.
This endows $\overline{\mathfrak{d}}_{t}^{(n)}:=\mathfrak{o}_{t}^{(n)} \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(1)} \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(2)}$ with the Lie algebra structure via

$$
\left[X+\lambda_{1} c_{\mathfrak{D}}^{(1)}+\lambda_{2} c_{\mathfrak{\mathfrak { O }}}^{(2)}, Y+\mu_{1} c_{\mathfrak{\mathfrak { O }}}^{(1)}+\mu_{2} c_{\mathfrak{\mathfrak { O }}}^{(2)}\right]=X Y-Y X+\phi^{(1)}(X, Y) c_{\mathfrak{\mathfrak { O }}}^{(1)}+\phi^{(2)}(X, Y) c_{\mathfrak{\mathfrak { O }}}^{(2)}
$$ for any $X, Y \in \mathfrak{d}_{t}^{(n)}$ and $\lambda_{1}, \lambda_{2}, \mu_{1}, \mu_{2} \in \mathbb{C}$. We also define a Lie subalgebra $\tilde{\mathfrak{d}}_{t}^{(n), 0} \subset \overline{\mathfrak{d}}_{t}^{(n)}$ via

\overline{\mathfrak{d}}_{t}^{(n), 0}:=\left\{\sum A_{k, l} D^{k} Z^{l}+\lambda_{1} c_{\mathfrak{d}}^{(1)}+\lambda_{2} c_{\mathfrak{d}}^{(2)} \in \overline{\mathfrak{d}}_{t}^{(n)} \mid \lambda_{1}, \lambda_{2} \in \mathbb{C}, A_{k, l} \in \mathbb{M}_{n}, \operatorname{tr}\left(A_{0,0}\right)=0\right\} .
$$

### 1.5. Differential operators on $\mathbb{C}^{\times}$.

For $s \in \mathbb{C}$, define the algebra of $s$-differential operators on $\mathbb{C}^{\times}$, denoted by $\mathfrak{D}_{s}$, to be the unital associative $\mathbb{C}$-algebra generated by $\partial, x^{ \pm 1}$ with the defining relations

x^{ \pm 1} x^{\mp 1}=1, \partial x=x(\partial+s)
$$

Define the associative algebra $\mathfrak{D}_{s}^{(n)}:=\mathbb{M}_{n} \otimes \mathfrak{D}_{s}$ (so that $\mathfrak{D}_{s}^{(n)}$ is the algebra of $n \times n$ matrices with values in $\mathfrak{D}_{s}$ ). We will view $\mathfrak{D}_{s}^{(n)}$ as a Lie algebra with the natural commutator-Lie bracket. Following [BKLY, Formula (2.3)], consider a 2-cocycle $\phi \in C^{2}\left(\mathfrak{D}_{s}^{(n)}, \mathbb{C}\right)$ given by
$\phi\left(M_{1} \otimes f_{1}(\partial) x^{l_{1}}, M_{2} \otimes f_{2}(\partial) x^{l_{2}}\right)= \begin{cases}\operatorname{tr}\left(M_{1} M_{2}\right) \cdot \sum_{a=0}^{l_{1}-1} f_{1}(a s) f_{2}\left(\left(a-l_{1}\right) s\right) & \text { if } l_{1}=-l_{2}>0 \\ -\operatorname{tr}\left(M_{1} M_{2}\right) \cdot \sum_{a=0}^{-l_{1}-1} f_{2}(a s) f_{1}\left(\left(a+l_{1}\right) s\right) & \text { if } l_{1}=-l_{2}<0 \\ 0 & \text { otherwise }\end{cases}$
for arbitrary polynomials $f_{1}, f_{2}$ and any $M_{1}, M_{2} \in \mathbb{M}_{n}, l_{1}, l_{2} \in \mathbb{Z}$.
This endows $\overline{\mathfrak{D}}_{s}^{(n)}:=\mathfrak{D}_{s}^{(n)} \oplus \mathbb{C} \cdot c_{\mathfrak{D}}$ with the Lie algebra structure via

\left[X+\lambda c_{\mathfrak{D}}, Y+\mu c_{\mathfrak{D}}\right]=X Y-Y X+\phi(X, Y) c_{\mathfrak{D}}
$$

for any $X, Y \in \mathfrak{D}_{s}^{(n)}$ and $\lambda, \mu \in \mathbb{C}$.

## 2. KEY ISOMORPHISMS

### 2.1. Main results.

Our first main result establishes a relation between the Lie algebras $\ddot{u}_{d}^{(n)}$ and $\overline{\mathfrak{d}}_{t}^{(n)}$.
Theorem 2.1. For $d \in \mathbb{C}^{\times}$not a root of unity (we will denote this by $d \neq \sqrt{1}$ ), the assignment $\bar{e}_{0, k} \mapsto E_{n, 1} \otimes D^{k} Z, \bar{f}_{0, k} \mapsto E_{1, n} \otimes Z^{-1} D^{k}, \bar{h}_{0, k} \mapsto E_{n, n} \otimes D^{k}-d^{n k} E_{1,1} \otimes D^{k}+\delta_{0, k} c_{\mathfrak{d}}^{(1)}, \bar{c} \mapsto c_{\mathfrak{d}}^{(2)}$,

$$
\bar{e}_{i, k} \mapsto d^{(n-i) k} E_{i, i+1} \otimes D^{k}, \bar{f}_{i, k} \mapsto d^{(n-i) k} E_{i+1, i} \otimes D^{k}, \bar{h}_{i, k} \mapsto d^{(n-i) k}\left(E_{i, i}-E_{i+1, i+1}\right) \otimes D^{k}
$$

(with $i \in[n]^{\times}, k \in \mathbb{Z}$ ) provides an isomorphism of Lie algebras $\theta_{d}^{(n)}: \ddot{u}_{d}^{(n)} \xrightarrow{\sim} \overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$.
Our second main result establishes a relation between the Lie algebras $\ddot{y}_{\beta}^{(n)}$ and $\overline{\mathfrak{D}}_{s}^{(n)}$.
Theorem 2.2. For $\beta \neq 0$, the assignment
$\bar{x}_{0, r}^{+} \mapsto E_{n, 1} \otimes \partial^{r} x, \bar{x}_{0, r}^{-} \mapsto E_{1, n} \otimes x^{-1} \partial^{r}, \bar{\xi}_{0, r} \mapsto E_{n, n} \otimes \partial^{r}-E_{1,1} \otimes(\partial+n \beta)^{r}+\delta_{0, r} c_{\mathfrak{D}}$,
$\bar{x}_{i, r}^{+} \mapsto E_{i, i+1} \otimes(\partial+(n-i) \beta)^{r}, \bar{x}_{i, r}^{-} \mapsto E_{i+1, i} \otimes(\partial+(n-i) \beta)^{r}, \bar{\xi}_{i, r} \mapsto\left(E_{i, i}-E_{i+1, i+1}\right) \otimes(\partial+(n-i) \beta)^{r}$ (with $i \in[n]^{\times}, r \in \mathbb{Z}_{+}$) provides an isomorphism of Lie algebras $\vartheta_{\beta}^{(n)}: \ddot{y}_{\beta}^{(n)} \xrightarrow{\sim} \overline{\mathfrak{D}}_{n \beta}^{(n)}$.

For $n=1$, these isomorphisms have been essentially established in T1]. In the rest of this section, we adapt arguments from [T1] to prove the above results for $n \geq 2$.

Remark 2.3. These two theorems played a crucial role in TB , while their proofs were missing. In the loc. cit., we considered the quotients $\ddot{u}_{d}^{(n)} /(\bar{c})$ and $\overline{\mathfrak{d}}_{d^{n}}^{(n), 0} /\left(c_{\mathfrak{d}}^{(2)}\right)$ and had a different 2cocycle. Nevertheless, Theorem 2.8 from [TB is equivalent to the above Theorem 2.1.

### 2.2. Proof of Theorem 2.1.

It is straightforward to see that the assignment from Theorem 2.1 preserves all the defining relations (u1-u7.2), hence, it provides a Lie algebra homomorphism $\theta_{d}^{(n)}: \ddot{u}_{d}^{(n)} \rightarrow \overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$. We also consider the induced homomorphism $\underline{\theta}_{d}^{(n)}: \underline{\ddot{u}}_{d}^{(n)} \rightarrow \mathfrak{d}_{d^{n}}^{(n), 0}$, where $\underline{\ddot{u}}_{d}^{(n)}:=\ddot{u}_{d}^{(n)} /\left(\bar{c}, \sum_{i} \bar{h}_{i, 0}\right)$ is a central quotient of $\ddot{u}_{d}^{(n)}$. Clearly, it suffices to show that $\underline{\theta}_{d}^{(n)}$ is an isomorphism.

Let $Q$ be the root lattice of $\widehat{\mathfrak{s l}}_{n}$. The Lie algebras $\ddot{\ddot{u}}_{d}^{(n)}$ and $\mathfrak{d}_{d^{n}}^{(n)}$ are $Q \times \mathbb{Z}$-graded via

\begin{gathered}
\operatorname{deg}\left(\bar{e}_{i, k}\right)=\left(\alpha_{i} ; k\right), \operatorname{deg}\left(\bar{f}_{i, k}\right)=\left(-\alpha_{i} ; k\right), \operatorname{deg}\left(\bar{h}_{i, k}\right)=(0 ; k) \\
\operatorname{deg}\left(E_{i, j} \otimes D^{k} Z^{l}\right)=\left(l \delta+\left(\alpha_{1}+\ldots+\alpha_{j-1}\right)-\left(\alpha_{1}+\ldots+\alpha_{i-1}\right) ; k\right),
\end{gathered}
$$

where $\alpha_{0}, \alpha_{1}, \ldots, \alpha_{n-1}$ are the simple positive roots of $\widehat{\mathfrak{s l}}_{n}$, while $\delta=\alpha_{0}+\ldots+\alpha_{n-1}$ is the minimal positive imaginary root. Note that $\underline{\theta}_{d}^{(n)}$ is $Q \times \mathbb{Z}$-graded, and it is easy to see that $\underline{\theta}_{d}^{(n)}$ is surjective for $d \neq \sqrt{1}$. Therefore, it suffices to prove

$$
\operatorname{dim}\left(\ddot{\ddot{u}}_{d}^{(n)}\right)_{(\alpha ; k)} \leq \operatorname{dim}\left(\mathfrak{d}_{d^{n}}^{(n), 0}\right)_{(\alpha ; k)}
$$

for any $\alpha \in Q, k \in \mathbb{Z}$. Note that

\operatorname{dim}\left(\mathfrak{d}_{d^{n}}^{(n), 0}\right)_{(\alpha ; k)}=\left\{\begin{array}{ll}
0 & \text { if } \alpha \text { is nonzero and is not a root of } \widehat{\mathfrak{s l}}_{n} \\
1 & \text { if } \alpha \text { is a real root of } \widehat{\mathfrak{s l}}_{n} \\
n & \text { if } \alpha \in \mathbb{Z} \delta \text { and }(\alpha ; k) \neq(0 ; 0) \\
n-1 & \text { if }(\alpha ; k)=(0 ; 0)
\end{array} .\right.
$$

For $\alpha \notin \mathbb{Z} \delta$, the inequality ( $\dagger$ ) can be proved analogously to MRY, Proposition 3.2] by viewing $\ddot{u}_{d}^{(n)}$ as a module over the horizontal subalgebra generated by $\left\{\bar{e}_{i, 0}, \bar{f}_{i, 0}, \bar{h}_{i, 0}\right\}_{i \in[n]}$, which is isomorphic to $\widehat{\mathfrak{s l}}_{n}$. Hence, it remains to handle the case $\alpha=l \delta$. The case $l=0$ is obvious since $\left(\underline{\underline{u}}_{d}^{(n)}\right)_{(0 ; k)}$ is spanned by $\left\{\bar{h}_{i, k}\right\}_{i \in[n]}$. For the rest of the proof, we can assume $l \in \mathbb{N}$.
Remark 2.4. For $n>2$, this step is different from the argument in VV, Sect. 13], where the authors prove that $\ddot{u}_{d}^{(n)}$ is the universal central extension of $\mathfrak{d}_{d^{n}}^{(n), 0}$ by showing that the former does not admit non-split central extensions.

Let $\ddot{\ddot{u}}_{d}^{(n), \geq}$ be the subalgebra of $\underline{\ddot{u}}_{d}^{(n)}$ generated by $\left\{\bar{e}_{i, k}, \bar{h}_{i, k}\right\}_{i \in[n]}^{k \in \mathbb{Z}}$. It is isomorphic to an abstract Lie algebra generated by $\left\{\bar{e}_{i, k}, \bar{h}_{i, k}\right\}_{i \in[n]}^{k \in \mathbb{Z}}$ subject to the defining relations (u1,u2,u5,u7.1) with $\bar{c}=0$ and $\sum_{i} \bar{h}_{i, 0}=0$. It suffices to show that $\operatorname{dim}\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; k)} \leq n$ for any $l \in \mathbb{N}, k \in \mathbb{Z}$.

Introduce the length $N$ commutator: $\left[a_{1} ; a_{2} ; \ldots ; a_{N-1} ; a_{N}\right]_{N}:=\left[a_{1},\left[a_{2},\left[\ldots\left[a_{N-1}, a_{N}\right] \ldots\right]\right]\right]$. We say that this commutator starts from $a_{1}$. The degree $(l \delta ; k)$ subspace of $\underline{\ddot{u}}_{d}^{(n), \geq}$ is spanned by length $l n$ commutators $\left[\bar{e}_{i_{1}, k_{1}} ; \ldots ; \bar{e}_{i_{l n}, k_{l n}}\right]_{l n}$ such that $k_{1}+\ldots+k_{l n}=k$ and $\alpha_{i_{1}}+\ldots+\alpha_{i_{l n}}=l \delta$. Define $v_{a, b}^{(i, l)}:=\left[\bar{e}_{i, a} ; \bar{e}_{i+1,0} ; \ldots ; \bar{e}_{i-2,0} ; \bar{e}_{i-1, b}\right]_{l n}$. Note that $v_{a, b}^{(i, l)} \in\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; a+b)}$ and $v_{a, b}^{(i, l)} \neq 0$ since $\underline{\theta}_{d}^{(n)}\left(v_{a, b}^{(i, l)}\right) \neq 0$. Combining this with $\operatorname{dim}\left(\underline{\underline{\ddot{u}}}_{d}^{(n)}\right)_{\left(l \delta-\alpha_{i_{1}} ; k-k_{1}\right)} \leq 1$, we see that $\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; k)}$ is spanned by $\left\{v_{a, k-a}^{(i, l)}\right\}_{i \in[n]}^{a \in \mathbb{Z}}$. It remains to show that the rank of this system is at most $n$.

- Case $k=0$.

Define $v_{1}:=v_{0,0}^{(1, l)}, \ldots, v_{n-1}:=v_{0,0}^{(n-1, l)}, v_{n}:=v_{1,-1}^{(0, l)}$ and set $V(l ; 0):=\operatorname{span}_{\mathbb{C}}\left\langle v_{1}, \ldots, v_{n}\right\rangle$. We prove $v_{a,-a}^{(i, l)} \in V(l ; 0)$ for all $i \in[n], a \in \mathbb{Z}$ by induction on $|a|$. The case $a=0$ follows from

$$
v_{0,0}^{(0, l)}+v_{0,0}^{(1, l)}+\ldots+v_{0,0}^{(n-1, l)}=0
$$

[^0]which is obvious once the horizontal subalgebra of $\underline{\ddot{u}}_{d}^{(n)}$ is identified with $\mathfrak{s l}_{n}\left[Z, Z^{-1}\right]$.
To proceed further, we need the following technical result based on non-degeneracy of the matrices $\left(a_{i, j} d^{k m_{i, j}}\right)_{i \in[n]}^{j \in[n]}($ for $n>2)$ and $\left(2 \delta_{i, j}-\left(d^{k}+d^{-k}\right) \delta_{i, j+1}\right)_{i \in[2]}^{j \in[2]}$ for any $d \neq \sqrt{1}, k \neq 0$.
Lemma 2.5. For any fixed $i \in[n], k \neq 0$, there exists an element $\bar{h}_{i, k}^{\prime} \in \operatorname{span}_{\mathbb{C}}\left\langle\bar{h}_{0, k}, \ldots, \bar{h}_{n-1, k}\right\rangle$ such that $\left[\bar{h}_{i, k}^{\prime}, \bar{e}_{j, l}\right]=\delta_{i, j} \bar{e}_{j, l+k}$ for all $j \in[n], l \in \mathbb{Z}$.

First, we prove $v_{-1,1}^{(i, l)} \in V(l ; 0)$. Applying $\operatorname{ad}\left(\bar{h}_{i,-1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{0,1}^{\prime}\right)$ to the equality ( $\nabla$, we get a sum of $l^{2} n$ length $l n$ commutators being zero. Among those, $l^{2} n-l+\delta_{i, 0}$ belong to $V(l ; 0)$ as they start either from $\bar{e}_{i^{\prime}, 0}\left(i^{\prime} \in[n]\right)$ or $\bar{e}_{0,1}$. The remaining $l-\delta_{i, 0}$ commutators start from $\bar{e}_{i,-1}$ and therefore are multiples of $v_{-1,1}^{(i, l)}$. It remains to show that the sum of these $l-\delta_{i, 0}$ terms is nonzero. For the latter, it suffices to verify that the image of this sum under $\underline{\theta}_{d}^{(n)}$ is nonzero, which is a straightforward computation based on the assumption $d \neq \sqrt{1}$. To prove $v_{1,-1}^{(i, l)} \in V(l ; 0)$, we apply $\operatorname{ad}\left(\bar{h}_{i, 1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+1,-1}^{\prime}\right)$ to $\boxed{\nabla}$ and follow the same arguments.

To perform the inductive step, we assume that $v_{a,-a}^{(i, l)} \in V(l ; 0)$ for all $i \in[n],|a| \leq N$ and we shall prove $v_{ \pm(N+1), \mp(N+1)}^{(i, l)} \in V(l ; 0)$. Applying $\operatorname{ad}\left(\bar{h}_{i, \pm(N+1)}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+2, \mp 1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+1, \mp N}^{\prime}\right)$ to $\boxtimes$, we get a sum of $l^{3} n$ length $l n$ commutators being zero. By the induction hypothesis, all of them, except for those starting from $\bar{e}_{i, \pm(N+1)}$, belong to $V(l ; 0)$. The remaining $l\left(l-\delta_{n, 2}\right)$ terms are multiples of $v_{ \pm(N+1), \mp(N+1)}^{(i, l)}$. For $(n, l) \neq(2,1)$, it is easy to see that the sum of their images under $\underline{\theta}_{d}^{(n)}$ is nonzero, implying $v_{ \pm(N+1), \mp(N+1)}^{(i, l)} \in V(l ; 0)$. In the remaining case $(n, l)=(2,1)$, the inclusion $v_{ \pm(N+1), \mp(N+1)}^{(i, l)} \in V(l ; 0)$ follows from the relation (u2).

This completes our induction step. Hence, $\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; 0)}=V(l ; 0) \Rightarrow \operatorname{dim}\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; 0)} \leq n$.

- Case $0<k<l$.

Define $v_{1}:=v_{0, k}^{(1, l)}, \ldots, v_{n-1}:=v_{0, k}^{(n-1, l)}, v_{n}:=v_{0, k}^{(0, l)}$ and set $V(l ; k):=\operatorname{span}_{\mathbb{C}}\left\langle v_{1}, \ldots, v_{n}\right\rangle$. We claim that $v_{a, k-a}^{(i, l)} \in V(l ; k)$ for any $i \in[n], a \in \mathbb{Z}$. We will prove this in three steps. Step 1: Proof of $v_{k, 0}^{(i, l)} \in V(l ; k)$ for any $i \in[n]$.

Applying $\operatorname{ad}\left(\bar{h}_{i, k}^{\prime}\right)$ to the equality (囚), we immediately get $v_{k, 0}^{(i, l)} \in V(l ; k)$.
Step 2: Proof of $v_{a, k-a}^{(i, l)} \in V(l ; k)$ for any $i \in[n], 0<a<k$.
It is known that any degree $k$ symmetric polynomial in $\left\{x_{j}\right\}_{j=1}^{l}$ is a polynomial in $\left\{\sum_{j} x_{j}^{r}\right\}_{r=1}^{k}$. Choose $P_{k, l}$ such that $\operatorname{Sym}\left(x_{1} x_{2} \cdots x_{k}\right)=P_{k, l}\left(\sum_{j} x_{j}, \ldots, \sum_{j} x_{j}^{k}\right)$. Define $L_{i ; k, l} \in \operatorname{End}\left(\ddot{\ddot{u}}_{d}^{(n), \geq}\right)$ via $L_{i ; k, l}=P_{k, l}\left(\operatorname{ad}\left(\bar{h}_{i, 1}^{\prime}\right), \ldots, \operatorname{ad}\left(\bar{h}_{i, k}^{\prime}\right)\right)$. Applying $L_{i ; k, l}$ to the equality ( $\Delta$, we get a sum of $\binom{l}{k} \cdot n$ length $l n$ commutators being zero. Each of these terms starts either from $\bar{e}_{i^{\prime}, 0}\left(i^{\prime} \in[n]\right)$ or $\bar{e}_{i, 1}$. In the former case the commutator belongs to $V(l ; k)$, while in the latter case the commutator is a multiple of $v_{1, k-1}^{(i, l)}$. There are $\binom{l-1}{k-1}$ terms starting from $\bar{e}_{i, 1}$ and the sum of their images under $\underline{\theta}_{d}^{(n)}$ is nonzero. Therefore, $v_{1, k-1}^{(i, l)} \in V(l ; k)$.

Applying the same arguments to the symmetric function $\operatorname{Sym}\left(x_{1}^{a} x_{2} \cdots x_{k-a+1}\right)$, we analogously get $v_{a, k-a}^{(i, l)} \in V(l ; k)$ for any $i \in[n], 0<a<k$.
Step 3: Proof of $v_{a, k-a}^{(i, l)} \in V(l ; k)$ for any $i \in[n]$ and $a \notin\{0,1, \ldots, k\}$.
We prove $v_{-N, k+N}^{(i, l)}, v_{k+N,-N}^{(i, l)} \in V(l ; k)$ for all $i \in[n], N \in \mathbb{Z}_{+}$by induction on $N$. The case $N=0$ is clear. Assume $v_{a, k-a}^{(i, l)} \in V(l ; k)$ for any $i \in[n],-N \leq a \leq k+N$. Applying $\operatorname{ad}\left(\bar{h}_{i,-N-1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+2,1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+1, k+N}^{\prime}\right)$ to \|, we get a sum of $l^{3} n$ length $l n$ commutators being zero. Each of these terms either belongs to $V(l ; k)$ by the induction hypothesis or is a multiple
of $v_{-N-1, k+N+1}^{(i, l)}$. There are $l\left(l-\delta_{n, 2}\right)$ summands of the latter form and the sum of their images under $\underline{\theta}_{d}^{(n)}$ is nonzero. This implies $v_{-N-1, k+N+1}^{(i, l)} \in V(l ; k)$.

To prove $v_{k+N+1,-N-1}^{(i, l)} \in V(l ; k)$, we apply $\operatorname{ad}\left(\bar{h}_{i, k+N+1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+2,-1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i+1,-N}^{\prime}\right)$ to 囚 and follow the same arguments.

- Case of an arbitrary $k$.

It is clear that $L_{i ; l, l}$ induces an isomorphism $\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{\left(l \delta ; k^{\prime}\right)} \xrightarrow{\sim}\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{\left(l \delta ; k^{\prime}+l\right)}$ for any $k^{\prime} \in \mathbb{Z}$. In particular, $\operatorname{dim}\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; k)}=\operatorname{dim}\left(\underline{\ddot{u}}_{d}^{(n), \geq}\right)_{(l \delta ; k \bmod l)} \leq n$, due to the previous two cases.

### 2.3. Proof of Theorem 2.2.

It is straightforward to see that the assignment from Theorem 2.2 preserves all the defining relations (y1-y6), hence, it provides a Lie algebra homomorphism $\vartheta_{\beta}^{(n)}: \ddot{y}_{\beta}^{(n)} \rightarrow \overline{\mathfrak{D}}_{n \beta}^{(n)}$. We also consider the induced homomorphism $\underline{\vartheta}_{\beta}^{(n)}: \underline{\ddot{y}}_{\beta}^{(n)} \rightarrow \mathfrak{D}_{n \beta}^{(n)}$, where $\underline{\ddot{y}}_{\beta}^{(n)}:=\ddot{y}_{\beta}^{(n)} /\left(\sum_{i} \bar{\xi}_{i, 0}\right)$ is a central quotient of $\ddot{y}_{\beta}^{(n)}$. Clearly, it suffices to show that $\underline{\vartheta}_{\beta}^{(n)}$ is an isomorphism.

The Lie algebra $\underline{\ddot{y}}_{\beta}^{(n)}$ is $Q$-graded via $\operatorname{deg}_{1}\left(\bar{x}_{i, r}^{ \pm}\right)= \pm \alpha_{i}, \operatorname{deg}_{1}\left(\bar{\xi}_{i, r}\right)=0$ and $\mathbb{Z}_{+}$-filtered as a quotient of the free Lie algebra on $\left\{\bar{x}_{i, r}^{ \pm}, \bar{\xi}_{i, r}\right\}_{i \in[n]}^{r \in \mathbb{Z}_{+}}$graded via $\operatorname{deg}_{2}\left(\bar{x}_{i, r}^{ \pm}\right)=r, \operatorname{deg}_{2}\left(\bar{\xi}_{i, r}\right)=r$. The Lie algebra $\mathfrak{D}_{n \beta}^{(n)}$ is also $Q$-graded via $\operatorname{deg}_{1}\left(E_{i, j} \otimes \partial^{r} x^{l}\right)=l \delta+\left(\alpha_{1}+\ldots+\alpha_{j-1}\right)-\left(\alpha_{1}+\ldots+\alpha_{i-1}\right)$ and $\mathbb{Z}_{+}$-filtered with the filtration $\leq k$ subspace consisting of the finite sums $\sum_{0 \leq i \leq k}^{j \in \mathbb{Z}} A_{i, j} \partial^{i} x^{j}$, where $A_{i, j} \in \mathbb{M}_{n}$ and $\operatorname{tr}\left(A_{k, j}\right)=0$ for any $j \in \mathbb{Z}$. Let $\left(\underline{\ddot{y}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k)}$ and $\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k)}$ denote the subspaces of $\ddot{\ddot{y}}_{\beta}^{(n)}$ and $\mathfrak{D}_{n \beta}^{(n)}$, respectively, consisting of the degree $\alpha$ and filtration $\leq k$ elements.

Note that $\underline{\vartheta}_{\beta}^{(n)}\left(\left(\ddot{\ddot{y}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k)}\right) \subset\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k)}$ for any $\alpha \in Q, k \in \mathbb{Z}_{+}$. Hence, we get linear maps $\underline{\vartheta}_{\beta ; \alpha, k}^{(n)}:\left(\underline{\ddot{y}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k)} /\left(\underline{\ddot{y}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k-1)} \rightarrow\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k)} /\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k-1)}$. We claim that all the maps $\underline{\vartheta}_{\beta ; \alpha, k}^{(n)}$ are isomorphisms. To prove this, it suffices to show that $\underline{\vartheta}_{\beta ; \alpha, k}^{(n)}$ is surjective and

$$
\operatorname{dim}\left(\ddot{\ddot{q}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k)}-\operatorname{dim}\left(\ddot{\underline{y}}_{\beta}^{(n)}\right)_{(\alpha ; \leq k-1)} \leq \operatorname{dim}\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k)}-\operatorname{dim}\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k-1)}
$$

for any $\alpha \in Q, k \in \mathbb{Z}_{+}$. The right-hand side of $(\ddagger)$ can be simplified as follows:

$$
\operatorname{dim}\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k)}-\operatorname{dim}\left(\mathfrak{D}_{n \beta}^{(n)}\right)_{(\alpha ; \leq k-1)}= \begin{cases}0 & \text { if } \alpha \text { is nonzero and is not a root of } \widehat{\mathfrak{s l}}_{n} \\ 1 & \text { if } \alpha \text { is a real root of } \widehat{\mathfrak{s l}}_{n} \\ n-\delta_{k, 0} & \text { if } \alpha \text { is an imaginary root or zero }\end{cases}
$$

For $\alpha \notin \mathbb{Z} \delta$, the inequality $(\ddagger)$ and the surjectivity of $\underline{\vartheta}_{\beta ; \alpha, k}^{(n)}$ can be deduced in the same way as $(\dagger)$. Hence, it remains to handle the case $\alpha=l \delta$. The $l=0$ case is obvious since the degree 0 subspace of $\ddot{\ddot{y}}_{\beta}^{(n)}$ is spanned by $\bar{\xi}_{i, r}$. For the rest of the proof, we can assume $l \in \mathbb{N}$.

Let $\ddot{\underline{y}}_{\beta}^{(n), \geq}$ be the subalgebra of $\underline{\ddot{y}}_{\beta}^{(n)}$ generated by $\left\{\bar{x}_{i, r}^{+}, \bar{\xi}_{i, r}\right\}_{i \in[n]}^{r \in \mathbb{Z}_{+}}$. It is isomorphic to an abstract Lie algebra generated by $\left\{\bar{x}_{i, r}^{+}, \bar{\xi}_{i, r}\right\}_{i \in[n]}^{r \in \mathbb{Z}_{+}}$subject to the defining relations (y1,y3,y4,y5,y6) and $\sum_{i} \bar{\xi}_{i, 0}=0$. It suffices to show that $\operatorname{dim}\left(\underline{\ddot{y}}_{\beta}^{(n), \geq}\right)_{(l \delta ; \leq k)}-\operatorname{dim}\left(\ddot{\ddot{y}}_{\beta}^{(n), \geq}\right)_{(l \delta ; \leq k-1)} \leq n-\delta_{k, 0}$ and $\underline{\vartheta}_{\beta ; l \delta, k}^{(n)}$ is surjective for any $l \in \mathbb{N}, k \in \mathbb{Z}_{+}$.

## Case $n=2$.

The degree $l \delta$ subspace of $\underline{\ddot{g}}^{(2), \geq}$ is spanned by all length $2 l$ commutators $\left[\bar{x}_{i_{1}, k_{1}}^{+} ; \ldots ; \bar{x}_{i_{2 l}, k_{2 l}}^{+}\right]_{2 l}$ such that $\alpha_{i_{1}}+\ldots+\alpha_{i_{2 l}}=l \delta$. Define $w_{a, b}^{(i, l)}:=\left[\bar{x}_{i, a}^{+} ; \bar{x}_{i+1,0}^{+} ; \ldots ; \bar{x}_{i, 0}^{+} ; \bar{x}_{i+1, b}^{+}\right]_{2 l}$ for any $i \in[2]$
and $a, b \in \mathbb{Z}_{+}$. Due to our description of the degree $l \delta-\alpha_{i}$ subspace of ${\underset{\underline{y}}{\beta}}_{(2), \geq}$, we see that $\left(\underline{\ddot{g}}_{\beta}^{(2), \geq}\right)_{l \delta}$ is spanned by $\left\{w_{a, b}^{(i, l)}\right\}_{i \in[2]}^{a, b \in \mathbb{Z}_{+}}$. Moreover, $\left(\underline{\ddot{g}}_{\beta}^{(2), \geq}\right)_{(l \delta, \leq k)}$ is spanned by $\left\{w_{a, b}^{(i, l)}\right\}_{i \in[2]}^{a, b \in \mathbb{Z}_{+}}$ with $a+b \leq k$. Therefore, the inequality $\operatorname{dim}\left(\underline{\ddot{q}}_{\beta}^{(2), \geq}\right)_{(l \delta ; \leq k)}-\operatorname{dim}\left(\underline{\ddot{g}}_{\beta}^{(2), \geq}\right)_{(l \delta ; \leq k-1)} \leq 2-\delta_{k, 0}$ and the surjectivity of $\underline{\vartheta}_{\beta ; l \delta, k}^{(2)}$ follow from our next result:

Proposition 2.6. Define $W(l ; N):=\operatorname{span}_{\mathbb{C}}\left\langle w_{0, M}^{(i, l)}\right\rangle_{i \in[2]}^{0 \leq M \leq N}$ for $l \in \mathbb{N}, N \in \mathbb{Z}_{+}$.
(a) We have $w_{a, b}^{(i, l)} \in W(l ; a+b)$ for any $i \in[2], l \in \mathbb{N}, a, b \in \mathbb{Z}_{+}$.
(b) The images of $\left\{\underline{\vartheta}_{\beta}^{(2)}\left(w_{0, N}^{(i, l)}\right)\right\}_{i \in[2]}$ in the quotient space $\left(\mathfrak{D}_{2 \beta}^{(2)}\right)_{(l \delta ; \leq N)} /\left(\mathfrak{D}_{2 \beta}^{(2)}\right)_{(l \delta ; \leq N-1)}$ are linearly independent for any $l, N \in \mathbb{N}$.

Proof of Proposition 2.6.
(a) Our proof is based on the following simple equalities:

$$
\begin{equation*}
\left[H_{3}, \bar{x}_{i, r}^{+}\right]=\bar{x}_{i, r+1}^{+},\left[H_{4}, \bar{x}_{i, r}^{+}\right]=\bar{x}_{i, r+2}^{+} \tag{2}
\end{equation*}
$$

where $H_{3}:=\frac{-1}{6 \beta^{2}} \sum_{i \in[2]} \bar{\xi}_{i, 3}, H_{4}:=\frac{-1}{12 \beta^{2}} \sum_{i \in[2]} \bar{\xi}_{i, 4}+\frac{1}{12} \sum_{i \in[2]} \bar{\xi}_{i, 2}$.

- Proof of $w_{1, b}^{(i, l)} \in W(l ; 1+b)$.

We prove this by induction on $b$. Applying $\operatorname{ad}\left(H_{3}\right)$ or $\operatorname{ad}\left(\frac{1}{2} \bar{\xi}_{i, 1}\right)$ to (11), we get $w_{1,0}^{(0, l)}+w_{1,0}^{(1, l)} \in$ $W(l ; 1)$ and $w_{1,0}^{(i, l)}-w_{1,0}^{(i+1, l)} \in W(l ; 1)$, respectively. Hence, $w_{1,0}^{(i, l)} \in W(l ; 1)$, which is the basis of induction. To perform the inductive step, we assume $w_{1, b}^{(i, l)} \in W(l ; 1+b)$ for any $0 \leq b \leq M$. In particular, $w_{1, M}^{(i, l)}=\sum_{j \in[2]}^{N \leq M+1} c_{j, N} w_{0, N}^{(j, l)}$ for some $c_{j, N} \in \mathbb{C}$. Applying $\underline{\vartheta}_{\beta}^{(2)}$ to this equality, we find $c_{i, M+1}=\frac{M+1-l}{M+1}, c_{i+1, M+1}=\frac{-l}{M+1}$. Hence $w_{1, M}^{(i, l)}-\frac{M+1-l}{M+1} w_{0, M+1}^{(i, l)}+\frac{l}{M+1} w_{0, M+1}^{(i+1, l)} \in W(l ; M)$. Applying $\operatorname{ad}\left(H_{3}+\frac{1}{2} \bar{\xi}_{i+1,1}\right)$ to this inclusion, we get $l w_{1, M+1}^{(i, l)}+\frac{l}{M+1} w_{1, M+1}^{(i+1, l)} \in W(l ; M+2)$. For $M>0$, this yields $w_{1, M+1}^{(i, l)} \in W(l ; M+2)$ as $w_{1, M+1}^{(i, l)} \in \operatorname{span}_{\mathbb{C}}\left\langle l w_{1, M+1}^{(j, l)}+\frac{l}{M+1} w_{1, M+1}^{(j+1, l)}\right\rangle_{j \in[2]}$.

It remains to treat separately the case $M=0$. We can assume $l>1$ as the case $l=1$ is simple. Applying $\operatorname{ad}\left(H_{3}+\frac{1}{2} \bar{\xi}_{i, 1}\right)$ to the inclusion $w_{1,0}^{(i, l)}+(l-1) w_{0,1}^{(i, l)}+l w_{0,1}^{(i+1, l)} \in W(l ; 0)$, we get $2(l-1) w_{1,1}^{(i, l)}+w_{2,0}^{(i, l)} \in W(l ; 2)$. On the other hand, applying ad $\left(H_{4}+\frac{1}{2} \bar{\xi}_{i, 2}\right)$ to (1), we find $w_{2,0}^{(i, l)} \in W(l ; 2)$. This implies $w_{1,1}^{(i, l)} \in W(l ; 2)$.

- Proof of $w_{a, b}^{(i, l)} \in W(l ; a+b)$ for $a>1$.

We prove this by induction on $a$. The base cases of induction $a=0,1$ have been already treated. To perform the inductive step, we assume $w_{a, b}^{(i, l)} \in W(l ; a+b)$ for all $0 \leq a \leq M$ and $b \in \mathbb{Z}_{+}$. In particular, $w_{M, b}^{(i, l)}=\sum_{j \in[2]}^{N \leq M+b} d_{j, N} w_{0, N}^{(j, l)}$ for some $d_{j, N} \in \mathbb{C}$. Applying ad $\left(H_{3}\right)$ to this equality and using the induction hypothesis, we immediately get $w_{M+1, b}^{(i, l)} \in W(l ; M+b+1)$.
(b) Straightforward computations yield $\underline{\vartheta}_{\beta}^{(2)}\left(w_{0, N}^{(1, l)}\right)=2^{N-1}\left(E_{1,1}-E_{2,2}\right) \otimes \partial^{N} x^{l}+$ l.o.t, $\underline{\vartheta}_{\beta}^{(2)}\left(w_{0, N}^{(0, l)}+w_{0, N}^{(1, l)}\right)=-2^{l-1} N \beta \cdot\left(E_{1,1}+E_{2,2}\right) \otimes \partial^{N-1} x^{l}+$ l.o.t., where l.o.t. denote summands with lower power of $\partial$. The result follows.

This completes our proof of Theorem 2.2 for $n=2$.

## Case $n>2$.

The proof for $n>2$ is completely analogous and crucially uses the same equalities (1) and (2); we leave details to the interested reader.

## 3. Consequences

### 3.1. Classical limits of the vertical and horizontal quantum affine $\mathfrak{g l}_{n}$.

For $n \geq 2$, the algebra $\mathcal{U}_{q, d}^{(n)}$ contains two subalgebras $\dot{U}_{q}^{v}, \dot{U}_{q}^{h}$ isomorphic to the quantum affine $U_{q}\left(\widehat{\mathfrak{s}} \mathbf{l}_{n}\right)$. Here $\dot{U}_{q}^{v}$ is generated by $\left\{e_{i, k}, f_{i, k}, h_{i, k}, c\right\}_{i \in[n] \times}^{k \in \mathbb{Z}}$, while $\dot{U}_{q}^{h}$ is generated by $\left\{e_{i, 0}, f_{i, 0}, h_{i, 0}\right\}_{i \in[n]}$. The following result is obvious.
Lemma 3.1. For $d \neq \sqrt{1}$, the isomorphism $\theta_{d}^{(n)}$ identifies the $q \rightarrow 1$ limits of the subalgebras $\dot{U}_{q}^{v}$ and $\dot{U}_{q}^{h}$ with the universal enveloping algebras of $\mathfrak{s l}_{n}\left[D, D^{-1}\right] \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(2)}$ and $\mathfrak{s l}_{n}\left[Z, Z^{-1}\right] \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(1)}$, respectively.

According to [FJMM], the algebra $\mathcal{U}_{q, d}^{(n)}$ also contains two Heisenberg subalgebras $\mathfrak{h}^{v}$ and $\mathfrak{h}^{h}$, which commute with $\dot{U}_{q}^{v}$ and $\dot{U}_{q}^{h}$, respectively. This yields two copies of the quantum affine $U_{q}\left(\widehat{\mathfrak{g}}_{n}\right)$ inside $\mathcal{U}_{q, d}^{(n)}$, which will be denoted by $\dot{U}_{q}^{v,{ }^{\prime}}$ and $\dot{U}_{q}^{h,{ }^{\prime}}$, respectively.

Lemma 3.2. For $d \neq \sqrt{1}$, the isomorphism $\theta_{d}^{(n)}$ identifies the $q \rightarrow 1$ limits of the subalgebras $\dot{U}_{q}^{v,{ }^{\prime}}$ and $\dot{U}_{q}^{h, '}$ with the universal enveloping algebras of $\mathfrak{g l}_{n}\left[D, D^{-1}\right]^{0} \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(2)}$ and $\mathfrak{g l}_{n}\left[Z, Z^{-1}\right]^{0} \oplus$ $\mathbb{C} \cdot c_{\mathfrak{d}}^{(1)}$, where $\mathfrak{g l}\left[D, D^{-1}\right]^{0}:=\mathfrak{s l}_{n} \otimes 1 \oplus \underset{k \neq 0}{\bigoplus} \mathfrak{g l}_{n} \otimes D^{k}$ and $\mathfrak{g l}\left[Z, Z^{-1}\right]^{0}:=\mathfrak{s l}_{n} \otimes 1 \oplus \underset{k \neq 0}{\bigoplus} \mathfrak{g l}_{n} \otimes Z^{k}$.

## Proof of Lemma 3.2.

(i) First, we recall the construction of $\mathfrak{h}^{v}$ from FJMM, Sect. 2.2]. For any $k \neq 0$ and $i, j \in$ $[n]$, define the constants $b_{n}(i, j ; k):=\left\{\begin{array}{ll}d^{-k m_{i, j}} \frac{q^{k a_{i, j}-q^{-k a_{i, j}}}}{k\left(q-q^{-1}\right)} & \text { if } n>2 \\ \delta_{i, j} \cdot \frac{q^{2 k}-q^{-2 k}}{k\left(q-q^{-1}\right)}-\delta_{i, j+1} \cdot\left(d^{k}+d^{-k}\right) \frac{q^{k}-q^{-k}}{k\left(q-q^{-1}\right)} & \text { if } n=2\end{array}\right.$, so that their $q \rightarrow 1$ limits are equal to $\bar{b}_{n}(i, j ; k)=\left\{\begin{array}{ll}a_{i, j} d^{-k m_{i, j}} & \text { if } n>2 \\ 2 \delta_{i, j}-\left(d^{k}+d^{-k}\right) \delta_{i, j+1} & \text { if } n=2\end{array}\right.$. For any fixed $k \neq 0$, let $\left\{c_{i, k}\right\}_{i \in[n]}$ be a unique solution of the system $\sum_{i \in[n]} b_{n}(i, j ; k) c_{i, k}=0$ for all $j \in[n]^{\times}$with $c_{0, k}=1$. By construction, the subalgebra $\mathfrak{h}^{v}$ is generated by $q^{c / 2}$ and the elements $\left\{h_{k}^{v}:=\sum_{i \in[n]} c_{i, k} h_{i, k}\right\}_{k \neq 0}$. The image of the $q \rightarrow 1$ limit of $h_{k}^{v}$ under $\theta_{d}^{(n)}$ equals

$$
H_{k}^{v}=\left(\bar{c}_{0, k}\left(E_{n, n}-d^{n k} E_{1,1}\right)+\sum_{i=1}^{n-1} \bar{c}_{i, k} d^{(n-i) k}\left(E_{i, i}-E_{i+1, i+1}\right)\right) \otimes D^{k}
$$

where the constants $\left\{\bar{c}_{i, k}\right\}$ satisfy $\sum_{i \in[n]} \bar{b}_{n}(i, j ; k) \bar{c}_{i, k}=0$ for all $j \in[n]^{\times}$and $\bar{c}_{0, k}=1$. Hence, $H_{k}^{v}=\frac{1-d^{n k}}{n} \cdot I_{n} \otimes D^{k}$ with $I_{n}=\sum_{j=1}^{n} E_{j, j}$. It remains to notice that the Lie subalgebra of $\overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$ generated by $\mathfrak{s l}_{n}\left[D, D^{-1}\right] \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(2)}$ and $\left\{I_{n} \otimes D^{k}\right\}_{k \neq 0}$ is exactly $\mathfrak{g l}_{n}\left[D, D^{-1}\right]^{0} \oplus \mathbb{C} \cdot c_{\mathfrak{d}}^{(2)}$.
(ii) According to FJMM, $\dot{U}_{q}^{h, '}$ is a preimage of $\dot{U}_{q}^{v, \prime}$ under the Miki's automorphism $\varpi$. Combining (i) with Lemma 3.4 below, we get the description of $\theta_{d}^{(n)}\left(q \rightarrow 1\right.$ limit of $\left.\dot{U}_{q}^{h,{ }^{\prime}}\right)$.

### 3.2. Classical limit of the Miki's automorphism.

The natural ' 90 degree rotation' automorphism of $\mathcal{U}_{q, d}^{(1)}$ (due to Burban-Schiffmann) admits a generalization to the case of $\mathcal{U}_{q, d}^{(n)}$ with $n \geq 2$ (due to Miki).

Theorem 3.3. [M] For $n \geq 2$, there exists an automorphism $\varpi$ of $\mathcal{U}_{q, d}^{(n)}$ such that

$$
\varpi\left(\dot{U}_{q}^{v}\right)=\dot{U}_{q}^{h}, \varpi\left(\dot{U}_{q}^{h}\right)=\dot{U}_{q}^{v}, \varpi(c)=-\sum_{i \in[n]} h_{i, 0}, \varpi\left(\sum_{i \in[n]} h_{i, 0}\right)=c .
$$

Our next result provides a description of the $q \rightarrow 1$ limit of $\varpi$, denoted by $\bar{\varpi}$, viewed as an automorphism of the universal enveloping algebra $U\left(\overline{\mathfrak{d}}_{d^{n}}^{(n), 0}\right)$.

Lemma 3.4. $\bar{\varpi}$ is induced by an automorphism of the Lie algebra $\overline{\mathfrak{d}}_{d^{n}}^{(n)}$ defined via

$$
c_{\mathfrak{d}}^{(1)} \mapsto c_{\mathfrak{d}}^{(2)}, c_{\mathfrak{d}}^{(2)} \mapsto-c_{\mathfrak{d}}^{(1)}, A \otimes D^{k} Z^{l} \mapsto d^{-n k}(-d)^{n l} A \otimes Z^{-k} D^{l} \forall A \in \mathbb{M}_{n}, k, l \in \mathbb{Z}
$$

Proof of Lemma 3.4 .
It is easy to see that the formulas $(\star)$ define a Lie algebra automorphism; we denote its restriction to $\overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$ by $\widetilde{\varpi}$. On the other hand, the action of $\varpi$ on the generators $\left\{e_{i, 0}, f_{i, 0}, h_{i, \pm 1}\right\}_{i \in[n]}$ was computed in T2, Proposition 1.4]. Taking the $q \rightarrow 1$ limit in these formulas, we get

$$
\begin{gathered}
\bar{\varpi}: E_{i, i+1} \otimes 1 \mapsto E_{i, i+1} \otimes 1, E_{i+1, i} \otimes 1 \mapsto E_{i+1, i} \otimes 1, \\
\bar{\varpi}: E_{n, 1} \otimes Z \mapsto(-d)^{n} E_{n, 1} \otimes D, E_{1, n} \otimes Z^{-1} \mapsto(-d)^{-n} E_{1, n} \otimes D^{-1}, \\
\bar{\varpi}:\left(E_{i, i}-E_{i+1, i+1}\right) \otimes D^{ \pm 1} \mapsto d^{\mp n}\left(E_{i, i}-E_{i+1, i+1}\right) \otimes Z^{\mp 1}
\end{gathered}
$$

for all $1 \leq i \leq n-1$. Therefore, images of the elements

$$
E_{i, i+1} \otimes 1, E_{i+1, i} \otimes 1, E_{n, 1} \otimes Z, E_{1, n} \otimes Z^{-1},\left(E_{i, i}-E_{i+1, i+1}\right) \otimes D^{ \pm 1}, c_{\mathfrak{d}}^{(1)}, c_{\mathfrak{d}}^{(2)}
$$

under $\bar{\varpi}$ and $\widetilde{\varpi}$ coincide. This completes our proof, since these elements generate $\overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$.

### 3.3. Classical limit of the commutative subalgebras $\mathcal{A}(\bar{s})$.

Let $\mathcal{U}_{q, d}^{(n),+}$ be the subalgebra of $\mathcal{U}_{q, d}^{(n)}$ generated by $\left\{e_{i, k}\right\}_{i \in[n]}^{\substack{k \in \mathbb{Z}}}$. In FT], we introduced certain 'large' commutative subalgebras $\mathcal{A}(\bar{s})$ of $\mathcal{U}_{q, d}^{(n),+}$ via the shuffle realization $\Psi: \mathcal{U}_{q, d}^{(n),+} \xrightarrow{\sim} S$. We refer the interested reader to [FT] for a definition of the shuffle algebra $S$ and its subalgebras $\mathcal{A}(\bar{s})$, where $\bar{s}=\left(s_{0}, s_{1}, \ldots, s_{n-1}\right) \in\left(\mathbb{C}^{\times}\right)^{[n]}$ satisfy $s_{0} s_{1} \cdots s_{n-1}=1$ and are generic. Let $\operatorname{diag}_{n} \subset \mathbb{M}_{n}$ be the subspace of diagonal matrices.
Proposition 3.5. For $d \neq \sqrt{1}$ and $a$ generic $\bar{s}=\left(s_{0}, \ldots, s_{n-1}\right)$ satisfying $s_{0} \cdots s_{n-1}=1$, the isomorphism $\theta_{d}^{(n)}$ identifies the $q \rightarrow 1$ limit of $\mathcal{A}(\bar{s})$ with the universal enveloping algebra of the commutative Lie subalgebra $\bigoplus_{k>0} \operatorname{diag}_{n} \otimes Z^{k}$ of $\overline{\mathfrak{d}}_{d^{n}}^{(n), 0}$.
Proof of Proposition 3.5.
According to the main result [FT, Theorem 3.3], the algebra $\mathcal{A}(\bar{s})$ is a polynomial algebra in the generators $\left\{F_{i, k}^{\prime}\right\}_{0 \leq i \leq n-1}^{k \in \mathbb{N}}$, where $F_{i, k}^{\prime}$ is the coefficient of $(-\mu)^{n-i}$ in $F_{k}^{\mu}(\bar{s})$ defined via

$$
F_{k}^{\mu}(\bar{s}):=\frac{\prod_{i \in[n]} \prod_{1 \leq j \neq j^{\prime} \leq k}\left(x_{i, j}-q^{-2} x_{i, j^{\prime}}\right) \cdot \prod_{i \in[n]}\left(s_{0} \cdots s_{i} \prod_{j=1}^{k} x_{i, j}-\mu \prod_{j=1}^{k} x_{i+1, j}\right)}{\prod_{i \in[n]} \prod_{1 \leq j, j^{\prime} \leq k}\left(x_{i, j}-x_{i+1, j^{\prime}}\right)} \in S_{k \delta}
$$

First, we compute the $q \rightarrow 1$ limit of $\mathcal{A}(\bar{s})_{\delta}$. Choose $\beta_{1} \in \mathbb{Z}$ such that the $q \rightarrow 1$ limit of $(q-1)^{\beta_{1}} \cdot F_{0,1}^{\prime}$ is well-defined and is non-zerd2. Define $F_{i, 1}:=(q-1)^{\beta_{1}} F_{i, 1}^{\prime}$ and let $\bar{F}_{i, 1}$ denote the $q \rightarrow 1$ limit of $F_{i, 1}$ (if it exists). According to [FT, Corollary 3.12], the element $F_{0,1}$ is a non-zero multiple of the first generator $h_{1}^{h}$ of the Heisenberg subalgebra $\mathfrak{h}^{h}$. Combining this with Lemmas 3.2 and 3.4, we see that $\theta_{d}^{(n)}\left(\bar{F}_{0,1}\right)=\mu_{1} \cdot I_{n} \otimes Z$ for some $\mu_{1} \in \mathbb{C}^{\times}$.

For $1 \leq i \leq n$, define $a_{i}:=s_{0} \cdots s_{i-1} \in \mathbb{C}^{\times}, A_{i}(d):=\sum_{j=1}^{n} d^{1-n \delta_{j, i}} E_{j, j} \in \mathbb{M}_{n}$, and let $e_{i}\left(y_{1}, \ldots, y_{n}\right)$ be the $i$ th elementary symmetric function in the variables $\left\{y_{j}\right\}_{j=1}^{n}$.
Lemma 3.6. (a) The limit $\bar{F}_{i, 1}$ is well-defined and $\theta_{d}^{(n)}\left(\bar{F}_{i, 1}\right)=\mu_{1} e_{i}\left(a_{1} A_{1}(d), \ldots, a_{n} A_{n}(d)\right) \otimes Z$. (b) The limits $\left\{\bar{F}_{i, 1}\right\}_{i=0}^{n-1}$ are linearly independent and $\left\{\theta_{d}^{(n)}\left(\bar{F}_{i, 1}\right)\right\}_{i=0}^{n-1}$ span $\operatorname{diag}_{n} \otimes Z$.

[^1]Proof of Lemma 3.6 .
(a) It suffices to show that the image of the $q \rightarrow 1$ limit of $\frac{x_{i-1,1}}{x_{i, 1}} F_{0,1}$ under $\theta_{d}^{(n)}$ equals $\mu_{1} A_{i}(d) \otimes Z$. Recall the elements $\bar{h}_{i, \pm 1}^{\prime} \in \operatorname{span}_{\mathbb{C}}\left\langle\bar{h}_{0, \pm 1}, \ldots, \bar{h}_{n-1, \pm 1}\right\rangle$ from Lemma 2.5 such that $\left[\bar{h}_{i, 1}^{\prime}, \bar{e}_{j, l}\right]=\delta_{i, j} \bar{e}_{j, l \pm 1}$ for any $j \in[n], l \in \mathbb{Z}$. Since $\Psi\left(e_{j, l}\right)=x_{j, 1}^{l}$, we see that the $q \rightarrow 1$ limit of $\frac{x_{i-1,1}}{x_{i, 1}} F_{0,1}$ equals $\operatorname{ad}\left(\bar{h}_{i-1,1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i,-1}^{\prime}\right)\left(\bar{F}_{0,1}\right)$. Combining the equality

$$
\theta_{d}^{(n)}\left(\bar{h}_{i, \pm 1}^{\prime}\right)=\left(\frac{d^{ \pm(2 n-i)}}{d^{ \pm n}-1}\left(E_{1,1}+\cdots+E_{i, i}\right)+\frac{d^{ \pm(n-i)}}{d^{ \pm n}-1}\left(E_{i+1, i+1}+\cdots+E_{n, n}\right)\right) \otimes D^{ \pm 1}
$$ with $\theta_{d}^{(n)}\left(\bar{F}_{0,1}\right)=\mu_{1} I_{n} \otimes Z$, we find $\theta_{d}^{(n)}\left(\operatorname{ad}\left(\bar{h}_{i-1,1}^{\prime}\right) \operatorname{ad}\left(\bar{h}_{i,-1}^{\prime}\right)\left(\bar{F}_{0,1}\right)\right)=\mu_{1} A_{i}(d) \otimes Z$ as claimed.

(b) Let $C(d)$ be an $n \times n$ matrix whose rows are the diagonals of $\left\{e_{i}\left(a_{1} A_{1}(d), \ldots, a_{n} A_{n}(d)\right)\right\}_{i=0}^{n-1}$. If $d \neq \sqrt[n]{1}$ and $a_{i} \neq a_{j}$ for $i \neq j$ (which is the case for generic $\bar{s}$ ), then $\operatorname{det}(C(d)) \neq 0$ due to the Vandermonde determinant. The result follows.

Let us generalize the above result to $k>1$. According to T2, Theorems 3.2, 3.5], we have

$$
\Psi\left(\exp \left(\sum_{r=1}^{\infty} a_{r}(d, q) \varpi\left(h_{0, r}^{\perp}\right) c^{-r}\right)\right)=\sum_{k=0}^{\infty}(q-1)^{k n} b_{k}(d, q) F_{0, k}^{\prime} c^{-k},
$$

where $c$ is a formal variable, the $q \rightarrow 1$ limits $\bar{a}_{r}(d)$ and $\bar{b}_{k}(d)$ of the constants $a_{r}(d, q)$ and $b_{k}(d, q)$ are nonzero for $d \neq 0, h_{0, r}^{\perp} \in \operatorname{span}_{\mathbb{C}}\left\langle h_{0,-r}, \ldots, h_{n-1,-r}\right\rangle$ are defined via $\varphi\left(h_{0, r}^{\perp}, h_{i, r}\right)=\delta_{i, 0}$ with the bilinear form $\varphi$ given by $\varphi\left(h_{i,-r}, h_{j, s}\right)=\delta_{r, s} \frac{b_{n}(i, j ;-r)}{q-q^{-1}}$. Following our proof of Lemma 3.2, we see that $h_{0, r}^{\perp}=(q-1) \lambda_{r}(d, q) h_{-r}^{v}$ and the $q \rightarrow 1$ limit of $\lambda_{r}(d, q)$ is nonzero. Combining this with Lemmas 3.2 and 3.4 we find $\theta_{d}^{(n)}\left(q \rightarrow 1\right.$ limit of $\left.(q-1)^{-1} \varpi\left(h_{0, r}^{\perp}\right)\right)=\bar{c}_{r}(d) \cdot I_{n} \otimes Z^{r}$, where $\bar{c}_{r}(d) \neq 0$ for $d \neq 0, \sqrt{1}$. Define $F_{i, k}:=(q-1)^{k n-1} F_{i, k}^{\prime}$ and let $\bar{F}_{i, k}$ denote the $q \rightarrow 1$ limit of $F_{i, k}$ (if it exists). We also set $\mu_{r}:=\bar{a}_{r}(d) \bar{c}_{r}(d) / \bar{b}_{r}(d) \in \mathbb{C}^{\times}$.

The above discussion implies that $\theta_{d}^{(n)}\left(\bar{F}_{0, k}\right)=\mu_{k} \cdot I_{n} \otimes Z^{k}$ for any $k \in \mathbb{N}$.
Lemma 3.7. The limit $\bar{F}_{i, k}$ is well-defined and $\theta_{d}^{(n)}\left(\bar{F}_{i, k}\right)=\mu_{k} e_{i}\left(a_{1} A_{1}\left(d^{k}\right), \ldots, a_{n} A_{n}\left(d^{k}\right)\right) \otimes Z^{k}$. Moreover, the elements $\left\{\theta_{d}^{(n)}\left(\bar{F}_{i, k}\right)\right\}_{i=0}^{n-1}$ are linearly independent and span $\operatorname{diag}_{n} \otimes Z^{k}$.
Proof of Lemma 3.7
To prove the first statement, it suffices to show

$$
\begin{equation*}
\theta_{d}^{(n)}\left(q \rightarrow 1 \text { limit of } \frac{\prod_{j=1}^{k} x_{i-1, j}}{\prod_{j=1}^{k} x_{i, j}} F_{0, k}\right)=\mu_{k} A_{i}\left(d^{k}\right) \otimes Z^{k} \text { for any } 1 \leq i \leq n \tag{3}
\end{equation*}
$$

Recall the elements $\bar{h}_{i, \pm k}^{\prime} \in \operatorname{span}_{\mathbb{C}}\left\langle\bar{h}_{0, \pm k}, \ldots, \bar{h}_{n-1, \pm k}\right\rangle$ from Lemma [2.5 such that $\left[\bar{h}_{i, \pm k}^{\prime}, \bar{e}_{j, l}\right]=$ $\delta_{i, j} \bar{e}_{j, l \pm k}$ for any $j \in[n], l \in \mathbb{Z}$ and the polynomials $P_{k, k}$ introduced in our proof of Theorem 2.1. Define $L_{i ; \pm k} \in \operatorname{End}\left(\ddot{u}_{d}^{(n), \geq}\right)$ via $L_{i ; \pm k}=P_{k, k}\left(\operatorname{ad}\left(\bar{h}_{i, \pm 1}^{\prime}\right), \ldots, \operatorname{ad}\left(\bar{h}_{i, \pm k}^{\prime}\right)\right)$. Then, the $q \rightarrow 1$ limit of $\prod_{j=1}^{k} \frac{x_{i-1, j}}{x_{i, j}} \cdot F_{0, k}$ equals $L_{i-1 ; k} L_{i ;-k}\left(\bar{F}_{0, k}\right)$. To derive (3), one needs to apply the formula

$$
\theta_{d}^{(n)}\left(\bar{h}_{i, \pm k}^{\prime}\right)=\left(\frac{d^{ \pm(2 n-i) k}}{d^{ \pm n k}-1}\left(E_{1,1}+\cdots+E_{i, i}\right)+\frac{d^{ \pm(n-i) k}}{d^{ \pm n k}-1}\left(E_{i+1, i+1}+\cdots+E_{n, n}\right)\right) \otimes D^{ \pm k}
$$

together with the identity $P_{k, k}\left(\frac{d^{k n}-1}{d^{n}-1}, \frac{d^{2 k n}-1}{d^{2 n}-1}, \cdots, \frac{d^{k^{2} n}-1}{d^{k n}-1}\right)=e_{k}\left(1, d^{n}, \ldots, d^{(k-1) n}\right)=d^{\frac{k(k-1) n}{2}}$.
The linear independence of $\theta_{d}^{(n)}\left(\bar{F}_{i, k}\right)$ is proved completely analogously to Lemma 3.6(b).
It remains to note that Proposition 3.5 follows from Lemma 3.7 by induction on $k$.
