# Categorification of Clifford algebra via geometric induction and restriction

## Introduction

In a book published in 1981 ([7]), Andrei Zelevinsky categorified an infinite-rank PSH-algebra in terms of representations of the collection of all $G L(n, \mathbb{F})$ where $\mathbb{F}$ is a finite field. He did this using a pair of adjoint functors, the parabolic induction and its adjoint.

We intend, in this paper, to apply the same set of ideas to the categorification of a infinite Clifford algebra acting on the Fock space of semi-infinite forms, in terms of representations of the collection of all classical supergroups $\operatorname{SOSP}(2 m+1,2 n)$, using the geometric induction functor and its adjoint called geometric restriction.

Let us start with the preliminary example of classical groups.
Let $\left(G_{n}\right)_{n \geq 1}$ be a family of complex classical Lie groups, $G_{n}$ of rank $n$, together with inclusions

G_{1} \subset G_{2} \subset \ldots \subset G_{n} \subset \ldots
$$

in such a way that $G_{n-1} \times \mathbb{C}^{*}$ is the reductive part of a maximal parabolic subgroup denoted $P_{n}$ of $G_{n}$, and we denote the maximal unipotent subgroup of $P_{n}$ by $U_{n}$. For instance, consider $G_{n}=G L(n, \mathbb{C})$. We use gothic letters for the corresponding Lie algebras. We denote $\mathcal{F}_{n}$ the category of finite-dimensional $G_{n}$-modules, it is a semi-simple category and we denote $\mathcal{K}_{n}$ its Grothendieck group.

We use the functors $\Gamma_{i}^{a}$ and $H_{b}^{j}$ defined as follows:

\end{gathered}

where $\mathbb{C}_{a}$ is the one-dimensional representation of $\mathbb{C}^{*}$ with character $a \in \mathbb{Z}$; we assume that $U_{n}$ acts trivially and $\mathcal{L}\left(\mathbb{C}_{a} \boxtimes M\right)^{*}$ is the induced vector bundle $G_{n} \times{ }_{P_{n+1}}$ $\left(\mathbb{C}_{a} \boxtimes M\right)^{*}$.

H_{b}^{j}: \mathcal{F}_{n} \rightarrow \mathcal{F}_{n-1} \\
H_{b}^{j}(M):=\operatorname{Hom}_{\mathbb{C}^{*}}\left(\mathbb{C}_{b+n}, H^{j}\left(\mathfrak{u}_{n}, M\right)\right)
\end{gathered}

At the level of Grothendieck groups we obtain linear maps

\gamma^{a}: \mathcal{K}_{n} \rightarrow \mathcal{K}_{n+1} \\
{[M] \mapsto \sum_{i}(-1)^{i}\left[H^{i}\left(G_{n+1} / P_{n+1}, \mathcal{L}\left(\mathbb{C}_{a+n} \boxtimes M\right)^{*}\right)^{*}\right],} \\
\eta_{b}: \mathcal{K}_{n} \rightarrow \mathcal{K}_{n-1}
\end{gathered}

[M] \mapsto \sum_{j}(-1)^{j}\left[\operatorname{Hom}_{\mathbb{C}^{*}}\left(\mathbb{C}_{b+n}, H^{j}\left(\mathfrak{u}_{n}, M\right)\right)\right]

We set $\mathcal{K}:=\oplus_{n} \mathcal{K}_{n}$ and extend those maps to $\mathcal{K}$. Then, applying Borel-Weil-Bott theorem, we obtain the following relations, for all $a$ and $b$ in $\mathbb{Z}$ :

\eta_{a} \eta_{b}+\eta_{b} \eta_{a}=0,  \tag{2}\\
\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}=\delta_{a, b} I d . \tag{3}
\end{gather*}

We recognise those relations as the ones of the infinite dimensional Clifford algebra C. Furthermore, we see $\mathcal{K}$ as an irreducible representation of $\mathbf{C}$ which is induced by the trivial representation of the subalgebra of $\mathbf{C}$ generated by $\left(\eta_{b}\right)_{b \in \mathbb{Z}}$.

This provides a categorification of the Clifford algebra $\mathbf{C}$ by the family of classical groups $\left(G_{n}\right)_{n \geq 1}$.

We follow the same scheme for the family of classical Lie supergroups $\operatorname{SOSP}(2 m+$ $1,2 n)$ when $m$ and $n$ vary, in this case we categorify the representation of the infinite Clifford algebra in the Fock space of semi-infinite forms. In the last section, we explain how our previous categorification work on orthosymplectic Lie superagebras ([3]) can be understood in this context.

We would also like to mention the work of Michael Ehrig and Catharina Stroppel [1], who used quantized symmetric pairs in order to refine our previous results on the category of finite dimensional modules over orthosymplectic Lie superalgebras and obtain a diagrammatic description of the endomorphism algebras of projective generators.

It would be very interesting now to construct a canonical basis in the Fock space of semi-infinite forms.

Finally, we would like to emphasize that what we do here can easily be done for all series of classical Lie supergroups, with minor changes only.

## 1. Basic setting

We work over the field of complex numbers in the category of $\mathbb{Z} / 2 \mathbb{Z}$-graded spaces. The reader should keep it in mind when we consider symmetric and exterior powers.

We denote by $\mathfrak{g}_{m, n}$ the Lie superalgebra $\mathfrak{o s p}(2 m+1,2 n)$ and

\mathfrak{g}_{\infty, \infty}=\underset{m, n \rightarrow \infty}{\lim } \mathfrak{g}_{m, n}
$$

Further more, we fix an embedding $\mathfrak{g}_{m, n} \subset \mathfrak{g}_{\infty, \infty}$.

We also fix a Cartan subalgebra $\mathfrak{h} \subset \mathfrak{g}_{\infty, \infty}$ and the standard basis $\left\{\varepsilon_{i}, \delta_{j}\right\}_{i, j \in \mathbb{Z}_{>0}}$. The roots of $\mathfrak{g}_{\infty, \infty}$ in this basis are:

\left( \pm \varepsilon_{i}\right), \quad\left( \pm \delta_{j}\right) \\
\left( \pm \varepsilon_{i} \pm \delta_{j}\right), \quad\left( \pm 2 \delta_{j}\right) \\
\left( \pm \varepsilon_{i} \pm \varepsilon_{j}\right), \quad\left( \pm \delta_{i} \pm \delta_{j}\right),
\end{gathered}
$$

where $i, j$ vary from 1 to $\infty$, and in the last line, $i \neq j$.
Then the roots of $\mathfrak{g}_{m, n}$ lie in the subspace generated by $\left(\varepsilon_{i}\right)_{1 \leq i \leq m}$ and $\left(\delta_{j}\right)_{1 \leq j \leq n}$.
We fix a Borel subalgebra $\mathfrak{b}_{0}$ of $\left(\mathfrak{g}_{\infty, \infty}\right)_{0}$ with the set of positive roots

\left\{\varepsilon_{i}, 2 \delta_{j},(i, j>0), \quad \varepsilon_{i} \pm \varepsilon_{j}, \delta_{i} \pm \delta_{j}(i>j>0)\right\}
$$

Inside $\mathfrak{g}_{m, n}$, we denote by $\mathfrak{p}_{\underline{m}, n}\left(\right.$ resp $\left.\mathfrak{p}_{m, \underline{n}}\right)$ the unique parabolic subalgebra containing $\mathfrak{b}_{0}$ with semi-simple part $\mathfrak{g}_{m-1, n}\left(\right.$ resp $\left.\mathfrak{g}_{m, n-1}\right)$.

We denote by $G_{m, n}$ the supergroup $\operatorname{SOSP}(2 m+1,2 n)$ and by $T_{m, n}$ the maximal torus of $G_{m, n}$ with Lie algebra $\mathfrak{h} \cap \mathfrak{g}_{m, n}$.

For fixed $m$ and $n$, we denote by $\mathcal{F}_{m, n}$ the category of finite dimensional $G_{m, n^{-}}$ modules and by $\mathcal{K}_{m, n}$ its Grothendieck group.

Let: $\mathcal{F}:=\oplus_{m, n} \mathcal{F}_{m, n}$ and $\mathcal{K}:=\oplus_{m, n} \mathcal{K}_{m, n}$.
Let $B$ be a Borel subgroup of $G_{m, n}$ with Lie superalgebra $\mathfrak{b}$ containing $\mathfrak{b}_{0} \cap \mathfrak{g}_{m, n}$ and let $\Delta_{1}^{+}$(resp. $\Delta_{0}^{+}$) be the set of odd (resp.) even positive roots of $\mathfrak{g}_{m, n}$. Set

\rho_{B}=\frac{1}{2} \sum_{\alpha \in \Delta_{0}^{+}} \alpha-\frac{1}{2} \sum_{\alpha \in \Delta_{1}^{+}} \alpha .
$$

Let $\Lambda_{m, n}$ be the set of weights $\lambda$ such that $\lambda-\rho_{B}$ is a character of $T_{m, n}$. Independently of the choice of $B$ we have

$$
\Lambda_{m, n}:=\left\{\lambda=a_{1} \varepsilon_{1}+\cdots+a_{m} \varepsilon_{m}+b_{1} \delta_{1}+\cdots+b_{n} \delta_{n} \mid a_{i}, b_{j} \in \frac{1}{2}+\mathbb{Z}\right\}
$$

We set

$$
\Lambda_{m, n}^{+}:=\left\{\lambda \in \Lambda_{m, n} \mid a_{i}, b_{j} \in \frac{1}{2}+\mathbb{N}, a_{1}<\cdots<a_{m}, b_{1}<\cdots<b_{n}\right\}
$$

Let $\nu$ be a character of $T_{m, n}$. We denote by $\mathcal{L}_{\nu}$ the corresponding line bundle over $G_{m, n} / B$.

Recall the definition of the Euler characteristic. For every $\lambda \in \Lambda_{m, n}$ we set

$$
\mathcal{E}(\lambda):=\left[\sum_{i \geq 0}(-1)^{i} H^{i}\left(G_{m, n} / B, \mathcal{L}_{\lambda-\rho_{B}}^{*}\right)^{*}\right] \in \mathcal{K}_{m, n}
$$

Recall also that the character of this virtual module is easy to compute, namely

$$
C h(\mathcal{E}(\lambda))=\frac{D_{0}}{D_{1}} \sum_{w \in W_{m, n}} \varepsilon(w) e^{w(\lambda)}
$$

where $W_{m, n}$ is the Weyl group of $S O(2 m+1) \times S P(2 n), D_{0}=\Pi_{\alpha \in \Delta_{0}^{+}}\left(e^{\alpha / 2}-e^{-\alpha / 2}\right)$, $D_{1}=\Pi_{\alpha \in \Delta_{1}^{+}}\left(e^{\alpha / 2}+e^{-\alpha / 2}\right)$.
(Remark: We avoided indexes $m$ and $n$ in this formula since one can easily recover them from the shape of $\lambda$ ).

Note that if we change our choice of $B$ containing $B_{0} \cap G_{m, n}$, the character of $\mathcal{E}(\lambda)$ doesn't change, thus the class in $\mathcal{K}_{m, n}$ remains the same, see 3].

For $w \in W_{m, n}$, notice that

$$
\begin{equation*}
\mathcal{E}(w(\lambda))=\varepsilon(w) \mathcal{E}(\lambda) . \tag{4}
\end{equation*}
$$

Proposition 1. (see [3]) The set

$$
\left\{\mathcal{E}(\lambda), \lambda \in \Lambda_{m, n}^{+}\right\}
$$

gives a linearly independant family in $\mathcal{K}_{m, n}$, and we denote by $\mathcal{K}(\mathcal{E})_{m, n}$ the subgroup generated by this family. We also set $\mathcal{K}(\mathcal{E}):=\oplus_{m, n} \mathcal{K}(\mathcal{E})_{m, n}$.

## 2. Fock space

Let $V$ be a countable dimensional vector space together with a basis $\left(v_{i}\right)_{i \in \frac{1}{2}+\mathbb{Z}}$ and similarly $W$ with a basis $\left(w_{i}\right)_{i \in \frac{1}{2}+\mathbb{Z}}$ with a non-degenerate pairing such that $\left(v_{i}\right)$ and $\left(w_{i}\right)$ are dual bases.

Let $C l(V \oplus W)$ be the Clifford algebra of $V \oplus W$, namely if we denote by $T(V \oplus W)$ the tensor algebra of $V \oplus W$,

\begin{gathered}
C l(V \oplus W)= \\
=T(V \oplus W) /\left(v \otimes v^{\prime}+v^{\prime} \otimes v, w \otimes w^{\prime}+w^{\prime} \otimes w, v \otimes w+w \otimes v-(v, w), v, v^{\prime} \in V, w, w^{\prime} \in W\right) .
\end{gathered}
$$

The Fock space of semi-infinite forms, $\mathbf{F}$, is the vector space generated by

$$
v_{i_{1}} \wedge \ldots \wedge v_{i_{k}} \wedge \ldots
$$

for $i_{1}>\ldots \ldots>i_{k}>\ldots$ such that, for $n$ large enough, $i_{n}=i_{n-1}-1$.
There is a natural linear action of $C l(V \oplus W)$ on $\mathbf{F}$ given by:

\forall v \in V, v \bullet v_{i_{1}} \wedge \ldots \wedge v_{i_{k}} \wedge v_{i_{k+1}} \ldots=v \wedge v_{i_{1}} \wedge \ldots \wedge v_{i_{k}} \wedge v_{i_{k+1}} \ldots \\
\forall w \in W, w \bullet v_{i_{1}} \wedge \ldots \wedge v_{i_{k}} \wedge v_{i_{k+1}} \ldots=\sum_{j}(-1)^{j-1}\left(w, v_{i_{j}}\right) v_{i_{1}} \wedge \ldots \wedge \hat{v}_{i_{j}} \wedge \ldots
\end{gathered}
$$

Define the vacuum vector in $\mathbf{F}$ as

$$
\left\lvert\,>:=v_{-\frac{1}{2}} \wedge v_{-\frac{3}{2}} \wedge \ldots\right.
$$

then, for $i<0, v_{i}$ acts on $\mid>$ by 0 as $w_{j}$ for $j>0$.
We can also see $\mathbf{F}$ as an induced module the following way. Denote by $\mathrm{Cl}^{+}(V \oplus W)$ the subalgebra generated by $\left\{v_{i}, i<0, w_{j}, j>0\right\}$, consider its trivial module and induce to the whole $C l(V \oplus W)$ : this gives another construction of $\mathbf{F}$.

Let $\lambda=\sum_{1 \leq i \leq m, 1 \leq j \leq n} a_{i} \varepsilon_{i}+b_{j} \delta_{j} \in \Lambda_{m, n}^{+}$. We define a $\mathbb{Z}$-linear map $f: \mathcal{K}(\mathcal{E}) \longrightarrow \mathbf{F}$ such that for any $\mathcal{E}(\lambda) \in \mathcal{K}(\mathcal{E})_{m, n}$ :

\mathcal{E}(\lambda) \mapsto v_{a_{m}} \wedge \ldots \wedge v_{a_{1}} \wedge \ldots \wedge \hat{v}_{-b_{1}} \wedge \ldots \wedge \hat{v}_{-b_{n}} \wedge \ldots
$$

## 3. Duality between geometric induction and restriction

In this section we will consider 3 different Grothendieck groups for $G_{m, n}$ namely $\mathcal{K}(P)_{m, n}$ generated by the indecomposable projective modules, $\mathcal{K}(\mathcal{E})_{m, n}$ which we already met and $\mathcal{K}(L)_{m, n}:=\mathcal{K}_{m, n}$ generated by the simple modules. After tensoring by the rational numbers $\mathbb{Q}, \mathcal{K}(P)_{m, n} \otimes \mathbb{Q}$ and $\mathcal{K}(\mathcal{E})_{m, n} \otimes \mathbb{Q}$ coincide (see [3]). We consider the natural pairing between $\mathcal{K}(P)_{m, n}$ and $\mathcal{K}(L)_{m, n},\langle[P],[L]\rangle:=\operatorname{dim} \operatorname{Hom}(P, L)$. The restriction of this pairing to $\mathcal{K}(P)_{m, n} \times \mathcal{K}(P)_{m, n}$ is symmetric (and therefore it is a scalar product): indeed $\operatorname{dim} \operatorname{Hom}\left(P_{1}, P_{2}\right)=\operatorname{dim} \operatorname{Hom}\left(P_{2}^{*}, P_{1}^{*}\right)$ and in this case projective modules happen to be self-dual (see [6]).

Proposition 2. Let us extend the scalar product from $\mathcal{K}(P)_{m, n}$ to $\mathcal{K}(P)_{m, n} \otimes \mathbb{Q}$. Then the set of $\mathcal{E}(\lambda)$, when $\lambda$ varies in $\Lambda_{m, n}^{+}$, form an orthonormal basis of $\mathcal{K}(P)_{m, n} \otimes$ $\mathbb{Q}$.
Proof. Let $L(\lambda)$ denote the simple module with highest weight $\lambda$ and $P(\lambda)$ denote its projective cover. Consider the decompositions

$$
[P(\lambda)]=\sum_{\mu} b_{\lambda, \mu} \mathcal{E}(\mu), \quad \mathcal{E}(\mu)=\sum_{\nu} a_{\mu, \nu}[L(\nu)] .
$$

By the weak BGG reciprocity, [3], we have $b_{\lambda, \mu}=a_{\mu, \lambda}$. Now, we write

$$
\mathcal{E}(\mu)=\sum_{\lambda} c_{\mu, \lambda}[P(\lambda)]
$$

Then, clearly, we have the following relation

$$
\sum_{\lambda} c_{\mu, \lambda} b_{\lambda, \nu}=\sum_{\lambda} c_{\mu, \lambda} a_{\nu, \lambda}=\delta_{\mu, \nu} .
$$

On the other hand,

$$
\langle[P(\lambda)],[L(\kappa)]\rangle=\delta_{\lambda, \kappa} .
$$

Therefore

$$
\langle\mathcal{E}(\mu), \mathcal{E}(\nu)\rangle=\sum_{\lambda, \kappa} c_{\mu, \lambda} a_{\nu, \kappa}\langle[P(\lambda)],[L(\kappa)]\rangle=\sum_{\lambda} c_{\mu, \lambda} a_{\nu, \lambda}=\delta_{\mu, \nu} .
$$

Let $G$ be a quasireductive algebraic supergroup, which is an algebraic supergroup with reductive even part (see [6] for information on their representation theory). Let $Q \subset G$ be a parabolic subgroup with quasireductive part $K$. Let $\mathfrak{g}, \mathfrak{q}, \mathfrak{k}$ denote the respective Lie superalgebras, and let $\mathfrak{r}$ denote the nil-radical of $\mathfrak{q}$. Consider the following derived functors $\Gamma_{i}: K-\bmod \longrightarrow G-\bmod$ and $H^{i}: G-\bmod \longrightarrow K-\bmod$ defined by

$$
\Gamma_{i}(M):=H^{i}\left(G / Q, \mathcal{L}\left(M^{*}\right)\right)^{*}, \quad H^{i}(N):=H^{i}(\mathfrak{r}, N)
$$

Here we denote by $\mathcal{L}\left(M^{*}\right)$ the vector bundle on $G / Q$ induced from $M^{*}$. The collection of functors $\Gamma_{i}$ is referred to as geometric induction while that of $H^{i}$ is referred to as geometric restriction.

The following observation is due to Penkov [5].
Proposition 3. For any $K$-module $M$ we have

$$
\sum_{i}(-1)^{i}\left[\Gamma_{i}(M)\right]=\sum_{i}(-1)^{i}\left[H^{i}\left(G_{0} / Q_{0}, \mathcal{L}\left(S^{\bullet}(\mathfrak{r}) \otimes M^{*}\right)\right)^{*}\right] .
$$

Proposition 4. For every projective $G$-module $P$, every $K$-module $M$ and $i \geq 0$ there is a canonical isomorphism

$$
\operatorname{Hom}_{G}\left(\Gamma_{i}(M), P\right) \simeq \operatorname{Hom}_{K}\left(M, H^{i}(P)\right)
$$

Proof. This result is a slight generalization of Proposition 1 in 3]. We consider an injective resolution $0 \rightarrow R^{0} \rightarrow R^{1} \rightarrow \ldots$ of $M$ in the category of $Q$-modules. Since $\operatorname{Hom}_{G}(P, \cdot)$ is an exact functor, $\operatorname{Hom}_{G}\left(P, H^{i}(G / Q, M)\right)$ is given by the $i$-th cohomology group of the complex

$$
0 \rightarrow \operatorname{Hom}_{G}\left(P, H^{0}\left(G / Q, R^{0}\right)\right) \rightarrow \operatorname{Hom}_{G}\left(P, H^{0}\left(G / Q, R^{1}\right)\right) \rightarrow \ldots
$$

The Frobenius reciprocity implies

$$
\operatorname{Hom}_{G}\left(P, H^{0}\left(G / Q, R^{j}\right)\right) \simeq \operatorname{Hom}_{Q}\left(P, R^{j}\right)
$$

Thus, we obtain the isomorphism

$$
\operatorname{Hom}_{G}\left(P, H^{i}(G / Q, M)\right) \simeq \operatorname{Ext}_{Q}^{i}(P, M)
$$

We now need the following lemma.
Lemma 1. The restricted module $\operatorname{Res}_{K} P$ is projective in the category $K-\bmod$.
Proof. Note that $P$ is a direct summand of the induced module $\operatorname{Ind}_{\mathfrak{g}_{0}}^{\mathfrak{g}} S$ for some semisimple $\mathfrak{g}_{0}$-module $S$. Using the isomorphism

$$
\operatorname{Res}_{K} \operatorname{Ind}_{\mathfrak{g}_{0}}^{\mathfrak{g}} S \simeq \operatorname{Ind}_{\mathfrak{k}_{0}}^{\mathfrak{k}} S \otimes S^{\bullet}\left(\mathfrak{g}_{1} / \mathfrak{k}_{1}\right),
$$

we obtain that $P$ is a direct summand of some module induced from a semisimple $\mathfrak{k}_{0}$-module. Therefore $P$ is projective as a $K$-module.

Applying the above lemma we can use the Koszul complex $\Lambda^{i}(\mathfrak{r}) \otimes \mathcal{U}(\mathfrak{r}) \otimes P$ (where $\mathcal{U}(\mathfrak{r})$ is the universal enveloping algebra of $\mathfrak{r}$ ) and thus obtain an isomorphism

$$
\operatorname{Ext}_{Q}^{i}(P, M) \simeq \operatorname{Hom}_{K}\left(H_{i}(\mathfrak{r}, P), M\right)
$$

Now we use the double dualization and the fact that $P^{*}$ is also projective:

$$
\begin{gathered}
\operatorname{Hom}_{G}\left(\Gamma_{i}(M), P\right) \simeq \operatorname{Hom}_{G}\left(P^{*}, H^{i}\left(G / Q, M^{*}\right)\right) \simeq \operatorname{Hom}_{K}\left(H_{i}\left(\mathfrak{r}, P^{*}\right), M^{*}\right) \simeq \\
\simeq \operatorname{Hom}_{K}\left(M, H^{i}(P)\right)
\end{gathered}
$$

Hence the statement.
Recall that for any quasireductive supergroup every projective module is injective and vice versa, [6].
Corollary 1. If $P$ is an injective (equivalently, projective) $G$-module, then $H^{i}(P)$ is an injective and projective $K$-module.

## 4. Two functors on $\mathcal{F}$

We choose a parabolic subalgebra $\mathfrak{p}$ which can be either $\mathfrak{p}_{\underline{m}, n}$ or $\mathfrak{p}_{m, \underline{n}}$ in $\mathfrak{g}_{m, n}$, where:
$\mathfrak{p}_{\underline{m}, n}=\mathfrak{g}_{m-1, n} \oplus \mathbb{C} z \oplus \mathfrak{r}_{\underline{m}, n}, \mathfrak{g}_{m, n}=\mathfrak{p}_{\underline{m}, n} \oplus \mathfrak{r}_{\underline{m}, n}^{-}$
$\mathfrak{p}_{m, \underline{n}}=\mathfrak{g}_{m, n-1} \oplus \mathbb{C} z \oplus \mathfrak{r}_{m, \underline{n},}$, and $\mathfrak{g}_{m, n}=\mathfrak{p}_{m, \underline{n}} \oplus \mathfrak{r}_{m, \underline{n}}^{-}$.
Denote by $Z$ the center of the reductive part of the parabolic subgroup $P$ corresponding to the parabolic subalgebra we chose above (the Lie algebra of $Z$ is $\mathbb{C} z$ ). For any $a \in \mathbb{Z}$ we denote by $\mathbb{C}_{a}$ the corresponding character of $Z$. Since $Z$ is a one-parameter subgroup of the torus $T_{m, n}$, if $\varpi$ is the corresponding weight in the dual, we denote by $\mathbb{C}_{a \varpi}$ the associated $T_{m, n}$-module (in our case, $\varpi$ is either $\varepsilon_{n}$ or $\delta_{n}$ ). Now, if $M \in \mathcal{F}_{m-1, n}$ or $\mathcal{F}_{m, n-1}$, denote $\mathbb{C}_{a} \boxtimes M$ the $P$-module with trivial action of the corresponding nilradical $\mathfrak{R}$ and the given action of $Z \times G_{m-1, n}$, or $Z \times G_{m, n-1}$ depending on the way the parabolic is chosen.

Definition 1. We define the following functors:

$$
\begin{aligned}
& \qquad \Gamma_{i}^{a}: \mathcal{F} \rightarrow \mathcal{F}, a \in \frac{1}{2}+\mathbb{Z} \\
& \text { if } a>0 \text {, if } M \in \mathcal{F}_{m-1, n}, \Gamma_{i}^{a}(M):=H^{i}\left(G_{m, n} / P_{\underline{m}, n}, \mathcal{L}\left(\mathbb{C}_{\left(a-\left(m-n-\frac{1}{2}\right)\right) \varepsilon_{m}} \boxtimes M\right)^{*}\right)^{*}, \\
& \text { if } a<0 \text {, if } M \in \mathcal{F}_{m, n-1}, \Gamma_{i}^{a}(M):=H^{i}\left(G_{m, n} / P_{m, \underline{n}}, \mathcal{L}\left(\mathbb{C}_{\left(-a-\left(n-m-\frac{1}{2}\right)\right) \delta_{n}} \boxtimes M\right)^{*}\right)^{*} . \\
& \qquad H_{b}^{j}: \mathcal{F} \rightarrow \mathcal{F}, b \in \frac{1}{2}+\mathbb{Z} \\
& \text { if } b>0 \text {, if } M \in \mathcal{F}_{m, n}, H_{b}^{j}(M):=\operatorname{Hom}_{Z}\left(\mathbb{C}_{\left(b-\left(m-n-\frac{1}{2}\right)\right) \varepsilon_{m}}, H^{j}\left(\mathfrak{r}_{m, n}, M\right)\right) \in \mathcal{F}_{m-1, n} \\
& \text { if } b<0 \text {, if } M \in \mathcal{F}_{m, n}, H_{b}^{j}(M):=\operatorname{Hom}_{Z}\left(\mathbb{C}_{\left(-b-\left(n-m-\frac{1}{2}\right)\right) \delta_{n}}, H^{j}\left(\mathfrak{r}_{m, \underline{n}}, M\right)\right) \in \mathcal{F}_{m, n-1} .
\end{aligned}
$$

Now, we consider the following operators in $\mathcal{K}$ : if $M \in \mathcal{F}_{m, n}$, denoting the sign of a half-integer $x$ by $\operatorname{sgn}(x)$ :

$$
\begin{aligned}
& \gamma^{a}([M]):=\operatorname{sgn}(a)^{m} \sum_{i \geq 0}(-1)^{i}\left[\Gamma_{i}^{a}(M)\right] \\
& \eta_{b}([M]):=\operatorname{sgn}(b)^{m} \sum_{j \geq 0}(-1)^{j}\left[H_{b}^{j}(M)\right] .
\end{aligned}
$$

Applying the results of the previous section, we get:
Proposition 5. Consider the pairing $\mathcal{K}(L) \times \mathcal{K}(P) \rightarrow Z$ defined by

$$
\langle[M],[P]\rangle:=\operatorname{dim} \operatorname{Hom}_{G_{m, n}}(M, P)
$$

for every projective $P \in \mathcal{F}_{m, n}$ and every $M \in \mathcal{F}_{m, n}$. Then for any $a \in \frac{1}{2}+\mathbb{Z}$ we have

$$
\left\langle M, \eta_{a}[P]\right\rangle=\left\langle\gamma^{a}[M],[P]\right\rangle
$$

Let us restrict those linear operators to $\mathcal{K}(\mathcal{E})$. Then for every $a \in \frac{1}{2}+\mathbb{Z}$, the linear operators $\gamma^{a}$ and $\eta_{a}$ are mutually adjoint.

We can identify the Grothendieck ring with the ring of characters of finite dimensional modules (cf [3]) and so we will check the relations we need at the level of characters.

We recall the following formula ([2], prop. 1): for $P \subset G$ a parabolic subgroup of a quasireductive supergroup with Levi part $L$,

\sum_{i}(-1)^{i} C h\left(H^{i}\left(G / P, \mathcal{L}\left(M^{*}\right)\right)^{*}\right)=D \sum_{w \in W} \varepsilon(w) w\left(\frac{e^{\rho} C h(M)}{\Pi_{\alpha \in \Delta_{1,!}^{+}}\left(1+e^{-\alpha}\right)}\right)
$$

where $D:=\frac{D_{0}}{D_{1}}, D_{0}=\Pi_{\alpha \in \Delta_{0}^{+}}\left(e^{\alpha / 2}-e^{-\alpha / 2}\right), D_{1}=\Pi_{\alpha \in \Delta_{1}^{+}}\left(e^{\alpha / 2}+e^{-\alpha / 2}\right)$, and the various $\Delta$ have the obvious composition (roots of $\mathfrak{g}$ if no other index, roots corresponding to a subalgebra if the subalgebra appears as index).

Proposition 6. Let $\nu=\left(a_{m}, \ldots, a_{1} \mid b_{1}, \ldots, b_{n}\right) \in \Lambda_{m, n}^{+}$. Then one has:
(1) $a>0$, if $\exists i$ s.t. $a_{i+1}>a>a_{i}$,

$$
\gamma^{a}(\mathcal{E}(\nu))=(-1)^{m-i} \mathcal{E}\left(a_{m}, \ldots, a_{i+1}, a, a_{i}, \ldots a_{1} \mid b_{1}, \ldots, b_{n}\right),
$$

and $\gamma^{a}(\mathcal{E}(\nu))=0$ if $\exists i, a=a_{i}$.
(2) $a<0$, if $\exists i$ s.t. $b_{i}<-a<b_{i+1}$,

$$
\gamma^{a}(\mathcal{E}(\nu))=(-1)^{n-i} \mathcal{E}\left(a_{m}, \ldots a_{1} \mid b_{1}, \ldots, b_{i},-a, b_{i+1}, \ldots, b_{n}\right),
$$

$$
\text { and } \gamma^{a}(\mathcal{E}(\nu))=0 \text { if } \exists i, a=-b_{i}
$$

(3) $b>0$, if $\exists i$ s.t. $b=a_{i}$

$$
\begin{aligned}
& \quad \eta_{b}(\mathcal{E}(\nu))=(-1)^{m-i} \mathcal{E}\left(a_{m}, \ldots, a_{i+1}, a_{i-1}, \ldots, a_{1} \mid b_{1}, \ldots, b_{n}\right) \\
& \text { if } b \neq a_{i} \forall i, \eta_{b}(\mathcal{E}(\nu))=0 .
\end{aligned}
$$

(4) $b<0$, if $\exists i$ s.t. $b=-b_{i}$

$$
\begin{aligned}
& \quad \eta_{b}(\mathcal{E}(\nu))=(-1)^{n-i} \mathcal{E}\left(a_{m}, \ldots, a_{1} \mid b_{1}, \ldots, b_{i-1}, b_{i+1}, \ldots, b_{n}\right) \\
& \text { if } b \neq-b_{i} \forall i, \eta_{b}(\mathcal{E}(\nu))=0 .
\end{aligned}
$$

Proof We will only prove (1), since (2) is analogous and then (3) and (4) follow by adjointness. Let us use [2], Theorem 1: one has, if $M$ is a $B$-module,
$\sum_{i, j}(-1)^{i+j}\left[H^{i}\left(G_{m, n} / P_{\underline{m}, n}, \mathcal{L}\left(H^{j}\left(P_{\underline{m}, n} / B, \mathcal{L}\left(M^{*}\right)\right)\right)^{*}\right]=\sum_{k}(-1)^{k}\left[H^{k}\left(G_{m, n} / B, \mathcal{L}\left(M^{*}\right)\right)^{*}\right]\right.$.
We take for $M$ the 1-dimensional representation $\mathbb{C}_{\lambda}$ with $\lambda+\rho_{B}=\left(a, a_{m}, \ldots, a_{1} \mid b_{1}, \ldots, b_{n}\right)$. Then, using the equation (4), and the definition of $\gamma^{a}$, we get

$$
\gamma^{a}(\mathcal{E}(\nu))=\mathcal{E}(\lambda)=(-1)^{m-i}\left(a_{m}, \ldots, a_{i+1}, a, a_{i}, \ldots, a_{1} \mid b_{1}, \ldots b_{n}\right)
$$

for the index $i$ of the statement. Hence the proposition.

## 5. Link with the Clifford algebra

Let us now interpret the map $f$ of section 2 in terms of the functors described in the previous section. The proposition 6 has the following immediate corollary:

Corollary 2. One has:
$f \circ \gamma^{a}=v_{a} \circ f$ for $a>0$,
$f \circ \gamma^{a}=w_{a} \circ f$ for $a<0$,
$f \circ \eta_{b}=w_{b} \circ f$ for $b>0$,
$f \circ \eta_{b}=v_{b} \circ f$ for $b<0$,
where $v_{a}, w_{b}$ stand for the action on the Fock space of the corresponding elements of the Clifford algebra.

This gives us an action of the Clifford algebra on the Grothendieck group $\mathcal{K}(\mathcal{E})$.
Theorem 1. The operators $\gamma^{a}$ and $\eta_{b}\left(a, b \in \frac{1}{2}+\mathbb{Z}\right)$ in the Grothendieck group $\mathcal{K}$ satisfy the Clifford relations:

$$
\eta_{a} \eta_{b}+\eta_{b} \eta_{a}=0, \quad \gamma^{a} \gamma^{b}+\gamma^{b} \gamma^{a}=0, \quad \gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}=\delta_{a, b} .
$$

Proof Let $a$ and $b$ be half-integers. We first show that

$$
\eta_{a} \eta_{b}+\eta_{b} \eta_{a}=0
$$

The arguments involved in the proof depend on the signs of $a$ and $b$, we will take care of the cases $a, b>0$ and $a>0, b<0$, leaving $a<0, b<0$ to the reader.

Assume first that $a>0, b>0$, let $M$ be a $\mathfrak{g}_{m, n}$ module, we consider the following increasing chain of Lie superalgebras:

$$
\mathfrak{g}_{m-2, n} \subset \mathfrak{p}_{\underline{m-1, n}} \subset \mathfrak{g}_{m-1, n} \subset \mathfrak{p}_{\underline{m}, n} \subset \mathfrak{g}_{m, n}
$$

Let $\mathfrak{q}$ be the parabolic subalgebra with reductive part equal to the direct sum of $\mathfrak{g}_{m-2, n}$ and the two-dimensional center $Z_{\mathfrak{q}}$, and the nilradical $\mathfrak{r}=\mathfrak{r}_{\underline{m}, n}+\mathfrak{r}_{\underline{m-1, n}}$. Then using the Hochschild-Serre spectral sequence for the pair $\mathfrak{r}_{\underline{m-1, n}} \subset \mathfrak{r}$ we obtain

$$
\eta_{a} \eta_{b}[M]=\sum_{i}(-1)^{i}\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(b-(n-m-1 / 2)) \varepsilon_{m}+(a-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{i}(\mathfrak{r}, M)\right)\right],
$$

and

$$
\eta_{b} \eta_{a}[M]=\sum_{i}(-1)^{i}\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(a-(n-m-1 / 2)) \varepsilon_{m}+(b-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{i}(\mathfrak{r}, M)\right)\right] .
$$

Now we consider the one-dimensional root subalgebra $\mathfrak{s}:=\mathfrak{g}_{\beta} \subset \mathfrak{r}$ for the root $\beta=\varepsilon_{m}-\varepsilon_{m-1}$. Note that $\mathfrak{s}$ is the nilradical of a Borel subalgebra of the $\mathfrak{s l}(2)$ generated by $\mathfrak{g}_{\beta}$ and $\mathfrak{g}_{-\beta}$. Hence by the Kostant theorem we have for any $\mathfrak{s l}(2)$ module $N$

$$
\begin{gathered}
{\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(a-(n-m-1 / 2)) \varepsilon_{m}+(b-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{p}(\mathfrak{s}, N)\right)\right]=} \\
{\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(b-(n-m-1 / 2)) \varepsilon_{m}+(a-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{q}(\mathfrak{s}, N)\right)\right]}
\end{gathered}
$$

for $(p, q)=(0,1)$ or $(1,0)$.

Once again we apply the Hochschild-Serre spectral sequence for the pair $\mathfrak{s} \subset \mathfrak{r}$ to get
$\eta_{a} \eta_{b}[M]=\sum_{i}(-1)^{i+j}\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(b-(n-m-1 / 2)) \varepsilon_{m}+(a-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{i}\left(\mathfrak{s}, \Lambda^{j}(\mathfrak{r} / \mathfrak{s})^{*} \otimes M\right)\right)\right]$,
$\eta_{b} \eta_{a}[M]=\sum_{i}(-1)^{i+j}\left[\operatorname{Hom}_{Z_{\mathfrak{q}}}\left(\mathbb{C}_{(a-(n-m-1 / 2)) \varepsilon_{m}+(b-(n-m+1 / 2)) \varepsilon_{m-1}}, H^{i}\left(\mathfrak{s}, \Lambda^{j}(\mathfrak{r} / \mathfrak{s})^{*} \otimes M\right)\right)\right]$.
This implies the relation.
Now let $a>0, b<0$. Let $M$ be a $G_{m, n}$-module. Set

$$
\mathfrak{r}:=\mathfrak{r}_{\underline{m}, n}+\mathfrak{r}_{m-1, \underline{n}}, \quad \mathfrak{r}^{\prime}:=\mathfrak{r}_{m, \underline{n}}+\mathfrak{r}_{\underline{m}, n-1} .
$$

Let $Z \subset T_{m, n}$ be the centralizer of $\mathfrak{g}_{m-1, n-1}$. Using Hochschild-Serre spectral sequence we obtain

$$
\eta_{b} \eta_{a}[M]=\sum_{i}(-1)^{m-1+i}\left[\operatorname{Hom}_{Z}\left(\mathbb{C}_{(a-(m-n-1 / 2)) \varepsilon_{m}-(b+n-m+1 / 2) \delta_{n}}, H^{i}(\mathfrak{r}, M)\right)\right]
$$

and

$$
\eta_{a} \eta_{b}[M]=\sum_{i}(-1)^{m+i}\left[\operatorname{Hom}_{Z}\left(\mathbb{C}_{(a-(m-n+1 / 2)) \varepsilon_{m}-(b+n-m-1 / 2) \delta_{n}}, H^{i}\left(\mathfrak{r}^{\prime}, M\right)\right)\right]
$$

Let $\alpha=\varepsilon_{m}-\delta_{n}$. Consider the root subalgebras $\mathfrak{g}_{\alpha}, \mathfrak{g}_{-\alpha} \subset \mathfrak{g}_{m, n}$. Note that $\mathfrak{s}:=\mathfrak{r} \cap \mathfrak{r}^{\prime}$ is an ideal of coduimension 1 in both $\mathfrak{r}$ and $\mathfrak{r}^{\prime}$ and that

$$
\mathfrak{r}=\mathfrak{s}+\mathfrak{g}_{\alpha}, \quad \mathfrak{r}^{\prime}=\mathfrak{s}+\mathfrak{g}_{-\alpha}
$$

Therefore by Hochschild-Serre spectral sequence we have
$\eta_{b} \eta_{a}=\sum_{i, j}(-1)^{i+j+m-1}\left[\operatorname{Hom}_{Z}\left(\mathbb{C}_{(a-(m-n-1 / 2)) \varepsilon_{m}-(b+n-m+1 / 2) \delta_{n}}, \Lambda^{j}\left(\mathfrak{g}_{-\alpha}\right) \otimes H^{i}(\mathfrak{s}, M)\right)\right]$,
$\eta_{a} \eta_{b}[M]=\sum_{i, j}(-1)^{i+j+m}\left[\operatorname{Hom}_{Z}\left(\mathbb{C}_{(a-(m-n+1 / 2)) \varepsilon_{m}-(b+n-m-1 / 2) \delta_{n}}, \Lambda^{j}\left(\mathfrak{g}_{\alpha}\right) \otimes H^{i}(\mathfrak{s}, M)\right)\right]$.
Taking into account that

$$
\sum_{j}(-1)^{j} C h\left(\Lambda^{j}\left(\mathfrak{g}_{\alpha}\right)\right)=\frac{1}{1+e^{\alpha}}=\frac{e^{-\alpha}}{1+e^{-\alpha}}=e^{-\alpha}\left(\sum_{j}(-1)^{j} C h\left(\Lambda^{j}\left(\mathfrak{g}_{-\alpha}\right)\right)\right)
$$

we obtain

$$
\sum_{j}(-1)^{j} C h\left(\Lambda^{j}\left(\mathfrak{g}_{\alpha}\right) \otimes H^{i}(\mathfrak{s}, M)\right)=e^{-\alpha}\left(\sum_{j}(-1)^{j} C h\left(\Lambda^{j}\left(\mathfrak{g}_{-\alpha}\right) \otimes H^{i}(\mathfrak{s}, M)\right)\right) .
$$

Therefore

$$
C h\left(\eta_{a} \eta_{b}[M]\right)=-C h\left(\eta_{b} \eta_{a}[M]\right),
$$

which proves the relation.
Note that the relation

$$
\gamma^{a} \gamma^{b}+\gamma^{b} \gamma^{a}=0 .
$$

follows from the relation for $\eta_{a}, \eta_{b}$ by Proposition 5 .

Let us now show that if $a>0$ and $b<0$, then

$$
\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}=0
$$

The case $a<0$ and $b>0$ is similar and we leave it to the reader. One should keep in mind the following diagram

$$
\begin{array}{cccc} 
& \eta_{b} & \\
\mathcal{F}_{m, n} & \rightarrow & \mathcal{F}_{m, n-1} \\
\gamma^{a} \downarrow & & \downarrow \gamma^{a} \\
\mathcal{F}_{m+1, n} & \rightarrow & \mathcal{F}_{m+1, n-1}
\end{array}
$$

$\eta_{b}$
because we follow it to keep tracks of the weights.
Let us denote $C h M_{\gamma}$ the character of $\operatorname{Hom}_{Z}\left(\mathbb{C}_{\gamma}, M\right)$. Then one has:

$$
\begin{gathered}
\gamma^{a} \eta_{b} C h(M)= \\
=\sum_{i, j}(-1)^{i+j+m} C h\left(\Gamma_{j}\left(G_{m+1, n-1} / P_{\underline{m+1, n-1}},\left(\mathbb{C}_{(a-(m-n+1 / 2)) \varepsilon_{m+1}} \boxtimes \Lambda^{i}\left(\mathfrak{r}_{m, \underline{n}}^{*}\right) \otimes M\right)_{(-b-(n-m-1 / 2)) \delta_{n}}\right)\right), \\
\eta_{b} \gamma^{a} C h(M)= \\
=\sum_{i, j}(-1)^{i+j+m+1} C h\left(\left(\Lambda^{i}\left(\mathfrak{r}_{m+1, \underline{n}}^{*}\right) \otimes \Gamma_{j}\left(G_{m+1, n} / P_{\underline{m+1, n}}, \mathbb{C}_{(a-(m-n-1 / 2)) \varepsilon_{m+1}} \boxtimes M\right)\right)_{(-b-(n-m-3 / 2)) \delta_{n}}\right) .
\end{gathered}
$$

We use Proposition 3. For any $G_{m, k}$-module $N$, the following holds:
$\sum_{j}(-1)^{j} \Gamma_{j}\left(G_{m+1, k} / P_{\underline{m+1, k}}, N\right)=\sum_{j}(-1)^{j} \Gamma_{j}\left(G_{m+1,0} / P_{\underline{m+1,0}}, N \otimes S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m+1, k}}^{*}\right)_{\overline{1}}\right)\right.$.
Then if we set:

$$
X:=\sum_{i}(-1)^{i} \Lambda^{i}\left(\mathfrak{r}_{m, \underline{n}}^{*}\right) \otimes S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m+1}, n-1}^{*}\right)_{\overline{1}}\right)
$$

and

$$
Y:=\sum_{i}(-1)^{i} \Lambda^{i}\left(\mathfrak{r}_{m+1, \underline{n}}^{*}\right) \otimes S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m+1, n}}^{*}\right)_{\overline{1}}\right),
$$

we get

$$
\begin{gathered}
\gamma^{a} \eta_{b}(C h(M))= \\
=\sum_{j}(-1)^{j+m} C h\left(\Gamma_{j}\left(G_{m+1,0} / P_{\underline{m+1,0}}, \mathbb{C}_{(a-(m-n+1 / 2)) \varepsilon_{m+1}} \boxtimes X \otimes M\right)_{(-b-(n-m-1 / 2)) \delta_{n}}\right)
\end{gathered}
$$

and

$$
\begin{gathered}
\eta_{b} \gamma^{a}(C h(M))= \\
=\sum_{j}(-1)^{j+m+1} C h\left(\Gamma_{j}\left(G_{m+1,0} / P_{\underline{m+1,0}}, \mathbb{C}_{(a-(m-n-1 / 2)) \varepsilon_{m+1}} \boxtimes Y \otimes M\right)_{(-b-(n-m-3 / 2)) \delta_{n}}\right) .
\end{gathered}
$$

Next we compute the quotient $C h(X) / C h(Y)$. One has

$$
\begin{aligned}
& C h(X)=\frac{\left(1-e^{-2 \delta_{n}}\right) \prod_{i=1}^{n-1}\left(1-e^{-\delta_{n} \pm \delta_{i}}\right) \prod_{j=1}^{n-1}\left(1+e^{ \pm \delta_{j}-\varepsilon_{m+1}}\right)}{\left(1+e^{-\delta_{n}}\right) \prod_{j=1}^{m}\left(1+e^{-\delta_{n} \pm \varepsilon_{j}}\right)} \\
& C h(Y)=\frac{\left(1-e^{-2 \delta_{n}}\right) \prod_{i=1}^{n-1}\left(1-e^{-\delta_{n} \pm \delta_{i}}\right) \prod_{j=1}^{n}\left(1+e^{ \pm \delta_{j}-\varepsilon_{m+1}}\right)}{\left(1+e^{-\delta_{n}}\right) \prod_{j=1}^{m+1}\left(1+e^{-\delta_{n} \pm \varepsilon_{j}}\right)}
\end{aligned}
$$

and the quotient turns out to be

$$
C h(X) / C h(Y)=e^{\varepsilon_{m+1}-\delta_{n}} .
$$

The result follows.
Let us show finally that for $a, b>0$ one has

$$
\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}=\delta_{a, b}
$$

where $\delta_{a, b}$ stands for the Kronecker symbol. The proof we provide lacks functoriality at the moment, but we intend to improve it.

Let $R: \mathcal{F}_{m, n} \rightarrow \mathcal{F}_{m, 0}$ be the restriction functor and denote by the same letter the corresponding map of the Grothendieck groups. Then it follows from Proposition 3 that for any $M \in \mathcal{F}_{m, n}$,

$$
R\left(\gamma^{a}[M]\right)=\gamma^{a+n}\left(\left[S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m+1, n}}^{*}\right)_{\overline{1}}\right)\right] R[M]\right) .
$$

On the other hand, for any Lie superalgebra $\mathfrak{r}$ and $\mathfrak{r}$-module $M$ we have

$$
\sum_{i}(-1)^{i}\left[H^{i}(\mathfrak{r}, M)\right]=\sum_{k, l}(-1)^{k+l}\left[\Lambda^{l}\left(\mathfrak{r}_{\overline{1}}^{*}\right)\right]\left[H^{k}\left(\mathfrak{r}_{\overline{0}}, M\right)\right] .
$$

Therefore

$$
R\left(\eta_{a}[M]\right)=\sum_{k}(-1)^{k} \eta_{a+n}\left(\left[\Lambda^{k}\left(\left(\mathfrak{r}_{\underline{m}, n}^{*}\right)_{\overline{1}}\right)\right] R[M]\right) .
$$

Therefore for $M \in \mathcal{F}_{m, n}$ we have

$$
\begin{gathered}
R\left(\gamma^{a} \eta_{b}[M]\right)=\sum_{k}(-1)^{k} \gamma^{n+a}\left(\left[S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m}, n}^{*}\right) \overline{1}\right)\right] \eta_{b+n}\left(\left[\Lambda^{k}\left(\left(\mathfrak{r}_{\underline{m}, n}^{*}\right)_{\overline{1}}\right)\right] R[M]\right)\right), \\
R\left(\eta_{b} \gamma^{a}[M]\right)=\sum_{k}(-1)^{k} \eta_{b+n}\left(\left[\Lambda^{k}\left(\left(\mathfrak{r}_{\underline{m+1, n}}^{*}\right)_{\overline{1}}\right)\right] \gamma^{n+a}\left(\left[S^{\bullet}\left(\left(\mathfrak{r}_{\underline{m+1, n}}^{*}\right)_{\overline{1}}\right)\right] R[M]\right)\right) .
\end{gathered}
$$

Let us denote by $U$ the standard representation of $\mathfrak{s p}(2 n) \subset \mathfrak{o s p}(2 m+1,2 n)$ and consider it as purely odd superspace. Then

$$
C h\left(\left(\mathfrak{r}_{\underline{m}, n}^{*}\right)_{\overline{1}}\right)=e^{-\varepsilon_{m}} C h(U) .
$$

Therefore the above expressions can be rewritten in the form

$$
\begin{aligned}
& R\left(\gamma^{a} \eta_{b}[M]\right)=\sum_{k, l}(-1)^{k} \gamma^{n+a-l}\left(\left[S^{l}(U)\right] \eta_{b+n+k}\left(\left[\Lambda^{k}(U)\right] R[M]\right)\right), \\
& R\left(\eta_{b} \gamma^{a}[M]\right)=\sum_{k}(-1)^{k} \eta_{b+n+k}\left(\left[\Lambda^{k}(U)\right] \gamma^{n+a-l}\left(\left[S^{l}(U)\right] R[M]\right)\right) .
\end{aligned}
$$

Now we note that the action of $G_{m, 0}$ on $U$ is trivial, hence multiplication with its exterior and symmetric powers commute with $\gamma^{a}$ and $\eta_{b}$. Thus, we have

$$
\begin{aligned}
& R\left(\gamma^{a} \eta_{b}[M]\right)=\sum_{k, l}(-1)^{k}\left[S^{l}(U)\right]\left[\Lambda^{k}(U)\right] \gamma^{n+a-l} \eta_{b+n+k}(R[M]), \\
& R\left(\eta_{b} \gamma^{a}[M]\right)=\sum_{k}(-1)^{k}\left(\left[\Lambda^{k}(U)\right]\left[S^{l}(U)\right] \eta_{b+n+k} \gamma^{n+a-l}(R[M])\right.
\end{aligned}
$$

Since $\mathcal{F}_{m, 0}$ is the category of representations of a purely even reductive group, we have $\mathcal{K}(\mathcal{E})_{m, 0}=\mathcal{K}(L)_{m, 0}$. Therefore Proposition 6 implies that for any $N \in \mathcal{F}_{m, 0}$

$$
\gamma^{a} \eta_{b}[N]+\eta_{b} \gamma^{a}[N]=\delta_{a, b}[N]
$$

Hence,

$$
\left(\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}\right)(R[M])=\sum_{l, k}(-1)^{k}\left[S^{l}(U)\right]\left[\Lambda^{k}(U)\right] \delta_{a+n-k, b+n+l} R[M],
$$

and hence

$$
\left(\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}\right)(R[M])=\sum_{k+l=a-b}(-1)^{k}\left[S^{l}(U)\right]\left[\Lambda^{k}(U)\right] R[M]
$$

Since the Koszul complex is acyclic except in the zero degree we have the identity

$$
\sum_{k+l=p}(-1)^{k}\left[\Lambda^{k}(U)\right]\left[S^{l}(U)\right]=\left\{\begin{array}{l}
1 \text { if } p=0 \\
0 \text { otherwise }
\end{array}\right.
$$

Hence, the sum we compute has only one non-zero term, namely we get:

$$
\left(\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}\right)(R[M])=\delta_{a, b} R[M] .
$$

Since the map $R$ is injective this proves the result for $\gamma^{a} \eta_{b}+\eta_{b} \gamma^{a}, a, b>0$. The case $a, b<0$ is similar and we leave it to the reader.

## 6. Translation functors

We would like to link this approach with the results on translation functors in [3].
Recall the Lie algebra $\mathfrak{g l}(\infty)$ which is embedded in $C l(V \oplus W)$ as the span of $v_{a} w_{b}$, $a, b \in \frac{1}{2}+\mathbb{Z}$. The subalgebra $\mathfrak{g l}\left(\frac{\infty}{2}\right)$ is generated by $v_{a} w_{b}+v_{-a} w_{-b}, a, b \in \frac{1}{2}+\mathbb{N}$.

Inside the Fock space $\mathbf{F}$, we consider the subspace $\mathbf{F}_{m, n}$ which is the image of $\mathcal{K}(\mathcal{E})_{m, n}$ under the map $f$, defined at the end of section 2 .

Remark 1. The space $\mathbf{F}_{m, n}$ is stable under the action of $\mathfrak{g l}\left(\frac{\infty}{2}\right)$. Furthermore, it is not difficult to see that $\mathbf{F}_{m, n}$ is isomorphic to $\Lambda^{m}\left(V_{+}\right) \otimes \Lambda^{n}\left(W_{+}\right)$as an $\mathfrak{s l}\left(\frac{\infty}{2}\right)$-module, where $V_{+}$and $W_{+}$are respectively the standard and costandard module of $\mathfrak{g l}\left(\frac{\infty}{2}\right)$.

Consider the Cartan subagebra $\mathfrak{t}$ of $\mathfrak{g l}\left(\frac{\infty}{2}\right)$ with basis $t_{a}:=v_{a} w_{a}+v_{-a} w_{-a}$ for all $a \in \frac{1}{2}+\mathbb{N}$, then $\mathbf{F}$ is a semi-simple $\mathfrak{t}$-module. We denote by $\omega$ the $\mathfrak{t}$-weight of the vacuum vector: $\omega\left(t_{a}\right)=1$ for all $a \in \frac{1}{2}+\mathbb{N}$. Let $\beta_{a} \in \mathfrak{t}^{*}$ be such that $\beta_{a}\left(t_{b}\right)=\delta_{a, b}$. If $\lambda=\left(a_{m}, \ldots, a_{1} \mid b_{1}, \ldots, b_{n}\right)$, then the $\mathfrak{t}$-weight of $f(\mathcal{E}(\lambda))$ equals

$$
\beta(\lambda):=\omega+\beta_{a_{1}}+\cdots+\beta_{a_{m}}-\beta_{b_{1}}-\cdots-\beta_{b_{n}}
$$

Lemma 2. Let $\mathcal{E}(\lambda), \mathcal{E}(\mu) \in \mathcal{K}(\mathcal{E})_{m, n}$. Then $\mathcal{E}(\lambda)$ and $\mathcal{E}(\mu)$ are in the same block of $\mathcal{F}_{m, n}$ if and only if the $\mathfrak{t}$-weights of $f(\mathcal{E}(\lambda))$ and $f(\mathcal{E}(\mu))$ coincide.
Proof. The statement follows from the remark 1 after comparing with the weights denoted by $\gamma(\lambda)$ in [3] (we do not keep this notation here because we have introduced a $\gamma^{a}$ which is not related). The relation between those $\mathfrak{t}$-weights is $\beta(\lambda)=\omega+\gamma(\lambda)$.

Consider now the Chevalley generators of $\mathfrak{g l}\left(\frac{\infty}{2}\right), E_{a, a+1}$ and $E_{a+1, a}$ for all $a \in$ $\frac{1}{2}+\mathbb{N}$. As it was shown in [3], the categorification of the action of these generators in $\Lambda^{m}\left(V_{+}\right) \otimes \Lambda^{n}\left(W_{+}\right)$is given by the translation functors:

$$
T_{a+1, a}(M):=(M \otimes E)_{\beta+\beta_{a+1}-\beta_{a}}, \quad T_{a, a+1}(M):=(M \otimes E)_{\beta+\beta_{a}-\beta_{a+1}},
$$

where $E$ is the standard $\mathfrak{g}_{m, n}$-module, we assume that the $\mathfrak{g}_{m, n}$-module- $M$ belongs to the block corresponding to the $\mathfrak{t}$-weight $\beta$, and by $(N)_{\beta^{\prime}}$ we denote the projection of the $\mathfrak{g}_{m, n}$-module $N$ onto the block corresponding to the $\mathfrak{t}$-weight $\beta^{\prime}$. By abuse of notations we denote also by $T_{a+1, a}$ and $T_{a, a+1}$ the corresponding linear operators in $\mathcal{K}(\mathcal{E})_{m, n}$.

The following statement is an immediate consequence of the remark 11 and Lemma 4 in [3].

Proposition 7. For all $a \in \frac{1}{2}+\mathbb{N}$ we have

$$
f \circ T_{a+1, a}=E_{a+1, a} \circ f, \quad f \circ T_{a, a+1}=E_{a, a+1} \circ f .
$$
