# ON NON-KÄHLER DEGREES OF COMPLEX MANIFOLDS 

DANIELE ANGELLA, ADRIANO TOMASSINI, AND MISHA VERBITSKY


#### Abstract

We study cohomological properties of complex manifolds. In particular, under suitable metric conditions, we extend to higher dimensions a result by A. Teleman, which provides an upper bound for the Bott-Chern cohomology in terms of Betti numbers for compact complex surfaces according to the dichotomy $b_{1}$ even or odd.


## Introduction

Let $X$ be a compact complex manifold. Consider the double complex $\left(\wedge^{\bullet \bullet} X, \partial, \bar{\partial}\right)$. Besides de Rham and Dolbeault cohomology, consider the Bott-Chern [BC65] and Aeppli [Aep65] cohomologies, defined as:

$$
H_{B C}^{\bullet, \bullet}(X):=\frac{\operatorname{ker} \partial \cap \operatorname{ker} \bar{\partial}}{\operatorname{im} \partial \bar{\partial}} \quad \text { and } \quad H_{A}^{\bullet \bullet \bullet}:=\frac{\operatorname{ker} \partial \bar{\partial}}{\operatorname{im} \partial+\operatorname{im} \bar{\partial}}
$$

The Hodge theory developed by M. Schweitzer [Sch07] assures their finite-dimensionality as $\mathbb{C}$-vector spaces. The identity induces the natural maps

of (bi-)graded vector spaces. One says that $X$ satisfies the $\partial \bar{\partial}$-Lemma if the natural map $H_{B C}^{\bullet \bullet \bullet}(X) \rightarrow$ $H_{d R}^{\bullet}(X ; \mathbb{C})$ is injective. This turns out to be equivalent to all the above maps being isomorphisms, [DGMS75, Lemma 5.15, 5.21, Remark 5.16]. Therefore, while compact Kähler manifolds satisfy the $\partial \bar{\partial}$-Lemma, for complex non-Kähler manifolds the above maps may be neither injective nor surjective. A (non-canonical) comparison between Bott-Chern and Aeppli cohomologies and de Rham cohomology is provided by the inequality à la Frölicher in [ATo13, Theorem A]. More precisely, for any $k \in \mathbb{Z}$, we have the non-negative degree

$$
\Delta^{k}:=\operatorname{dim}_{\mathbb{C}} H_{B C}^{k}(X)+\operatorname{dim}_{\mathbb{C}} H_{A}^{k}(X)-2 b_{k} \in \mathbb{N}
$$

where $H_{B C}^{k}(X):=\bigoplus_{p+q=k} H_{B C}^{p, q}(X)$, (and same for Aeppli,) and $b_{k}:=\operatorname{dim}_{\mathbb{C}} H_{d R}^{k}(X ; \mathbb{C})$ denotes the $k$ th Betti number. The validity of the $\partial \bar{\partial}$-Lemma is characterized by $\Delta^{k}=0$ for any $k \in \mathbb{Z},[A T o 13$, Theorem B]. Such a result is extended to generalized-complex structures, here including symplectic structures, in [ATo15, CS15]. An upper-bound of the dimensions of the Bott-Chern cohomology in terms of the Hodge numbers is provided in [ATa17].

In this note, we study the cohomology of compact complex manifolds.
In general, the degrees $\Delta^{k}$ measure the failure of $\partial \bar{\partial}$-Lemma, that is, non-cohomologically-Kählerness. In fact, they measure non-Kählerness for compact complex surfaces. This is because of the topological

[^0]characterization of Kählerness in terms of the parity of the first Betti number, [Kod64, Miy74, Siu83], see also [Lam99, Corollaire 5.7], and [Buc99, Theorem 11].

In [Tel06], (see also [LT95],) A. Teleman proves that, for compact complex surfaces, $\Delta^{1}$ is always zero and $\Delta^{2} \in\{0,2\}$; and, in [ADT16], the Bott-Chern and Aeppli cohomologies for compact complex surfaces diffeomorphic to solvmanifolds and for class VII surfaces are computed, here including Inoue and Kodaira surfaces, [ADT16, Theorem 4.1], and class VII surfaces, [ADT16, Theorem 2.2].

Theorem 0.1 ([Tel06, Lemma 2.3]). Let $X$ be a compact complex surface. Then:

- $b_{1}$ is even if and only if $\Delta^{1}=\Delta^{2}=0$;
- $b_{1}$ is odd if and only if $\Delta^{1}=0$ and $\Delta^{2}=2$.

We notice that this result provides an answer to a question by A. Fujiki, asking whether $\Delta^{2}$ may change under deformations of the complex structure.
Corollary 0.2. For compact complex surfaces, $\Delta^{1}$ and $\Delta^{2}$ are topological invariants.
Note that this is no more true in higher-dimension: see the examples on the Iwasawa manifold in [Ang13], and the examples on the Nakamura manifold in [AK12, AK17].

In higher dimension, we get a result concerning the first degree $\Delta^{1}$ under additional assumptions concerning the existence of special Hermitian metrics.

Theorem 1.7. Let $X$ be a compact complex manifold of complex dimension n endowed with a Hermitian metric $g$. Suppose that its associated $(1,1)$-form $\omega$ satisfies either the condition that $\mathrm{d} \omega^{n-2} \in \mathrm{imd}^{c}$, or the condition that $\omega^{n-2}$ is the $(n-2, n-2)$-component of a d-exact $(2 n-4)$-form. (In particular, such an $\omega$ is astheno-Kähler in the sense of Jost and Yau [JY93].) Then $\Delta^{1}=0$.

Note that the assumption is trivially satisfied for compact complex surfaces. On the other side, as in [ATo11, EFV12], we show that 6-dimensional nilmanifolds endowed with left-invariant complex structures never admit Hermitian metrics as above, see Proposition 1.4. Notwithstanding, there are examples of 6 -dimensional manifolds with $\Delta^{1}=0$, see [AFR15, LUV14].

## 1. Non-KÄhlerness 1st degree for higher-dimensional complex manifolds

Let $X$ be a compact complex manifold of complex dimension $n$ endowed with a Hermitian metric $g$. Denote by $\omega$ its associated (1,1)-form. Recall that

$$
\mathcal{D}: \mathcal{C}^{\infty}(X ; \mathbb{C}) \rightarrow \wedge^{2 n} X \otimes \mathbb{C}, \quad \mathcal{D}(f):=\operatorname{dd}^{c} f \wedge \omega^{n-1}
$$

is an elliptic differential operator with index zero and 1-dimensional kernel, [Gau75].
Define the Hermitian degree

$$
\operatorname{deg}: H_{B C}^{1,1}(X) \rightarrow \frac{\wedge^{2 n} X \otimes \mathbb{C}}{\operatorname{im} \mathcal{D}} \simeq \mathbb{C}, \quad \operatorname{deg}([\alpha]):=\frac{\alpha \wedge \omega^{n-1}}{\omega^{n}}
$$

Lemma 1.1. Let $X$ be a compact complex manifold of complex dimension $n$ endowed with a Hermitian metric $g$. Suppose that its associated $(1,1)$-form $\omega$ satisfies the following condition:
(a): $\omega^{n-2}$ is the $(n-2, n-2)$-component of $a$ d-closed $(2 n-4)$-form.

If $[\mathrm{d} \alpha] \in H_{B C}^{1,1}(X)$ is such that $\operatorname{deg}([\mathrm{d} \alpha])=0$, then $[\mathrm{d} \alpha]=0$.
Proof. By the hypothesis: take $f \in \mathcal{C}^{\infty}(X ; \mathbb{C})$ such that

$$
\mathrm{d} \alpha \wedge \omega^{n-1}=\mathrm{dd}^{c} f \wedge \omega^{n-1}
$$

Set $\alpha^{\prime}:=\alpha-\mathrm{d}^{c} f$. Note that $[\mathrm{d} \alpha]=\left[\mathrm{d} \alpha^{\prime}\right]$ in $H_{B C}^{1,1}(X)$, and that $\mathrm{d} \alpha^{\prime}$ is primitive. Hence use Weil identity to write $* \mathrm{~d} \alpha^{\prime}=\frac{1}{(n-2)!} J \mathrm{~d} \alpha^{\prime} \wedge \omega^{n-2}=\frac{1}{(n-2)!} \mathrm{d} \alpha^{\prime} \wedge \omega^{n-2}$.

Under the assumption (a), take $\beta \in \wedge^{2 n-4}$ such that: (here $\pi_{\wedge n-2, n-2 X}$ denotes the natural projections onto $\wedge^{n-2, n-2} X$ )

$$
\omega^{n-2}=\pi_{\wedge^{n-2, n-2} X} \beta \quad \text { with } \quad \mathrm{d} \beta=0
$$

We have:

$$
\begin{aligned}
\left\|\mathrm{d} \alpha^{\prime}\right\|^{2} & =\int_{X} \mathrm{~d} \alpha^{\prime} \wedge \overline{*\left(\mathrm{~d} \alpha^{\prime}\right)}=-\frac{1}{(n-2)!} \int_{X} \mathrm{~d} \alpha^{\prime} \wedge \mathrm{d} \bar{\alpha}^{\prime} \wedge \omega^{n-2} \\
& =-\frac{1}{(n-2)!} \int_{X} \mathrm{~d} \alpha^{\prime} \wedge \mathrm{d} \bar{\alpha}^{\prime} \wedge \pi_{\wedge^{n-2, n-2}} \beta \\
& =-\frac{1}{(n-2)!} \int_{X} \mathrm{~d} \alpha^{\prime} \wedge \mathrm{d} \bar{\alpha}^{\prime} \wedge \beta \\
& =\frac{1}{(n-2)!} \int_{X} \alpha^{\prime} \wedge \mathrm{d} \bar{\alpha}^{\prime} \wedge \mathrm{d} \beta=0,
\end{aligned}
$$

thus giving $\mathrm{d} \alpha^{\prime}=0$.
Remark 1.2. Note that the condition (a) in Lemma 1.1 yields that $\mathrm{dd}^{c} \omega^{n-2}=0$. That is, $\omega$ is asthenoKähler in the sense of J. Jost and S.-T. Yau, [JY93]. Note that the condition is trivially satisfied in case $2 n=4$. In a sense, condition $(a)$ is the $(n-2)$-degree counterpart of Hermitian-symplectic condition in the sense of [ST10]. Note that a Hermitian metric satisfying $\mathrm{d} \omega^{n-2}=0$ is actually Kähler, [GH80].
Remark 1.3 (Ionut Chiose). Condition (a) is satisfied e.g. when
(b): $\mathrm{d} \omega^{n-2} \in \mathrm{im} \mathrm{d}^{c}$.

Proof. Condition (b) assures that $\partial \omega^{n-2}=\partial \bar{\partial} \eta$ where $\eta \in \wedge^{n-2, n-3} X$. Then $\beta:=\partial \eta+\omega^{n-2}+\bar{\partial} \eta$ is a $(2 n-4)$-form such that $\mathrm{d} \beta=0$ and whose $(n-2, n-2)$-component is $\omega^{n-2}$.

The following generalizes the result in [ATo11], see also [EFV12], in proving that conditions (a) and (b) are not satisfied for 6 -dimensional nilmanifolds with invariant structures.

Proposition 1.4. On a 6-dimensional non-torus nilmanifold endowed with a left-invariant complex structure, there is no left-invariant metric with the property (a) in Lemma 1.1.

Proof. In dimension 6, condition (a) is equivalent to have a Hermitian-symplectic structure. This is proven to be impossible on 6-dimensional nilmanifold in [ATo11, Theorem 3.3], except the torus; see also [EFV12, Theorem 1.3].
Remark 1.5. Note that there are examples of 6 -dimensional nilmanifolds such that $\Delta^{1}=0$, see [AFR15, LUV14].

Lemma 1.6. Suppose that the Hermitian $(1,1)$-form $\omega$ on a complex manifold $X$ satisfies either condition (b) in Lemma 1.1, or condition
( $\left.\mathbf{a}^{\prime}\right): \omega^{n-2}$ is the $(n-2, n-2)$-component of a d-exact $(2 n-4)$-form.
Then a product of a $\mathrm{d}^{c}$-closed and d -exact form $\mathrm{d} \nu$ with $\omega^{n-2}$ is exact.
Proof. Indeed, in case the assumption (b) is true, then $\mathrm{d} \omega^{n-2}=\mathrm{dd}^{c} \mu$, giving

$$
\int_{X} \mathrm{~d} \nu \wedge \omega^{n-2}=-\int_{X} \nu \wedge \mathrm{~d} \omega^{n-2}=-\int_{X} \nu \wedge \mathrm{~d}^{c} \mu=\int_{X} \mathrm{~d} \mathrm{~d}^{c} \nu \wedge \mu=0
$$

which proves the statement.
In case the assumption $\left(a^{\prime}\right)$ is true, let $\omega^{n-2}=(\mathrm{d} \kappa)^{(n-2, n-2)}$, and

$$
\int_{X} \mathrm{~d} \nu \wedge \omega^{n-2}=\int_{X}(\mathrm{~d} \nu)^{(2,2)} \wedge \omega^{n-2}=\int_{X}(\mathrm{~d} \nu)^{(2,2)} \wedge \mathrm{d} \kappa
$$

because $\mathrm{d} \nu$ is both d -closed and $\mathrm{d}^{c}$-closed, whence $(\mathrm{d} \nu)^{(2,2)}$ is d -closed, and $\mathrm{d} \kappa$ is exact.
Theorem 1.7. Let $X$ be a compact complex manifold endowed with a Hermitian metric $g$. Suppose that the associated ( 1,1 )-form $\omega$ satisfies either condition (b) in Lemma 1.1 or condition (a') in Lemma 1.6. Then $\Delta^{1}=0$.
Proof. We claim that, under the hypotheses, the sequence

$$
\begin{equation*}
0 \rightarrow H_{d R}^{1}(X ; \mathbb{C}) \rightarrow H_{A}^{1}(X) \xrightarrow{\text { deg od }} \mathbb{C} \tag{1}
\end{equation*}
$$

is exact.
Indeed, take $[\alpha]_{d R} \in H_{d R}^{1}(X ; \mathbb{C})$ yielding a zero class in Aeppli cohomology, that is, $\alpha=\partial f+\bar{\partial} g$ for $f, g \in \mathcal{C}^{\infty}(X ; \mathbb{C})$. Since $\mathrm{d} \alpha=0$, then $\partial \bar{\partial}(f-g)=0$. By the maximum principle, we get $f-g$ constant.

Then $\alpha=\mathrm{d} f$ yields the zero class in de Rham cohomology. We have that (1) is a complex, and it remains to show that all classes in $H_{A}^{1}(X)$ of degree 0 come from $H_{d R}^{1}(X)$.

Let $[\alpha]_{A} \in H_{A}^{1}(X)$ satisfy $\operatorname{deg}[\mathrm{d} \alpha]_{B C}=0$. Choose a representative $\alpha \in \wedge^{1} X \otimes \mathbb{C}$. Let $\rho=\mathrm{d} \alpha$ be decomposed as $\rho=\rho^{(1,1)}+\rho^{(2,0)}+\rho^{(0,2)}$. Without restricting the generality we may assume that $\rho$ is real, giving $\rho^{(2,0)}=\overline{\rho^{(2,0)}}$. Since $\alpha$ is $\mathrm{dd}^{c}$-closed, $\mathrm{d} \alpha$ is both d and $\mathrm{d}^{c}$-closed, hence the forms $\rho^{(1,1)}$, $\rho^{(2,0)}$ and $\rho^{(0,2)}$ are closed. Since $\rho$ is $\mathrm{d}^{c}$-closed and d-exact, the form $\rho \wedge \rho^{(0,2)}$ is also $\mathrm{d}^{c}$-closed and d -exact. However, a product of a $\mathrm{d}^{c}$-closed and d-exact 4 -form $\mathrm{d} \nu$ with $\omega^{n-2}$ is exact by Lemma 1.6 above. This gives

$$
0=\int_{X} \rho \wedge \rho^{(0,2)} \wedge \omega^{n-2}=\int_{X} \rho^{(0,2)} \wedge \rho^{(2,0)} \wedge \omega^{n-2}=\int_{X}\left|\rho^{(0,2)}\right|^{2} \omega^{n}
$$

This implies that $\rho=\mathrm{d} \alpha$ is of type $(1,1)$. By Lemma 1.1, we can replace the representative $\alpha$ by $\alpha-\mathrm{d}^{c} f$ in Aeppli cohomology in such a way that $\mathrm{d}\left(\alpha-d^{c} f\right)=0$, thus proving the claim.

It follows that

$$
\operatorname{dim}_{\mathbb{C}} H_{A}^{1}(X)-b_{1}=1-\operatorname{dim}_{\mathbb{C}} \operatorname{coker}(\operatorname{deg} \circ \mathrm{d}) \in\{0,1\}
$$

according to the parity of $b_{1}$. Indeed, $\operatorname{dim}_{\mathbb{C}} H_{A}^{1}(X)$ is always even.
Note that the natural map $H_{B C}^{1}(X) \rightarrow H_{d R}^{1}(X ; \mathbb{C})$ is always injective. Then

$$
\begin{aligned}
0 \leq \Delta^{1} & =\operatorname{dim}_{\mathbb{C}} H_{A}^{1}(X)+\operatorname{dim}_{\mathbb{C}} H_{B C}^{1}(X)-2 b_{1} \\
& \leq\left(1-\operatorname{dim}_{\mathbb{C}} \operatorname{coker}(\operatorname{deg} \circ \mathrm{d})\right) \leq 1 .
\end{aligned}
$$

Since $\Delta^{1}$ has to be even, this yields $\Delta^{1}=0$.
Remark 1.8. The same statement can be proven under the hypotheses that the Hermitian (1,1)-form $\omega$ satisfies condition (a) in Lemma 1.1 and that $H_{B C}^{2,0}(X)=0$. In this case, the exactness at $H_{A}^{1}(X)$ follows directly by Lemma 1.1, noting that $[\mathrm{d} \alpha]_{B C} \in H_{B C}^{2}(X)=H_{B C}^{1,1}(X)$. The condition $H_{B C}^{2,0}(X)=0$ may hold, for example, for a hypothetical complex structure on the six-sphere with $H_{\bar{\partial}}^{2,0}(X)=0$, see e.g. [Uga00, McH1]. In low dimension, the condition is satisfied by the Bombieri-Inoue and Inoue surfaces, by the secondary Kodaira surfaces, and by the Calabi-Eckmann structure on $\mathbb{S}^{1} \times \mathbb{S}^{3}$, see e.g. [ADT16].
