# GREEN'S FORMULA AND VARIATIONAL INEQUATIONS 

MARC ATTEIA


#### Abstract

In this paper, I give an extension to the banachic - non linear- case of the work of B. Hanouzet and J.L. Joly which is quoted below in the bibliography and which was elaborated in the hilbertian-linear- case.


## 1. Introduction

Let $\mathcal{L}, \mathcal{B}, \mathcal{B}_{0}, \mathcal{B}_{1}, \mathcal{T}$ be five reflexive Banach spaces such that:
$(*) \quad \mathcal{B}_{0}\left(\right.$ resp. $\left.\mathcal{B}_{1}\right)$ is a dense vectorial subspace of $\mathcal{L}$ and $j_{0}$ (resp. $j_{1}$ ) is continuous injection from $\mathcal{B}_{0}$ (resp. $\mathcal{B}_{1}$ ) into $\mathcal{L}$.
$(* *) \quad \mathcal{B}_{0}$ is a vectorial subspace of $\mathcal{B}_{1}$, embedded with the norm of $\mathcal{B}_{1}$, which is closed in $\mathcal{B}_{1}$.
We shall denote by $j$ the (continuous) injection of $\mathcal{B}_{0}$ into $\mathcal{B}_{1}$.
$(* * *) \Gamma$ is the (closed) image of $\mathcal{B}_{1}$ in $\mathcal{T}$ by a linear mapping $\gamma_{0}$ such that:
$\operatorname{Im} j=\operatorname{ker} \gamma_{0}$.
Let us denote by $\mathcal{L}^{\prime}, \mathcal{B}^{\prime}, \mathcal{B}_{0}^{\prime}, \mathcal{B}_{1}^{\prime}, \mathcal{T}^{\prime}$ the topological duals of $\mathcal{L}, \mathcal{B}, \mathcal{B}_{0}$, $\mathcal{B}_{1}, \mathcal{T}$ respectively.
Then, ${ }^{t} j_{0}$ (resp. ${ }^{t} j_{1}$ ) is a (linear and continuous) injective mapping from $\mathcal{L}^{\prime}$ into $\mathcal{B}_{0}^{\prime}$ (resp. $\mathcal{B}_{1}^{\prime}$ ) with a dense image for the strong topology.
As : $j_{0}=j_{1} j$, we have : ${ }^{t} j_{0}={ }^{t} j{ }^{t} j_{1}$. We set : $\rho={ }^{t} j$.
As $\operatorname{Im}(j)$ is closed , $\operatorname{Im}\left({ }^{t} j\right)$ is also closed.
${ }^{t} \gamma_{0}$ is a (linear and continuous) injective mapping from $\mathcal{T}^{\prime}$ into $\mathcal{B}_{1}^{\prime}$ (embedded with its strong topology).
Moreover, $\operatorname{Im}\left({ }^{t} \gamma_{0}\right)$ is closed (as $\operatorname{Im}\left(\gamma_{0}\right)$ is closed) and we have :

$$
\operatorname{Im}\left({ }^{t} \gamma_{0}\right)=\operatorname{ker}\left({ }^{t} j\right)
$$

So, we have the following scheme :

$$

\mathcal{L}^{\prime} & \longrightarrow & \mathcal{B}_{1}^{\prime} & & \longrightarrow \\
& \mathcal{B}_{1} & \longrightarrow & \mathcal{L} \\
& \downarrow & & \uparrow \\
& \mathcal{B}_{0}^{\prime} & & \longrightarrow & \mathcal{B}_{0}
\end{array}
$$

Below, we denote by $\|\cdot\|_{\mathcal{L}}$ (resp. $\|\cdot\|_{1},\|\cdot\|_{0},\|\cdot\|_{\mathcal{T}}$ ) the norm of $\mathcal{L}$ (resp. $\left.\mathcal{B}_{1}, \mathcal{B}_{0}, \mathcal{T}\right)$ and by $\langle\cdot, \cdot\rangle_{\mathcal{L}^{\prime}, \mathcal{L}}$ (resp. $\langle\cdot, \cdot\rangle_{1},\langle\cdot, \cdot\rangle_{0},\langle\cdot, \cdot\rangle_{\mathcal{T}^{\prime}, \mathcal{T}}$ ) the duality bracket between $\mathcal{L}$ and $\mathcal{L}^{\prime}$ (resp. $\mathcal{B}_{1}$ and $\mathcal{B}_{1}^{\prime}, \mathcal{B}_{0}$ and $\mathcal{B}_{0}^{\prime}, \mathcal{T}$ and
$\left.\mathcal{T}^{\prime}\right)$.
So, we have the following scheme :

$$
\begin{array}{rlll}
\mathcal{L}^{\prime} & \longrightarrow & { }^{t} j_{1} \mathcal{L}^{\prime} & \longrightarrow
\end{array} \mathcal{B}_{1}^{\prime}
$$

The restriction of $\rho$ to $\quad{ }^{t} j_{1} \mathcal{L}^{\prime}$ is injective and surjective as $\quad{ }^{t} j_{0}=\rho \circ{ }^{t} j_{1}$ and ${ }^{t} j_{0}\left({ }^{t} j_{1}\right)$ are injective.
The restriction of $\rho$ to ${ }^{t} j_{0} \mathcal{L}^{\prime}$ is bijective. Its inverse denoted by $\bar{\omega}$ is bijective.
(We don't know, however, if $\bar{\omega}$ is continuous).

## Example 1:

$\forall u, v \in H^{1}(0,1)$, let : $a(u, v)=\int_{0}^{1}\left(u^{\prime} v^{\prime}+u v\right) d t=\langle A u, v\rangle_{1}$.
Then : $\forall u, v \in H^{1}(0,1), a(u, v)=\langle L u, v\rangle_{0}$, thus: $L=\rho A$, and :
$\forall u, v \in C^{\infty}(0,1), \int_{0}^{1}\left(u^{\prime} v^{\prime}+u v\right) d t=\int_{0}^{1}\left(-u^{\prime \prime}+u\right) \cdot v d t+u^{\prime}(1) v(1)-$ $u^{\prime}(0) v(0)$.
i.e. $\langle A u, v\rangle_{1}=\langle\pi L u, v\rangle_{1}=\left\langle\gamma_{0} u, \gamma_{0} v\right\rangle_{\mathcal{T}^{\prime}, \mathcal{T}}$.

If, $v \in \mathcal{D}(0,1)$, then $:\langle\pi L u, v\rangle_{1}=\int_{0}^{1}\left(-u^{\prime \prime}+u\right) v d t=\left\langle\left(-u^{\prime \prime}+u\right), v\right\rangle_{\mathcal{D}^{\prime}(0,1), \mathcal{D}(0,1)}$

## Example 2 :

Let $p \in \mathbb{N}^{*}$.
$\forall u, v \in \mathcal{B}_{1}, h(u, v)=\int_{0}^{1}\left(\left|u^{\prime}\right|^{p-1} \operatorname{sign}\left(u^{\prime}\right) \cdot v^{\prime}\right) d t=\langle G u, v\rangle_{1}$ and :
$\forall u \in \mathcal{B}_{1}, \forall v \in \mathcal{B}_{0}, \quad h(u, v)=\int_{0}^{1}\left(\left|u^{\prime}\right|^{p-1} \operatorname{sign}\left(u^{\prime}\right) \cdot v^{\prime}\right) d t=\langle\rho G u, v\rangle_{0}$
where:
$\rho G u$ is the restriction of $G u$ to $\mathcal{B}_{0}^{\prime}$.
Formally, we can write :

$$
\langle G u, v\rangle_{1}=\langle\pi \rho G u, v\rangle_{1}+\left\langle\gamma_{G} u, \gamma_{0} v\right\rangle_{\mathcal{T}^{\prime}, \mathcal{T}}
$$

We do not need to precise, here, the definition of $\mathcal{B}_{0}$ and $\mathcal{B}_{1}$.
However, if $p>1, \mathcal{B}_{1}=\left\{u \in \mathcal{D}^{\prime}(0,1) ; u, u^{\prime} \in L^{p}(0,1)\right.$ and $\left.u(0)=0\right\}$ and $\mathcal{B}_{0}=\left\{v \in \mathcal{B}_{1} ; \gamma_{1} v=0\right\}$ with : $\forall v \in C^{1}(0,1), \gamma_{1} v=v^{\prime}(1)$ we deduce that, if $u$ is sufficiently regular, $\gamma_{G} u=\left(\left|u^{\prime}\right|^{p-1} \operatorname{sign}\left(u^{\prime}\right)\right)(1)$. (cf. "Quelques méthodes de résolution de problèmes aux limites non linéaires", de J.L. Lions, p.25).

## 2. Green's formula.

We recall that $\bar{\omega}$ is a linear mapping from ${ }^{t} j_{0} \mathcal{L}^{\prime}$ into $\mathcal{B}_{1}^{\prime}$ such that:

$$
\forall l^{\prime} \in \mathcal{L}^{\prime}, \quad \bar{\omega}^{t} j_{0} l^{\prime}={ }^{t} j_{1} l^{\prime}
$$

Let $G$ be an operator (which is linear or not) continuous from $\mathcal{B}_{1}$ into $\mathcal{B}_{1}^{\prime}$. We set :

$$
\mathcal{B}_{G}=\left\{u \in \mathcal{B}_{1} ; \rho G u \in{ }^{t} j_{0} \mathcal{L}^{\prime}\right\}
$$

Then :

$$
\begin{aligned}
\forall u \in & \mathcal{B}_{G}, \exists l^{\prime} \in \mathcal{L}^{\prime} \text { such that : }{ }^{t} j\left(G u-{ }^{t} j_{1} l^{\prime}\right)=\theta_{\mathcal{B}_{0}^{\prime}} \\
& \text { where } \theta_{\mathcal{B}_{0}^{\prime}} \text { is the neutral element of } \mathcal{B}_{0}^{\prime}
\end{aligned}
$$

Thus, we deduce that:

$$
G u-{ }^{t} j_{0} l^{\prime}=G u-\bar{\omega}^{t} j_{0} l^{\prime} \in \operatorname{ker}{ }^{t} j=\stackrel{t}{\operatorname{Im}} \gamma_{0}
$$

So :

$$
G u-\bar{\omega}^{t} j_{0} l^{\prime}=G u-\bar{\omega} \rho G u={ }^{t} \gamma_{0} z^{\prime}, \text { with } z^{\prime} \in \mathcal{T}^{\prime}
$$

We shall set, in the following :

$$
\forall u \in \mathcal{B}_{G}, \gamma_{G} u={ }^{t} \gamma_{0}^{-1}\left(I_{1}^{\prime}-\bar{\omega} \rho\right) G u \in \mathcal{T}^{\prime}
$$

where $I_{1}^{\prime}$ is the identity of $\mathcal{B}_{1}^{\prime}$.

## Remarks :

$\left.{ }^{*}\right) \gamma_{G}$ is a mapping from $\mathcal{B}_{G}$ into $\mathcal{T}^{\prime}$ which is not necessarily linear, but ${ }^{t} \gamma_{0}^{-1}\left(I_{1}^{\prime}-\bar{\omega} \rho\right)$ is a linear mapping which is definite on $G\left(\mathcal{B}_{G}\right)$.
$\left({ }^{* *}\right) \quad\left(u \in \mathcal{B}_{G}\right) \Longleftrightarrow \chi_{1}^{-1} J_{1}^{*} G u \in \mathcal{B}_{J_{1}}$.
Then :

$$
\forall u \in \mathcal{B}_{G}, \forall y \in \mathcal{B}_{1}, \quad\langle G u, y\rangle_{1}=\langle\bar{\omega} \rho G u, y\rangle_{1}+\left\langle\gamma_{G} u, \gamma_{0} y\right\rangle_{\mathcal{T}^{\prime}, \mathcal{T}}
$$

Thus, we have the following scheme:

So :

$$
l_{0}=l_{1} \circ j,{ }^{t} l_{0}=\rho \circ{ }^{t} l_{1}, l_{1}=k \circ j_{1}, \quad l_{0}=k \circ j_{0}
$$

$$
\text { with } \forall e^{\prime} \in E^{\prime}, \bar{\omega}^{t} l_{0} e^{\prime}={ }^{t} l_{1} e^{\prime}
$$

## Example :

$$
\mathcal{B}_{1}=W^{1, p}(\Omega) \quad, \quad \mathcal{B}_{0}=W_{0}^{1, p}(\Omega) \quad, \quad \mathcal{L}=L^{p}(\Omega) \quad, \quad E=\mathcal{D}^{\prime}(\Omega)
$$

Now, we suppose that $j_{1}$ (resp. $j_{0}, k$ ) is a weakly dense injection (and weakly continuous) from $\mathcal{B}_{1}$ into $\mathcal{L}$ (resp. $\mathcal{B}_{0}$ into $\mathcal{L}, \mathcal{L}$ into $E$ ).
Then : ${ }^{t} j_{1}$ (resp. ${ }^{t} j_{0},{ }^{t} k$ ) is injective and its image is weakly (strongly) dense in $\mathcal{B}_{1}^{\prime}\left(\right.$ resp. $\left.\mathcal{B}_{0}^{\prime}, \mathcal{L}^{\prime}\right)$ when those vector spaces are Banach spaces (reflexive or not).
Let us set :

$$
\mathcal{B}_{G, E}=\left\{u \in \mathcal{B}_{1} ; \rho G u \in{ }^{t} l_{0} E^{\prime}\right\} \subset \mathcal{B}_{G}
$$

So :

$$
\forall u \quad \in \quad \mathcal{B}_{G, E}, \exists e^{\prime} \in E^{\prime}, \text { such that : }{ }^{t} j\left(G u-{ }^{t} l_{1} l^{\prime}\right)=\theta_{\mathcal{B}_{0}^{\prime}}
$$

$$
\Longrightarrow \quad G u-{ }^{t} l_{1} e^{\prime}=G u-\bar{\omega}_{E}{ }^{t} l_{0} e^{\prime} \in \operatorname{ker}{ }^{t} j=\stackrel{t}{\operatorname{Im}} \gamma_{0}
$$

$$
\Longrightarrow \quad G u-\bar{\omega}^{t} l_{0} e^{\prime}=G u-\bar{\omega}_{E} \rho G u={ }^{t} \gamma_{0} z^{\prime}, z^{\prime} \in \mathcal{T}^{\prime}
$$

Now, we set :

$$
\forall u \in \mathcal{B}_{G, E}, \quad \gamma_{G} u={ }^{t} \gamma_{0}^{-1}\left(I_{1}^{\prime}-\bar{\omega}_{E} \rho\right) G u \in \mathcal{T}^{\prime}
$$

## Remark :

$\forall e^{\prime} \in E^{\prime}, \bar{\omega}_{E}{ }^{t} j_{0}{ }^{t} k e^{\prime}={ }^{t} j_{1}{ }^{t} k e^{\prime}=\bar{\omega}^{t} j_{0}{ }^{t} k e^{\prime}$
Thus: $\bar{\omega}_{E}$ is the restriction of $\bar{\omega}$ to ${ }^{t} j_{0}{ }^{t} k E^{\prime}$ which is contained in ${ }^{t} j_{0} \mathcal{L}^{\prime}$, and :

$$
\forall u \in \mathcal{B}_{G, E}, \quad \forall y \in \mathcal{B}_{1}, \quad\langle G u, y\rangle_{1}=\left\langle\bar{\omega}_{E} \rho G u, y\right\rangle_{1}+\left\langle\gamma_{G, E} u, \gamma_{0} y\right\rangle_{\mathcal{T}^{\prime}, \mathcal{T}}
$$

where $\gamma_{G, E}$ is the restriction of $\gamma_{G}$ to $\mathcal{B}_{G, E} \subset \mathcal{B}_{G}$.
3. An order on $\mathcal{L}$ and its induced order on $\mathcal{B}_{1}$ (resp. $\mathcal{B}_{0}$ ).

Let $C^{+}$be a closed convex cone in $\mathcal{L}$ with $\theta_{\mathcal{L}}$ as its vertex.
Then :

$$
\mathcal{L}=C^{+}-C^{+} \text {and } \theta_{\mathcal{L}}=C^{+} \cap\left(-C^{+}\right)
$$

Let :

$$
C_{m}^{+}=\left\{u \in \mathcal{B}_{m} ; j_{m} u \in C^{+}\right\} \text {for } m=0,1
$$

We have :

$$
\mathcal{B}_{m}=C_{m}^{+}-C_{m}^{+} \text {and } \theta_{\mathcal{B}_{m}}=C_{m}^{+} \cap\left(-C_{m}^{+}\right) \text {for } m=0,1
$$

## Hypotheses :

We suppose that :
(*) for $m=0,1, j_{m} C_{m}^{+}$is dense in $C^{+}$(for the topology of $\mathcal{L}$ ).
$(* *) \mathcal{B}_{m}$ is nested for the order induced by that of $\mathcal{L}$.
If $u \in\left[C^{+}\right]$(resp. $C_{1}^{+}, C_{0}^{+}$), we shall write : $u \geq 0$ (and $u \leq 0$ if $u \in\left(-C^{+}\right)=C^{-}$(resp. $\left(-C_{m}^{+}=C_{m}^{-}\right)$for $m=0,1$ )
We shall denote by $D^{+}\left(\right.$resp. $\left.D_{1}^{+}, D_{0}^{+}\right)$the polar cone of $C^{+}\left(\right.$resp. $C_{1}^{+}$
, $C_{0}^{+}$) for the duality between $\mathcal{L}$ and $\mathcal{L}^{\prime}$ (resp. $\mathcal{B}_{1}$ and $\mathcal{B}_{1}^{\prime}, \mathcal{B}_{0}$ and $\left.\mathcal{B}_{0}^{\prime}\right)$. So :

$$
D^{+}=\left\{x^{*} \in \mathcal{L}^{\prime} ; \forall x \in C^{+},\left\langle x^{*}, x\right\rangle \geq 0\right\}
$$

$D^{+}$(resp. $D_{m}^{+}$for $m=0,1$ ) is a weakly (and strongly) closed cone as $\mathcal{B}$ (resp. $\mathcal{B}_{m}$ for $m=0,1$ ) is reflexive.
If $u^{*} \in D^{+}$(resp. $D_{m}^{+}$for $m=0,1$ ), we shall write $u^{*} \geq 0$ and $u^{*} \leq 0$ if $u \in\left(-D^{+}\right)=D^{-}$(resp. $\left(-D_{m}^{+}=D_{m}^{-}\right)$for $\left.m=0,1\right)$.
Proposition 1. $D_{m}^{+}$is the adherence of ${ }^{t} j_{m} D^{+}$in $\mathcal{B}_{m}^{\prime}$ for $m=0,1$.
Proof. First, we remark that : ${ }^{t} j_{m} D^{+} \subset D_{m}^{+}$(we have : ${ }^{t} j_{0} D^{+}=\rho^{t} j_{1} D^{+}$ ).
Indeed: $\forall l^{\prime} \in D^{+}, \forall u \in C_{m}^{+},\left\langle{ }^{t} j_{m} l^{\prime}, u\right\rangle_{m}=\left\langle l^{\prime}, j_{m} u\right\rangle_{\mathcal{L}^{\prime}, \mathcal{L}} \geq 0$.
Let us suppose that: ${ }^{t} j_{m} D^{+} \subsetneq D_{m}^{+}$and let: $u^{\prime} \in D_{m}^{+} \backslash \overline{{ }^{t} j_{m} D^{+}}$.
As $\overline{{ }^{t} j_{m} D^{+}}$is a closed convex cone (with $\theta_{\mathcal{B}_{m}^{\prime}}$ as its vertex)
and as $\mathcal{B}_{m}$ is reflexive, there exists $u \in \mathcal{B}_{m}$ such that:

$$
\forall l^{\prime} \in D^{+},\left\langle{ }^{t} j_{m} l^{\prime}, u\right\rangle_{m} \geq 0 \text { and : }\left\langle u^{\prime}, u\right\rangle_{m}<0
$$

Thus, we have :

$$
\forall l^{\prime} \in D^{+},\left\langle l^{\prime}, j_{m} u\right\rangle \geq 0 \text { and }:\left\langle u^{\prime}, u\right\rangle_{m}<0
$$

So :

$$
\left(j_{m} u \geq 0, u \geq 0 \text { and }:\left\langle u^{\prime}, u\right\rangle_{m}<0\right) \quad \text { what is impossible. }
$$

Lemma 2. $\bar{\omega}$ is an homomorphism for the oder structures which are definite on ${ }^{t} j_{0} \mathcal{L}^{\prime}$ and ${ }^{t} j_{1} \mathcal{L}^{\prime}$ respectively by ${ }^{t} j_{0} D^{+}$and ${ }^{t} j_{1} D^{+}$.
Moreover : $\bar{\omega}\left({ }^{t} j_{0} D^{+}\right)={ }^{t} j_{1} D^{+}$.
Proof. $\left(l^{\prime} \in \mathcal{L}^{\prime},{ }^{t} j_{m} l^{\prime} \geq 0\right) \Longleftrightarrow\left(l^{\prime} \in \mathcal{L}^{\prime}, l^{\prime} \geq 0\right)$ for $m=0,1$ because $\left({ }^{t} j_{m} l^{\prime} \geq 0\right) \Longleftrightarrow\left(\forall v \in C_{m}^{+}, \quad\left\langle{ }^{t} j_{m} l^{\prime}, v\right\rangle_{m}=\left\langle l^{\prime}, j_{m} v\right\rangle_{m} \geq 0\right)$
$\Longleftrightarrow\left(\forall u \in C^{+},\left\langle l^{\prime}, u\right\rangle \geq 0\right)$ (because ${ }^{t} j_{m} C^{+}$is dense in $\left.C^{+}\right)$.
Thus: $\left({ }^{t} j_{0} l^{\prime} \geq 0\right) \Longrightarrow\left(\bar{\omega}^{t} j_{0} l^{\prime}={ }^{t} j_{1} l^{\prime} \geq 0\right)$.
Lemma 3. $\forall u \in C_{1}^{+}, \forall v^{\prime} \in \rho D_{1}^{+}, \forall w^{\prime} \in(\rho)^{-1} v^{\prime}$,

$$
\operatorname{Sup}\left\{\left\langle v^{\prime}, v\right\rangle_{0} ; 0 \leq v \leq u, v \in \mathcal{B}_{0}\right\} \leq\left\langle w^{\prime}, u\right\rangle_{1} .
$$

Proof.

$$
\forall v \in \mathcal{B}_{0}, 0 \leq v \leq u,\left\langle v^{\prime}, v\right\rangle_{0}=\left\langle\rho w^{\prime}, v\right\rangle_{0}=\left\langle w^{\prime}, j v\right\rangle_{1} \leq\left\langle w^{\prime}, u\right\rangle_{1}
$$

Lemma 4. $\forall u \in C_{1}^{+}, \forall v^{\prime} \in{ }^{t} j_{0} D^{+}=\rho^{t} j_{1} D_{1}^{+},\left\langle\bar{\omega} v^{\prime}, u\right\rangle_{1}=\operatorname{Sup}\left\{\left\langle v^{\prime}, v\right\rangle_{0} ; 0 \leq v \leq u\right\}$ Proof. Let $v \in C_{0}^{+}$such that: $u-j v \in C_{1}^{+}$.Then : $\left\langle\bar{\omega} v^{\prime}, u-j v\right\rangle_{1}=\left\langle{ }^{t} j_{1} l^{\prime}, u-j v\right\rangle_{1}=\left\langle l^{\prime}, j_{1}(u-j v)\right\rangle_{\mathcal{L}^{\prime}, \mathcal{L}} \geq 0 \quad\left(\right.$ where $\left.l^{\prime} \in D^{+}\right)$
Thus:

$$
\left\langle\bar{\omega} v^{\prime}, u\right\rangle_{1} \geq\left\langle v^{\prime}, v\right\rangle_{0} .
$$

On the other hand, we know that there exists a sequence ( $v_{m} ; m \in \mathbb{N}$ ) contained in $C_{0}^{+}$such that:

$$
\forall p \in \mathbb{N}, u-j v_{p} \in C_{1}^{+} \quad \text { and } \quad \lim _{p \rightarrow \infty}\left\|j_{0} v_{p}-j_{1} u\right\|_{\mathcal{L}}=0
$$

We deduce that:

$$
\forall p \in \mathbb{N},\left\langle\bar{\omega} v^{\prime}, u\right\rangle_{1} \geq\left\langle v^{\prime}, v_{p}\right\rangle_{0}
$$

and :

$$
\begin{aligned}
