# ON THE STABILITY OF TYPE I BLOW UP FOR THE ENERGY SUPER CRITICAL HEAT EQUATION

Abstract. We consider the energy super critical semilinear heat equation

$$
\partial_{t} u=\Delta u+u^{p}, \quad x \in \mathbb{R}^{3}, \quad p>5 .
$$

We first revisit the construction of radially symmetric self similar solutions performed through an ode approach in [51, [2], and propose a bifurcation type argument suggested in 3] which allows for a sharp control of the spectrum of the corresponding linearized operator in suitable weighted spaces. We then show how the sole knowledge of this spectral gap in weighted spaces implies the finite codimensional non radial stability of these solutions for smooth well localized initial data using energy bounds. The whole scheme draws a route map for the derivation of the existence and stability of self similar blow up in non radial energy super critical settings.

## 1. Introduction

1.1. Setting of the problem. We consider the focusing nonlinear heat equation

$$

\partial_{t} u=\Delta u+|u|^{p-1} u, \quad(t, x) \in \mathbb{R} \times \mathbb{R}^{d}  \tag{1.1}\\
u_{\left.\right|_{t=0}}=u_{0}
\end{array}\right.
$$

where $p>1$. This model dissipates the total energy

$$
\begin{equation*}
E(u)=\frac{1}{2} \int|\nabla u|^{2}-\frac{1}{p+1} \int u^{p+1}, \quad \frac{1}{2} \frac{d E}{d t}=-\int\left(\partial_{t} u\right)^{2}<0 \tag{1.2}
\end{equation*}
$$

and admits a scaling invariance: if $u(t, x)$ is a solution, then so is

$$
\begin{equation*}
u_{\lambda}(t, x)=\lambda^{\frac{2}{p-1}} u\left(\lambda^{2} t, \lambda x\right), \quad \lambda>0 \tag{1.3}
\end{equation*}
$$

This transformation is an isometry on the homogeneous Sobolev space

$$
\left\|u_{\lambda}(t, \cdot)\right\|_{\dot{H}^{s_{c}}}=\|u(t, \cdot)\|_{\dot{H}^{s_{c}}} \text { for } s_{c}=\frac{d}{2}-\frac{2}{p-1}
$$

We address in this paper the question of the existence and stability of blow up dynamics in the energy super critical range $s_{c}>1$ emerging from well localized initial data.
1.2. Type I and type II blow up. There is a large litterature devoted to the question of the description of blow up solutions for (1.1) and we recall some key facts related to our analysis.

Type I blow-up. The universal scaling lower bound on blow up rate

[^0]is saturated by Type I singularities:
$$
\|u(t, \cdot)\|_{L^{\infty}} \sim \frac{1}{(T-t)^{\frac{1}{p-1}}} .
$$

These solutions concentrate to leading order a blow up profile

$$
u(t, x) \sim \frac{1}{\lambda(t)^{\frac{2}{p-1}}} v\left(\frac{x}{\lambda(t)}\right), \quad \lambda(t)=\sqrt{T-t},
$$

which solves the non linear elliptic equation

$$
\begin{equation*}
\Delta v-\frac{1}{2} \Lambda v+v^{p}=0, \quad \Lambda v=\frac{2}{p-1} v+y \cdot \nabla v . \tag{1.4}
\end{equation*}
$$

There are three known classes of radial solutions to (1.4):

- the constant solution

$$
\kappa=\left(\frac{1}{p-1}\right)^{\frac{1}{p-1}}
$$

which generates the stable ODE type blow up [20, 21, 22, 23, 39, 40];

- the singular at the origin homogeneous self similar solution

$$
\begin{equation*}
\Phi_{*}=\frac{c_{\infty}}{|x|^{\frac{2}{p-1}}}, \quad c_{\infty}=\left(\frac{2}{p-1}\left(d-2-\frac{2}{p-1}\right)\right)^{\frac{1}{p-1}} \tag{1.5}
\end{equation*}
$$

- for

$$
1+\frac{4}{d-2}<p<p_{J L}=\left\{\begin{array}{l}
+\infty \text { for } d \leq 10,  \tag{1.6}\\
1+\frac{4}{d-4-2 \sqrt{d-1}} \text { for } d \geq 11,
\end{array}\right.
$$

where $p_{J L}$ is the so called Joseph-Lundgren exponent, there exists a quantized sequence of smooth radially symmetric solutions $\Phi_{n}$ to (1.4) which behave like

$$
\Phi_{n}(r) \sim \frac{c_{n}}{r^{\frac{2}{p-1}}} \text { as } r \rightarrow+\infty
$$

These solutions have been constructed using global Lyapounov functionals based ODE methods, [30, 51, 1, 2, and a sharp condition for their existence in the radial positive class is given in [44].
Note that all these profiles have infinite energy and it is not clear how they may participate in singularity formation emerging from smooth well localized initial data. In the radially symmetric setting, the series of breakthrough works [35, 36] gives partial answers showing the universality of the ODE blow up, and the possiblity of threshold dynamics with $\Phi^{*}$ or $\Phi_{n}$ regimes depending on the value of $p$. The analysis however is strongly restricted to the radial setting and uses the intersection number Lyapounov functionals based on the maximum principle. In particular this approach does not provide any insight into the direct construction of these blow up profiles and their dynamical stability in the non radial setting.

Type II blow-up. For $p>p_{J L}$, there exist type II blow-up solutions

$$
\lim _{t \rightarrow T}\|u(t)\|_{L^{\infty}}(T-t)^{\frac{1}{p-1}}=+\infty .
$$

They appear in the radial setting as threshold dynamics again at the boundary of the ODE blow up set, [37, and dynamical proofs were proposed in [25, 43, 45]. Their construction has been revisited in [42, 6] in the setting of dispersive Schrödinger and wave equations, and in $[7$ for the non radial heat equation, to produce the full
quantized sequence of smooth type II blow up bubbles. The blow-up profile near the singularity is a stationary profile:

$$
u(t, x) \sim \frac{1}{\lambda(t)^{\frac{2}{p-1}}} Q\left(\frac{x}{\lambda(t)}\right), \quad \lambda(t) \ll \sqrt{T-t}
$$

where $Q$ solves the soliton equation:

$$
\begin{equation*}
\Delta Q+Q^{p}=0 . \tag{1.7}
\end{equation*}
$$

The heart of the analysis is to control the flow near $Q$ using suitable energy estimates, hence avoiding maximum principle tools or spectral arguments. Type II is intimately connected to the singular self similar profile (1.5), see [25, 42] for a discussion on this fundamental matter.
1.3. Statement of the result. Our aim in this paper is to propose a robust approach for both the existence and stability of self similar blow up with smooth self similar $\Phi_{n}$ like profile. For the sake of simplicity, we restrict ourselves to

$$
\begin{equation*}
d=3, \quad p>5, \quad p_{J L}=+\infty . \tag{1.8}
\end{equation*}
$$

We first revisit the construction of self similar blow up solutions of [51, 2] and implement an abstract bifurcation argument which relies on the sole existence of the stationary profile $Q$ given by (1.7). Note that this kind of argument is classical in the ODE literature, see for example [1, 11, 9, and relies on the oscillatory nature of the eigenfunctions of the linearized operator close to $\Phi^{*}$ for $p<p_{J L}$.
Proposition 1.1 (Existence and asymptotic of excited self similar solutions). Assume (1.8). For all $n>N$ large enough, there exist ${ }^{1}$ smooth radially symmetric solution to the self similar equation (1.4) such that

\Lambda \Phi_{n} \text { vanishes exactly } n \text { times on }(0,+\infty) .
$$

Moreover, there exists a small enough constant $r_{0}>0$ independent of $n$ such that: 1. Behavior at infinity:

\lim _{n \rightarrow+\infty} \sup _{r \geq r_{0}}\left(1+r^{\frac{2}{p-1}}\right)\left|\Phi_{n}(r)-\Phi_{*}(r)\right|=0 . \tag{1.9}
\end{equation*}

2. Behaviour at the origin: there exists a sequence $\mu_{n}>0$ with $\mu_{n} \rightarrow 0$ as $n \rightarrow+\infty$ such that

$$
\begin{equation*}
\lim _{n \rightarrow+\infty} \sup _{r \leq r_{0}}\left|\Phi_{n}(r)-\frac{1}{\mu_{n}^{\frac{2}{p-1}}} Q\left(\frac{r}{\mu_{n}}\right)\right|=0 . \tag{1.10}
\end{equation*}
$$

Hence these solutions realize a connection between the ground state behavior $Q$ at the origin, and the homogeneous self similar decay $\Phi_{*}$ at infinity. We now claim that these solutions are the blow up profile of a class of finite energy initial data leaving on a non radial n codimensional manifold.
Theorem 1.2 (Finite codimensional stability of $\Phi_{n}$ ). Assume (1.8). Let $n>N$ large enough. There exists a Lipschitz codimension n manifold $\boldsymbol{q}^{2}$ of non radial initial data with finite energy

where $A_{0} \gg 1$ is large enough and $w_{0}$ is small enoug $]^{3}$

$$
\begin{equation*}
\left\|w_{0}\right\|_{H_{\rho}^{2}}+\left\|\Delta w_{0}\right\|_{L^{2}}+\left\|w_{0}\right\|_{\dot{H}^{s c}} \ll 1, \tag{1.11}
\end{equation*}

[^1]such that the corresponding solution to (1.1) blows up in finite time $0<T<+\infty$ with a decomposition
$$
u(t, x)=\frac{1}{\lambda(t)^{\frac{2}{p-1}}}\left(\Phi_{n}+v\right)\left(t, \frac{x-x(t)}{\lambda(t)}\right)
$$
where:

1. Control of the geometrical parameters: the blow up speed is self similar

$$
\lambda(t)=\sqrt{(2+o(1))(T-t)} \text { as } t \rightarrow T
$$

and the blow up point converges

$$
\begin{equation*}
x(t) \rightarrow x(T) \quad \text { as } \quad t \rightarrow T \tag{1.12}
\end{equation*}
$$

2. Behaviour of Sobolev norms: there holds the asymptotic stability of the self similar profile above scaling

\lim _{t \rightarrow T}\|v(t)\|_{\dot{H}^{s}}=0 \quad \text { for } \quad s_{c}<s \leq 2 \tag{1.13}
\end{equation*}

the boundedness of norms below scaling

$$

\limsup _{t \rightarrow T}\|u(t)\|_{\dot{H}^{s}}<+\infty \quad \text { for } 1 \leq s<s_{c} \tag{1.14}
\end{equation*}
$$

and the logarithmic growth of the critical norm

$$
\begin{equation*}
\|u(t)\|_{H^{s_{c}}}=c_{n}\left(1+o_{t \rightarrow T}(1)\right) \sqrt{|\log (T-t)|}, \quad c_{n} \neq 0 \tag{1.15}
\end{equation*}

Comments on the results.

1. On the construction of self similar solutions. The construction of self similar solutions has been performed in [51, 2] using a global Lyapounov functional ode approach. A very interesting variational approach has also been developed in [5, [19] in the setting of the related wave map problem. But there are many classical problems which lack both the variational structure and the monotonicity formulas, hence the need for a more systematic approach typically connected in a way or another to a bifurcation argument, which is the method we are implementing here. This procedure has been applied in various settings, see for example [1, 11]. One advantage is that the proof further allows for a control of the linearized operator near the bifurcated object. The prize to pay however is that we only get the bifurcated family locally near the bifurcation point, and not the whole branch 4 , in particular not the fundamental mode. A closely related theorem is the construction [29] for the KdV equation near the critical exponent.
2. Stability of self similar blow up. There is an important literature devoted to the stability of self similar solutions for both parabolic and dispersive problems. We aim at developing a robust approach which will extend to more complicated systems. Hence we avoid on purpose maximum principle like tools. In [13, 14, 15, 16, this kind of question has also been addressed for the radially symmetric supercritical wave map problem, Yang-Mills, wave equation and Yang-Mills heat flow. In those works, the analysis requires a detailed description of the complex spectrum of the linearized operator in suitable spaces which is a delicate matter, and seems to rely heavily on the fact that in the cases under consideration, the self similar solution has an explicit formula. Our approach is different: once we know the spectral gap estimate with exponential weight which is an elementary consequence of either the

[^2]variational characterization of the self similar solution as in [5], or the construction of the solution by bifurcation as in the setting of Proposition 1.1 then the control of the nonlinear flow follows by adapting the general strategy based on energy bounds of [48, 42]. In fact, the exponential decay bounds behind (1.13) considerably simplify the analysis with respect to the study of type II blow up. The connexion with type II blow up has been made in [26] using exponential weights again, and the analysis is indeed intrinsically more involved. This energy method in weighted spaces also draws a natural connexion with the analysis of ODE type I blow up for both the heat and the wave equation [21, 39, 41]. Note also that we assume (1.8) for the sake of simplicity only 5 . The solutions of Theorem 1.2 will be obtained using first a by now classical Brouwer like topological argument [10, 42], which is then complemented by a local uniqueness statement to construct the Lipschitz manifold as in [6, 33, 28, 17].
3. The flow near the ground state. The question of the classification of the flow near the special class of stationary solutions $Q$ has attracted a considerable attention in the past ten years in connection with the construction of the unstable manifold [46], or the complete classification of the flow near $Q$ in energy subcritical 46, 34 and critical settings [8. The corresponding instabilities are central in the derivation of unstable type II blow up bubbles, 42. From (1.10), the self similar solution ressembles the solitary wave $Q$ up to scaling near the origin, and hence the stability Theorem 1.2 can be viewed as describing one instability of the solitary wave solution in a suitable function space. Here a fundamental issue is that the linearized operator $H=-\Delta-p Q^{p-1}$ is unbounded from below in the sense of quadratic forms for $p<p_{J L}$. This is a major difference with respect to the case $p>p_{J L}$ where $H>0$. Our analysis in this paper shows how the nonlinear bifurcated solution $\Phi_{n}$ precisely allows for the suitable modification of the linearized operator which fixes this unboundedness from below of $H$. One also observes the same behaviour of Sobolev norms (1.13), (1.14) as in [42] which illustrates the deep non trivial structure in space of the associated blow up scenarid. Let us also stress that the nature of our energy like non linear estimates goes far beyond the stability issues of specific dynamics, and has allowed in [34 in a dispersive setting and [8] in the parabolic setting for a complete description of the flow near the ground states.

This paper and [48, 42, 6, 7] hence display a deep unity and design a route map based on robust energy estimates for the proof of the existence and stability of type I or type II blow up bubbles in both radial and non radial settings.

Notations. From now on and for the rest of this paper we fix

The ground state expansion. We let $\Phi_{*}$ given by (1.5) be the unique radial homogenous self similar solution to (1.4). We let $Q(r)$ denote the unique radially symmetric solution to

The next term is this expansion relates to the $p_{J L}$ exponent (1.6) which is infinite in dimension $d=3$. Hence the quadratic polynomial

has complex roots

$$
\begin{equation*}
\gamma=\frac{1}{2} \pm i \omega, \quad \Delta:=1-4 p c_{\infty}^{p-1}<0, \quad \omega:=\frac{\sqrt{-\Delta}}{2} \tag{1.16}
\end{equation*}
$$

and the asymptotic behavior of $Q$ may be precised ${ }^{8}$ :

\end{equation*}

where $c_{1} \neq 0$ and $c_{2} \in \mathbb{R}$. Note that

$$
\frac{1}{2}-\frac{2}{p-1}=s_{c}-1>0
$$

so that the second term in the expansion of $Q$ is indeed a correction term.
Weighted spaces. We define the derivation operator

We define the scalar product

and let $L_{\rho}^{2}$ be the corresponded weighted $L^{2}$ space. We let $H_{\rho}^{k}$ be the completion of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ for the norm

Linearized operators. The scaling semi-group on functions $u: \mathbb{R}^{d} \rightarrow \mathbb{R}$ :

has for infinitesimal generator the linear operator

We define the linearized operator corresponding to (1.4) around respectively $\Phi_{*}$ and $\Phi_{n}$ by

[^4]Note that $\mathcal{L}_{\infty}$ is formally self adjoint for the $L_{\rho}^{2}$ scalar product but (1.16) implies that the associated quadratic form is not bounded from below ${ }^{9}$ on $H_{\rho}^{1}$. We similarly define the linearized operator corresponding to (1.7) around $Q$ :

and again $H$ is not bounded from below on $\dot{H}^{1}$.
General notation. We let $\chi(x)$ denote a smooth radially symmetric function with

\chi(x):= \begin{cases}1 & \text { for } \quad|x| \leq \frac{1}{4} \\ 0 & \text { for } \\ |x| \geq \frac{1}{2}\end{cases}

and for $A>0$ (note the difference with (1.19) ),

Organization of the paper. This paper is organized as follows. In section 2, we construct the family of self similar solutions $\Phi_{n}$ using a nonlinear matching argument. The argument is classical, but requires a careful track of various estimates to obtain the sharp bounds (1.9), (1.10). In section 3, we show how these bounds coupled with Sturm-Liouville like arguments allow for a sharp counting of the number of instabilities of the linearized operator close to $\Phi_{n}$ which is self adjoint against the confining measure $\rho(y) d y$, Proposition 3.1. In section 4, we turn to the heart of the dynamical argument and show how the spectral estimates in the weighted space coupled with the control of the super critical $\dot{H}^{2}$ norm design a stability zone for well localized initial data.

## 2. Construction of self-similar profiles

Our aim in this section is to construct radially symmetric solutions to the self similar equation

$$
\begin{equation*}
\Delta v-\Lambda v+v^{p}=0 \tag{2.1}
\end{equation*}
$$

by using the classical strategy of gluing solutions which behave like $\Phi_{*}$ at infinity, and like $Q$ at the origin. As in [3, 11, 1], the matching is made possible by the oscillatory behaviour (1.17) for $p<p_{J L}$. The strength of this approach it that it relies on the implicit function theorem and not on fine monotonicity properties, and in this sense it goes far beyond the scalar parabolic setting, see for example [29] for a deeply related approach. The sharp control of the obtained solution (1.9), (1.10) will allow us to control the eigenvalues of the associated linearized operator in suitable exponentially weighted spaces, see Proposition 3.1.
2.1. Exterior solutions. Recall that $\Phi_{*}$ given by (1.5) is a solution to (2.1) on $(0,+\infty)$. Our aim in this section is to construct the full family of solutions to (2.1) on $\left[r_{0},+\infty\right)$ for some small $r_{0}>0$ with the suitable behaviour at infinity. The argument is a simple application of the implicit function theorem and continuity properties of the resolvent of $\mathcal{L}_{\infty}$ in suitable weighted spaces.

[^5]Given $0<r_{0}<1$, we define $X_{r_{0}}$ as the space of functions on $\left(r_{0},+\infty\right)$ such that the following norm is finite

where $c_{3}, c_{5} \neq 0$ and $c_{4}, c_{6} \in \mathbb{R}$. Moreover, there exists $c \neq 0$ such that

2. Continuity of the resolvent: let the inverse

\mathcal{T}(f)=\left(\int_{r}^{+\infty} f \psi_{2} r^{\prime 2} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right) \psi_{1}-\left(\int_{r}^{+\infty} f \psi_{1} r^{\prime 2} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right) \psi_{2},
$$

then

$$
\mathcal{L}_{\infty}(\mathcal{T}(f))=f
$$

and

$$
\begin{equation*}
\|\mathcal{T}(f)\|_{X_{r_{0}}} \lesssim \int_{r_{0}}^{1}|f| r^{\prime \frac{3}{2}} d r^{\prime}+\sup _{r \geq 1} r^{\frac{2}{p-1}+2}|f| . \tag{2.6}
\end{equation*}
$$

Proof. The proof is classical and we sketch the details for the reader's convenience.
step 1 Basis of homogeneous solutions. Recall (1.16). Let the change of variable and unknown

& \partial_{y}\left(\frac{1}{y^{\frac{\gamma}{2}}} \phi(y)\right)=\frac{1}{y^{\frac{\gamma}{2}}} \phi^{\prime}(y)-\frac{\gamma}{2 y^{\frac{\gamma}{2}+1}} \phi(y), \\
& \partial_{y}^{2}\left(\frac{1}{y^{\frac{\gamma}{2}}} \phi(y)\right)=\frac{1}{y^{\frac{\gamma}{2}}} \phi^{\prime \prime}(y)-\frac{\gamma}{y^{\frac{\gamma}{2}+1}} \phi^{\prime}(y)+\frac{\gamma}{2}\left(\frac{\gamma}{2}+1\right) \frac{1}{y^{\frac{\gamma}{2}+2}} \phi(y),
\end{aligned}
$$

we infer

$$
\begin{aligned}
\mathcal{L}_{\infty}(\psi) & =\left\{-4 y\left(\frac{1}{y^{\frac{\gamma}{2}}} \phi^{\prime \prime}(y)-\frac{\gamma}{y^{\frac{\gamma}{2}+1}} \phi^{\prime}(y)+\frac{\gamma}{2}\left(\frac{\gamma}{2}+1\right) \frac{1}{y^{\frac{\gamma}{2}+2}} \phi(y)\right)\right. \\
& \left.+(-6+2 y)\left(\frac{1}{y^{\frac{\gamma}{2}}} \phi^{\prime}(y)-\frac{\gamma}{2 y^{\frac{\gamma}{2}+1}} \phi(y)\right)+\left(\frac{2}{p-1}-\frac{p c_{\infty}^{p-1}}{y}\right) \frac{1}{y^{\frac{\gamma}{2}}} \phi(y)\right\} \\
& =\frac{1}{y^{\frac{\gamma}{2}}}\left\{-4 y \phi^{\prime \prime}(y)+(4 \gamma-6+2 y)\right) \phi^{\prime}(y) \\
& \left.+\left(\frac{2}{p-1}-\gamma+\left(3 \gamma-\gamma(\gamma+2)-p c_{\infty}^{p-1}\right) \frac{1}{y}\right) \phi(y)\right\} .
\end{aligned}
$$

Since $\gamma$ satisfies

we infer

\mathcal{L}_{\infty}(\psi)=-\frac{4}{y^{\frac{\gamma}{2}}}\left\{y \phi^{\prime \prime}(y)+\left(-\gamma+\frac{3}{2}-\frac{y}{2}\right) \phi^{\prime}(y)+\frac{1}{4}\left(-\frac{2}{p-1}+\gamma\right) \phi(y)\right\} .

We change again variable by setting

(2.7) is known as Kummer's equation. As long as $a$ is not a negative integer - which holds in particular for our choice of $a$ in (2.8) -, a basis of solutions to Kummer's equation consists of the Kummer's function $M(a, b, z)$ and the Tricomi function $U(a, b, z)$. These special functions have the following asymptotic behavior for $z \geq 0$ (see for example [47])

M(a, b, z)=1+O(z) \text { as } z \rightarrow 0, \tag{2.10}
\end{gather*}
$$

and ${ }^{10}$ for $1 \leq \Re(b)<2$ with $b \neq 1$,

\begin{equation*}
U(a, b, z)=\frac{\Gamma(b-1)}{\Gamma(a)} z^{1-b}+\frac{\Gamma(1-b)}{\Gamma(a-b+1)}+O\left(z^{2-\Re(b)}\right) \text { as } z \rightarrow 0 . \tag{2.11}
\end{equation*}
$$

[^6]Since $w$ is a linear combination of $M(a, b, z)$ and $U(a, b, z)$, we immediately infer from (2.9), (2.10) and (2.11) the asymptotic of $w$ both as $z \rightarrow+\infty$ and $z \rightarrow 0_{+}$. Finally, since

In particular, $\mathcal{T}(f)$ corresponds to the choice $a_{1}=a_{2}=0$ and thus satisfies

Next, we estimate $\mathcal{T}(f)$ using the asymptotic behavior (2.3) and (2.4) of $\psi_{1}$ and $\psi_{2}$ as $r \rightarrow 0_{+}$and $r \rightarrow+\infty$. For $r \geq 1$, we have

\lesssim & r^{2}\left(\int_{r}^{+\infty}|f| r^{\prime \frac{2}{p-1}-1} d r^{\prime}\right)+r^{\frac{4}{p-1}-1} e^{\frac{r^{2}}{2}}\left(\int_{r}^{+\infty}|f| \frac{1}{r^{\prime} \frac{2}{p-1}} r^{\prime 2} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right) \\
\lesssim & \left\{\sup _{r>1}\left(r^{2}\left(\int_{r}^{+\infty} \frac{d r^{\prime}}{r^{\prime 3}}\right)+r^{\frac{4}{p-1}-1} e^{\frac{r^{2}}{2}}\left(\int_{r}^{+\infty} r^{\prime-\frac{4}{p-1}} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right)\right)\right\} \sup _{r \geq 1} r^{\frac{2}{p-1}+2}|f| \\
\lesssim & \sup _{r \geq 1} r^{\frac{2}{p-1}+2}|f| .
\end{aligned}
$$

Also, for $r_{0} \leq r \leq 1$, we have

\begin{aligned}
& r^{\frac{1}{2}}\left|\left(\int_{r}^{+\infty} f \psi_{2}{r^{\prime}}^{2} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right) \psi_{1}-\left(\int_{r}^{+\infty} f \psi_{1} r^{\prime 2} e^{-\frac{r^{\prime}}{2}} d r^{\prime}\right) \psi_{2}\right| \\
\lesssim & \int_{r}^{1}|f| r^{\prime \frac{3}{2}} d r^{\prime}+\int_{1}^{+\infty} r^{\prime \frac{2}{p-1}-1}|f| d r^{\prime} \lesssim \int_{r_{0}}^{1}|f| r^{\prime \frac{3}{2}} d r^{\prime}+\sup _{r \geq 1} r^{\frac{2}{p-1}+2}|f|
\end{aligned}
$$

and (2.6) is proved.
step 3 Refined control of $\psi_{1}$. We now turn to the proof of (2.5). We decompose

f & =-\mathcal{L}_{\infty}\left(\frac{1}{r^{\frac{2}{p-1}}}\right)=\partial_{r}^{2}\left(\frac{1}{r^{\frac{2}{p-1}}}\right)+\frac{2}{r} \partial_{r}\left(\frac{1}{r^{\frac{2}{p-1}}}\right)+\frac{p c_{\infty}^{p-1}}{r^{2}} \frac{1}{r^{\frac{2}{p-1}}} \\
& =\frac{2(p-3)}{p-1)} \frac{1}{r^{\frac{2}{p-1}+2}}
\end{aligned}
$$

In view of (2.12), we infer

\widetilde{\psi}_{1}=\left(a_{1}+\frac{2(p-3)}{p-1)} \int_{r}^{+\infty} \psi_{2} \frac{e^{-\frac{r^{\prime 2}}{2}}}{r^{\prime} \frac{2}{p-1}} d r^{\prime}\right) \psi_{1}+\left(a_{2}-\frac{2(p-3)}{p-1} \int_{r}^{+\infty} \psi_{1} \frac{e^{-\frac{r^{\prime 2}}{2}}}{r^{\prime} \frac{2}{p-1}} d r^{\prime}\right) \psi_{2} .
$$

On the other hand, we deduce from the asymptotic behavior of $\psi_{1}$

for some constant $c \neq 0$ and concludes the proof of Lemma 2.1
We are now in position to construct the family of outer self similar solutions as a classical consequence of the implicit function theorem.

& +\sup _{r \geq 1} r^{\frac{2}{p-1}+2}\left|G\left[\Phi_{*}, \psi_{1}, \varepsilon\right] w_{1}-G\left[\Phi_{*}, \psi_{1}, \varepsilon\right] w_{2}\right| \\
\lesssim & r_{0}^{1-s_{c}}\left\|w_{1}-w_{2}\right\|_{X_{r_{0}}} . \tag{2.18}
\end{align*}

Assume (2.17), (2.18), then we look for $w$ as the solution of the following fixed point

where $c_{7}, c_{9} \neq 0, c_{8}, c_{10} \in \mathbb{R}$.
step 2 Continuity of the resolvent. We compute

In view of the bound $\lambda^{2} r_{1}^{2} \ll 1$, the resolvent estimate (2.20) and the nonlinear estimates (2.28), (2.29), the Banach fixed point theorem applies and yields a unique solution $T_{1}$ to (2.30) which furthermore satisfies:

2.3. The matching. We now construct a solution to (2.1) by matching the exterior solution to (2.1) constructed in section 2.1 on $\left[r_{0},+\infty\right)$ to the interior solution to (2.1) constructed in section [2.2 on $\left[0, r_{0}\right]$. The oscillations (1.17) allow to perform the matching at $r_{0}$ for a quantized sequence of the small parameter $\varepsilon$ introduced in Proposition [2.2.

Proposition 2.5 (Existence of a countable number of smooth selfsimilar profiles). There exists $N \in \mathbb{N}$ large enough so that for all $n \geq N$, there exists a smooth solution $\Phi_{n}$ to (2.1) such that $\Lambda \Phi_{n}$ vanishes exactly $n$ times.

r_{0, n}=\mu_{n} r_{\Lambda Q, n}\left(1+O\left(r_{0}^{2}\right)\right)
$$

Proof. We choose $r_{0}>0$ small enough as in the proof of Proposition 2.5. We start with the proof of the first claim. Recall from the proof of Proposition 2.5 that we have for $r \geq r_{0}$

\Phi_{n}(r)=\Phi_{*}(r)+\varepsilon\left(\mu_{n}\right) \psi_{1}(r)+\varepsilon\left(\mu_{n}\right) w(r)
$$

where we have in particular

\sup _{r_{0} \leq r \leq 1} r^{\frac{1}{2}}\left(\left|\psi_{1}\right|+|w|\right)+\sup _{r \geq 1} r^{\frac{2}{p-1}}\left(\left|\psi_{1}\right|+|w|\right) \lesssim 1
$$

and

$$
\lim _{n \rightarrow+\infty} \varepsilon\left(\mu_{n}\right)=0 .
$$

We infer

$$
\begin{aligned}
& \sup _{r \geq r_{0}}\left(1+r^{\frac{2}{p-1}}\right)\left|\Phi_{n}(r)-\Phi_{*}(r)\right| \\
\lesssim & \varepsilon\left(\mu_{n}\right)\left(\sup _{r \geq r_{0}}\left(\left|\psi_{1}(r)\right|+|w(r)|\right)+\sup _{r \geq 1} r^{\frac{2}{p-1}}\left(\left|\psi_{1}(r)\right|+|w(r)|\right)\right) \\
\lesssim & \varepsilon\left(\mu_{n}\right) r_{0}^{-\frac{1}{2}}
\end{aligned}
$$

and hence

$$
\lim _{n \rightarrow+\infty} \sup _{r \geq r_{0}}\left(1+r^{\frac{2}{p-1}}\right)\left|\Phi_{n}(r)-\Phi_{*}(r)\right|=0 .
$$

Next, recall from the proof of Proposition 2.5 that we have for $r \leq r_{0}$

$$
\Phi_{n}(r)=\frac{1}{\mu_{n}^{\frac{2}{p-1}}}\left(Q+\mu_{n}^{2} T_{1}\right)\left(\frac{r}{\mu_{n}}\right)
$$

with

$$
\sup _{0 \leq r \leq \frac{r_{0}}{\mu_{n}}}(1+r)^{-\frac{3}{2}}\left|T_{1}\right| \lesssim 1 .
$$

We infer for $r \leq r_{0}$

$$
\left|\Phi_{n}(r)-\frac{1}{\mu_{n}^{\frac{2}{p-1}}} Q\left(\frac{r}{\mu_{n}}\right)\right| \leq \mu_{n}^{2-\frac{2}{p-1}}\left|T_{1}\right|\left(\frac{r}{\mu_{n}}\right) \lesssim \mu_{n}^{\frac{1}{2}-\frac{2}{p-1}}
$$

and hence

$$
\begin{equation*}
\sup _{r \leq r_{0}}\left|\Phi_{n}(r)-\frac{1}{\mu_{n}^{\frac{2}{p-1}}} Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim \mu_{n}^{s_{c}-1} . \tag{2.56}
\end{equation*}
$$

and since $\mu_{n} \rightarrow 0$ as $n \rightarrow+\infty$, (2.55) is proved.
We now estimate the localization of the last zeroes of $\Phi_{n}$ and $\Lambda Q$ before $r_{0}$. Recall that

\Lambda Q(r) \sim \frac{c_{7} \sin \left(\omega \log (r)+c_{8}\right)}{r^{\frac{1}{2}}} \text { as } r \rightarrow+\infty .
$$

Since $\sin \left(\omega \log (r)+c_{8}\right)$ changes sign on the interval

e^{-\frac{3 \pi}{2 \omega}} \frac{r_{0}}{\mu_{n}} \leq r \leq \frac{r_{0}}{\mu_{n}},

and since $r \gg 1$ on this interval, we infer by the mean value theorem that $\Lambda Q(r)$ has a zero on this interval. In particular, this yields

e^{-\frac{3 \pi}{2 \omega}} \frac{r_{0}}{\mu_{n}} \leq r_{\Lambda Q, n} \leq \frac{r_{0}}{\mu_{n}} .
$$

Also, recall from the proof of Proposition 2.5 that we have for $r \leq r_{0}$

\Lambda \Phi_{n}(r)=\frac{1}{\mu_{n}^{\frac{2}{p-1}}}\left(\Lambda Q+\mu_{n}^{2} \Lambda T_{1}\right)\left(\frac{r}{\mu_{n}}\right)
$$

Since

\Lambda Q(r) \sim \frac{c_{7} \sin \left(\omega \log (r)+c_{8}\right)}{r^{\frac{1}{2}}} \text { as } r \rightarrow+\infty
$$

and

$$
\sup _{0 \leq r \leq \frac{r_{0}}{\mu_{n}}}(1+r)^{\frac{3}{2}}\left|\Lambda T_{1}\right| \lesssim 1
$$

and since

$$
e^{-\frac{2 \pi}{\omega}} r_{0} \leq r \leq r_{0}
$$

we have $r / \mu_{n} \sim r_{0} / \mu_{n} \gg 1$ for $n \geq N$ large enough, we infer

$$
\Lambda \Phi_{n}(r) \sim \frac{c_{7} \sin \left(\omega \log (r)-\omega \log \left(\mu_{n}\right)+c_{8}\right)+O\left(r_{0}^{2}\right)}{\mu_{n}^{\frac{2}{p-1}}\left(\frac{r}{\mu_{n}}\right)^{\frac{1}{2}}}
$$

This yields

$$
\left|\omega \log \left(r_{0, n}\right)-\omega \log \left(\mu_{n}\right)+c_{8}-\left(\omega \log \left(r_{\Lambda Q, n}\right)+c_{8}\right)\right| \lesssim r_{0}^{2}
$$

and hence

$$
\begin{aligned}
r_{0, n} & =\mu_{n} r_{\Lambda Q, n} e^{O\left(r_{0}^{2}\right)} \\
& =\mu_{n} r_{\Lambda Q, n}\left(1+O\left(r_{0}^{2}\right)\right)
\end{aligned}
$$

Furthermore, since we have

e^{-\frac{3 \pi}{2 \omega}} \frac{r_{0}}{\mu_{n}} \leq r_{\Lambda Q, n} \leq \frac{r_{0}}{\mu_{n}}
$$

we deduce

$$
e^{-\frac{2 \pi}{\omega}} r_{0} \leq r_{0, n} \leq r_{0}
$$

This concludes the proof of the corollary.

## 3. Spectral gap in weighted norms

Our aim in this section is to produce a spectral gap for the linearized operator corresponding to (1.4) around $\Phi_{n}$ :

$$
\begin{equation*}
\mathcal{L}_{n}:=-\Delta+\Lambda-p \Phi_{n}^{p-1} \tag{3.1}
\end{equation*}
$$

Recall (1.18), then $\mathcal{L}_{n}$ is self adjoint for the $L_{\rho}^{2}$ scalar product. Moreover, from (A.1) and the local compactness of the Sobolev embeddings $H^{1}(|x| \leq R) \hookrightarrow L^{2}(|x| \leq R)$, and the fact that $\Phi_{n} \in L^{\infty}$, the selfadjoint operator $\mathcal{L}_{n}+M_{n}$ for the measure $\rho d x$ is for $M_{n} \geq 1$ large enough invertible with compact resolvent. Hence $\mathcal{L}_{n}$ is diagonalizable in a Hilbert basis of $L_{\rho}^{2}$, and we claim the following sharp spectral gap estimate:

Proposition 3.1 (Spectral gap for $\mathcal{L}_{n}$ ). Let $n>N$ with $N \gg 1$ large enough, then the following holds:

1. Eigenvalues. The spectrum of $\mathcal{L}_{n}$ is given by

$$
\begin{equation*}
-\mu_{n+1, n}<\cdots<-\mu_{2, n}<-\mu_{1, n}=-2<-\mu_{-1, n}=-1<0<\lambda_{0, n}<\lambda_{1, n}<\ldots \tag{3.2}
\end{equation*}
$$

with

$$
\begin{equation*}
\lambda_{j, n}>0 \text { for all } j \geq 0 \text { and } \lim _{j \rightarrow+\infty} \lambda_{j, n}=+\infty \tag{3.3}
\end{equation*}
$$

The eigenvalues $\left(-\mu_{j, n}\right)_{1 \leq j \leq n+1}$ are simple and associated to spherically symmetric eigenvectors

$$
\psi_{j, n}, \quad\left\|\psi_{j, n}\right\|_{L_{\rho}^{2}}=1, \quad \psi_{1, n}=\frac{\Lambda \Phi_{n}}{\left\|\Lambda \Phi_{n}\right\|_{\rho}}
$$

and the eigenspace for $\mu_{-1, n}$ is spanned by

$$
\begin{equation*}
\psi_{-1, n}^{k}=\frac{\partial_{k} \Phi_{n}}{\left\|\partial_{k} \Phi_{n}\right\|_{\rho}}, \quad 1 \leq k \leq 3 \tag{3.4}
\end{equation*}
$$

Moreover, there holds as $r \rightarrow+\infty$

$$
\begin{equation*}
\left|\partial_{k} \psi_{j, n}(r)\right| \lesssim(1+r)^{-\frac{2}{p-1}-\mu_{j, n}-k}, \quad 1 \leq j \leq n+1, \quad k \geq 0 \tag{3.5}
\end{equation*}
$$

2. Spectral gap. There holds for some constant $c_{n}>0$ :

$$
\begin{equation*}
\forall \varepsilon \in H_{\rho}^{1}, \quad\left(\mathcal{L}_{n} \varepsilon, \varepsilon\right)_{\rho} \geq c_{n}\|\varepsilon\|_{H_{\rho}^{1}}^{2}-\frac{1}{c_{n}}\left[\sum_{j=1}^{n+1}\left(\varepsilon, \psi_{j, n}\right)_{\rho}^{2}+\sum_{k=1}^{3}\left(\varepsilon, \psi_{0, n}^{k}\right)_{\rho}^{2}\right] \tag{3.6}
\end{equation*}
$$

In other words, $\mathcal{L}_{n}$ admits $n+1$ instability directions when $\Lambda \Phi_{n}$ vanishes $n$ times, and 0 is never in the spectrum. Moreover, there are no additional non radial instabilities apart from the trivial translation invariance (3.4).

The rest of this section is devoted to preparing the proof of Proposition 3.1 which is completed in section 3.4.
3.1. Decomposition in spherical harmonics. We first recall some basic facts about spherical harmonics. Spherical harmonics are the eigenfunctions of the LaplaceBeltrami operator on the sphere $\mathbb{S}^{2}$. The spectrum of this self-adjoint operator with compact resolvent is

\{-m(m+1), m \in \mathbb{N}\}
$$

For each $m \in \mathbb{N}$ the eigenvalue $m(m+1)$ has geometric multiplicity $2 m+1$. We then denote the associated orthonormal family of eigenfunctions by $\left(Y^{(m, k)}\right)_{m \in \mathbb{N},-m \leq k \leq m}$ so that we have

$$
L^{2}\left(\mathbb{S}^{2}\right)=\stackrel{+}{m=0}+\operatorname{Span}\left\langle Y^{(m, k)},-m \leq k \leq m\right\rangle
$$

and

$$
\begin{equation*}
-\Delta_{\mathbb{S}^{2}} Y^{(m, k)}=m(m+1) Y^{(m, k)}, \quad \int_{\mathbb{S}^{2}} Y^{(m, k)} Y^{\left(m^{\prime}, k^{\prime}\right)} d \sigma_{\mathbb{S}^{2}}=\delta_{(m, k),\left(m^{\prime}, k^{\prime}\right)} \tag{3.7}
\end{equation*}
$$

In particular, $u \in H_{\rho}^{1}$ is decomposed as

$$
u=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m} u_{m, k} Y^{(m, k)}
$$

where $u_{m, k}$ are radial functions satisfying the Parseval formula

$$
\|u\|_{\rho}^{2}=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m}\left\|u_{m, k}\right\|_{\rho}^{2}
$$

This allows us to write

$$
\begin{equation*}
\left(\mathcal{L}_{n}(u), u\right)_{\rho}=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m}\left(\mathcal{L}_{n, m}\left(u_{m, k}\right), u_{m, k}\right)_{\rho} \tag{3.8}
\end{equation*}
$$

where we recall

$$
\mathcal{L}_{n, m}:=-\partial_{r r}-\frac{2}{r} \partial_{r}+\frac{2}{p-1}+r \partial_{r}+\frac{m(m+1)}{r^{2}}-p \Phi_{n}^{p-1}
$$

We also recall for further use the definition of the operators:

\begin{aligned}
\mathcal{L}_{\infty, m} & :=-\partial_{r r}-\frac{2}{r} \partial_{r}+\frac{2}{p-1}+r \partial_{r}+\frac{m(m+1)}{r^{2}}-p \Phi_{*}^{p-1} \\
H_{m} & :=-\partial_{r r}-\frac{2}{r} \partial_{r}+\frac{m(m+1)}{r^{2}}-p Q^{p-1}
\end{aligned}
$$

3.2. Linear ODE analysis. We compute in this section the fundamental solutions of $\mathcal{L}_{n, m}, H_{m}$ and we recall the behavior of the eigenvalues of $\mathcal{L}_{\infty}$. The claims are standard and follow from a classical ODE perturbation analysis using in an essential way the uniform bound (1.10).

Lemma 3.2 (Fundamental solution for $\mathcal{L}_{n, m}, H_{m}$ ). Let $m \geq 1$. Let $\Delta_{m}>0$ be given by (C.1).

1. Basis for $\mathcal{L}_{n, m}$. Let $\phi_{n, m}$ be the solution to $\mathcal{L}_{n, m} \phi_{n, m}=0$ with the behaviour at the origin

$$
\begin{equation*}
\varphi_{n, m}=r^{m}\left[1+O\left(r^{2}\right)\right] \text { as } \quad r \rightarrow 0 \tag{3.9}
\end{equation*}
$$

then

$$
\begin{equation*}
\varphi_{n, m} \sim \frac{c_{1}}{r^{\frac{2}{p-1}}}+c_{2} r^{\frac{2}{p-1}-3} e^{\frac{r^{2}}{2}} \text { as } r \rightarrow+\infty, \quad\left(c_{1}, c_{2}\right) \neq(0,0) \tag{3.10}
\end{equation*}
$$

2. Basis for $H_{1}$ : let $m=1$, then there exists a fundamental basis $\left(\nu_{1}, \phi_{1}\right)$ with

$$
\nu_{1}(r)=\frac{Q^{\prime}(r)}{Q^{\prime \prime}(0)} \left\lvert\, \begin{align*}
& =r\left[1+O\left(r^{2}\right)\right] \quad \text { as } \quad r \rightarrow 0  \tag{3.11}\\
& \sim \frac{c_{1,+}+\sqrt{\Delta_{1}}}{2}
\end{align*}\right. \text { as } \quad r \rightarrow+\infty
$$

and

$$
\phi_{1}(r)=\left\lvert\, \begin{align*}
& \frac{1}{r^{2}}\left[1+O\left(r^{2}\right)\right] \quad \text { as } r \rightarrow 0  \tag{3.12}\\
& \sim \frac{c_{1,-}}{r \frac{1-\sqrt{\Delta_{1}}}{2}}
\end{align*}\right. \text { as } r \rightarrow+\infty, \quad c_{1,-} \neq 0 .
$$

2. Basis for $H_{m}$ : let $m \geq 2$, then there exists a fundamental basis $\left(\nu_{m}, \phi_{m}\right)$ with

$$
\nu_{m} \left\lvert\, \begin{align*}
& =r^{m}\left[1+O\left(r^{2}\right)\right] \quad \text { as } \quad r \rightarrow 0  \tag{3.13}\\
& \sim \frac{c_{m,-}}{r^{\frac{1-\sqrt{\Delta_{m}}}{2}}} \quad \text { as } r \rightarrow+\infty, \quad c_{m,-}>0
\end{align*}\right.
$$

and

$$
\phi_{m}(r)=\left\lvert\, \begin{align*}
& \frac{1}{r^{1+m}}\left[1+O\left(r^{2}\right)\right] \quad \text { as } r \rightarrow 0  \tag{3.14}\\
& \sim \frac{c_{m,+}}{r^{\frac{1+\sqrt{\Delta m}}{2}}} \text { as } r \rightarrow+\infty, \quad c_{m,+} \neq 0
\end{align*}\right.
$$

4. Positivity:

$$
\begin{equation*}
\nu_{m}(r)>0 \quad \text { on }(0,+\infty) \tag{3.15}
\end{equation*}
$$

5. Uniform closeness: Fix $m \geq$ 1. There exists a sequenc ${ }^{13} \mu_{n} \rightarrow 0$ as $n \rightarrow+\infty$ such that for $n \geq N$ large enough

$$
\begin{equation*}
\sup _{0 \leq r \leq r_{0}} \frac{\left|\mu_{n}^{-m} \varphi_{n, m}(r)-\nu_{m}\left(\frac{r}{\mu_{n}}\right)\right|}{\left|\nu_{m}\left(\frac{r}{\mu_{n}}\right)\right|}+\sup _{0 \leq r \leq r_{0}} \frac{\left|\mu_{n}^{-m+1} \varphi_{n, m}^{\prime}(r)-\nu_{m}^{\prime}\left(\frac{r}{\mu_{n}}\right)\right|}{\left|\nu_{m}^{\prime}\left(\frac{r}{\mu_{n}}\right)\right|} \lesssim r_{0}^{2} \tag{3.16}
\end{equation*}
$$

[^9]The uniform in $n$ bound (3.16) follows from the uniform control (1.10) using a standard ODE analysis. We provide a detailed proof of Lemma 3.2 in Appendix C for the sake of completeness.

We now detail the structure of the smooth zero of $\mathcal{L}_{n, 0}$ which is the key to the counting of non positive eigenvalues. Let $\varphi_{n, 0}$ be the solution to

$$
\begin{equation*}
\mathcal{L}_{n, 0}\left(\varphi_{n, 0}\right)=0, \quad \varphi_{n, 0}(0)=1, \quad \varphi_{n, 0}^{\prime}(0)=0 \tag{3.17}
\end{equation*}
$$

We recall that $r_{0, n}<r_{0}$ denotes the last zero of $\Lambda \Phi_{n}$ before $r_{0}$, and we let $r_{1, n}<r_{0}$ denote the last zero of $\varphi_{n, 0}$ before $r_{0}$. We claim:

Lemma 3.3 (Zeroes of $\Phi_{n, 0}$ ). There holds

$$
\begin{equation*}
\sup _{0 \leq r \leq r_{0}}\left(1+\frac{r}{\mu_{n}}\right)^{\frac{1}{2}}\left|\varphi_{n, 0}(r)-\frac{p-1}{2} \Lambda Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim r_{0}^{2} \tag{3.18}
\end{equation*}
$$

and

$$
\begin{equation*}
r_{1, n}=r_{0, n}+O\left(r_{0}^{3}\right), \quad e^{-\frac{2 \pi}{\omega}} r_{0} \leq r_{1, n} \leq r_{0} \tag{3.19}
\end{equation*}
$$

This is again a simple perturbative analysis which proof is detailed in Appendix D.

We now claim the following classical result which relies on the standard analysis of explicit special functions:

Lemma 3.4 (Special functions lemma). Let $\lambda \in \mathbb{R}$. The solutions to

\mathcal{L}_{\infty}(\psi)=\lambda \psi, \quad \psi \in H_{\rho}^{1}(1,+\infty)
$$

behaves for $r \rightarrow+\infty$ as

$$
\psi \sim r^{-\frac{2}{p-1}+\lambda}
$$

and for $r \rightarrow 0_{+}$as

\begin{equation*}
\psi=\frac{1}{r^{\frac{1}{2}}} \cos (\omega \log (r)-\Phi(\lambda))+O\left(r^{\frac{3}{2}}\right) \tag{3.20}
\end{equation*}
$$

where

$$
\Phi(\lambda)=\arg \left(\frac{2^{\frac{i \omega}{2}} \Gamma(i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}+\frac{i \omega}{2}\right)}\right)
$$

Proof. We consider the solution $\psi$ to

\mathcal{L}_{\infty}(\psi)=\lambda \psi .
$$

The change of variable and unknown

$$
\psi(r)=\frac{1}{(2 z)^{\frac{\gamma}{2}}} w(z), \quad z=\frac{r^{2}}{2}
$$

leads to
$\mathcal{L}_{\infty}(\psi)-\lambda \psi=-\frac{2}{(2 z)^{\frac{\gamma}{2}}}\left(z w^{\prime \prime}(z)+\left(-\gamma+\frac{3}{2}-z\right) w^{\prime}(z)-\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{\gamma}{2}\right) w(z)\right)$
and thus $\mathcal{L}_{\infty}(\psi)=\lambda \psi$ if and only if

$$
z \frac{d^{2} w}{d z^{2}}+(b-z) \frac{d w}{d z}-a w=0
$$

with

$$
\begin{equation*}
a=\frac{1}{p-1}-\frac{\lambda}{2}-\frac{\gamma}{2}, \quad b=-\gamma+\frac{3}{2} . \tag{3.21}
\end{equation*}
$$

Hence $w$ is a linear combination of the special functions $M(a, b, z)$ and $U(a, b, z)$ whose asymptotic at infinity is given by (2.9):

$$
M(a, b, z) \sim \frac{\Gamma(b)}{\Gamma(a)} z^{a-b} e^{z}, \quad U(a, b, z) \sim z^{-a} \text { as } z \rightarrow+\infty
$$

In particular, a non zero contribution of $M(a, b, z)$ to $w$ would yield for $\psi(r)$ the following asymptotic

$$
\psi(r) \sim r^{\frac{2}{p-1}-3-\lambda} e^{\frac{r^{2}}{2}} \text { as } r \rightarrow+\infty .
$$

which contradicts $\psi \in H_{\rho}^{1}(1,+\infty)$. Hence

$$
w(z)=U(a, b, z) .
$$

In view of the asymptotic of $U$ recalled in (2.9), we have

$$
w(z) \sim z^{-a} \text { as } z \rightarrow+\infty .
$$

Since

\psi(r)=\frac{1}{r^{\gamma}} w\left(\frac{r^{2}}{2}\right)
$$

this yields

\psi \sim r^{-\frac{2}{p-1}+\lambda} \text { as } r \rightarrow+\infty .
$$

Also, in view of the asymptotic of $U$ recalled in (2.11), we have

w(z)=\frac{\Gamma(b-1)}{\Gamma(a)} z^{1-b}+\frac{\Gamma(1-b)}{\Gamma(a-b+1)}+O\left(z^{2-\Re(b)}\right) \text { as } z \rightarrow 0
$$

which in view of (3.21) and the fact that $\gamma=1 / 2+i \omega$ yields

$$
w(z)=\frac{\Gamma(-i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}-\frac{i \omega}{2}\right)} z^{i \omega}+\frac{\Gamma(i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}+\frac{i \omega}{2}\right)}+O(z) \text { as } z \rightarrow 0
$$

Since

$$
\psi(r)=\frac{1}{r^{\gamma}} w\left(\frac{r^{2}}{2}\right)
$$

this yields

$$
\begin{aligned}
\psi(r)= & \frac{2^{-\frac{i \omega}{2}}}{r^{\frac{1}{2}}}\left(\frac{2^{-\frac{i \omega}{2}} \Gamma(-i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}-\frac{i \omega}{2}\right)} r^{i \omega}+\frac{2^{\frac{i \omega}{2}} \Gamma(i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}+\frac{i \omega}{2}\right)} r^{-i \omega}\right) \\
& +O\left(r^{\frac{3}{2}}\right) \text { as } r \rightarrow 0,
\end{aligned}
$$

and since $\psi$ is real valued, we infer $\sqrt{14}$

[^10]3.3. Perturbative spectral analysis. We now prove elementary spectral analysis perturbation results based on the uniform bounds (1.9), (1.10) which allow us to precisely count the number of instabilities of $\mathcal{L}_{n, 0}$.

Lemma 3.5 (Control of the outside spectrum). Let $r_{0}>0$ and let $r_{n, 2}$ such that $r_{n, 2}>e^{-\frac{2 \pi}{\omega}} r_{0}$. Let us define the operators

\end{equation*}

as $n \rightarrow+\infty$.
Proof. In view of (A.1), the local compactness of the Sobolev embeddings

\leq & \left(\sup _{r \geq r_{n, 2}}\left(p\left|\Phi_{n}(r)-\Phi_{*}(r)\right|^{p-1}\right)\right)^{\frac{1}{2}}\left\|w_{n}\right\|_{L_{\rho}^{2}\left(r>r_{n, 2}\right)} \leq\left(\sup _{r \geq r_{n, 2}}\left(p\left|\Phi_{n}(r)-\Phi_{*}(r)\right|^{p-1}\right)\right)^{\frac{1}{2}} \\
\rightarrow & 0 \text { as } n \rightarrow+\infty

from (1.9). (3.23) follows by exchanging the role $A_{n}\left[r_{n, 2}\right]$ and $A_{\infty}\left[r_{n, 2}\right]$.

\lesssim & \left|c\left(\varphi_{1}, r_{0}, \tilde{g}\right)\right|\left(1+r_{0}\|\tilde{g}\|_{L_{\rho}^{2}}\right)+r_{0}\|\tilde{g}\|_{H_{\rho}^{1}} \\
& +\left\|h_{1}\right\|_{L^{\infty}\left(r>r_{1}\right)}\left(1+r_{0}\|\tilde{g}\|_{L_{\rho}^{2}}+\left\|\varphi_{1}+r_{0} \tilde{g}\right\|_{L_{\left(r_{1}<r<1\right)}^{\infty}}\left\|r^{-2}\right\|_{L^{2}\left(r_{1}<r<1\right)}\right) \\

3.4. Proof of Proposition 3.1. Recall that $\mathcal{L}_{n}$ is diagonalizable in a Hilbertian basis of $L_{\rho}^{2}$, and hence the spectral gap estimate (3.6) follows from the explicit distribution of eigenvalues (3.2) which we now prove. Observe that the symmetry group of dilations and translations generates the explicit eigenmodes

step 1 The case $m=1$. Let $\varphi_{n, 1}$ be defined in Lemma 3.2. In particular, $\varphi_{n, 1}$ satisfies

\left|\left(\mathcal{L}_{\infty, 1}(u), u\right)_{\rho}-\left(\mathcal{L}_{n, 1}(u), u\right)_{\rho}\right| & \lesssim \int_{r_{0}}^{+\infty}\left|\Phi_{n}^{p-1}-\Phi_{*}^{p-1}\right| u^{2} r^{2} \rho(r) d r \\
& \leq o_{n \rightarrow+\infty}(1)\left\|\frac{u}{r}\right\|_{L_{\rho}^{2}}^{2} \tag{3.32}
\end{align*}
$$

Since $f_{n, 1}$ is supported in $\left(r_{n, 1}, r_{n, 2}\right) \subset\left(r_{0},+\infty\right)$, (3.30), (3.32) applied to $f_{n, 1}$ and (3.29) yield a contradiction for $n \geq N$ large enough. Thus, $r_{n, 2}$ can not exist, and hence $\varphi_{n, 1}$ vanishes only once.
$\varphi_{n, 1}$ is not an eigenstate. Since $\varphi_{n, 1}$ vanishes only once, $\mathcal{L}_{n, 1}$ has exactly one strictly negative eigenvalue. It remains to check the $\varphi_{n, 1} \notin L_{\rho}^{2}$, i.e. $\varphi_{n, 1}$ is not an eigenvector associated to the eigenvalue 0 . To this end, note that $\varphi_{n, 1}$ is strictly positive on $\left(0, r_{n, 1}\right)$ from (3.9) and strictly negative on $\left(r_{n, 1},+\infty\right)$. In particular, we have

\varphi_{n, 1}^{\prime}\left(r_{n, 1}\right)<0
$$

Since $\mathcal{L}_{n, 1}\left(\varphi_{n, 1}\right)=0$, we have

\left(r^{2} \rho \varphi_{n, 1}^{\prime}\right)^{\prime}=r^{2} \rho\left[\frac{2}{p-1}+\frac{\left(2-p r^{2} \Phi_{n}^{p-1}\right)}{r^{2}}\right] \varphi_{n, 1}
$$

and from (3.32) for $r \geq r_{n, 1} \geq r_{0}$ :

$$
\begin{equation*}
2-r^{2} p \Phi_{n}^{p-1}=2-p c_{\infty}^{p-1}+p c_{\infty}^{p-1}-r^{2} p \Phi_{n}^{p-1} \geq \frac{2(p+1)}{(p-1)^{2}}+o(1)>0 \tag{3.33}
\end{equation*}
$$

Since $\varphi_{n, 1}$ is strictly negative on $\left(r_{n, 1},+\infty\right)$, we deduce

$$
r^{2} \rho \varphi_{n, 1}^{\prime}(r) \leq r_{n, 1}^{2} \rho\left(r_{n, 1}\right) \varphi_{n, 1}^{\prime}\left(r_{n, 1}\right)=c_{1}<0 \text { on }\left(r_{n, 1},+\infty\right)
$$

which implies

$$
\int_{r_{n, 1}}^{+\infty}\left|\varphi_{n, 1}^{\prime}(r)\right|^{2} \rho r^{2} d r \gtrsim \int_{r_{n, 1}}^{+\infty} \frac{d r}{r^{2} \rho}=+\infty
$$

and hence $\varphi_{n, 1} \notin H_{\rho}^{1}$ and is therefore not an eigenvector.

Conclusion. We conclude that -1 is the only negative eigenvalue of $\mathcal{L}_{n, 1}$, and is associated to the single eigenvector $\Phi_{n}^{\prime}$. Hence, there exists a constant $c_{n}>0$ such that for all $u \in H_{\rho}^{1}$ :

\begin{equation*}
\left(\mathcal{L}_{n, 1}(u), u\right)_{\rho} \geq c_{n}\|u\|_{L_{\rho}^{2}}^{2}-\frac{1}{c_{n}}\left(u, \Phi_{n}^{\prime}\right)_{\rho}^{2} \tag{3.34}
\end{equation*}
$$

step 2 The case $m \geq 2$. Let $\varphi_{n, m}$ be defined in Lemma 3.2. In particular, $\varphi_{n, m}$ satisfies

$$
\mathcal{L}_{n, m}\left(\varphi_{n, m}\right)=0 \text { and } \varphi_{n, m}=r^{m}\left(1+O\left(r^{2}\right)\right) \text { as } r \rightarrow 0_{+}
$$

Then, the number of zeros of $\varphi_{n, m}$ in $r>0$ corresponds to the number of strictly negative eigenvalues of $\mathcal{L}_{n, m}$. On $\left[0, r_{0}\right]$, we have by Lemma 3.2.

$$
\sup _{0 \leq r \leq r_{0}} \frac{\left|\mu_{n}^{-m} \varphi_{n, m}(r)-\nu_{m}\left(\frac{r}{\mu_{n}}\right)\right|}{\left|\nu_{m}\left(\frac{r}{\mu_{n}}\right)\right|} \lesssim r_{0}^{2}
$$

and $\nu_{m}(r)>0$ for all $r>0$, and hence $\varphi_{n, m}$ cannot vanish on $\left[0, r_{0}\right]$ :

$$
\varphi_{n, m}(r)>0 \text { on }\left[0, r_{0}\right] .
$$

Next, we investigate the sign of $\varphi_{n, m}^{\prime}\left(r_{0}\right)$. Recall (3.13):

\nu_{m}(r) \sim \frac{c_{m,-}}{r^{\frac{1-\sqrt{\Delta_{m}}}{2}}} \text { as } r \rightarrow+\infty \quad c_{m .-}>0
$$

and hence

$$
\nu_{m}^{\prime}(r) \sim \frac{c_{m,-}\left(\sqrt{\Delta_{m}}-1\right)}{r^{\frac{3-\sqrt{\Delta_{m}}}{2}}} \text { as } r \rightarrow+\infty
$$

We infer for $n \geq N$ large enough

$$
\varphi_{n, m}\left(r_{0}\right)=\frac{c_{m,-}\left(1+O\left(r_{0}^{2}\right)\right) \mu_{n}^{m}}{\left(\frac{r_{0}}{\mu_{n}}\right)^{\frac{1-\sqrt{\Delta_{m}}}{2}}}
$$

and

$$
\varphi_{n, m}^{\prime}\left(r_{0}\right)=\frac{c_{m,-}\left(\sqrt{\Delta_{m}}-1\right)\left(1+O\left(r_{0}^{2}\right)\right) \mu_{n}^{m-1}}{\left(\frac{r_{0}}{\mu_{n}}\right)^{\frac{3-\sqrt{\Delta_{m}}}{2}}}
$$

Thus, taking also into account that $\varphi_{n, m}(r)>0$ on $\left[0, r_{0}\right]$, we infer from the identity for $\varphi_{n, m}\left(r_{0}\right)$ that

$$
c_{m,-}>0
$$

Since $\sqrt{\Delta_{m}} \geq \sqrt{\Delta_{1}}=\frac{p+3}{p-1}>1$, we conclude:

$$
\begin{equation*}
\phi_{n, m}\left(r_{0}\right)>0, \quad \phi_{n, m}^{\prime}\left(r_{0}\right)>0 \tag{3.35}
\end{equation*}
$$

Since $\mathcal{L}_{n, m}\left(\varphi_{n, m}\right)=0$, we have

$$
\begin{equation*}
\left(r^{2} \rho \varphi_{n, m}^{\prime}\right)^{\prime}=r^{2} \rho\left[\frac{2}{p-1}+\frac{\left(m(m+1)-p r^{2} \Phi_{n}^{p-1}\right)}{r^{2}}\right] \varphi_{n, m} \tag{3.36}
\end{equation*}
$$

which together with (3.35), (3.33) and the fact that $m \geq 2$, and an elementary continuity argument ensures

$$
\phi_{m, n}^{\prime}(r)>0, \quad \phi_{n, m}(r) \geq \phi_{n, m}\left(r_{0}\right)>0 \text { for } r \geq r_{0}
$$

Hence $\phi_{n, m}$ does not vanish on $(0,+\infty)$ and using (3.36):

r^{2} \phi_{n, m}^{\prime} \rho(r) \geq r_{0}^{2} \phi_{n, m}^{\prime} \rho\left(r_{0}\right)=c_{0}>0
$$

which implies

\int_{r_{0}}^{+\infty}\left(\phi_{n, m}^{\prime}\right)^{2} \rho r^{2} d r \gtrsim \int_{r_{0}}^{+\infty} \frac{d r}{r^{2} \rho}=+\infty
$$

and hence $\phi_{n, m}$ is not eigenvector. We finally conclude that for $m=2$ and all $n \geq N$ large enough, $\mathcal{L}_{n, 2}$ has a spectral gap and there exists a constant $c_{n}>0$ such that we have for all $u \in H_{\rho}^{1}$

$$
\left(\mathcal{L}_{n, 2}(u), u\right)_{\rho} \geq c_{n}\|u\|_{L_{\rho}^{2}}^{2}
$$

Since we have for all $m \geq 2$

$$
\left(\mathcal{L}_{n, m}(u), u\right)_{\rho} \geq\left(\mathcal{L}_{n, 2}(u), u\right)_{\rho}
$$

we infer for all $m \geq 2$ and for all $u \in H_{\rho}^{1}$

$$
\begin{equation*}
\left(\mathcal{L}_{n, m}(u), u\right)_{\rho} \geq c_{n}\|u\|_{L_{\rho}^{2}}^{2} . \tag{3.37}
\end{equation*}
$$

step 3. The case $m=0$. We now focus onto $\mathcal{L}_{n, 0}$ which is the most delicate case, and we claim that $\mathcal{L}_{n, 0}$ has exactly $n+1$ strictly negative eigenvalues, and that 0 is not in the spectrum. The key is to combine the uniform bounds (1.9) with the explicit knowledge of the limiting outer spectrum, Lemma 3.4, as nicely suggested at the formal level in [3].
Let $\varphi_{n, 0}$ be the solution to (3.17) so that the number of strictly negative eigenvalues of $\mathcal{L}_{n, 0}$ coincides with the numbers of zeroes of $\varphi_{n, 0}$. We count the number of zeros of $\varphi_{n, 0}$ by comparing them with the number of zeros of $\Lambda \Phi_{n}$.

Lower bound. First, since $\Lambda \Phi_{n}$ is an eigenvector of $\mathcal{L}_{n, 0}$ corresponding to the eigenvalue -2 and since $\Lambda \Phi_{n}$ vanishes $n$ times from Proposition 2.5, we infer from Sturm Liouville

\# \operatorname{Spec}\left(\mathcal{L}_{n, 0}+2\right) \cap(-\infty, 0]=n+1
$$

In particular, since the number of strictly negative eigenvalues of $\mathcal{L}_{n, 0}$ coincides with the number of zeroes of $\varphi_{n, 0}$, we infer

\#\left\{r \geq 0 \text { such that } \varphi_{n, 0}(r)=0\right\} \geq n+1
$$

Upper bound. Recall (3.18):

\sup _{0 \leq r \leq r_{0}}\left(1+\frac{r}{\mu_{n}}\right)^{\frac{1}{2}}\left|\varphi_{n, 0}(r)-\frac{p-1}{2} \Lambda Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim r_{0}^{2}
$$

Also, we have $\Lambda Q(0) \neq 0$ and from (2.41):

$$
\left(\frac{r_{0}}{\mu_{n}}\right)^{\frac{1}{2}}\left|\Lambda Q\left(\frac{r_{0}}{\mu_{n}}\right)\right| \geq c>0
$$

for some constant $c>0$ independent of $n$. Hence $\varphi_{n, 0}$ and $\Lambda Q$ vanish the same number of times on $\left[0, r_{0}\right]$. Since on the other hand $\Lambda Q$ and $\Lambda \Phi_{n}$ vanish the same number of times on $\left[0, r_{0}\right]$ from (2.40),$\varphi_{n, 0}$ and $\Lambda \Phi_{n}$ vanish the same number of times of $\left[0, r_{0}\right]$.
Let now $r_{n, 0}$ to be the last zero of $\Lambda \Phi_{n}$ before $r_{0}$. In view of Corollary 2.6, we have

$$
e^{-\frac{2 \pi}{\omega}} r_{0} \leq r_{n, 0} \leq r_{0}
$$

Let us now consider the operators (3.22):

$$
\begin{array}{ll}
A_{n}\left[r_{n, 0}\right](f)=\mathcal{L}_{n, 0}(f) \text { on } r>r_{0, n}, & f\left(r_{n, 0}\right)=0, \\
A_{\infty}\left[r_{n, 0}\right](f)=\mathcal{L}_{\infty}(f) \text { on } r>r_{n, 0}, & f\left(r_{n, 0}\right)=0,
\end{array}
$$

then

$$
\mathcal{L}_{n, 0}\left(\Lambda \Phi_{n}\right)=-2 \Lambda \Phi_{n} \text { and } \Lambda \Phi_{n}\left(r_{n, 0}\right)=0
$$

implies

$$
A_{n}\left[r_{n, 0}\right]\left(\Lambda \Phi_{n}\right)=-2 \Lambda \Phi_{n}
$$

In particular, -2 belongs to the spectrum of $A_{n}\left[r_{n, 0}\right]$. In view of Lemma 3.5, we deduce for $n \geq N$ large enough that the exists an eigenvalue $\lambda_{0}$ of $A_{\infty}\left[r_{n, 0}\right]$ such that $\lambda_{0}=-2+o(1)$. On the other hand, in view of Lemma 3.4, the solutions to

$$
\mathcal{L}_{\infty}(f)=\lambda f
$$

with $f \in H_{\rho}^{1}$ are completely explicit and behave for $r \rightarrow 0$ as

$$
f \sim \frac{1}{r^{\frac{1}{2}}} \cos (\omega \log (r)-\Phi(\lambda))
$$

with

$$
\Phi(\lambda)=\arg \left(\frac{2^{\frac{i \omega}{2}} \Gamma(i \omega)}{\Gamma\left(\frac{1}{p-1}-\frac{\lambda}{2}-\frac{1}{4}+\frac{i \omega}{2}\right)}\right)
$$

In order for $f$ to be an eigenfunction of $A_{\infty}\left[r_{n, 0}\right]$, we need $f\left(r_{n, 0}\right)=0$ and hence there should exists $k \in \mathbb{Z}$ such that

$$
\omega \log \left(r_{n, 0}\right)-\Phi(\lambda) \sim \frac{\pi}{2}+k \pi
$$

Recall that $\lambda_{0}=-2+o(1)$ is an eigenvalue of $A_{\infty}\left[r_{n, 0}\right]$, and let $\lambda_{1}>\lambda_{0}$ be the next eigenvalue of $A_{\infty}\left[r_{n, 0}\right]$. Then, there exists $k_{0} \in \mathbb{R}$ such that

$$
\omega \log \left(r_{n, 0}\right)-\Phi\left(\lambda_{0}\right) \sim \frac{\pi}{2}+k_{0} \pi, \quad \omega \log \left(r_{n, 0}\right)-\Phi\left(\lambda_{1}\right) \sim \frac{\pi}{2}+\left(k_{0}-1\right) \pi
$$

and hence

$$
\begin{equation*}
\Phi\left(\lambda_{1}\right)=\Phi(-2)+\pi+o(1) \tag{3.38}
\end{equation*}
$$

Now, by numerical check, we have 15

$$
\sup _{5 \leq p<+\infty} \sup _{-2 \leq \lambda \leq 0.5}(\Phi(\lambda)-\Phi(-2)-\pi) \sim-0.5945<0
$$

and hence, the solution $\lambda_{1}$ to (3.38) satisfies

$$
\inf _{5 \leq p<+\infty} \lambda_{1} \geq 0.5>0
$$

We infer that $A_{\infty}\left[r_{n, 0}\right]$ has no eigenvalue between $\lambda_{0}=-2+o(1)$ and $\lambda_{1} \geq 0.5$. Hence, using again Lemma 3.5, $A_{n}\left[r_{n, 0}\right]$ has no eigenvalue between -2 and $\lambda_{1}+$ $o(1) \geq 0.25$. Thus, we have

\# \operatorname{Spec}\left(A_{n}\left[r_{n, 0}\right]\right) \cap(-\infty, 0]=\# \operatorname{Spec}\left(A_{n}\left[r_{n, 0}\right]+2\right) \cap(-\infty, 0]
$$

On the other hand, we have

$$
\# \operatorname{Spec}\left(A_{n}\left[r_{n, 0}\right]+2\right) \cap(-\infty, 0]=\#\left\{r>r_{n, 0} \text { such that } \Lambda \Phi_{n}(r)=0\right\}+1
$$

[^11]since $\Lambda \Phi_{n}$ is in the kernel of $A_{n}\left[r_{n, 0}\right]+2$, and hence
$$
\# \operatorname{Spec}\left(A_{n}\right) \cap(-\infty, 0]=\#\left\{r>r_{n, 0} \text { such that } \Lambda \Phi_{n}(r)=0\right\}+1 .
$$

Also, since $\varphi_{n, 0}$ can not be an eigenvector of $A_{n}{ }^{[16}$, we have

\# \operatorname{Spec}\left(A_{n}\left[r_{n, 0}\right]\right) \cap(-\infty, 0]=\#\left\{r>r_{n, 0} \text { such that } \varphi_{n, 0}(r)=0\right\} .

We infer

\#\left\{r>r_{n, 0} \text { such that } \varphi_{n, 0}(r)=0\right\}=\#\left\{r>r_{n, 0} \text { such that } \Lambda \Phi_{n}(r)=0\right\}+1 .
$$

But since $r_{n, 0}$ has been chosen to be the last zero of $\Lambda \Phi_{n}$ before $r_{0}$, we have

\#\left\{r>r_{n, 0} \text { such that } \Lambda \Phi_{n}(r)=0\right\}=\#\left\{r>r_{0} \text { such that } \Lambda \Phi_{n}(r)=0\right\}
$$

and hence
$\#\left\{r>r_{n, 0}\right.$ such that $\left.\varphi_{n, 0}(r)=0\right\}=\#\left\{r>r_{0}\right.$ such that $\left.\Lambda \Phi_{n}(r)=0\right\}+1$.
Next, together with the fact that $\varphi_{n, 0}$ and $\Lambda \Phi_{n}$ vanish the same number of times of $\left[0, r_{0}\right]$, we infer

\#\left\{r>0 \text { such that } \varphi_{n, 0}(r)=0\right\}
$$

$\leq \#\left\{0 \leq r \leq r_{0}\right.$ such that $\left.\varphi_{n, 0}(r)=0\right\}+\#\left\{r>r_{n, 0}\right.$ such that $\left.\varphi_{n, 0}(r)=0\right\}$
$=\#\left\{0 \leq r \leq r_{0}\right.$ such that $\left.\Lambda \Phi_{n}(r)=0\right\}+\#\left\{r>r_{0}\right.$ such that $\left.\Lambda \Phi_{n}(r)=0\right\}+1$
$=\#\left\{r>0\right.$ such that $\left.\Lambda \Phi_{n}(r)=0\right\}+1$
$=n+1$
and since

$$
\#\left\{r \geq 0 \text { such that } \varphi_{n, 0}(r)=0\right\} \geq n+1 .
$$

$\phi_{n, 0}$ is not an eigenstate. We conclude that

$$
\#\left\{r \geq 0 \text { such that } \varphi_{n, 0}(r)=0\right\}=n+1 .
$$

Assume now by contradiction that $\varphi_{n, 0}$ is in the kernel of $\mathcal{L}_{n, 0}$. Recall that $r_{0, n}<r_{0}$ is the last 0 of $\Lambda \Phi_{n}$ and let $r_{1, n}<r_{0}$ be the last 0 of $\varphi_{n, 0}$. In particular, we have from Lemma 3.3

$$
e^{-\frac{2 \pi}{\omega}} r_{0} \leq r_{0, n}, r_{1, n} \leq r_{0} \text { and } r_{1, n}=r_{0, n}+O\left(r_{0}^{3}\right) .
$$

Also, since $\varphi_{n, 0}$ is in the kernel of $\mathcal{L}_{n, 0}$ and $\varphi_{n, 0}\left(r_{1, n}\right)=0$, we infer that 0 is in the spectrum of $A_{n}\left[r_{1, n}\right]$, and hence applying Lemma 3.5 twice as well as Lemma 3.6, we obtain that

$$
\operatorname{dist}\left(\operatorname{Spec}\left(A_{n}\left[r_{0, n}\right]\right), 0\right) \lesssim r_{0}^{\frac{3}{2}}+o(1)
$$

as $n \rightarrow+\infty$. In particular, we have for $r_{0}>0$ small enough and $n \geq N$ large enough

$$
\operatorname{dist}\left(\operatorname{Spec}\left(A_{n}\left[r_{0, n}\right]\right), 0\right) \leq 0.2 .
$$

On the other hand, we have proved above that $A_{n}\left[r_{n, 0}\right]$ has no eigenvalue between -2 and $\lambda_{1}+o(1) \geq 0.25$ so that

$$
\operatorname{dist}\left(\operatorname{Spec}\left(A_{n}\left[r_{0, n}\right]\right), 0\right) \geq 0.25
$$

which is a contradiction. Hence $\varphi_{0, n}$ is not in the kernel of $\mathcal{L}_{n, 0}$.

[^12]Conclusion. We conclude that $\mathcal{L}_{n, 0}$ has exactly $n+1$ strictly negative eigenvalues. On the other hand, since $\Lambda \Phi_{n}$ is an eigenvector of $\mathcal{L}_{n, 0}$ corresponding to the eigenvalue -2 and since $\Lambda \Phi_{n}$ vanishes $n$ times, we infer

$$
\# \operatorname{Spec}\left(\mathcal{L}_{n, 0}+2\right) \cap(-\infty, 0]=n+1
$$

and hence $\mathcal{L}_{n, 0}$ has exactly $n+1$ negative eigenvalues and the largest negative eigenvalue is -2 . We denote these eigenvalues by

$$
-\mu_{n+1, n}<\cdots<-\mu_{2, n}<-\mu_{1, n}=-2
$$

By Sturm Liouville, these eigenvalues are simple and associated to eigenvectors

$$
\psi_{j, n}, \quad\left\|\psi_{j, n}\right\|_{L_{\rho}^{2}}=1, \quad \psi_{1, n}=\frac{\Lambda \Phi_{n}}{\left\|\Lambda \Phi_{n}\right\|_{\rho}}
$$

Also, there holds for some constant $c_{n}>0$ and for all $u \in H_{\rho}^{1}$

$$
\begin{equation*}
\left(\mathcal{L}_{n, 0}(u), u\right)_{\rho} \geq c_{n}\|u\|_{L_{\rho}^{2}}^{2}-\frac{1}{c_{n}}\left[\sum_{j=1}^{n+1}\left(u, \psi_{j, n}\right)_{\rho}^{2}\right] \tag{3.39}
\end{equation*}
$$

The behavior as $r \rightarrow+\infty$ of the eigenstates (3.5) follows from the asymptotic in Lemma 3.4 and a standard ODE argument using the variation of constants formula, this is left to the reader.
step 4 Conclusion. We decompose $u \in H_{\rho}^{1}$ as

$$
u=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m} u_{m, k} Y^{(m, k)}
$$

where $u_{m, k}$ are radial functions satisfying

\|u\|_{\rho}^{2}=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m}\left\|u_{m, k}\right\|_{\rho}^{2}
$$

We have

\left(\mathcal{L}_{n}(u), u\right)_{\rho}=\sum_{m=0}^{+\infty} \sum_{k=-m}^{m}\left(\mathcal{L}_{n, m}\left(u_{m, k}\right), u_{m, k}\right)_{\rho}
$$

Together with (3.34), (3.37) and (3.39), we infer for all $u \in H_{\rho}^{1}$

$$
\begin{aligned}
\left(\mathcal{L}_{n}(u), u\right)_{\rho} & =\left(\mathcal{L}_{n, 0}\left(u_{0,0}\right), u_{0,0}\right)_{\rho}+\sum_{k=-1}^{1}\left(\mathcal{L}_{n, 1}\left(u_{1, k}\right), u_{1, k}\right)_{\rho}+\sum_{m=2}^{+\infty} \sum_{k=-m}^{m}\left(\mathcal{L}_{n, m}\left(u_{m, k}\right), u_{m, k}\right)_{\rho} \\
& \geq c_{n}\|u\|_{\rho}^{2}-\frac{1}{c_{n}}\left[\sum_{j=1}^{n+1}\left(u_{0,0}, \psi_{j, n}\right)_{\rho}^{2}+\sum_{k=1}^{3}\left(u_{1, k}, \Phi_{n}^{\prime}\right)_{\rho}^{2}\right]
\end{aligned}

Since $\psi_{j, n}$ are all radial, we have

## 4. Dynamical control of the flow

We now turn to the question of the stability of the self similar solution, and more precisely the construction of a manifold of finite energy initial data such that the corresponding solution to (1.1) blows up in finite time with $\Phi_{n}$ profile in the self similar regime described by Theorem [1.2] $n$ is now fixed.
4.1. Setting of the bootstrap. We set up in this section the bootstrap analysis of the flow for a suitable set of finite energy initial data. The solution will be decomposed in a suitable way with standard technique, see [32, 38].
Geometrical decomposition. We start by showing the existence of the suitable decomposition. Recall the spectral Proposition 3.1. To ease notations we now omit the $n$ subscript and write $\psi_{j}, \mu_{j}$ and $\lambda_{j}$ instead.

Define the $L^{\infty}$ tube around the renormalized versions of $\Phi_{n}$ :

step 2 Decomposition near any $\lambda, \bar{x}$. For any $\delta>0$, we take $C=C(\delta):=K \delta$. Let $u \in X_{\delta}$ then for some $\lambda^{\prime}>0$ and $y$ one has

The first step then provides the decomposition claimed in the lemma for $\delta$ small enough via the formulas $\lambda=\lambda^{\prime} \mu(v), \bar{x}=y-\lambda^{\prime} z(v), a_{j}=a_{j}(v)$ and $\varepsilon=\varepsilon(v)$. We will show in the next step that the decomposition is unique, implying that the parameters are Fréchet differentiable on $X_{\delta}$ for those of step 1 are.
step 3 Uniqueness of the decomposition. First, from a continuity argument, for any $\epsilon>0$, there exists $\delta>0$ such that if

and the force terms

Proposition 4.2 is the heart of the analysis, and the corresponding solutions are easily shown to satisfy the conclusions of Theorem 1.2. The strategy of the proof follows [10, 42]: we prove Proposition 4.2 by contradiction using a topological argument à la Brouwer: given $\left(\varepsilon_{0}, \lambda_{0}\right)$ satisfying (4.5), (4.15) and (4.4), we assume that for all $\left(a_{2}(0), \ldots, a_{n+1}(0)\right)$ satisfying (4.6), the exit time

From now on, we therefore study the flow on $\left[s_{0}, s^{*}\right]$ where (4.16), (4.17), (4.18), (4.19) and (4.20) hold. Using a bootstrap method we show that the bounds (4.16), (4.18), (4.19) and (4.20) can be improved, implying that at time $s^{*}$ necessarily the unstable modes have grown and (4.17) is violated. Since 0 is a linear repulsive equilibrium for these modes, this would contradict Brouwer fixed point theorem.

From the asymptotic (3.5) of $\psi_{j}$ for $2 \leq j \leq n+1$, (4.6) and (4.15), one can fix the constant $K_{0}$ independently of $\left(s_{0}, \mu,\right)$ such that (4.7) holds. Also, note that the bootstrap bounds (4.17), (4.18), (4.19) and (4.20) imply the $L^{\infty}$ bound (4.23), and
therefore the decomposition used in the Proposition is well defined since Lemma 4.1 applies.
4.2. $L^{\infty}$ bound. We start with the derivations of unweighted $L^{\infty}$ and Sobolev bounds on $v, w$ which will be essential to control nonlinear terms in the sequel and follow from (4.19), (4.20).

Lemma 4.3 ( $L^{\infty}$ smallness). There holds

4.3. Modulation equations. We now compute the modulation equations which describe the time evolution of the parameters. They are computed in the self-similar zone, and involve the $\rho$ weighted norm.
Lemma 4.4 (Modulation equations). There holds the bounds

step 1 Law for $a_{j}$. Take the $L_{\rho}^{2}$ scalar product of (4.11) with $\psi_{j}$ for $2 \leq j \leq n+1$, then using (4.9) and the orthogonality

Summing the above estimates and using the smallness of $\eta$ yields (4.25).
4.4. Energy estimates with exponential weights. We now turn to the proof of exponential decay which is an elementary consequence of the spectral gap estimate (3.6), the dissipative structure of the flow and the $L^{\infty}$ bound (4.23) to control the non linear term.

We first show that the bounds (4.16), (4.18), (4.19) and (4.20) can be improved on $\left[s_{0}, s^{*}\right]$, and then, the existence of the data $\left(a_{j}(0)\right)_{2 \leq j \leq n+1}$ follows from a classical topological argument à la Brouwer.
step 1 Improved scaling control. We estimate from (4.17), (4.18), (4.19), (4.25):

= & \left(\Delta a_{j}(0) e^{-\mu_{j} s_{0}}+\int_{s_{0}}^{+\infty} O\left(e^{-\left(\mu_{j}+(c+1) \mu\right) s^{\prime}}(A+\sqrt{\mathcal{E}})\right) d s^{\prime}\right) e^{\mu_{j} s} \\
& -e^{\mu_{j} s} \int_{s}^{+\infty} O\left(e^{-\left(\mu_{j}+(c+1) \mu\right) s^{\prime}}(A+\sqrt{\mathcal{E}})\right) d s^{\prime} . \tag{4.69}
\end{align*}
$$

The integral appearing in this identity is indeed convergent and satisfies:

\left|\int_{s}^{+\infty} O\left(e^{-\left(\mu_{j}+(c+1) \mu\right) s^{\prime}}(A+\sqrt{\mathcal{E}})\right) d s^{\prime}\right| \lesssim e^{-\left(\mu_{j}+(c+1) \mu\right) s}(A+\sqrt{\mathcal{E}}) .
$$

From (4.68) one gets $\left|\triangle a_{j}\right| \lesssim e^{-\mu s}$ and from the two above identities one necessarily must have that the parameter in front of the diverging term $e^{\mu_{j} s}$ is 0 :

& \lesssim\|\triangle \varepsilon(0)\|_{L_{\rho}^{2}}^{2} e^{-c_{n}\left(s-s_{0}\right)}+A^{2} e^{-(c+2) \mu s}
\end{aligned}
$$

since $\mu=\frac{c_{n}}{4}$ from (4.49) and $0<c \ll 1$ can be chosen arbitrarily small. Injecting (4.71) in the above identity yields

= & \int_{0}^{+\infty}\left(\partial_{r} u\right)^{2} \rho r^{2} d r+\frac{1}{4} \int_{0}^{+\infty} r^{2} u^{2} \rho r^{2} d r-\frac{1}{2}\left[r^{3} \rho u^{2}\right]_{0}^{+\infty} \\
& +\frac{1}{2} \int_{0}^{+\infty} u^{2}\left(3-r^{2}\right) \rho r^{2} d r \\
= & \int_{0}^{+\infty}\left(\partial_{r} u\right)^{2} \rho r^{2} d r-\frac{1}{4} \int_{0}^{+\infty} r^{2} u^{2} \rho r^{2} d r+\frac{3}{2} \int_{0}^{+\infty} u^{2} \rho r^{2} d r
\end{aligned}
$$

and hence

$$
\|r u\|_{L_{\rho}^{2}}^{2}=\int_{0}^{+\infty} r^{2} u^{2} \rho r^{2} d r \leq 4 \int_{0}^{+\infty}\left(\partial_{r} u\right)^{2} \rho r^{2} d r+6 \int_{0}^{+\infty} u^{2} \rho r^{2} d r \lesssim\|u\|_{H_{\rho}^{1}}^{2}
$$

which concludes the proof of (A.1).
step 2. Proof of (A.2). We compute:

We now turn to the proof of Hardy type inequalities. All proofs are more or less standard and we give the argument for the sake of completeness.

and hence summing (A.6) ensures A.5).

& A_{m}^{*}=\partial_{r}+\frac{2-\gamma_{m}}{r} \partial_{r}=\frac{1}{r^{2-\gamma_{m}}} \partial_{r}\left(r^{2-\gamma_{m}}\right)
\end{aligned}\right.
$$

Hence from (A.4):

\begin{aligned}
& \int_{1}^{+\infty}\left(\Delta_{m} v\right)^{2} r^{2} d r=\int_{1}^{+\infty}\left(A_{m}^{*} A_{m} v\right)^{2} r^{2} d r=\int_{1}^{+\infty} \frac{1}{r^{2-2 \gamma_{m}}}\left(\partial_{r}\left(r^{2-\gamma_{m}} A_{m} v\right)\right)^{2} d r \\
\geq & \left(\frac{2-2 \gamma_{m}+1}{2}\right)^{2} \int_{1}^{+\infty}\left(A_{m} v\right)^{2} d r=\left(\frac{2-2 \gamma_{m}+1}{2}\right)^{2} \int_{1}^{+\infty} \frac{1}{r^{2 \gamma_{m}}}\left(\partial_{r}\left(r^{\gamma_{m}} v\right)\right)^{2} d r \\
\geq & \left(\frac{2-2 \gamma_{m}+1}{2}\right)^{2}\left(\frac{2 \gamma_{m}+1}{2}\right)^{2} \int_{1}^{+\infty} \frac{v^{2}}{r^{2}} d r
\end{aligned}
$$

since $\gamma_{m}=-m$ with $m \in \mathbb{N}$ which ensures that the forbidden value (A.3) is never attained. We conclude that for some universal constant $\delta>0$ independent of $m$ :

& \lesssim \int_{1}^{+\infty}\left(\Delta_{m} v\right)^{2} r^{2} d r
\end{aligned}
$$

and (A.6) follows.

\lesssim & \left(\int_{0}^{+\infty}\left(\frac{\sup _{|y| \leq t}\|u(\cdot-y)(v(\cdot-y)-v(\cdot))\|_{L^{2}}}{t^{\nu}}\right)^{2} \frac{d t}{t}\right)^{\frac{1}{2}} \\
& +\left(\int_{0}^{+\infty}\left(\frac{\sup _{|y| \leq t}\|v(\cdot)(u(\cdot-y)-u(\cdot))\|_{L^{2}}}{t^{\nu}}\right)^{2} \frac{d t}{t}\right)^{\frac{1}{2}} \\
\lesssim & \|u\|_{L^{p_{4}}}\left(\int_{0}^{+\infty}\left(\frac{\sup _{|y| \leq t}\|v(\cdot-y)-v(\cdot)\|_{L^{p_{3}}}}{t^{\nu}}\right)^{2} \frac{d t}{t}\right)^{\frac{1}{2}} \\
& +\|v\|_{L^{p_{2}}}\left(\int_{0}^{+\infty}\left(\frac{\sup _{|y| \leq t}\|u(\cdot-y)-u(\cdot)\|_{L^{p_{1}}}}{t^{\nu}}\right)^{2} \frac{d t}{t}\right)^{\frac{1}{2}} \\

& +\left(a_{2}-\int_{r}^{+\infty} p\left(\Phi_{n}^{p-1}-\Phi_{*}^{p-1}\right) \varphi \psi_{1, m} r^{\prime 2} e^{-\frac{r^{\prime 2}}{2}} d r^{\prime}\right) \psi_{2, m}
\end{aligned}

& +\frac{1}{(1+r)^{\frac{1-\sqrt{\Delta_{m}}}{2}}}\left(\int _ { 1 } ^ { r } \left(\frac{\mu_{n}^{s_{c}+1}}{\left.r_{0}^{2-\frac{2}{p-1}}\left|\nu_{m}\right|+\mu_{n}^{2}\left|\Lambda \nu_{m}\right|+\left(\frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}}}+\mu_{n}^{2}\right)\left|\kappa_{n, m}-\nu_{m}\right|\right)}\right.\right. \\
& \left.\times \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{\frac{1+\sqrt{\Delta_{m}}}{2}}} d r^{\prime}+\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}\right) .

\lesssim & \frac{1}{(1+r)^{\sqrt{\Delta_{m}}}}\left\{\int_{1}^{r}\left(\frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}}}+\mu_{n}^{2}\right)\left(\frac{1}{\left(1+r^{\prime}\right)^{\frac{1-\sqrt{\Delta_{m}}}{2}}}+\left|\kappa_{n, m}-\nu_{m}\right|\right)\right. \\
& \left.\times \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{\frac{1-\sqrt{\Delta_{m}}}{2}}} d r^{\prime}+\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}\right\} \\

which together with (C.13) concludes the proof of (3.16) for $n \geq N$ large enough and $m \geq 2$.
case $m=1$ We estimate using (3.11), (3.12):

& +\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2} \\

since $p>5$, so that

\int_{0}^{r} \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{1+\sqrt{\Delta_{1}}}} \lesssim(1+r)^{2-\sqrt{\Delta_{1}}}
$$

Recall the solution $\rho$ to $H(\rho)=0$ constructed in Lemma 2.3 such that ( $\Lambda Q, \rho$ ) forms a basis of solutions of $H(w)=0$, then the solution to

\kappa_{n}-\frac{p-1}{2} \Lambda Q=\left(a_{1}+\int_{0}^{r} f_{n} \rho r^{\prime 2} d r^{\prime}\right) \Lambda Q+\left(a_{2}-\int_{0}^{r} f_{n} \Lambda Q r^{\prime 2} d r^{\prime}\right) \rho .
$$

Since $\Lambda Q$ is a smooth function at $r=0$ with

\Lambda Q(0)=\frac{2}{p-1} \neq 0
$$

we infer from the Wronskian relation that $\rho$ has the following asymptotic behavior

for some constant $c \neq 0$, and hence, we must have $a_{2}=0$. Furthermore, since we have

we infer $a_{1}=0$. Hence, we have

\kappa_{n}-\frac{p-1}{2} \Lambda Q=\left(\int_{0}^{r} f_{n} \rho r^{\prime 2} d r^{\prime}\right) \Lambda Q-\left(\int_{0}^{r} f_{n} \Lambda Q r^{\prime 2} d r^{\prime}\right) \rho .
$$

In order to estimate $f_{n}$, recall from Corollary 2.6 that we have

\sup _{r \leq r_{0}}\left|\Phi_{n}(r)-\frac{1}{\mu_{n}^{\frac{2}{p-1}}} Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim \mu_{n}^{s_{c}-1}
$$

This yields

$$
\begin{equation*}
\sup _{r \leq \frac{r_{0}}{\mu_{n}}}\left|p\left(\left(\mu_{n}^{\frac{2}{p-1}} \Phi_{n}\left(\mu_{n} r\right)\right)^{p-1}-Q^{p-1}(r)\right)\right| \lesssim \frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}} .} \tag{D.1}
\end{equation*}
$$

Also, we rewrite $f_{n}$ as

\begin{align*}
f_{n}= & p\left(\left(\mu_{n}^{\frac{2}{p-1}} \Phi_{n}\left(\mu_{n} r\right)\right)^{p-1}-Q^{p-1}(r)\right) \frac{p-1}{2} \Lambda Q-\mu_{n}^{2} \frac{p-1}{2} \Lambda^{2} Q  \tag{D.2}\\
& +p\left(\left(\mu_{n}^{\frac{2}{p-1}} \Phi_{n}\left(\mu_{n} r\right)\right)^{p-1}-Q^{p-1}(r)\right)\left(\kappa_{n}-\frac{p-1}{2} \Lambda Q\right)-\mu_{n}^{2} \Lambda\left(\kappa_{n}-\frac{p-1}{2} \Lambda Q\right)
\end{align*}
$$

We start with the region $0 \leq r \leq 1$. In view of the asymptotic behavior for $\Lambda Q$ and $\rho$ :

\Lambda Q \sim \frac{2}{p-1} \text { and } \rho \sim \frac{c}{r} \text { as } r \rightarrow 0+
$$

we infer

Together with (D.1) and (D.2) and integrating by parts the term $\Lambda\left(\kappa_{n}-(p-\right.$ 1) $/ 2 \Lambda Q$ ), we deduce

\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \lesssim & \left(\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}\right)\left(1+\int_{0}^{r}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| r^{\prime} d r^{\prime}\right. \\
& \left.+\frac{1}{r}\left(\int_{0}^{r}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| r^{\prime 2} d r^{\prime}\right)\right)
\end{aligned}
$$

We infer

$$
\begin{equation*}
\sup _{0 \leq r \leq 1}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \lesssim \frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}}}+\mu_{n}^{2} . \tag{D.3}
\end{equation*}
$$

In particular, this yields

$$
\begin{equation*}
\int_{0}^{1}\left|f_{n}\right| r^{\prime} d r^{\prime}+\int_{0}^{1}\left|f_{n}\right| r^{\prime 2} d r^{\prime} \lesssim \frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}}}+\mu_{n}^{2} \tag{D.4}
\end{equation*}
$$

Next, we consider the region $r \geq 1$. Recall the asymptotic behavior at infinity of $\Lambda Q$ and $\rho$ given by Lemma 2.3

$$
\Lambda Q(r) \sim \frac{c_{7} \sin \left(\omega \log (r)+c_{8}\right)}{r^{\frac{1}{2}}}, \quad \rho(r) \sim \frac{c_{9} \sin \left(\omega \log (r)+c_{10}\right)}{r^{\frac{1}{2}}} \text { as } r \rightarrow+\infty,
$$

where $c_{7}, c_{9} \neq 0, c_{8}, c_{10} \in \mathbb{R}$. We infer for $r \geq 1$

$$
\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \lesssim\left(\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}+\int_{1}^{r}\left|f_{n}\right| \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{\frac{1}{2}}} d r^{\prime}\right) \frac{1}{(1+r)^{\frac{1}{2}}}
$$

After integrating by parts the term $\Lambda\left(\kappa_{n}-(p-1) / 2 \Lambda Q\right)$, and together with (D.1) and (D.2), we deduce

\begin{aligned}
& (1+r)^{\frac{1}{2}}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \\
\lesssim & \left(\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}\right)\left(1+\int_{1}^{r}\left(\frac{1}{\left(1+r^{\prime}\right)^{\frac{1}{2}}}+\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right|\right) \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{\frac{1}{2}}} d r^{\prime}\right) \\
\lesssim & \left(\frac{\mu_{n}^{s_{c}+1}}{2-\frac{2}{p-1}}+\mu_{n}^{2}\right)(1+r)^{2}+\left(\frac{\mu_{n}^{s_{c}+1}}{r_{0}^{2-\frac{2}{p-1}}}+\mu_{n}^{2}\right)\left(\int_{1}^{r}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \frac{r^{\prime 2}}{\left(1+r^{\prime}\right)^{\frac{1}{2}}} d r^{\prime}\right) .
\end{aligned}
$$

This yields

$$
\sup _{1 \leq r \leq \frac{r_{0}}{\mu_{n}}}(1+r)^{\frac{1}{2}}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \lesssim r_{0}^{2}\left(1+\frac{\mu_{n}^{s_{c}-1}}{2-\frac{2}{p-1}}\right)
$$

which together with (D.3) implies

$$
\sup _{0 \leq r \leq \frac{r_{0}}{\mu_{n}}}(1+r)^{\frac{1}{2}}\left|\kappa_{n}-\frac{p-1}{2} \Lambda Q\right| \lesssim r_{0}^{2}\left(1+\frac{\mu_{n}^{s_{c}-1}}{r_{0}^{2-\frac{2}{p-1}}}\right)
$$

Hence, we have for $n \geq N$ large enough

$$
\sup _{0 \leq r \leq r_{0}}\left(1+\frac{r}{\mu_{n}}\right)^{\frac{1}{2}}\left|\varphi_{n, 0}(r)-\frac{p-1}{2} \Lambda Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim r_{0}^{2}
$$

step 2 Proof of (3.19). Recall from Lemma 3.3 that we have for $n \geq N$ large enough

\sup _{0 \leq r \leq r_{0}}\left(1+\frac{r}{\mu_{n}}\right)^{\frac{1}{2}}\left|\varphi_{n, 0}(r)-\frac{p-1}{2} \Lambda Q\left(\frac{r}{\mu_{n}}\right)\right| \lesssim r_{0}^{2}
$$

Also, recall that

$$
\Lambda Q(r) \sim \frac{c_{7} \sin \left(\omega \log (r)+c_{8}\right)}{r^{\frac{1}{2}}} \text { as } r \rightarrow+\infty
$$

and that $r_{\Lambda Q, n}<r_{0} / \mu_{n}$ introduced in Corollary 2.6 denotes the last zero of $\Lambda Q$ before $r_{0} / \mu_{n}$. This yields

\left|\omega \log \left(r_{1, n}\right)-\omega \log \left(\mu_{n}\right)+c_{8}-\left(\omega \log \left(r_{\Lambda Q, n}\right)+c_{8}\right)\right| \lesssim r_{0}^{2}
$$

and hence

$$
r_{1, n}=\mu_{n} r_{\Lambda Q, n} e^{O\left(r_{0}^{2}\right)}=\mu_{n} r_{\Lambda Q, n}\left(1+O\left(r_{0}^{2}\right)\right)
$$

Furthermore, since we have from the proof of Corollary 2.6 that

$$
e^{-\frac{3 \pi}{2 \omega}} \frac{r_{0}}{\mu_{n}} \leq r_{\Lambda Q, n} \leq \frac{r_{0}}{\mu_{n}}
$$

and

$$
r_{0, n}=\mu_{n} r_{\Lambda Q, n}\left(1+O\left(r_{0}^{2}\right)\right)
$$

we deduce

$$
r_{1, n}=r_{0, n}+O\left(r_{0}^{3}\right)
$$

and

$$
e^{-\frac{2 \pi}{\omega}} r_{0} \leq r_{1, n} \leq r_{0}
$$
