# ISOPERIMETRIC EQUALITIES FOR ROSETTES 

MICHA£ ZWIERZYŃSKI


#### Abstract

In this paper we study the isoperimetric-type equalities for rosettes, i.e. regular closed planar curves with non-vanishing curvature. We find the exact relations between the length and the oriented area of rosettes based on the oriented areas of the Wigner caustic, the Constant Width Measure Set and the Spherical Measure Set.

We also study and find new results about the geometry of affine equidistants of rosettes and of the union of rosettes.


## 1. Introduction

The classical isoperimetric inequality for plane curves states the following.
Theorem 1.1. (Isoperimetric inequality) Let $M$ be a simple curve. Let $L_{M}, A_{M}$ be the length of $M$ and the area of region enclosed by $M$, respectively. Then

$$
L_{M}^{2} \geqslant 4 \pi A_{M}
$$

and the equality holds if and only if $M$ is a circle.
This result is known already in the Ancient Greece but first proof was given in the nineteenth century by Steiner 34. After this paper, there have been many new proofs, applications and generalizations of this theorem, see [2, 11, 12, 13, 19 , 20, 22, 26, 34, 37, 38] and the literature therein. Recently in [37, 38] we prove the improved isoperimetric-type inequalities and equalities for planar ovals.

Theorem 1.2. 37, 38, (Isoperimetric-type equalities) Let $M$ be an oval. Then

L_{M}^{2}=4 \pi A_{M}+8 \pi\left|\widetilde{A}_{E_{0.5}(M)}\right|+\pi\left|\widetilde{A}_{C W M S(M)}\right|
$$

and if $M$ is not a curve of constant width, then

$$
L_{M}^{2}=4 \pi A_{M}+4 \pi\left|\widetilde{A}_{S M S(M)}\right|
$$

where $\widetilde{A}_{E_{0.5}(M)}, \widetilde{A}_{C W M S(M)}, \widetilde{A}_{S M S(M)}$ are the oriented area of the Wigner caustic of $M$, the oriented area of the Constant Width Measure Set of $M$ the oriented area of the Spherical Measure Set of $M$, respectively.

Furthermore $M$ is a curve of constant width if and only if

L_{M}^{2}=4 \pi A_{M}+8 \pi\left|\widetilde{A}_{E_{0.5}(M)}\right|
$$

and $M$ is a curve which has the center of symmetry if and only if

$$
L_{M}^{2}=4 \pi A_{M}+\pi\left|\widetilde{A}_{C W M S(M)}\right|
$$

[^0]The Wigner caustic of an oval on the affine symplectic plane was first introduced by Berry, in his celebrated 1977 paper [1] on the semiclassical limit of Wigner's phase-space representation of quantum states. The Wigner caustic is an example of an affine $\lambda$-equidistant (for $\lambda=\frac{1}{2}$ ). The affine $\lambda$-equidistant is the set of points divided chords connecting points on $M$ where tangent lines to $M$ are parallel in the ratio $\lambda$. There are many papers considering affine equidistants, see [4, 6, 7, 8, ,9, 14, 16, 24, 32, 36]. In [4, 14] the Wigner caustic is known as the area evolute and in [24] is known as the symmetry defect. The well-known Blaschke-Süss theorem ( 18,27 ) states that if $M$ is an oval then $M$ has at least three antipodal pairs, i.e. two points where the tangent lines at these points are parallel and the curvatures are equal. Singularities of the Wigner caustic occur exactly from an antipodal pair of an oval. The Wigner caustic also leads to one of two constructions of improper affine spheres ([5]). In [9] we study the global geometry of the Wigner caustic and equidistants of plane curves, we find many global results, for instance we presented an algorithm to describe smooth branches of equidistants of parametrized closed planar curves. By this algorithm we can find among other things the exact number of smooth branches, the number of inflexion points, the parity of the number of cusps of each branch. In this paper we use this method in Section 3 .

The paper is organized as follows.
In Section 2 we study the geometry of affine $\lambda$-equidistants, the Wigner caustic, the Constant Width Measure Set and the Spherical Measure Set of rosettes, i.e. closed smooth regular curves with non-vanishing curvature. We prove generalizations of Theorem 1.2 for rosettes.

Section 3 contains theorems on the geometry of branches of affine $\lambda$-equidistants of the union of rosettes.

## 2. Rosettes

Rosettes were studied in details in many papers, see [3, 28, 29, 30] and the literature therein. In particular well studied ovals are examples of rosettes.

Definition 2.1. Let $m$ be a positive integer. An $m$-rosette is a regular closed curve with non-vanishing curvature of the rotation number equal to $m$.
Remark 2.2. By the above definition we get also that every rosette is positively oriented.

Let $R_{m}$ be an $m$-rosette. Let $M$ be a regular closed curve.
Definition 2.3. A pair of points $a, b \in M(a \neq b)$ is called a parallel pair if the tangent lines to $M$ at $a$ and $b$ are parallel.
Definition 2.4. An affine $\lambda$-equidistant is the following set

$$
E_{\lambda}(M)=\{\lambda a+(1-\lambda) b \mid a, b \text { is a parallel pair of } M\} .
$$

The set $\mathrm{E}_{0.5}(M)$ will be called the Wigner caustic of $M$.
Note that, for any given $\lambda \in \mathbb{R}$, we have $E_{\lambda}(M)=E_{1-\lambda}(M)$. Thus, the case $\lambda=\frac{1}{2}$ is special. In particular we have $E_{0}(M)=E_{1}(M)=M$.

If $M$ is a generic closed regular curve then $E_{\lambda}(M)$ for $\lambda \neq 0,1$ is a union of smooth parametrized curves. Each of these curves we will call a smooth branch of $E_{\lambda}(M)$. Generically each such branch has at most cusp singularities ([1, 17]).

In Fig. 1 we present (i) a rosette $R_{4}$, (ii) $E_{0.4}\left(R_{4}\right)$, (iii) $E_{0.5}\left(R_{4}\right)$ and in (iv-viii) different smooth branches of $E_{0.5}\left(R_{4}\right)$.

Definition 2.5. A smooth curve $\mathcal{L}$ is a convex loop if $\mathcal{L}$ is parametrized by a smooth function $f:[0, b] \rightarrow \mathbb{R}^{2}$ such that the region bounded by $\mathcal{L}$ is strictly convex, $f(0)=f(b)$ and vectors $f^{\prime}(0), f^{\prime}(b)$ are linearly independent.

In [9] we study the geometry of $E_{\lambda}$ of rosettes and obtain the following result.
Theorem 2.6. 9] Let $R_{m}$ be a generic rosette. Then
(i) the number of smooth branches of $E_{0.5}\left(R_{m}\right)$ is equal to $m$,
(ii) at least $\left\lfloor\frac{m}{2}\right\rfloor$ branches of $E_{0.5}\left(R_{m}\right)$ are rosettes,
(iii) $m-1$ branches of $E_{0.5}\left(R_{m}\right)$ have a rotation number equal to $m$ and one branch has a rotation number equal to $\frac{m}{2}$,
(iv) every smooth branch of $E_{0.5}\left(R_{m}\right)$ has an even number of cusps if $m$ is even,
(v) exactly one branch of $E_{0.5}\left(R_{m}\right)$ has an odd number of cusps if $m$ is odd,
(vi) cusps of $E_{0.5}\left(R_{n}\right)$ created from convex loops of $M$ are in the same smooth branch of $E_{0.5}\left(R_{m}\right)$,
(vii) the total number of cusps of $E_{0.5}\left(R_{m}\right)$ is not smaller than 2 ,
(viii) the number of smooth branches of $E_{\lambda}\left(R_{m}\right)$ for $\lambda \neq 0,0.5,1$ is equal to $2 m-1$,
(ix) the rotation number of every smooth branch of $E_{\lambda}\left(R_{m}\right)$ for $\lambda \neq 0,0.5,1$ is equal to $m$,
(x) at least $m-1$ branches of $E_{\lambda}\left(R_{m}\right)$ for $\lambda \in(0,0.5) \cup(0.5,1)$ are rosettes,
(xi) at least $m$ branches of $E_{\lambda}\left(R_{m}\right)$ for $\lambda \in(-\infty, 0) \cup(1, \infty)$ are rosettes.

In this section we improve Theorem 2.6 - see Theorem 2.8. Theorem 2.9 and Theorem 2.17

Let us consider an oval $R_{1}$. Take a point $\Theta$ as the origin of our frame. Let $p$ be the oriented perpendicular distance from $\Theta$ to the tangent line at a point on $R_{1}$. Let $\theta$ be the oriented angle from the positive $x_{1}$-axis to this perpendicular ray. Clearly, $p$ is a $2 \pi$-periodic function. It is well known (see for instance [20, 23, 33]) that a parameterization of $R_{1}$ in terms of $\theta, p(\theta)$ is as follows

\gamma_{R_{1}}(\theta)=\left(\gamma_{R_{1}, 1}(\theta), \gamma_{R_{1}, 2}(\theta)\right)=\left(p(\theta) \cos \theta-p^{\prime}(\theta) \sin \theta, p(\theta) \sin \theta+p^{\prime}(\theta) \cos \theta\right) \tag{2.1}
\end{equation*}
$$

The pair $\theta, p(\theta)$ is known as the polar tangential coordinate on $R_{1}$ and $p(\theta)$ its Minkowski's support function.

Then, the curvature $\kappa$ of $R_{1}$ is in the following form

$$
\begin{equation*}
\kappa(\theta)=\frac{d \theta}{d s}=\frac{1}{p(\theta)+p^{\prime \prime}(\theta)}>0 \tag{2.2}
\end{equation*}
$$

or equivalently, the radius of a curvature $\rho$ of $R_{1}$ is given by

$$
\begin{equation*}
\rho(\theta)=\frac{d s}{d \theta}=p(\theta)+p^{\prime \prime}(\theta) . \tag{2.3}
\end{equation*}
$$

Let $L_{R_{1}}$ and $A_{R_{1}}$ be the length of $R_{1}$ and the area it bounds, respectively. Then one can get that

\begin{equation*}
L_{R_{1}}=\int_{R_{1}} d s=\int_{0}^{2 \pi} \rho(\theta) d \theta=\int_{0}^{2 \pi} p(\theta) d \theta \tag{2.4}
\end{equation*}
$$

and

$$
\begin{align*}
A_{R_{1}} & =\frac{1}{2} \int_{R_{1}} p(\theta) d s  \tag{2.5}\\
& =\frac{1}{2} \int_{0}^{2 \pi} p(\theta)\left[p(\theta)+p^{\prime \prime}(\theta)\right] d \theta=\frac{1}{2} \int_{0}^{2 \pi}\left[p^{2}(\theta)-p^{\prime 2}(\theta)\right] d \theta
\end{align*}
$$

(2.4) and 2.5 are known as Cauchy's formula and Blaschke's formula, respectively.

The notion of support function can be generalized to obtain function of similar properties, but for rosettes $([28,33])$, but in this case the support function of $R_{m}$ is $2 m \pi$-periodic.

Let $p$ be the support function of $R_{m}$ and $\gamma$ be the parameterization of $R_{m}$.
Let $E_{0.5, k}\left(R_{m}\right)$ for $k=1,2, \ldots, m$ be different branches of the Wigner caustic of $R_{m}$. Then by [9] the parameterization of $E_{0.5, k}\left(R_{m}\right)$ is as follows.

$$
\begin{equation*}
\gamma_{0.5, k}(\theta)=\frac{1}{2}(\gamma(\theta)+\gamma(\theta+k \pi)) \tag{2.6}
\end{equation*}
$$

Remark 2.7. The map $R_{m} \ni \gamma(\theta) \mapsto \gamma_{0.5, m}(\theta) \in E_{0.5, m}\left(R_{m}\right)$ is the double covering of $E_{0.5, m}\left(R_{m}\right)$.

Then the support function of $E_{0.5, k}\left(R_{m}\right)$ is in the following form.

$$
\begin{equation*}
p_{\lambda, k}(\theta)=\lambda p(\theta)+(-1)^{k}(1-\lambda) p(\theta+k \pi) \tag{2.7}
\end{equation*}
$$

In Fig. 1 (iv) there is $E_{0.5,1}\left(R_{4}\right)$, in (v) $E_{0.5,2}\left(R_{4}\right)$, in (vi) $E_{0.5,3}\left(R_{4}\right)$ and in (vii) $E_{0.5,4}\left(R_{4}\right)$.

Theorem 2.8. (i) If $k$ is even and $k<m$ then

$$
L_{E_{0.5, k}\left(R_{m}\right)}=L_{R_{m}}
$$

(ii) If $k$ is even and $k=m$ then

$$
2 L_{E_{0.5, k}\left(R_{m}\right)}=L_{R_{m}} .
$$

(iii) If $k$ is odd and $k<m$ then

$$
L_{E_{0.5, k}\left(R_{m}\right)} \leqslant L_{R_{m}}
$$

(iv) If $k$ is odd and $k=m$ then

$$
2 L_{E_{0.5, k}\left(R_{m}\right)} \leqslant L_{R_{m}} .
$$

(v) If $k$ is even and $\lambda \in(0,1)-\{0.5\}$, then

$$
L_{E_{\lambda, k}\left(R_{m}\right)}=L_{R_{m}}
$$

(vi) If $k$ is odd and $\lambda \in(0,1)-\{0.5\}$, then

$$
L_{E_{\lambda, k}\left(R_{m}\right)} \leqslant L_{R_{m}}
$$

(vii) If $k$ is odd and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

$$
L_{E_{\lambda, k}\left(R_{m}\right)}=L_{R_{m}}
$$

(viii) If $k$ is even and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

$$
L_{E_{\lambda, k}\left(R_{m}\right)} \leqslant(|\lambda|+|1-\lambda|) L_{R_{m}}
$$

Proof. We prove (i-iv), other points are analogous.
Let us notice that $\rho_{0.5, k}(\theta)=\frac{1}{2}\left|\rho(\theta)+(-1)^{k} \rho(\theta+k \pi)\right|$.
(i) If $k$ is even and $k<m$, then

$$
\begin{aligned}
L_{E_{0.5, k}\left(R_{m}\right)} & =\int_{0}^{2 m \pi} \rho_{0.5, k}(\theta) d \theta \\
& =\frac{1}{2} \int_{0}^{2 m \pi}(\rho(\theta)+\rho(\theta+k \pi) d \theta \\
& =\frac{1}{2}\left(L_{R_{m}}+L_{R_{m}}\right)=L_{R_{m}}
\end{aligned}
$$

(ii) It is a consequence of (i) and Remark 2.7 .
(iii) If $k$ is odd and $k<m$, then

$$
\begin{aligned}
L_{E_{0.5, k}\left(R_{m}\right)} & =\int_{0}^{2 m \pi} \rho_{0.5, k}(\theta) d \theta \\
& \left.=\frac{1}{2} \int_{0}^{2 m \pi} \right\rvert\, \rho(\theta)-\rho(\theta+k \pi \mid d \theta \\
& \leqslant \frac{1}{2}\left(L_{R_{m}}+L_{R_{m}}\right)=L_{R_{m}}
\end{aligned}
$$

(iv) It is a consequence of (iii) and Remark 2.7 .

The support function $p$ of $R_{m}$ has the following Fourier series.

\begin{equation*}
p(\theta)=a_{0}+\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) \tag{2.8}
\end{equation*}
$$

Therefore we get the following equalities.

p^{\prime \prime}(\theta)=-\frac{1}{m^{2}} \sum_{n=1}^{\infty} n^{2}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) \tag{2.10}
\end{equation*}
$$

$$
\begin{equation*}
\rho(\theta)=p(\theta)+p^{\prime \prime}(\theta)=a_{0}-\frac{1}{m^{2}} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) \tag{2.11}
\end{equation*}
$$

$$
\begin{equation*}
p^{\prime}(\theta)=\frac{1}{m} \sum_{n=1}^{\infty} n\left(-a_{n} \sin \frac{n \theta}{m}+b_{n} \cos \frac{n \theta}{m}\right) \tag{2.9}
\end{equation*}
$$

$$
\begin{equation*}
L_{R_{m}}=\int_{0}^{2 m \pi}\left|\gamma^{\prime}(\theta)\right| d \theta=\int_{0}^{2 m \pi} \rho(\theta) d \theta=\int_{0}^{2 \pi} p(\theta) d \theta=2 \pi m a_{0} \tag{2.12}
\end{equation*}
$$

$$
\widetilde{A}_{R_{m}}=\frac{1}{2} \int_{0}^{2 m \pi}\left(p^{2}(\theta)-p^{\prime 2}(\theta)\right) d \theta=m \pi a_{0}^{2}-\frac{\pi}{2 m} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right)
$$

Theorem 2.9. Let $R_{m}$ be a generic rosette. Then exactly $\left\lfloor\frac{m}{2}\right\rfloor$ branches of $E_{0.5}\left(R_{m}\right)$ are rosettes.
Proof. By Theorem 6.1. in [9] we know that branches $E_{0.5,2}\left(R_{m}\right), E_{0.5,4}\left(R_{m}\right), \ldots$, $E_{0.5,2 \cdot\lfloor 0.5 m\rfloor}\left(R_{m}\right)$ are rosettes. We will show that other branches has at least one
singular point. It is enough to show that there exists $\theta$ such that $\rho_{0.5, k}(\theta)=0$ for $k=1,3, \ldots, 2\left\lceil\frac{m}{2}\right\rceil-1$. By 2.7 we get that

$$
\begin{aligned}
\rho_{0.5, k}(\theta) & =0 \\
p_{0.5, k}(\theta)+p_{0.5, k}^{\prime \prime}(\theta) & =0 \\
\rho(\theta)-\rho(\theta+k \pi) & =0
\end{aligned}
$$

So the number of singular points of $E_{0.5, k}\left(R_{m}\right)$ is equal to the number of zeros of $f(\theta)=\rho(\theta)-\rho(\theta+k \pi)$ in the range $[0,2 m \pi)$. Since $f(0)=f(2 m \pi)$ and $\int_{0}^{2 m \pi} f(\theta) d \theta=0$, therefore there are at least two zeros of $f(\theta)$ in $[0,2 m \pi)$.

The lower bound of 2 cusps of the branches of the Wigner caustic which are not rosettes can be obtained, see Fig. 2.


Figure 2. A 2-rosette (the dashed line) and two branches of the Wigner caustic.

Corollary 2.10. A rosette $R_{m}$ has at least $2\left\lceil\frac{m}{2}\right\rceil$ antipodal pairs.
Lemma 2.11. The oriented area of $E_{0.5, k}\left(R_{m}\right)$ for $k<m$ in terms of coefficients of the Fourier series of the Minkowski support function $p$ of $R_{m}$ is equal

\widetilde{A}_{E_{0.5, k}\left(R_{m}\right)}=\frac{1+(-1)^{k}}{2} m \pi a_{0}^{2}-\frac{\pi}{4 m} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right)\left(1+(-1)^{k} \cos \frac{n k \pi}{m}\right)\left(a_{n}^{2}+b_{n}^{2}\right) \tag{2.14}
\end{equation*}
$$

and for $k=m$

$$
\begin{equation*}
\widetilde{A}_{E_{0.5, m}\left(R_{m}\right)}=\frac{1+(-1)^{m}}{4} m \pi a_{0}^{2}-\frac{\pi}{8 m} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right)\left(1+(-1)^{n+m}\right)\left(a_{n}^{2}+b_{n}^{2}\right) \tag{2.15}
\end{equation*}
$$

Proof. By 2.7) and 2.13 we get the following equalities for $k<m$.

\begin{aligned}
\widetilde{A}_{E_{0.5, k}\left(R_{m}\right)} & =\frac{1}{2} \int_{0}^{2 m \pi}\left(p_{0.5, k}^{2}(\theta)-p_{0.5, k}^{\prime 2}(\theta)\right) d \theta \\
& =\frac{1}{8} \int_{0}^{2 m \pi}\left[\left(p(\theta)+(-1)^{k} p(\theta+k \pi)\right)^{2}-\left(p^{\prime}(\theta)+(-1)^{k} p^{\prime}(\theta+k \pi)\right)\right] d \theta \\
& =\frac{1}{2} \widetilde{A}_{R_{m}}+\frac{(-1)^{k}}{2} \Psi_{R_{m}}
\end{aligned}
$$

where

\Psi_{R_{m}}=\frac{1}{2} \int_{0}^{2 m \pi}\left(p(\theta) p(\theta+k \pi)-p^{\prime}(\theta) p^{\prime}(\theta+k \pi)\right) d \theta \tag{2.16}
\end{equation*}

By 2.8 we get the following:

p(\theta+k \pi)=a_{0}+\sum_{n=1}^{\infty}\left[a_{n} \cos \left(\frac{n \theta}{m}+\frac{n k \pi}{m}\right)+b_{n} \sin \left(\frac{n \theta}{m}+\frac{n k \pi}{m}\right)\right] d \theta \tag{2.17}
\end{equation*}

One can check that

& \int_{0}^{2 m \pi} \cos \frac{n_{1} \theta}{m} \cos \left(\frac{n_{2} \theta}{m}+\frac{n_{2} k \pi}{m}\right) d \theta=m \pi \cos \frac{n_{2} k \pi}{m} \cdot \delta_{n_{1}, n_{2}}  \tag{2.18}\\
& \int_{0}^{2 m \pi} \sin \frac{n_{1} \theta}{m} \sin \left(\frac{n_{2} \theta}{m}+\frac{n_{2} k \pi}{m}\right) d \theta=m \pi \cos \frac{n_{2} k \pi}{m} \cdot \delta_{n_{1}, n_{2}}  \tag{2.19}\\
& \int_{0}^{2 m \pi} \cos \frac{n_{1} \theta}{m} \sin \left(\frac{n_{2} \theta}{m}+\frac{n_{2} k \pi}{m}\right) d \theta=m \pi \sin \frac{n_{2} k \pi}{m} \cdot \delta_{n_{1}, n_{2}}  \tag{2.20}\\
& \int_{0}^{2 m \pi} \sin \frac{n_{1} \theta}{m} \cos \left(\frac{n_{2} \theta}{m}+\frac{n_{2} k \pi}{m}\right) d \theta=-m \pi \sin \frac{n_{2} k \pi}{m} \cdot \delta_{n_{1}, n_{2}} \tag{2.21}
\end{align*}
$$

where $\delta_{n_{1}, n_{2}}$ is the Kronecker delta, i.e. $\delta_{n_{1}, n_{2}}=\left\{\begin{array}{ll}1, & n_{1}=n_{2} \\ 0, & n_{1} \neq n_{2}\end{array}\right.$.
Therefore by 2.182 .21 we can express $\Psi_{R_{m}}$ in the following way.

\Psi_{R_{m}} & =\frac{1}{2} \int_{0}^{2 m \pi}\left(p(\theta) p(\theta+k \pi)-p^{\prime}(\theta) p^{\prime}(\theta+k \pi)\right) d \theta  \tag{2.22}\\
& =m \pi a_{0}^{2}-\frac{\pi}{2 m} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right) \cos \frac{n k \pi}{m}\left(a_{n}^{2}+b_{n}^{2}\right)
\end{align*}

By 2.13 and 2.22 we get 2.14 and by Remark 2.7 we get 2.15

Theorem 2.12. ( Corollary 5.1 in [28]) Each rosette of constant width of the rotation number equal to $m$ is given by the following support function.

p_{R_{m}}(\theta)=a_{0}+\sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) . \tag{2.23}
\end{equation*}

Theorem 2.13. A rosette $R_{m}$ is a rosette of constant width if and only if

\begin{equation*}
L_{R_{m}}^{2}=8 \pi m \widetilde{A}_{E_{0.5, m}\left(R_{m}\right)}+2 \pi m\left(1-(-1)^{m}\right) \widetilde{A}_{R_{m}} . \tag{2.24}
\end{equation*}
$$

Proof. By 2.23) and by 2.13 we get that the oriented area of $R_{m}$ is in the following form.

$$
\widetilde{A}_{R_{m}}=m \pi a_{0}^{2}-\frac{\pi}{2 m} \sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right)
$$

Therefore by Lemma 2.11 and by 2.12 we get the following equalities.

$$
\begin{aligned}
2 \widetilde{A}_{E_{0.5, m}\left(R_{m}\right)} & =\frac{1+(-1)^{m}}{2} m \pi a_{0}^{2}-\frac{\pi}{4 m} \sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(n^{2}-m^{2}\right)\left(1-(-1)^{m}\right)\left(a_{n}^{2}+b_{n}^{2}\right) \\
& =\frac{1+(-1)^{m}}{2} m \pi a_{0}^{2}-\frac{1-(-1)^{m}}{2}\left(\widetilde{A}_{R_{m}}-m \pi a_{0}^{2}\right) \\
& =\pi m a_{0}^{2}-\frac{1-(-1)^{m}}{2} \widetilde{A}_{R_{m}} \\
& =\frac{L_{R_{m}}^{2}}{4 \pi m}-\frac{1-(-1)^{m}}{2} \widetilde{A}_{R_{m}}
\end{aligned}
$$

Therefore we get 2.24 .

In 38 we introduced the following set for 1 -rosettes.
Definition 2.14. The Constant Width Measure Set of $R_{1}$ is the following set

$$
\operatorname{CWMS}\left(R_{1}\right)=\left\{\left.a-b+\frac{L_{R_{1}}}{\pi} \cdot \mathfrak{m}(a) \right\rvert\, a, b \text { is a parallel pair of } R_{1}\right\}
$$

where $\mathfrak{m}$ is the unit normal vector field compatible with the orientation of $R_{1}$. We treat CWMS $\left(R_{1}\right)$ as a subset of a vector space $V=\mathbb{R}^{2}$. To visualize the CWMS and the other sets in the same picture let us assume that the origin of $V$ is $\Theta$.

We generalize the CWMS for all rosettes in the following way.
Definition 2.15. Let $\gamma$ be parameterization of $R_{m}$ in terms of $\theta$ and $p(\theta)$. Then the Constant Width Measure Set of $R_{m}$ is a curve defined by the following parameterization

$$
\gamma_{\mathrm{CWMS}\left(R_{m}\right)}(\theta)=\gamma(\theta)-\gamma(\theta+m \pi)+\frac{L_{R_{m}}}{m \pi} \cdot \mathrm{~m}(\theta)
$$

It is easy to see that $\mathrm{CWMS}\left(R_{m}\right)$ has the following support function

$$
\begin{equation*}
p_{\mathrm{CWMS}\left(R_{m}\right)}(\theta)=p(\theta)-(-1)^{m} p(\theta+m \pi)-\frac{L_{R_{m}}}{m \pi} \tag{2.25}
\end{equation*}
$$

and in terms of coefficients of the Fourier series of $p$
$p_{\mathrm{CWMS}\left(R_{m}\right)}(\theta)=\left(-1-(-1)^{m}\right) a_{0}+\sum_{n=1}^{\infty}\left(1-(-1)^{n+m}\right)\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right)$.

Theorem 2.16. Let $R_{m}$ be a generic m-rosette. If $m$ is odd then $C W M S\left(R_{m}\right)$ is a smooth curve with only cusp singularities and the number of cusp singularities of $C W M S\left(R_{m}\right)$ is even and positive.
Proof. CWMS $\left(R_{m}\right)$ is a connected smooth curve. The set $\operatorname{CWMS}\left(R_{m}\right)$ is singular if and only if

$$
\begin{equation*}
\rho_{\mathrm{CWMS}\left(R_{m}\right)}(\theta)=0 . \tag{2.27}
\end{equation*}
$$

By theory of Thom (1975) [35] one can get that generically CWMS( $M$ ) has cusp singularity when 2.27 holds.

If $m$ is odd the condition 2.27 is equivalent to

$$
\begin{equation*}
\rho(\theta)+\rho(\theta+m \pi)=\frac{L_{R_{m}}}{m \pi} . \tag{2.28}
\end{equation*}
$$

The number of cusp singularities of $\operatorname{CWMS}\left(R_{m}\right)$ is the number of zeros of 2.28 ) in the range $[0,2 m \pi)$. Since the function $\rho(\theta)+\rho(\theta+m \pi)$ is $m \pi$-periodic, we get that the number of cusp singularities of $\operatorname{CWMS}\left(R_{m}\right)$ is even. Let us assume that this number is equal to zero. Then we get that for all $\theta \in[0, m \pi)$ one of two following inequalities holds.

$$
\begin{aligned}
& \rho(\theta)+\rho(\theta+m \pi)<\frac{L_{R_{m}}}{m \pi}, \\
& \rho(\theta)+\rho(\theta+m \pi)>\frac{L_{R_{m}}}{m \pi} .
\end{aligned}
$$

If $\rho(\theta)+\rho(\theta+m \pi)<\frac{L_{R_{m}}}{m \pi}$ for all $\theta \in[0, m \pi)$, then

$$
\begin{aligned}
\int_{0}^{m \pi}(\rho(\theta)+\rho(\theta+m \pi)) d \theta & <\int_{0}^{m \pi} \frac{L_{R_{m}}}{m \pi} d \theta \\
L_{R_{m}} & <L_{R_{m}}
\end{aligned}
$$

Since we get the same contradiction for $\rho(\theta)+\rho(\theta+m \pi)>\frac{L_{R_{m}}}{m \pi}$, the number of cusp singularities of $\mathrm{CWMS}\left(R_{m}\right)$ is positive.

In Fig. 3 we present examples of $\operatorname{CWMS}\left(R_{m}\right)$.
Theorem 2.17. (Isoperimetric equalities for rosettes I) If $m$ is an odd number, then

$$
\begin{equation*}
L_{R_{m}}^{2}=4 \pi m \widetilde{A}_{R_{m}}-8 \pi m \widetilde{A}_{E_{0.5, m}\left(R_{m}\right)}-\pi m \widetilde{A}_{C W M S\left(R_{m}\right)} \tag{2.29}
\end{equation*}
$$

If $m$ is an even number, then

$$
\begin{equation*}
L_{R_{m}}^{2}=-2 \pi m \widetilde{A}_{R_{m}}+4 \pi m \widetilde{A}_{E_{0.5, m}\left(R_{m}\right)}+\frac{\pi m}{2} \widetilde{A}_{C W M S\left(R_{m}\right)} \tag{2.30}
\end{equation*}
$$

Proof. Let $m$ be odd. Then by 2.7 and 2.25 we get that

$$
\begin{aligned}
& p_{E_{0.5, m}\left(R_{m}\right)}(\theta)=\sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) \\
& p_{\mathrm{CWMS}\left(R_{m}\right)}(\theta)=2 \sum_{\substack{n=2, n \text { is even }}}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right) .
\end{aligned}
$$



Figure 3. Two rosettes $R_{2}$ and $R_{3}$ (the dashed lines) and CWMS $\left(R_{2}\right)$, $\mathrm{CWMS}\left(R_{3}\right)$. Their support functions are $p_{R_{2}}(\theta)=$ $10+4 \cos \frac{\theta}{2}+\sin 2 \theta$ and $p_{R_{3}}(\theta)=12+\cos \frac{2 \theta}{3}+4 \cos \frac{5 \theta}{3}-\sin 2 \theta$, respectively.

Therefore

$$
\begin{aligned}
& \widetilde{A}_{E_{0.5, m}\left(R_{m}\right)}=-\frac{\pi}{4 m} \sum_{\substack{1=2, n \text { is odd }}}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right) \\
& \widetilde{A}_{\mathrm{CWMS}\left(R_{m}\right)}=-\frac{2 \pi}{m} \sum_{\substack{n=2, n \text { is even }}}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right) .
\end{aligned}
$$

Let $m$ be even. Then similarly one can get that

$$
\begin{aligned}
p_{E_{0.5, m}\left(R_{m}\right)}(\theta) & =a_{0}+\sum_{\substack{n=2, n \text { is even }}}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right), \\
p_{\mathrm{CWMS}\left(R_{m}\right)}(\theta) & =-2 a_{0}+2 \sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(a_{n} \cos \frac{n \theta}{m}+b_{n} \sin \frac{n \theta}{m}\right), \\
\widetilde{A}_{E_{0.5, m}\left(R_{m}\right)} & =\frac{m \pi a_{0}^{2}}{2}-\frac{\pi}{4 m} \sum_{\substack{n=2, \\
\text { is even }}}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right), \\
\widetilde{A}_{\mathrm{CWMS}\left(R_{m}\right)} & =8 \pi m a_{0}^{2}-\frac{2 \pi}{m} \sum_{\substack{n=1, n \text { is odd }}}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right) .
\end{aligned}
$$

Then by 2.13 it is easy to verify that 2.29 and 2.30 hold.

We recall definition of an offset (this set is also known as a parallel set).
Definition 2.18. Let $M$ be a regular positively oriented closed curve. An $\alpha$-offset of $M$ is the following set

$$
F_{\alpha}(M)=\{a+\alpha \cdot \mathfrak{m}(a) \mid a \in M\},
$$

where $\mathfrak{m}(a)$ is a continuous unit normal vector field to $M$ at $a$ compatible with the orientation of $M$.

Offset curves and surfaces are well-known geometric objects in the field of mathematics and computer aided geometric design, possibly because they give a powerful tool in many applications. It is well known that offsets of curves generically admit at most cusp singularities, singularities of all offsets of a curve form an evolute and set of all points of self-intersections of offsets forms a medial axis. For details see [10, 15, 21, 25, 31 and the literature therein.

In 38 we define the Spherical Measure Set for simply closed curves as follows.
Definition 2.19. The Spherical Measure Set of a regular positively oriented simply closed curve $M$ is an offset at level $\frac{L_{M}}{2 \pi}$,

$$
\begin{equation*}
\operatorname{SMS}(M)=F_{\frac{L_{M}}{2 \pi}}(M)=\left\{\left.a+\frac{L_{M}}{2 \pi} \cdot \mathfrak{m}(a) \right\rvert\, a \in M\right\} \tag{2.31}
\end{equation*}
$$

where m is the unit normal vector field compatible with the orientation of $M$.
In this paper we generalize this notion for rosettes.
Definition 2.20. The Spherical Measure Set of an m-rosette $R_{m}$ is an offset at level $\frac{L_{R_{m}}}{2 m \pi}$,

$$
\begin{equation*}
\operatorname{SMS}\left(R_{m}\right)=F_{\frac{L_{R_{m}}}{2 m \pi}}\left(R_{m}\right)=\left\{\left.a+\frac{L_{R_{m}}}{2 m \pi} \cdot \mathrm{~m}(a) \right\rvert\, a \in R_{m}\right\} . \tag{2.32}
\end{equation*}
$$

It is easy to see that the support function of $\operatorname{SMS}\left(R_{m}\right)$ is in the following form

$$
\begin{equation*}
p_{\mathrm{SMS}\left(R_{m}\right)}(\theta)=p(\theta)-\frac{L_{R_{m}}}{2 m \pi} \tag{2.33}
\end{equation*}
$$

and has the following Fourier series

$$
\begin{equation*}
p_{\mathrm{SMS}\left(R_{m}\right)}(\theta)=\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \pi}{m}+b_{n} \sin \frac{n \pi}{m}\right) \tag{2.34}
\end{equation*}
$$

Directly by 2.34 we got the following propositions.
Proposition 2.21. A rosette $R_{m}$ is a circle if and only if $S M S\left(R_{m}\right)=\{\Theta\}$.
Proposition 2.22. If $m$ is odd and $R_{m}$ is a rosette of constant width, then $\operatorname{SMS}\left(R_{m}\right)=E_{0.5, m}\left(R_{m}\right)$.
Theorem 2.23. Let $R_{m}$ be a generic rosette. Then the number of cusp singularities of $\operatorname{SMS}\left(R_{m}\right)$ is even and not smaller than 2.

Proof. A curve $\operatorname{SMS}\left(R_{m}\right)$ is singular if and only if

$$
\begin{equation*}
\rho_{\mathrm{SMS}\left(R_{m}\right)}(\theta)=0, \tag{2.35}
\end{equation*}
$$

which is equivalent to

$$
\begin{equation*}
\rho(\theta)-\frac{L_{R_{m}}}{2 m \pi}=0 . \tag{2.36}
\end{equation*}
$$

The number of cusp singularities of $\operatorname{SMS}\left(R_{m}\right)$ is equal to the number of zeros of $f(\theta)=\rho(\theta)-\frac{L_{R_{m}}}{2 m \pi}$ in the range $[0,2 m \pi)$. Since $f(0)=f(2 m \pi)$, the number of
zeros is even. Since $\int_{0}^{2 m \pi} f(\theta) d \theta=L_{R_{m}}-L_{R_{m}}=0$, there are at least two zeros of $f(\theta)$ in the range $[0,2 m \pi)$.

In Fig. 4 we present examples of the SMS of a 2 -rosette and a 3 -rosette.


Figure 4. Rosettes $R_{2}$ and $R_{3}$ (the dashed lines) and $\operatorname{SMS}\left(R_{2}\right), \operatorname{SMS}\left(R_{3}\right)$. Support functions of $R_{2}$ and $R_{3}$ are equal to $p_{R_{2}}(\theta)=3+\cos \frac{\theta}{2}$ and $p_{R_{3}}(\theta)=4+\cos \frac{2 \theta}{3}-\frac{1}{2} \sin 2 \theta$, respectively.

Theorem 2.24. (Isoperimetric equality for rosettes II) If $m$ is odd and $R_{m}$ is an $m$-rosette which is not of constant width, then

$$
\begin{equation*}
L_{R_{m}}^{2}=4 \pi m \widetilde{A}_{R_{m}}+4 \pi m \widetilde{A}_{S M S\left(R_{m}\right)} \tag{2.37}
\end{equation*}
$$

Proof. By 2.34 the oriented area of the Spherical Measure Set of $R_{m}$ is in the following form

$$
\begin{align*}
\widetilde{A}_{\mathrm{SMS}\left(R_{m}\right)} & =\frac{1}{2} \int_{0}^{2 m \pi}\left(p_{\mathrm{SMS}\left(R_{m}\right)}^{2}(\theta)-p_{\mathrm{SMS}\left(R_{m}\right)}^{\prime 2}(\theta)\right) d \theta  \tag{2.38}\\
& =-\frac{\pi}{2 m} \sum_{n=1}^{\infty}\left(n^{2}-m^{2}\right)\left(a_{n}^{2}+b_{n}^{2}\right)
\end{align*}
$$

Then (2.37) is an easy consequence of 2.12, , 2.13) and 2.38 .

## 3. Affine $\lambda$-EQUidistants of the union of rosettes

We recall the definitions and theorems from 9 and then prove Theorem 3.12 and Theorem 3.15. We also simplify definitions and theorems from 9 to match only rosettes.

Definition 3.1. Let $R_{m}$ be a generic $m$-rosette and let $f: S^{1} \rightarrow \mathbb{R}^{2}$ be a parameterization of $R_{m}$ in terms of $p(\theta), \theta$. Then the sequence of parallel points $\mathcal{S}$ is the following sequence $\left(s_{0}, s_{1}, \ldots, s_{2 m-1}\right)$, where $s_{k}=k \pi$.

Definition 3.2. The set of parallel arcs for an $m-$ rosette is the following set

$$
\Phi_{0}=\{(0,1),(1,2), \ldots,(2 m-2,2 m-1),(2 m-1,0)\} .
$$

Proposition 3.3. (9]) Let $R_{m}$ be a generic $m$-rosette and let $f: S^{1} \rightarrow \mathbb{R}^{2}$ be a parameterization of $R_{m}$ in terms of $p(\theta), \theta$. For every two tuples $\left(k_{1}, l_{1}\right),\left(k_{2}, l_{2}\right)$ in $\Phi_{0}$ the well defined map

$$
f\left(\left(s_{k_{1}}, s_{l_{1}}\right)\right) \ni p \mapsto P(p) \in f\left(\left(s_{k_{2}}, s_{l_{2}}\right)\right)
$$

such that $p, P(p)$ is a parallel pair of $R_{m}$, is a diffeomorphism.
Remark 3.4. The set of parallel arcs includes tuples of integers that are related to arcs of the $m$-rosette from which we can construct arcs of branches of an affine equidistants, see Fig. 5


Figure 5. Two $\operatorname{arcs} \mathcal{A}_{1}, \mathcal{A}_{2}$ which are related to the tuples in the set of parallel arcs and (i) $E_{\frac{1}{2}}\left(\mathcal{A}_{1} \cup \mathcal{A}_{2}\right)$, (ii) $E_{\frac{2}{5}}\left(\mathcal{A}_{1} \cup \mathcal{A}_{2}\right)$.

Definition 3.5. Let $\left(k_{1}, k_{2}\right),\left(l_{1}, l_{2}\right)$ belong to the set of parallel arcs, then | $k_{1}$ | $k_{2}$ |
| :--- | :--- |
| $l_{1}$ | $l_{2}$ | denotes the following set (an arc)

$$
\left\{\lambda a+(1-\lambda) b \mid a \in f\left(\left[s_{k_{1}}, s_{k_{2}}\right]\right), b \in f\left(\left[s_{l_{1}}, s_{l_{2}}\right]\right), a, b \text { is a parallel pair of } R_{m}\right\}
$$

for an affine $\lambda$-equidistant for a fixed value of $\lambda$.

In addition | $k_{1}$ | $k_{2}$ | $\ldots$ | $k_{n-1}$ | $k_{n}$ |
| :--- | :--- | :--- | :--- | :--- |
|  | $l_{2}$ | $\ldots$ | $l_{n-1}$ | $l_{n}$ | denotes $\bigcup_{i=1}^{n-1} \frac{k_{i}}{} \frac{k_{i+1}}{l_{1}}$. We will call this set a glueing scheme for $E_{\lambda}\left(R_{m}\right)$ for a fixed value of $\lambda$.

Definition 3.6. A maximal glueing scheme for $E_{\lambda}\left(R_{m}\right)$ for $\lambda \neq 0,1$ is a glueing scheme which is a maximal element of the set of all glueing schemes for $E_{\lambda}\left(R_{m}\right)$ equipped with the inclusion relation.

Remark 3.7. In 9 we prove among other things that each maximal glueing scheme corresponds to a branch of an affine equidistant. If $\lambda \neq 0, \frac{1}{2}, 1$, then $E_{\lambda}\left(R_{m}\right)$ is the

union of $2\binom{\left|\Phi_{0}\right|}{2}$ different arcs. If $\lambda=\frac{1}{2}$, then $E_{\frac{1}{2}}\left(R_{m}\right)$ is the union of $\binom{\left|\Phi_{0}\right|}{2}$ different arcs. Furthermore if $\lambda \neq 0, \frac{1}{2}, 1$, then the maximal glueing scheme of a branch of $E_{\lambda}\left(R_{m}\right)$ is in the form \begin{tabular}{lllll}
\hline$k_{1}$ \& $k_{2}$ \& $\ldots$ \& $k_{n-1}$ \& $k_{n}$ <br>
\hline$l_{1}$ \& $l_{2}$ \& $\ldots$ \& $l_{n-1}$ \& $l_{n}$ <br>
\hline

, where $\left(k_{1}, l_{1}\right)=\left(k_{n}, l_{n}\right)$ and if $\lambda=\frac{1}{2}$, then the maximal glueing scheme of a branch of $E_{\lambda}\left(R_{m}\right)$ is in the form 

\hline$k_{1}$ \& $k_{2}$ \& $\ldots$ \& $k_{n-1}$ \& $k_{n}$ <br>
\hline$l_{1}$ \& $l_{2}$ \& $\ldots$ \& $l_{n-1}$ \& $l_{n}$ <br>

\end{tabular}, where $\left(k_{1}, l_{1}\right)=\left(k_{n}, l_{n}\right)$ or $\left(k_{1}, l_{1}\right)=\left(l_{n}, k_{n}\right)$.

Definition 3.8. Let $M$ be a smooth regular curve. Let $a, b$ be parallel pair of $M$ and let us assume that the curvature at $a$ and $b$ does not vanish. We say that $M$ is curved in the same side at $a$ and $b$ if the center of curvature of $M$ at $a$ and the center of curvature of $\tau_{a-b}(M)$ at $a=\tau_{a-b}(b)$ are lying on the same side of the tangent line to $M$ at $a$.

Proposition 3.9. ([9]) Let $M$ be a smooth regular curve.
(i) If $M$ is curved in the same side side at a parallel pair $a, b$, then $\lambda a+(1-\lambda) b$ is a $C^{\infty}$ regular point of $E_{\lambda}(M)$ for $\lambda \in(0,1)$.
(ii) If $M$ is not curved in the same side at a parallel pair $a, b$, then $\lambda a+(1-\lambda) b$ is a $C^{\infty}$ regular point of $E_{\lambda}(M)$ for $\lambda \in(-\infty, 0) \cup(1, \infty)$.

Theorem 6.1 in [9] and theorems in previous chapter (mainly Theorems 2.8 . 2.9 and 2.17 show the geometry of the affine $\lambda$-equdisitants and in parcticular of the Wigner caustic of rosettes in a fairly detailed way. To study the geometry of affine $\lambda$-equidistants for the union of two rosettes we want in particular study the geometry of branches which are created from both $M$ and $N$. Therefore we present the following definition.

Definition 3.10. Let $M$ and $N$ be planar regular closed curves. Then an affine $\lambda$-equidistant of the pair $M, N$ is the following set

$$
\begin{gathered}
E_{\lambda}(M, N)=\{\lambda x+(1-\lambda) y \mid(x \in M \wedge y \in N) \vee(x \in N \wedge y \in M) \\
x, y \text { is a parallel pair of } M \cup N\}
\end{gathered}
$$

Note that $E_{\lambda}(M, M)=M \cup E_{\lambda}(M)$ and $E_{\lambda}(M \cup N)=E_{\lambda}(M) \cup E_{\lambda}(M, N) \cup$ $E_{\lambda}(N)$.

Lemma 3.11. Let $M$ be a closed smooth curve with at most cusp singularities and let the rotation number of $M$ be an integer. Then the number of cusp singularities of $M$ is even.

Proof. A continuous normal vector field to the germ of a curve with the cusp singularity is directed outside the cusp on the one of two connected regular components and is directed inside the cusp on the other component as it is showed in Fig. 6 .

Since the rotation number of $M$ in an integer, we get that the number of cusps $M$ is even.

Let $\operatorname{gcd}(m, n)$ and $\operatorname{lcm}(m, n)$ denote the greatest common divisor and the least common multiplier of two positive integers $m$ and $n$, respectively.


Figure 6. The cusp singularity with a continuous normal vector field. Vectors in upper regular component of a curve are directed outside the cusp, others are directed inside the cusp.

Theorem 3.12. Let $R_{m_{1}}$ and $R_{m_{2}}$ be two generic rosettes. Then
(i) there exist $2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ branches of $E_{0.5}\left(R_{m_{1}}, R_{m_{2}}\right)$.
(ii) at least $\operatorname{gcd}\left(m_{1}, m_{2}\right)$ branches of $E_{0.5}\left(R_{m_{1}}, R_{m_{2}}\right)$ are rosettes.
(iii) there exist $4 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ branches of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $\lambda \neq 0, \frac{1}{2}, 1$.
(iv) at least $2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ branches of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $\lambda \neq 0, \frac{1}{2}, 1$ are rosettes.
(v) every branch of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $\lambda \neq 0,1$ has the rotation number equal to $\operatorname{lcm}\left(m_{1}, m_{2}\right)$.
(vi) the number of cusps of every branch of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $\lambda \neq 0,1$ is even.

Proof. The sets of parallel arcs $\Phi, \Phi^{\prime}$ of rosettes $R_{m_{1}}, R_{m_{2}}$ are as follows.

\Phi^{\prime} & =\left\{\left(0^{\prime}, 1^{\prime}\right),\left(1^{\prime}, 2^{\prime}\right), \ldots,\left(2 m_{2}^{\prime}-2,2 m_{2}^{\prime}-1\right),\left(2 m_{2}^{\prime}-1,0^{\prime}\right)\right\}
\end{aligned}
$$

where $a^{\prime}:=a+2 m_{1}$.
Therefore the set of parallel arcs of $R_{m_{1}} \cup R_{m_{2}}$ is in the following form.

\Phi_{0}=\{ & (0,1),(1,2), \ldots,\left(2 m_{1}-2,2 m_{1}-1\right),\left(2 m_{1}-1,0\right)  \tag{3.1}\\
& \left.\left(0^{\prime}, 1^{\prime}\right),\left(1^{\prime}, 2^{\prime}\right), \ldots,\left(2 m_{2}^{\prime}-2,2 m_{2}^{\prime}-1\right),\left(2 m_{2}^{\prime}-1,0^{\prime}\right)\right\}
\end{align*}
$$

Let $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ for an integer $k$ denote a branch of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$.
Let us notice that the maximal glueing scheme of $E_{0.5, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $k=$ $0,1,2, \ldots, 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ is in the following form

where on the upper part of 3.2 we have repetitively the following segment

of the length $2 m_{1}$ and on the lower part of 3.2 we have repetitively the following segment

of the length $2 m_{2}$. Therefore the maximal glueing scheme 3.2 is made of $2 \operatorname{lcm}\left(m_{1}, m_{2}\right)$ arcs.

The number of arcs of branches of $E_{0.5}\left(R_{m_{1}} \cup R_{m_{2}}\right)$ is equal to $\binom{\left|\Phi_{0}\right|}{2}$. Because the number of arcs of branches of $E_{0.5}\left(R_{m_{1}}\right)$ (resp. of $E_{0.5}\left(R_{m_{2}}\right)$ ) is equal to $\binom{2 m_{1}}{2}$ (resp. $\binom{2 m_{2}}{2}$ ), therefore the number of arcs of $E_{0.5}\left(R_{m_{1}}, R_{m_{2}}\right)$ is equal to $\binom{\left|\Phi_{0}\right|}{2}-\binom{2 m_{1}}{2}-\binom{2 m_{2}}{2}=4 m_{1} m_{2}$. Since we already used $2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$. $2 \operatorname{lcm}\left(m_{1}, m_{2}\right)=4 m_{1} m_{2}$ arcs in maximal glueing schemes in the form (3.2) we cannot construct more branches of $E_{0.5}\left(R_{m_{1}}, R_{m_{2}}\right)$.

Let $\lambda \neq 0, \frac{1}{2}, 1$. Using the same arguments as previous we can show that all maximal glueing schemes of $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $k=0,1,2, \ldots, 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ are in the form (3.3) and for $k=2 \operatorname{gcd}\left(m_{1}, m_{2}\right), 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)+1, \ldots, 4 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ are in the form (3.4), where $a^{\prime \prime}:=\left(a-2 \operatorname{gcd}\left(m_{1}, m_{2}\right)\right)^{\prime}$.

where on the upper part of (3.3) (resp. the lower part of (3.4) we have repetitively the following segment

of the length $2 m_{1}$ and on the lower part of (3.3) (resp. the upper part of (3.4) we have repetitively the following segment

of the length $2 m_{2}$.
By (3.2), (3.3) and (3.4) let us notice that every branch $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ is made of $2 \operatorname{lcm}\left(m_{1}, m_{2}\right)$ arcs and each arc has the rotation number equal to $\frac{1}{2}$. Since the rotation number of every branch $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ in an integer and for generic rosettes $R_{m_{1}}, R_{m_{2}}$ every branch $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ are smooth curves with at most cusp singularities, we get that the number of cusp singularities of every branch $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ is even (see Lemma 3.11).

Let $S^{1} \ni s \mapsto f_{i}(s) \in \mathbb{R}$ be the parameterization of $R_{m_{i}}$ for $i=1,2$. Without loss of generality let us assume that curve $R_{m_{1}}$ at $f_{1}(0)$ and $R_{m_{2}}$ at $f_{2}\left(0^{\prime}\right)$ are curved in the same direction. Then one can see that branches $E_{0.5,2 l}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $l=0,1, \ldots, \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ have the property that for any parallel pair $a_{1}, a_{2}$ such that $a_{1} \in R_{m_{1}}, a_{2} \in R_{m_{2}}$ and the point $\frac{a_{1}+a_{2}}{2}$ belongs to one of the branches above, the curves $R_{m_{1}}, R_{m_{2}}$ are curved in the same side, then by Proposition 3.9
these branches are rosettes. Using the same method one can show that at least $2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ branches of $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $\lambda \neq 0, \frac{1}{2}, 1$ are rosettes.

Remark 3.13. The set $E_{\lambda}\left(R_{m_{1}}, R_{m_{2}}\right)$ can be the union of only rosettes (see Fig. 7).


Figure 7. Two rosettes $R_{2}, R_{2}^{\prime}$ (the dashed lines) and two branches of $E_{0.5}\left(R_{2}, R_{2}^{\prime}\right)$ (the normal and the bold line). The support functions of $R_{2}$ (resp. $R_{2}^{\prime}$ ) is $p_{R_{2}}(\theta)=10+\cos \frac{5 \theta}{2}$ (resp. $\left.p_{R_{2}^{\prime}}(\theta)=2+36 \cos \theta+\sin \frac{\theta}{2}\right)$.

By the maximal glueing schemes (3.2), (3.3) and (3.4) we can get the following lemma.
Lemma 3.14. If $\lambda=\frac{1}{2}$ then the $2 \pi l c m\left(m_{1}, m_{2}\right)$-periodic support function of $a$ branch $E_{0.5, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $k=0,1,2, \ldots, 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ is in the following form

p_{E_{0.5, k}\left(R_{m_{1}}, R_{m_{2}}\right)}(\theta)=\frac{1}{2}\left(p_{R_{m_{1}}}(\theta)+(-1)^{k} p_{R_{m_{2}}}(\theta+k \pi)\right) . \tag{3.5}
\end{equation*}

If $\lambda \neq 0, \frac{1}{2}, 1$ then the $2 \pi l c m\left(m_{1}, m_{2}\right)$-periodic support function of a branch $E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)$ for $k=0,1,2, \ldots, 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1$ (resp. for $k=2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$, $\left.2 \operatorname{gcd}\left(m_{1}, m_{2}\right)+1, \ldots, 4 \operatorname{gcd}\left(m_{1}, m_{2}\right)-1\right)$ is in the form (3.6) (resp. in the form (3.7).

\end{equation*}

\begin{equation*}
p_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}(\theta)=(1-\lambda) p_{R_{m_{1}}}(\theta)+(-1)^{k} \lambda p_{R_{m_{2}}}\left(\theta+\left(k-2 \operatorname{gcd}\left(m_{1}, m_{2}\right)\right) \pi\right) . \tag{3.7}
\end{equation*}
$$

Theorem 3.15. (i) If $k$ is even, $k<2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(0,1)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}=\lambda \frac{l c m\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+(1-\lambda) \frac{l c m\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(ii) If $k$ is even, $k \geqslant 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(0,1)-\left\{\frac{1}{2}\right\}$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}=(1-\lambda) \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+\lambda \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(iii) If $k$ is odd, $k<2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(0,1)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)} \leqslant \lambda \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+(1-\lambda) \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(iv) If $k$ is odd, $k \geqslant 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(0,1)-\left\{\frac{1}{2}\right\}$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)} \leqslant(1-\lambda) \frac{l c m\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+\lambda \frac{l c m\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(v) If $k$ is odd, $k<2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}=|\lambda| \frac{l c m\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+|1-\lambda| \frac{l c m\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(vi) If $k$ is odd, $k \geqslant 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}=|1-\lambda| \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+|\lambda| \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(vii) If $k$ is even, $k<2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)} \leqslant|\lambda| \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+|1-\lambda| \frac{l c m\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

(viii) If $k$ is even, $k \geqslant 2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and $\lambda \in(-\infty, 0) \cup(1, \infty)$, then

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)} \leqslant|1-\lambda| \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+|\lambda| \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
$$

Proof. We prove (i), other points are analogous. So let $k$ be an even number and $k<2 \operatorname{gcd}\left(m_{1}, m_{2}\right)$ and let $\lambda \in(0,1)$. Therefore we get

L_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)} & =\int_{0}^{2 \pi \operatorname{lcm}\left(m_{1}, m_{2}\right)} \rho_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}(\theta) d \theta \\
& =\int_{0}^{2 \pi \operatorname{lcm}\left(m_{1}, m_{2}\right)} p_{E_{\lambda, k}\left(R_{m_{1}}, R_{m_{2}}\right)}(\theta) d \theta \\
& =\lambda \int_{0}^{2 \pi \operatorname{lcm}\left(m_{1}, m_{2}\right)} p_{R_{m_{1}}}(\theta) d \theta+(1-\lambda) \int_{0}^{2 \pi \operatorname{lcm}\left(m_{1}, m_{2}\right)} p_{R_{m_{2}}}(\theta) d \theta \\
& =\lambda \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{1}} L_{R_{m_{1}}}+(1-\lambda) \frac{\operatorname{lcm}\left(m_{1}, m_{2}\right)}{m_{2}} L_{R_{m_{2}}}
\end{aligned}
$$
