# ON $M$ - TERMS APPROXIMATIONS BESOV CLASSES IN LORENTZ SPACES

#### Abstract

In this paper we consider Lorentz space with a mixed norm of periodic functions of many variables. We obtain the exact estimation of the best M-term approximations of Nikol'ski's, Besov's classes in the Lorentz space with the mixed norm.

## 1. Introduction

Let $\bar{x}=\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{T}^{m}=[0,2 \pi)^{m}$ and $\theta_{j}, p_{j} \in[1,+\infty), j=1, \ldots, m$. Let $L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right)$ denotes the space of Lebesgue measureable functions $f(\bar{x})$ defined on $\mathbb{R}^{m}$, which have $2 \pi$ - period with respect to each variable such that

where

\|g\|_{p, \theta}=\left\{\int_{0}^{2 \pi}\left(g^{*}(t)\right)^{\theta} t^{\frac{\theta}{p}-1} d t\right\}^{\frac{1}{\theta}}
$$

where $g^{*}$ a non-increasing rearrangement of the function $|g|$ (see. [1]).
It is known that if $\theta_{j}=p_{j}, j=1, \ldots, m$, then $L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right)=L_{\bar{p}}\left(\mathbb{T}^{m}\right)$ the Lebesgue measurable space of functions $f(\bar{x})$ defined on $\mathbb{R}^{m}$, which have $2 \pi$ - period with respect to each variable with the norm

where $\bar{p}=\left(p_{1}, \ldots, p_{m}\right), 1 \leqslant p_{j}<+\infty, j=1, \ldots, m$ (see [2],p. 128).
Any function $f \in L_{1}\left(\mathbb{T}^{m}\right)=L\left(\mathbb{T}^{m}\right)$ can be expanded to the Fourier series

where $a_{\bar{n}}(f)$ Fourier coefficients of $f \in L_{1}\left(\mathbb{T}^{m}\right)$ with respect to multiple trigonometric system $\left\{e^{i(\bar{n}, \bar{x}\rangle}\right\}_{\bar{n} \in \mathbb{Z}^{m}}$, and $\mathbb{Z}^{m}$ is the space of points in $\mathbb{R}^{m}$ with integer coordinates.

For a function $f \in L\left(\mathbb{T}^{m}\right)$ and a number $s \in \mathbb{Z}_{+}=\mathbb{N} \cup\{0\}$ let us introduce the notation

where $\langle\bar{y}, \bar{x}\rangle=\sum_{j=1}^{m} y_{j} x_{j}$,

where $[a]$ is the integer part of the number $a$.
Let us consider Nikol'skii, Besov classes( see [2], [3]). Let $1<p_{j}<+\infty, 1<\theta_{j}<+\infty$, $j=1, \ldots, m, 1 \leqslant \tau \leqslant \infty$, and $r>0$

B_{\bar{p}, \bar{\theta}, \tau}^{r}=\left\{f \in L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right):\left(\sum_{s \in \mathbb{Z}_{+}} 2^{s r \tau}\left\|\delta_{s}(f)\right\|_{\bar{p}, \bar{\theta}}^{\tau}\right)^{\frac{1}{\tau}} \leqslant 1\right\} .
\end{gathered}

It is known that for $1 \leqslant \tau \leqslant \infty$ the following holds

B_{\bar{p}, \bar{\theta}, 1}^{r} \subset B_{\bar{p}, \bar{\theta}, \tau}^{r} \subset B_{\bar{p}, \bar{\theta}, \infty}^{r}=H_{\bar{p}, \bar{\theta}}^{r} .

Let $f \in L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right)$ and $\left\{\bar{k}^{(j)}\right\}_{j=1}^{M}$ be a system of vectors $\bar{k}^{(j)}=\left(k_{1}^{(j)}, \ldots, k_{m}^{(j)}\right)$ with integer coordinates. Consider the quantity

e_{M}(f)_{\bar{p}, \bar{\theta}}=\inf _{\bar{k}^{(j)}, b_{j}}\left\|f-\sum_{j=1}^{M} b_{j} e^{\langle i \bar{k}(j), \bar{x}\rangle}\right\|_{\bar{p}, \bar{\theta}}
$$

where $b_{j}$ are arbitrary numbers. The quantity $e_{M}(f)_{\bar{p}, \bar{\theta}}$ is called the best $M$ - term approximation of a function $f \in L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right)$. For a given class $F \subset L_{\bar{p}, \bar{\theta}}\left(\mathbb{T}^{m}\right)$ let

e_{M}(F)_{\bar{p}, \bar{\theta}}=\sup _{f \in F} e_{M}(f)_{\bar{p}, \bar{\theta}} .
$$

The best $M$ - term approximation was defined by S.B.Stechkin [4]. Estimations of $M$ - term approximations of different classes were provided by R.S. Ismagilov [5], E.S. Belinsky [6], V.E. Maiorov [7], B.S. Kashin [8], R. DeVore [9], V.N. Temlyakov [10], A.S. Romanyuk [11], Dinh Dung [12], Wang Heping and Sun Yongsheng [13], L. Q.Duan and G.S. Fang [14], W.Sickel and M. Hansen [15], S.A. Stasyuk [16], [17] and others (see bibliography in [18], [19], [20]).

For the case $p_{1}=\ldots=p_{m}=p$ and $q_{1}=\ldots=q_{m}=\theta_{1}=\ldots=\theta_{1}=q$ R.A. De Vore and V.N. Temlyakov [20] proved the following theorem.

Theorem A. Let $1 \leqslant p, q, \tau \leqslant \infty$ and $r(p, q)=m\left(\frac{1}{p}-\frac{1}{q}\right)_{+}$if $1 \leqslant p \leqslant q \leqslant 2$, or $1 \leqslant q \leqslant p<\infty$ and $r(p, q)=\max \left\{\frac{m}{p}, \frac{m}{2}\right\}$ in other cases. Then for $r>r(p, q)$ the following holds

e_{M}\left(B_{p, \tau}^{r}\right)_{q} \asymp M^{-\frac{r}{m}+\left(\frac{1}{p}-\max \left\{\frac{1}{q}, \frac{1}{2}\right\}\right)_{+}},
$$

where $a_{+}=\max \{a ; 0\}$.
Moreover, in the case of $m\left(\frac{1}{p}-\frac{1}{q}\right)<r<\frac{m}{p}, 1<p \leqslant 2<q<\infty$ S.A. Stasyuk [16] proved $e_{M}\left(B_{p, \tau}\right)_{q} \asymp M^{-\frac{q}{2}\left(\frac{r}{m}-\left(\frac{1}{p}-\frac{1}{q}\right)\right)}$. In the case $r=\frac{m}{p}$ obtained $e_{M}\left(B_{p, \tau}\right)_{q} \asymp M^{-\frac{1}{2}}(\log M)^{1-\frac{1}{\tau}}$ (see [17] ).

The main goal of the present paper is to find the order of the quantity $e_{M}(F)_{\bar{q}, \bar{\theta}}$ for the class $F=B_{\bar{p}, \bar{\theta}, \tau}^{r}$.

The notation $A(y) \asymp B(y)$ means that there exist positive constants $C_{1}, C_{2}$ such that $C_{1} A(y) \leqslant B(y) \leqslant C_{2} A(y)$. If $A \leqslant C_{2} B$ or $A \geqslant C_{2} B$, then we write $A \ll B$ or $A \gg B$.

## 2. Auxiliary results

To prove the main results the following auxiliary propositions are used.
Theorem B ([21] ). Let $p \in(1, \infty)$. Then there exist positive numbers $C_{1}(p), C_{2}(p)$ such that for any function $f \in L_{p}\left(\mathbb{T}^{m}\right)$ the following inequality holds:

Theorem C ([22] ). Let $\bar{n}=\left(n_{1}, \ldots, n_{m}\right), \quad n_{j} \in \mathbb{N}, j=1, \ldots, m$ and

Then for $1 \leqslant p_{j}<q_{j}<\infty, 1 \leqslant \theta_{j}^{(1)}, \theta_{j}^{(2)}<+\infty, j=1, \ldots m$ the following inequality holds

\left\|T_{\bar{n}}\right\|_{\bar{q}, \bar{\theta}^{(2)}} \ll \prod_{j=1}^{m} n_{j}^{\frac{1}{p_{j}}-\frac{1}{q_{j}}}\left\|T_{\bar{n}}\right\|_{\bar{p}, \bar{\theta}^{(1)}} .
$$

Let $\Omega_{M}$ be a set containing no more than $M$ vectors $\bar{k}=\left(k_{1}, \ldots, k_{m}\right)$ with integer coordinates, and $P\left(\Omega_{M}, \bar{x}\right)$ be any trigonometric polynomial, which consists of harmonics with "indices" in $\Omega_{M}$.

Lemma 1 (see [18]). Let $2<q_{j}<+\infty, j=1, \ldots, m$. Then for any trigonometric polynomial $P\left(\Omega_{N}\right)$ and for any natural number $M<N$ there exists trigonometric polynomial $P\left(\Omega_{M}\right)$, such that the following estimation holds

\left\|P\left(\Omega_{N}\right)-P\left(\Omega_{M}\right)\right\|_{\bar{q}} \ll\left(N M^{-1}\right)^{\frac{1}{2}}\left\|P\left(\Omega_{N}\right)\right\|_{2}

and, moreover, $\Omega_{M} \subset \Omega_{N}$.

## 3. Main Results

Let us prove the main results.
Theorem 1. . Let $\bar{p}=\left(p_{1}, \ldots, p_{m}\right), \quad \bar{q}=\left(q_{1}, \ldots, q_{m}\right), \quad \bar{\theta}^{(1)}=\left(\theta_{1}^{(1)}, \ldots, \theta_{m}^{(1)}\right), \quad \bar{\theta}^{(2)}=$ $\left(\theta_{1}^{(2)}, \ldots, \theta_{m}^{(2)}\right), 1<p_{j} \leqslant 2<q_{j}<\infty, 1<\theta_{j}^{(1)}, \theta_{j}^{(2)}<\infty, j=1, \ldots, m, 1 \leqslant \tau \leqslant \infty$.

1. If $\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)<r<\sum_{j=1}^{m} \frac{1}{p_{j}}$, then

e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \asymp M^{-\left(2 \sum_{j=1}^{m} \frac{1}{q_{j}}\right)^{-1}\left(r-\sum_{j=1}^{m}\left(\frac{1}{\left.\left.p_{j}-\frac{1}{q_{j}}\right)\right)} . . . . ~ . ~\right.\right.}
$$

2. If $r=\sum_{j=1}^{m} \frac{1}{p_{j}}$, then

e_{M}\left(B_{\bar{p}, \overline{\theta^{(1)} \tau} \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \asymp M^{-\frac{1}{2}}\left(\log _{2} M\right)^{1-\frac{1}{\tau}}
$$

for $M>1$.
3. If $r>\sum_{j=1}^{m} \frac{1}{p_{j}}$, then

e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \asymp M^{-\frac{1}{m}\left(r+\sum_{j=1}^{m}\left(\frac{1}{2}-\frac{1}{p_{j}}\right)\right)} .
$$

Proof. Firstly, we are going to consider the upper bound in the first item. Taking into account the inclusion $B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r} \subset H_{\bar{p}, \bar{\theta}^{(1)}}^{r}, 1 \leqslant \tau<+\infty$, it suffices to prove it for the class $H_{\bar{p}, \bar{\theta}^{(1)}}^{r}$.

Let $1<p_{j} \leqslant 2<q_{j}<\infty, \quad j=1, \ldots, m$, and $\mathbb{N}$ be the set of natural numbers. For a number $M \in \mathbb{N}$ choose a natural number $n$ such that $2^{n m}<M \leqslant 2^{(n+1) m}$. For a function $f \in H_{\bar{p}, \bar{\theta}^{(1)}}^{r}$, it is known that

\left\|\delta_{s}(f)\right\|_{\bar{p}_{\bar{\theta}} \bar{\theta}^{(1)}} \leqslant 2^{-s r}, \quad 1<p_{j}<\infty, \quad j=1, \ldots, m
$$

We will seek an approximation polynomial $P\left(\Omega_{M}, \bar{x}\right)$ in the form

P\left(\Omega_{M}, \bar{x}\right)=\sum_{s=0}^{n-1} \delta_{s}(f, \bar{x})+\sum_{n \leqslant s<\alpha n} P\left(\Omega_{N_{s}}, \bar{x}\right), \tag{1}

where the polynomials $P\left(\Omega_{N_{s}}, \bar{x}\right)$ will be constructed for each $\delta_{s}(f, \bar{x})$ in accordance with Lemma 1, and the number $\alpha>1$ will be chosen during the construction.

Let $\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)<r<\sum_{j=1}^{m} \frac{1}{p_{j}}$. Suppose

N_{s}=\left[2^{n m} 2^{s\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)} 2^{-n \alpha\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)}\right]+1,

where $[y]$ integer part of the number $y$.
Now we are going to show that polynomials (1) have no more than $M$ harmonics (in terms of order). By definition of the number $N_{s}$, we have

+ & \sum_{n \leqslant s<\alpha n}\left(2^{n m} 2^{s\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)} 2^{-n \alpha\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)}+1\right) \ll 2^{n m}+(\alpha-1) n \ll 2^{n m} \asymp M,
\end{aligned}
$$

where $\sharp A$ denotes the number of elements of the set $A$.
Next, by the property of the norm we have

& \left\|f-P\left(\Omega_{M}\right)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \leqslant\left\|\sum_{n \leqslant s<\alpha n}\left(\delta_{s}(f)-P\left(\Omega_{N_{s}}\right)\right)\right\|_{\bar{q}, \bar{\theta}^{(2)}}+ \\
& \quad+\left\|\sum_{\alpha n \leqslant s<+\infty} \delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}^{(2)}}=J_{1}(n)+J_{2}(n) . \tag{2}
\end{align*}

Let us estimate $J_{2}(n)$. Applying the inequality of different metrics for trigonometric polynomials (see Theorem C), we can obtained

J_{2}(n) \leqslant \sum_{\alpha n \leqslant s<+\infty}\left\|\delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}\left(\bar{\theta}^{2}\right)} \ll \sum_{\alpha n \leqslant s<+\infty} 2^{s \sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)}\left\|\delta_{s}(f)\right\|_{\bar{p}, \bar{\theta}\left(\bar{\theta}^{1)}\right.}
$$

Therefore, taking into account $f \in H_{\bar{p}, \bar{\theta}^{(1)}}^{r}$ and $\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)<r$, we get

J_{2}(n) \ll \sum_{\alpha n \leqslant s<+\infty} 2^{-s\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} \ll 2^{-n \alpha\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} . \tag{3}

Let us estimate $J_{1}(n)$. Using the property of the quasi-norm, Lemma 1 and the inequality of different metrics (see Theorem C), we get

J_{1}(n)=\left\|\sum_{n \leqslant s<\alpha n}\left(\delta_{s}(f)-P\left(\Omega_{N_{s}}\right)\right)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \ll \sum_{n \leqslant s<\alpha n}\left\|\delta_{s}(f)-P\left(\Omega_{N_{s}}\right)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \ll \\
\ll \sum_{n \leqslant s<\alpha n}\left(N_{s}^{-1} 2^{s m}\right)^{\frac{1}{2}}\left\|\delta_{s}(f)\right\|_{2} \ll \\
\ll \sum_{n \leqslant s<\alpha n}\left(N_{s}^{-1} 2^{s m}\right)^{\frac{1}{2}} 2^{s \sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{2}\right)}\left\|\delta_{s}(f)\right\|_{\bar{p}, \bar{\theta}(1)} \ll \\
\ll \sum_{n \leqslant s<\alpha n} N_{s}^{-\frac{1}{2}} 2^{s \sum_{j=1}^{m} \frac{1}{p_{j}}} 2^{-s r} \ll \\
\ll 2^{-\frac{n m}{2}} 2^{\frac{n \alpha}{2}\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)} \sum_{n \leqslant s<\alpha n} 2^{s\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right) \frac{1}{2}} \ll 2^{-\frac{n m}{2}} 2^{n \alpha\left(\sum_{j=1}^{m} \frac{1}{p_{j}}-r\right)} \tag{4}

Suppose $\alpha=m\left(2 \sum_{j=1}^{m} \frac{1}{q_{j}}\right)^{-1}$. Then from the inequality (4), we get

For $\alpha=m\left(2 \sum_{j=1}^{m} \frac{1}{q_{j}}\right)^{-1}$, using the inequality (3) and taking into account $2^{n m} \asymp M$ we obtain

By (5) and (6), we get from the inequality (2) the following

\left\|f-P\left(\Omega_{M}\right)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\left(2 \sum_{j=1}^{m} \frac{1}{q_{j}}\right)^{-1}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)}
$$

for any function $f \in H_{\bar{p}, \bar{\theta}^{(1)}}^{r}$ in the case of $\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)<r<\sum_{j=1}^{m} \frac{1}{p_{j}}$.
From the inclusion $B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r} \subset H_{\bar{p}, \bar{\theta}^{(1)}}^{r}$ and the definition of $M$ - term approximation, it follows that

e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\left(2 \sum_{j=1}^{m} \frac{1}{q_{j}}\right)^{-1}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)}
$$

in the case of $\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)<r<\sum_{j=1}^{m} \frac{1}{p_{j}}$.
Let us consider the lower bound. We will use the well-known formula ([23], p.25)

\left\|v_{1}\right\|_{\bar{q}^{\prime}, \bar{\theta}^{(2)^{\prime}}} \ll \sum_{s=1}^{n}\left\|\delta_{s}\left(g_{1}\right)\right\|_{\bar{q}^{\prime}, \bar{\theta}^{(2)^{\prime}}} \ll \\
\ll \sum_{s=1}^{n} 2^{s \sum_{j=1}^{m}\left(1-\frac{1}{q_{j}^{\prime}}\right)} \ll 2^{n \sum_{j=1}^{m}\left(1-\frac{1}{q_{j}^{\prime}}\right)}=C 2^{n \sum_{j=1}^{m} \frac{1}{q_{j}}} .
\end{gathered}
$$

Therefore, taking into account $\frac{1}{q_{j}}<\frac{1}{2}, \quad j=1, \ldots, m$, we get

$$
\left\|w_{1}\right\|_{\bar{q}^{\prime}, \bar{\theta}^{(2)^{\prime}}} \ll\left(2^{\frac{n m}{2}}+M^{\frac{1}{2}}\right) \leqslant C_{2} 2^{\frac{n m}{2}}
$$

Hence the function

$$
P_{1}(\bar{x})=C_{2}^{-1} 2^{-\frac{n m}{2}} w_{1}(\bar{x})
$$

satisfies the conditions of the formula (7). Then, by substituting the functions $f_{1}$ and $P_{1}$ into (7) and by orthogonally of a trigonometric system, we obtain

$$
\begin{gathered}
e_{M}\left(f_{1}\right)_{\bar{q}, \bar{\theta}(2)} \gg \sum_{n_{1} \leqslant s<n} \sum_{\bar{k} \in \rho(s)} \prod_{j=1}^{m} k_{j}^{-1} 2^{-\frac{n m}{2}} n^{-\frac{1}{\tau}} \gg \\
\geqslant C(\ln 2)^{m} \sum_{n_{1} \leqslant s<n} 2^{-\frac{n m}{2}} n^{-\frac{1}{\tau}}=C(\ln 2)^{m} 2^{-\frac{n m}{2}} n^{-\frac{1}{\tau}}\left(n-n_{1}\right) \geqslant \\
\gg(\ln 2)^{m} 2^{-\frac{n m}{2}} n^{1-\frac{1}{\tau}} \asymp M^{-\frac{1}{2}}\left(\log _{2} M\right)^{1-\frac{1}{\tau}},
\end{gathered}
$$

where $n_{1}$ is a natural number such that $n_{1}<\frac{n}{2}$.
So, for the function $f_{1} \in B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}$ it has been proved that

$$
e_{M}\left(f_{1}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg M^{-\frac{1}{2}}\left(\log _{2} M\right)^{1-\frac{1}{\tau}}
$$

in the case of $r=\sum_{j=1}^{m} \frac{1}{p_{j}}$. Hence

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \theta^{(\overline{2})}} \gg M^{-\frac{1}{2}}\left(\log _{2} M\right)^{1-\frac{1}{\tau}}
$$

in the case of $r=\sum_{j=1}^{m} \frac{1}{p_{j}}$. It proves the lower bound estimation in the second item.
Let us prove the lower bound estimation for the case $r>\sum_{j=1}^{m} \frac{1}{p_{j}}$. Since in this case an upper bound estimation of the quantity $e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}}$ does not depend on $\tau$ and $B_{\overline{\bar{p}}, \bar{\theta}^{(1)}, 1}^{r} \subset B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}, 1<\tau<+\infty$, it suffices to prove the lower bound estimation for
$B_{\bar{p}, \bar{\theta}^{(1)}, 1}^{r}$

For a number $M \in \mathbb{N}$, we choose a natural number $n$ such that $2^{n m}<M \leqslant 2^{(n+1) m}$ and $2 M \leqslant \sharp \rho(n)$, where $\sharp \rho(n)$ denotes the number of elements in the set $\rho(n)$.

Consider the following function

$$
f_{3}(\bar{x})=n^{-1} \sum_{s=1}^{n} 2^{-s \sum_{j=1}^{m}\left(1-\frac{1}{p_{j}}\right)} \sum_{\bar{k} \in \rho(s)} \prod_{j=1}^{m} k_{j}^{-\frac{r}{m}} \cos k_{j} x_{j} .
$$

Then

$$
\left\|\delta_{s}\left(f_{3}\right)\right\|_{\bar{p}, \bar{\theta}(1)} \ll 2^{-s r} n^{-1}
$$

Hence

$$
\sum_{s=0}^{\infty} 2^{s r}\left\|\delta_{s}\left(f_{3}\right)\right\|_{\bar{p}, \bar{\theta}^{(1)}} \leqslant C_{3}
$$

i.e. the function $C_{3}^{-1} f_{3} \in B_{\bar{p}, \bar{\theta}^{(1)}, 1}^{r}$.

Next, consider the functions

$$
\begin{gathered}
v_{3}(\bar{x})=\sum_{s=1}^{n} \sum_{\bar{k} \in \rho(s)} \prod_{j=1}^{m} \cos k_{j} x_{j} \\
u_{3}(\bar{x})=\sum_{s=1}^{n} \sum_{\bar{k} \in \rho(s) \cap \Omega_{M}} \prod_{j=1}^{m} \cos k_{j} x_{j} .
\end{gathered}
$$

Suppose $w_{3}(\bar{x})=v_{3}(\bar{x})-u_{3}(\bar{x})$. By the Perseval's equality,

$$
\begin{gathered}
\left\|u_{3}\right\|_{2} \leqslant M^{\frac{1}{2}} \\
\left\|v_{3}\right\|_{2}=2^{\frac{(n-1) m}{2}}
\end{gathered}
$$

From these relations, we obtain, by the properties of the norm, the following

$$
\left\|w_{3}\right\|_{2} \leqslant\left\|v_{3}\right\|_{2}+\left\|u_{3}\right\|_{2} \leqslant C_{4} 2^{\frac{n m}{2}}
$$

Therefore the function $P_{3}(\bar{x})=C_{4}^{-1} 2^{-\frac{n m}{2}} w_{3}(\bar{x})$ satisfies the conditions of the formula (7). Since $2<q_{j} j=1, \ldots, m$, we have $e_{M}\left(f_{3}\right)_{2} \leqslant C e_{M}\left(f_{3}\right)_{\bar{q}, \bar{\theta}(2)}$. Now, by the formula (7), we get

\begin{gathered}
e_{M}\left(f_{3}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg e_{M}\left(f_{3}\right)_{2} \gg n^{-1} 2^{-\frac{n m}{2}} \sum_{s=1}^{n} 2^{-s \sum_{j=1}^{m}\left(1-\frac{1}{p_{j}}\right)} \sum_{\bar{k} \in \rho(s)} \prod_{j=1}^{m} k_{j}^{-\frac{r}{m}} \gg \\
\gg n^{-1} 2^{-\frac{n m}{2}} \sum_{s=1}^{n} 2^{-s \sum_{j=1}^{m}\left(1-\frac{1}{p_{j}}\right)} 2^{s(m-r)}= \\
=C n^{-1} 2^{-\frac{n m}{2}} \sum_{s=1}^{n} 2^{-s\left(r-\sum_{j=1}^{m} \frac{1}{p_{j}}\right)} \gg 2^{-n\left(r+\sum_{j=1}^{m}\left(\frac{1}{2}-\frac{1}{p_{j}}\right)\right)} .
\end{gathered}
$$

It follows from the relation $2^{n m} \asymp M$ that

$$
e_{M}\left(f_{3}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg M^{-\frac{1}{m}\left(r+\sum_{j=1}^{m}\left(\frac{1}{2}-\frac{1}{p_{j}}\right)\right)}
$$

in the case $r>\sum_{j=1}^{m} \frac{1}{p_{j}}$ for the function $C_{3}^{-1} f_{3} \in B_{\bar{p}, \theta^{(\overline{1})}, 1}^{r}$. Hence

$$
e_{M}\left(B_{\bar{p}, \theta^{(\overline{1}}, 1}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg M^{-\frac{1}{m}\left(r+\sum_{j=1}^{m}\left(\frac{1}{2}-\frac{1}{p_{j}}\right)\right)}
$$

Therefore

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}} \gg M^{-\frac{1}{m}\left(r+\sum_{j=1}^{m}\left(\frac{1}{2}-\frac{1}{p_{j}}\right)\right)}
$$

in the case $r>\sum_{j=1}^{m} \frac{1}{p_{j}}$. So Theorem 1 has been proved.
Theorem 2. . Let $\bar{p}=\left(p_{1}, \ldots, p_{m}\right), \bar{q}=\left(q_{1}, \ldots, q_{m}\right), 1<p_{j}<q_{j} \leqslant 2,1<\theta_{j}^{(1)}, \theta_{j}^{(2)}<\infty$, $j=1, \ldots, m, 1 \leqslant \tau \leqslant+\infty$.

If $r>\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)$, then

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \theta^{(2)}} \asymp M^{-\frac{1}{m}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} .
$$

Proof. For a number $M \in \mathbb{N}$ choose a natural number $n$ such that $M \asymp 2^{n m}$. By the inequality of distinct metrics and by Holder's inequality, we have

$$
\begin{gathered}
\left\|f-\sum_{s=0}^{n} \delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \leqslant \sum_{s=n}^{\infty}\left\|\delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \leqslant \\
\leqslant\left[\sum_{s=0}^{\infty} 2^{s \tau r}\left\|\delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}\left(\bar{\theta}^{2}\right)}^{\tau}\right]^{\frac{1}{\tau}} \leqslant\left[\sum_{s=n}^{\infty} 2^{s \tau^{\prime}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)}\right]^{\frac{1}{\tau^{\prime}}} \ll
\end{gathered}
$$

$$
\ll 2^{n\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} \leqslant C M^{-\frac{1}{m}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)}
$$

for $f \in B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}, \quad \frac{1}{\tau}+\frac{1}{\tau^{\prime}}=1$. Therefore

$$
e_{M}(f)_{\bar{q}, \bar{\theta}^{(2)}} \leqslant\left\|f-\sum_{s=0}^{n} \delta_{s}(f)\right\|_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\frac{1}{m}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} .
$$

Hence

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\frac{1}{m}\left(r-\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-\frac{1}{q_{j}}\right)\right)} .
$$

It proves the upper bound estimation.
For the lower bound estimation, let us consider the function

$$
f_{0}(\bar{x})=n^{-r+\sum_{j=1}^{m}\left(\frac{1}{p_{j}}-1\right)} V_{n}(\bar{x}),
$$

where $V_{n}(\bar{x})$ is a Valle-Poisson sum with multiplicity.
Next, following the proof in [19] (pp. 46-47) and applying Theorem B, we obtain the lower bound estimation of the quantity $e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}}$.
Theorem 3. . Let $\bar{p}=\left(p_{1}, \ldots, p_{m}\right), \bar{q}=\left(q_{1}, \ldots, q_{m}\right), 2 \leqslant p_{j}<q_{j}<\infty, 1<\theta_{j}^{(1)}, \theta_{j}^{(2)}<\infty$, $j=1, \ldots, m, 1 \leqslant \tau \leqslant+\infty$. If $r>\frac{m}{2}$, then

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \asymp M^{-\frac{r}{m}} .
$$

Proof. By the inclusion $B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r} \subset B_{\overline{2}, \bar{\theta}^{(1)}, \tau}^{r} \subset H_{2, \bar{\theta}^{(1)}}^{r}$, we have

$$
e_{M}\left(B_{\bar{p}, \overline{\theta^{(1)}, \tau}}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \leqslant e_{M}\left(B_{2, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \leqslant e_{M}\left(H_{2, \bar{\theta}^{(1)}}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} .
$$

By Theorem 1,

$$
e_{M}\left(H_{2, \bar{\theta}^{(1)}}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\frac{r}{m}}
$$

for $p_{j}=2, j=1, \ldots, m$. Hence

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \ll M^{-\frac{r}{m}} .
$$

it proves the upper bound estimation.
Let us consider the lower bound estimation. Consider Rudin-Shapiros polynomial (see [24], p.155) of the type

$$
R_{s}(x)=\sum_{s=2^{s-1}}^{2^{s}} \varepsilon_{k} e^{i k x}, \quad x \in[0,2 \pi], \quad \varepsilon_{k}= \pm 1
$$

it is known that $\left\|R_{s}\right\|_{\infty}=\max _{x \in[0,2 \pi]}\left|R_{s}(x)\right| \ll 2^{\frac{s}{2}}$ (see [24], p. 155). For a given number $M$ choose a number $n$ such that $M \asymp 2^{n m}$. Now consider the function

$$
f_{0}(\bar{x})=2^{-n\left(\frac{m}{2}+r\right)} \sum_{s=1}^{n} \prod_{j=1}^{m} R_{s}\left(x_{j}\right)
$$

Then, by the continuity, $f_{0} \in L_{\bar{p}, \bar{\theta}^{(1)}}\left(\mathbb{T}^{m}\right)$ and

$$
\sum_{s=0}^{\infty} 2^{s \tau r}\left\|\delta_{s}\left(f_{0}\right)\right\|_{\bar{p}, \bar{\theta} \bar{\theta}^{(1)}}^{\tau}=2^{-n\left(\frac{m}{2}+r\right)} \sum_{s=1}^{n} 2^{s \tau r}\left\|\prod_{j=1}^{m} R_{s}\left(x_{j}\right)\right\|_{\bar{p}, \bar{\theta} \bar{\theta}^{(1)}} \leqslant
$$

$$
\leqslant 2^{-n\left(\frac{m}{2}+r\right)} \sum_{s=1}^{n} 2^{s\left(\frac{m}{2}+r\right) \tau} \leqslant C_{0}
$$

Hence, the function $C_{0}^{-1} f_{0} \in B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}$. Now construct a function $P(\bar{x})$, which would satisfy the conditions in the formula (7). Suppose

$$
v_{0}(\bar{x})=\sum_{s=1}^{n} \prod_{j=1}^{m} R_{s}\left(x_{j}\right), \quad u_{0}(\bar{x})=\sum_{s}^{*} \prod_{j=1}^{m} R_{s}\left(x_{j}\right)
$$

where the $\operatorname{sign} *$ means that the polynomial $u_{0}(\bar{x})$ contains only those harmonics of $v_{0}$ which have indices in $\Omega_{M}$. Suppose $w_{0}(\bar{x})=v_{0}(\bar{x})-u_{0}(\bar{x})$. Then, since $1<q_{j}^{\prime}=\frac{q_{j}}{q_{j}-1}<$ $2, \quad j=1, \ldots, m$, and by the Percevals equality, we have

$$
\left\|w_{0}\right\|_{\bar{q}^{\prime}, \bar{\theta}^{(2)^{\prime}}} \leqslant\left\|w_{0}\right\|_{2} \leqslant C_{1} 2^{\frac{n m}{2}}
$$

Therefore, for the function $P_{0}(\bar{x})=C_{1}^{-1} 2^{-\frac{n m}{2}} w_{0}(\bar{x})$, the inequality holds $\left\|P_{0}\right\|_{\bar{q}^{\prime}, \theta^{(2)^{\prime}}} \leqslant 1$. Now using the formula (7), we obtain

$$
\begin{aligned}
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)} \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} & >e_{M}\left(f_{0}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg 2^{-n\left(\frac{m}{2}+r\right)} 2^{-\frac{n m}{2}}\left(2^{n m}-M\right) \gg \\
& \gg 2^{-n(m+r)} 2^{n m} \gg M^{-\frac{r}{m}}
\end{aligned}
$$

So

$$
e_{M}\left(B_{\bar{p}, \bar{\theta}^{(1)}, \tau}^{r}\right)_{\bar{q}, \bar{\theta}^{(2)}} \gg M^{-\frac{r}{m}}
$$

It proves Theorem 3.
Corollary. Let $1<p \leqslant 2<q<\infty, 1 \leqslant \tau \leqslant \infty$ and $r=\frac{m}{p}$. Then

$$
e_{M}\left(B_{p, \tau}^{r}\right)_{q} \asymp M^{-\frac{1}{2}}(\log M)^{1-\frac{1}{\theta}}
$$

The proof follows from the second item of Theorem 2.1 if $p_{j}=\theta_{j}^{(1)}=p, q_{j}=\theta_{j}^{(2)}=$ $q, j=1, \ldots, m$.

Remark. In the case $p_{j}=\theta_{j}^{(1)}=p, q_{j}=\theta_{j}^{(2)}=q, j=1, \ldots, m$ and $r>m\left(\frac{1}{p}-\frac{1}{q}\right),$, the results of R.A. DeVore and V.N. Temlyakov [20] follow from Theorem 1 - 3. If $1<p \leqslant 2<q<\infty$ and $m\left(\frac{1}{p}-\frac{1}{q}\right)<r \leqslant \frac{m}{p}$, the results of S.A. Stasyuk [16], [17] follow from the first and second items of Theorem 1.

The cases $p_{j}=\theta_{j}^{(1)}, q_{j}=\theta_{j}^{(2)}, j=1, \ldots, m$. of Theorem 1-3 were announced in [25] and in of Theorem 1 the first item proved [26].
